4 jawans shot in Bathinda, Nitish, Tejashwi meet Rahul for Opp unity 2 masked killers at large

Bathinda Military Station firing FIR rules out terror possibility; crime rifle recovered

PNS CHANDIGARH/ NEW DELHI

Four Indian Army jawans — belonging to the 80 Medium Regiment and on guard duty in the Officers' Mess — were killed in a firing incident, reported incide incident reported inside Bathinda Military Station early on Wednesday. As per preliminary investigations, two "masked" men in kurta-payjama attacked the jawans - all in their twenties - when they were asleep in their barracks at 4.30 am, with an INSAS assault

rifle and an axe. A jawan saw the two unidentified men coming out of the barracks after the firing. The suspected attackers, who were of medium height, went towards a forested area near the barracks on seeing the jawan,

according to the FIR. Subsequently, two Army officers went inside the barracks and found Gunner Sagar Banne (25), Gunner Yogesh Kumar J (24) in a pool of blood. In another room, the bodies of Gunner Santosh M Nagaral (25) and Gunner Kamalesh R (24), were found. The bodies bore bullet marks, according to vital clues.

Banne and Nagaral hailed from Karnataka, while Kamalesh and Yogesh were from Tamil Nadu, police said.

From the spot of the incident, total 19 empty shells of INSAS rifle — believed to be the one went missing from the unit about two days back – were recovered from the spot.

The joint search team, comprising military and Bathinda district police, later located the INSAS assault rifle suspected to be the weapon used in the incident and the ammunition that went missing two days ago. The joint team is scanning the CCTV footage for

According to "the information we have gathered so far, it is clear that it is not a terrorist act," a senior police officer said

Initially, the police suggested that it was an incident of "fratricide". However, officials later said there was no clarity on the incident yet.

Army's South Western command, in a statement, stated, "A search team has located the INSAS rifle along with the magazine. Army and Police Joint teams will now be undertaking forensic analysis of the weapon to ascertain further details. The balance number of rounds in the weapon will only be available after forensic

analysis. A joint investigation with Punjab Police is in progress. All possible assistance is being provided. It is reiterated that no individual has been detained or apprehended."

Meanwhile, Army Chief General Manoj Pande on Wednesday briefed Defence Minister Rajnath Singh about the Bathinda military station

incident. The Bathinda military station is the largest military base in Asia and home to the Army's HQs 10 Corps. The pivot "Chetak" corps is responsible for defending India's border with Pakistan in south Punjab and north Rajasthan.

In yet another attempt to forge Opposition unity to take on the BJP in the 2024 Lok Sabha polls, the top leaders of Congress, JD(U) and RJD met on Wednesday, with Bihar Chief Minister Nitish Kumar saying they will make all efforts to unite more and more parties in the country against the BJP.

among some regional outfits. The JD(U), the RJD and the Congress are in a coalition Government in Bihar and they are in talks to bring other Opposition parties together on a common platform in their fight against the BJP.

Kumar and Tejashwi also met Delhi Chief Minister and AAP chief Arvind Kejriwal on Wedneday. Kejriwal lauded Nitish's efforts to bring together Opposition parties and pledged his support.

India recording 7,830 cases and daily positivity rate surging from 2.88 per cent on Tuesday to 3.65 per cent — a rise of 26.73 per cent in a day. At 7,830 fresh cases in the last 24 hours, India recorded the highest number of Covid-19 cases in over seven months, according to the latest Government data.

However, officials in the Union Health Ministry said there's no need to worry as infections are expected to rise for the next 10-12 days and then subside. Though the infection may rise, hospitalisation will remain low, they said.

The XBB.1.16 subvariant of Omicron, which is driving the latest surge, is not a cause of worry and vaccines are effective against it, the officials added. The subvariant's prevalence increased from 21.6 per cent in February to 35.8 per cent in March, but no incident of hospitalisation or death has been reported.

D etail inflation in March fell to a 15-month low of 5.66 per cent and came back to the Reserve Bank's comfort level of 6 per cent, as prices of vegetables and protein-rich items eased, showed government data released on Wednesday.

Meanwhile, India's industrial production growth rose marginally to 5.6 per cent in February from 5.5 per cent in January 2023, mainly due to good performance of the power, mining and manufacturing sectors, according to official data released on Wednesday.

The retail inflation based on Consumer Price Index (CPI) was 6.44 per cent in February 2023 and 6.95 per cent in the year-ago period. The previous low was also 5.66 in December 2021.

The Reserve Bank has been mandated by the Government to ensure inflation remains within the 4-6 per cent bracket. The CPI was above 6 per cent in January and February. According to the National

Delhi's single-day COVID-19 cases count breached the 1,000-mark for the first time in over seven months on Wednesday, while the positiv-ity rate stood at 23.8 per cent, according to data shared by the health department here.

The national capital logged 1,149 fresh cases along with one fatality.

However, the department said coronavirus was not the primary cause of death. Wednesday's cases were the highest since August 19 last year. The city had on August 19 last year recorded 1,417 cases, with a reduced positivity rate of 7.53 per cent and three fatalities due to the viral disease

School evacuated after hoax **bomb email creates panic**

STAFF REPORTER NEW DELHI

Indian School in South Delhi's Sadiq Nagar was evacuated on Wednesday morning after the school administration received an email from an unknown sender with a threat about a bomb on the premises According to police, an email was sent to Indian Public School in Sadiq Nagar at 10:49 am, claiming that a bomb has been planted on its premises. After hours of meticulous searches, police declared it a hoax call.

Earlier in the day, the panicked students and parents of 'The Indian School' gathered outside the school as the bomb squad and other agencies inspected the premises for any explosive substance. "This morning, a bomb threat email was received by the school. Immediately all safety protocols were carried out and all children and staff were safely evacuated," Tania Joshi, principal, The Indian School said. She said the police is investigating the matter to identify the per-

petrator. "The threat seems to be a hoax," she added. Videos from outside the

school show a large crowd, mostly parents of the students, assembled at the gate. "We received a message from the school asking us to take our children home," one of the parents said. This is not the first time the school admin received a bomb threat. Last year in

November, the admin received a similar email from an unknown sender. That was a hoax email

A senior police officer said person named Brijesh of The Indian School, BRT Road, informed them about the email. The school was evacuated as a precaution, he added.

Deputy Commissioner of Police (south) Chandan

Chowdhary said, "The school received the e-mail regarding the bomb threat at 10.49 am on Wednesday. They then informed the Defence Colony police station following which the security personnel reached the spot and immediately evacuated the school. "We deployed our bomb squads and also informed the Special Cell and the Special Branch. The SWAT team is also conducting searches inside the premises," he said.

Chowdhary further said that the police force has so far conducted two rounds of search and that the third round is underway

"We are looking for the source of the e-mail. In November last year, the school received a similar mail which was sent via a German server, he said. The DCP, however, said the e-mail threat appears to be a hoax.

Vigyan, a class 5 student, said he along with his classmates was evacuated from the school building and taken to the ground.

The Education department further said that temperature in Delhi crosses more than 40 degrees Celsius during the summer and that it is detrimental to the health of children and adolescents studying in schools.

"The rise in temperature in national capital has led to increased instances of heatrelated illnesses like exhaustion, dehydration, diarrhea and vomiting among citizens. Since children are one of the most vulnerable groups, all heads of schools under the are directed to adopt measures for circulating awareness and ensure protection of school children," the DoE circular stated.

There are 13.4 lakh registered construction workers in Delhi so far. At a review meeting with the labour department, the Kejriwal Government has identified a series of measures aimed at improving the lives

and welfare of these workers. Chief Minister Arvind Keiriwal has directed the officers to explore the possibility of providing each worker with a free bus pass, in addition to those who are already availing it. He asked the officials to discuss with the DTC whether the government can pay a standard charge for these passes on

behalf of the workers and they can get to use buses for free. "DTČ will earn revenue as well and workers will also get a free bus pass. We can active-ly persuade these workers to come and collect their bus pass. A lot of people do not even know of the schemes available to them," he said.

Kejriwal, also directed the labour department to reach out to over 13.4 lakh construction workers of Delhi and offer them free bus passes after

proper registration and verification with the Delhi Building and Other Construction Workers' Welfare Board. The Chief Minister has

also directed the department to assess the possibility of group life insurance for construction workers, similar to that provided for lawyers. The meeting was also attended by Labour Minister Raai Kumar Anand and other senior officials of concerned departments. The CM discussed various schemes and their current situation in the meeting with the officers.

The Chief Minister also directed the officials to assess whether a group life insurance can be implemented for construction workers by the government like it does for lawyers. The discussion then moved to Educational Schemes of the department.

Defence Minister Rajnath Singh on Wednesday stressed upon the need to devise innovative methods to maximise the value of money spent on the security needs of the country, terming a robust defence finance system as the backbone of a strong military.

Inaugurating the three-day International Conference on Finance and Defence Economics here, he asserted that a legal and procedural defence-finance framework is an integral part of a mature state system, which ensures prudent management of the defence expenditure.

Rajnath stated that such a framework, which includes expenditure control as per guidelines, financial advice by professionals, audit and pavment authentication mechanism ensures that the defence

Rajnath also emphasised on the role of expert financial advice to the Service personnel in day-to-day financial matters. He said, the system of Integrated Financial Advisor (IFA) has been created to provide financial advice to the Competent Financial Authority (CFA) in order to help them in avoiding the wastage of public money

In this system, the IFA and CFA work as a team towards utilising public money in a prudent manner, he said.

He batted for a fool-proof system of internal and external audit which would tackle the instances of wastages, pilferage and corruption, if any, even after following the principles of conscious way

financial prudence and propriety. The role of auditors is that of a watchdog or a sentinel, he said.

The three-day conference, organised by the Ministry of Defence (Finance), will witness the participation of eminent policy makers, academics and government officials from India and abroad, including from USA, UK, Japan, Australia, Sri Lanka, Australia, Sri Laika, Bangladesh and Kenya. T aunched with much fanfare way back in 2016, the Modi Government's pet project, Shyama Prasad Mukherjee Rurban Mission (SPMRM) has ended in a dismal note with just three clusters completed till January 31, this year against the goal of 300 clusters to be developed as rural growth centres having urban amenities and services. The completion deadline date was March 2020.

These three developed clusters are Revapar in Gujarat, Vevaji in Maharashtra and Aibawk in Mizoram

Stating that the other 270 clusters are at various stages of completion, the Rural

Development Ministry had sought Mission's extension to upto March 2024. But the Union Finance Ministry has refused permission as no allocation has been made in this year's budget.

It seems extremely difficult to complete the pendency within such a short span when the funds are available only till 15th March,

"It is a matter of concern that the goals for which the Scheme was mooted remain unfulfilled. Intermittent fasting may affect reproductive health: Study

Time restricted fasting, a type of intermittent fasting which is fast becoming fad among many as a weight loss strategy can have an adverse impact on the reproductive health of women and men, sometimes even leading to fertility problems, according to a study published in the journal Proceedings of the Royal Society B.

While intermittent fasting includes all intentional fasting patterns and doesn't distinguish between fasting during day or night, time-restricted eating calls for eating within a limited number of hours during daylight. To understand the effects of time-restricted fasting, researchers at the University of East Anglia in the UK, studied zebrafish (Danio rerio)



The findings showed that time-restricted fasting affects reproduction differently in male and female zebrafish. Once the fish returned to their normal feeding schedule, females increased the number of offspring they produced at the cost of egg quality resulting in reduced quality of offspring.

The quality of male sperm also decreased. The research team said that while the study was conducted in fish, their findings highlight the importance of considering not just the effect of fasting on weight and health, but also on fertili-

"Time-restricted fasting is an eating pattern where people limit their food consumption to certain hours of the day. It's a popular health and fitness trend and people are doing it to

lose weight and improve their health," said Prof Alexei Maklakov, from UEA's School of Biological Sciences. "But the way organisms respond to food shortages can affect the quality of eggs and

sperm, and such effects could potentially continue after the end of the fasting period," Maklakov said.

To find out what happens when individuals are exposed to food during and after a period of fasting, the team measured how males and females allocate resources to body maintenance versus production and maintenance of sperm and eggs, and the quality of the resulting offspring.

Strangely enough, Patole denied that there were any differences among the MVA constituents and accused the ruling Eknath Shinde-led Shiv Sena-BJP alliance for trying a wedge among the constituents of the three party Opposition front.

In a statement issued here, Patole said: "The MVA is strong. There are no differ-ences between its allies. Vajramuth rallies of Mahavikas Aghadi are being held across the state. After a successful rally at Chhatrapati Sambhajinagar, a rally is now being held in



Nagpur on April 16". "After the Nagpur rally, we plan to hold similar MVA rallies in Mumbai and other places," Patole said.

Alleging that the ruling Shinde Sena-BJP alliance "is scared of the growing popularity of the MVA", Patole said: "That's why the ruling alliance is spreading disinformation about there being differences in the

Alluding to the meeting held between Uddhav and Sharad Pawar at the latter's "Silver Oak" residence in south Mumbai, Patole said: "There is no need to draw any unwanted conclusions about the meeting between Pawar ji and Uddhavji last night. Leaders in MVA meet each other regularly. If anyone interprets this as a break-up in the alliance, then they are wrong."

"There is harmony in the Mahavikas Aghadi, even today we hold discussions with the leaders of all the parties. The opposition parties are afraid that the Mahavikas Aghadi

is strong, that is why the BJP is opposing the MVA from holding its meeting in Nagpur on April 16 by using one of its MLAs," Patole said

There should be a fight in politics. It is not new to me as I had fought against HD Deve Gowda in 1985, later against HD Kumaraswamy. My life is a struggle, I will continue to fight".

BJP Miniser Somanna belongs to the Lingayat community which has a large presence in Varuna, while Ashoka is seen as BJP's prominent Vokkaliga face, the community to which Shivakumar also belongs.



Petty politicking

The row around Amul in Karnataka underlines the dangers of widespread credulity and sentimentalism

f there is no dirty controversy hogging news headlines, our politicians create one. The one surrounding Amul's entry into Bengaluru's market is an example of such • 'creativity.' The history of Amul, a national milk cooperative brand, goes back to the British era. Nandini, on the other hand, is a popular brand of the Karnataka Milk Federation's (KMF). Nandini reportedly has close ties with Kannadiga identity. Karnataka's politicians, essentially those in the Opposition, have found it convenient to unctuously embrace the Nandini brand and, concomitantly, present Amul as an 'invader' which is determined to destroy native dairy products. The fact that Amul is based in Gujarat has helped Congress leaders to conjure up a conspiracy theory that Gujarati leaders (read Prime Minister Narendra Modi and Union Home Minister Amit Shah) are determined to destroy



a native brand. Congress state president DK Shivakumar compared Amul and Nandini, and found Nandini as the "better brand." His party colleague and former Karnataka chief minister Siddaramaiah went a step ahead and alleged that the Bharatiya Janata Party government in Karnataka was "destroying the state's pride." Unfortunately, politicians are the only people muddying the waters; the Karnataka State Hotels' Association also alleged that an "artificial scarcity" of Nandini products has been created in "favour" of Amul's entry in Karnataka. The fact, however, that scarcity is because of Nandini milk is far cheaper than Amul's, primarily because of the subsidy that the State Government gives to the local federation.

The State government correctly denied the allegations made by the rival Congress and Janata Dal (Secular), and accused them of transforming the matter "into a political issue ahead of elections." Apparently, Opposition leaders in the State have politicised Amit Shah's statement in December that he made at a rally in Mandya, "Together, Amul and Nandini will help set up primary dairies in every village of Karnataka within three years." When Amul announced last week that it would begin to sell milk and curd in Bengaluru, Opposition leaders were able to manufacture a conspiracy theory in which Amul is pitted against Nandini. A couple of points need to be made here. First, credulity has assumed alarming proportions in our country. Opposition leaders are able to peddle the more implausible of ideas in the political arena. Mirages appear real and myths look like well-known facts. Second, the 'ism' all politicians cutting across parties and ideologies believe and practice is sentimentalism. In this case, anti-BJP leaders have been able to further their political agenda by birthing and promoting the fake narrative of Kannadiga Nandine versus Gujarati Amul. It is perhaps the first time that Amul has been portrayed as a Gujarati brand. This is regrettable, for it is a premium Indian brand that has been giving global majors a run for their money. Such are the wages of petty politicking.



The Opposition doesn't measure up



At most times, the Opposition has been weak, divided and untrained in governance

he Emergency of June 1975 lasted till the general elections in early 1977. During that year and a half, there was an order without law in the country. That isn't so now and yet the Opposition keeps blaring that "democracy in India is in danger". Hosts on television discussions often say that they feel like second-class citizens these days. (One Dr Shama Mohammed said so on 8 April on NDTV).

The Emergency was imposed mainly in the Hindi-speaking states, with forced sterilization of men. The main targets were Muslim men.

The real problem is with the opposition; since the beginning of Independence. At most times, it has been weak, divided and untrained in governance. There is hardly any other political party that has a coherent ideology. A few of them, like the Akali Dal for example, have programmes, which is to retain their control over Sikh institutions. Tamil Nadu's DMK has hung on to its anti-Brahminism; the rest function according to ad hoc and opportunistic causes that come their way. The members of all such parties are more beholden to the street than the assembly halls of legislatures.

Most Indian politicians may never have heard of the concept of a shadow cabinet, which is very useful to the opposition party so that at least some members of the party have a working knowledge of subjects like foreign affairs, finance, defence etc. This would make it easy for the Opposition to oppose the government and not let it get away with an incorrect or inadequate policy. After an election that follows, if the opposition is able to participate in the formation of a cabinet in a new government, it would have several ready-made ministers who would be well-versed in their



a global phenomenon and it is difficult to name a country that is free of corruption". These utterances turned out to be a signal to India's politicians that politics can be a lucrative business. Come election time, a party begins by selling the application forms of party tickets to an MLA election. Thereafter, when the party is ready to distribute the tickets, each ticket attracts good money. The entire election expense is to be met by the candidate. Win or lose, at the end of the election, every party can hope to make a tidy profit.

As the lure of money shone more and more, the significance of talent, popularity, and political competence began to diminish and gradually disappear. The other consequence of increasing wealth led to parental compulsions of bequeathing one's political party to one's son or daughter. Can Indian democracy throw up ethnic alternatives? It seems difficult if not doubtful.

ommunity radio stations (CRS) in India are playing a crucial role in informing, educating and entertaining communities that have limited access to mainstream media. These stations are run and managed by local communities, NGOs, educational institutions, and other grassroots organizations.

They did commendable work during the pandemic by spreading awareness about it and how it could best be avoided. CRS routinely play programs on vaccination, nutrition, menstrual hygiene, and sanitation. They also promote literacy. They have also been instrumental in empowering women by having programs on women's health, education, and entrepreneurship. They provide a platform for women to share their experiences. Besides, they promote local culture and traditions by showcasing local talent and also conducting programs on local festivals and traditions. But unfortunately, most

of them struggle to remain on air due to a severe paucity of funds and resources. As they have to muster their own



resources, they rely heavily on government campaigns and ocal ads for funds. But of late the government funds are just not there. The proverb 'Beating around the Bush' fits apt to the government's approach to CRS. Why not take God's shelter and gain all kinds of benefits, which only he can grant?

few things only God can do. Yes, it is a fact that all of us should know. The first one is giving 'vardaan'. The English equivalent is a blessing, which is something good that you are thankful for. Boon is another word for it, which means a thing that is helpful or beneficial. Both of these meanings do not fully convey what vardaan is. Vardaan is what only God or His manifestations can give to deserving persons. Our scriptures have many details of vardaans being given by Lord Krishna to different persons.

Similarly, only God can grant liberation. A famous example is that of Lord Rama liberating Jatayu. Such liberated souls are freed from the painful cycle of birth and death. Lord Krishna speaks about this in many verses of the Bhagavad-Geeta. In verse #8.15, He states, "Those great souls, achievers of the supreme perfection, having attained Me, do not take rebirth in this impermanent place of miseries." The Lord also guides us about different ways to qualify for liberation.

Only God can forgive our sins. Arjuna was afraid that he would be guilty of many sins if he participated in the Mahabharat War. Lord Krishna assured him in these words, "I will release you from all sins. Do not worry." (18.66) And we know how knowingly and unknowingly we commit many sins. If we truly take shelter from God, He may forgive our sins. In verse #9.30, Lord Krishna assures, "Even if a person of very bad conduct worships Me with undivided devotion, he should be considered pious only, because he is now engaged properly."



The next power, which only God has, is about a change of our natures in a substantial way, otherwise, we are stuck with whatever we have been programmed with due to our past 'karmas'. For example, someone is very lusty, to begin with; he remains lusty for the rest of his life; our natures are so obstinate. Lord Krishna told Arjuna that he would engage in fighting, even though Arjuna was in denial, which ultimately Arjuna did. (18.59) In an earlier verse, the Lord had emphatically stated that people follow their natures. (3.33) One definitely needs help from God to subdue one's nature. The same is true about the appearance of 'karmaphalas' both good and bad. They are forever coming and going. (2.14) Only God can do something about them. He can, but He doesn't usually prevent them from coming, though we would wish that He stopped the bad ones. What God does is help us negotiate them better by guiding us if we take God's shelter. (18.58) Only God can do this, otherwise, our bad karmas run through their entire course. If God is especially merciful on us, He even changes people's minds in our favour. This favour only God can do and no one else. I get pleasantly surprised when an apparently inimical person becomes favourable. God even appoints His devotees as His 'nimitta' (instruments) to carry out specific tasks, just as Arjuna was chosen to play a decisive role in the Mahabharat War. This is a very special privilege because it means that God becomes 'karta' in our lives. When God is the doer then nothing is impossible. That is how miracles happen to surprise us. God and only God can guide perfectly because He alone knows the big picture, which includes the past, present and future in their entirety. Very fortunate souls are blessed thus because then they move in the right direction. When the direction is perfect, one is bound to get the best results in one's life. God surprises me to no end when He informs me about what only He could know about me, about which even I am unaware. Similarly, only God can alert us about impending dangers. God's powers are unlimited. Why not take His shelter and gain all kinds of benefits, which only God can grant?

Ambedkar's idea of cultural nationalism

He always insisted on 'spiritual and cultural unity' as the basis of modern nation-state formation



r Bhim Rao Ambedkar's work and philosophy were built on the sensibility of India's ethos, a passionate desire for India's Unity and cultural nationalism. He was one of the leading nation-builders of modern India as early as 1916, in his famed paper presented at an anthropology seminar at Columbia University, Dr Ambedkar made an observation that may well become the definition of what is today called "cultural nationalism" in the Indian context:

"It may be granted that there has not been a thorough amalgamation of the various stocks that make up the peoples of India, and to a traveller from within the boundaries of India, the East presents a marked contrast in physique and even in colour to the West, as does the South to the North. But amalgamation can never be the sole criterion of homogeneity as predicat-

ed of any people. Ethnically all people are heterogeneous. It is the unity of culture that is the

There are innumerable definitions given by various thinkers on Nation. Patterson defines Nation as, 'people, a folk, held together by some or all of such more or less immutable characteristics as common descent, territory, history, language, religion, way of life or other attributes that members of a group have birth on the ward' (Patterson 1975).

However, according to Sri Aurobindo, Nationalism is a religion that has come from God; Nationalism is a creed that you shall have to live. He elevated the demand for national freedom to a religious faith so that the masses could be awakened. His concept of nation was deeply influenced by Bankimchandra. He believed that the nation is not just a piece of land or a mass of human beings. Sri Aurobindo was convinced that imi-

Ambedkar contends Nationality is "consciousness of a kind, awareness of the existence of that tie of kinship" and nationalism is "the desire for a separate national existence for those who are bound by this tie of kinship". Ambedkar was never against the idea of Nationalism but against the Congress's version of Nationalism which entailed freedom of India from British Colonialism but not from caste hierarchy through which millions of scheduled castes had been yoked for hundreds of years. Ambédkar took up the question from the social below and elevated it to a political high by linking this social question of caste with the political question of democracy and nationalism.

According to Ambedkar "without social union, political unity is difficult to be achieved. If achieved, it would be as precarious as a summer sapling, liable to be uprooted by the gust of hostile wind. With mere political unity, India may be a State. But to be a State is not to be a Nation and a State, which is not a Nation, has small prospects of survival in the struggle for existence". He had faith in the spiritual aspect of Indian texts and codes but not in its ritualistic aspect which had developed in the last 1200 years. He talked about the "Annihilation of Caste not Dharma". He had the option of declaring himself an atheist but his rootedness in Indian ethos compelled him to choose Buddhism.

become the spiritual basis of social democracy.

The Constitution of India has abolished Untouchability. But what Dr Ambedkar had visualized, "If social conscious is such that it is prepared to recognize the rights which law chosen to enact, rights will safe and secure. But if the fundamental rights are opposed by the community, no law, no parliament, no judiciary can guarantee them in the real sense of the word," appears to be true.

Ambedkar argued that race, language and country do not suffice to create a nation. Quoting Renan, Ambedkar argued that: A nation is a living soul, a spiritual principle. Two things, which in truth are but one, constitute the soul, this spiritual principle. One is in the past, the other in the present. One is the common possession of a rich heritage of memories; the other is the actual consent, the desire to live together, the will to preserve worthily the undivided inheritance which has been handed down... (Ambedkar 1990: 35). On the day when the Constitution of India was to be finally passed, Ambedkar told the Constituent Assembly to have selfintrospection. He said: ... my mind is so full of the future of our country... On 26th January 1950, India will be an independent country. What would happen to her independence? Will she maintain her independence or will she lose it again?... It is not that India was never an independent country. The point is that she once lost the independence she had. Will she lose it a second time? What perturbs me greatly is the fact that not only India has once before lost her independence, but she lost it through the infidelity and treachery of some of her people. (Ambedkar 1994: 1213-14).

While talking about Nations, Ambedkar asserted that the realisa-TOWARDS tion of the fact that India was not a nation can be called the first step towards nation-building. According to him, "The sooner we realize that we are not as yet a nation...we shall realize the necessity of becoming a nation and seriously think of ways and means of realizing the goal" (Ambedkar 1994: 1217). Taking a clue from Renan who had sighted the case of the union of Northern and Southern France after a struggle of nearly a hundred years, Ambedkar emphasized forgetfulness as a second factor in the creation of a nation (Ambedkar 1990:36)

He emphasizes that Hindus need not "borrow from foreign sources" concepts to build a society on the principle of equality, fraternity and liberty. They "could draw for such principles on the Upanishads". Even in "Riddles in Hinduism" he points out that Hinduism has the potential to

SEBI pulls the plug on financial influencers

The role of social media platforms in abusing markets has been adequately underscored in an order passed by SEBI

Response to the termination of term age freelancer-influencer generation believes in providing simplified, concise and conclusive information. Simultaneously, the new age class of retail investors also wants quick money without having to do hours of market research. Over-simplification is the new complexity and those who capitalize on this ability control the narrative.

This issue surfaced again when SEBI heavily cracked down on YouTube influencers manipulating prices in March 2023. It barred about 44 entities from the Indian securities market via interim orders dated March 2, 2023

The crux of the regulator's clampdown revolves around

and profit-makers with YouTube creators. The false and misleading content was peddled by the creators as a part of a marketing campaign to trick innocent investors.

This helped generate artificial volumes in scrips of Sharpline Broadcast Ltd. and Sadhna Broadcast and book massive profits for certain shareholders.

This incident portrays how social media has democratized financial services at the click of a button. But, it can be misused as an open channel for mass manipulation and perilous ambitions of one man duping thousands of innocents.

The role of social media platforms in enabling market abuse has been adequately underscored in an order passed by SEBI in January

the collusion of promoters 2022 in Re. Stock Recommendations using Social Media Channel (Telegram). It is critical to delve into this case and understand the legal framework governing investor advisory on social media.

Present Legal Framework:

SEBI allows only authorized research analysts and investment advisers to provide financial advice. Such entities are governed under the SEBI (Intermediaries) Regulations 2008, the SEBI (Investment Advisors) Regulations 2013, and the SEBI (Research Analysts) Regulations 2014.

Consequently, any impersonation shall lead to a violation of the aforesaid regulations. Moreover, abusive market practices are prohibited under the provisions of the SEBI Act of 1993 and the SEBI

(Prohibition of Fraudulent & Unfair Trade Practices relating to Securities Market) Regulations 2003 ('PFUTP regulations'). Section 12 A of the SEBI

Act 1993 prohibits any such action of commission or omission relating to securities or issues, via any scheme or device amounting to deceptive practices, fraudulent trade practices, unfair trade practices or manipulative trade practices (collectively referred to as 'abusive market practices'). The provision intends to prevent malpractices in the finan-

cial market. Regulation 4 specifies acts amounting to abusive market practices. E.g.: misrepresentation of facts, misinformation inducing the sale or purchase

manipulation triggering fluctuations in prices for wrongful gain, circular trading, reverse trading creating artificial volumes, dubious synchronized trades, false corporate announcements, front running, insider trading, diversion of funds, cornering shares in issues, forged share certificates, misstatement of financials, delayed dematerialization, concealment or non-disclosure of client transactions.

It may be imperative to mention in this regard that SEBI also enhanced its powers to tackle unfair trade practices via amendments made to Regulation 4(2)(k) in January 2022. It extended the ambit of regulations to reckless dissemination of information likely influencing investment of such securities, market patterns under the ambit of

regulations. While it is permissible to discuss macro stock patterns on public platforms and social media, unsolicited advice on any closed subscription-based channels that are accessible only to limited members is prohibited; espe-cially by SEBI unregistered entities.

In the Telegram Investment Advice case mentioned above, SEBI noted how entities who lack basic minimum qualifications related to securities markets projected themselves as established investment advisors via social media. Such misleading advertisements entailed fake claims of combined experience of over 40 years in securities markets and that they are in process of seeking registration from SEBI. The tips given on the

channel were repetitively acted on by an increasingly large number of subscribers which created a gradual artificial boom in prices of thinly traded scrips leading to deepened belief in the recommendations. In a fast-paced digital age, social media influencing is an extremely impactful way of marketing and advertising. The securities market in specific is flooded with many fraudsters purporting to SEBI registered research analysts and investment advisors. A consequential issue that the market regulator faces in recent times is difficulty in monitoring the misuse of social media by fraudulent investment advisors. The risk amplifies tremendously when unsolicited advisories come from a celebrity.

China issues warning as US, **Philippines stage drills**

hina warned on Wednesday that Ca deepening security alliance between the United States and the Philippines should not harm its security and territorial interests and interfere in long-simmering territo-rial disputes in the South China Sea. When asked to comment on the combat exercises between American and Filipino forces that started on Tuesday in the Philippines, the Chinese Embassy in Manila on Wednesday issued a statement by Chinese Foreign Ministry spokesperson Wang Wenbin, who said that such drills "should not target any third party and should be conducive to regional peace and stability."

Wang did not say how China would respond if it concludes that the US-Philippine security cooperation was hurting Beijing's core interests

In Washington, the US and Philippine defence and foreign secretaries met on Tuesday to discuss the development of nine Philippine military camps, where American forces have been allowed to stay indefinitely under the 2014 Enhanced Defence Cooperation Agreement.

"These sites will support combined training exercises and interoperability between our forces to ensure that we're even better prepared for future crises," Defence Secretary Lloyd Austin said. He added the US was allocating

more than USD 100 million to build infrastructure at the sites, where Americans would be stationed.

China has strongly opposed that agreement, which would allow American forces to establish military staging grounds and surveillance outposts in the northern Philippines across the sea from the Taiwan Strait and in western Philippine provinces facing the disputed South China Sea, which Beijing claims virtually in its entirety on historical grounds. Washington disputes China's claims.

BEIJING (PTI): China on with both the US and China. Wednesday waded into controversy over French President Emmanuel Macron's comments in which he called for greater "European sovereignty" by not following the US policy over China and Taiwan.

"The question we need to answer, as Europeans, is the following: Is it in our interest to accelerate (a crisis) on Taiwan? No," Macron was quoted as saying in the interview after his recent visit to China during which he held extensive talks with Chinese President Xi Jinping in Beijing and later Guangzhou.

"The worst thing would be to think that we Europeans must become followers on this topic and take our cue from the US agenda and a Chinese overreaction," Macron said.

The comments were made last Friday before China launched largescale combat drills around Taiwan that simulated sealing off the island in response to the Taiwanese president's trip to the US last week.

Macron's comments raised questions over the EU's relationship

Indian-origin executives convicted on fraud charges

wo Indian-origin executives of a L Chicago-based start-up have been convicted by a federal jury in the US of running a USD 1 billion corporate fraud scheme that targeted the company's clients, lenders and investors. Following a 10-week-long trial, jurors on Tuesday found health technology company Outcome Health co-founder and former CEO Rishi Shah guilty on 19 of 22 counts, co-founder and former president Shradha Agarwal guilty on 15 of 17 counts and former chief operating officer Brad Purdy guilty on 13 of 15

counts. Shah, 37, was convicted of five counts of mail fraud, 10 counts of wire fraud, two counts of bank fraud and two

counts of money laundering. Agarwal, 37, was convicted of five counts of mail fraud, eight counts of wire fraud, and two counts of bank fraud, while Purdy, 33, was convicted of five counts of mail fraud, five counts of wire fraud, two counts of bank fraud, and one count of false statements to a financial institution.

The defendants face a maximum penalty of 30 years in prison for each count of bank fraud and 20-year imprisonment for each count of wire fraud and mail fraud.

Shah faces a maximum penalty of 10 years in prison for each count of money laundering. A sentencing hear-

ing will be scheduled at a later date.

A statement issued by the Justice Department said on Tuesday that the company installed television screens and tablets in doctors' offices around the US and then sold advertising space on those devices to clients, most of whom were pharmaceutical companies.

According to evidence presented at the trial, Shah, Agarwal, and Purdy sold advertising inventory the company did not have to Outcome's clients, then under-delivered on its advertising campaigns

Despite these under-deliveries, the company still invoiced its clients as if it had delivered in full.

Shah, Agarwal, and Purdy lied or caused others to lie to conceal the under-deliveries from clients and make it appear as if the company was delivering advertising content to the number of screens in the clients' contracts.

Purdy and others at the company also inflated metrics that purported to show how frequently patients engaged with the company's tablets installed in doctors' offices.

According to the trial evidence, the scheme targeting the company's clients began in 2011, lasted until 2017, and resulted in at least USD 45 million of overbilled advertising services.

Shah, Agarwal, and Purdy were also convicted of defrauding the company's lenders and investors

During the meeting, the finance minister noted IMF's concerns on key downside risks to the economy including financial sector stress, rising real interest rates, elevated debt,

inflation, geo-political frag-mentation, and faltering growth in China, as highlighted in World Economic Outlook World Economy Outlook.

World Economy Outlook. Sitharaman acknowledged IMF's support to the G20 Presidency of India in the form of inputs towards developing evidence-based policy guid-ance, the ministry said. India assumed the

Wickremesinghe and his state finance minister Shehan Semasinghe will also join the in-person live streaming.

Global company can't think about growth without India: FICCI head

Washington (PTI): A series of reforms undertaken by the government coupled with efforts aimed at making it eas-ier to do business has made India a land of opportunities, a top Indian industrialist has said, asserting that no global company can think about growth without India being a

part of its plans. Subhrakant Panda, presi-dent of the Federation of Indian Chambers of Commerce and Industry (FICCI) said India is where it is today because of a couple of factors, including sustained reforms even during

the Covid-19 pandemic. 'You cannot think about growth without India being in your plans.

It's as simple as that. But if were to expand on that a little bit more, where else in the world would you find an opportunity where you not only have a large unified domestic market, but also the resources to produce not just for the domestic market, but use it as an export base," he told PTI on Tuesday.

Poll funds: Pak SC asks officials to appear before it on April 14

Cash-strapped Pakistan's Supreme Court on Wednesday ordered top officials to appear before it on April 14 with relevant records to show why funds were not released for holding snap elections in Punjab and Khyber Pakhtunkhwa despite clear instructions.

The apex court last week ordered the federal govern-ment to provide Rs 21 billion to the Election Commission of Pakistan (ECP) by April 10 to enable it to organise polls in Punjab and Khyber-Pakhtunkhwa. It also asked the election body to submit a report about availability of funds on April 11.

However, instead of releasing the funds, the government introduced a bill in the parliament to authorise the release of required funds for the ECP to elections.

It is not clear so far if the government succeeded to implement the court orders regarding provision of finances or if it was just an effort to delay the release of funds to influence the ECP. Elections are due to be held on May 14 in Punjab but the date for the Khyber Pakhtunkhwa elections has not been decided as yet.

Following the instructions, the ECP submitted its report on the specified date, informing the court about the government's reluctance to issue the amount needed for elections. The court issued notices to

the finance secretary, head of the State Bank of Pakistan (SBP), Attorney General and the ECP over the government's failure to disburse the sum and asked the officials to appear in

court on April 14. The SC registrar in the notice stated that the court noted that the ECP had stated that no funds were released and provided to it.

"The failure of the federal government to comply with the order of the court as aforesaid is prima facie disobedience," according to the notice.

"The consequences that can flow from such prima facie defiance of the court are well settled and known...Every person who embarks upon, encourages or instigates disobedience or defiance of the court can be held liable and accountable," the notice pointed out.

"The question of the provision of funds for such a vital constitutional purpose is something that requires immediate attention which takes priority over proceeding against those who may have committed con-

Islamabad (PTI): The IMF has lowered its forecast for Pakistan's economic growth rate from 2 per cent to just 0.5 per cent for the current fiscal year, amid high inflation and a growing unemployment rate in the cash-strapped

country. This showed an unambiguous deterioration of economic fundamentals over the last six months since October when the IMF forecast the country's gross domestic product to grow by 3.5 per cent against 6 per cent for 2022 ago and inflation at 20 per cent against 12.1 per

The revision in Pakistan's growth prospects is in line with similar 0.4 per cent and 0.6 per cent projected last week by the World Bank and the Asian Development Bank, respectively. They also projected inflation at 29.5 per cent and 27.5 per cent respec-tively for the current year, the Dawn newspaper reported on Wednesday.

Revised gas pricing formula to aid demand, profit stability for producers: Fitch

The government's decision to limit prices of domestic natural gas from legacy fields to between USD 4-6.5 per million British Thermal Unit (mmbtu) will support margins for city gas distributors, encourage the use of gas, and reduce cash flow volatility for upstream producers, Fitch Ratings said on Wednesday.

"We expect a partial passthrough of the lower administered price mechanism (APM) gas prices, at which domestic upstream producers supply gas to city gas distributors, in the prices of compressed natural gas (CNG) and domestic piped natural gas (PNG) to add to the distributors' margins in the near term," it said in a statement.

City gas retailers like Indraprastha Gas Ltd and Adani Total Gas Ltd last weekend announced Rs 6-8 cut in CNG and PNG prices, reflecting the cut in input gas prices

The APM price under the new regime was calculated at USD 7.92, but is capped at USD 6.5 for the rest of April, 24 per cent below levels in October 2022-March 2023.

"We expect such price cuts by city gas distributors and the fixing of a price ceiling to add certainty to domes-

tic natural gas' price advan-tage relative to alternative fuels, supporting gas usage for transportation and households, and overall demand in the medium term," Fitch said The revised mechanism

dovetails with India's target of increasing natural gas' share in its energy mix.

We expect the price floor and ceiling to reduce the volatility in cash flows from gas production for Oil India Limited (OIL) and Oil and Natural Gas Corporation Limited (ONGC). The floor is higher than APM prices over 2015 to 2021 while the ceiling is below current market prices," it said.

Gas sales accounted for 9per cent of OIL's and ONGC's standalone revenues in the financial year ended March 2022 (FY22), and the legacy fields account for the majority of their gas production

Financial buffers built by OIL and ONGC over the last 18 months, when industry conditions were favourable. will help them to absorb the near-term reduction in APM prices, Fitch said, adding that it expects the cut in gas prices

to ease inflationary pressure in the economy, with domestic gas accounting for 55 per cent of India's gas consumption in the first nine months of 2022-23 fiscal.



Erling Haaland scored his 45th goal of the season as Man-chester City took a commanding 3-0 lead over Bayern Munich from their Champions League quarter-final, first leg on Tuesday.

Rodri and Bernardo Silva were also on target for the English champions, who took a giant stride towards finally conquering Europe for the first time. Victory was sweet for City boss Pep Guardiola as he came up against his former club for the first time since leaving Bayern for Manchester in 2016, but he warned that the job is not yet done.

"I've been three years there and I know in Europe this team is special. To knockout these type of teams you have to make two good games not just one," said Guardiola.

"I know exactly what we have to do there, They are capable to score one, two, three goals. We have to do our game with huge personality."

City also partially settled a Champions League score with Bayern boss Thomas Tuchel, who beat Guardiola's men to lift the trophy as Chelsea manager in the 2021 final. Tuchel was appointed less than three weeks ago by the German champions with one eye on this tie and he believed his side deserved more

"I try to not allow my players to focus on the result because it is not the deserved result, it does not tell the story of this match," said Tuchel.

"I've seen so many good things that I refuse to just focus on the result. You may say 'that's not Bayern' but I was very proud on the sideline, we were courageous and showed the right character."

City fought off interest from Bayern among other European giants to win the race to sign Haaland a year ago for nights like this and the Norwegian played his part in a clinical performance.

Haaland uncharacteristically fluffed his lines with the first big chance of the game when his weak shot was straight at Yann Sommer.

At the other end, City were grateful to a brilliant block from Ruben Dias to prevent Jamal dent.

Man Utd bidding process goes to third round

Rival bidders for Manchester United have been invited to submit a third offer by the end of April, according to reports.

Qatari banker Sheikh Jassim Bin Hamad Bin Jassim Bin Jaber Al Thani and British billionaire Jim Ratcliffe both submitted a second bid for the Premier League club last month.

Several offers are understood to have been received in recent weeks but Sheikh Jassim and Ratcliffe remain the front runners to buy United should the Glazers give up control of the club they bought in 2005 for $\pounds790$ million (\$980 million).

United's unpopular owners announced in November they were conducting a strategic review, with the sale of the club one option being considered.

The Qatari group has reportedly made an offer of about £5 billion for 100 percent ownership of the club while Ratcliffe, a boyhood United fan, wants to buy the combined Glazer shareholding of 69 percent.

The Americans' asking price is believed to be around \$6 billion — a figure that would make the 20-time English champions the most expensive sports club in history.

Alejandro Garnacho and Luke Shaw remain sidelined for Thursday's match against the Spaniards but Casemiro is available after serving a ban.

The Brazil midfielder's return provides a welcome boost - Sevilla are enduring a tough domestic campaign but have won the Europa League a record six times.

Their most recent triumph came in 2020, when they beat United in a one-legged semi-final behind closed doors in Cologne.

"They have a big reputation winning the Europa League," Ten Hag said.

Djokovic, Tsitsipas advance in Monte Carlo PTI 🗖 ASTANA

Novak Djokovic made a winning return to competition in the Monte Carlo Masters on Tuesday but was made to work by his 198th-ranked Russian opponent as two-time defending champion Stefanos Tsitsipas advanced when his rival retired injured.

Djokovic is back on court after failing to get a waiver to enter the United States for last month's Indian Wells tournament and Miami Open due to his anti-Covid vaccination stance.

The world number one was in danger of losing the opening set against Russian qualifier Ivan Gakhov before easing through 7-6 (7/5), 6-2 in 1hr 47min.

"I had never seen him play before today, and it's always difficult to face an opponent you don't know," said the Serbian, a winner on clay in Monte

Carlo in 2013 and 2015.

Favourite for a third crown in the Principality in the absence of Rafael Nadal and Carlos Alcaraz, Djokovic will face either 21st-ranked Lorenzo Musetti or Luca Nardi, 159th, both Italian, for a place in the quarter-finals.

Tsitsipas advanced to the third round after Frenchman Benjamin Bonzi retired with a left wrist issue after just 22 minutes, trailing the Greek 4-1 in the first set.

World number three Tsitsipas next meets either Chilean Nicolas Jarry, ranked 58, or Australian Alexei Popyrin, 94th, for a place in the quarter-finals.

Djokovic is tuning up for a 23rd Grand Slam bid at the French Open. But the game was not as easy as expected with Gakhov taking the first break lead 4-3.

Djokovic broke back immediately, but could not prevent the tie-break

The second set was one-sided even though Gakhov hung on until the end.

"It was probably, if you can call it this way, an ugly tennis win for me today," said Djokovic, who is looking for a record-extending 39th ATP Masters title this week.
