Delhi Police files 2 FIRs on wrestlers' sexual assault plaint; SC orders protection to minor victim

The Delhi Police on Friday registered two FIRs in connection with sexual harassment allegations levelled by women wrestlers against Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh.

The first FIR pertains to allegations levelled by a minor which is registered under the Protection of Children from Sexual Offences (POCSO) Act along with relevant sections of the Indian Penal Code concerning outraging modesty, a police officer said

# WFI chief Brij Bhushan File hate speech FIR even sans plea, SC orders States

Book such persons to preserve secular fabric of Bharat, or face contempt: SC

The Supreme Court on Friday directed all States and Union Territories to register cases against those making hate speeches even without any complaint, terming these speeches as a "serious offence" capable of affecting the secular fabric of the country. Extending the scope of its

2022 order beyond three States — Uttar Pradesh, Delhi and Uttarakhand — a bench of Justices KM Joseph and BV Nagarathna also made it clear to authorities that any hesitation to act will be viewed as contempt of the top court and appropriate action will be taken against the erring officers.

The bench ordered the Directors General of Police of

all States and UTs to issue direction(s) to their subordinates so that appropriate action

in law is taken at the earliest.

"We make it clear that any hesitation to act in accordance with this direction will be viewed as contempt of this court and appropriate action will be taken against the erring will be taken against the erring officers. We further make it clear that such action will be taken irrespective of the religion that the maker of the speech or the person who commit such act belongs to, so that the secular character of Bharat as is envisaged by the Preamble, is preserved and protected," said the apex court, adding that hate speech attracts offences such as Sections 153A, 153B and 295A and 505 of the IPC.

The top court's order came on a plea filed by journalist Shaheen Abdullah, who had initially sought direction against the Delhi, Uttar Pradesh and Uttarakhand Governments to register cases against those delivering hate speeches. Abdullah, represented through advocate Nizam Pasha, on Friday filed a fresh application seeking



implementation of the apex court's October 21, 2022 order across States and UTs and appointment of nodal officers in every State, who will recommend action against those making hate speeches.

Senior advocate Sanjay Parikh, appearing for the Maharashtra chapter of NGO PUCL, said despite the SC's order, incidents are happening across the State and the police is not taking action against those giving hate speeches in public functions, which are being attended by Members of Parliament and MLAs Parliament and MLAs.

The bench said that it is precisely what the court has said on the very first day of the

hearing of the matter that the Supreme Court cannot go into every incident. We have laid down a

broad framework and now it is up to the authorities to act upon it. We cannot monitor each and every incident," Justice Nagarathna said. Solicitor General Tushar Mehta, appearing for the Centre, said no government

### report from SC, court nixes order **Developments occur**

Hours after the Supreme Court asked the Calcutta High Court acting chief justice to reassign the West Bengal school jobs "scam" case to another judge after examining a report on Justice Abhijit Gangopadhyay's interview to a news channel about the matter,



the HC judge sought the report submitted before the CII against him.

Soon the Supreme Court swung into action and in a hearing late on Friday evening, stayed his order that directed the Supreme Court Secretary General to produce the report and official transcript of an interview the HC judge had given to a news channel

The SC directed its Secretary General that Justice Gangopadhyay be conveyed the top court's order. "The order of present nature ought not to have been passed in judicial proceedings keeping in view the judicial discipline. We hereby stay the order passed by the High Court judge in the suo motu proceeding. We direct the Secretary General of the Supreme Court to communicate this order to the Registrar General of Calcutta High Court forthwith who shall communicate the same to the High Court judge," said the SC.

### **IMD** begins issuing heat index for parts of country

¬he India Meteorological Department (IMD) on Friday started issuing heat index for different parts of the country on an experimental basis, taking into account the air temperature and relative humidity. IMD also said there is a good chance that a moderate El Nino might emerge during the June-September monsoon season. The department was, however, circumspect about its impact on the disruption of rainfall.

In addition to giving the day's minimum and maximum temperatures, the heat index, mainly for the plains, will give people "a sense of what the temperature actually feels like". "We are utilising the temperature and humidity data at 2:30 pm for the heat index and the

IMD Director General Mrutyunjay Mohapatra said at a Media Workshop on Weather and Climate. Currently, the weather office uses a formula of the National Oceanic and Atmospheric Administration (NOAA) to calculate the heat index.

However, the heat index is yet to be validated for Indian conditions and uses the comfort levels of weather experienced by Americans in their regions."We have to work with the health ministry to validate the observations for Indian

For example, in India, 40 degrees Celsius temperature and 20 per cent relative humidity could be okay, but the same is intolerable for a person residing in the US," said M

Ministry of Earth Sciences.

The heat index issued by the IMD on Friday carried a disclaimer stating "not validated for India", making it clear that it was an experimental forecast to educate people about the implications of heat on them.Ravichandran said the index will be issued to make such data more accessible to the public for precautionary measures.

The heat index will be issued for the entire country every day in weather bulletins. The weather office declares a heatwave when the maximum temperature crosses 40 degrees Celsius and is 4.5 degrees above normal for the day. A severe heatwave is declared when the temperature is above 40 degrees Celsius and 6.5 degrees above normal.

Abody representing Indian Administrative Service (IAS) officers in Madhya Pradesh on Friday expressed deep concern and anguish over the release of gangster-turned-politician Anand Mohan, who was serving a life sentence for killing a district magistrate in Bihar three decades ago, after the Nitish Kumar government

tweaked jail rules. Mohan, a former Lok Sabha MP, was released from Bihar's Saharsa jail on Thursday morning after being behind bars for 15 years for the murder of G Krishnaiah, the then-district magistrate of Gopalganj who was beaten to death by a mob in Muzaffarpur district in 1994. The 69-year-old gangsterturned-politician was convict-

ed for the IAS officer's murder in 2007. Mohan's name figured in a list of more than 20 prisoners who were ordered to be set free by a notification issued by the Bihar government's law department earlier this week.

His remission of sentence followed an amendment of Bihar Prison Manual, whereby the restriction on early release of those involved in killing of a public servant on duty was done away with. "The decision (to change jail rules and facilitate Mohan's release) will adversely affect the morale and fortitude of each and every public servant," the association's secretary, Vivek Porwal, told PTI. The association unanimously disapproves of this decision and urges the state government concerned (Bihar)

The bench also directed the Delhi Police Commissioner to make an assessment of the threat perception to the grapplers and provide adequate security to one of them who is a minor. The girl is an alleged victim of sexual assault. In its order, the apex court noted the Solicitor General told the bench that since the allegations indicate commission of cognisable offence, the police have decided to register an FIR. It noted senior advocate Kapil Sibal, appearing for the wrestlers, placed or record an affidavit in a sealed cover apprehending threat to the safety of the minor girl, an alleged victim of sexual assault.

Bearing in mind the content which has been placed on record, we direct the Commissioner of Police, Delhi, to make an assessment of the threat perception and provide adequate security to the minor girl involved," the bench said. It directed that an affidavit be filed before the apex court on or before May 5, the next date of hearing, about the steps taken for the security of the minor girl. Sibal told the court there are seven complainants and all of them must be given protection. The bench said its direction for providing security to the alleged minor victim shall not stand in the way of the Commissioner of Police to make independent assessment of the threat perception of the other complainants.

### Sisodia's bail plea in excise case rejected

The court denied the relief noting the "serious nature of allegations made and role played by Sisodia in the criminal conspiracy, his connection with the activities relating to generation or acquisition and use etc. Of the proceeds of crime...And the oral and documentary evidence collected in support of the same."

"Hence, this court is not inclined to grant bail to the applicant in this case of economic offences having serious repercussions upon the general public and society at large as the evidence collected during investigation speaks volumes of his involvement in commission of the said offence," the judge

He said that the medical illness of Sisodia's wife was also not a ground to enlarge him on bail in this case. The court further said that the possibility of Sisodia influencing prime witnesses could not be ruled out. The judge noted that the offence alleged against Sisodia was a "serious economic offence of money laundering" and he has not been accused of commission of the said offence in his individual capacity, but committed it in his official capacity of a public servant holding the charge or portfolio of Excise Ministry as well as being the Deputy Chief Minister of Delhi. Again, the allegations made in the case are found to be serious from another angle, too, as huge proceeds of crime in crores of rupees are alleged to have been generated or processed through different activities, he said.

'The seriousness or gravity of the offence and its nature or category, the capacity of applicant in which was committed, the manner of its commission and also certain other factors like impact of the offence as well as the possible impact of release of applicant on society etc. Are the factors which go against the applicant and force this court to decide against his release on bail in the present case," the judge said.

The judge said it emerged from the evidence that Sisodia was connected with generation of proceeds of crime of around Rs 100 crore in the form of advance kickbacks, which were paid by the 'south-lobby' to coaccused Vijay Nair through co-accused Abhishek Boinpally, the meetings held with different conspirators and stakeholders in liquor business and the amount was received by him on behalf of Sisodia and his other political colleagues for extending undue pecuniary benefits to the conspirators and members of the cartel.

The judge noted that cartel was permitted to be formed by manipulation of some provisions of the excise policy and by insertion of some favourable clauses therein for the benefit of conspirators. The judge had reserved the order after hearing arguments on Sisodia's plea seeking relief claiming that his custody was no longer required for investi-

Reacting on the court order, Delhi BJP president Virendra Sachdeva has said that the repeated efforts made by Sisodia to get bail are proved futile and he is not getting bail in any case shows that the investigation agencies' case against Sisodia is strong and the evidences of CBI and ED are solid strong. Sachdeva said that Sisodia's case has also become somewhat similar to

When her son did not return home till 7 P.M., the family members began a search for him."I enquired with my son's friends who said he was seen standing in line while leaving the school but did not accompany them. Then I called up his teacher

who said all the students had left school around 6:30 P.M. and early this morning, we got to see his body with multiple injuries. I can't see my son in this state. He was brutally killed," the mother alleged.

These projects include the Sarai Kale Khan-T junction flyover, the doubling and expansion of the flyover from Punjabi Bagh to Raja Garden, a six-lane flyover Garden, a six-lane flyover between Anand Vihar and Apsara Border, a double-decker flyover at the Ghonda-Brijpuri junction, and the Mukarba Chowk underpass, among other important projects. PWD Minister Atishi, on Friday, reviewed the progress of various flyover projects currently underway in Delhi with senior officials of the depart-

After the reviewing ongoing 30 infra project, the PWD Minister said these projects are extremely important for making traffic smooth and after their completion, lakhs of daily commuters will be rid of traffic. ### 40 Covid-19 related deaths recorded in Delhi from Apr 19-27

A t least 40 COVID 19-related deaths have been recorded in Delhi from April 19 to 27, with experts saying the infection is turning serious mostly in elderly patients and those with comorbidities. The medical experts also said though the number of daily cases in absolute numbers is still not low, the count needs to monitored over the next few days, before one can say if a downward trend has set in or

Delhi reported seven Covid-related fatalities for the second consecutive day on Thursday and 865 fresh cases of the viral disease with a positivity rate of 16.9 per cent. With the new cases and fatalities, the national capital's Covid caseload has climbed to 20,37,061, while the death toll stands at 26,620, according to data shared by the city government's health department.

Of the seven fatalities reported on Thursday, COVID-19 was the primary cause of death in three cases, the department said in a bulletin. On Wednesday, Delhi registered 1,040 cases with a positivity rate of 21.16 per cent and seven fatalities, with Covid being the primary cause of death in three cases.

During the April 19-27 period, the city health department did not issue a bulletin on April 21. In this period, the city registered six Covid-related fatalities each on April 19, 22

### Noida boy posts prank suicide video on Insta; cops get him counselled

¬aking note of a social media Taking note of a social line post, alert police in Uttar Pradesh's Noida rushed to save a schoolboy who posted a "suicide" message only to find that his act was a prank. The Gautam Buddh Nagar

police commissionerate's social media cell had come across the "suicide video" by a Class 10 student on Instagram and took help from Meta, the parent company of Instagram, to trace the boy's location.

Additional Commissioner of Police (Central Noida) Rajeev Dixit said the incident took place around 1.30 AM on April 26. "The local Phase 2 police station was alerted by Gautam Buddh Nagar police headquarters about a boy putting a suicide video. The Meta headquarters helped in tracing the location of the boy," Dixit said.

"On getting the inputs, the local police immediately reached the spot and found the boy. However, it turned out that video of him consuming the liquid of All Out (mosquito repellent) but in reality he had consumed water which he had



filled in an empty All Out vaporizer," the police officer

When the police interacted with the boy, he told them he had done this to get more viewers on social media, Dixit said. As per the rules, the boy was sent for a medical examination and later handed over to his family after counselling, he said. "His family members have been urged to ensure continued counselling of the boy," he

While the incident turned out to be a prank, there have been episodes in the past in which the police have been able probable suicide cases on the basis of social media monitor-

A recent example in Noida

was seen on March 18, when the police saved a 20-year-old man who had posted a picture on Instagram that showed a

noose along with caption "everything will get over". In March 2022, UP police entered into agreement with Meta, the parent company of Facebook and Instagram, on real-time sharing information linked to social media posts related to suicide or self harm.

"If any person posts something related to suicide or selfharm on Facebook or Instagram, then Meta headquarters in USA immediately sends an alert to the social through phone and email," a senior officer said in February, recounting how the agreement has helped save multiple lives.

She said, "The poor state of cleanliness in the school reflects the insensitive behavior of the school administration toward the future of the children studying here, and such carelessness regarding education cannot be tolerated." She gave an ultima-

Reprimanding the principal for the poor state of the school, Ms. Atishi said, "It is the duty of the principal to ensure that all children receive quality education in a clean and safe environment in the school However, looking at the condition of the school, it is clear that the school administration is insensitive to the future of the children studying here."

### Stations of first regional rail RAPIDX to sport peacock hues

Inspired by our national bird, the stations of India's first regional rail - RAPIDX - will wear a blue and beige colour spectrum of the peacock feath-

The National Capital Region Transport Corporation (NCRTC) is soon going to operationalise the 17 km long priority section of the Delhi-Ghaziabad-Meerut corridor for the public ahead of schedule.

According to an official statement, the colours of the station's exterior facade have been inspired by the hues of peacock feathers. The facade structure is coloured in two shades of blue and beige. The exterior roofs of its stations are designed to be curved on both sides to depict the speed, which is one of the main characteristics of this train.

The beige-coloured perforated panels have been installed for the wall of the stations and in addition to that, beige-coloured louvres have also been installed along the railings which ensure uninterrupted flow of air in the station, it said.



"The façade has been conceptualised from the station's concourse level itself. The stations also have foot-over bridges built under multimodal integration which will also be painted in the same colours," it added.

Instead of making the entry and exit of the station on the main carriageway, a dedicated passage has been made for passengers on both sides of the road. ### Post panel meet, Delhi, Hry officials to coordinate to rejuvenate Yamuna

In a move to rejuvenate the Yamuna river, officials of Delhi and Haryana will coordinate among themselves to enhance the impact of the efforts being made at the government level

The statement from Delhi Lieutenant General VK Saxena's office said officials of the two States on Thursday attended the meeting of a highlevel committee set up by the National Green Tribunal for the

rejuvenation of the river.

The meeting came following several rounds of discussions between Delhi L-G VK Saxena and Harvana Chief Minister ML Khattar.

Saxena, who chaired Thursday's meeting described the rejuvenation of the Yamuna river as a national mission and asked officials of the two States to proactively cooperate to achieve the goal.

It was decided that Haryana officials will attend the meetings of the high-level com-



mittee and carry out directions in coordination with their Delhi counterparts, the statement said.

The meeting saw discussions being held on various aspects of pollution in the Yamuna river in Haryana and Delhi. Saxena thanked Haryana Chief Minister Khattar for his proactive support and instructed officials to evolve seamless coordination by undertaking

The participants of the meeting were of the view that

concerted efforts were required by both states as any action taken by only Delhi was insufficient since continued pollution from sources in Haryana made the exercise futile.

The second batch of 246 Indian evacuees arrived in Mumbai in a C-17 Globemaster aircraft the next day. The total number of Indians who were brought back home now stands at 998, according to official data.

### Day after Rajnath's tough message, China terms situation at LAC 'generally stable'

day after Defence Minister Agjnath Singh's tough message to China that its violation of the border pacts has "eroded" the entire basis of bilateral ties, Beijing on Friday said the situation at the border is "generally stable." It also said both the nations should put the boundary issue in an "appropriate position" and promote its transition to "normalized management."

This reaction came after Rajnath on Thursday told his Chinese counterpart General Li Shangfu in a 45-minute meeting in New Delhi that development of relations between India and China is premised on prevalence of peace and tranquility at the borders.

He added that all issues at the Line of Actual Control(LAC)need to be resolved in accordance with existing bilateral agreements and commitments. Rajnath reiterated that violation of existing agreements has "eroded" the entire basis of bilateral relations and disengagement at the border will logically be followed with de-escalation. The Chinese Defence Minister was in national capital to attend the Shanghai Cooperation



Organisation (SCO) Defence Ministers' Meeting. Rajnath reportedly did not shake hands

A Chinese Defence Ministry statement issued in Beijing on Friday said that during the meeting the two sides exchanged views on militaries and bilateral relations.

General Li pointed out that "currently, the situation on the China-India border is generally stable and the two sides have maintained communication through military and diplomatic channels."

'The two sides should take a long-term view, place the border issue in an appropriate position in bilateral relations, and promote the transition of the border situation to normalised management," he said.

"It is hoped that the two sides will work together to continuously enhance mutual

trust between the two militaries and make proper contributions to the development of bilateral relations," Li told

The Chinese defence minister said as major neighbouring countries and important developing countries, China and India share far more common interests than differences.

"The two sides should view bilateral relations and each other's development from a comprehensive, long-term and strategic perspective, and jointly contribute wisdom and strength to world and regional peace and stability", he said.

Sources in New Delhi said Rajnath conveyed to Li that after disengagement in remaining friction points in eastern Ladakh, there should be a movement towards de-escalation and expressed hope for a "positive response".





## **Cops cane protesters trying** to stop soil test for refinery

The ongoing agitation against the proposed Ratnagiri Refinery & Petrochemicals Project (RRPL) at Barsu in Rajapur taluka of coastal Ratnagiri district took a violent turn on Friday, as the police resorted to lathi-charge and burst tear-gas shells to disperse the protesters who attempted to stop the soil testing survey work in one of the affected villages. Shiv Sena (UBT) MP Vinayak Raut was detained when he attempted to go near the areas where the soil testing work was on.

Trouble broke out on the fifth day of the agitation, after 400-odd villagers, including a sizeable number of women, surged towards members of the RRPL team in an attempt to stop them from carrying out the soil testing work. The police prevented them from going ahead, lathi-charged some of the protesters and burst teargas shells to quell the crowds.

Though some villagers were reportedly injured in the lathi-charge, details were not immediately available as to the exact number of injuries. Following the police action in the afternoon, the leader of the protesters Kashinath Gorle announced the suspension of their agitation for three days.

Among other things, the protesters asked the RRPL teams to stop the soil testing work for three days. They also demanded that the cases filed against some of the agitators be withdrawn and those arrested be released immediately.

The local police, who have enforced prohibitory orders in the affected villages surrounding the proposed project site where the soil testing work is



currently on, claimed that they merely dispersed the protesters when attempted to prevent the soilo testing teams from carrying out their work. However, Inspector General of Police Pravin Pawar claimed that no lathi-charge took place as claimed by the villagers. He said that the police jostled with the villagers who tried to surge towards the soil testing teams. He said that in the minor scuffle that took place, a few women constables were injured.

Interacting with media ons in Mumbai, persons in Maharashtra chief minister Eknath Shinde also denied reports of lathi-charge on the protesting villagers. He reiterated that the state government would not allow the start of the project work till it took the affected villagers into confidence. ### Incongruous

The BJP should listen to the concerns of the wrestlers protesting in the national Capital

he Delhi Police's decision to register an FIR against Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh could have come sooner. He has been accused of sexually harassing seven female wrestlers, including a minor. The fact that the matter had to reach the Supreme Court doesn't show the Bharatiya Janata Party or Delhi cops in a good light. Top wrestlers had to stage a protest in the national capital to get the FIR filed. On April 26, the Delhi Police had informed the SC they needed to carry out a preliminary inquiry before registering an FIR over the accusations. Delhi cops' U-turn, however, has failed to mollify the protesting wrestlers; they want Singh's arrest. Meanwhile the episode has once again brought PT Usha, the iconic athlete who heads the Indian Olympic Association, into the limelight—but not in a nice way. She did her country in her heyday, but by slamming the protesting



wrestlers she did not cover herself in glory. Her remark that Vinesh Phogat, Bajrang Punia, Sakshi Malik and other leading grapplers brought a bad name to Indian sports was not in good taste. She said that shortly after the IOA announced the setting up of a three-member ad-hoc committee to run the affairs at the WFI. "Thoda toh discipline hona chahiye (there should be some discipline). Instead of coming to us they have gone straight to the streets. It's not good for sport," Usha added.

Her caustic remarks were resented by the wrestlers and elicited sharp reactions from politicians and sportspersons. Congress MP Shashi Tharoor and Shiv Sena (UBT) MP Priyanka Chaturvedi slammed

Usha. Legendary sports persons like Kapil Dev and Neeraj Chopra supported the wrestlers' cause; this support also amounted to oblique criticism of Usha's. Brij Bhushan Sharan Singh's political clout in a few districts in Uttar Pradesh is said to be his shield. The BJP doesn't seem to like the prospect of losing influence in these areas. His association with the BJP is very old, going back to 1991 when he got the BJP ticket for the Lok Sabha seat for the first time. But he is more of an opportunistic politician than a leader committed to the ideology of the saffron party. Though he got elected as MP five times on the BJP ticket, in 2008 he joined the Samajwadi Party. Besides, his bahubali image and his stewardship of the WFI are at odds with the narrative of 'no danga, no curfew' that the Yogi Adityanath regime in the country's largest state is trying to peddle to people. He was charged with the Terrorist and Disruptive Activities (Prevention) Act or TADA for allegedly sheltering Dawood Ibrahim's aide Subhash Thakur, though he was later acquitted. This is not exactly the profile of a leader the BJP would like to sell to the electorate. No political party can ignore the realpolitik imperative, but then it cannot be seen as completely cynical too. It is time the BJP showed to the country that its commitment to morality is real.

# No tears for shrines razed in Medina


he dignity of a society is reflected through the value it gives to its cultural heritage. The sum total of cultural heritage is a nation, community or group's language, books, literature, rituals, knowledge, traditions, performing arts, crafts, festive eventsa and monuments. It's therefore our moral and civic duty to preserve, conserve and protect our cultural heritage.

In India, the five-centuriesold Babri Masjid in Ayodhya was demolished on December 6, 1992, by a radical Hindu mob. Intellectuals across the globe condemned the demolition. Muslims across the world protested. In its landmark judgement of 2019, the Supreme Court held that the demolition was illegal and directed the authorities to allot an alternative plot to build a mosque as com-

On the other hand, the bigger heinous crime of multiple demolitions of holy shrines, relics and heritage sites together with massacres took place in Saudi Arabia. This was done at the behest of Saudi Arab's Wahabi/Salafi rulers of Zionist ancestry who, wearing the cloak of Islam, in the middle of the 18th century introduced a new distorted version of Islam based on terrorism. This new cult was named 'Wahabism' in the name of its founder, Sheikh Muhammad Najdi-ibn-Abd-al-Wahab, who was born in Najd of Arabian Peninsula.

In 1744, sidelining the preaching of true Islam, Najdi created a cult 'Wahabism'. To gain manpower support, he shrewdly found a pattern in Muhammad-ibn-Saud, Bedouin tribal chief. Ibn Saud belonged to the Zionist tribe of Anza Ben Wael. Islam is not the original religion of Saudi Arabia rulers. Najdi too belonged to Zionist ancestry, and got his daughter married to Ibn Saud's son Abd-al-Aziz.

The Quran says, "Prophet Mohammad was sent to the voria as a mercy to mankina. (21:107). It states, "Allah abhors any disturbance of peace." (2:205). Whereas, Wahabi ideology is enshrined in their book



In 1766, Muhammad-ibn-Saud was killed and his son Abd-al-Aziz took over as Emir (temporal leader). He introduced firearms replacing conventional weaponry and accelerated his attacks in a spectacular bid to extend his territory. British historian Charles Allen writes in his book, 'God's Terrorists- The Wahabi Cult and the Hidden Roots of Modern Jihad': "Abdal-Aziz issued every (socalled) holy warrior a firman addressed to the gatekeeper of Heaven, requiring him to be admitted forthwith should he die in battle." Since then, it has been the common schismatic, fraudulent practice of terror operators to misguide and exploit the youth.

On June 2, 1/92, Sneikn Najdi, the founder of Wahhabism died, leaving behind 24 wives and 18 children. His son-in-law Abd-al-

In 1803, Abd-al-Azizibn-Saud obtained a visit permit from the Sharif of Mecca on the pretext of performing Hajj; wherein, his Wahabi fighters laid waste in Ka'aba, like the accursed Yazid-ibn-Muawiya desecrated Ka'aba in

According to Ravenshaw, author of 'A memorandum on the sect of Wahabis': "They robbed the splendid tombs of the Mahomedan saints, who were interred there; and their fanatical zeal did not even spare the Prophet's mosque Masjid ul Nabavi) in

In 1804, a Wahabi gang of terrorists again crossed the desert in Hijaz and destroyed

tombs of the Prophet's family members at Jannat-ul-Baqi, and even despoiled the grave of Prophet Mohammad. Again in 1925 (On 8th Shawwal 1344 Hijri), Wahabi terrorists demolished the shrines of Hazrat Fatima Zehra, daughter of Holy Prophet, and his grandsons: Hazrat Imam Hasan, Hazrat Imam Zain ul Abedeen, Hazrat Imam Mohammad

On December 6, every year marking the anniversary of the demolition of Babri Masjid, Muslims organise protests, file petitions in court. Whereas, on 8th Shawwal, 1344 Hijri (1925 AD), Saudi Arab rulers had demolished the holy tombs of Prophet Mohammad's family razing to ground, but surprisingly no Muslim of any sect reacted or lodged protests against the pseudo-Muslim Saudi rulers. Is it because those perpetrators are not non-Muslims?

### **HOW EFFECTIVE ARE DEFAMATION CASES**

There is an increasing trend of filing defamation cases against opponents

he "DMK Files" released by Tamil Nadu BJP chief Annamalai recently — a compendium of corruption allegations against the M K Stalinled party — has roiled the political circle in the state, with the ruling party sending the BJP leader a legal notice and seeking Rs.500 crore in damages. The DMK has accused Annamalai of making "constant attempts to defame, scandalise and tarnish the reputation" of Chief Minister M K Stalin and other leaders of the party with "vile, defamatory, scandalous and motivated statements".

Interestingly Annamalai has demanded compensation of Rs.500 crore and Re 1 from DMK's Organising Secretary R S Bharathi for levelling baseless allegations against him and his party. If any person communicates false statements about a person that injure the reputation of that person when observed through the eyes of an ordinary man, it will amount to defamation. Any false and unprivileged statement published or spoken deliberately, intentionally, or knowingly intending to damage someone's reputation is defamation. Defamation can be treated as an offence under the civil as well as criminal law. Under civil law, punishment in the form of damages will be awarded to the claimant. Under Section 499 of the Indian Penal Code, defamation is a bailable, non-cognizable offence and compoundable offence.



#### **INGREDIENTS FOR DEFAMATION**

There should be a presence of a defamatory statement. The statement should have been made to injure the reputation of a person or a class of persons by exposing them to hatred, contempt or ridicule. It will be looked into from the eyes of a common man to decide whether it damages reputation.

The statement should be specific to a person or a class of persons. General statements like 'all ministers are corrupt' can't be taken as defamatory. The statement may be in oral or written form and should be available to a third person.

#### **DEFENDANT'S RIGHTS**

- He can plead that he has made only a true statement
- He can plead that he has made fair comments with public interest
- Persons who are holding some positions are privileged to make state-

#### ments even if they are defamatory **DEFAMATION UNDER CRIMINAL LAW**

Defamation is a punishable offence under Section 499 of the Indian Penal Code 1860. Here the intention to defame is necessary. The allegation should be made with malice intent to defame another or at least the knowledge that the publication is likely to defame another is essential. Section 499 also provides various exceptions.

- Imputation of truth which public good requires to be made
- Public conduct of public servants
- Conduct of any person touching any public question
- Publication of reports of proceedings of courts. Merits of a case decided in Court or conduct of witnesses
- Merits of public performance
- Censure is passed in good faith by a person with lawful authority.
- Accusations preferred in good faith to authorised persons. Imputationby a person for the protection of his or other's interests.
- Caution intended for the good of the person to whom conveyed

It is difficult to prove the charges. It is also possible in the end, the accused may apologize, which may be accepted by the court. So, in the end nothing happens. In a study in the year 2018, it was found that out of all the judgements delivered about Section 499 of IPC, only 14.29 per cent resulted in the defendant being found guilty of defamation.

# GST is undergoing metamorphosis



There is a surge in GST collections, which has proved sceptics wrong and even surpassed the expectations of the authorities

nly a couple of years ago, top officials in the Department of Revenue used to gloat over a collec-tion of GST Rs 150,000 crore if achieved in any given month. They couldn't even imagine that collection of Rs 150,000 crore consistently every month in a year would ever be possible. But, this happened during 2022-23, when the department garnered a total of Rs 1800,000 crore. During the current year, it is aiming at a target of Rs 2000,000 crore.

A major factor behind this is an increase in nominal GDP during 2022-23 by 15.9 per cent (from a tax collection angle, this is what matters) on top of a surge of 18.4 per cent registered during 2021-22 when GST collection was Rs.1476,000 crores. But, an equally potent factor was relentless efforts made by the tax authorities to ensure compliance and prevent evasion. For instance, during 2022-23, the Directorate General of GST Intelligence (DGGI) detected GST evasion of over Rs 100,000 crore

GST is a single nationwide tax that subsumes within it more than a dozen taxes of the pre-GST era, namely central excise duty (CED), service tax, sales tax/value added tax (VAT) besides a host of local taxes such as octroi, purchase tax, turnover tax, etc. It is applied all over India, with the provision of set-off for tax paid on inputs also known in common parlance as input tax credit (ITC). It has an in-built disincentive for an entity not keen on reporting its purchases or sales or else, it won't get ITC.

Yet, fraudsters have dared to dodge the tax administration and the latter has

acted with alacrity to track and nail them. The modus operandi adopted by tax dodgers and fraudsters include nonpayment of tax on supply of taxable goods and services (clandestine removal); fraudulent availment of the ITC based on invoices from fake firms; wrong availment of ITC; short payment of tax by undervaluing taxable goods and services; wrong availment of exemption notifications etc.


Under the pre-GST dispensation, it was possible to remove goods from the factories without raising an invoice, move to the sale points and sold to the consumers without getting noticed hence, no payment of tax. It was a horrible situation of the consumers paying tax but not reaching where it should (read: the government coffers). The situation was aggravated by most of the transactions happening in cash which meant there won't be any trail.

Under GST, the activity of a firm about a transaction is under gaze at every stage. At the time of goods leaving its premises, it is required to generate an electronic or e-Invoice - a document in a digital file format, just like a PDF file that is authenticated electronically by GST Network or GSTN and involves the issue of an identification number against every invoice by the Invoice Registration Portal (IRP). E-invoicing is mandated by the Union Government for businesses with a turnover of more than Rs. 10 crores.

The firm is also required to generate an electronic Way or e-Way bill on the eWay Bill Portal. This document is required to be carried by a person in charge of the conveyance carrying any consignment of goods of value exceeding Rs 50,000/. This

Transporters are responsible for generating an e-way bill from the consignment's invoice, bill of supply, or delivery challan if nei-ther the seller or buyer has generated one.

What if, the seller has neither generated an e-Invoice nor an e-Way bill (this could be possible if he manages to show the values as being less than the threshold of Ks 10 crore and Ks 50,000 respectively) nor the transporter has generated an e-Way bill? The tax department can still nab him by looking at the details uploaded by the buyer on the GSTN portal which the latter is required to do to claim ITC. Surely, the tax administration would have made use of the above mechanisms to collect tax dues from the sellers indulging in the clandestine removal of goods.

Fraudulent availment of the ITC based on invoices from fake firms refers to cases where such entities generate bills for goods that don't exist or services not rendered. These entities are created on paper with the sole intent of defrauding the exchequer. For alert taxmen, it should not be difficult to figure them out by crosschecking their address and phone numbers with available data in other government departments, cent if sold in pre-packaged and

say, the registrar's office in the Ministry of Corporate Affairs (MCA) or even conducting physical verification. A somewhat less severe fraud

perpetrated on the exchequer is wrong availment of ITC. The entities do it by showing in the claim/document a higher value of services than what is paid to the service provider. For instance, the DGGI is going hammer and tongs after dozens of insurance companies that have paid much higher commissions (albeit on paper) to service providers than permitted by the Insurance Regulatory and Development

Authority (IKDA). Undervaluing taxable goods and services (also referred to as under-invoicing in business circles) is a commonly used practice to pay less tax than what is due. For instance, if a good worth Rs 100 is shown as Rs 80 then GST of say 18 percent will lead to a short payment of Rs 3.6 (20x0.18). Under GSTN which has a digital record of the transaction up to the point of sale to a consumer, this understatement of the true value (read: Rs 100) can't go unnoticed. The taxman will get to see Rs 100 at some stage and collect the shortfall in tax along with a penalty.


Finally, businesses also wrongly avail of exemption notifications. For instance, milk products, including paneer, curd etc attract nil GST if sold in loose form whereas these attract 5 per

labelled. Dubious firms can leverage this fine demarcation to escape tax net even when they sell

in pre-packs. Even as the actions of DGGI in all aforementioned areas are yielding good results in terms of detecting evasion and making dodgers pay up tax dues, the lat-ter could still invent ways to escape the former's radar. For instance, all players in the supply chain right up to the retailer could gang up to ensure that the transaction doesn't show up on GSTN. Can the department deal with such situations also?

DGGI is using technology toois such as end-to-end data analytics for a sector or a sub-part of it and 'gap analysis' of the taxes paid in a supply chain (this includes inter alia comparison of the tax payment profile of a particular sector vis-a-vis the pre-GST regime) to identify high-risk sectors where a significant chunk of value addition is not captured leading to tax pilferage. This will be followed by necessary enforcement action to check tax evasion at the manufacturing stage itself or a change of policies if required.

Hopefully, the above efforts will bear fruit. Together with sustaining the momentum of current actions, India could even target a GST collection of Rs 2400,000 crore during 2024-25. At that stage, the government could implement pending reforms such as taxing petroleum products under GST and going for a simpler tax

### Iran Navy seizes oil tanker in Gulf of Oman | US sanctions FSB, IRGC

### Iran TV airs footage

Masked Iranian Navy com-mandos conducted a helicopter-borne raid to seize a USbound oil tanker in the Gulf of Oman, footage aired by Iran's state television showed on Friday. The capture on Thursday of the Turkish-man-Chinese-owned Advantage Sweet represents the latest seizure by Iran amid tensions with the US over advancing nuclear programme.

The vessel's manager, a Turkish firm called Advantage Tankers, issued a statement acknowledging the Advantage Sweet was "being escorted by the Iranian navy to a port on the basis of an international dispute." All the ship's 24 crew members are Indian.

While Tehran says the

ning into another Iranian vessel, it has provided no evidence yet to support the claim - and the Islamic Republic has taken other ships as bargaining chips in negotiations with the West.

The footage showed the commandos descending on the deck of the Advantage Sweet by ropes from a hovering helicopter.

A photograph showed one commando with his fist in the air after apparently taking the vessel. The US Navy's 5th Fleet has said the Iranian seizure was at least the fifth commercial vessel taken by Tehran in the last two years.

'Iran's continued harassment of vessels and interference with navigational rights in regional waters are a threat to maritime security and the global economy," it added. "The safety and welfare of our valued crew members is our No. 1 priority," the firm said.

"Similar experiences show that crew members of vessels



taken under such circum-

stances are in no danger."

The Navy initially said paramilitary Revolutionary Guard seized the vessel, but an American naval aircraft later confirmed that Iran's navy captured the ship, 5th Fleet spokesman Cmdr. Timothy Hawkins told The Associated Press.

Iran's state-run IRNA news agency said the seizure came after an "unknown ship collided with an Iranian vessel last night in the Persian Gulf, caus-

ing several Iranian crew members to go missing and get injured." It did not identify the

other ship involved in the

alleged collision. The Advantage Sweet had been in the Persian Gulf on Wednesday, but its track showed no unusual behavior as it transited through the Strait of Hormuz, through which a fifth of all oil traded passes. Iran has made allegations in other seizures that later fell apart as it became clear Tehran was trying to leverage the capforeign nations.

Iran's "harassing activity within the Persian Gulf and Gulf of Oman is commensurate with an established pattern of behavior that has seen Iran target vessels as a result of ongoing disputes," maritime security firm Dryad Global said.

Thursday's seizure by Iran was the latest in a string of hijackings and explosions to roil the region.

The incidents began after then-President Donald Trump unilaterally withdrew the United States from Iran's nuclear deal with world powers, which saw Tehran drastically limit its enrichment of uranium in exchange for the lifting of economic sanctions.

Also, the US Navy has blamed Iran for a series of limpet mine attacks on vessels that damaged tankers in 2019, as well as for a fatal drone attack on an Israeli-linked oil tanker that killed two European crew members in 2021.

The Biden administration on 1 Thursday sanctioned Russia's Federal Security Service and Iran's Islamic Revolutionary Guard Corps intelligence organisation, accusing them of wrongfully detaining Americans.

It's the first rollout of new

sanctions authorisations established last year by President Joe Biden for use against those holding Americans unjustly cap-Still, the sanctions are large-

ly symbolic, since both organisations already are under sweeping sanctions for an array of malevolent behaviour — from election interference and Russia's invasion of Ukraine to support for terrorist activity.

Biden said the safe return of Americans held hostage or wrongfully detained abroad has been a priority since the first day

"Today, and every day, our message to Russia, Iran, and the world is holding hostage or wrongfully detaining Americans is unacceptable. Release them immediately," he said in a written statement.

Senior administration officials declined to specify which detentions specifically underpinned the sanctions, saying they were a response to a pattern of actions by the two countries in unjustly holding Americans both currently and in the past.

A US Treasury news release stated that Iranian authorities frequently hold and interrogate detainees in Evin Prison in Tehran and have a "direct role in the repression of protests and arrest of dissidents, including dual nationals." Senior administration officials noted that Thursday's actions were in the works well before the arrest last

reporter Evan Gershkovich in Russia, whose imprisonment was swiftly deemed unjust by the U.S. government. He joins American Paul Whelan with that designation in Russia. In addition to targeting the two organisations, the administration is also adding additional sanctions on four IRGC leaders it alleges are involved in hostage

taking efforts. Brian E. Nelson, Treasury's under secretary for terrorism and financial intelligence, said the U.S. is "committed to bringing home wrongfully detained U.S. nationals and acting against foreign threats to the safety of US nationals abroad."

The senior administration officials said that relief from the sanctions could be used as an inducement in negotiations to try to secure the release of the Americans held overseas.

### China flies 38 fighter jets near Taiwan

Taipei (AP): China's military flew 38 fighter jets and other warplanes near Taiwan, the Taiwanese defence ministry said on Friday, in the largest such flight display since the large military exercise in which it simulated sealing off the island earlier in the month. Naval vessels were also seen in the area as part of China's long-running campaign of intimidation against Taiwan

Later Friday, China's People's Liberation Army issued a protest over the flight of a US Navy P-8A Poseidon anti-submarine patrol aircraft through the Taiwan Strait separating mainland China from the self-governing island democracy claimed by Beijing. Calling Thursday's flight a

provocation that the US "openly hyped-up", the PLA's Army's Eastern Theatre Command said it scrambled fighter jets to monitor the plane's flight.

Such acts "fully prove that the US is a disruptor of peace and stability in the Taiwan Strait and a creator of security risks in the Taiwan Strait", the statement said.

### Pak's Opp, ruling coalition fail to agree on holding general elections

PTI ISLAMABAD

Pakistan's opposition party and the ruling coalition led by PML-N on Friday failed to make a breakthrough on holding general elections but exchanged proposals and agreed to meet again on Tuesday to end the political uncertainty plaguing the cashstrapped country.

The second round of talks was held in the backdrop of the controversy with Pakistan Tehreek-e-Insaf (PTI) seeking early polls — particularly in Punjab and Khyber Pakhtunkhwa where assemblies were dissolved in January - and the government maintaining that elections across the country be held on the same day in October.

The government side included İshaq Dar, Khawaja Saad Rafique, Azam Nazeer Tarar, and Sardar Ayaz Sadiq from the Pakistan Muslim League-Nawaz (PML-N).

They were joined by Yusuf Raza Gilani and Syed Naveed

Oamar from the Pakistan Peoples Party (PPP) as well as other parties in the coalition government.

The PTI, which is the main opposition party, fielded its Vice Chairman Shah Mahmood Qureshi, Senior Vice President Fawad Chaudhry, and Senator Ali Zafar for talks. The talks were held in the Parliament House, a neutral venue acceptable to the two sides.

The first round was held on Thursday which went on for two hours and the rivals decided to meet again after consulting their party heads.

He wanted to put pressure on as by the law, elections should be held within 90 days of the dissolution of an assem bly. However, the government used delaying tactics by citing a lack of funds and a rise in terrorism to set a date for polls in the two provinces while pushing the narrative that elections should be held on the same day in the country after the completion of the term of the National Assembly in August.

The problems began when the issue landed in the Supreme Court which after a hearing ordered that elections be held in Punjab on May 14 and the government provide Rs 21 billion for polling to the Election Commission of Pakistan.

### Wang promises continued support for Pakistan

Beijing (PTI): Top Chinese diplomat Wang Yi on Friday reiterated China's continued support to its all-weather ally Pakistan which is facing grim political and economic turmoil as he met Pakistan Army chief General Asim Munir, who is on his maiden visit.

Wang, who was the former foreign minister and was promoted as the director of the Office of the Foreign Affairs Commission Communist Party of China (CPC) Central Committee, told Gen Munir that China will continue to firmly support Pakistan in safeguarding its sovereignty, independence and territorial integrity, as well as in achieving unity, stability, development and prosperity.

The Pakistani military is a staunch defender of the ironclad friendship between China and Pakistan, Wang said, adding that China commends successive Pakistani administrations and all political parties for firmly pursuing friendly policies toward China, staterun Xinhua news agency

Since his arrival on a fourday maiden visit, Gen Munit held talks with Chinese military officials, while China's new Premier, Li Qiang spoke over the phone with his Pakistani counterpart Shehbaz Sharif on Thursday promising continued financial help.

During his talks with Sharif, Qiang voiced support for cash-strapped Pakistan in maintaining financial stability and hoped that Islamabad will continue to create a favourable environment to guarantee the safety of Chinese institutions and personnel working in the country.

### 11 dead as speedboat capsizes in **W Indonesia**

Pekanbaru (AP): A speedboat carrying 74 people capsized in rough seas in western Indonesia, killing at least 11 and leaving one person missing, officials said on Friday.

Many of the dead were women and children, said Nyoman Sidakarya, chief of the Pekanbaru Search and Rescue He said 62 people had

been rescued, including some who were unconscious after drifting in the choppy waters for hours. They were hospitalised and were in stable condition, he said.

The Evelyn Calista 01 was carrying 68 passengers, mostly people returning from visits to their hometowns to celebrate the Eid al-Fitr holiday with their families, and six crew members, Sidakarya said. He revised the number of people on board from an initial

estimate of 78. Television video showed people standing on an overturned boat trying to reach a fishing boat packed with survivors. The boat sank on thursday afternoon about three hours after leaving Tembilahan, a town in Indragiri Hilir Regency in Riau province. It was bound for Tanjung Pinang in the Riau (125-mile) trip. The cause of the sinking was still being investigated, but some survivors told authorities that the boat swayed suddenly and capsized after hitting a large log while travelling in strong winds, local police chief

Two tugboats and two inflatable boats battled high waves in the overnight darkness as they searched for survivors, said Norhayat, who uses a single name. He said a tugboat pulled the capsized boat to shore to ease the search efforts.Boat tragedies are common in Indonesia, an archipelago of more than 17,000 islands. where ferries are often used as transport and safety regulations are sometimes ignored.

We must stand hand in hand around our children and protect them against this

sperm donors are allowed to produce a maximum of 25 children with 12 mothers and that the donor lied to prospective parents about his donation history. The donor, identified as

Jonathan M. under Dutch privacy guidelines, provided sperm to several Dutch fertility clinics and to a clinic in Denmark as well as to many other people he connected with through advertisements and online forums, the court said in its written judgment.

The donor's lawyer said in a court hearing that he wanted to help parents who would otherwise be unable to conceive. The judge who heard the civil case said that the donor "deliberately lied about this in order to persuade the parents to take him as a donor", the court said in

Friday.

In a series of details released around the ceremonial roles to be carried out at the historic event when the 74year-old monarch is formally crowned along with wife Camilla, the palace also confirmed that Indian-origin peers will be participating in the cer-

the Hindu, Sikh and Muslim faiths as they hand over key elements of the royal regalia to King Charles. In keeping with this theme of diversity and inclusion for the Christian ceremony, one of the first processions into the Abbey will be made up of faith representatives of different religions.

"The first processions into Westminster Abbey will be made up of faith leaders and faith representatives followed shortly afterwards by representatives from His Majesty's Realms," the palace said.
"Flags of each Realm will

be carried by national representatives accompanied by the Governors General and Prime Ministers. Bearing the flag of



the United Kingdom ahead of Prime Minister Rishi Sunak and Mrs Akshata Murty will be Cadet Warrant Officer Elliott Tyson-Lee," it said.

The ceremonial roles on

the day include bearing the regalia in the procession and presenting the items to the King and Queen on the day. As previously revealed, Lord Narendra Babubhai Patel, 84,

While Lord Indrajit Singh, 90, will represent the Sikh faith and present the Coronation Glove, Lord Syed Kamall, 56, of Indo-Guyanese heritage, will represent the Muslim faith and present the Armills or a pair of bracelets. Baroness Gillian Merron, 64, who is Jewish, will carry the Robe Royal to the King.

The palace said that those

undertaking these historic roles in the Coronation Service have been chosen to "recognise, thank and represent the nation due to their significant service, and include representatives from Orders of Chivalry, the military and

Those presenting the regalia have been chosen on the advice of the British government and will be directed by the Archbishop of Canterbury, Reverend Justin Welby, as he presides over the ceremony.

"I feel honoured and privileged to be part of the historic Coronation ceremony. To be selected to carry the Sovereign's Sceptre with Dove, which represents spirituality, equity and mercy, is for me very symbolic as it's everything I stand for and sends out a clear message that diversity and inclusion is being embraced," said Baroness Floella Benjamin, a Trinidad and Tobago born former children's TV presenter, who will

be carrying the Sceptre with the Dove to the altar. The ceremony will not

only include dukes, bishops, peers and retired generals but also a farmer named Francis Dymoke, who will act as the King's Champion on the day in a ceremony steeped in royal tradition dating back to the 11th century. "The title of King or Queen's Champion has been held by the Dymoke family since the Middle Ages. The King's Champion would previously ride on horseback into the Coronation Banquet and challenge any who doubted the right of The King or Queen to the throne," the palace revealed.

"There has not been a Coronation Banquet since that held by King George IV in 1821 so the Champion has instead undertaken a different role since, usually bearing a flag or Royal Standard," it

The palace has been unveiling details around next week's grand ceremony, which marks a Coronation ceremony in Britain after a gap of 70 years since Charles' mother Queen Elizabeth II was crowned

monarch in 1953.

Processions involving gilded horse-drawn carriages and thousands of military per-sonnel will mark the day on May 6, followed by a long weekend of celebrations involving a gala concert, street parties and pomp and pageantry.

## Russian missile kills 22 in Ukraine

 $R^{ussia\ fired\ more\ than\ 20}_{cruise\ missiles\ and\ two}$ drones at Ukraine early on Friday, killing at least 22 people, almost all of them when two missiles slammed into an apartment building in the centre of the country, officials said. Three children were among the dead.

The missile attacks included the first one against Kyiv, Ukraine's capital, in nearly two months, although there were no reports of any targets hit. The city government said Ukraine's air force intercepted 11 cruise missiles and two unmanned aerial vehicles over

The strikes on the ninestory residential building in central Ukraine occurred in Uman, a city located around 215 kilometres (134 miles) south of Kyiv. Seventeen people died in that attack, according to the capital region's governor, Ihor Taburets. They included two 10-year-old chil-

dren and a toddler.

Another of the victims was a 75-year-old woman who lived in a neighbouring building and suffered internal bleeding from the huge blast's shock wave, according to emergency personnel at the scene.

The Ukrainian national

police said 17 people were wounded and three children were rescued from the rubble. Nine were hospitalised.

The bombardment was nowhere near the war's sprawling front lines or active combat zones in eastern Ukraine, where a grinding war of attrihas frequently launched longrange missile attacks during the 14-month war, often indiscriminately hitting civilian

Ukrainian officials and analysts have alleged such strikes are part of a deliberate intimidation strategy by the Kremlin.

The Russian Defence Ministry said the latest longrange air-launched cruise missiles launched overnight were aimed at places where Ukrainian military reserve units were staying before their deployment to the battlefield.

"The strike has achieved its goal. All the designated facilities have been hit," Lt. Gen. Igor Konashenkov, the Defence Ministry's spokesperson, said. He didn't mention any specific areas or residential buildings getting hit.

Survivors of the Uman strikes recounted terrifying moments as the missiles hit when it still was dark outside. Halyna, a building resident,

covered in glass by the blast. They saw flames outside their window and scrambled out, but first Halyna checked whether her friend in a neighbouring apartment was OK.

"I was calling, calling her (on the phone), but she didn't pick up. I even rang the doorbell, but still no answer," she told The Associated Press. She used the spare keys from her friend's apartment and went inside to check on her. She found her lying dead on her apartment floor.

Halyna refused to provide her last name out of security concerns.

Another building resident, Olha Turina, told the AP that glass from the explosion flew everywhere.

Turina, whose husband is fighting on the front lines, said one of her child's classmates was missing."I don't know where they are, I don't know if they are alive," she said. "I don't know why we have to go through all this.

### BBC chairman resigns after row over loan deal for ex-PM

London (PTI): BBC chairman Richard Sharp resigned on Friday after a report found he broke the rules by failing to disclose the role he played in helping former British prime minister Boris Johnson secure an 800,000-pounds loan. The 67-year-old former






