The Lok Sabha on Thursday night passed the passed the Government of the National Capital Territory of Delhi (Amendment) Bill, 2023, by a voice vote amid a walkout by the Opposition.

Immediately after the Bill was passed, Speaker Om Birla suspended AAP MP Sushil Kumar Rinku for the remaining period of the Monsoon session for "not holding the dignity of the House" by throwing papers on the Chair. Parliamentary Affairs Minister Pralhad Joshi set the motion for the MP's suspension.


Upholding the Bill, Union Home Minister Amit Shah hit out at the Opposition for not participating in the discussion over nine Bills passed by the Parliament but "coming together" in the Lok Sabha to oppose the Delhi Services Bill with the sole intention of "saving" their

"Opposition parties, including Congress, DMK, TMC, SP, said the Bill was against the 'Constitution,' 'federalism,' and 'overrides powers of the elected by the selected."

While replying to over a 5hour debate, Shah asserted that the Centre "has all the power to make laws for the Delhi State".

The Home Minister said the fear of losing Delhi Chief Minister Arvind Kejriwal's AAP in the alliance and "election" has brought Opposition parties together and "not their love for democracy, country, or people of the

"When you need it, you take the help of former PM Jawaharlal Nehru. If you had actually taken the help of Nehru, then the country would not have witnessed Manipur," said the Congress MP.

After days of disruption in the ongoing Monsoon session, the opposition was, for the first time, participating in the discussion of a Bill in the house. The government has so far passed nine bills without any discussion with the Opposition, derailing both Houses of Parliament over the Manipur

Gyanvapi survey challenged in SC

SC to hear today **Anjuman's plea** against HC order for ASI survey to find masjid was **build on temple**

The Anjuman Intezamia Masjid committee, a Muslim body, swiftly moved the Supreme Court on Thursday following the Allahabad High Court's judgment permitting an Archaeological Survey of India (ASI) survey at the Gyanvapi mosque to determine if the mosque was built upon a tem-

Advocate Nizam Pasha sought an urgent hearing before Chief Justice DY Chandrachud, who is heading a five-judge constitution bench dealing with the Article 370 challenge.

"The Allahabad High Court has passed an order today. We have filed an SLP against the order. I have sent an email (seeking an urgent hearing). Let them not proceed with the survey...," Pasha stated. Responding to this, the CJI said, "I will look at the email right away."

Lawyers representing the Muslim parties in the case claimed that the Supreme Court would hear the plea of the Anjuman Intezamia Masjid Committee on Friday.

The controversy centres around a Varanasi district court's direction on July 21, instructing the ASI to conduct a "detailed scientific survey" to ascertain whether the Gyanvapi mosque, located next to the Kashi Vishwanath temple, was

mony in the State. Å total of 176 people have been arrested and 78 taken into preventive detention in connection with the communal clashes in Haryana, Prasad said. He further said 93 FIRs have been registered, including 46 in Nuh, 23 in Gurugram, three each in Faridabad and

Rewari, and 18 in Palwal. "I would say it has returned to normalcy. We have ade-quate forces. The Centre was requested and 24 companies of central forces were provided."

Prasad said in the chain of events which unfolded in Nuh on Monday, one thing important to note is why cyber crime police station was targeted by arsonists and asked who was to benefit by damaging the police station. "The whole thing warrants a thorough investiga-

tion," he said. Six people have died in the clashes that erupted in Nuh after attacks on a Vishva Hindu

Parishad procession. Meanwhile, late on Wednesday night, a mosque was set on fire and a short circuit apparently triggered a blaze in another in Nuh district, while two brothers belonging to Muslim community were allegedly beaten up in Gurugram by a group of about 30 people, police said.

Bring younger Af cheetahs in Kuno to boost survival: Experts

In the wake of a spate of Cheetah deaths at Madhya Pradesh's Kuno National Park, international experts have advised the Government to introduce young and habituated predators in the region to enhance their survival and adaptability.

Out of the 20 adult cheetahs relocated to Kuno from Africa since March this year, six have tragically died, with the latest incident reported on

The experts have identified 10 young cheetahs, aged between 19 months and 36 months, which can be relocated to India in early 2024.

14-yr-old gangraped, killed, burned in coal furnace in Raj; 5 arrested

Allegedly murdered and later burned in a coal furnace in Rajasthan's Bhilwara district, police said on Thursday as the locals claimed that she was also gang-raped.

Police have detained five people, who work at five coal furnaces in the area, in connection with the incident.

Locals alleged that the girl was gang-raped before she was murdered and thrown into the furnace.

On Wednesday, the teenage girl had gone to graze cattle but did not return home till evening following which the family members started searching for her, police said.

Later in the night, the family members spotted the girl's footwear near one of the five furnaces. On peeping inside, they found her bangle and a few bones, they said. Locals caught hold of a few

people, suspecting their involvement in the crime, and handed them over to the police,

The detained people who live near the furnaces are being



SHO of Kotri police station said that there were a total of five furnaces in a row and last night one of them was being operated without being fully covered, contrary to the normal practice.

"The locals spotted a fire in one furnace. Usually, the fur-nace is fully covered but the furnace was opened from the side. They reached there and found the girl's bangle and

some bones," he said.

He said that barring the crime scene, four other furnaces were demolished today as they were illegally set up on ernment land.

"The family members informed the local police station in the evening that the girl was missing but the police did not take action and asked them to bring documents of the girl to establish she was a minor," BJP Anita Bhadel said.

IT Dept discloses middlemen's names in Maha land-graft case Affidavit filed in HC names middlemen

 \mathbf{I} n a major development, an affidavit filed by the Income Tax department (Investigation) before the Bombay High Court has disclosed the names of three middlemen engaged in liaising activities in close coordination with various Ministries of Maharashtra government in an alleged corruption case involving the allotment of land belonging to the state government.

In her say filed before the HC bench of Acting Chief Justice Nitin Jamdar and Justice Arif S Doctor that had directed Income Tax Department to file a comprehensive affidavit related to current status of a case involving irregularities in the government land allotment, Ms Teresa Joseph, Deputy Director of Income Tax (Investigation) Unit 32 (2) confirmed that "the relatives/ family members/ references of



the bureaucrats in whose name the properties were purchased"

were under investigation.
Following raids conducted on 25 residential, 15 office premises and some suites in a five-star hotel in south Mumbai between September and November 2021, the IT officials had detected total transactions to the tune of Rs 1,050 crore. The syndicate – comprising businessmen, middlemen, their associates and also those public offices had used code names in their records and in one case, they had backdated records by 10 years. Huge cash exchanges were involved in the overall transactions. BJP will hack EVMs, incite violence to win 2024 polls, alleges Mamata

Bengal Chief Minister Mamata Banerjee on Thursday said that the BJP was working on a twopronged strategy of inciting communal violence and hacking electronic voting machines (EVM) to win the 2024 general elections and promised to take up the issue in the next meeting of the Indian National Developmental Inclusive Alliance (I.N.D.I.A).

Speaking to the media at State secretariat Nabanna the Chief Minister said that she had information regarding the BJP's plans to hack the EMMs. "I have information that they are trying to play some mischief ... planning to hack EVMs ... We have gathered some evidence and will gather more ... and then discuss it at the next I.N.D.I.A meeting," Banerjee said. The BJP knew that it was going to lose the elections, which was why it was planning to hack voting machines and incite communal tensions to polarize the electorate and win the elections, she told journalists.

"Every time they resort to violence to win polls ... they torture dalits, SCs, STs and minorities ... it is their ploy to saffronise India ... also I have been informed about some dress codes in petrol pumps and metro stations

where saffron colour will be used ... Saffron is a pure and holy colour but here the BJP is using this colour for political purpose ...

Wednesday referred to the violence in Haryana saying whenever the nation faced elections the BJP resorted to engineering communal tension and violence in order to polarize the electorate. "Look what is going on ...

You can see how Manipur is burning, Haryana is burning ... and rioters are on rampage everywhere ... It is clear that like their usual practice they have started igniting riots when the elections are but a few months away ... this is a part of their politics," Banerjee said on Wednesday.

When asked to comment on Union Home Minister Amit Shah's claim that despite all the efforts of the I.N.D.I.A leaders it was Narendra Modi

who would once again ascend the Prime Ministerial chair Banerjee said that "All the NDA partners have left ... whereas I.N.D.I.A is a new one and will win the 2024 election and form the gov-

ernment. INDIA will save the country from disaster, communal tension and unemployment."

Reacting to Banerjee's statements Bengal BJP leader Samik Bhattacharya said that before dreaming of winning Delhi the Chief Minister should first save Bengal as she was going to get a bigger shock than 2019 general elections.

She is talking of violence and EVM hacking but what did her party do in Bengal ... they resorted to hacking of ballot papers on a large scale which is why her own officers are facing suspension ... and to talk of violence no one can match the TMC in committing violence," he said

that Desai was under tremendous mental pressure over the insolvency proceedings launched against him. He had reportedly confessed to his close aides that some businessmen were allegedly harassing him over financial matters, which might have led to his taking an extreme step.

On their part, the Raigad Police have begun to investigate Desai's suicide from multiple angles, including financial, external or business pressures and other aspects.

Kejriwal slams Centre after Services Bill passed in LS

Delhi Chief Minister Arvind Kejriwal on Thursday accused the BJP of backstabbing the people of the national capital after Lok Sabha passed a bill to replace an ordinance promulgated for handling the transfers and postings of senior officers in the city government.

Kejriwal lashed out at the BJP and Prime Minister Narendra Modi, and urged people not to believe anything the PM says.

"BJP always promised to give full statehood to Delhi. In 2014, Modi himself said that on becoming the prime minister, he would give full statehood to Delhi. But today these people stabbed the people of Delhi in the back. Don't believe anything said by Modiji from now



on," he said in a tweet in Hindi. The Government of National Capital Territory of Delhi (Amendment) Bill, 2023, was passed by Lok Sabha on Thursday amid a walkout by opposition parties. The Delhi services bill was passed after a nearly four-hour-long debate which was replied to by Union Home Minister Amit Shah.

Shah made it clear that the central government has the power to make laws on Union territories and Delhi, being a Union Territory, the Centre enjoys full rights to make rules also. As the House debated on the bill, Kejriwal said earlier in the day that Home Minister Shah did not have a single valid argument in favour of bringing the bill, and asserted that the opposition bloc INDIA will never let it happen. Initiating the debate in Lok

Sabha, Shah said the BJP and the Congress had ruled the national capital without any confrontation, but problems arose only in 2015 when a government came that had no intention to serve but only to fight with the Centre.

In his first reaction after the introduction of the bill, Kejriwal said this is a bill to enslave people of Delhi. "Today I heard Amit Shah ji speaking in Lok Sabha on the bill which snatches away the rights of the people of Delhi. They do not have a single valid argument to support the bill... They also know that they are doing wrong. This bill is a bill to enslave the people of Delhi. This is a bill that makes them helpless and helpless. INDIA will never let this

happen," he said in a tweet in Hindi. The AAP-led Delhi government has been at loggerheads with the Centre over the control of Group-A officers in the National Capital Territory administration. In May, the Centre pro-

IMD: Sporadic rain in city for 4-5 days

 \mathbf{H}^{ot} and humid weather troubled Delhi residents on Thursday with only mar-ginal relief expected over the weekend. Intermittent rains are like-

ly over the next five or six days with the intensity peaking on the weekend, the India Meteorological Department (IMD) forecast showed.

Safdarjung Observatory, Delhi's primary weather station, recorded a minimum temperature of 25.2 degrees Celsius, two notches below normal. The maximum temperature settled at 35 degrees Celsius.


Bountiful rains in July gave Delhi its best air quality for the month in five years, while the average maximum temperature also dropped to its lowest level since 2016, according to data from the India Meteorological Department (IMD) and the Central Pollution Control Board (CPCB).

The city recorded 384.6 mm of rainfall in July, which is the second-highest in the month in the last 15 years,



195.8 mm. It gauged abovenormal rainfall in the last four months - 53.2 mm against a normal of 17.4 mm in March, 20.1 mm against an average of 16.3 mm in April, 111 mm against a normal of 30.7 mm in May and 101.7 mm against a normal of 74.1 mm in June.

The average maximum temperature in July was 34.7 degrees Celsius, the lowest since 2016 when it was 34.5 degrees Celsius.

The High Court had on May 29 issued warrants for production of Malik, who is presently serving life term in the case in Tihar Jail, on August



9 when the NIA's plea for enhancement of sentence is listed for hearing

In the application seeking modification of the order, the jail authorities said Malik was a "very high risk prisoner" and it was imperative to not physically produce him in court to maintain public order and safety.

It also said that as per an order passed by the Home Ministry, Malik cannot be "moved from Tihar Jail" and shall not be taken out of jurisdiction of the national capital. 'Respondent/Convict

Yasin Malik has been lodged in Tihar Jail, New Delhi under the category of very high risk prisoners and thus, the present application is in relation to a heavy security issue.

Therefore, it is imperative that the respondent/convict Yasin Malik is not physically produced before this Hon'ble Court in order to maintain public order and safety," the application said.

On May 29, the high court had issued notice to Malik on the NIA's plea seeking death penalty for him in the terror funding case and said, "Let warrants of production be issued against Yasin Malik, before this Court on the next date of hearing. List on 09.08.2023." On

May 24, 2022, a trial court here had awarded life imprisonment to Jammu Kashmir Liberation Front chief Malik after holding him guilty for various offences under the stringent Unlawful Activities (Prevention) Act (UAPA) and

Malik had pleaded guilty to the charges, including those under the UAPA, and he was convicted and sentenced to life imprisonment. Appealing against the sentence, the NIA has emphasised that a terrorist cannot be awarded life sentence only because he has pleaded guilty and chosen not to go

through trial. While seeking enhancement of the sentence to death penalty, the NIA has said if such dreaded terrorists are not given capital punishment on account of pleading guilty,

there would be complete erosion of the sentencing policy and terrorists would have a way out to avoid capital punishment.

A life sentence, the NIA has asserted, is not commensurate with the crime committed by terrorists when the nation and families of soldiers have suffered loss of lives, and that the trial court's conclusion that Malik's crimes did not fall within the category of the "rarest of the rare cases" for grant of death penalty is "exfacie legally flawed and completely unsustainable".

The agency has emphasised that it has been proved beyond reasonable doubt that Malik spearheaded terrorist activities in the Valley and with the help of dreaded foreign terrorist organisations, had been "masterminding, planning, engineering and executing armed rebellion in the Valley in an attempt to usurp the sovereignty and integrity of a part of India".

The trial court had awarded Malik 10-year jail term each under sections 120 B (criminal conspiracy), 121-A (conspiracy to wage war against the government of India) of IPC and sections 15 (terrorism), 18 (conspiracy for terrorism) and 20 (being member of terror organisation) of UAPA.

Garbage dumped on road from Shahdara to Karkardooma: Court seeks MCD's response

Review Civil Service recruitment process: Parl panel

Committee outlines in it's 131st report that maximum number of officers recruited have technical and medical background

Noting that above 70 per cent of recruits in civil services are from technical streams, a parliamentary committee on Thursday said the allurement to become a civil servant is perhaps adversely affecting other professions that are a requirement for the

It is high time to rethink the entire recruitment process for the civil services, the Department-related Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice opined in its latest

The panel said a civil servant is an interface between the government and the common people, and works at the grassroots, which requires considerable human touch and a sensitive approach towards the people. It also noted that a civil servant has to be given train-



ing in such a way that he develops a more humane and empathetic approach towards

In its 131st report on"Review of Functioning of Recruitment Organizations of Government of India", tabled in Parliament on Thursday, the committee, said that the maximum number of officers recruited have technical and medical background."Above 70 per cent of the recruits in the civil service by the UPSC (Union Public Service Commission) nowadays are from technical streams. Every year, hundreds of technocrats are thus being lost, who are likely to work in other specific areas which is also a requirement for the nation," the panel, headed by BJP MP Sushil Kumar Modi, said. So, doctors and top technocrats are being lost who can perform as very good doctors and engineers, it said."The allurement to become civil servant is perhaps also

adversely affecting other fields

of working. Hence, the com-

mittee opines that it is high time to have a rethink about the whole process of recruitment for the civil service," the report

The committee said that the UPSC and the Staff Selection Commission (SSC) conduct various examinations each year and allocate recommended candidates to different posts. For instance, through the civil services examination, UPSC selects about 1,000 candidates every year and these candidates are posted across 19 different services, it said.

"With reference to this the committee notes that the same process and yardstick is being applied to select candidates who would be manning the top administrative posts in various services. It may happen sometime that the aptitude and interest of the candidate selected may not be suitable for that particular post," the report said. Citing statistics for the last 10 years, it said that out of 833 candidates selected through the civil services examination-2020, 541 candidates (65 per cent) had an engineering background, 33 (four per cent) medical background, 193 (23 per cent) humanities background and 66 (eight per cent)"others" background.

Of the 922 candidates selected through the civil services examination-2019, 582 (63 per cent) had an engineering background, 56 (six per cent) medical background, 223 (25 per cent) humanities background and 61 (six per cent)"others" background.

The committee also sought to know whether the UPSC is contemplating to make any change in the pattern of civil services examination to curtail the length of the examination cycle. Each recruit-ment test conducted by the UPSC as of now, takes anywhere between six months to one year to complete, it said."This long drawn process

involves a lot of expenses for the competing candidates and also contributes to the erosion of human capital. In view of this, the committee desires to know whether UPSC is contemplating to make any change in the pattern of civil services," the report said. The panel appreciated that with changing times, the government has brought in several significant changes in the training methodology.

"However, the efficiency, energy and intensity of the officers still needs to improve and the officers need to be further trained for working in adverse situations, particularly to tackle law and order problems effectively," it said.

The panel also observed that the present day civil servant did not possess the same legal prowess as their predecessors."The committee feels that there is a need to impart better training in the legal part as they are also quasi judicial officers so that the officers when they take the final assignment, address the judicial problems more meticulously than what they are doing nowadays,' the report said. The committee asked the UPSC to explore the feasibility of declaring the answer key of civil services preliminary exams after the preliminary exam stage is over and not after the declaration of final results of the civil services examination

"The committee appreciates the UPSC and the SSC for conducting the diligence exercises before publishing the answer keys. However, the committee is of the view that this will become further more credible if the feedback of the candidates are taken through a dedicated portal and then keys are published. The committee hopes that this process will be followed in future," the report said. Candidates should be allowed to raise objections at this stage only and on that basis

any discrepancies related to the answer key of the preliminary examination should be resolved, it said. This should be taken into account before publishing the result of candidates qualifying for the next stage that is civil services mains examination, it said

It said that rendering services to the common people is the primary task of the civil servants and inclination to serve society with human touch must be an essential quality amongst the civil servants. The committee, therefore, recommended that while examinations are conducted and the question paper is prepared, these factors also need to be taken into account apart from the subject and intelligence, the report

The committee is of the view that these factors probably could help in moulding the prospective/selected candidate to work for betterment of the

GARDP, ICMR to study antimicrobial resistance in India

 $W^{ith \ antimicrobial \ resistance \ (AMR) \ becoming \ a}$ major threat in India for physicians and patients alike, the Global Antibiotic Research and Development Partnership (GARDP) has launched a study in India in collaboration with the ICMR at six hospitals to understand drug-resistant infections and subsequently learn how to treat patients bet-

ter in the future. The study will collect and analyze data in 180 patients being treated for infections caused by carbapenem-resistant organisms at Kasturba Medical College in Manipal, Christian Medical College in Vellore, Tata Medical Centre in Kolkata, PD Hinduja Hospital & Medical Research Centre in Mumbai, the Postgraduate Institute of Medical Education and Research (PGIMER) in Chandigarh and Sir Ganga

Ram Hospital in Delhi. "We are seeing rising rates of resistance to carbapenems – the class of last-line antibiotics most commonly used to treat hospital-associated multidrugresistant bacterial infections, noted Francois Franceschi, GARDP's Project Lead for Serious Bacterial Infections.

The concerns come amid various researches including the recently published in The Lancet that says that nearly 1.3 million people - and potentially millions more - died as a direct cause of antibioticresistant infections in 2019.

The study will also look at the epidemiology as well as the treatments administered to both adults and children with

severe bacterial infections caused by carbapenem-resis-Enterobacterales (CRE)and/or Pseudomonas aeruginosa (CRPA). Infections caused by these bacteria are difficult to treat because they do not respond to commonly used last-line antibiotics. Data will also be collected on the clinical outcomes for patients with

tions in the six hospital sites. These infections have been recognized as critical in the Indian Priority Pathogen List, which guides research, discovery and development of new antibiotics in India."Treating Pseudomonas infections has become significantly more difficult because of antibiotic

confirmed CRE/CRPA infec-

Without enough antibiotics in the pipeline to address this challenge and as access to newer drugs is not available in India, the situation appears grim. More research as well as active involvement of regulators and policymakers is vital.

The study will provide crucial information that could ultimately be used to improve treatments and help reduce deaths and illness associated with bacterial infections," said Dr Soumyadip Chatterji, principal investigator for the study at the Department of Infectious Diseases, Tata Medical Centre,

The results of the study will also help the hospitals involved to carry out future interventional trials of novel therapeutics which are able to combat carbapenem-resistant infections. GARDP's observational study is also underway at five hospitals in South Africa, said

The plea filed by Nalanda resident Akhilesh Kumar submitted that in terms of the constitutional mandate, only the Union fovernment is empowered to conduct a census. "In the present case, the State of Bihar has sought to usurp the powers of Union of India, by merely publishing a notification in the official gazette. "It is submitted that the

Notification dated June 6, 2022 is against the Constitutional mandate of distribution of powers between the State and the Union legislature as enshrined under Article 246 of the Constitution read with Schedule VIIth of the Constitution and ultravires the Census Act, 1948 read with Census Rules, 1990 and is therefore void ab intio (since beginning)," the plea, filed through advocate Barun Kumar Sinha, said.

The plea submitted the entire exercise of conducting a"census" by the State of Bihar is without authority and legislative competence, and reeks of malafide. "The short question of constitutional importance that arises in the present petition is whether the Notification dated June 6, 2022 published by the State of Bihar based on decision of Bihar Cabinet dated June 2nd, 2022, to conduct Caste based Survey from its own resources and the consequent appointment of District Magistrate to supervise the same, is within the Constitutional mandate of separation of power between the State and Union," the plea said.

ED conducts raids in PMLA case probe against Balaji

Enforcement The Directorate on Thursday conducted fresh searches in connection with its ongoing money laundering investigation against Tamil Nadu min-ister V Senthil Balaji and others. Officials said premises linked to some entities being probed in this case and alleged benamidars (benami property holders) were being raided in Coimbatore and Karur.

Balaji continues to be a minister without portfolio in the Tamil Nadu government despite his arrest by the ED on June 14 in a money laundering case linked to an alleged cashfor-jobs scam in the State transport department. On Wednesday, the ED told the Supreme Court that Balaji was

preventing it from exercising its right of custodial interrogation and the apex court reserved its verdict on the pleas of the DMK leader and his spouse challenging his arrest.

The apex court had on

July 21 sought the ED's response on the petitions filed by Balaji and his wife Megala challenging the July 14 order of the Madras High Court upholding his arrest by the probe agency in the money

laundering case. The controversial minister and his wife have filed two separate petitions in the top court challenging the high court order. Earlier, the agency had claimed that Balaji allegedly"misused" his office for illegal gratification and"engineered" a job racket scam in the State transport undertakings during 2014-15 with purported kickbacks paid by candidates through his associates including RV Ashok Kumar and B Shanmugam.

The ED filed a case under the Prevention of Money Laundering Act in September 2021 to probe these allegations. The PMLA case stems from three Tamil Nadu Police FIRs filed during 2018 and later by some of the candidates who failed to get the promised jobs.

Ganga water level rising again Niranjan rail under pass to

The water level of river Ganga restarted rising again in the city here on Thursday. This rise is mainly due to recent flood in river Yamuna in Delhi, Haryana and adjoining areas because the level of Ganga at Phaphamau, prior to Sangam in Prayagraj was still recorded constant, as per the report of Middle Ganga Division-III of Central Water Commission (CWC). However, right from Prayagraj to Varanasi including Mirzapur it was recorded rising again. In Varanasi, it was rising at 10 mm per hour.

After crossing 65 metres mark, the water level receded slightly when the river was steady in the city during the last few days but now, it has restarted rising again and at 8 am on Thursday, it was at 64.89 metres. Though it was still flowing several metres below the warning level of 70.262 metres, the rise has affected life at Kashi's ghats. The venue of the famous Ganga aarti at Dashashwamedh Ghat has already shifted on some occasions and still the river was flowing at the feet of Sheetla Mata Mandir. In the downstream areas, though the river was steady at Ghazipur and Ballia, the same may start rising there within a day or two. In Ballia, the river was at 55.31 metres against the warning

Meanwhile, the rain lashed the city in the afternoon after a good rain during the night hours when it had received 19.8 mm rain. Due to rain, the normal life was paralysed and many areas were waterlogged, exposing the tall claims of Nagar Nigam that the drains were already desilted.

However, the rains and recent efforts made by the government and administration has brought a good result as ground water level has improved in 2022 as compared to 2016 in all the development blocks and urban areas of the district, informed Chief Development Officer (CDO) Himanshu Nagpal. According

to him, in order to improve the water level in the rural and urban areas of the district, rainwater harvesting, constructions of Amrit Sarovars and renovation of ponds, tree plantation, construction of check dams and renovation of restored rivers etc have been

"Due to these efforts, at present the ground water level is improving and continuous efforts are being made to check the ground water level," he said, adding that the work of rooftop rainwater harvesting has been done in the area of 3,39,305 square metres in the urban area and the work is in meters, which will be completed soon. Along with this, more and more rooftop rainwater harvesting work will be done by making more efforts.

The CDO said that for water conservation, rejuvenation of rivers, construction of ponds, rain water harvesting, tree plantation and construction of chak dams etc are being done in all the development blocks. "Under Corporate Social Responsibility (CSR) programme, the work of renovation of a 12 hectare pond is being done for water harvesting on a large scale in village panchayat Karkhiyaon of development block Pindra," he

India-US ties: China is the elephant in the room

he India- US relation-ship indeed seems to have come of age. There was a time when the US would invariably have a soft corner for Pakistan in its dealings and would generally hyphenate the two countries together in its dealings of the region. The Bush administration even went ahead and gave Pakistan a major on-NATO ally status, a status which continued during the Obama administration as well. So what has suddenly changed as far as the attitude of the US towards India is concerned? Or has the overall thought process changed? The US failed to make India bow to its demands after the advent of the Russia-Ukraine war, and hence is this now a 'charm offensive' by them?

The US did charm China in the 90s during the Clinton administration to keep Russia under check. Is it now trying to charm India only to keep China under check? Is India is now a long-term strategic ally of the US or just a counterbalance to China? The answers to these questions would shape the geopolitics of the world over the next decade or two, and hence we as Indians must be cautiously optimistic and not outrightly euphoric about the evolving equation with the

Support by China for the Russian offensive in Ukraine is no secret. It looks as if China wants to do the same thing to Taiwan that Russia has done to Ukraine. This has put the US on an alert, as this would make it lose considerable futuristic technology, trade and geo-political clout not only in the Indo-Pacific, but also globally. The Biden administration thereafter emphasized India's centrality in America's Indo-Pacific

The US also suggested India play a larger role in South, Central and Southeast Asia - this is obviously to counter the growing Chinese presence in the region. Is India thus a part of larger counterplay and an act of decoupling by the US? Or is India a natural democratic leader whose time has come? If the present set of events is an indication, it looks like the truth lies somewhere in the mid-

dle. If there is a country that can stand up to China's expansionist policy, it is India, for it can match up to it in soldier to soldiers, in an eyeball-to-eyeball conflict. This naturally presents an opportunity for deepening cooperation between India and the US.

Now, let's talk about the takeaways from the visit of the Indian Prime Minister to the US and the deals around defence and semiconductor businesses that were sealed. The transfer of technology by GE to HAL is significant, for it provides India with the teeth to stand up to the Chinese Air Force. The supply of predator drones is for surveillance and to keep an eye on Chinese incursions.

It would also act as a deterrence to Chinese misadventures along the LAC. The predator drones would also keep the PLA's Rocket Forces under check. The US Navy's pacts with public sector undertakings (PSUs) Mazagon Dock Limited (MDL) and Goa Shipyard to avail service and repair of their mid-voyage ships is aimed at increasing the reach of the US Navy and thereby keeping the growth of

the Chinese Navy under check. Recently, China banned

Micron, citing that it posed a security risk to China's critical information infrastructure supply chain. This has not gone down well with the US, as semiconductors are the key to future technology and China has so far led the semiconductor technology with the help of tech giants. Both the US and China has been using the phrase 'decoupling' loosely. For the US, it means discouraging imports from China to safeguard US citizens' jobs and ensure the safety and security of America's civil and military infrastructure.

From the Chinese perspective, however, decoupling is a strategic shift whereby China switches its focus from economic growth to economic control and then leverages that dominance. Controlling the semiconductor space is like controlling the future, for it opens up areas of innovation and growth of future advances in information, communication, AI, Quantum tech, blockchain, Cloud technology and Data gathering. India has grabbed this opportunity with open arms and facilitated

Micron setting up its plant in India. China may not be the overriding factor behind this deal, however, its behaviour over the last two years has acted as a catalyst.

Despite China being a non-democratic country was pampered by the West for capital gains. The West hoped in the 1990s that communist China could be encouraged to be more liberal both politically and culturally by having an open trade policy with it. However, though China did open up economically, it closed its political doors to liberal ideas even more. This attitude of the West toward helping China become the world's manufacturing hub helped China grow into the giant that it is. India is now the largest populated country with the largest youth population in the world. There can be no future world order sans India's primary role in it. Decoupling or otherwise, the time has come now when India needs to make its presence felt on the world stage both politically and economically.

¬oday every tenth person in India is an adolescent girl. A staggering 59.1% of these girls (age 15-19) are grappling with anaemia, a health complication disproportionately affecting adolescent girls.

Given the significance of anaemia in the overall health, well-being, and future development of these young girls, its potential prevention through awareness of optimal nutrition and health is crucial.

Anaemia is an intergenerational issue for women and girls - undernourished women are prone to giving birth to low-weight or premature babies. These infants are at heightened risk of being anaemic, which can increase childbirth complications.

An adolescent girl suffering from anaemia is more vulnerable to infections, reduced cognitive abilities, fatigue, weakness, lack of concentration in study and other work, and shortness of breath. -This affects their day-to-day life from the foundational years. Further, while menstruation, increased nutritional needs often go unmet due to limited awareness and gender norms. Gender-based prefer-

ential treatment often favours boys over girls in terms of food and healthcare access, deprioritising girls in terms of necessary nutrients. Medical facilities such as

regular haemoglobin screenings, IFA (Iron & Folic Acid) supplementations and deworming are critical in addressing anaemia. Healthcare services particularly in rural areas are often limited, which can escalate nutritional deficiencies. These issues are additionally exacerbated due to affordability and accessibility concerns of healthcare services in smalltown India.

The Indian government's Anaemia Mukt Bharat, a part of the broader POSHAN Abhiyan, seeks to address anaemia through services such as Iron and Folic Acid supplementation, deworm-

ing, and health screenings. Integrated with initiatives like Rashtriya Bal Suraksha Yojana (RBSK) Surakshit Matritva Aashwasan (SUMAN), Janani Suraksha Yojana (JSY), Janani Shishu Suraksha Karyakram (JSSK), and Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA), that aim to bolster maternal and child health, promote institutional delivery, and offer free

antenatal check-ups. Non-government organizations, philanthropies, and private entities also play a substantial role in improving nutrition and combatting anaemia, thereby reducing infant and maternal mortality rates (IMR and MMR). Havells India Limited, for example, has devoted its Corporate Social Responsibility (CSR) efforts to addressing malnutrition in Rajasthan, ensuring quality and hygiene through an end-

to-end mid-day meal process

for schools. Anaemia is a pressing concern that requires holistic interventions. A comprehensive three-tiered framework functioning at the policy, administrative, and multistakeholder levels can help address the various facets of the country's anaemia prob-

Policy-level action redefining food security through providing fortified foods in the Public Distribution System (PDS) must be prioritised, similar to the provision of fortified rice to all beneficiaries under the PDS by the end of FY 2024, as approved by the cabinet committee on Economic affairs in April 2022In addition, the government can implement colour-coding food packaging through Jan Aushadhi Kendras, thereby enabling widespread adoption of iron-rich foods and supplements as a result of easier identification from this tangible visual clue. THE GEOPOLITICAL **SEMICONDUCTOR STORY**

The ecosystem required for setting up a fab facility could be elaborate

↑ merican theoretical physicist Michio Kaku wrote "By 2100, our des-Atiny is to become like the gods we once worshipped and feared. But our tools will not be magic wands and potions but the science of computers, nanotechnology, artificial intelligence, biotechnology, and most of all, the quantum theory." As if on a cue, Indian external affairs minister Dr S Jaishankar in a crisp speech at the recently concluded Semicon India conference last week, outlined the entire geopolitical economic narrative being played out all around the world when it comes to building resilient, trustworthy, reliable supply chains for future of humans. Dr Jaishankar in his speech outlined the value one draws out from harnessing the power of critical and emerging technologies. He said "To begin with, it is an intrinsic element of the knowledge economy that is steadily unfolding. One of its primary characteristics is how deeply it embeds technologies in a manner that profoundly influences all aspects of our lives.

If the very nature of our economic and social activities transforms as a result, it is not surprising that CET should now emerge as one of the important metrics of power. Who invents, who manufactures, what are the market shares, where are the resources, who has the skills, where is the talent pool - these are increasingly the crucial questions. The depiction of a Chip War may be somewhat overstated, but it has more than a fundamental kernel of truth. To a considerable extent, concerns in the CET field are influenced by how market shares and production dominance was leveraged in other areas. Technology trade is not just trade; it is as much about political science. The truth is that we are seeing the re-emergence of export controls as a response to strategic assertions of economic strength. How to do business needs to be tempered with where and with



Trust and transparency are also today key issues as we debate the future of the digital domain. Who processes and harvests our data is increasingly crucial in a world of artificial intelligence. Nor indeed can we any longer separate even basic manufacturing and everyday commodities and services from their data implications. As political democracies, pluralistic societies and market economies, we all have understandable concerns about both privacy and security. It is, therefore, essential that those of us who are comfortable working with each other enhance our collaboration. Another relevant factor here is the mismatch between demographic supply and workplace demand. The pace of change that we are witnessing when it comes to CET will also create an accompanying upheaval when it comes to the required talent pool."

While the message was directed towards several of the semiconductor industry's top bosses present in the audience, the veiled reference to China wasn't missed. India announced a \$10 bn semiconductor mission in 2022, to put itself in the middle of the ongoing restructuring of international relations, specially viewed from a future technology dominance perspective. Dr Jaishankar referred to the Covid pandemic and over-concentration of production, followed by "disruption, manipulation or simply transactionalism" which caused heartburn for every global citizen. He was pitching to the Taiwan delegation (one of the largest manufacturers of chips in the world) to look at India favourably.

Taiwan's Foxconn has recently junked a nearly \$20bn semiconductor joint venture with Vedanta, however, it did not prevent the company's chairman from showing up in Gandhinagar, the venue for the Semicon India conference. As per news reports, the local market for semiconductors would be 4 times the current size of \$23bn in the next 5 yrs. It makes for a powerful case for global giants, such as Foxconn, which already has a presence in India in different domains of manufacturing, to start their semiconductor journey.

NSDC along with Ernst & Young (EY) has conducted the 'Global Skill Gap Study.' The study showcases an in-depth analysis of the global workforce markets with a prime focus on leveraging the opportunities to benefit the Indian

workforce. The study highlighted that several nations would face workforce shortages in the foreseeable future and mapped out the corresponding opportunities that these shortages present for the Indian workforce.

Canada is currently experiencing workforce shortages in sectors such as transportation, construction, agriculture, health, beauty and wellness, IT, hospitality and retail. There is no doubt that having the right skills for young people should be the most important thing in meeting the Canadian workforce. It is hoped that the NSDC and SCC partnership will provide Indian workers with the knowledge and skills necessary to thrive in the new workplace. According to the Royal Bank of Canada, there were approximately 300,000 vacancies in Ontario alone in December 2022, requiring similar skills to Canadian employers. NSDC should facilitate the training and development of office staff across the country. It is hoped that this partnership will facilitate the transfer of workers from India to Canada.

An efficient system should ensure a smooth transit from India to Canada after an extensive skills screening process to match newcomers' skills with established employers everywhere, useful for newcomers and the Canadian market. The SCC-NSDC partnership will demonstrate the power of international cooperation in solving local problems and promoting economic growth in both countries.

To bridge the global shortage of workforce in the coming years by reaping the demographic dividend of the young Indian workforce, India International Skill Centres (IISCs) - aimed at imparting international standard skill training to youth and enhancing overseas opportunities for them – have the potential to transform our country into the skill capital of the world.IISCs will also have a wide network of partner organisations and overseas recruiters to facilitate the supply of skilled and certified workforce in other countries.

These partnering organisations will work with the National Skill Development Corporation (NSDC) to aggregate demand from overseas markets. The centres will have services such as mobilisation, counselling, skill training, pre-departure orientation, foreign language training, placement and immigration and post-placement support. India has signed memorandums of understanding and other administrative agreements in the field of apprenticeship and skill training with Germany, Belarus, the United Kingdom, France, Australia, Japan and Qatar.

The government initiatives to improve or impart skills to our youths have not been successful in the past. This hints at a systemic problem that affects the talent ecosystem. A major challenge that currently our unemployed youth face is the mismatch between their skills and the needs of global job providers. Search costs are prohibitive for employ-

ers and a candidate's qualifications are difficult to verify. There seem to be many jobs available on different platforms but there is no real way to establish the quality of job roles. For someone to successfully navigate through this maze would be almost impossible. Similar issues plague the arena of skilling. Candidates looking to upskill themselves find it difficult to connect them selves with credible skill providers, and the so-called 'certified' trainers often do not have the required skills to make them decently employable globally.

National Skill Qualification Framework (NSQF) should be globally aligned with certificates. There should be a focus on the identification of transferable skills. This can be done by developing a skills or trade matrix; and highlighting the overlap of skills across different trades, such as information and communication technology (ICT), knowledge of languages, beauty-wellness etc. The most common transferable skills across the world should be made part of the employable skill development curriculum.

As an industry expert, I can vouch for that by 2047, India will be the world's largest exporter of skilled workforce, and the Indian economy will reach trillions of dollars. Floods are the biggest disaster in India. About 12 per cent of India's landmass (40 million hectares) is vulnerable to flood, while river erosion and hilly areas are at risk from landslides. Between 1980 and 2021, 265 floods occurred in India, 132,286 people died and 1.93 billion people were affected. Financial loss from the flood was as high as US\$58.7 billion. Floods in India account for 68% of all disasters and economic losses.

Deforestation and forest cover in the basin area led to soil erosion and siltation of the riverbed, increasing the number of floods and reducing the carrying capacity of river channels. The massive rise in population has resulted in the expansion and encroachment of floodplains catchments area in rivers. Urban flooding is the result of such unbridled expansion without a proper drainage network and proper planning for waste disposal. Unplanned growth of urban areas has increased pressure on natural resources like extracting sand faster than it can be replenished naturally.

Large amounts of sand, both legal and illegal mining not only destroy banks and riverbeds but also make them prone to flooding. When ing the local population very vulnerable to flooding, soil extraction is done rampantly from riverbeds may cause a rapid change in bed configu-

In addition, the lack of appropriate information on the environmental impact of water sand mining is a major gap. Therefore, scientific assessment is the basis for developing management strategies for sand mine-hit areas. In this background, a recent study by the World Wide Fund for Nature (WWF) examined the environmental impact of sand mining and the flooding of rivers. Major rivers such as the Ganges, Yamuna, Satluj, Ravi, Bias, and Ghaggar swell, causing breaches. This has lowered

the deltas of the rivers, mak-

loss, water pollution, and severe crop damage.

DISASTER RISK COVERAGE NEEDED Manmade and natural disasters have many direct and indirect impacts on people at all levels, including loss of life, destruction, damage, and financial consequences to public and private property and infrastructure as well as fiscal impacts arising from recovery and reconstruction expenditures. Restoring livelihoods and rebuilding economic and social relationships requires a lot of substantial financial resources, so financial strategies are needed to manage the financial impact of natural and human-

induced disaster risks.

The State Disaster Response Funds have limitations because the central government contributes 75% and is only used to cover the costs of emergency relief to people affected by the notified calamities. Funds will be released upon proof of previous use of funds and receiving a report from the state government on SDRF's activities. Therefore, there is a need to promote comprehensive and affordable disaster insurance. Many countries have established various types of public-private partnerships to support disaster risk management. Tax incentives, subsidies, and other forms of regulation can be used to provide adequate insurance.

'Pak Cabinet OKs security pact with US'

 $P^{akistan's\,Cabinet\,has\,quiet}_{ly\,approved\,the\,signing\,of}$ a new security pact with the US, a move that indicates a fresh start in bilateral defence cooperation after years of wilderness in ties and may open avenues for Islamabad to get military hardware from Washington, a media report said on Thursday.

The Cabinet, through a circulation summary, gave its seal of approval to the signing of the Communication Interoperability and Security Memorandum of Agreement, known as the CIS-MOA, between Pakistan and the US, The Express Tribune newspaper reported.

However, there was no official announcement from either side about the signing of the agreement. According to the report, Federal Minister for Information Marriyum Aurangzeb was approached but did not respond.

The development comes days after Pakistan and the US agreed to further enhance their bilateral relations, including in the defence field, at a meeting between US Central Command (Centcom) chief General Michael Erik Kurilla and Pakistan's Chief of Army Staff (COAS) General Asim Munir.CIS-MOA is a foundational agreement that the US signs with its allies and countries with which it wants to maintain close military and

defence ties. It also provides legal cover to the US Department of Defence for ensuring the sale of military equipment and hardware to

The signing of the CIS-MOA means that the two countries are keen to maintain the institutional mechanism. The agreement, first signed between the Joint Staff Headquarters of Pakistan and the US Department of Defence in October 2005 for 15 years, expired in 2020. The two sides have now renewed that arrangement which covers joint exercises, operations, training, basing and equip-

The signing of the CIS-MOA indicates that the US might sell some military hardware to Pakistan in coming years, a source in Washington was quoted as saying in the

However, a retired senior Army officer who previously dealt with the US played down the development and said that it was not easy for Pakistan to buy military hardware from the US despite this agreement.

Referring to the growing strategic ties between the US and India, the officer said Washington's long-term interests are not aligned with

Nevertheless, the US needs Pakistan in some critical regions, and hence this agree-

'Pak's spy agency using Israel's cyber tech since 2012'

Tsraeli cyber tech firm, Cellebrite, has sold Pakistan's Federal Investigation Agency (FIA) and various police units products that are highly intru-sive and can lead to gross human rights violations despite the two countries not having diplomatic ties and Israeli norms prohibiting such deals, a local media report said on

The Ísraeli firm's products have been in use by Pakistani agencies since 2012, Ha'aretz newspaper reported in an

Cellebrite's flagship prod-uct, UFED, is traded in Nasdaq and enables law enforcement agencies to engage in digital forensic work by hacking into password-protected cell phones and can copy information stored on the device, including

sages, call logs and contacts.
Unlike Israeli company NSO, whose sale of Pegasus cyber tech grabbed worldwide attention, and other manufacturers of offensive-cyber products, Cellebrite operates in a grey area between security exports and civilian ones. In 2020, the export of

forensic equipment such as that produced by Cellebrite came under the Defence Ministry's oversight, since it was included in the Wassenaar Arrangement on Export Controls for Conventional Arms and Dual-Use Goods and Technologies, which defines which dual-use (security use and civilian use) products require oversight, the report noted.

However, International shipment records show that until at least 2019, Cellebrite

Asia-Pacific Pte (its Singapore subsidiary) sold products directly to companies in Pakistan and to its Federal Investigation Agency, the Israeli

daily reported. This happened despite Cellebrite's end-user license agreement forbidding sales to

In other proofs presented in the report, the investigative piece notes that in 2012 it was reported in Pakistan that the Sind Province police had acquired UFED Touch Ultimate devices made by Cellebrite, and their use has been expanding since. The Express Tribune news-

paper had also published pictures that clearly show Cellebrite's product, the Israeli "Operating manuals, doc-

uments and official invitations for bids show that police units systems," Ha'aretz claimed.

"FIA officials, past and present who were tasked with enforcing the draconian cybercrime law, even state in their LinkedIn profiles that they have been trained and certified to use these systems and that they use them on a regular basis", it noted.

Court rulings in Pakistan also refer to the extraction of forensic evidence from telephones but do not specify which technology was used, the report said. The country's different

agencies use forensic systems made by other companies as well, but in an FIA invitation for bids from 2021 for systems made by two other firms, Belkasoft and Compelson, both were required to support files produced using Cellebrite's technology, the report stressed.

Bidding requests issued by Pakistan's Punjab police include a request for three UFED Ultimate devices, it further added.

Another bidding request by the counterterrorism division of the Peshawar police, from May of this year, also includes a request to renew the UFED license for another two years.

In yet another strong proof presented of the Israeli firm's firm roots in Pakistan, a 2021 catalogue from Pakistan's National Radio and Telecom m u n i c a t i o n Corporation (NRTC) touts a long list of technologies produced in the country.

On page 17, there is a listing for a UFED Touch 2 by Cellebrite. On the next page, NRTC advertises BlackBag's Mobilyze digital forensic technology, which was acquired by Cellebrite in 2020, the report

'(We'll mobilize) against all forms of threats to continue the struggle for the sovereignty of the people. The dignity of the Nigerian people will be respected by all without exception."

The march falls on the

West African nation's independence day from its former colonial ruler, France, and as anti-French sentiment spikes, more than one week after mutinous soldiers ousted the country's democratically elected president. Protests are expected throughout the capital, Niamey, to push back against foreign meddling. The coup has been strongly condemned man and unprecedented.

Palestinian foreign minister on Thursday attacked the Biden administration as weak and passive in the Middle East, as violence between Israel and the Palestinians surges to its highest levels in nearly two decades. The comments by Riad Malki reflected the Palestinian frustration with US. President Joe Biden, who initially won plaudits from the Palestinians when he rejected the Trump administration's unabashedly pro-Israel stance. But Biden so far has done little to follow through on that vision "I'm frustrated," Malki told members of the Foreign Press Association, an organisation representing international media outlets in Israel and the Palestinian territories. "It seemed that (Biden)

wanted to change all policies Trump has taken, but not when it comes to Palestine."

Pressured by Israel's farright government, increasingly isolated in the Arab world and running out of money, the Palestinian Authority is confronting what analysts say could be its greatest threat to its existence. Malki said the Biden administration has been mealymouthed about the expansion of Jewish settlements, the escalation of Israeli military raids in the West Bank that have killed a growing number of Palestinians and the daily abuses of the open-ended Israeli occupation.

He also lashed out at Biden's failure to to reverse several measures taken by the Trump administration that Palestinians saw as undermining their quest for statehood. 'We have a weak (US) administration when it comes to Palestine," he said. The US has not reopened its consulate to the Palestinians in Jerusalem, which was closed under President Donald Trump. 'Won't allow army to take any unconstitutional steps'

akistan's Chief Justice Umar Ata Pandial on Thursday said that the country's top judiciary would not allow the army to take any unconstitutional step. Chief Justice Bandial made the remarks while hearing a set of petitions challenging civilian trials in military courts of those accused of attacking military installations during the May 9 protest. Referring to the incident of arson and violence by the supporters of former prime minister Imran Khan, the top judge termed the riots as serious, expressing regret and grief over the happening on that fateful day.

On May 9, violent protests erupted after the arrest of Khan by paramilitary Rangers in Islamabad. Over 20 military installations and state buildings, including the army headquarters in Rawalpindi, were damaged or torched in the violent protests that followed Khan's arrest. The violence elicited a strong reaction from of taking action against the culprits, leading to an ongoing crackdown against those involved.

The chief justice praised the armed forces for not opening fire on civilians despite the violence on May 9 but added that "the military will not be allowed to take any illegal steps". He also said that the hearing would

not be conducted for about two weeks due to the unavailability of judges and asked the Attorney General of Pakistan (AGP) Usman Awan to ensure that the trial of civilians is not held during this period."AGP sahib, no military trials of civilians will be conducted," he told Awan, who assured the court that its directives would be followed.

Bandial also said that the earlier directives to provide relevant facilities to the suspects in the custody of military authorities would remain in place.

China proposes to limit children's screen time

hina's internet watchdog has laid out regulations to curb the amount of time children spend on their smartphones, in the latest blow to firms such as Tencent and ByteDance, which run social media platforms and online games. The Cyberspace Administration of China on Wednesday published the draft guidelines on its site, stating that minors would not be allowed to use most internet services on mobile devices from 10 p.m. to 6 a.m., and that children between the ages of 16 and 18 would only be able to use the internet for two hours

Children between the ages of 8 and 15 would be allowed only an hour a day, while those under 8 would only be allowed 40 minutes. Only certain services, such as apps or platforms that are deemed suitable to the physical and mental development of minors, will be



specify which internet services would be allowed exemptions.

The restrictions are Beijing's latest efforts to attempt to limit internet addiction, a problem it views as widespread among its youth. In 2019, Beijing limited children's daily online game time to 90 minutes a day and tightened those restrictions in 2021, allowing children only an hour a day of online game play on Fridays, weekends and public holidays. Short-video and online video platforms like Douyin, Bilibili and Kuaishou have offered

type of content shown to minors and the length of time they can use the service. Children are also pushed educational content, such as science experiments.

The latest restrictions

would impact firms like Tencent, China's largest online company, ByteDance, which runs popular short-video platform Douyin. Firms in China are often responsible for enforcing regulations. To effectively strengthen

the online protection of minors, the CAC has in recent years pushed for the establishment of a youth mode on internet platforms, expanding its coverage, optimising its functions and enriching it with age-appropriate content," the CAC said. The Greenpeace activists had climbed onto the roof of Sunak's sprawling constituency home in Richmond, North Yorkshire, to unfold 200 square metres of "oil-black fabric" to cover one side of the mansion.

The local North Yorkshire Police issued a statement to say that its officers had responded to the protest activity at the Prime Minister's home in Kirby

"Officers have contained the area and no one has entered the building. The PM and his family are not at home," the police said. It confirmed the arrests on Thursday afternoon after the four protesters finally climbed down from the roof after around three hours and were seen being led away into the back of police vans.

Sunak, along with wife Akshata Murty and daughters Krishna and Anoushka, is currently away on a week-long holiday in California.

Asked about the incident, deputy prime minister Oliver Dowden told the BBC he thought the British people were "sick of these stupid stunts".

Two other Greenpeace activists unfurled a banner emblazoned with the words

13 injured as man goes on stabbing spree in South Korea

Seoul (AP): At least 13 people were injured in South Korea on Thursday when a man rammed a car onto a sidewalk, before stepping out of the vehicle and stabbing people inside a shopping mall in the city of Seongnam. Yoon Sung-hyun, an official from the southern Gyeonggi provincial police department, said at least nine people were stabbed and four others were injured by the vehicle in the attacks that occurred in a crowded leisure district near a subway station. Police did not confirm whether any were in serious condition. Police were questioning an

unidentified suspect in his 20s who was arrested at the scene. Police officials did not immediately comment on any potential motive for the attack Photos from the scene showed forensic units examining the halls of the AK Plaza, where the stabbings took place.

Violent unrest is escalating in Ethiopia's Amhara region as federal security forces clash with a local ethnic militia, leading the deputy prime minister in an unusually outspoken statement to call the situation "increasingly grave."

Ethiopia's second most populous region has been gripped by instability since April, when federal authorities disarmed the Amhara regional force as part of the recovery from a devastating two-year conflict in the neighbouring Tigray region. Authorities last year also tried to dismantle the Amhara militia known as Fano.

Both forces had fought alongside federal ones in the Tigray conflict, but now the federal government wants to centralise its security powers.

Many Amhara, however, are deeply attached to their regional fighters and accuse the federal government of trying to undermine their region, which federal officials reject.

Deputy Prime Minister Demeke 'Mekonnen on Wednesday called for dialogue to seek a peaceful resolution and described some of the concerns of the Amhara population as "understandable." His comments came a day after the Fano fought with federal police at the airport in Lalibela, a key supply point, according to two witnesses and several residents. Flights to

Britain on Tuesday issued travel warning describing the Lalibela airport as "taken over by Fano militias" and noted instability along the A2 highway that links the eastern part of the Amhara region with Addis Ababa, Ethiopia's capital. The internet has been shut down in several parts of the Amhara region, the Ethiopia-based Center for Advancement of Rights and Democracy said Thursday.

Elsewhere in the Amhara region, residents said protesters blocked roads and Fano militia ambushed military units, while government officials fled several towns.

A witness said there was "heavy fighting" in Gondar, another popular tourist town, on Thursday. All spoke on condition of anonymity out of fear for their safety. Flight tracking data showed canceled flights from Ethiopia's capital to Gondar.In Kobo, the military used artillery against the Fano on Monday night and Tuesday morning, damaging homes, two residents said. Gunfire could be heard in Debre Tabor on Wednesday, according to a witness, who said the military used live ammunition to disperse stone-throwing youths on Tuesday. Sensex, Nifty fall for 3rd day

US rating downgrade triggers global equity sell off

enchmark Sensex tanked 542 Bounts to settle at a four-week low while Nifty closed below the 19,400 mark, extending their losses for a third straight day on Thursday in tandem with a bearish trend in global markets following the US rating downgrade.

The 30-share BSE Sensex fell by 542.10 points or 0.82 per cent to settle at a four-week low of 65,240.68. During the day, it slumped 819.7 points or 1.24 per cent to 64,963.08.

The NSE Nifty declined below the 19,300 mark in intraday trade before paring some of the losses to close at 19,381.65, still down by 144.90 points or 0.74 per cent. It moved in a range of 19,537.65 to 19,296.45 in day trade.

In three days of losses, Sensex plunged by around 1,287 points or 2.16 per cent while Nifty has tanked 372 points or 2.42 per cent.

Global markets are still grappling with the impact of the US rating downgrade, with spiking bond yield and strengthening dollar index," Vinod Nair, Head of Research at Geojit Financial Services

Fitch Ratings lowered the US government credit rating by one level, citing rising debt and a steady deterioration in standards of governance. The downgrade triggered a sell-off in US stock markets.

From the Sensex pack, Titan fell the most by 2.56 per cent after the company reported a 4.3 per cent drop in consolidated net profit at Rs 756 crore for the June

Ease of doing biz: DPIIT to help States in simplifying, decriminalising provisions

The Centre will help states a simplification, rationalisation of The Centre will help states in tion or decriminalisation of provisions with a view to promoting ease of doing business and living in the country, a top government official said on

Secretary in the Department for Promotion of Industry and Internal Trade (DPIIT) Rajesh Kumar Singh said that Parliament passed a bill which seeks to promote ease of business by decriminalising minor offences through amendments in 183 provisions of 42 Acts.

"We will do this in the future as well...We intend to follow with an inter-ministerial working group which will look at other provisions where further simplification, rationalisation or decriminalisation is possible and we are intending to do the same exercise at the state level by



providing guidance to the states as well," he told reporters here.

He said that there will be many more rounds of this exercise with the overall objective of promoting ease of doing business and ease of living.

The Jan Vishwas (Amendment of Provisions) Bill, 2023 was passed by Rajya Sabha by a voice vote on August 2. Lok Sabha cleared the legislation on

The bill converts several fines to penalties, meaning that court prosecution is not neces-



India can become USD 6.7 trillion economy by 2031: S&P Global

Tndia can become a USD 6.7 **⊥**trillion economy by 2031, from USD 3.4 trillion currently, if the country clocks an average growth of 6.7 per cent for 7 years, an S&P Global report said on Thursday. India had clocked a 7.2 per cent GDP growth in 2022-23 fiscal. But a global slowdown and lagged effect of a policy rate hike by RBI could slow down growth to 6 per cent in the current fiscal, S&P Global said in a report titled 'Look Forward: India's Money'.

We expect India to grow 6.7 per cent (average) from fiscal 2024 to fiscal 2031, catapulting GDP to USD 6.7 trillion from USD 3.4 trillion in fiscal 2023. Per capital GDP will rise to report jointly authored by S&P Global Ratings Global Chief Economist Paul Gruenwald, Crisil Chief Economist Dharmakirti Joshi and S&P Global Market Intelligence Chief Economist Asia Pacific Rajiv Biswas.

The macro challenge for India in the upcoming decade is to turn traditionally uneven growth into a high and stable trend, it said. Capital accumulation will drive India's economy toward this desirable path with the government and increasing-

After the practice games in Bengaluru, the Netherlands will travel either to Hyderabad or Thiruvananthapuram for official warm-up matches.

However, Hyderabad is the preferred destination of the Dutchmen because they will play their first two World Cup matches in the city. Netherlands will open their World Cup campaign against Pakistan on October 6 at the Rajiv Gandhi International Stadium, while on October 9 they will take on New Zealand at the same venue.

The busy schedule for Netherlands ahead of the qua drennial showpiece assumes importance because their coach Ryan Cook had made an emotional plea to allot them some matches in the sub-continent to get acclimatised to the conditions. "This is a call-out to anyone who wants to play us. We'd love to have a fixture or two. Our guys have not been to the subcontinent many times before so it would be good to have some fixtures somewhere in the subcontinent as well," Cook had said post their World Cup entry.

"In the bowling department, you can't have two teams. If Bumrah doesn't play we will lose, like we did in Asia Cup T20 and 2022 T20 World Cup. We don't have his back up. At the moment the team is not looking the strongest on paper as it is missing key players including K L Rahul, Pant, Iyer, and the biggest factor is Bumrah," said the 42-year-old.

"I won't judge the team for what it has done on the West Indies tour. If Rohit Sharma and Kohli had to take a break then they should not have been part of the squad. I will judge them from Asia Cup and the 15 they pick for the tournament," said Kaif

"From Asia Cup onwards,

they have to be sure what their 11 is and what their backups are. He will be in the squad as he has done well. I am not sure if Kishan, SKY, Samson, and Iyer, all of them won't be in the 15."

'It remains to be seen if Kishan will be the backup wicket-keeper to Rahul. World Cup for India will start with the semifinal. They will need to win two big games to lift the title," he

Former England skipper Nasser Hussain expects pace bowler James Anderson to tour India for the gruelling five-Test series early next year, saying that with pacer Stuart Broad and allrounder Moeen retiring, the experience of the 41-year-old will come in handy in sub-continental conditions.

Anderson, the highest wick-et-taking quick in Test cricket, would be more than keen to tour India for the series, scheduled to commence in January next year, after an ordinary bowling effort during the recently concluded "Jimmy's (Anderson) got a

very good record against India... And you need a balanced attack. You need that experience for younger players to come in," Hussain said on The ICC Review on Thursday.

Anderson has a good record against India, with six of his 32 five-wicket hauls in Tests coming against them. His average in the Asian country (29.32) is decent in comparison to other places he has played in.

"Listen, Jimmy's had a bad or an average couple of months, but you are a fool if you're writing off Jimmy Anderson. I spoke to him in an interview and he was like, the hunger is still there. He's already thinking about how to get back to his best," added Hussain.

Hussain added that with the Ashes now history, Anderson was looking ahead to newer challenges and aiming to hit the nets soon.

"He's already thinking about going back in the nets and working hard at his game and that's a good sign for me that he's still got that hunger. He's, what, 10 wickets away from 700 (Test wickets), and that will keep him

going for a while yet. England have been hit by a oate of retirements, notably by

all-rounder Moeen Ali and pacer Broad. But Hussain felt that while the absence of the two stalwarts will be felt, the team has depth in their bowling ranks to perform well in India. "I think especially with

Broad going, I would like that experience (of Anderson in India).'

(All-rounder) Chris Woakes has stated that he's not that keen anymore of playing away from home and his

record's not great away from home. We'll see, he (Woakes) might change his mind. There's been a lot of mind changes recently. But if you don't have Woakes and you don't have Broad, you will need that experience of someone like Jimmy Anderson," added Hussain.

Hussain added that tour of India will pose then next biggest challenge to "Bazball", a term which has come to be associated with England's aggressive style of play under coach Brendon McCullum and skipper

ously Jofra Archer is injured.
"You need that extra pace as well in India. So England have got...They've got that lad (Gus) Atkinson at Surrey, who has a lot of good things being said about him. So England have options. It's (India) the next test for Bazball. They said Bazball will work against one side, then

they moved on to the next side. Then they moved on to New Zealand, Australia, Pakistan. The next challenge is India and everyone knows India in India is one of the sternest challenges in Test match crick-

Hussain indicated he was keen to know how "Bazball" will work against the likes of India's ace spinners like Ravichandran Ashwin, Ravindra Jadeja and

Axar Patel. "It's Bazball against spin. Bazball against Ravi Ashwin, Jadeja and Axar Patel and that is going to be fascinating.
