3 killed in Manipur, bodies desecrated

Tragedy struck Manipur's Bishnupur district on a fateful Friday night when terrorists carried out a ruthless attack, claiming three lives, including that of a father and

Three others were injured. The violent episode cast a shadow over the Imphal valley, coinciding with a 24-hour general strike organised by the coordinating committee of 27 Assembly constituencies, paralysing normal life in the

As the night unfolded, the victims fell prey to the bullets while they lay asleep, their bodies later desecrated with swords in the heartless attack at Kwakta. The deceased, once seeking refuge in a relief camp, had dared to return to their homes in Kwakta, hoping for better days, only to meet this

The brutal act stirred a tide of anger among the locals, leading to an agitated mob assembling at Kwakta, wanting Churachandpur.

However, security personnel intervened to prevent any further escalation of violence. The agitated mob set ablaze several houses in Ukha



Amid the turmoil, the hill districts managed to maintain a semblance of normalcy, but the general strike impacted normal life.

The committee's leader, L Binod, emphasised that the strike aimed not to exacerbate the hardships faced by the citizens but to exert much-needpressure on the

Meanwhile, the Manipur Cabinet recommended the State Governor to convene a session of the Assembly on August 21. The last Assembly session held in March seemed distant in memory as the State

grappled with ethnic violence that began in May, continuing to claim innocent lives in sporadic bursts, pushing the death toll to over 160.

The recent announcement of a public mass burial of tribals killed during these riots heightened tensions, with talks between former Kuki terrorist organisations and the Centre further complicating matters.

As the State reeled under the shadow of violence and uncertainty, the Indigenous Tribal Leaders' Forum (ITLF) sought answers from the Government on addressing the security threat posed by the rampant looting of guns and ammunition by mobs.

Expressing concern over the lack of safeguarding Government-issued weapons during the ethnic conflict, the ITLF warned that Manipur could face a catastrophic bloodbath if prompt action is not

Despite the grim situation, the people's resilience manifested through the strike, effectively bringing life to a standstill in the Imphal Valley. Markets, business establishments, and schools remained shut as public transport van-

Chandrayaan inserted into **lunar orbit**

ndia's ambitious third Moon **⊥**mission's 'Chandrayaan-3 spacecraft was successfully inserted into the lunar orbit on Saturday, ISRO said. The required manoeuvre was done from an ISRO facility here, the city-headquartered national space agency said in a tweet.

"Chandrayaan-3 has been successfully inserted into the lunar orbit. A retro-burning at the Perilune was commanded from the Mission Operations Complex (MOX), ISTRAC (ISRO Telemetry, Tracking and Command Network), Bengaluru," ISEO tweeted. Perilune is the spacecraft's closest point to the moon.

The next operation reduction of orbit — will be done at 11 pm on Sunday, ISRO added. ISEO also shared a message from the satellite to its centres, which read, "MOX, ISTRAC, this is Chandrayaan

3. I am feeling lunar gravity."
According to ISRO sources, there will be four more Moon-bound manoeu vres to bring the satellite closer to the Moon, which is a 100 kilometre circular orbit.

Imran gets 3-yr jail for graft, arrested

Conviction for selling state gifts bars him from fighting polls for 5 years

Imran Khan was arrested on Saturday after the embattled former Pakistan Prime Minister was found guilty in a high-profile corruption trial and sentenced to three years in prison, a verdict that disqualified him for five years from holding any public office.

Additional Humayun Dilawar of the Islamabad-based district and sessions court found Khan, 70, guilty of unlawfully selling state gifts during his tenure as prime minister from 2018 to

The unexpected developments came as Pakistan is heading for general elections later this year, with the current National Assembly set to complete its term on August 12.

The judge also imposed a fine of Rs 100,000 on Khan, adding that the chairman of the Pakistan Tehreek-e-Insaf (PTI) party would be kept in jail for another six months if failed to pay the fine.





planetary missions. The propulsion module will carry the lander and rover configuration till 100 km lunar orbit. The propulsion module has Spectropolarimetry of Habitable Planet Earth (SHAPE) payload to study the spectral and polarimetric measurements of earth from the lunar

The mission objectives of Chandrayaan-3 are to demonstrate safe and soft landing on the lunar surface, to demonstrate rover roving on the Moon, and to conduct in-situ

scientific experiments. The lander will have the capability to soft land at a specified lunar site and deploy the rover that will carry out in-situ chemical analysis of the Moon's surface during

the course of its mobility. The lander and the rover have scientific payloads to carry out experiments on the lunar surface.



Couple arrested for financial fraud

New Delhi: A couple was arrested from Maharashtra for allegedly mortgaging a property with different financial institutions using forged documents and availing loans, police said on Saturday.

A case was registered on the complaint of an assistant manager of a finance services company alleging that Anjana Jain, proprietor of a fashion outlet, and Jitender Jain, proprietor of a sweet shop, had got sanctioned a loan of Rs 2.6 crore against their residential property from the complainant company in 2014, a senior police officer said. antibiotic treatment in all cases, he said, adding that hand and facial hygiene are very important to prevent its spread. There is no approved treatment but topical corticosteroids may be helpful in a subgroup of patients with adenoviral conjunctivitis and may prevent

scarring in severe cases. "It should be noted, however, that treatment guidelines suggest caution in the use of corticosteroids because they can potentially prolong infection," Bhalla said. Dr J S Titiyal, chief of the RP Centre at AIIMS, said the condition is usually caused by

viruses, which are highly contagious and spread quickly. He said the RP Centre found adenovirus to be the causative agent in all cases tested. Among these, nearly 20-30 per cent of cases have a positive bacterial culture as well, pointing towards superadded bacterial infection, Titiyal added. 'The viral infection of the

eyes is self-limiting and one can recover in one to two weeks. However, secondary bacterial infection may rarely occur and delay recovery," he said. "In such cases, use of antibiotic eye drops is advised.

However, Bhalla said primary or urgent care physicians may prescribe antibiotics without making an informed differential diagnosis, adding that misdiagnosis of viral etiologies as bacterial conjunctivitis and the resulting inappropriate use of antibiotics can occur in as much as 50 per cent of cases. This can lead to inappropriate antibiotic prescriptions and the risk of antibiotic resistance, the doctor added. Both Bhalla and Titiyal warned against the indiscrim-

inate use of steroid eye drops, saying over-the-counter steroids should not be used unless advised by an ophthalmologist for specific indications. "Since it provides rapid relief of symptoms due to its anti-inflammatory properties, patients feel symptomatically

As per the statement, Special Representative of the Chinese Government on Eurasian Affairs Li Hui will lead the Chinese delegations at the event. China's participation is significant since it has been a longtime ally of Russia in war.

India, Nepal review bilateral relations during telephonic conversation

NIA arrests 1 for IED test in ISIS Maha module case

In its sixth arrest in the ISIS Maharashtra module case, the National Investigation Agency (NIA) on Saturday took into custody one Aakif Ateeque Nachan for his involvement in the fabrication and testing of Improvised Explosive Devices (IED) for commission of terrorist acts and arranging a hideout for two other terror operatives.

"Aakif was found actively involved in promotion of the terror related activities of the ISIS, a designated Foreign Terrorist Organisation, in collaboration with four other accused, namely Zulfikar Ali Barodawala, Mohammed Imran Khan, Mohammed Yunus Saki and Abdul Kadir Pathan (all arrested recently by ATS Pune), along with some other suspects, the NIA said in a statement.

Khan Imran Mohammed Yunus Saki, members of 'Sufa terrorist gang' were absconding and had been declared 'most wanted' by the NIA in a case relating to recovery of explosives from a car in Rajasthan in April 2022. The NIA nabbed Aakif after a series



of raids in Borivali, Tehsil Bhiwandi in Thane. Several incriminating materials, such as electronic gadgets and documents were also seized during the raids, the NIA said. Besides assembly of IEDs

and purchasing materials and components for the fabrication of IEDs, Aakif had facilitated the stay of Imran and Yunus at a house in Kondhwa, Pune. The accused had organised and participated in bombmaking workshops in Kondhwa in 2022 and had also been involved in preparation of a demo IED and conduct of a controlled explosion at this location, it said. As per NIA investigations,

the accused had hatched a conspiracy to further the terrorist activities of ISIS (also known as Islamic State (IS)/Islamic State of Iraq and Levant (ISIL)/Islamic State of Iraq and Syria (ISIS)/Daish/ Islamic State in Khorasan Province (ISKP)/ISIS Wilayat Khorasan/Islamic State of Iraq and the Sham Khorasan (ISIS-

Aakif had planned to commit terrorist acts to disturb the unity, integrity, security and sovereignty of the country, and wage a war against the Government of India, it said.

This is the sixth arrest by NIA in the ISIS Maharashtra module case, relating to the ISIS conspiracy to disrupt the nation's peace.

The case was registered by the NIA on June 28, 2023. Last month, the NIA had arrested five accused, Tabish Nasser Siddiqui from Mumbai, Zubair Noor Mohammed Shaikh alias Abu Nusaiba from Pune, and Sharjeel Shaikh and Zulfikar Ali Barodawala from Thane and Dr Adnan Sarkar from Kondhya, Pune. The arrests had followed extensive searches by the NIA in Mumbai, Thane and Pune.

Munnar Villa Vista Pvt Ltd assets worth ₹2.53 cr seized

The Enforcement Directorate (ED) has taken possession of immovable properties having book value of Rs 2.53 crore belonging to Munnar Villa Vista Pvt Ltd. on money laundering charges in the Popular Front of India and others case.

The properties whose possession the ED has taken include four unsold villas measuring 338.03 sq. mt. and 6.75 acres of vacant land of the Munnar Villa Vista Project, the ED said in a statement

The ED had issued a Provisional Attachment Order in respect of the properties on January 7 that was confirmed by the Adjudicating Authority on June 30. The ED initiated investigation on the basis of an FIR and charge sheet filed by NIA, Kochi before Special Court for Trial of NIÀ cases, Ernakulam, Řerala.

According to the FIR and related charge sheet, a group of PFI / SDPI (Socialist Democratic Party of India) activists entered into a criminal conspiracy to impart training to their cadres in use of explosives and weapons and organized a terrorist camp at Narath in Kannur District.Subsequently more FIRs against members of PFI and its related entities were taken within the ambit of Prevention of Money Laundering Act (PMLA) investigations in the

The ED said its investigation revealed that PFI leaders and members associated with overseas entities were developing a residential project Munnar Villa Vista Project (MVVP) at Munnar, Kerala with a motive to launder money collected from foreign countries as well



as within the country and to generate funds for PFI to finance its radical activities. The project was being developed by forming a company in the name of Munnar Villa Vista Pvt. Ltd.

ED investigation further revealed infusion of large volumes of unaccounted cash in the project, subscription of shares of MVVPL in cash in the name of ghost shareholders, transfer of shares of MVVPL without any consideration, and bogus transfers made to other companies without any supply of goods or services.

As a result of ED investigation into the money laundering activities of MVVPL and its key persons, total 'Proceeds of Crime' to the tune of Rs 21.9 crore were quantified.

Prosecution complaint or charge sheet was

filed before the Special Court of PMLA cases, Lucknow on May 6. Charges have been framed in the case and trial is underway.

ED raids 9 places linked to TN MLA in job scam

 $T_{\text{Directorate (ED) on Saturday said it has conducted}}^{\text{he Enforcement}}$ searches at nine locations linked to Tamil Nadu MLA Thiru Senthil Balaji who was arrested in a cash-for-jobs scam and is currently in Central Prison, Puzhal, under judicial custody.

The ED initiated investigation on the basis of three FIRs registered by the Central Crime Branch (CCB) in Chennai, related to the 'Cash for Jobs Scam'.

During the investigation, intelligence inputs indicated that one of Balaji's close associates, ST Saminathan, possessed incriminating documents/proceeds of the crime and attempted to hide/transfer

Consequently, searches were conducted at his premises. It was discovered during the search that a relative of ST Saminathan, Shanthi (sister-inlaw), is acting as benami of ST Saminathan and was seen moving bags containing documents and valuables. As a result, the investigative teams covered Shanthi's premises under the

However, Shanthi was not present at the location. Further scrutiny of CCTV footage and investigation revealed that the bags had been handed over to the driver Thiru Shiva.

search operation, the ED said.

When Shiva's house was searched, he had already absconded and turned off his mobile phone upon hearing about the searches at Shanthi's house, it said.

During the search at Shiva's residence, cash amounting to Rs 22 lakh and unaccounted valuables worth Rs 16.6 lakh along with unexplained property documents for 60 land

parcels has been found, it said. Shanthi, who is a housewife, did not cooperate and participate in the search proceedings.

ED investigation revealed that she has no source of income. Shiva, in his statement, admitted that Shanthi gave him the bags out of fear that incriminating details would be discovered. Based on the ongoing investigation, it appears that seized property and cash belong to ST Saminathan, a close associate of Balaii. Further investigation is under progress.

New Delhi: Urbanisation has aggravated the prevalence of inflammatory bowel disease (IBD) in India, increasing to more than 5 per cent compared to 0.1 per cent in 2006, according to a study published in The

symptoms such as abdominal

chronic pain, bowel habit

changes and chronic diarrhoea,

the study conducted by the

IBD is a chronic illness characterized by symptoms varying from bloody diarrhea, weight loss, fever, fatigue, abdominal pain to anemia, joint pain, skin problems among others. IBD accounted for more than 5 per cent of patients presenting lower gastrointestinal



Institute of Gastroenterology (AIG), Hyderabad, has found.

The figure of 5 per cent remained unchanged between urban and rural populations, the researchers said, after evaluating nearly 31,000 patients displaying lower gastrointestinal (GI) symptoms from March, 2020 to May, 2022. A previous rural survev conducted by the same institute in 2006 estimated IBD

prevalence at 0.1 per cent, the study said. Urbanisation could be a likely cause behind the trend, say the researchers, citing Asian countries like Japan and Korea which have reported a rising prevalence, and both of which experienced rapid industrialisation after World War II. The last two decades have

seen an increasing incidence and prevalence of IBD in the Asia-Pacific region and that India appeared to be in an accelerated industrialisation phase, with a rapidly increasing IBD incidence, they said in the study. If the trend continued, then the number of affected could likely exceed those in the West in the next decade, and

this could have "significant implications for healthcare policy and expenditure in the region," they wrote in the study. "With the advent of globalization, IBD made its entry into the developing world and today we are in the similar situation where the west was two decades The most problematic thing

about the incidence of IBD especially in India is the age group that is getting affected and it is the active, working population between 20 - 40 years who are getting diagnosed more frequently," Dr. Rupa Banerjee, Director, IBD Center, AIG Hospitals and Principal Author of the study said.

Imran asks supporters 'not to sit silent' No 'major hurdle' left in

Dakistan's ousted prime min-**P**ister Imran Khan on Saturday in a pre-recorded video said that his arrest was "expected" and asked his supporters "not to sit silent" and stand up for their rights and freedom.

The 70-year-old Pakistan Tehreek-e-Insaf (PTI) chairman was arrested from his Zaman Park residence here after the Islamabad trial court convicted him in the Toshakhana case and sentenced him to three-year imprison-

In a pre-recorded statement on X, formerly known as Twitter, Khan said, "By the time this video message reaches you, I would be arrested and in jail...which is why I have a request...an appeal to all of vou...vou should not sit at home in silence. These earnest efforts of mine are not for me but for my people, my community, for you. I am doing it for you. I am doing it for the good fortune of your children."

"If you will not stand for your rights, you will live a life of slavery, and mind you, slaves do not have a life," he

August 2022: National Assembly Speaker Raja Pervaiz Ashraf sent the Toshakhana case against Khan to the Election Commission of Pakistan (ECP) in accordance with the Articles of the Constitution.

September 19, 2022: ECP reserved judgment in the case. October 21, 2022: The ECP ruled that Khan made "false state ments and incorrect declarations" about the gifts and disqual ified him under the Constitution.

November 21, 2022: The ECP moved a session court in Islamabad for criminal proceedings against Khan. May 10, 2023: The trial court indicted Khan.

July 4, 2023: The Islamabad High Court (IHC) overturned the trial court's ruling on the maintainability of the case and directed it to rehear the petitioner and decide the matter with-

July 8, 2023: Judge Humayun Dilawar declared the Toshakhana case against Khan as maintainable.

August 2, 2023: The trial court rejected the list of witnesses presented by Khan.

August 4, 2023: Islamabad High Court Chief Justice Aamer Farooq referred the matter back to the trial court with a direction to re-examine the jurisdiction and any procedural lapse in the filing of the complaint by the Election Commission. August 5, 2023: Judge Dilawar found Khan guilty of "corrupt practices" in the Toshakhana case and sent the PTI chief to jail for three years.

"They (the military establishment and the Shehbaz Sharif-led government) want to enslave you, but you have to stand up for your rights and freedom," he said, urging people to exercise their voting rights to remove the corrupt government in the next elec-

Pakistan is likely to have general elections in the coming months as the current National Assembly's term will end on August 12.

In the tweet accompanying the video, Khan said his arrest was expected, so he recorded the message before his arrest.

"It is one more step in fulfilling the London Plan (made by PML-N supremo Nawaz Sharif) but I want my party workers to remain peaceful, steadfast and strong. We bow before no one but Allah who is Al Haq. We believe in La illaha Ilallah," he said in the

Earlier on May 9, Pakistan saw unprecedented nationwide anti-government protests by PTI supporters following Khan's arrest by paramilitary Rangers in a corruption case. He was later released on bail. Dozens of military instalings, including the military headquarters in Rawalpindi, were damaged or torched during the riots.

Over 100 vehicles of police and other security agencies were set on fire. After the May 9 violence, the police backed by the military launched a crackdown on the PTI and arrested 10,000 party workers, including women. Over 100 have been handed over to the military for their trial under the

The PTI contests that its members were not involved in the attacks, but the government and military reject the claims and say they have "irrefutable evidence" of their involvement

Khan is also facing numerous cases related to attacks on military installations. Currently he is facing more than 150 cases related to terrorism, murder and blasphemy. Khan was ousted from power in April last year after

 $\mathbf{I}^{ ext{mran}}$ Khan's conviction and his three-year jail term in a corruption case have cleared a "major hurdle" for the ruling PML-N and the military establishment, who appear to be on the same page, to hold the elections, a leading political analyst said on Saturday.

Former Pakistan prime minister Khan, 70, was arrested from his Zaman Park home in Lahore on Saturday shortly after an Islamabad trial court found him guilty of "corrupt practices" in the Toshakhana corruption case and sentenced him to three-year imprison-

The case alleges that the Pakistan Tehreek-e-Insaf (PTI) chief "deliberately concealed" details of the gifts he retained from the Toshakhana, a repository where presents handed to government officials from foreign officials are kept, during his time as the prime minister and proceeds from their reported sales.

From political analysts to politicians of the mainstream parties, there has been a discussion in Pakistan in recent weeks

that the general elections which are due in October/November will only be held once Khan is sent to jail, making it easier for the military establishment to get desired results (in the polls) and install a set up of its

Political analyst Hasan Askari Rizvi told PTI that after the arrest of Khan, there seems to be no reason left to delay the

"Both the ruling PMLN and the military establishment appear to be on the same page," he said. The elections may be delayed for a couple of months because of the census issue, he said, adding that otherwise no other "major hurdle" is left.

Prime Minister Shehbaz Sharif recently said that elections will be held under the digital census of 2023.

Senior PTI leader Mussarat Cheema said Khan was arrested to meet the demand of the PML-N, especially its chief organiser Maryam Nawaz who had set this condition for going into polls.

Today, justice was slaughtered by disqualifying and convicting a national hero (Imran Khan) in a phoney case. This is what Marvam Nawaz has long been demanding - a level playing field to go into elec-

tions," she said in a tweet. A senior PML-N leader in Punjab told PTI that Khan's arrest has paved the way for general elections.

"There was an apprehension both in the establishment and PML-N that as long as Khan is a free man, it will not be easy to contain him in polls. Therefore, his arrest was a prerequisite to the polls...otherwise delay was imminent," he said on the condition of anonymity. Columnist Nadeem Farooq Paracha linked the dramatic rise and fall of Khan with his style of politics attached to the powerful military establish-

'The so-called 'Imran Khan Project' has been system-atically dismantled by the same army institution that had first launched it with great fanfare in 2011," he said.

He added the cricketerturned-politician has been networking with former military personnel since the days when he formed a lobby with the former ISI chief Hamid Gul in

Thousands evacuated as more | Ukrainian drones hit Russian tanker floods hit northeast China

Taipei (AP): Rain continued to pelt northeastern China in the wake of Typhoon Doksuri on Saturday, as authorities reported more fatalities and missing people while evacuating thousands more. One person died and five went missing in the city of Shulan in Jilin province, which has seen five straight days of rainfall, according to state media.

Over 14,300 people were evacuated from the city of more than 700,000, according to the local disaster relief agency. State news agency China News Service showed images of waterlogged streets around homes and factories. The average precipitation in the city had reached 111.7 mm (4.4

inches) by Friday afternoon. China is struggling with record-breaking rainfall in some areas while others suffer scorching summer heat and drought that threatens crops. The heavy rains - remnants of Typhoon Doksuri - have battered northern China since late July, disrupting the lives of millions. Flooding near Beijing and in neighbouring Hebei province this week killed at least 22 people. In northeastern Heilongjiang province, which is known as China's "great northern granary," rain inundated farms and flooded streets, leading to the evacuation of thou-

Ukrainian drones hit a Russian tanker in the Black Sea near Crimea late on Friday night, according to Russian officials and video circulating on social media.

Cape Canaveral (AP): NASA's Voyager 2 spacecraft was back chatting it up on Friday after flight controllers corrected a mistake that had led to weeks of silence.

Hurtling ever deeper into interstellar space billions of miles away, Voyager 2 stopped communicating two weeks ago. Controllers sent the wrong command to the 46-year-old spacecraft and tilted its antenna away from

On Wednesday, NASA's Deep Space Network sent a new command in hopes of repointing the antenna, using the highest powered transmitter at the huge radio dish antenna in Australia. Voyager 2's antenna needed to be shifted a mere 2 degrees. It took more than 18 hours

for the command to reach Voyager 2 -- more than 12 billion miles (19 billion kilometres) away -- and another 18 hours to hear back. The long shot paid off. On

Friday, the spacecraft started returning data again, according to officials at California's Jet Propulsion Laboratory. 'I just sort of sighed. I

Syrian baby born under quake rubble turns 6 months old

Ababy girl who was born under the rubble of her family home destroyed by the deadly earthquake that hit Turkiye and Syria six months ago is in good health, loves her adopted family and likes to

smile even to strangers. The dark-haired baby Afraa survived 10 hours under the rubble after the February 6 earthquake crushed to death her parents and four siblings in the northern Syrian town of Iinderis. When she was found. her umbilical cord was still connected to her mother.

Her story captivated the world at the time, and people from all over offered to adopt

After spending days at a hospital in north Syria, Afraa was released and handed over to her paternal aunt and her husband, who adopted her and are raising her along with their five daughters and two

Afraa was handed over to her aunt's family days after a DNA test was conducted to make sure the girl and her aunt are biologically related, her adopted father, Khalil al-Sawadi, said.

On Saturday, baby Afraa was enjoying herself, swinging on a red swing hanging from the ceiling while al-Sawadi pushed her back and forth. "This girl is my daughter.

She is exactly the same as my children," said al-Sawadi, sitting cross-legged with Afraa on his

Al-Sawadi said he spends the day at an apartment he rented but at night the family goes to a tent settlement to spend the night, as his children are still traumatised by the earthquake which killed more than 50,000 people in southern Turkiye and northern Syria.

According to the UN Office for the Coordination of Humanitarian Affairs, more than 4,500 deaths and 10,400 injuries were reported in northwest Syria due to the earthquakes.

It estimated that 43 per cent of the injured are women and girls while 20 per cent of the injured are children aged five to 14 years old.

The devastating 7.8 magnitude earthquake struck in the early hours of February 6, followed by multiple aftershocks. Among the hardest hit areas was rebel-held northwestern Syria that is home to some 4.5 million people, many of whom have been displaced by the country's 12-year conflict that has killed half a million.

expected to be a highlight of Francis' visit to Fatima, given the shrine's century-old affiliation with exhortations of peace and conversion in Russia.

Francis instead "prayed silently for peace, with pain", while meditating for a long period before a statue of the Mary, Vatican spokesman Matteo Bruni said. And the Vatican later tweeted the prayer. The unusual morning

unfolded at the shrine where, according to legend, three young peasant children in 1917 saw visions of the Madonna. The apparitions turned the

small town nestled in the fields of vineyards, olive groves and fruit orchards north of Lisbon into one of the most popular Marian pilgrimage sites in the world, drawing millions of vis-

Israel arrests 2 settlers after deadly rampage

Jerusalem (AP): Israeli police said Saturday that they arrested two Israeli settlers after they stormed a Palestinian village in the West Bank in a rampage that left one Palestinian

Armed settlers entered Burqa, a herding village east of the city of Ramallah, late Friday, shooting and killing 19year-old Qusai Matan, Palestinian health officials said. Israeli media reported that

one of the arrested settlers used to work as an aide, who remained unnamed, for a lawmaker of the far-right Israeli 'Jewish Power" party which is in Prime Minister Benjamin Netanyahu's coalition of ultranationalist and ultraorthodox parties in the Israeli parliament. It includes Itamar Ben-Gvir, a pro-settlement firebrand known for hardline positions against Palestinians.

The party couldn't be reached for comment.

Police said they arrested two settlers after detaining five for questioning. The other settler who was arrested was hospitalised after sustaining injuries on Friday night. Authorities did not elaborate on the charges. The army said that Israeli settlers arrived in the area to herd sheep, leading to clashes between Israelis and Palestinians from the village. Both sides hurled rocks at each other, the army said.

One more indictment to close out election: Trump

Trump pleaded not guilty on Thursday to crimes related to his efforts to overturn the results of his 2020 election loss. Although it is his third criminal indictment this year, this case is the most serious, with the federal government he once ran charging him with orchestrating a scheme to block the peaceful transfer of power.

But Trump was characteristically unapologetic as he took the stage on Friday night to Lee Greenwood's "God Bless the USA", flashing a thumbs-up at the crowd, raising his fist and taking in a standing ovation of nearly three minutes.
"We are gonna be here for a little while," he joked, asking

Govt defers implementation order of Leading laptop companies to restrictions on PC/ laptop imports

⊣he government on Friday deferred the implementation of the import restriction order on laptops and computers (including tablet computers) by about three months till October 31, a move that gives more time to electronic companies to import these devices without a licence.

Now, these companies would need to take a licence from the government to import these devices from November 1. On August 3, the government put the import of these devices under a licence regime with immediate effect. Subsequently, industry raised issues with the government on the notification.

The Directorate General of Foreign Trade (DGFT), in an order issued late on Friday, said the notification dated August 3 (Thursday) shall be effective from November 1.

"Import consignments can



be cleared till October 31, 2023 all-in-one personal computers, without a licence for restricted ultra-small form factor computers and servers ... Till October imports. For clearance of import consignments with effect from 31, 2023". November 1, 2023, a valid licence for restricted imports is required," it said.

Home Media Rights: Can BCCI breach 1 billion dollar mark?

The Indian cricket board is expecting to breach the USD 1 billion (INR 8200 crore approx) mark in its cumulative earnings from selling the separate TV and digital rights for India's 88 home games during the five-year period till March

The highlight of this new cycle will be 21 home games against Australia (five Tests, 6 ODIs and 10 T20Is) along with 18 games against England (10 Tests, 3 ODIs and 5 T20Is) out of the 25 Tests, 27 ODIs and 36

During the last five-year phase (2018-23), the BCCI had earned USD 944 million (INR 6138 crore approx in 2018 exchange rate) from Star India with a price per international game being Rs 60 crore (digital plus TV).

Unlike last time, the BCCI will invite separate bids for TV and digital rights after a whopping INR 48,390 crore earning during the IPL media rights auction where Reliance won the digital bid and Star won the TV

The bidding process will once again be conducted through e-auction just like it happened with the IPL media rights as it is considered the most transparent process for best price discovery. Those who are tracking the developments feel that even digital rights for Indian cricket will skyrocket and the response for TV will be way more tepid in comparison.

"It is difficult to put a number right now as the value of dollar to rupee has also changed from the exchange rate of last time. But don't be surprised if digital rights earns way more than TV," a broadcaster involved in this business said.

While there are number of companies who has bought the

bid document worth Rs 15 lakh, the three serious bidders for India's (men and women's) home matches are going to be Disney-Star and Reliance-Viacom while Zee could be a big contender if the merger with Sony is completed before the auction scheduled during the first week of September. "It is too early to comment

but there will be only three serious bidders if Zee-Sony conglomerate joins the bidding war. There are many things one needs to factor in. Two entities Reliance and Star — had gone all out for IPL rights. Star also owns the ICC tournament property. So how much each will stretch is a question," a senior executive from one of the broadcasters told PTI on conditions of anonymity.

"As far as Amazon is concerned, they didn't even bid for IPL, which is BCCI's biggest property right now."

But, considering there is a World Cup happening in three months and in case India doesn't win the championship, the subsequent few months could be bad in terms of advertisement

"There are 25 home Tests in this cycle. But if you check out last cycle, how many Tests practically went into the fifth day? Most Tests in India end inside three days. The broadcaster will factor that in," another broadcaster said. "Obviously a series against Sri Lanka or Afghanistan won't fetch you the amount that England or Australia will get you. The ad rates per second for a T20 match will be more than most Test matches. So when your company puts in a bid, these things are kept into account.

"Also you need to ensure your current stars play 'x' number of games in that cycle in this day and age of workload. The NBA has a clause," he added.



he recent Supreme Court stay on the conviction of former Congress President Rahul Gandhi in the "Modi Chor" defamation case has sent shockwaves through the Indian political landscape. WHAT THE SUPREME COURT SAID

The sentence for an offence punishable under Section 499 of the Indian Penal Code is a maximum of two years of a sentence or fine or both. The learned trial judge, in the order passed by him, has awarded the maximum sentence of two years. Except for the admonition to the petitioner by this Court in a contempt proceeding, no other reason has been granted by the learned trial judge while imposing the maximum sentence of two years. It is to be noted that it is only on account of the maximum sentence of two years imposed by the learned trial judge that the

provisions of Section 8(3) of the Representation of Peoples Act came into play. Had the sentence been a day lesser, then the provisions would not have been attracted.

Particularly when the offence was non-cognizable, bailable and compoundable, the least which was expected from the learned trial judge was to give reasons for imposing the maximum punishment. Though the learned appellate court and the High Court have spent voluminous pages in rejecting the applications, these aspects are not seen considered".

DEFAMATION LAW IN INDIA

Defamation under the Indian Penal Code (IPC)

Section 499: This section defines defamation and states that whoever, by words either spoken or intended to be read or by signs or visible representations, makes or publishes any imputation concerning any person intending to harm or knowing or having reason to believe that such imputation will harm the reputation of that person, is said to defame that person.

defame that person.
Section 500: This section deals with the punishment for defamation. Any person found guilty of defamation under Section 499 shall be punished with simple imprisonment for a term which may extend to two years, or with a fine, or with both.

Exceptions to Defamation (IPC)

Section 499: The section also provides certain exceptions under which the act of defamation is not an offense.

These exceptions include imputations made in good faith for the public good, opinions on public conduct, and fair criticism of public servants in the discharge of their public duties.

Procedure for Defamation (Code of Criminal Procedure - CrPC)

Section 198(1) and (2): This section deals with the procedure for taking cognizance of offenses related to defamation. It states that no court shall take cognizance of defamation except upon a complaint made by the person defamed or his/her representative.

It is important to note that defamation can be both a civil and a criminal offense in India. The aggrieved party can file a civil suit for damages seeking compensation for the harm caused to their reputation. Simultaneously, they can also pursue criminal action under the IPC against the person who has allegedly defamed them.



Sometimes it may be a result of an autoimmune disease.

A healthy person falls prey to hepatitis somewhere in the world every 10 seconds, that means 8000 people get infected with hepatitis every day.

Almost half of the world's pulation is currently facing the havoc of floods. Under such circumstances, there is an apprehension of a huge increase in the cases of hepatitis.

In fact, a recent study has flagged that individuals who have been cured of hepatitis C infection still face a substantially greater risk of death compared with the general population - between 3 and 14 times higher depending on liver disease stage, a latest study has cautioned. The study is published in the BMJ.


Based on data from more than 20,000 patients with a hepatitis C cure, the results show that drug and liverrelated causes of death were the main drivers of excess deaths - and highlight the importance of continued support to fully realise the benefits of a hepatitis C cure.

Historically, hepatitis C was treated with interferonbased therapy, which was

TYPES OF VIRAL HEPATITIS

It is of five types from A to E depending on the virus causing the infection. Hepatitis A and E are caused by the use of contaminated water and infected food items. Generally, hepatitis A occurs in children, while E occurs

Hepatitis B and C are caused by infected blood or needles and unprotected sex. If a pregnant woman is infected, the unborn baby can also get hepatitis B or C. Hepatitis D usually occurs in patients who have been previously infected with hepatitis B.



SYMPTOMS

In most cases, there are no symptoms in the begin ning on the basis of which hepatitis can be suspected. Patients reach the doctor very late. When a person gets infected with the virus, liver functions begin to be adversely affected. There is a decrease in the production of bile, which leads to digestive disturbances. The speed of removal of bilirubin, cholesterol, hormones and medicines slows down. Digestion of carbohydrates, fats and proteins is adversely affected. Initial symptoms of the disease include generalised weakness, fatigue, fever, abdominal pain, vomiting, loss of appetite, yellowing of urine and eyes. With the progression of the disease, symptoms like pain in the joints, yellowing of the skin and faeces start appearing. Some of the other symptoms include constipation, indigestion and foul smell in the faeces.

They analysed data from three population studies carried out in British Columbia (Canada), Scotland and England involving 21,790 individuals who achieved a hepatitis C cure between 2014 and 2019.

Individuals were grouped by the severity of liver disease at the time of cure: pre-cirrhosis (British Columbia and Scotland studies only), com-pensated cirrhosis, and end stage liver disease.

Data were then linked to national medical registries and several causes of death were examined, including liver cancer, liver failure, drugrelated death, external causes (mainly accidents, homicides and suicides) and diseases of the circulatory system, over an average follow-up period of 2-

Most participants did not have cirrhosis at cure. The average age of pre-cirrhosis patients in Scotland was 44 ears and 56 years in British Columbia, and males outnumbered females across all studies and disease severity groups (65-75%).

A total of 1,572 (7%) of participants died during follow-up. The leading causes of death were drug related (24%), liver failure (18%) and liver

cancer (16%). After taking account of age, death rates were considerably higher than the general population across all disease

severity groups and settings. For patients without cirrhosis, the leading cause of excess death was drug related, whereas in patients with cirrhosis, the two leading drivers were liver cancer and liver fail-

These are observational findings and the researchers acknowledge that they may not apply to all settings, particularly where injecting drug use is not the dominant mode of hepatitis C transmission.

TIPS TO PREVENT HEPATITIS

Hepatitis can be controlled only by maintaining hygiene & cleanliness, washing hands before eating. Non-contaminated water and food are necessary to prevent hepatitis. Be careful while drinking outside water, especially the water cooled by market ice. Avoid cooled by market ice . Avoid eating outside food. Do not use previously cut fruits, salads or chaat. Do not use salad of vegetables growing under the ground during the rainy season. Never use already used needles, razor or toothbrush.

Move to make India tobacco-free in 'Amrit Kaal'

After economists, public health experts, a Parliamentary panel too bats for higher tobacco tax, reports THE HEALTH PIONEER

oncerned at the growing cases of tobacco-induced ✓ cancers in the country, a parliamentary committee has suggested raising taxes on tobacco products, stating that increasing their market price would make them less affordable. The suggestion has come

not without reason. "This will result in lower consumption and decrease the risk of tobacco-related diseases, including cancer," the panel

The report which was presented in Rajya Sabha recently has come close on the heels of a study by the global agency World Health Organisation (WHO) which highlights that 5.6 billion people – 71% of the world's population – are now protected with at least one best

practice policy to help save lives from deadly tobacco - five times more than in 2007.

"The Health Ministry must pursue with the Department of Revenue to expedite the decision on raising taxes on tobacco products," the Departmentrelated Parliamentary Standing Committee on Health and Family Welfare said in its 147th

The Parliamentary panel recommendations on tax hike on tobacco items echo views of several economists and antitobacco activists who have been urging the Government to impose a substantial hike in tax on all tobacco products and stronger laws which would not only bring the best out of human capital by ensuring better health of citizens, but also

help in achieving Prime Minister Narendra Modi's vision of a five trillion dollar economy by 2025.

Four countries (Australia, Lithuania, Nicaragua and Vanuatu) have moved to the best-practice group by levying taxes that comprise at least 75% of retail price. However, India is moving slowly in this

Nevertheless, the WHO report says that India has the highest levels on tobacco products and providing tobacco dependence treatments. Also, India has prohibited e-cigarettes and nicotine products, and there is a comprehensive prohibition on tobacco advertising, says the report.

In the latest anti-tobacco measures, India has become a



first country in the world to issuing a notification mandating anti-tobacco warnings for OTT platforms. The Ministry of Health and Ministry of Information and Broadcasting will take strict action upon failure to comply with the rules to come into force soon.

In fact, BJP MP Manoj Tiwari, recently voiced his con-

cerns over the misuse of Over-The-Top (OTT) platforms for tobacco promotion while addressing the parliament.

Noting that after movies, OTT platforms have become quite popular these days, he expressed concern at the alarming prevalence of smoking scenes involving tobacco products in numerous series

and scenes. Appreciating Government's move to tighten the noose around the tobacco industry which has been luring the youth into deadly tobacco grips, Tiwari, himself an actor said that such a legislation was the need of the hour.

According to the new guidelines, streaming plat-forms will be required to dis-

play anti-tobacco warnings similar to those seen in movies shown in theaters and on television. The move aims to dissuade tobacco consumption and protect people from the harmful effects of tobacco.

The WHO Regional Director, Dr Poonam Khetrapal also praised the Indian government's commitment to safeguarding the health and well-being of its citizens, expressing support for the Health Ministry's recent actions that reinforce India's commitment to fighting against the harmful effects of tobacco and ensuring that OTT platforms are used responsibly to entertain and

educate the masses. The argument that antitobacco measures do not help

as asserted by a few film makers and OTT platforms falls flat given that in the last 15 years since WHO's MPOWER tobacco control measures were introduced globally, smoking rates have declined.

Without this decline there would be an estimated 300 million more smokers in the world today, says the WHO.

"These data show that slowly but surely, more and more people are being protected from the harms of tobacco by WHO's evidence-based best-practice policies," said Dr Tedros Adhanom Ghebreyesus, WHO Director-General.

Eight countries are just one MPOWER policy away from joining the leaders in tobacco control: Ethiopia, Iran, Ireland, Jordan,

Madagascar, Mexico, New Zealand, and Spain. "While smoking rates have

been going down, tobacco is still the leading cause of preventable death in the world largely due to relentless marketing campaigns by the tobacco industry," said Michael R. Bloomberg, WHO Global Ambassador Noncommunicable Diseases

and Injuries and founder of Bloomberg Philanthropies. There is still much work to

be done, 44 countries remain unprotected by any of WHO's MPOWER measures and 53 countries still do not have complete smoking bans in healthcare facilities. Meanwhile, only about half of countries have smoke-free private workplaces and restaurants.

India's G20 presidency: Focus on Mass Entrepreneurship

As it gains greater international recognition, India assuming charge of the G20 Presidency can be an ideal opportunity to address endemic rates of high youth unemployment, which was reported in 2022 across G20 nations, such as South Africa (more than 50 per cent) as well as India, Italy and Saudi Arabia (around 23-24 per cent).

Why Mass Entrepreneurship Counts

As per the International Labour Organisation, the overall number of unemployed

all number of unemployed youth globally was estimated at 73 million in 2022 - six million above the 2019 pre-pandemic level. Youth from minority religious and ethnic groups, indigenous communities, women and LGBTQIA+ were most severely affected. It is in this context that Mass Entrepreneurship is crucial. The term denotes the millions of common local enterprises using indigenous inputs to serve local needs across every community, typically hiring or raising income levels of between five and 20

people. To thrive, Entrepreneurship requires policy, financial and enterprise development tools that promote self-employment and speed up the growth of MSMEs (micro, small and medium enterprises). For instance, a successful youth entrepreneurship development programme in Northeast India helped establish more than 1,000 grassroots enterprises and created over 55,000 jobs between 2012 and 2017.

By encouraging and supporting mass entrepreneurship, countries can unlock the economic potential of their youth and marginalised communities such as women, tribal/indigenous people, migrants and minority communities, and others.

Thereby, it helps drive innovation, creativity and inclusivity while overcoming social and cultural barriers, including issues such as lack of access to credit and hurdles in regulatory frameworks and trade facilitation.



The Benefits of Collaboration

During the past three decades, the United Nations has been forging collaboration among countries to address climate change- a pressing challenge confronting humanity in the 21st century. Worldwide, ESG has been adopted by stakeholders since it helps companies and countries manage risks as well as opportunities linked to environmental, social and governance norms.

Without active partner-ships with large corporations and the MSME segment- the latter being an integral part of global value chains - countries cannot meet their ESG targets. Therefore, a key incentive to assist MSMEs in becoming inclusive and sustainable is their significant size, which represents around 90 per cent of enterprises, 50 per cent of GDP and more than half of the

employment generated globally in 2020, according to the World Bank.

An excellent example exemplifying ESG adoption is a 35-year-old entrepreneur's unit in rural India. His watersaving agricultural mulching film benefits 200,000 farmers by conserving water, preserving soil health, and contributing to sustainable agriculture. Launched in 2011, his unit has created 255 local jobs, facilitating economic growth and community development through the sharing of knowledge and global best practices.

The above example shows why a special focus is required on grassroots entrepreneurs who are often left behind in institutional programmes, despite the value they bring in driving local job creation. With such scenarios in mind, the G20 must actively encourage MSME adoption of ESG good practices via supportive busi-

ness legislation, procurement programmes and financial incentives.

The G20 YEA has been built upon a tradition of collaboration between the world's young entrepreneurs that began in Italy in 2009 and continued at successive meetings in Canada, Mexico, Argentina, France, Germany, Russia, China, Turkey, Australia and Japan.

But swiftly changing business conditions, which include rising energy costs, supply chain disruptions, community lockdowns and shortages of raw materials, have compounded the challenges posed by ongoing issues such as climate change, rising social intolerance and growing barriers to international mobility.

To promote the cause of young entrepreneurs, the Hamburg edition of the G20 YEA meeting in October 2022 called on business and politi-

cal leaders to support and advance entrepreneurship by promoting an inclusive global recovery; fostering peace through sustainable growth and economic inclusion and encouraging climate and energy entrepreneurship. The biggest advantage of the G20 YEA is that young entrepreneurs throughout the globe receive a chance to network, collaborate and share their

ideas with venture capitalists.

While savvy entrepreneurs can leverage the G20 YEA, governments, corporates and NGOs should also support grassroots entrepreneurs from marginalised groups, vulnerable sections (women, Dalits, etc.) and underserved areas to participate in the deliberations and recommendations to make G20 truly inclusive for MSMEs.

The YEA aims to provide G20 trade opportunities to a diverse group of young entrepreneurs. This is an opportune moment for India to ensure that women-owned businesses (WOBs) and traditional artisans benefit. Similarly, Canada can emphasise that members of Black, Indigenous and People of Colour and LGBTQ+ communities, new Canadians and persons with disabilities (PwDs) are supported.

The G20 YEA should aim to integrate micro-entrepreneurs, including Indian MSMEs, into the ESG movement and the global trade value chain. MSMEs must be encouraged to promote local sourcing of raw materials and supplies, invest in employee welfare, reduce waste, adopt energy-saving business processes, commit to continuous improvement, and educate employees, suppliers and customers about sustainable practices.

India's G20 Sherpa, Amitabh Kant, stated recently that MSMEs should be encouraged to focus on producing quality goods using renewable energy sources for catering to global markets. Besides, he suggested that regulatory policies should be eased and clearances regarding the functioning of MSMEs be digitalised so physical interaction with government officials is eliminated. Here, new-age technology should be leveraged to completely digitalise Indian MSMEs. Simultaneously, the economic value and general potential of Indian MSMEs should be conveyed to the world at large.

The Criticality of Digital
Furthermore, supported
entrepreneurs should be assisted in adopting "digital readiness", which comprises three
essential elements: digital presence, digital payments and
digital commerce. Also, to help
MSMEs cater to global markets, a global consensus on
defining, understanding and
recognising these segments
transparently is important.

Beyond the YEA deliberations, members of the G20 can launch Youth Entrepreneurship Development initiatives, such as Business Idea Contests, Entrepreneurial Hackathons, Mobile Mentor Clinics and Industry Incubation Centres. Youth from underserved communities can also be motivated to refine and develop their business ideas under the guidance of a cadre of accredited mentors.

Customised training, business networking and peer learning opportunities can be delivered through webinars, videos and user-friendly mobile apps to help MSMEs adopt international best practices and market understanding to build scalable businesses. All of this can transform their entrepreneurial dreams into reality and change the trajectory of global economic growth and social transformation.







¬aking off from the previous issue, first, the symbology of Damru needs attention. With its play, the equilibrated state of the primordial source gets shaken, when the primal sound note 'Om' gets excited. while pulling a cart keeps moving unprovoked at a constant speed. It will not stop in the way till it reaches a place designated for being fed and taking rest. After a while, the bull again takes the journey forward. After reaching the desired destination, it again reverts to its normal place of abode after completing the voyage. The manifest world too, after being on the run for a specified time, gets back to the primal source to acquire a restful state, whence it gets recharged once again. Following which, out of the seeds of life withdrawn into primal source, fresh creation cycle takes

Let us now have a look at those forming Lord Shiva's entourage. It exemplifies multitude of existences forming this world.
