Modi calls Opp selfish, vows to restore peace in Manipur

PM slams Cong's 'jhoot ka bazaar'; No Trust motion defeated

In a stirring speech that underscored the achievements of his Government and envisioned a promising future for both the BJP and the nation Prime Minister Narendra Modi vehemently critiqued the Opposition during his response to the no-confidence motion.

The Congress-sponsored motion was ultimately defeated through a voice vote after the INDIA coalition of Opposition parties staged a walkout amid the Prime Minister's address.

The Prime Minister commenced by listing the welfare and developmental initiatives undertaken by his administration over the past nine years.

He emphasised that these efforts had uplifted millions of individuals from the depths of poverty, consequently propelling India toward becoming the third-largest global economy by 2027.

In addition, the Prime Minister strongly rebuked Congress leader Rahul Gandhi's assertion that "Bharat Mata" (Mother India) had been figuratively killed in Manipur. He argued that this claim highlighted the frustration experienced by the Congress leader due to his party's prolonged absence from power.

Taking a pointed dig at Rahul, the Prime Minister

remarked that while the Congress leader may talk about espousing a sentiment of "mohabbat" (love), his actions merely propagated animosity and division.

Replying to the debate, Modi accused the Opposition of caring more about their parties than the country. He stated that the Opposition parties' focus was "not on the hunger of the poor, but on the

hunger for power."

In a free-wheeling speech interspersed with humour, jabs, and poetry, the Prime Minister remarked that the Opposition's arguments on the no-confidence motion were "bereft of substantial issues."

Amid laughter from the treasury benches, he quipped, "I hope you will be better pre-

pared in 2028. He highlighted that the Opposition alliance had merely rebranded itself, following the Congress's "last rites of the UPA at Bengaluru".

Modi used an analogy, stating, "You are trying to pass off an old vehicle as an electric one just by applying new paint." This assertion was met with enthusiastic cheers from the ruling side, with senior Ministers like Amit Shah, Rajnath Singh, and Nitin Gadkari visibly expressing their

The Opposition, chanting 'INDIA' and 'Manipur,' staged a walkout while the Prime Minister was still addressing

Regarding Manipur, Modi contended that the "origin of all the troubles plaguing the northeast" lay in the rule of Congress. He assigned blame to the policies of Congress regimes, including those of the first Prime Minister of India, Jawaharlal Nehru, for issues like partition, neglect of the North-East, and insurgency in the region.
"How can the Opposition

talk about the 'murder' of Bharat Mata, when they themselves cut Bharat Mata into three pieces?" Modi responded, addressing Congress Rahul's speech in reference to recent incidents of violence against women in Manipur.

Assuring the people of Manipur, Modi pledged that the State would return to the path of development. He praised Chief Minister Biren Singh's Government for diligently working to foster peace in Manipur. Modi emphasised the Centre is taking stringent action against those responsible for the violence in Manipur, assuring that the state would soon experience renewed

ED scans Karat's mails in NewsClick anti-India drive

s part of its money laun-A dering probe against news portal NewsClick which is alleged to have received dubious funds from American billionaire Neville Roy Singham to spread Chinese propaganda, the Enforcement Directorate (ED) is investigating a dump of email exchanges that include some between the US businessman and senior CPI(M)

The ED is also probing the alleged transfer of funds of about ₹40 lakh from NewsClick to the family members of activist Teesta Setalvad, the transfer of about ₹72 lakh to a senior journalist, some employees of NewsClick, and a few independent media profes-

sionals over a period of time. The agency had found that NewsClick also allegedly paid ₹17.08 lakh as "salary" to jailed activist Gautam Navlakha, ₹97.32 lakh to Bappaditya Sinha, a shareholder in NewsClick and a member of the IT cell of the CPI(M), over

an unspecified period.
Sources said the ED is investigating the "end use" of these funds

The online news portal and its dubious activities came under scrutiny again after a recent New York Times report claimed that the outlet was part of a global network that



received funding from Singham, who allegedly works closely with the Chinese Government media machine.

The NYT report was also raised in Parliament when BJP the funds pumped into NewsClick were used to create an anti-India environment and that he had documents pertaining to email exchanges between Karat and Singham.

The ED, as part of its money laundering investigation against NewsClick, its promoters, and others, is probing alleged fraudulent foreign funds infusion of more than ₹86 crore from entities linked to Singham into its holding company (PPK Newsclick Studio Pvt Ltd) and it is soon expected to file a chargesheet in this case

The ED had first raided the premises of NewsClick in the Saidulajab area of the national Capital in September 2021 on charges of money laundering and since then the probe is continuing beside the litigation between the two sides before the Delhi High Court.

The RBI opted for the status quo in key policy rates for the third consecutive time on Thursday.

Meitei fleeing burning house gangraped Manipur MLAs urge PM for 'complete disarmament', NRC

Another case of sexual assault has come to light in Manipur after a 37-year-old married woman from Churachandpur district alleged she was gangraped by a group of men while fleeing her burning house on May 3, the day on which the ethnic strife began in the State, police said. An FIR in this connection

has been registered in Bishnupur women police station on August 9, police said, adding it was later forwarded to Churachandpur police station for further investigation. According to the FIR, the

woman was gangraped at Khumujamba Meitei Leikai in

Churachandpur district by ʻunidentified Kuki men". According to woman's

statement to police, around 6.30pm on May 3, a group of Kuki miscreants set fire to several houses, including her's. Amid the chaos, she tried to flee. However, after running for about half-a-kilometre, she was stopped by a few men and was sexually assaulted, police said quoting the FIR. Meanwhile, 40 MLAs of

Manipur have written to Prime Minister Narendra Modi urging complete disarmament to foster an environment of peace and security. These MLAs, most of whom are ethnic Meiteis, also

The Congress on Thursday gave a notice in the Lok Sabha against alleged breach of privilege by Home Minister Amit Shah, accusing him of speaking untruth on Maharashtra farm widow Kalawati Bandurkar who Rahul Gandhi had met in

The notice was given to Speaker Om Birla by Congress MP and party's whip in Lok Sabha Manickam

Tagore.
"I submitted a privilege motion against Sh Amit Shah for misleading the Parliament yesterday on smt Kalawati story to Honble Speaker," Tagore said on X, formerly known as Twitter, while sharing the notice.

Gandhi had visited Bandurkar's house in 2008 after her husband committed suicide following a farm crisis in Maharashtra's Vidarbha.

During the debate on the no-confidence motion on Wednesday, Shah had referred to 13 "failed" attempts to launch Rahul Gandhi's political career and recalled how he narrated a tale of a poor woman Kalawati. Shah said it was the Modi government which ensured that she got a home and benefited from various government schemes.

However, the Congress alleged the Modi government was lying on Kalawati and shared a video of the farmer

Disclaimer must for celebrities endorsing as health experts: Govt

The government said "disclosure or disclaimer" is must for celebrities, influencers and virtual influencers while endorsing as health experts or medical practitioners as it issued additional guidelines on Thursday.

Even medical practitioners, health and fitness experts hold-ing certifications from recognized institutions are required to "disclose" that they are certified health/fitness experts and medical practitioners while sharing information or promoting products or services or making any health-related

These additional guidelines for celebrities, influencers and virtual influencers in the field of health and wellness were released by the nodal Consumer Affairs Ministry.

The guidelines have been released after discussions with the stakeholders including Ministry of Health, Ministry of Ayush, Food Safety and Standards Authority of India (FSSAI), and Advertising Standards Council of India (ASCI).

"Celebrities, influencers and virtual influencers pre-



senting themselves as health experts or medical practitioners, when sharing information, promoting products or services or making any healthrelated claims, must provide tions," it added. clear disclaimers, ensuring the audience understands that their endorsements should not be seen as a substitute for professional medical advice, diagno-

This "disclosure or disclaimer" is necessary when talking or making claims on topics such as health advantages including those derived from food items and nutraceuticals, disease prevention, treatment or cure, medical conditions, recovery methodologies or immunity boosting, etc., it

sis or treatment," the ministry

'This disclosure or dis claimer should be displayed during endorsements, promotions, or at any instance of making health-related asser-

The ministry further said the celebrities, influencers and virtual influencers presenting themselves as health experts or medical practitioners should 'clearly distinguish between their personal views and professional advice" and "refrain from making specific health claims without substantiated

"It is always recommended to encourage audiences to consult with healthcare professionals for seeking professional medical advice and complete information about the products or services," it added.

Ex-Manipur CM demands emergency Assembly session to end strife

Former Manipur chief min-ister and senior Congress leader Okram Ibobi Singh has demanded an emergency session of the Assembly to find a way to end the ethnic strife in the state.

He said the Congress and 10 like-minded parties have been pressing the Governor and the state government to immediately convene an emergency session to end the violence in the state which has claimed more than 160 lives so

Talking to reporters on the sidelines of the observance of the 81st anniversary of Quit India Movement held at Congress Bhavan here on Wednesday, the former chief minister asserted that adopting a unanimous resolution to end the crisis is a must.

"The proposed emergency session should discuss the crisis unfolding in the state and adopt a unanimous resolution to end the strife," Ibobi said. The leader of the Congress

Legislators Party in the state



Assembly said there will certainly be a way for ending the prevailing crisis in a peaceful manner.

"Searching for a way under the provisions of the Constitution of the country and bringing the parties in conflict to the negotiating table would be a right step. However, in searching for the way for resolving the conflict, the territorial integrity of Manipur must not be compromised at any cost," Ibobi asserted.

It may be noted that during a recent cabinet meeting called by Chief Minister N Biren Singh, it was resolved to recommend to the Governor to convene the Assembly session on August 21.

Later talking to the media, Chowdhury said, "I have not insulted PM Modi. Modi ji speaks on everything but on the Manipur issue, he is sitting 'Nirav', which means sitting silent. 'Nirav' means to be silent. My intention was not to insult PM Modi... PM Modi did not feel that he was insulted, his courtiers (darbari) felt so and brought this proposal against me. The agency had last year attached a flat, worth Rs 4.52 crore and located in south

On Wednesday, Rajya Sabha Chairman Jagdeep Dhankhar had referred complaints of four MPs, who accused Chadha of proposing

Addressing a press confer-

ence, the Aam Aadmi Party (AAP) leader asserted that the allegations against him were "baseless" and said an MP can propose the name of any other member without their written consent or signature for a

Select Committee. "I will approach the Committee of Privileges and court of law against the BJP Lok Sabha members who levelled the false allegations of forgery against

any other member without a written consent of the member or signature," the AAP MP said, showing the rule book at the press conference. According to rules, neither a member's consent nor signature is required to propose his or her name for a Select Committee.

a select Committee.

Terming the allegations against him "baseless", Chadha claimed that a "rumour" is being spread about him doing forgery. He asked how does the question of forgery arise when question of forgery arise when nobody's signature was taken and submitted.

"A rumour which is being spread about forged signatures absolutely wrong and baseless," Chadha claimed. "I challenge the BJP to show the papers that has the forged signatures as alleged by them. The Parliamentary Bulletin on complaints against me has no mention of forgery, fake signathat the BJP was "trying to suppress his voice". He alleged that the BJP is after him because he "exposed" the party's "double standards" and also demanded justice for the people of Delhi. "But I will fight. I am not scared of the BJP," he added.

Chadha said that one does not give public statements if the Committee of Privileges begins proceedings against them.
"Whenever

Committee of Privileges begins proceedings against someone, they don't give public statements. But it was out of compulsion that I have to speak up. But I won't speak against the Hon'ble Chair or the Committee of Privileges," he

A Rajya Sabha bulletin said the chairman had received complaints from MPs Sasmit Patra, S Phangnon Konyak, M

Thambidurai and Narhari Amin, who alleged breach of privilege by Chadha "for interalia including their names without their consent, in violation of the Rules of Procedure and Conduct of Business, in a motion on August 7".

Chadha had proposed the constitution of a select committee to consider the Government of National Capital Territory of Delhi (Amendment) Bill, 2023 and had included the names of the four MPs.

Addressing the press conference, AAP Rajya Sabha MP Sanjay Singh alleged that the Modi government has started a new tradition of getting those members suspended from the House who speak against it.

"Then, declare its dictatorship in the country. Why are you playing a drama about democracy?" Singh asked the

Hitting out at Home Minister Amit Shah, he said, 'You should at least know that the name of any member can be proposed for the select committee by any other member of the House, and there is no need to have the member's signature." The AAP leader also accused Shah of lying on the floor of the House by terming as "fraud" the inclusion of the names of the five MPs.

The home minister's sole objective is to get Chadha disqualified from the Rajya Sabha as was done in the case of Congress leader Rahul Gandhi in the Lok Sabha, he alleged.

"But, we are soldiers of Arvind Kejriwal. We will fight. And, if you disqualify Raghav Chadha by any means, he will come back after being re-elected," Singh, who was suspended from Upper House of Parliament during Monsoon

Ban on tobacco products in Delhi extended for one year

In a significant move aimed at safeguarding public health, Delhi Lieutenant Governor (LG) VK Saxena has extended the ban on tobacco products including Gutkha and Paan Masala in Delhi for an additional period of one year. This decision comes under the authority vested in him by Article 239 AA (4) of the Constitution of India.

The decision to extend the ban on tobacco products underscores the growing concern over the rising number of oral cancer cases in the national capital. The LG emphasized the critical importance of addressing this issue, particularly among children and young individuals, to ensure a



healthier future generation. The LG has called for strict enforcement of the notification, leaving no room for laxity in its implementation within the city. Any indifference towards enforcing the ban will not be

The Ministry of Health and Family Welfare, Government of India, has

already prohibited and restricted the sale of products containing tobacco and nicotine as ingredients in any food items under regulation 2.3.4. of the Food Safety and Standards (Prohibition and Restrictions on Sales) Population 2011

on Sales) Regulations, 2011.

The Food Safety
Department of the
Government of National Capital Territory of Delhi (GNCTD) will soon issue a notification to extend the ban, following the approval by LG This measure will encom-

pass the prohibition of manufacturing, storage, distribution, and sale of various tobacco products, including Gutka, Paan Masala, flavoured/scented tobacco, Kharra, and similar products. The ban applies to both packaged and unpackaged tobacco products and will remain effective for an additional year under Clause (A) of Sub Section (2) of Section 30 of the Food Safety and Standards Act, 2006.

This move aligns with the Delhi High Court's recent affirmation of the ban on the manufacture, storage, and sale of Gutka, Paan Masala, flavoured tobacco, and related products

The Court overturned a September 2022 decision by a single judge that had quashed the ban, supporting the appeals brought forth by the Centre and Delhi government against it. Entities within the tobacco business had objected to the prohibition notifications issued

Over 19,000 students allotted seats in DU colleges in second round of UG admission

Delhi University Thursday filled up over 19,000 undergraduate seats across colleges in the second round of admission for the academic year 2023-24. In the first round, over 62,000 students had paid fees to confirm their seats. Many of them opted for upgradation, while several students froze their seats.

The university said 34,174 candidates so far have opted for an upgrade after the first round.

In the second round of admission, new allocation totalled 19,038. As many as 10,104 students got their upgraded choices and around 17,561 froze their seats allotted to them in the first round," a varsity official said.

As many as 32,600 candidates were retained on their earlier allocation. Of the total allotment of 85,853 UG seats in the first round of allocation, 62,008 students, of which 53 per cent are females, have paid fees and confirmed their admission to DU colleges. DU has a total of 71,000 UG seats across all its colleges. However,

was higher this year as the varsity allocated extra seats in various categories, the DU official said. The seats for the undergraduate programmes are being allotted under the Common Seat Allocation System (CSAS)-UG-2023. The varsity issued a list of

ED raids against Balaji's sister-in-law; plot frozen

The Enforcement Directorate (ED) on Thursday said it has carried out search operations in Karur (Tamil Nadu) in connection with the 'Cash for Jobs Scam' involving the Tamil Nadu State Transport Corporations and froze a 2.49 acre plot of land worth Rs 30 crore belonging to the sister-in-law of Tamil Nadu minister V Senthil Balaji, the prime accused in the money laundering case.

Balaji, who formerly served as the transport minister, was earlier arrested on June 14 for his alleged involvement in money laundering. The ED initiated investigation on the and chargesheets filed by the Central Crime Branch (CCB), Chennai, in the 'Cash for Jobs Scam arraying Balaji as the main accused. "V Senthil Balaji Personal Assistants B Shanmugam and Karthikeyan, gave jobs in lieu of cash. This led to jobs being awarded at the expense of deserving candidates, the ED said in a statement.

During the investigation, it was revealed that a substantial parcel of land admeasuring 2.49 acre located at Salem Bypass Road, Andankoil, Karur was acquired by P Lakshmi (Mother-in-Law of RV Ashok Balaji) from Anuradha Ramesh for a mere Rs. 10 lakhs, as against the land's true value amounting to more than 30 crore, the agency said. However, while scrutinizing it was revealed that she lacked any credible means of income. Her assertion of selling old jewellery to secure Rs 10 lakh for the land purchase were proven tigation, the agency added.

Subsequently, this plot of land was gifted to her daughter Nirmala, wife of Ashok Kumar, the brother of Balaji. Upon further investigation, it was disclosed that the remaining sum required for the land acquisition was paid in cash to Anuradha Ramesh. This cash, in turn, was employed by Anuradha Ramesh to procure another piece of land in the same vicinity.

Considering these developments, the said property has been placed under a freeze order in accordance with section 17(1-A) of Prevention of Money Laundering Act



categories: (1) "variants of interest," (2) "variants of concern" and (3) "variants of high consequence." According to the US National Institutes of Health (NIH), VOIs are defined as variants with specific genetic markers that have been associated with changes that may cause enhanced transmissibility or virulence, reduction in neutralisation by antibodies obtained through nat-

EG.5 is a descendent lineage of Omicron subvariant XBB.1.9.2. It carries an additional mutation in the spike protein which the SARS-CoV-2 uses to enter and infect the human cells - compared to the parent subvariant. Within the EG.5 ineage, the subvariant EG.5.1 has an additional spike mutation and represents 88 per cent of the available sequences for EG.5 and its descendent lineages, the WHO said.

Along with this, children of labourers working in brick kilns were also given medicines at Anganwadi centres, he said, adding that a mop-up round would be organised on August 17 for those children who have missed taking medicines during the day. "Efforts will be made to fulfill the target 100 percent by covering all the children left out in this," he said. He said that diarrhoea, abdominal pain, weakness, vomiting and loss of appetite can be symptoms of worm infestation. According to him, the greater the number of worms in the child's stomach, the more severe the symptoms of the infected person and the children with a mild infection usually do not show any symp-

Missing student's body found floating in pond

The body of a girl student missing since August 6 was found floating in a pond near her house late on Wednesday evening. The police called the forensic team and dog squad. The family members apprehended murder after kidnapping. The police said the matter is being investigated.

Pakistan is once again likely to plunge into uncertainty after the premature dissolution of the National Assembly

akistan's fragile democracy is once again at stake. The National Assembly has been dissolved prematurely, though only three days before Shehbaz Sharif's government would have completed full term. However, the move gives 30 more days to Shehbaz to prepare for the hustings. But the chances are that elections would be delayed even beyond 90 days due to technical reasons. Pakistan President Arif Alvi has dissolved the National Assembly based on the advice of outgoing Prime Minister Shehbaz Sharif, signalling the end of the current government's term and paving the way for the upcoming general elections. The dissolution, executed under Article 58 of the Constitution, came three days before the scheduled end of the five-year constitutional term of the Assembly. The elections are likely to be delayed due to the requirement for delimitation of constituencies following the approval of new census results. The ECP must complete delimitation within 120 days before announcing the election schedule. While expedited process-



es are technically possible, uncertainties remain about whether the ECP will adhere to the 90-day deadline. Following the dissolution of the National Assembly, the appointment of a caretaker prime minister will be initiated under Article 224-A of the Constitution. Prime Minister Sharif and Leader of the Opposition Raja Riaz will collaborate to finalise the interim prime minister's name. If an agreement is not reached within three days, the matter will be referred to a parliamentary committee for selection.

In all likelihood, elections are nowhere in sight for at least six months. This means that democracy goes into suspended animation and the accountability of the

caretaker government remains zero. Meanwhile, Imran Khan is behind bars and his chances of coming out soon are bleak for now. Therefore, the army and Shehbaz Sharif have effectively turned Pakistan into a military state by proxy. On the face of it, all looks technically sound and legal but when the Opposition leader is behind bars and the ruling dispensation has a free run, the Opposition is for all practical purposes done away with. Internal dynamics within the ruling party and its coalition partners could have played a role. The ruling party might have assessed that the timing of the dissolution could be advantageous in terms of rallying support from their political base and managing potential challenges from opposition parties. Besides, the government's assessment of its popularity and public sentiment could have played a role in what is seemingly an innocuous move. Shehbaz Sharif iwould have time to run an anti-Imran campaign and discredit him as he would not be around to defend himself. Shehbaz seizes control of the timing and narrative surrounding the transition to the next government. Besides, it would get a free hand to deal with the unrest in the wake of Imran Khan's arrest. But if Shehbaz fails to check the unrest and Imran's popularity increases, there is going to be more trouble in Pakistan.

IMPORT RESTRICTIONS WILL HURT INDIA

The decision to ban the import IT hardware does not augur well for India's image

In a surprise move, India slapped import restrictions on key Information communication technology hardware products such as tablets, laptops etc last week, which were, if implemented as per the actual notice, would have been effective, in less than twenty-four hours. However, economic considerations and frantic calls to senior government officials ensured the due date of implementation for the order has now been pushed to the 1st of November. In the interim, there has been alleged hoarding of these ICT products by some retailers creating an artificial increase in prices, and a heightened purchase by consumers to avoid the import restrictions.

It was surprising for many, that the government chose a month before the G20 leaders' summit and the Digital Economy Work Group ministerial meeting (scheduled in the third week of August) to impose the restrictions. The G20 summit besides focussing on multilateral issues, also has several bilateral meetings on trade-related issues which the government participates in. A negative public relations exercise such as the one just announced, could potentially hijack most of these bilaterals into sorting out trade issues, especially with key trade partners, who are part of the

The government has been quite careful with its G20 preparations and so far, has avoided major public relations faux pas, but the recent order seems to be pushing things in a negative direction. Almost every major India partner country's government has been approached by their respective industry stakeholders to sort out the issue with the Indian government. The message going out to international businesses," India is back to the License Raj, a protectionist regime, a term mostly used to describe India to foreign investors, before the 1990s. Meanwhile, India managed to stitch up early harvest trade deals with Australia and UAE last year and is hopeful to have an agreement with the UK, Israel, Canada and the EU soon. Import restrictions of any nature, especially those related to ICT hardware can become the proverbial straw on the camel's back during many of these ongoing discussions.



The Indian government has its arguments for imposing the restrictions. While they maintain, that many of these hardware have security concerns, given they store huge amounts of citizens' sensitive data, these restrictions shall be able to put a check on possible data pilferage, especially to countries threatening India's sovereignty. The reference to China can't be missed which according to data is one of the largest exporters (amounting to almost 70%) of ICT hardware in the country. The argument for reducing the trade deficit with China is also being liberally splashed in private meetings. However, the real reason seems to be the lack of enthusiasm by top manufacturers towards the government's incentive scheme for manufacturing in India.

The government after much deliberations, upgraded the Production Linked Incentive scheme, with available sops of nearly INR 17,000 cr for any large manufacturer setting up their production base in India. The window for making the investments has been revised a couple of times, due to the lack of enthusiasm from potential investors and the current deadline is 31st August. Many sources indicated that the import restrictions are a last-ditch attempt by the government to coax some manufacturers to invest under the production-linked incentive scheme. The wider influence of the political economy can't be missed, as India faces a huge general election early next year. The young voter will not be swayed by flavours from the last century electoral politics. Jobs, disposable income to spend on travels and eat-outs for a social media first generation form an important swing, However, the domestic concerns should not blindfold the overall goodwill generated by India as an important investment destination. A balance has to be found.

Russia's newfound interest in Africa



Africa is being emphasised as the 'bedrock of the foundations of Russia's foreign policy "to garner support from developing countries

ussia has, for a long, considered African nations as critical actors in its endeavours to enhance global influence and reshape the existing highly divided international order. Through the recently held second Russia-Africa Forum Summit in St. Petersburg on 27-28 July 2023, Russia is trying to seize an opportunity to enhance its geopolitical position. Moscow is strategically leveraging its influence in Africa to secure advantageous access to the continent's abundant natural resources, expand its export markets, and most importantly garner African backing for its diplomatic goals both with-in Africa and on the international stage. With 54 nations, Africa constitutes the most substantial voting bloc at the United Nations. However, when it came to General Assembly resolutions denouncing Russia's actions in Ukraine, Africa was the most divided region globally in condemning the Russian aggression on Ukraine.

Presently, leaders from just 17 African states are attending high-level talks in St Petersburg less than half the 43 who went to the first forum summit in 2019 – which Kremlin described "as a crude Western pressure to discourage African nations from taking part". On Thursday, Russian President Putin warmly welcomed African leaders to strengthen Moscow's position in a continent that has grown significantly crucial to Russia's geopolitical aspira-tions. Putin has emphasized the significance of the two-day summit, as a pivotal event aimed at reinforcing connections with the assertive and influential continent of 1.3 billion people on the global stage. Moscow's main objective is to demonstrate its capabilities and prove a point and showcase that Russia can effectively navigate the isolation attempts made by several Western nations.

African states on the other hand are

aiming to assert themselves as influential bloc instead of becoming entangled in yet another proxy conflict between Russia and the United States. Their objective is to diversify their economic and political partnerships strategically, seeking tangible outcomes beyond superficial promises. Analysts note that African leaders, constituting the largest bloc at the UN General Assembly, are well aware of their rising geostrategic significance amid the competition between Russia and the United States on various fronts.

This awareness prompts them to adopt a cautious and strategic approach intervene were largely inconsequential and did not yield any positive results.

The recently adopted St. Petersburg Declaration by both Russian and African leaders underscores their strong dedication to nurturing a mutually beneficial partnership and exploring new avenues for cooperation. lysts, Russia's engagement with Africa appears to be symbolic rather than substantive. While

Moscow aims to demonstrate its continued global importance to African leaders and counter the perception of being a pariah, it has not translated its growing geopolitical ambitions into significant investments in Africa. Despite the pledges made at the first Russia-Africa Summit in 2019 to double trade with African countries to \$40 billion in five years, the actual trade volume between the two sides has remained stagnant at around \$18 billion. Moreover, Africa imports nearly eight times more from Russia compared to what Russia buys from the continent. Russia only accounts for a mere one per cent of foreign direct investment that flows into

Furthermore, during the St. Petersburg summit, great emphasis was paid to the narrative of Russia and Africa facing a shared struggle against new forms of colonialism imposed by the West. This narrative aligns with the Kremlin's strategy to rally support in Africa behind its actions in Ukraine. Therefore, if there is any political lesson to be drawn from the Russia-Africa Forum Summit, it is that Russia's pursuit of Africa has intensified. Now more than ever, Africa is emphasized as the bedrock of the foundations of Russia's foreign policy" to garner support from developing countries. This coalition-building strategy is not solely based on economic incentives but also relies on indirect, implicit, and sophisticated efforts to gain the favour and support of both current and future

36 killed on Maui as fires burn through Hawaii

housands of Hawaii residents raced to escape homes on Maui as blazes swept across the island, destroying parts of a centuries-old town and killing at least 36 people in one of the deadliest US wildfires in recent years.

The fire took the island by surprise, leaving behind burned-out cars on once busy streets and smoking piles of rubble where historic buildings had stood in Lahaina Town which dates to the 1700s and has long been a favourite destination for tourists. HK police arrest 10 linked to overseas

activist support Hong Kong (AP): Hong Kong police on Thursday arrested 10 people on suspición of endangering national security through their alleged involve-ment with a now-defunct fund that aimed to help people arrested in 2019 pro-democracy protests, escalating a crackdown on dissidents in the semi-autonomous Chinese city.

The four men and six women are suspected of con-spiring to collude with the 612 Humanitarian Relief Fund to receive overseas donations and provide financial support to people who fled Hong Kong or organisations that called for sanctions against the city, police said. A police statement did not identify the suspects or those alleged to be supported by them. The arrests further intensified the Hong Kong government's crackdown on dissidents after the 2019 protests. More than 260 people have been arrested under a Beijingimposed national security law, including many of the city's leading pro-democracy activists.

Last year, the fund's former trustees including Roman Catholic Cardinal Joseph Zen, singer Denise Ho and former pro-democracy lawmaker Margaret Ng were arrested under the tough law. Zen's arrest at that time sent shockwaves through the Catholic



Russia forces Ukraine to evacuate civilians

Ukrainian authorities ordered a mandatory evacuation Thursday of nearly 12,000 civilians from 37 towns and villages in the eastern Kharkiv region, where Russian forces reportedly are making a concerted effort to punch through the front line. The local military administration in Kharkiv's Kupiansk district said residents must comply with the evacuation order or sign a document saying they would stay at their own risk. Ukrainian Deputy Defence Minister Hanna Maliar had said the previous day that "the intensity of combat and enemy shelling is high" in the area.

The city of Kupiansk and the territories around it were under Russian occupation until September 2022, when Ukrainian forces conducted a Thursday, Russian air defence

Kim calls for military to sharpen war plans

North Korean leader Kim Jong Un ordered his military to sharpen its war plans and signed off on expanding combat operations of frontline units, state media said Thursday, as the United States and South Korea prepare for a large-scale combined military exercise.

Condemning the allies' expanding drills as invasion rehearsals, Kim has used them as a pretext to further accelerate his weapons demonstrations, which have included the testing-firings of more than 100 missiles since the start of 2022, driving tensions on the Korean Peninsula to their highest point in years. Experts say Kim's nuclear

push is aimed at forcing the United States to accept the idea of the North as a nuclear power so he can eventually negotiate economic and security concessions from a position of strength.

Thursday's meeting of the North Korean ruling Workers' Party's central military commission, which Kim controls as chairman, was to discuss advancing his military's war readiness and establishing offensive countermeasure plans to deter his adversaries, getting more blatant in their reckless military confrontation" with the North.

After talks of boosting North Korean frontline units and stepping up war drills to incorporate new strategies and weapons, Kim signed an order to implement unspecified "important military measures," Pyongyang's official Korean Central News Agency said. During the meeting, Kim stressed that the military must acquire "more powerful must acquire "more powerful strike means" to bolster his nuclear deterrent and make speedier deployments of those weapons to combat units. He called for the country's munitions industry to step up mass production of various weapons and systems, and for the military to actively conduct "actual war drills" to digest those systems and enhance its war-fighting capabilities, KCNA said.

Photos of the meeting published by state media showed Kim pointing to spots in a blurred map of the Korean Peninsula. The spots appeared to be the metropolitan region surrounding the South Korean capital of Seoul, where half of the country's 51 million people live, and an area around the central city of Daejeon, the

Kim's comments during the meeting echoed what he said last week during a threeday tour of the country's key weapons factories, including a facility that produces launcher trucks for his intercontinental ballistic missiles designed to target the U.S. mainland, and called for significant improvements to the country's arms and war readiness. Kim's visits also included an artillery factory that deepened outside concerns that North Korea was preparing to export artillery and other arms supplies to Russia as President Vladimir Putin reaches out to other countries for support in the war in

Redouble recovery efforts, **RBI deputy Guv asks banks**

eserve Bank Deputy Governor Swaminathan J on Thursday asked banks to double down on recovery efforts to limit the losses from the write-off of loans, saying it will help them post higher profits.

The career commercial banker who recently joined the regulator also added that a bank's ability to recover or a borrower's liability to repay does not diminish with a loan write-off and recoveries can help a lender post higher profits. Earlier this week, the government informed Parliament that over Rs 14.56 lakh crore of advances were written-off by banks since FY15.

"We would like the banks to redouble their efforts because these are accounts that are parked in a special account and we would like to see more and more recoveries,' Swaminathan told reporters at the central bank headquarters here.

Non-tariff barriers emerging as potent tool to disrupt legitimate textiles trade: AEPC

Non-tariff barriers (NTBs) are gradually emerging as a potent tool to damage and even disrupt legitimate textiles trade, apparel export promotion council (AEPC) said on Thursday.
As many as 131 NTB notifications are issued

related to the textile sector since 2019 with Uganda at the top position with 71 notifications, it said. It was followed by Ecuador (10), China (8), Taiwan (7), Israel (5), USA (4), and Peru (3).


These barriers include certifications, inspections, regulations, standards, SPS (sanitary and phyto-sanitary - related with plants and animals) measures, and technical barriers to trade (TBT).

These measures are by and large in conformity with the rules of the World Trade Organisation (WTO). But when these measures are used unfairly, in violation of WTO agreements to discriminate against imports and restrict market access, then they become non-tariff barriers hampering legitimate trade. The council has organized a webinar on emerging non-tariff barriers in the apparel export sector with an aim to sensitize the industry about the issue. Mithileshwar Thakur, Secretary General, AEPC, said: "NTBs have slowly but surely emerged as a potent tool to damage and even disrupt legitimate trade." Of late, innovative ways were being explored by developed economies like the European Union to restrict imports from developing countries, he said



Legislations like CBAM (Carbon Border Adjustment Mechanism) and EUDR (EU Deforestation Legislation) are violative of WTO agreements and bound to make Indian exports to the EU less competitive, he added.

Ways and means need to be explored to handle the challenges arising out of these legislations, Thakur said. Speaking during the webinar, Seetharaman Sampath, Co-founder, Sarvada Legal, said that these NTBs arise from different measures taken by governments and authorities in the form of laws, regulations, policies, conditions, restrictions or specific requirements, or prohibitions that protect the domestic industries from foreign competition. "EU, US and UK are our top markets for the apparel sector and so we should be extra careful about their moves to bring any legislation/regulation in the nature of TBTs affecting the apparel sector," Sampath said. Most countries follow a consultation process before a new TBT is introduced or an existing TBT is modified.

The Securities Appellate Tribunal (SAT) has set aside a markets regulator Sebi's order directing the National Stock Exchange (NSE) to disgorge Rs 62.6 crore, along with interest, in

the dark-fibre case. However, all other orders passed against NSE, comprising a periodic review of its co-location facility, putting in place comprehensive guidelines, Standard Operating Procedures and protocols with respect to its co-location facility were found appropriate and were upheld,

according to an SAT order.

In addition, the appellate tribunal has quashed Sebi's direction barring NSE's former MD and CEO Chitra Ramkrishna from holding any managerial positions in a market intermediary for three years and three other former officials -Ravi Varanasi, Nagendra Kumar and Devi Prasad Singh — for a period of two years.

The case relates to the alleged differential access given to certain broking firms in the form of 'dark fibre' at NSE, to connect across the co-location facilities before other members.

Dark fibre or unlit fibre, with respect to network connectivity, refers to an already laid but unused or passive optical fibre, which is not connected to active electronics/equipment and does not have other data flowing through it and is available for use in fibre-optic communication.

The order came after 11 entities challenged Sebi's order

NSE in dark-fibre case passed in April 2019, against 17 entities, including NSE, its for-

mer officials and stock brokers. In its order, Sebi alleged that NSE was negligent in not carrying out due diligence while allowing an unauthorised vendor to provide P2P connectivity to its trading members. Partly quashing Sebi's order,

"the direction to disgorge an amount of Rs 62.58 crore along with interest cannot be sustained and to that extent, the order is quashed".

the appellate tribunal said that

It further said that other directions passed by Sebi against NSE "are affirmed and are

appropriate". "Since we have set aside the unlawful gains, we direct SEBI to refund a sum of Rs 62.58 crore along with interest accrued on it to the appellant within four weeks from today. We further vacate the direction given to the appellant for depositing the revenues emanating from co-location facility, etc. In an escrow account and the details to be submitted to Sebi from time to time," SAT said in its 111-page order passed on Wednesday.

Also, SAT has quashed Sebi's order that directed Way2Wealth Brokers to disgorge Rs 15.34 crore and GKN Securities to disgorge Rs 4.9 crore. It upheld the market regulator's directions that restrained W2W and GKN Securities from accepting, inducting or enrolling any new client for one year and barring them to undertake any trade in their proprietary accounts for two years.

Bayern reach deal to sign Kane

Alvarez joins West Ham from Ajax

AP LONDON

Bayern Munich have reached an agreement to sign England captain Harry Kane from Tottenham, for a Bundesliga record fee of more than 100 million euros (\$110 million), reports said on Thursday.

Talks between the two clubs had been ongoing for several weeks, as Tottenham chairman Daniel Levy pushed for a higher fee, aware that Kane could leave on a free at the end of his deal in 2024.

Bayern had reportedly submitted their final bid for the 30-year-old striker in recent days, breaking through the 100-million-euro barrier for the first time.

The Athletic reported the deal between the two clubs first, and was followed by Sky Sports and several other British and German media.

Kane must now decide whether he wants to leave or not, the reports said.

"Kane is coming!" ran a headline in top-selling German tabloid Bild, which reported the striker had pushed for the negotiations to be resolved before Tottenham's Premier League opener on Sunday.

The mood in British media

was more downbeat however -- The Sun reported that Spurs fans were "heartbroken" and had "gone into meltdown".

Six-time European champions Bayern have been historically more reluctant to spend big on transfer fees than many of their European rivals.

International badminton's flagship event, the World Tour Finals, will be held in Hangzhou for the next four years, a further sign the post-Covid revival of major sports events in China is gathering

Badminton is hugely popular in the country and the national team is a dominant force in the global arena, having recently retained the mixed-team Sudirman Cup for a record 13th time.

This year's season-ending BWF World Tour Finals will be held from December 13-17, the federation announced late on Wednesday. The finals were last held in China in 2019, in Guangzhou.

Hangzhou, an eastern Chinese city 160 kilometres from Shanghai, will next month host the pandemicdelayed Asian Games, an Olympic-sized multisport event originally due to have been staged a year ago.

England face Colombia test, Japan eye Women's WC

rhe Women's World Cup is down **1** to the last eight, with European champions England widely seen as the favourites to lift the trophy following the elimination of holders

the United States. Here's a look ahead to the quarter-final action on Friday and Saturday in Australia and New Zealand:

SPAIN V NETHERLANDS

The first quarter-final might be the most-evenly matched, with a Spain side sitting sixth in the world rankings facing the ninth-ranked Netherlands.

Spain are in the quarter-finals for the first time despite reigning Ballon d'Or Alexia Putellas struggling to make an impact as she continues to recover fitness following a ruptured ACL. Instead her

Barcelona teammate Aitana Bonmati has been the standout.

Coach Jorge Vilda made sweeping changes to his line-up for the 5-1 last-16 win over Switzerland and must decide whether to stick with the likes of Laia Codina in central defence and Cata Coll in goal.

The Netherlands, runners-up in 2019, have put the absence at the tournament due to injury of prolific striker Vivianne Miedema behind them and topped their group ahead of the USA.

Andries Jonker's team have conceded just one goal so far. They will need to be strong at the back against a Spain team that has notched 13 goals in four games.

JAPAN V SWEDEN

Practically written off before the tournament, Japan are the only former World Cup winners still stand-



ing following the exits of the USA, Germany and Norway. The 2011 champions have been clinical, scoring 14 goals and letting in just one in wins over Zambia (5-0), Costa Rica (2-0), Spain (4-0) and Norway

The player grabbing the attention is Hinata Miyazawa, the 23year-old leader in the race for the golden boot with five goals. But it is not just about her.

World number three Sweden are the top-ranked team left in the tournament after they ousted the USA on penalties. However, they were second-best throughout that game and grateful to goalkeeper Zecira Musovic for several key saves. They have now kept three consecutive clean sheets.

Japan beat Sweden 3-1 in the semi-finals in 2011, but Sweden won by the same scoreline when they met at the Tokyo Olympics.

AUSTRALIA V FRANCE Australia appear to be getting

stronger as they go along, surviving a wobble in the group stage before comfortably dispatching Denmark 2-0 in the last 16. They are aiming to reach the

semi-finals for the first time and are boosted by the return to fitness of star striker Sam Kerr, who returned from three weeks out with a calf problem as a substitute against Denmark.

France are hoping Australia suffer the same fate as befell them four years ago, when as hosts they went out in the quarter-finals to the eventual winners, the USA.

Herve Renard's team cruised through in the last 16, beating Morocco 4-0. They have scored 12 goals in their last three games, but they will have to deal with a hostile atmosphere from 50,000 spec-

ENGLAND V COLOMBIA England are the favourites to win

the trophy, while Colombia are the surprise quarter-finalists, and 21 places separate the teams in the world rankings. However, England stumbled into

the last eight, needing penalties to see off Nigeria, and they cannot afford to take Colombia lightly given the South Americans beat Germany in the group stage and have one of the most exciting players at the tournament in Linda Caicedo. Sarina Wiegman's European

champions are also hindered by the absence of Lauren James, with the 21year-old Chelsea attacker suspended after being sent off against Nigeria for stamping on an opponent. Colombia reached the quarter-

finals for the first time by beating Jamaica 1-0 and will hope to have a lot of support like in previous

No. 4 slot in ODIs issue for India: Rohit Not really thinking

o batter has succeeded in settling into the vital number four slot in the Indian ODI team since the retirement of Yuvraj Singh, captain Rohit Sharma said on Thursday, raising serious concerns before the World Cup.
With the 50-over World

Cup less than two months away, India are struggling to find a batter for the No. 4 slot, something that has also troubled them in the previous edition in 2019 in England.

Shreyas Iyer, who is on a comeback trail after a long injury layoff, did well in his 20 matches at No. 4, scoring 805 runs at 47.35 with two centuries and five fifties.

"Look, No. 4 has been an issue for us for a long time. After Yuvi (Yuvraj Singh), nobody has come and settled themselves in.

"But, for a long period of time, Shreyas (Iyer) has actually batted at No. 4 and he has done well - his numbers are really good," Rohit told reporters on the sidelines of a La Liga event

"Unfortunately, injuries have given him a bit of trouble; he has been out for a while and that is honestly what has happened in the last 4-5 years. A lot of these guys have got injured and you will always see a new guy coming and playing there," he said.

The India captain said the percentage of injuries to players in key positions has hampered

the team in the longer run.

"The percentage of injuries that have happened in the last 4-5 years, it is massive. When the players get injured or are not available, you try doing different things with different players that is what I have to say about No. 4," he said.
"Even before, when I was

not the captain, I was watching no? There were so many guys who came in and went out. But injuries kept them away or they were not available or someone lost form," Rohit added.

With both KL Rahul India's preferred option for No. 5 as wicketkeeper-batter - and Iyer on comeback trail, Rohit

said they will wait and watch how these two players go.

"No one is an automatic (selection), even I am not. We have this thing where nobody is guaranteed a spot. We cannot say that 'you are there after all

or things like that," Rohit said. "Yes, some players know that they are going to play but at this point in time, playing three ODIs in the West Indies was a good opportunity to look at a few guys. In the Asia Cup, again, we will face good opposition," he said.

More than 900 samples collected for dope tests by NADA in June & July

The National Anti-Doping ▲ Agency (NADA) collected more than 900 dope samples from athletes of various sports, with a whopping 199 coming from track and field, in June and July ahead of the upcoming Asian Games.

The national anti-doping watchdog collected 914 samples, mostly urine though few are of blood, from June 1 to July 31, according to the latest data released by NADA on Thursday.

Athletics is followed by boxing (71), aquatics (65), weightlifting (56), cycling (55), kabaddi (52), wrestling (46), shooting (43) in the number of samples collected in these two months.

The number of samples in other sports are: wushu (35) fencing (33), canoe (32), badminton (24), hockey (23) triathlon (23), rowing (20), archery (15), football (11), judo (11), softball (10), electronic sports (8), sport climbing (7) and cricket (2).
