US court denies Tahawwur Rana's plea, paves way for US to extradite Pakistan-origin biz man to India

In a positive development for India regarding the 26/11 Mumbai terror attack, a US court has denied the writ of habeas corpus filed by Pakistani-origin Canadian businessman Tahawwur Rana. This paves the way for US Secretary of State Antony Blinken to issue a certification for him to be extradited to India where he is sought for his involvement in the 2008 terror attacks.

In a major victory for India's fight in bringing the perpetrators of the 26/11 terror attacks to justice, a US court approved 62-year-old Rana's extradition to India in May.

In June, Rana, who is detained at the Metropolitan Detention Centre in Los Angeles, filed a "writ of habeas

corpus" challenging the court order that acceded to the request of the US that the 2008

'The court has denied Tahawwur Rana's petition for writ of habeas corpus by a separate order," Judge Dale S Fischer, Central District of California, wrote in his order on August 10.

However, Rana has filed an appeal against the order and sought a stay on his extradition to India till the time his appeal in the Ninth Circuit Court is heard. Rana faces charges for his role in the Mumbai attacks and is known to be associated with Pakistani-American terrorist David Coleman Headley, one of the main conspirators of the 26/11 Mumbai attacks.

Judge Fischer in his order

said Rana has only made two basic arguments in the writ. First, he claims that, pursuant Mumbai terror attacks accused to the treaty, he cannot be extradited because India plans be extradited to India. to prosecute him for the same acts for which he was charged and acquitted in a United States court. Second, he argues that the Government has not established that there is probable

> denied both arguments. "Given that, even if (David) Headley's testimony were the entire basis for the probable cause finding, it would be sufficient for the purposes of habeas review because it constitutes some competent evidence supporting the finding. For the reasons stated above,

Following Judge Fischer's order, Patrick Blegen and John D Cline, Rana's two attorneys filed an appeal to the United States Court of Appeals for the Ninth Circuit from the Order entered on August 10, 2023, for denying his petition for writ of habeas corpus.

In a separate appeal, Blegen has filed a petition "for a stay of extradition pending his appeal" to the United States Court of Appeals for the Ninth Circuit from the court's order denying his petition for a writ of habeas corpus.

"As set forth in the accom-

panying memorandum, petitioner submits that a stay of extradition pending appeal is appropriate because he has made a strong showing that he is likely to succeed on the merits of his non-bis in idem claim; he will suffer irreparable harm if he is extradited, potentially including the death penalty; a stay pending appeal will not substantially injure the Government; and the public interest favours a full review of Rana's non-bis claim before he is sent to a country that seeks to execute him," Rana's attorney wrote on August 14.

CBI challenges Lalu's bail in fodder scam

Rashtriya Janata Dal (RJD) Minister of Bihar Lalu Prasad has landed in trouble as Central Bureau of Investigation (CBI) has challenged his bail in alleged fodder scam in the Supreme Court. The SC will hear the matter on August 25. The Jharkhand High Court

had granted bail to the RJD president in four cases relating to multi-crore fodder scam (Dumka, Chaibasa, Doranda, Deogarh treasuries).

Lalu was convicted in the cases and his appeals lay pending in various courts. CBI has sought that the Supreme Court cancels Lalu's bail. The 950crore fodder scam relates to withdrawals made from multiple Government treasuries for cattle fodder.

SC nixes acquittal of RJD leader **Prabhunath in** double murder

The Supreme Court on Friday overturned the acquittal of Rashtriya Janata Dal (RID) leader and former Member of Parliament (MP) murder case from 1995.

Currently serving a life imprisonment term for another murder case, Singh was pronounced guilty by a trial court in 2017 for his involvement in the 1995 murder of legislator Ashok Singh. The latter had triumphed over Prabhunath in the 1995 Bihar Assembly election, leading to threats of elimination within 90 days of the election.

A panel of justices com-prising Sanjay Kishan Kaul, AS Oka, and Vikram Nath convicted Prabhunath, a former three-term Janata Dal (United) or JD(U) and one-time RJD MP from Maharajganj, in the

bears brunt with 518 lives PNS NEW DELHI series of natural calamities, A series of flatural calling floods, lightning

strikes, and landslides during this monsoon season has taken 2,038 lives. Bihar witnessed the gravest impact with a reported casualty count of 518 lives, followed closely by Himachal Pradesh with 330 lives lost.

According to Union Home Ministry data, 101 people went missing and 1,584 received injuries during the rains and floods from April 1 to August 17. As many as 335 districts were affected by the rains, landslides and lightning -- 40of them in Madhya Pradesh, 30 in Assam and 27 in Uttar Pradesh.

Twelve districts in Himachal Pradesh and seven districts in Uttarakhand were also hit by the monsoon floods and landslides.

drowned due to floods, 506 died due to lightning and 186 lost their lives due to landslides during this period, according to the data. As many as 454 people also died due to various other reasons during the mon-

Besides Bihar and Himachal Pradesh, 165 people died due to rains, floods, landslides and lightning in Gujarat, 138 in Madhya Pradesh, 107 A total of 892 persons each in Karnataka and

Uttarakhand. A total of 160 teams of the National Disaster Response Force have been deployed in

Chhattisgarh and 75 in

various States. Of them, 17 teams were deployed in Himachal Pradesh, 14 in Maharashtra, 12 each in Uttar Pradesh and Jammu and Kashmir, 10 each in Assam and West Bengal and nine in Uttarakhand.

Keep environment first: Shah to CAPF

Union Home Minister Amit Shah on Friday urged Central Armed Police Forces' personnel to make environment protection an essential part of their lives as a countrywide plantation drive of the forces reached the four-crore mark with the minister plant-

ing a sapling.
Shah said he trusts that these security forces, more than 10 lakh personnel in collective strength, will ensure that the target of planting 5 crore saplings across the country is met by the end of this

He watered a 'peepal' (Ficus religiosa) tree after putting some soil on the sapling and later e-inaugurated 15 newly constructed buildings that have been built in eight different campuses of the Central Reserve Police Force (CRPF), the country's largest CAPF or paramilitary force with about 3.25 lakh personnel.

Shah launched the 'environment protection' themed plantation drive by the CAPFs' on July 12, 2020, from a CRPF camp in Gurugram, Haryana and all the forces under the command of the Union Ministry of Home Affairs (MHA) were tasked to plant trees, which have a long life of 60-70 years, in their area of

deployment.

These forces included the CRPF, Border Security Force (BSF), Indo-Tibetan Border Police (ITBP), Central Industrial Security Force (CISF), Sashastra Seema Bal (SSB), National Security Guard (NSG), National Disaster Response Force (NDRF) and the Assam Rifles. Shah said when he planned this initiative



there were doubts in some quarters if these figures of plantation could be achieved. Still, the CAPFs and other forces under the MHA made it possible as they undertook this mega mission which can be called a 'Maha Kumbh' for environment protection and conservation.

"As you have made bravery and country's security your nature, I urge you to similarly make environment protection your way of life," he told the jawans at a CRPF camp here.

This way, he said, you will ensure oxygen for future generations and help in minimising the damage to the environment and damage to the ozone layer, he said.

The increase in temperature will not keep life safe on earth and the only solution is to plant more and more trees and lessen carbon dioxide emissions, Shah said. He said climate change and global

warming were a reality as he thanked Prime Minister Narendra Modi for taking initiatives in this context that helped India become a "leader" in this fight to save the environment from harmful gases and human activities.

Shah said this was also the reason that India kept the G20 Summit theme as 'One Earth, One Family, One Future'. India is hosting the G20 Leaders Summit next month in Delhi under its presidency.

He said various initiatives steered or launched by PM Modi like the International Solar Alliance, Mission LiFE (Lifestyle for Environment) and as many as eight national missions for the environment were a testimony of his government's resolve for this sub-

Forces recover foreign ultra's body from Reasi

Ajoint team of security forces early Friday morning recovered the dead body of a foreign terrorist from the thickly forested belt of Dhakikot in the Reasi district. The terrorist was believed to be part of the same group tracked down by the security forces in Gundha-Khawas area of Rajouri on August 5.

One terrorist was killed in the operation while another injured terrorist managed to escape the encounter site. "The body of a second terrorist injured in an encounter at Khawas found by a special operation group (SoG) at Dhakikot area of Reasi", Additional Director General of Police (ADGP), Jammu zone, Mukesh Singh said on Friday. Singh said two grenades, three AK magazines, 90 AK rounds, 32 pistol rounds, and some other material were recovered from the spot.

Lt Col Suneel Bartwal PRO (Defence) Jammu in a separate statement said, "Indian Army, JKP, and SOG have been continuing relentless operations in the thickly forested belt of Reasi district to track down the footprints of an injured terrorist. During the ongoing operations, the security forces deployed along the



high ridge lines near Dhakikot observed suspicious movements of unidentified persons. When one of the suspicious persons approached the deployment site and was challenged, he tried to escape. The Army troops readjusted their positions to prevent his escape. The terrorist was seen stumbling and falling down the cliff in a

Defence PRO said the search was halted for the night due to inclement weather conditions in the forest area. The dead body of a terrorist, possibly a foreigner, was found in the Dhakikot jungle area, he added. Meanwhile, a huge cache of arms and ammunition was recovered by the security forces in Machhal Sector, Kupwara on

India, China hold more talks on Ladakh

However, the Government has said that Rana be extradited to India. In his submission to the US Court on June 23, the US attorney argued that Rana's claims about the legitimacy of his business in Mumbai fall flat.

The evidence does not support Rana's assertion that the Mumbai office conducted legitimate business, but even if it did, the engagement of legitimate business activities does not preclude a finding that Rana's business also served as a cover for Headley's terrorismrelated activities in Mumbai.

"Rana's claims about who funded the Mumbai office also do not relate to whether Rana lacked knowledge of and support for Headley's activities. to continue business operations in Mumbai, the evidence reveals that neither Rana nor Headley renewed the business lease that expired approximately two weeks before the start of the Mumbai attacks," Estrada argued.

The court found sufficient evidence linking him to the murders of Rajendra Rai, aged 18, and Daroga Rai, aged 47, near a polling booth in Chhapra in March 1995. These three persons were fatally shot as they did not cast their votes according to Singh's instructions. After concerns were raised about witness intimidation and influence, the case was transferred from Chhapra to Patna. In December 2008, the trial court acquitted Prabhunath due to insufficient evidence. This acquittal was upheld by the Patna High Court in 2012. The Supreme Court intervention was prompted by the challenge made by Rajendra Rai's brother against the acquittal.

Justice Nath, while deliv-

ering the verdict, stated, "We set aside the impugned order of the Patna High Court and conrespondent vict 2...Prabhunath Singh, under Section 302 (murder) for the murders of Daroga Rai and Rajendra Rai.

elhi Lieutenant-Governor (LG) VK Saxena on Friday wrote a letter to Chief Minister Arvind Kejriwal listing lapses on the part of the Delhi Government that resulted in the recent flooding in the national Capital. In the letter, Saxena also suggested a slew of measures to prevent floods in Delhi in the future. The steps included creating a hydrographic profile of the Yamuna River's width, depth and the height it can reach when excess water is released in it. The LG also proposed that sustainable desilting/dredging, that has been pending for the last 10 years, be undertaken, at the earliest.

Flagging alleged lapses by various Government departments, Saxena stressed that the situation last month had put a question mark on the Capital's preparedness to deal with "such manageable exigencies". He also suggested that instead of the multiplicity of agencies, one Government agency or department be entrusted with the management of the Yamuna.

The LG said that the

Yamuna flows for 44 kms in Delhi, out of which the 22 km stretch from Wazirabad to Okhla has 18 major obstructions that impede the free flow of water.

"Lapses on the part of the Government include the outdated and inaccurate levelbased discharge computing table used by the Delhi Jal Board (DJB) to compute the discharge at Wazirabad barrage and the unprofessional practice of Government departments of not clearing the construction and demolition (C&D) and other waste from bridge construction sites that obstruct the free flow of the Yamuna.

"The highest recorded discharge of 8.28 lakh cusec from Hathni Kund was in 2019, which resulted in the water level in the Yamuna at the Old Railway Bridge (ORB) touching the 206.6-meter mark, whereas, the discharge this year was only 3.59 lac cusec, yet the Yamuna level reached the record level of 208.66 meter at the Old Railway Bridge," the letter read.

Saxena also held heavy accumulation of silt over the last



several years and lack of desilting as one of the reasons for floods in Delhi.

The Najafgarh drain, which brings the maximum discharge from the city into the Yamuna, is filled with silt and garbage to the tune of 108 lakh metric ton. This severely affects the water holding/carrying capacity of this 57-km-long channel," the LG wrote.

The LG further said that there was not one single department or agency that had ownership of Yamuna, especially during the floods.

"While giving a NOC to various agencies for construction of bridges across the Yamuna, the requirement of minimum obstruction inside the river course (must) be ensured. An advance Flood Management Plan for Yamuna Bazaar and other low-lying areas (must) be put in place now," reads the letter.

"While all hands on the deck grappled with the situation, with myself visiting affected areas and sites and supervising restoration and rehabilitation works, this unfortunate instance that threw the city out of gear for days together, also provided us with an opportunity to assess the gaps and accordingly, put in place remedial

LG's 'innovative' desilting work to blame, retorts AAP

Delhi Water Minister Sau-rabh Bhardwaj on Friday alleged that L-G VK Saxena was responsible for the recent floods in the national Capital as the latter had directed an "innovative method called partial gravitational desilting" of drains which caused huge quantities of silt to be deposited in the Yamuna riverbed.

Responding to a letter from Raj Niwas, the Delhi Govern-ment claimed these projects worth several crores were unscientific and illegal, and were not approved by the Minster. "Various desilting and drain/riverbed cleaning projects were being executed under the direction of the LG without sharing any details with the Minister and the elected Government of Delhi," Bhardwaj said in a statement.



Bhardwaj said that the Haryana Government had already accepted that their engineers did not maintain the ITO Barrage and had suspend-

ed the Chief Engineer.
"The HOD of the IFC department was hiding the fact from the Government that the ITO Barrage gates were jammed. It would be interesting to see if the LG would initiate any action against the officer. Also, the Haryana Government sent huge quantities of water towards Delhi through the Hathnikund Barrage while keeping the

Eastern Yamuna canal dry, just to save UP from flooding," Bhardwaj listed the reasons for the cause of floods and sought an explanation from the Raj Niwas.

"Some facts are conveniently concealed regarding various obstructions in river Yamuna that have been created by Central agencies in the name of various road/railway construction projects like the RRTS. Ideally, they should have been removed before the monsoon season. Your good self forgot to mention how huge quality of water was diverted to Yamuna River in Delhi while the Eastern Yamuna canal was kept dry to save UP from flooding. Large quantity of water was diverted towards Delhi despite the fact that the River Yamuna in Delhi was flowing above danger mark," he said, targeting the LG.

'2025 poll will be fought on issue of full statehood for Delhi'

hief Minister Arvind Kejri-Wal on Friday attacked the BJP-led Centre, saying the Ordinance on Services was brought as money power and the threat of the ED and the CBI failed in Delhi. Kejriwal stressed that the next election would be fought on the issue of full statehood for Delhi. Replying to a debate in the Delhi Assembly on the GNCTD (Amendment) Bill, Kejriwal claimed that the BJP was set to lose all seven Lok Sabha seats in the national Capital. The AAP Convener also claimed that the BJP had brought the "Sanghi" model of democracy through the Services Bill and asserted that the 2024 Lok Sabha elections would be fought on the issue of full statehood for the national Capital.

In a scathing attack on the BJP-led Government at the Centre, Kejriwal said the rights of Delhiites were taken away by enacting a law, but he would not let the work being done in Delhi by his Government stop under any circumstances and promised that he would get the rights of the people back.

Kejriwal said, "The demo-cratic rights of the people of Delhi were trampled through the Ordinance and the Bill. There are several styles of democratic systems like the Westminster style and parliamentary style. These people (BJP) have brought the Sanghi style of democracy through this Bill," he said. "The Ordinance on Services was brought because money power and the threat of the ED and the CBI failed in Delhi. He added that recently,

someone from the BJP had threatened him, saying, "We will make you bow. But I want to tell them that no power can make Kejriwal and the two crore people of Delhi bow." Earlier, speaking on the issue, Delhi Services Minister Atishi criticised the BJP for its disruptive efforts to diminish the powers of the elect-



ed Government of Delhi with the GNCTD (Amendment) Bill. The BJP's manifestos from 1989-2014 claimed that the party would get Delhi 'full statehood', but they forgot their own promises after 2014, why?" the Minister questioned.

Atishi said that just as the Viceroy ruled over India during colonial times, regardless of the people's wishes, the BJP has done the same by imposing the LG on the people of Delhi and the elected Government. "The BJP was scared that if CM Arvind Kejriwal gets complete power the nation would witness the pace and efficiency with which work for the public is done. The BJP oppressed Delhiites and took away their power to vote. The people will give BJP a stern response in the forthcoming Lok Sabha elections," Atishi added.

HC reserves verdict on confirmation of death penalty in Batla House case

¬he Delhi High Court on Friday reserved its verdict on confirmation of the death penalty awarded to Ariz Khan, following his conviction in the sensational 2008 Batla House encounter case, in which decorated Delhi Police Inspector Mohan Chand Sharma lost his life.

"Arguments have been heard. Verdict reserved," said a Bench of Justices Siddharth Mridul and Amit Sharma after the lawyers for the convict and the State concluded their submissions. Advocate MS Khan argued that there was nothing to suggest that Ariz Khan can't be reformed.

"If there is a probability, not possibility, that the convict can he reformed, life sentence is the rule. There is a probability of transformation and reformation," he submitted.

Special Public Prosecutor



the Delhi Government, said that killing a uniformed police officer was a "rarest of rare" case which justified the death sentence. He also placed before the court Ariz Khan's social investigation report and psychological analysis report, and submitted he has "adequate intellectual and cognitive functioning" and his conduct in jail was "unsatisfactory."

Inspector Sharma of the Delhi Police's Special Cell was killed during the encounter between the police and terrorists in Jamia Nagar in South Delhi on September 19, 2008. Two terrorists were also killed in the encounter which took place days after five synchronised

bomb explosions rocked the national Capital, killing 39 people and wounding 159. Sharma had raided the place while looking for the terrorists responsible for the blasts.

The trial court had on March 8, 2021, convicted Ariz Khan, saying it was duly proved that he and his associates murdered the police officer and fired gunshots at him. On March 15, 2021, it had awarded Khan capital punishment and also imposed a fine of Rs 11 lakh on him, making it clear that Rs 10 lakh should be immediately released to the family of Sharma.

Subsequently, the High Court received a reference for confirmation of the death sentence awarded by the trial court to Khan. When a trial court sentences a person to death, its verdict is examined by the High Court where arguments are heard for confirmation of the

The Lt Governor said the Centre of excellence in wrestling, weight lifting, boxing, judo and kabaddi is being developed at Sector-8, Dwarka, Centre of excellence in tennis and shooting at Sector-19, Dwarka and Centre of excellence in football and hockey at Sector-23, Dwarka. Besides, a golf course, spread over 157.92 acres is also coming up at Sector-24, Dwarka. All these projects are likely to be completed by end of this year. More such sports complexes will be opened in the national capital soon, he added. In Rohini Sector 33, Centre of excellence in aquatics is being developed, which is likely to be completed by June 2024.

But, Birla did not allow them to speak, observing "Do Opposition members think this is some garden or cafe where they can come and

go whenever they want?"

Speaking on the issue, Delhi Cabinet Minister Imran Hussain said on one hand Prime Minister Modi talks about fighting corruption, but the CAG report has shown that agencies of the Centre are

Even as the Minister spoke, the BJP MLAs protested over being denied the chance to participate in the discussion and continued to raise slogans.

MLAs not allowed to speak in Assembly: BJP

A case is being registered and further investigation is underway," the officer said. Flight UK971 was to depart at 8:30 AM. Airport security sources said the airport call centre received a call at 7:38 AM and the caller said that "three bombs have been kept in flight No. UK971 parked at gate No. 42 and they will explode in an hour. The call got disconnected immediately.

All passengers and crew of the flight were deboarded and anti-sabotage checks were conducted in an isolation bay at IGIA, they said.

Gadkari slams NHAI officials over 'lax response' to CAG on Dwarka project

On being 'targeted', Union Minister Nitin Gadkari has conveyed his displeasure with the lopsided attitude adopted by certain officials responsible for responding to queries raised by the Comptroller and Auditor General (CAG) with regard to the cost of construction of the Dwarka Expressway.

A political row has erupted on the CAG report that flagged the high cost of construction of the Dwarka Expressway with Opposition parties led by Congress attacking the Modi Government with allegations of corruption in the matter.

With series of audit reports related to road and highways constructions implicating the Road Transport Highways Ministry (MoRTH), Gadkari



convened high-level review meetings on Thursday and Friday and directed the Ministry as well as the Central road making agency NHAI to fix the responsibility of this lapse on the part of senior concerned officials.

Sources said the Ministry had concluded that in the absence of an adequate response from the Ministry and National Highway

Authority of India (NHAI), the CAG adopted an incorrect methodology for computing the cost of Dwarka Expressway.

Ministry officials also explained that the CAG has simply divided the total cost of construction of ₹91,000 crore (expenditure) under National Efficiency Programme with the project's entire length of 5,000 kilometres under development. They

CAG slams Tourism Ministry for ₹5 cr loss to Govt in Puducherry

The Comptroller Auditor General of India (CAG) has come down heavily on the Union Tourism Ministry for wasteful expenditure of over ₹ 5 crore by sanctioning a project at a flood-prone zone in Puducherry without assessing its feasibility.

Needless to say, the spate of floods in the region in the past few years have washed away the tourism amenities constructed under the project at the site in Yanam in the UT, thus along with it, exchequer money also went down the drain, the CAG has revealed in its report tabled in Parliament recently.

It stated that under the central flagship Swadesh Darshan, the UT's project envisaging construction of tourism amenities such as of walkway, fencing, and bamboo house etc at a sand dune in mid-stream at the junction point of Coringa river and Gowthami Godavari river in Yanam was given nod. "The DPR for development of

the Department of Tourism, Puducherry, was sanctioned in December 2015 by the Ministry under the project 'Development of UT of Puducherry as Tourist circuit," said the report.

The approval came despite the fact that the site was in a flood prone area and the highest flood level was faced in Yanam in August 2013, stated the top auditor. The Andhra Pradesh Government too had objected to the work stating that it was obstructing free flow of the Godavari River. Also, approval for construction activities was not obtained from the Yanam Planning Authority, it

ED files chargesheet against Senthil Balaji

Enforcement ▲ Directorate (ED) on Friday said it has filed Prosecution Complaint or chargesheet before Special Court, Chennai against V Senthil Balaji, the then Transport Minister, Tamil Nadu on money laundering charges linked the 'Cash for Jobs Scam' in the State Transport Corporation and Metropolitan Transport Corporation (Chennai).

The chargesheet was filed under Prevention of Money Laundering Act on August 12 and the court took cognizance of the Prosecution Complaint August 16. The ED initiated money laundering investigation on the basis of three FIRs registered by Central Crime Branch (CCB), Chennai in the 'Cash for Jobs Scam' wherein three chargesheets have been filed arraying Senthilbalaji as main accused. In this case, the Supreme Court by order dated

May 16, 2023, had directed Tamil Nadu State Police to further investigate and file supplementary chargesheet within two months and allowed the ED to proceed with its investigation lifting the stay on investigation vide Madras High Court order dated September

cardiovascular disease, as per a team of scientists who have identified a link between high white blood cells in the saliva of healthy young adults and an early cardiovascular disease warning sign. Researchers noted that

high levels of white blood cells, which indicate gum inflam-mation, correlated with a compromised flow-mediated dilation, an early warning sign of heart disease. Scientists suspect that

inflammatory factors may enter the bloodstream through the gums and damage the vascular system, leading to cardiovascular diseases.

The study, published recently in the journal Frontiers in Oral Health, found that

high levels of white blood cells correlated with compromised flow-mediated dilation, an early indicator of poor arterial health.

"Even in young healthy adults, low levels of oral inflammatory load may have an impact on cardiovascular health - one of the leading causes of death in North America," said the corresponding author of the study, Trevor King from the Mount Royal University in Canada.

Periodontitis is a common infection of the gums which has previously been linked to the development of cardiovascular disease.

Scientists suspect that inflammatory factors may enter the bloodstream through the gums and damage the vascular

"We are starting to see more relationships between oral health and risk of cardioauthor of the study, Ker-Yung Hong, who now studies dentistry at the University of

Western Ontario, Canada. "If we are seeing that oral health may have an impact on the risk of developing cardiovascular disease even in young healthy individuals, this holis-

tic approach can be imple-mented earlier on," Hong said. "Optimal oral hygiene is always recommended in addition to regular visits to the dentist, especially in light of this evidence. But this study was a pilot study," said King.

"We are hoping to increase the study population and explore those results. We are also hoping to include more individuals with gingivitis and more advanced periodontitis to more deeply understand the impact of different levels of gingival inflammation on cardiovascular measures," he added.

NIA raids in Bihar arms seizure case

to judicial custody. The case was subsequently handed over to the NIA, which re-registered it on June 23, 2023. "Following extensive investigations, the NIA today cracked down on two premises connected with the two jailed accused and seven premises of other suspects in the case.

Several digital devices, including mobile phones, Tablet, HD card and Memory card, along with SIM cards, a pocket diary containing mobile numbers, pages containing Naxal content, as well as other incriminating documents were seized during the raids," the agency said in a statement. The case relates to the seizure of two AK-47 rifles, five magazines

and 460 rounds of 7.62x39 mm live ammunition, which were found buried in the for est area near Bariakala village under Laukariya police station, Bagaha in West Champaran district.

The recoveries were made by the State police after a tipoff led them to the Siudi Bandh area of Mashrakh under Saran police station where the two accused were camping and conspiring to commit a terrorist act. Their interrogation subsequently took the police to the Bariakala village forest area. The NIA is examining the various gadgets and documents seized in raids conducted on Friday as part of its ongoing investigations in case.





Man-made tragedy

Unbridled construction on riverbeds is behind the catastrophic floods in Himachal Pradesh

mid the ongoing monsoon season, Himachal Pradesh, Punjab and Haryana are grappling with a dire catastrophe that has cost these states a fortune. The relentgrappling with a une catastrophic that has cost these downpour has transformed serene rivers into roaring torrents, causing widespread devastation and loss of life and property. This situation, however, is not solely the result of nature's fury; it is the consequence of unchecked human actions that have disrupted the delicate balance between progress and environmental responsibility. The disturbing trend of constructing hotels and resorts on riverbeds, oblivious to the potential consequences, has emerged as a prominent contributor to the ongoing tragedy. The allure of scenic waterfront properties has driven a reckless pursuit of profit, often overshadowing prudent considerations for the environment and local communities. As these structures sprawl across the riverbanks, they impair the natural flow of water, causing disastrous consequences during heavy rainfall. The repercussions of this short-sight-



ed development approach are now on full display. Thousands of residents have been forced to abandon their homes, a direct result of the man-made encroachments that obstructed the rivers' natural paths. The scale of destruction is staggering, with homes reduced to rubble and livelihoods swept away. This indeed is a direct consequence of greed and unbridled desire to choke nature to the maximum. The nexus among the builders, politicians and

bureaucrats has played havoc in the state. The illegal construction goes full steam while the administration looks the other way.

Incessant rain has triggered flash floods, landslides and other calamities, compounding the crisis. The toll on lives and agriculture is heart-wrenching, with both states witnessing substantial financial losses. Haryana and Punjab have suffered estimated losses of hundreds of crores, while Himachal Pradesh's losses are estimated at a staggering Rs 8000 crores. The unchecked expansion of human settlements onto riverbeds must be met with strict regulations and responsible land use practices. The consequences of prioritising short-term financial gains over long-term environmental sustainability have become painfully clear. The lessons from this disaster should serve as a stern reminder that our actions have profound repercussions on the environment and the local population we share it with. It is imperative that accountability is assigned not just for immediate relief efforts, but also for the regulatory oversights that allowed such reckless construction to thrive. These floods must become a turning point in our approach to development. Only through responsible planning and a renewed commitment to environmental stewardship can we hope to prevent such disasters from recurring.



national convener of the IT cell of a national party makes a wholly partisan accusation at members of his rival party, he is entitled to be suggestive, provocative, and in the lamentable context of our politics, even 'economizing' with the truth. But the creativity can get unwarranted and indecorous when it is tantamount to questioning the sacred and inviolable tenets of constitutional governance e.g., the principle of civilian control over military affairs.

The Armed Forces of India have coercive and kinetic abilities that allow them to undertake violence on behalf of the Sovereign (externally or internally), as ordered by the legitimate government of the day. A professional soldier is expected to respect and abide by the constitutional wiring of 'civil-military relations' in a non-partisan and non-prejudiced manner (all pros and cons of undertaking or refraining from an order are left to the competent authorities who are expected to nuance the civilian thinking, optimally) – but the soldiers on the ground simply take 'orders' and failing to do so, is a dereliction of duty. This discipline is critical to maintaining the apolitical nature of the 'sword arm of the nation' and for it to serve the sovereign, regardless of the party in But the incorrigibly partisan

politicians can sometimes disregard this nonpartisan ideal and either try to usurp and appropriate the 'muscular' imagery of Indian Soldiers towards their utility or like recently, drag the combatants (whilst in service) into ascribing 'intent' onto their actions, while in 'Uniform'. It is dangerous and unacceptable, either way. Beyond the operational imperatives, the Armed Forces do not act on their own volition but do so, at the behest of the government. Only enemy nations and forces inimical to constitutional India would suggest that the operational action of a soldier is owing to his/her

A far more consequential concern of dragging the apolitical institution and that of its fraternity in 'Uniform' towards political decisions, was recklessly sug-

All political parties have someone or the other in terms of Veterans in their ranks which is usually a matter of pride and necessity to have a cross-section of perspective, especially from the security realm. But to link their prior participation in any militaristic act with the implicit 'intent' besetting their act then is fraught with frightening consequences for the apolitical institution. Whereas, to question the dispensation of the day then (in this case, the rival opposition party today), may be par for the course, as could be said of other latter-day actions e.g., 1984 Operation Blue Star etc., – but questioning the individual 'intent' of Soldiers who merely undertook orders then, is unwarranted and indecorous (that it was also an abjectly false statement, is far less in terms of impropriety). It sadly demonstrates, that matters about the hallowed 'Uniform' are not free from political taint or absorp-

Ironically, some of the most illustrious Veterans in the political domain did repose faith in the party flag of the said convener, after hanging their boots, and rightfully their conduct or participation in any earlier combat operation, insurgency, or war remained beyond the remit of their personal 'intent', as it should be. The increasing trend to blur the hard lines of necessary 'distance' between the Armed Forces and Politics, is a sad reality, and Robert Frost's insistence that 'good fences make good neighbours' applies to the sensitive civilian-military relations, too. Just across the Lineof-Control (LOC), their Armed Forces do indeed have an independent 'intent' akin to a 'State-within-a-State' (unlike India), and they are infinitely poorer as a nation, for that. If speaking the truth in politics is a luxury by itself, at least spare the 'Uniform' from discourse and linkages.

Forced conversions spark concerns in India and Pakistan. The well-being and rights of all individuals, regardless of their faith, must be ensured

orced conversions of women have emerged as a pressing issue in both ◀ India and Pakistan, casting a shadow over the principles of individual freedom, religious choice, and societal harmony. As the spotlight intensifies on these disconcerting practices, civil society activists, legal experts, and concerned citizens are grappling with the complexities surrounding this contentious

In India, the focal point of concern revolves around the conversion of women from the majority community, stirring restiveness among various segments of the population. Activists, while recognizing the sacrosanct right of individuals to alter their faith, invoke the provisions of the Special Marriage Act, which legally sanctions interfaith unions. Indian courts have generally upheld the rights of couples choosing diverse religious paths. However, across the border in Pakistan, the scenario is marred by a polarizing debate over the legitimacy of conversions.

Pakistan witnesses a parallel but distinct narrative. Here, activists and lawyers are increasingly raising their voices against the conversion of women hailing from minority communities. These women, often hailing from economically disadvantaged backgrounds, find themselves with limited agency in these life-altering decisions. The dilemma faced by courts in Pakistan is rooted in the absence of pertinent legal frameworks and the paradox of converted women claiming contentment when produced in court.

Civil society activists in both countries underscore the bewildering disarray caused by the relatively small number of interfaith unions and conversions. The stark numerical disparities further highlight the disproportionate social turmoil emanating from these cases. Pakistan's demographic composition portrays a mere three per cent representation of Hindus and Christians, while in India, Muslims account for 15 per cent of the populace. Astonishingly, despite their numerical insignificance, these conversions incite significant societal disrup-

The paradox is striking. India has seen the emergence of controversial "anti-love jihad" statutes and laws aimed at criminalizing the conversion of Hindu women to Islam and their subsequent marriages with Muslim men. Meanwhile, in Pakistan, the discourse predominantly revolves around the conversion of women from Hindu and Christian minorities. Astonishingly, instances involving Hindu men converting to marry Muslim women, or vice versa, remain virtually non-existent in both countries.

The legal frameworks governing these issues also diverge. In India, the Special Marriage Act offers a legal avenue for couples to retain their respective faiths while solemnizing their unions, safeguarding the bedrock of personal freedom and choice. On the contrary, Pakistan's legal landscape remains devoid of comparable legislation, rendering converted women with limited legal recourse.

M. Shoaib Ashraf, a human rights activist and advocate at the Pakistan Supreme Court, emphasizes that authentic religious conversion must emanate from sincere belief, untainted by ulterior motives.

A watershed moment in India came through the historic ruling delivered by Chief Justice of Indian Supreme Court Justice DY Chandrachud, unequivocally

affirming the indomitable prerogative of individuals to select life partners, irrespective of religious affiliations. This judgment underscored the impervious realm of personal privacy and the Constitution's unwavering defence of religious Similarly, the Lahore High Court in Pakistan acknowledged

Recent developments in India have ushered in the Prohibition of Unlawful Conversion of Religion Ordinance in Uttar Pradesh. This legislative initiative has culminated in numerous arrests, with a predominant number of cases involving Muslim individuals, who are

accused of luring and coercing

women into conversion. The most recent legislative addition making waves is the Uttarakhand Freedom of Religion (Amendment Act), 2022. This freshly minted legal framework, duly passed by the Uttarakhand assembly, introduces significant revisions to the preexisting Freedom of Religion Act of 2018. The crux of this amendment lies in its stance against coercive or deceptive conversion practices.

Under the new amendments, any individual found attempting to induce religious conversion through methods involving "misrepresentation, force, undue influence, coercion, allurement, or fraudulent means" could face a hefty penalty of Rs. 50,000. This legal stride is accompanied by the categorization of such actions as both cognizable and non-bailable offences. If proven guilty, the offender could be sentenced to a minimum of 3 years in prison, with a potential extension of

up to 10 years. Moreover, the amendment introduces the requirement for the convicted individual to provide compensation of Rs. 5 lakhs to the aggrieved party, adding a financial dimension to the conse-

Contrastingly, the Jharkhand Freedom of Religion Act, 2017, takes a distinct approach. It levies a milder penalty for converting adults from upper castes, encompassing a three-year imprisonment term or a fine of Rs. 50,000, or potentially both. Conversely, conversion involving individuals from Scheduled Castes (SC), Scheduled Tribes (ST), women, or minors is met with more stringent punishment, carrying a four-year prison sentence and a fine of Rs. 1 lakh, or

Similarly, the Uttar Pradesh Prohibition of Unlawful Conversion of Religious Ordinance, 2020, underscores a focus on heightened penalties. It places an emphasis on safeguarding lower castes, Adivasis, minors, and women from undue influence, enacting penalties of greater severity for those involved in their conversion.

The first anti-Conversion bill that was passed by the Odisha government in 1967, Cynthia Stephen in her EPW paper Anti-Conversion legislation in Karnataka notes when the state passed the bill, the Christian population of the state was around 2 lakhs, 1.1% of the population in comparison to 1.7 crores Hindus. Madhya Pradesh also followed the Odisha line and in 1968, passed its first Freedom of Religion bill. Notably, as per the 2011 census the Christian population in Madhya Pradesh stands at 0.29%.

In essence, these recent legislative moves reflect a commitment to curbing undesirable religious conversion practices, while simultaneously aiming to maintain a balance between religious freedom and the prevention of coercive or deceptive

Pakistan, grappling with the absence of a specialized legal framework against forced conversions, has compelled affected families to resort to existing laws about abduction, forced marriages, child marriages, and the rape of minors to seek justice. Activists underline the misleading nature of a victim's proclamation of voluntary conversion and stress the necessity of nuanced consideration in such intricate sit-

Jibran Nasir, an advocate, and lead campaigner, accentuates the intricate nature of consent in such cases, contending that apparent satisfaction may belie underlying coercion. Data emanating from the Center for Social Justice in Pakistan unveils the highest reported instances of alleged forced conversions in Punjab (52%) and Sindh (44%) between the years 2013 and

Regrettably, despite the clarion directives emanating from the Supreme Court of Pakistan, endeavours to enact comprehensive legislation against forced conversions have faltered repeatedly at both the provincial and national levels. Frustratingly, even in cases where legislative frameworks have been drafted, their passage has been hamstrung, despite unambiguous directives from the apex court.

In Pakistan, a provision allowing courts to provide victims with a respite in "darul aman" (places of safety) has been incorporated to facilitate contemplation in such circumstances. However, the overarching absence of well-rounded legal measures continues to loom large over addressing this intricate matter, intertwining the fundamental tenets of freedom, consent, and justice. As India and Pakistan grapple with these weighty issues, it remains imperative for societies to engage in a thoughtful and nuanced discourse to ensure the well-being and rights of all individuals, regard-

Standardisation of natural dyeing for textiles will pave the way for a sustainable tomorrow

Per since the world became a global village with the advent of the internet and new-age technology, businesses all over the world have seen allaround growth in the past few decades. However, with an increase in opportunity came the responsibility of selling and buying genuine products tested against welldefined standards across industries.

The textile industry is also no exception when it comes to manufacturing standardised products that are tested for their quality through a series of certification protocols. The testing and certification of the products are not only in the interest of the buyer but also help brands become synonymous

with authenticity and trust. Until a few years ago, it was difficult to decipher if a certain textile product was coloured using synthetic or Textile colourants (natur-

al and synthetic) have added value to the desires of consumers. In ancient times, the processing of dyeing was done using colours from natural sources until synthetic dyes were introduced into commercial practice and started being used widely by textile dyers. Almost all synthetic colourants are synthesised using petrochémical sources and pose a grave threat to the environment. Hence, the growing consciousness of preferring eco-friendly products has renewed the interest of con-

sumers and manufacturers in the use of eco-friendly natural dyes. Following the increase in demand and awareness, commercial dyers and textile export businesses have started re-looking at using natural dyes for dyeing a variety of textiles and enhancing the market for eco-friendly colourants.

Not only do natural dyes prevent environmental hazards, but they also produce soft shades that are skinfriendly compared to synthetic dyes, which are available at an economical price but often cause skin allergies. The extraction of colour components from the source in natural dyeing is an important step to optimise the colour yield. The impediments in creating trust in the global markets towards natural dyes have been a gradual process that has been through the journey of formulating certification protocols for natural dyes that are indigenous to India.

Any standardisation in our country cannot be called foolproof unless it has achieved the parameters set under the Bureau of Indian Standards, which is the apex body for setting up standard protocols for all consumer products. A special panel was also set up to prepare certification protocols for indigenous dye products by the Bureau of Indian Standards (BIS). The journey started as early as 2007-08 when we roped in IIT Kanpur to develop standards for testing natural dyes. This is the first project leader in the standardisa-

in the world under which a certification protocol has been developed for natural dye products.

My association with the Textile Specialty Chemicals and Dyestuffs Sectional Committee, TxD 07, BIS Committee of the Textiles Department for the last 7 years has resulted in achieving significant milestones as a nation. After extensive work, the committee has been successful in formulating three benchmarks on natural colours, which include Standards on Natural Indigo, Rubia Madar, Katha, Lac, Punica Granatum, Rheum Emody, Canna Indica, Gulmehandi, Teak, and Arjun Bark.

Ukraine to get F-16 jets from **Dutch & Danes**

The United States has given its approval for the Netherlands and Denmark to deliver F-16s to Ukraine, offi-cials in Washington and Europe said Friday, in a major gain for Kyiv even though the fighter jets won't have an impact any time soon on the almost 18-month war.

It was not immediately clear when the first F-16s might enter the conflict but Ukrainian pilots will first have to undertake at least six months' training on the aircraft, according to

Ukraine has long pleaded for the sophisticated fighter to give it a combat edge. It recently launched a long-anticipated counteroffensive against the Kremlin's forces without air cover, placing its troops at the mercy of Russian aviation and

In eastern Ukraine, attack helicopter pilots welcomed the news. They said Russia has a clear advantage in the skies, but the introduction of modern fighter jets could dramatically shift the balance of power Kyiv's way. Ukrainian forces supporting infantry are using decades-old Soviet-era models, which are vulnerable to air-toair missile attacks from Russian fighter jets, Capt Yevgen Rakita, a spokesman for the 18th Army Aviation Brigade, told The Associated Press.

"A modern war cannot be won without aviation (capabilities)," Rakita said.

In making the decision on F-16 deliveries, Washington aims to ensure warplanes can be provided to Ukraine as soon as its pilots complete their training, according to a Biden administration official who was not authorised to comment and spoke to The Associated Press on condition of anonymity.

The official said US Secretary of State Anthony Blinken sent a letter to his Dutch and Danish counterparts earlier this week, offering formal assurance that the US would fast-track approval of all requests from third parties to transfer F-16s to Ukraine.

Danish Defence Minister Jakob Ellemann-Jensen said Friday the training of Ukrainian pilots is starting this month.

A coalition of 11 Western countries - the Netherlands, Belgium, Canada, Denmark, Luxembourg, Norway, Poland, Portugal, Romania, Sweden and the United Kingdom pledged in July to train Ukrainian pilots to fly F-16s.

Officials have previously said that Ukrainian pilots will need six to eight months of

Xi to attend BRICS summit, China confirms | Tharman

AP ■ BEIJING

Chinese President Xi Jinping will attend next week's in Johannesburg, to be followed by a state visit to South Africa, the Foreign Ministry said Friday.

Foreign Ministry spokesperson Hua Chunying also said in a statement that during his August 21-24 visit to South Africa, Xi will co-chair the China-Africa Leaders' Dialogue with his South African counterpart, Cyril Ramaphosa.

China is a core member of the BRICS nations, which also include Brazil, Russia and India.

The grouping was predicated on linking the interests of the world's leading emerging economies but has sought to expand into other civil and governmental fields.

Vladimir Putin has decided

not to attend the summit because of an arrest warrant issued by the International Criminal Court for him, according to South African authorities. The development could

be viewed as embarrassing for Putin, who is expected to be the only leader of a country in the bloc not to attend.

Kremlin spokesperson President Dmitry Peskov said Putin

"has decided to take part" in the summit via video link, without confirming if he had intended to attend in person.

The BRICS summit is the first to be held in person since 2019 and comes as the bloc seeks new relevance amidst Russia's war in Ukraine, South Africa's crashing economy and sharpening competition between Asian giants China and

Luiz Inácio Lula da Silva has said that he supports more countries joining the group and intends to raise the topic at the summit.

Around 20 countries have formally applied to join, Brazilian Foreign Affairs Minister Mauro Vieira said following the comments by Lula, who since taking office has repeatedly bucked the existing Western-dominated international structure.

Among the hopefuls are Argentina, United Arab Emirates, Saudi Arabia, Indonesia, Iran and Venezuela, Vieira said.

Facing isolation by the US and European Union, China and Russia have sought to expand their economic influence in developing countries.

Beijing has done so partly through the Chinesebacked New Development India. Brazilian President Bank, commonly known as

the BRICS bank, which is funding infrastructure projects in Brazil and elsewhere the developing worldAsked at a daily briefing about China's expectations for the summit, Foreign Ministry spokesperson Wang Wenbin said BRICS had been "taking on increasing inter-national influence," but did not mention the issue of expansion.

He said China looks forward to working with South Africa to "jointly pursue development and revitalisation and make a positive contribution to a multipolar world and greater democracy in international relations."

"All sides will have an indepth exchange of views on prominent global challenges enhance coordination and cooperation in international affairs, and inject stability and positive energy into today's world," Wang said.

The two Chinese origin who have qualified as candidates for the presidential election are Chief Investment Officer Ng Kok Song and former NTUC Income Chief Executive Tan Kin Lian. The department noted that Tharman submitted his bid under the public sector service track while Ng applied under the public sector deliberative

track, and Tan under the private sector deliberative track.
Tharman who launched his bid for the presidency on July 26 met the public sector service requirements, having held office as a minister for at least three years. Tharman, 66, resigned from public and political posts last month to run for the presidency.

Tharman was an economist and civil servant, mainly at the Monetary Authority of Singapore, before joining politics in 2001.He served as Minister for Education and Finance and was Deputy Prime Minister from 2011 to

Ukraine and Romania to boost Kyiv's grain exports

Ukraine and neighbouring Romania signed an agreement Friday to work together to boost Kyiv's export of grain through Romania after Moscow broke off a key wartime shipping agreement that allowed safe passage through the Black Sea. The accord was signed during a trip by Ukrainian Prime Minister Denys Shmyhal to the Romanian capital, Bucharest, for talks with his Romanian counterpart Marcel

The two leaders discussed ways to ramp up the war-torn nation's key grain exports, and improve infrastructure for transportation across river, rail, road, sea, including at border crossings. Ukraine's economy is heavily dependent on farming, and its grain is crucial for world supplies of wheat, barley, and sunflower oil.

Ciolacu told a news conference after the meeting that he hopes Romania can transport more than 60% of Ukraine's grain exports.

He also noted the "ambitious" target to double the transport of Ukrainian grain through Romania that was set last week during a meeting that included Western and Ukrainian officials in Romania's Danube River town of Galati. Romania intends to double the amount from 2 million to 4 million tons per month,

but Ciolacu did not specify a timeframe for the increase.

"I emphasized the importance of collaboration between our countries as well as with our international partners," The Romanian leader added that

Momika, a refugee from Iraq, has desecrated the Quran in a series of anti-Islam protests that have caused anger in many Muslim countries. Swedish police have allowed his demonstrations, citing freedom of speech while filing preliminary hate speech charges against him.

Prosecutors are investigating whether his actions are permissible

under Sweden's hate speech law, which prohibits incitement of hatred against groups or individuals based on race, religion or sexual orientation. Momika says his protests target the religion of Islam, not Muslim

The Quran-burnings have sparked angry protests in Muslim countries, attacks on Swedish diplomatic missions and threats from Islamic extremists.

t least 20 churches and 86 Ahouses of Christians were burnt down by the mob in Pakistan's Punjab province and a total of 145 suspects have been taken into custody, police said in a preliminary report submitted to the government on Friday on the unprecedented attack on the minority community. The report also hinted at the presence of radical Islamist Tehreek-i-Labbaik Pakistan (TLP) elements that spearheaded the mob that unleashed the attack in Jaranwala tehsil of Faisalabad district, some 130 km from Lahore on Wednesday. The mob was enraged over reports that two Christians had desecrated the Quran.

"At least 20 churches and 86 houses of Christians were burnt down by the mob in Jaranwala. Two Christians who were accused of desecrating the Quran have also been arrested. Besides, a cleric who made announcements from five

mosques inciting people to attack Christian homes and churches is among 145 suspects arrested so far," says the Punjab Police report submitted to the

Earlier in the day, the police produced 127 suspects before an anti-terrorism court in Faisalabad and obtained their two-day physical remand. Pakistani police have also arrested two prime suspects involved in the attacks, Punjab caretaker Chief Minister Mohsin Naqvi said. "Major breakthrough in

the Jaranwala Incident - both main accused now in CTD Custody. Appreciation for Chief Secretary Punjab and IG Punjab for their relentless efforts...," Naqvi posted on social media platform X, formula language of the social media lan merly known as Twitter.

Meanwhile, the Christian families started returning to their houses only to find their dwellings in ruin. They blamed the government for failing to provide security to their lives and properties in the face of



radical Islamists' onslaught. All educational institutions, markets and business establishments remained closed in Jaranwala on the second day

The caretaker chief minister said the violent attacks on churches and homes of the Christians were a planned conspiracy to sabotage peace in the country. Iran's FM visits Saudi Arabia's crown prince trying to finalize a deal with

Dubai(AP): Iran's foreign minister met Friday with Saudi Arabia's Crown Prince Mohammed bin Salman as part of his visit to the kingdom, a sign of how the two countries are trying to ease tensions after years of turmoil. Images of Iran's top diplomat, Hossein Amirabdollahian, sitting with Prince Mohammed would have been unthinkable only months earlier, as the longtime rivals have been engaged in what officials in both Tehran and Riyadh have viewed as a proxy conflict across the wider Middle

The prince even went as far as to compare Iranian Supreme Leader Ayatollah Ali Khamenei to Adolf Hitler at one point in 2017. But since reaching a Chinese-mediated détente in March, Iran and Saudi Arabia have moved toward reopening diplomatic missions in each other's countries.

India using all platforms to flag non-tariff barriers: Govt

India is using all multilateral and bilateral platforms including G20 to flag concerns with regard to non-tariff barriers (NTBs) which are impacting the free flow of trade, a top government official said on Friday

India has already raised its concerns on issues like the European Union's (EU) carbon tax on different platforms, including the World Trade Organisation (WTO).

Such measures by G20 member countries are likely to figure in the trade ministers' meeting of the grouping next week in Jaipur.

"Definitely, we are discussing those NTBs and we are also discussing how to find a good solution, how to find a platform where we can coordinate on these issues and we can understand these issues. Commerce Secretary Sunil Barthwal told reporters here.

The two-day Trade and Investment Ministerial Meeting (TIMM) is scheduled on August 24 and 25 in Jaipur

The secretary also said that on the sidelines of TIMM, several high-level bilateral meetings will be held with countries such as the UK, Canada and the EU to discuss progress with regard to proposed free trade agree-Negotiations on such agree-

ments are underway with all these countries.

The five priority areas which



will be discussed in the meeting are trade for growth and prosperity; trade and resilient global supply chain; integrating MSMEs in global trade; logistics for trade; and WTO reforms.

Strengthening mutual cooperation in the G20 to increase transparency in the use of nontariff measures will be discussed in the meeting.

Barthwal said that "all platforms will be used" to discuss these barriers.

Citing an example of the EU Carbon Border Adjustment Mechanism (CBAM), which is going to impact exports of certain sections of Indian industry, he said there will be compliance with this mechanism and there are certain regulatory require-

Sensex below 65K; IT, metal weigh on weak global trend

E quity benchmark index Sensex buckled under selling pressure for the second straight session to close below the 65k mark on Friday, as investors offloaded IT, teck and metal stocks amid a bearish global trend. Besides, fresh foreign fund outflows also hit investor sentiments, traders said.

In a volatile trade, the 30-share BSE Sensex declined 202.36 points or 0.31 per cent to settle at 64,948.66. During the day, it fell by 396.3 points or 0.60 per cent to 64,754.72.

The NSE Nifty dipped 55.10 points or 0.28 per cent to end at 19,310.15.

On a weekly basis, the BSE gauge fell 373.99 points or 0.57 per cent, and the Nifty declined 118.15 points or 0.60 per cent.

'It turned out to be a roller coaster ride on Friday as Nifty oscillated on both sides and ended lower. Meanwhile, majority of sectors felt the heat, wherein IT and realty were among the top losers. The broader indices too traded in sync and lost nearly half a per cent each.

"Fresh weakness in the US markets is largely weighing on the sentiment, however, the pace of decline is still capped," said Ajit Mishra, SVP Technical Research, Religare Broking Ltd.



In addition, the financial sector continues to strengthen alleviating much of the economic and contingent liability risks that had previously driven downward rating pressure, Moody's said.

Engine Lease Finance to inspect its jet engines with Go First

The National Company Law Appellate Tribunal (NCLAT) on Friday allowed Engine Lease Finance BV to inspect their four engines leased to crisis-hit carrier Go First.

A two-member bench of the appellate tribunal granted relief to Engine Lease Finance (ELF) after modifying the earlier order of the National Company Law Tribunal (NCLT) on July 26.

NCLAT has directed the resolution professional of Go First, which is going through the corporate insolvency resolution process (CIRP), to allow the world's leading independent engine financing and leasing company to inspect the engines within 10 days of the order.

"We are of the view that inspection be permitted within 10 days from today," said an NCLAT bench comprising Chairperson Justice Ashok Bhushan and Barun Mitra.

Give fixed rate option on EMI-based loans while resetting interest rates: RBI to banks

PTI MUMBAI

The RBI on Friday directed banks to allow individual borrowers paying loans through EMIs to opt for fixed interest rate system or extension of loan tenor, a move aimed at preventing loanees from falling into the trap of negative amortisation, in wake of rising interest rate.

The interest rates have

moved northward since May 2022 after the central bank started raising the benchmark lending rate (repo) in a bid to check inflation following the outbreak of the Russia-Ukraine war. As a result of 250 basis points increase in the repo rate, a large number of borrowers faced negative amortisation, wherein the Equated Monthly Instalment (EMI) works out to be less than the interest obligation, resulting in persistent increase of the principal amount. RBI said that at the time of

sanction of EMI-based floating rate personal loans, banks and

NBFCs should take into account the repayment capacity of borrowers to ensure that adequate headroom is available for elongation of tenor and/ or increase in EMI, if interest rate rises.

Home, auto and other personal loans are linked to external benchmark rates, like repo

RBI said several consumer grievances have been received in relation to elongation of loan tenor or increase in EMI amount with regard to EMI-based floating rate personal loans, without proper communication or con-

sent of the borrowers. "At the time of reset of interest rates, REs shall provide the option to the borrowers to switch over to a fixed rate as per their Board-approved policy. The policy...May also specify the number of times a borrower will be allowed to switch during the tenor of the loan," RBI said in a circular to banks and NBFCs, including housing finance com-

It further said at the time of sanction, regulated entities (REs) should clearly communicate to the borrowers about the possible impact of change in benchmark interest rate on the loan leading to changes in EMI

"Subsequently, any increase in the EMI/ tenor or both on account of the above shall be communicated to the borrower immediately through appropriate channels," RBI said

and/or tenor or both.

Banks and NBFCs have been asked to ensure compliance of the instructions for the existing as well as new loans by December 31, 2023.

Also, the borrowers should be given a choice to opt for enhancement in EMI or elongation of tenor or for a combination of both options; and to prepay, either in part or in full, at any point during the tenor of the loan. Levy of foreclosure charges/ pre-payment penalty should be subject to extant instructions.



□ormer Formula One dri-**▲** ver Felipe Massa has accused auto racing's governing body of conspiring to prevent him from winning the 2008 title, and the Brazilian claims he is the "rightful" champion.

Massa, who was the runner-up to Lewis Hamilton in the 2008 season, made his claim in a letter sent to the FIA in the first step of a legal battle to take place in Britain.

A member of Massa's management team told The Associated Press on Thursday that the letter was also sent to Formula One Management, alleging the two bodies failed to act after learning that same year that Renault's Nelson Piquet Jr. Had deliberately crashed at the Singapore Grand Prix to then-teammate Fernando Alonso win the

The crash caused a safety car to come in with Massa in the lead and squandered his advantage. A calamitous pit stop at the Ferrari boxes soon after

cost the Brazilian the race, where he finished 13th.

McLaren's Hamilton finished third in Singapore. The British driver went on to lift the first of his seven titles that year with a dramatic fifth-place finish at the Brazilian Grand Prix, which was won by Massa. The difference between the two

drivers was one point.

"Simply put, Mr. Massa is the rightful 2008 champion, and F1 and the FIA deliberately ignored the misconduct that stripped him of

that title," the letter states. Massa's letter was triggered by an interview of for-mer F1 boss Bernie Ecclestone, who said in March that he was aware of Piquet's deliberate crash in that same year but chose not to investigate it until Hamilton received the season's title at an FIA ceremo-

"I see Tilak Varma as an option, being a left-hander," Ganguly said, highlighting Varma's adaptability and fearless

approach to the game. The 20-year-old left-hander made an impressive 22-ball 39 on his T20I debut against the

West Indies, followed by scores of 51 and 49 not out in his next two outings Ganguly further mentioned

that the left-handed trio of Yashasvi Jaiswal (back-up opener), Ishan Kishan (wicketkeep er-batter), and Varma can play fearless cricket and they should be picked when selectors announce India's World Cup squad before the September 5

"He (Tilak) is a very good young player, not with much experience, but it does not mat-

ter. I also want to see the young left-hander (Jaiswal) in the side at the top of the order. He has enormous ability and he's fearless. So, this is a great side," said

Ganguly said the Indian team should be a mix of experienced players and fresh faces.

"It has to be a team of experience and people who don't have any scars — like Jaiswal, Varma, Ishan Kishan. They can go and play fearless cricket. Rahul (Dravid), Rohit and the selectors have plenty of choices;

they just have to identify and pick the best XI," he said.

Pace spearhead Jasprit Bumrah made a return to national side after a long injury lay-off and Ganguly termed it as a welcome development.

Bumrah is currently leading India against Ireland in a threematch T20I series at Dublin.

"I've spoken to some players at the NCA, and they said he's at his best...Bumrah was bowling at almost 90 miles per hour the other day. That's great news for Indian cricket," he added.

Ganguly said India has a very good bowling unit going into the marquee tournament.

"With Bumrah, (Mohammed) Shami, (Mohammed) Siraj, they have a fantastic attack to go with (Ravindra) Jadeja, Axar (Patel), Kuldeep (Yadav); they have enormous talent. How can that team be unsettled?" he stated. "It's just that they played new players in the West Indies and you will see that by the time the World Cup comes, and when they pick the team, it will be a top side. It's about how you

play during that tournament," said Ganguly.

INDIA AMONG GANGULY'S TOP FIVE

Ganguly said India will be a favorite in the World Cup as he picked the hosts alongside Australia, England, Pakistan and New Zealand in his top five.

"I presume Australia will be one; England, Pakistan, don't rule New Zealand out; and then there's South Africa...

"But if you ask my best five at the moment, it's Australia,

England, India, Pakistan and New Zealand," he said. With Rishabh Pant still recovering from an accident, Ganguly said Kishan could be the choice for

wicketkeeper batsman. "Pant is the best wicketkeep-

er in the country, but you can see Ishan Kishan, KL Rahul (depending on his fitness); these two will be right up in Rohit's and Rahul's minds. "I like Ishan Kishan because he just opens up the game for any team. I am sure Dravid will keep him in his plans," he signed off.
