Emphasising the need for robust actions to curb child marriages, Chief Secretary Reddy called for a comprehensive effort to raise awareness among citizens, particularly parents. He said that families facilitating child marriages would not benefit from any government assistance.

The Chief Secretary convened a meeting at the Secretariat on Friday to review an inter-departmental strategy in collaboration with officials from various departments to combat child marriage.

The Chief Secretary underscored the stringent enforcement of the AP Prohibition of Child Marriages Rules-2012 and 2023 as an important step in controlling child marriages in the State.

To ensure effective implementaand child welfare, SERP, education, and medical health have been directed to work in unison. In



adherence to the new regulations, Child Marriage Prohibition Officers (CMPOs) will be designated at different levels, vested with specific duties and authority to prevent child marriages within their jurisdiction.

Chief Secretary Reddy said that any failure to prevent child marriages would result in consequences for these officers.

At the grass roots level, child marriage control monitoring committees are to be established in villages tion, departments such as women and wards, chaired by the Sarpanch or Ward Councillor.

AI-model could tell age from chest X-ray

A newly developed artificial intelligence (AI) model could estimate one's age from their chest X-ray, new research published in The Lancet Healthy Longevity journal

The model can also signal chronic diseases such as hypertension and chronic obstructive pulmonary disease from the difference between estimated and chronological age, the research from Osaka Metropolitan University, Japan, said.

The findings marked a leap in medical imaging and paved the way for improved early disease detection and intervention, the researchers said in their study.

As the global population ages, aging and longevity research is gaining importance.

Aging, a complex change associated with several diseases, has varied effects across individuals, they said. "Chronological age is one of the most critical factors in medicine. Our results suggest that chest radiography-based apparent age may accurately reflect health conditions beyond chronological age, said lead researcher Yasuhito Mitsuyama.

For age estimation, the AI model was trained using around 67,100 chest radiographs of 36,051 healthy individuals who underwent health check-ups between 2008 and 2021.

The model showed a strong correlation between the AI-estimated age and the chronological age of the individuals, the researchers found

"Thanks for the ride, mate! said the Lander Module (LM). LM is successfully separated from the Propulsion Module (PM). LM is set to descend to a slightly lower orbit upon a deboosting planned for tomorrow around 1600 Hrs IST," the Indian Space Research Organisation(ISRO) said in a post on X (formerly Twitter). The estimated

Rs 600 crore Chandrayaan-3 mission was launched on July 14, a far more complicated 41-day voyage to reach the lunar south pole.

After Thursday's separation, the lander is expected to undergo a "deboost" (the process of slowing down) to place it in an orbit, where the Perilune (the orbit's closest point to the Moon) is 30 km and Apolune (farthest point from the Moon) is 100 km, from where the soft landing on the south polar region of the Moon will be attempted, an ISRO official said. The Propulsion Module will continue its journey in the current orbit for months/years, the ISRO

"Now really the match starts. These are the final overs we are talking about," Chandrayaan-

I Project Director M Annadurai told Chandrayaan-3 is a follow-on mission to Chandrayaan-2 and its objectives are to demonstrate safe and soft landing on the lunar surface, roving on the moon, and to conduct in-situ scientific experiments.

Chandrayaan-2 had failed in its lunar phase when its lander 'Vikram' crashed into the surface of the moon following anomalies in the braking system in the lander while attempting soft landing on September 7, 2019. Chandrayaan's maiden mission was in 2008.

The lander has the capability to soft land at a specified lunar site and deploy the rover that will carry out in-situ chemical analysis of the moon's surface during the course of its mobil-The lander and the rover have scientific pay-

loads to carry out experiments on the lunar sur-

If the Chandrayaan-3 mission succeeds in landing a robotic lunar rover in ISRO's second attempt in four years, India will become the fourth country to master the technology of softlanding on the moon's surface after the US, China and the former Soviet Union.

AP, TS have maximum no. of billionaire MPs

Andhra Pradesh and Telangana are the top two States with the highest percentage of billionaire MPs. Around five (45%) of the 11 MPs from Andhra Pradesh and three (43%) of the seven MPs from Telangana have declared assets worth around Rs 100 crore.

The total assets of the seven MPs analysed from Telangana is Rs 5,596 crore, followed by 11 MPs from Andhra Pradesh with Rs 3,823 crore. 30 MPs analysed from Uttar Pradesh have assets worth Rs 1,941

The total assets of the 85 BJP MPs analysed is Rs 2,579 crore, and that of the 30 INC MPs analysed is Rs 1,549 crore. The nine YSRCP MPs

analysed have Rs 3,561 crore, and seven TRS MPs analysed have Rs 5,596 crore. The 10 AAP MPs have assets worth Rs 1,316 crore.

The top three Rajya Sabha MPs with high assets is Dr Bandi Partha Saradhi with Rs 5,300 crore, followed by Alla Ayodhya Rami Reddy with Rs 2,577 crore and Jaya Amitabh Bachchan with Rs 1,001 crore.

The Association for Democratic Reforms (ADR) and the National Election Watch (NEW) analysed the criminal, financial and other background details of 225 of 233 Rajya Sabha MPs.

In the current Rajya Sabha one seat is vacant. Three MPs have not been analysed as their affidavits were unavailable and four seats of Jammu and Kashmir are undefined.

Rain forecast in Coastal AP





he said, "We have written to the authority yesterday requesting it to review its decision to release 10,000 cusecs of water per day for 15 days to Tamil Nadu, because there is less rains, there is scarcity of water even for drinking, leave aside agricul-

"Tamil Nadu has utilised water for crops, the water we release from here is taking five to six days to reach there, but still they have used," he said.

Tamil Nadu on Monday approached the Supreme

Court with a plea to direct Karnataka to release 24,000 cusecs of Cauvery water daily for standing crops.

Following this, Shivakumar had on Tuesday had said Karnataka would release 10 tmc ft of Cauvery river water to Tamil Nadu, while maintaining that the state doesn't have sufficient water in dams to meet its requirements like drinking water and agriculture, due to deficit monsoon.

He then joined Regional Eastern Bureau senior Naxalite cadre Navin Yadav and was involved in several Naxalite incidents for three years, including the firing on three CRPF jawans in 2020 and planting improvised explosive devices (IEDs) to target security forces.

In 2021, Yadav left the Naxal outfit and went underground. The official said he was found to be living with his family in a rented house in Bhagalpur village of Jashpur district.

He was produced in a court which sent him to jail, the official added.

MP: Two killed, six injured as man opens fire after argument over pet dogs

A man and his brother-in-law were killed and six others, including a pregnant woman, were injured when a person who works as a bank security guard opened fire on them from his double-barrel gun after an altercation over pet dogs in Indore city of Madhya Pradesh, police said on Friday.

The incident occurred late Thursday night, after which the accused security guard, his son and nephew were arrested, a police official said.

"Rajpal Singh Rajawat posted as a security guard at a local branch of Bank of Baroda, opened fire with his licensed gun in a colony located under Khajrana police station limits following an argument over pet dogs," Additional Deputy Commissioner of Police Amrendra Singh said.

Rahul Verma (28) and his brother-in-law Vimal Amcha (35) were killed in the firing, while six others who were injured in the incident are undergoing treatment at a hospital, he said.

"The incident occurred after Rajawat took his pet dog out for a walk in Krishnabagh Colony. His dog started barking at

the neighbour's pet dog. This

triggered an argument between Rajawat and Amcha's family members," Singh said.

Their argument escalated to such a level that Rajawat went to his house, took out his gun and fired two rounds in the air from the terrace. After that, he opened fire on the people standing on the road below, the official said.



Man-made tragedy

Unbridled construction on riverbeds is behind the catastrophic floods in Himachal Pradesh

mid the ongoing monsoon season, Himachal Pradesh, Punjab and Haryana are grappling with a dire catastrophe that has cost these states a fortune. The relentless downpour has transformed serene rivers into roaring torrents, causing widespread devastation and loss of life and property. This situation, however, is not solely the result of nature's fury; it is the consequence of unchecked human actions that have disrupted the delicate balance between progress and environmental responsibility. The disturbing trend of constructing hotels and resorts on riverbeds, oblivious to the potential consequences, has emerged as a prominent contributor to the ongoing tragedy. The allure of scenic waterfront properties has driven a reckless pursuit of profit, often overshadowing prudent considerations for the environment and local communities. As these structures sprawl across the riverbanks, they impair the natural flow of water, causing disastrous consequences during heavy rainfall. The repercussions of this short-sight-



ed development approach are now on full display. Thousands of residents have been forced to abandon their homes, a direct result of the man-made encroachments that obstructed the rivers' natural paths. The scale of destruction is staggering, with homes reduced to rubble and livelihoods swept away. Moreover, the human toll extends beyond material losses, with health issues exacerbating the already dire situation. More than 100 lives have been lost in Himachal alone, while thousands of crores have been washed away. Incessant rain has triggered flash floods, landslides and other calamities, compounding the crisis. Haryana and Punjab have suffered estimated losses of hundreds of crores, while Himachal Pradesh's losses are estimated at a staggering Rs 8000 crores. Unwarranted and indecorous linkages

Politicians should leave the armed forces alone and not use them to score brownie points, else politicisation of forces is not far away

national convener of the IT cell of a national party makes a wholly partisan accusation at members of his rival party, he is entitled to be suggestive, provocative, and in the lamentable context of our politics, even 'economizing' with the truth. But the creativity can get unwarranted and indecorous when it is tantamount to questioning the sacred and inviolable tenets of constitutional governance e.g., the principle of civilian control over military affairs.

The Armed Forces of India have coercive and kinetic abilities that allow them to undertake violence on behalf of the Sovereign (externally or internally), as ordered by the legitimate government of the day. A professional soldier is expected to respect and abide by the constitutional wiring of 'civil-military relations' in a non-partisan and non-prejudiced manner (all pros and ons of undertaking or refraining from an order are left to the competent authorities who are expected to nuance the civilian thinking, optimally) – but the soldiers on the ground simply take 'orders' and failing to do so, is a dereliction of duty. This discipline is critical to maintaining the apolitical nature of the 'sword arm of the nation' and for it to serve the sovereign, regardless of the party in

But the incorrigibly partisan politicians can sometimes disregard this nonpartisan ideal and either try to usurp and appropriate the 'muscular' imagery of Indian Soldiers towards their utility or like recently, drag the combatants (whilst in service) into ascribing 'intent' onto their actions, while in 'Uniform'. It is dangerous and unacceptable, either way. Beyond the operational imperatives, the Armed Forces do not act on their own volition but do so, at the behest nations and forces inimical to constitutional India would suggest that the operational action of soldier is owing to his/her

India's history post-independence has been complex and



painful with many insurgent movements necessitating the invocation of Armed Forces onto its citizenry (as policing forces routinely fail). It is neither a desirable nor strictly speaking, the mandated task of the Armed Forces, to take up internal sorting, but as the sovereign's 'last resort', they do so. It is especially concerning as most of the hardy soldiers hail from the rural/hinterlands of the sensitive border states e.g., Punjab, Himachal Pradesh, Uttrakhand, Jammu & Rajasthan, Kashmir, Northeastern States etc. But because the profession of arms was typically afforded the respectful 'distance' from political passions and suggestions, these soldiers were able to tide over dark periods of insurgency in Punjab, J&K, Northeast etc., professionally without getting ascribed any personal 'intent', in the conduct of their combat duties.

Recently, one such painful incident from the past i.e., air raids in Mizoram, was regrettably invoked in a completely political moment (no-confidence motion) to score political points - the issue was further escalated by the overenthusiasm of a party convener when he attacked a rival's father (Air Force officer) of "flying the Indian Air Force planes that bombed Aizwal"! Not only was this statement a

lie as rebutted by the politician/son of the late Air Force Officer, "You have the wrong dates, wrong facts...Yes, as an IAF pilot did drop bombs. But that was on the erstwhile East Pakistan during the 1971 Indo-Pak war and not as you claim, on Mizoram on the 5th March 1966"....who added for good measure, "He was commissioned into the IAF only on 29th October 1966!". A far more consequential concern of dragging the apolitical institution and that of its fraternity in 'Uniform' towards political decisions, was recklessly sug-

All political parties have someone or the other in terms of Veterans in their ranks which is usually a matter of pride and necessity to have a cross-section of perspective, especially from the security realm. But to link their prior participation in any militaristic act with the implicit 'intent' besetting their act then is fraught with frightening consequences for the apolitical institution. Whereas, to question the dispensation of the day then (in this case, the rival pposition party today), may be par for the course, as could be said of other latter-day actions e.g., 1984 Operation Blue Star etc., – but questioning the individual 'intent' of Soldiers who merely undertook orders then, is unwarrant-

ed and indecorous (that it was also an abjectly false statement, is far less in terms of impropriety). It sadly demonstrates, that matters about the hallowed 'Uniform' are not free from political taint or absorp-

Ironically, some of the most illustrious Veterans in the political domain did repose faith in the party flag of the said convener, after hanging their boots, and rightfully their conduct or participation in any earlier combat operation, insurgency, or war remained beyond the remit of their personal 'intent', as it should be. The increasing trend to blur the hard lines of necessary 'distance' between the Armed Forces and Politics, is a sad reality, and Robert Frost's insistence that 'good fences make good neighbours' applies to the sensitive civilian-military relations, too. Just across the Lineof-Control (LOC), their Armed Forces do indeed have an independent 'intent' akin to a 'State-within-a-State' (unlike India), and they are infinitely poorer as a nation, for that. If speaking the truth in politics spare the 'Uniform' from discourse and linkages

Religion is a matter of choice, not force



Forced conversions spark concerns in India and Pakistan. The well-being and rights of all individuals, regardless of their faith, must be ensured

orced conversions of women have emerged as a pressing issue in both India and Pakistan, casting a shadow over the principles of individual freedom, religious choice, and societal harmony. As the spotlight intensifies on these disconcerting practices, civil society activists, legal experts, and concerned citizens are grappling with the complexities surrounding this contentious matter.

In India, the focal point of concern revolves around the conversion of women from the majority community, stirring restiveness among various segments of the population. Activists, while recognizing the sacrosanct right of individuals to alter their faith, invoke the provisions of the Special Marriage Act, which legally sanctions interfaith unions. Indian courts have generally upheld the rights of couples choosing diverse religious paths. However, across the border in Pakistan, the scenario is marred by a polarizing debate over the legitimacy of conversions.

Pakistan witnesses a parallel but distinct narrative. Here, activists and lawyers are increasingly raising their voices against the conversion of women hailing from minority communities. These women, often hailing from economically disadvantaged backgrounds, find themselves with limited agency in these life-altering decisions. The dilemma faced by courts in Pakistan is rooted in the absence of pertinent legal frameworks and the paradox of converted women claiming contentment when produced in court.


Civil society activists in both countries underscore the bewildering disarray caused by the relatively small number of interfaith unions and conversions. The stark numerical disparities further highlight the disproportionate social turmoil emanating from these cases. Pakistan's demographic composition portrays a mere three per cent representation of Hindus and Christians, while in India, Muslims account for 15 per cent of the populace. Astonishingly, despite their numerical insignificance, these conversions incite significant societal disrup-

The paradox is striking. India has seen the emergence of controversial "anti-love jihad" statutes and laws aimed at criminalzing the conversion of Hindu women to Islam and their subsequent marriages with Muslim men. Meanwhile, in Pakistan, the discourse predominantly revolves around the conversion of women from Hindu and Christian minorities. Astonishingly, instances involving Hindu men converting to marry Muslim women, or vice versa, remain virtually non-existent in both countries.

The legal frameworks governing these issues also diverge. In India, the Special Marriage Act offers a legal avenue for couples to retain their respective faiths while solemnizing their unions, safeguarding the bedrock of personal freedom and choice. On the contrary, Pakistan's legal landscape remains devoid of comparable legislation, rendering converted women with limited legal recourse.

M. Shoaib Ashraf, a human rights activist and advocate at the Pakistan Supreme Court, emphasizes that authentic religious conversion must emanate from

sincere belief, untainted by ulterior motives. A watershed moment in India came through the historic ruling delivered by Chief Justice of Indian Supreme Court Justice DY Chandrachud, unequivocally



Similarly, the Lahore High Court in Pakistan acknowledged religion as a deeply personal conviction, refraining from overstepping into these matters. Despite this, both countries have, unfortunately, witnessed

instances of subterfuge and deceit in the context of forced conversions, often culminating in tragic conse-Recent developments in India have ushered in the Prohibition of Unlawful Conversion of Religion

Ordinance in Uttar Pradesh. This legislative initiative has culminated in numerous arrests, with a predominant number of cases involving Muslim individuals, who are accused of luring and coercing women into conversion. The most recent legislative addition making waves is the Uttarakhand Freedom of Religion

(Amendment Act), 2022. This freshly minted legal framework, duly passed by the Uttarakhand assembly, introduces significant revisions to the preexisting Freedom of Religion Act of 2018. The crux of this amendment lies in its stance against coercive or deceptive conversion practices.

Under the new amendments, any individual found attempting to induce religious conversion through methods involving "misrepresentation, force, undue influence, coercion, allurement, or fraudulent means" could face a hefty penalty of Rs. 50,000. This legal stride is accompanied by the categorization of such actions as both cognizable and non-bailable offences. If proven guilty, the offender could be sentenced to a minimum of 3 years in prison, with a potential extension of up to 10 years. Moreover, the amendment introduces the requirement for the convicted individual to provide compensation of Rs. 5 lakhs to the aggrieved party, adding a financial dimension to the consequences.

Contrastingly, the Jharkhand Freedom of Religion Act, 2017, takes a distinct approach. It levies a milder penalty for converting adults from upper castes, encompassing a three-year imprisonment term or a fine of Rs. 50,000, or potentially both. Conversely, conversion involving individuals from Scheduled Castes (SC), Scheduled Tribes (ST), women, or minors is met with more stringent punishment, carrying a four-year prison sentence and a fine of Rs. 1 lakh, or

Similarly, the Uttar Pradesh Prohibition of Unlawful Conversion of Religious Ordinance, 2020, underscores a focus on heightened nenalties. It places an emi safeguarding lower castes, Adivasis, minors, and women from undue influence, enacting penalties of greater severity for those involved in their conversion.

The first anti-Conversion bill that was passed by the Odisha government in 1967, Cynthia Stephen in her EPW paper Anti-Conversion legislation in Karnataka notes when the state passed the bill, the Christian population of the state was around 2 lakhs, 1.1% of the population in comparison to 1.7 crores Hindus. Madhya Pradesh also followed the Odisha line and in 1968, passed its first Freedom of Religion bill. Notably, as per the 2011 census the Christian population in Madhya Pradesh stands at 0.29%.

In essence, these recent legislative moves reflect a commitment to curbing undesirable religious conversion practices, while simultaneously aiming to maintain a balance between religious freedom and the prevention of coercive or deceptive

Pakistan, grappling with the absence of a specialized legal framework against forced conversions, has compelled affected families to resort to existing laws about abduction, forced marriages, child marriages, and the rape of minors to seek justice. Activists underline the misleading nature of a victim's proclamation of voluntary conversion and stress the necessity of nuanced consideration in such intricate situations.

Jibran Nasir, an advocate, and lead campaigner, accentuates the intricate nature of consent in such cases, contending that apparent satisfaction may belie underlying coercion. Data emanating from the Center for Social Justice in Pakistan unveils the highest reported instances of alleged forced conversions in Punjab (52%) and Sindh (44%) between the years 2013 and

Regrettably, despite the clarion rectives emanating from the Supreme Court of Pakistan, endeavours to enact comprehensive legislation against forced conversions have faltered repeatedly at both the provincial and national levels. Frustratingly, even in cases where legislative frameworks have been drafted, their passage has been hamstrung, despite unambiguous directives from the apex court.

In Pakistan, a provision allowing courts to provide victims with a respite in "darul aman" (places of safety) has been incorporated to facilitate contemplation in such circumstances. However, the overarching absence of well-rounded legal measures continues to loom large over addressing this intricate matter, intertwining the fundamental tenets of freedom, consent, and justice. As India and Pakistan grapple with these weighty issues, it remains imperative for societies to engage in a thoughtful and nuanced discourse to ensure the well-being and rights of all individuals, regardless of their faith.

Standardisation of natural dyeing for textiles will pave the way for a sustainable tomorrow

ver since the world became a global village with the advent of the internet and new-age technology, businesses all over the world have seen allaround growth in the past few decades. However, with an increase in opportunity came the responsibility of selling and buying genuine products tested against well-defined standards across

industries. The textile industry is also no exception when it comes to manufacturing standardised products that are tested for their quality through a series of certification protocols. The testing and certification of the products are not only in the interest of the buyer but also help brands become synonymous



Until a few years ago, it was difficult to decipher if a certain textile product was coloured using synthetic or natural dyes. Textile colourants (natur-

al and synthetic) have added value to the desires of consumers. In ancient times, the processing of dyeing was done using colours from natural sources until synthetic dyes were introduced into commercial practice and started being used widely by textile dyers. Almost all synthetic colourants are synthesised using petrochemical sources and pose a grave threat to the environment. Hence, the growing consciousness of preferring ecofriendly products has

with authenticity and trust. sumers and manufacturers in the use of eco-friendly natural dyes. Following the increase in demand and awareness, commercial dyers and textile export businesses have started re-looking at using natural dyes for dyeing a variety of textiles and

enhancing the market for eco-friendly colourants. Not only do natural dyes prevent environmental hazards, but they also produce soft shades that are skinfriendly compared to synthetic dyes, which are available at an economical price but often cause skin allergies. The extraction of colour components from the source in natural dyeing is an important step to optimise the colour yield. The impedi-

global markets towards natural dyes have been a gradual process that has been through the journey of formulating certification protocols for natural dyes that are indigenous to India.

Any standardisation in our country cannot be called foolproof unless it has achieved the parameters set under the Bureau of Indian Standards, which is the apex body for setting up standard protocols for all consumer products. A special panel was also set up to prepare certification protocols for indigenous dye products by the Bureau of Indian Standards (BIS). The journey started as early as 2007-08 when we roped in IIT Kanpur to develop standards for testing natur-

in the world under which a certification protocol has been developed for natural dye products.

My association with the Textile Specialty Chemicals and Dyestuffs Sectional Committee, TxD 07, BIS Committee of the Textiles Department for the last 7 years has resulted in achieving significant milestones as a nation. After extensive work, the committee has been successful in formulating three benchmarks on natural colours, which include Standards on Natural Indigo, Rubia Madar, Katha, Lac, Punica Granatum, Rheum Emody, Canna Indica, Gulmehandi, Teak, and Arjun Bark.

India, being a project renewed the interest of conments in creating trust in the al dyes. This is the first project leader in the standardisa-

tion of natural materials for textiles, has also developed three ISO standards on natural dyes. These include the standards for Madder, Catachu, lac, and Punica Granatum. The demand for natural dves has increased tremendously over the past decades. This has created a need for standardisation as there is a vast pool of players and products in the market. The presence of the ECO logo along with the ISI Mark on a product dye indicates that it offers the best quality requirements as specified in the relevant Indian Standard and is eco-friendly, which consumes less water and

energy in its making. It is due to hard work and determination that the textile industry in India has started synthetic dyes.

paying special attention to the use of natural dyes in place of chemical dyes. Our country is taking giant leaps in propagating the wide use of natural dyes, in line with the intention of the Indian government. When we use svnthetic dye, 5.6 kg of carbon footprints are generated by dyeing 10 kg of cotton fabric.

Currently, we have numerous natural options available for natural dye substitutes. Among many things, a lot of money will be required to reduce the carbon footprint during the production process. It has also been proven in life cycle analysis (LCA) reports that the use of natural dyes can reduce the carbon footprint manifold as compared to

Gadkari expresses dismay over inadequate response to CAG

Union Road Transport and Highways Minister Nitin Gadkari has expressed dismay over the inadequate response to questions raised by the Comptroller and Auditor General (CAG) which resulted in controversy over the cost of construction of Dwarka

Expressway in Delhi. According to ministry sources, Gadkari has conveyed his displeasure with the lopsided attitude adopted by certain officials responsible for responding to queries raised by the CAG with regard to the cost of construction of the Dwarka Expressway at a highlevel review meeting on

Thursday. The source said that the minister also directed to fix the responsibility of this lapse on the part of senior concerned officials.

Earlier in the month, a political row erupted on the CAG report which flagged the high cost of construction of the Dwarka Expressway.

Earlier the ministry sources had said that in the absence of an adequate response from the ministry and the National Highway Authority of India (NHAI), the CAG adopted an incorrect methodology for computing the cost of Dwarka Expressway.

They also explained that the CAG has simply divided the total cost of construction of Rs



91,000 crore (expenditure) under National Corridor Efficiency Programme with the project's entire length of 5,000 kilometres under devel-

They had said the CAG has itself noted that the cost of con-

struction of Rs 18.2 crore per kilometre does not include the cost norms for flyovers, ring roads, etc.

They were of the view that the expressway in question has elevated roads, underpasses, tunnels and other components

which were not part of the project. The cost of Rs 91,000 crore for 5,000 km under Bharatmala Phase-I project was finalised by the ministry on August 10, 2016, for the year 2016-17 to the extent possible.

The ministry sources had claimed that the government saved over 12 per cent in construction cost against estimates in awarding contracts for the expressway. They pointed out that the CAG findings that the cost was exorbitant are misplaced as the auditor did not factor in the actual cost.

According to reports, the CAG had found that the NHAI decision to go for an elevated carriageway on the Haryana portion of the Dwarka

Expressway pushed up the construction cost to Rs 251 crore per kilometre from Rs 18.2 crore per km estimated

earlier. The audit report on the implementation of Phase-I of the 'Bharatmala Pariyojana' highway projects, triggered a political row with the opposition parties alleging corruption in the process of awarding the project.

The ministry sources had explained that all four packages of Dwarka Expressway were put for tender at an average civil cost of Rs 206.39 crore per kilometre but the contracts were finally awarded at a lower rate of Rs 181.94 crore per km.

NLC India inks pact to supply 300 MW solar power to Rajasthan

The city has given me the opportunity to work at my own pace and have my atelier and studio at home, which is not something that is feasible in other ing metropolitan cities This lets me invest more time in my label and produce something cre-

Admitting that the city is ever-growing and has seen varied cul-tures, she spills the beans: "It still has to evolve to be more open and experimental and have acceptance when it comes to trends and fashion on a daily basis rather than just for an occasion."

And she very well knows how Hyderabad used to be a city of lakes, but the development has taken a toll on its beauty. And the lakes started disappearing into concrete jungles, which she's so critical about.

India has been on the verge of becoming a champion nation. Well, recently, India emerged as a double winner in cricket and hockey. In fact, even in football at the SAFF championship As we talk of sports, another sport that's making it big is arm wrestling, and so yes, we can just not forget to thank championships like the Pro Panja League for bringing the sport to notice. Today, we have Hyderabadi arm wrestler, Ahmed Faizan, who is making it big in the sport with his skills. Talking of table arm wrestling, a 'Pucca Hyderabadi' that he is, he recalls properly starting doing it towards the end of 2018. "My brother has a school, IAS International School, and I had gone to a printing shop to get a banner printed for the school. On the adjacent computer, the Telangana Arm Wrestling Championship poster was being edited. I saw it and thought, "Oh, is this a thing? There are arm wrestling championships?" But then I forgot about it. I was busy with my work. In the morning, I was jogging near a function hall when I saw the same poster again. I simply went inside and registered my name. I was like, "Anyways, I arm wrestle here and there." I also used to be number 1 at arm wrestling in school." So there he was, registered his name, and was playing in the 80kg category. He then won the bronze medal, which not only gave him confidence but also gave him the thought that if this is an actual sport, then he can make something of himself here, and he joined an Arm Busters Club in Ramkoti, King Kothi. He began practising there, playing local tournaments and club matches. The second big match he played

ooking at the sports scenario around the world,

Fizan had also dreamt of becoming a football player but faced a setback due to an unfortunate accident during a club game in 2017. Battling depression, he decided to take control of his life by focusing on his fitness and embarking on an extensive workout programme at the gym. To date, football isn't just a game for him; it's his life. "Back then, it was like if I didn't touch football. I could neither eat nor digest food. I was very involved, but I never got the right guidance to go ahead. We had normal practise and improvisation in the game, but I never got a platform for it. Plus, there was also the matter of injuries. I mean. injuries are a part of normal practise. It was like every field had its own name and its own team. I used to play for the Nizam College side. Nizam College versus LB Stadium or Lal Bahadur Stadium versus Darulshifa This is how the matches would take place. One

time, there was a Nizam versus LB Stadium match. I was playing for the Nizam College team, and on the other side of the field, they were conducting practise for long jump. Parkour is a type of game where participants perform front flips, back flips, jumps on buildings, etc. I had that craziness in me. I was seventy kilogrammes at the time. In that game, I scored a goal and, in my excitement, did a front flip. My body was on the left side, and I landed straight on my legs, which led to a ligament injury. It was actually a severe injury, but I didn't take it seriously. I took a break for a day, and the next day I went to play. Which is why the injury kept getting severe." Back then, he wasn't very aware of the injuries. Well, he was just 19 years old back then. He had no indepth knowledge about sports, and this injury took up

a lot of his time. Initially, there were Sheru classes that started in Mumbai in 2019. At that point in time, Faizan hadn't learned much from arm wrestling. The local associations used to take people to Sheru classes for the Pro Panja league. However, he skipped it because he neither had the support of his family nor was financially stable. Seeing the videos where people had performed on stage made him feel pretty dejected. However, he started appreciating the Pro Pania League since he had never seen this level of arm wrestling before. The stage, the audience, the round table, the appreciation, and the entries made him feel like, "Can a palm be such a thing?" He then goes on, "I became serious about the game. I also write and rap, and I had written four raps at the

time for my YouTube channel. I was just sitting one day when it occurred to me that I should write a song

on the 'Panja'. As I was sitting there, I caught a rhythm, got a book and a pen, and made a song. I wrote the anthem for the 'Pro Panja League'. It was only in the writing; it hadn't even been composed yet when I directly messaged Parvin sir on Instagram. He saw the message and asked me to send the song; he said he'd listen to it. I had sent the same message to three people. Another person also asked me to send it. It was like he was waiting. Then I properly started working on it. It took nearly four months for the song to be ready. But before that happened, the 2022 nationals had arrived in Hyderabad. There I met Parvin Dabas sir on the second or third day. I was sitting in the front; I was managing everything back then. I met him, spoke about the song, and reminded him that we'd spoken before. He was like, "Oh, is that you?" So actually, I had rapped there, on the national stage. Everybody enjoyed it a lot." Impressive, isn't it? "Then I went to Gwalior. Before I went, I had sent my song to Parvin Dabas, sir. As the date approached, I received tickets from Pro Panja, and I went to Gwalior. This Gwalior event was the first Pro Panja event I attended, and it was an incredible experience. The refereeship and the game were very clean. There, I achieved the eighth rank in the hundred-plus category. Before I went there, the song was ready. It was a promo song, and I got a call from Parvin sir saving, "Don't release the song. We'll launch it there, in Gwalior." And when I went there the first day, they opened it with the song. So I feel very grateful about this thing. I'm very thankful to Parvin, sir. I'm thankful to Allah, and I'm thankful for my hard work. Then the matches took place, and I came eighth in the 100+ category. After the final match, I got a chance to sing, and the federation enjoyed it. And this is my journey

experience is the best experience. If you have a bad first experience, it leaves an impression in your mind. It makes vou feel like this thing is bad and nothing worthwhile will come out of it. But when I came to Pro Panja, I felt like, Here, I can do something. I realised there that Pro Panja could rightly give back to the hard work that goes into arm wrestling.' He began his journey in arm wrestling at a time when there was not much awareness about it. In speaks about his

this regard, he considers himself special because he says, "Ever since I've started arm wrestling, I've never even once thought that this sport would take me nowhere. All the events I have attended so far have given me positive returns. You could say I've gotten fame, a name, an audience, and everything else. For instance, Parvin Dabas sir was paying me for the song, but I was like, No, this is for Pro Panja. I like making music. Parvin Dabas,

sir, gave me such a big stage. I've gotten recognition here; no return could be bigger than that. So the whole thing with money, at least for now, I'm keeping aside. I am more inclined towards recognition. I want my name to be known so people can recognise me. Currently, money is not my intention.'

Faizan feels grateful to be a part of Kiraak Hyderabad and shared that, though the members of the team are more experienced compared to him, they've always been a huge support to him.

"Hyderabad has many players, many good players," he shares, adding, "If they come to the forefront, all the popular names will go down. I want people to come ahead. I will bring them ahead. There is some division because of federation disputes, but I want everyone to get a good, big platform. I was lucky. I got on such a big stage with relatively little hard work. And I'm very grateful for this. I am grateful to my parents and my elder brother, who supports me a lot. Hyderabad has a lot of good players, but they've left arm wrestling because they don't get any returns. They go to state tournaments, national tournaments, and open tournaments, but everywhere they have to spend their own money for accommodation, food, etc., and all they come back with is a medal. No footage at all. No recognition, no platform, nothing for the player's game, his passion. But now with Pro Panja, people, and even kids, are getting to know about it. The craze is increasing. You could say a new generation is getting involved in the game. The people who used to go for wrestling, the people who wanted to go for proper body building, have started shifting towards arm wrestling."

Having made his internaal debut in January 2010, the 34-year-old Thirimanne had called time on his international career in July during an announcement made on social media.

"Sri Lanka Cricket's Executive Committee accepted the resignation of Lahiru Thirimanne from playing all forms of international cricket," Sri Lanka Cricket said.

Thirimanne's last appear-

ance for the island nation was in March 2022, when he played against India in the Bengaluru Test in March 2022.

In 44 Tests, he averaged a mere 26.43 with three centuries - two against Bangladesh and one versus England - and 10 fifties, making an overall 2,088 runs. Thirimanne played 127 ODIs and scored 3,194 runs with four tons and 21 fifties at 34.71.

However, Thirimanne's career failed to take off in T20Is - he managed just 291 runs in 26 outings at 16.16. He was, though, a member of the 2014 World T20 winning Sri Lankan side which beat India in the final.

"It has been an absolute honour to represent my country for past few years. This game that has given me so much over the years. But, with a lot of mixed feelings, I am here to announce my retirement from international cricket with an immediate effect," the batter said while announcing his retire-Thirimanne hinted he was


