Modi warns anti national elements against adventurism

Sources reported that the Prime Minister expressed serious concern over the matter and regretted the incident, which he termed an attack on the temple of democracy. "Take this incident seriously. Don't indulge in politicking We all need to take precautions," the PM is said to have conveyed to his council of ministers at a meeting before the start of Parliament session on Thursday

Sources mentioned that Modi wanted to be informed about the latest actions taken and the directions of the investigation. He emphasised the need to apprehend the perpetrators swiftly to send a clear message that the current regime is strict.

'There should be zero tolerance for any such antinational incidents," a source quoted the PM as saying during the review meeting.

Expressing shock at the breach, several Members of Parliament stated that visitors must clear five levels of security before entering the

complex, and signatures from an MP's office are required for a pass to the visitors' gallery. The breach occurred 22 years after the 2001 attack on Parliament.

In a statement shortly after Parliament assembled at 2 pm, Parliamentary Affairs Minister Pralhad Joshi said, "We all agree that the unfortunate incident on Wednesday was a serious one concerning the safety and security of MPs."

MHA swings into action: NIA intensifies probe into Parliament invasion

fter a series of interroga-Ations with multiple probe agencies, the four culprits arrested over the Parliament security breach on Wednesday have been charged under the anti-terror Unlawful Activities Prevention Act (UAPA), even as raids are being conducted at several places to apprehend one Lalit Îha, suspected to be the key conspirator.

Initial investigations have revealed that the main conspirator is someone else, and efforts are underway to apprehend him. However, the security agencies have not found connections with any terror group so far. The Delhi Police has formed

several teams and are moving across the country for probes at various locations, seeking cooperation from other agencies, including mobile and internet operators.

A Delhi court sent the four accused — Sagar Sharma (26), Manoranjan D (34), Amol Shinde (25), and

Neelam Devi (37) — to seven days of police custody. They were presented before NIA Special Judge Hardeep Kaur by the city police who sought their custodial interrogation for 15 days. While seeking a remand for 15 days, the Delhi Police informed the court that it was a well-planned attack on Parliament. The police mentioned that special shoes were made in Lucknow, which need to investigated. They need to be

investigation. The Delhi Police further informed the court that they have added Sections 16 and 18 of the anti-terror law Unlawful Prevention Act (UAPA), related to terrorism and conspiracy for terrorism,

respectively, against them. "Their rights were limited to galleries. They jumped from the (visitors) gallery into the Well, which was trespassing. They hid (smoke) canisters in their shoes," the police taken to Mumbai, Mysore, said.

Rajasthan CM to take oath today

Rajasthan Chief Minister-designate Bhajan Lal Sharma, along with his deputies Diya Kumari and Prem Chand Bairwa, is set to take the oath of office on Friday outside the Albert Hall museum at Ram Niwas Bagh. The ceremony will be attended by Prime Minister Narendra Modi, Union Home Minister Amit Shah, BJP National President JP Nadda, and other prominent party leaders. Governor Kalraj Mishra will administer the oath, echoing a similar venue used by Chief Minister Ashok Gehlot in 2018.

Massive security measures and seating arrangements have been implemented at the historic Albert Hall, anticipating a large audience for the ceremony. As of Thursday evening, final preparations were underway to ensure a grand event. The ceremony is scheduled for 11:15 am, with public representatives, party workers, and people from across the state expected to participate. BJP leaders confirmed that invitations have been extended to central leaders and state chief ministers for the ceremony. Main roads leading to the state capital have been adorned with posters and banners

showcasing various welfare schemes of the Centre, along with cutouts of

leaders. earlier an statement, Rai Bhawan announced that the swearing-in ceremony, proposed by Sharma, would

take place on Friday outside Albert Hall in Ram Niwas Bagh. Governor Mishra congratulated Sharma and approved the ceremony's program.

Sharma's oath on December 15 holds significance according to the Hindu calendar, as it precedes the commencement of Kharmas on December 16, 2023, considered inauspicious in Hindu mythology until January 15, 2024. Astrologers advise against new endeavors, marriage, engagement ceremonies, house purchases, and starting ventures during this

Sharma, a first-time MLA, was announced as the chief minister-designate on Tuesday during a BJP Legislature Party meeting, attended by central observers Rajnath Singh, Saroj Pandey, and Vinod Tawde. Deputy chief ministers Diya Kumari and Prem Chand Bairwa, along with Speaker of the Assembly Vasudev Devnani, were also appointed during the meeting. Former Chief Minister Vasundhara Raje is expected to attend the ceremony. Party leaders held several meetings at the party's state office to coordinate responsibilities for the event.

14 MPs suspended for ruckus in Parliament

Atotal of 14 Parliamentarians from the Opposition benches, including one from the Rajya Sabha, were suspended on Thursday for the remaining period of the Winter Session on charges of disrupting proceedings in Parliament. Thirteen Opposition MPs from different parties were suspended from the Lok Sabha, while one TMC MP, Derek O'Brien, faced the action in the upper house.

Amid demands from the opposition for a statement from Home Minister Amit Shah and Prime Minister Narendra Modi regarding the security breach in the Lok Sabha, Parliamentary Affairs Minister Pralhad Joshi moved two resolutions on separate occasions for the suspension of the MPs.

Before their suspension, the MPs moved into the Well of the

House, raising slogans and demanding a statement from the government on Wednesday's security breach.

The Lok Sabha witnessed its first adjournment during the question hour, as it was adjourned until 2 pm amid the opposition's uproar. At 2 pm, Joshi read a statement on behalf of the government, stating that internal security in Parliament falls under the purview of the Speaker. He then moved a resolution amid the

chaos to suspend five MPs. "I move the following, that this House, having noted the misconduct of TN Prathapan, Hibi Eden, Jothimani, Ramya Haridas, and Dean Kuriakose, in utter disregard to the House and the authority of this Chair, and having been named by the Chair... to be suspended from the service of the House for the remainder of the session," the resolution read.

Milestone in Mathura dispute as HC allows mosque survey

The Allahabad High Court on Thursday allowed a courturvev of the Idgah premises adjoining the Krishna Janmabhoomi temple, an important milestone in the temple-mosque dispute in Mathura. The High Court agreed to the appointment of an advocate commissioner to oversee the survey of the mosque, which the petitioners claim holds signs suggesting that it was a Hindu

temple once. Justice Mayank Kumar Jain said the modalities of the survey will be discussed at the next hearing on December 18.

The order on the Krishna Janmabhoomi-Shahi Idgah issue is the second temple-mosque dispute in which the high court has given its nod to a survey

over the past months. The Archeological Survey of India (ASI) recently completed a survey of the Gyanvapi mosque next to Varanasi's Kashi Vishwanath temple, but has sought more time from a local

court to submit its report. According to advocate Vishnu Shankar Jain, the application submitted to the Allahabad High Court in the Mathura case said a lotus-shaped pillar characteristic of Hindu temples



It was also submitted that Hindu symbols religious engravings are visible at the base of the pillar.

In May, the Allahabad High Court transferred to itself all cases related to the Mathura dispute. On November 16, Justice Jain had reserved the order on the Hindu side's

petition seeking a survey of the Shahi Idgah premises.

The petition was filed on behalf of the deity Bhagwan Sri Krishna Virajman and seven others through advocates Hari Shankar Jain, Vishnu Shankar Jain, Prabhash Pandey and Devki Nandan. It claimed that Lord Krishna's birthplace lies

beneath the mosque. The applicants had sought the appointment of a commission

with specific directions to submit its report within a stipulated time period after

conducting a survey.

The petition also sought directions to photograph and record the entire proceedings on

video. According to the petitioners, the factual aspects of the "disputed structure" have to be brought before the court for proper

Humans run riot over our regal animals again

70-member team of crack Ashooters from the Kerala Police, tranquilising experts from the Forest Department, forest guards, and a "Kumki" elephant specially summoned from Mysore are on the trail of a tiger designated as a man-eater in Kerala's Wayanad district. Local residents in Wayanad allege that last week, the tiger killed a person who had entered the reserve forests to collect forest produce, and his halfeaten body was subsequently recovered.

In late November, people discovered the carcass of a leopard on the outskirts of Wayanad forests. Additionally, another leopard was killed in the

Kannur district by officials entrusted with protecting it. According to the government's account, the big cat died when it was tranquilised as part of a mission to rescue it from a well into which it had accidentally fallen.

Within two days, the carcass of a three-and-a-half-year-old leopard was found in the "murdered" by porcupines, according to forest officials. The carcass bore numerous quills, supporting the officials' claims that the leopard fell victim to a territorial dispute between big cats and unruly porcupines. These incidents have earned Kerala the grim nickname "graveyard of wild animals".



forest officer, a woman, issued orders to tranquilise the big cat, the locals remained dissatisfied.

They demonstrated with the victim's lifeless body, demanding that the tiger be euthanised. Adding insult to injury, TV news channels are reporting the sighting of a tiger in Valparai, a village on the Kerala-Tamil Nadu border. Valparai, once abundant with reserve forests and a politic for tigers, learned as and a habitat for tigers, leopards, elephants, boars, as well as smaller animals like rabbits, jackals, foxes, and deer, has undergone significant changes. 'The reserve forests gave way to tea estates, and as the number of plantations increased, the homes of animals shrank. Hence, the sighting of tigers and leopards is treated as 'Breaking News,' as if a major mishap has occurred," said Sudheer Damodaran, ecologist based in Thrissur who monitors events in Valparai. He noted that massive encroachment into reserve

forests has led to wild animals becoming strangers in their own land. Pius, a retired assistant

conservator of forests, stated that there has been no considerable increase in the number of leopards, tigers, and other wild animals in the forests of Kerala. "Many of them, displaced from their habitats, are forced to enter new settlements, resulting in man-animal clashes. Tigers, cheetahs, and leopards are shy animals and typically keep away from humans. They attack humans only when they become old and infirm," said Pius, drawing on his three decades of experience dealing with wild animals. Continued on Page 2

Knew Jha but no role in LS attack: Kolkata UG student

Nilakkha Aich the college student — to whom Lalit Jha the parliament smoke bomb attack accused allegedly WhatsApped the first video of the attack - on Thursday denied any role in the Wednesday's raid. He had no idea about why Jha, now at large, had sent him the video,

Aich also said that he had met Jha only once in Kolkata. "I had met him in the month of April during an event at Central Avenue ... I was told that like me he too was involved in social works," Aich said.

A second-year under-graduate student, Aich said "I have no idea as to why he sent me this video ... I was inside my class room and had no idea of what had taken place inside Parliament ... I only came to know about things after I received the WhatsApped video ... I only watched them." He said that he did not know other persons who had been



arrested in the case adding none of these people, not even Jha came to his house at Halisahar in North 24 Parganas some thirty miles north of

Neloy Aich, the father of Nilakkha, said that his son was a good student and had no objectionable track record. 'He was involved with some

NGOs but every activity took place through Facebook or social media ... there was no physical activity involved," the

elder Aich said adding the NGO of which Nilakkha Aich was a member was "probably named Samajwadi Subhas

Sources however claimed that Jha and his people were involved with a number of NGOs functioning from the Jangalmahal area of Jhargram and Purulia --- once a Maoist hotbed. Six people were allegedly involved in the planning and execution of Wednesday's attack. While two of them '--

Sagar Sharma and Manoranian D. -- burst yellow smoke canisters after jumping into the Lok Sabha chamber from the visitors' gallery the others videographed the incident. Meanwhile, the Bengal Police after being alerted by the Crime Branch of Delhi Police on Thursday questioned Aich at

his residence. Aich reportedly told the police that as he was involved with a number of NGOs he had come in contact with Jha in the month of April this year. Aich also informed the police

that Jha lived in Kolkata's Burrabazar area for some time. He allowed himself to be known in the locality as a teacher, sources said.

Jha was an introvert kind of person but never aroused any suspicion among his neighbours, the police sources said adding the man used to pay his rent online.

Jha had not come to his flat for the past one-and-a-half years and his room was under lock and key, neighbours said.

17 lakh Maharashtra Government employees go on strike, services hit

Various public services were badly affected on Thursday, as more than 17 lakh Maharashtra Government employees went on a day-long strike to press for Old Pension Scheme (OPS), and 17 other demands.

Thursday was the second occasion in the last nine months when lakhs of employees owing allegiance to the Maharashtra Štate Government Employees Association (MSGEA) struck work across the state, to demand OPS and press for other pending demands.

The agitation, which covered all government departments, including schools, colleges, hospitals -- from the block to the state level, affected public services at many places.

It may be recalled that chief minister Eknath Shinde had had appointed a committee to study the OPS and the New Pension Scheme. The committee, comprising top former bureaucrats Subodh Kumar, K. P. Bakshi and Sudhir Kumar,

Maharashtra cops gun down 2 Maoists on Chhattisgarh border

¬he Gadchiroli police on The Gaucinion points
Thursday foiled a plan by naxal operatives to ambush security forces and kill the local tribals, by gunning down two Maoists in a fierce encounter and recovering a cache of arms and ammunition in the forests located on Maharashtra-

Chhattisgarh border. Acting on a tip-off that a large contingent of naxals was camping in the forests located on the Chattisgarh as part of its plan to ambush security forces and kill innocent tribals, the police teams launched a massive combing operation in the forest area, prompting the Maoists to indulge in indiscriminate firing at them. The police teams retaliated in a big way at the

The credible intelligence input that the Gadchiroli police had received was that a large mumber heavily armed Maoists were camping from last outpost Godalwahi in Chhattisgarh, with "an intention to cause sabotage and ambush on the police forces and to kill innocent tribals branding them as police informers".

In the fierce encounter between naxals and the police that lasted for more than an

hour, at least two Maoists were killed. After the encounter, the police recovered the bodies of two Maoists killed in the firing and also some arms and ammunition, including an AK47 and a SLR weapon,

According to sources, the role of two more persons has also surfaced during investigation, adding that all the accused did everything as part of their foolproof plan. The police have registered a case under UAPA sections 16 (punishment for a terrorist

act) and 18 (punishment for conspiracy, etc.) and IPC sections 120B (criminal (criminal conspiracy), 452 (trespass), (wantonly giving provocation, with intent to cause riot), 186 (obstructing a public servant in the discharge of public functions), and 353 (assault or criminal force to deter a public servant from the discharge of his duty) at the Parliament Street police station. Offenses punishable under the stringent Unlawful Activities (Prevention) Act are non-bailable.

Raids on as key conspirator still on run

The Delhi Police has conducted raids to nab Lalit Jha, the sixth man suspected to be a key part of the group that breached Parliament. A resident of Kolkata, Jha is a teacher by profession and was the main conspirator of the security breach. However, Jha is on the run and is suspected to be either in Rajasthan or Harvana. Multiple teams are on the lookout for Jha, who is also a teacher by profession.

Jha, one of the accused in the Parliament security breach, had shot the video of the entire protest by two accused outside Parliament and had shared it with one man, who is associated with an NGO (Samovadi Subash) in Kolkata, sources

Aday before the major security breach in the Lok Sabha, the Central Public Works Department (CPWD) floated a tender for additional security infrastructure, including security gadgets and bulletproof enclosure for security personnel, at an estimated cost of Rs 35 crore for the Parliament complex. lished on December 12, the CPWD named the project as "Redevelopment of reception lounge & other security infrastructure in Parliament Complex, New Delhi".

The CPWD, which comes under the Union Housing and Urban Affairs Ministry, invited pre-qualification bids for the project. The last date to submit the pre-qualification bid is December 22 and it will be opened the same day. The



tender document states that the financial bid will be invited from pre-qualified bidders at a later date. The CPWD said that in view

of the high degree of security concerns at site and the kind of work involved, stringent access-control measures will be exercised for entry and exit of manpower, material and construction equipment. "Reception lounge & other

Mohalla bus service may be rolled out in January, says Gahlot

Delhi Transport Minister Kailash Gahlot on Thursday said the Delhi government's 'mohalla' bus service could be rolled out in January next year with the delivery of the first lot of buses after necessary approvals.

The 'mohalla' bus service, announced in the 2023-24 Delhi budget, aims to deploy shorter nine-metre electric buses to boost last-mile connectivity in crowded areas and those with narrow roads. These buses have been specially designed to cater to such areas.

"The delivery of the ninemetre buses is likely to start from next month and we are waiting for that. Except for one company that had supplied such buses to the Delhi Metro Rail Corporation, no company has such buses ready.



prototype is made and the certifying agencies assess its roadworthiness. After the roadworthiness is certified, they (buses) are given to the Transport Department and it carries out an inspection. Then the trial happens," Gahlot said at a press conference.

"We held a meeting with the OEM and we are confident of getting the first lot of buses by January. Once we get them, we will flag them off and dedicate

them to the people of Delhi," he added. According to officials, certain

areas like outer Delhi, Sangam Vihar, Deoli, Chhatarpur, Vasant Kunj, Dwarka, Rohini and Najafgarh have been identified for deployment of these buses as they do not have proper connectivity to bus stops and metro stations. The Chief Minister Arvind Kejriwal-led government plans to procure more than 2,000 feeder buses to operate on routes that cannot be accessed by 12-metre buses. A technical committee was constituted by the transport minister in May to decide routes and operational characteristics of the new bus service. As part of research for the

launch of the 'mohalla' bus service, Gahlot will also be meeting MLAs of southeast and outer Delhi constituencies to understand issues of areas lacking last-mile connectivity.

Saxena, Kejriwal flag off 500 electric buses in city

In a move to provide relief to commuters, Delhi Lieutenant Governor Vinai Kumar Saxena and Chief Minister Arvind Kejriwal flagged off 500 electric buses on Thursday, taking the number of such buses in the national capital to 1,300. With this, Delhi has the highest number of electric buses plying on its roads in the country.

"We have rolled out 500 (électric) buses today. These are zero emission buses. We will continue to do such things to make Delhi better," Saxena told reporters. Kejriwal in his turn thanked Saxena and promised to keep improving the city transport.

"I want to congratulate the people of Delhi on this occasion. I also want to thank the LG for taking out time from his busy schedule to grace this occasion. We now have 1300 electric buses in Delhi. We will continue to strengthen Delhi's transport system," he told reporters.

In a post on X, Transport Minister Kailash Gahlot said,

brating another huge milestone today! Flagged off 500 new E-buses along with Hon'ble CM @ArvindKejriwal and Hon'ble @LtGovĎelhi. Success is never overnight, it is guaranteed result of Consistency! We are yet again leading the way with a record Later, addressing a press con-

ference, the minister said the addition of the buses is a strong step in the fight against pollution. "In winters, pollution levels go up. One CNG bus emits 800 gram of carbon dioxide per kilometre. One electric bus saves that much amount of carbon dioxide going into the atmosphere," he said. Before the Thursday addition,

800 electric buses had been plying on Delhi roads since January 2022. These buses have covered a distance of more than 42 million kilometres and cut more than 34,000 tonnes of carbon dioxide so far, the minister said.

By 2025, Delhi will have a total of 10,480 buses with electric ones making up 80 per cent of

lakh tonnes of carbon dioxide annually, according to the minister. The new buses are airconditioned, comfortable, and equipped with CCTV cameras and panic buttons.

"If you do not feel comfortable while travelling, you can press the panic button and immediately the live feed to the command and control centre will

The feed will also be accessible to Delhi Police that will be able to step in," he said. The Leader of Opposition in

Delhi Assembly Ramvir Singh Bidhuri has thanked Prime Minister Narendra Modi saying with the help of the Central Government, Delhi has got the unique gift of 500 electric buses. "This will make it easier to fight against pollution in Delhi and will give life to Delhi's dying public transport system," said Bidhuri, adding that the AAP government should rationalize the routes properly as there are a number of routes where less number of buses are plying making life hell for the daily commuters.

Amid tussle, Delhi Government releases ₹535 cr for DJB projects

mid a tussle over release of Afunds, the Delhi government's finance department has released Rs 535 crore to the Delhi Jal Board for nearly 70 projects of the agency, officials

said on Thursday.

Delhi Water Minister Atishi had last month claimed that the national capital was staring at a "man-made water crisis" due to the stoppage of funds to the Delhi Jal Board (DJB) by the finance department and demanded Lieutenant Governor Vinai Kumar Saxena's immediate intervention.

"The file for release of funds came on December 7 and the funds were sanctioned on December 9. These are from the second installment of funds that are supposed to be released to the DJB," said a government Amid an ongoing tussle

between the Centre and Aam Aadmi Party, Delhi Finance and Services Minister Atishi in an affidavit submitted before the Delhi High Court said the Finance Secretary Ashish Chandra Verma is delaying the much-needed funds for the DJB. "Despite adherence to the prescribed payment schedule and timely submission of utilisation certificates and requisite details by the DJB on September 12, the Principal Secretary (Finance), Finance and Planning Department has persistently raised new and varied queries, impeding the release of the much-needed funds," Atishi said in an affidavit. The AAP minister also claimed that she had asked the officers to look into the matter but to no avail. "I have repeatedly asked for the officers responsible for the alleged mismanagement to be identified and for recommendations for

disciplinary action, to no avail. Neither have names been forwarded, nor has any action been initiated," she said.

Earlier this month, DJB vicechairman Somnath Bharti had said all maintenance and developmental works have "come to a standstill" due to the delay in disbursal of funds from the finance secretary.

"We have to release a total of Rs 2,200 crore to the Delhi Jal Board and out of that Rs 535 crore has been released. The finance department had informed the Delhi High Court about the release of funds on December 11," he added.

The government official said that there are about 70 projects for which these funds have been released. "These 70 projects have been geotagged and all their details were furnished to us. These include providing the DJB tankers for water supply and laying of sewer lines.

Don't fall prey to fake job offers abroad, MEA warns job seekers

The Ministry of External Affairs (MEA) on Thursday cautioned Indians seeking employment abroad to not fall prey to fake job offers and urged them to use safe and legal services of registered recruiting agents.

In an advisory, the MEA also warned all unregistered agencies promising jobs abroad not to involve in overseas recruitment saying such activities are in violation of Emigration Act 1983 and amount to human trafficking, which is a punishable criminal offence.

It has been noticed that there has been a huge rise in the number of overseas job seekers being cheated by unregistered recruitment agents by fake job offers and also overcharging to the tune of Rs 2 to 5 lakh, it

The MEA said these unregistered and illegal agents operate without obtaining a licence from the ministry which is mandatory for any recruitment abroad

"It is reported that many illegal agents operate through Facebook, WhatsApp, text message and other such medi-



ums. These agencies provide little or no details of their whereabouts and contacts," it

'They usually communicate only through WhatsApp, making it difficult to ascertain the location and identity of the caller and genuineness of the job offer," it added in the advi-

The MEA also cautioned that such agents lure workers to work in difficult and life threatening conditions and that such cases are being reported for recruitment to work in several East European countries, some of the Gulf countries, Central Asian countries, Israel, Canada, Myanmar and Lao People's Democratic Republic. A valid job offer comes along

with an employment contract duly signed by foreign employer, recruitment agent and the emigrant worker, the MEA

It said the employment contract must mention terms and conditions of the job being offered and the salary and other emoluments, adding valid job offers must allow the workers to emigrate on strength of employment or work visa or other similar visa except tourist visa. Normally, reputed foreign

employers provide for the cost of airfare, boarding and lodging and insurance cover, it mentioned.

The MEA urged people seeking jobs abroad to use the safe and legal services of registered recruiting agents (RA) only.



Continue MDS beyond 2024 to address mental health issues: Panel

¬iting poor primary infra-Cstructure for mental health and low psychiatristpatient ratio in the country grappling with mental health issues, a Parliamentary panel has asked the Government to not to go ahead with its plans to terminate the Manpower Development Scheme (MDS) in 2024 and instead continue it beyond to help address the mental health needs of the population.

The panel on 'mental healthcare and its management in contemporary times', led by Śabha Bhubaneswar Kalita, highlighted the existing shortage of mental health profession-

als while emphasizing the inadequacy of the current ratio of 0.75 mental health professionals for every 100,000 people.

In its report tabled in Rajya Sabha, the panel pointed out that this shortage of mental health professionals has realworld consequences, as millions of individuals grappling with various mental health issues continue to suffer. The panel identified not only the stigma and ignorance surrounding mental health but also the insufficiently trained mental health workforce as significant barriers to addressing the mental health needs of the population.

By recommending the continuation of the MDS, the Parliamentary Panel urged the government to take proactive measures to address the shortage of mental health professionals. The scheme plays a crucial role in training and developing a workforce equipped to meet the growing mental health challenges faced by the country, said the

The MDS was incorporated in the central flagship National Mental Health Programme



(NMHP) with an aim to boost infrastructure and human resources in the sector. As per the programme, the four kinds of PG seats are there -Psychiatry, Clinical Psychologists, MSc in Psychiatric Nursing and MSc Social Worker. Under Scheme-A, about 1,007 seats have been added in recent years -- 55 in Psychiatry, 306 in Clinical Psychology, 251 in Psychiatric Social Worker and 385 in Psychiatric Nursing. The MDS also envisages strengthening/establishment of PG departments in mental health specialities as well as financial support towards capital works and faculty support to the existing Central and State Mental Health Institutions for strengthening/establishment of Post Graduate Departments in mental health specialities viz: Psychiatry, Clinical Psychology, Psychiatric Social Work and Psychiatric Nurse.

A total of 47 PG Departments in 19 institutes have been established/ approved to date. These schemes are set to be completed by 2024, as per the Government.

However, the RS panel opined that the MDS should not be phased out and instead be continued given urgency in

The Committee also recommended the National Medical Commission (NMC) through the Union Health Ministry to actively explore the feasibility of augmenting the MD Psychiatry seats in the medical colleges.

"The Committee also suggests the Ministry to examine the possibility of a 3 year DNB degree in Psychiatry and other mental health specialisation in private hospitals, railway hospitals, PSU hospitals etc, through the National Board of Examinations." The panel further recomhave already joined the course." There is a shortage of mental health infrastructure, particularly in rural areas, and a lack of trained professionals.

Listing the initiatives taken for the welfare of women, he said it was the Modi government which launched the "Beti Bachao, Beti Padhao" campaign that aimed to improve the education among girls as well as the efficiency of welfare service intended for them.

For the security of women, the one nation one helpline was launched and a one-stop centre initiative was also started. While 733 one stop centres have been approved, 703 are operational in the country presently.

These provide integrated support and assistance to women affected by violence and in distress, both in private and public spaces, through a range of services including police facilitation, medical aid, legal aid and counselling, psychological support and temporary shelter in an integrated manner under one roof.

Speaking about the law against triple talaq, Mandaviya said it was an important step for



Muslim women to get freedom

from the age-old tradition. This freedom means they will no longer have to face this type of divorce and will be able to make full use of their rights. It is a social and legal reform that promotes women empowerment and provides them support in the society. With this type of change, women will feel more independent and will get the freedom to make their own decisions," he said.

Under the leadership of the prime minister, the government implemented various skill development schemes especially for women. "We launched the Pradhan

Mantri Matru Vandana Yojana, which provides financial assistance to pregnant and lactating mothers, thereby improving the health and nutrition of the mother and child as well as compensation for wage loss," he Keeping in view the health of

Mandaviya, who inaugurated five new facilities at the Indian Council of Medical Research -National Institute of Malaria Research (ICMR-NIMR) here, said "Jai Anusandhan" is a very important principle in the endeavour towards making India self-reliant.

The facilities include a test research laboratory, an innovation complex, a conference hall complex and a 300-seat Auditorium.

Mandaviya said this inauguration is "indicative of the focus of the government on research and innovation in every field of health".

The government is working to develop India's health sector completely and make it self-reliant". Highlighting the importance of "Jai Anusandhan", the Health

Minister said that it would have taken months for India to get the vaccine during the time of Covid.

"But we not only developed the vaccine in the country itself, we provided the best quality vaccine at the cheapest price to the world," said Mandaviya.

"Similarly, there are 14-15 medicines for rare diseases like Hydroxy-urea that used to cost tens of thousands of rupees. Today, these medicines are made in India and cost only a fraction of the earlier amount," he added.

Mandaviya urged the scientists, innovators and other people of the country who are developing new technologies in the field of health to use their new ideas, new thoughts, new innovations and new tech-nologies to "fulfil the dream of New India".

The Minister focused on the integration of technologies like digital health and artificial intelligence in healthcare and emphasized the importance of innovative use of drones for vaccine and drug delivery and the exploration of organ transfer via drones, which would signify a major leap in healthcare accessibility and efficiency.

Practising yog nidra may improve sleep, cognitive functioning: Study

Practising yoga nidra—a kind of mindfulness training- might improve sleep, cognition, learning, and memory, even in novices, according to a pilot study conducted by Dr Karuna Datta of the Armed Forces Medical College in India, and colleagues. After a two-week intervention

with a cohort of novice practitioners, the researchers found that the percentage of deltawaves in deep sleep increased and that all tested cognitive abilities improved. Unlike more active forms of

yoga, which focus on physical postures, breathing, and muscle control, yoga nidra guides people into a state of conscious relaxation while they are lying down. While it has reported to improve sleep and cognitive ability, those reports were based more on subjective measures than on objective data. The new study used objective

polysomnographic measures of sleep and a battery of cognitive tests. Measurements were taken before and after two weeks of yoga nidra practice, which was carried out during the daytime using a 20 minute audio recording. The study is published in the open-access journal PLOS ONE. Among other things,

polysomnography measures brain activity to determine how long each sleep stage lasts and how frequently each stage occurs. After two weeks of yoga nidra, the researchers observed that participants exhibited a significantly increased sleep efficiency and percentage of delta-waves in deep sleep.

The tribals who convert get benefits as members of a minority community and also as members of a Scheduled Tribe (ST), he said, speaking in the Legislative Council. Many tribals are being converted through coercion and inducement, the BJP leader claimed, adding that conversions hollow out the tribal culture. A committee headed by a retired vice chancellor will be formed to study the issue of delisting of the persons who get

BJP demands resignation of Naveen after IT seizes huge cash from liquor traders in Odisha

It also rejected Sisodia's request for an oral hearing on the review petitions.

JKLF chief Yasin Malik cases: 3 witnesses fail to appear before TADA court in Jammu

Three witnesses, including former Kashmir Bar Association president Mian Abdul Qayoom, failed to appear in a special court here on Thursday in connection with the 1989 abduction of Rubaiya Saveed, while separatist leader Yasin Malik and his associate Rafiq Pahloo appeared before it via video-conferencing.

Pahloo was given a final opportunity by the special TADA court to file objections to an application for the cancellation of his bail in a 1990 case in which four Indian Air Force (IAF) officers were killed case and the abduction case of Rubaiya Sayeed, the daughter of the then Union home minister Mufti Mohammad Saveed

"Four eyewitnesses were summoned to appear before the special court. Among them, Mian Qayoom did not appear and

submitted a medical certificate that he is admitted in a hospital. It was said that another eyewitness (number 23) is dead. Both were witnesses in the Rubaiya Saveed abduction case," Senior Public Prosecutor S K Bhat told PTI.

In the case of the killing of the IAF personnel in a terror attack in Srinagar in 1990, the court had summoned two witnesses for identification, but they could not appear citing medical reasons, Bhat said, adding that both of them had to come from outside. Bhat said Jammu Kashmir Liberation Front (JKLF) chief Malik and Pahloo appeared before the court via video-conferencing.

The court would again hear the case of the killing of the IAF personnel on January 18 and the Rubaiya Sayeed case the next day. Bhat said Pahloo was given a last opportunity by the court for filing objections to an application for the cancellation of his bail. The court has agreed to summon eye-

The Central Bureau of Investigation (CBI) moved an application in August for the can-cellation of Pahloo's bail in the two cases, informing the court that he had violated in separatist activities.

Two witnesses — numbers 24 and 25 were examined in November. They supported the prosecution's case and identified accused Ali Mohammad Mir, Bhat

Mir, who is the prime accused in the abduction case after Malik, had taken Rubaiya Sayeed in his vehicle to Sopore from Srinagar and kept her in a guesthouse. Malik, who is lodged in Delhi's Tihar Jail where he is serving a term in connection with a terror-financing case, was not produced in the court physically due to an order issued by the Union Ministry of Home Affairs restricting his movement. Pahloo is lodged in the Central Jail in Srinagar following his arrest for reviving the

terrorist apparatus in the Kashmir valley, Bhat said. Pahloo alias "Nanaji" was among the 10 terrorists arrested in July from a hotel in a case related to a conspiracy to revive the banned JKLF and separatist amalgam Hurriyat Conference in the valley.

The special Terrorist and Disruptive Activities (Prevention) Act court has already framed charges separately against Malik and several others in both cases. The charges against Malik, Pahloo and eight others in the 1989 abduction case of Rubaiya Sayeed were framed by the court on January 11, 2021.

Paradigm shift

The BJP's choice of new CMs is a shift towards strategic allegiance and social signalling

o less surprising than the recent Assembly poll results are the new BJP Chief Minister choices in Rajasthan, Madhya Pradesh and Chhattisgarh. Their names have sparked discussions about the party's strategy, with veterans being sidelined for newer faces, mostly with a low profile. This shift in approach to State leaders' selection sheds light on the BJP's evolving formula of governance, where loyalty, organisational experience and social signalling play pivotal roles. The decision to replace seasoned leaders, including Shivraj Singh Chouhan who ruled Madhya Pradesh for 18 years, with fresh faces in the three States marks a departure from convention. The stalwarts, who had been at the party's forefront in these States, suddenly find themselves on the sidelines. This shift implies a calculated move by the BJP high command to inject the leadership with new energy and perspective. One of the central themes emerging from these appointments is the preference for candidates seen as more amenable to the directives



of the Prime Minister and Home Minister. This idea of having 'yes-men' in key positions reflects a strategy aimed at ensuring a seamless alignment between the Centre's agenda and a State's leadership, especially with general elections just round the corner. This topdown decision-making model has both advantages and drawbacks, as it may streamline governance but could stifle counter-views and creative policymaking.

The BJP's choices in the three States also reflect a keen awareness of social signalling. In Chhattisgarh, Chief Minister Vishnu Deo Sai is a tribal while Dr Mohan Yadav, Madhya Pradesh's new CM, is an OBC leader. The biggest surprise is in Rajasthan where CM-elect

Bhajan Lal Sharma, a first-time MLA, was the last person on the radar of political pundits. He is the RSS favourite, though the decision did not sit well with top contender Vasundhara Raje. The new Chief Ministers, often representing different social or demographic groups, are strategically positioned to send out a message of inclusivity and representation. This approach aligns with the broader political trend of diversifying leadership to appeal to a wider voter base. However, the challenge lies in balancing symbolic representation with actual policy outcomes that address the concerns of diverse communities. The new Chief Ministers, while relatively fresh faces, have a history of dedicated service within the party. This emphasis on loyalty is not only political strategy but also a means to ensure that they remain aligned with the party's ideology and goals. However, an overemphasis on loyalty may compromise a State's interests as only a strong leader there can deal with the Union Government effectively. The BJP's selection of new Chief Ministers underscores a strategic shift in its leadership dynamics. The sidelining of the old guard and the emphasis on organisational experience, loyalty and social signalling also highlight the hold that Prime Minister Narendra Modi and Home Minister Amit Shah have over the party.

Compulsory voting for vibrant democracy




There is a strong case for compulsory voting as it means an end to tactical voting, votebank politics and can lead to stronger democracy

ompulsory voting is an effect of laws requiring eligible citizens to register and vote in elections and impose penalties on those who fail to do so. Presently, 22 countries provide for compulsory voting, and 11 democracies—about 5% of all United Nations members—enforce it.

Athenian democracy held that it was every citizen's duty to participate in decision-making, but attendance at the assembly was voluntary. Sometimes there was some form of social opprobrium to those not participating. Belgium has the oldest existing compulsory voting system. Compulsory voting was introduced in 1893 for men and in 1948 for women, following universal female suffrage. Belgians aged 18 and over and registered non-Belgian voters are obliged to present themselves at their polling stations. If they fail to vote in at least four elections, they can lose the right to vote for 10 years. Nonvoters also might face difficulties getting a job in the public sector. Australia introduced compulsory enrolment for voting at federal elections in 1912. Voting for Indigenous Australians was introduced in 1949, but enrolment and having one's name marked on the voting register was not compulsory for Indigenous Australians until 1984. Venezuela and the Netherlands are countries that have moved from compulsory voting to voluntary participation. The last compulsory Dutch and Venezuela elections were in 1967 and 1993, respectively.

Compulsory voting is increasingly resented by citizens in some countries such as Brazil, the largest country where compulsory voting is enforced: at the last presidential election in 2014, some 30 million voters, about 21% of registered voters, did not vote, even though Brazil has some of the most severe penalties enforced against non-voters.

It was a phenomenal initiative for India to launch its democracy with a universal adult franchise on the morrow of independence. It has to be borne in mind that in ough. Cross-border terror attacks instigated by our neighbouring country with impunity were allowed to remain unpunished because of the fear that retaliatory action might aggrieve voters belonging to a particular religion and thereby hurt the ruling party's prospects in future elections. This led to India justifiably being known as a soft state and therefore brought us little or no global sympathy in the face of unrelenting terror. Only after the 2014 elections have we seen a sea change in both voting behaviour and the government's policies emanating thereof. That makes the case for compulsory voting even

TESTING TIME FOR INDIA-MALDIVES TIES

Maldives is drifting away from India and tilting towards China and Türkiye

■ ndia's close ally in the Indian Ocean region, a country with which it shares maritime boundaries seems favourably tilting towards China under its newly elected president Dr Mohammed Muizzu.

Maldives and India have had a warm relationship so far, bolstered by Mr Muizzu's predecessor Ibrahim Mohamed Solih, who was widely seen to be favourably inclined to India. Two incidents have triggered fresh concerns about this ally of India in the Indian Ocean region.

First, in one of his foreign visits after being president, Mr Muizzu chose to visit Türkiye and establish an embassy in Ankara. The press release from the president's office reasoned it out as "the Maldives importing many essential commodities used in daily life and other important items from Türkiye and as part of additional efforts to encourage Turkish investment in the Maldives and export Maldivian goods. Furthermore, the number of Maldivian students studying in Türkiye for higher education and the Maldivian tourists travelling to Türkiye are increasing rapidly.

Second, Maldives sent its vice president Hussain Mohamed Latheef to China sponsored China-Indian Ocean Region Forum on Development Cooperation(IORFDC), while ignoring any concurrent gesture in a similar forum the Indian Ocean Rim Association (IORA), earlier.

The Vice president during his address to the IORFDC made a special mention regarding developing closer relations with China. The press release stated "China has been crucial to the Maldives' recent development and highlighted the two countries' solid shared commitment to a people-centric strategy, aiming to promote social development, peace, and prosperity." He added that the recently inaugurated President of the Maldives, HE Dr Mohamed Muizzu, and his administration are dedicated to fortifying the long-standing relations between China and the Maldives, built upon the foundation of mutual respect and shared goals.



Now both of these events, when looked at from an India angle, raise concerns, as both Turkey and China have not been favourable towards India's unique security interests, on land and the ocean. To be sure, there has been an anti-India rhetoric brewing in Maldives for the last few years, accentuated more so during Mr Muizzu's noisy political campaign. The anti-India campaign shot to prominence in 2020, primarily due to a minor Indian military presence in Maldives. However, it was enough for the opposition parties to raise it as a cause of concern against the sovereignty of this strategic island country. Almost two decades back a similar sentiment was echoed across Male and other neighbouring islands dotting the Indian Ocean, under the then leader Abdulla Yameen Abdul Gayoom, who along with his colleagues had indulged in Anti India sloganeering, to curry favours from China. Maldives is strategically located in the busy Indian Ocean maritime trade route and its geography makes it a strategic location for any country, wanting to have a reasonable say on maritime geopolitics. The presence of a few Indian military personnel to man some aerial stations from a security perspective for the island country, has created a rift in the India-Maldives bilateral. Mr Muizzu and Indian PM Narendra Modi met up in Dubai, on the side-

lines of the high-level climate summit. On his return from Dubai he said "Even in my first meeting after taking the oath of office, I communicated very clearly that we do not want foreign military troops in Maldives... In all our communications, India has agreed to accommodate this". The Indian press release post the meeting of the leaders did not mention any of the pricky issues even though in an earlier social media post Mr Modi had indicated respecting the democratic decision of the citizens of Maldives, meaning, India may be willing to work with Muizzu government and let not the bilateral relationship sail away. India has so far maintained its neighbourhood-first approach and looks like it is will-

ndia's GDP growth has brought optimism against the backdrop of an unbalanced world economy. In this scenario, the focus is once again on skilling initiatives. Skill India Mission and the skill development of the new generation are crucial for building 'Viksit Bharat' by 2047. The New Education Policy (NEP) 2020 emphasizes the need for every youth to be empowered with skills starting from school time, to become important stakeholders in a development revolution.

Today, education is not limited to what is taught in schools, colleges, and universities. The scope of learning has widened due to the evolving market and digital advancements. Acquiring market-driven skills will provide great placement opportunities to the youth and strengthen the oundation of Viksit Bharat

India has a demographic advantage that needs to be harnessed by building the capacity and infrastructure for skilling, reskilling, and upskilling both existing and new entrants to the workforce. The goal was to increase the proportion of formally skilled workforce from the current 5.4% to at least 15% by 2022-2023. However, the India Skills Report 2022 by Wheebox shows that the overall youth employability in India is only 48.7%. While several government-led skilling initiatives are covering some ground, they are not enough to meet the targeted supply of 109 million

According to the latest Periodic Labour Force Survey (PLFS) data, 86% of those aged between 15 and 59 years have not received any vocational training, while the remaining 14% received training through diverse formal and informal channels. The conversion of this pool into human capital requires a dedicated focus on skilling and education. There is ample evidence to prove that upskilling the youth could

lead to increased incomes, higher profitability, and greater productivity in the economy.

The NEP has set a clear goal to increase the gross enrolment ratio in higher education, including vocational education, to 50% by 2035. We are determined to achieve this goal by adding 3.5 crore new seats to higher education institutions (HEIs) focusing on a flexible curriculum with creative combinations of subjects, integrating vocational education with mainstream education, and allowing multiple entries and exits with appropriate certification. We will establish Multidisciplinary Education and Research Universities (MERUs) at par with Il is and IlMs to provide the best possible education to our stu-

We are committed to providing vocational exposure to at least 50% of learners through school and higher education by 2050. We firmly believe that every child should learn at least one vocation and be exposed to several more. With over 15 lakh schools teaching 25.38 crore students, India has one of the largest education networks in the world, and we are determined to make it even better. However, we acknowledge that achieving this ambitious goal requires sustained, concerted efforts, willpower, and steadfastness in implementing critical reforms. Many reports suggest that GKRY's market demand-driven skilling initiatives were not successful and did not reach the intended beneficiaries. This indicates a systemic problem that affects the talent ecosystem in India. Therefore, instead of merely making youths 'Labharathi' (Beneficiary), we should equip them with the necessary skills

to make them 'Kamarathi' (Workman).

The informal sector employs around 93 per cent of India's working population, which puts them at a high risk of exclusion. To mitigate this risk, marginalized groups need to be engaged through both online and offline channels. Common Service Centers (CSCs) can help with last-mile reach, while user-friendly and vernacular interfaces can benefit job and skill seekers across different segments. The Talent NODE is not a silver bullet, but with an innovative and inclusive approach, it can help between 50-80 million people find better job opportunities that match their skills and aspirations. An interconnected ecosystem can create a million different opportunities, enabling India's youth to become job-ready and contribute significantly to the country's develop-

ment. It is crucial for industry stakeholders, including the government, private, and public sectors, to bring cognitive skills, a growth mindset, cultural intelligence, and digital literacy to create innovators and entrepreneurs in the country. This will help the youth to be jobready and contribute significantly to India's development as a developed nation.

Israel vows to fight on in Gaza despite deadly ambush

rsrael has vowed to keep fight Israel nas vowed to keep to ling in Gaza until it crushes Hamas after one of the deadliest single battles of the war for its soldiers, even as it faces mounting international calls for a cease-fire and unease on the part of its closest ally, the United States. The ambush a fresh reminder that Hamas is still able to fight after six weeks of devastating warfare aimed at crushing its military capabilities. Israel has imposed a total siege and flattened much of northern Gaza with a massive air and ground campaign, driving hundreds of thousands of

people from their homes. Hamas' resilience has called into question whether Israel can defeat Hamas without wiping out Gaza. Support for Hamas has surged among Palestinians, in part because of the militant group's stiff resistance to a far more powerful foe, while Israel's most important ally, the US, has expressed growing discomfort over civilian deaths in what is already

devastating military campaigns.

"We are continuing until the end, there is no question," Prime Minister Benjamin Netanyahu said late Wednesday. "I say this even given the great pain and the international pressure. Nothing will stop us."

Biden, in a rare statement about the impeachment effort, questioned the priorities of House Republicans in pursuing an inquiry against him and his family

In January 2020, a Danish court upheld a nationwide police ban on the gang, saying that the LTF should be dissolved as illegal under Denmark's constitution.

Court upholds conviction

The Hague (AP): Appeals judges at a special Kosovo court upheld Thursday the convictions of a former commander in the Kosovo Liberation Army for arbitrarily detaining and torturing prisoners and murdering one of them during Kosovo's war for independence, but reduced his sentence by four years.

The commander, Salih Mustafa, was convicted a year ago and sentenced to 26 years' imprisonment for the crimes committed at a KLA compound in Zllash, Kosovo, in April 1999. He was acquitted of one charge of mistreating detainees who were perceived as supporters of Serbia.

While dismissing all Mustafa's appeals against his convictions, the appeals chamber at the Kosovo Specialist Chambers cut his sentence to 22 years of imprisonment, saytional and domestic sentencing standards in comparable cases.

Presiding Judge Michèle Picard called the ruling — the first appeals judgment in a war crimes case at the court an important milestone and a 'significant step towards providing justice to victims and ensuring accountability".
Picard stressed that the

reduction in Mustafa's sentence "in no way suggests that the crimes for which he has been convicted and sentenced are not grave".

Mustafa showed no emotion as Picard read out the appeal judgment. Mustafa was the first person convicted of war crimes by the Kosovo Specialist Chambers, a branch of Kosovo's court system that was established in the Netherlands to investigate crimes from the conflict.

Tokyo (AP): Japanese Prime Minister Fumio Kishida replaced four of his Cabinet ministers on Thursday in an effort to contain the damage from a widening slush fund scandal that has shaken his governing party and his grip on power within it.

The shakeup is Kidhida's third of his Cabinet, whose support ratings have continued to drop to new lows. The scandal involves the Liberal Democratic Party's largest and most influential faction. No peace in Ukraine until Orban tests EU goals achieved: Putin

Russian President Vladimir Putin vowed on Thursday that there would be no peace in Ukraine until his goals are achieved and said those objectives remain unchanged at a year-end news conference that offers the leader an opportunity to reinforce his grip on

Giving rare detail on what Moscow calls its special military operation, Putin dismissed the need for a second wave of mobilization of reservists to fight in Ukraine — a move that proved deeply unpopular in the past. He said there are some 617,000 Russian soldiers currently there, including around 244,000 troops who were called up to fight alongside professional Russian military forces.

The Russian president, who has held power for nearly 24 years and announced recently he is running for reelection, was greeted with applause as he arrived in the hall in central Moscow. Putin did not hold his traditional press conference last year after his military failed to take Kyiv and as the Ukrainian army retook swaths of territory in the east and south of the country.

But with Ukrainian Volodymyr President Zelenskyy now forced to plead for more US aid, a stalling counteroffensive and reports of fracturing Western support for Ukraine, the Russian president has decided to face the media once more — though the broadcast remains heavily choreographed and more about spectacle than scrutiny.

This year, ordinary citizens have the chance to phone in questions along with those asked by journalists, and Russians have been submitting queries for Putin for two weeks. It is the first time the Russian leader, who has heavily limited his interaction with foreign media, will potentially face multiple questions from Western journalists since the fighting in Ukraine began.

The press conference opened with questions about the conflict in Ukraine and highlighted concerns some Russians have about fears of another wave of mobilization. In September 2022 Putin

ordered a partial military callup as he tried to boost his forces in Ukraine, sparking

There is no need," for mobilization now, Putin said, because 1,500 men are being recruited into the Russian army every day across the country. He said, as of Wednesday evening, a total of 486,000 soldiers have signed a contract with the Russian military.
Putin reiterated that

Moscow's goals in Ukraine — "de-Nazification, de-militarization and a neutral status" of Ukraine — remain unchanged. He spelled out those loosely defined objectives the day he sent troops to the country in February 2022.

"De-Nazification" refers from Russia's allegations that the Ukrainian government is heavily influenced by radical nationalist and neo-Nazi groups - claims derided by Kyiv and the West. Putin has also demanded that Ukraine remain neutral — and not join the NATO alliance.

There will be peace when we will achieve our goals," Putin said, repeating a frequent Kremlin line. Putin's last news conference was in 2021 amid US warnings that Russia was on the brink of sending troops into Ukraine. He delayed his annual state-of-thenation address was until February of this year.

Putin's appearance is pri-

marily aimed at a domestic audience and is a chance for him to personally resolve the problems of ordinary Russian citizens ahead of the March 17 election. Putin fielded questions Thursday from a group of children in Russian-annexed Crimea concerned about the leaking roof and mold in their sports hall and a woman who addressed "my favorite president," to complain about the spiking price of eggs.

"I regret and apologize about that. A glitch in the work of the government" Putin told her, explaining that egg production has not matched demand and blaming the government for not increasing imports quickly enough.

State media said that as of Wednesday, about 2 million questions for Putin had been submitted ahead of the broadcast. Journalists lined up for hours in freezing temperatures to get into the venue and some donned traditional dress, including elaborate hats in order to catch Putin's attention. Many journalists also hold placards, prompting the Kremlin to limit the size of signs they can carry during the news conference, which often lasts about four hours.

Attendees must test for COVID-19 and flu before entering the news conference site. Putin enforced strict quarantine for visitors during the COVID-19 pandemic.

European Union leaders two-day summit on Thursday to keep intact their two most basic promises to Ukraine at war — to give it the money and wherewithal to stave off the Russian invasion and maintain its hope that one day it will be able to join the wealthy bloc.

And stunningly, the threat to that commitment does not come from outside, but from within, from the EU's increasingly recalcitrant member Hungary. The vision of its prime minister, Viktor Orban, ĥeartily shaking hands with Russian President Vladimir Putin two months ago still hung heavy over the gathering.

Orban came into the summit vowing to both block the plans by his 26 fellow leaders to officially declare that membership negotiations with Ukraine can start, and more pressingly, deny Kyiv 50 billion euros (\$54 billion) in financial aid that the country desperately needs to stay afloat. "The European Union is about to make a terrible mistake and they must be stopped — even if 26 of them want to do it, and we are the only ones against it," he said in comments released by his office Thursday. "This is a mistake, we are destroying the European Union."

The challenge comes at an especially dire time for Ukrainian President Volodymyr Zelenskyy, straight off a trip to Washington where his pleas for more aid from the

US Congress fell on deaf ears. "Ukraine will not stand without supports and ongoing support from both the European Union and the US," said İrish Prime Minister Leo Varadkar. Barring that, he added "well then, Putin will win." Lithuanian President Gitanas Nauseda said the decision on the financial aid had to be taken at the summit, "because Ukraine is not fighting tomorrow. Ukraine is fighting right now." The urgency to find a solution is matched only by the potential blow to the EÚ's credibility, Zelenskyy said

ers. "Nobody wants Europe to be seen as untrustworthy. Or as unable to take decisions it prepared itself," he said.

Referring to Putin, he added, "Don't give him this first - and only - victory of the year. Europe must win, agreements must be honoured."

"Whatever it takes" had been the relentless mantra of the EU in pledging its support, leaders dressed up in the yellow and sky-blue colours of Ukraine, and countless speeches ending with the rallying cry "Slava Ukraini!" — "Glory to

The EU, a group of 27 nations which still cherish their independence on strategic and foreign affairs issues, works by unanimity on most issues relating to Ukraine. Orban is seen by many as Putin's foot in the summit door, Putin's wrecking ball to demolish EU support for Zelenskyy. Even ahead of the summit, French President Emmanuel Macron and German Chancellor Olaf Scholz had already taken Orban aside in an attempt to make him change his mind.
"It is important that a clear

signal of support be sent here – a signal directed to the courageous citizens of Ukraine, who are defending their country, but a signal also directed to the Russian president," said German Chancellor Olaf

Orban said such negotiating tactics would not work with him. "We will not shift on this, no matter the offer. Hungarians are genetically insensitive to pressure," he said. He said at least three conditions had not yet been fulfilled by Ukraine. 'So there is no need to negotiate membership of Ukraine now." The next EU summit is slated in March. Orban has complained of corruption in Ukraine and has demanded a "strategic discussion" on the country's future in Europe as the war with Russia bogs down and concerns mount about what kind of administration might emerge in Washington after the US elections in a

Special court allows in-camera trial of Imran Khan, Qureshi

A special court in Pakistan on Thursday accepted the country's top investigative agency's plea seeking an incamera trial of jailed former prime minister Imran Khan and ex-foreign minister Shah Mahmood in the cipher case involving the alleged leaking of state secrets and violation of laws. The special court on Wednesday once again indicted Khan, 71, and Qureshi, 67, in the cipher case, which is based on the allegation that a secret diplomatic document sent by the Pakistan embassy in March last year was mishandled by them and they violated the laws of the country.

On Thursday, the Federal Investigation Agency (FIA) urged Special Court Judge Abual Hasnat Zulgar-nain to allow the trial to be held incamera, which he accepted, despite ruling last month that the proceedings would continue at the Adiala Jail but in an

After hearing arguments, the judge said the next hearing would be heard in-camera, which he adjourned until Friday. He further ruled that family members of the suspects would be allowed to attend the hearing. The FIA registered the cipher case on August 15 on the charges of violating the secret laws of the country. The FIA on September 30 filed the charge sheet against Khan and Qureshi who signed its copies. The FIA invoked in the charge sheet sections 5 and 9 of the Official Secrets Act which may lead to a death sentence, or two to 14 years' imprisonment if convicted. Khan and Qureshi were initially indicted in the case on October 23. Both had pleaded

The special court judge while hearing the case on December 4 had declared that fresh indictment was mandatory in the light of the Islamabad High Court judgment which declared all proceedings illegal after ruling against the jail trial on procedural grounds.

the special court started fresh proceedings. On Monday, the former premier challenged the process of his indictment in the cipher case in the Islamabad High Court, urging it to halt the proceedings till deciding on the petition. Speaking to the media after Thursday's hearing, Qureshi's daughter Mehrbano Qureshi asserted that an open trial was the "requirement of justice". However, the National

Accountability Bureau prosecutor Rizwan Abbasi said the FIA has filed a petition seeking an in-camera hearing of the case under section 14 (exclusion of public from proceedings) of the Secrets Act. "If this matter was not secret, then there would not have been an FIR. How can a secret matter be made public?' Abbasi asked.

Imran's lawyer held outside HC

Tailed former prime minister Imran Khan's lawyer and a leader from his Pakistan Tehreek-e-Insaf party was arrested on Thursday outside the Lahore High Court where he was attending the lawyers' strike against the Supreme Court's decision to allow military courts to try civilians allegedly involved in the May 9 violence.

Lawyer Sher Afzal Marwat, who is also the senior vice president of Khan's PTI, was arrested under a public order ordinance, Punjab police said. A heavy contingent of police, accompanied by plainclothes men, pounced on Marwat, dragged him from the road and bundled him into a nearby police van. "Marwat is also wanted in

Khyber case Pakhtunkhwa (KPK) province and he may be handed over to its police," they said. Pakistan's Supreme Court on Wednesday allowed the trial of civilians by the military courts, conditionally suspending its October 23 ruling in which it had ordered authorities to conduct the hearing of the cases of more than 100 supporters of Khan arrested for their alleged role in May 9 violence in ordinary courts. Earlier on October 23, a

five-member Supreme Court

bench had declared that trying civilians in military courts for their alleged role in attacks on army installations after the arrest of Khan on May 9 was ultra vires of the Constitution. Taliban sending women to jail to protect them from violence, says UN report

Islamabad (AP): Taliban officials are sending Afghan women to prison to protect them from gender-based violence, according to a UN report published on Thursday. Before the Taliban seized power in 2021, there were 23 state-sponsored women protection centers in Afghanistan where survivors of genderbased violence could seek refuge. Now there are none, the UN report said. Officials from the Taliban-led administration told the UN Assistance Mission in Afghanistan that there was no need for such shelters or that they were a Western concept.

The Taliban sends women to prison if they have no male relatives to stay with or if the male relatives are considered unsafe, the report said. Authorities have also asked male relatives for commitments or sworn statements that they will not harm a female relative, inviting local elders to witness the guarantee, it added. Women are sent to prison for their protection akin to how prisons have been used to accommodate drug addicts and homeless people in Kabul," the report

The Associated Press contacted Taliban-led ministries about where survivors of gender-based violence can seek help, what protection measures are in place, and the conviction rates for offenders, but nobody was available for comment. Women and girls have been increasingly confined to their homes since the Taliban takeover in 2021. They are barred from education beyond sixth grade, including university, public spaces like parks, and most jobs. They are required to take a male chaperone with them on journeys of more than 72 km (45 miles) and follow a dress code.

Pak extends deadline for Afghan refugees in transit to Western countries

Amidst mounting international pressure, Pakistan has extended the deadline for the repatriation of Afghan nationals without proper documents and waiting to relocate to Western countries till February 29. The development comes a week after US Special Representative for Afghanistan Thomas West visited Pakistan and met with Pakistan's caretaker Foreign Minister Jalil Abbas Jillani. "The decision to extend the deadline from December 31 to February 29. 2024, was taken to encourage Afghan nationals to obtain legal documents or finalise evacuation arrangements in a third country as soon as possible," the Dawn newspaper quoted the caretaker Information Minister Murtaza Solangi as saying. Wednesday extended the deadline for the repatriation of Afghan nationals who have been residing in the country without proper documentation, but waiting to relocate to Western countries under their respective resettlement plan. The forced expulsion of Afghans without documentation has drawn widespread criticism from human rights activists, UN officials, and others, who have asked Pakistan to reconsider the controversial policy. HK places arrest bounties on activists | PPP announces Bilawal Bhutto as PM abroad for breaching security law

Hong Kong (AP): Hong Kong police accused five activists based overseas on Thursday of breaching a harsh national security law imposed by Beijing and offered rewards of 1 million Hong Kong dollars (\$128,000) for information leading to each of their arrests.

The latest arrest warrants further intensified the Hong Kong government's crackdown on dissidents after anti-government protests in 2019.

Many leading pro-democracy activists were arrested, silenced, or forced into self-exile after the introduction of the security law in 2020, in a sign that freedoms promised to the former British colony when it returned to China in 1997 had been eroded drastically. But

both Beijing and Hong Kong

governments have hailed the security law for bringing back stability to the semiautonomous Chinese city. The arrest warrants were

issued for Johnny Fok and Tony Choi, who host a YouTube channel focusing on current affairs, and pro-democracy activists Simon Cheng, Hui Wing-ting and Joey Siu. Police refused to tell their whereabouts, but their social media profiles and earlier media reports indicated they had moved to the United States and Britain. In July, Hong Kong warned eight other activists who now live abroad that they would be pursued for life under bounties put on them. It was the first such use under the secu-

rity law, and the authorities'

announcement drew criticism

from Western governments. Steven Li, chief superintendent of the police national security department, said the authorities received some 500 pieces of information since the last round of bounties were announced. While some of the information was valuable to the police, no arrest of the eight had vet been made.

Li said the five activists newly added to their wanted list committed various offenses including colluding with foreign forces and incitement to secession. "They all betrayed their own country and betrayed Hong Kong," he said in the news conference. "After they fled overseas, they continued to engage in activities endangering national security."

Li said authorities will try

their best to cut the financial support to the wanted activists. Police arrested four other people Wednesday on suspicion of funding former pro-democracy lawmakers Nathan Law and Ted Hui — two of the eight activists targeted by the police in July — through an "online subscription and crowdfunding platform." The four were alleged to

have provided financial support to others committing secession. The amount involved ranged from 10,000 to 120,000 Hong Kong dollars (\$1280 to \$15,400). Cheng wrote on X, formerly known as Twitter, that he embraced the charges. "Being hunted by China (Hong Kong)'s secret police, under a one-million-dollar bounty, is a

lifelong honour," he wrote.

Zardari, 68, who had become the President of Pakistan after elections held in 2008, served in the post till 2013. Bilawal, 35, served as the Minister of Foreign Affairs from April 2022 to August 2023. Kundi also said that the elections "should not be delayed" beyond February 8 and that the PPP is "fully ready" for the elections.

Don't apply SC ruling in NOS case mechanically in all employee secondment cases: CBIC to officials

The CBIC has asked its field I offices not to mechanically apply the Supreme Court judge-ment in the Northern Operating System (NOS) case in relation to the secondment of employees. In an instruction to field formations, the Central Board of Indirect Taxes and Customs (CBIC) said secondment as a practice is not restricted to service tax and the issue of taxability on secondment shall arise in GST also

Secondment of employees refers to an agreement between an employer and employee, that requires the employee to work in another location or department for a specified period.

GST officials have recently issued notices to various multinational companies over secondment of employees following the Supreme Court judge-ment which held that the secondment of employees by overseas group company to NOS was a taxable service of 'manpower supply' and service tax was applicable on the same.

It is noted that secondment as a practice is not restricted to service tax and the issue of taxabil ity on secondment shall arise in GST also, the CBIC said.

A careful reading of the NOS judgment indicates that the

Supreme Court's emphasis is on a nuanced examination based on the unique characteristics of each specific arrangement, rather than relying on any singular test, the CBIC said. The CBIC said there may be

multiple types of arrangements in relation to secondment of employees of overseas group company in the Indian entity. In each arrangement, the tax implications may be different, depending on the specific nature of the contract and other terms and conditions attached to it. "Therefore, the decision of the Hon'ble Supreme Court in the NOS judgment should not be applied mechanically in all the cases. Investigation in each case requires a careful considera-

tion of its distinct factual matrix.

Wholesale price-based inflation rose at the fastest pace in eight months at 0.26 per cent in November mainly due to a sharp rise in food prices.

The WPI inflation was in the negative zone for the past seven months and was at (-) 0.52 per cent in October.

"Positive rate of inflation in November, 2023 is primarily due to increase in prices of food articles, minerals, machinery & equipment, computer, electronics & optical products, motor vehicles, other transport equipment and other manufacturing etc," the Commerce and Industry Ministry said in a statement

Food inflation rose to 8.18 per cent in November, from 2.53 per cent in October.

Official data released earlier this week showed retail or consumer price based inflation rising at its fastest pace in three months at 5.55 per cent in November, driven by spike in food prices.

The Reserve Bank in its bimonthly monetary policy last week, held interest rates steady and flagged risks of rising food inflation in November and

Average power purchase cost rises 71 paise/unit in FY22-23

verage power purchase cost Average power parse per Aincreased by 71 paise per unit during FY22-23 due to a rise in various overheads like transmission and distribution rates, Parliament was informed on Thursday.

On the rise in power cost due to increased use of imported coal, Union Power Minister RK Singh, in a written reply to the Lok Sabha, said, "Average power purchase cost increased by 71 paise only between FY22 and FY23. This is because of increase in various costs - including an increase in transmission and distribution costs"

The minister explained that with the rise in electricity demand from July 2021 onwards, the consumption of coal in thermal power plants increased.

The supply of domestic coal on a daily basis was less than consumption, which resulted in the depletion of coal stock and stocks at plants came down from 28.7 million tonnes (MT) as of June 30, 2021, to about 8.1 million tonnes (MT) as of September 30, 2021, he added. Therefore, in December 2021, the Ministry of Power advised state Gencos and IPPs (independent power producers) to import (coal) at the rate of four per cent of the total requirement and central Gencos at the rate of 10 per cent during 2022-23. During April-September 2022 (H1 of FY 2022-23), the receipt of domestic coal was about 355 385 MT (domestic -- 359 MT + imported: 1.4X18.9 MT) - a shortage of 30 million tonnes. The gap between the supply of domestic coal and consumption of coal was about 1.6 lakh tonnes/day during this period, he informed the House.

To improve the situation, the Ministry of Power advised Gencos on August 1, 2022, to make the decision regarding blending at their level, taking into account the domestic coal supply and stock position (need-based blending) with continuous monitoring of stock levels. The gap between daily coal consumption and daily arrival of domestic coal ranged between 2.65 lakh tonnes to 0.5 lakh tonnes between September 2022 and January 2023, he stated.

If the imports for blending had not been made, the coal stocks in thermal power plants would have reduced to zero in September 2022 and would have continued so, leading to widespread power cuts and blackouts, he noted.

Therefore, Singh stated that the Ministry of Power advised central, state Gencos and independent power producers (IPPs) on January 9, 2023, to import coal at the rate of 6 per cent by weight to have sufficient coal stocks at their power plants for smooth operations till September 2023.

The gap between daily coal consumption and daily arrival of domestic coal increased from 1.30 lakh tonnes per day to 2.80 lakh tonnes per day between he pointed out. Therefore, the Ministry of

Power advised central and state Gencos and IPPs on September 1, 2023, and October 25, 2023. to import coal through a transparent competitive procurement process for blending, he

In another reply to the House, he explained that the cost of generation of electricity is dependent on the share of imported coal used and the price of imported coal. The pricing of imported coal is

linked with international

indices, sources of origin, and other factors like ocean freight, insurance etc, which is purely dynamic and varies with international conditions, he noted. Also, imported coal has a high calorific value compared to domestic coal, he pointed out. The cost of fuel, including that of imported coal, is passed into generation tariff in accordance with regulations laid down by the appropriate Electricity Regulatory Commission, Singh

The generation cost becomes an input for the determination of retail consumer tariff, which is again approved by the respective regulatory commission before it is passed on to the consumers, he stated.

The regulator lays down norms for various input costs and does not allow costs in excess of the norms to be passed through, he

In another reply to the House, the minister said the power increasing rapidly because we have added 2.86 crore new consumers and because our economy is growing rapidly.

"The peak demand during the FY2013-14 was 1,35,000 MW. The peak demand during the current financial year (till November 2023) has increased to 2,43,000 MW," he informed

Ashneer Grover moves NCLT, alleges mismanagement,

BharatPe co-founder and former managing director Ashneer Grover has moved the National Company Law Tribunal (NCLT), alleging oppressive conduct and mismanagement by the board of the fintech firm.

In his petition, Grover has prayed for reinstating him as managing director of the company and declare as "illegal" changes in the management of the company by altering the board of Resilient Innovations Pvt Ltd, which is doing business as BharatPe. He has also requested NCLT to

order inspection and audit of the company by Ministry of Corporate Affairs and to revert any shares/ESOPs issued since his resignation on March 1, 2022. Grover has also sought revocation of termination of his wife Madhuri Jain by the board, terming it "illegal". He has also asked for removal of any new member inducted on the board after his exit.

Moreover, he has requested NCLT to direct winding up of the company in the "interest of justice" in the petition filed under Sections 241 and 242 of the Companies Act 2013, which deals with oppression and mismanagement.

Rupee recovers 7 paise to close at 83.33 against dollar as rate hike fear eases

The rupee recovered from all-time lows to close at 83.33 against the US dollar on Thursday, gaining 7 paise as the greenback weakened in the overseas markets following sig-nals that rate hikes by the US Federal Reserve were over.

A stellar rally in domestic equities fuelled by foreign fund inflows also boosted the rupee sentiment.

However, dollar buying by state-run banks and a rise in oil prices capped the rupee gains, forex traders said.

At the interbank foreign exchange market, the rupee opened strong at 83.30 against the last close of 83.40, the lowest closing level against the US dollar. The rupee moved in a tight range of 83.35 and 83.27 in the day trade. It finally closed at 83.33, up by 7 paise over the previous close.

The US dollar index, which measures the greenback's strength against a basket of six currencies, eased by 0.32 per cent to 102.54. The US Federal Reserve kept its key interest rate unchanged on Wednesday for a third time in a row.

ENGLAND FLOPS, SPAIN SURGES

AP LONDON

So much for the English taking over European soccer. The final Champions League group stage in its current for-mat ended with representation from the supposedly allpowerful Premier League cut in half as Manchester United and Newcastle United failed to advance to the knockout stage and were even knocked out of European competition alto-Instead, there was a Spanish

resurgence, a decent showing from the German contingent, and a couple of nice surprises making their way into the round of 16 in the form of Copenhagen and PSV Eindhoven This was the last year of the

32-team, eight-pool group stage, with the Union of European Football Associations pivoting next season to a single 36-team league that will see clubs play eight games - up from the cur-

The top eight teams will advance automatically to the round of 16 knockout bracket and Nos. 9 to 24 in the round to decide the other eight qualifiers.

So, what have we learned ahead of the round of 16 draw on Monday?

ENGLAND'S STRUGGLES There will be wry smiles around Europe as English teams received a bloody nose, just when the Premier League seemed to have unstoppable momentum on the back of wealth generated from huge broadcast deals. Only defending champion Manchester City and Arsenal got through, marking England's weakest round-of-16 challenge in 11 years. It's quite the slump for a country that has provided six of the last 10 finalists and three of the last five winners. Not helping England's cause was this being Newcastle's first participation in 20 years, with the Saudi-owned northeast team plunged into the toughest group - containing Borussia Dortmund, Paris Saint-Germain and AC Milan - and running into an injury crisis that hit a relatively shall low squad.



Oh, and there was a huge refereeing error that ultimately cost Newcastle dear. As for United, it was a chaotic campaign for a club in something of a maelstrom amid ownership wrangles and concerns over the quality of its manag-

SPAIN'S SURGE

Of the eight group winners -Bayern Munich, Arsenal, Real Madrid, Real Sociedad, Atletico Madrid, Dortmund, Man City and Barcelona - four are from Spain. While it was expected from Madrid, and potentially Barca and Atletico, too, given they were placed in weak groups, Sociedad's rise mostly homegrown team and coach is a welcome sight for romantics keen to see new names thrive.

In its first Champions League season in a decade, Sociedad was unbeaten and conceded just two goals. Barca is back in the big time, too, after failure to get out of the group stage in its first two post-Lionel Messi seasons.

Real, fueled by Jude Bellingham, was one of two teams - with Man City - to claim a maximum of 18 points while Atletico was unbeaten, too. Germany arguably performed the best of the rest with Bayern and Dortmund winning groups and Leipzig second behind City.
SURPRISE PACKAGES

PSV, the European champion in 1988 and runaway leader in the Eredivisie is in the knockout stage for the first time since 2016. Its only loss in 26 games this season was a 4-0 eating by Arsenal in their Champions League opener. Copenhagen's only previous appearance in the round of 16 was in 2011.

Defending an Olympic title is a great achievement and India's champion javelin thrower Neeraj Chopra needs to "stay calm" to achieve the feat in Paris next year, feels former 110m hurdles world record holder Welshman Colin Jackson. Chopra has been the face of

Indian athletics since the historic gold medal at the Tokyo Olympics. Since then, he has continued to add silverware, winning World Championships, Diamond League, while challenging the 90-metre barrier. His personal best stands at 89.94m. "He (Neeraj) is really focused



Soccer clubs in England, Saudi fuel record \$888 mn spend on agents fees in transfers

Soccer clubs in England and Saudi Arabia fueled spending on player agents in international transfer deals to a record USD 888 million this year, the International Federation of Association Football said on Thursday. FIFA noted "isolated cases of service fees even surpassing USD 10 million," though the soccer body lost a key court ruling in London last month which threatens its global regulations that seek to limit how much agents can be paid

from deals. Agents across Europe have brought legal cases against FIFA and national soccer federations to block the rules which were intended to take effect worldwide in October. The project is stalled in England, which FIFA's latest research showed still dominates the multi-billion dollar soccer player transfer market. FIFA said English clubs were "the number one spenders by a long shot" in 2023 with combined spending of more than



USD 280 million on agent commissions in transfers between two clubs in different countries. Money from player transfers between two clubs in the same country does not count in the FIFA numbers. The total spend on agents was up 42% in 2022 and more than one-third from the previous peak of USD 654 million in the pre-pandemic year of 2019.

Italian clubs spending USD 115.7 million was the only other collective national total in nine figures.

Saudi Arabian clubs spent USD 86 million on agents in a state-backed recruitment

program to boost its domestic league with hires such as Cristiano Ronaldo, Neymar and Karim Benzema. FIFA did not specify details of

individual transfers, though said in 224 cases the agent service fee was at least USD 1 million, and those deals accounted for nearly 69% of the total spend. In most deals, agents were paid fees of USD 10,000 to

USD 100,000, FIFA said. Clubs in North and Central America collectively spent USD 5.4 million across 20 transfers, and African clubs spent less than USD 200,000, FIFA said.

Dorussia Dortmund has Behavior the Champions League stage against Paris Saint-Germain, AC Milan and Newcastle. Now comes the tricky part - Augsburg away on a Saturday afternoon.

Süle was a standout performer against PSG, sliding at full stretch to keep out a Kylian Mbappe shot headed for goal. In the Bundesliga, though, the Dortmund defense has not gone



a full game without conceding a goal since Oct. 20.

In nearly two months since then, Dortmund has earned five points from six Bundesliga games, conceded 15 goals in total, and was knocked out of the German Cup by Stuttgart, too. So is Dortmund raising its game for the Champions League, underperforming in Germany, or both?

There have certainly been no easy games in recent weeks as Dortmund lost to Bayern Munich and Leipzig and drew with leader Bayer Leverkusen. Stuttgart is flying high in third place and far exceeding expectations, but Dortmund has still lost twice to a team it would normally be expected to beat. Dortmund heads to ninth-

FEMA violation: HC upholds reduction in penalty on Rajasthan Royals

The Bombay High Court has upheld an order passed by a tribunal reducing the penalty imposed on the owners of the Indian Premier League (IPL) cricket franchise Rajasthan Royals from Rs 98 crore to Rs 15 crore for alleged financial irregularities.

A division bench of Justices K R Shriram and Neela Gokhale in its judgement on Wednesday dismissed an appeal filed by the Enforcement Directorate (ED) challenging the July 11, 2019

order passed by the tribunal. The high court in its order noted the tribunal arrived at its conclusion based on evidence and analysis of the same. "The findings are far from being perverse. Thus, no question of law arises in the case. We find that in fact no justification has been recorded by the special director (ED) to impose maximum penalty as opposed to the tribunal having considered relevant material has interfered and reduced the penalty," the court



said in its order. "We find that the special director has completely failed to apply the doctrine of proportionality, while choosing to impose maximum penalty on the respondents (owners)," the HC said.

The bench said it was in agreement with the tribunal's finding and does not find anything perverse in its reasoning and conclusion. In 2013, the ED imposed a penalty of Rs 98.35 crores on

the owners of the franchise team after its preliminary probe revealed alleged irregularities under provisions of the Foreign Exchange Management Act (FEMA).

The Rajasthan Royals team owners filed an appeal against this before the appellate tribunal which held the ED's order as unreasonable and reduced the amount to Rs 15 crore.

The high court in its order noted the tribunal held that no loss was caused to the public exchequer and the remittances have come into India and remained in the country.

This is not a case where any foreign exchange has gone out of India. Also, the remittances were utilised for the purposes for which they were intended and there is not even an allegation of utilisation of the money for extraneous purposes," it said.

The HC further said the tribunal has also found no justification in the order passed by the ED's special director for imposing maximum penalty on the owners.

India defeat Nepal to clinch Women's Bilateral Series for Blind

Sushma Patel scored a breezy 37-ball 45 as India Odefeated Nepal by seven wickets to take an unassailable 3-1 lead in the five-match T20 Women's Bilateral Cricket Series for the Blind here on Thursday.

Sushma, who was adjudged 'Player of the Match' Ravanni, Basanti Hansda and Simu Das all scored as India chased down the target in the 19th over for the loss of three wickets. The last match of

the series will be played on Friday. India had won the first two T20s before Nepal came back in the third game on Wednesday.
