Death for mob lynching: Shah


The Centre on Wednesday passed a new Criminal Bill in the Lok Sabha, introducing provisions for the death penalty for those committing the crime of mob lynching. While announcing the punishment for mob lynching, Home Minister Amit Shah questioned the Congress previous governments, asking why they had not included mob

lynching in the laws during their 58 years of ruling the country. "You used the term mob lynching to criticise us (BJP),

but then you forgot about it once you came into power, the Home Minister said in his response to the members, including the Opposition, during the discussion on The Bharatiya Nyaya Sanhita. The Lok Sabha passed three

key Bills to overhaul the criminal justice system, with Home Minister Amit Shah asserting that the focus is on delivering speedy justice rather than merely handing down punishment.

initially The Bills were introduced during the Monsoon Session Parliament in August. After the standing committee on home affairs made several recommendations,

Lok Sabha during the ongoing Winter Session as they insisted on a statement from the Home Minister over the Parliament breach incident

Replying to the debate, Shah said the three Bills also have a clear definition of terrorism and scrap sedition as a crime while introducing a new section titled "offences against the State?

Members of Congress, DMK, TMC, and other Opposition parties were not present during the debate. While many Opposition parties have been critical of the Bills that seek to replace IPC, CrPC, and Evidence Act, only a handful of non-NDA including members, Hyderabad MP and AIMIM chief Asaduddin Owaisi, MPs of the Biju Janata Dal, and Bahujan Samaj, were present in the House.

"I am astonished at how some people defend and save the lives of terrorists in the name of 'human rights.' Remember, this is neither the rule of the Britishers nor of Congress. This is Modi's rule. No arguments to save terrorists will be entertained here," Shah said, adding that the Modi Government has explicitly brought 'terrorism' under the purview of the criminal justice system.

Will probe US Khalistani murder plot if evidence provided: Modi

Prime Minister Narendra Modi has said that India's commitment is to the rule of law, and if someone provides information, the government would look into it. These remarks mark his first comments on the US allegations relating to an Indian link over a foiled plot targeting Sikh separatist Gurpatwant Singh Pannu.

Making this assertion in an interview with *The Financial* Times, Prime Minister Modi also mentioned that ties between India and the US are robust, and there is strong bipartisan support for strengthening relations between the two nations. He further said that it is not appropriate to link a few incidents with diplomatic ties. Modi said, "If someone gives

us any information, we would definitely look into it." He also emphasised, "If a citizen of ours has done anything good or bad, we are ready to look into it. Our commitment is to the rule of law."

These observations from the Prime Minister come in the backdrop of US federal prosecutors charging that one Nikhil Gupta was working with an Indian government employee in the foiled plot to kill Sikh separatist Gurpatwant Singh Pannun, who holds dual citizenship of the US and Canada.

India has already constituted a probe committee to investigate the allegations.

In the interview, Modi expressed India was "deeply concerned about the activities of certain extremist groups based overseas.

He emphasised, "These elements, under the guise of freedom of expression, have engaged in intimidation and incited violence." At the same time, Modi

stated, "There is strong bipartisan support for the strengthening of this relationship, which is a clear indicator of a mature and stable partnership... Security and counterterrorism cooperation have been key components of our partnership," Modi stated.
"I don't think it is appropriate

to link a few incidents with diplomatic relations between the two countries," said the Prime Minister.

India-US ties have experienced significant progress in various areas, including defence, trade, investment,

critical technology, energy, and climate change. Modi emphasised, "We need to accept the fact that we are

living in the era of multilateralism. The world is interconnected and interdependent. This reality compels us to recognise that absolute agreement on all matters cannot be a prerequisite for collaboration. Both sides are currently work-

ing on an ambitious roadmap for Indo-US collaboration in seven specific high-technology areas, including semiconductors, next-generation telecommunication, artificial intelligence, and defense under the "Initiative on Critical and Emerging Technologies (iCET)". Modi visited Washington in

June, bringing new momentum to ties between the two sides. US President Joe Biden visited India in September for the G20 summit, during which he had extensive talks with Modi to further expand

Murmu, PM slam mimicry; 2 more MPs suspended

m huge}$ political row unfolded on Wednesday after Trinamool Congress 'leader mimicked Vice President of India Jagdeep Dhankhar during the $\bar{\text{O}}\textsc{pposition}\sc{is}$ protest on the stairs of Parliament on Tuesday against the suspension of MPs. This action drew strong condemnation from President Droupadi Murmu, Prime Minister Narendra Modi, and members of the ruling BJP.

As Dhankhar, who is also the Rajya Sabha Chairperson, declared that he would not tolerate any insult to Parliament or the post of Vice President, the TMC MP at the centre of the storm said that he did not intend to hurt anyone with his actions in the Parliament complex on Tuesday. In contrast, Jat Mahasangh volunteers held a protest march near the Congress headquarters against

the "mocking" of Dhankhar. Meanwhile, the Lok Sabha on Wednesday suspended two more Opposition MPs for displaying placards in the House. Thomas Chazhikadan of the Kerala Congress (Mani) and A M Ariff of the CPI(M) were suspended for misconduct after a resolution, moved by Parliamentary Affairs Minister Pralhad Joshi, was adopted by the House. This brings the total number of suspended MPs in the Lok Sabha to 97. So far, 143 Opposition MPs have



been suspended from the two Houses of Parliament.

West Bengal Chief Minister Mamata Banerjee backed her party MP, while the Congress criticised what it termed the government's "desperate attempt" to divert attention from the unprecedented suspension of over 140 MPs by raising the matter. Attacking Opposition parties

over the "mimicry" incident, BJP chief JP Nadda alleged their elected representatives were acting as "clowns" and took a swipe at Rahul Gandhi, suggesting he could apply for a job as a cameraman in the studio of BJP MP Ravi Kishan.

Murmu took to social media expressing her dismay at the manner in which the vice president was humiliated in the Parliament complex. "Elected representatives must be free to express themselves, but their expression should be within the norms of dignity and courtesy. That has been the parliamentary tradition we are proud of, and the people of India expect them to uphold it," Murmu said. Responding to the president's

the Rajya Sabha person thanked chairperson Murmu for her kind words and the timely reminder that basic courtesy must always remain. committed to unhal constitutional principles until my last breath. No constitutional insults can prevent me from doing so," Dh responded to Murmu. Dhankhar

'I received a telephone call from the Prime Minister. He expressed great concern over the abject theatrics of some Honourable MPs, and that too in the sacred Parliament complex on Tuesday," stated a social media post from the Vice President's secretariat. 'He (PM) told me that he

receiving end of such insults for twenty years and counting, but the fact that it could happen to a Constitutional office like the Vice President and that too in Parliament was unfortunate," Dhankhar was quoted as saying in the post. He also expressed his anguish in the House. Dhankhar said the act of mimicking him and its videography caused an "insult" to the honour of the post of the vice president, the farmers, and his community. Congress president and Rajya Sabha Leader of Opposition Mallikarjun Kharge took Ďhankhar offense at describing the mimicry as an

Kejriwal to skip ED questioning today, goes out for Vipassana

Aday after he attended the Opposition INDIA Chief Minister Arvind Kejriwal on Wednesday left for a 10-day Vipassana meditation retreat, and is likely to skip the ED summons sent to him.

Enforcement Directorate on Monday issued fresh summons to Kejirwal for questioning on December 21 in the excise policy-linked money laundering case. Kejriwal was first called by the ED to appear on November 2, but skipped the summons alleging that the notice was "vague, motivated and unsustainable in law".

Kejriwal was scheduled to leave for the Vipassana course on Tuesday but could not do so as he was busy with the INDIA bloc meeting, officials said. He left around 1.30 pm on Wednesday for the prescheduled meditation course, they added. The pre-scheduled Vipassana programme will continue until December 30.

According to sources, Kejriwal would remain in the camp in Anandgarh of Punjab's village Hoshiarpur district till December 30 and remain completely cut off from his political life.

tion for sewer death is increased (given that the previous amount fixed, that is, Rs 10 lakh - made applicable from 1993). The current equivalent of that amount is Rs 30 lakh. This shall be the amount to be paid by the concerned agencies," said an order from the Delhi Jal Board (DJB). "In the event, the dependents of any victim have not been paid such amount, the above amount shall be payable to them. Furthermore, this shall be the amount to be hereafter paid as compensation," the DJB added. The DJB further said the compensation will be disbursed in the case of sewer victims suffering disabilities, depending upon the severity of disabilities.

Delhi's Indira Gandhi International (IGI) Airport will get India's first inter-state multi-modal transport hub near Aerocity. A proposal has been floated to construct a hub near the GMR Aerocity at the Delhi airport, which will be the confluence point of an Interstate Bus Terminal (ISBT), the upcoming Phase 4 line of the Delhi Metro, the proposed Passenger Transport Center (PTC) and RRTS station, and a station for the Automated


Passenger Mover (APM) near

States should be on alert on Covid rise: Mandaviya

As the country reported the highest number of 614 new Covid cases since May 21 and three deaths in Kerala, Union Health Minister Mansukh Mandaviya has asked the States to be prepared and remain alert against new and emerging strains of Covid-19, especially ahead of the upcoming festivities.

The Minister also underlined the challenge posed by the rise in JN.1 cases in some countries such as China, Brazil, Germany and the United States and the recent one back home in Kerala. As many as 20 cases of Covid-19 sub-variant JN.1 have been found across the country with 18 traced in Goa and one each in Kerala and Maharashtra, INSACOG data

Meanwhile, the World Health Organisation said that it has classified JN.1 as a separate "variant of interest" given its rapidly increasing spread but said that it poses a "low" global public health risk. A rise in daily Covid positivi-

ty rate has been observed in a few states like Kerala. Maharashtra, Jharkhand and Karnataka, however the Minister said that there was no cause for panic. On the new JN.1 variant of SARS-CoV-2, the Minister said that the variant was under intense scientific scrutiny, but not a cause of immediate concern. No clustering of cases has been observed in India due to JN.1. Chairing the high-level review meeting with states, Mandaviya, however, reiterated that Covid was not over yet and requested the states to monitor emerging infections, symptoms and case severity to plan appropriate public health

He assured the states of all support from the Centre and stressed the need for collective efforts between the Centre and the states to deal with the emerging situation in the spirit of the "whole-of-government" approach.

Mamata meets Modi, demands release of funds by Centre

West Bengal Chief Minister Mamata Banerjee on Wednesday met Prime Minister Narendra Modi and demanded the release of pending Central funds to the State. The TMC supremo said the prime min-ister proposed that officials from the State and the Centre can sit together and clear the issues.

Speaking to the media after the meeting in the Parliament complex along with nine party MPs, Banerjee said 155 central teams have already visited West Bengal and the state government has given clarification on issues raised by the Centre. The Centre and the West Bengal government have been involved in a tug-of-war over the release of funds to the state, with the TMC even holding a protest led by its general secretary Abhishek Banerjee in the national capital in October. The BJP has accused the TMC government of siphoning off central funds meant for Pradhan Mantri Aawas Yojna and MGNREGA.



Talking about the pending MGNREGA funds for the state. Baneriee said it is mandatory under the Constitution to pay the workers. "We didn't even get a penny for 100 days of work (under MGNREGA) in the budget for 2022-23.

"Funds for Aawas Yojna have been stopped, rural development schemes have been shut, and the health mission programme has also been shut. We are also not getting funds under the Commission," Finance Banerjee alleged.

"Our officials have given all the clarification they asked for. PM has said a joint meeting will be held by the Centre and state officials. I said we have given clarification 155 times. We can do that once again, they can decide the formula. In a

federal structure, the central government has a share and the state also has a share," she said. "It is not right to stop the money for poor people, Banerjee said, adding that the Centre owed nearly Rs. 1.16 lakh crore to the state under various centrally sponsored schemes and pending claims for natural disasters over the

The pending dues include MGNREGA payment to the tune of nearly Rs 6911 crore -Rs 3732 crore against wage liability and Rs 3179 crore against non-wage liabilities; central share for 11,01,731 houses sanctioned under PM Awaas Yojana which has not been released; and fund under National Health Mission by the Union Ministry of Health and Family Welfare.



NDPP, BJP alliance returns to power

Nagaland sees women legislators for first time in 2023

The ruling NDPP-BJP alliance returned to power in Nagaland in this year's assembly polls, which also saw the election of two women candidates to the House for the first time in the northeastern State's history.

The state also saw the assembly unanimously passing the Municipal bill seeking to reserve 33 per cent of seats in urban local bodies (ULB) for women, paving the way for civic polls in the state after two

The People's Democratic Alliance (PDA) of the NDPP and the BJP won the Nagaland Assembly elections held on February 27 by winning 37 seats in the 60-member House, with Neiphiu Rio becoming the chief minister of the tribaldominated state for the fifth consecutive term, making him the longest-serving CM of the

The alliance bettered its performance from the previous election, when the regional party had won 18 seats while the saffron party had bagged 12 constituencies.

In this year's assembly polls, two women candidates --Hekhani Jakhalu and Salhoutuonuo Kruse of the ruling Nationalist Democratic Progressive Party (NDPP) were greenhorns but they defeated sitting MLAs in Western Angami and Dimapur-III seats respectively. The Republican Party of India (Athawale) and Lok Janshakti Party (Ram Vilas) opened their accounts in the Christian-dominated state by winning two constituencies and one seat respectively in the assembly

elections. All the political parties in the state, including seven NCP legislators and four Independent MLAs, extended unconditional support to the NDPP-BJP dispensation, making it an all-party government for the third time in the state. The solution to the decades-old Naga political issue, which every political party pronounces as its top priority before every election, went backstage as the state government was yet to form any political affairs committee (PAC) to facilitate negotiating

The Centre has been holding separate negotiations with NSCN-IM since 1997 and the

parties to conclude the peace



National Political Group (NNPG), comprising at least seven groups, since 2017 to conclude the peace talks.

Eight years have passed since the signing of the Framework Agreement on August 3, 2015 with the NSCN-IM and another six years have gone by following the signing of Agreed Position on November 17, 2017 with WC NNPGs.

With no significant development in the political negotiations between the Centre and the Naga groups, another year is coming to an end with no solution to the Naga political

The Nagaland Assembly on November 9 unanimously passed a bill seeking to reserve 33 per cent of seats in urban local bodies (ULB) for women, resolving a contentious issue and paving the way for municipal elections in the state after two decades.

The CM has said that the apex tribal bodies, which had earlier opposed such a reservation, accepted it and the State Election Commission (SEC) will soon announce the dates for municipal polls.

ULB elections in the northeastern state have been long overdue, with the last civic polls having been held in 2004. Since then, elections were not conducted first due to the unresolved Naga peace talks and then on the issue of 33 per cent reservation for women which the tribal bodies had opposed, asserting it infringes upon the special rights of Nagaland guaranteed under Article 371(A) of the

Constitution. The 10-day Hornbill Festival, the annual tourism promotional event of the state, saw an overall footfall of 1,54,057 visitors, an increase of 13,758 from the previous year.

The tally included 1,14,860 and 2,108 foreigners who witnessed the coming together of the 18 tribes of Nagaland at the

PDP favours prepoli alliance with National **Conference in J&K**

International tourist arrivals pick up in **Goa but far from prepandemic times**

The number of foreign tourist arrivals in Goa is picking up after a major drop due to COVID, but is yet to touch the pre-pandemic levels, according to official figures. For the first seven months of this calendar year, 2.81 lakh foreign tourists arrived in the coastal state, which is more compared to the figures for 2021 and 2022, when the sector was hit by the coronavirus outbreak and its aftermath. According to numbers provided in the Lok Sabha by the

Union tourism ministry, in response to a question by Goa MP Francisco Sardinha, the year 2021 saw 22,000 foreign and the number rose to 1.75

A senior official from the state tourism department said that

this year's footfall - 2.81 lakh foreign visitors - is much less compared to the pre-pandemic times. "But this is not the case only with Goa. Overall, there has been a drop in inter-

national travels," he said. The figures provided by the Sardinha also said that 9.34 lakh foreign tourists arrived in Goa in 2018, which increased to 9.37 lakh in 2019 but then nosedived due to COVID-19. Amid a drop in the foreign tourist arrivals compared to the pre-pandemic times in Goa, the tourism industry is banking on the new sectors to make up for the losses in the number of international arrivals, said and Tourism Association of

Telangana will have an out-standing debt of Rs 6,71,757 crore, including nonguaranteed loans of corporations or institutions by the end of FY 24 against Rs 72,658 crore in 2014, the state government said.

Telangana State Finances-White Paper was tabled by the government in the Legislative Assembly.

The debt servicing burden of monies which are borrowed on the budget and off-budget has increased enormously and is consuming 34 per cent of the state's revenue receipts while the salaries and pensions of employees consume another 35 per cent of the state revenue receipts, a State Government document said on Wednesday. "The total debt on the books

of the State, guaranteed and

serviced by the State, guaranteed but not serviced by the State, and not guaranteed and serviced by the institutions is Rs 6,71,757 crores, it said. Further, as per budget estimates for FY 2023-24, the debt under FRBM (Fiscal Responsibility and Budget Management Act, 2003) is estimated to increase to Rs

3,89,673 crore.

J&K Police raids 5 locations in Srinagar in investment fraud

The officials, however, said the amount might increase as the investigation is still in progress. Initially, the company made good on its promise which brought in more investors and the scheme was promoted by at least two local YouTubers adding to its popularity.

Soon after, the owners of the company disappeared, officials said, adding that they found the Karan Nagar office

locked. One of the YouTubers, Idris Mir, said he could not be held responsible for the fraud as he had featured the company on his channel as a paid promo-

Indian researchers team to visit Egypt

To study Red Sea coast and Nile River basin

 \mathbf{A}^{n} interdisciplinary team of eight researchers from the Kerala-based PAMA Institute for Advancement of Archaeological Sciences is embarking on a visit along Egypt's Red Sea coast and the Nile River with the aim of exploring the ancient maritime link between India and

The institute is located in Pattanam in Ernakulam district. In a statement, the institute said the primary objective is to explore the ancient maritime connections between India and Egypt during the Sangam Age (300 BCE - 300 CE) and prepare a ground for

future Indo-Egyptian studies. Historical records distinctly reveal early interactions between the Indian subcontinent and Egypt, notably dating back to the pharaonic era, which is prior to third century BCE, Nehal Singh, PAMA Research Officer, said in the statement. Evidence such as the utilisation of black pepper in Ramses II's mummification during the 12th century BCE illuminates this ancient connection, he noted. Around the first century BCE, the early coastal port network of the Red Sea and Indian Ocean witnessed a significant transformation. Ships originating from peninsular India managed to reach Red Sea ports like Berenike and Myos Hormos in just 40 days, the expert explained in the statement. Research carried out in Pattanam highlights the peak phase of Indo-Roman contact through Egypt, spanning from 100 BCE to 300 CE, it said.

A 64-year-old man died in the city due to COVID-19

The lure of lucre

IPL is no more about just cricket; mega bucks have turned it into a purely commercial venture

■ n our country where cricket is treated nothing less than religion, the Indian Premier League (IPL) auctions have always been a spectacle. This annual event, nowadays even televised live, draws awe, amazement and immense attention from cricket enthusiasts, team owners and players alike. In the latest edition of these auctions, the demand was for pace bowlers, with Australian sensation Mitchell Starc emerging as the most expensive buy at a staggering Rs24.75 crore. While such high pay packets are apt to make headlines, they also raise important questions about the balance between the commercial aspects and the essence of the sport. The mouthwatering price tag attached to players like Starc is indicative of the IPL's transformation into a lucrative business venture. The 'gentleman's game' is fast turning into an orgy of the moneyed elite where players are just pawns in the game. It is not very far from South Korean web series 'Squid Games' where a few rich people place bets



on poor players for enjoyment. Team owners are willing to shell out astronomical sums to secure marquee players, creating a bidding war that often borders on the extravagant. While this certainly adds an element of excitement to the auction, it also underscores how commercialisation has taken centre stage. Since inception, the IPL has been a money spinner, attracting sponsorships, broadcast deals and a massive fan following.

The league's format, blending cricketing entertainment with glitz and glamour, has turned it into a cash cow. While financial success is crucial for sustaining any sports league, there is growing concern that

the balance between sporting integrity and commercial interests is tilting in favour of the latter at IPL. As zeroes are added to cheques, there's a risk of cricket itself being relegated to the background. The primary purpose of IPL was to showcase top cricketing talent in a format that was both thrilling and entertaining. However, the shift of focus to the commercial spectacle rather than the game itself raises questions about the impact on the purity of the sport. The team game has turned into a showcase of individual overkill. The exorbitant amounts spent on stars hurt team dynamics. Teams may find themselves overly reliant on a few key players, diminishing the competitive balance that makes cricket such a riveting sport. The increasing influence of commercial interests is evident not only in player auctions but also in the league's overall structure. The tournament's scheduling, marketing strategies and even venue choices often prioritise financial gains over cricketing considerations. The IPL has become a brand, but that should not overshadow the essence of the sport it represents. Striking a balance between financial success and the sport's spirit is crucial for IPL's long-term sustainability and credibility. It is imperative to ensure that love for the game remains at the forefront of the IPL experience.

Old Pension Scheme: Should it be restored



Prime Minister Modi took a political risk in Assembly elections and did not promise the restoration of old pension scheme

t was a farsighted, extrapolative and prophetic vision of late prime minister, Atal Bihari Vajpayee who made a daring decision to replace the old pension scheme (OPS) with a market-driven and financially viable, national pension scheme (NPS) in 2003, which was not primarily dictated by short term benefits to present generation at the cost of future generations thereby protecting the states from an imminent fiscal distress and economic structural col-

Centre and RBI are opposed to


According to an article published in a Sept. bulletin of the Reserve Bank of India, it was made crystal clear that states reverting to OPS may face unsustainable fiscal stress. The cumulative effect of OPDS could be 4.5 times higher than NPS with an additional burden of 0.9% of GDP annually by 2060. The authors have highlighted that while OPS may be more attractive to employees, it puts a significant financial burden on the government, unlike NPS, which aims to ensure good pensions while reducing the budgetary burden. As per research conducted 23 years back, India's implied pension debt of centres and states coupled with the funding gap of the pension scheme was bound to reach unmanageable and unsustainable levels which may spell doom for the growing economy of the country in future. OPS may lead to economic dis-

tress in future.

As per projection, states opting for OPS may land in serious economic distress and the burden will keep on multiplying every year especially when the burden will be exceeding lakhs of crore after ten years. BJP leadership could resist the pressure of its state leaders to counter the Cong party's poll promise of OPS though the risk of losing the elections due to employees' annoyance loomed large before polls.

Prominent economists are vehemently opposed to OPS as it will have a cascading effect on the health of the economy in future.

ments have implemented OPS though they are having debt liabilities of Rs 2.63 crore and Rs 90,000 crore respectively. OPS will put an additional burden of thousands of crores on state exchequer.

As per data, pension liabilities of the states account for 2.1% of the total expenditures and it rose by 8.9 % which is expected to grow unhindered in future. It is likely to go up to 7.98 % by 2040 because it has already witnessed an increase of 15.90% from 2014 to 2019. The old pension scheme (OPS) acted as a 'saviour' to ensure the victory of the Cong in Himachal Pradesh in 2022 and contributed substantially to Karnataka assembly polls but it miserably failed to save the Grand Old Party from a humiliating defeat in state elections including Chhattisgarh and Rajasthan which had already implemented the scheme.

Economists opine that the insignificant impact of support of employees to help beleaguered Congress in three states may act as a blessing in disguise for the economy in the

states as well as the country because OPS has got potential to destroy the economic structure in states thereby affecting the the the country's ambition to emerge as a big economic power in the world. Employees prefer OPS as it guarantees a lifelong pension which is fifty per cent of the last drawn salary. On the other hand, NPS generates marketlinked returns without any guarantee. The returns are taxable whereas OPS is free from any type of tax. Having 531.71 lakh subscribers, NPS assets were 7.36 trillion as of March 31, 2022, as against 5.78 trillion in 2021. Congress failed to retain power in Rajasthan and Chhattisgarh which had implemented OPS one year before polls and made a promise to revert to the old scheme in MP also. Given the disastrous fallout of OPS, BJP may opt for via media thereby making some improvement in NPS and the process may be accelerated in the coming days.

TELECOMMUNICATION BILL

Sir — The Telecommunications Bill, 2023, introduced in the Lok Sabha on Monday, proposes the first comprehensive rewrite of telecommunications law in 138 years, consolidating spectrum rules, right of way, dispute resolution between service providers and the Department of Telecommunications or local governments, and other aspects of telecom regulation into one fresh statute. FRUITS OF OUR KARMA ARE UNAVOIDABLE

Keep Faith and the quality of life will be good, pain will not overwhelm you

hat is 'karmaphala?' It is the fruit of all acts done by us through our bodies, minds and words. Every act of ours, done by either of these three, is recorded for future rewards and punishments. As a matter of fact, the creation is based on the 'Karmaphala Principle'. Even God, who is all-powerful, does not interfere in its onset, though He can. This will amount to giving liberation (moksha), which is awarded only upon leaving the present body.

Why does He not? There are many logical reasons. The creation cannot exist unless there are set rules for its functioning. The karmaphala principle is the bedrock upon which it is founded. Dharma requires that there must be justice regarding the results one gets. That is the reason why good people run into bad times, because of their earlier bad acts. What they are doing now will bring good results in future. Similarly, bad people have good times also, because their earlier good acts have come to fruition. They will be punished in future for their present acts. There had to be a deterrent, otherwise how many of us, would toe the line? Even devotees of God are not spared. Citing a famous example, King Dasharatha – the father of Lord Rama suffered separation from his favourite son, which caused his death. He had been cursed to die in this fashion. Lord Rama did not prevent it, which He could have. Before I continue with this topic, let me clarify about the matter of 'shapa' (curse). All those who suffer on account of shape given are destined due to their earlier bad acts; the person giving shape just acts as a medium. This is similar to 'siddha \purush' (the perfected ones) blessing someone, and the recipient gaining something desirable. The law is clear: "We reap what we sow". Curses, which are not destined, do not affect. Aren't many



curses thrown around indiscriminately by bitter people? Then, how does God help His devotees, who have qualified for special treatment due to their devotion? Some famous examples will help. Meerabai was given poison to drink as her punishment for worshipping Lord Krishna. Her Lord made the poison harmless, and Meerabai continued to be healthy. The examples cited above should inspire us to get started; this journey is long and hard; and it involves doing many spiritual practices. That is how you develop God's consciousness.

It is wise to get started, because without God's protection anything can happen, as destined, due to previous bad karma. We are in fact sitting ducks. This is the reason we must take shelter from God, earlier the better. Then, what will happen? Troubles will certainly come because this is the material world, which is an impermanent place of miseries. (8.15) And one will get out of them, as God will intervene and help. The reality is this for devotees of God: "Troubles will certainly come, and we will certainly get out also."

However, it is difficult to have this faith even for devotees, who are just getting started on the spiritual journey. They begin to feel that no troubles should come to them, because they have taken God's shelter. But this is not how the system works. It is unlike our relationships with our parents, who do their level best to try to prevent troubles coming to us. Unfortunately, they are in the ultimate sense helpless, and troubles come, and we suffer. In the case of God, troubles do come, as destined, but God bails us out. How does it matter if troubles come, if we are assured that we will safely negotiate them? Faith should not be allowed to be shaken. If one has become a devotee, life will go on in this birth and the next and so on till one is liberated after many births. (6.45)

Therefore, take shelter from God actively. Do whatever is appropriate. Troubles will come and God will take care of them. Pain will be there, but it will be tolerable. Faith must be kept, and quality of life will be good, as different from the lives of non-devotees, who are likely to be derailed at any time. That way it is a nasty place, this material world.

Unlock the potential of manufacturing sector

he remarkable boost in India's growth projections, majorly driven by its manufacturing sector, surging at an impressive 10.4 per cent growth in October has turned its turbulent road into fueling optimism and prospects. Despite the headwinds, India stood its ground, which was later reflected in the manufacturing sector's performance and has been identified as a crucial driver of economic growth.

ing \$453 billion in 2022 from \$9.1 billion in 1985. In comparison, China's goods exports have grown more than 131 times from \$27 billion in 1985 to \$3500 billion in

China's merchandise exports surged because it adopted an export-oriented approach, specialising in industries with higher export potential. It tried to benefit from economies of scale and focussed on SEZs and other traderelated infrastructures like ports, logistics and effective single-window clearing systems. China adopted a long-term strategy of skilling its labour force which made technology absorption much easier and allowed it to move up in the global value chain, leaving low-end products to low-wage Indonesia. India could not achieve the desired level of skilling, leadthe desired level of skilling, leadasset for the economy, as it has the ing to export inefficiency.

India's weak infrastructure continues to be a fatal flaw for the manufacturing sector. Our country uses only 3% of its GDP for infrastructure construction each year, as compared to China's 20% of its GDP. Even today, India's surface transportation systems simply cannot meet the expectations of modern high-speed logistics – the backbone of efficient manufactur-

The manufacturing sector in India needs to prioritize technology-driven approaches to achieve growth and prosperity. This includes affordable digitization and automation, homegrown technology, sustainability, innovation and emerging manufacturing technologies, and adopting sustainable practices. Automation is crucial for

success in this sector, but its adoption in India remains low and requires immediate attention. A holistic approach that considers product, process, and sustainability is essential.

Micro, small, and medium enterprises (MSMEs) account for 36 per cent of India's total manufacturing output. However, MSMEs face several challenges, including limited market reach, lack of access to finance, and inadequate technology. To enhance the efficiency and cost-effectiveness of logistic processes, efforts should be directed towards streamlining them. Improving energy efficiency will also be critical for the growth of MSMEs. Priority financing and guidance are required to help MSMEs grow their business in the

potential to bring in investments and scale up manufacturing. A collaborative model that incentivizes the industry and supports stakeholders along the value chains is essential for building a resilient manufacturing sector. The focus should be on supporting fragile stakeholders, starting with suppliers, to achieve a shared vision. India's manufacturing industry requires a significant investment in infrastructure, including transportation systems, power and water supply networks, and high-

speed internet access. India has a wealth of talent in science and technology, and fostering innovation will be key to building a strong manufacturing sector. The government can support this by providing funding and incentives for research and development. To

achieve the goal of becoming a developed country by 2047, India needs to modernize its regulatory system and business laws. Simplifying regulations and reducing bureaucratic red tape can attract more investments, as India's regulatory environment can be complex for manufacturers to

operate efficiently. India has great potential in the manufacturing sector, which can make it an industrial superpower. To achieve this goal, all industry stakeholders need to work hard and strive for competency and competitiveness. The disqualification of the 77-year-old former president on Tuesday was based on the Constitution's Amendment, which says officials who take an oath to support the US Constitution are banned from future office if

they "engaged in insurrection."
The 4-3 ruling by the seven-member Colorado Supreme Court does not apply outside of the state.

Trump is currently the front-runner in the Republican Party's nomination process for the race for the White House in 2024. Trump's campaign has vowed to appeal against the "flawed" ruling by the Supreme Court of Colorado in the US

The Colorado Supreme Court upheld a trial judge's decision that Trump engaged in the January 6, 2021, insurrection and also overturned her conclusion that the ban does not apply to the presidency.

The landmark decision

from the divided top state court marks the first time a court has found Trump ineligible to return to the White House due to his conduct surrounding the January 6, 2021, attack on the US Capitol, CBS News reported.

Never before has a court determined that a presidential candidate is disqualified under the Civil War-era provision clause, it said. The state high court stayed its ruling until January 4 — a day before the deadline for the state secretary to certify the candidates for Colorado's March 5 primary

"President Trump's direct and express efforts, over several months, exhorting his supporters to march to the Capitol to prevent what he falsely char-

Sunak celebrates 'good news' of falling inflation

 $B^{\rm ritish\ Prime\ Minister\ Rishi}_{\rm Sunak\ on\ Wednesday\ wel-}$ comed the "good news" of falling prices ahead of the Christmas holiday period as official statistics revealed that inflation had dropped to 3.9 per cent, hitting the lowest level for the economy over two years. It comes as some muchneeded festive cheer for the British Indian leader who had made halving inflation one of his top priorities at the start of the year, when it was hovering around the 11 per cent mark.

According to the Office for National Statistics (ONS), inflation - or the rate at which prices are rising in the UK economy - dropped from 4.6 per cent last month and is now under double the 2 per cent target aimed for by policymakers at the Bank of England. "



A year ago inflation was at .1 per cent. Today, it's down 3.9 per cent. This is good news for everyone in this country," said Sunak in a social media post.

The ONS said that falling petrol prices and slowing prices for food and household goods were largely behind the drop in inflation. However, experts point out that many households will not feel better off any time soon as energy bills and borrowing costs remain high. "Inflation has more than

halved, from over 11 per cent to 3.9 per cent – so we can see the plan is working," said UK Chancellor Jeremy Hunt.

With inflationary pressures easing, alongside the major business tax cuts I announced in the autumn statement, we are back on the path to healthy sustainable growth...Once you do the hard work to squeeze inflation out of the system, you can start looking forward to the kind of growth that will see people's wages go up," he said

It is being dubbed as an early Christmas present for the Sunak-led government which is lagging behind most of its other targets set for the year, such as stopping the boats of illegal migrants crossing the English Channel and cutting long waiting lists for medical procedures on the state-funded National Health Service

At the same time, the US has been concerned that Israel will launch a similar military operation along its northern border with Lebanon to expel Hezbollah militants there, potentially opening a second front and widening the war.

Death toll mounts to 134 in China's quake-hit areas

China has stepped up rescue and relief work in the earthquake-hit areas of Gansu and Qinghai provinces in the country's northwest where the death toll on Wednesday climbed to 134 with over 980 injured. Amidst the biting cold, rescuers were making frantic efforts to pull those who were still stuck under the rubble of collapsed structures. Monday's 6.2-magnitude earthquake killed 113 people and injured 782 others in Gansu Province, officials told media in Jishishan county, which witnessed widespread destruc-

The earthquake, the worst in nine years, also has claimed 18 lives in neighbouring Qinghai Province, with 16 people still missing, local authorities said. A total of 14,939 homes had collapsed and 2,07,204 homes were damaged, affecting 1,45,736 people from 37,162 households in

"Let's not underestimate the risk if we had not reached such a deal," she told reporters. "This means, hopefully, that member states will feel less inclined to reintroduce internal borders because the influx is being managed."

'Al image-generators being trained on explicit photos of children'

 H^{idden} inside the foundation of popular artificial intelligence image-generators are thousands of images of child sexual abuse, according to a new report that urges companies to take action to address a harmful flaw in the technology they built. Those same images have made it easier for AI systems to produce realistic and explicit imagery of fake children as well as transform social media photos of fully clothed real teens into nudes, much to the alarm of schools and law enforcement around the world.

Until recently, anti-abuse researchers thought the only way that some unchecked AI tools produced abusive imagery of children was by essentially combining what they've learned from two sep-

adult pornography and benign photos of kids.

But the Stanford Internet Observatory found more than 3,200 images of suspected child sexual abuse in the giant AI database LAION, an index of online images and captions that's been used to train leading AI image-makers such as Stable Diffusion.

The watchdog group based at Stanford University worked with the Canadian Centre for Child Protection and other anti-abuse charities to identify the illegal material and report the original photo links to law enforce-

The response was immediate. On the eve of the Wednesday release of the Stanford Internet Observatory's report, LAION told The Associated Press it

LAION, which stands for

the nonprofit Large-scale Artificial Intelligence Open Network, said in a statement that it "has a zero tolerance policy for illegal content and in an abundance of caution, we have taken down the LAION datasets to ensure they are safe before republishing them".

While the images account for just a fraction of LAION's index of some 5.8 billion images, the Stanford group says it is likely influencing the ability of AI tools to generate harmful outputs and reinforcing the prior abuse of real victims who appear multiple times.



UK's top court: Al systems can't be named as inventor of patents

 $A^{\rm n}$ artificial intelligence system can't be registered as the inventor of a patent, Britain's Supreme Court ruled Wednesday in a decision that denies machines the same status as humans. The UK's highest court concluded that "an inventor must be a person" to apply for patents under the current law. The decision was the culmination of American technologist Stephen Thaler's long-running British legal battle to get his AI, dubbed DABUS, listed as the inventor of two patents.

Thaler claims DABUS autonomously created a food and drink container and a light beacon and that he's entitled to rights over its inventions. Tribunals in the US and the European Union

Don't pay taxes: Oppn **BNP** urges citizens

Calls for civil disobedience against govt

 $B_{\text{tion BNP on Wednesday}}^{\text{angladesh's main opposition}}$ called for a "non-cooperation" movement against the Awami League-led government, urging people not to pay taxes and utility bills, as Prime Minister Sheikh Hasina launched her poll campaign amid political unrest ahead of the January 7 elections.

Bangladesh Nationalist Party (BNP) and its mostly farright allies allege that no election under the incumbent dispensation would be fair and demand the restoration of a non-party interim government for election oversight by amending the country's Constitution.

"There is no alternative to the launch of non-cooperation of all sorts to establish the rights of every citizen," BNP spokesman Ruhul Kabir Rizvi told a virtual press conference.

He urged people to start the civil disobedience from Wednesday itself by suspending payment of taxes, and water, gas and electricity bills as part of the movement.

"We urge the countrymen to stick to the demands and boycott the farcical vote," Rizvi said, adding that he is appealing on behalf of the BNP's ailing chairperson and former premier Khaleda Zia's son Tarique Rahman, who now lives in London. Rahman is BNP's acting president.

Several Bangladeshi courts declared Rahman a "fugitive" as he took refuge in the UK to evade jail terms for several criminal charges, including a grenade attack on a rally of the then-opposition Awami League in 2004 in which 24 people Hasina narrowly escaped

the attack, which also wounded some 500 of her party leaders, activists and supporters. Zia, 79, was also

convicted and jailed on two graft charges with a 17-year jail term. However, she is now in a hospital with multiple health

Putin ratchets up military pressure on Ukraine

 $A^{\text{fter blunting Ukraine's}}_{\text{counteroffensive from the}}$ summer, Russia is building up its resources for a new stage of the war over the winter, which could involve trying to extend its gains in the east and deal significant blows to the country's vital infrastructure. Russian President Vladimir Putin seems to be hoping that relentless military pressure, com-bined with changing Western political dynamics and a global focus on the Israeli-Hamas war, will drain support for Ukraine in the nearly 2-yearold war and force Kyiv to yield to Moscow's demands. "As far as the Russian lead-

ership is concerned, the confrontation with the West has reached a turning point: The Ukrainian counteroffensive has failed, Russia is more confident than ever, and the cracks in Western solidarity are spreading," said Tatiana Stanovaya, senior fellow with Carnegie Russia Eurasia Center, in a



An aid package for Ukraine has stalled in the US Congress as Republicans insist on linking any more money to US-Mexico border security changes opposed by Democrats. The European Union last week failed to agree on a USD 54 billion package in financial help that Ukraine desperately needs.

Amid these signs of fraying Western support, Russia has ramped up its pressure on Ukrainian forces on several parts of the more than 1,000kilometre front line.

"The Russian military since October has been trying to

seize initiative across the front in a couple of areas," said Michael Kofman, a military expert with the Carnegie Endowment.

Ukraine has built multiple defenses in Avdiivka, complete with concrete fortifications and a web of underground tunnels, allowing them to repel fierce Russian attacks.

Despite massive losses, Russian troops have inched forward steadily, seeking to envelop Avdiivka and cut Ukrainian supply lines.
That battle has evolved

into a gruesome grind for both parties and has been compared to the fighting for Bakhmut, the war's longest and bloodiest battle that ended with Russia capturing it in May.

Myanmar ethnic N Korea, Russia clash with US, S Korea armed group seizes another

Covid infections going down in Singapore

Singapore (PTI): The number of COVID-19 infections in Singapore appear to have plateaued over the past week, but experts have urged people to be cautious and mask up in crowded enclosed places as a precaution. Last week, Singapore's Ministry of Health (MOH) reported a 75 per cent jump with 56,043 cases, compared with 32,035 cases in the previous week. The seven-day moving average of the infection was 7,870 on December 12 and decreased slightly to 7,730 on December 17, The Straits Times newspaper reported.

Experts have urged people to be socially responsible and mask up in crowded, enclosed places, even if they feel well, since the transmission of the virus occurs a day or two before symptoms appear.

"It'll be a bell curve confounded by Christmas parties," Professor Dale Fisher, a senior infectious diseases consultant at the National University Hospital (NUH), said. "You don't know if it's peaked until after it's peaked," he was quoted as saying by the newspaper on Tuesday

While the numbers remain high, experts say it is not a cause for concern, even though serious illness and deaths tend to lag infection figures. In the week of December 3, a total of 9,763 people were hospitalised, and 23 were admitted to intensive care units (ICU). The health ministry is pro-

viding daily updates of the COVID-19 infection figures from December 19 "to provide the latest information on the situation during this period of surge in cases". Professor Paul Tambyah of the NUH, president of the International Society for Infectious Diseases, said people do not need to worry about rising COVID-19 infections. Instead, they should "just be sensible about taking precautions about their health, not go to work or school if they are unwell and seek medical attention instead," Tambyah said.

Christians raise outcry over detention of another 'house church' elder

Bangkok (AP): Ding Zhongfu was awakened by loud pounding on his door. Five policemen greeted Ding, an elder in a Chinese church. The officers pinned him to the wall that Thursday morning in November and interrogated him while searching the apartment he shared with his wife, Ge Yunxia, and their 6-year old

Ding's family now pleads for his release after he was taken from his home in China's central Anhui province on suspicion of fraud. In their first public comments on the case, the family denies that Ding committed any fraud. Instead, they told The Associated Press in an interview, it is part of a wider crackdown on religious freedoms in China.

Four others were detained. all senior members of the Ganquan church, a name that means "Sweet Spring", according to the family. All were taken on suspicion of fraud, according to a bulletin from the church. "Under the fabricated charge of fraud, many Christians faced harsh persecution," said Bob Fu, the founder of a US-based Christian rights group, ChinaAid, who is advocating for Ding's release.

Benchmark equity indices Sensex and Nifty went into a tailspin after hitting their fresh all-time high levels on Wednesday, closing down by over 1 per cent as investors cashed in on the recent rally. Erasing all its early gains, the 30-share BSE Sensex crashed 930.88 points or 1.30 per cent to settle at 70,506.31.

The index opened higher and later gained 475.88 points or 0.66 per cent to hit its all-time high of 71,913.07. However, across the board selling dragged the barometer down from record highs and it dropped to a low of 70,302.60. The Nifty fell by 302.95 points

or 1.41 per cent to 21,150.15. During the day, it climbed 139.9 points or 0.65 per cent to reach its record high of 21,593.

Italy's athletics team had a breakout performance in Tokyo, winning five gold medals including a surprise victory for Marcell Jacobs in the 100 meters.

He said in a Golf Digest interview he wants to clean up his image from "serious mistakes." Without confirming Cabrera was ever suspended - the PGA Tour does not publicize conduct violations - a tour spokesman confirmed the 54year-old Argentine is eligible to

Cabrera, who won the US Open at Oakmont in 2007 and the Masters in a playoff in 2009, was imprisoned for two years for threats and harass-ment of Cecilia Torres Mana, his partner of two years. Her case was joined by that of another former partner, Micaela Escudero.

In a lengthy interview with Golf Digest published in the December-January edition, Cabrera said he was embarrassed by his behaviour and said, "I made serious mis-

"I refused to listen to anyone and did what I wanted, how I wanted and when I wanted," Cabrera said.

"That was wrong. I ask Micaela for forgiveness. I ask Celia for forgiveness. They had the bad luck of being with me when I was at my worst. I wasn't the devil, but I did bad things.



"I am deeply embarrassed because I disappointed the people closest to me - and everyone who loves me

through golf," he said. "Golf gave me everything, and I know I will never be able to repay the debt I owe this

sport."
Golf Digest said Cabrera was undergoing treatment for alcohol addiction, including taking daily medication that causes sickness if he drinks. His longtime coach, Charlie Epps, said Cabrera was taking alcohol education courses for six hours

In the interview, the 54-yearold Cabrera said he was trying to complete classes to graduate the sixth grade and had two months left when he was

released on parole. Epps said he asked Ping if it could supply Cabrera with a new set of golf clubs, which the coach took down to Argentina upon the release

is no doubt about that. Someone who can bowl with the new ball, howl in the death overs and more importantly, someone who can lead the attack," Gambhir, who was present at the auction,

"He is going to be of massive help to our two domestic bowlers because both of them are very talented and you need someone to help them out in the middle and Starc covers those

"It is not only about his bowling but also about leading the attack and helping all guys around him. So, somebody will have to pay for it," the former India opener told Jio Cinema.

Gambhir, who captained KKR to two IPL titles, said for him having a strong bowling line-up takes precedence over a strong batting line-up

"We have a lot of depth in our bowling line-up. We always wanted to have a stronger bowling attack and now we have the options with Mujeeb (Ur Rahman), Gus (Atkinson), Sunil (Narine), Varun (Chakravarthy), and Mitchell Starc along with two Indian seamers (Harshit Rana and Suyash Sharma) and Chetan Sakariya.

"Now, we have enough options where we can play different combinations looking at the venue as well. For me, it has always been about having a strong bowling line-up compared to a very strong batting line-up," said the BJP Member of Parliament.

Asked about his coming back to the franchise he had led to titles in 2012 and 2014, Gambhir said, "For me, KKR is not a team, it is an emotion. The reason is the amount of love that I have received from the people of Kolkata for seven years that I led them and, hopefully, I led them with a lot of honesty.

"Hopefully, we can recreate the same memories that we did in 2012 and 2014. There is no guarantee that we will go out and win but there is one guarantee for sure, that we will fight till the last drop of our blood.

India captain Harmanpreet Kaur wants the hosts to play with the same energy and intensity which they displayed against England, when they take the field in the one-off women's Test versus Australia starting here on Thursday.

India thrashed England by a record 347-run margin in the lone Test at the DY Patil Stadium to record the biggest win for any side in terms of runs and will now look to register their maiden Test win over Australia. India have never beaten

Australia in 10 Tests and the contest will definitely challenge them in terms of fitness and playing back-to-back matches. The way we played the first Test (of the season), we want to carry the same energy into this one. It is very exciting, knowing Australia is such a good team and everyone wants to beat them," Kaur told reporters after India's training session on Wednesday.

Australia will be without Meg Lanning who has retired from international cricket recently, and in her place Alyssa Healy will lead the side.

Kaur said Lanning's absence will not make much difference as Australia have a strong side. "They have a balanced side and

everyone has experience of all formats. We can't say Meg (Lanning) is not there and take them lightly. We just need to think what best we can do rather than thinking all and to rather than thinking all and to return the state of th rather than thinking about how good they are," she said. The India skipper said while the

prospect of playing Test cricket excites her side, it has been slightly challenging to manage the players' workload.

"When you are playing back-to-back Tests, it is important to recover and feel fresh. When you bat and bowl for three days - the likes of Deepti (Sharma), Pooja (Vastrakar) who didn't get enough rest - we try to take care of their loads," Kaur said.

"They need to feel ready for the accordingly. The ones who had lesser loads we pushed them hard in the nets to feel more con-

'The more we feel fresh, the better it will be for us, because there is hardly (any) time to prepare. If there was a 10-12 day (break), you can take 2-3 days off and again prepare yourself. We were lucky we had fourth day off (against England) and then just one day off. We tried to recov-
