Unprecedented Parliament Winter Session

Crucial Bills passed without 146 suspended MPs

 $P_{\text{sine}}^{\text{arliament}}$ was adjourned sine die on Thursday, a day before its scheduled time. after the Lok Sabha and the Rajya Sabha passed the pending crucial Bills in the complete absence Opposition benches from both Houses, making it unprecedented. While the Lok Sabha was adjourned after the passage of important including election appointment of commissioners and the Press registration process, the Rajya Sabha passed important legislations on three criminal Bills and the Telecom Bill.

The last time such a large number of MPs were suspended was under the late Prime Minister Rajiv Gandhi on March 15, 1989, by then Lok Sabha Speaker Balram Jakhar. A total of 63 MPs from the Opposition benches were suspended for the remainder of the week, which was three days during the Budget session. The suspended MPs included VP Singh, Somnath Chatterjee, VC Shukla, Indrajit Gupta, S Jaipal Reddy during the 8th Lok Sabha, sources said.

key Bills to replace the Indian Penal Code (IPC), Code of Criminal Procedure (CrPC), and the Indian Evidence Act on Wednesday, followed by the same in the Rajya Sabha on Thursday. During his reply in the Upper House after the Bill was moved by him, Home Minister Amit Shah said over 70,000 people were killed due to terrorism on account of Congress government's wrong

policies. "We had been deliberating and discussing on this since August 2019. I feel joyous to be presenting this today. Not just the names of laws have been changed, but major changes have been made in their objectives. Indian Penal Code, Criminal Procedure Code, and Evidence Act were

formulated to safeguard the British rule," Minister said.

The Lower House also cleared a bill to establish a mechanism appointment of the chief election commissioner and election commissioners. With the passage of the Bill in the Rajya Sabha on Thursday, the Parliament approved the Bill that seeks to allow the government to temporarily take control of telecom services in the interest of national security and also provide a non-auction route for the allocation of satellite

spectrum. Telecommunications 2023, was approved by the Rajya Sabha through a voice vote. It was passed by the Lok Sabha on Wednesday after a short debate in the absence of Opposition MPs.

Anurag bats for journalists

On Thursday, the Centre passed a historic Bill in support of press freedom and simulcontinuous attacks on journalists in West Bengal. The Centre urged the State to ensure the safety of mediapersons. In a landmark decision, the Lok

Sabha passed the Press and Registration of Periodicals Bill, 2023, repealing the colonial-era law of the Press and Registration of Books Act, 1867. The Bill simplifies the process of title allotment and registration of periodicals through an online system without the need for any physical interface. This Bill had already been passed by the Rajya Sabha in the Monsoon Session.

During the Question Hour in the Rajya Sabha earlier in the Information Broadcasting Minister Anurag Thakur stated that law and order is a State subject, and the Government should provide an environment for mediapersons to

independently. Thakur was responding to a question raised by TMC member Dola Sen, who was not present in the House, having been suspended along with a few other MPs for the remainder of the winter session. Responding to a supplementary query on steps being taken by the government to ensure the safety of journalists, the minister mentioned that the main question was asked by an MP from West Bengal who is

not in the House. Thakur expressed hesitation to point out a particular State but noted that several incidents had occurred one after the other in



He emphasised the serious concern for the safety of journalists, citing specific incidents in various districts.

"The media is the fourth pillar of democracy," the minister asserted, urging West Bengal and other States to take steps to ensure the safety of journalists within their borders.

Regarding The Press and Registration of Periodicals Bill, 2023, passed in the Lok Sabha, it enables the Press Registrar General to fast-track the process, ensuring publishers, especially small and medium publishers, face little difficulty in starting publication. Introducing the Bill in the Lok Sabha, Minister for Information & Broadcasting Anurag Singh Thakur said, "the Bill reflects yet another step of the Modi Government towards jettisoning the mentality of slavery and bringing new laws

Bagchi also underscores that the TMC, and if an alliance is formed, the BJP would benefit, as opposition votes consolidate in its favor. At this juncture, he argues, an alliance with the TMC would ultimately

aid the saffron outfit. While the TMC leadership atmosphere,

remains tight-lipped about the PCC's demand, a senior leader in the party indicates there is no intention of offering more than 2-3 seats to the Congress. The leader suggests that, given the current Congress may struggle to retain even the 2 seats it won last time without TMC support.

Be sensitive to Divyang, EC asks political parties

In a groundbreaking move, the Election Commission (EC) has issued guidelines to political parties, urging them to use disability and gender-sensitive language. Political parties are advised to refrain from using derogatory references to persons with disabilities (PwD) in public speeches, campaigns, and writings. Examples of ableist

"dumb" (gunga), "retarded" (pagal, sirphira), "blind" (andha, kana), "deaf" (behra), and "lame" (langda, lula, apahij). The EC emphasised the need to

avoid such derogatory language, stating, "PwDs have to be accorded justice and respect in political discourse campaigns."

The advisory cautioned that any usage of derogatory language or insults directed at PwDs may language highlighted in the attract provisions of Section 92 advisory include words like of the Rights of Persons with



Disabilities Act, 2016. The EC appealed to political parties and their candidates to abide by the guidelines in both letter and spirit, recognising their role as important stakeholders in the electoral process.

For the first time, the Commission has issued a set of guidelines to promote inclusivity and respect in political discourse toward the PwD community. The EC is consciously striving to promote the principles of accessibility and inclusivity in elections through initiatives. In an advisory issued to parties,

the poll panel highlighted that the foundation of democracy lies in the representation of all communities in the electoral process. It expressed concern about the use of derogatory or offensive language in political discourse about PwDs and warned that such language could be interpreted as an affront to the

4 Army jawans martyred in terror ambush in Poonch

In yet another provocative strike targeting Indian army personnel, a heavily armed group of foreign terrorists Thursday ambushed two army vehicles in the general area of Dera Ki Gali, Poonch in which four army personnel were 'killed in action' and three others received critical injuries. The Indian army personnel

were passing through the Thannamandi-Surankote road link in two separate vehicles including one gypsy and an army truck at the time of the attack. Till the time of filing the report, none of the terrorists was neutralized. Unconfirmed reports suggested one of the terrorists received injuries during the intense gunfight but there was no official confir-

According to a Jammu-based Defence Spokesman, Lt-Col Suneel Bartwal, the army vehicles were targeted at approximately 3:45 PM on Thursday. The vehicles carrying troops



were moving to the operational site in the general area of Dera Ki Gali. The terrorists, hiding in the area, targeted the army vehicles. The fire was retaliated effectively. In the ongoing operation, three Indian army jawans laid down their lives and three others

Meanwhile, some of the images circulated on various social media platforms captured the intensity of the 'dastardly' attack. It showed a bloodstained helmet, AK rifle magazines, and human blood splattered near the front door of the

According to ground reports, the Indian army has cordoned off the general area and fresh reinforcements were rushed to the area to track down the footprints of the terrorists.

A joint operation was launched in the Dera Ki Gali on December 20 soon after receiving intelligence reports about the suspected movement of terrorists in the area. The contact was established with the terrorists after the gruesome attack took place.

five Indian army personnel including two army officers were 'killed in action' during a fierce gunfight with a group of well-entrenched terrorists in the Solki forest area of Kalakote in Rajouri district.

Twenty-two security personnel have been killed in action since April 2023 in five similar strikes by the terrorists in Jammu Kashmir.

Five Indian soldiers were charred to death after a moving truck was ambushed in the Poonch district on April 20, Fifteen days later on May 5

2023, Five elite commandos of Para Special forces were 'killed in action' by a group of heaviy armed terrorists in the thickly forested belt of Kotranka in the frontier district of Rajouri. Later on 4 August 2023, 3 soldiers of 34 RR were killed in action in the Kulgam district. On September 13, 2023, three officers and one sepoy were killed in action in the Kokernag forest area of Anantnag.

and Adish C Aggarwala contended before the court that action should be taken for such "vilifying speeches during elections" but the EC lacked the power to enforce any strict measures.

Mamata announces 4 per cent DA for Govt employees

With pressure building on her ahead of the general elections, Bengal Chief Minister Mamata Banerjee on Thursday announced an additional 4 per cent Dearness Allowance for the State Government employees.

With Thursday's announcement the State government staff would now get 10 percent DA from January 1. 'Though DA is not a matter of

right for the State government employees ... rather it is optional for the State to grant DA ... still I am announcing additional 4 percent DA from January 1 next year taking the total DA to 10 percent," Banerjee said, reminding how difficult it would be for her cash-starved Government which got nothing from the Centre to discharge its new lia-

The increased DA would benefit state government employees including teachers, health staff, pensioners and all such persons," Banerjee said.

The Government employees



been agitating for a DA hike on par with the Centre which presently gives 46 percent DA

. "I am ready to accept every legal summon. However, this ED summon is also illegal and politically motivated like the previous summons," Kejriwal

Registration of the property you sell or purchase or documents related to your will is set to become easier in Delhi. The Arvind Kejriwal government has decided to intro-duce the 'Anywhere Registration' policy for sale and purchase of properties in the national capital. This will pave the way for Delhi residents to pick an office of their choice and convenience to get various documents registered. The chief minister Arvind Kejriwal has approved this scheme, and the file has been sent to the Lieutenant Governor for noti-

According to officials, if people want to register their property, they can go to any Sub-Registrar Office in Delhi. Now, individuals will not be restricted to a specific Sub-Registrar Office for property registration. To buy or sell property in Delhi, people need to visit the Sub-Registrar Office. Whether it's a property transaction or registering the property through other means, one has to go to the Sub-Registrar Office. A sub-registrar offices on an average takes care of reg-



istrations of around 32 different documents, including the sale deeds, rent agreements, wills, and power of attorney. According to Raj Niwas official, in another path-breaking move aimed at mitigating corruption and harassment of citizens in Sub Registrar offices, the Lieutenant Governor Vinai Kumar Saxena has asked for entire Delhi to be declared as a single district for the purpose of registration of properties, on line with a similar step taken in Andhra Pradesh in 2015. "This would enable any person to get the property registered from any Sub Registrar office in the Capital rather than going to specific offices. This move is

expected to put an effective check over malpractices. Further, the issuance of NOCs by Revenue Department regarding status of a particular land will also be made online in a faceless module, thereby eliminating any human interface," official said.

Saxena has earlier reviewed the performance of the Vigilance Department, Delhi government with regards to the disposal/pendency of cases and stricter enforcement to curb corruption and prevalent malpractices in government offices. During the meeting, the Lt Governor laid emphasis on making the Sub Registrar offices corruption free, so as to

cause minimum inconvenience and harassment to the people at large. To this effect, he directed to bring the entire area in all Sub Registrar offices under the surveillance of CCTV cameras the feed of which will be brought directly to the Central Command & Control Centre.

The LG was informed that fol-lowing his directions in the last meeting, for the first time in the country an Online Complaint Information Management System (OCIMS) had been developed that would enable online registration of complaints in corruption cases. The portal being developed by NIC will also have provisions for the complainants to upload photographic/video/audio evidences online along with their complaints.

"All Sub-Registrars in Delhi will now function as Joint Sub-Registrars, and their jurisdiction will cover the entire Delhi. So, anyone residing in Delhi can make an online appointment for property registration at any of the 22 Sub-Registrar Offices in Delhi," the AAP government said in a statement. In Delhi, the erstwhile Sheila Dikshit government had tried

to connect the 16 sub registrar offices in Delhi.

'Many complaints about the Sub-Registrar Office often Sub-Registrar Office often reach chief minister Arvind Kejriwal. One complaint is that in many Sub-Registrar Offices, there are long queues and it takes a long time to book an appointment. On the other hand, some Sub-Registrar Offices do not have excessive crowds. Another complaint that often comes in is of prevathat often comes in is of prevalent corruption in many Sub-Registrar Offices.

There are middlemen outside the offices who demand money, and people are forced to pay these middlemen to get their registry work done in the same office. To address these Department has initiated this new policy," reads the state-

Holding placards and raising slogans demanding action against the two MPs, the Jat Mahasabha volunteers staged a protest for the second consecutive day on Thursday. A similar protest was held by them near the Congress headquarters on Wednesday.

Ashok Balyan, National Secretary of Jat Mahasabha said more than 1,000 people are expected to gather at Jantar Mantar on Thursday and most of them have come from western Uttar Pradesh. Balyan said Banerjee and Gandhi should be "permanently suspended from Parliament".

States ready to check Covid spread | CISF to secure Parliament complex

Not keen to take risk, as the Covid-19 cases gradually move northwards amid fear that the JN.1 variant is responsible for the sudden spurt of infection, several States are gearing up to check its spread through self-proclaimed measures such as making mask mandatory and identifying separate Covid-wards to meet emergency, if any.

This comes even as the Centre has decided to adopt a wait and watch policy on the issue of making the RT-PCR testing for Covid-19 mandatory at airports for travellers. Also, there has been no direction from the Centre on making masks com-

However, after Karnataka made it compulsory for senior citizens to wear masks, the Chandigarh administration on Thursday followed suit as it made masks usage compulsory for people in the crowded places, especially during the whole journey in the public transport (like buses, trains, aircraft and taxis etc); during stay inside cinema halls, shopping malls and departmental stores etc; during stay inside classrooms, office rooms, indoor gatherings.

Also, those showing symptoms such as fever, cold, and difficulty breathing have been recommended immediate medical consultation while individuals testing positive for the infection have been asked to self-isolate



for 7 days.

In the wake of JN.1 variant found in Kerala, the neighboring Karnataka government has made it mandatory for senior citizens to wear masks. In its preparedness measure, the state government has urged those with comorbidities, and symptoms of cough, phlegm and fever to mandatorily wear face masks. As of now there is no restriction on the movement of people from the neighbouring state Kerala which has topped the Covid-19 cases list.

In the national capital, Delhi Health Minister Saurabh Bhardwaj said that the infrastructure and resources such as oxygen cylinders, required medicines and ventilators are being reviewed to meet emergencies in case of any.

At the same time, the Delhi

health department has ordered the authorities to send an "adequate" number of Covid samles for RT-PCR test and conduct the genome sequencing of the positive samples.

In a major revamp of security after Parliament security breach earlier this month, the Government has decided to hand over "comprehensive" security of the Parliament building complex to the Central Industrial Security Force (CISF).

The CISF will render access control to the new and old Parliament complex in an air-port security-like fashion where body frisking of persons will be done through handheld detectors and their belongings will be checked through X-ray machines, with a provision to even scan shoes, heavy jackets and belts by putting them on a tray and passing them through the scanner, sources said. Earlier, frisking of visitors to Parliament complex was done by Delhi Police personnel.

In a major security breach on the anniversary of the 2001 Parliament terror attack on December 13, two persons jumped into the Lok Sabha chamber from the public gallery during Zero Hour, released yellow smoke from canisters and shouted slogans before being overpowered by the MPs. One of the accused had hidden a canister in his shoes.

Union home ministry on Wednesday directed for a survey of the Parliament building complex so that a "regular

number of CISF personnel required for this new task and also clearly define the role of what each security agency engaged in Parliament security will do, they said.

Both the new and the old Parliament complex and their allied buildings will be brought under a comprehensive security cover of the CISF which will also have the existing elements of Parliament Security Service (PSS), the Delhi Police and the Parliament Duty Group (PDG) of the Central Reserve Police Force(CRPF), the sources said.

Following this Parliament security breach incident, a committee under the chairmanship of CRPF director general Anish Dayal Singh is looking into the overall security issues of the Parliament complex and will make recommendations to the Union home ministry for improve-

India thrice obtained consular access to man indicted by US for plotting Pannun murder: MEA

m inistry\,\,of\,\,External}$ on Thursday that Indian officials thrice obtained consular access to Nikhil Gupta, who has been indicted by US authorities over an alleged plot to kill separatist Gurpatwant Singh Pannun. Gupta is currently in a jail in the Czech Republic.

The 52-year-old Indian national was arrested in the Czech Republic on June 30 at the request of the US authorities, who accused him of being involved in the planning to kill Pannun, who is an American citizen.

In a plea to the Supreme Court of India earlier this month, Gupta's family alleged that he was denied consular access, the right to contact his family, and the freedom to seek legal representation.

that Czech authorities had not sent any correspondence to the Indian embassy or Indian authorities in the Czech Republic or in India regarding the arrest and detention of Gupta.

The family had also alleged

The family had also requested the top court to direct an Indian envoy in the European country to find out about the status of the case. However, the apex court directed the family to approach a court in the Czech Republic.

Gupta was charged on November 20 by the US Justice Department for his involvement in the alleged murder plot. According to US officials, Gupta had agreed to

pay \$100,000 to an assassin to carry out the killing, with an advance payment of \$15,000 already made on June 9, 2023. However, the individual he contacted for the hitman turned out to be a confidential source working with US law enforcement.

Terming the charges a "matter of concern" and contrary to government policy, New Delhi has announced a high-level probe into the allegations. Meanwhile, US officials have sought the extradition of Nikhil Ğupta, who is currently lodged in solitary confinement in the Czech Republic.

Prime Minister Narendra Modi has said India's commitment is to the rule of law and if someone gives information, it would look into it, in his first comments on the US allegations relating to an Indian link over a foiled plot targeting Sikh separatist Gurpatwant Singh Pannu.

Making this assertion in an interview to The Financial Times, Prime Minister Modi also said ties between India and US are robust and there is strong bipartisan support for strengthening of ties between the two nations. He also said it is not appropriate to link a few incidents with diplomatic ties.

In the interview to the British daily, Modi said "If someone gives us any information, we would definitely look into it." Modi said. He also said "If a citizen of ours has done anything good or bad, we are ready to look into it. Our commitment is to the rule of law," he said.

If emissions reduced to Covid lockdown levels, Himalayan snowmelt could be reduced by up to half: Study

Covid-19 lockdown in 2020 may have come as a doom for almost all economies across the world, but for the Himalayan glaciers it was a respite as it breathed cleaner air due to less soot deposition amid drastic decline in passenger and freight transport, industrial emissions and energy consumption in this

region during the period. No wonder that an international research team from India, Germany and the UK has said if emissions of air pollutants such as soot could be reduced to at least the level of the lockdowns, snowmelt could be reduced by up to half.

The move can prevent them from disappearing by the end of the century, said the team following analysis of the cleaner air during the period when less soot was deposited on the glaciers, resulting in 0.5 to 1.5 milimeter (mm) less snow melting per day." The rapid retreat of glaciers and the loss of snow cover already pose a threat to the sustainable water supply of billions of people in Asia who live in the catchment areas of rivers such as the Indus, Ganges and Yangtze," according to the researchers.

The study, published in the journal Atmospheric Chemistry and Physics, found that a switch to clean energy supplies and loweremission modes of transport would therefore bring significant benefits for sustainable water supplies, agriculture and ecosys-

tems in large parts of Asia. The mountains of the Hindu Kush Himalayas (HKH) and the highlands of Tibet in Central Asia form the largest snow-covered region outside the poles and



are highly vulnerable to air-pollutants

Model simulations for extreme scenarios show that the melting snow in the Himalayas could cause the glaciers there to disappear by the end of the 21st cen-

Satellite observations showed cleaner snow with almost a third less light-absorbing pollution during the lockdown in Asia between March and May 2020, the researchers said. This led to a decrease in

snowmelt of 25 to 70 mm in 2020—compared to the 20-year average for the months of March to May in the western Himalayas, they said.

The changes in snow absorption and surface albedo thus ensured that around 7 cubic kilometers of meltwater remained in the Indus catchment area, according to the study.

The team used global simulations to analyse in detail the impact of reduced air pollution over high mountains in Central Asia during the COVID-19 lockdowns between March and May 2020. "The aerosol optical thickness (AOD), i.E., the atmospheric opacity, over this region decreased by around 10 per cent in April 2020 compared to before the pandemic," said Suvarna Fadnavis from the Indian Institute of Tropical Meteorology (IITM), Pune.

NGT fines States ₹79,098 crore for violations of solid waste management

The National Green Tribunal (NGT) has cracked a whip on many States and Union Territories for violating municipal solid waste management rules and other environmental violations in 2022-23 by impos-ing fines totalling Rs 79,098 crore, the Government told Parliament on Thursday.

Tamil Nadu earned the dubious distinction by topping the list with the highest fine of Rs 15,419 crore, followed by Maharashtra (Rs 12,000 crore) and Madhya Pradesh (Rs 9,688 crore), as per the data provided by Union Minister of State for Environment Ashwini Kumar Choubey in a written reply to a question in the Rajya

The NGT directed Uttar Pradesh to pay Rs 5,000 crore, Bihar Rs 4,000 crore, Telangana Rs 3,800 crore, West Bengal Rs 3,500 crore, Karnataka Rs 3,400 crore and Delhi Rs 3,132 crore for not complying with the Municipal Solid Waste Management Rules, 2016 and other environmental violations. The Central Pollution Control Board (CPCB) monitors the water quality of aquatic resources at 4,703 locations in 28 states and eight Union territories under the National Water Quality Monitoring Programme (NWMP).

The programme covers surface, coastal and groundwater locations in collaboration with the state pollution control boards (SPCBs) and pollution control committees (PCCs) on different periodic bases.

Navy deploys second | BJP confident guided-missile destroyer of winning over in Gulf of Aden 50 seats in J&K in Gulf of Aden

The Indian Navy has deployed a second frontline ship in the Gulf of Aden to augment its anti-piracy mission, following the hijacking of a Malta-flagged cargo vessel by pirates.

The Navy now has stealth guided-missile destroyer INS Kochi and INS Kolkata in the region, officials said.

The Navy swiftly responded after receiving a call for help from MV Ruen, the Malta-flagged hijacked vessel, on December 14.

Days later, it evacuated one of the 18 crew members onboard the vessel off the coast of Somalia to provide medical care after he was injured by the pirates.

"In a swift response, Indian Navy's maritime patrol aircraft deployed to investigate the incident arrived overhead MV Ruen on December 15 and established communication with the crew," a Navy spokesperson said.

"All 18 crew (no Indians onboard) were reported to be in the citadel.

Concurrently, in response to the incident, INS Kochi on anti-piracy patrol in the Gulf of Aden was also diverted immediately to render assistance," he said.

The official said INS Kochi intercepted MV Ruen in the early hours of December 16 and launched its integral helicopter to assess the situation. "It was ascertained from the crew that the citadel onboard MV Ruen had been breached and all crew members were held hostage by the pirates. One of the crew members had also sustained injuries, but was reported to be stable," he

'Whilst no armed interven tion was undertaken to ensure crew safety onboard the hijacked MV, requisite actions were taken by the warship towards ensuring suitable treatment of the crew by the pirates," he added.

The Navy spokesperson said a Japanese warship also arrived in the area on December 16 and was relieved by Spanish warship ESPNS Victoria later in the

The BJP will not enter into a pre-poll alliance for the assembly elections in Jammu and Kashmir as the party is confident of winning over 50 seats and forming the Government on its own, senior leader Ashok Koul said on Thursday.

"After the elections take place, if an alliance is needed, it will happen. But, as of now, the BJP has decided that we will cross 50 seats and the support the BJP is getting in Kashmir, we are confident that we will cross 50 seats," Koul, the BJP's general secretary, organisation, Jammu and Kashmir, told reporters here.

When asked some political parties in Jammu and Kashmir are claiming the BJP is afraid of facing the elections in the Union Territory, Koul said his party is ready for the polls.
"It is not like that. The Supreme

Court (SC) has said about the elections and so. I want to tell the parties to start preparations as the assembly elections are to take place before September (next year). The BJP is ready for the polls," he added.

Court's ruling on the issue of Article 370 is not acceptable to some parties in the valley, the BJP leader said his party's stand is that everyone should accept the apex court's verdict. "I do not have an answer to that. The SC is the highest court in democratic India. We have said it before as well that whatever decision the SC takes, everyone should accept that. If someone has anything to say about it, they know it, but the stand of the BJP is that every-

DMK leader gets 3 years jail in DA case **Dhami honours**

In a disproportionate assets case, the Madras High Court on Thursday sentenced Tamil Nadu Higher Education Minister K Ponmudy to three years in prison under the Prevention of Corruption Act and also slapped a fine of Rs 50lakh on him. Consequent to his conviction

and the prison sentence awarded by the court, Ponmudy, a senior leader of the ruling DMK stands disqualified as a legislator and as a result ceases to be a Minister. A DMK strongman hailing from Villupuram district in northern Tamil Nadu, he was

Assembly from Tirukkovilur Assembly constituency. Justice G Jayachandran also sentenced Ponmudy's wife P Visalakshi to three years in jail. The judge imposed a fine of Rs 50 lakh each on Ponmudy and

his wife. When the court began its hearing before pronouncing the sentence, senior counsel N R Ellango prayed the court to grant leave to enable Ponmudy and his wife Visalakshi to file a Special Leave Petition before the Supreme Court and also to



suspend the sentence.

The judge, declining to entertain the plea, granted Ponmudy and Visalakshi 30 days time to surrender before the trial court in Villupuram to undergo the prison sentence.

In case the accused persons fail to surrender on or before January 22, 2024, the trial court shall secure the accused by executing warrant, the judge added.

The HC had already convicted the minister and his wife in the case and pronounced the sentence today. Legal experts said Ponmudy,

following his conviction and prison term, stands disqualified from the post of MLA and he also loses the post of Minister. Asked about the disqualification of Ponmudy, Senior counsel Abudukumar Rajarathinam said, "In view of his conviction, Ponmudy stands disqualified by virtue of Section 8 (1) (m) of Representation of Peoples Act for a period of 6 years from the date of his release after the sentence?

Further, he said, "Ponmudy stands disqualified from the moment he is convicted. His only option is to approach the Supreme Court to seek stay of his conviction so as to not to attract disqualification under the Representation of Peoples Act. Since he stands disqualified as an MLA, he stands disqualified from holding the position of a Minister of Tamil Nadu cabinet".

The judge had on December 19 convicted Ponmudy and his wife Visalakshi in the case and directed them to appear before the court on Thursday to hear them before awarding

them the sentence. Accordingly, Ponmudy and Visalakshi were present in the court hall by 9.50 a.M today. The judge asked Ponmudy and Visalakshi, whether they had anything to say about the sentence. Ponmudy said he is innocent and 72-year old and that he is a heart patient for the

last 10 years. He pleaded with the court to impose a lesser punishment. Visalakshi said she is 68-year old. Her husband is a 'heart patient' and she has to look after him and hence lesser sentence may be imposed.

Caution ahead!

Mandaviya appeals for calm amid concerns of yet another Covid outbreak as new JN.1 variant spreads

The biggest scare this generation has seen, or heard gory stories about, is back. After a few months of being mentioned as an aside, Covid has returned as the centrepiece of discussions. One of its newest variant, JN.1, has registered a sharp uptick in the number of recorded cases, both in India and abroad. Though the unwelcome development has garnered heightened attention from health authorities and public alike, India's Union Health Minister Mansukh Mandaviya has urged citizens not to panic, emphasising that the situation is under control. This latest wave of Covid infections comes while the nation is still grappling with the lingering effects of the Covid-19 pandemic, which has left an indelible impact on the collective psyche of the nation, in fact the entire world. The emergence of the JN.1 variant has raised serious concerns as it demonstrates a level of adaptability that demands close monitoring. It carries mutations that may impact transmissibility and potential resistance to existing vaccines. As cases surge



across States, concerns about the healthcare system's capacity to handle the influx of patients have grown in proportion. Seeking to set aside fears, Mandaviya emphasises that the increase in JN.1 cases must not trigger panic and that authorities are implementing measures to contain its spread. Even health experts, while echoing that there is no need for panic, underscore the importance of remaining vigilant. The JN.1 variant's characteristics warrant continued monitoring and adjustments to public health strategies.

Increased testing, contact tracing and the promotion of vaccination campaigns are crucial components of managing the situation effectively. Though there are

no health advisories so far from the Government or health departments, it is best to avoid situations amenable for the spread of the virus. It is advisable to use masks, avoid overcrowding, not take any fever/ breathlessness lightly and consult a doctor for the same. India, like the rest of the world, has not been immune to the lasting effects of the Covid-19 pandemic. The crisis has left an enduring impact on the mental health and well-being of the population. Fear and anxiety stemming from the initial outbreak, coupled with the loss of loved ones and economic hardships, have contributed to a collective sense of unease. The trauma of the pandemic has left an imprint on the minds of individuals, influencing their perspectives on health, safety and community wellbeing. In this scenario, a sense of panic is rather natural but must be avoided as it multiplies the intensity of the virus. As we confront the surge in JN.1 cases, it is crucial to strike a balance between being vigilant and maintaining a sense of calm. The Government's commitment to monitoring and managing the situation, combined with individual responsibility in adhering to public health guidelines, will play a pivotal role in trumping this menace once again. The resilience of people, coupled with a proactive and responsive healthcare system, will surely overcome the latest wave of infections.

Use the SC verdict to normalise Kashmir-

ecently, the Hon'ble Supreme Court ruled in favour of the Modi Government's August ≥2019 decision to nullify Article 370 of the Constitution. That Article gave Jammu and Kashmir special status within our federal structure giving it the right to have its constitution along with exemption from the complete applicability of our constitution. Bizarrely, though only a temporary provision, it de facto came to be treated as permanent because the J&K Constituent Assembly did not specify its abrogation when it dissolved itself. This seems illogical because common sense suggests whichever authority has the power to promulgate such an article, obviously also has the power to dissolve it. In essence, we created a mountain out of a molehill!

Notwithstanding this, legal luminaries and eminent commentators, former Supreme Court Justice Madan Lokur and our foremost constitutional expert, Fali S Nariman, amongst them, have gone on to express their unhappiness with the Supreme Court's verdict. Justice Lokur, for example, has pointed out that the verdict was based on inherent contradictions of the court's earlier judgements and extremely convoluted logic. Furthermore, he was also unhappy with the Court's refusal to determine whether the reorganisation of the state, which was divided into the Union Territories of Ladakh and Jammu & Kashmir, was constitutionally permissible under Article 3. He saw this as a failure of the court to do its constitutional duty. Mr. Nariman was even more critical going so far as to call the verdict "totally erroneous and bad in law."

More than just the question of Jammu and Kashmir, what seems to be troubling those critical of the verdict is the precedent that the Supreme Court has set. In their view, this verdict will have a significant impact on India's federalism, which it had earlier deemed to be a basic characteristic of our constitution and inviolable and sacrosanct. YOGA AND MEDITATION FOR HOLISTIC HEALTH

Indian knowledge system has solutions to the problems faced in contemporary times

t is a well-known fact today that mindfulness is an essential survival mechanism. Mindfulness prevents stress, and anxiety and helps boost mental and thereby physical health. In an article titled "Mindfulness Matters: Can Living in the Moment Improve Your Health?" published in NIH News in Health (January 2022); it is stated that: mindfulness practices may help people manage stress, cope better with serious illness and reduce anxiety and depression. Many people who practice mindfulness report an increased ability to relax, a greater enthusiasm for life and improved self-esteem. After Yogasans and Pranayama (to strengthen the body and organs & systems), our next goal is to proceed inwards to strengthen our mind. To bring calmness and to remove restlessness. Therefore, we need to control our sensory organs so that contact with the outside world is minimised and our energies are channelled within. Dhaarna: this is the stage where we gradually concentrate, detach our mind from the outside noise and tend to focus within. This is the beginning of the Dhayaan or Meditation. Here slowly, our breathing becomes deeper and slower and we start feeling light in our body and mind both. There are many ways to focus and concentrate, one can focus on a picture of a Deity, or a flame of a diya or on the forehead. There is nothing wrong in any of these, everything is good and well. Moreover, down the ages, our saints have found more effective measures for maintaining a healthy mind, body and soul. These are Lotus and Chakra Meditation.Lotus & Chakra + Dharma & Dhyan (2 stages of Meditation): The Lotus is an important symbol in Meditation. The lotus can be seen as a form whose power originates at the centre and radiates outwards



symmetrically. Both the inner concentrated centre and the outward radiating petals are versions of the same powerful energy. This image can be helpful in approaching our practice of meditation. We can see a parallel process in the growth of the lotus: Its seed starts in the mud (which represents our routine, external existence). With the help of the stem, the lotus rises higher and higher, leaving the mud behind, just as the spiritual aspirant turns the attention away from external factors and seeks the pure inner self. This inward seeking is the 'Dharna' stage of Yoga. When it reaches the zenith of its blossoming, the perfectly formed petals and fragrances of the lotus have no trace of mud at all. This perfect attainment of the blossom is representative of the 'Dhyan' stage of Yoga when the aspirant has withdrawn completely from the scattered perceptions of the outside world and united all thought with the One Creator. This oneness of thought fixed on the Creator is Meditation or DHYAN.

Chakra Meditation: As per yogic science, there are seven Chakras: five on the spinal cord, one where the spinal cord meets the brain, and the seventh one nearer to the top of the brain. Significantly, these Chakras are situated near the major glands and the nerve junctions (plexuses/plexus). Starting from the tip of the tailbone, these are: Root or Mooladhar Chakra (pelvic plexus), Swadhishthan Chakra (sacral plexus), Manipur Chakra (solar plexus), Anahat Chakra (Cardiac Plexus - Thymus Gland), Vishuddhi Chakra (Carotid Plexus), Agya Chakra (Pituitary Gland), and Sahasrar Chakra (Pineal Gland).

The objective of Chakra Meditation is to focus inwards on a specific Chakra. This energises the energy centres situated there, resulting in enhanced energy flow to the organs and systems served by that Chakra. Therefore, with regular practice of Chakra Meditation (covering each Chakra for 7 days each and repeating the cycle), all the negative energies and forces from within our body and mind go away and we are filled with positive energy and calmness. It is, therefore, only appropriate to practice these time-tested remedies; viz.; Ashtanga, Chakra and Dhaarna; for a healthy mind, body and soul.



Places of Worship Act must be reviewed

The Places of Worship Act, as a legislative instrument, must evolve to meet the challenges of the present while honouring the historical tapestry



he recent green-lighting of a survey of the Shahi Eidgah in Mathura by the Allahabad High Court has re-ignited a longstanding debate over the Places of Worship Act 1991. Amid escalating disputes mirroring the complexities seen in the Varanasi Gyanvapi case, the focus shifts to the legal framework designed to maintain the religious status quo - the Places of Worship Act.

This trend is not limited only to Varanasi and Mathura. Hindu organizations also filed petitions demanding they should be allowed to offer prayers at Quwwatul Islam mosque in the Qutub Minar premises in New Delhi, while another Hindu organization claimed the Taj Mahal as the Tajo Mahal temple of Lord Shiva and asked for the court's permission to offer prayers there. This was visible in Soth too, Vishwa Hindu Parishad volunteers demanded they should be allowed to offer prayers on the outskirts of Mangaluru after a Hindu temple-like architectural design was purportedly found there underneath the Juma Masjid on April 21, 2022. The VHP claimed that the mosque was built atop Sri Ramanjaneya Bhajana Mandira. Pronibitory orders were imposed in the cit after Hindu organizations said they would organize 'Tambula Prashne' at Sri Ramanjaneya Bhajana Mandira.

The legal battle is the latest instance of a growing phenomenon in which Hindu groups petitioning courts demanding land where mosques are located by claiming these belong to Hindus. These petitions question the Places of Worship Act putting the Government and Judiciary in a tight

Enacted against the backdrop of the Ram Janmabhoomi Movement, the Act has played a crucial role in preserving religious harmony in the country. However, the recent surge in disputes, notably in Mathura and Varanasi, raises pertinent questions about the efficacy and current validity of this legislative measure.

The Places of Worship Act passed in 1991, emerged from the turbulent period leading up to its enactment, marked by fervent communal tensions, notably centred around the Ayodhya dispute. The legislation was conceived as a pivotal step

towards preventing similar fractious litigations and safeguarding the social fabric of the nation.

The core principle of the Places of Worship Act is to freeze the religious status of all places of worship as they existed on August 15, 1947. The Act categorically exempts the Ayodhya dispute, acknowledging its unique historical and emotional significance. The explicit intent was to prevent litigation that could potentially disturb the communal equi-Recent legal battles in Mathura and

Varanasi have seen litigants invoking the 1991 Act, emphasizing its role in protecting the sanctity of religious places. In the Mathura case, Hindu groups claim that the Shahi Eidgah was constructed on land belonging to the Sri Krishna Janambhoomi Trust, demanding the removal of the mosque and the return of the land to the Trust. The Varanasi dispute, on the other hand, revolves around claims by Hindu groups regarding the Gyanvapi mosque.

Worship Act is now under scrutiny as disputes continue to emerge, challenging the very essence of the legislation. One key challenge lies in the interpretation and application of the freeze date - August 15, 1947. Critics argue that freezing the religious character of places of worship at a specific historical moment may not account for the evolving social fabric and religious demographics of the nation over time.

Moreover, the Act faces criticism for its seeming inability to address disputes arising from historical grievances, such as the alleged demolition of temples during medieval times. The Mathura case, where petitioners claim that the Katra Keshav Dev Temple was demol-ished by Mughal Emperor Aurangzeb, brings this historical

Eidgah in Mathura has opened a Pandora's Box, potentially setting a precedent for similar disputes across the country. The survey, akin to the one ordered for the Gyanvapi mosque in Varanasi, aims to verify claims made by Hindutva groups regarding the historical positioning of these places of worship.

In both instances, the survey results have the potential to reshape the narrative, either affirming the claims of the Hindu groups or challenging them. The complex intertwining of historical accounts, archaeological evidence, and religious sentiments underscores the gravity of these disputes.

The Legal Labyrinth: Pending Proceedings and Confusion

Amidst the evolving legal landscape, a multitude of cases and petitions in various courts further complicate the scenario. Eighteen separate pleas in Mathura alone seek full ownership of the disputed 13.37-acre land by the temple management. The consolidation of these pleas by the high court adds a layer of complexity to an already convoluted legal web.

Complicating matters further is the reluctance of the Union Government to clearly articulate its stance on the Places of Worship Act. The ongoing ambiguity raises concerns about the government's commitment to either uphold, review or scrap the legislation. The lack of a definitive position exacerbates the confusion surrounding the legal framework and its applicability in present times.

In this undesirable situation, the onus is on the government to provide clarity on its position regarding the Places of Worship Act. The Supreme Court, being the ultimate arbiter, must expedite proceedings on the validity and interpretation of the Act in the context of evolving

In the labyrinth of legal complexities, it is essential to recognize that the preservation of religious harmony and historical justice need not be mutually exclusive. A nuanced and inclusive approach is required to navigate these intricate contours, acknowledging the diverse tapestry of India's cultural and religious heritage. Top US military officer speaks with Chinese counterpart

the sidelines of the Asia-Pacific Economic Cooperation summit in San Francisco, was aimed in part at restoring the military talks amid escalating concerns about frequent unsafe or unprofessional incidents between the two nations' ships and aircraft in the Pacific region. The US has consistently viewed military communications with China as critical to avoiding any missteps between taining a peaceful Indo-Pacific

Brown's call is the first Cabinet-level communication with China since Secretary of State Antony Blinken spoke on December 6 with Chinese Foreign Minister Wang Yi.

While few details about Brown's call were released, a senior US defence official and a senior military official said it was an important first step. These are the kinds of discussions that the US needs to have with China, they said, in order to avoid misunderstandings or miscalculations as the two militaries interact. The two officials spoke to reporters on condition of anonymity to provide information before the call. They said the US is talking with China at various levels to work out a series of calls and meetings in the coming weeks and months. They include plans to hold the bilat-Defence Policy Coordination Talks early next year and the possible resumption of the China-US Military Maritime Consultative Agreement talks in the spring.

In August 2022, Beijing suspended all military contacts with the US when Pelosi became the highest-ranking American lawmaker to visit Taiwan since 1997, when then-

elled there. Her visit sparked a surge in military maneuvers by China. Beijing dispatched warships and aircraft across the median line in the Taiwan Strait, claiming the de facto boundary did not exist, fired missiles over Taiwan itself, and challenged established norms by firing missiles into Japan's

exclusive economic zone. There also has been an increase in what the Pentagon calls risky Chinese aircraft and warship incidents. The Defence Department in October released video footage of some of the more than 180 intercepts of US warplanes by Chinese aircraft that have occurred in the past two years — more than the total number over the pre-

In one of the more recent incidents, a Chinese pilot flew within 10 feet (3 metres) of a US Air Force B-52, which was conducting routine operations over the South China Sea in international airspace.

Canberra (AP): Australia will send 11 military personnel to support a US-led mission to protect cargo shipping in the Red Sea, but it will not send a warship or plane, the defense minister said on Thursday. Defense Minister Richard Marles said Australia's military needs to keep focused on the Pacific region.

The United States announced this week that several nations are creating a force to protect commercial shipping from attack by drones and ballistic missiles fired from Houthi-controlled areas of Yemen. Marles said 11 military personnel will be sent in January to Operation Prosperity Guardian's headquarters in Bahrain, where five Âustralians are already posted.

"We won't be sending a ship or a plane," he told Sky News television. "That said, we will be almost tripling our contribution to the combined maritime force."

'We need to be really clear around our strategic focus, and our strategic focus is our region: the northeast Indian Ocean, the South China Sea, the East China Sea, the Pacific," Marles added. The US and its allies are concerned by China's growing assertiveness in the region. Australia is one of the United States' closest military allies. The US Congress last week passed legislation allow-ing the sale of Virginia-class nuclear-powered submarines to Australia under a security pact that includes Britain.

Marles rejected opposition lawmakers' criticism that a failure to send a warship as the United States had requested made Australia a less reliable partner and ally. "That's patenty ridiculous," Marles said. The United States is aware of the scale of the Australian defense force and the need to maintain its focus on the Asia-Pacific region, he said. "It is to state the obvious that to take a major asset and put it in the Middle East is to take a major asset away from what we're doing in the immediate region," Marles said. Opposition defense spokesman Andrew Hastie called on Australia to send a North Korea's Kim again threatens use of nukes troops at the General Missile Bureau on Wednesday to con-

North Korean leader Kim Jong Un said his country has a policy of not hesitating to launch a nuclear strike on a rival if provoked, as he praised troops involved in its recent intercontinental ballistic missile test, state media reported on Thursday.

Since adopting an escalato-

ry nuclear doctrine last year, Kim has repeatedly threatened to use nuclear weapons preemptively. But many foreign experts say North Korea has yet to obtain functioning nuclear missiles and is also unlikely to use its nukes first because it's outgunned by the US and its allied forces. North Korea on Monday conducted its first intercontinental ballistic missile test in five months, calling the drill a warning over confrontational US and South Korean moves. North Korea cited a recent US-South Korean meeting on boosting their nuclear deterrence plans.

The North's Korean Central

South Korean governments gratulate them on the launch of the developmental solid-fueled Hwasong-18 missile, the North's newest and most powerful During the meeting, Kim

said the launch demonstrated the evolution of the North's nuclear doctrine and strategy "not to hesitate even with a nuclear attack when the enemy provokes it with nukes," KCNA said. Kim said peace is guaranteed by a war posture of being willing to launch preemptive strikes on the enemy anywhere to make it feel fear, KCNA said.

Last year, North Korea adopted a law that stipulates a broad range of situations in which it can use nuclear weapons. Since the beginning of 2022, it has also test-fired about 100 ballistic missiles, many of them nuclear-capable weapons targeting the U.S. and South Korea. Monday's Hwasong-18 launch was the weapon's third test-flight this year. The US and

have repeatedly warned that any attempt by North Korea to use nuclear weapons would result in the end of the Kim Jong Un government. The allies have also expanded their military training, which Kim views as invasion rehearsal. After the North's latest

ICBM launch, the US, South Korea and Japan began sharing real-time missile warning data on North Korea and established details of their trilateral exercises in the coming years. On Wednesday, the US flew long-range B-1B bombers for joint aerial training with South Korean and Japanese warplanes in a demonstration of strength against North Korea.

In an emergency UN Security Council meeting on Tuesday, the US, South Korea and their partners maintained that North Korea's repeated missile launches threatened international peace and violated Security Council resolutions that ban any ballistic activities by North Korea.

Up to 300,000 Sudanese fled homes after notorious group seized their safe haven hosted more than 86,000 of the

Sudan's military and a notorious paramilitary group forced up to 3,00,000 people to flee their homes in a province that had been a safe haven for families displaced by the devastating conflict in the northeastern African country, the UN said on Thursday.

The fighting erupted in the city of Wad Medani, the provincial capital of Jazeera province, after the Rapid Support Forces attacked the city earlier this month. The RSF said that it took over Wad Medani earlier this week, and the military said that its troops withdrew from the city, and an investigation was opened.

Sudan's war began in mid-April after months of tensions between military chief Gen Abdel-Fattah Burhan and RSF commander Gen. Mohammed Hamdan Dagalo. Both generals led a military coup in October 2021 that derailed

democracy following a popular uprising that forced the removal of President Omar al-Bashir in April 2019.

UN International Organization for Migration said that between 2,50,000 and 3,00,000 people fled the province - many reportedly on foot — to safer areas in the provinces of al-Qadarif, Sinnar and the White Nile. Some sheltered in camps for displaced people and many sought shelter in local communities, it said. Jazeera, Sudan's breadbasket, was home to about 6 million Sudanese. Since the war, about 5,00,000 displaced fled to the province, mostly from the capital, Khartoum, which has been the centre of fighting, according to the UN Office for the

displaced, OCHA said.

World Food The Programme announced Wednesday that it has temporarily halted food assistance in some parts of Jazeera, in what it described a "major setback" to humanitarian efforts in the province. The UN food agency said that it had provided assistance to 8,00,000 people in the province, including many families that fled the fighting in Khartoum.

The conflict in Sudan has wrecked the country and killed up to 9,000 people as of October, according to the United Nations. However, activists and doctors' groups say the real toll is far higher. More than 7 million people were forced out of their homes, including more than 1.5 million who have sought refuge in neighbouring countries, according to the UN

Int'l astronaut will be invited on future NASA moon landing

Cape Canaveral (AP): An international astronaut will join US astronauts on the moon by decade's end under an agreement announced Wednesday by NASA and the White House. The news came as Vice President Kamala Harris convened a meeting in Washington of the National Space Council, the third such gathering under the Biden administration. There was no mention of

who the international moonwalker might be or even what country would be represented. A NASA spokeswoman later said that crews would be assigned closer to the lunar-landing missions, and that no commitments had yet been made to another country. NASA has included international astronauts on trips to space for decades. Canadian Ieremy Hansen will fly around the moon a year or so from now Another crew would actually land; it would be the first lunar touchdown by astronauts in more than a half-century. That's not likely to occur before 2027, according to the US Government Accountability Office. All 12 moonwalkers during NASA's Apollo programme of the 1960s and 1970s were US citizens.

US frees Maduro ally for ten Americans, fugitive contractor

The United States freed a I close ally of Venezuelan President Nicolas Maduro in Americans imprisoned in the South American country and the return of a fugitive defense contractor known as "Fat Leonard" who is at the center of a massive Pentagon bribery scandal, the Biden administration announced Wednesday.

The American detainees arrived at Kelly Airfield Annex in San Antonio, Texas, late Wednesday. The deal represents the Biden administration's boldest move yet to improve relations with the major oil-producing nation and extract concessions from the self-proclaimed socialist leader. The largest release of American prisoners in Venezuela's history comes weeks after the White House agreed to suspend some sancment by Maduro to work toward free and fair conditions for the 2024 presidential election. Maduro celebrated the return of Alex Saab as a "triumph for truth" over a U.S.-led campaign of lies, threats and torture against someone he considers a Venezuelan diplomat illegally arrested on a US warrant.

¬he European Union on Thursday paid the final tranche of a multibillion-euro support package to Ukraine to help keep its war-ravaged economy afloat this year, leaving the country without a financial lifeline from Europe as of next month.

The EU has sent 1.5 billion euros (\$1.6 billion) each month in 2023 to ensure macroeconomic stability and rebuild critical infrastructure destroyed in the war. It's also helping to pay wages and pensions, keep hospitals and schools running, and provide shelter for people forced

To ensure that Ukraine has predictable, longer-term income, the EU's executive branch, the European Commission, proposed to

billion euros (\$55 billion.) At a summit last week, 26 of the 27 nation bloc's leaders endorsed the plan, but Hungary imposed a veto. The decision came as a major blow to Ukrainian President Volodymyr Zelenskky, days after he had failed to persuade US lawmakers to approve an additional \$61 billion for his war effort.

Hungary's nationalist leader, Prime Minister Viktor Orbán, is widely considered to be Russian President Vladimir Putin's closest ally in the EU. Critics accuse him of putting Moscow's interests ahead of those of his EU and NATO allies.

Orban has called for an immediate end to the fighting, which has ground on for almost two years, and pushed for peace talks between

he accused his EU partners of seeking to prolong the war and said that sending more money to Ukraine was a "violation of (Hungary's) inter-

Orban is set to meet again with fellow EU leaders on Feb 1 to try to break the deadlock.

The 50-billion-euro package is included in a revision of the bloc's long-term budget. More money is needed to pay for EU policy priorities given the fallout from the war, including high energy prices and inflation, and the impact of the COVID-19 pandemic.

In between, there was a short-lived rebellion in Russia, a dam collapse in Ukraine, and the spilling of much blood on both sides of the conflict.

Twenty-two months since it invaded, Russia has about one-fifth of Ukraine in its grip, and the roughly 1,000-kilometer (620-mile) front line has barely budged this year.

Congo has a history of disputed elections that can turn violent, and there's little confidence among many Congolese in the country's institutions. President Felix Tshisekedi, who is seeking his second and final five-year term, has spent much of his presidency trying to gain legitimacy after a disputed 2018 election. There is no second round of voting and the winner, expected to be announced no later than December 31, needs to get a majority of votes.

A fractured opposition makes Tshisekedi the likely favourite to win.

Some 44 million people almost half the population were expected to vote for Congo's next president. But many, including several million displaced by conflict in the vast to do so. The fighting prevented 1.5 million people from registering to vote.

The election commission said Wednesday there was a delay in the deployment of certain materials and equipment during the vote, which resulted in some polls opening late and others not opening at all. It's unclear how many voting stations weren't operational.



'Shipping firms revenue may decline in next fiscal'

On the supply side, capacity addition for tankers is expected to remain limited given the decadal-low orderbook, which will keep charter rates much higher than the pre-pandemic level of USD 15,000-25,000/day, it said.

But the charter rates for dry bulk are expected to remain range-bound this fiscal and the next, with moderate growth in demand for key commodities, especially iron ore and coal (accounting for 40-45 per cent of the global dry-bulk trade), and moderate fleet orders, it said. According to CRISIL, the averlast fiscal due to lower demand of these and other key commodities due to subdued industrial / construction activities in

The government has sold 3.46 lakh tonnes of wheat and 13,164 tonnes of rice through e-auctions to bulk consumers as part of its effort to boost domestic supplies and control retail prices.

The government is selling wheat and rice from its buffer stocks to keep retail prices under control under the Open Market Sale Scheme (OMSS). Food Corporation of India (FCI), the government's nodal agency for food grains procurement and distribution, is conducting the eauctions.

The Centre has allocated 101.5 lakh tonnes of wheat for

the OMSS till March 2024. "The 26th e-auction was held on December 20 wherein 4

lakh tonnes wheat and 1.93 lakh tonnes rice was offered. In the e-auction, 3.46 lakh tonnes wheat and 13,164 tonnes rice was sold at a weighted average of Rs 2,178.24 per quintal for wheat and Rs 2905.40 per quintal for rice," an official statement

To control the retail prices of rice, wheat and atta, the government is organising weekly e-auctions of both wheat and rice.

The minimum and maximum quantity of rice that a bidder can bid has been fixed at 1 tonne and 2,000 tonne, respectively. The bidders can bid in multiples of 1 tonne with respect

But India's march to ascendancy began through Vastrakar (4/53) who teamed up with Sneh Rana (3/56) and Deepti Sharma (2/45) to snap Aussies innings in 77.4 overs despite an even fifty by Tahlia McGrath. However, Australia made a poor start as they lost opener Phoebe Litchfield in the first over itself after a mix-up with her partner Beth Mooney at the Wankhede Stadium

Four deliveries later, Vastrakar produced a jaffa to remove Ellyse Perry (4) and reduced Australia to 7/2 inside the first two overs.

Vastrakar beat the defence of star all-rounder Perry by getting the ball move into her to disturb the stumps

But McGrath (50 off 56 balls, 8x4s) came out firing on all cylinders to put pressure back on India, making most of the errors in line and in the field. McGrath was severe on anything that had width, racing to her third fifty in five Tests with eight fours while also utilising two lifelines in the form of dropped catches when she was on 24 and 45.

While making the bulk of runs during her 80-run stand with Mooney for the second wicket, McGrath also set herself up for a big score. But an error in judgement made her pay heavily, and it also opened the flood-

It is no brainer that an IPL franchise coached by former India pacer Ashish Nehra bought Johnson who now sits behind Rashid Khan as Gujarat Titans' second most expensive player.

After playing in The Hundred, Johnson also caught the eye of national selectors, and he was selected to play for Australia in the lead-up to the World Cup. He played his lone ODI against India in August in Indore where he was wicketless for 61 runs from his eight

He has also played two T20Is, both against South Africa in August-September. Johnson said netting the lucrative IPL contract was a

special moment but more satsmile on FaceTime. "It's obviously a pretty special

moment, I never really thought I'd be in this situation," Johnson said ahead of Brisbane Heat's BBL match against Melbourne Renegardes. "But it was nice to get on the FaceTime back home in

Adelaide (with) mum and to see her smile. It's not just my moment, I guess it's a moment for my whole family and they've been there the whole way. So for them to experience it as well, it's pretty special." With just 30 overseas players spots up for grabs in the mini auction in Dubai, Johnson thought his opportunity

might not come. "I think the longer it went, I guess you start to lose a little bit of hope. So the longer it was going, I think the less chance I had.

But at the end of the day I was in a position where I was in the auction, and this time last year I wasn't. So whatever happened was going to happen, and anything would have been a good result."

A life-changing IPL contact has been sealed but Johnson does not want to go down the T20-only route and believes Test cricket is actually where

his strengths lie. "Ideally, I'd like to play more red ball. I think my body's just let me down over the last few years but my body's hardening and I'm getting ready to play, hopefully, some longer format cricket, which is, I feel,

my better format.
"I think post-Big Bash, we'll get back to South Australia and play the last four Shield games there. And then hopefully with a couple of performances, you never know what might happen."
