Rajnath vows action on sea attacks

Aday after the merchant vessel MV Chem Pluto reached Mumbai port, Defence Minister Rajnath Singh said on Tuesday that the Indian Government has taken serious cognizance of the recent attacks on it and another ship MV Sai Baba. He emphasised that strict action will be taken against those behind the attacks, even locating them from the "depths of the seas.

guided missile destroyer INS Imphal in Mumbai, Rajnath also stated that India has intensified patrolling of the seas following the recent attacks on merchant navy ships. "The Indian Government has taken the drone attack on MV Chem Pluto and the attack on MV Sai Baba in the Red Sea seriously. We will find those who executed the recent attacks on merchant navy ships, even from the depths of the seas, and take strict action Speaking after the against them," the Defence commissioning of the stealth Minister said.

MV Chem Pluto, with 21 Indian crew members, was struck by a drone about 217 nautical miles from Porbandar in the Arabian Sea on Saturday, prompting both the Indian Navy and the Indian Coast Guard to deploy several assets to provide assistance to the ship. A Gabon-flagged commercial

crude oil tanker with 25 crew members Indian reportedly came under a drone attack in the Southern Red Sea. Indian officials later clarified that the commercial oil tanker was not an Indian-

flagged vessel. Meanwhile, Navy Chief Admiral R Hari Kumar Navy mentioned that four warships have been deployed to counter piracy and drone attacks on merchant ships. He stated that P-8I aircraft, Dorniers, Sea Guardians, helicopters, and Coast Guard ships have all been deployed jointly to counter the threats of piracy and drone attacks. On Monday, the Navy revealed that, after the oil tanker MV Chem Pluto

reached Mumbai, analysis of

the area of the attack and

debris found on the ship pointed towards a drone attack. However, further and technical forensic analysis will be required to establish the vector of the attack, including the type and amount of explosive used. A Joint Investigation by

various agencies has commenced upon completion of the analysis by the Navy's Explosive Ordnance Team. MV Chem Pluto has been cleared for further operation by her company-in-charge in Mumbai.

The ship is scheduled to undergo mandatory checks various inspecting authorities before undertaking Ship-to-Ship (STS) transfer of cargo. This is likely to be followed by docking and repairs of the damaged portion of MV Chem Pluto.

Considering the recent spate of attacks in the Arabian Sea, the Indian Navy has deployed Guided Missile Destroyers, INS Mormugao, INS Kochi, and INS Kolkata (Guided Missile Destroyers) in various areas to maintain a deterrent presence.

Long-range maritime reconnaissance P8I aircraft are being regularly tasked to maintain domain awareness. Western

Maritime Command's Operations Centre is actively monitoring the situation in close coordination with the Coast Guard and concerned agencies.

Pakistan first Hindu woman files papers for election

Dr Saveera Parkash has become the first woman from the minority Hindu community to run in the provincial elections in Pakistan's restive Khyber

Pakhtunkhwa province. A doctor by profession, Parkash, 25, on Friday filed her nomination papers for the general seat of PK-25 in Khyber Pakhtunkhwa's Buner district, her father Om Parkash told PTI on Tuesday.

Om Parkash said his daughter filed a nomination for the general seat PK-25 constituency of the KPK Assembly from the mountainous Buner district as a Pakistan Peoples Party (PPP) candidate.

She has also filed papers for a seat reserved for women in the KPK

Assembly. Parkash filed the papers at the request of the provincial leadership of the party Senator Rubina Khalid.

She will formally get a party ticket during a PPP rally in Buner on Wednesday. "She is a serious candidate and will contest the upcoming elections due for February 8 on a general as well reserved seat," said Om Parkash, a recently retired doctor who had been an active member of the

party for the past 35 years.

According to local politician Saleem Khan, who is affiliated with the Qaumi Watan Party, Parkash is the first woman from Buner to have submitted her nomination papers to contest the upcoming elections from the

general seat.
Parkash completed her MBBS from the Abbottabad International Medical College in 2022 and is also the general secretary of the PPP women's wing in Buner.

Parkash said she wanted to follow in her father's footsteps in working for the area's poor. She said she had submitted her

nomination papers on December 23 (Friday) Parkash emphasised her desire to

work for the welfare of women in the area to ensure a safe space for them and to help them attain their

Leopard remains elusive in Sainik Farm

The Delhi Government Forest Department has not found an elusive leopard in South Delhi's Sainik Farm area after the recovery of a nilgai carcass on Monday morning.

According to Sushil Jain of Bail a Tail in Sainik Farms, there was no sighting of a leopard on Tuesday night. "My team monitored the entire night in Sainik Farm where a nilgai carcass was found. Nothing has been found. It seems the leopard has returned to the Asola Bhatti wildlife sanctuary," Jain

added. Meanwhile, panic has gripped the residents of the area as this is the second incident this month. The Residents Welfare Association of Sainik Farm issued an advisory urging residents to be careful while stepping out and also advised keeping their pets

inside. Jain said they have asked the WARWA, Sainik Farm, to install CCTV cameras in the area adjacent to sanctuary boundaries. Earlier this month, after three days of rigorous searches, the Delhi Police and Forest Department officials called off their hunt for a leopard that was spotted in the Sainik Farm area.

However, pugmarks believed to be a leopard's were seen in the area where the forest department hunted for a big cat but did not find one. The Asola Bhatti Wildlife sanctuary shares boundaries with densely populated settlements like Sangam Vihar, Chattarpur, Sainik Farms, Fatehpur Beri, and villages such as Mangar and Pali in Faridabad. Farooq Gaza analogy for Kashmir draws BJP fire

National Conference president Farooq Abdullah faced criticism from the BJP for drawing an analogy between the situation in Kashmir and Poonch civilian deaths case, he advocated for talks with Pakistan,

warning that without dialogue, the region could face a situation

similar to that of Palestinians in Gaza. Speaking to reporters, the Srinagar MP referred to former Prime Minister Atal Bihari Vajpayee's statement on India-Pakistan relations that "We can change our friends but not our neighbours". The BJP objected to Abdullah's comparison. Senior BIP leader Dr Hina Shafi Bhat criticised the veteran leader's remarks, expressing regret that a senior leader from Jammu and Kashmir is still talking about talks with Pakistan. "Farooq saab should learn now; this regime is not going to bow down before Pakistan. We tried, they

have backstabbed us again and again." In response to a question on whether India should hold talks with Pakistan, Abdullah referred to former Prime Minister Atal Bihari Vajpayee's famous statement that "we can change friends but we cannot change neighbours". "If we live in friendship with neighbours, we will both prosper, but if we live in enmity, then we cannot progress rapidly. Modiji also has said war is not an option now, and issues have to be resolved through dialogue. Where is that dialogue?" He added, "Leave aside Imran Khan. Now Nawaz Sharief is going to be the PM of Pakistan and he has been saying at the top of his voice that they are ready for talks. Why are we not talking?"

Delhi blanketed in dense fog; flights, trains services disrupted

Delhi experienced the most intense fog of this winter on Tuesday, causing visibility to plummet to zero metres at the Indira Gandhi International Airport (IGIA) and disrupting both flight and train operations. The minimum temperature dropped to nearly 7 degrees Celsius.

As of 10 am, over 100 flights were delayed at the Delhi airport, and 14 train arrivals faced delays due to the foggy conditions. The Air Quality Index (AQI) in the national capital remained in the "very poor" category, reaching 377 by 4 pm, with specific areas recording higher AQI levels. Reduced visibility due to thick fog was observed in various parts of the city, including Safdarjung, Anand Vihar, and India

At Delhi's primary weather station in Safdarjung, visibility was recorded at 200 metres at 5:30 am, while it measured 100 metres at Palam. According to Delhi airport officials, at least 55 domestic and 17 international departures, along with 39 domestic and 12 international arrivals, were delayed due to poor visibility. Additionally, five flights were diverted from Delhi to Jaipur

between 8:30 am and 10 am. The Delhi airport issued an alert to passengers regarding flight delays as dense fog persisted over the national capital for the third consecutive day, reducing visibility to nearly zero. According to the Delhi Airport Flight Information Display System data, the IGI airport is experiencing delays in both arrivals and departures for an advisory, notifying passengers

Delayed arrivals in Delhi include Puri-New Delhi Purushottam Express, Howrah-New Delhi Poorva Express, Kanpur-New Delhi Shramshakti, Allahabad-New Delhi Prayagraj, Azamgarh-Delhi Kaifiyat Express, Bhagalpur-Anand Vihar Vikramshilla, Gaya-New Delhi Magadh Express, Dibrugarh-New Delhi Rajdhani, Durg-Nizamuddin

Samparkkranti, Chennai-New Delhi GT Express, Hyderabad-New Delhi Telangana, Habibgang-New Delhi Bhopal Express, Khajuraho-Kurukshetra Express, and Vasco-Nizamuddin Goa Express.

Meteorological India The Department (IMD) forecasts that dense to very dense fog is likely to persist over northwest and parts of adjoining central India for the next 3-4 days. Foggy conditions are expected from December 29 to December 30, with a slight dip in the minimum temperature, according to the weather department. Morning scenes from Delhi's

India Gate, Sarai Kale Khan, AIIMS, Safdarjung, and Anand Vihar areas revealed a dense fog, significantly reducing visibility.

Blast near Israeli embassy in Delhi

blast took place on Tuesday Aevening near the Israel embassy located in the New Delhi district but no explosive has been found yet. A letter addressed to the Israeli ambassador has been found near the country's embassy in the national capital, minutes after reports of an explosion there. The letter, sources said, is typed and "abusive" in nature. The authenticity of the letter is being verified, police said. They also found a flag wrapped with the letter. The letter has been seized by the police.

Israeli embassy spokesperson Guy Nir said, "We can confirm that around 5:48 pm, there was a blast in close proximity to the embassy. Delhi Police and the security team are still investigating the situation."Deputy Chief of Mission (Israel) Ohad Nakash Kaynar said, "All our diplomats and workers are safe. Our security teams are working in full cooperation with local Delhi security and they will investigate the matter fur-

The blast was reported to the authorities on a call by an unidentified caller to the Delhi Fire Service at around 6 pm earlier on Tuesday. The caller claimed that an explosion took place on an empty plot behind the Israeli Embassy. The identity of the caller, as well as the



motive, is currently under investigation. Israel Embassy is located along Dr APJ Abdul Kalam Road in the national

According to Delhi Fire Services officials, they received a call about the blast at 5:45 pm and it was transferred from the Delhi Police PCR (police control room). The fire department immediately sent two fire engines to the spot. Delhi Police and the security team are still investigating the situa-tion." A guard deployed at Hindi Bhawan told the media that he heard a loud noise behind the embassy and informed the police. According to him, the incident took place at around 5 pm.

"This happened around 5 pm, I was on my duty and heard a huge sound. When I came out, I saw smoke coming from the top of a tree, that's all I

saw...The police have taken my statement," he said. A team of Delhi Police's Special Cell has also reached the spot. The area has been cordoned off and security personnel have been

This comes amid a war between Israel and Hamas in Gaza. Earlier, Delhi Police had beefed up security around the Israeli embassy and Chabad House in the capital.

The local police stationed around the embassy in New Delhi and Chabad House, located in Chandni Chowk in central Delhi, had been directed to maintain a tight vigil. Additional police vehicles have been deployed outside the Israeli Embassy and the official residence of the Israeli Ambassador to India, Naor Gilon. Union Home Minister Amit Shah and BJP national president JP Nadda on Tuesday created a 15-member election management committee for Bengal, sources in the saffron party said adding the election committee for the 2024 general polls would comprise Shah, Nadda, State party president Sukanto Majumdar, Opposition Leader Suvendu Adhikari and Amitabh Chakrabarty.

Defence Minister Rajanth Singh to the frontier districts of Rajouri and Poonch on Wednesday, the Indian army has further intensified its relentless search and combing operations in the general area of Dera ki Gali of Surankote tehsil to track down the footprints of the foreign terrorists. Army Chief General Manoj Pande during his visit to Rajouri on Monday had directed the field commanders to conduct operations in the 'most professional manner". Four soldiers were killed in action when these suspected foreign terrorists ambushed two army vehicles in the Dera Ki Gali area of Surankote tehsil in Poonch district on December 21. The terrorists had taken advantage of the poor road conditions and thickly forested belt, far away from the nearest residential habitats to target the army vehicles.

India to launch surveillance after vaccine-derived polio virus detection ARCHANA JYOTI - NEW DELHI

m ollowing}$ detection of vaccine-derived polio virus (VDPV) in sewage samples last year in Kolkata in 2021, an alarmed India is now gearing up to launch a nationwide surveillance from January 1, 2024 to ascertain whether the pathogen is present in any case of clinically diagnosed child with primary immune deficient (PID), a rare class of hereditary diseases.

The Sentinel site based iVDPVs surveillance will be conducted at 21 identified sites in the States in the four zones of the country. A vaccine-derived polio virus is a rare variant that mutates from the strain contained in the oral polio vaccine (OPV).

To mitigate the individual and community risks posed by iVDPVs during the polio endgame and the post-eradication era, it is important to identify those PID patients excreting polioviruses and provide the strategies and treatments available to rid both the individual and the community of the risk posed by iVDPVs, said Dr Pawan Kumar, Additional Commissioner (Imm) from the Union Health Ministry to the concerned officials in the States. Doctors say, individuals with PID can excrete polioviruses (iVDPVs) for prolonged peri-ods, which could act as a source of transmission of pathogens for months and go undetected by acute flaccid paralysis surveil-

The ED sought their remand for five days, claiming they were required to be confronted with the other accused arrested in the case

The police complaint was filed by the Corporate Affairs Ministry alleging that GPIC-

"forged" identification documents and "falsified" addresses at the time of incorporation of the company in December

This company had its registered addresses in Himachal Pradesh's Solan, Gujarat's Gandhinagar and in Jammu. The crackdown on the leading Chinese company came after ED found that three Chinese nationals, all of whom left India between 2018 and 2021, and another person from that country incorporated 23 companies in India in which chartered accountant Nitin Garg allegedly assisted them.

"The allegations (made by the Corporate Affairs ministry) were found to be true as the investigation revealed that the addresses mentioned by the directors of GPICPL did not belong to them.

In fact, it was a government building and the house of a senior bureaucrat," the ED

Atishi finds seepage in **Saket Court Complex**

Delhi Law Minister Atishi inspected the Saket Court Complex on Tuesday morning and found issues of seepage in newly constructed blocks of the court complex. Upon observing the poor building maintenance, the minister pulled up the Public Works Department officials and instructed them to urgently

address all issues promptly. Immediate action has also been ordered to address the recent problems in the newly constructed building blocks, with strict instructions to take stringent action against the responsible engineers

During the inspection, she observed issues of seepage in newly constructed blocks of the court complex, leading to dampened walls. Moreover, severe concerns of dampened walls was also raised by the Judges and lawyers present at Court - indicating to basic architectural defects and improper construction.

Expressing dissatisfaction with the state of the court premises, the Law Minister emphasised that "the Saket Court Complex is regularly used by a large number of judges, lawyers, and their staff. It is the government's responsibility to ensure that these individuals face no inconvenience while performing their duties

She asked officials to swiftly resolve these issues and take strict action against responsible engineers and contractors. The Law Minister stressed that the "Court is a prestigious institution where thousands come in pursuit of justice every day, and negligence in the court's maintenance will simply not be tolerated. Stern action must be taken for inconvenience caused to judges, lawyers and

She instructed officials to create a comprehensive checklist for necessary maintenance and repairs, addressing all issues promptly. The minister stated that the government is improving the infrastructure of court premises and providing all necessary facilities, and lapses are absolutely unacceptable in pursuit of this cause.

Meanwhile, the PWD has ordered a structural audit of the judicial residential complex of Saket court, besides seeking an FIR against the contractor responsible for its poor condition. According to an internal inspection report, the condition of the building started to deteriorate within six months of its construction. 1 labourer killed, another seriously injured in lift crash in Narela building

A 40-year-old labourer was killed and another suffered serious injuries in outer Delhi's Narela area after the cable of a lift installed at a factory snapped, police said on

The accident took place on Monday night, when Nemi Chand and Anirudh Chauhan (28) were climbing the upper portion of the factory.

The lift was already loaded with heavy construction material. As the lift reached the first floor, its cable broke and it had a free fall from the first floor to the basement from a height of around 30 feet," a senior police officer

"We have taken custody of the body of Chand. It has been sent for autopsy, while injured Chauhan was rushed to the hospital," the officer

Police have registered an FIR under sections 287 (negligent conduct with respect to machinery), 337 (causing hurt



ligence), of the Indian Penal Code (IPC), against the owner and the contractor of

Investigation of the spot revealed that the cable of the lift snapped due to which it had a free fall, police said.

Both had received serious injuries and were rushed to hospital, where Chand died during treatment. We got to know that Chauhan, along with Chand, was going to the first floor to cook, when the cable of the lift snapped. Both were working as labourers and had been staying there," an investigator said.

AAP Government not giving old age pension for 5 years: Bidhuri

Leader of the Opposition in Legislative Assembly Ramvir Singh Bidhuri on Tuesday charged that the Arvind Kejriwal gov-ernment has discontinued old age pension for the elderly for the last five years. Bidhuri also said not only are

new applicants not receiving pensions, but even with over one lakh vacancies, new individuals are not being granted pensions, while more than two lakh elderly individuals are pleading for pensions. Bidhuri mentioned that the Delhi government not only maintains an inhumane perspective towards the elderly but is also committing con-tempt of the Delhi High

Court's orders. It has been reported that on October 17, 2018, the Kejriwal government issued an order stating that applications for the new pension can only be made through the MLA's ID. People protested this arbitrary order and approached the Delhi High Court.

The court immediately can-



celled the order, emphasizing that applications for the new pension can be submitted individually, Bidhuri said. Expressing dissatisfaction with the order of the High Court the Delhi government did not accept any new application, he added.

Bidhuri stated that not only is the government not approving new applications, but it is also not providing approved pensions. While 5,30,000 elderly individuals in Delhi are eligible for pensions, only 4,29,210 receive them.

This means that an additional 1,00,790 elderly individuals could be granted pensions, but the Delhi government is not making any decision on this sensitive matter. Tulips to bloom all across Delhi after NDMC, DDA plan to increase plantation

 $F^{\rm or}$ the first time, the city would see tulips blooming in such a large number not just in Lutyens' Delhi but other parts of central, west and north Delhi. While New Delhi Municipal Council (NDMC) will plant two lakh bulbs in its area compared to 1.23 lakh bulbs in 2022 and 65,000 bulbs imported in 2021 from the Netherlands, DDA will plant one lakh bulbs in its parks. The increase in plantation of Tulips and other flowers across

the city is in line with the emphasis given by Lieutenant Governor's goal of turning the Capital into a 'City of Flowers'. At least500 Tulip bulbs have also been planted

in the Raj Niwas Campus for the first time. While Tulips will be planted in 65 locations, other winter flowers would adorn the Capital at 91 loca-

These bulbs and other flowering plants will sprout in places such as Central Park, NDMC headquarters, Akbar Road, Windsor Place roundabout, Shanti Path, Talkatora Garden, Ashoka Road, India Gate, Race Course Road, Mandi House, Parliament roundabout and the vicinity of the Vice-President's bungalow (Akbar Road and Maulana Azad Road), and 11 Murti. This year, tulip bulbs will grow into flowers of six colours - white, yellow, red, pink and two in shades of yel-



low-red and white-red and other varieties of seasonal flowers like Petunia, Salvia, Cineraria, Antirrhinum, Poppy, Verbena, Dianthus, Hollyhock, Nasturtium, Coreopsis, Pansy, Lianum, etc will be planted soon at prominent locations for full public view. Each of these bulbs cost According to Raj Niwas offi-

cial, Lieutenant Governor Vinai Kumar Saxena over the year chaired meetings and discussions with Horticulture Divisions of various Departments and Agencies and their future preparedness with regards to flower plantation and other activities.

"Brahmos Aerospace installed Brahmos missile on the ship. Torpedo tube launchers are of Larsen & Toubro (L&T). Former Brazilian president Jair Bolsonaro is second on the list of subscriber numbers with around 64 lakh -- less than a third of Modi's.

In terms of views, Ukrainian President Volodymyr Zelenskyy is second to the Indian prime minister with 22.4 crore, a small fraction of Modi's.

US President Joe Biden has 7.89 lakh subscribers while his Turkiye counterpart Recep Tayyip Erdogan has 3.16 lakh. 'Yoga with Modi', a YouTube channel linked to the prime minister, is also high on the list with more than 73,000 subscribers.

Modi's channel, with its 4.5 billion (450 crore) video views, outshines the competition, setting the benchmark for political leaders on YouTube. This achievement underscores his global popularity, consistently highlighted in various surveys, including Morning Consult, where he has been consistently rated as the most popular global leader with an approval rating exceeding 75 per cent.

Among other notable Indian leaders, former Congress chief Rahul Gandhi's channel has more than 35 lakh subscribers, a little over a sixth of Modi's.

The prime minister set up his YouTube channel in 2007 when he was Gujarat chief minister and is considered a pioneer in Indian politics in understanding the potential of social media in public communication and is credited for harnessing it to huge

Researchers uncover mechanism that allows TB persistence in body

 $R^{\text{esearchers}} \ \text{at the Indian} \\ \text{Institute of Science (IISc)}$ have uncovered an important mechanism that allows the tuberculosis (TB) bacterium to decades. The team, including researchers from the National Centre for Biological Sciences (NCBS) and Institute For Stem Cell Science and Regenerative Medicine (InStem), Bengaluru, found that a single gene involved in the production of iron-sulphur clusters could be crucial for the persistence of the

TB bacterium. is caused Mycobacterium tuberculosis (Mtb), which can be present in the human body for decades

without any symptoms. "Mtb needs humans to survive. In many cases of Mtb infection, the immune system can detect the bug and clear it out," said Mayashree Das, a PhD student at IISc, and first author of the study published in the journal Science Advances.

However, in several asymptomatic individuals, Mtb hides within deep oxygen-limiting pockets of the lung and enters a state of dormancy in which it does not divide and is metabolically inactive, successfully evading the immune system and TB drugs.

"Due to persistence, there is a bacterial reservoir in a subset of the human population at any point which can reactivate and cause infection. Unless we understand persistence, we will not be able to eradicate TB," said Amit Singh, Associate Professor at IISc and corresponding author of the study. Ŝingh's team grew Mtb in liquid cultures containing special supplements needed for its growth.

Several proteins in Mtb depend on iron-sulphur clusters for functioning. These clusters consist of iron and sulphur atoms organised in various configurations like chains or cuboids.

The iron atoms in the cluster can pass on electrons from one site of a protein complex to another in cellular reactions such as respiration and carbon

robust collaborations and informetabolism. "The iron-sulphur clustercontaining proteins are impor-

tant for essential processes such as energy production by respiration, enabling the bacteria to survive harsh conditions of the lungs and causing infection. So, we wanted to study the mechanisms that Mtb uses to build these ironsulphur clusters," said Singh. These clusters are mainly produced by Mtb's SUF operon, a

said. However, there is another single gene called IscS that can also produce the clusters, they said.

To solve this mystery of why the bacterium needs both, the researchers generated a mutant version of Mtb that lacked the IscS gene.

They found that under normal and oxygen-limiting conditions, iron-sulphur clusters are produced mainly by the action of the IscS gene. However, when the bacterium

faces a lot of oxidative stress, the iron atoms of the clusters become oxidised and released, damaging the clusters. Therefore, there is an increased demand for producing more clusters, which switches on the SUF operon.

The researchers then sought to find out how the IscS gene contributes to disease progression. They infected mice models with the mutant version of Mtb lacking the IscS gene. The absence of the IscS gene

led to severe disease in the infected mice rather than a persistent, chronic infection typically seen in TB patients. This is because, in the absence of the IscS gene, the SUF oper-

on is highly activated - but in an unregulated fashion - leading to hypervirulence, the researchers said. Depleting both IscS and the SUF system dramatically

Manpower abroad for software can get tax relief: Karnataka HC

m he}$ High Court of Karnataka has set aside three reassessment notices of the Income Tax Department against EIT Services India Ltd (formerly Hewlett Packard) for three assessment years issued by the Income Tax Department and ruled that deputing manpower abroad for software development is eligible for tax exemption under Section 10A of the IT Act. The Commissioner of Income Tax (CIT), Bengaluru had ordered for the re-examination of the claim for deduction under Section 10A/80HHE of the Income Tax Act for the assessment years 2005-06, 2006-07 and 2007-08 on the ground that "part of the petitioner's profits was related to rendering technical services outside India which was not eligible for

deduction. The company filed three writ petitions challenging the re-assessment notices which was heard by the bench of Justice S Sunil Dutt Yaday. The HC in its judgement on December 19 cited a circular issued by the Ministry of Finance in 2013 which clarified that "expenditure incurred for services to develop software outside India could be allowed under Section 10A of the IT Act if deputation is for development of software."

'Church destroyed identity of Tripura indigenous people'

Accusing the church of destroying the identity of indigenous people, Janajati Suraksha Manch (JSM) leader Prakash Singh Uikey on Tuesday said they will not allow those who are attempting to convert tribal families.

Uikey said the day is not far when people will have to visit museums in order to witness the culture of two ethnic tribes, the Reangs and Tripuris. According to Uikey, the church has destroyed the "unique identity" of the tribals by using conversion as a tool. "For the past 70 years, tribals who continued to adhere to their own customs, rituals, beliefs, traditions and culture have been deprived of receiving benefits guaranteed



by the Constitution under Article 342 because of conversion," he said while addressing a rally here demanding the delisting of converted tribals.

"After conversion, do the tribals follow their old tradition, culture and custom? That's why we want the Scheduled Tribe (ST)

Uikey also made a reference to the abrogation of Article 370 of the Constitution which used to grant special status to Jammu & Kashmir.

Gaining currency

The first payment in rupees to the UAE for crude oil gives a major push for making it a global currency

■ n a significant development in global trade and finance, India has made its first-ever payment for oil in rupees to the United Arab Emirates (UAE), marking a potential turn-Ing point in the quest to establish the rupee as a global currency. This move not only strengthens economic ties between India and the UAE but also has broader implications for the international financial landscape. The historic transaction took place as part of a trade agreement between India and the UAE, where India paid for a consignment of crude oil in its own currency rather than the traditionally used US dollar. This departure from the standard practice is seen as a bold step that could have a cascading effect on global trade dynamics. The move by India to make payments in rupee aligns with the nation's broader strategy of diversifying its currency reserves. Historically, the US dollar has been the dominant currency for international trade. By opting for the rupee, India is taking a step towards reducing its dependence on dollar and promoting the use



of its currency. The arrangement with the UAE proves that India has truly arrived in the world arena. Not only do many countries look up to India for direction and support but also follow the path it treads. As External Affairs Minister S Jaishankar rightly pointed out, the era of a bipolar world is over and "we are into a multipolar world" where a number of countries play pivotal roles. The payment in rupees not only has economic implications but also strengthens economic and strategic ties between India and the UAE.

It reflects confidence in each other's economies and sets a precedent for other nations to explore alternative currency options. However, it is not to suggest that

the Indian rupee is anywhere near the dollar. The US dollar has long been the dominant currency in global trade, accounting for nearly 60 per cent of all foreign exchange (Forex) reserves and more than 80 per cent of global forex trading worldwide. One of the advantages of conducting trade in local currencies is the reduction of currency exchange risks. By sidestepping the need for conversions into a third-party currency like the US dollar, both India and the UAE can potentially save on transaction costs and minimise exposure to exchange rate fluctuations. Other countries may now be inspired to explore similar arrangements, challenging the longstanding dominance of the US dollar in the international financial system. But the initiative to make rupee payments poses certain challenges, too. The rupee is not as widely traded as the US dollar or the euro, which may hinder its immediate adoption on a large scale. Additionally, concerns about the rupee's stability and the need for a robust financial infrastructure will need to be addressed for the currency to gain broader acceptance. While challenges remain, the move surely signifies a shift in the traditional dynamics of international trade and finance. The global financial landscape may witness further diversification in currency usage, challenging the dominance of the dollar and contributing to a multipolar world economy.





angladesh"s 12th parlia-mentary elections are to be held 11 days from now. The question is will it be a walkover/cakewalk for Prime Minister Sheikh Hasina-led Awami League into her fourth consecutive and fifth overall term in office? When I was in Dhaka last month and asked people who would win the election, most including one person from our Embassy responded that if it was a free and fair election under a caretaker government Begum Khaleda Zia's Bangladesh National Party would win. Antiincumbency, price rise, unemployment and corruption, the usual culprits, were quoted as reasons for people's discontentment. In Dhaka, I witnessed mass mobilisation protests by the BNP that were countered by AL counter-protests leading to violence and wide scale arrest of BNP leaders and workers. Readymade Garment Workers - garment factories account for 85 per cent of Bangladesh's USD 53bn exports - also called hartal over wage dispute. Since 28 October, BNP's 12th hartal was held last week. No matter their stance on science, these nominees have made a lasting impression. Reporters and editors at Nature assess people whose positions have significantly influenced science or whose impact on the world is significant as part of the selection process. The list includes short biographies of the people responsible for some of the year's most important discoveries and events.

The compilation also features five people named "ones to watch" for the coming year. This year's list, which was published on December 13, made every Indian proud as it featured our Kalpana Kalahasti, who played a crucial part in ensuring Chandrayaan-3's triumphant touchdown on the Moon, along with global stalwarts.

The basic objective of ChatGPT is to maintain discussions reasonably and compellingly that are consistent with its training data. Nevertheless, in the process of achieving this objective, it, along with other generative artificial intelligence (AI) programmes, is transforming the landscape of scientific endeavour. The advent of this transition has rekindled conversations about the limits of artificial intelligence (AI), the fundamental nature of human intellect, and the most effective ways to regulate the interaction between the two. It can form only a part of a comprehensive scheme for the outlook and the belief that fundamentally, men and women are souls and that each has a role complementary to the others.

Society must also be given the realisation that there is a moral law in the world, which none, however high and influential can violate with impunity that a person who can go to the extent of extracting dowry from his wife and can indulge in wife-beating or wife-burning, is a mere degenerate who, in his day-to-day dealings, can throw all moral norms to winds and the first thing, therefore, needed is to reform this potential criminal rather than give him a girl in marriage. So, c'mon let us all make a strong resolve to educate our girls and sensitize our boys to burn this evil system from its roots & make a society where each soul has a right to live with dignity & self-respect.

A recap of turmoil and triumphs in 2023



The defining year of AI, 2023, offered us glimpses into understanding the plight of humanity under 'despotic democracy' in many purported democratic nations

he year 2023 witnessed a pro-found clash between human existence and technological ascension. As machines surpassed algorithmic boundaries, humanity, paradoxically, embraced a perilous sprint towards self-imposed ignorance. From the ruthless expulsion of Afghan War refugees by Pakistan to the relentless march of Artificial Intelligence reshaping life's core, the world grappled with unprecedented shifts. Emerging threats in space programs and manufactured wars in Ukraine and elsewhere set a foreboding tone, while natural disasters claimed lives across Turkey, Morocco, and Afghanistan. In the midst of these upheavals, the demographic landscape transformed, as India eclipsed China as the most populous nation. In this crucible of change, human-ity stands at the crossroads of technologi-cal marvels and enduring struggles, navigating an uncertain future.

In the Middle East, optimism for improved relations crumbled as Hamas attacked Israel, leading to the deadliest day in the nation's history. The conflict escalated, drawing global condemnation for alleged war crimes and prompting a U.S. shift from unequivocal support to calls for protecting civilians, leaving the resolution and aftermath uncertain as the year concluded. Simultaneously, Artificial Intelligence (AI) reached a pivotal juncture in 2023, notably exemplified by the advancement of technologies like large language models (LLM). The latest iteration, reportedly ten times more sophisticated, fueled rapid interest from governments, businesses, and individuals. Optimists lauded AI's role in scientific breakthroughs, while pessimists warned of societal risks, including mass unemployment and heightened social inequalities. The year emerged as a defining moment for AI, epitomized by figures like Altman pushing boundaries, emphasizing the inevitability of business evolution, and underscoring AI's potential to reshape civilization itself, echoing Aldous Huxley's words, 'civilization is sterilization.'

In 2023, climate change ceased to be a distant threat, emerging as an undeniable global reality. The year potentially witnessed record-high temperatures in the last 125,000 years, breaching the 2°C limit set by the 2015 Paris Agreement and triggering a deluge of extreme weather events. From historic wildfires to punishing droughts and ecord floods, the consequences were stark. The ominous notion of wet bulb temperature' entered the global lexicon, highlighting the lethal combination of high humidity and temperatures. Amid this crisis, glimpses of optimism appeared, with surging investments in clean energy and the promising emergence of hydrogen. However, scepticism persisted regarding the scalability of these solutions against the backdrop of escalating fossil fuel production. International forums like the COP-28 provided conversational platforms, yet the vast chasm between rhetoric and action underscored the daunting challenge of effectively addressing climate change.

In purported 'democratic nations,' individuals often find themselves compelled to adhere to what is termed a 'despotic democracy,' where the emphasis lies on the will of the majority, fostering a system adept at constructing a series of fantasies to perpetuate its influence through human idiocy in decision-making. Conversely, the democratic fabric, particularly in Africa, is experiencing upheaval, as evidenced by

coups casting doubt on the stability of democracies. The military ousting of Niger's democratically elected president in July triggered regional tensions while neighbouring juntas in Mali and Burkina Faso responded with threats of war. In August, Gabon witnessed a military takeover with vague promises of eventual elections.

As 2024 unfolds, elections will define the political landscape across Asia, Africa, Latin America, and the West. Across Asia in particular, democracies representing 2.2 billion people and a combined GDP of US\$8.9 trillion brace for pivotal polls. From the scheduled January elections in Bangladesh to pivotal contests in India, Russia, and the United States, where the Presidential race in November holds significant weight, the global stage is set for political upheaval. Anticipation surpower for the ruling Awami League in Bangladesh, securing a fourth consecutive term and affirming Sheikh Hasina's status as the world's longest-serving female leader. In the electoral theatre, the ejection seat holds the fate of leaders like Justin Trudeau in Canada, with Conservative leader Pierre Poilievre eyeing a potential succession bid. In troubled Ukraine, martial law President

VolodymyrZelenskyy from elections, allowing him to consolidate power. Despite a desperate plea for military service targeting Ukrainian men aged 25 to 60 abroad, over 700,000 from this group have fled since the conflict's onset, casting doubts on the enforceability of the invitation that carries the threat of sanctions for non-compliance. In 2023, Ukraine's counteroffensive against the Russian army faced resistance, leaving 18% of its territory still under Russian control. The war persists, and Vladimir Putin remains confident in Russia's ability to outlast Western support for

India, with its Lok Sabha election in April-May 2024, anticipates the incumbent coalition, led by the Bharatiya Janata Party (BJP), to secure a resounding victory. Prime Minister Narendra Modi, a diplomatic linchpin, played a crucial role in bridging global disparities during 2023. As the chasm between wealthy democracies and develop-ing nations widened, Modi's adept diplomacy fostered compromises on climate policy and debt issues. Emphasizing national interest, Modi's leadership in the G7 and G20 reinforced India's standing on the global stage, though the quality of once-celebrated democracy inhouse appeared to be frightening. On the flip side, President Xi Jinping, his main competitor, has played a significant role on the global political stage, engaging in BRICS and APEC, and spearheading peace efforts for Ukraine and Palestine. In the Maldives, the political scene shifts with the opposition coalition, led by the Progressive Party of Maldives (PPM) and the People's National Congress, anticipating a parliamentary majority in the 2024 elections. President Mohamed Muizzu, triumphant in the 2023 presidential race, positions himself for streamlined policymaking amidst the changing geopolitical landscape marked by uncertainty and determination. Meanwhile, Indonesia anticipates a seismic moment as presidential and legislative elections coincide in February, with predictions of a run-off in mid-2024. PrabowoSubianto, supported by incumbent Joko Widodo

chairman of the Great Indonesia Movement Party (Gerindra) and the current defence minister. In South Korea's April legislative election, prevailing expectations point to the liberal Minjoo Party securing parliamentary dominance, albeit with a reduced seat share. Iran, too, braces for legislative elections amid another political transformation. Pakistan's National Assembly election in February is poised to elevate the ruling coalition, led by the Pakistan Muslim League (Nawaz), with military alliances fortifying their majority. Sri Lanka, marred by economic collapse in 2022, anticipates a presidential election by September. However, the incumbent president contemplates delaying the election to extend the IMF program's impact. Mongolia charts its course with parliamentary elections in June, where the ruling Mongolia People's Party (MPP) aims to retain dominance, albeit with a potentially narrower margin. In 2024, the technopolar world, as framed by Ian Bremmer, may intensify the polarization of multipolarism and politics, spanning the West and the Global South. A looming spectre emerges, teasing the possibility of an investable space conflict, an unprecedented venture into the unknown. In this tumult, the certainties we once knew may dissipate, leaving a transformed world where the only constant is change. Here's to navigating the uncharted waters of 2024, where the very essence of humanity may find itself reshaped amid the dynamic forces at play. Rise in child labour: Why children always pay the price

Studies by ILO show a significant rise in child labour in India in recent years, mostly driven by the Covid 19 pandemic

t was a bitterly cold win-ter night. But child activist Kailash Satyarthi and his team hardly felt the chill. The burning determination to rescue bonded labourers, especially children, employed at the stone quarry in Haryana's Dadri Kalan, helped them ignore the falling temperatures as they waited for the right moment to achieve their goal. Discreet investigations prior to this rescue mission had revealed that the best time to raid the quarry was between 5 and 6 am. It was around this time that the gun-toting guard took an hour-long break and went to his village to freshen

As soon as the clock struck five and the guard left, Satyarthi and his team swung

into action. They managed to rescue 40 labourers, many of them children. While the adults were helped into the waiting truck, Satyarthi bundled as many children as possible in his car and drove off as fast as he could. While driving, he remembered there were some bananas in the

back of the car. He asked one of the children to distribute them to everyone. To his shock, he realised the children had never seen a banana before when they said they had never seen an onion or potato in this shape before. When he explained the banana was an edible fruit, the children began biting into it without knowing that it had to be peeled first. The sadness that had engulfed Satyarthi on seeing labour and slavery over the

The 270-page book highlights how children are trafficked, physically and sexually abused and forced into child labour.

Whether it is the story of Sabo, a girl rescued from a brick kiln in 1981, or of emaciated Bhavna, who took

years to overcome her trauma of being sexually exploited at the circus she was forced to work in, or of little Kalu labouring in rug weaving, their heart-wrenching accounts are a harsh reminder that the scourge of child labour needs to be completely eliminated. According to studies by the ILO and the Campaign Against Child Labour, there has been a significant rise in child labour in India in recent years. While much of it has been driven by the Covid 19 pandemic and the closure of schools, why is it that children always pay the

Biden orders strikes on Right to protest under threat in Britain **Iranian-aligned group**

AP WASHINGTON

President Joe Biden ordered the United States military to carry out retaliatory airstrikes against Iranian-backed militia groups after three US service members were injured in a drone attack in northern Iraq. National Security Council spokesperson Adrienne Watson said one of the US troops suffered critical injuries in the attack that occurred earlier Monday. The Iranianbacked militia Kataib Hezbollah and affiliated groups, under an umbrella of Īranian-backed militants, claimed credit for the attack that utilized a one-way attack

Iraqi officials said US strikes targeting militia sites early Tuesday killed one militant and injured 18. They came at a time of heightened fears of a regional spillover of the Israel-Hamas war. Iran announced Monday that an Israeli strike on the outskirts of the Syrian capital of Damascus killed one of its top generals, Razi Mousavi, who had been a close companion of Gen Qassem Soleimani, the former head of Iran's elite Quds Force. Soleimani was slain in a US drone strike in Iraq in January

Iranian officials vowed revenge for the killing of Mousavi but did not immediately launch a retaliatory strike. The militia attack Monday in northern Iraq was launched prior to the strike in Syria that

killed Mousavi. Biden, who was spending Christmas at the presidential retreat at Camp David, Maryland, was alerted about the

attack by White House national security adviser Jake Sullivan shortly after it occurred Monday and ordered the Pentagon and his top national security aides to prepare response options to the attack on an air base used by American troops in Irbil. Sullivan consulted with Defense Secretary Lloyd Austin. Biden's deputy national security adviser, Jon Finer, was with the president at Camp David and convened top aides to review options, according to a US official, who was not authorised to comment publicly and requested anonymity. Within hours, Biden convened his national security team for a call in which Austin and Gen CQ Brown, chair of the Joint Chiefs of Staff, briefed Biden on the response options. Biden opted to target three locations used by Kataib Hezbollah and affiliated groups, the official

The US strikes were carried out at about 4:45 am Tuesday in Iraq, less than 13 hours after the US personnel were attacked. According to US Central Command, the retaliatory strikes on the three sites "destroyed the targeted facilities and likely killed a number of Kataib Hezbollah militants."

"The President places no higher priority than the protection of American personnel serving in harm's way," Watson said. "The United States will act at a time and in a manner of our choosing should these attacks continue."

The latest attack on US troops follows months of escalating threats and actions against American forces in the region since the October 7 Hamas attack on Israel that sparked the devastating war in The dangerous back-and-

The US has thousands of troops in Iraq training Iraqi forces and combating remnants of the Islamic State group, and hundreds in Syria, mostly on the counter-IS mission. They have come under dozens of attacks, though as yet none fatal, since the war began on October 7, with the US attributing responsibility to Iran-backed groups. "While we do not seek to escalate conflict in the region, we are committed and fully prepared to take further necessary measures to protect our people and our facilities," Austin said

Britain is one of the world's oldest democracies, home of the Magna Carta, a centuriesold Parliament and an independent judiciary. That democratic system is underpinned by an "unwritten constitution" a set of laws, rules, conventions and judicial decisions accumulated over hundreds

The effect of that patchwork is "we rely on selfrestraint by governments," said

GOVERNMENT TAKES AIM AT PROTESTERS

The canaries in the coal mine of the right to protest are

environmental activists who have blocked roads and bridges, glued themselves to trains, splattered artworks with paint, sprayed buildings with fake blood, doused athletes in orange powder and more to draw attention to the threats posed by climate change.

The protesters, from groups such as Extinction Rebellion, Just Stop Oil and Insulate Britain, argue that civil disobedience is justified by a climate emergency that threatens humanity's future.

Sunak has called the protesters "selfish" and "ideological zealots," and the British government has responded to the disruption with laws constraining the right to peaceful protest. Legal changes made in 2022 created a statutory offense of "public nuisance," punishable by up to 10 years in prison, and gave police more powers to restrict protests judged to be disruptive.

It was followed by the 2023 Public Order Act, which broadened the definition of "serious disruption," allowing police to search demonstrators for items including locks and glue. It imposes penalties of up to 12 months in prison for protesters who block "key infrastructure," defined widely to include roads and bridges.

The government said it was acting to "protect the law-abiding majority's right to go about their daily lives." But Parliament's cross-party Joint Human Rights Committee warned that the changes would have "a chilling effect on the right to protest."

Days after the new act took effect in May, six antimonarchist activists were arrested before the coronation of King Charles III before they had so much as held up a "Not My King" placard. All were later released without

In recent months the pace of protests and the scale of arrests has picked up, partly as a result of a legal tweak that criminalized slow walking, a tactic adopted by protesters to block traffic by marching at low speed along roads.

t least 140 people were At least 140 people were killed by gunmen who attacked remote villages over two days in north-central Nigeria's Plateau state, survivors and officials said Tuesday in the latest of such mass killings this year blamed on the West African nation's farmer-herder crisis.The assailants targeted 17 communities during the "senseless and unprovoked" attacks on Saturday and Sunday, during which most houses in the areas were burned down, Plateau Gov Caleb Mutfwang said Tuesday in a broadcast on the local Channels Television.

"As I am talking to you, in Mangu local government alone, we buried 15 people. As of this morning, in Bokkos, we are counting not less than 100 corpses. I am yet to take stock

of (the deaths in) Barkin Ladi," Gov Mutfwan said. "It has been a very terrifying Christmas for us here in Plateau." Amnesty International Nigeria's office told The Associated Press that it has so far confirmed 140 deaths in the Christian-dominated Bokkos and Barkin-Ladi local government areas of Plateau based on data compiled by its workers on the ground and from local officials, though locals feared a higher death toll with some people unaccounted for. Some of the locals said that it took more than 12 hours before security agencies responded to their call for help, a claim the AP couldn't independently verify, but which echoes past concerns about slow interventions in Nigerias deadly security crisis, which

"I called security but they never came. The ambush started 6 in the evening but security reached our place by 7 in the morning," said Sunday Dawum, a youth leader in Bokkos. At least 27 people were killed in his village, Mbom Mbaru, including his brother, he said.

No group took responsibility for the attacks though the blame fell on herders from the Fulani tribe, who have been accused of carrying out such mass killings across the northwest and central regions where the decadeslong conflict over access to land and water has further worsened the sectarian division between Christians and Muslims in Africa's most populous nation.

The Nigerian army said it has begun "clearance operations" in search of the suspects, with the help of other security agencies, although arrests are rare in such attacks.

"We will not rest until we bring all those culpable for these dastardly acts to book," said Abdullsalam Abubakar, who commands the army's special intervention operation in Plateau and neighbouring

Nigerian President Bola Tinubu, who was elected this year after promising to help tackle the security challenges that his predecessor failed to address, has yet to make any public comments about the latest attacks days after they happened. -Tinubu's government and

others in the past haven't taken any "tangible action" to protect lives and ensure justice for victims in the conflict-hit northern region, Amnesty International Nigeria director Isa Sanusi told the AP.

Turkish parl committee resumes debate on Sweden's NATO bid

Ankara (AP): The Turkish parliament's foreign affairs committee was poised on Tuesday to resume deliberations on Sweden's bid to join NATO, days after President Recep Tayyip Erdogan linked the Nordic country's admission on US approval of Turkiye's request to purchase F-16 fighter jets. NATO-member Turkey lifted its objection to Sweden joining the trans-Atlantic alliance in July but the ratification process has since stalled in parliament. Turkiye accuses Sweden of not taking Turkiye's security concerns seriously enough, including its fight against Kurdish militants and other groups that Ankara considers to be secu-

rity threats. This month, Erdogan threw another obstacle by openly linking ratification of Sweden's NATO member-ship to the US Congress' approval of Turkiye's request to purchase 40 new F-16 fighter jets and kits to mod-

ernise its existing fleet. The Turkish leader also to act "simultaneously" and said Canada and other NATO allies must lift arms embargoes imposed on

The White House has backed the Turkish F-16 request but there is strong opposition in Congress to military sales to Turkiye.

The Turkish parliament's foreign affairs committee had begun discussing Sweden's membership in NATO last month. The meeting however, was adjourned after legislators from Erdogan's ruling party submitted a motion for a postponement on grounds that some issues needed more clarification and that negotiations with Sweden had not "matured" enough. If approved by the committee, Sweden's bid would then need to be approved by the

full assembly.

Iranian-backed militias in Iraq carried out a drone strike on a US base in Irbil in northern Iraq on Monday, wounding three American service members, one of them critically, according to US officials. In response, American warplanes before dawn Tuesday hit three locations in Iraq connected to one of the main militias, Kataib Hezbollah.The Israeli strike main Monday hit a neighbourhood of the Syrian capital Damascus, killing Gen Seyed Razi Mousavi, Syria. Throughout the war, a constellation of Iranian-backed militia groups around the region have stepped up attacks in support of Hamas. Iran-backed militias in Iraq have launched more than 100 attacks on bases housing US troops in Iraq and Syria. In the Red Sea, attacks by Houthi rebels in Yemen against commercial ships have disrupted trade and prompted a US-led multinational naval operation to protect shipping routes.

Israel says it also aims to free the more than 100 hostages who remain in captivity in Gaza. Israel faces international criticism for the civilian death toll. It blames Hamas, citing the militants' use of crowded residential areas and tunnels.

Cyberattack blocks Albania's Parliament

Tirana (Albania): Albania's Parliament reported Tuesday it had suffered a cyberattack with hackers trying to get into its data and wipe them out, temporarily halting its work.

A statement said Monday's cyberattack had not "touched the data of the system," adding that experts were working to discover what consequences the attack could have. It said services would resume at a later time.

The local media reported that a cellphone provider and an air flight company were also targeted by cyberattacks Monday from Iranian-based hackers called Homeland Justice, something which could not be verified independently. Albania suffered a cyberattack in July 2022 that

the government and multinational technology companies blamed on the Iranian Foreign Ministry. Believed to be in retaliation for Albania sheltering members of the Iranian opposition group Mujahedeen-e-Khalq, or MEK, the attack led the government to cut diplomatic relations with Iran two months later.

The Iranian Foreign Ministry denied Tehran was behind an attack on Albanian government websites and noted that Iran has suffered cyberattacks from the MEK.

In June, Albanian authorities raided a camp for exiled MEK members to seize computer devices allegedly linked to prohibited political activi-

Court suspends EC order to deprive PTI of symbol 'bat'

railed former prime minister Imran Khan's party partially won a legal battle when the Peshawar High Court on Tuesday suspended an order of the election commission to deprive the Pakistan Tehreeke-Insaf of its electoral symbol of a cricket 'bat'.

The Election Commission of Pakistan last week in a verdict rejected the intra-party polls of Khan's party and also stopped it from using 'bat' as the party's electoral symbol.

The party had challenged the verdict in the Peshawar High Court where after a detailed hearing, Justice Kamran Hayat Miankhel suspended the ECP ruling until the final adjudication of the petition. "It is the victory of justice and we hope that in the final decision, the court would permanently revoke the ECP ruling," said Barrister Gohar Ali Khan, who was elected as the party's new chairman in the intra-party polls held in Peshawar earlier this month.

During the hearing, PTI counsel Barrister Ali Zafar highlighted that when a party provides its intra-party poll details to the ECP, the commission typically issues a certificate

and posts it on its website.

However, Zafar argued that, as of now, the certificate has not yet been uploaded to the ECP website. The PTI earlier on Tuesday challenged the ECP order and urged the court to fix the matter for hearing at the earliest. The party insisted that the ECP's proceedings that questioned the PTI's intraparty polls were "coram nonjudice (without jurisdiction) and without lawful authority".

It urged the court to direct the ECP to publish the results of the PTI's intra-party polls on its website and restore the symbol of the party. Imran Khan is currently incarcerated in corruption cases, including in the Toshakhana case. He was granted bail in the cypher case after the Supreme Court's intervention last week.

The ECP had issued a verdict following a first-of-itskind microscopic examination of the inner workings of a political party and declared the party ineligible to obtain an election symbol to contest the upcoming general elections. As many as 28,626 candidates, including 3,139 women, have filed their nominations to contest the February 8 general elections in Pakistan to the National Assembly and four provincial legislatures, the country's top electoral body said here on Tuesday. The election will be held for 1,085 general and reserved seats of the national and provincial assemblies. Of the total 1,085 seats, there are 336 National Assembly (NA) seats — 226 general and 70 reserved for women (60) and non-Muslims (10); and 749 provincial assembly seats - 593 general and 156 reserved for women (132) and

Punjab province has 371 seats, including 297 general, 66 reserved for women and 8 for minorities. Sindh has 168 seats, including 130 general, 29 reserved for women and 9 for Khyber minorities. "The law that deals with punishment cannot be applied retrospectively unless the legislature categorically gives this effect. The Supreme Court's 2018 ruling says disqualification under Article 62(1f) of the Constitution is lifelong," he said. Another senior lawyer Kashif Ali Malik said that the lifelong interpretation in the Elections Act cannot interpret, override or defeat constitutional provisions.

in his Red Book which once resonated across the world and sparked Communist movements paled into insignificance after his death as it was overtaken by his successor Deng Xiaoping's widespread economic reforms, propelling China into the second largest economy next only to the US. Deng's opaque Socialism

with Chinese Characteristics gave wide room for the successive Chinese leaders to expand reforms including the introduction of private property, shunned by Mao. The party theoreticians in recent years were also critical of some of Mao's political and economic campaigns, especially his disastrous Cultural Revolution (1966-76) in which thousands were killed in the name of purging capitalists and tradi-

China (CPC) every 10 years observes Mao's birth anniversary. Xi's speech this year was regarded as significant as he is the only CPC leader after Mao to continue in power for the third consecutive fiveyear term. Like Mao, he also holds the title of "core leader" meaning that he was above the rest of the party leaders and widely expected to remain in power for life.

In an article this month commemorating Mao's legacy, Qiushi, a leading party theoretical journal of the CPC, also hailed what it called the country's "good fortune" to have Xi as the "core of the party and leader of the people" again, the Hong Kong-based South China Morning Post newspaper reported.

Leading the celebrations, Xi addressed a symposium at the Great Hall of the People to commemorate in which he stressed the importance of pushing forward the cause pioneered by "Comrade Mao Zedong" and called for efforts to build China into a stronger country and rejuvenate the Chinese nation on all fronts by pursuing Chinese modernisation. Russian Foreign Minister Sergey Lavrov on Tuesday said that 30 countries have expressed their interest in establishing partnership ties with the BRICS grouping. Lavrov said Moscow expects a wide range of solutions to be developed ahead of the group's next summit, set to take place in the Russian city of Kazan in October next year.

Addressing a session of United Russia's Commission on International Cooperation and Support for Compatriots Abroad, Lavrov said the aspiration of many countries to become closer with the fivenation bloc comprising Brazil, Russia, India, China, and South Africa is "natural given that BRICS is operating on a genuinely democratic and mutually respectful basis", the staterun TASS news agency reported. "In addition to the countries

union, as of today, about 30 countries would like to establish partner ties with BRICS," he said. During the 15th BRICS summit held at Johannesburg in South Africa from June 22-24, the BRICS leaders agreed to admit Argentina, Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates as new members, effective January 1, 2024. Russian naval ship in Crimea damaged in airstrike

Kyiv (AP): A Russian naval ship in Crimea was damaged in an airstrike by Ukrainian forces, Russia's Defence Ministry said on Tuesday. The landing ship Novocherkassk was hit at a base in the city of Feodosia by plane-launched guided missiles, the ministry said, adding that two Ukrainian fighter jets were destroyed by anti-aircraft fire during the attack.

Over the past several months, Ukrainian forces have conducted attacks around Crimea, mostly with sea drones. Ukrainian President Volodymyr Zelenskyy credits those attacks with allowing Ukraine to restore navigation in the Black Sea and allowing the export of millions of tons of grain. The Russia-appointed head of Crimea, Sergei Aksyonov, said one person was killed in the attack. "The Russian fleet has become smaller," Ukrainian air force Cmdr. Mykola Oleschuk said in a mocking message on the Telegram app. He urged Russians to leave Crimea which Russia annexed in 2014 "while it's not too

The ministry did not specify the extent to which the Russian ship was damaged, but videos circulating on Ukrainian channels showed a large fire in the port area. Ukrainian authorities claimed the ship was destroyed and said it was likely carrying an ammunitions shipment, possibly including drones. "We saw how powerful were the blast and detonation. It's extremely difficult for a ship to survive something like that," Ukrainian air force spokesperson Yurii Ihnat said on Radio Liberty.

Toll in Indonesia's **furnace** explosion climbs to 18

The death toll following the explosion of a smelting furnace at a Chinese-owned nickel plant on Indonesia's Sulawesi island rose to 18 on Tuesday, as police ordered the plant to stop operations until an investigation is completed. The blast, which occurred on Sunday, was the latest in a series of fatalities at nickel smelting plants in Indonesia that are part of China's ambitious transnational development programme known as the Belt and Road Initiative.

Nickel is a key component in global battery production for electric vehicles. Four Chinese and nine Indonesian workers died instantly on Sunday when the furnace exploded while they were repairing it, Central Sulawesi police chief Agus Nugroho said. Three more victims died a day later while being treated at a local hospital. Two more workers died on Tuesday while hospitalized, bringing the total number of fatalities to 18, including eight workers from China, said Deddy Kurniawan, a spokesperson for PT Indonesia Morowali Industrial Park, known as PT IMIP, the parent company of PT Indonesia Tsingshan Stainless Steel, where the explosion

The plant is in the Bahodopi neighborhood of Morowali regency. "We have ordered PT Indonesia Tsingshan Stainless Steel to stop its operation until our entire investigation is completed," said Nugroho, the police chief, adding that authorities had set up a team to determine whether negligence by the company led to the deaths. The blast

was so powerful that it demolished the furnace and damaged parts of the side walls of the building, Nugroho said.

The head of central Sulawesi's manpower and transmigration office, Arnold Firdaus, said that joint investigation team is made up of 18 members, and it includes officials from the central government in Jakarta and a working group from the Chinese Embassy. PT IMIP said in a statement on Sunday that the furnace was under maintenance and not operating at the time of the explosion. However, "residual slag in the furnace" came into contact "with flammable items," causing the furnace walls to collapse and the remaining steel slag to flow out.

Rescuers extinguished the fire and evacuated workers after a nearly four-hour operation, Kurniawan said. About 41 workers were still being treated at a hospital and the company's clinic on Tuesday with serious to minor injuries, including 11 Chinese nationals. Three of them who suffered serious burns will be flown to China for further treatment, Kurniawan said. In a news briefing on Monday, Chinese Foreign Affairs Ministry spokesperson Mao Ning expressed condo-lences for the victims and said that China is "saddened by the casualties caused by the acci-

She said her ministry is working closely with authorities in Indonesia and has instructed the Chinese Embassy in Jakarta to assist in the aftermath, including ensuring medical treatment is provided to the injured and helping to determine the cause of the explosion.

4 kids, mother found dead; father held

Paris (AP): Four children

between nine months and 10 years old and their mother were killed in their apartment east of Paris, in what the local prosecutor called an exceptionally violent crime. Authorities said the children's father was arrested Tuesday and is the primary suspect. Neighbors spotted a pool of blood outside the family's door on Christmas Day and alerted police, who discovered the five bodies, Prosecutor Jean-Baptiste Bladier told reporters in the city of Meaux. The mother and two daughters, ages 7 and 10, were stabbed several times overnight from Sunday to Monday, he said. The couple's two sons, ages 9 months and 4 years old, were suffocated or drowned. The prosecutor described a small, bloodstained apartment in extreme disarray. The motive for the killings was unclear. The suspect, a 33-year-old man born in the Paris suburb of Colombes, was arrested Tuesday outside his father's home northeast of the French

capital, the prosecutor said. The suspect had stabbed his partner once before, when she was pregnant with their older son in 2019, but the investigation was dropped because he was declared mentally unsound at the time of the attack, the prosecutor said. The suspect had been placed in a psychiatric hospital in 2017, and also attempted suicide that year, the prosecutor said. The couple had been

together for 14 years and had known each other since high school, Bladier said.

CAD declines sharply to 1 pc of GDP in Q2: RBI

rndia's current account deficit declined sharply to 1 per cent of the GDP or USD 8.3 billion in the second quarter of this financial year, mainly due to lower merchandise trade deficit and growth in services exports, according to a RBI data released on Tuesday. The current account deficit (CAD), which represents the difference between the total amount of money sent abroad and money received from overseas across the economy, was 3.8 per cent of GDP or USD 30.9 billion in the July-September quarter in 2022-23. CAD was USD 9.2 billion or 1.1 per cent of GDP in the first quarter (April-June) of the current financial year 2023-24.

"Underlying the lower current account deficit on a year-on-year (y-o-y) basis in Q2:2023-24 was the narrowing of mer-chandise trade deficit to USD 61.0 billion from USD 78.3 billion in Q2:2022-23," said the data on Developments in India's Balance of Payments during the second quarter (July-September) of 2023-24. Services exports grew by 4.2 per cent on a y-o-y basis on the back of rising exports of software, business and travel services, the Reserve Bank said. Net services receipts increased both sequentially and on a yo-y basis, it added.

In the first half of the fiscal, CAD moderated to 1 per cent of GDP from 2.9 per cent of GDP in the year-ago period, on the back of a lower merchan-

Nevertheless, we now foresee the FY2024 CAD in a range of 1.5-1.6 per cent of GDP, unless commodity prices chart a sharp rebound.

India 208 for 8 as rain stops play at Centurion

ndia laboured to 208 for eight when bad light and rain halted the I final session's play on the first day of the opening Test against South Africa here on Tuesday.

The elemental adversity stopped the play after 59 overs on a day that also saw a delayed toss due to wet patches on the field.

South Africa pacer Kagiso Rabada rocked India with a five-wicket haul (5/44) as the visitors hung on for dear life through an unbeateKagiso Rabada bowled two of the most intimidating and incisive spells witnessed in recent times to completely rock the Indian batting line-up, which struggled to 176 for 7 at tea on the opening day of the first Test against South Africa here Tuesday.

One of the finest fast bowlers in contemporary cricket, Rabada (5/41 in 15 overs) bowled an absolute peach to dismiss Virat Kohli (38 off 64 balls) with the old ball after having bounced out Indian skipper Rohit Sharma (5) in his first spell.

In between, Shreyas Iyer (31 off 50 balls), who lived dangerously, got a shooter that completely exposed his

Rabada's 14th five-wicket haul in



Tests also comprised the scalp of Ravichandran Ashwin, who was completely rocked by extra bounce, and Shardul Thakur (24), who after a gutsy effort was softened by a bouncer and

then taken out with a length delivery. KL Rahul (33 batting) looked solid but is slowly running out of partners as a first innings score of 250 looks a distant reality now.

Rabada, who was given a break from white ball leg, didn't need time to hit the rhythm as he bowled long spells, got a disconcerting bounce along with late swing that had the Indian batters The manner in which Kohli was forced into making a mistake was an

education for young pacers. Rabada bowled a couple of incoming deliveries to peg him on the backfoot and then unleashed his lethal weapon. He made a nearly 31-over-old Kookaburra to move in and kept it on fuller length as Kohli shaped himself to play inside the line of the delivery. But to his amazement, the ball pitched and deviated late to take the outside edge en route to keeper Kyle Verreynne's hands.

Kohli got a massive reprieve in the first session when he was on four as Tony de Zorzi dropped a dolly at square leg off debutant Nandre Burger (2/39) but he then carried out the repair work with Iyer.

At the toss, Temba Bayuma took the expected decision of bowling first and his bowlers did make best use of the conditions during that first hour.

The steep tennis-ball like bounce was always going to create problems for the star-studded Indian line-up which for the last six months has played only white ball formats.

"In response, the ACB assigned a dedicated committee to thoroughly investigate the matter, develop appropriate recommendations that best serve the ACB's interests and share them with the ACB's top management," the ACB said.

The board added that Mujeeb, Naveen and Farooqi have also requested to "consider their consent for participation in the national events".

While Mujeeb was roped in by Kolkata Knight Riders for Rs 2

crore during the auction earlier this month for IPL 2024, Naveen was retained by Lucknow Super Giants and Farooqi by Sunrisers Hyderabad.

The ACB further informed that its special committee has made a three-point recommendation. "Starting from January 1, 2024, the three players shall not be eligible for the central contract for one year. In this case, ACB will consider and decide their participation in events when needed, read the first point.

The ACB said NOCs to these three players will be revoked immediately.

Each of these three players represented Afghanistan in the 50over World Cup in October-November.

How Indian blind cricket team captain found way to serve nation

rowing up, Ajay Kumar GReddy only wanted to become a soldier and serve the country. He was heartbroken when he got to know that the visually impaired cannot enter

the army. But Ajay, who became partially sighted at an early age, soon found another way to serve India: by playing cricket and winning the World Cups. For his contributions, he will receive the Arjuna Award next month, becoming the first to win the honour from blind cricket.

Born in Gurazala, Andhra Pradesh, the Indian blind cricket team skipper lost his left eye in a freak accident when he was just four.

'My parents were farmers. One day I wasn't able to sleep when my parents had gone to work in the field," Ajay told PTI.

"I wanted my mother. As I got up, the latch of the door went inside my eye. I had surgery but I lost all vision in my left eve. "I had some vision in my right eve but by the time I turned 12, I couldn't see the letters on the

To avoid complete vision loss,



the doctors advised Ajay's parents to take him to a blind

Ajay's parents thus moved to Narsarapet to enrol him into the Lutheran High School for the Blind in 2002, and he embarked on what would become a lifechanging experience.

"I got to know about blind cricket at that school. I also heard that Pakistan was the number one team, that Pakistan has beaten India and they had just won the World Cup."

It was a time when tensions between the two neighbours were at a high. The Indian

Parliament had been attacked by militants and there was mass mobilisation of both nations' military forces at the border. "I felt very angry. I had always wanted to become a soldier and at that time I kept hearing about the issue at the border. So

my mindset was simple - India losing is wrong. Without knowing the rules I decided will play for India and make them win the World Cup." But life was one big ordeal for

Ajay then. 'Ít was a very hard time for us. My parents only knew farming.

We started having financial

issues after a month. We needed to borrow money to eat," recalled the 33-year-old. "My parents started selling tea

and set up an idli-dosa stall. They kept me in the hostel so that I get proper food but I didn't stay. I felt they were abandoning me.

Ajay tried to help his parents. "I used to support my parents by cleaning tea cups, bringing water, make dosas, serve the cus-

"But sometimes because of my vision, I had problems and people used to abuse me dikhta nahi kya, andha hai

kya?' (Can't you see, are you blind?) But I wanted to help my parents.' He found succour in cricket

and would play all night, sleep in the morning and then wake up at 1pm and start playing In 2010, he made his India

debut and was part of the T20 World Cup-winning team. But that did not give him much

The first time we won a T20 World Cup. Pakistan cricketers said 'Oh this is a new format, you were lucky that's why you won. In ODIs we are number 1'.
