Centre OK for panel Def yield 'rejuvenated', export to

Govt agrees to SC proposal to form panel to boost regulatory regime

PNS NEW DELHI

The Centre on Monday agreed to the Supreme Court's proposal to set up a panel of experts to look into strengthening the regulatory mechanisms for the stock market in the wake of the recent Adani group shares crash trig-gered by Hindenburg Research's fraud allegations.

Saying it has no objection to constituting the panel, the Centre, at the same time, stressed that market regulator Securities and Exchange Board of India (SEBI) and other statu-tory bodies are "fully tory bodies are equipped", not only regime wise, but otherwise also to deal with the situation. It also wanted to be allowed to provide details such as names and the scope of the panel's mandate in a "sealed cover".

The top court on Friday said the interests of Indian investors need to be protected against market volatility in the backdrop of the Adani stocks rout and asked the Centre to consider setting up a panel of domain experts headed by a former judge to look into strengthening the regulatory

mechanisms. The court, which was hear-



ing two PILs alleging exploitation of innocent investors and "artificial crashing" of the Adani Group's stock value, was told by Solicitor General Tushar Mehta that the Centre was agreeable to the proposal as it came from the court.

Mehta, however, told the bench also comprising Justices PS Narasimha and JB Pardiwala, that the "remit" of the proposed committee would be relevant because any "unintentional" message to the investors that regulatory bodies here needed a monitoring by a panel may have some adverse impact on flow of money into the country.

"I have instructions that the SEBI and other agencies are fully equipped, not only regime wise, but otherwise also to take care of the situation. However, responding to the suggestion which fell from the court, the Government has no objection to constituting a

Aldermen can't vote, observes SC; Feb 16 MCD mayoral poll put off

The Mayoral election — stalled thrice due to fight in the House - scheduled for February 16 has been postponed again as the Supreme Court on Monday observed that nominated members of the Municipal Corporation of Delhi (MCD) cannot vote in a mayoral election.

As the wait for a Delhi mayor gets longer after results of the civic polls were announced on December 7, the court also said the constitu-tional provision is "very clear" on the voting rights of nominated members (aldermen).

As a bench headed by Chief Justice DY Chandrachud posted for Friday the hearing on a plea filed by AAP mayoral candidate Shelly Oberoi seeking early holding of the mayoral poll, Additional Solicitor General (ASG) Sanjay Jain, appearing for the office of Delhi Lieutenant Governor, said the February 16 poll would be postponed to a date after



February 17

"Nominated members can not go for election. The constitutional provision is very clear," the bench, also comprising Justices PS Narasimha and JB Pardiwala, orally

observed.
"Nominated members should not vote. That is very well settled. It is very clear Mr Jain," the CJI told the ASG.

However, Jain said he

would argue on this aspect.

Delhi Lt Governor VK Saxena had given his approval to convene the next session of the MCD House on February 16 for election to the post of

polls, three meetings were adjourned amid ruckus and commotion over the decision to give voting rights to aldermen (nominated members).

After the court hearing, the Aam Aadmi Party(AAP) and the Bharativa Janata Party(BJP) indulged in a blame game with the ruling party accusing the Centre of resorting to "dishonest tactics

The BJP hit back alleging that its "suspicion" that the AAP did not want voting in MCD House has proved true.

Both the BJP and the AAP have previously accused each other of preventing the mayoral poll with the bone of contention being the appointment of aldermen and their voting rights in the House.

The AAP, which has a majority with 134 out of 250 elected members, has alleged that the BJP is trying to steal its mandate by giving voting rights to the nominated members.

SC rejects plea against J&K's delimitation

The Supreme Court on challenging the Government's decision to constitute the Delimitation Commission for redrawing the legislative Assembly and Lok Sabha constituencies in Jammu and

Kashmir. A bench of Justices SK Kaul and AS Oka delivered the verdict on a plea filed by two Kashmir residents. While pronouncing the verdict, Justice Oka said nothing in this judgement shall be construed as giving an imprimatur to the exercise of power under clauses one and three of Article 370 of the Constitution.

The bench observed that issue of validity of the exercise of power relating to Article 370 is subject matter of petitions pending before the apex court.

The top court is seized of petitions challenging the constitutional validity of the Centre's decision to abrogate provisions of Article 370 on August 5, 2019.

Deputy Chief Minister Manish Sisodia interacted with the 45 Delhi Government School students who scored the

All the 45 students from the Delhi government schools have secured above 98 percentile in JEE Mains, of which two have secured 99.98 percentile, the Delhi government said in a release. "There is no dearth of talent in Delhi government school students: if given an opportunity, they can also work hard and crack tough exams like JEE," Sisodia said.

Chief Minister Arvind Kejriwal said, "Along with the students, the hard work of their parents, teachers and the entire team of Delhi Education



has also contributed a lot in this stupendous success of these children of Delhi.'

"Our schools come from varied socio-economic backgrounds and have seen the toughest times in their lives, but still they are determined to

achieve their goals. Hard work of students and teachers along with facilities like upgraded libraries, free coaching classes, and reading rooms have contributed to this success," Sisodia said.

Last year, 496 students of Delhi government schools qualified for Mains and thereafter 74 cleared the JEE Advanced competition that allows admissions into Indian Institutes of Technology (IITs).

ACB arrests three contractors for swindling ₹20 cr of DJB funds

The Delhi government's Anti-Corruption Branch (ACB) has arrested three people for allegedly embezzling Rs 20 crore from the Delhi Jal Board, a senior enforcement officer said on Monday

The accused were identified as 56-year-old Raju Nair, 52-year-old Gopi Kumar Kedia, and Dr Abhilash Vasukuttan Pillai, he said.

According to the officer,

DIB had awarded the work of 'Setting up automotive bill payment collection machines" at different DJB offices to the Corporation Bank (Now Union Bank of India). The machines were meant to

facilitate bill payments in cash and cheques and other modes by DJB consumers. Corporation Bank in its turn gave the contract to Freshpay IT Solutions which further gave it to Aurrum e-Payments Pvt Ltd. The contract was valid up to October 10, 2019, but Aurrum e-payments Pvt Ltd collected the amount till March 2020, the officer said. One of the three accused, Nair, who hails from Kerala, has an Indian passport but lives in Moscow in Russia. He was the owner and Director of Aurrum e-payment.

Kedia, another accused, was the CFO and authorised signatory of Aurrum e-payment, and Pillai was the Director of Freshpay IT Solution and also an authorised signatory of Aurrum

e-payment and Freshpay IT Solution, the senior ACB officer said. "The preliminary enquiry conducted by the Vigilance Department of DJB revealed embezzlement of DIB funds amounting to Rs 20 crore ... by private persons in connivance with Corporation Bank and DJB officials," he said.

"Accordingly, a case was registered on November 12, 2022, with the Anti Corruption Branch and an investigation was taken up," he added.

Locals protest demolition; drive has legally admissible flaws: AAP

An "anti-encroachment drive" in the Mehrauli Archaeological Park area went on for the fourth consecutive day on Monday, with Delhi Development Authority (DDA) and police personnel facing protests from many local residents during the exercise. Amid the ongoing 'anti-encroachment' drive AAP MLA Somnath Bharti has urged the Lieutenant Governor VK Saxena to stop the exercise and enforce the city government's order for fresh demar-

The demolition drive continued on Monday and action was taken in the area located near the Bhool Bhulaiyaa monument, a senior DDA official said. "We will continue the drive to remove illegal structures. Some parties have approached court seeking a stay on the demolitions and so any litigation," an official source said.

A group of around 50 women staged a protest in the locality against the antiencroachment drive. They raised slogans "demanding justice" and also showed their documents to members of the media present during the drive. Officials spoke to them and pacified them, and eventually they ended their protest, a senior police officer said.

Meanwhile, Bharti, in a letter to the L-G, said the demolition drive in Mehrauli has been causing "extreme hardships" to the residents there and that it suffers from "fundamental and legally admissible errors". "The L-G is kindly requested to direct the authorities to stop any demolition further and to take remedial measures to compensate the already demolished strucor owners," he said. The AAP MLA further requested the L-G to carry out new demarcation and said that, present owners or occupiers should be made party to all such demarcation processes and their objection must be duly con-

The demolition drive will be carried out till March 9, officials had said on Friday. "If the lands, on which these buildings are situated, happened to be of the government then before undertaking any demolition exercise on the buildings situated on such lands, you are kindly requested to direct the concerned to come up with a rehabilitation package for the people who will get displaced," the letter read.

Bharti further urged to identify the authorities of DDA and Delhi police who were supposed to guard these government lands and during whose

up. "There should be thorough investigation of all the people involved in cheating ordinary people and selling them government lands for construction. Officers involved in moving the line of division from Gair abadi to Abadi should be identified and suitable punitive action including termination should be taken against them," he wrote in the

The drive had begun on Friday and comes a month ahead of a proposed G20 meeting at the park in South Delhi that, according to the DDA, has about 55 monuments under the protection of the archaeological Survey of India, state archeological department and the authority.

A day before, a group of protesting women had thrown chilli powder at many police personnel who were deployed during the drive, he said.

Hearing a plea filed by the AAP's mayoral candidate Shelly Oberoi, the apex court on Monday observed that nominated members of the MCD cannot vote in the mayoral election and the constitutional provision is "very clear" on that. The electoral college for the election of the MCD mayor comprises 250 elected councillors, seven Lok Sabha and three Rajya Sabha MPs from Delhi and 14 MLAs. The Delhi Assembly Speaker has nominated 13 AAP MLAs and a BJP member to the civic body. LG The LG VK Saxena nominated 10 people as Aldermen of the MCD. The AAP won 134 wards and the BJP 104 in the civic body polls held in December last year. A BJP rebel, who had contested as an independent, rejoined the party after winning from the Mundka ward. The total votes in the mayoral polls are 274. The numbers game favours AAP, which has 150 votes against the BJP's 113. The Congress had earlier declared it will not participate in the mayoral poll.

However, in the MCD House meeting on February 6, Presiding Officer and BJP Councillor Satya Sharma had decided that the 10 LGappointed Aldermen will vote in the mayor's election. If the Alderman are allowed to vote the voting strength of the BJP will go up to 123 from 113.

Referring to the plea being heard by the top court, Delhi BJP working president Virendra Sachdeva said the date for the mayoral election on February 16 has been postponed. He alleged that the BJP's "suspicion" that AAP does not want voting in the MCD House for Mayor has been proved to be correct. "They had gone to the court for a stay (on voting) in which they have succeeded. Our endeavour has always been that Delhi gets its Mayor at the earliest," Sachdeva said.

The BJP leader said he hoped that the Supreme Court would decide the matter at the earliest, and added that his party would accept the court's judgement. A Supreme Court Bench headed by Chief Justice DY Chandrachud posted the matter on Friday for further hearing. Additional Solicitor General (ASG) Sanjay Jain, appearing for the office of the Delhi LG, said the February 16 poll would be postponed to a date after February 17.

The AAP alleged that giving voting rights to the nominated members was a "shameful act" by the BJP-led central government. "It was shameful

People with less than 67 sq mtr plot eligible for flats, says DDA

With a large number of flats built by Delhi W built by Delhi Development Authority (DDA) remaining unsold in one housing scheme after another, a person having less than 67 sq mtrs flat or plot in Delhi would now became eligible to apply for allotment of newly constructed flat offered by DDA for the first time.

In a move to enable general public to buy DDA flats without any hassles, the Ministry of Housing and Urban and Affairs (MoHUA) has approved modifications proposed by the authority in Housing Regulations 1968 which were issued under section 57 of DDA Act, 1957. "Earlier, the main regulations didn't allow any person to apply for allotment of DDA flats, if he/she or family members were having any flat/plot irrespective area of flat/plot," the DDA said in a statement on Monday.



approved modifications/relaxations in the Regulations are that any person having less than 67 sq. mtrs. Flat or Plot in Delhi now became eligible to apply for allotment of newly constructed flat offered by DDA for the first time.

The main Regulations did not allow any person to apply for allotment of DDA flats, if he/she or family members were having any flat/plot irrespective of area of flat/plot.

Waiting list of a main Housing Scheme shall be 100 percent of the total flats offered under the respective Housing

Scheme. Till now numbers of waitlisted applicants were restricted up to 25 percent. These wait listed applicants are allotted surrendered/cancelled flats through a mini

If more than 25 percent flats remain unsold in any area/locality on closing of the Housing Scheme in which they are offered for the first time, such locality/area shall be deemed to be a 'Developing

There will not be any restriction in terms of having flat/land in Delhi to the appli cants as and when such unsold flats located in a developing area are offered under the subsequent Housing Scheme.

Apart from individual/certain Government entities like Central Government, State Government, Local Bodies, Autonomous Bodies of Central/State Government shall be eligible for allotment of

NDMC to hold 13-day Tulip Festival at Shanti Path lawns



According to sources, this is the sixth notice to Sharma under Section 41.1 (A)

Sharma has appeared for questioning twice -- on December 6, 2021, and May 14, 2022 -- and submitted reasons for not being able to appear on three other dates.

Why stubborn refusal to order JPC probe into Hindenburg report on Adani, Cong asks Govt

The Congress on Monday asked the Government why A asked the Government why it was "stubbornly refusing" to order a Joint Parliamentary Committee (JPC) probe into the Hindenburg report on the Adani group when earlier, too, stock market manipulations had been probed by JPCs.

Congress general secretary, communications, Jairam Ramesh asked if Prime Minister Narendra Modi feared being "personally implicated" by a truly independent investigation. Posing a set of three questions to the Prime Minister as part of the "Hum Adani ke Hain Kaun" series, he tweeted, "Does he think we had run out of questions for him, on this 'maĥa mega scam' he facilitated and that took place under his nose with his eyes wide

The Congress leader said both Indian National Congress

and Bharatiya Janata Party-

led Governments have in the past agreed to set up a JPC to investigate large-scale cases of stock market manipulation.

In 1992, he said, a JPC was set up to look into the Harshad Mehta case while in 2001 a JPC investigated the Ketan Parekh case. Both Narasimha Rao and Atal Bihari Vajpayee as prime ministers had the confidence and trust in elected representatives to investigate scams that affected crores of Indian

"What are you afraid of? Do you fear that a truly independent investigation might implicate you personally in the Adani Group's wrongdoings," Ramesh asked. He also alleged that "the government is turning a blind eye to fresh collusion between (stockbroker Ketan) Parekh and the Adani Ramesh claimed a 2007

SEBI ruling following an investigation into excessive volatility in the shares of Adani Exports (now known as Adani Enterprises) between 1999 and 2001 had found that entities associated with Ketan Parekh had indulged in "manipulative activities such as synchronised trading/circular trading and creation of artificial volume to influence the price in the scrip of Adani".

This bears a disturbing resemblance to the current allegations against the Adani Group, he claimed "Why did SEBI tolerate an even more extreme rise in Adani Group stock prices after 2020 without investigating it with the required seriousness," he asked.

Appointment of judges: Ensure most of what is expected is done, SC tells Centre

The Supreme Court on Monday told the Centre to make sure that "most of what is expected is done" on issues concerning appointment and transfer of judges as recommended by the apex court Collegium.

A Bench headed by Justice SK Kaul observed that it is "concerned with some issues" regarding judges' appointment.

As Attorney General R Venkataramani was not available, the top court adjourned to March 2 the hearing on two pleas, including one alleging delay by the Centre in clearing the names recommended by the Collegium.

"Please make sure, most of what is expected is done. Communicate to the Attorney General," the Bench, also comprising Justices Manoj Misra and Aravind Kumar, told the counsel who sought a short accommodation on behalf of the top law officer.

Prashant Advocate Bhushan, appearing for one of

the petitioners, told the Bench that some appointments are being selectively notified while some are being kept pending.

'Mr Bhushan, I have already flagged the issue. I am also concerned with some issues," Justice Kaul said, adding, "Issues are, let me say, more than one."

Bhushan said this cannot go on endlessly.

"I can assure you that I am equally concerned, if not more, of what is happening," Justice

Bhushan said at some point of time, the apex court will have to "crack the whip so to say, otherwise this will go on end-

He said on some recom-

mendations for appointments and transfers, the government does not do anything.

"I am putting it after two weeks," Justice Kaul said and posted the matter for March 2.



Unacceptable

The Rajasthan Government must follow CAG's norms and should not try to set its own

The Rajasthan Government's reluctance to share the state's accounts with the Comptroller and Auditor General is as weird as it is fraught. The Ashok Gehlot Government reportedly intends to launch its own Pay and Accounts System (PAO), thus dispensing with the established treasury system which is in tune with the Constitution. In this system, the Comptroller & Auditor General (CAG), through its accountant general, keeps the pay and pension accounts of a state. Cognisant of the impropriety, the CAG has written a letter to Rajasthan Chief Secretary Usha Sharma, reminding her that Article 150 of the Constitution mandates that the accounts of the Union and of the states "shall be kept in such form as the President may, on advice of the CAG, prescribe."



The CAG has also rightly informed the state Government that any change in the current system of treasury to the PAO independently would "cause disruption in compilation, preparation and reporting of government accounts." The federal auditor has also warned the state administration a new PAO system by one state "will derail the time-tested treasury system where huge human and digital resources have evolved along with corresponding treasure rules and with its inherent system of checks and balances and the linkage of entire IT infrastructure with PFMS, etc." Besides, it can also have a domino effect, with other states following suit. This will also strengthen separatist elements, most

of which have been reined in. We should not forget that various kinds of secessionists—for instance, Tamil nationalists in Tamil Nadu, Khalistanis in Punjab, and different insurgencies in the North East—were threatening to tear our country apart as we know it. Thankfully, none of these centrifugal forces are strong enough to imperil the sovereignty and integrity of India. This burdens the political class with greater responsibility; they should not do anything that could trigger a chain reaction fattening those who have a vested interest in destroying national unity. Chief Minister Gehlot is a seasoned politician; he must realise that tampering with a constitutionally-compliant process is much more dangerous than badmouthing his political rival Sachin Pilot. In political bickering, careers are made or marred, but when any leader tries to trifle with the established constitutional norms and conventions, there could be far-reaching ramifications. Unfortunately, it is not that just a government under the Congress is not playing by the book; other parties are no better. Tamil Nadu Governor RN Ravi recently suggested 'Tamizhagam' as the new name of Tamil Nadu; it would be, he said, "a more appropriate name." This without informing the state Government, leading to unsavoury scenes in the Assembly. Then there is Kerala Governor Arif Mohammad Khan, battling continually with the state Government. Both the Bharatiya Janata Party and Opposition must realise that maintaining Constitutional propriety is the sine qua non of stability.

Cow Hug Day

The Government withdraws the "Cow Hug Day" following public outcry

ow Hug Day" declared by the AWBI is being portrayed by the western media as an order issued by the Government of India asking its citizens to hug the cow and set aside the global Valentine's Day celebrations. This order or notification has tarnished India's image as the liberals, intellectuals, and secularists were handed over a weapon by the AWBI with which the Government is being mocked, trolled. and criticized. The issue is whether the AWBI is empowered to issue a notification on a controversial issue like this. Students of law are aware that there are two kinds of laws visualized in the Constitution, viz Supreme Legislation and Subordinate Legislation. Supreme Legislation is the law enacted by Parliament/State Legislatures. Since the time at the disposal of these Houses are limited and some of the legislations to be enacted in the Houses are left to be formulated by the executive branch of the

> government. The laws enacted by the executive branch are known by the name delegated or subordinate legislation. The Constitution has enough safeguards to check and ensure that the executive branch does not violate its brief. Any misadventure by the executive branch while enacting legislation could be nipped in the bud itself by the Supreme Court.

The Cow Hug Day notification issued by the AWBI was a misadventure and the Government was forced to withdraw the controversial order following public outcry. It has to be said that the Constitution has enough inherent provisions like judicial reviews to preserve its sanctity. This helps in preserving the pristine glory of the Constitution. The Cow Hug Day

Order is not the first time the executive wing has put the Government on the wrong wicket. The Supreme Court order banning Jallikkaatu (taming of bulls) was quashed in 2017 through a notification following a stage-managed sit-in at Chennai's Marina Beach. The crowd masquerading as animal lovers were mobilized by political parties which were aided by Tamil chauvinist. The fact that hundreds of people and bulls get killed in the Jallikattu melee every year and millions of rupees change hands during this inhuman pastime went unnoticed by the authorities. When the apex court banned the cruel sports, these animal lovers sold the bulls to slaughter house! That much for love of animals. The possibility of these babus issuing orders in the future to hug cobras, tigers, elephants, lions, and leopards could not be ruled out.



he socio-economicsecurity crisis in Pakistan is unprecedented with the official annualized inflation soaring upwards of 35%, and the severe 'corrective' measures insisted on by the International Monetary Fund, yet to kick in. Estimated two million jobs have evaporated in just one year. Coming on the back of the Covid pandemic-related misery and devastation, coupled with the imploding issues of secessionism, violent terrorism, and polarising religiosity, the 'land of the pure is under acute stress. Even more economic tightening, inflationary pressures, and counter-insurgency actions are guaranteed if Pakistan is to survive.

So where did it err? What explains its morass? Is it because of its unhinged politicians? Is it because of its frequent disruption to democracy by its military dictators? Is it to do with its governance choices in diplomacy and geopolitics?

While all these factors are true, however, there is one basic foundational flaw in the 'Idea of Pakistan' bestowed by its founding fathers that have spun completely out of control, metastasized, and institutionalized itself in everything that Pakistan does i.e., religiosity, that has emptied its coffers and brutalized its society. This sovereign instinct has necessitated selectivity and curation of historical narrative - much before the independence of Pakistan as 'New Medinah' (echoes of the same persist with Imran Khan's call to Riyasat-e-Medinah), ensuring the imagined history to start with the arrival of Muhammad bin Qasim in Sindh, got fixed. The long civilizational past is not just obliterated or diminished, but outrightly denied. Even flashes of Pakistan's Qaid-e-Azam, Muhammad Ali Jinnah's invocation of secularity are completely removed from public consciousness e.g., Jinnah's address to the first Constituent Assembly of Pakistan goading secularism. But Jinnah himself had knowingly used the bigoted 'two-nation thepolitically and to assume that it wouldn't grip the narrative Haq who accelerated the slipsocietally and culturally was both, pery slope of religiosity by



naïve and fatal. Pakistan has centralized religiosity and its outcomes are playing out. Exclusivist ideology of

intolerance and discrimination led to the 'othering' of many of its majoritarian masses, most notably the Bengalis, but soon enough, even the Shias, Ahmediyas, etc., were 'othered'. Denialism was used to galvanize a powerful section of society as part of political propaganda. Bangladesh was a natural outcome of the flawed 'two-nation' theory - but Pakistanis remained committed to their path to religious hardening. Even the once secular British Raj military had adopted a decidedly religious tenor in Pakistan as within months of independence, it recruited tribal Lashkars in the name of jihad that was discussed in every hujra and jirga. Martial myths of Islamic Ghazis e.g., Akbar Khan's leading of Lashkars under the nom de guerre of General Tariq (Moorish invader) connected the Pakistani Military to religious symbolism. Misplaced hope for local uprisings on account of co-religiosity beset misadventures like Operation Gibraltar (1965) and Kargil (1999). It was after all a Military man in Zia-ul-

Today, the institution of the Pakistan Military which has never won any battle for its nation, sucked its financials, and invested heavily in fanning 'anti-India' sentiments to justify its own bloated and privileged existence, is under the scanner. It had conceptualized the devious idea of 'Strategic Depth' in Afghanistan, nurtured the 'global nursery' of terrorism, and the antecedents of its Inter-Services-Intelligence (ISI) for playing double games (e.g., harboring Osama Bin Laden) are well documented – now, the chickens are coming home to roost. In this melee, civilian politicians outdid each other to prove themselves more pious than the other, and that willy-nilly tantamount to appeasing the regressive and pernicious forces of the clergy. Normalizing relations with neighboring India could have brought in incalculable economic benefits, but that would have delegitimize the foundational sovereign tenet, the carefully created 'Islam is in danger' war cry. Net result, it is not the 900 km long Iran Pak border or the 750 odd km long Line of Control (LOC) on

the Indo-Pak front but instead, the 2640 km long Durand Line dividing Pakistan and Afghanistan (controlled by its progeny i.e., Taliban), that is wreaking havoc in the 'land of pure'. Pakistan is under attack by even more vicious strains of religiosity, a genie unleashed by Pakistan itself. In civil society, instances of cabinet ministers hailing a rare victory over India in a cricket match as one of 'Islam' or a former Captain hailing the moment a player offered namaz on the grounds 'in front of Hindus' as the turning point is a picture of normalized religiosity. The conflation of religiosity and hatred of 'others' is the definition of patriotism in Pakistan as it concurrently beseeches IMF for 'bail'. But beyond 'bail', it must reflect its sovereign-societal anchorages as it is not just a socio-economic-security crisis, but a fundamental and existential one. Religion must remain a private matter and not one for the state, an important lesson for us too, saved as we were by those who framed an alternative constitution and normalcy

Sir — Bhagat Singh Koshyari, the controversial Governor of Maharashtra, eventually had his resignation accepted. The decision for a change in the Maharashtra Raj Bhavan was necessitated since Koshyari's actions and remarks throughout his three-year tenure not only inflamed the Opposition parties but he also did everything in his power to make the ruling party look bad. Even in the State's non-political circles, his comments on Chhatrapati Shivaji Maharaj, Mahatma Phule and Savitribai Phule sparked hostility. He found it challenging to remain in office as a result of these controversies.

In this regard, the President's decision was made in a way that all the parties felt relieved. Iharkhand Governor Ramesh Bais, who was transferred to Maharashtra, will also be remembered for political controversies during his nearly one year and eight months in office. 

NOTHING SPECIAL FOR WOMEN IN BUDGET '23

Interest rate under Mahila Samman not attractive

n 2019, Finance Minister Nirmala Sitharaman became the second woman to have presented the Budget after Indira Gandhi, who had presented the budget for the financial year 1970-71. Sitharaman is the sixth minister in independent India to present five consecutive budgets, joining a select league of legends like Manmohan Singh, Arun Jaitley and P Chidambaram.

Sitharaman's Budget for the fiscal year starting April 1, 2023, is her fifth straight since 2019. But on seeing her Budget proposal, there seems to be no special treatment for women. The budget presentation discusses women only at two places. Let us have a look at what the second woman finance minister has done to the segment of women.

Under para 13 (1), the FM has discussed Economic Empowerment of Women. She has claimed that Deendayal Antyodaya Yojana National Rural Livelihood Mission has achieved remarkable success by mobilizing rural women into 81 lakh Self Help Groups.



She has outlined the following for further action: "We will enable these groups to reach the next stage of economic empowerment through formation of large producer enterprises or collectives with each having several thousand members and managed professionally. They will be helped with supply of raw materials and for better design, quality, branding and marketing of their products. Through supporting policies, they will be enabled to scale up their operations to serve the large consumer markets, as has been the case with several startups growing into Unicorns"

When we analyse this statement, there is no concrete proposal with outlay of funds or credit dispensation or structural methodology, etc. What is described is good intention to carry forward the good work that is claimed to have been achieved earlier.

Under para 108, the FM has outlined this new savings scheme for women. This scheme is launched to commemorate 'Azadi Ka Amrit Mahotsay' and the scheme is a one-time new small savings scheme. 'Mahila Samman Savings Certificate', which will be made available for a two-year period up to March 2025. This will offer deposit facility up to Rs 2 lakh in the name of women or girls for a tenor of two years at fixed interest rate of 7.5 per cent with partial withdrawal option.

The purpose of the scheme is not clear. There are various bank fixed deposit schemes with similar interest rates available in the market. Suryoday Small Finance Bank offers 8.01 per cent for two years, Fincard Small Finance Bank offers 7.30 per cent for two years and 8.00 per cent for 1000 days, Utkarsh Small Finance Bank offers 8.00 per cent for 700 days, City Union Bank offers 7.75 per cent for 444 days, while there are more options.

IDFC First Bank offers 7.5 per cent for 18 months plus one day and RBL Bank offers 7.55 per cent for 15 months. Suryoday Small Finance Bank, Fincard Small Finance Bank, IDFC First Bank and RBL Bank offer 0.50 per cent additional interest for senior citizens. Jana Small Finance Bank offers 0.70 per cent additional interest and City Union Bank offers 0.25 per cent additional interest for senior citizens.

The interest rate under this Mahila Samman Savings Certificate is not attractive. It is also not clear what are the other terms and conditions of this scheme. What is the interest in periodicity is not known. Banks provide interest once in three months, though they may pay monthly also. It is mentioned that partial withdrawal is allowed. It is not clear about any penalty clause for this. In the same way additional interest for senior citizens or nomination facility or joint account facility are not informed. One expects the government to come out with more details and clarity on the scheme.

We need judiciary for people and by people



It is time we re-evaluated the collegium system and addressed its flaws to serve the best interest of the nation

s the cornerstone of any democratic society, the 'will of the people' forms the foundation of the Constitution of India. Among its various facets, the selection of judges for the higher judiciary, which serves as the repository of citizens' rights, is of paramount importance for maintaining public faith in the judiciary. The current system of judicial appointments in India, the collegium system, has been the subject of much debate and controversy. It is imperative that we evaluate whether this system truly reflects the will of the people and serves the best interests of the nation.

Judicial appointments: History and evo-

When the Constitutional provisions relating to the appointment of judges to the Supreme Court (SC) and the High Courts were being debated, it was proposed that the appointment of judges should be made by the President in consultation with the Chief Justice of India (CJI). This was to strike a balance between the independence of the judiciary and ensuring that appointments are made in a fair and impartial manner. Accordingly, Articles 124 and 217 were framed to state that the President shall appoint the judges in the SC or High Courts in 'consultation' with the CJI, Governor of the relevant state (for appointments to High Courts) and other judges as the President may deem fit.

Despite the clarity with which the Constitution spells out the primacy of the executive as regards to the judicial appointments, the same has been the subject of multiple judicial decisions. In the First-Judges case (1981)' the SC ruled that the government was not bound by the views of the CJI in the appointment of judges. This was overruled in the 'Second-Judges case (1993)' wherein the word 'consultation' in Articles 124 and 217 was interpreted to mean that the government was bound' by the advice of the CJI, who in turn would consult two senior-most judges of the SC.

This paved the way for the current collegium system of appointment, which was further solidified in 1998. Despite subsequent challenges to the system, the SC has consistently upheld it, reaffirming its status as the established method for appointing judges. However, the question remains whether the Constitution intended for such a system in the first place.

Justice Dinakaran's saga

It claims independence and impartiality. The collegium system is beleaguered by serious flaws that have had a detrimental impact on the functioning of the judiciary. Justice Ruma Pal noted "consensus within the collegium is sometimes resolved through a trade-off, resulting in dubious appointments with disastrous consequences for litigants and credibili-

ty of the judicial system. Besides, institutional independence has also been compromised by growing sycophancy and lobbying within the system.

The case of Justice PD Dinakaran, who was recommended by the collegium for appointment to the SC in 2009, is a case in point. Despite facing serious allegations of illegal land acquisition and owning assets disproportionate to known sources of income, the collegium seemed hesitant in taking any action. Instead, in an unprecedented move, the collegium requested Justice Dinakaran to go on leave, which he refused, stating that the collegium did not have the power to do so. Subsequently, the collegium had him transferred to the Sikkim High Court as Chief Justice without investigating the allegations against him.

This raises several questions about the integrity and functioning of the collegium system. It begs to ask, why a judge who has an alleged case of corruption against him would be transferred to any High Court without investiga tion. Surely, Sikkim did not deserve to have a judge with such serious allegations against him.

Striking down NJAC Act, 2014

It is high time that we re-evaluated the collegium system and addressed its flaws to ensure that it truly reflects the will of the people and serves the best interest of the nation. The judgment of the SC striking down the National Judicial Appointments Commission (NJAC) Act, 2014, was a missed opportunity for meaningful reform of the appointment process. The Act included the right checks and balances that could have contributed to a more transparent and accountable appointment process.

A key aspect of the Act was the composition of the Commission, which was to consist of the CII. two senior-most judges of the SC, the Union Minister of Law and Justice, and two 'eminent persons' who would have been appointed by a committee consisting of the CJI, Prime Minister and the Leader of Opposition in the Lok Sabha. This diverse composition could have ensured a balanced yet representative selection

Furthermore, the NJAC was required to invite applications and hold interviews for judicial appointments, and to make the proceedings of the interviews and the reasons for selection public. This transparency would allow the executive to participate in the selection process, but ensure that appointments were on merit and not lopsided. The SC, however, disregarding the merits of the enactment suggested that the executive is not to be trusted and that it would do all things possible to appoint the people they wanted to.

Accordingly, the Law Minister being a member of the NJAC, and that the participation of the Prime Minister and the Leader of Opposition along with the CJI in appointing the two 'eminent persons' would

mean political involvement and would vitiate the whole process. Thus, the enactment was abolished.

Democratisation of the judiciary

It is important to acknowledge that the current system, despite being upheld by the Supreme Court, is not perfect and there is room for improvement. It is within legal bounds to engage in discussions about the system and consider ways to improve it.

The greatest irony of our country is that the people have no say in the selection of judges, which is not fair as the judges are appointed to serve the people. A completely unaccountable judiciary does not align with the concept of democracy. The Judicial Standards and Accountability Bill, 2010, and the NJAC Act, 2014, were proposed to ensure that elected representatives of the people have a say in the appointment of judges, this is the only way to ensure that the judiciary is representative of the diverse population of India and the views and concerns of the cit-

It is imperative that the judiciary remains open to interventions and suggestions for reform, as transparency and inclusivity are essential for the functioning of a fair and just judiciary. The judiciary must adopt the approach of, in the SC's own words, "sunlight is the best disinfectant" in order to ensure that it is truly representative of the society it serves and is not beholden to any particular group or individual.

Russia pushes advance on Bakhmut

Nadine Krueger said in Berlin. Germany pledged to deliver 14 of the tanks to Ukraine by the end of March.

"For me, this just highlights the importance of timing. It's urgent to provide Ukraine with more weapons," he told reporters in Brussels. Stoltenberg said that NATO sees "no sign whatsoever that for peace" and that arming Ukraine more quickly could save lives by bringing a quicker end to the conflict. Russian forces shelled a

dozen cities and villages in the Donetsk region in the last 24 hours including in Druzhkivka where a missile hit a hospital and in Pokrovsk where shelling damaged seven houses and a kindergarten. "The shelling intensifies,

and the Russians accumulate more forces for an attack on peaceful cities," Donetsk Gov. Pavlo Kyrylenko said. "We're seeing a very tough battle in which the Russians aren't sparing neither themselves,

In the neighboring Luhansk region, Russian troops pulled back after several days of intense fighting near the key city of Kreminna, although they're not "running out of steam," Luhansk Gov. Serhii Haidai told Ukrainian television.

In the partially occupied southern region of Kherson,

Ex-Italy Prez blames Zelenskyy for war

Former Italian Premier Silvio Berlusconi has blamed Ukraine's president for Russia's invasion, again putting him at odds with Premier Giorgia Meloni's support for Kyiv.

Berlusconi, whose party is part of Meloni's right-wing coalition government, is a long-time friend and ally of Russian President Vladimir Putin.

He said the war in Ukraine "would have never happened" had Zelenskyy "ceased attacking the two autonomous republics of Donbass.

Berlusconi said he judged Zelenskyy's behaviour "very, very negatively."

He also criticised Meloni for meeting with Zelenskyy, telling reporters Sunday that

he wouldn't have done the same if he were premier.

The comments drew a quick rebuttal from Meloni's office, which said that "the government's support for Ukraine is solid and unwaver-

R ussia is the main security threat for all of Europe and will remain so for a long time, Norway's intelligence officials said Monday, warning that recent burnings of Islam's holy book in Scandinavia could possibly lead to terror attacks in the country.

"Russia today poses the biggest threat to Norwegian and European security, and the confrontation with the West will be long-lasting," said Defence Minister Bjorn Arild Gram. Arild Gram made the remark after the government received the annual threat assessments from Norway's three security services: the domestic and the foreign intel-

Norwegian National Security Authority, or NSM. "The burning of the Quran could be seen as offensive or provocative and we expect that such events will also occur in 2023 in Norway," said Beate Gangas, head of the domestic security service, known by its acronym

"When such events take place in Norway, the likelihood of radicalisation and ultimately terrorist planning against Norway increases.'

Despite the warning, Norway's terror domestic threat level was left unchanged at "moderate." The deputy head of the foreign Norwegian Intelligence Service Lars Nordrum said that Norway's oil

Training of Ukrainians on new tanks observed

Poland's president and defence minister met on Monday with Polish instructors intensively training Ukrainian troops to operate the German-made Leopard 2 tanks that some European countries have offered Kyiv to help fight the Russian invasion.

President Andrzej Duda and minister Mariusz Blaszczak also watched Leopard 2 training at a military base and test range in Swietoszow, in southwestern Poland.

The training is part of the European Union's military assistance to Ukraine. Taking part are Ukrainian troops from units fighting in the east of the country. The intensive training



lasts up to 10 hours a day, including weekends, the Polish military said. Instruction is also being held in Germany. Stationed in Swietoszow are Poland's 10th Armoured Cavalry Brigade and a U.S. Armoured cavalry combat

group. Warsaw is among the most active supporters of neighbouring Ukraine, and has pushed European nations to provide the Leopard 1 and 2 tanks. Germany has pledged at least 178 Leopard 1 tanks and 14 Leopard 2s. Poland has pledged 14 Leopard 2s. Other contributing countries are Denmark and the Netherlands. Poland has also provided or pledged more than 300 of its Soviet-era T-72 tanks and modernised PT tanks.

Ukrainian officials say they expect Russian forces to make a new drive in eastern and southern Ukraine, as the Kremlin strives to secure territory it illegally annexed in late September and where it claims its rule is welcomed.

Germany's Defence Minister Boris Pistorius said last week that first battalion of 31 Leopard 1 tanks in Ukraine should be ready in April. The first Ukrainian soldiers to be trained on tanks departed for

Rescue crews have pulled more survivors, including entire families, from toppled buildings despite diminishing hopes as the death toll of the enormous guake that struck a border region of Turkey and Syria five days continued to rise

But tens of thousands of dead have been found during the same period. Experts say the window for

such rescues has nearly closed, given that temperatures have fallen to minus 6 degrees Celsius (21

degrees Fahrenheit) and the total collapse of so many buildings.

The Turkish Enterprise and Business Confederation, a nongovernmental business organisation, estimated the quake's financial damage in Turkiye alone at USD 84.1 billion.

Calculated using a statistical comparison with a similarly devastating 1999 quake, the figure was considerably higher than any official estimates so far.

Senior United Nations officials conceded that help to quake victims in Syria had been too slow, and Turkiye on Monday offered to open a second border crossing to

assist the international effort. The UN Security Council scheduled a closed meeting on the

quake's effect on Syria for Monday afternoon. Some 100 kilometres (62 miles) from the epicentre, almost no houses were left standing in the village of Polat, where residents salvaged refrigerators, washing

Atter quake, war-hit Syrians struggle to get aid, rebuild

fter years of war, residents of areas After years of war, restrict by a in northwest Syria struck by a massive earthquake are grappling with their new and worsening reality.

Almost one week after the devastating 7.8 magnitude earthquake struck northern Syria and neighboring Turkey, the United Nations has acknowledged an international failure to help Syrian quake victims.

In Atareb, a town that Syrian rebels still hold after years of fighting government troops, survivors dug through the debris of their homes Sunday, picking up the remnants of their shattered lives and looking for ways to heal after the latest in a series of humanitarian disasters to hit the war-battered area.

Excavators lifted rubble and residents with shovels and picks destroyed columns to even out a demolished building. Dozens of newly displaced families gathered for hot meals from local volunteers and the local opposition-run government.

A private citizen went tent to tent to give out wads of cash in a makeshift shelter — the equivalent of about \$18 to each family. Syrians were doing what they have honed over years of crises: relying on themselves to pick up the pieces and move on. "We are licking our own wounds," said Hekmat Hamoud, who had been displaced twice by Syria's



ongoing conflict before finding himself trapped for hours beneath rubble. Syria's northwestern rebel-held enclave, where over 4 million people for years have struggled to cope with ruthless airstrikes and rampant poverty, was hit hard by the Feb. 6 quake.

Many in the area were already displaced from the ongoing conflict and live in crowded tent settlements or buildings weakened by past bombings. The quake killed over 2,000 people in the enclave, and displaced many more for a second time, forcing some to sleep under olive groves in the frigid winter weather.

"I lost everything," said father of two Fares Ahmed Abdo, 25, who survived the quake. But his new home and body shop where he fixed motorcycles for a living were destroyed. Once again with barely any shelter and no power nor toilets, he, his wife, two boys and ill mother are crammed in a small tent.

10 US balloons flew in our airspace: China

hina on Monday said more than 10 US high-✓altitude balloons have flown in its airspace during the past year without its permission, following Washington's accusation that Beijing operates a fleet of surveillance balloons around the world.

The Chinese allegation comes after the US shot down a suspected Chinese spy balloon that had crossed from Alaska to South Carolina, sparking a new crisis in bilateral relations that have spiralled to their lowest level in decades.

Foreign Ministry spokesperson Wang Wenbin gave no details about the alleged US balloons, how they had been dealt with or whether they had government or military links.

"It is also common for US balloons to illegally enter the airspace of other countries," Wang said at a daily briefing. "Since last year, US high-altitude balloons have illegally flown over China's airspace more than 10 times



without the approval of Chinese authorities.

Wang said the US should "first reflect on itself and change course, rather than smear and instigate a confrontation".

China says the balloon shot down by the US was an unmanned airship made for meteorological research that had been blown off course. It has accused the US of overreacting by shooting it down and threatened to take unspecified action in

Following the incident, US Secretary of State Antony Blinken cancelled a visit to Beijing that many had hoped would put the brakes on the

Taiwan, trade, human rights and threatening Chinese actions in the disputed South China Sea.

Also on Monday, the Philippines accused a Chinese coast guard ship of targeting a Philippine coast guard vessel with a military-grade laser and temporarily blinding some of its temporarily blinding some of its crew in the South China Sea, calling it a "blatant" violation of Manila's sovereign rights. Wang said a Philippine coast

guard vessel had trespassed into Chinese waters without permission on February 6 and that Chinese coast guard vessels responded "professionally and with restraint" China claims virtually all of the strategic waterway and has

She remembers it all: How female relatives held her down when she was 11, legs spread and genitals exposed. The fear that stiffened her body. The stranger in black holding the scissors. And the pain.

Like so many others, the 34year-old Egyptian woman has lived with the psychological and physical repercussions of that day, when she was subjected to a practice many activists call "mutilation."

For N.S., who asked to be identified only by her initials to discuss the sensitive topic, the trauma continuing into adulthood was accompanied by a desire to reclaim control over her health and body.



"I had a feeling of being incomplete and that I will never feel happy because of this," she

said. "It's a horrible feeling." A global target aims to eradicate the deeply entrenched practice by 2030, and protect the next generations of girls, though campaigners acknowledge the difficulties in achieving that. It was the largest protest outside the Knesset in years and reflected the deep divisions over the plan. The proposed changes have triggered weeks of mass demonstrations, drawn cries of protests from influential business leaders and former military men and even prompted a statement of concern from President Joe Biden.

Despite a plea from the nation's figurehead president to put the legislation on hold, Netanyahu's allies approved a series of legislative changes during a stormy committee meeting Tuesday. The vote now sends the legislation to the full parliament for a series of votes — an opening salvo in a battle expected to stretch on for weeks.

"They hear our cry. They hear the strong voice of truth," opposition leader Yair Lapid said from the stage outside parliament. "They hear it and they're afraid."

Netanyahu and his supporters say the proposed changes are needed to rein in a judiciary that wields too much power. But his critics say the judicial overhaul is tantamount to a coup and will destroy Israeli democracy. They also say that Netanyahu, who is on trial for a series of corruption charges, has a conflict of interest.

The protesters came from across the country. Organizers said that upwards of 100,000 people were in attendance, with female LGBTQ activists and leaders of the opposition parties addressing

Thousands of people arrived in Jerusalem on packed trains, streaming up escalators in the city's main train station chanting, "democracy," cheering and whistling, and waving the national flag. Hundreds of others gathered in protest at Jerusalem's Western Wall, the holiest site where Jews can pray, before marching toward the

With the exception of November and December 2022, retail inflation has remained above the RBI's upper tolerance level of 6 per cent since January 2022.

The retail inflation based on the Consumer Price Index (CPI) was 5.72 per cent in December and 6.01 per cent in January 2022. The previous high was 6.77 per cent in

While the prices of vegetable declined in January, most of the other items, including 'fuel and light' became

The rate of price rise in the food basket was 5.94 per cent in January, up from 4.19 per cent in the preceding month and 5.43 per cent in the yearago month, as per data released by the National Statistical Óffice (NSO).

The inflation in rural areas was higher at 6.85 per cent as

Last week, the RBI which has been mandated to ensure inflation remains below 6 per cent — had raised the key short-term rate (repo) by 25 basis points to 6.5 per cent with an aim to check price rise.

The Reserve Bank has projected the retail inflation at 6.5 per cent in 2022-23, with January-December quarter at 5.7 per cent.

Headline CPI inflation moderated by 105 basis points during November-December 2022 from its level of 6.77 per cent in October 2022.



Milan host Tottenham Hotspur on Tuesday night having snapped a seven-match winless streak in all competitions which left their Serie A title defence in tatters and threatened to completely derail their season.

The San Siro breathed a heavy sigh of relief on Friday night when Olivier Giroud headed Milan to a 1-0 win over Torino and coach Pioli wants that tight victory to be the turning point after two Milan derby defeats and heavy league losses to Lazio and Sassuolo in just

over a fortnight. Pioli said that Friday's win should be looked at as a "rebirth" as it ended a run which had left fifth-placed Milan not only miles behind runaway league leaders Napoli but also in a real

fight for a place in next season's Champions League.

"We need to keep going, playing the Champions League next season would be a good finish at this point, but we need to be more consistent," he told DAZN. Pioli will be hoping for a

better result than nine years ago, when Milan were thrashed 5-1 on aggregate by Atletico Madrid and became also-rans for a tournament which they have won more times than any other club apart from Real Madrid.

He will be boosted by the return of both Ismael Bennacer and Fikayo Tomori from injury and a public rebuttal of rumours of a major dressing room bustup which was given as a reason for Milan's collapse in form.

Shubman Gill named ICC Men's Player of January

ndia batter Shubman Gill was on Monday Inamed ICC Men's Player of the Month for January following a series of impressive innings in the ODI format, while England U-19 skipper Grace Scrivens became the youngest player to be named for the women's honour.

Gill enjoyed a record-breaking month in white-ball cricket in January. The free-scoring batter was a prolific source of runs throughout the month, most notably in the ODI format, scoring big against both Sri Lanka and New Zealand.

With 567 runs during January, which included three century-plus scores, the 23-year-old Gill wowed fans with a lethal combination of graceful and attacking strokeplay.

In a month which presented several highlights for Gill, his stand-out performance came in the form of a stunning double-hundred in the nailbiting victory over New Zealand in the series opener in Hyderabad.

His unbeaten 208 came off just 149 balls with 28 boundaries — a startling feat not just because it made him the youngest double-centurion in the ODI format, but also because all those around him seemed to falter on a diffi-

cult pitch for batters. Sandwiched between this innings were two further centuries — 116 in a dominant victory over Sri Lanka, and 112 in the final ODI against New

Gill overcame a competitive field to claim his first ICC Men's Player-of-the-Month award, beating New Zealand opener Devon Conway and compatriot Mohammed Siraj in the global vote. In doing so, he becomes the first Indian winner since Virat Kohli in October 2022.

"January was a special month for me and winning this award makes it all the more memorable. It is always heartening to be recognised for your performances, and I will take great confidence from these innings, especially as we head into an extremely important period prior to an ICC Men's Cricket World Cup on home soil," Gill said in an ICC release.

Scrivens bagged the award after her all-round brilliance in the inaugural ICC U-19 Women's T20 World Cup. Equally, the England captain excelled in her leadership role, guiding her side to the final, only to lose to eventual title winners India.

Women's cricket set to turn new corner with WPL but IPL is a different entity

After all, the women were seeing the occasion as the beginning of a new dawn where they would also be able be to call themselves millionaires like their male counterparts in the Indian Premier League (IPL).

For long, there had been talk about a T20 league for women in India, with several veterans like Mithali Raj, Jhulan Goswami and Harmanpreet Kaur, among others, waiting for this seminal moment in country's cricketing landscape.

But all that will change on March 4 this year when the inaugural match of the five-franchise tournament begins.

While it will most likely continue to be the precursor to the 'big event', the IPL, women cricketers will finally have a niche window, which they will be able to call their own in a milieu overcrowded with men's T20 leagues.

While in terms of money and clout, the WPL and IPL, will never be comparable, the new baby of Indian cricket will at least add a lot of glamour to women's cricket, which was so far lacking, and also bring in hordes of fresh Indian and foreign faces, hoping to make big

bucks through WPL. As India women cricketer set foot into hitherto uncharted territory, it would be fair to say the auction has gone way beyond expectation for several of them if one compares it with

the IPL Mandhana getting Rs 3.40 crore, spinner Deepti Sharma being bought by UP Warriorz for Rs 2.60 crore and Jemimah Rodrigues and young India opener Shafali Verma earning Rs crore-plus deals, certainly bodes well for the women cricketer in the country, given that the salary cap for each of the five franchises was just Rs 12 crore compared to the IPL mega auction last year where the total budget per franchise was increased from Rs 90 crore to Rs

Comparing the inaugural WPL auction to the first IPL auction ahead of the 2008 season, there is just a three-fold difference between what CSK dished out for Mahandra Singh Dhoni (Rs 9.5 crore) and what

In fact, during the 2010 IPL auction Shane Bond (KKR) and Kieron Pollard (MI) were the highest money earners at Rs 4.8 crore each. It was only in 2011, that the salary purse of franchises started getting bigger and Gautam Gambhir (KKR) broke bank to earn a mind-boggling

Over the years, IPL has become the biggest and best domestic T20 tournament in the world, thanks to the multi-fold increase in telecast, broadcast and online revenue, which has translated into huge monetary gains for the players as well.

Ravindra Jadeja got Rs 12.8 crore in 2012, RCB shelling out Rs 14 crore for Yuvraj Singh and Delhi Daredevils (Delhi Capitals) buying him for a then IPL auction record of Rs 16 crore, were the offshoot of the burgeoning salary purse of the franchises. The upward trend has continued with England all-rounder Sam Curran now the highest ever money-earner from the 2023 IPL auction at Rs 18.5

When compared to the mega-bucks being earned by male cricketers, Mandhana's Rs three crore-plus pay packet certainly pales in front of these celebrated IPL icons.

But, come to think of it, the inaugural IPL auction too had a "humble" start and gradually, over the years, more money started flowing into the environment. As the WPL brand takes baby steps towards creating a niche for itself, it's just a matter of time before more TV money gets pumped into the league and the salary caps of franchises are revised.

Ten years down the line, who knows, a new woman cricketer could be laughing her way to the bank with a Rs 20plus crore purse. By then, the IPL would be touching astro-

nomical figures. While not getting into the debate of who gets what, women's cricket was certainly the winner on Monday and with WPL, it'll turn a new corner.
