# Shinde's party real Shiv Sena, says EC

### Panel grants party symbol; Uddhav to move SC on Mon

RAJESH KUMAR NEW DELHI

n a setback for the Uddhav Thackeray-led faction, the Election Commission (EC) on Friday recognised the Eknath Shinde-led faction as the real Shiv Sena and ordered the Shinde camp to retain the official name and the "bow and arrow" symbol of the party amid an ongoing tussle between the Shinde and the Uddhay Thackeray factions over the symbol rights.

The EC has announced that the Uddhav Thackeray-led Sena will retain the interim party name Shiv Sena UBT and poll symbol flaming torch. As of now, the two factions were using separate party names and symbols allotted to them after the EC "froze" the Shiv Sena name and party symbol until the dispute was decided by it. This is for the first time that the Thackeray family has lost control of the party founded in 1966 by Balasaheb Thackeray on the principle of justice for the sons

In a late night develop-ment, the Thackeray camp a high-voltage revolt. The order was p decided to move a special leave petition in the Supreme Court on Monday challenging the EC's order.

The Uddhav and the Shinde factions have been at loggerheads over the party name and symbol since June 2022, when Shinde walked out of the Maha Vikas Aghadi Government with 40 MLAs in

The order was passed by Chief Election Commissioner Rajiv Kumar and Election Commissioners Anup Chandra Pandey and Arun Goel on a plea by the Shinde faction seeking decision on which is the real Shiv Sena — the Shinde camp or the Thackeray camp.

The party name 'Shiv Sena' and the party symbol 'bow and arrow' will be

retained by the petitioner faction," the Commission said in its order. "The name of "Balasahebanchi Shiv Sena" and symbol of "Two Swords and Shield", which was allotted to the petitioner by way of the interim order dated October 11, 22 in this dispute case will henceforth be frozen with immediate effect and will not be used," reads the order.

# Aldermen can't vote to elect MCD mayor: SC

### **Announce poll** date in 24 hrs, orders court

The Supreme Court on Friday ended the political tussle over the voting rights of the 10 members nominated by Lieutenant Governor VK Saxena to Municipal Corporation of Delhi (MCD) by ruling that nominated members cannot vote to elect

A bench comprising Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala also ordered that the date for the much-delayed mayoral polls be announced within 24 hours.

The SC directed that the election of the Delhi mayor shall be conducted at the first MCD meet for the purpose and once elected, the mayor shall preside over the deputy Mayor's election.

The top court was hearing a plea moved by the AAP mayoral candidate, Shelly Oberoi, seeking an early conduct of the elections.

The bench rejected the submission of Solicitor General Tushar Mehta, appearing for the Lieutenant Governor, and Additional Solicitor General Sanjay Jain, appearing for the municipal body, that alder-



men (members nominated by the LG to MCD) can vote in the polls.

Municipal Corporation of Delhi (MCD) is an important global body and it is desirable that the election to the post of mayor is held at the earliest. As a national capital it does not look good if the mayoral polls are held up," the bench observed orally.

Referring to Article 243R of the Constitution, it said the Constitution has imposed a restriction in terms of which nominated members do not have the right to vote.

'We have heard the counsel for the parties. We are unable to accept the submission on behalf of the municipal corporation. The Constitution has imposed a restriction in terms of which nominated members who are brought in on account of their special knowledge in municipal administration could not have right to vote. The prohibition on nominated members in the

exercise of the right to vote applies on the first meeting." 'The notice for the election

of mayor and the first meeting of the MCD shall be issued within 24 hours and the notice shall fix the date at which the elections of mayor, deputy mayor and standing committee members shall be held," it said The Delhi unit of BJP wel-

comed the court order, saying it always wanted a mayor to be elected as soon as possible. Delhi Chief Minister

Arvind Kejriwal termed the court order a "victory of democracy" and claimed that it has proved how the Lt Governor and the BJP were passing "illegal and unconstitutional orders"

Both the BJP and the AAP have accused each other of preventing the mayoral polls with the bone of contention being the appointment of aldermen and their voting rights as a result of which the MCD could not elect a mayor on three previous occasions.

The AAP, which has a majority in the unified MCD with 134 out of 250 elected members ending the BJP's 15year rule in the civic body, has alleged that the saffron party is trying to steal its mandate by giving voting rights to the nominated members. The BJP won 104 wards to finish second. Delhi's three civic bodies were unified in May last year, ten years after it was trifurcat-

# Crucial evidence found at BBC offices during I-T survey: CBDT

The Central Board of Direct Taxes (CBDT) on Friday said the survey operation condepartment at the offices of the Broadcasting British Corporation (BBC) in Delhi and Mumbai has unearthed crucial evidence by way of statement of employees, digital proof and documents.

The CBDT said income

and profits shown by various group entities of BBC are not commensurate with scale of operations in India. Several discrepancies and inconsistencies with regard to transfer pricing documentation have also been found during the survey operation, the CBDT said in a statement.

A survey action under section 133A of the Income Tax Act, 1961 was carried out on the business premises of group entities of a prominent international media company (BBC) at Delhi and Mumbai, the CBDT said.

The survey operation that began on Tuesday concluded



on Thursday clocking 60 hours of continuous action.

The group is engaged in the business of development of content in English, Hindi and various other Indian languages; advertisement sales and market support services among others.

The survey revealed that despite substantial consumption of content in various Indian languages (apart from English), the income/profits shown by various group enti-

ties is not commensurate with the scale of operations in India, it said.

During the course of the survey, the department gathered several pieces of evidence pertaining to the operation of the organisation which "indicate that tax has not been paid on certain remittances which have not been disclosed as income in India by the foreign entities of the group".

# **UK MP raps BBC**, terms Modi docu propaganda piece

A mid raging controversy over a British Broadcasting Corporation (BBC) documen-tary on Prime Minister Narendra Modi, a British MP has slammed the broadcaster and termed the film as "a propaganda video" and "a disgraceful piece of shoddy journalism." He also said the BBC is not an arm of the British Government and it regards India as a strong friend and a

strong ally. Airing these views, British MP Bob Blackman also talked about the issue "around the review of the BBC tax affairs" in the context of Income Tax department's survey at its offices in India and said "this is nothing new and has been going on for quite sometime".

He said in an interview with ANI, there have been discussions between the Income Tax authorities in India and the BBC and the broad-



caster has to follow the relevant

rules and regulations. Blackman said the documentary should never have been released and that it did not look at the "all-important fact" that India's Supreme Court investigated the claims against Narendra Modi in connection with the 2002 riots and found that there is not a shred of evidence to support them.

Blackman, a member of the ruling Conservative and MP for Harrow East, said as Chief Minister of Gujarat in 2002, Narendra Modi had done his best to try and appeal for calm during the riots.

# **US slams China for bid** to change LAC, calls **Arunachal part of India**

ven as China has always Eclaimed Arunachal Pradesh as part of its territory, the US has said the State is an integral part of India and condemned Beijing's use of force to try to change status quo at the Line of Actual Control (LAC). This assertion in a biparti-

san resolution in the US Senate late on Thursday came weeks after China tried to forcibly change the status quo at the LAC in Arunachal Pradesh in December last year. It led to exchange of blows between the Indian and Chinese troops. Moreover, tension still prevails at the LAC in Eastern Ladakh as China tried to transgress there in May 2020. The resolution was intro-

duced in the US Senate on Thursday to recognise Arunachal Pradesh as an integral part of India, pushing back against Beijing's military aggression to change the status quo along the LAC The resolution condemns

additional Chinese provocations, including China's use of military force to change the sta-tus quo along the LAC, construction of villages in contested areas, publication of maps with Mandarin-language names for cities and features in the Indian State of Arunachal Pradesh, and expansion of Beijing's territorial claims in ritorial claims in belongings of partition witnesses, and a souvenir shop.



# **Security beefed up outside** Yogi home after bomb scare

bomb scare outside 5, Akalidas Marg, the Uttar Pradesh Chief Minister Yogi Adityanath's residence in Lucknow, sent the security apparatus scrambling on Friday. A bomb disposal squad reached the Chief Minister's residence as soon as the alert was issued. Security was also beefed up soon after the police received the information that a bomb was planted near the Chief Minister's residence in

Lucknow DCP (Central) said that they received information that a bomb was planted at the residence of the UP Chief Minister.

He said immediately, the police rushed to the spot and launched a combing operation in the area. A senior police officer confirmed it was just a hoax call and no bomb was found after the entire area was fully checked. The State police are trying to identify the unknown caller. It may be recalled that Yogi Adityanath had earlier received death threats from an



unknown Twitter user, who also threatened to blow up the chief minister's cavalcade with a bomb and claimed that explosives had been planted in several areas. The Twitter user 'Done' (@ladydone3) had said that bombs had been planted to blow up the Vidhan Sabha in Lucknow, railway and bus stations. The next tweet said that one Sulaiman Bhai had planted a bomb in Gorakhnath

After an hour, a tweet from the same handle warned about a blast at Meerut CDA Army Cantonment, adding that one Furqan Bhai had planted bombs at 10 places in Meerut. The account holder also

tagged the Hapur police and the UP Police in the tweets, challenging them to stop him if they could. The user also tagged actor and BJP Member of Parliament from Gorakhpur Ravi Kishan, along with Yogi Adityanath, saying that they both would be killed by a human bomb before Monday morning. The UP police have taken the required action in the matter, and the Twitter account has been suspended. As per the information available, the Twitter handle was created in February 2022 only with one follower. The user mentioned that a 'Mujahid' from Pakistan would destroy everything.

Gorakhpur's Senior Superintendent of Police Vipin Tada said a massive combing drive was launched at Gorakhnath temple and other places after the tweet, but no explosive or detonator was found."It seems that it was a prank," the SSP said.

The tweet came days after All India Majlis-e-Ittehadul Muslimeen (AIMIM) MP Asaduddin Owaisi's convoy was attacked in Meerut while he was returning from a pre-poll event in Uttar Pradesh to

### RPG attack on 5 men held Punjab Police: for extorting Terrorist Landa's man held in Mohali businessman PTI CHANDIGARH

An associate of Canada-based terrorist Lakhbir Singh Landa was arrested in connection with the Mohali RPG attack case, police said on Friday. A rocket-propelled grenade (RPG) was fired at the Punjab Police's Intelligence headquarters located in Mohali on May 9 last year.

Director General of Police Gaurav Yadav said Gurpinder alias Pindu was allegedly involved in the RPG attack in Mohali and he is the 11th accused arrested so far in the Mohali RPG attack case.

Pindu, a resident of Bhura Kona village in Khemkaran, is the close associate of Canada based terrorist Lakhbir Singh alias Landa and was in constant touch with accused Nishan Singh and Charhat Singh during the attack, he said.

Yadav said on April 25 last year, accused Charhat Singh, Nishan Singh and Baljinder Rambo had brought consignment of RPG and accusts and ment of RPG and assault rifle from Tarn Taran to Amritsar, and kept at Pindu's house near Alpha Mall in Amritsar.

The resolution says China claims Arunachal Pradesh as its own territory, which it calls 'South Tibet", and has invoked these claims as part of its increasingly aggressive and expansionist policies.
"The United States recognises the State of Arunachal

Pradesh not as a disputed territory but as an integral part of the Republic of India, and this recognition is not qualified in any way," says the bipartisan resolution introduced by Senator Jeff Merkley, a Democrat, and Bill Hagerty, a Republican. Senator John Cornyn, Co-Chair of the India Caucus, has co-sponsored the resolution. Pushing back against Chinese claims that Arunachal Pradesh is its territory, which is part of Beijing's increasingly aggressive and expansionist policies, the Senate resolution reaffirms that the US recognises the McMahon Line as the international boundary between China and the Indian state of Arunachal Pradesh.

The line that was agreed to by Britain and Tibet as part of the 1914 Simla Accord is named after Sir Henry McMahon, foreign secretary of the British-run Government of India and chief negotiator of settling disputes with China.

On December 9, The Indian and Chinese troops were engaged in a fresh clash in the Yangtse area of Arunachal Pradesh's Tawang sector, in the first such major flare-up after the deadly hand-to-hand combat in the Galwan Valley in June 2020 that marked the most serious military conflict between two sides in decades

"America's values supporting freedom and a rules-based order must be at the centre of all of our actions and relationships around the world — especially as the PRC (People's Republic of China) government pushes an alternative vision," said Merkley, who serves as the Co-Chair of the Congressional-Executive Commission on China.

'This resolution makes clear that US views Indian state of Arunachal Pradesh as part of Republic of India — not People's Republic of China and commits US to deepen support and assistance to region, alongside like-minded international partners and donors," Merkley said. At a time when China continues to pose grave and gathering threats to Free and Open Indo-Pacific, it is critical for US to stand shoulder-to-shoulder with our strategic partners in the region — especially India, said Senator Hagerty after introduction of resolution.

## ARCI researchers develop nanocomposite coating to prevent surgical infections

Aunique non-toxic nanocomposite coating named 'ATL' to prevent postsurgical infections has been developed by researchers from the International Advanced Research Centre for Powder Metallurgy and New Materials (ARCI), under the Department of Science and Technology of the Union Science and Technology Ministry.

The developed coating not only inhibits biofilm formation by restricting bacterial and water adhesion but also kills attached bacteria. The coating has been developed by combining water repellence and biocidal property (combinatorial approach) that exhibits both hydrophobic and biocidal behaviour, a statement from the Ministry said. ATĹ was deposited on dif-

ferent surgical sutures made of silk, nylon, and polyglactin 910 (vicryl) in addition to sur-

The survey operations also revealed that "services of sec-onded employees have been utilised for which reimbursement has been made by the Indian entity to the foreign entity concerned".

In a 78-page order, the commission observed that the current constitution of the Shiv Sena is undemocratic. "It has been mutilated to undemocratically appoint people from a coterie as office bearers without any election at all. Such party structures fail to inspire confidence, it said.

In a landmark decision with far-reaching implications on political parties and their conduct, the EC advised all political parties to reflect democratic ethos and principles of inner party democracy and regularly disclose on their respective websites aspects of their inner party functioning, such as organisational details, holding of elections, the copy of Constitution and list of office bearers.

The Commission observed that the party had been made into a fiefdom by undemocratic norms of the original Constitution of Shiv Sena. The Commission said MLAs backing Eknath Shinde got nearly 76 per cent of votes polled in favour of the 55 winning Shiv

Sena candidates in the 2019 Maharashtra Assembly polls. The Uddhav Thackeray faction's MLAs got 23.5 per cent of votes polled in favour of the winning Shiv Sena candidates, the three-member Commission said in a unanimous order.

These procedures ought to be difficult to amend and should be amendable only after ensuring larger support of the organisational members for the same.

The very survival and sustenance of the party depends on this. Yet, the party Constitutions are often amended to allow for its self-destruction by obliterating the internal democratic mechanisms," the EC said.""In the absence of such democratic internal structures internal disputes are bound to create rifts and factions leading to determination of the question by the Election Commission under the Symbols Order," it said.

# Kejriwal terms SC order on mayor poll 'victory of democracy'

Delhi Chief Minister Arvind Kejriwal on Friday termed the Supreme Court's order on the Mayor's election a "victory of democracy" and demanded Lieutenant-Governor (LG) VK Saxena's resignation. Other AAP leaders, too, demanded Saxena's resignation after the top court's decision.

Kejriwal said that the SC verdict has proved how the LG and the BJP were passing "illegal and unconstitutional

"I thank the Supreme Court; Delhi will now get a Mayor after two-and-a half months," Kejriwal said.

The Supreme Court on Friday said Aldermen (nominated members) of the Municipal Corporation of Delhi (MCD) cannot vote in

the mayoral election. The order came on a plea moved by the ruling AAP mayoral candidate, Shelly Oberoi, seeking an early conduct of the election. "SC order is a victory of democracy. Many thanks to SC. Delhi will now get a mayor after twoand-a-half months. It has been proved how the LG and the BJP together were passing illegal and unconstitutional orders in Delhi," Kejriwal tweeted in

The AAP had emerged as a clear winner in the December four polls, bagging 134 wards and ending the BJP's 15-year rule in the civic body. The BJP won 104 wards to finish second, while the Congress won nine seats in the 250-member municipal House.

After the Supreme Court ruled that nominated members of the MCD cannot vote in the

it was a victory for it and that people's faith in the apex court has grown. Addressing a press conference, AAP leader Durgesh Pathak said, "We are thankful to SC. The apex court order on Delhi mayoral poll is a tight slap on the face of BJP."

"Delhi LG has no moral right to stay on his post, he must resign immediately. The Court's directive is a tight slap on the face of BJP & LG. Both BJP and LG had been illegally controlling MCD in last 2.5 months," he added.

"It is a victory for AAP. Delhi will get mayor and deputy mayor two-and-half months after the MCD polls. BJP has got a clear direction to sit in the Opposition and the mayor will be of AAP as people have voted for the Aam Aadmi Party," he added.

"Supreme Court has proven that LG Vinai Saxena is a compulsive liar; he must resign immediately. The Supreme Court has exposed the syndicate of BJP & LG, all their frauds and lies have been exposed today," AAP spokesperson Saurabh

spokesperson

Bhardwaj said.

"It is a written fact that nominated councillors do not have the right to vote, yet BJP tried to brazenly get them to vote. LG and BJP hatched conspiracies in MCD to prevent AAP from forming government," he said.

According to the Delhi Municipal Corporation (DMC) Act, 1957, the mayor and the deputy mayor are to be elected in the very first session of the House after the civic polls. However, it's been over two months since the municipal elections were held and Delhi is yet to get a mayor.

On February 6, the MCD House meeting could not elect a mayor for the third time in a row in a month, following ruckus over the decision to allow aldermen to vote in the mayoral poll, even as the AAP had alleged a "planned con-spiracy" by the BJP to stall the process, saying it would move the SC to seek a "court-monitored" election. The petitioner had moved the apex court on February 7.

The Municipal House has witnessed unprecedented developments since January 6 when it had convened for the first time after the high-stakes civic polls and adjourned following acrimonious exchanges between members of the BJP and the AAP. The second municipal House held on

January 24, was briefly adjourned after the oath-taking ceremony, and was later adjourned till next date by the presiding officer.

After the third session too was adjourned by the pro-tem presiding officer and BJP councillor Sharma, the issue had snowballed into a face-off between the AAP and the BJP, with both sides indulging in a blame game.

The AAP had alleged that the mayoral election could not be held as the BJP is "strangulating democracy and the Constitution of India", while the saffron party accused the Aam Aadmi Party of coming out with excuses to stall the

# NGT orders Govt to pay ₹2K cr for improper solid-liquid waste mgmt

¬he National Green Tribunal The National Green II Delhi Government to pay Rs 2,232 crore as environmental compensation for improper management of solid and liq-uid waste.

A Bench headed by NGT chairperson Justice AK Goel said there were gaps in the management of solid and liquid waste in Delhi.

"On the pattern of compensation awarded in respect of other States (at the rate of Rs 2 crore per million litres per day (MLD) of untreated sewage and Rs 300 per tonne of untreated legacy waste), compensation of Rs 3,132 crore is liable to be levied on the Delhi Government — Rs 990 crore for solid waste and Rs 2,142 crore for solid waste," the Bench, also comprising judicial members Justice Sudhir Agarwal and Justice Arun Kumar Tyagi along with expert members A Senthil Vel and Afroz Ahmad, said.

Deducting the compensa-tion for solid waste already levied (Rs 900 crore), the remaining amount of Rs 2,232 crore has to be paid by the city Government on the "polluter pays" principle, the Bench said. The amount has to be used for tackling the "emergent situation prevailing in Delhi, posing danger to the safety of the citizens," and for remedying the continuing damage to the environment, the Bench added. "This payment will be the responsibility of the Chief Secretary, Delhi and the payment be made within one month and credited to a separate ring-fenced account," it

After the NGT order, the BJP and the Congress demanded that the penalty amount should be recovered from the AAP and not from

the tax payers, as it was due to the incompetence and inaction of CM Kejriwal that the Yamuna water has become dangerously toxic.

# Delhi Govt approves project worth ₹23 cr for beautification of Ring Road

The Delhi government has approved a project worth Rs 23 crores for the beautification and maintenance of a 4.60 km road stretch on the Ring Road from the IP flyover to

The stretch includes memorials such as Rajghat, which are visited by national and international dignitaries, and hence needs to have smooth roads for commuting. The project has been taken up on priority by the Public Works Department (PWD) in view of the preparations for G20, which will see visitors from all over the world. # Yamuna Vihar man, son shot at by neighbour over parking

vened," police said.

Later, Arif barged inside the Aggarwals' house, a building in front of his rented accommodation, and started arguing with the family, the



officer said. The argument escalated and Arif and his associates opened fire, injuring Virender and Sachin, police added. The victim deals in building materials.

Virender's other son Saurabh Aggarwal said 10-15 rounds were fired by the group. Police said local people managed to catch one of Arif's two associates. He The locals alleged that the

accused, who was taken to GTB hospital, seemed under the influence of some intoxicant, police said, adding that medical examination will clear According to police, Arif deals in second-hand cars and had shifted to the neighbourhood around seven to eight

A case under sections 307 (attempt to murder) and 34 (common intention) of the



IPC and Arms Act was registered at Bhajanpura Police Station and the investigation was initiated. Arif and his other associate are absconding. Multiple teams have been formed to nab them, police said. There is no communal angle in this incident. However, police presence in the area has been increased to prevent any kind of rumours or any untoward situation, they added.

Subhash Aggarwal, the younger brother of Virender, said, "We have been living here for the past 35 years and nothing like this happened before in the area. Our society is very peaceful and people know each other for long. First time I am seeing that the firing took place over a parking issue. We have asked the accused earlier also to move his car and no scuffle took place then.'

The council deliberated on a slew of matters including the extension of the adoption of the Common University Entrance Test (CUET) in its undergraduate and postgraduate courses. The matter will be presented before the next meeting of the Executive council - the highest decision-making body of the varsity. JMI Vice the varsity. Chancellor Najma Akhtar told PTI that the varsity was in the process of adopting several aspects of the NEP. "We have tried to adopt all aspects of the National Education Policy. We

are taking steps to adopt sev-

eral parts of NEP."

The NEP, approved by the government in August 2020, replaced the 34-year-old National Policy on Education framed in 1986 and is aimed at paving the way for "transformational reforms" in school and higher education systems to make India a "global knowledge superpower.'

'In the recently held Academic Council meeting, the members adopted UGC guidelines for multiple entry and exit options in academic programmes offered in higher education institutions and implementation of the layout of restructured four-year undergraduate programmes," Akhtar said. Jamia is likely to offer four-year undergraduate programmes (FYUP) with multiple exit and entry options from the upcoming academic session. The layout of the programme was adopted in a recently held AC meeting. The matter will now be presented in the next meeting of the Executive Council, which is the highest decision-making body of the university, they said.





# Won't accept advice on investors' safety in sealed cover: SC to Govt

The Supreme Court on Friday refused to accept in a sealed cover the Centre's suggestion on a proposed panel of experts for strengthening regulatory measures for stock markets in the wake of the recent crash of Adani Group triggered Hindenburg Research's fraud allegations. Observing that it wanted "full transparency for protection of investors", the SC also ruled out the possibility of any sitting judge overseeing the functioning of the proposed panel and said it will appoint a panel of experts on its own. "We are closing it for orders," said the Bench headed by Chief Justice DY Chandrachud after hearing brief submissions by Solicitor

General Tushar Mehta and

PIL petitioners, including



lawyers Prashant Bhushan and ML Sharma. The law officer said he had given a note on the names and "remit" (scope) of the committee in a sealed cover. "This has been given with two intentions in mind. A) A holistic view is taken and the truth comes out; B) No unintended message goes out having an impact on the security market, which is an emotion driven market," Mehta

The bench referred to the losses suffered by the investors. the SG said he has no issues with regard to any judge supervising the committee. "We would rather not accept

the sealed cover suggestions. We want to ensure transparency. In case we take your suggestions from sealed cover, it automatically means the other party won't know," said the bench, which also comprised Justices PS Narasimha and JB Pardiwala.

"We want full transparency for the protection of investors. We will form a committee. There will be a sense of confidence in the court," the bench said. "Sitting (SC) judges can hear the matter and they cannot be the part of the committee," the CJI said, adding he has been facing difficulties in setting up benches everyday.

On February 10, the top court had said the interest of Indian investors need to be protected against market volatility against the backdrop of the Adani Group stocks rout and asked the Centre to consider setting up a panel of domain experts headed by a former judge to look at strengthening the regulatory mechanism. The crucial hearing on

the PILs on Friday assumed significance in the wake of the recent developments like the Centre agreeing to the apex court's proposal to set up a committee, likely to be headed by a former Supreme Court judge, to go into the regulatory regimes. The Centre had told the bench that it wanted to provide details such as names and the scope of the panel's mandate in a "sealed cover". SEBI, in its note filed in the court, had indicated it is not in favour of banning shortselling or sale of borrowed shares, and said it is investigating allegations made by a tiny short-seller against Adani Group as well as its share price movements.

# India readies list of activities for carbon credit trading

Tn a move aimed at meeting Lits goal of Net Zero emissions by 2070 and reduce the carbon intensity of its economy by more than 45 per cent, India has finalised a list of activities to be considered for trading of carbon credits in the carbon markets under bilateral/ cooperative approaches.

The list comes days after the Government in the Union Budget 2023 gave a fresh thrust to the country's transition to clean energy by allocating Rs 35,000 crore in priority capital investment towards achieving the goal of net zero carbon emission by 2070. An additional Rs 19,700 crore was sanctioned towards the Government's National Green Hydrogen Mission, being seen as a fuel of the future.

As expected, under the GHG mitigation measures, the Government is banking on



green hydrogen, renewable energy with storage (only stored component), solar thermal power, off- shore wind, compressed bio-gas, emerging mobility solutions like fuel cells, high end technology for energy efficiency, sustainable aviation fuel, best available technologies for process improvement in hard to abate sectors, tidal energy and ocean thermal energy to move towards clean energy system.

Other areas are ocean salt gradient energy, ocean wave energy and ocean current energy, high voltage direct current transmission in conjunction with the renewable energy projects. Under the category, alternate materials it hopes projects

related with green ammonia will have good potential to earn carbon credit.

"These activities will facilitate adoption/transfer of emerging technologies and may be used to mobilise international finance in India. The activities will initially be for the first three years and may be updated/revised by the concerned authorities. The projects under the

said activities may take part in international carbon market under Article 6 mechanisms, according to which emission reductions that have been authorized for transfer by the selling country's government may be sold to another country, but only one country may count the emission reduction toward its Nationally Determined Contributions (NDCs). It is critical to avoid double counting so that global emission reductions are not

Temple defacement: Canadian MP asks authorities to 'take issue seriously'

His condemnation of hate crimes by "anti-Hindu" and "anti-India" groups came days after a temple was sprayed with graffiti in Ontario's Mississauga city with anti-India graffiti on Tuesday.

Arya also recalled other ncidents of 'hate crimes' by ʻanti-Hindu' and ʻanti-India' groups and urged the authorities to 'take the issue serious-

He condemned the defacing of the latest incident and said, "It is with pain and anguish I note that the Ram Mandir, a Hindu temple in Mississauga has become the latest target of hate crime. Authorities in Canada need to seriously look into the activities of anti-Hindu and anti-India groups and take action now." He shared his speech in the House of Commons on

A Hindu temple was desecrated with anti-India and pro-Khalistan graffiti. The slogans spray-painted in the back of the Shri Ram Mandir in the area included those attacking India, Prime Minister Narendra Modi and describing the founder of the separatist Khalistan movement, Jarnail Singh Bhindranwale, as a 'mar-

The issue was earlier raised by India's High Commission in Ottawa with the Canada's foreign ministry. "We strongly condemn the defacing of Ram Mandir in Mississauga with anti-India graffiti. We have requested Canadian authorities to investigate the incident and take prompt action on perpetrators," India's consulate in Toronto tweeted

# IRCTC to run Gurukripa Trains for Sikh pilgrimages

fter special Bharat Gaurav Attrains to Hindu pilgrimage sites, the Indian Railway Catering and Tourism Corporation (IRCTC) is set to run a special train service to places of significance for the Sikh community. Christened as Gurukripa Train, it will run from Lucknow on April 5 and take pilgrims to gurdwaras and five Takhts in Punjab, Maharashtra, Karnataka and Bihar.

The announcement comes at the backdrop of Railways flagging off its Bharat Gaurav deluxe AC tourist train on Friday for a tour of the "Shri Ram-Janaki Yatra: Ayodhya to Janakpur", covering two significant pilgrimage centres of Ayodhya in India and Janakpur in Nepal. The tourist train is expected to strengthen the relations and promote the cultural relations between the two neighbouring countries. The tour package will also include visits to Nandigram, Sitamarhi, Kashi



and Prayagraj as added attractions.

A senior Railway Board official said the IRCTC will run the Gurukripa Yatra train which will take pilgrims to Gurudwaras in Sitapur, Pilibhit and Bareilly in Uttar Pradesh. After that its first halt will be in Shri Kesgarh Sahib and then it will go to Anandpur Sahib. From there, it will go via Shri Fatehgarh Sahib to Shri Akal Takht, Amritsar; Shri Damdama Sahib, Bathinda; Shri Hazur Sahib, Nanded-Maharashtra; Shri Guru Nanak Jhira Sahib, Bidar-Karnataka; and Patna

The journey will be of 10 nights and 11 days. The capacity of the tourist train is 678. The Gurukripa train will have modern sleeper, AC-2 and AC-3 coaches. The fare for sleeper will be Rs 19,999 per passenger, while the AC-3 fare will be Rs 29,999, and AC-2 fare 39,999. # **'Hindu Rashtra** idea against Bapu's ideals'

Bihar Chief Minister Nitish Kumar on Friday frowned upon the Sangh Parivar's con-cept of India as a "Hindu" nation, underscoring that his militated against what Mahatma Gandhi stood for.

The veteran Socialist leader, who ended his long alliance with the BJP last year, was responding to queries from journalists about the "Hindu rashtra" clamour, which was openly endorsed earlier this week by his Uttar Pradesh counterpart Yogi Adityanath.

"We must not listen to any thing that goes against what Bapu stood for. In this country, people of all religions live together. Bapu stood for unity and this was the reason for his assassination", said Kumar, who draws inspiration from Mahatma's views in formulating his ideas of governance.

The Chief Minister also warned that any deviation from Gandhi's insistence on secularism could lead to perversions (jo isse kuchh alag karna chahta hai, No ulta pulta karna chahta hai). A product of the Bihar movement of 1974, Kumar had aligned with the BJP way back in the 1990s and held important portfolios in Atal Bihari Vajpayee Government.

The longest-serving CM assumed power in Bihar in 2005 and his rule has been marked by a refusal to give in to BJP's "Hindutva" plank despite alliance. The hardline "Hindutva" image of his then



Modi had caused him to have reservations about BJP leader campaigning for elections in Bihar and break alliance when it became evident that saffron party wanted to make charismatic leader its Prime Ministerial candidate.

Kumar realigned with BJP in 2017, only to call off alliance five years later, but maintained a distinct ideological position on key issues like Ayodhya, Article

370, triple talaq and NRC.

The chief minister spoke to journalists on the sidelines of a function where his deputy Tejashwi Yadav, of current ally RJD, was also present. He reacted dismissively to allegations of RJD's MLA and former minister Sudhaker Singh that gov-ernment was "anti-farmer".

"These people have no idea how much has been done by us for farmers and how much progress has been made in agriculture sector", said Kumar, refusing to give any importance to recalcitrance of Singh, who was first made to resign as agriculture minister and thereafter served with a show cause by his party for frequent vitu-

### Nitish raps IT raids on BBC, rejection of demand for probe into Adani Group

Patna: Bihar Chief Minister Nitish Kumar on Friday said the Income Tax Department's surveys on the BBC's premises in Delhi and Mumbai were a "clear cut" indication of the Narendra Modi Government's intolerance of criticism.

Talking to reporters on the sidelines of a function here, the JD(U) leader also criticised the brusque manner in which the demand for a Joint Parliamentary Committee probe into allegations against the Adani Group has been rejected by the Centre, pointing out that this was unlike the Vajpayee era when the voice of the Opposition was given a patient hearing.

"I had been busy with my Samadhan Yatra all these days. But I read something about it (IT raids) in newspapers. I will try to learn about it in more detail," Kumar said in reply to a question on the action against the international broadcaster.

When his attention was drawn to the fact that the IT department's survey has come shortly after a documentary produced by the BBC, on the Gujarat riots, raised the hackles of the Modi government which has banned its telecast across the country, Kumar

"While in Bengal we provide land and shelter to the people, in UP they torture them... Snatch their dwelling places," Banerjee said.

"In Bengal they will frequently send central teams but no central team was sent to probe the incident at Kanpur,' the Chief Minister said while addressing a gathering a meeting at Bankura.

The Bengal government had been highly critical of the Centre for frequently sending teams to inquire into the proper implementation of schemes funded by the New Delhi. Much to the chagrin of the



Chief Minister Central teams have been visiting Bengal at regular intervals to inquire into the implementation of PMAY (housing) scheme, MNREGA, alleged violation of human rights etc.

"On one hand they have stopped all funds that rightfully belong to the State ... and on the other they will send central teams to humiliate us ... am I a magician to implement the schemes without funds," Banerjee had said on Thursday.

She alleged that while the Centre takes away the GST it refuses to pay back the State's share to the effect that more than Rs one lakh crore was presently due from the Centre. The Chief Minister had been visiting the districts announcing various schemes ahead of the panchayat elections.

# SC refuses to refer Sena case to bigger seven-judge Bench

The Supreme Court on Friday declined to refer pleas related to the June 2022 Maharashtra political crisis triggered by the Shiv Sena's division to a seven-judge Bench for reconsideration of the 2016 Nabam Rebia judg-

The judgment came to the rescue of the rebel Shiv Sena MLAs led by Eknath Shinde, now the Chief Minister of Maharashtra. The party's Uddhav Thackeray faction had sought their disqualification even when a notice of the Shinde group for the removal of Maharashtra Assembly Deputy Speaker Narhari Sitaram Zirwal, a Thackeray loyalist, was pending before the House.

In 2016, a five-judge Constitution bench, while deciding the Nabam Rebia case of Arunachal Pradesh, had held that the assembly speaker cannot proceed with a plea for disqualification of MLAs if a prior notice seeking the speaker's removal is pending before the House.

A five-judge Constitution bench headed by Chief Justice DY Chandrachud said whether the 2016 Nabam Rebia judgement requires reference or not

will be considered with the merits of the case on February 21. The Bench said the issue whether a reference to a larger seven-judge bench is to be made can not be considered in an "abstract, isolated and divorced" manner. "Whether the principle

formulated in Nabam Rebia has an impact on the factual position in the present case needs deliberation. The issue whether the reference of the decision in Nabam Rebia to a larger bench is warranted would be determined together with the merits of the case.

"Consequently, hearing on merits of the case will be held on Tuesday, 10:30 am," said the bench, which also comprises justices MR Shah, Krishna Murari, Hima Kohli and PS Narasimha. Senior advocates Kapil Sibal and AM Singhvi, appearing for the Thackeray faction, had sought reference of the cases to a seven-judge bench for a relook at the Nabam Rebia judgment.

Senior advocates Harish Salve and N K Kaul, appearing for the Shinde-led faction, had opposed the reference to a larger bench. Solicitor General Tushar Mehta, appearing for the Maharashtra Governor, had also opposed any move to refer the matter to a larger

Bajrang Dal is the youth wing of the VHP. Reacting to the allegation, VHP joint general secretary Surendra Jain said, "It seems that without preliminary investigation, the Rajasthan Police have assumed that the names taken by the smuggler's brother are responsible for the incident.

Claiming that the Assam Government's fortnightlong crackdown on child marriage had a "positive" impact in the State, Chief Minister Himanta Biswa Sarma on Friday said several families had cancelled scheduled weddings of underage people as a fallout of the ongoing drive.

The operation started on February 3 and 3,031 people have been apprehended against registration of 4,225 cases till "Reports are coming from

various parts of Assam that several families have cancelled pre-scheduled marriages between underage children after our drive against such illegal practices," Sarma wrote on Twitter. "This is definitely a positive impact of our twoweek long crackdown against child marriage," he added on the micro-blogging site.

Opposition parties have criticised the manner in which the drive is being carried out, terming the arrests of teenage husbands and family members as an "abuse of law" for political gain, and equating the police action with "terror-

ising people".

The Gauhati High Court had also come down heavily on the state government for slapping stringent laws like the Protection of Children from



Sexual Offences Act, 2012 (POCSO) and rape charges on child marriage accused, and stated that these are "absolutely weird" allegations.

Observing that arresting a large number of people in the crackdown has created "havoc in the private life of people", Justice Suman Shyam had on February 14 said there is no need for custodial interrogation of the accused in such cases.

Coming under criticism for failing to secure the future of the affected women and their children, the government had on February 9 formed a cabinet sub-committee for rehabilitation of the "victims".

Asserting that the drive will continue till the 2026 Assembly election, Sarma had justified the measures and said nearly 17 per cent of over 6.2 lakh pregnant women in Assam last year were teenagers, according to the Reproductive and Child Health (RCH) portal.

Rights body raps Assam Govt for crackdown on child marriages, arresting 3K people

**New Delhi:** The Association for Protection of Civil Rights on Friday lashed out at the Assam Government for arresting over 3,000 people allegedly involved in child marriages, accusing it of creating fear among the minorities in the The Government's crackdown on child marriages began on February 3, and 3,031 people have been apprehended against registration of 4,225 cases till Tuesday, according to officials.

Advocate Tamanna Pankaj, who was a part of a fact-finding team of the rights body that conducted a survey in Dhubri district in Assam, alleged that the state police has been "violating guidelines" and arresting people "by barging into their houses".

"More than 2,700 people have been arrested so far in the name of women protection. The police there have been violating guidelines and arresting people in the early hours of the day. By these actions, the administration is instilling fear among the people, copulation the minority community,"

PTI Pankaj alleged.

conspicuous feature of Republican leader Nikki Haley's presidency bid is her embrace of her country of origin. "I am the proud daughter of Indian immigrants embrace of her country of origin. I am the product data.

and I am blessed that they are here today," she said while launching the presidential campaign. This is in sharp contrast with the attitude of Bobby Jindal's. Also a Republican like Haley, he has the distinction of being the first Governor (of Louisiana) of Indian origin. Again like her, he was also a rising star in his party, eyeing the top office. Just like her, he too converted to Christianity. But, unlike her, he didn't want to be known by his origins. Jindal said, "I am done with all this talk about hyphenated Americans." He went on to say, "We are not Indian-Americans, African-Americans,



Irish-Americans..." We are just Americans, period that was his ideology. On the other hand, Haley has no problems highlighting, even being proud of, her origins. In general, however, her position is essentially Republican or conservative — that is, conservative in the American sense of the word. Even though she is challenging former president and her former boss Donald Trump who appointed her as Ambassador to the United Nations, her views on most issues are not much different from Trump's. But she blamed Trump for the January 6, 2021, turbulence at the US Capitol (liberals call it an 'insurrection') and suggested that the Republican Party would move on without him.

In consonance with Trump's anti-China stand, Haley slammed China in her launch address, asserting that the communist nation will also end up on the "ash heap of history," just like the erstwhile Soviet Union. Would she, if elected American president, be good for India? Well, her ethnicity is unlikely to mould her policies; at any rate, for one, the institutions and mechanisms in developed countries are too strong for a head of government to impose their whims and fancies. Secondly, politicians in democratic countries think about the electoral and political prospects, and these are determined by the people in their countries, not in other countries. The reason is that the Democratic Party is heavily influenced by the radical Left, as evident from its thoughtless support for the anarchist 'defund the police' movement, the divisive critical race theory, and the increasingly doctrinaire climate change policies. We must remember that it was Trump's relentless campaign against China that built a climate of opinion in the US against China. Haley will be good for the US, India, and the world—and so would be any other Republican president.

akistan has now been abandoned by its donors. Pakistan's Prime Minister Shehbaz Sharif knocked at the doors of all the donors in the recent weeks. He went to Saudi Arabia. Sharif rushed to Beijing to congratulate Xi Jinping when he took the third term as the general secretary of the Chinese Communist Party. He went to Washington and Dubai. Turkey has spurned him. At last, Pakistan is now signing on the dotted lines to secure a \$1.2 billion tranche loan from the International Monetary Fund (IMF).

The foreign currency reserves of Pakistan is now below \$3 billion. Pakistan is not left with enough foreign currency to meet three months of imports. Offices and commercial establishments now down their shutters by the dusk in Pakistan. Electricity at home is a luxury. Buying petrol and diesel now is a sign of

the richness of the people.
As long as dollars flowed into Pakistan because of the largess of the donors, Islamabad indulged in excesses. Economic prudence was foreign to the policy makers and the political establishment. The people were addicted to not paying for the electricity consumption. Electricity subsidies touched all sections of the society. Military, farmers, businessmen, politicians and others indulged in the freebies of Pakistan.

Little more than a year ago, the US left Afghanistan and also left behind a message to Pakistan that Washington would now give a damn to its geo-strategic blackmailing. Pakistan's former patrons too learnt lessons that they had burnt their cash enough in the Pakistani black hole. China never forgives those who fritter away its money. The pipeline of easy money to leverage a life of indulgence even while there was no healthy revenue ran dry in a span of one year.

Pakistan has gone for a steep hike in the electricity charges. The government there has imposed several surcharges across the electricity consumption groups. Now, all will have to pay for the electricity at rates, which would be much higher than normal market pricing. Sri Lanka also has decided to hike the

electricity rates. The Sri Lankan government on Thursday announced a 66 per cent hike in the electricity rates. Inflation in Pakistan and Sri Lanka is riding rockets. Inflation in Sri Lanka is now over 56 per cent. Inflation numbers for Pakistan are now redundant, as viral videos from the Islamic nation show that the people are indulging in street fights for a piece of bread.

Before Pakistan went broke financially, Sri Lanka had declared default on the servicing of the foreign debts. Pakistan is on the verge of default. Both the nations are begging the International Monetary Fund (IMF) for bail out. The international lending agency has dug in its heels. It

earning is most effective when communication ⊿and collaboration are encouraged. At the same time, technology too has been a major factor in education from its inception. Today, it defines how we live and interact with one another. Whether we like it or not, technology is everywhere.

With the advancement in the field of digital technology, youth is more attracted towards social media, messaging platforms, gaming platforms and mobile phones. There is also an accompanying fastest growing digital crime termed as cyber bullying.

Bullying, once restricted to the school or neighbourhood, has now moved into the online world. Cyber bullying or cyber harassing is often termed as



electronically mediated behaviours among peers. It is often a repeated behaviour aimed to scare, anger or shame a target. Ukraine's top military officer later acknowledges that the attacks on Crimea were launched by Kyiv's forces.

On August 20, Darya Dugina, the daughter of Russian nationalist ideologist Alexander Dugin, dies in a car bomb explosion outside Moscow that the Russian authorities blame on Ukraine.

### **SEPTEMBER**

On September 6, the Ukrainian forces launch a surprise counteroffensive in the northeastern Kharkiv region,

back from broad areas held for months. On September 21, Putin orders mobilization of 300,000 reservists, an unpopular move that prompts hundreds of thousands of Russian men to flee to neighbouring countries to avoid recruitment.

# Ukrainian refugees safe, but not at peace, after year of war with Russia

Moccupied southern Ukraine's Kherson province last year, they started paying visits to the home of a Ukrainian woman and her Russian husband.

They smashed their refrigerator and demanded possession of their car. One day, they seized the wife and her teenage daughter, put pillowcases over their heads and led them away.

The woman was locked up for days, her legs beaten with a hammer. The men accused her of revealing Russian soldiers' locations. They subjected her to electric shocks and bore down on her feet with the heels of their military boots until two of her toes broke. She heard screams nearby and feared they came from her daughter.

More than once, with a bag on her head and her hands tied, a weapon was pointed at her head. She'd feel the muzzle at her temple, and a man started counting. One. Two. Two and

a half. Then, a shot fired to the

'Although at that moment, it seemed to me that it would be better in my head," she told The Associated Press, recounting the torture that lasted five days, counted by the sliver of sunlight from a tiny window in the room. "The only thing that kept me strong was the awareness that my child was some-

where around." The Russian officials eventually released the woman and her daughter, she said, and she made her way home. She took a long shower and packed a bag, and the two fled the occupied area - first to Russianoccupied Crimea and then to mainland Russia, from where they crossed by land into Latvia and finally Poland.

Her body was still bruised. and she could barely walk. But in December in Warsaw, she reunited with a son. And she and her daughter joined the refugees who have fled their homes since Russia launched its full-scale invasion of

# Protests hit multiple Iran cities for first time in weeks

Protesters in Iran marched through the streets of multiple cities overnight in the most widespread demonstration in weeks amid the monthslong unrest that's gripped the Islamic Republic, online videos purported to show Friday.

The demonstrations, marking 40 days since Iran executed two men on charges related to the protests, show the continuing anger in the country. The protests, which began over the Sept. 16 death of 22-year-old Mahsa Amini after her arrest by the country's morality police, have morphed into one of the most serious challenges to Iran's theocracy since the 1979 Islamic Revolution.

Videos showed demonstrations in Iran's capital, Tehran, as



well as in the cities of Arak, Isfahan, Izeh in Khuzestan province and Karaj, the group Human Rights Activists in Iran said. The Associated Press could not immediately verify the videos, many of which had been blurred or showed grainy nighttime scenes.

In Iran's western Kurdish regions, online videos shared by the Hengaw Organization for

Human Rights showed burning roadblocks in Sanandaj, which has seen repeated demonstrations since Amini's death.

Hengaw shared one video that included digitally altered voices shouting: "Death to the Dictator!" That call has been repeatedly heard in the demonstrations, targeting Iran's 83vear-old Supreme Leader Ayatollah Ali Khamenei. Other

Tehran had similar chants, as well as scenes of heavily protected riot police in the street. Protesters also marched in

Iran's Sistan and Baluchestan province near Pakistan after Friday prayers, online videos showed. Anti-government demonstrations have been happening for months as well on Fridays in the restive province, which is a majority Sunni region. Its Baluch people long have complained about being treated as second-class citizens by Iran's Shiite rulers.

Iranian state media did not immediately acknowledge the demonstrations.

Since they began, at least 529 people have been killed in demonstrations, according to Human Rights Activists in Iran. Over 19,700 others have been

violent crackdown trying to suppress the dissent. Iran for months has not offered any overall casualty figures, though the government seemed to acknowledge making "tens of thousands" arrests earlier this month.

The demonstrations had appeared to slow in recent weeks, in part due to the executions and crackdown, though protest cries could still be heard at night in some cities.

Forty-day commemorations for the dead are common in Iran and the wider Middle East. But they also can turn into cyclical confrontations between an increasingly disillusioned public and security forces that turn to greater violence to suppress them, as they had in the chaos leading up to Iran's 1979 revo-

# **'Budget's focus on capex** to raise pvt investment'

To push growth to 7%: RBI article

**PTI** MUMBAI

The Union Budget's focus on capital expenditure is expected to crowd-in private investment and push the GDP growth rate close to 7 per cent in the next financial year beginning April 1, said a Reserve Bank article on 'State of the Economy'. In 2023-24, capital expenditure is budgeted at Rs 10 lakh crore which will constitute 3.3 per cent of GDP.

"We believe that India will decouple from macroeconomic projections of current vintage and also from the rest of the

"In our view, the instrument of decoupling will be the Union Budget by raising India's growth prospects over the period 2023-27; and raising India's potential growth," said the article 'State of the Economy' published in the RBI's February 2023 Bulletin.

It further said the Union Budget's tax, capex and fiscal consolidation proposals can



take India's real GDP growth close to 7 per cent in 2023-24 if they are effectively imple-

'The Union Budget 2023-24's emphasis on capital expenditure is expected to crowd-in private investment, strengthen job creation and demand, and raise India's potential growth," said the article authored by a team lead by RBI Deputy Governor Michael Debabrata Patra. The Economic Survey tabled in Parliament a day head of the Union Budget projected the GDP growth at 6.5 per cent as the base.

The central bank, however, said the views expressed in the article are of the authors and do not represent the views of the Reserve Bank of India

### India's forex RBI issues final reserves drop guidelines on interest by \$8.32 bn rate risk in banking book to \$566.95 bn

The Reserve Bank on Friday issued final guidelines on Interest Rate Risk in Banking Book which require banks to measure, monitor, and disclose their exposure to IRRBB that may impact the capital base and future of earnings of

IRRBB refers to the current or prospective risk to banks' capital and earnings arising from adverse movements in interest rates that affect its banking book positions. Excessive IRRBB can pose a significant risk to banks' current capital base and/or future

"These guidelines, accordingly, require banks to measure, monitor, and disclose their exposure to IRRBB," the RBI said in a circular.

The final guidelines on IRRBB are in alignment with the revised framework issued by the Basel Committee on Banking Supervision (BCBS).

date for implementation of the guidelines will be communicated in due course.

"Banks are advised to be in



preparedness for measuring, monitoring, and disclosing their exposure to interest rate risk in the banking book" in terms of the circular, it added.

As per the guidelines, the Board of the banks has the responsibility for understanding the nature and the level of the bank's IRRBB exposure. The Board should approve broad business strategies as well as overall policies with respect to IRRBB

Accordingly, the circular said the Board is responsible for ensuring that steps are taken by the bank to identify, measure, monitor and control IRRBB consistent with the approved strategies and policies.

## 'Raise GST exemption threshold to ₹1.5 crore' Do away with state-wise reg of biz: GTRI

The Goods and Services Tax Council should consider raising the GST exemption threshold to ₹1.5 crore annual turnover and also do away with the requirement of state wise registration, which would help ease compliance, economic think tank GTRI said on Friday

The GST network has over 1.4 crore registered taxpayers, making it the largest global platform for indirect "The GST Council now

needs to consolidate gains by making compliance easy," the Global Trade Research Initiative (GTRI) said, while recommending seven reforms for next phase of transformational growth.

The think tank suggested increasing the GST exemption limit to ₹1.5 crore, which it feels will be a game changer for India's MSME sector and set them on the path to job creation and growth. Currently, registration for

# After Club World Cup, Al-Hilal turns attention back to Asia

Days after losing 5-3 to Real Madrid in the final of the FIFA Club World Cup, Saudi Arabia's Al-Hilal returns to its home continent to try and extend its recent dominance of the Asian Champions League in a second-round match against Shabab Al-Ahli of

In 2019, Al-Hilal broke the eastern zone stranglehold of the tournament that had seen teams from Australia, China, South Korea and Japan winning every title but one from 2006 to 2018. The Riyadh club repeated the win in 2021, to become champion of Asia for a record fourth time.

This is still the 2022 edition as the eight teams from West Asia — the tournament is divided into two geographic zones until the final — finished the group stage last April. The delay is due to the Champions League transitioning from its traditional March-to-November calendar to a

European-style August-to-May schedule in the 2023-24 season. Leonardo Jardim led Al-Hilal to its last Asian Champions League title in

November 2021 but the Portuguese coach is now in charge of opponent Shabab Al-Ahli. The former Monaco boss knows that Monday's against a star-studded team.

"Al-Hilal has won the

Asian title twice in three years and was preparing for that for six or seven years before that," Jardim said. "This is a team with a lot of strong foreign players but also have many of the Saudi Arabian internationals who played at the World Cup. Hilal is always a strong

# **Australian Govts agree funding split for 2032 Olympics**

The federal and the Queensland State State Government have agreed on an almost 50-50 funding split to build or remodel venues for the 2032 Brisbane Olympics. Australian Prime Minister

Anthony Albanese visited the Queensland state capital Friday to make the formal announcement about a deal worth an estimated 7 billion Australian dollars (\$4.8 bil-

The federal government

indoor arena at Roma Street, the city's main public trans-port hub, and contribute to other stadium and venue refurbishments. The state government will be responsible for demolishing and rebuilding the Gabba, which will be the main stadium for the Olympics. The Gabba is the long-time home of cricket in Queensland state.

'This will leave a really lasting legacy for Queensland," Albanese told local radio station 4BC. "It's an investment that will produce a return with increased economic



activity, increased visitors ... Oueensland is such a fantastic tourist destination and this

will really showcase the state." Federal Sport Minister Anika Wells told ABC radio it would be a 50-50 funding split. "It's an agreement between the federal government and the Queensland government about how we're going to pay for all of the infrastructure that the southeast Queensland venues will need to put on the 2032 Games," she said.

International Olympic Committee awarded

the 2032 Games to Brisbane in July 2021 under a revamped procedure for choosing host cities in which a small group of IOC members identify and propose host cities to the board. That made Brisbane next in line after Paris and Los Angeles, giving local organiz-

Australia has twice previously hosted the Summer Olympics, at Melbourne in 1956 and Sydney in 2000. The state government of New South Wales picked up most of the costs for the 2000 Games.

### Olympic bribery trial opens; accused Tokyo C accepts guilt

trial looking into wide-Aspread bribery at the Tokyo Olympic organizing committee began Friday with a former head of a major ad company admitting to the

charges.

Shinichi Uneo, who formerly headed ADK Holdings, quietly told the Tokyo District Court the allegations were accurate. In Japan, a trial continues even if a suspect admits guilt. Three prosecutors took turns reading their opening statement during a two-hour session.

Ueno is accused of paying

nearly 15 million yen (\$110,000) to Haruyuki Takahashi, a former executive at ad giant Dentsu, who wielded powerful influence in selecting sponsors for the 2020 Games. Ueno is among 15 people arrested in the bribery scandal.

Takahashi has long been a prominent person in sports marketing with Dentsu, the official marketing partner of the Tokyo Olympics. Dentsu has also been implicated in a scandal to bribe International Olympic Committee members who picked Tokyo back in 2013.

The sprawling scandals



around the Tokyo Olympics have badly damaged the chance of the northern city of Sapporo of landing the 2030 Winter Olympics. It was the early favorite. The IOC has now pulled Sweden into a possible bid for the 2030

Tokyo officials spent \$13 billion to hold the delayed Tokyo Games, although a Japanese government audit suggested the real price might have been twice that much.

Other trials involving Olympic bribery are expected to follow, including that of Takahashi. Takahashi is suspected of having received

about 200 million yen (\$1.5 million) in bribes from various companies.

A trial began in December of three officials formerly at clothing manufacturer Aoki Holdings. Aoki was chosen to make licensed products, including outfits for the Japanese Olympic team.

Another company embroiled in the scandal is publisher Kadokawa, where two officials have been arrested. They are accused of paying 76 million yen (\$540,000) to Takahashi. The sponsorship allowed Kadokawa to publish programs and other books

related to the Tokyo Olympics. Sun Arrow, which pro-

duced the Olympic and Paralympic mascots named Miraitowa and Someity, is also scheduled to stand trial. Tokyo prosecutors are

also carrying out a separate investigation over bid-rigging for Olympics pre-events, and possibly the actual Games. Senior Olympic official

Yasuo Mori, Dentsu's sports division chief Koji Henmi, and two other executives at event organizing companies were arrested earlier this month on charges of violating anti-monopoly laws.

(81, 125 balls) made amends for a horrendous first-Test outing at Nagpur with an attractive knock while Peter Handscomb (72 not out, 142 balls) played with determination at the Arun Jaitley Stadium on Friday, but their efforts weren't enough as the visitors were all out in 78.4

At stumps, India were 21 for no loss with Rohit Sharma (13 batting) and KL Rahul (4 batting) at the crease. Shami's (14.4-4-60-4) repertoire of deliveries was on full display as he struck with the new, semi-new and old ball, while Ashwin (21-4-57-3) and Jadeja (21-2-68-3) came up with breakthroughs



just when the opposition seemed to be gaining foothold as India took the opening day's

The highlight on Friday was KL Rahul's brilliant catch at point off a powerful reverse sweep by Khawaja. That athletic effort not just broke the 59run sixth-wicket partnership between Khawaja and Handscomb it also halted Australia's charge.


