# NOTE BAN VALID: SC

DeMo notification does not suffer from any flaws in decision-making process: Court

The Supreme Court's five-judge Constitution bench on Monday in a majority 4-1 judgment upheld the Central Government's decision of demonetisation of ₹1,000 and ₹500 notes in 2016.

Observing that the scope of judicial review in matters of economic policy is "narrower", the majority verdict said there has to be great restraint in matters of economic policy and the court will not interfere with any opinion formed by the Government if it is based on the relevant facts and circumstances or on expert advice.

On the issue of directing the RBI to accept the demonetised currency notes still in possession of individuals, the court said the RBI has no independent power to accept the demonetised notes beyond the specified period. The court directed the registry to place the matter before the CJI for placing the matter before the appropriate Bench.

The dissenting judge Justice BV Nagarathna said that the decision was vitiated and unlawful and the RBI did not apply its mind. The lone dissenting judge also said that such decisions should have come through legislation and not through notifications.

The majority decision pronounced by Justice BR Gavai, supported by the Bench headed by Justice S Abdul Nazeer and Justice AS Bopanna and Justice V Ramasubramanian said the decision-making not flawed merely because the procedure emanated from the Government.

The SC also noted that there was consultation of six months between Government and RBI and observed that enough time of 52 days was given to exchange the cancelled notes, as compared to the eight days given during the demon-

etisation of 1978. "There was consultation between the Centre and the RBI for a period of six months. We hold that there was a reasonable nexus to bring such a measure, and we hold that demonetisation was not hit by doctrine of proportionality," the judgment said, adding, "It has been held that there has to be great deal of restraint before interfering in matters of economic significance... We cannot supplant such views with the judicial one."

expertise to do so," it said. Mere errors of judgment by the Government seen in retrospect are not subject to judicial review, it added.

On the issue of hardship suffered by citizens during demonetisation, the apex court said if the impugned notification had a nexus with the objectives to be achieved, then, merely because some citizens suffered hardship, it would not be a ground to hold the impugned notification to be bad in law.

"The decision-making

process is also sought to be attacked on the ground that the decision was taken in a hasty manner. We find that the 'hasty' argument would be destructive of the very purpose of demonetisation.

"Such measures undisputedly are required to be taken with utmost confidentiality and speed. If the news of such a measure is leaked out, it is difficult to imagine how disastrous the consequences would be... It can thus be seen that confidentiality and secrecy in such sort of measures is of paramount importance," the Bench said.

the function of the court to sit in judgment over matters of economic policy, the top court said such issues must necessarily be left to the Government of the day to decide and the courts can certainly not be expected to decide them without even the aid of experts.

"In the present case also the delegation is to the Central Government, i.e. the highest Executive body of the country. We have a Parliamentary system in which the Government

is responsible to the Parliament. "In case the Executive does not act reasonably while exercising its power of delegated legislation, it is responsible to Parliament who are elected representatives of the citizens for whom there exists a democratic method of bringing to book the elected representatives who act unreasonably in such matters," the Bench said.

## **'Vitiated,** unlawful', says judge in dissent

In her dissenting verdict, Justice BV Nagarathna said the decision to implement demonetisation in November 2016 was vitiated and unlawful and the RBI could not have applied its mind on the proposal sent by the Central Government in 24 hours.

In her 122-page dissenting judgment against the majority judgment of four judges, she said such serious decisions concerning the citizens should have come through legislation and not throug

"Looking at the records submitted by the RBI, it is noted that it says 'as recommended by the Central Government. This shows there was no independent application of mind by the RBI. Such a proposal with serious economic ramifications must be placed before the Central Board of the Bank so that there is an application of mind by the experts," she said.

Nagarathna also compared the demonetisation process in many countries like the US, the

UK, Venezuela, and Nigeria and said that such decisions must have come through legislature and not through notifications.

Observing that there was no independent application of mind by the RBI, she said the entire exercise was carried out in 24 hours.

### Terrorists verified identity of residents before killing them

The New Year has begun on a bloody note for Jammu & Kashmir. After terrorists gunned down four civilians on Sunday, a powerful IED blast planted by them killed two children on Monday in the thickly-forested Dhangri vil lage, located barely 8 kms from Rajouri district headquarters.

Four-vear-old Vihan was declared dead by doctors at the Hospital, Rajouri. The second child, identified as Samiksha, succumbed to her injuries after she was operated upon.
The IED, according to police, was planted by the ter-

rorists in the same village late Sunday night where they had

killed four civilians on day one of the New Year by pumping bullets from a close range. One of the youngest civilians, identified as Deepak Kumar, was supposed to join the government service as he

had been selected for the same. The terrorists are believed to have selected a Hindu-dominated village to target the civilians in a bid to stoke up

Local villagers claimed the

terrorists reportedly verified the identity of the four civilians before killing them on Sunday. The majority of residents in the village were cooking dinner

at the time of the terror attack on Sunday. Half cooked vegetables, open dishes, and plates lay scattered on the floor of the kitchens when security personnel arrived there to track down the footprints of the ter-

One of the local residents, identified as Bala, managed to save several lives as he retaliated against the fire, forcing the terrorists to flee the area under the cover of darkness.

## Recession to hit third of world this year, warns IMF

third of the global econo-Amy will be in recession this year, the IMF chief has said, and warned that 2023 will be "tougher" than last year as the US, EU and China will see their economies slow down.

Kristalina Georgieva, the chief of the International Monetary Fund (IMF) made these grim assertions on Sunday during a CBS news programme "Face the Nation."

It comes at a time when the ongoing conflict in Ukraine shows no signs of abating after more than 10 months, with spiralling inflation, higher interest rates and the surge in coronavirus infections in China *Continued on Page 2* | fuelled by the Omicron variant.

"We expect one-third of the world economy to be in recession," Georgieva said on

the news programme.

The year 2023 will be tougher than last year because the economies of the US, the EU and China will slow down, she said. "Even in countries that are not in recession, it would feel like a recession for hundreds of millions of people," she explained.

In October, the IMF trimmed its growth forecast for 2023. "Global growth is forecast to slow from 6 per cent in 2021 to 3.2 per cent in 2022 and 2.7 per cent in 2023. This is the weakest growth profile since 2001 except for the global financial crisis and the acute phase of the Covid-19," it said.

### RT-PCR test must for flyers transiting via China, 5 nations

With no let-up in Covid cases in countries like China, South Korea, Singapore, Hong Kong, Thailand and Japan, the Indian Government has now made a negative RT-PCR test mandatory for travellers even transiting through these nations, irrespective of

their originating countries. Earlier, RT-PCR was made mandatory for travellers from these six countries. As per the advisory issued by the Government on December 29, 2022, the RT-PCR test should be conducted 72 hours prior to undertaking the journey from January 1, 2023.

## HC rejects Purohit's plea for Malegaon blast discharge

The Bombay High Court on Monday rejected the plea of accused Lt Colonel Prasad Purohit, seeking his discharge from the 2008 Malegaon blasts case, after observing that he was not discharging his official duty when he was attending meetings of Abhinav Bharat where conspiracy for the blasts were hatched

In a development that came exactly a month after two other accused withdrew their applications seeking discharge from the 2008 Malegaon blasts case, a HC bench of Justices AS Gadkari and PD Naik rejected Lt Col Purohit's discharge plea, challenging the lower court's order rejecting his discharge application on the ground that the Centre had not taken proper sanction to prosecute a serving Army officer.

"We have observed that he was not on duty. And that he was not assigned to attend meetings where conspiracy to cause bomb blast," the HC bench noted, while rejecting Lt Col Purohit's plea seeking discharge from the case.

Lt Col Purohit had sought to make a case on the twin grounds that he had been attending Abhinav Bharat's meetings after informing his superiors about the same, while the fact is he was not on duty then, and that since he was a serving officer, the prosecution agency had not sought proper sanction from the competent authorities.

In 2018, Sadhvi Pragya, Kulkarni and Purohit had moved the HC seeking discharge in the case after it was rejected by the special NIA court in 2017.

Commenting on the procedure adopted by the Centre in the entire exercise, the apex court said all the relevant factors were placed for consideration before the Union Cabinet when it took the decision to demonetise.

"We are of the considered view that the contention that the decision-making process suffers from non-consideration of relevant factors and eschewing of the irrelevant factors, is without substance," the bench said while rejecting the submission of the peti-

It also junked the contention that there was lack of quorum in the meeting of the RBI's Central Board dated November 8, 2016.

## Kejriwal condemns death of woman, demands justice

Delhi Chief Minister Arvind Kejriwal on Monday condemned the killing of a 20-year-old woman who was hit by a car and dragged for nearly 10-12 kilometers in the Capital's Sultanpuri area.

The Chief Minister also spoke to Delhi Lt-Governor VK Saxena about the incident and demanded justice for the woman. "Spoke to Hon'ble LG on Kanjhawala incident. Requested him to take exemplary action against culprits, strictest Sections of IPC (Indian Penal Code) should be slapped against them. No leniency should be showed even if they have high political connections. He assured that he will take strong action," Kejriwal

Earlier, Kejriwal called the incident of a woman's body being dragged for 10-12 kilometres by a car after hit her scooter a "rarest of rare" crime and demanded that the accused be given the strictest punish-

"It is a rarest of rare crime. I don't know where society is heading. I have learnt that the postmortem is underway, " he told reporters at a ceremony to flag off 50 electric buses. Earlier in the day, taking to Twitter, Kejriwal had demanded justice for the 20-year-old

Calling it an "extremely shameful" incident, he said, "I appeal that the accused, despite whatever influence they might hold, be given strictest pun-

"What happened to our sister in Kanjhawala is very shameful. I hope that the culprits will be punished severely," Kejriwal, who is also the national convenor of the Aam Aadmi Party (AAP), said in a

Describing it as an "extremely shameful" incident, he said, "This comes under the category of rarest of rare crimes. Such people should be given capital punishment.

This can happen to anyone's sister, daughter or daughter-in-law. The accused in this case may be associated with highly-placed politicians, but all of us together should make an effort to ensure that they get the harshest punishment." Five men have been arrested in

The new footage shows the Maruti Baleno car making U-turn on a road in Kanjhawala in West Delhi, where the eyewitness, Deepak Dahiya, runs a confectionary shop. Dahiya had said he saw

the car take a U-turn after hitting the scooty. The footage, recorded at 3.34 am, shows the car returning to the spot where the body was found.

The body can be clearly seen under the car. The witness said the car driver dragged the body of the girl, which got entangled in the undercarriage, for 18 to 20 kms, and drove that way for about one-



### Woman was sole breadwinner, supporting mom, 6 siblings

New Delhi: The 20-year-old woman who was dragged under a car for kilometres was the sole bread-earner of her family and supported an ailing mother and six siblings.

After her father died last year, she supported her family and paid for her mother's dialysis by working part-time at an event management company, which also meant that she had to work late nights.

One of her sisters is married. She was the only support to her two other sisters and two brothers who lived with her. Like every day, on Sunday too,

she left her home for work in the evening telling her mother she would be back by 2-3 am. But what happened in the meantime scarred her family forever. The young woman's work involved attending weddings and other events and she had been out for one such event on Sunday.

'She used to work at an event management company and told me she was going to an event and would return late. I was waiting for her," her mother said. The last conversation she had with her daughter was at 9 PM", she recalled

ffirming that demonetisa-Ation was an "effective counter to terror funding", and the use of black money and fake currency in the country even as it also "facilitated" the high growth of digital economy, the BJP on Monday welcomed the Supreme Court verdict on the demonetisation process as "historic".

The ruling party questioned the Congress for selecting the "minority ruling" and not commenting on the "majority judgment" that ruled demonetization as fair and valid decision of the government. The party also wondered whether Congress leader Rahul Gandhi would apologise for launching a caustic campaign against the demonetisation and venomously targeting Prime Minister Narendra

Addressing a press conference here after the apex court verdict, former law minister and senior BJP leader Ravi Shankar Prasad found it curious that the Congress was reading the minority ruling and not the majority judgment and condemned former Minister

Chidambaram for calling it a "slap on the wrist of govern"uncharitable comment is condemnable", he said. Prasad said even the dissenting judge has also said the policy was "well-intentioned". The Supreme Court in a 4:1 majority verdict upheld the government's 2016 decision to demonetise Rs 1,000 and Rs 500 denomination notes, saying the decision-making process was not flawed.

Prasad asserted that the demonetisation done in 2016 proved to be the "biggest blow" to terrorism by curbing terror funding. It boosted income tax and cleansed the economy, he claimed. "It is a historic decision and is in the national interest. The Supreme Court has held a decision taken in the national interest valid. Will Rahul Gandhi now say sorry for his campaign against demonetisation? He spoke against it even abroad," he said at a press conference.

Îndia has become a global leader in digital payment which was boosted after demonetisation, he told reporters, noting that the country notched up over 730 crore digital transactions worth over Rs 12 lakh crore in October this year alone. Prasad said it is a "very important" decision and added the whole exercise was under-

Chidambaram's taken for valid causes, including removing fake currency and curbing terror funding and money laundering. The BJP leader said the court has noted that the government has a right to take a policy decision and rejected the argument that appropriate consultation with the Reserve Bank of India was not done. In sum and substance, the

apex court looked at the entire decision-making exercise and found the process fair and reasonable, he said, hitting out at the opposition party for raising a "big storm" against the demonetisation. Rahul understands an issue only after a Supreme Court verdict, Prasad said, in a swipe at the former Congress president.

The former Union minister said Rahul "abused" Prime Minister Narendra Modi in his campaign during the 2019 Lok Sabha polls against the alleged corruption in the Rafale deal and stopped after the apex court adjudicated on the matter and rejected the demand for a probe. Prasad said the demonetisation resulted in reducing the share of the informal economy from 52 per cent to 20 per cent, he said, alleging that the Congress promoted and protected informal elements of the economy.

On Monday, these and many other similar tales of hardship became alive again, when the Supreme Court upheld the Government's November 8, 2016 decision to demonetise Rs 1000 and Rs 500 denomination notes.

The decision, touted by the government to be a 'surgical attack' on black money, missed its mark by a great margin and became the bane of the daily-wage labourers and poor Indians, a section which relies almost exclusively on cash.

To 38-year-old house help Parvesh, even the mere mention of the word 'notebandi' sends a shiver down her spine. The single mother of a 20year-old son said she was forced to work without a salary for almost two months and went empty stomach for days at a stretch. "It was the demonetisation.

worst time of my life. Worse than even Covid-19, because during the Covid there was at least some help from the government and society at large. But during demonetisation, we are left alone to suffer," said Parvesh.

"I mean how can I expect my employer to help me when he himself was struggling with money?" she said, having little to no idea about Monday's Supreme Court verdict.

The SC in its verdict said the decision-making process behind the 2016 demonetisation was "not flawed." In a five-judge bench, four judges voted in favour of upholding the note-ban decision-making whereas one judge dissented.

The pain was not limited to the poor, and the middle class too struggled to understand the withdrawal rules that cascaded with everyday regularity in the wake of demonetisation.

## India very deeply concerned by Ukraine-Russia conflict: EAM

India has expressed "very deep concern" over the ongoing Ukraine conflict and urged Russia and Ukraine to resolve their differences by diplomacy and dialogue, External Affairs Minister S Jaishankar said on Monday in Vienna.

Underlining this message, he said, "My Prime Minister has been in contact with leaders of both nations, pressing our point of view in that regard. We're also anxious about effects of conflict on accessibility and affordability

global south." The minister enunciated these views after holding bilateral meeting with his Austrian counterpart Alexander Schallenberg.

This was the first foreign minister-level visit from India to Austria in the last 27 years and takes place against the backdrop of 75 years of diplomatic relations in 2023. Schallenberg visited India in March 2022, and the two ministers have met thrice this year on the margins of international gatherings (Munich, Bratislava and New York).

Giving details of his talks, Jaishankar said India and in the backdrop of terrorism.

The Congress, earlier in December, had extended an invitation to SP president Akhilesh Yadav, Bahujan Samaj Party supremo Mayawati and Rashtriya Lok Dal chief Jayant Chaudhary to join the yatra. Akhilesh Yadav had feigned ignorance of the letter, saying he had received no letter from the Congress about joining the Bharat Jodo Yatra.

"Our wishes are with the yatra, but we have not got any invitation. Our party's principles are different. Bharatiya Janata Party and Congress both are the same," he said.

Akhilesh's attack on the

Congress is not new. In March 2021 too, he had said, "... the ways being followed by the party are the same as the BJP."

The Uttar Pradesh leg of the Bharat Jodo Yatra will enter Ghaziabad's Loni area on January 3 and travel to Haryana via Kairana in Shamli. The next day, the yatra will reach Mavi Kalan in Baghpat and pass through Baghpat city and Sisana, Sarurpur and Barot in the same district. On January 5, the yatra will reach Alam in Shamli district and pass through Kandhla, Uncha vil-

lage, and Kairana.

## NIA to visit Dangri village in Rajouri where IED killed child, injured 5 others

PNS NEW DELHI

The National Investigation ▲ Agency (NIA) is likely to visit Upper Dangri village in Rajouri district of Jammu and Kashmir where a suspected Improvised Explosive Device (IED) explosion early on Monday killed a child and injured five others.

A senior NIA official from the Jammu unit of the NIA is likely to visit the spot soon to get first hand information on the incident which could be handy if it subsequently takes over the probe into the case, sources said.

As per the Standard Operating Procedure (SOP), the NIA team visits the blast site to collect all preliminary evidence with the local probe agency if the case is later handed over to the agency for the further probe, officials

The NIA team along with the Jammu and Kashmir police officials will collect primary details relating to the incident, including the likely modus operandi of killings of civilians in two back to back terror attacks in the village. While the first incident occurred on Sunday evening, the second took place on Monday.

On Sunday, suspected terrorists opened fire on three succumbed to injuries and houses in the area in Rajouri district killing four civilians and injuring six. In the Monday attack, a child was killed and five others injured Singh. after the explosion of a suspected IED.

"The (improvised explosive device) blast has taken place near the house of the first firing incident. Five people were injured. One child 9.30 AM and a number of



## **Good verdict**

The Supreme Court's verdict has supported the 2016 demonetisation move in a majority judgment

The Government must have heaved a sigh of relief over the Supreme Court's verdict supporting Prime Minister Narendra Modi's 2016 demonetisation move. The 4-1 majority judgment said it was "not relevant" whether the objective of the ban was met. The apex court seems to have agreed with the Government's position that it (the court) cannot decide on a case when no tangible relief can be granted. Its counsels maintained that demonetisation was a "well-considered" decision, aimed at checking fake money, terror funding, black money, and tax evasion. "There has to be great restraint in matters of economic policy. [The] court cannot supplant the wisdom of the executive with its wisdom," Justice BR Gavai said, reading out the order. That's a judi-



cious remark, underlying the judiciary's reluctance to tread on the jurisdiction of the executive. In general, it's a good verdict, primarily because demonetisation good, bad, or ugly—is something in the past. And the past cannot be rectified. But the Government ought to take the views of the dissenting judge, Justice BV Nagarathna, very seriously. She is critical of the note ban and the way the decision was arrived at. Her objections are very pertinent. Calling the demonetisation decision "an exercise of power contrary to law and unlawful," she said that the entire exercise was carried out in 24 hours. She was also unhappy with the role of the Reserve Bank of India, wondering whether the central bank had even visualised problems associated with

the decision. The RBI used phrases like "as desired by the Central Government." This, Justice Nagarathna said, suggests that there was "no independent application of mind by the RBI.

She has hit the nail on the head, for the RBI looked at deer in the headlights at that time. It was clueless and feckless, having little idea about the monetisation that was urgently needed. The new notes were not getting printed fast enough; then there was a problem with their size, which was not compatible with that of the ATMs. For weeks there were long queues outside ATMs and banks; businesses were disrupted. The majority judgment of the Supreme Court may have come in support of the Government, but it is undeniable that this was not the best decision that it has taken in the last eight and a half years. As for the objectives of demonetisation, there has been a decline in the killings related to terrorism since 2014, according to the South Asia Terrorism Portal, but it is difficult to ascertain any causality between demonetisation and the decline. Similarly, it is difficult to say if the move did check black money or corruption. Its adverse effects on the economy, however, are well-known. The growth rate, for instance, declined for two years after the decision. The lesson that not just the Government but the entire political class must learn from demonetisation is that the best decisions are those that are made after wide consultation.

# Pakistan hits a new low in India bashing



Pakistan would do well to address its domestic problems rather than blame India for everything wrong with it. And it is not helping.

akistan recorded a new low even in its perennial hostility towards India on sixteenth of December when in an unbecoming and shameful manner its Foreign Affairs Minister Bilawal Bhutto Zardari made personal and uncivilised outburst against the Prime Minister of India Narendra Modi. He was alluding to comments of External Affairs Minister of India Jai Shankar. After chairing a special meeting of the UN Security Council focused on 'global counter terrorism approach' Jai Shankar had told media that the world perceives Pakistan as epicentre of terrorism as it still shelters terrorist groups. Pakistan has been doing more than this.

Apart from maltreatment of its minorities, It glorifies Osama bin Laden as a martyr and shelters terrorists like Lakhvi, Hafiz Saeed, Masood Azhar, Sajid Mir and Dawood Ibrahim and 126 UN designated terrorists and 27 UN designated terrorist groups. Ever since it came into existence as a new country in August, 1947, Pakistan has maintained hostile attitude towards its immediate biggest neighbour India. This is despite the fact that the author of two nation theory and founder of new nation of Pakistan Mohammed Ali Jinnah had advised the leaders of Pakistan to maintain good neighbourly relations with India but it has been hardly ever so from the very beginning. Despite being culturally also equally close to India, Pakistan linked its hostility towards India to the fault line of the world based on religion.

Just to mention a few lows in its relations with and actions towards India, the first low occurred in 1947 when the princely ruler of Jammu and Kashmir Maharaja Hari Singh offered standstill agreement with both India and Pakistan to allow him time to decide about accession. While India called for talks, Pakistan accepted it in breach and finally sent in armed tribals on twenty second October, 1947 to force accession on the princely ruier. The Manaraja nad no choice but to accede to India. At the same time, though born itself

out of two nation theory, Pakistan made all out efforts to effect political partition of princely states of India.

Pakistan also joined pacts created to encircle Soviet Communist block. Pakistan did all this in the name of fighting against communism but the actual motive was hostility towards India. In 1959 the then Pakistan President General Ayub Khan declared that arms received from USA are not meant to be wrapped in wool clearly indicating that these can be used against India. Later during 1965 Indo-Pakistan war, Pakistan actually used these weapons against India.

The worst low level of Pakistan's conduct and bankruptcy of its policy was witnessed when after General elections in Pakistan in 1970, East Pakistan got majority but its leader Sheikh Mujibur Rehman was denied the opportunity to form government in Pakistan. To suppress the people of East Pakistan a reign of terror and genocidal crackdown was unleashed against ethnic Bengalis and Hindus there under orders of the then Pakistan military ruler General Yahaya Khan. The result was formation of Bangladesh.



# PMGKAY withdrawn but free food stays



Government should seriously ponder over giving subsidy directly to the beneficiary as the current system is defective

fter much dilly-dallying, the Union Government has cleared the air on the fate of Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). On December 23, 2022, the Cabinet decided to terminate it from January 1, 2023. At the same time, it has decided to provide free ration to about 820 million poor in the country under the National Food Security Act (NFSA) for one year i.e. till December 31, 2023, in a bid "to shield the masses from shocks to the system at a time the economy was recovering in the aftermath of Covid crisis".

Making these announcements, Consumer Affairs, Food and Public Distribution Minister Piyush Goyal said that the Government was merging the free part of PMGKAY with the regular food security schemes under NFSA, which would previously provide subsidized ration to the poor. With these changes, the Centre's annual food subsidy bill is estimated to be Rs 200,000 crore.

In March 2020, Finance Minister Nirmala Sitharaman had announced PMGKAY to mitigate the hardship suffered by people due to a major disruption in economic activity and resultant loss of jobs and income in the wake of Covid-19 pandemic. Under it, the government would give five kg of rice or wheat per person per month for "free" to around 820 million people through the Public Distribution System (PDS) initially for a period of three months till June 30, 2020.

It would also give for "free" one kg of pulses per household. On June 30, 2020, Prime Minister Narendra Modi announced extension of the scheme for five months till November 30, 2020 with a slight change to provide one kg grams (instead of leaving the choice of pulse to the beneficiary) free to each family per month. The scheme was discontinued for five months during December 2020-April 2021. From May 2021, it was resurrected and got three extensions during the financial year (FY) 2021-

During FY 2022-23, it has got two extensions sixth (April – September 2022) and seventh (October-December 2022). Under the extensions given since May 2021, the provision for pulses was removed from the entitlement.

During FY 2020-21, economic activity had remained disrupted particularly dur-ing the first three quarters resulting in 'neg-ative' growth in GDP by 6.6 per cent. So, the first two phases were perfectly justified.

However, its resurrection during FY 2021-22 when the economy rebounded with GDP registering growth of 8.9 per cent, raises many a hackles. During FY 2022-23 also, with the economy entering a phase of consolidation with an expected GDP growth of 6.8-7 per cent, one wonders whether its continuation was tenable.

Political considerations have been at work or else the government would not

have run the scheme during these times when the economy was getting back to normal obviating the need for any extra support. Since March 2020, the government has spent a total of Rs 390,000 crore on running the scheme. A good slice of this expenditure could have been avoided if its actions had been guided purely by economic considera-

Given a spate of state elections during 2023 followed by general elections in 2024, there was much speculation that the government might continue the PMGKAY. Yet, going strictly by economic rationale, it has discontinued the scheme. This will spare the national exchequer an outgo of around Rs 130,000 crore annually and help reining in fiscal deficit. But, by modifying the reg-ular NFSA to provide for supply of 'free' food,

Modi has made way for populism to some extent. Under the NFSA, the Centre directs the Food Corporation of India (FCI) and other state agencies to procure food from the farmer at MSP (minimum support price) and organize its distribution to around 820 mil-lion people through a network of fair price shops (FPS) at the subsidized price (call it 'issue price') of Rs 2/3/1 per kg for wheat, rice, and coarse cereals respectively.

There are two types of beneficiaries. As part of the Antyodaya

Anna Yojana (AAY), the poorest of the poor households get 35 kg of food grains per family (@ 7 kg per person in a family of five) each month. The number of families

under AAY being 24 million, the persons getting 7 kg cereals per month @ Rs 2/3/1 per kg are 120 million. The rest 700 million persons are eligible to receive five kg of cereals per month at the same price. In addition, the PMGKAY gave 5 kg to each of 820 million for

Even as the additional (read: PMGKAY) has been withdrawn, the Cabinet has added a sweetener to the regular NFSA by supplying to all 820 million beneficiaries their eligible monthly quota for 'free' instead of Rs 2/3/1 per kg they pay currently. Considering that already, the extant price was close to zero, this was unwarranted. It is hard to fathom that nearly 2/3rd of the population can't pay even a notional price

of Rs 2/3/1 per kg.

The current issue price was specified in the NFSA legislation. The law enacted in 2013 had frozen these rates for three years. Since 2016 thus, there is no legal bar on or 320 million (440-120) should pay increasing the price. An increase of Rs 1 per kg can yield savings of per kg of wheat. This would yield about Rs 5,200 crore annually; Rs an annual saving of about Rs 16,500 4,500 crore it hike is confined only to non-AAY beneficiaries. Instead, the government has made all sales 'free' which would entail an increase in subsidy by around Rs 13,000 crore annually.

Ridiculously, low price is only one major aspect of the food subsidy conundrum. There are others as well. Fundamentally, subsidized food is meant for the poor and their number is much less the present gargantuan 820 million - expected to increase to 920 million if one were to go by the Supreme Court directive to take into account the population during 2021 instead of the present coverage being based on the 2011 Census estimates.

As per the recommendations of the Shanta Kumar Committee (2015), the people eligible for subsidized food under NFSA should not be more than 40 per cent of the population against the existing 67 per cent. Denying subsidy to 27 per cent or around 380 million will result in saving of about Rs 66,000 crore annually (29x5x380x12). This is based on a person taking all of her 5 kg monthly quota as wheat and subsidy @ Rs 29 per kg [(MSP: 21 + HDC: 10) – issue price: 2] where HDC stands for handling and distribution cost.

Of the remaining 440 million (820-380), the committee felt that only persons under AAY i.e. 120 million should be eligible to pay Rs 2/3/1 per kg. It wanted that others 50 per cent of the MSP or Rs 10.5 crore (8.5x5x320x12); 8.5 being the excess of Rs 10.5 over the current price Rs 2.

There is no reason why these beneficiaries (read: non-AAY) should not pay more say MSP. Asking them to pay MSP or Rs 21 per kg can yield savings of around Rs 36,500 crore.

Finally, the Government should seriously ponder over giving subsidy directly to the beneficiary as the current system is prone to high inefficiencies, leakages and misuse.

## Need to address root-causes of domestic violence

### While the impact of domestic violence on the victim is worrisome, it can also have a traumatic effect on witnesses, especially kids

evti Devi (name changed) has a difficult life. At the age of 15, she got married, and her ordeal of domestic violence began at that time. Her husband even tried to burn her alive, but she survived. Discussing her trauma, she said, "One day, he tried

to smother me using a pillow." Devti is a resident of Ason village in Bageshwar district's Kapkot block in Uttarakhand. Lately, cases of domestic violence in Uttarakhand have been on a rise. According to a report published last year, everyday 60 women are reported to face domestic violence across the state. Besides, during Covid-19, in the 20 days of February 2021, out of total 2,041 complaints of harassment of women in the control room, 1,210 com-



plaints were of domestic vio-

As per another report, in 2019, 727 domestic violence cases were reported to Legal Services Authorities and Uttarakhand accounted for 144 out of the 727, the highest in the country. Tired of domestic violence, Khasti Devi, (name changed) another woman from the same village tried to end her life. "I have not spent a single day without the fear of getting thrashed by my husband," lamented Khasti.

In India, approximately 45,026 women died by suicide in 2021, nearly one in every nine minutes. Out of this, more than two-third were married women and over half of them, 23178, were housewives, stated the annual report

of the National Crime Records Bureau.

Women and girls residing in some of the most inaccessible hilly villages in Uttarakhand have difficulty accessing the legal and medical aid options made available by both the government and nongovernment organizations.

For the safety and security of women facing domestic and other forms of gender-based violence, in 2015, a Centrally Sponsored Scheme was formulated by the Ministry of Women and Child Development (MWCD), for establishing One Stop Centre (OSC) as a sub-scheme of National Mission for Empowerment of Women.

In 2022-23, the scheme was subsumed into the Sambal sub-scheme of Mission Shakti.

OSCs have been approved for 730 districts across the country, out of which 704 OSCs have been operationalized in 35 States/ ÛTs, which have assisted over 4.50 lakh women.

In this case, the OSC is located in Bageshwar district. Anju Pandey, an advocate who works at the 'One Stop Centre' in Bageshwar, while informing the process of receiving cases of domestic violence from the women in villages, said, 'Usually the survivors report to the Pradhan of the villages who support them to report the cases to the nearest police station. From the police station, the cases are then referred to our centre."

The 'definition' of nearest police station needs some attention here as the distance it are often taunted by the affects my mental status and

As on February 11, 2022, 733 from the village might be 20 OSCs have been approved for km or beyond without availability of transport and at times, a motorable road. The socio-economic status of these women also doesn't allow them to report the cases. Unless the Pradhan of their villages take some serious action, they continue to face the vio-

Social activist Neelam Grandy from Charson village in Garur block in Bageshwar, while shedding light on the situation said that although women have been facing some serious violence at the hands of their own partners, they back out from reporting it. "Women lack the support to file cases against the husbands. They fear the social stigma, for the ones who report

neighbours or family members, saying they have harmed the peace of the family," said Neelam, adding, "The irony is that even the media is not bothered much. This is the reason that instead of making headlines, such cases get buried in a corner of the newspaper."

While the impact of domestic violence on the primary victim is worrisome, it can also have a long-lasting traumatic effect on those who witness it, especially children. At times, they even face abuse. Akshita (name changed), a teenager from the same village, shared that every day, not only does her father fight with her mother, but also abuses

and beats her. "Their quarrel directly

studies. Whenever I prepare myself to study, the flashes of my father thrashing my mother dominates my thoughts. It becomes difficult to focus and concentrate on studies or to have a positive outlook towards life," said Akshita. Although the local admin-

istrations have undoubtedly come up with redress mechanisms at their levels to address the increasing violence against women, accessibility should be equally focused on. For many women who do not understand the redress procedures or lack the support to take any action, should be reached out without any failure. For a long-term solution, there is a dire need to address the rootcauses of such violence against

## Russia presses home Ukraine strategy, fires 40 drones at Kyiv

Russia deployed multiple exploding drones in another nighttime attack on Ukraine, officials said Monday, as the Kremlin signalled no letup in its strategy of using bombardments to target civilian infrastructure and wear down Ukrainian resistance to its

The barrage was the latest in a series of relentless year-end attacks, including one that killed three civilians on New Year's

Kyiv Mayor Vitali Klitschko said Monday that 40 drones "headed for Kyiv" overnight. All of them were destroyed, according to air defence forces.

Klitschko said 22 drones were destroyed over Kyiv, three in the outlying Kyiv region and 15 over neighbouring provinces. Energy infrastructure facil-

ities were damaged as the result of the attack and an explosion occurred in one city district, the mayor said.

It wasn't immediately clear whether that was caused by drones or other munitions. Á wounded 19-year-old man was hospitalised, Klitschko added, and emergency power outages were underway in the capital.

In the outlying Kyiv region a "critical infrastructure object" and residential buildings were hit, Gov. Oleksiy Kuleba said.



Russia has carried out airstrikes on Ukrainian power and water supplies almost weekly since October.

Ukrainian President Volodymyr Zelenskyy has accused Russia of "energy terrorism" as the aerial bombardments have left many people without heat amid freezing temperatures.

Ukrainian officials say Moscow is "weaponising winter' in its effort to demoralise the Ukrainian resistance.

Ukraine is using sophisticated Western-supplied weapons to help shoot down Russia's missiles and drones, as well as send artillery fire into Russian-held areas of the country

Moscow's full-scale invasion on Feb. 24 has gone awry, putting pressure on Russian President Vladimir Putin as his ground forces struggle to hold ground and advance. He said in his New Year's address to the nation that 2022 was "a year of difficult, necessary decisions."

Putin insists he had no choice, but to send troops into Ukraine because it threatened Russia's security — an assertion condemned by the West, which savs Moscow bears full responsibility for the invasion.

Russia is currently observing public holidays through Jan.

The strikes came 36 hours after widespread missile attacks Russia launched Thursday to damage energy infrastructure facilities, and the unusually quick follow-up alarmed Ûkrainian officials.

In Russia, a Ukrainian drone hit an energy facility in the Bryansk region that borders with Ukraine, Bryansk regional governor Alexander Bogomaz reported on Monday morning.

# Canada, Australia impose Covid rules on travellers from China

Australia and Canada have joined a growing list of countries requiring travellers from China to take a COVID-19 test prior to boarding their flight, as China battles a nationwide outbreak of the coronavirus after abruptly easing restrictions that were in place for

much of the pandemic. Australian health authorities said Sunday that from January 5 all air travellers from mainland China, Hong Kong or Macao will need to show a negative COVID-19 test taken within two days of their departure.

Canadian authorities announced similar measures that will also come into effect January 5 in a statement dated Saturday — a move experts say isn't very effective.

Kerry Bowman, assistant professor at the University of Toronto's Temerty Faculty of Medicine, said the requirement is "not based on science at this

"This isn't the early days of the pandemic," he said. "It's pretty clear that point-of-entry screening is not very effective at all. Often people can test positive days and weeks later." Dr. Isaac Bogoch, associate

professor at University of Toronto's Temerty Faculty of Medicine, said it's not entirely clear what the policy's goals are, but such measures have not

"We know from the past that very focused and targeted

travel measures such as this don't do much to prevent the spread of COVID, either by importing COVID to Canada, or by the threat of variants of concern in Canada," he said. Australia and Canada join

other countries including the US, UK, India, Japan and several European nations in imposing tougher COVID-19 measures on Chinese travellers amid concerns over a lack of data on infections in China and fears of the possibility that new variants may spread.

Research has shown how the virus spreads through human mobility, which means that the next variant of the virus may not even emerge from China, and even if it did, it could land in Canada from other indirect routes, Bowman said, adding that a more effective measure would be testing wastewater from airplanes and airports to check for the viral load and mutations.

## New Israeli Govt vows to develop West Bank as tourism hub

The tourism minister of Israel's new hardline government on Sunday promised to invest in developing the West Bank, calling the occupied area "our local Tuscany."

Haim Katz made the comments days after Prime Minister Benjamin Netanyahu's new government took office, promising in its coalition guidelines to make West Bank settlement construction a top priority. His coalition includes far-right settler leaders in top posts.

Israel captured the West Bank in the 1967 Mideast war and has built dozens of settlements that are now home to roughly 500,000 Israelis.

The Palestinians claim the entire area as part of a future independent state and consider the settlements illegal — a position that is widely shared by the international community. Israel's commitment to deepening its control of the West Bank has threatened to put it on a collision course with some of its closest

At a ceremony Sunday, Katz said he would channel resources to promote tourism in the West

Bank. "We will invest in areas that may not have received sufficient support to date," he said. "For example, our local Tuscany in Judea and Samaria," he added, using the biblical term for the West Bank favored by religious and right-wing Israelis.

The West Bank settler com-

munity has developed a small tourism sector that includes hotels, bed and breakfasts and wineries. Israel considers these industries to be part of the country's broader tourism sector, while international human rights groups have said they deepen control of occupied ter-

Áirbnb in 2018 said it would bar listings in the Israeli settlements, but it quickly backed down under heavy Israeli pressure. Last year, Booking.Com said it was adding warnings to its listings there.

On Friday, the U.N. General Assembly asked the U.N.'s highest judicial body to give its opinion on the legality of Israeli policies in the occupied West Bank. Netanyahu called the resolution "disgraceful" and said Israel is not obligated to cooperate with the International

Israeli strikes hit the airport as well as an arms depot close to the facility south of Damascus. The Britain-based Syrian Observatory for Human Rights said four people were killed in the strike. There was no comment from Israel. On June 10, Israeli airstrikes that struck

Damascus International Airport caused significant damage to infrastructure and runways. It reopened two weeks later after repairs.

In September, Israeli airstrikes hit the inter-



Syria's largest and once commercial center, also putting it out of service for days.

In late 2021, Israeli warplanes fired missiles that struck the port of Latakia hitting containers and igniting a huge fire. Israel has carried out hundreds of strikes on targets inside government-controlled parts of Syria in recent years, but rarely

acknowledges or discusses such operations.

Israel has acknowledged, however, that it targets bases of Iran-allied militant groups, such as Lebanon's Hezbollah, which has sent thousands of fighters to support Syrian President Bashar Assad's forces. Thousands of Iran-backed fighters have joined Syria's 11-year civil war and helped tip the balance of power in Assad's favor. ## New York's first elected woman Guv Kathy Hochul sworn-in

 $N^{\mathrm{ew}}$  York Governor Kathy Hochul was sworn in for her first elected term on Sunday, making history as the first woman elected to the position in the state. The Democrat, launching

her term as the 57th governor of New York, said her goals were to increase public safety and to make the state more affordable. "Right now there are some

fights we have to take on," Hochul said after taking the oath of office at the Empire State Plaza Convention Center in Albany. "First we must and will make our streets safer.'

Hochul also called for making the state more affordable, citing the high cost of living. Also sworn in Sunday was Lt. Gov. Antonio Delgado. A native of Buffalo, Hochul,

64, defeated Republican con-

gressman Lee Zeldin, an ally of

Donald Trump, in November's election to win the office that she took over in 2021 when former Gov. Andrew Cuomo resigned.

A former congresswoman, she served as Cuomo's lieutenant governor before taking over in August 2021 and has tried to cast herself as a fresh start from Cuomo. He resigned amid sexual harassment allegations, which he denies.

New York Democratic U.S. Sen. Chuck Schumer described her November victory as "breaking the glass ceiling.

During her time as gover-nor, New York passed some of the strictest gun laws in the nation, some of which are experiencing court challenges.

Delgado, a former Democratic U.S. Representative who identifies as Afro-Latino, took over the position as lieutenant governor in May after Brian Benjamin resigned, and said he couldn't "wait to get down to business" of "transparent" and "accountable" government.

New York Attorney General Letitia A. James, 64, also took oath Sunday for her second elected term in the position. She made history in 2018 as the first woman elected as the state's attorney general and the first Black person to serve in the role.

"Four years ago I made a commitment to make this office a force of justice. I promise to fight for all New Yorkers, regardless of your political affiliation," James, of Brooklyn, said.

## Brazil's Lula sworn in, vows accountability and rebuilding

m razil's}$  Luiz Inacio Lula da Silva was sworn in as president on Sunday, and in his first address expressed optimism about plans to rebuild while pledging that members of outgoing Jair Bolsonaro's administration will be held to account.

Lula is assuming office for the third time after thwarting far-right incumbent Bolsonaro's reelection bid. His return to power marks the culmination of a political comeback that is thrilling supporters and enraging opponents in a fiercely polarized nation. "Our message to Brazil is

one of hope and reconstruction," Lula said in a speech in Congress' Lower House after signing the document that formally instates him as president. "The great edifice of rights, sovereignty and development systematically demolished in recent years. To re-erect this edifice, we are going to direct all our

Sunday afternoon in Brasilia's main esplanade, the party was on. Tens of thousands of supporters decked out in the red of Lula's Workers' Party cheered after his swearing in. They celebrated when the

president said he would send a report about the prior administration to all lawmakers and judicial authorities, revoke Bolsonaro's "criminal decrees" that loosened gun control, and hold the prior administration responsible for its denialism in the face of the COVID-19 pandemic.

"We do not carry any spirit of revenge against those who sought to subjugate the nation to their personal and ideological designs, but we are going to ensure the rule of law," Lula said, without mentioning Bolsonaro by name. "Those who erred will answer for their errors, with broad rights to their defense within the due legal process.

Lula's presidency is unlikely to be like his previous two mandates, coming after the tightest presidential race in more than three decades in Brazil and resistance to his taking office by some of his opponents, political



## attack on Mexican border prison

The Chihuahua state prosecutor's office said in a statement that around 7 a.M. Various armored vehicles arrived at the prison and gunmen opened fire on guards. In addition to those killed, 13 people were wounded and at least 24 inmates escaped.

Mexican soldiers and state police regained control of the prison later Sunday. The state prosecutor's office said its personnel were investigating.

In August, a riot inside the same state prison spread to the streets of Juarez in violence that left 11 people dead.

In that case, two inmates were killed inside the prison and then alleged gang members started shooting up the town, including killing four employees of a radio station who were doing a promotion at a restau-

Violence is frequent in

Mexican prisons, including in some where authorities only maintain nominal control Clashes regularly erupt among inmate of rival gangs, which in places like Juarez serve as proxies for drug cartels.

Shortly before Sunday's attack on the prison, municipal police were attacked and managed to capture four men after a pursuit, according to the state rosecutor's office statement.

### South Asian black carbon aerosols increase glacial mass loss over Tibetan plateau: Study sised black carbon aerosols

 $B^{\text{lack carbon aerosols have}}_{\text{indirectly affected the mass}}$ gain of the Tibetan Plateau glaciers by changing longrange water vapour transport from the South Asian monsoon region, a study has found.

The South Asia region adjacent to the Tibetan Plateau has among the highest levels of black carbon emission in the world, the researchers said.

Black carbon aerosols are produced by the incomplete combustion of fossil fuels and biomass, and are characterised by strong light absorption. Many studies have emphafrom South Asia can be transported across the Himalayas to the inland region of the Tibetan Plateau. Researchers noted that

black carbon deposition in snow reduces the albedo of surfaces — a measure of how much of Sun's radiations are reflected — which may accelerate the melting of glaciers and snow cover, thus changing the hydrological process and

water resources in the region. The study, published in Nature Communications, found that since the 21st century, South Asian black carbon aerosols have indirectly affect-

ed the mass gain of the Tibetan Plateau glaciers by changing long-range water vapour transport from the South Asian monsoon region. "Black carbon aerosols in

South Asia heat up the middle and upper atmosphere, thus increasing the North--South temperature gradient," said Professor KANG Shichang from Chinese Academy of Sciences (CAS) "Accordingly, the convec-

tive activity in South Asia is enhanced, which causes convergence of water vapour in South Asia. Meanwhile, black carbon also increases the number of cloud condensation



nuclei in the atmosphere," Shichang said.

These changes in meteorological conditions caused by black carbon aerosols make more water vapour form precipitation in South Asia, and the northward transport to the Tibetan Plateau was weakened, the researchers said.

As a result, precipitation in the central and the southern Tibetan Plateau decreases during the monsoon, especially in the southern Tibetan Plateau, they said.

The decrease in precipitation further leads to a decrease of mass gain of glaciers. From 2007 to 2016, the

reduced mass gain by precipitation decrease accounted for 11 per cent of the average glacier mass loss on the Tibetan Plateau and 22.1 per cent in the Himalayas. "The transboundary transport and deposition of

black carbon aerosols from South Asia accelerate glacier ablation over the Tibetan Plateau. "Meanwhile, the reduc-

tion of summer precipitation over the Tibetan Plateau will reduce the mass gain of plateau glaciers, which will increase the amount of glacier mass deficit," Shichang

## Nepal's PM 'Prachanda' to face vote of confidence on January 10

epal's newly-appointed Prime Minister Pushpa Dahal Kamal 'Prachanda' has decided to take the vote of confidence in the Parliament on January 10, an official said on Monday.

The 68-year-old CPN-Maoist Centre leader was sworn in as the Prime Minister for the third time on December 26 after he dramatically walked out of the prepoll alliance led by the Nepali Congress and joined hands with opposition leader K P Sharma Oli.

Prachanda on Monday requested the parliament secretariat to arrange to table the agenda of the vote of confidence in parliament on January 10.

"The Prime Minister has sent a letter to include the subject of vote of confidence on the agenda of the Parliament on the 10th of January," said Rojnath Pandey, spokesperson of the the Parliament Secretariat.

There is a constitutional provision that a person who has become the Prime Minister should take a vote of



confidence within one month of swearing into office.

President Bidhva Devi Bhandari called the first session of the new Parliament on January 9 after the country went to polls on November 20.

This will be the first Parliament session after the appointment of "Prachanda" as the new prime minister of the landlocked nation.

Prachanda was appointed as the country's new prime

minister after he submitted a letter to President Bhandari showing the support of 169 members in the 275-member House of Representatives.

He needs 138 votes for a clear majority in the House.

Photos on social media showed residents in Misamis Occidental province in Northern Mindanao sweeping away thick mud from the floors of their homes. In the seaside village of Cabolanonan, coconut trees were uprooted and huts made of light material were nearly flattened.

Over 4,500 houses were damaged by the floods, along with roads and bridges, and some areas still have disrupted power and water supply, the disaster management agency said. The government sent food and other essentials to flood-hit residents, deployed heavy equipment for clearing operations, and provided iron sheets and shelter repair kits, officials said.

Teams from the capital Manila were sent to assist communities with limited clean water in setting up water filtration systems.

At least 22 cities and municipalities have declared a state of calamity, the disaster management council said. The move will allow the release of emergency funds and hasten rehabil-

Novel water filter removes 99.9% microplastics supply," Chi-Young said in a

Scientists have developed a new water purification system that can filter out small plastic particles, as well as other pollutants, very quickly and with high efficiency.

The porous material, described in the journal Advanced Materials, may be used as a high-efficiency adsorption material in the future as it has cost competitiveness based on raw materials and enables solar-based water purification process.

"The technology is an unrivaled with the world's highest purification efficiency, removing more than 99.9 per cent of phenolic microplastics and volatile organic compound (VOC) contaminants in water at ultra-high speeds," said Professor Park Chi-Young from



Daegu Gyeongbuk Institute of Science and Technology (DGIST) in Korea.

"We expect that it will be a universal technology with high economic efficiency that can purify contaminated water and supply drinking water even in areas where there is no power

Water pollution caused by the rapid development of the chemical industry is a big problem in environmental pollution. Various water purification

technologies and materials have been developed to solve this problem.

The researchers noted that carbon-based porous materials using existing adsorption mechanisms have limitations in that the adsorption rate is slow and high thermal energy is required for recycling.

Various materials have been developed to improve contaminant removal efficiency, but it has been difficult to develop materials that simultaneously satisfy excellent recyclability, high efficiency, economic efficiency of raw materials, and industrialisation potential.

## 6 yrs after Demo: Cash is king, circulation up 83% over 2016

PTI NEW DELHI

Six years after the shock move to ban 86 per cent of the currency in circulation, cash is still the king with official data showing close to doubling of cash with the public.

The value of the currency in circulation (or public holding of cash) stood at Rs 32.42 lakh crore as on December 23, 2022, according to Reserve Bank data.

This compares to Rs 17.74 lakh crore worth of notes in circulation (NiC) on November 4, 2016, days before Prime Minister Narendra Modi announced outlawing of old 1,000 and 500 rupee notes to target black money and fight

NiC fell to about Rs 9 lakh crore after demonetisation.

Compared with January 6, 2017, the cash in circulation has seen a more than 3-fold or 260 per cent jump, while from November 4, 2016, it has seen about 83 per cent rise.

After the shock announcement, the government gave a limited-time window for the public to return the banned



currency. According to the Reserve Bank of India (RBI), almost the entire amount of currency withdrawn was

The total value of notes returned by the public was Rs 15.3 lakh crore or 99.3 per cent of the total of Rs 15.4 lakh crore of notes in circulation on November 8, 2016. This raised questions over the purpose of a shock move that triggered a sharp slowdown in the economy and put the public to hard-

The outlawed currency notes were replaced by new 500 and 2,000 rupee notes. However, the 1,000 rupee note was not reintroduced.

"As per the principles laid under the rule, wagering on the outcome of game will not be allowed. All online gaming companies will have to register with the self-regulatory body that will decide on the action required to be taken as per the rules," Chandrasekhar said.

The Ministry of Electronics and IT has published draft rules for online gaming companies and has invited comments on the same by The government has proposed a self-regu-

latory mechanism, mandatory verification of players and physical Indian address for online gaming companies, according to the draft online gaming rules.

Online gaming companies will be covered under the new IT rules that were issued in 2021 for social media platforms.

Online gaming platforms are expected to comply with the laws of the land, including any such law that relates to gambling or betting.

"If you bet on an outcome of the game, it is prohibited. The self-regulatory organisations will

## Oil price spike brings back subsidies but India wins at crude diplomacy

wild swing in internation-Aal oil prices in 2022 brought back indirect fuel subsidies in India in a setback to reforms, but the nation won at crude diplomacy as it refused to succumb to western pressures and continued to buy oil from the cheapest available source.

International oil prices have been turbulent in the last couple of years. It dipped into the negative zone at the start of the pandemic in 2020 and swung wildly in 2022 -- climbing to a 14-year high of nearly USD 140 per barrel in March 2022 after Russia invaded Ukraine, before sliding on weaker demand from top importer China and worries of an economic contraction.

But for a nation that is 85 per cent dependent on imports, the spike meant adding to already firming inflation and derailing the economic recovery from the pandemic.

So, state-owned fuel retail-



ers Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Petroleum Hindustan Corporation Ltd (HPCL) froze petrol and diesel prices for the longest duration in at least two decades. They stopped daily price revision in early November 2021 when rates across the country hit an alltime high, prompting the government to roll back a part of the excise duty hike it had effected during the pandemic to take advantage of low oil prices.

The freeze continued into 2022 but the war-led spike in

international oil prices prompted a Rs 10 a litre hike in petrol and diesel prices from mid-March before another round of excise duty cut rolled back all of the Rs 13 a litre and Rs 16 per litre increase in taxes on petrol and diesel effected during the pandemic.

That followed the current price freeze that began on April 6 and still continues. The result was while consumers were insulated, the three firms suffered a combined loss of Rs 21,000 crore in the first half of the 2022-23 fiscal year, and reforms took a backseat.

"SBI, ICICI Bank and HDFC Bank continue to be identified as Domestic Systemically Important Banks (D-SIBs), under the same bucketing structure as in the 2021 list of D-SIBs," the Reserve Bank said in a statement.



Equity Tier 1 (CET1) requirement for D-SIBs was phasedin from April 1, 2016 and became fully effective from April 1, 2019.

The additional CET1 requirement will be in addition to the capital conservation

The Reserve Bank of India (RBI) had announced SBI and ICICI Bank as D-SIBs in 2015 and 2016. Based on data collected from banks as on March 31, 2017, HDFC Bank was also classified as a D-SIB.

### IAMAI terms draft data protection bill as industryfriendly; seeks clarity on implementation timelines



"Long live the king"; the third said simply, "Pele 82 years." Entry to the stadium will be allowed until 10:00 am

Tuesday, officials said. After that, a procession will be held through the streets of Santos, a port city about 75 kilometers (47 miles) from the state capital Sao Paulo.

The parade will pass the house of Pele's mother, 100year-old Celeste Arantes, who is unaware that her worldfamous son has died.

"She doesn't know," Pele's sister Maria Lucia do Nascimento told *ESPN* on

iday. "She is not conscious.' The procession will end at cemetery in Santos, where Pele will be interred in a special mausoleum.

His death sparked a global outpouring of tributes, with his native Brazil holding three days of national mourning.

He scored 1,283 goals in a career of 21 years, most of them played at Santos. Wreaths of flowers left by

his fans have brought a splash of color to Vila Belmiro, which houses a bust and a statue of the football great. Silvio Neves Souza, an elec-

trician on holiday from Sao Paulo, took a moment Sunday to visit the stadium since he will not be able to attend the official ceremony. "I'm sure a lot of people will

come to the wake, not just old people who saw him play, but also young people," the 54year-old said.

At the headquarters of the Brazilian Football Confederation in Rio de Janeiro, a giant poster with Pele's image bears the word

And at the inauguration on Sunday of Brazil's President Luiz Inacio Lula da Silva, the ceremony began with a minute's silence in Pele's memory.

Paulo state, where digital street screens also pay tribute to the prolific striker, said there would be a "robust" deployment for the posthumous tributes.

Security will be strengthened at Congonhas airport in Sao Paulo ahead of the expected arrival of throngs of athletes, politicians, dignitaries and fans for the wake.

Pele had been hospitalized at the Albert Einstein Hospital for a month until his death on December 29.

"We were with him" on December 21, his sister recounted. "It was very quiet, we talked a little, but I already sensed that he was feeling it, he already knew he was leaving.'

Born on October 23, 1940, Pele grew up selling peanuts on the street to help his impoverished family. He got his famous nick-

## INDIA PREPARE FOR LIFE WITHOUT 'BIG THREE'

ardik Pandya will be expected to begin his full-time T20 captaincy tenure on a bold note as the Indian T20 team prepares to start its life beyond Virat Kohli, Rohit Sharma and KL Rahul with the three match series against Sri Lanka, beginning here on Tuesday. The followers of Indian cricket got more than glimpse of Hardik's vision for the team when led the team to victory in the rain-hit T20 series in New Zealand

In an ODI World Cup year, the shortest format is not priority for the Indian team but the series will allow Hardik to start planning for the future, specifically the 2024 T20 World Cup.

India's famed top three -Rohit, Kohli and Raĥul — are not part of the squad and irrespective of their T20 future, the team must prepare for life with-out them. The problem with the current Indian T20 team in recent past, has been distinct lack of intent and ability to play fearless cricket.

The idea of self preservation at the cost of impactful performance was hurting the team for a long time and perhaps the poor show in the T20 World Cup became the last straw.

### THE COMBINATION

Rishabh Pant, who suffered a horrific car crash last week, opened for the team in New Zealand alongside Ishan Kishan. Pant was anyway not picked for the Sri Lanka series, making Kishan and Ruturaj Gaikwad opening combination most likely for the first T20 at the high-scoring Wankhede Stadium.

Both Kishan and Gaikwad have been bonafide IPL stars for

a past few years and this is their real chance to show their wares without worrying about their place in the side. With next T20 World Cup

at least 18 months away, the duo is expected to get a fair run although the number of T20 Internationals this year is less than 15 with ODI gaining more precedence.

Shubman Gill, who is yet to make his T20 debut, is another opening option for Hardik.

At number three, the skipper will rely on the brilliance of world's No. 1 batter Suryakumar Yadav. With Hardik keen to have six bowling options in the play-



ing eleven, Deepak Hooda could be a likely starter for Tuesday's game. The management will have to choose between Sanju Samson and uncapped Rahul Tripathi for the one spot in the middle order. Tripathi has been warming the bench for a while now and it could continue against Sri Lanka but Samson on account of experience should get a first go.

Though uncapped Shivam Mavi and Mukesh Kumar have been included in the squad, the likely pace bowling trio will be of Arshdeep Singh, Harshal Patel and Umran Malik.

India could also pack in more all-rounders in the team with the option of Washington Sundar and Axar Patel. Specialist spinner Yuzvendra Chahal is expected to play in the series

Reigning Asia Cup champions Sri Lanka will be no pushovers for India even in their own conditions. Sri Lanka have rewarded the star performers of the Lanka Premier League — Avishka Fernando, Chamika Karunaratne and Sadeera Samarawickrama — by including them in the team for the India series.

Milne pulls out of

India, Pak tours

New Zealand pacer Adam Milne on Monday withdrew himself from the white-ball tours of Pakistan and India due to lack of preparation.

Milne finished the recent home series against India with a tight hamstring and subsequently had his return delayed for the Wellington Firebirds, missing two Ford Trophy matches in December.

Despite playing the first two games of the Dream11 Super Smash season for the Firebirds, the prospect of six ODIs in 16 days across Pakistan and India was considered too big of a risk. A decision was therefore made, by mutual agreement, to replace Milne with Central Stags pace bowler Blair Tickner, who is already in

Pakistan with the Test team. New Zealand selector Gavin Larsen said the decision wasn't

"Adam was very up front with us about his concerns around the lack of one-day bowling loading for the upcoming tours," Larsen said in a New Zealand Cricket statement.

"After chatting to him, we agreed his preparation leading into the tour wouldn't be sufficient for him to cope with the demands of back-to-back, threegame ODI series.

"We appreciate his honesty and his genuine desire not to let the team down."

Milne will continue to play for the Wellington Firebirds when available for the remain-

der of the home summer. Larsen said Tickner, who has six ODIs to his name, was a

ready-made replacement. The ODI players depart New Zealand for Pakistan on January 4. The India series comprising three ODIs and as many T20s begins January 18.
