SC gives new lease of life to 5K families in Haldwani

Apex court stays HC order for eviction from Railways' land; hearing on Feb 7

The Supreme Court on Thursday acted as a "savior" to about 5,000 families who faced eviction in the biting cold from alleged Indian Railways' land at Haldwani and had nowhere to go.

The court cited funda-

mental human consideration for its reason to stay the Uttarakhand High Court order for the removal of encroachments from 29 acres claimed by the Railways in Haldwani. Justices SK Kaul and AS

Oka said 50,000 people cannot be uprooted overnight and noted that some people have titles over 60 years and also suggested workable solutions, practical ways and rehabilitations. The bench also observed it may not be correct to say to bring in paramilitary forces to dispossess these people.

The apex court issued notices to the Railways and the Uttarakhand Government seeking their responses to a batch of pleas challenging the High Court order for removal of encroachments.

According to the Eailways, there are 4,365 encroachers on the land, while the occupants are holding protests at Haldwani asserting they are its

rightful owners. Nearly 50,000 people, a majority of them Muslims, belonging to over 4,000 families reside on the disputed land. "Issue notice. In the meantime, there shall be stay of directions passed in the impugned order," said the bench, which posted the matter for further hearing on or development on the disput-

"We do believe that a workable arrangement is necessary to segregate people who may have no rights on the land... Coupled with schemes of rehabilitation which may already exist while recognising the need of the railways," the bench said. "We have not stayed the proceedings and only the directions of the High Court have been stayed," the court clarified.

The court also said there shall be no further construction

Justice Kaul said since people sought to be removed have stayed there for so many years, some rehabilitation has to be found for them. "Even let us assume for the sake of arguments, it is completely Railways land, some scheme will have to be done," said the judge. The bench was hearing a series of petitions filed by the people from Haldwani, represented by noted lawyers Salman Khurshid, Prashant Bhushan

Additional Solicitor General (ASG) Aishwarya Bhati, appearing for the Railways, said the land belongs to the Railways and 4,365 unauthorised occupants have been identified.

On this, the bench said these people have claimed they have the leases and also the properties of those, who migrated in 1947, were auctioned and, in that process, they have got the properties.
"What is troubling us is

this. One, how do you deal with a scenario where people may have purchased in the auction... If the people have acquired the title, how will you do it?" the court asked the railways.

'We are trying to tell you, find out some solution. This is a human issue," the bench said, adding, "Somebody has to examine whether somebody is entitled for rehabilitation. "But there are multiple angles arising from the nature of the land, ownership of the land, the nature of rights conferred...," it acknowledged.

Bhati said it should be considered how critical the land is for development of the area and the railway station there is really the gateway to entire Uttarakhand. She said the railways cannot expand at the Kathgodam station which is just five km away from Haldwani.

Ram temple to be ready by Jan 1, 2024, says Shah

Cong delayed construction, **but Modi Govt** sped it up: HM

Union Home Minister Amit Shah on Thursday declared that the Ram Mandir in Ayodhya will be ready by January 1 next year.

Addressing a public rally here in poll-bound Tripura, Shah held the Congress responsible for delaying the construction of the Ram temple through a series of unending litigations and hailed the Modi Government for clearing the deck for its construction.

"Congress dragged the issue for years...from one court to another...from session court to high court, then to Supreme Court...then back to the session court," Shah said, adding, "But Prime Minister Narendra Modi fulfilled the aspiration of the people by laying foundation for the temple after apex court settled the dispute."

Taunting Rahul Gandhi for his oft-repeated jibe that the BJP raised the slogans that "mandir wahi banayege but date nahi batayege," Shah said, 'Rahul Baba, listen from Sabroom, that a mammoth Ram Mandir will be ready on January 1, 2024."

Prime Minister Narendra Modi performed the "Bhoomi puja" for the construction of the temple on August 5, 2020. At

Sabroom in South Tripura district, Shah flagged off a BJP rath yatra, the second one during the day after Dharmanagar in North Tripura district, aimed at highlighting the State Government's achievements ahead of the Assembly elections due early this year.

The BJP is facing a serious challenge in Tripura in the run-up to the polls as a score of MLAs have quit the saffron outfit. The BJP is also wary of the rise of the Tipraha Indigenous Progressive Regional Alliance (TIPRA Motha) which may impact the outcome in 20 tribal-domi-

nated seats in Tripura.

Reacting to Shah's

announcement, Congress Adhir Ranjan Chowdhury termed it as the roll-out of the "election slogan for 2024."

The Trinamool Congress which too is trying to get a foothold in Tripura as well as other North-Eastern States, said the BJP should not try to claim political mileage out of the temple's construction.

Asserting that the country was safe in the hands of Modi the Union Home Minister said, Ten days after the Pulwama incident in Kashmir, Indian soldiers went inside Pakistan and carried out a successful operation under Modi's lead-ership."

Centre stays J'khand Govt's order to convert Jain temple into tourist hub



Giving in to the protest by the Jain community over designating their main shrine Sammed Shikharji Tirth in Jharkhand as an eco tourism destination, the Central Government on Thursday ordered for stopping all similar efforts in the greater Parasnath Hills where the temple is located.

Meanwhile, the Congress party has called for withdrawal of the notification declaring the site as "eco-tourism zone" which was issued in 2019 by the then BJP Government.

Earlier in the morning, Jharkhand Chief Minister Hemant Soren wrote to the Centre to seek "appropriate decisions" on its 2019 notification. Soren wrote that the State's 2021 tourism policy it is also being opposed by the community — is for forming a management board that can

better manage the shrine. Following opposition from



also instructed the State Government to take harsh action against forbidden behaviours like drinking alcohol or "defiling of locations of religious and cultural value" or ological harm.

Jain community leaders have been expressing reservation against the notification, fearing that designating the place as a tourist destination

Period of parole to be excluded from sentence: SC

The Supreme Court ruled on Thursday that the period of parole granted to a prisoner is to be excluded from the sentence while considering his premature release. Upholding a Bombay High

Court order, a bench of justices M R Shah and C T Ravikumar said if the period is included in the sentence, then a prisoner who may be influential may get

parole a number of times.
"If the submission on behalf of the prisoners that the period of parole is to be included while considering 14 years of actual imprisonment is of actual imprisonment is accepted, in that case, any prisoner who may be influential may get parole for a number of times as there is no restrictions and it can be granted a number of times and if the submission on behalf of the prisoners is accepted, it may defeat the very objective of sentence."



CBI unearths 160 fake accounts during cattle smuggling probe

There was more embarrass-I ment for the Mamata Banerjee Government even as a fresh scam tended to explode in its face with the Central Bureau of Investigation while investigating the cattle smug-gling case on Thursday stum-bled upon yet another scam in Suri Cooperative Bank in Birbhum district.

In the course of investigating the cattle smuggling case that has seen senior TMC leader and party strongman Anubrata Mondal going to jail, the CRI slouths upporthed at the CBI sleuths unearthed at least 160 fake accounts in the Suri branch of Cooperative Bank where a majority of the account holders are rural farm-

The CBI officers had scanned 60 fake accounts that had accounted for more than Rs 5 crore when the reports last came in. Heavy amounts had been transacted through the

"Only one signature figures in most of these transac-



ly that the poor farmers who are the account holders of a cooperative bank might have transacted in so many lakhs of rupees and on several occassions," sources said adding the accounts had great chances of being linked to some big shot,

The CBI officials would not comment on reports doing the rounds that the accounts had links to cattle smuggling as also the state food department. The CBI sleuths are also trying to find out whether the accounts had any link with Mondal, sources said.

Woman dragged by truck for over 3 kms in Banda, killed

Arerun of the Delhi car dragging incident was witnessed in Banda where a woman employee of the Agricultural University was dragged by a truck for over three kilometers before the vehicle caught fire and she was charred alive.

The accident took place on Wednesday evening and the agitated university students staged a demonstration that led to a huge traffic jam.

Reports said that Pushpa Singh (32) hailing from Gomti Nagar in Lucknow was a junior clerk at Banda University of Agriculture and Technology. She was earlier a teacher at Don Bosco School in Lucknow. On Wednesday evening, she left the university campus on a

scooty. As soon as she came out of the university gate, a truck hit her from behind. Due to this Pushpa got trapped in the front part of the truck along with the scooty. She was dragged along with her scooty for three kilometres before both the vehicles caught fire.

The truck driver and the cleaner immediately jumped out of the vehicle and escaped while Pushpa Singh was charred alive before the police could rush to her rescue or call the fire brigade to douse the

The apex court had on September 6 last year taken note of the Uttar Pradesh policy on remission that there will be no requirement for the convict to submit an application for premature release and their cases will be considered automatically by the jail authorities.

Truck rams into bike: 2 workers die, 2 injured

Two restaurant workers died here and another two were hospitalized with injuries after their motorcycle was allegedly hit by a truck amid reduced visibility due to fog early on Thursday. All the four workers, aged below 25 years, were on the same motorcycle when the crash took place near the Advant building under the Expressway police station limits around 1 am, Additional Deputy Commissioner of Police (Noida) Ashutosh Dwivedi said. Two workers Bhawna (19) and Shobhit (23) have died, while the other two

and Sonu have been hospitalized, according to the police. The truck, which was loaded with furniture, has been impounded and its driver arrested, police said.

"An underpass is being constructed near the Advant Building. The canter truck appears to have gone out of control due to the fog and reduced visibility in the night. The letter to the Union Environment Ministry came days after the Ministry wrote to the State asking it to "recommend necessary modifications for further needful action".

The officer said that all five accused are being interrogated. Hooda said the incident occurred between 2.04 am to 2.06 am, while the body was found around 4.15 am. "Footage is emerging and we are also investigating the matter," he added.

"We are of the firm view that for the purpose of considering actual imprisonment, the period of parole is to be excluded. We are in complete agreement with the view taken by the high court holding so," the bench said.

The top court was hearing an appeal filed by some convicts undergoing life imprisonment, who were released on parole under the provisions of the Goa Prisons Rules, 2006. All the petitioners

had applied for a premature release under the 2006 rules and the State Sentence Revenue Board had recommended their premature release.

sion of police remand, the investigating officer said their further custody was required as police needed to establish the nearly 13-km-long route the accused had taken to traverse in two hours on the fateful night when the victim woman had got entangled under the

vehicle after being hit.

"The long route has to be established...Starting at 7 pm, the accused travelled for around two hours," he said.
The Investing Officer also said the accused Amit was driving the car but another accused Deepak was "planted" as the vehicle's driver. He informed the court that police had obtained disclosure statements of all accused.

He said all of them were subjected to "sustained interrogation" over the last three days in custody. Police have identified the petrol pump and eatery where the accused had stopped, the IO said, adding the Call Detail Records (CDRs) of the accused were also analysed.

The victim Anjali Singh (20) was killed in the early hours of the New Year after her scooter was hit by a car, which dragged her for about 12 kilometres. Her body with multiple injuries was found on the road in Kanjhawala.

The prevailing cold conditions pushed Delhi's peak power demand to a record high of 5,247 MW on Thursday morning, more than the peaks during winters in the past two years as the city witnessed the coldest day of the season.

The minimum temperature of the city settled at 3 degree Celsius, at Safdurjung observatory, Delhi's base weather station

According to sources in the discoms, Delhi's plummeting temperatures are pushing-up the city's peak power demand.
According to the State

Load Dispatch Centre (SLDC) Delhi data, Capital's peak power demand on Thursday clocked 5247 MW at 10:56 am, highest for this winter so far.

This is more than the peak ower demand clocked during the winters of 2022 and 2021. Yesterday, for the first time this winters, it had crossed the 5000 MW- clocking 5126 MW," they said. "Even during November and December, the city's peak power demand has been more than that of previ-



ous years. During the December of 2022, Delhi' it surpassed that of 2021 and 2020. During November of 2022 also, Delhi's peak power demand surpassed the city's peak power demand in 2021, 2020 and even that of 2019," they stated.

Informing the reason behind the increasing power demand in the city, sources said that the Cooling and Heating load is the main reason behind Delhi's power load. "Infact, according to estimates, almost around 50 percent of Delhi's power demand in summers is because of the cooling load (ACs + Coolers + Fans) and because of the heating load (heaters ad geysers) in winters," they said. They claimed that the according to the SLDC data,

Delhi's peak power demand this winter can go upto 5500 MW, surpassing the peak winter demand of the last couple of

"Last year, it had peaked at 5104 MW and 5021 in 2020. The peak winter power demand in BRPL and BYPL areas had reached 2140 MW and 1122 MW respectively during last winter. This year, it is expected to reach 2289 MW and 1159 MW for BRPL and BYPL respectively," they under-

Giving the details of the measure taken by the BSES to meet the peak power demand of the city, BSES spokesperson said that the back-bone of discoms power-supply arrangements during the wintermonths includes long-term agreements from power-plants including Hydro and Delhi based gas fuelled generating

"Additionally, BSES is also receiving 840 MW of solar power from Solar Energy Corporation of India Limited(SECI), 439 MW of wind power, ~ 25 MW from Waste-to Energy.

Foreign universities to open campuses in India

UGC unveils draft norms for establishment, operations

In what would give a big boost to the higher education sector, the Centre has opened the doors for foreign universities to set up their campuses in India with the regulator UGC on Thursday unveiling the draft norms for their establishment and operations.

The draft rules of the University Grants Commission mentioned that such foreign universities would be able to decide their admission process and fee structure and also repatriate their funds to their originating country. They will also have the autonomy to recruit faculty and staff from India and abroad as per their recruitment norms.

As per the Centre's nod, there will be two categories of foreign institutions eligible to apply for setting up their campuses in India---the universities that have secured a position within the top 500 of overall or

subject-wise global ranking or a reputed institution in its The initial appro home jurisdiction.

UGC chairperson M Jagadesh Kumar said the foreign universities with campus-es in the country can only offer full-time programmes in offline mode and not online or distance learning and every time they set up their campus they will have to take permission from UGC.

The UGC announced the draft regulations for 'Setting up and Operation of Campuses of Foreign Higher Educational Institutions in India' and the final norms will be notified by the end of the month after considering feedback from all stakeholders. While these universities will have the freedom to decide their admission criteria and fee structure, the commission has advised keeping the fees "reasonable and transparent".

"The new National Education Policy (NEP), 2020 had envisioned that top universities in the world will be facilitated to operate in India. For this, a legislative framework facilitating such entry will be put in place, and such universities will be given special dispensation regarding regulatory, governance, and content norms on par with other autonomous institutions of said.

The initial approval will be

for 10 years and will be renewed in the ninth year subject to the meeting of certain conditions, he added and clarified that these institutions shall not offer any such study programme which jeopardize the national interest of India or the standards of higher educa-tion in India. "The regulatory framework allowing the entry of higher-ranked foreign varsities will provide an international dimension to higher education, enable Indian students to obtain foreign qualifications at affordable cost, and make India an attractive global study destination, "the UGC chairman said.

On matters related to funds and funding, he said that the cross-border movement of funds will be according to the Foreign Exchange Management Act. "Cross-border movement of funds and maintenance of Foreign Currency Accounts, mode of payments, remittance, repatriation, and sale of proceeds, if any, shall be as per FEMA, 1999. An audit report shall be submitted annually to the commission certifying that the operations of the FHEIs in India are in compliance with the Act and related rules," he



SC has paused the eviction of people from land in Haldwani and sought some workable solution

he Supreme Court order checking an eviction drive on railway land in Uttarakhand's Haldwani is a big relief for the people concerned. The apex court rightly said, "There cannot be uprooting of 50,000 people overnight... It's a human issue; some workable solution needs to be found." It would indeed have been very harsh for those people to be made homeless suddenly. The court has also barred any construction in the area and asked the Railways and the Uttarakhand Government to respond. Both will respond; ideally, the response should pertain to not just the instant case of encroachments but all Railway and state Government lands that have been illegally occupied. In fact, the Central Government should come up with some kind of mechanism to (i) get all such land evac-



uated and (ii) ensure that no future encroachments are made in the future. That would be the "workable solution" that the SC favours. Is it possible? Yes, it is, but the current state of affairs is not conducive for that; the situation in the Haldwani locality and various reactions to it inform us why. The 2-km strip of land near the Haldwani railway station has houses, schools (including four government schools), water tanks, mosques, temples, shops, etc. All these came up over decades. The colony came on the radar in 2013 in an illegal sand mining case in a river near the area. The matter reached the High Court which ordered eviction, even suggesting that paramilitary force be used for the purpose. The SC didn't find that correct.

Typically, the issue has got embroiled in politicking. Activists and Congress leaders are blaming the BJP Government in the state for eviction because most residents in the area are Muslim. "Uttarakhand is a spiritual state," senior Congress leader and former chief minister Harish Rawat said. "If 50,000 people including children, pregnant women, old men and women are forced to vacate their homes and come out on roads, then it would be a very sad sight." Now that the apex court has paused the eviction, what does he, or his party, have to offer for a workable solution? Such are the perils of a polity in which sentiments rule the roost and from which reason has been exiled. Statesmen, they say, think of the next generation, politicians of the next election—and Indian politicians of the next day's Twitter trends. Encroachment is a huge problem, resulting in environmental degradation (as in the Haldwani case), urban decay, corruption, and waste of national resources. Worse, it is not just illegal occupation of government and public land that makes the countryside, towns, and cities ugly; there is also the issue of 'plotting'—that is, unauthorised conversion of land (mostly agricultural land) into habitations. The so-called unauthorised colonies. The need of the hour is a comprehensive policy, involving major political parties and other stakeholders. Our political leaders have to lead such an endeavour, but they are busy fighting each other.

Curb online gaming

The Govt must put in place mechanism to check online gambling sites posing as gaming portals

nline gaming has emerged as one of the fastest growing categories on the internet which is drawing huge crowds with the lure of big prizes. But not all gaming sites are the same. Some are out and out gambling sites masquerading as online portals. The result is many innocent users, mostly teenagers, are indulging in gambling without even realizing it and losing hefty sums of money. At the same time online gaming is one vertical which has a lot of promise for Indian startups and is likely to see exponential rise in the near future. India's gaming market, which has crossed 507 million active gamers, is definitely one of the biggest in the world. The sheer size of the vertical is mind boodling as it has reached \$2.6 billion as per the figures given by Interactive Media Venture Capital Fund Lumikai in its latest report.

The domestic gaming industry is expected to almost quadruple to \$8.6 billion by 2027. To protect users from the harmful effects of gambling, the Indian government is now taking steps to make sure "online games" conform to Indian laws. How effective they would be known when they are implemented.

Recently, all matters pertaining to online gaming were allocated to the Ministry of Electronics and Information Technology (MeitY). The government has also proposed new amendments, which include reasonable restrictions to 'host, display, upload, publish, transmit or share' an online game not in conformity with Indian law, including any law on "gambling or betting". This means the ministry is directly taking on the online gambling portals which have mush-

roomed and lure people with their catchy ads. The amended rules once in place will be applicable to all online gaming matters. As part of the process, MeitY has shared the draft amendments made to the Information Technology Rules, 2021. The government proposal of a "Self-Regulatory Body" (SRO) to keep a tab on the gaming sites is a welcome step. Online gaming sites will need to display a SRO registration mark on all online games. Indeed, the government has a duty to protect young people from falling into the trap of online gambling sites. This is a good start and maybe later on a regulatory body could oversee the activities of online gaming and gambling sites. It is of course important to make a distinction between gaming and gambling but the lines are hazy and it would take careful probe to weed out the bad ones.

ritish colonists had deployed a formula to deal with the restive swathes that constitute modern Pakistan i.e., Rule the Punjabis, intimidate the Sindhis, buy the Pashtun, and honour the Baloch'. It is an instructive insight that occasionally plays out, as Syed Ahmad Khan's 'twonation theory' gets routinely punctured with regional insurgencies that refuse to accept the amalgamation of ethnicities into Pakistan, just on co-religiosity. The creation of Bangladesh in 1971 was the most definitive rebuttal to nationhood based on a singular religion. The historical and lingering 'Pashtunistan' movement or the Baluch separatist movement are direct byproducts of the shaky bind of the 'two-nation theory' that seeks to rationalise the foundational idea of Pakistan.

While Mortimer Durand's cartographical flourish to fix the limits of the British Raj and the Emirate of Afghanistan as part of 'Great Game' was largely ignored by local Pashtuns on both sides of the Durand Line - even the latter-day creation of the State of Pakistan was met with resistance by the Khudai Khidmatgar movement. Reasonable leniency of movement across borders, retention of local laws, and integration of Pashtuns into Pakistani governance (especially into the establishment' or the Pakistani Armed Forces) ensured a gradual waning of sentiment, till Pakistan soured relations with Afghanistan and murmurs of 'Pashtunistan' resurfaced. The willful creation of the Afghan Mujaheddins in the '80s and support to amoral warlords like Gulbuddin Hekmatyar and later to the creation of its Frankensteinian monster i.e., Taliban – Pakistan has inadvertently reignited and weaponised the Pashtunistan sentiments with its metastasized, Tehrik-i-Taliban (TTP), on the rebound.

Whereas formal insurgency in the equally lawless Baluchistan harks back to the stormy signing of the Instrument of Accession by the Sardar of Kalat in 1948. The continuea economic marginalisation, forcible control, human fact that Baluch majority areas, right violations, and lack of rela- as well as Pashtun dominated

tive participation in the affairs of Pakistan has led to recurring waves of violent insurgent movements. Even Pakistan's economy-sustaining \$50 billion punt i.e., the China-Pakistan-Economic-Corridor (CPEC) with its nerve centre in the Gwadar port of Baluchistan is perceived to be anathema and discriminatory towards local Baluch interests. Fronted by the Balochistan Liberation Army (BLA) and a few other militant groups based on tribal affiliations, attacks on the Pakistan Armed Forces and its assets have been relentless, in recent times. While support for Pashtun groups from Afghanistan can expected based on parochial sentiments across both sides of the Durand Line - Afghanistan has also been known to support and offer bases to Baluch insurgent groups as a payback to Pakistani machinations in Afghanistan. With the takeover of Afghanistan by the Taliban in 2021, it was expected that the Pakistan-beholden Taliban would rein in the Pakistan-centric insurgent groups, but the escalating tensions between the Taliban and Pakistan itself have led to a very different dynamic. The





LIKELY FROM BUDGET

Global challenges may have a bearing on the Budget

he upcoming Budget to be presented on February 1 could be one of the most challenging for Finance Minister Nirmala Sitharaman. The Budget has to balance out the recessionary trends seen in other geographies, particularly the developed ones, manage the fiscal situation domestically, keep the domestic consumption hydrated, while keeping inflation within reasonable

These challenges have been laid out in the run up to the budget's digital document preparation and she has heard it from various stakeholders as part of the multiple consultations.

The industry wants more disposable income to be put in the hands of the middle class, which is yet to recover from the impact of the Covid-led organised sector slowdown. The rising prices of food and fuel primarily impacted due to the Russia-Ukraine War. It is an added burden on the middle class, which is also a large and organised voter base. There have been demands to decrease the current highest tax rate slab from 30 and increase the limit from current Rs 10 lakh. It makes sense since the current rates and threshold limits do not reflect the average rise in costs of living annually for the average middle class



In the past, Sitharaman has steered clear of making any significant changes in the IT structure for the salaried, but this tool can be used in the upcoming budget to keep the morale high.

The other long pending demand from the industry and investors is changing the capital gains tax regime. Several Finance Ministry officials and tax experts acknowledge the complex processes involved while filing tax returns, when it comes to definitions of capital gains. Capital gains tax rates fluctuate based on the type of assets and the period for which it has been kept. This creates a speculative market for almost all asset categories including gold, financial products, land, or buildings, etc. A simpler capital gains tax regime with simpler tax rates could again put more money into the hands of the

This apart, the Government in the upcoming budget is most likely to continue the path of strict fiscal discipline, which to its credit, has been tackled well so far, despite several challenges from pandemic year lockdowns and slowdowns. The emphasis would be in controlling the fiscal deficit to a healthy manageable 6.4 per cent of the GDP (gross domestic product).

Also, one of the factors which kept the wheels of the Indian economy moving and buoyant during and after pandemic years was the rural sector demand. One of the key drivers of this demand has been the rural employment guarantee scheme which again puts money into the hands of the rural consumer. This leads to more shampoo, shoes, soaps, etc., being sold in rural markets and increases jobs or those working in factories. This happens even if the region faces inclement weather which impacts agricultural activities

The Government is most likely to continue with the rural employment guarantee schemes but would focus more on asset creation in the villages in the form of roads, permanent structures, etc., which serve a meaningful purpose in local communities. It will be a tough Budget for the Finance Minister, but she has now got nearly five years' experience, so expect some sharp messaging coming out from her Budget speech

Meaning of China's strategy in Tawang



It is high time that India developed the offensive capabilities of cyber warfare and asserted 'digital sovereignty'

he Tawang conflict has ignited discussions on Chinese objectives and future war scenarios. On the surface, there seems to be many causes for triggering the Tawang conflict. The Chinese side was vociferous in its opposition to the 'Yudh Abhyas' exercise of the Indian and the US militaries along the Indo-China borders in Uttarakhand. Further, the Indian Air Force was to conduct exercises in the Eastern sector, and the Tawang transgression served as a deterrent warning for India against any display of aerial superiority and build-up along the contested region.

Although the development points towards the larger Chinese pattern of 'Salami Slicing', at the sub-surface level, China had different objectives to achieve from this clash. At the domestic level of China, the move could be seen as a tactic by the Xi Jinping Government to divert attention from the Tiananmen like protests being faced by the Communist Government against the unpopular covid related restrictions.

The building up of nationalistic rhetoric to divert attention from critical domestic issues is evident in Chinese transgressions, as was the case with the Galwan incident, where China was facing the backlash as the originator of the virus and its poor man-

At the regional level, the Tawang transgression is objectively different from the Galwan clash. Galwan was more strategic and operational, as indicated by the larger military build-up along the Depsang plains and the Chinese occupation of the finger ridges. On the contrary, if noticed, in the Tawang sector clashes, the Chinese forces withdrew immediately post the Corps commander-level talks, indicating that the development was largely tactical.

It was a diversionary tactic with an ulterior hidden objective. The aim of the PLA in Tawang was not occupation but rather a display of strength apart from an assess-ment of the Indian readiness in differing climatic conditions.

Through the clash Beijing also wanted to acclimatise its soldiers for high altitudinal warfare. In modern history, the PLA remains untested in large-scale military operations, which means it lacks the planning as well as operational tactics in a prolonged conflict in the mountains. The military has not experienced combat in decades nor fought with its current suite of capabilities and organisational structures. From this perspective, China got a 'handson experience' for a possible clash. Thus, China might not push its soldiers in open and contact warfare where heavy casualties are a direct consequence.

China may opt for offsetting India's operational readiness through hybrid warfare. In such a case, it will play the role of

a 'shadow boxer' in collusion with Pakistan. First, it might incite internal strife within India through the malicious use of

The next question that comes to mind is, what tools can China use against India? Recent developments under China's Total Information warfare must be looked out for. Beijing can potentially use its advanced information technology and communications systems to gain operational advantage even before a conflict breaks out.

diplomatic outreach.

China has developed a hypersonic missile with a non-nuclear warhead capable of travelling at speeds of 4,600 mph. The warhead can potentially develop an electromagnetic impulse which would be capable of disrupting the power grid and electrical systems of the adversary within a 5-8 km radius. Such advanced technological weaponry has the potential to stop India from launching counter-offensive operations against Pakistan's terror

Disruption of power and communication systems can cause mayhem just before initiating hostilities in the form of clashes in either of the sectors. The timing of the AIIMS cyberattack, which was in sync with the Tawang clash. It highlighted the strategy of China to involve in "two-front wars" at both the territorial borders and the digital con-The AIIMS cyberattack, along

with numerous others, has highlighted the vulnerability of the Critical National Infrastructure at the civilian and military levels. India needs to be cautious, especially in the case of military infrastructure, hospitals, and other data centres. There can be a case of sensitive data theft, such as the medical data of high-profile patients and the military's top brass could be breached for differing uses.

The example of Iranian hackers publishing the personal photos and medical records of Israel's Mossad intelligence agency Chief David Barnea sets an important precedent.

Thus, the Indian government must prepare for conventional and non-conventional attacks. After the recent developments on the LAC, the Indian government has announced the deployment of Pralay tactical missiles with a range of 150-500 km along the LAC. These missiles are well suited for low-level escalations as they provide an effective deterrent. It also has the punishing capability to hit the military build-up on the Sino-Pak side without violating international humanitarian law while achieving

The step is indeed much appreciable. Further, the push by the Government to develop dual-use infrastructure in the country provides an impetus to military responsiveness and troop build-up in targeted areas in the case of conflicts. Also, the planned frontier highway is a step ahead in the direction to militarily counter China.

A lot needs to be done too. There is a need to establish a National Intelligence Reserve Corps on the lines of the US, which can be called upon in times of emergency when extra support is required for shorter periods. It can comprise highly technical individuals from the private sector, academia or civil society. Second, a possible establishment of a strategic technological group within the NSCS that focuses exclusively on developing new and disruptive technologies while reforming the existing ones apart from synchronising them between various stakeholders, such as the police and the armed forces. These measures will also encourage interagency cooperation and civil-military fusion and give a technological edge to the defensive offensive capabilities.

Further, it is high time that India developed the offensive capabilities of cyber warfare and coined the concept of 'digital sovereignty'. Simultaneously, the development of quantum communication satellites and systems for the armed forces, which ensures the non-hackability of communication and the strategic network, would be a force multiplier in the deterrent capabilities. This technology is really useful in providing secure channels of communication to the military in cases of conflict. Such technologies will truly keep 'Buddha Smiling'.

Tactically, developing and implementing multiple offset strategies that exploit the inherent weakness of Pakistan and China at their domestic level to limit their operational cohesiveness could be another step. Finally, at the diplomatic level, India should assertively push forward the reforming of the existing multilateral structures that is able to withstand the asymmetric power dynamics of the global order apart from the double standards of the foreign and security policies.

How climate change causes 'geoengineering' scam

If the scamsters manage to get enough attention, they could delay the consensus for a critical extra year or two

 t was the moral equivalent of a fart in a hurricane. The 'hurricane' was the explosion of the Mount Pinatubo volcano in the Philippines in 1991, which boosted 17 million tons of sulfur dioxide into the stratosphere

The sulfur dioxide didn't hurt anything, because there are no living things in the stratosphere. Moreover, it stayed up there long enough, reflecting some incoming sunlight, to lower the average global temperature by half a degree Celsius for about

This was the time when 'global warming' was first being recognised as a serious threat to human welfare. Scientists, aware of this phenomenon, speculated that



putting sulfur dioxide into the stratosphere might serve as an 'emergency brake' if the warming ever gets out of control. But there was no emergency, so they just filed the idea under 'contingencies'.

Fast forward three decades, and last week Luke Iseman, the cofounder and CEO of fly-by-night startup 'Make Sunsets', revealed that he pumped a few grams of sulfur dioxide into a weather balloon at a secret launch site in Mexico's Baja California. He then freed the balloon to rise into the stratosphere, where it presumably ruptured and released the SO2.

That was the fart. A quite deliberate fart, intended to get everybody's attention. And Iseman's company is already offering to sell \$10 "cooling

credits" for releasing one gram of sulfur dioxide particles in the stratosphere – enough, he says, to offset the warming effect of one ton of carbon dioxide for one year.

We are currently putting about 44 billion tons of carbon dioxide into the atmosphere each year, so counteracting one year's warming at the price Iseman plans to charge would bring in \$440 billion. That's about one hundred times the amount that real scientists calculate it would cost to cancel one year's warming, so it gives him a decent profit margin.

Is this guy for real? Not entirely. He was previously a director of hardware at Y Combinator, so he is a player of sorts, and he will undoubtedly cash the cheques that people send him. But about his company, 'Make Sunsets', he says that "We joke/not joke that this is partly a company and partly a cult."

The balloon launches (there were actually two of them) were pure provocation without a scintilla of science. The payloads were so small as to be meaningless, there was no instrumentation to observe the 'experiments' anyway, and Iseman doesn't even know the altitude that the balloons actually burst at.

But he was looking for a reaction, and he got one. The scientists who are really investigating 'climate engineering' techniques unanimously condemned his rogue behaviour. Harvard University's David Keith blogged that "commercial development cannot pro- they are fighting, and he has

duce the level of transparency and trust the world needs to make sensible decisions about

deployment." Even Kelly Wanser, the secretive director of climate research funder SilverLining, bestirred herself to email that "From a business perspective, reflective cooling effects and risks cannot currently be quantified in any meaningful way." She added that Iseman is "offering 'junk credit' that is unlikely to have value to climate credit."

And of course the many people who fear geoengineering and distrust even the real scientists who work in the field rejoiced at the gift Iseman has given them. He's exactly the kind of reckless and egotistical monster that they imagine

given them years' worth of ammunition for anti-geoengineering propaganda.

Why is Iseman really doing this? To save humanity, he probably tells himself. If you have been nurtured in the selfregarding Silicon Valley swamp for long enough, you can actually believe that the fate of the human race is in your hands-and that there's no crime in turning a buck or two while you're saving it.

But his actions are doing real damage. We are probably going to need an emergency brake on the warming as soon as the mid-2030s, if the real-world consequences of breaching the 'never-morethan +1.5 degrees Celsius' limit are as grave as they are

starting to seem. That means we have per-

haps a dozen years to do all the research that will tell us how to safely deploy 'stratospheric aerosol injection' of sulfur dioxide (or some alternative reflecting particle), and to develop the equipment that would actually do it.

It is a highly controversial topic, largely because there is a huge amount of disinformation about it and a lot of opposition that is really ideological rather than sciencebased. It's going to take a lot of time to reach a global consensus that holding the temperature down temporarily with geoengineering techniques is the least bad option.

If Iseman can get enough attention, he could delay the consensus for a critical extra year or two. Am I helping him by writing this? I hope not.

Faithful mourn Benedict XVI at funeral presided over by Pope

Ope Francis joined tens of thousands of faithful in thousands of fathers bidding farewell to Benedict XVI at a rare requiem Mass Thursday for a dead pope presided over by a living one, ending an unprecedented decade for the Catholic Church that was sparked by the German theologian's decision to retire.

Bells tolled and the crowd applauded as pallbearers carried Benedict's cypress coffin out of the fog-shrouded St. Peter's Basilica and placed it before the altar in the square outside. Wearing the crimson vestments typical of papal funerals, Francis opened the service with a prayer and closed it by solemnly blessing the simple casket — decorated only with the former pope's coat of arms.

In between, Francis made only fleeting reference to Benedict in his homily, offering a

a eulogy of his predecessor's legacy before the casket was sealed and entombed in the basil-

Heads of state and royalty, clergy from around the world and thousands of regular people flocked to the subdued ceremony, despite Benedict's request for simplicity and official efforts to keep the first funeral for a pope emeritus in modern times

Many mourners hailed from Benedict's native Bavaria and donned traditional dress, including boiled wool coats to guard against the morning chill.

"We came to pay homage to Benedict and wanted to be here today to say goodbye," said Raymond Mainar, who traveled from a small village east of Munich for the funeral. "He was a very good pope."

Ignoring exhortations for decorum at the end, some in the



crowd held banners or shouted "Santo Subito!" — "Sainthood Now!" — echoing the spontaneous chants that erupted during St. John Paul II's 2005 funer-

The former Joseph Ratzin-

ger, who died Dec. 31 at age 95, is considered one of the 20th century's greatest theologians and spent his lifetime upholding church doctrine. But he will go down in history for a singular,

the future of the papacy: He retired, the first pope in six centuries to do so.

Francis has praised Benedict's courage in stepping aside, saying it "opened the door" for

to the Vatican, after around 200,000 paid their respects during three days of public viewing.

Benedict's close confidants were also in attendance, and the former pope's longtime secretary, Archbishop Georg Gaenswein, bent down and kissed a book of the Gospels that was left open on the coffin before the ceremony began.

Matteo Colonna, a 20-yearold seminarian from Teramo, Italy, said he came in part because of the historic nature of the funeral — but also because it had personal resonance for

"The first spark of my vocation started under the pontificate of Benedict, but then it became even stronger under Pope Francis," Colonna said, while sitting in prayer in St. Peter's Square at dawn. "I see a continuity between these two popes and the fact that today Francis

Benedict's memory is an historical event.'

But the service was also significant for what it lacked: the feeling of uncertainty that would normally accompany the passing of a pope before a new one is elected. Instead, with Francis in place, Benedict's death marked the end of a decade in which a reigning pope lived alongside a retired one.

Biden weighs sending Bradley Fighting Vehicles to Ukraine

President Joe Biden said Wednesday that the US is considering sending Bradley Fighting Vehicles to help Ukraine combat Russia's ongoing invasion.

Biden was asked during an exchange with reporters while travelling in Kentucky whether providing the tracked armoured fighting vehicle to Ukraine was on the table. He responded "yes," without offering further comment. With Russia's war on Ukraine now in its 11th

month, Kyiv has been pressing the US for tanks, longer-range missiles, armour and air defense systems. Intense fighting has continued in eastern Ukraine despite the onset of winter. The Bradley is a medium armoured combat vehicle that can serve as a troop carrier. It has

tracks rather than wheels, but the vehicle is lighter

and more agile than a tank. It can carry about 10

personnel, or be configured instead to carry additional ammunition or communications equip-Bradleys are still used by the US Army, although the military has been looking for a

replacement for years.

The Pentagon has already provided Ukraine with more than 2,000 combat vehicles, including 477 Mine Resistant Ambush Protected Vehicles and more than 1,200 Humvees. Biden announced last month that the U.S.

Would for the first time send Ukraine a Patriot missile battery, the most advanced surface-to-air missile system the West has provided to help repel Russian aerial attacks. The U.S. Congress last month approved near-



ly \$44.9 billion in military and economic aid for var that has no end in sight.

The same day Biden acknowledged that he was weighing sending Bradleys to Ukraine, France announced it would send French-made AMX-10 RC light tanks to Ukraine — the first tanks to be supplied by a Western European country. That announcement followed a phone call oetween French President Emmanuel Macron and Ukrainian President Volodymyr Zelenskyy.

The French presidency didn't say how many tanks would be delivered and when. The NATO member has given Ukraine anti-tank and air fense missiles and rocket launchers.

Zelenskyy, who visited Washington last month, has made clear to the U.S. And Western allies that Ukraine needs more sophisticated

'I assure you that Ukrainian soldiers can perfectly operate American tanks and planes for themselves," Zelenskyy said during an address to American lawmakers during the visit.

Ukrainian tycoon denies embezzlement in French hearing

AUkrainian billionaire and former legislator suspected of embezzling more than USD 100 million appeared in a French court on Thursday, calling the case against him politically driven and declaring he wants to return to Ukraine to fight Russians who invaded his country.

Mining magnate Kostiantyn Zhevago, 48, was arrested in the ski resort of Courchevel in the French Alps last week based on an international warrant issued by Ukraine.

"It's really a political thing. have always fought corrupt people in Ukraine," Zhevago told a court hearing on Thursday in the Alpine city of Chambery. His wife and daughter were also present. Ukrainian authorities sub-

mitted 244 pages of documents supporting their request for Zhevago's extradition, and the court adjourned until January 19 to study them. Zhevago said he had noth-

ing to do with the embezzlement he is accused of, and vigorously objected to extradition. "I want to return to Ukraine. but not to go to prison — to fight

against the (Russian) aggressors, he said in his closing appeal. Zhevago was the principal beneficiary of Ukraine's now-

defunct Finance and Credit Bank and the former chief executive of mining company Ferrexpo, among the world's top exporters of iron ore pellets and listed on the London Stock

Beds run out at Beijing hospital as Covid brings more sick

Patients, most of them elderly, are lying on stretchers in hallways and taking oxygen while sitting in wheelchairs as COVID-19 surges in China's capital Beijing.

The Chuiyangliu hospital in the city's east was packed with newly arrived patients on Thursday. By mid-morning beds had run out, even as ambulances continued to bring those in

Hard-pressed nurses and doctors rushed to take information and triage the most urgent

The surge in severely ill peo-ple needing hospital care follows China abandonment of its most severe pandemic restrictions last month after nearly three years of lockdowns, travels bans and school closures that weighed heavily on the economy and prompted street protests not seen since the late 1980s.

It also comes as the the European Union on Wednesday "strongly encouraged" its member states to impose pre-departure COVID-19 testing of passengers from China.

Over the past week, EU nations have reacted with a variety of restrictions toward travelers from China, disregarding an earlier commitment to act in unity.

Italy where the pandemic first exacted a heavy toll in



Europe in early 2020 was the first EU member to require coronavirus tests for airline passengers coming from China, but France and Spain quickly followed with their own measures.

That followed the imposition by the US of a requirement that all passengers from China show a negative test result obtained in the previous 48 hours before departure.

China has warned of "countermeasures" if such policies were to be imposed across the

Still, World Health Organisation head Tedros Adhanom Ghebreyesus said Wednesday he was concerned about the lack of outbreak data from the Chinese government

At a daily briefing on Thursday, Chinese Foreign Ministry spokesperson Mao Ning said Beijing has consistently "shared information and data with the international community in an open and transparent manner."

"At present, China's COVID-19 situation is under control," Mao said. "Also, we hope that the WHO secretariat will take a science-based, objective and impartial position to play a positive role in addressing the pandemic globally.

The terse language between China and the WHO contrasts sharply with what critics in the US Congress and elsewhere called an overly friendly relationship between the two as the UN organisation sought to probe the origins of the pandemic.

While the first cases were reported in the central Chinese city of Wuhan in late 2019, China has claimed the virus originated in the US or Europe and has been accused of withholding data that could help narrow the search for the cause.

In dealing with the latest

outbreak, China has sought to get more of its elderly population vaccinated, but those efforts have been hampered by past scandals involving fake medications and previous warnings about adverse reactions to the

vaccines among older people. China's domestically developed vaccines are also considered less effective than the mRNA jabs used elsewhere.

Meanwhile, local authorities in some areas are appealing to the public to avoid traveling during this month's Lunar New Year holiday, as the last formal restrictions on movement are lifted.

"We recommend that everyone not return to their hometowns unless necessary during the peak of the outbreak," the government of Shaoyang county in Hunan province in central Ćhina said in a notice dated Thursday.

"Avoid visiting relatives and traveling between regions. Minimize travel."

Similar appeals were issued by Shouxian county in Anhui province southeast of Beijing and the cities of Qingyang in Gansu province in the northwest and Weifang in Shandong on the east coast.

The Weifang government notice said residents should celebrate the holiday with video and phone gatherings.

McCarthy rejected for House Speaker with GOP in disarray

House Republicans flailed through a second day of multiple balloting Wednesday, unable to elect their leader Kevin McCarthy as House speaker or come up with a new strategy to end the political chaos that has tarnished the start of their new majority.

For a fourth, fifth and sixth

time, Republicans tried to vote McCarthy into the top job as the House plunged deeper into disarray. But the votes were producing almost the same outcome, 20 conservative holdouts still refusing to support him, and leaving him far short of the 218 typically needed to win the

In fact, McCarthy saw his tally slip to 201, as one fellow Republican switched to vote simply present.

Seeing no quick way out of the political standoff, Republicans voted abruptly late Wednesday to adjourn as they desperately searched for an endgame to the chaos of their own making. They were due back at 8 pm.

"Well, it's Groundhog Day," said Rep. Kat Cammack, R-Fla., in nominating McCarthy on the sixth ballot. She said, "To all Americans

watching right now, We hear you. And we will get through this no matter how messy." But the right-flank conser-

vatives, led by the Freedom Caucus and aligned with Donald Trump, appeared emboldened by the standoff though Trump publicly backed McCarthy.

"This is actually an invigo-McCarthy said at the start of the session. "At the end of the day,

held a meeting with former premier and CPN (Unified Socialist) Chairman Madhav Kumar Nepal to seek his support. The Madhav Nepal-led party has 10 seats in the House of Representatives (HoR).

During the meeting held at the Maoist Centre's Parliamenin Singh Durbar, Prachanda proposed to work together in the new government, MyRepublica news-

paper reported on Thursday. The Prime Minister requested the CPN (Unified Socialist) leader to cast votes in his favour during the confidence motion, the newspaper reported, citing Dahal's Personal Secretary

Ramesh Malla. However, Madhav Nepal did not give any words to the Prime Minister about his party's support to the new govern-

The CPN (Unified Socialist) leader earlier on Wednesday said his party is not in a hurry to join the Prachanda-led coalition government.

He said that his party will take the decision on January 10 after looking at the policies and programmes of the government and the activities of the political parties that are part of the gov-

Prince Harry has made a shocking revelation in his upcoming autobiography that his brother Prince William "knocked" him to the floor during an argument over his American wife Meghan Markle, according to a media report.

Describing a confrontation at his London home in 2019, Harry says William called Meghan "difficult", "rude" and "abrasive", which Harry calls a "parrot (ing of) the press narrative" about his American wife, according to the Guardian, which says it has seen a copy of the duke's memoir 'Spare'.

The confrontation escalated, Harry writes, until William "grabbed me by the collar, ripping my necklace, and knocked me to the floor," the paper says. The extraordinary scene,

which Harry says resulted in visible injury to his back, is one of many in the book, which will be published worldwide next week. The book is likely to spark a serious furore for the British royal family.

The Kensington Palace said it "has no comment to make".

The book's title comes from an old saying in royal and aristocratic circles: that a first son is an heir to titles, power and fortune, and a second is, therefore, a spare, should anything happen to the first-born, the report

Spare is a remarkable volume, in which the altercation between the two princes forms a startling passage.

Harry, 38, writes that William, 40, wanted to talk about "the whole rolling catastrophe" of their relationship and struggles with the press.

After William complained about Meghan, Harry told him he was repeating the press narrative and that he expected better. But William, Harry says, was not being rational, leading to the two men shouting over each

Harry then accused his brother of acting like an heir, unable to understand why his younger brother was not content

Stocks skid for 2nd day as hawkish Fed weighs

Bajaj Finance tanks 7.21%

Equity benchmarks buck-led under selling pres-sure for the second straight session on Thursday as traders reduced their exposure to riskier assets after minutes from the US Federal Reserve's latest meeting indicated more rate hikes this year.

Continuous foreign fund outflows added to the selling pressure, market participants said. Paring initial gains, the 30share BSE Sensex tumbled 304.18 points or 0.50 per cent to close at 60,353.27.

Similarly, the broader NSE Nifty dipped 50.80 points or 0.28 per cent to end at 17,992.15.

Bajaj Finance was the top loser among Sensex constituents, plunging 7.21 per cent, followed by Bajaj Finserv, ICICI Bank, Infosys, Power Grid, Titan, Axis Bank, and Tech Mahindra.

In contrast, ITC, NTPC,



Hindustan Unilever, Mahindra & Mahindra, Nestle India, Sun Pharma and Tata Steel were among the gainers, climbing as much as 1.91 per cent.

The market breadth was negative, with 18 declines compared to 12 advances.

"Globally, investors are digesting the Federal Open Market Committee (FOMC) minutes with stock markets trading lower revealing that the Fed officials are determined to tame inflation by maintaining its aggressive stance. Financials led the losses in the domestic market, fol-lowing dismal business num-

bers from NBFC leader.

"Oil prices recovered after falling sharply on fears of a worldwide recession, as investors remain optimistic about long-term demand," said Vinod Nair, Head of Research at Geojit Financial Services.

In the broader market, the BSE midcap gauge climbed 0.33 per cent and smallcap index inched up 0.01 per cent.

Among sectoral indices, financial services declined 1 per cent, bankex dipped 0.78 per cent, teck (0.61 per cent), IT (0.61 per cent) and telecommunication (0.20 per cent). Oil & Gas rallied 1.60 per

cent, FMCG climbed 1.36 per cent, energy jumped 1.28 per cent, auto 1.12 per cent and metal 1.03 per cent.

"Markets have been drifting lower amid mixed signals from the global front however the pace of decline is gradual, thanks to rotational buying in select index majors from across sectors... Total vehicle retail sales jump 15% to 2.11 cr units

Retail sales of overall vehicles Rin India grew by 15.28 per cent to 2,11,20,441 units in 2022 led by record sales of passenger vehicles and tractors, Federation of Automobile Dealers Associations (FADA) said on Thursday.

In 2021, total retail sales of vehicles in India were at 1,83,21,760 units, FADA said in a statement.

Two-wheelers retail sales stood at 1,53,88,062 units last year, a growth of 13.37 per cent from 2021 when sales stood at 1,35,73,682 units.

Passenger vehicles (PV) retail sales were at 34,31,497 units in 2022, as against 29,49,182 units in 2021, up 16.35 per cent, it added.

FADA President Manish Raj Singhania said, "For CY2022, while total vehicle retails grew by 15 per cent year-on-year and 17 per cent compared to CY20 it failed to surpass CY19 retails, (a pre-Covid year) and registered a fall of 10 per cent.' He further said, "The PV

category during this period continued to gain new grounds by clocking 34.31 lakh retails during the full year. This is by far, the highest retails which PV has done till date."

Singhania, however, lamented that the two-wheeler segment once again failed to impress as retail sales during December 2022 continued to fall after two

The government is planning to come out with a comprehensive policy for mandatory adoption of Indian Standard Time (IST) nationwide, a senior consumer affairs ministry offi-

The purpose is to ensure synchronization of all networks and computers to IST and adoption of IST by Telecom Service Providers, Internet Service Providers, power grids, banks, said. Presently, IST is not being adopted mandatorily by all telecom and internet service providers. They are utilising the servers synchronised to other sources such as Global Navigation Satellite System

The Department of Consumer Affairs (DoCA) is already working on a project in coordi-

nation with the National Physical Laboratory (NPL) and Indian Space Research Organisation (ISRO) to generate and

disseminate accurate time trace-

Speaking to PTI, the official said the ministry is also planning to develop a comprehensive policy and regulatory framework for "mandatory adoption of IST" under the Legal Metrology Act, 2009.

Consultants will be hired for carrying out a detailed assesssynchronisation, study best international practices in this domain and lay down plans and procedures for effective implementation of the project.

"It is imperative that all networks and computers within the country, especially those that cater to the real time applications to the strategic sectors for national security, be synchronized to the national time standard," the official said.

The project which is being implemented along with NPL and ISRO aims to create technology and infrastructure to disseminate IST from five sites across India to all the telecom operators, power grids, financial institutions, data centres, common citizens etc. These locations are the

Regional Reference Standard Laboratories (RRSLs) of DoCA at Ahmedabad, Bengaluru, Bhubaneswar, Faridabad and Guwahati. "Upon completion, the pro-

ject is expected to enhance national security and reduce the error in time synchronisation," the official added.

Precise time is essential for country's strategic and nonstrategic sectors for navigation, tele-communication, internet, power grid synchronization, banking systems, digital governance, transport systems, financial transactions, defence sysand upcoming technologies of 5G, artificial intelligence and internet of things.

Precise time with nanosecond accuracy is also required for high-end research in science, namely, measurement of fundamental physical constants, detection of the gravitational waves, geodesy, deep space navigation, radio telescopes, etc.

Six entities, including HSBC and Creditwatch, have been allowed to test their fintech products to prevent and mitigate financial fraud as part of the fourth cohort under the RBI's regulatory sandbox scheme. Regulatory sandbox refers

to the live testing of new products or services in a controlled/test regulatory environment for which the regulators may permit certain relaxations. The Reserve Bank announ-

ced the opening of the fourth cohort under the regulatory sandbox in June 2022 for the prevention and mitigation of financial fraud. The RBI said it had received

nine applications under the fourth cohort, of which six entities have been selected for the 'test phase'.

The six entities are -Bahwan Cybertek, Crediwatch Information Analytics, enStage Software (Wibmo), HSBC in napID Cybersec and Trusting Social. The selected entities would commence testing their products in February.

The applications for the fourth cohort were received from June 15 to August 1, 2022.

The regulatory sandbox allows the regulator, innovators, financial service providers and customers to conduct field tests



to collect evidence on the benefits and risks of new financial products.

The objective of the regulatory sandbox is to foster responsible innovation in financial bring benefits to consumers.

As per the RBI, the first and foremost benefit of the regulatory sandbox is that it fosters 'learning by doing' on all sides. Among other benefits, the regulatory sandbox could lead to better outcomes for consumers through an increased range of products and services, reduced costs and improved access to The RBI invited applications

for the first cohort with the theme 'Retail Payments' in November 2019 and for the second cohort with the theme of December 2020.

The target applicants for entry to the regulatory sandbox are fintech companies, including startups, banks, financial institutions, any other company and Limited Liability Partnerships (LLPs) and partnership firms, partnering with or providing support to financial services

Sebi extends relaxation for cos' to send hard copies of annual reports to shareholders

apital markets regulator Sebi Con Thursday extended the relaxation to listed companies whereby they will not be required to dispatch physical copies of the annual reports to their shareholders till September Earlier, the regulator had

given similar relaxations to listed companies till December 2022. The fresh decision has been taken after Sebi received representations from listed companies, seeking dispensation from requirements of sending hard copies of annual reports to the shareholders. Against this backdrop, the

watchdog has decided to provide relaxation till September 30, 2023, from LODR (Listing Obligations and Disclosure Requirements) Regulations, pertaining to dispatching of hard copies of the annual report to shareholders, according to a circular.

The LODR rules require listed companies to dispatch a hard copy of the statement containing salient features of all the documents — financial statements, board's report, auditor's report — to those shareholders who have not registered their email addresses.

However, Sebi said listed



copies of full annual reports to those shareholders who request the same. Further, the notice of the annual general meeting (AGM) published by advertisement under the norms would disclose the web link to the annual report so as to enable shareholders to have access to the full annual report.

Separately, the regulator has eased the rules for entities, which listed their non-convertible securities, from dispatching hard copies of annual reports to debenture holders. The relaxations have been extended till September 2023. Earlier such relaxations were given till

The latest move also comes after the Ministry of Corporate Affairs (MCA) on December 28 last year extended the relaxations from dispatching physical copies of financial statements to the shareholders for the AGMs conducted till September 30, 2023.

Kane will break all goalscoring records: Conte

AP ■ LONDON

Tottenham Hotspur striker Harry Kane will have beaten every goalscoring record by the time he retires, according to the club's manager Antonio Conte. The 29-year-old England captain needs just three more goals to become Spurs all-time record scorer after his brace in Wednesday's 4-0 thumping of

Crystal Palace.
The double —which took Kane's tally to 15 in the Premier League this season -moved him on to 264 goals, two shy of the late Jimmy Greaves' tally. Kane has 198 Premier League goals to his credit, with only Alan Shearer (260) and Wayne Rooney (208) ahead of him.

"I think to speak about Harry, I think a bit that we waste time to explain about the type of player that he is," said Conte after Spurs' win.

"I repeat, we are talking about a really world-class striker and he's going to beat every record with the goals."

Conte says his belief that Kane will set new milestones is based on what a strong character he is. Kane has had to bounce back after his missed penalty in the World Cup quarter-final with England saw the French prevail 2-1. If he had converted it he would also have become England's record goalscorer.

Asia Cup in Sept but itinerary and venue not announced

The Asian Cricket Council (ACC) on Thursday said that the Asia Cup, to be played in 50-over format, will be held in September this year, though the itinerary and the host country have not been announced yet.

Pakistan is the original host of the Asia Cup this year but the BCCI is not keen on playing there owing to political tension between the two countries.

The then Pakistan Cricket Board (PCB) chairman Ramiz Raja had opposed the BCCI's stand and even threatened boycott of the 50-over World Cup in India.

But following a change of guard in the PCB, with Raja being replaced by Najam Sethi, there could be some positive development.

The Asia Cup 2023 will be a six-team affair involving India, Pakistan, Sri Lanka, Bangladesh, Afghanistan and a qualifier team.

Sri Lanka are the defending Asia Cup champions in the UAE after they beat Pakistan in the final. The tournament was played in T20 format because of the upcoming ICC T20

World Cup in Australia. With India set to host the ODI World Cup later this year and the focus of all the participating teams being on the 50over format, this year's Asia Cup will be held in that format.

A total of 145 ODI and T20I matches will be played during the two-year cycle (between 2023-2024) announced by ACC. There will be 75 games in 2023 and 70 games in

Also, the Emerging (U23) Asia Cup is back and will be held in the 50-over format in July this year for men and involve eight teams. The tournament next year will be held in December but in T20 for-

The women's Emerging Asia Cup this year in June will be T20 affair involving eight

Khawaia and Smith shared in a 209-run stand and Travis Head rammed home the initiative with a blistering 59-ball 70 to leave the visitors yet again fac-

The red-hot Khawaja sur- in his 92nd Test match. score of 174, made against New Zealand in Brisbane in 2015.

Smith more than played his part, passing Bradman's 29 Test tons with a majestic pullshot off Anrich Nortje to the boundary ropes to claim a hometown hundred off 190 balls.

He was out two balls later for 104 when he innocuously chipped back a catch to Keshav Maĥaraj for the left-arm spinner's first wicket of the series.

Along the way Smith also overtook Michael Clarke to become Australia's fourth-highest Test run-getter with 8,647, behind Ricky Ponting, Allan Border and Steve Waugh.

Only Ponting (41) and Waugh (32) have scored more Test centuries for Australia than Smith, who is second only to the immortal Bradman (99.94) with

a current Test average of 60.89


