'We want globalisation that brings prosperity'

Prime Minister Narendra Modi on Friday called for the human face of globalisation ensuring prosperity for all and does not create a climate crisis or debt crisis, besides not leading to unequal distribution of vaccines.

Making this assertion at the Global South Summit here hosted by India, the PM said, "We appreciate the principle of globalisation but developing countries also desire that it does not lead to over-concentrated global supply chains. We want globalisation that brings prosperity and well-being to humanity as a whole. In short, we want human-centric globalisation?

A day after cautioning that the world is facing a crisis due to the Ukraine conflict and climate change, while inaugurating the two-day summit hosted by India, the Prime Minister

Modi said the last three years have been difficult, especially for the developing nations. The challenges of the Covid pandemic, rising prices

of fuel, fertiliser and food grains, and increasing geopolitical tensions have impacted our development effort

Over the past two days, this Summit has seen the participation of more than 120 developing countries — the largest-ever virtual gathering of the global south, he noted.

He also said for synergising diplomatic voice of the developing nations he proposes a Global South Young Diplomats Forum to connect youthful officers to our Foreign Ministries. India will also institute Global South scholarships for students from developing countries to pursue higher education in India, the Prime Minister said.

Referring to India's G20 Presidency this year, Modi said the country will attempt to voice the views of the Global South on these important

In its development partnership, India's approach has been consultative, outcomeoriented, demand-driven, people-centric, and respectful of the sovereignty of partner countries, he said, adding, "I firmly believe that countries of the Global South have a lot to learn from each other's development experiences.

Modi calls for human Joshimath sank 5.4 cm

NEW DELHI/DEHRADUN

With the passing of every day Joshimath town faces the danger of becoming a casualty of land subsidence. The satellite images of Joshimath released by the Indian Space Research Organisation (ISRO) show that the Himalayan town sank at a rapid pace of 5.4 cm in just 12 days, triggered by a possible subsidence event on January 2.

Amid reports that a similar situation can arise at other subsidence-prone locations in the State, the Uttarakhand Government on Friday decided to conduct a study on the carrying capacity of all towns located in the hills.

The Government unveiled a series of relief measures. The decisions were taken at a meeting of the State Cabinet here chaired by Chief Minister Pushkar Singh Dhami.

The Cabinet gave approval to the construction of prefabricated houses for short-term rehabilitation of the affected people of Joshimath at identified locations in Koti Farm, Pipalkoti, Gauchar, Gaukh Selang, and Dhak villages after their survey.

Meanwhile, the preliminary study by ISRO's National Remote Sensing Centre (NRSC) said the land subsi-

dence was slow between April top and fanning out at the base. and November 2022, during which the pictures were taken from the Cartosat-2S satellite.

The region subsided around 5 cm within a span of a few days and the areal extent of subsidence has also increased. But it is confined to the central part of Joshimath town," the \hat{NRSC} report said.

It said a subsidence zone resembling a generic landslide shape was identified — tapered

The report noted that the crown of the subsidence was located near Joshimath-Auli road at a height of 2,180 metres.

The images show the Army Helipad and Narsingh Temple as the prominent landmarks in the subsidence zone that spans the central part of Joshimath

A total of 169 families consisting of 589 members have so far been shifted to relief centres.

There are 835 rooms serving as relief centres in Joshimath and Pipalkoti which can together accommodate 3,630 people. Interim assistance of ₹1.5 lakh has been paid so far to 42 affected families. Dhami on Thursday said a committee would decide the market rate for compensation to be paid to the families affected in Joshimath by keeping in mind the interests of stakeholders.

SC: Hate-spilling anchors should be taken off air

The Supreme Court on Friday once again came down hard on TV channels, saying they are creating divisions in society and went to creating anchors should be taken off the air. The court was hearing a petition seeking direction to control hate speech.

The Central Govt's counsel said that the Government is planning to introduce comprehensive amendments to the Code of Criminal Procedure (CrPC) to tackle hate speech.

The Bench comprising Justices KM Joseph and BV Nagarathna even observed that such hate-creating anchors have to be taken off the air and said that TV channels work as per the dictates of their funders and asked the Govt to suggest ways to tackle these issues.

also disbursed among the medal winners.

Delhi is making its mark in the country in sports. India won 61 medals in the Commonwealth Games, of which sportspersons from Delhi won seven, Kejriwal said in his address.

"Less than two per cent of the country's population live in Delhi but we brought more than 10 per cent of the medals for the country. There is no dearth of talent in our country but sportspersons don't get facilities because of political interference. We changed this in Delhi," he claimed.

He said we would fulfill our promise to provide Rs 1,500 per month to women and a sub-committee with Cabinet Ministers, including Chander Kumar, Dhani Ram Shandil, Anirudh Singh and Jagat Negi, has been constituted to prepare a road map for disbursement of Rs 1,500 per month in 30 days.

The brutal death of Anjali, a 20-year-old sole breadwinner of a family of five, in the wee hours of January 1, 2023, shocked the nation. Her scooter was hit by a Baleno car that was being driven by five drunk men and she got caught underneath the four-wheeler vehicle and dragged for 12 km. Seven people have been arrested in connection with the accident.

The MHA has directed the Delhi Police to file the chargesheet in the case as soon as possible so that the culprits are punished. The police have also been ordered to ensure that there is no let-up in the investigation and fortnightly reports on progress in the

MHA. The report was submitted by Singh and it highlighted loopholes in the police response to the incident.

In a letter sent to Delhi Police, the Ministry added that the role of supervisory officers should also be examined and if their negligence was established, action should be initiated against them. The Ministry asked the police to assess all the poorly lit roads in the city and work with civic authorities to get them properly illuminated. It also asked for the installation of CCTVs in vulnerable stretches.

Slanging match at LG-CM meeting on governance

Saxena, Kejriwal blame each other for the lack of administration in Capital

ieutenant-Governor (L-G) VK Saxena Land Chief Minister Arvind Kejriwal met after a long gap to discuss governance, only to blame each other for the lack of it

in the national Capital.

While Kejriwal said that the L-G told him that he can ask for any file since he is the "administrator" and stressed that various orders of the L-G are illegal in view of the 2018 Supreme Court judgement on transferred subjects, the L-G flagged a 12point concern list including "immoral continuance of Satyendar Jain as Minister despite being in prison", and no hospital or flyover being made in the last 8 years among others.

Interestingly, both Kejriwal and Saxena advised each other not to politicise every issue and focus on governance. Addressing a press conference after the weekly meeting with Saxena, Kejriwal alleged that dur-



ing his meeting with the L-G, he had cited Supreme Court judgments and various provisions of the Constitution but Saxena aid that he has been referred to as the "administrator" and enjoys supreme authority."Delhi L-G has been interfering in the Government's work that is causing inconvenience to people of Delhi. My intention was to sort out the issues, which



is why I carried copies of the Constitution, Motor Vehicles Act, School Education Act, Supreme Court judgement," Kejriwal said. Kejriwal said that there are two kinds of subjects in Delhi - "reserved subjects" that include police, land, and public order on which LG can only take decisions, and "transferred subjects". "All the other subjects come under the Delhi Government.

On July 4, the Constitution Bench of the Supreme Court had passed a judgement that said the L-G has not been entrusted with any independent decision-making power in terms of transferred subjects," he said. He also said, "There is no independent authority vested in the L-G to take decisions. In some matters, he can act as

a judicial authority."

Kejriwal said that this means that various orders passed by L-G, including ones on sealing of Delhi Dialogue and Development Commission Vice Chairman Jasmine Shah's office and issuing of notice demanding Rs 164 crore in recovery for ad expenses, are "illegal and unconstitutional". "However, the L-G said that he has been referred to as the 'Administrator' and enjoys supreme authority," Kejriwal added.

The Chief Minister also said that several departments stopped payments to the Delhi Government three months ahead of the MCD polls. "Officials said that they had been unofficially told to do so. This was done to hurt the AAP in the polls," he said.

After Kejriwal's press conference, Raj Niwas issued a press release saying that the statements that the Chief Minister attributed to Saxena with regard to orders of the Supreme Court and powers as administrator are misleading and twisted to suit a particular agenda.

Informing about the points that were discussed in the meeting, Raj Niwas said that the points which were underlined in the meeting are broken/potholed roads; no new flyover/underpass in eight years, record Air pollution and worsening condition of Yamuna, no new Hospital in eight years, no new school / college building in eight years, despite 13 plots given by DDA, no effort undertaken to create new park/

"Apart from this, encroachment on Yamuna floodplains, worsened drainage system - severe waterlogging across the

city, no effort ever taken to clean Najafgarh Drain, corruption in Government Departments, illegal appointment of private persons as government nominees on Boards of Private DISCOMS instead of government officers, despite written objections from two LGs, delaying and derailing projects of National / Public Importance – redevelopment of AIIMS, new Academic Blocks in IIT, expansion of Metro and NHAI projects and immoral continuation of Satyendra Jain as Minister despite him being in prison for long were the topics which were raised by the L-G in the meeting," Raj Niwas said.

The statement said that all statements attributed by the CM to the LG in his press conference after the meeting, with regards to orders of the Supreme Court, powers as administrator, supremacy over all subjects and directions to officers are misleading, patently false and fabricated and twisted to suit a particular agenda.

LG orders removal of Govt nominees from discoms boards

SC states LG has no powers to take independent decisions, so directions are illegal, says AAP

Delhi Lieutenant-Governor (L-G) VK Saxena on Friday ordered removal of the Delhi Government's nominees appointed by the Arvind Kejriwal Government from the Board of the Anil Ambaniowned DISCOMs BRPL (BSES Rajdhani Power Limited) and BÝPL (BSES Yamuna Power Limited), who allegedly caused a Rs 8,683.67 crore loss to the Government.

He also directed to replace them with senior Government officers, as had been the practice in the past. These nominees include AAP spokesperson Jasmine Shah, Naveen ND Gupta (son of AAP MP, ND Gupta), Umesh Tyagi and JS Deswal.

Saxena has also asked the Directorate of Vigilance to investigate the omission/commission noted on part of these private individuals acting as Government nominees, from the angle of any possible quid pro quo. Saxena has allegedly taken the decision on the basis of an inquiry report submitted to him by Power Department and the Chief Secretary, following a complaint on September 26, 2022. The L-G has asked for Chief Minister Arvind Kejriwal to be informed about this and action be taken.

The Delhi Government dismissed the allegations as absolutely baseless" and said the decisions taken by the L-G are "illegal". "All allegations made by the L-G are absolutely baseless. "These compromised nominees provided undue financial benefits running into thousands of crores to Ambani's discoms at the cost of the State exchequer and Delhi Government-run undertakings (DTL, IPGCL and PPCL). The -G has asked for the Chief Minister to be informed about this and action be taken," Raj Niwas said in a statement.

It has been brought out in the report that, these private individuals were illegally appointed surreptitiously by the AAP government as 'government nominees' on the Board of BRPL and BYPL in 2019, despite written objections on file by the then LG, Najeeb Jung on November 1, 2016 and LG, Anil Baijal on August 11, 2017.

In 2017, CM Keiriwal had sent a file proposing their appointment as Government nominees, disposing of which Baijal had directed that a Cabinet Decision in this regard be taken and sent to him so that, he could invoke difference of opinion as per Clause 4 of Article 239AA of the Constitution of India.

However, the Cabinet took a decision to appoint them and instead of sending the file to LG, Baijal, who would have invoked the said clause, surreptitiously notified the appointment of these private individuals as Government nominees on the Board of the DISCOMs.

Once appointed these Government nominees rather than taking care of the government interests, in cahoots with the Anil Ambani nominees on the Board, facilitated a decision of the DISCOMs Boards of unilaterally lowering interest rates charged on LPSC (that these DISCOMs owed to DTL/PPCL/IGPCL), from 15-18 per cent to 12 per cent, thereby causing a loss of Rs 8683.67 crore, said the statement.

Noida gang duping aspirants on pretext of MBBS berths busted

Mastermind of gang absconding, says DCP Chander

Noida Police on Friday arrested two persons and busted a gang allegedly involved in duping hefty sums of money from aspiring doctors on pretext of facilitating their admission into MBBS courses.

According to Deputy Commissioner of Police, Noida district, Harish Chander, the

third member and key operative of the gang is still at large but has been identified.

The police had started investigation after lodging an FIR at the Sector 126 police eta. FIR at the Sector 126 police station over a complaint of fraud by a Lucknow-based aspirant Darshika Singh (26) who

Truth Advisors Career Consultancy. "On the basis of the complaint, a team was formed in the supervision of ACP (Noida 1) Rajneesh Verma to investigate the case and resultantly we have arrested two persons although the mastermind of the gang is abscond-

Those held have been identified as Deepak Kumar, a native of Muzaffarpur district in Bihar, and Rajesh Kumar Ahuja, who hails from Banda district in Uttar Pradesh, according to the police. "The gang would call the aspirants

claimed being cheated of Rs and assure them of admission 13.98 lakh by Noida-based on paid seats. The gang quoted Rs 35 lakh for a seat (in a medical college) in home state (of a candidate) and Rs 25 lakh in other states.

This way, they would get in touch with aspirants," he said. "Further, they would carry out some forged document work and also arrange a visit to medical colleges as selected by an aspirant.

DTC now has 34 women drivers navigating the city roads, one of the highest in any state in India, a statement by the Delhi government said. "The Delhi Government has been consistently working on inducting more women as bus drivers under its city transportation fleet.

"Ten women out of the 13 women given a letter of appointment today have joined after receiving training under the Delhi government's 'Mission Parivartan' initiative," the government said in a statement. Seventeen women were

hired under the initiative, while

programme is currently training its 4th batch of women candidates, having already trained 123 women. Out of the 13 women drivers who received a letter of appointment on Friday, six are from Delhi and three from Haryana. Nirmala Devi,

Rajkumari, Meena and Maya Devi are from Delhi, while Nisha, Sonia and Usha Rani are from Haryana. Abita Mishra originally hails from Bihar, Laxmi Rawat from Uttar Pradesh, Asha Rani from West Bengal, and Neetu Devi is from Rajasthan.

As she got her appointment letter, Abita Mishra said, "Now we have become birds that soar in the sky from a frog in the well due to this training.'

Usha Rani, who has a double MA in yoga science and physical education, said it would be challenge to drive through heavy Delhi traffic.

'I started training as a bus driver in October last year. I have driven on Haryana's roads in a car but driving a bus on Delhi roads will be challenging. Haryana's roads are wider and

have lesser traffic, but in Delhi, traffic will be a challenge," she said. Laxmi Rawat, who has been a cab driver since 2017, was held back by lack of money for training, till she heard about the Delhi government scheme. The Supreme Court on Friday observed that TV channels are creating divisions in society and compete to sensationalise news.

Hearing petitions to control hate speech, the Bench comprising Justices KM Jospeh and BV Nagarathna even observed that such hate creating anchors have to be taken off the air and that the TV channels work as per the dictates of their funders.

As the court asked the Government to suggest ways to tackle these issues, the Centre's counsel said that the Government is planning to introduce comprehensive amendments to the Code of Criminal Procedure (CrPC) to tackle hate speech.

"When you claim freedom of speech and expression, you must act like you deserve it. Otherwise what dignity is left for us," Justice Joseph remarked, adding that such channels are creating fissures in the society.

"Channels are basically competing with each other. They sensationalize it. How do you control this? Freedom of speech and expression is important. Problem with free-



India has called for making Laccountable countries backing cross-border terrorism for narrow political gains and urged the international community to stand united against this scourge and not engage in double standards for political expediency.

Making this assertion in an apparent reference to Pakistan in the United Nations Security Council (UNSC), New Delhi also said late Thursday, "The application of rule of law at the international level should protect the sovereignty and territorial integrity of states from



aggression, including terrorism, and including cross border terrorism." United Nations Secretary Antonio Guterres said the Russian invasion of Ukraine has created a humanitarian and human rights catastrophe, traumatized a generation of children, and accelerated the global food and energy crises. Enunciating her country's stand on the issue in the UNSC, India's Permanent Representative to the UN

Ambassador Ruchira Kamboj stressed that states that use cross-border terror to serve narrow political purposes must be held accountable.

Speaking at the Security Council's open debate on the Rule of Law held under Japan's current presidency of the Council, she said "this is only feasible when all countries stand together against common threats such as terrorism and do not engage in double standards for political expediency."

"In our view, a rules-based international order is one that is free from coercion and based on respect for sovereignty and territorial integrity, transparency, and peaceful resolution of disputes," she said.

India to wipe out Lymphatic Filariasis ahead of 2027 goal

New Delhi: Aiming to eliminate Lymphatic Filariasis —a mosquito-borne disease—three years ahead of the global target of 2027, India has chalked out a five-pronged endgame strategy including multi-drug administration (MDA) in a mission mode twice a year, an early diagnosis and treatment; engagement of medical colleges for strengthening morbidity management and disability ser-

vices among others. Though India's National Health Policy 2002 had set a goal to eliminate LF as a public health problem by 2015, it had to be later extended to 2017. Again, the goal set by the Global Program to Eliminate Lymphatic Filariasis was to eliminate LF by 2020. The target has been subsequently revised to 2030. While national goals across endemic countries have aligned to meet that target, India has taken the

challenge head on, keeping the visibility campaigns at the elimination goal three years ahead of the global target by

In keeping with this commitment, the Union Health Ministry shared its five pronged strategy to tackle the disease at the 'National Symposium on India's Roadmap to Eliminate Lymphatic Filariasis' here which was inaugurated by Union Health Minister Mansukh Mandaviya.

He said, "Lymphatic filariasis is not a neglected disease for India as may be the case in some other countries but is a priority for elimination in a time-bound manner." To begin with, the Government will kick off the pan-India MDA Campaign in mission mode on February 10 this year and August 10.

The Ministry will observe these days with necessary mass national, state, district, sub-district and block levels to ensure that no one is left behind when it comes to accessing LF preventing drugs. Mandaviya called for the right synergy of governmen-

tal action and societal improvement" while highlighting that 133 districts across 20 states and Union Territories provide anti-filarial drugs for free. The other aspects of the strategy include early diagno-

sis and treatment; engagement of medical colleges for strengthening morbidity management and disability services; integrated vector control with multi-sectoral coordinated efforts; inter-sectoral convergence with allied departments and ministries; leveraging existing digital platforms for LF and exploring alternative diagnostics.



Flagging of MV Ganga Vilas, the longest river cruise opens a new vertical - river tourism

V Ganga Vilas, the world's longest river cruise, will go a long way promoting tourism in the eastern states concerned, boosting economic activity there, and generating employment. Prime Minister Narendra Modi today flagged off the cruise Varanasi through video conferencing. As many as 32 tourists from Switzerland will enjoy the maiden journey to reach Dibrugarh in Assam via Bangladesh. The Prime Minister also inaugurated a Tent City, with 200 luxury tents offering the scenic view of the famed ghats of the Ganga. The tent city lets tourists soak the spirituality and mystique of the ancient city and the holy river, complete with live classical music, the famous evening 'aarti,' and yoga sessions. Modi also laid the foundation of Rs



1,000-crore inland waterways projects. He rightly said, "With this cruise, many places of eastern India will now figure in the world tourism map... What can be more unfortunate than the fact that since Independence the banks of the Ganga became backward, let alone developed." Cruise tourists, witnessing 27 river systems, will be able to visit a variety of 50 prominent destinations, including world heritage sites, national parks, river ghats, and cities like Patna, Shahiganj in Jharkhand, Kolkata, Dhaka, and Guwahati. It is interesting to note Modi's interest in and zeal for promoting tourism, including the luxury variant. The cruise, costing Rs 20 lakh per head, is surely for the top income bracket people.

This highlights the fact Modi is perhaps the first Prime Minister who is not infected with the India-is-poor syndrome. In the last one hundred years, if not more, Indian politicians have not only suffered from this syndrome but also promoted it in their statements and speeches, policies and programmes. Worse, poverty was even glorified, something which began with Mahatma Gandhi. One casualty was tourism, for it was regarded as the prerogative of the rich. It never received the attention that other areas—for example, heavy industries under Jawaharlal Nehru, agriculture under Indira Gandhi, and computers under Rajiv Gandhi—received. After all, only the rich people are interested in tourism—or so it was thought. Few in India—and none in politics—even bothered to have a look at tourism which has enormous growth and job potentials. This is one sector in which people from all walks of life—the educated and the uneducated, the skilled, the semi-skilled, and the unskilled, artisans and craftsmen, hotels and shopkeepers—participate. Unsurprisingly, the tourism sector is highly taxed, as parliamentary panels have reported. It goes to the credit of PM Modi that he not only recognised the potential of tourism but also worked on it; the promotion of the Kutch region in Gujarat, where a tent city came up much earlier, is a testimony to his support for tourism. It is time his Government thought of bringing down the incidence of taxation in the sector.

Adieu Sharad Yadav

Sharad Yadav leaves a void in the socialist

movement in the country

he veteran socialist leader Sharad Yadav is no more. He died while undergoing treatment in Gurugram, Haryana. He was admitted after he collapsed at home, Yadav is survived by his wife and two children. His death is a sudden jolt to the socialist politics in the country as he was one of the most prominent faces of socialism in the country. He was one of the key leaders who opposed Indira Gandhi's Congress during the Emergency. Sharad Yaday was always active in politics and had been a part of the Lok Dal and Janata Party and its spin offs. Yadav first won a seat in the Lok Sabha in 1974, defeating the Congress candidate. Since then, he was elected as MP multiple times. Yadav served as minister in the Atal Bihari Vajpayee

and VP Singh governments. Yadav was elected to Lok Sabha for the first time from Jabalpur in Madhya Pradesh in 1974 in a by-poll. It was the time when JP Movement was at its peak and he was the first candidate chosen by Jai Prakash Narayan. In 1977, he was reelected from the same constituency. When Janata Party split in 1979, he sided with the Charan Singh faction. Though he switched parties but he never gave up his ideology and remained committed to

> socialistic values that he imbibed in his college days. He contested the Madhepura Lok Sabha constituency in Bihar several times which became his favourite seat. He won the Madhepura seat four times in 1991, 1996, 1999 and 2009. He lost four times from Madhepura constituency when he contested on RJD's ticket. A few years ago, there was a rift between Sharad Yadav and Nitish Kumar, after which

Chief Minister Nitish Kumar himself became the national president of the party. Sharad Yadav left JDU and formed a new party, although his new party did not work, after which he got associated with Lalu Prasad Yadav's party RJD and remained there till his last day. He had fair share of highs and lows in his long political career spanning over five decades. He was one of the accused in the 'hawala' scandal however, the charges were dismissed by the Supreme Court of India. Without him socialism which is already fading would fade even faster. Mulayam Singh Yadav, another exponent of socialism is already gone. However, the values he stood for would continue to inspire the generations to come as the dream of the egalitarian society is still unfulfilled in the country.

Stop demonising demonetisation



Demonetisation was a major reform that helped in laying the foundation for inclusive and sustainable growth

elivering a majority 4:1 verdict on January 2, 2023, the Supreme Court (SC) upheld the constitutional validity of the demonetization announced by the prime minister, Narendra Modi on November 8, 2016. But the controversy refuses to die down. Reiterating its stance that the decision was disastrous, the grand old party (GOP) opines that the question of 'whether the stated objectives of demonetization have been achieved' was not examined by the SC.

Being a policy matter that lies within the exclusive domain of the Union government/executive. its examination by the judiciary was not required; SC's mandate was to deliver its verdict on the legality of the decision which it did. As for the impact of demonetization, there is a need for an objective and dispassionate analy-

A major plank underlying the move was to curb the menace of black money — a jargon for income generated in cash that goes unrecorded and no tax is paid. Working on the premise that most of such cash was held in 1000/500 denomination notes, Modi declared these notes as illegal meaning that the Reserve Bank of India (RBI) won't be under an obligation to discharge its liability to the holders of such notes. Put simply, the worth of these notes would become 'NIL'

Modi acted in the belief that those who had accumulated cash by indulging in undesirable activities such as a bureaucrat taking bribe money instead of a favor extended to private entities etc. (or a person not disclosing his income and paying tax) won't have the courage to go to the bank as this would come on the radar of the income tax (I-T) department and other agencies. So, they would let these notes be annihilated while sitting in their

The mandarins in the finance ministry were hoping that notes worth over Rs 300,000 crore won't come back leading to corresponding gain for the KBI by way of a reduction in its liabilities for that amount. A portion of this mammoth gain, in fact, of it. could be transferred to the Union government to be used by the latter for reducing its fiscal deficit or funding infrastructure projects and welfare schemes. But things didn't pan out as expected. As on November 8, 2016 (the day, demonetization announced), the total value of 1000/500 notes with the public was Rs 1540,000 crore.

Of these, notes worth Rs 1530,000 crore were either deposited or exchanged for new currency. Thus, notes worth Rs 10,000 crore didn't come back, a tiny fraction of what was expected. The cost of printing new currency to replace the banned notes and putting up infrastructure to deliver being around Rs 8,000 crore, the RBI ended up with a meager gain of Rs 2000

However, merely on this basis, we can't say that the exercise was a damp squib as it unleashed a host of other benefits. A close look at the numbers reveals that a mere 110,000 persons deposited Rs per person.

Thus, a mountain of black cash was brought to the banks and many of its carriers made attempts to convert it into white. How far did they succeed? This is a matter of probe. But a big positive is: banks got hundreds of thousands of crores to increase lending.
Under 'Operation Clean',

1.8 million accounts in which 'suspicious' deposits of over Rs 300,000 crore were made, were subjected to intense scrutiny by the I-T department and made to pay tax plus penalty. Meanwhile, the government offered them a less stringent option of paying 50 percent tax plus a 25 percent

interest-free loan to PM Garib Kalyan Yojna (PMGKY) from December 16, 2016, to March 31, 2017. This was instead of a person accepting the wrong and agreeing to be an honest taxpayer in the future.

This led to buoyancy in tax collection. During the 2017-18 assessment year (AY), the total number of return filers was about 70 million almost double the number during AY 2014-15 at 36 million. Of 34 million filers added during the intervening period, around 16 million were added during AY 2017-18 alone. Correspondingly, the direct tax revenue (DTR) surged from Rs 850,000 crore during 2016-17 to over Rs 1000,000 crore during 2017-18.

The disclosures also helped in nabbing shell companies that were being used for laundering black money. Over 200,000 such companies have been deregistered. It has also helped the I-T department intensify searches and seizures leading to the disclosure of unaccounted income

FIRST COLUMN AI CAN HELP FIGHT **FOOD CRISIS**

Several states are serious about adoption of AI in agriculture



RAJESH KUMAR SINGH

The world is witnessing a widespread food crisis owing to a number of factors like climate change and other environmental shocks such as flooding and drought are adding to the food crisis. Also, supply chain disruptions caused by Russia-Ukraine and other conflicts, poverty, hyperinflation, rising commodity prices, lingering Covid pandemic, low production of cereals, and then rising population in some parts of the globe are making the food crisis acute.

The World Bank suggests that the rising food crisis is driving millions into extreme poverty, increasing hunger and malnutrition and threatening to wipe out the gains in terms of Sustainable Developmental Goals (SDGs) through the last few decades. Here, experts concede that only leveraging new technologies like artificial intelligence (AI) can be able to combat this food crisis which otherwise may aggravate.



Evolving multi-fold in the last few years, artificial intelligence offers a slew of solutions in several sectors, including agriculture. Al can help in detecting crop disease, pests, impact of weather, pesticides and weedicides. Al helps farmers achieve higher yields through precision farm-

The lack of required infrastructure and technical knowhow and persisting with traditional styles of cultivation worsen agricultural problems in large part of the globe, including India. However, demands are fast growing. If estimates of the Indian Council of Agriculture Research (ICAR) are to be believed, demands for cereals, pulses, eggs, fruits, vegetables and milk may be more than twice by 2030 compared with the requirements in 2000. During this period, food grain demands are also expected to jump by more than 85 per cent. Similar is the situation in several parts of the world.

Sensing the situation well in advance, India has already ventured on to this path with all the required wherewithal. The Prime Minister's Science, Technology and Innovation Advisory Council says, Al expenditure is expected to grow at 39 per cent year on year basis during 2019 and 2025 and Niti Aayog estimates that AI can add up to one trillion dollar to Indian economy by 2035 and experts suggest that a significant amount of this would be in the agriculture sector only.

Presently, the value of the Indian agri-tech market is estimated to be at \$204 million. New AI technologies coming into being are expected to transform Indian agriculture with the Economic Survey suggesting the contribution of agriculture to India's GDP is likely to be 19.9 per cent in 2020-21, which was just 17.1 per cent in 2019-20.

Moreover, Al can help in efficient and cost-effective resource and yield management, besides helping in coping with the complexities of modern agriculture. Helping in agri-data stacks, Al can help farmers to extract and analyze relevant information like temperature, weather, water consumption, soil conditions, use of fertilizers, besides supporting both public and privates entities who are increasingly getting involved in agricultural activities. Al can help farmers in having seasonal weather forecasts and early warnings to improve farming accuracy and productivity. Al with its accurate and real time data, can also help in addressing demand and supply mismatch.

Besides, precision farming, yield and price management would also be possible through Al-enabled internet of things, as the availability of 5G technology is just a matter of time. Al-supported drone-based cameras can also help identify real-time issues related to cultivation. Clearly, a combination of artificial intelligence, cloud computing, satellite imagery and advanced analytics is sure to lead us to smart agriculture with reduced uncertainties. Several states are serious about adoption of Al in agriculture, with Karnataka, Uttar Pradesh and a few others spearheading the

High-values currency should be checked

he Supreme Court's verdict put an end to the 10 legal questions it raised about the validity and due process by which demonetisation was carried out. However, the critics of demonetisation would continue to question the efficacy which was spelt out by Prime Minister Narendra Modi at the time of announcing the decision to the

When any public policy is devised and implemented, the intended benefits are stated. The outcome may not achieve all the stated benefits, but it may achieve some which were not envisaged at the time of implementation of a public policy.

There are essentially four menaces that were targeted by the government from demonetisation announced on November 8, 2016. They were counterfeit currency, terror financing, tax evasion and black money.

Although counterfeit currencies can be printed by anybody, it is not easy to print them very similar to currencies printed by the RBI and hence, its circulation is exceptionally difficult if the public is a little alert. The alertness and quick action of the local police also plays a large role in quickly nabbing the culprits, who try to circulate counterfeit currencies. Counterfeit currencies are also very difficult to pass through the bank-

invariably, attempts have been made to print counterfeit currencies of larger denominations as the huge risk involved in circulating counterfeit currencies can be compensated only by printing larger denomination currencies by the culprits. With INR 2000 denominations constituting only about 13.8 per cent in terms of value of the total currency in circulation in December 2022 and which has been on the decline further in the months to come, it is more futile now to attempt to generate counterfeit currencies.

The number of counterfeit banknotes has come down from 7.62 lakh pieces in 2016-17 to 2.09 lakh pieces in 2020-21 postdecision of the Government of India to cancel the legal tender status of Rs 1,000 and Rs 500 denomination currency notes on November 8, 2016.

The second one is terror financing. It was the use of counterfeit currencies that played a key role in the terror financing before demonetisation and with the demonetisation, the counterfeit currencies reached the lowest level of link 2.60 lakh between 09.11.2016 and 14.07.2017 (PIB dated 25.07.2017). But terror funding need not always have to come from counterfeit cur-

rencies but from legal tender too. After the repeal of Article 370 for Jammu & Kashmir, the terror unleashed against the public is more local and one can surmise that it has been happening with legal tender. The third one is tax evasion. With GST and the electronic trailing associated with it, businessmen and traders are forced to show their true transactions and thereby true income to some extent. The

and personal income tax. The fourth one is black money or precisely unaccounted currency. Unaccounted wealth includes unaccounted currency to a limited level, but essentially consists of other movable and non-movable assets. There are different policy instruments to combat unaccounted currency and unaccounted wealth and demonetisation was never aimed to combat unaccounted wealth.

Only when the unaccounted wealth goes for sale next time, unaccounted currency may surface again or may come out whitewashed. It is a hide and seek game played by people who have accumulated unaccounted currency. Only when the unaccounted currency is captured in one or other way, the linkages between unaccounted currency and unaccounted wealth can be cut, till new unaccounted current is generated from the corrupt sys-

The purchase of gold by currency, the difference between the registered value and the market value of a real estate property, unaccounted donations to educational institutions and bribes and commissions, distribution of currencies to vulnerable sections of the voters to seek votes and hiding the unaccounted currencies by creating unaccounted wealth are some of the factors that contribute to the generation of

Real estate is one sector where unaccounted currency hides behind unaccounted wealth, as the registered values are different from market values. The Residential Property Price Index, which was 165 just before demonetisation, is at 165 in June 2022. The stagnation of the Residential Property Price Index (RPPI) for the last six years cannot be fully attributed to demonetisa-

The anecdotal evidence shows that still unaccounted currency may contribute to about 30 per cent of the total value of a real estate asset, but the control of unaccounted currency stopped the unreasonable price increase of real estate proper-

The above analysis indicates that demonetisation gave a jolt to those who had unaccounted currencies at the time of demonetisation. But the unaccounted currencies will grow again with corruption, bribes and untrue revelation of revenue and profit and will be either kept as 'Store Value' or hide behind unaccounted wealth. This systemic problem cannot be rectified with one demonetiation or demonetisation at regular intervals.

Although India witnessed an exponential rise in using non-currency transactions, first due to demonetisation, then due to the development of various Fintech platforms, including Universal Payment Interface and Covid and people's quick adoption of UPI, the currency in circulation increased from INR 17 lakh crore in 2016 to about INR 33 lakh crore in 2022.

Although the RBI has stopped

printing of Rs 2000 denominations and its circulation is limited to only 13.8 per cent of the total value of currency in circulation, the circulation of Rs 500 is alarming at a level of 73.3 per cent of the total value. The combination of Rs 2000 and Rs 500 constitutes about 87 per cent of the total value of currency in circulation, which is the same as the pre-demonetisation level of Rs

500 and Rs 1000 denominations. It may be argued that the total currency value in circulation has increased only in proportion to the increase of GDP in current value, but that does not hold water, given the huge penetration of digital transactions. Hence, the surmise is that a substantial portion of the currency, especially the Rs 2000 and Rs 500 denominations in circulation, have been kept as 'Stored Value', although there is no data to support this surmise.

If the RBI retains the two high denomination currencies which come to the banks and releases only smaller denominations such as Rs 100 and Rs 50 through their ATMS and counters by printing it on a larger scale, a time will come where banks receive meagre numbers of Rs 2000 and Rs 500 denominations or may stop receiving Rs 2000 and Rs 500 denominations altogether. That is the inflection point to arrive at the estimation of the 'Stored value' of Rs 2000 and Rs 500 denominations in circulation and the right time to devise innovative measures to get hold of 'Stored Value' and crackdown against hoarders. This is the way forward to bring justification to the demonetisation exercise.

linical data management is an important phase of clinical research that collects reliable, highquality, and statistically sound data from clinical trials. It, thus, saves a lot of time in the development and marketing of

Data generated by trials is becoming complicated with time, resulting in overflowing data. Researchers prefer adaptive clinical design over fixed clinical design because of its ability to modify according to the data accumulated by subjects. Oncology drugs and biologics can be developed swiftly through adaptive studies which include basket, umbrella, and platform designs.

Master study protocol uses dynamic and flexible database builds and is used to con-

There is abundant data for the trials, including diverse data sources (e.g., wearable devices or sensors), increased data volume and precision, risk-based quality control techniques, decentralized clinical trials, and adaptive designs.

Clinical trials are focusing more on patient experience and the value they provide, which further complicates the trial. Therefore, it is becoming impossible for clinical data managers to implement and enable old-school, heads-down data cleaning methods.

Clinical data managers can utilise modernised processes and technologies to support their roles and responsibilities, and adapt to the latest domain of data manage-

ment in clinical trials.

Earlier, clinical data management was centralised and collected using paper CRFs. Furthermore, they were translated into the database by manual data entry.

The clinical managers in the pre-CDM era were skilled and could review patient data by conducting cross-from reviews and using SQL queries to get the output and check the validity of the data. The managers could also review listings and by using the knowledge of therapeutic areas and indications, could raise the issue back to the investigation site.

Sponsors are centralising their technology along with centralizing their data management systems. The functional service providers (FSPs) in smaller companies are outsourcing their work to keep everyone on the same level. The right software and partnership with an FSP can produce an efficient and produc-

A good data management system makes an organized and analytics-based approach possible. Data sources such as Electronic Data Capture (EDC), Electronic Clinical Outcome Assessment (eCOA), central laboratory data, and electrocardiograms (ECGs) are used in CDM. In recent years, we have witnessed the use of biosensors, wearable devices, and Electronic Health Records (EHRs). It helps in enabling real-time access to participant statistics.

The current clinical trials are dependent on real-time analytics, modeling, and simulation. This, in turn, reduces the cost and development time and failures in research, and supports data-driven decision-

The traditional methods to acquire and manage clinical trials have not seen much advancement as compared to the technology. Russia says it took Soledar, Ukraine denies its capture

ussia claimed Friday that Riss forces captured a fierce-ly contested salt mining town, in what would mark a rare victory for the Kremlin after a series of setbacks in its invasion of Ukraine Ukrainian authorities said

of Soledar was completed in the evening of Jan. 12," Lt. Gen. Igor Konashenkov, the Russian Defense Ministry's spokesman, said, adding that the develop-

Rifts in Russian military command

The fighting for the salt mining town of Soledar and the nearby city of Bakhmut has highlighted a bitter rift between the Russian Defence Ministry leadership and Yevgeny Prigozhin, a rogue millionaire whose private military force known as the Wagner Group has played an increasingly visible role in

Putin's shakeup of the military brass this week was seen as a bid to show that the Defence Ministry still has his support and is in charge as the troubled conflict nears the 11-month mark.

Prigozhin rushed Wednesday to declare that his mercenary force had captured Soledar, arguing that the prize was won exclusively by Wagner.

The Defence Ministry has challenged that characterisation describing action by airborne troops and other forces in the battle - and on Friday claimed credit for taking the town. A Ukrainian army spokesman denied that, saying fighting in Soledar continued.

The 61-year-old Prigozhin,

who was known as "Putin's chef" for his lucrative catering contracts and was indicted in the U.S. For meddling in the 2016 presidential election, has expanded his assets to include Wagner, as well as mining and other spheres. He has scathingly criticised the military brass for blunders in Ukraine, saying Wagner was more efficient than

regular troops.

He has found a powerful ally in Chechnya's leader Ramzan Kadyrov, who has deployed elite troops from his southern Russian region to fight in Ukraine and also assailed the military leadership and the Kremlin for being too soft and indecisive.

While both have pledged loyalty to Putin, their public attacks on his top generals openly challenged the Kremlin's monopoly on such criticism, something that Russia's tightly controlled political system hadn't seen before. In the reshuffle announced Wednesday, the Defense Ministry said the head of the General Staff, Gen. Valery Gerasimov, was named the new chief of Russian forces in Ukraine, while the former top commander there, Gen. Sergei Surovikin, was demoted to Gerasimov's deputy after only three months on the job.

US launches online system to seek asylum on Mexican border

AP ■ SAN DIEGO (US)

The Biden administration on Thursday launched an online appointment system as the only way for migrants to get exceptions from pandemic-era limits on asylum — the US government's latest major step in eight days to overhaul border enforcement.

US Customs and Border Protection began allowing migrants to make appointments up to two weeks out using its a mobile app that the agency has used in limited ways since 2020.

CBPOne is replacing an opaque, bewildering patchwork of exemptions to a public health order known as Title 42 under which the government has denied migrants' US and international rights to claim asylum since March 2020. Until now, CBP has arranged exemptions through advocates, churches, attorneys and migrant shelters, without publicly identifying them or saying how many slots were available. The advocates have chosen who gets in, with

CBP having final say.
Under the new system, migrants apply directly to the agency and a government official will determine who gets in.

Their appointments will be at one of eight crossings — at Brownsville, El Paso, Hidalgo and Laredo in Texas; Nogales, Arizona; and Calexico and San Diego in California. Exemptions for Title 42 are meant to go to

the most vulnerable migrants.

Thursday's rollout is separate from measures announced last week to expel migrants from Cuba, Haiti, Nicaragua and Venezuela to Mexico under Title 42 and — at the same time — allow up to 30,000 migrants admitted to the United States every month under humanitarian parole for two years if they apply online, pay their airfare and provide a financial sponsor.

While the administration previously signalled that it would introduce CBPOne for people seeking asylum at land border crossings with Mexico, the speed of change caught advocates offguard. "Utter and complete confusion," said Priscilla Orta, an attorney at Lawyers For Good Government's Project Corazon in Texas' Rio Grande Valley.

US officials told advocates on Friday they expected the app to be ready in a month, Orta said. Then on Monday, advocates were informed the rollout had been moved up to this week.

Problems are mounting at hospitals across the nation as they try to deal with widespread staffing shortages, overworked nurses beaten down by the pandemic and a busted pipeline of new nurses. That's led to nurses juggling

dangerously high caseloads, said Michelle Collins, dean at the college of nursing and health at Loyola University New Orleans. 'There's no place that's

immune from what's happening with the nursing shortage, Collins said. "It's everywhere. Union leaders say the tentative contract agreement end-

ing the strike by nurses at Mount

Sinai Hospital and Montefiore

Medical Center, each privately

owned, nonprofit hospitals that hold over 1,000 beds in New York City, will relieve chronic short staffing and boost pay by 19 per cent over three years. The walkout, which ended

Thursday, was just the latest dispute between nurses and their employers. Last year, six unions repre-

senting a total of 32,000 nurses launched strikes outside of hospital systems around the country, according to the Bureau of Labour and Statistics. Those strikes represented about a quarter of all the major strikes in the US last year, an increase from the

Describing hospital environments where nurses are unable to take breaks because they are assigned too many patients - some of whom are pleading for care from frontline workers — the president of the American Nurses Association, Dr Jennifer Mensik Kennedy, said some nurses may think their only option is to strike.

"Nurses don't feel like their

voices have been heard with this

exact topic," she told The Associated Press Wednesday. In California, nurse unions at two hospitals are likely to

strike this year when their contract expires, said former nurse Peter Sidhu, who now works for the state union. Sidhu, who fields objections from nurses across the state who say their caseloads are unsafe, has received 7,000 such complaints in Los Angeles County hospitals since December. He said objections have at least doubled since

before the pandemic began.

Biden, Kishida discuss Japan 'stepping up' security

President Joe Biden and Japanese Prime Minister Fumio Kishida were holding wide-ranging talks at the White House on Friday as Japan looks to build security cooperation with allies in a time of provocative Chinese and North Korean military

The two administrations were also ready to seal an agreement to bolster U.S.-Japanese cooperation on space with a signing ceremony by Secretary of State Antony Blinken and Japanese Foreign Affairs Minister Hayashi

The Oval Office meeting and signing ceremony at NASA's Washington headquarters will cap a weeklong tour for Kishida that took him to five European and North American capitals for talks on his effort to beef up Japan's security.

Biden welcomed Kishida to the White House on Friday morning for the prime min-ister's first visit to Washington since he took office in October 2021. Inside the Oval Office, the U.S. President praised



Japan for its "historic" increase in defense spending and pledged close cooperation on economic and security mat-

"We meet at a remarkable moment," Biden told Kishida, adding later: "The more difficult job is trying to figure out how and where we disagree."

Kishida, speaking through an interpreter, said the two nations "share fundamental values such as democracy and the rule of law" and stressed

that their joint role on the global stage "is becoming even

It all comes as Japan announced plans last month to raise defense spending to 2% of gross domestic product in five years, a dramatic increase in spending for a nation that forged a pacifist approach to its defense after World War II. Japan's defense spending has historically

remained below 1% of GDP. "Japan is stepping up and United States," White House National Security Council spokesman John Kirby said.

Blinken said this week that the U.S.-Japan space cooperation framework was a "decade in the making" and "covers everything from joint research to working together to land the first woman and person of color on the moon."

He added that the U.S. And Japan agree that China is their "greatest shared strategic challenge" and confirmed that an attack in space would trig-ger a mutual defense provision in the U.S.-Japan security

Before Friday's meeting of the two leaders, U.S. And Japanese officials announced an adjustment to the American troop presence on the island of Okinawa in part to enhance anti-ship capabilities that would be needed in the event of a Chinese incursion into Taiwan or other hostile acts in the region. Japan is also reinforcing defenses on its southwestern islands close to Taiwan, including Yonaguni and Ishigaki, where new bases are being constructed.

Sri Lanka announces plans to downsize military by half by 2030 Due to the forex shortage Sri Lanka was unable to afford

Cash-strapped Sri Lanka on Friday announced plans to reduce the current strength of its military to half by 2030 to build a technically and tactically sound and well-balanced defence force, amid criticism that military expenditure was more than the allocation for health care and education in the 2023 budget.

The Army's strength is to be reduced to 100,000 by the year 2030, down from the current figure of 200,783. The strength would be limited to 135,000 by next year, the Defence Ministry said in a statement.

"The overall aim of the strategic blueprint is to broach a technically and tactically sound and well-balanced defence force by the year 2030 in order to meet upcoming security challenges,



the statement quoting the state minister of defence Pramitha

539 billion rupees in the budget 2023 drew criticism as the island nation faced its worst econom-

key imports, including fuel, fertilisers and medicines, leading to serpentine queues. For health and education, the 2023 budget has allocated over 300 billion rupees each. Although the strength had been halved from around 400,000 since the conflict with the Liberation Tigers of Tamil Eelam (LTTE) ended in 2009, the current strength of 200,000 was termed excessive.

President Ranil Wickremesinghe said last year that military strategy reforms were needed to gear the island's army to face new challenges.

The protest outside City Hall on Wednesday drew an angry backlash from Turkey, a NATÓ member which already had held off approving Sweden's application to become part of the Western military alliance until the government in Stockholm satisfies its demands.

The speaker of Turkey's parliament, Mustafa Sentop, cancelled a visit by Andreas Norlen, the speaker of the Swedish Riksdag, that was scheduled for Monday, the reported.

Turkish lawmakers need to ratify Sweden's NATO application for the Nordic nation to become a member. Turkey has made its approval conditional on Stockholm cracking down on Kurdish militants and other groups that Ankara considers a threat to national security.

Migrant entry numbers into Europe hit 6-yr high

AP BRUSSELS

The number of attempts by migrants to enter the European Union without authorisation reached around 330,000 last year, the highest number since 2016, the EU's border and coast guard agency said Friday.

Almost half of the 2022 attempts were made overland through the Western Balkans region, EU agency Frontex said, according to its "preliminary cal-culations." Regardless of entry route, Syrians, Afghans and Tunisians together accounted for roughly 47 per cent of the attempted border crossings. Men accounted for more

than 80 per cent of the attempts to get in, Frontex said. The agency calculates entry attempts rather than the number of people trying to get into Europe because it is often difficult to identify migrants, who routinely travel without passports, and enter multiple times. People arriving at Europe's borders to apply for asylum have a reasonable chance of being allowed in, while those who come without a visa in search of jobs and better lives are mostly turned away.

Well over 1 million people, most of them Syrians fleeing conflict, entered the EU in 2015,

Germany to scrap mask mandate in long-distance transport AP BERLIN

Germany will soon drop a mask mandate on longdistance trains and buses, one of the country's last remaining COVID-19 restrictions, the

health minister said on Friday. The mandate will be dropped on February 2, Health Minister Karl Lauterbach announced in Berlin.

Other European countries already have scrapped mask mandates in public transport, and Lauterbach faced increasing pressure to follow suit in recent

Masks remain mandatory in doctors' practices, while masks and negative tests are still required to enter hospitals and nursing homes. Rules for local transporta-

tion are a matter for Germany's 16 state governments, and an increasing number have dropped or are dropping their mask mandates. Some also have scrapped rules requiring infected people to isolate at home.

The long-distance transportation rules were scheduled to end on April 7, though legis-lation allows for them to be suspended earlier if the situation is better than expected.

After one of Germany's top virologists said shortly after Christmas that the pandemic is long taken a cautious stance faced mounting calls from inside and outside the governing coalition to do away with them.

UFO reports rise to 510

AP WASHINGTON

The US has now collected 510 reports of unidentified flying objects, many of which are flying in sensitive military airspace. While there's no evidence of extraterrestrials, they still pose a threat, the government said in a declassified report summary released Thursday.

Last year the Pentagon opened an office, the Alldomain Anomaly Resolution Office, solely focused on receiving and analyzing all of those reports of unidentified phenomena, many of which have been reported by military pilots. It works with the intelligence agencies to further assess those incidents.

The events "continue to occur in restricted or sensitive airspace, highlighting possible concerns for safety of flight or adversary collection activity," the Office of the Director of National Intelligence said in its

2022 report. The classified version of the report addresses how many of those objects were found near locations where nuclear power plants operate or nuclear weapons are stored.

India's forex reserves drop by USD 1.268 bn to USD 561.583 bn

India's forex reserves declined by USD 1.268 billion to USD 561.583 billion for the week ended January 6, the Reserve Bank said on Friday.

India could prudently sustain

The overall reserves had increased by USD 44 million to USD 562.851 billion in the previous reporting week after two consecutive weeks of the slide.

In October 2021, the country's foreign exchange kitty reached an all-time high of USD 645 billion. The reserves had been declining as the central bank deployed the reserves to defend the rupee amid pressures caused by global devel-

Foreign currency assets (FCA), a major component of the overall reserves, dropped by USD 1.747 billion to USD 496.441 billion during the week



to January 6, according to the Weekly Statistical Supplement released by the RBI.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves increased by USD 461 million to USD 41.784 billion, it said.

The Special Drawing Rights (SDRs) were up by USD 35 million to USD 18.217 billion, the apex bank said.



Sebi mulls allowing private equity funds to become sponsor of mutual fund

apital markets regulator Sebi on Friday proposed allowing Private Equity (PE) funds to sponsor a mutual fund house as they can bring in strategic guidance and talent to fuel growth of the industry.

The proposal comes in the backdrop of IDFC Mutual

Fund getting acquired by a consortium comprising Bandhan Sovereign Wealth Fund GIC and private equity fund ChrysCapital.

Ín its consultation paper, a Sebi-constituted working group proposed alternative set of eligibility criteria to enable private equity funds, who do not qualify based on the current requirement, to act as sponsors of Mutual Funds (MFs) and suggested to further strength-

en the existing eligibility requirements to ensure that only high quality entities qual-

At present, any entity that owns 40 per cent or more stake in a mutual fund is considered as a sponsor and is required to fulfil the eligibility

Securities and Exchange Board of India (Sebi) has sought comments from

Under the alternate eligibility criteria for sponsor of MF, Sebi has proposed that sponsors should adequately capitalise the AMC such that the positive liquid net worth of AMC should be at least Rs 150

The capital contributed to the AMC should be locked-in for a period of 5 years. Further, the minimum sponsor stake of 40 per cent should also be locked in within the same period of five years.

Apart from meeting alternate eligibility routes, the regulator has suggested additional criteria as well as safeguards that would be applicable for PEs to qualify as a mutual fund

Under this, PE or its manager should have a minimum participate as an anchor ving inclusive growth. PE may the capacity of investment manager in the financial sector and should have managed committed capital of at least Rs

It has been suggested that off-market transactions should not be permitted between the schemes of MF and Sponsor

Further, the mutual fund sponsored by the PE should not



an investee company, where any of the schemes/ funds managed by the sponsor PE have an investment of 10 per cent or more, or have a board representation.

"PE with significant capital can invest in technology, bring in strategic guidance and good talent to fuel growth and innovation and expand the presence of mutual funds, including dripetition to the current entities in the Mutual Fund industry and improve value to investors," Sebi noted.

With regard to the role of sponsor after AMC matures, Sebi's Working Group felt that the ideal balance is to not require mandatory reduction in sponsor stake but to let the market dynamics decide the ownership composition.

ovak Djokovic returns to next week's Australian Open as heavy favourite and with his ominous form in stark contrast to the struggles of defending champion Rafael

A year ago Djokovic was consumed by a legal battle over his Covid vaccination stance which he ultimately lost and was deported on the eve of the Grand Slam. It opened the door for great rival Nadal on the Melbourne Park hardcourts, his thrilling five-set win over Daniil Medvedev in the final earning the Spaniard a record 21st major

The 36-year-old made it 22 when he clinched the French Open. Serbia's Djokovic, who is a year younger, can draw level on 22 Grand Slam triumphs if he becomes Australian champion for a record-extending 10th

He brought a practice match against Medvedev to an early conclusion on Wednesday to protect a hamstring niggle, but prior to that called his preparations spot-on.

"I couldn't ask for a better preparation and lead-up to the Australian Open," said Djokovic. "I love playing in Australia. My results are a testament to

Djokovic's recent exploits, coupled with Nadal's iffy form, the absence of injured world number one Carlos Alcaraz and last year's retirement of Roger Federer, undoubtedly make him the man to beat. After ending a



turbulent 2022 by winning the ATP Finals, he came through five tough matches to lift the Adelaide International trophy on

His fears of a hostile reception in Australia after the deportation saga were alleviated by a warm welcome in Adelaide.

Djokovic faces Spain's 75thranked Roberto Carballes Baena in his opening match.

Nadal has been written off

Muguruza has 'bittersweet feelings' at Australian Open

Two-time Grand Slam champion Garbine Muguruza said Friday that she has started from scratch and goes into next ıstralian Open with

feelings" following a year to forget.
The 29-year-old Spaniard won the French Open in 2016, Wimbledon in 2017 and reached the final in Melbourne in 2020, before losing to the American Sofia Kenin. But the former world number one is now 58th in the rankings after a poor season by her high standards which included first-round exits at Roland Garros and Wimbledon, scenes of her biggest triumphs. She has not won a match since September, which at least gave her more time on the practice court.

"I have bittersweet feelings because it is true that I have had a lot of time to prepare and train to start from scratch this season," said the Venezuelan-born Muguruza.

"That's the good thing about tennis, that now in 2023 it's a new season.
