Judiciary, Centre row over Collegium ratchets up

Rijiju shares video of ex HC judge who says SC 'hijacked' Constitution by deciding to appoint judges itself

The ongoing tussle between the judiciary and the Centre escalated further on Sunday with Law Minister Kiren Rijiju virtually endorsing the view of a retired Delhi High Court judge that the Supreme Court has "hijacked" the Constitution by deciding to appoint judges itself.

Rijiju shared the video of

an interview of Justice RS Sodhi (Retd), a former judge of the Delhi High Court, saying it is the "voice of a judge" and that the majority of people have similar "sane views."

In the interview, Justice Sodhi said the right to frame laws lies with Parliament and not with the Supreme Court.

...Only Parliament will amend Constitution. But here I feel the Supreme Court for the first time 'hijacked' the Constitution. After 'hijacking' they (the SC) said that we will appoint (judges) ourselves and the Government will have no role in it," Justice Sodhi said in Hindi. Backing Justice Sodhi's remarks, Rijiju tweeted: "Actually the majority of the people have similar sane views. It's only those people who disregard the provisions of the Constitution and mandate of the people think that they are above the Constitution of



India." In another tweet, the Law Minister said: "Voice of a Judge....Real beauty of Indian Democracy is its success. People rule themselves through their representatives. Elected representatives represent the interests of the people & make laws. Our Judiciary is independent and our Constitution is Supreme.

Incidentally, on December 8, the apex court had objected to adverse comments made against the judiciary by vernment functionaries.

Observing that comments made on the Supreme Court Collegium by Government functionaries are "not well taken", a Bench headed by Justice SK Kaul asked Attorney-General R Venkataramani to advise the Government about it. The court had said the

Collegium system of appointment of judges is the law of the land and comments against it are "not well taken". The apex court also observed that any law declared by it is "binding" on all stakeholders and the Collegium system must be fol-

Rijiju's comments are the latest in an ongoing tussle between the Government and the Supreme Court Collegium over judicial appointments.

Ón January 19, the Supreme Court Collegium asserted its supremacy in appointment of judges and backed its earlier proposal to elevate five advocates to judges of High Courts. The Collegium summarily rejected the inputs provided against them by Intelligence agencies to the Centre

Before that, Vice-President Jagdeep Dhankhar launched a scathing attack on the judiciary on the issue of appointment of judges on January 12.

In an unprecedented attack on the judiciary by a senior constitutional functionary, the Vice- President asked the judges to refrain from "oneupmanship and public posturing" from judicial platforms and also frowned at the power allegedly usurped by the judiciary to review laws passed by

SC orders in mother tongue: Modi lauds CJI

Prime Minister, Narendra Modi on Sunday lauded Chief Justice of India (CJI) Justice DY Chandrachud for thinking about making Supreme Court judgments available in regional languages.

"At a recent function, the Hon'ble Chief Justice of India Justice DY Chandrachud spoke of the need to work towards making SC judgments available in regional languages. He also suggested the use of technology for it. This is a laudatory thought, which will help many people, particularly young-sters", said Modi in a tweet.

The Prime Minister wrote on Twitter and shared on the site the relevant clip of the CJI's speech delivered at an event organized by the Bar Council of Maharashtra and Goa in

Mumbai. Modi further said, "India has several languages, which add to our cultural vibrancy. The Central Government is undertaking numerous efforts to encourage Indian languages including giving the option of studying subjects like engineering and medicine in one's Matru Bhasha." Modi has, for long, been pitching for doing away with several old practices, abolishing obsolete laws, and

underlining the need to

encourage the use of local lan-

guages in courts". He holds the view that since a large section of the country's population "finds it difficult to understand the judicial process and court rulings," local languages should be used in judicial process which will make justice easily accessible to the poor.

Despite twin blasts Gandhi to celebrate R-Day with people at Banihal

A day after twin bomb blasts rocked Jammu, the Congress on Sunday said the 'Bharat Jodo Yatra' will conclude in Srinagar on January 30 as per schedule and there will be no compromise on the security of Raĥul Gandhi.

The party also announced that Rahul Gandhi was likely to celebrate Republic Day with the people of Jammu and Kashmir

(J&K) at Banihal - the gateway town to Kashmir along the Jammu-Srinagar National Highway. After a day's break on Saturday, the yatra resumed from Hiranagar on Sunday and will reach Jammu on Monday. Two back-to-back explo-

sions rocked a busy locality on the outskirts of Jammu on Saturday, leaving nine people injured. Officials said IEDs were used to carry out the explosions in an SUV parked in a repair shop and in a vehicle at a nearby junkyard at the Transport Nagar area of Narwal

"There will be no compromise on the security of Gandhi. His security is our topmost priority and we are following the guidelines of security agencies in totality," Congress chief spokesperson Jairam Ramesh said at a press conference at Chak Nanak in Samba, where

the Yatra will stop at night halt. J&K AICC in-charge Rajni Patil, J&K Congress chief Vikar Rasool Wani and party chief spokesperson Ravinder Sharma also addressed the press conference, asserting that the Yatra will conclude as per schedule.

"Rahul Gandhi is staying back in the Union Territory and is likely to hoist the Tricolour at Banihal along the Jammu-Srinagar National Highway on Republic Day,"

10 killed in California shooting

Lunar New Year revelry mourning; killer on the run

Agunman killed 10 people and wounded 10 others at a Los Angeles-area ballroom dance club following a Lunar New Year celebration, setting off a manhunt for the suspect in the fifth mass killing in the US this month. Capt Andrew Meyer of the Los Angeles Sheriff's Department said on Sunday the wounded were taken to hospitals and their conditions range from stable to critical. He said the 10 people died at the scene in the city of

Monterey Park. Meyer said people were "pouring out of the location screaming" when officers



arrived at around 10:30 PM on Saturday. He said officers then went into the ballroom and found victims as firefighters

treated the wounded. Meyer gave no description of the male suspect or the weapon he used, or why police gave no information on the

shooting for hours while the shooter apparently remained on the run. He also said police were investigating another incident in the nearby city of Alhambra, where a similar business, the Lai Lai Ballroom,

Assam Chief Minister Himanta Biswa Sarma said Bollywood actor Shah Rukh Khan talked to him over the phone early on Sunday and expressed concern over a protest against his new film Pathaan' in the city.

Sarma assured the actor that his Government will enquire about the demonstration against the movie and ensure that "no such unto-ward incidents" would occur again. The development comes a day after the CM had said



'Who is Shahrukh Khan? I don't know anything about him or his film 'Pathaan'," while responding to queries by reporters about the violent protest by Bajrang Dal activists, who held a demonstration in front of a theatre at Narengi in the city on Friday, where the film is slated to be screened.

The far Right-wing group's volunteers tore down the film's posters and burnt them.



"Bollywood actor Shri @iamsrk called me and we talked today morning at 2 AM. He expressed concern about an incident in Guwahati during screening of his film. I assured him that it's the duty of the State Government to maintain law & order. We'll enquire and ensure no such untoward incidents," Sarma said on

Tale of INA's martyrs comes alive

Scholar reveals genocide of 2K POWs by **British soldiers**

The heroic battle of Azad Hind Fauj (also known as the Indian National Army -INA) and its legendary leader, Netaji Subhas Chandra Bose, has been sung many times in history. But, the genocide of nearly 2,300 INA 'prisoners of war' at Nilganj near Barrackpore, West Bengal on the intervening night of the intervening night of September 25/26, 1945 is yet to get due recognition despite the scale of atrocities by the British

Indian army.
Recently, researcher Tamal Sanyal, after a painstaking work of three years, has revealed all



unsung soldiers of INA, who were camped in Bengal, in British captivity and killed in a

Many stories have been written about INA and even some movies have also been made about its revolutionary leaders. But there is a latent chapter in the whole episode, which was hidden from public

gaze, until now. Sanyal's research has sentries. These three camps

operated three Prisoner of War (PoW) camps in undivided Bengal, immediately after the Second World War. The INA

soldiers who were captured from the Indo-Burma border and North Eastern India were ept there. These PoW camps had cages' in them, inside which the INA prisoners were kept under 24X7 watch of armed

were located at Barasat (in North 24 Paraganas of West Bengal), Nilganj (near Barrackpore, West Bengal) and Jhikorgachha (in district Jessore, now in Bangladesh).

Remnants of the Nilganj camp are still found and subsequently a prestigious institute

sequently a prestigious institute of the Central government CRIJAF (Central Research Institute for Jute and Allied Fibres) has come up at that place since 1953, which allegedly could be a cover up of the genocide that took place inside that camp on a night of Sanyal told The Pioneer,

"The PoWs brought here in these camps were subjected to intense interrogation first, to segregate them on the basis of their loyalty to the cause of Indian independence. 'Colour coding' of the PoWs was done to mark them from the most to

As of now the NIA team is assisting the Jammu and Kashmir police in detailed investigations in the case. The case is yet to be handed over

Talking to reporters in Rohtak, Hooda said Singh has unnecessarily dragged his name along with that of his MP-son Deepender Singh Hooda in the matter.

He said he is contemplating to file a defamation case against the WFI chairman. Earlier speaking to a TV

channel, the WFI head had said, "The protesting players have become a toy in the hands of the Congress and Deepender Hooda. This type of conspiracy was hatched against me by the Congress almost three decades ago. Once again the

conspiracy has been done. "I had earlier said that there was a conspiracy, and big powers are behind it. Now these forces are coming out in the open," he had said.

"The INA soldiers most loyal to Netaji and the cause of Indian independence were marked as 'Black and had to bear most of the tortures at the hands of the British Army, while the lesser ones were coded "Grey" (somewhat loyal) and "White" (faintly loyal).

A planned massacre took place on the intervening night of September 25 and 26, 1945, at the Nilganj camp. The PoWs were taken to a pond called 'Moslem Pukur' (Muslim Pond), situated outside the

boundary of the campus. While walking, they sang songs in praise of Mother India and Netaji. At night, the villagers heard gunshots which rang through the air, for the whole night. On daybreak, they rushed to the camp to find the reasons behind the gunshots. They discovered piles of dead bodies of INA soldiers were being transported in military trucks. The bodies were reportedly thrown into the 'Lavanyavati River' (now called

Nowai canal, just adjacent to

the camp) and river Ganges.

Some bodies were reportedly buried inside the campus. All the bodies were disposed of in a single day.

Searching for the records of that incident, which was just a hearsay till now, Sanyal stumbled upon one Court of Inquiry Report by a British Army Major General Stuart. He confirmed that such an incident took place on the same night, as claimed by the locals. He said in his report that 26/5 Madras Regiment was stationed to guard the Nilganj camp and was commanded by Lt. Col.

Vaughan, who was away at the Regimental Centre. The camp was commanded by Major Nambiar and the company responsible for the shootout was commanded by Capt ERR Menon. At about 10 PM at night, he ordered the inhabitants of cages to fall in for a sudden roll call, which they refused to oblige.

According to the Court of

Inquiry report, he was abused in Tamil. Then he came out of the cage and sounded the alarm at Quarter Guard to alert his company, which came out of

the barracks. Then Capt Menon entered the cage again, this time with a loaded Tommy Gun. Behind him, entered his company. It is recorded that as per the statement of Capt Menon, he saw a bamboo being whirled in air and a brick was thrown at him, after exchange of some abuses inside the cage. Then someone from his company, which was behind him, shouted "our company commander is finished". Then the firing started. While Capt Menon said he had not ordered any firing, the company per-

sonnel said that they fired upon orders of Menon.

The British Army claimed that only five persons were killed in the incident and nine injured. But according to Sanyal, the Major General said in the report that it cannot be surely said how many rounds were fired, but empty cases of 103 rounds of .303 rifle were fired and the Kote commander was still short of empty cases of 116 rounds. 8 rounds of Tommy gun were also fired. It is obvious that only five people will not be killed if 219

rounds of bullets are fired inside a closed cage/camp. No mention about the disposal of bodies was mentioned in the

The legendary Col. GS Dhillon of Azad Hind Fauj, who was tried at the Red Fort, wrote in his diary that 2,300 personnel of Azad Hind Faui were slaughtered in cold blood on that night, by Capt Menon of the British Army. Strangely, he named Captain Menon correctly in his diary, although he was not incarcerated in that camp or could not have known

This incident was long

buried in history . Sanyal claims he is the first person to access most of the old official British Army documents on this inci-Sanyal said he is also writ-

The database also shows that 2022 was also one of the worst years ever in terms of mass killings, with 42 such attacks - the second-highest number since the creation of the tracker in 2006. The database defines a mass killing as four people killed not including the perpetrator.

The latest violence comes two months after five people were killed at a Colorado Springs nightclub.

The White House said that President Joe Biden was briefed on the situation by Homeland Security Adviser Elizabeth Sherwood-Randall.

"The President has been briefed by the Homeland Security Advisor on the mass shooting in Monterey Park. He directed her to make sure that the FBI is providing full support to local authorities, and to update him regularly today as more details are known."

Attorney General Merrick Garland was also briefed, Justice Department spokesperson Dena Iverson said.

The shooting occurred at Star Ballroom Dance Studio, a few blocks from city hall on Monterey Park's main thoroughfare of Garvey Avenue, which is dotted with strip malls full of small businesses whose signs are in both English and Chinese. Cantonese and Mandarin are both widely spoken, Chinese holidays are celebrated, and Chinese films are screened

regularly in the city.

Want city Govt schools to be world's best, says Kejriwal

Amid tussle with the Lt Governor Vinai Kumar Saxena over a training visit to Finland by government school teachers, Delhi Chief Minister Arvind Kejriwal on Sunday said he wants the city's government schools the best in the world so that students from abroad should come here for education. He said that he will keep sending them abroad and they have the support of the people of Delhi and the country.

Kejriwal held an interaction with government school teachers who participated in the training programme in Finland, Cambridge and Singapore. Deput Chief Minister Manish Sisodia and MLA Atishi were also present.

During the event, while taking a tacit jibe at the Centre, the Chief Minister also said that "there is no better investment" than training of teachers after the LG sought a "cost-benefit analysis" of teachers training in Finland - a proposal which has

They are to groom the students---- who would build roads and bridges in the future," he said. Lamenting that some people are trying to defame

them as they are in the habit of pulling down those who want to do good work.

"We have been able to send you (teachers) to foreign countries. I have been the Chief Minister for eight years. But I have gone abroad just twice - once I went to Rome when Mother Teresa died, and second to South Korea," he stressed in his address.

"My motive is to send teachers to other countries. I visit foreign countries on monthly basis. We want you to gain global experience. Our government schools have to be better than international schools... not just the private schools," Kejriwal said, adding that "the government aims to imbibe best practices".

"Even our critics agree that the Delhi government schools have seen a lot more improvement over the years. That's not because of us; it's because of the

"Earlier, they used to ask what is the whole point of sending government principals and teachers for training abroad. We broke that barrier by providing them with the best training in the world. Delhi government schools should not just compete with schools of few counties but the whole world," CM Kejriwal asserted. "I am ready to give Manish Sisodia as a loan to other States' parties if they want to improve their schools,

Charges baseless, politically motivated, says Gupta

Gupta, however, termed the allegations "false and politically motivated". Reacting to the allegations, Gupta said he will file a defamation case against Saurabh Bhardwai. "They have a history of making false allegations and then



rendering apology to BJP after defamation cases later on," he

The AAP's chief spokesperson and MLA Saurabh Bhardwaj said the Lokayukta is conducting a probe into the allegation of disproportionate assets against Gupta.
"Despite the Lokayukta

issuing notices multiple times, Adesh Gupta did not declare his source of income. The company promoted by the sons of Gupta and Jaju is under scanner for allegedly using it as a vehicle to aid financial wrongdoings," he claimed dur-

ing a press conference.

Bhardwaj claimed that a complaint with the Lokayukta has claimed that Gupta got the



company incorporated while he was the North Delhi MCD mayor and his earnings are disproportionate to his declared sources of income.

AAP leader said that according to the report of Assistant Director Investigation, transactions worth crores have been found in the company held by sons of Gupta and Shayam Jaju. The Lt Governor should also write a letter to the Anti Corruption Branch and CBI about how these properties were bought and sold. The Centre should take up a detailed investigation of the case to prove whether it believes in the principle of 'no corruption' or not," Bharadwaj

He said, "These transactions include but are not limited to - the purchase of a prop-erty in 33/18 West Patel Nagar by Yash Gupta, Rajat Gupta and Anuradha Gupta - the sons and wife of Gupta. Court dismisses accident claim plea, calls cop 'ignorant of basic law'

city court dismissed a Amotor accident claim petition and called the police officers who filed the case "ignorant of basic law" for filing an FIR against a fire tender driver at the complaint of an illegal hawker.

It observed that registering an FIR against an official — in this case, the fire tender driver going on an emergency reflected the "inefficiency of the system" where senior officers, such as the Station House Officer (SHO) and Assistant Commissioner of Police(ACP), appeared "ignorant of basic

The motor accident claims tribunal was hearing the plea of Arun Kumar, a fruit vendor, who in his complaint claimed he sustained injuries at Matia Mahal Chowk in Central Delhi, when a fire tender, being driven in a rash and negligent manner, hit a cart, which in turn hit his leg on December

"I hereby hold that the petitioner Arun Kumar is not entitled to any compensation. The Detailed Accident Report

(DAR) which was registered as a claim petition is hereby dismissed," Presiding Officer Kamini Lau said in a recent

The court said that Kumar was not a licensed hawker and was squatting in the area by illegally putting his cart. As he was causing obstructions to the public way because of illegal hawking, the risks necessarily followed, the court said.

On the other hand, Constable Somander, the driver of the fire tender posted at Jama Masjid fire station, had complete immunity from being

prosecuted as he was discharging his official functions, being on emergency duty, the court said. "The manner in which the FIR has been registered against the respondent no. 1 (Somander) a public servant on official emergency duty (going to attend a call) and in favour of a wrongdoer, speak volumes about the inefficiency of the system where even the senior officers of the rank of SHO and ACP appear to be ignorant of basic law," the court

It said the Investigating Officer (IO) of Chandni Mahal Police Station had "seriously erred" in booking the vehicle and its driver. It is settled law that there is a yielding right of way for emergency vehicles and when such a vehicle approaches, it is to be given a free passage, the court said.

It said the hawker, who was seeking compensation, was himself found to be plying his trade in contravention of not only the Indian Penal Code, but also the Delhi Municipal Corporation Act. With these observations, the court denied the sanction to prosecute Somander, ordered by a magisterial court in September

The court also said the manner in which Somander was dragged in the case could "demoralise" other officials of the fire department. It said the directions for registration of an FIR against the public officer engaged in discharge of official duty and protected by sovereign immunity was "per se illegal" and had caused him

"immense harassment." "Securing monetary benefit by those who do not respect and follow existing law has become a trend and cannot be encouraged. "There can be no monetary compensation for those who violate the law and constitutional as well as legal rights of others," the court said.

It said the "conscience of the nation" would be shaken if wrongdoers, specifically those who faked a claim by wrongly booking a public servant, were rewarded through a monetary

benefit. The court also observed that the fire department is protected by sovereign immunity and cannot be sued for decisions during a fire emergency.
"Emergency vehicles are protected from lawsuits in

cases of accidents that happen en -route to a fire and fire tenders do not have to follow the standard traffic law during an emergency," the court said. Emergency vehicles have

right of way and if you see flashing lights, safely move towards the left side of the road or move out of the lane (and if)the fire tender is moving; slow down, pull over and stay out of the way till the emergency vehicle passes," the court


R-Day: 'Ops Alert' along Indo-Pak border

Modi Govt burying country's generations in debt: Cong

'Debt per Indian increased from ₹43K to ₹109K since 2014'

The Congress on Sunday alleged that the Modi Government is burying the country's future generations in debt as per capita debt has multiplied during the last years.

Congress spokesperson Gaurav Vallabh on Sunday said debt per Indian increased from ₹43,124 to ₹109,373 since 2014.

"The total outstanding debt of the Government of India, which was 55.87 Lakh Crores as on March 31, 2014, would be estimated to go up to ₹155.31 Lakh Crores by March 31, 2023. By the end of the financial year 2023, each Indian will owe ₹109,373/- a loan they have never taken. From 1947 till March 31, 2014, debt per Indian was ₹43,124. But in the last nine years, debt per Indian has become 2.53 times what it was in 2014. In absolute terms, debt per Indian increased by ₹66,249 in the lastnine years, Vallabh said at the Press conference.

He mentioned, as per IMF, for 2022, India debt to GDP was 83%, far above our peers, emerging market and developing economies (EMDEs), which have average Debt of 64.5%.

"As per Oxfam report, the wealthiest 5% in India now own more than 60% of the country's



total wealth, while the bottom half of the pop ulation (50%) together share just 3% of the wealth. On the other side, 64% of the total ₹14.83 lakh crore in Goods and Services Tax (GST) came from the bottom 50% of the population, with only 3% of GST coming from the top 10%, Vallabh who is Professor in economics said.

"So, the borrowing is just helping in the Kshaped recovery, with some sectors doing well but not others. The pandemic hit the middleand low-income groups and small and medium industries harder. As a result, growth in consumption (PFCE*) fell from 25.9% in Q1 of FY23 to 9.7% in Q2," Vallabh added.

The National Investigation Agency (NIA) has filed a charge sheet against two accused in a case related to funding to the banned CPI (Maoist) and the revival of the Magadh Zone.

The NIA said the charge sheet was filed before the NIA Special Court, Ranchi, Jharkhand on Friday.

The case relates to a conspiracy hatched by the mem-

bers of CPI (Maoist) for its revival in the Magadh Zone and to raise funds for the orga-

'During investigations, it has been established that huge funds were extorted from contractors and were routed through various channels," the NIA said in a statement.

The case was suo-moto registered by the NIA on December 30, 2021.

Investigations revealed that a prominent Communist Party of India (Maoist) cadre Pradyuman Sharma, alongwith FIR named accused Abhinav alias Gaurav Kumar and others were conspiring to revive the CPI (Maoist) organization in the Magadh Zone.

'In furtherance of this sinister motive, they conspired to raise funds for procurement of arms and ammunition and imparting training to Maoist cadres in the fabrication of Improvised Explosive Devices (IEDs) and to liaise with incarcerated Naxals and Over Ground Workers (OGWs) in various jails for the commission of terrorist acts and activities," the agency added.

Accused Pradyuman Sharma and son Tarun Kumar, both residents of village Rustampur under Hulasganj police station in Jehanabad district of Bihar have been charged under various sections of the Indian Penal Code (IPC) and Unlawful Activities (Prevention) Act

'Work for affordable therapeutics for genetic disorders'

With over 95 per cent of patients suffering from inherited rare diseases having no treatment options or those available being unaffordable to many, the Indian Council of Medical Research (ICMR) has sought proposal from interested scientists to work towards affordable therapeutics for genetic rare disorders.

Inherited rare diseases are infrequently occurring disorders and have been defined by countries in terms of prevalence in their own population. As per the World Health Organisation (WHO), rare diseases are often debilitating lifelong disorders with a preva-

Only 5% of inherited rare disorders have treatment among which most of the treatments are highly priced and often not available worldwide. Availability and access to medicines are important to reduce morbidity and mortality associated with rare diseases.

"Therefore, there is a need for research and development in intervention, technology transfer and indigenously manufactured therapeutics for rare diseases which could be achieved by collaborative efforts," said an official from the ICMR giving reason for seeking such proposals.
"Also, the goal for seeking

proposal is to support research and development research proposals towards developing

intervention strategies on various aspects of inherited rare diseases including discovery of newer therapeutic agents and approaches, development of therapeutics including repurpose drugs, biologics, genetic error corrective measures and management to improve quality of life of patients with rare diseases such as orthopedic/ surgical approaches, innovative management protocols etc," he

The ICMR has sought intervention for diseases like storage disorders, small molecule inborn errors of metabolism, primary immunodeficiency disorders (PID), neuromuscular disorders (NMD), hematological disorders (excluding Sickle cell diseases

Approaches may include development of resources such as cellular and animal models, vector for genetic error corrective measures, and mechanistic aspects that are required for drug development as a part of the project, explained the

To save the lives of the patients suffering from rare diseases, the Government in March, 2021 formulated the National Policy for Rare Diseases As per the amendment to this policy in May 2022, all groups of rare disease patients were assured financial assistance of ?50 lakh for treat-

However, accessibility and availability of medicine continue to plague the sector.

Researchers suggest link between dietary exposure to nitrites, risk of type 2 diabetes

 $F^{\rm ood}$ additives used to maintain flavour or enhance taste, appearance, or other sensory properties, are associated with an increased risk of type 2 diabetes, according to a

The study, which is published in the journal PLOS Medicine, says that nitrites and nitrates are chemical compounds used as food additives to increase shelf life. However, researchers suggest a link between dietary exposure to nitrites

and the risk of type 2 diabetes.
To investigate the relationship between dietary exposure to nitrites/nitrates type 2 diabetes risk, researchers accessed data collected from 1,04,168 participants in the prospective cohort NutriNetSante. The researchers analyzed self-reported diet information with health outcomes using detailed nitrite/nitrate exposure derived from multiple databases and

Individuals with the highest intakes of nitrites from food additives (top third) had a 53% higher risk of developing type 2 diabetes during a median follow-up of 7 years compared to those with the lowest intake of this food additive after controlling for intake of sugars, red and processed meats, heme iron, salt, and saturated fatty acids. Consumption of nitrates from food additives was not associated with risk of type 2 diabetes.

The researchers discovered that participants in the NutriNet-Sante cohort who reported a higher intake of nitrites overall, and specifically from food additives and non-additive sources, had a higher risk of developing type 2 diabetes. "This is the first large-scale cohort study to suggest a direct association between additives-originated nitrites and type-2 diabetes risk. It also corroborates previously suggested associations between total dietary nitrites and T2D risk," said the study authors.

The cohort included a greater number of younger individuals, more often women, who exhibited healthier behavior. "These results provide a new piece of evidence in the context of current discussions regarding the need for a reduction of nitrite additives' use in processed meats by the food industry, and could support the need for better regulation of soil contamination by fertilizers," the authors added.

NDRF to station permanent teams in hills for high-altitude rescue operations

The National Disaster **▲** Response Force (NDRF) is mulling to permanently station specialised mountaineering teams in the higher reaches of the Himalayas so that they are ready and acclimatised to launch swift rescue operations during snow avalanches, land slides and glacial lake outburst floods among others, officials

The federal contingency force has initiated a slew of measures to prepare its saviours for tackling natural and manmade catastrophes in these fragile mountain ranges on India's north which, according to experts, may see a rise in accidents due to a variety of reasons, including climate change and human develop-

The force, that draws its complete manpower on deputation from paramilitary forces proposes to keep multiple small

teams of four-five mountaineering trained personnel at the border posts of various Central Armed Police Forces (CAPFs) like the ITBP.



Respect judiciary

If the Government wants BBC to respect our Supreme Court, it should also do the same

aw Minister Kiren Rijiju now talks about the authority of the Supreme Court. Calling the British Broadcasting Corporation's (BBC's) two-part documentary on Prime Minister Narendra Modi, 'India: The Modi Question,' Rijiju tweeted on Saturday, "Some people in India still haven't gotten over the colonial intoxication. They consider the BBC above the Supreme Court of India and lower the country's dignity and image to any extent to please their moral masters." Earlier, the Ministry of External Affairs had slammed the documentary, which made uncharitable remarks about the Prime Minister. MEA spokesperson Arindam Bagchi called it a "propaganda piece." Later, more than 300 eminent citizens, including retired judges, bureaucrats, armed



forces veterans, and senior cops, condemned the BBC documentary. Rijiju has a point: Modi was cleared of all charges of involvement in the 2002 riots by all courts, so blaming him again for the riots is tantamount to questioning the impartiality and wisdom of the highest court of the land. Further, Modi was cleared of the charges way back in 2012. At that time, not only he or the Bharatiya Janata Party was not in power at the Centre but the Congress-led United Progressive Alliance in New Delhi was also hostile to him. In such a milieu, it was extremely difficult for him or anyone else to get a favourable verdict. And yet, the BBC documentary hauls him over the coals for the riots in which around a thousand people died.

But there is also a ring of irony surrounding Rijiju's remarks: he is leaning on an institution that he and other Government partisans have been badgering for months. The Government wants to have a say in the appointment of judges, for which it had devised the National Judicial Appointment Commission (NJAC). The judiciary, favouring the current collegium system, invalidated the NJAC in 2015. The Government didn't like that; its impatience reached a crescendo, with Vice-President Jagdeep Dhankhar recently not just asserting parliamentary sovereignty but also questioning the validity of the basic structure doctrine. This was unprecedented, for nobody ever questioned it. This was not surprising, because changing the basic structure of the Constitution would entail changing the ideas and principles as mentioned in the Preamble. The towering BJP leader and former prime minister LK Advani has upheld the doctrine. Even the Congress finds it inviolable. And now the judiciary, having decided to take on the Government over the issue of collegium, has come out fully in support of the doctrine. Chief Justice of India DY Chandrachud praised the basic structure doctrine on Friday. He said, "The basic structure of our Constitution, like the north star, guides and gives certain direction to the interpreters and implementers of the Constitution when the path ahead is convoluted." If Rijiju wants the BBC to respect our Supreme Court, he should also do the same.

Jumping the gun

Some governors play to the tune of their political

he type of treatment which a government gives to its intellectuals, to its most talented people, is a good index of the government's own caliber," Nani A Palkhivala, the legendary Constitutional expert, had written in an essay. Palkhivala had referred to emperors and kings of yore who used to travel hundreds of miles to sit at the feet of rishis and monks, the then intellectuals to seek their counsel on issues of governance. "But the modern-day intellectuals are those who know which side of the bread is buttered," the legal wizard had said. There are persons who work sincerely to resolve burning issues faced by the country. Some among them reach the pinnacle of glory as the Government of the day appoints them to Constitutional positions. Persons like R N Ravi and Arif Mohammed Khan, the governors of Tamil Nadu and Kerala belong to this genre. The only 'blot' on them is that



they were appointed by the BJP-led Government at the Centre. These two gentlemen are resisting the move by the State governments in committing constitutional impropriety. While the DMK, which had supported the National Eligibility Entrance Test (NEET) for selecting students for medical schools till 2014 (while they were in power at the Centre as part of the UPA), they made a volte-face and demanded that Tamil Nadu be freed from the shackles of NEET. The DMK leaders failed to see that the all-India examination and rank list would rob them of the moolah as most medical colleges in the State were owned by them. The kind of language used by the

Dravidian leaders to defame the Governor was reprehensible. As an IPS officer, Ravi had commanded all round respect and he reached Raj Bhavan only because of his spotless service to the nation. T P Senkumar, who retired from IPS in 2017 had mentioned in his memoirs that he badly wanted to work

under Ravi, a Kerala cadre IPS officer. Khan questioned the CPI(M) move to appoint party members and their relations as vice chancellors and faculty members. He stands vindicated as the Supreme Court itself ordered the dismissal of the vice chancellor appointed by the CPI (M) government. Well, there are BJP leaders like Sreedharan Pillai, the Goa Governor, who refuse to come out of their saffron costumes. Time we learned to separate the wheat from the chaff. Persons like Ravi and Khan are national assets.

Jacinda Ardern is a true Gandhian



Jacinda Ardern New Zealand's outgoing PM stands tall among the leaders of her ilk who stood for human values & renounced power voluntarily

n a world full of unhinged politicians, reckless ambitions, and amoral shortsightedness, New Zealand's Jacinda Ardern stood out like a colossus. For a distant and tiny country with relatively low impact - Jacinda Ardern had become a global byword for 'empathy' and radiant sincerity in leadership. Only she could have sought a legacy, "as someone who always tried to be kind". It wasn't easy to be always so, especially as the nation of 5 million was struck by its worst-ever terror attack (Christchurch in 2019, which killed 51), deadly natural disaster (volcanic eruption on White Island, killing 20), and of course the crippling Covid pandemic, back-to-back. It was Jacinda's acute sense of solidarity personified by her famous 'they are us' in a different scarf, which exemplified and differentiated her dignified humanity from the thundering, divisive, and vainglorious world of 'strongmen' across global capitals. A rare Gandhian of her time – even as the Mahatma is sought to be diminished and politically out-offavor, even in his own homeland. Jacinda had once confessed,

'I had first heard of the Mahatma when I was a schoolgirl" and added, "Gandhi himself understood the inner truths of all faiths of dignity and humanity that bind all people and all religion. Like Gandhi, we should not be afraid to stand up and transform our society for the better". Like the Mahatma and his intrinsic belief in non-violence, honesty, and inclusivity - Jacinda had posited her own empathetic style of leadership not as a measure of weakness, but as tremendous strength. Clearly, ahead of her times and often accused of 'woke' sensibilities, Jacinda had reneged on her Mormon upbringing on account of its regressive stance on homosexuality, she like Gandhi, always put humanity over puritanical religiosity.

Even on the now increasingly dissed issue of political dissent, she invoked Gandhi on non-violent opposition, "It is critical to resolving tensions in a peacerui manner. I believe that Gandhi's age of 42! But that's exactly

before". For one who is arguably amongst the most progressive leaders of the twenty-first Mahatma's teachings are not irrelevant or signs of enfeeble-ment as she noted, "We look forward to Gandhi's principles to address the pressing problems. There are three aspects of Gandhi's message that carry particular weight: tolerance, equality, and sanctity of nonviolence and peace". Like Gandhi, she shunned tags of extraordinariness like 'super woman' and infallibility - she did infamously fall victim to a hot microphone when was picked up calling the opposition leader, "such an arrogant prick"! Ardern had apologized, as she should have.

Today, the refreshing note of integrity and honesty in leaving the highest office of her land owing to what she calls "nothing left in the tank" is in stark contrast to leaders who peddle everything in their wares to retain their positions. It is true that her personal and political brand was fading and with the looming elections, she was not guaranteed success - yet she had time on her side and no pressures to throw in the towel immediately, and certainly not at the

Review had identified as the 'authentic, empathetic and bold' style of Jacinda's leadership. Perhaps this authenticity is borne out of her Gandhian beliefs, as she invoked the Mahatma's timeless values by insisting, "these are values that we should always keep in the forefronts of our minds not just in good times but especially when faced with difficult choices". Jacinda faced her own difficult choices and the truth about her incapability to lead any further with her mantra, 'you can be your own kind of leader - one who knows when it's time to go, and she ultimately left with minimum fuss or fanfare.

naturally courted. While kindness as a state policy was her leitmotif, her political honesty disallowed reckless populism that is thriving in the post-truth era of today – she perhaps paid a price for that too, as it invariably happens in participative democracies.

Politics in democracies do not have to reflect majorities, it can also create them - politicians can if they wish to construct majorities out of vivid diversity by embracing even those that they usually choose not to include, within. Earlier Mahatma Gandhi taught us that one could be morally strong and kind simultaneously, today a young Jacinda Ardern reconfirms the relevance and necessity to 'Be Strong, Be Kind'. Óddly enough, even in her unprompted exit, she has defied many stereotypes and enhanced her respectful politics and personal brand of liberal and ultra-democratic leadership, to aspirational levels. As Mahatma Gandhi profoundly said, 'In a gentle way, you can shake the world, Jacinda Ardern certainly did, even in her exit.

SUNAK FINED

Sir — As per the report United Kingdom Prime Minister Rishi Sunak, who has been tasked with solving the economic crisis of the country, ended up on the wrong side of the law when a fine was imposed on him during the filming of his social media campaign video. UK PM Rishi Sunk was traveling in the back of a sedan car when he was fined by the Lancashire Police on Friday. The UK police fined their prime minister for not wearing a seat-belt in a moving car while filming a social media video. The Lancashire Police fined a 42year-old man for not wearing a seatbelt as he sat on the passenger seat of a moving car. It was later revealed that the man was none other than their own prime minister. In a statement, the police said, "Following the circulation of a video on social media showing an individual failing to wear a seat belt while a passenger in a moving car in Lancashire we have today (Friday, January 20) issued a 42year-old man from London with a conditional offer of a fixed penalty.

"Lancashire Police, which had been 'looking into" the matter, confirmed it had issued a fixed penalty notice to Sunak, which involves a 100-pound fine for not wearing a seatbelt in a moving car. As per the rules, the UK PM has 28 days to pay off the fine. Rishi Sunak later acknowledged his mistake and issued an apology for the brief "error of judgment" where he removed his seatbelt to film his social media campaign video. UK PM Rishi Sunak's spokesperson said, "That was a brief error of judgment. The PM removed his seatbelt to film a small clip. He fully accepts this was a mistake and apologizes for it. The prime minister believes that everyone should wear a seatbelt."It is likely that Rishi Sunak was fined 100 pounds for not wearing a seatbelt, while the fine can have an increased value if the matter is taken to court. Exemptions include having a doctor's certificate for a medical reason or being in a vehicle used for police, fire, or other rescue ser-

FIRST COLUMN FREEBIES MUST BE **AVOIDED**

States can't pile up debt to fund extravaganza of politicians

The newly-elected Himachal Pradesh government has reinstated the 'Old Pension Scheme' (OPS) in its first cabinet meeting. Other states ruled by opposition parties have already announced switching back to OPS. These decisions have initiated a fresh round of discussion around freebies and fiscal prudence. Before going to the financial and other aspects of reverting back to OPS, it is necessary to understand the basic differences between these two schemes. In layman terms, under OPS a retiring employee was eligible to get a monthly pension of almost 50 per cent of his last drawn salary. Subsequent increments based on dearness allowance hike and pay commission revision was also included in the pension.

Under the new pension scheme (NPS), monthly contributions from both employees and government goes to a fund managed by PFRDA and the returns on this fund are market-linked. At the time of retirement, the employee can withdraw up-to 60 per cent of his corpus and he has to buy an annuity plan from the remaining amount. A monthly pension shall be paid out of the annuity.



In technical terms, OPS is a defined benefit scheme in which the liability of the employer (i.e., government) can go to any extent while NPS is a defined contribution scheme in which the employer is liable to the extent of its contribution. Another key difference between these two schemes is around funding. Matching a future liability with corresponding funding is basic economics and OPS failed on this parameter. While NPS corpus ensures that the future pension is going to be paid out of a dedicated fund created for it, OPS had no specific funding and the yearly outlay was out of budgetary resources. OPS was not only a drain on the government's resources, it was unfair to the taxpayers also because the current generation had to fund the ever-increasing pension bill.

As per RBI data, the pension bill of state governments has increased from Rs. 3,131 crores in 1990-91 to Rs. 406,867 crores in 2021-22 (BE). Pension liability has increased by 130 times over this period but there is no commensurate increase in revenue of the states to fund the bill. All of the states which have gone back to OPS are already facing revenue deficit and their fiscal position doesn't allow them to go for such misadventures. Share of revenue expenditure has been increasing consistently over the years (71 per cent in 1984-85 to 79 per cent in 2018-19, pre-covid era), leaving lesser resources for asset/capacity creation

NPS was implemented in 2004 and there was a consensus around this policy shift. All the state governments except West Bengal adopted this scheme over the period and breaking this consensus for petty political gains is not in public interest. A small section of society working in government sector will benefit out of this decision but the costs are going to be very huge because spending signi?cant portion of the state's budget on pension will compel the government to curtail its outlays on general welfare as a whole. Former Planning Commission deputy chairman Montek Singh Ahluwalia also confessed that reverting to OPS is unwise and suicidal. There can be deliberations around bringing changes in the NPS scheme like introducing new products which have guaranteed return features but outrightly taking a U-turn on the pension reforms for immediate political mileage should be stopped.

If a state wants to implement OPS, then the Cabinet should also consider the present value of pension liability determined by actuaries and the funding status. In case there is an unfunded liability, then the Cabinet should also announce how it is going to meet it. States can't be piling up their debt to fund the extravaganza of politicians. If the opposition is adamant on taking the poison pill, then Centre should consider amending the FRBM Act to include the unfunded pension liability of states due to reintroduction of OPS within the ambit of general government debt. The Indian hospitality market, including domestic, inbound and outbound, was estimated at \$32 billion in FY20 and is expected to reach \$52 billion by FY27, driven by the surging demand from travelers and sustained efforts of travel agents to boost the market. During 2019, foreign tourist arrivals (FTAs) in India stood at 10.93 million, achieving a growth rate of 3.5 per cent year on year basis. In 2020, FTAs decreased by 75.5 per cent YoY to 2.68 million and arrivals through e-Tourist Visa (Jan-Nov) decreased by 67.2 per cent YoY to 0.84 million. As of March 2021, the e-Tourist Visa facility was extended to citizens of 171 countries.

In April 2021, the percentage share of FTAs was highest from USA (26.85 per cent), followed by Bangladesh (15.65 per cent), Afghanistan (6.92 per cent), UK (5.87 per cent), Nepal (4.59 per cent), Canada (4.27 per cent), Iraq (2.99 per cent), Portugal (2.40 per cent), Germany (1.42 per cent), Russian Fed (1.41 per cent), Maldives (1.39 per cent), France (1.33 per cent), Sudan (1.21 per cent), Korea (Rep.) (1.18 per cent), and Australia (1.02 per cent).

Digital literacy in Rajasthan bridges gender gaps

The interventions by both the government and non-government organisations have contributed towards addressing this gap

nformation, communication, and technology play **▲**crucial roles in the overall development of young girls and women. Yet, the gender gap in the field of ICT is vast.

In states like Rajasthan where discrimination against women and girls is highly prevalent, efforts to bridge this gap through digital literacy is proving to be a game changer. The interventions designed and being implemented by both the government and non-government organisations have contributed immensely towards addressing this gap, especially in rural regions of the country.

Twenty-one-year-old Deepika Soni, a resident of Lohakhan Basti in Ajmer, Rajasthan, is one such example of how access to digital litNEERAJ GURJAR

eracy can alter the route of development for adolescent girls from underserved communities. Deepika was a student at one of the Sakhi Centres (Tech Centres) run by Mahila Jan Adhikar Samiti (MJAS), a non-government organization based in Ajmer. Today, she has become a digital educator at the same center. She also completed the Rajasthan State Certificate of Information Technology (RSCIT) programme conducted by the Government of Rajasthan.

Through its targeted initiatives such as Digital Kishori Bane Saksham – Computer Learning Programme, Grassroots Journalism, and Each One Teach Ten – Mobile Learning, MJAS has been able

2000 adolescent girls from rural areas of this district.

Explaining the interventions, Mery Sadumha and Kamini Kumari, two young trainers at the centre, said that the courses are based on the feminist approach to technical learning, in which the girls not only acquire technical knowledge but also learn about their rights and decision-making. This empowers them not only socially but also financially. "Girls from different villages and settlements of the district are learning these courses. They come from different castes and communities," informed the duo.

Nineteen-year-old Maya Gurjar of Padampura village, currently working as the incharge of MJAS's Sakhi cenexpressed: "In 2021, I received a smartphone for a journalism course by the organization. This was the first time I had touched and operated a phone so closely. At that time, I felt as if I had entered a new world," shared Maya with a twinkle in her eyes, adding, "At present, I am fully aware of all the features of Android mobiles and consider myself digitally educated. I don't depend on anyone to know about any government scheme. I can easily get information about government schemes and job vacancies without having to visit eMitra."

Maya also provides training to other girls at the centre on how to use phones and laptops. This allows her to take to digitally empower over tre in her own village, care of her own educational

and household expenses. Digital literacy has not only empowered the girls to stay updated with the latest information but also contributed towards making them financially self-sufficient.

Like Maya, 18-year-old Monika, a resident of Ajaysar village, manages a Sakhi Center and earns for herself. "I have bought a scooter for myself with the money received by working at the center. And now I can go to the college or anywhere easily," said Monika with a sense of pride.

Talking about other benefits of acquiring digital education, Manju, the assistant in charge at the same center, believes that digital literacy makes it easier for students to prepare for government jobs

from the comfort of their homes. They no longer have to face the problem of a lack of transportation and pay costly fees to the coaching centres as they can easily access tutorial videos on YouTube and other digital platforms.

Reflecting on how difficult it was to start the centres in the villages, Indira Pancholi, the founding member, MJAS, said, "Where there is a ban and financial penalty on the use of phones for girls, it was a difficult task for the organization to provide them complete control of digital resources. Opening such centres was tantamount to challenging the patriarchal society. But these centres have been able to run successfully only because of these girls and their hope to move forward in their lives

and the courage to face the challenges."

So far, MJAS has established nine such Sakhi Centers, where books, libraries, tablets, and internet connections have been made available to digitally empower adolescent girls. At these centers, various programmes on life skills, health, and environment are also organized for the girls in order to raise their awareness on all levels.

These girls from rural areas have not only understood the importance of digital literacy but also made it a way of their lives. At the same time, while several reports state that rural girls have limited access to phones and technology, the examples set by MJAS' centres can provide a ray of hope!

Ukraine's tragic week shows there's no safe place in war

small broom and dust-Apan in hand, Olga Prenzilevich cleans up the debris along the road in a sleepy Kyiv suburb next to a cordoned-off mound of charred vehicles and misshapen wreckage. But she can't sweep away the terrible memory of seeing the government helicopter that carried Ukraine's interior minister tumbling through the fog and crashing into the kindergarten building. Or the frantic dash afterward to save the children, their tiny bodies in

"I am still in shock," the 62year-old custodian says, the acrid stench of burning still in the air. Nearby, Oksana Yuriy, 33, watches investigators photograph the scene to try to piece together how Wednesday's crash happened.

"I thought this was a safe place," she said. "Now I understand there is no such thing."

This is the hard lesson Ukrainians have had to learn in a week of mourning at least 59 dead in places that many considered safe from the violence of the war against Russia, now in its 11th month.

Since February, they have seen lives lost from missile strikes and battlefield combat, and civilians dying in schools,



theaters, hospitals and apartment buildings. They have suffered irretrievable losses: a loved one, a place to call home, and for some, any hope for the

But this past week seemed to have a special cruelty to it.

It started on the weekend, when a barrage of Russian missiles slammed into an apartment complex that housed about 1,700 people in the southeastern city of Dnipro. The Jan. 14 barrage killed 45 civil-

ians, including six children the deadliest strike on civilians since spring — in an area once considered safe for many who fled front-line areas farther

Then came Wednesday's helicopter crash at the kindergarten in the Kyiv suburb of Brovary that killed 14, including Interior Minister Denvs Monastyrskyi, other members of his ministry and the aircraft's crew. One child on the ground was killed and 25 people were

injured, including 11 children. Monastyrskyi, 42, had been traveling to the front line when the Super Puma helicopter went down in the fog, although no official cause has been determined. Flowers piled up Friday at the fence outside the kindergarten. A 73-year-old woman hung a plastic bag full of aloe vera plants after reading that they might help heal burn vic-

tims. But not all the mourning was in Brovary or Dnipro. At a cemetery in the town

of Bucha, near the capital, Oleksy Zavadskyi was laid to rest after falling in battle in Bakhmut, where fighting has been intense for months. His fiancee, Anya Korostenstka, tossed dirt on his casket after it was lowered into the grave. Then she collapsed in tears.

"The courage of our military and the motivations of the Ukrainian people is not enough," President Volodymyr Zelenskyy said in a news conference Thursday at the Mariinskyi Palace in Kyiv.

He had appeared a day earlier in a video link to the World Economic Forum in Davos, Switzerland, where he asked his high-powered audience to stand silently to honor those killed in the helicopter crash. His wife, Olena Zelenska, who had traveled to the conference to muster support for Ukraine in person, dabbed tears from her eyes as she learned of the crash.

At an event Thursday at Kyiv's lavish Fairmont Hotel, Ú.S. Ambassador Bridget Brink told attendees that some of the embassy's staff had died in fighting on the front. "I know a lot of Ukrainians inside and outside the government are hurting right now," she said, urging her audience of diplomats, businessmen and journalists to not lose faith

Zelenskyy honours those killed in helicopter crash

Ukrainian Vol- 1 President Volodymyr Zelenskyy held an emotional meeting Saturday with the families of those who died in a helicopter crash earlier this week.

Zelenskyy spoke with family members of seven of those killed in Wednesday's crash in the Brovary area of Kyiv, the capital city. The helicopter carrying Interior Minister Denys Monastyrskyi and other top officials slammed into a kindergarten building in the residential suburb, killing him and about a dozen other people, including a child on the ground.

Monastyrskyi, who oversaw the country's police and emergency services, was the most senior official killed since Russia invaded Ukraine. His death, along with the rest of his ministry's leadership and the entire helicopter crew, was the second major calamity in four days to befall Ukraine, after a Russian missile struck an apartment building in the south-eastern city of Dnipro, killing dozens of civilians.

At the somber service in Kyiv, Zelenskyy and his wife laid flowers on each of the seven coffins draped in the blue and yellow flags of Ukraine. Zelenskyy then spoke briefly with the families, as a small orchestra played a mournful



The cause of the crash isn't known, but Zelenskyy said earlier that it happened because the country is at war. That view was repeated by Ruslan Stefanchuk, chairman of Ukraine's parliament, speaking after the service. "All this would not have happened if not for this terrible and undeclared war which the Russian Federation is waging against Ukraine," Stefanchuk said. "Therefore, we must remember this and not forget these people. Because for Ukraine and Ukrainians, every lost life is a great tragedy."

Russia's war in Ukraine, which started nearly a year ago, is "in a state of deadlock," with Ukrainian forces likely achieving small gains in the northeast, near the town of Kreminna, while Russian forces "have likely been reconstituting" in

the eastern town of Soledar after taking it earlier in the week, the U.K. defense ministry said Saturday.

"There is a realistic possibility of local Russian advances" around Bakhmut, an eastern city whose capture would give the Kremlin a long-awaited victory after months of battlefield setbacks, the U.K. ministry said. Fierce battles for Bakhmut have been raging and three civilians were killed by Russian shelling in that area of the eastern Donetsk region, the deputy head of Ukraine's presidential office reported on Saturday

morning.

In total, five civilians were killed and 13 wounded by Russian shelling over the past 24 hours in Ukraine's east and south, where active fighting is ongoing, Kyrylo Tymoshenko said in a Telegram post.

Chief diplomats boycott Libya-hosted Arab League meeting

Ahandful of Arab chief diplomats met on Sunday in the Libyan capital in a gathering boycotted by powerful foreign ministers who argued that the mandate of the Tripolibased government has ended.

Five of the 22 member states of the Arab League sent their foreign ministers to the periodic, consultative meeting. They included the chief diplomats of neighbouring Algeria and Tunisia, local media reported. Others sent their envoys to the meeting in Tripoli.

Outrage over a Quran-burn-ing protest in Sweden produced a second day of protests in Turkey, reflecting tensions between the two countries. Some 250 people gathered outside the Swedish Consulate in Istanbul, where a photo of Danish anti-Islam activist Rasmus Paludan was set on fire. Paludan burned Islam's holy book outside the Turkish Embassy in Stockholm on Saturday, sparking protests in Istanbul and Ankara that night.

Participants in Sunday's event carried green flags featuring the Islamic proclamation of faith and banner that said "We condemn Sweden's state-supported Islamophobia."

A sign on a window of the Swedish Consulate read, "We do not share that book-burning idiot's view."

The protests have renewed concerns about Turkey holding up Sweden and Finland's bid to join NATO. Turkey has not yet ratified the Nordic nations' memberships in the military alliance, saying Sweden needs to address Ankara's security concerns. Turkish officials slammed Sweden for allowing the Quranburning protest but President Recep Tayyip Erdogan did not comment on it during his weekend speeches.

Swedish Prime Minister Ulf Kristersson tweeted late Saturday that freedom of expression was crucial to democracy but added that "what is legal is not necessarily appropriate." "Burning books that are holy to many is a deeply disrespectful act. I want to express my sympathy for all Muslims who are offended by what has happened in Stockholm today," Kristersson said.

Turkish Muslims protest US ambassador heading to Africa as part of Biden's big push

The US ambassador to the The US ambassaco to I Thomas-Greenfield, is the second Cabinet member heading to Africa as part of President Joe Biden's big push to engage with the world's second-largest continent.

The US Mission to the UN said Sunday she will travel to Ghana, Mozambique and Kenya starting January 25 "to affirm and strengthen our partnerships with key current and former UN Security Council members."

Thomas-Greenfield's visit follows last week's start of a 10day African visit by Treasury Secretary Janet Yellen. She arrived in Dakar, Senegal late Wednesday and will also visit

Biden announced at the end of a US-Africa Leaders Summit in December that he will visit sub-Saharan Africa in 2023, the first trip to the region by a US leader in a decade.

The summit and trip are aimed at strengthening US relations with Africa, where China has surpassed the US in trade and is aiming to increase its military presence, and Russia has military ties with the authorities in Mali and Central African Republic.

Biden stressed at the summit that he is serious about increasing US attention to the continent and told the 49 African leaders attending the meeting in Washington that "Africa belongs at the table" in every conversation of global

The first stop for Thomas-Greenfield, a former US assistant secretary of state for Africa, is Ghana, which is in the second year of a two-year term as an elected member of the Security Council. On January 25 she will meet with women leaders and civil society representatives, the US mission said.

Thomas-Greenfield then heads to Mozambique, which is just starting its first-ever twovear term on the council.

During her visit on January 26-27, the US mission said she will meet with UN officials, entrepreneurs, alumni of US exchange programmes, international relations students and civil society members engaged in work to adapt to climate change, the mission said.

The ambassador's final stop on January 28-29 is Kenya, whose two-year term on the council ended on December

The US mission called Kenya "a key partner" and said Thomas-Greenfield's visit will focus on humanitarian programmes, including the regional response to drought and assistance to refugees, and on "the impact Russia's war against Ukraine continues to have on global food security, which has exacerbated the humanitarian crisis in the region.

The ambassador will also meet refugees pending resettlement in the United States and Kenya-based entrepreneurs "at the forefront of the country's transition to a green economy," the mission said.

Nearly 1,000 people have been charged in the Capitol riot with federal crimes, with about half of them pleading guilty to riot-related charges and more than three dozen convicted at trial. The charges range from misdemeanors for those accused of entering the Capitol illegally but not participating in conspiracy for far-right extremist group members accused of plotting to stop the transfer of presidential power.

In November, two leaders of the Oath Keepers extremist group were convicted of seditious conspiracy for what prosecutors alleged was a weekslong plot to use force to keep Trump in office. Leaders of the Proud Boys and additional members of the Oath Keepers are currently standing trial on the sedition charge, which carries up to 20 years behind bars.

Weeks after the committee exchange, Cappelletti told The Associated Press that it's important to make sure people understand that the attack on the Capitol was an insurrection.

"These are factually correct things," she said. "That doesn't mean that we can't disagree politically about policy or other things, but we can acknowledge that that happened and start to figure out how we move forward to work together to build up that public trust again."

FBI searches Biden's Wilmington home, finds more classified material

 $F^{\text{BI investigators have found}}_{\text{additional classified docu-}}$ ments from US President Joe Biden's residence in Wilmington after conducting a 13-hour search of the home, intensifying the probe into discoveries that could become a political and possible legal liability for him as he prepares to launch a reelection bid in 2024.

Bob Bauer, the President's personal attorney, said in a statement that during the search on Friday, "Department of Justice took possession of materials it deemed within the scope of its inquiry, including six items consisting of documents with classification markings and surrounding materials, some of which were from the President's service in the Senate and some of which were from his tenure as vice

"DOJ also took for further review personally handwritten notes from the vice-presidential years," he said.

The total number of classified documents found in the residences and private offices of Biden has now increased to nearly a dozen and a half. All documents, including from his term as vice president from 2009 to 2016, have now been taken into possession of federal agents.

"DOJ requested that the search not be made public in advance, in accordance with its standard procedures, and we agreed to cooperate," Bauer said. Biden is spending time at his Wilmington, Delaware residence this weekend.

"DOJ had full access to the President's home, including personally handwritten notes, files, papers, binders, memorabilia, to-do lists, schedules, and reminders going back decades," Bauer said. Last week, US Attorney

General Merrick B Garland appointed a special counsel Robert Hur to investigate the discovery of the classified documents at the private offices and residence of the President. Richard Sauber, Special

Counsel to the President, said that Biden directed his personal lawyers to be fully cooperative with the Justice Department as part of its ongoing investigation. That has been the case since a small number of materials were initially discovered at the Penn Biden Center, he

'Govt may not announce capital infusion | B20 India inception meeting begins; for PSU banks in Budget 2023-24'

PTI ■ NEW DELHI

The government is unlikely I to announce capital infusion for public sector banks (PSBs) in the upcoming Budget as their financial health has improved significantly and they are on track to earn a combined profit of Rs 1 lakh crore, sources said.

Their capital adequacy ratio is much above the regulatory requirement and varies between 14-20 per cent.

To augment their resources, banks are raising growth funds from the market and also by selling their noncore assets, they added.

The government last provided capital support to banks in 2021-22. It had earmarked Rs 20,000 crore for recapitalisation of PSBs through supplementary demands for

The government infused Rs 3,10,997 crore to recapitalise banks during the last five financial years i.E., from 2016-17 to

2020-21, out of which Rs 34,997 crore were sourced through budgetary allocation and Rs 2,76,000 crore through issuance of recapitalisation bonds to these banks.

Finance Minister Nirmala Sitharaman is scheduled to present the fifth and final full Budget of the Modi 2.0 government on February 1.

All the 12 public sector banks earned a cumulative profit of about Rs 15,306 crore in the first quarter which increased to Rs 25,685 crore in the September quarter.

On a year-on-year basis, the growth was 9 per cent in the first quarter while it surged to 50 per cent in the second During the second quarter,

SBI reported the highest-ever profit of Rs 13,265 crore. On a year-on-year basis, this was 4 per cent higher. In the first half of FY23, the

cumulative net profit of all PSBs increased by 32 per cent to Rs 40,991 crore. The com-



bined profit more than doubled to Rs 66,539 crore in 2021-22 despite COVID-19 pressure.

Many state-owned banks after a hiatus also declared dividends in last financial year. In all, nine banks, including SBI, declared dividends of Rs 7,867 crore to shareholders.

India FTA can be clinched this year, but no more visa offers: UK Trade Min

The India-UK free trade agreement (FTA) is expected to be clinched this year but it won't involve any boost of free movement visa offers for Indians, British trade minister in charge of the negotiations

Kemi Badenoch, who was in New Delhi last month to kick off the sixth round of FTA talks with Commerce and Industry Minister Piyush Goyal, said that former prime minister Boris Johnson's "deal by Diwali" deadline last year was not feasible and had to be

changed.
In an interview with 'The Times' recently, the UK Secretary of State for Trade also ruled out any major similarities between the FTA the UK had struck with Australia - one of the first post-Brexit trade deals - and that with India.

"We left the EU (European Union) because we didn't believe in free movement, we didn't think it was working. This is not a deal that's negotiating some kind of free movement with India," Badenoch told the newspaper, with reference to more visa offers.

The minister indicated a

willingness to make concessions on issues like business mobility, but ruled out the prospect of Indians getting the same kind of deal as with Australia - which allows under-35s to live and work in the UK for three years.

The reciprocal UK-India Young Professionals Scheme, formally launched earlier this month, is seen as overcoming this hurdle by annually offering 3,000 18 to 30-year-old graduates visas to live and work in either country for up

"We have to make sure that each trade agreement we

sign is tailored to the specific country. The kind of mobility offer I can do to a country like Australia is not going to be the same kind of mobility offer I can do with a country like India, which has got many times the population," said Badenoch.

Increased E&P, import diversification, biofuels part of India's four-plank energy security strategy: Puri

Tndia, the world's third largest Lenergy consumer, is increasing domestic oil and gas exploration, diversifying import basket, switching to alternate sources and using gas and green hydrogen as a pathway to energy transition and security, Oil Minister Hardeep Singh Puri said Sunday.

Puri, who was here for an event showcasing age-old boats on the 'ghats' of the holy city switching to CNG instead of polluting diesel, said India is projected to contribute fourth of the world's energy demand growth in next couple of decades

While the nation is dependent on imports to meet 85 per cent of its oil needs and 50 per cent of its natural gas requirements, India is mixing ethanol extracted from sugarcane and other agri produce in petrol to cut overseas reliance.

It will achieve 20 per cent ethanol blending in petrol by 2025, Puri said.

"Our energy security strat-

egy is based on four pillars of diversification of energy supplies, increasing exploration and production footprint, using alternate energy sources, and meeting energy transition through the gas-based economy, green hydrogen and EVs," India increased the num-

ber of its crude oil suppliers from 27 countries in 2006-07 to 39 in 2021-22, adding new suppliers like Columbia, Russia, Libya, Gabon and Equatorial Guinea etc.

Crude oil extracted from below the earth's surface is refined to produce fuels like petrol and diesel. Natural gas too is found below the surface and is used to generate electricity, make fertilizer and convert into CNG to run automobiles and piped to homes for cooking purposes.

Energy prices globally shot up following Russia's invasion of Ukraine but consumers in India were largely insulated as state-owned retailers did not raise prices commensurate with

Prices of diesel -- the most used fuel in the country -- rose by only 3 per cent between December 2021 and December 2022 while they went up by 34 per cent in the US, 36 per cent in Canada, 25 per cent in Spain and 10 per cent in the JK, Puri said. Diesel price increased from

Rs 86.67 per litre in December 2021 to Rs 89.62 a year later. Rate of petrol rose from Rs 95.41 per litre to Rs 96.72. The increase was tempered

by a cut in excise duty. The government had raised the excise duty on petrol by Rs 13 a litre and that on diesel by Rs 15 per litre in 2020 when the pandemic had battered global energy prices. This hike was rolled back in two instalments in November 2021 and May 2022.

Also, some states cut VAT or local sales tax on fuel to help consumers. Puri said the government is targeting to increase India's exploration acreage to 0.5 million square kilometre by 2025 and 1 million sq km by

In India, 100% of marketing originated from accounts associated with third-party retailers.

Pegula warns 'long way to go'

Tessica Pegula surged into the Australian Open quarter-finals in straight sets on Sunday, but warned there was "still a long way to go" to win the title despite Iga Swiatek's exit leaving her the woman to beat.

The American third seed is the highest-ranked player left in the women's draw after beating former French Open champion Barbora Krejcikova 7-5, 6-2 in 1hr 41min. Pegula will face either 24th seed

Victoria Azarenka of Belarus, who won the Australian Open in 2012 and 2013, or China's Zhu Lin for a place in the semi-finals.

Pegula, 28, has never made it to a Grand Slam semi-final before, and didn't regard herself as the Australian Open favourite.



"I look at the draw and there's still Jelena (Ostapenko) -- she won the French Open. You have Rybakina, who won Wimbledon last year," she said. "You have Vika (Azarenka), who does really well here and Caroline (Garcia) won the WTA Tour championships," said Pegula.
"It doesn't really feel like I'm the

highest (player) left, even though I guess that's a cool stat.

"It feels like there's still a long way to go, to be honest."

But, with seven of the top 10 women's seeds already knocked out before the second Monday of the tournament, Pegula accepted this could be her big chance.

"I mean, I have a great shot here," she said. "I've been playing the best I have than in any of my other Grand Slam quarter-finals."

'NEVER DOUBTED'

Korda claims another upset at Aus Open

After more heroics against Poland's Hurkacz, Korda said his displays were down to learning from previous blockbuster matches he had lost, including to Rafael Nadal and Novak Djokovic. "I think I'm really good

at just kind of moving forward, learning from my mistakes, what I've done in the past, then using them in matches like this," he said. "I've had a tough match

with Rafa, serving for it a

couple times. Match point with Djokovic. I think that really helped me, especially in the last match (in Melbourne) with Medvedev.

"Then today as well. I think all those little moments that I've gone through, kind of learning from them, staying patient, staying positive, going through the process, I think have really helped me going forward."

Elsewhere, Jiri Lehecka stunned Felix Auger-Aliassime to surge into the quarter-finals in only his fifth Grand Slam appearance as yet another seed fell.



India out of Men's World Cup after losing crossover match against New Zealand in sudden death

Hosts India made a shock exit from the FIH Men's World Cup after losing to New Zealand in sudden death in their mustwin crossover match in front of a relentlessly cheering 15000 home crowd here on Sunday

The loss ended India's hopes of a Wold Cup medal after 48 years.

Despite vociferous support from the jampacked Kalinga Stadium crowd, India allowed New Zealand to come back from two-goal deficit in the regulation time as the match ended at 3-3 in the regulation time.

In the penalty shootout, the scores were also tied after the first five set of strikes, and the match was finally decided via sudden death.

Captain Harmanpreet Singh had the golden chance to take India to victory in sudden death but he failed to do that as he missed the target.

Veteran goalkeeper PR Sreejesh made two saves in the shootout to rescue India after they were 2-3 down. He saved another one during the sudden death and got himself injured and Krishan Pathak replaced him in the next three rounds of strikes. Finally, Shamsher Singh missed and Sam Lane scored to hand New Zealand the win.

New Zealand will now face defending champions Belgium, who topped Pool B, in the quarterfinals here on Tuesday.

Three minutes later, New Zealand again cut the deficit to just one goal with Kane Russell converting a penalty corner.

In the last quarter, New Zealand made a spirited fightback and restored parity in the 50th minute following their second penalty corner of the match as Sean Findlay deflected in a Hayden Phillips strike.

Goalkeeper Krishan Pathak saved India from disaster as he palmed away a high shot from Sam Hiha in the 51st minute.

In the earlier crossover match of the day, Spain beat Malaysia 4-3 in penalty shootout to qualify for the quarterfinals after the two sides were locked 2-2 in the regulation time.

Spain will face title contenders and Pool A toppers Australia in the last eight stage on Tuesday.

Guardiola quickly took the chance to give his star striker a rest as Haaland was replaced on the hour mark by Julian Alvarez to Wolves' relief.

An indigenous Australian member of the Australian national women's cricket team has condemned a decision to play a T20I against Pakistan on Australia's national day.

The holiday on January 26 commemorates the arrival in 1788 of the "first fleet" which brought first white settlers to Australia.

But some indigenous Australians commemorate the day as Invasion Day or Colonization Day because the arrivals set in motion the seizure of lands and the diminution of the indigenous Australian cul-

Ashleigh Gardner who is second indigenous Australian woman to play test cricket for Australia said January 26 is a "day of hurt and a day of mourning" for her people. In a tweet Gardner said playing a



match on the day "certainly doesn't sit well with me as an individual but also all the peo-

ple I'm representing. "For those who don't have a good understanding of what that day means it was the beginning of genocide, massacres and dispossession," she said. "When I take the field for this game I will certainly be reflecting and thinking about all of my ancestors and peoples' lives who changed from this day." Cricket Australia has yet to

confirm details of the match but the Australian Associated Press reported the Australian players will likely perform a barefoot ceremony before the match and wear an indigenous-themed
