

# **Biren shelves plan to quit**

Under fire for Manipur riots, CM decided not to quit after supporters tore up his resignation

Manipur Chief Minister N Biren Singh, who had been facing criticism for his handling of ethnic violence in the State for nearly two months, was on the brink of resigning on Friday but ultimately changed his mind due to public pressure.

Government The spokesperson and Minister Sapam Ranjan Singh said Biren was saddened by the events and decided to resign then. "The Chief Minister felt very sad about what had hap-pened. He felt he had lost the trust of the people," he said. Biren Singh had started his

journey towards the Governor's House but turned back after witnessing a massive show of support outside his residence in Imphal, the Minister stated.

Hundreds of women gathered near Singh's residence and formed a human chain, expressing their desire for him not to resign. When two Ministers emerged from his residence with a copy of his resignation letter, it was torn up in a symbolic gesture.

Later in the day, Singh clarified that he had no intentions of resigning from his post, putting an end to the daylong speculation surrounding the issue. Prior to his clarifica tion, thousands of protesters blocked the Chief Minister's convoy from proceeding to Raj Bhavan. Biren Singh took to Twitter, stating, "At this crucial juncture, I would like to clarify that I will not be resign-ing from the post of Chief Minister.

The Modi Government is considering to introduce the contentious Uniform Civil Code (UCC) Bill during the upcoming Monsoon session of Parliament. The Covernment is beneful that it Government is hopeful that it can secure the necessary sup-port in the Rajya Sabha, with parties such as the Aam Aadmi Party (AAP) and the Biju Janata

Party (AAP) and the biju janata Dal (BJD) on their side. Arvind Kejriwal's AAP, the Shiv Sena (Shinde faction), and the All-India Anna Dravida Munnetra Kazhagam (AIADMK) have openly (AIADMK) have openly expressed their support for the UCC. The BJP is also hoping for the backing of Naveen Patnaik's BJD and Jagan Mohan Reddy's YSR Congress, although Reddy's stance on the matter is yet to be clarified. However a significant

However, a significant number of Opposition parties, including the Congress, Trinamool Congress (TMC), Janata Dal United (JDU), Dravida Munnetra Kazhagam (DMK), Samajwadi Party (SP), and Bahujan Samaj Party (BSP), have described the UCC as a "diversionary tactic" employed by the Modi Government with an eye on the Lok Sabha polls. They have voiced their opposition to the Bill, while other parties like the Nationalist Congress Party (NCP) and the Shiv Sena (Uddhav faction) have called for "wider consultations" on the issue.

India and Russia on Friday discussed the entire gamut of their bilateral ties during tele-phonic talks between Prime Minister Narendra Modi and President Vladimir Putin, Both the leaders also reiterated their commitment to further strengthening the bilateral strategic partnership, the Kremlin said, adding they also discussed the ongoing Ukraine

conflict. The Kremlin statement also said Prime Minister Modi has expressed support for the actions taken by the Russian leadership in connection with the short-lived armed rebellion by the Wagner mercenary group last week.



"In connection with the June 24 developments, Modi expressed understanding and support for the resolute actions by the Russian authorities to defend law and order, and ensure stability in the country and security of its citizens," it said. The Prime Minister's Office (PMO) in New Delhi

said Modi reiterated his call for dialogue and diplomacy to find a solution to the Ukraine conflict as he spoke to the Russian President over phone. In their talks, the two leaders reviewed progress in bilateral cooperation and exchanged views on regional and global issues of mutual interest, the PMO said, adding that Putin informed Modi about the recent developments in Russia

The Mamata Banerjee Government has been claiming that the Centre had held up about Rs 15,000 crores of MNREGA and PM Awas funds. "The poor people have worked under the 100-days work scheme but are not being paid their dues ... what kind of rule is this ... here in Bengal



Mamata Banerjee is working day and night for the poor people introducing poor-friendly schemes on regular intervals and there they are trying to starve the poor people of Bengal ... but this will not be allowed to continue for long and soon after the panchayat elections I will lead 10 lakh people to Delhi and will not move out till our demand is met," Banerjee who is also the

'Uniform personal law applicable for every citizen of our country is the finest step towards our attempt to remain a progressive and democratic State. This would ensure human dignity for every citizen irrespective of their gender, caste, religion, language.

We are sure that the new law will eradicate social injustice and inequality prevalent in our society.

We are also hopeful that this move will end vote-bank politics and appeasement towards some sections of the society by some political parties," said Kevin Peter, president, CASA. CASA is an umbrella organization repre-senting all factions of the Church and plays a significant role in moulding the opinion of Christians," Archbishop who had hinted of a possible support to the BJP the members of the communi-

Kevin Peter said that having a common civil code would be the right attempt to openly discuss and bring the required inclusivity and neutrality of all "It is a right attempt from

"There is every sign of the Manipur riots have turned out to be a genocide. The governments at the Centre as well as in Imphal have failed miserably to save the lives of hundreds of

The Law Commission has received nearly 8.5 lakh responses to its public notice as of Tuesday evening.

Meanwhile, Uttarakhand, which was the first state to establish a committee to examine the UCC, is making significant progress on the task. The committee has already prepared a report to frame a bill based on its recommendations.

Justice (Retd) Ranjana Prakash Desai, the head of the committee of experts appointed by the Uttarakhand government last year, stated, "The draft of the proposed Uniform Civil Code for Uttarakhand is complete and will be submitted to the state government in July itself?

Addressing a press conference, the committee highlighted that it had considered various opinions and examined different statutes and uncodified laws, including the legal frameworks in select countries, while drafting the code. The committee also aimed to understand the diverse customary practices prevalent in different parts of Uttarakhand.

Desai added, "The report of the committee, along with the draft code, will soon be printed and submitted to the government of Uttarakhand."

Uttarakhand Chief Minister Pushkar Singh Dhami emphasized the importance of early implementation of the UCC and stated that the views of over two lakh people were taken into account during the consultation process.

The Uttarakhand government had formed an expert committee under retired Supreme Court judge Desai in May last year to examine the existing laws governing personal civil matters of the state's residents and to propose draft laws or changes to existing laws regarding subjects such as marriage, divorce, property rights, succession, inheritance, adoption, maintenance, custody, and guardianship.

## **Delhi Govt to move SC** against Ordinance

The Delhi government on Friday moved the Supreme Court against the Centre's ordinance over control of services in the national capital. Earlier in the day, the AAP

had announced to burn copies of the Centre's ordinance at the party office in central Delhi on July 3 but later the programme was cancelled. "AAP National Convener Arring Kairingland Convener Arvind Kejriwal and the senior leadership of AAP will neither burn nor participate in the protests and agitations against the Delhi Ordinance on July 3 as proposed earlier since the matter is now sub-judice in the Supreme Court. July 3 program is cancelled," the AAP said in a statement.

In its plea filed through advocate Shadan Farasat, the Delhi government has said that the ordinance, which came days after the apex court verdict, is a plain attempt to "override" the top court and the basic structure of the Constitution itself vide executive fiat.

Seeking quashing of the ordinance, the plea alleged that it is an "unconstitutional exercise of executive fiat" that violates the scheme of federal, democratic governance entrenched for the NCTD in Article 239AA and is mani-

festly arbitrary. "Article 239AA of the Constitution is a sui generis provision in that it constitutionally entrenches for NCTD a Westminster-style democracy, to fulfill the popular, region-al, and democratic aspirations

## India dismayed over delay in UNSC reforms

Edelay in reforming the United Nations Security Council(UNSC), India has termed it as "yet another wasted opportunity." This reaction was in response the UN General Assembly deciding to roll over the Inter-Governmental Negotiations on Security Council reform to its next session. India also said the process could well go on for another 75 years without achieving genuine progress

The UN General Assembly late Thursday adopted a draft oral decision to continue the intergovernmental negotiations(IGN) on Security Council reform at the 78th session of the UN General Assembly that will commence in September. The rollover decision marked the end of the IGN for the current 77th session.

India's Permanent Representative at the UN Ambassador Ruchira Kamboj underscored that the roll-over go on for yet another 75 years

decision of the IGN simply cannot be reduced to a mindless technical exercise. 'We see this technical

rollover decision as yet another wasted opportunity to instil a breath of life into a process that has shown no signs of life or growth in over four decades," Kamboj said adding that India joined the consensus in the adoption of the draft presented, simply to acknowledge the personal efforts of Csaba Korosi, President of the 77th session of the General Assembly.

Kamboj stressed it is now apparent that the IGN could well

without any progress whatsoever in the direction of genuine reform in its current form and

modalities - that is, without application of the GA Rules of Procedure, and without a single negotiating text.

"As a responsible and constructive member of the United Nations, India will, of course, continue to engage in this process alongside our reformminded partners, and persist with our efforts to move from repetitive speeches to text-based negotiations.

However, for those of us who truly wish to fulfil our lead-

ers' commitment towards an early and comprehensive reform of the UN Security Council, looking beyond the IGN looks increasingly to us as the only viable pathway to a future UN Security Council that would better reflect the world of today," she said.

Referring to the roll-over decision, Kamboj said as the only formal General Assembly outcome that emerges from this process each year, it must also evolve and reflect the progress achieved during Member States' deliberations during the year.

She said India was encouraged by the PGA's efforts to introduce in the decision a small reflection of this evolution, with regard to webcasting and the beginning of a digital repository. "I must say though that even with these so-called changes, there has been no breakthrough whatsoever, that may be described as progress. This state of affairs is clearly in the interest of those who seek a status quo, to keep this process frozen in repetitive cycles," she

In his remarks, Korosi noted that for the first time in the history of these negotiations, the first segments of the IGN meetings are now webcast and a ded icated website on Security Council reform has been established as a repository for the IGN process.

Korosi said ultimately, the intergovernmental negotiations are driven by Member States and it is therefore up to the 193 nations of the UN General Assembly to show "political will for the reform you want to see". "The eight billion people

outside these walls do not see the UN as a conglomerate of separate bodies. They see the UN as one. Amid these unprecedented crises, their expectation for us to deliver is at its highest. Let us work in good faith to meet that expectation. We do not have the luxury to spend another 17 years on this issue," he said.

India has been pitching for a permanent seat in the expanded membership of the UNSC arguing that the existing body does not truly reflect the contemporary world realities.

As the indigenously designed and manufac-tured Tejas light combat aircraft(LCA)completes seven years of service in the Indian This latest advisory, that Air Force(IAF) on Saturday, IAF is expected to get delivcraft Tejas MK-1A from February next year. It will be capable of firing a plethora of weapons, including beyond visual range missiles. Stating this on Friday, the defence ministry the aircraft and its future variants will form the mainstay of IAF. In February 2021, the ministry sealed a Rs 48,000 crore deal with state-run aerospace major Hindustan Aeronautics Ltd for procurement of 83 Tejas MK-1A jets for the IAF. At present, more than 30 Tejas iets are in service. Tejas is a single-engine multi-role fighter aircraft capable of operating in highthreat air environments. Egypt, Argentina, the US, Australia, Indonesia, Malaysia and the Philippines are among

the countries showing keen interest in procuring Tejas aircraft. The LCA, christened Tejas in 2003, is a multi- role platform that ranks amongst the best in its class. It has been designed to undertake air defence, maritime reconnaissance and strike roles. The airoffers carefree handling and enhanced manoeuvrability. This capability is further enhanced with its multi-mode airborne radar, helmet mounted display, self-protection suite and laser designation pod. The first IAF Squadron to induct the Tejas was No 45 Squadron, the 'Flying Daggers'. Over the years, the squadron progressed from Vampires to Gnats and then onto the MiG-21 Bis, before being equipped with its current steed. Each of the aircraft flown by the Flying Daggers has been manufactured in India - either under license production or having been designed and developed in India. In May 2020, No 18 Squadron became the second IAF unit to operate the Tejas.



## Rising global temp could fuel domestic violence: Study

That rising global tempera-tures and subsequent heat waves could fuel domestic violence against women in South Asian countries, particularly India, followed by Nepal and Pakistan, said a study published in the medical journal JAMA Psychiatry. The heatwave could see an increase

of 23.5 per cent in family abuses against women in India.

The researchers have linked a 1-degree Celsius rise in the yearly average temperature with a 4.5 per cent increase in intimate partner violence (IPV) in the study --Association of Ambient Temperature With the Prevalence of Intimate Partner Violence Among Partnered Women in Low and Middle-South Income Asian Countries" of almost 1,95,000

This could cause biological malfunctioning, leading to health and behavioural problems, warned researchers at the Pennsylvania State University, US, after they measured cotinine levels, along with metals, in children's saliva.

Cotinine, a nicotine metabolite present in children's blood or saliva, is measured to assess their exposure to tobacco smoke, or their environmental tobacco smoke (ETS) The researchers also said

that metals have also been found in vapours of common products used for vaping, cast



Second-hand tobacco exposure could

increase lead in children's saliva

as a healthier alternative to tobacco-based products, indicating that these products too are capable of being transmitted as second- and third-hand smoke.

A total 238 (7.5 years of age and under) out of 1,300 children born in 2003 and 2004 and growing up in the rural areas of Pennsylvania and North Carolina in the US, originally recruited for childhood developmental studies, were investigated for the study published in the Journal of Exposure Science - & Environmental Epidemiology.

Lead researcher Lisa Gatzke-Kopp and her team found significant associations

between salivary cotinine and salivary levels of essential trace metals such as copper and zinc and of non-essential metals such as lead. Metals such as copper and zinc in trace amounts are necessary for healthy bone development and general metabolism in humans.

Children with higher levels of cotinine were also found to have higher levels of heavy metals in their saliva.

'We were surprised by the levels of heavy metals in children at this age," said Gatzke-Kopp, professor of human development and family stud-

"Our findings suggest that environmental tobacco smoke exposure may be one source of increased children's exposure to

heavy metals," she said. "Tobacco smoke contains thousands of chemical compounds, most of which are harmful to humans," said Gatzke-Kopp.



olitics and cinema are two factors that are intertwined in Tamil Nadu. Since 1967, when the DMK formed the first non-Congress Government, cinema and politics rule the roost of Tamil politics. It all started with CN Annadurai, the DMK chief, who became the first non-Congress chief minister of the State. After his two-year-long tenure was cut short by terminal illness, Muthuvel Karunanidhi was anointed as chief minister. Karunanidhi used cinema and dramas to propagate his style of politics embellished with bribery and freebies. No DMK representative in the Union Cabinet (1996-98, 1999-2004 and 2004-2013) was free of corruption charges which earned the party the unprecedented reputation of an outfit with "DNA of corruption in its genes". The Justice Ranjit Singh Sarkaria Commission of Inquiry, appointed by the Indira Gandhi regime in 1976 to probe corruption charges against Karunanidhi, found out that there were "cogent, convincing and reliable" pieces of evidence against him and described Karunanidhi as



an expert in scientific corruption. Propensity to corruption was the basic requirement to get admission to Karunanidhi's heart, said MG Ramachandran who was ousted from the DMK for questioning the impropriety of the K-clan members. Though MGR's tenure as CM was bereft of any charges of corruption, his successor Jayalalithaa was embroiled in a series of such cases and the Supreme Court itself upheld the verdict sentencing her to four years' imprisonment. It is at this juncture that Senthil Balaji, a minister in the MK Stalin Cabinet, has been arrested by the Enforcement Directorate on charges of cash for jobs

and money laundering. Balaji, an AIADMK activist till the demise of Jayalalithaa in 2016, was no stranger to misuse of office. Hundreds of people had complained to Jayalalithaa against Balaji, who was the transport minister during the 2011-2015 Government. Jayalalithaa dropped him from the Council of Ministers and even Stalin, now the chief minister, had demanded Balaji's arrest. Interestingly, the same Stalin received Balaji in DMK with open arms, got him elected as MLA and made him the minister of the money-spinning departments of electricity and prohibition. There was no dearth of corruption charges against Balaji and finally law caught up with him. In normal circumstances, the chief minister should have dropped him from the Council of Ministers till the conclusion of the probe. But Stalin was adamant that Balaji would remain with him and took strong objection to Governor RN Ravi's action of dismissing him. Though the Governor took back his order, the damage has been done. The requirement that "probity should be the hallmark of public life" is alien to Tamil Nadu. Since the State and Central agencies were probing the charges against Balaji, he should ideally have tendered the resignation on his own. If his honesty and integrity are proved beyond doubt, the stock of DMK, Stalin and Balaji himself would go up. Public life is not a bed of roses, it needs boldness.



# Another birthday spent behind bars



A symbol of aspirations for freedom and democracy, Aung San Suu Kyi has reportedly been kept in 10 ft by 10 ft concrete cell with two windows

nnoticed by the world at large, Daw Aung San Suu Kyi, the symbol of Myanmar's aspiration for freedom and democracy, spent her 78th birthday on June 19 in Naypyidaw Prison. Mohinga Matters, an important source of information about developments in Myanmar, cites those released from the same prison as saying that she has been kept in a 10x10 feet small concrete building with two small windows. If any of the heads of state and governments demanded her release on the occasion of her birthday, it was not audible enough to be heard. The overwhelming majority of the Myanmar diaspora, including her younger son, Ko Htein Lin Kim Aris, rallied in her support for the restoration of democracy in that country.

In a video message released on the eve of her birthday, and carried by an independent news agency, he appealed to Myanmar's ruling junta to release her and all other political prisoners and agree to a ceasefire while opening negotiations for handing power back to the democratically elected government. He also said that he had not been granted any contact with her since her arrest and subsequent internment. All his efforts to know about her whereabouts and the conditions in which she was being kept, fetched no response.

The statement touched upon matters on which there is a wide global consensus-the utter illegality of Daw Aung San Suu Kyi's arrest and internment, the sheer mockery of the trials she is facing, and the savage repression the Junta has unleashed on the country. In addition, he made two noteworthy points. The first is that the world should put meaningful pressure on Myanmar's military to end its brutal attacks on its own people. Also, the British government and all other countries should regard Myanmar (he used the original name of Burma) as a pariah state, of the National League for Democracy — the party led by Daw Suu Kyi - activists and representatives of several insurgent ethnic organisations and minor parties). The second is that the military would not win the current civil war in the country; the people will not allow their freedoms to be taken away

As to the first, the United States and the European countries have taken measures like sanctioning the generals and others involved in the coup on February 1, 2021, which prevented the NLD, which had swept the general elections held on 8 November 2020, from assuming power, and the subsequent atrocities. As late as June 22, 2023, the US Department of Treasury imposed new sanctions on Myanmar's Ministry of Defence and two junta-owned banks. Unfortunately, such measures have not deterred the junta because sanctions do not deliver and it is support-

## A case for regulating Artificial Intelligence



reasonable care and caution

There is an urgent need to tap the potential of AI for accomplishing national objectives and fulfilling the aspirations of Indian citizens

rtificial Intelligence (AI) is the new buzzword in the town and is making too much flutter and scoop around. AI and Machine Learning are being widely discussed and claimed across the board to bring about a revolution in the way things will be performed and looked at in future. AI has revolutionised the method of performing various tasks through its algorithm-based software and has made future predictions possible and accurate. With the use of AI, many tasks have become easier to perform with more efficiency. It is expected that the way AI is advancing it will develop various applications that will be able to do acts the doing of which seem humanly impossible at present.

Artificial intelligence is the creation of computer systems that can carry out tasks that traditionally require human intellect, including perception, speech recognition, decision-making, and language translation. Through AI, the goal is to develop intelligent machines that can think, comprehend, and act on their own, modelling some human actions.



The invention of AI applications and tools has made it possible to answer questions and write code and poems and books with human-like sensitivity. It is also expected that AI shall become an indispensable tool for carrying out numerous industrial activities. AI has developed and is in the process of developing such tools that will be immensely beneficial in business operations. Against this backdrop, it is not an exaggeration to say that the manner of growth and popularisation of AI would have made it seem like a one-stop solution

for all human problems. However, AI tools also have limitations and can generate untruthful and toxic comments and can spread misinformation, and spam,

academic literature. At present, India does not have a law on AI. The government of India has already expressed its intention some time back that it is not considering any law to regulate AI. The government had conveyed its position that AI is useful for the digital and innovation ecosystem, but had ethical concerns and associated risks. Various government agen-

cies have started efforts to standardize responsible AI development and are drawing up a blueprint for the development of AI for India.

Despite the position taken by the government, successful use of AI technology would require the enactment of legislation that will prevent the misuse of AI in situations that involve, loss to or, infringement of the rights of people. Such a law may permit only authorized persons to utilize the govt recognized AI Platforms, allow limited access to the usage of "Smart AI", and may have penal provisions to cover cases of mali-

cious use of AI such as blackmailing, morphing and creating false evidence etc.

Moreover, such a law may and can write misleading require programmers to take

while creating AI systems in order to prevent harm to AI users. Businesses using AI ought to alert end users against any potential danger and must attach strong technical safeguards and technological measures of protection with every AI application to minimize their misuse. Failure in complying with such stipulations must entail legal liability for creators, intermediaries and commercial dealers.

There is a need to tap the potential of AI positively in order to use this technology for accomplishing national objectives and fulfilling the aspirations of Indian citizens. AI should be used to serve the interests of our created social institutions and economic, legal, and administrative machinery. There can be no doubt that AI has enormous potential to revolutionise many facets of society but to maximise its advantages and minimise its downsides, serious deliberations over ethical/legal frameworks should be initiated.

## Pak strikes \$3 bn bailout deal with IMF

#### PTI ISLAMABAD

In a major relief to cash-strapped Pakistan, the IMF has agreed to inject USD 3 billion into the country's ailing economy after months-long negotiations that pushed it to the brink of default.

The Pakistan government and the Washington-based global lender reached a ninemonth Stand-By Arrangement (SBA) on Thursday to support the authorities' immediate efforts to stabilise the economy from external shocks.

Pakistan's is facing its worst economic crisis since independence from Britain in 1947. The country's economy has been in a free fall mode for the last many years, bringing untold pressure on the poor masses in the form of unchecked inflation, making it almost impossible for a vast number of people to make ends meet.

Prime Minister Shehbaz Sharif on Friday said that Staff-Level Agreement with the International Monetary Fund would help strengthen

### Mossad discovers Pakistan involvement in murder plot

In a counter-terrorist operation on Iranian soil, the Mossad apprehended the head of the cell, Yusef Shahabazi Abbasalilu, who gave his investigators a detailed confession bringing about the dismantling of the attack cell in Cyprus.

Abbasalilu received detailed instructions and weapons from senior Iranian Revolutionary Guards personnel in Iran. During questioning, parts of which were shared with the media, he admitted to his involvement in an attempted attack and described how he tried to carry it out.

In the wake of the information that he gave to the Mossad investigators, the cell was dismantled in an operation by the Cypriot security services, the announcement said

In the video footage released by the spy agency, the Iranian also reveals Pakistani involvement in the plot to kill Jews and Israelis. Pakistan nationals have been caught recently in several other such plots targeting Israelis.

#### UN nuclear agency 'Haiti youths face chief to visit staggering levels of Fukushima plant

**Tokyo (AP):** The chief of the UN nuclear agency will visit Japan next week to meet with Japanese leaders and see final preparations for the release of treated radioactive wastewater from the damaged Fukushima nuclear plant into the Pacific Ocean, officials said Friday.

Japan's government hopes the visit by International Atomic Energy Agency head Rafael Mariano Grossi will add credibility to the discharge plan. It has been strongly opposed by local fishing groups and by neighboring South Korea, China and some Pacific Island nations over safety concerns.Grossi will visit Japan July 4-7, Foreign Minister Yoshimasa Hayashi said.

He is expected to meet with Hayashi, Industry Minister Yasutoshi Nishimura and Prime Minister Fumio Kishida and visit the Fukushima plant, which was damaged by a massive earthquake and tsunami in 2011.

Only Canadian news will be blocked, so Canadian users will still be able to see content from outlets like Fox News or BBC, for example.

Meta made a similar announcement last week, saying it would remove news from its social media platforms Facebook and Instagram before the law comes into force. It is also ending existing deals with local publishers. Meta is already

running a test to block news for on their sites if it helps them up to 5 per cent of its Canadian generate money. users. Google ran a similar test

Google had been seeking assurances about how much that could cost it and how the bargaining process would unfold. Those details are likely to become clear after the bill's regulatory process is complete.

# 600 held, 200 cops hurt in France unrest

Protesters erected barricades, lit fires and shot fireworks at police who responded with tear gas and water cannons in French streets overnight as tensions grew over the deadly police shooting of a 17-year-old that has shocked the nation.

More than 600 people were arrested and at least 200 police officers injured as the government struggled to restore order on a third night of unrest.

Armoured police vehicles rammed through the charred remains of cars that had been flipped and set ablaze in the northwestern Paris suburb of Nanterre, where a police officer shot the teen identified only by his first name, Nahel.

On the other side of Paris, protesters lit a fire at the city hall of the suburb of Clichy-sous-Bois and set a bus depot ablaze in Aubervilliers. In several Paris neighbour-

hoods, groups of people hurled firecrackers at security forces. The police station in the

city's 12th district was attacked, while some shops were looted along Rivoli street, near the Louvre museum, and at the Forum des Halles, the largest shopping mall in central Paris.

US colleges seeking new ways to promote diversity after SC move

#### AP WASHINGTON

The Supreme Court has sent shockwaves through higher education with a landmark media such as Snapchat and TikTok to remove sensitive decision that struck down affirmative action and left colleges content and said that violence is being organised online. Of across the nation searching for young rioters, he said: "We sometimes have the feeling new ways to promote student diversity.

Leaders of scores of universities said on Thursday that they were disappointed by what they see as a blow to diversity.

Yet many also voiced optimism that they would find new ways to admit more Black and Hispanic students, despite evidence that eliminating the practice often leads to steep enrollment decreases among them. President Joe Biden said he disagreed with the decision and asked the Education Department to explore policies that could help colleges build diverse student bodies.

He also pushed against policies like legacy preferences - admissions boosts given to the children of alumni - that tend to help white, wealthy students. "We should never allow the country to walk away from

the country to wark away from the dream upon which it was founded," Biden told reporters. "We need a new path for-ward, a path consistent with the law that protects diversity and expands opportunity."

Yet evidence from states that previously outlawed affirmative action show it will be a daunting challenge.

As an alternative to affirmative action, colleges from California to Florida have tried a range of strategies to achieve the diversity they say is essential to their campuses. Many have given greater preference to low-income families. Others started admitting top students from every community in their state. But years of experimentation - often prompted by state-level bans on considering race in admissions - left no clear solution.

In states requiring raceneutral policies, many colleges saw enrollment drops among Black and Hispanic students, especially at selective colleges that historically have been mostly white. At Amherst College, officials had estimat-

#### ed going entirely race-neutral would reduce Black, Hispanic and Indigenous populations by half. "We fully expect it would be a significant decrease in our population," said Matthew McGann, Amherst's director of admission, earlier this year. Facing a conservative Supreme Court that appeared skeptical from the start, colleges have been preparing for a rollback. Some were considering adding more essays to get a better picture of an applicant's background, a strategy invited in Thursday's Supreme Court

"Nothing prohibits universities from considering an applicant's discussion of how race affected the applicant's life, so long as that discussion is concretely tied to a quality of character or unique ability that the particular applicant can contribute to the university," Chief Justice John Roberts wrote for the court's conserv-

ative majority. Other colleges were plan-ning to boost recruiting in racially diverse areas, or admit more transfer students from

community colleges. The court took up affirmative action in response to chal-lenges at Harvard University and the University of North Carolina.

Lower courts upheld admission systems at both schools, rejecting claims that the schools discriminated against white and Asian

American applicants. But at Supreme Court arguments in late October, all six conservative justices expressed doubts about the practice, which had been upheld under Supreme Court decisions reaching back to 1978, and as recently as 2016.

Nine states already have banned affirmative action, starting with California in 1996 and, most recently, Idaho in 2020. Michigan voters rejected it in 2006, the University of Michigan shifted attention to low-income students.

#### Mexico acknowledges 112 Judge rejects Trump's request to toss heat-related deaths so far Mexico City (AP): Mexican

health authorities say there have been at least 112 heatrelated deaths so far this year, acknowledging the deadliness of a recent heatwave that the president previously said was being overblown by alarmist journalists.

The report, released late Wednesday, also shows a significant spike in heat-related fatalities in the last two weeks. So far this year, the overall heatrelated deaths are almost triple the figures in 2022. The Health Department normally issues a report on heat-related fatalities each week, but in June — at the height of the heat wave - it skipped a week, for reasons that remain unclear.

The deaths reached a peak in the week of June 18-24, with 69 deaths in one week nationwide, an unprecedented number. Temperatures in some parts of Mexico have risen to over 105 degrees Fahrenheit

(40 degrees Celsius) in recent weeks. The week of June 11-17 was also unusually bad, with 31

deaths across the country. So far this year, the largest number of deaths from heatstroke and dehydration have occurred in the northern border state of Nuevo Leon, home to the industrial hub of Monterrey. President Andrés Manuel López Obrador claimed last week that mounting reports of heat deaths were untrue, and were part of a media campaign against his administration. "There is an alarmist, yellow-journalism trend," López Obrador said, citing lower death figures that were already outdated at that time. The high number of

heat-related deaths appeared to be due in part not only to high temperatures, but to a delay in the onset of seasonal rains that normally come to Mexico in mid-June and tend to cool things off a bit.

Former President Donald Trump's claims that absolute presidential immunity and free speech rights shield him from the defamation claims of a New York columnist were rejected Thursday by a federal judge.

The writer, E. Jean Carroll, can continue to press claims that Trump owes her at least \$10 million in damages for comments he made before and after she won a \$5 million sexual abuse and defamation verdict against him last month, Judge Lewis A. Kaplan said in a written opinion.

Trump tried to dismiss the lawsuit on grounds that he is entitled to absolute presidential immunity, his statements were not defamatory and that his statements were opinion protected by free speech rights. Kaplan said Trump surren-

dered absolute presidential

immunity as a defense by failing to assert it years ago when the lawsuit was filed. The lawsuit was delayed until recently as appeals courts considered legal issues surrounding it.

Trump countersued Carroll this week, claiming that she has libeled him by continuing to insist that he raped her even after a jury found otherwise. After a jury returned its verdict last month in Manhattan federal court, Trump made comments on a CNN town hall that prompted Carroll to assert new defamation claims in a 2020 defamation lawsuit.

The jury award resulted from a sexual abuse and defamation lawsuit filed last November after New York state temporarily enacted a law allowing sexual assault victims to sue for damages resulting from attacks that occurred even decades earlier. Trump's claims in the CNN

broadcast mirrored statements he made while president in 2019 when Carroll published a memoir in which she claimed Trump raped her in the dressing room of a luxury midtown Manhattan department store in spring 1996. Within hours of

excerpts from the book being published in a magazine, Trump denied a rape occurred or that he ever knew Carroll. "Mr. Trump did not mere-

ly deny Ms. Carroll's accusation of sexual assault," Kaplan wrote. "Instead, he accused Ms. Carroll of lying about him sexually assaulting her in order to increase sales of her book, gain



## **SC** rejects Biden's plan to wipe away \$400 bn in student loans

Washington (AP): A sharply divided Supreme Court ruled on Friday that the Biden administration overstepped its authority in trying to cancel or reduce student loans for millions of Americans.

The 6-3 decision, with conservative justices in the majority, effectively killed the USD 400 billion plan, announced by President Joe Biden last year, and left borrowers on the hook for repayments that are expected to resume by late summer.

The court held that the administration needs Congress' endorsement before undertak ing so costly a program.

The majority rejected arguments that a bipartisan 2003 law dealing with student loans, known as the HEROES Act,

gave Biden the power he claimed. "Six States sued, arguing that the HEROES Act does not authorise the loan cancellation plan. We agree," Chief Justice John Roberts wrote for the court. Justice Elena Kagan wrote

in a dissent, joined by the court's two other liberals, that the majority of the court "overrides the combined judgment of the Legislative and Executive Branches, with the consequence of eliminating loan forgiveness for 43 million Americans." Loan repayments are

expected to resume by late August under a schedule initially set by the administration and included in the agreement to raise the debt ceiling.

Seoul (AP): The United first time in six years. States flew nuclear-capable bombers to the Korean Peninsula on Friday in its latest show of force against North Korea, days after the North staged massive anti-US rallies in its capital.

The long-range B-52 bombers took part in joint aerial drills with other US and South Korean fighter jets over the peninsula, South Korea's Defence Ministry said in a statement. The bombers' flyover is the latest in a series of temporary US deployments of strategic assets in South Korea in response to North Korea's push to expand its nuclear arsenal. Two weeks ago, the US deployed a nuclear-powered submarine capable of carrying about 150 Tomahawk missiles to South Korean waters for the

The USS Michigan's arrival came a day after North Korea resumed missile tests to protest previous US-South Korean drills that it views as an invasion rehearsal.

The South Korean Defence Ministry said the B-52 bombers' deployment boosted the visibility of US strategic assets to the peninsula. It said the allies have been demonstrating their firm resolve to strengthen combined defense postures and will continue joint drills involving US strategic bombers.

On Sunday, more than 120,000 North Koreans participated in mass rallies in Pyongyang to mark the 73rd anniversary of the start of the Korean War.

## UN votes to establish independent body to clarify fate of over 130,000 Syrians

he UN General Assembly L has approved a resolution that will establish an independent body to determine what happened to more than 130,000 people missing as a result of the conflict in Syria.

The resolution, an important response to appeals by their families and loved ones, was adopted Thursday by the 193-member world body on a vote of 83-11 with 62 abstentions. Among those opposing the resolution was Syria, which said it will not cooperate with the new institution. Russia, China, North Korea, Venezuela, Cuba and Iran also

voted no. The resolution, spearheaded by Luxembourg, noted that after 12 years of fighting in

Syria "little progress has been achieved in alleviating the suffering of families by providing answers as to the fate and whereabouts of all missing persons". It authorises the estab-

lishment of an Independent Institution of Missing Persons in the Syrian Arab Republic, under UN auspices, "to clarify the fate and whereabouts of all missing persons ... and to provide adequate support to victims, survivors and the families of those missing".

It says victims, survivors and the families of the missing should be represented in the new body, which will be guided by principles including "do no harm," impartiality, transparency and the confidentiality of sources and information. Under the resolution, UN

Secretary-General Antonio Guterres must present terms of reference for the new institution within 80 working days and take steps to speedily establish the body and put it in operation. It requests the UN chief to report on implementation of the resolution within 100 working days. Luxembourg's UN ambas-

sador, Olivier Maes, told the General Assembly before the vote that "every day families, especially women, face administrative and legal difficulties, financial uncertainties and deep trauma as they continue to search for their missing loved ones". 

Fiscal deficit is the difference between the total expenditure and revenue of the government. It is an indication of the total borrowings that are needed by the government. In actual terms, the deficit was Rs 2,10,287 crore at May-end 2023, as per the data of the Controller General of Accounts (CGA).

In the Union Budget, the government aimed to bring down the fiscal deficit during the current financial year 2023-24 to 5.9 per cent of the gross

domestic product (GDP). The deficit was 6.4 per cent of the GDP in 2022-23 against the earlier estimate of 6.71 per cent. Unveiling the revenueexpenditure data of the Union government for the first two months of 2023-24, CGA said the net tax revenue was Rs 2.78 lakh crore or 11.9 per cent of the BE.

Its total expenditure was Rs 6.25 lakh crore or 13.9 per cent of the estimates presented in the Union Budget for the current fiscal. Commenting on the CGA data, Aditi Nayar, Chief Economist, Head - Research & Outreach, Icra said that while tax revenues reported a contraction of 9.6 per cent, non-tax revenues surged by 173 per cent, boosted by the RBI dividend, amidst a 4.3 per cent decline in revenue expenditure, and a 56.7



ly by global developments. For the week ended June 23, the foreign currency assets,

a major component of the reserves, decreased by USD 2.212 billion to USD 525.44 billion, according to the Weekly Statistical Supplement released by the RBI on Friday.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves. Gold reserves dropped USD 745 million to USD 44.304 billion, the RBI said.

Mumbai. SBI is the only authorised bank to issue electoral bonds. An electoral bond will be valid for 15 days from the date of issuance. No payment will be made to any political party if the bond is deposited after the expiry of the validity period, the statement said.

Electoral bonds can be purchased by Indian citizens or entities incorporated or established in the country. Registered political parties that have secured not less than 1 per cent of the votes polled in the last Lok Sabha or legislative assembly election are eligible to receive funding through electoral bonds.

### Govt: tomato prices will cool down in next 15 days PNS 📕 NEW DELHI

¬omato prices are expected to cool down in the next 15 days with increase in supplies from producing centres and reach a normal level in a month, a top government official said, as retail prices of the kitchen staple shot up over Rs 100 per kg in major cities.

Consumer Affairs Secretary Rohit Kumar Singh, in a media briefing, also said the retail prices of tomato in the national capital will come down immediately on improved supplies from Solan and Sirmaur districts of Himachal Pradesh.

"The phenomena of price rise in tomato happens every year at this time. Every agriculture commodity in every country goes through a seasonality in the price cycle. In June, prices reached a high level," he said.

Tomato is also a highly perishable commodity and weather vulnerability, which has become prevalent in the recent times due to climate change and other issues, has disturbed



the supplies, he added. The secretary further said, "You cannot store tomato for a long time and transport it for a long distance. There is an inherent vulnerability in the commodity. Transportation is also a big issue."

June-August and October-November are also lean production seasons and prices in this period normally see a sharp increase, he said. Âll India average retail

price of tomato on June 29 was ruling at Rs 49 per kg as against Rs 51.50 per kg in the year-ago same day, he said, and added, "I am not justifying the rate. This also proves seasonality."

Stating that it's a complex problem, the secretary said, however the government is handling it and finding a solution to streamline the supplies throughout the year. For this, a Grand Tomato Challenge was launched on Friday.

It is like a hackathon where ideas are being invited from students to industry stakeholders on primary processing, storage and valorisation of tomato, he said.

Agri Ministry told to give incentive to kharif onion: Consumer Affairs Secv PTI 📕 NEW DELHI

The Consumer Affairs Ministry has asked the Agriculture Ministry to give more incentive and impetus to kharif onion during the festival period in the winter season to avoid any spike in prices, a top government official said on Friday.

Normally, onion prices shoot up during the winter season, as stored rabi onion gets exhausted and fresh kharif onion cannot be stored. Currently, the sowing of kharif onion is underway.

Briefing media, Consumer Affairs Secretary Rohit Kumar Singh said the kharif onion plays a critical role during the festival period in winter.

"To ensure availability during that time, we have requested the agriculture ministry to give more incentive and impetus to kharif onions. This point was emphasised in the meeting of the cabinet secretary yesterday," Kumar said

The country's onion production is estimated at 319 lakh tonne in the ongoing 2023 calendar year, slightly lower than 324 lakh tonne in the previous year, he said. Onion is produced in two seasons - rabi and kharif/late kharif seasons. The rabi crop of 219 lakh tonne has already arrived, the remaining 100 lakh tonne will come in kharif and late kharif, which will meet the onion demand in the winter season, he added.

"Out of 319 lakh tonne, a big supply of 219 lakh tonne from rabi season is already with us. From this, the government has procured 3 lakh tonne for buffer stock.

## Rupee closes at 82.03 against US dollar as rate hike worries cap gain

The rupee\ closed flat at 82.03 (provisional) **L** against the US dollar in a restricted trade on Friday amid a rally in the domestic equities and firm crude oil prices. 
