Eight senior NCP leaders sworn-in as Mins in Maha Govt

In the third major political earthquake that rocked Maharashtra in three-and-ahalf years, senior NCP leader and leader of the Opposition in Maharashtra Ajit Pawar on Sunday rebelled against his uncle and his party chief Sharad Pawar, walked out of the party with a sizeable number of supporters and took oath as Deputy Chief Minister in the Eknath Shinde-led Shiv Sena-BJP alliance Government.

Sunday's development which saw eight senior NCP leaders who had joined Ajit Pawar in his rebellion, being sworn in as Ministers in the Shinde-led Government stunned not just Sharad Pawar but the entire Maha Vikas Aghadi (MVA) that suffered a similar body blow when Shiv Sena leader Eknath Shinde revolted against his party president Uddhav Thackeray and teamed up with senior BJP leader Devendra Fadnavis to topple the MVA Government and form a new Government in June last year.

Major Cabinet rejig likely soon; PM to hold meeting today

Dharmendra Pradhan, Bhupendra Yadav may be moved for BJP's organisational reboot before 2024

The expected rejig in the Narendra Modi Cabinet may see the Prime Minister move some of the bigwigs like Dharmendra Pradhan and Bhupendra Yadav to the party organisation to do the nuts and bolt strategy in the run-up to the Lok Sabha polls.

The Council of Ministers

with Prime Minister Narendra Modi at its head is to meet on Monday. The impending reshuffle this week may include members from the current allies as also those "re-joining" the BJPled National Democratic Alliance (NDA) which, incidentally, is completing 25-years of its existence. The NDA was formed in 1998. The Prime Minister is also holding meetings with the State leaders as the rejig in the Cabinet may include members from the States going to polls later this year like Madhya Pradesh, Rajasthan, Chhattisgarh

and Telangana. like Bihar, States Maharashtra, Punjab, Andhra Pradesh and Tamil Nadu could be on the Prime Minister's radar while he makes changes in the Cabinet and includes new faces, sources indicated

Union Ministers Pradhan who was election-in-charge of Karnataka and Yadav, may be joining the party organisation to 'strengthen' the hands of Union Home Minister Amit Shah who is overall "strategising and micromanaging" for the party in the Lok Sabha polls.

Lok Jan Shakti party leader Chirag Paswan may be included in the Council of Ministers to consolidate the BJP's Dalit turf in Bihar where it is facing a stiff challenge from the mahagathbandhan of the Rashtriya-Janata Dal (United), Congress and the left parties. Shah is also working towards a patch-up between Chirag and his uncle Pashupati Kumar Paras, they said. The reshuffle in the Modi Cabinet, happening after two years, could witness dropping of some of the Ministers who would "not be contesting Lok Sabha polls" or not be given party tickets, sources

Fresh wave of violence hits Manipur

3 village volunteers killed, 5 hurt in attack by militants

PNS IMPHAL

t least three "village vol-Aunteers" were killed, and five others sustained injuries in a fresh wave of violence in Manipur. The region has been experiencing ongoing turmoil for the past two months due to ethnic clashes between the Meitei community, predominantly residing in the valley, and the Kuki tribe, which predominantly inhabits the hills.

The 'latest incident occurred around 4 AM in the tribal villages of Langza and Chinglangmei

Churachandpur, located approximately 70 km southeast of Imphal. According to sources, the "village volunteers" were stationed in a makeshift bunker, diligently protecting the area.

Chief Minister N Biren Singh, who had offered his resignation earlier this week before retracting it, visited the affected area and shared images



depicting the situation.

Security forces are present at the scene and have initiated a combing operation to apprehend the militants responsible

Will recover ₹55 lakh spent on Ansari in jail fire victims done from Captain: Mann

Punjab Chief Minister Bhagwant Mann on Sunday declared that the State Government will not pay Rs 55 lakh spent on the "cozy stay" of Uttar Pradesh-based dreaded criminal Mukhtar Ansari in the State's jails and the amount will be recovered from former Chief Minister Captain Amarinder Singh and former Deputy Chief Minister and Jails Minister Sukhjinder Randhawa

At the same time, the Chief Minister also made it clear that in case, the two failed to pay the amount, "their pensions and other benefits will be stopped to recover this money".

In an statement, Mann said this was a serious crime against the State and its people and those involved in it will have to pay for it.

"For reasons best known to them, both Captain and Randhawa extended largesse to notorious gangster for his comfortable stay in jails of Punjab Why should the State waste taxpayer's money in this way just because those in power at that time had a strong bond

with Ansari," he said. Notably, during Capt Amarinder's regime, Ansari was lodged at Ropar jail in connection with an extortion case from January 2019 to April 2021. At that time, senior Congress leader Randhawa was heading the Jails Department.

Ansari was brought to Punjab on a transit remand from UP in connection with an FIR accusing him of seeking a ransom of Rs 10 crore from a builder in Mohali's Sector 70. However, the challan regarding the same was never presented

in the court. 'This is brazen loot of the public money which cannot be tolerated. For reasons best known to the previous regimes, this notorious criminal was kept in Ropar Jail with full comforts. Apart from ensuring comfortable stay, the State Government ensured that this hardcore criminal does not face any sort of difficulty within the jail and escapes the legal action against him," said Chief Minister Mann.
The Chief Minister said

surprisingly, the then Government spent Rs 55 lakh of tax-payers' money to safeguard the interests of this criminal lodged in Ropar Jail.

'This atrocious loot of the public money is totally unwarranted and undesirable...This open plundering of the common man's money cannot be tolerated at any cost," he declared.

"Captain and Randhawa will have to pay this money from their own pocket else their pensions and other benefits will be stopped to recover this money," he said, adding that everyone involved in this heinous crime will be made accountable for their sins.

Unplanned dev sank Joshimath, people's livelihood: Study

Unplanned infrastructure development, inadequate drainage and excavation of roads through unstable debris slopes accelerated the instability and land subsidence in the historical Himalayan town of Joshimath in Uttarakhand. These are the findings in the study 'Unstable slopes and threatened livelihoods of the historical Joshimath town, Uttarakhand Himalaya, India, published in the latest edition of Current Science journal

The study was conducted by Indian geologists and scientists between August 2022 and January 2023 when the region reported land subsidence resulting in the evacuation of the locals from their houses. SP Sati, a senior geologist and head of department of basic and social science, College of Forestary, Ranichauri said, "As an imme-

diate measure, there should not be any excavation activities, par ticularly of the precariously balanced crystalline boulders. The landslide deposits contain moderately fine grains (pebbly sand), which act as the filling material between the boulders.

"It has been observed that there are cavities (mimicking potholes) on the surface which we speculate are caused due to the selective removal of fine sediments by unregulated domestic wastewater drainage. In recent times, these cavities are posing a serious threat to the stability of the built-up structures in



The opposition parties have been asking for deployment of at least half section (numbering four) CAPF in polling booths, demand which have been endorsed not only by the Calcutta High Court but also the Supreme Court.

The Calcutta High Court earlier directed the Commission to deploy more CAPF than was deployed in 2013 panchayat elections leading the Commission to seek 825 companies of central forces. However, sources in the Union Home Ministry wonder whether it would be possible for the Centre to deploy as many security forces without breaking the singlephase election process to multiple phases a la 2013.
"We are not closing our

UCC: Congress will protect interest of countrymen, says Pramod Tiwari

Senior Congress leader and Rajya Sabha member Pramod Tiwari, on Sunday, said the Congress would fully protect the interest of 140 crore Indians in the monsoon session of Parliament by opposing implementation of uniform civil code (UCC).

"Congress will not allow any attempt of the Central government to succeed at any cost to play with the sentiments of all the communities of the country, including Hindus, Muslims, Sikhs and Christians, for electoral gains," Tiwari asserted here on Sunday.

"The interest of the country has always been paramount for the Congress and on the contrary, the Bharatiya Janata Party has always been trying to weaken the country through the politics of polarisation for electoral gains," Tiwari said.

He said that before the gov-

ernment brought out the draft of the proposed uniform civil code in the monsoon session, the viewpoint of the Congress and the opposition parties over the issue should come to the

Clarifying the agenda of the Congress and the opposition in the monsoon session of Parliament, Tiwari said the issue as to how Manipur was

Mayawati: BSP supports UCC but is against 'politicising' it

Bahujan Samaj Party chief Mayawati on Sunday said her party was not against implementing uniform civil code (UCC), which she believed would "lead to communal harmony" but slammed the Bharatiya Janata Party for "politicising" the issue.

Mayawati's remarks came after Prime Minister Narendra Modi at a recent programme in Bhopal in Madhya Pradesh pitched for a uniform civil code in the country.

"Our party (the BSP) is not against the implementation of



UCC. But we do not support the way BJP is trying to implement uniform civil code in the country. It is not right to politicise this issue and forcefully implement UCC in the country," 67-year-old Mayawati, a former chief minister of Uttar Pradesh, told reporters here on

According to the BSP national president, the implementation of UCC will strengthen the country and unite Indians. "It will also develop a sense of brotherhood among people. However, the forceful implementation of UCC is not right. Politicising this issue will create problems," she said.

'The uniform civil code is already mentioned in the Constitution. But the Constitution does not support imposing it. The BJP should have considered all the dimensions related to UCC," the BSP

BJP-Apna Dal(S) alliance has rid UP of divisive SP, BSP: Shah

Union Home Minister Amit Shah on Sunday made a strong pitch for consolidation of backward class voters in Uttar Pradesh ahead of the 2024 Lok Sabha elections, saying the state had got completely rid of the "divisive forces" of Samajwadi Party and Bahujan Samaj Party after Bharatiya Janata Party and Apna Dal (Sonelal) joined hands to win four elections in the state.

Paying glowing tributes to Apna Dal founder Dr Sonelal Patel on his 74th birth anniversary at Indira Gandhi Pratishthan here on Sunday, Shah lashed out at the SP and the BSP while underlining the credentials of the BJP as a party devoted to the welfare and uplift of the poor disadvantaged groups, Scheduled

Shah said the BJP in alliance with the Apna Dal (Sonelal) had won two Lok Sabha elections and two state assembly polls in Uttar Pradesh since 2014 and the BJP in alliance with Apna Dal (Sonelal) and NISHAD party would again win the 2024 Lok Sabha election in UP and Narendra Modi would be the prime minister for the third term with over 300 seats in Lok Sabha. The Delhi government's Excise department has earned nearly Rs 1,700 crore in excise duty and value added tax in the first quarter of 2023-24, official data showed. In the 2022-23 fiscal, the

department had raked in Rs 6,821 crore by selling over 62 crore bottles of liquor. The amount included Rs 5,548.48 crore as excise duty and Rs 1,272.52 crore as value added tax. The Excise department expects the revenues to increase in the next few months with the opening of more liquor shops.

Beer sale has dropped in May by 52% in May this year as compared with 2022 due to the weather, less variety and brand push, non-availability of chilled options at shops, less stock in stores and companies diverting the product to states where the margins are higher. "Beer is preferred during the which is why the revenue collection in the first half is always



relatively lower as compared to the second half of the financial year when whisky sells more," said an official.

Delhi sold 83 lakh liters of beer in May this year as opposed to 173 lakh litres during the same month last year. The first five months of 2023 saw beer sales of 311 lakh litres, almost 43% down from the same period last

CM0: Civil services body reduced to farce

'Bureaucrats overturning CM's decisions'

The Chief Minister's Office (CMO) on Sunday said the National Capital Civil Services Authority (NCCSA) set up by the Centre through an ordinance to control transfer of officers working under the Delhi Government has been reduced to a "complete farce", allowing bureaucrats to overturn decisions taken by an elected Chief Minister and dictating their own will.

The statement came two days after the second meeting of the NCCSA during which two member-bureaucrats "did not oppose" Chief Minister Arvind Kejriwal's stand but later on cancelled his decisions.

The three-members NCCSA was set up by the Centre through the National Capital Territory of Delhi (Amendment) Ordinance, 2023, promulgated on May 19 to create an authority for transfer and posting of Group-A officers in Delhi

It comprises the chief minister as chairperson, with the chief secretary and principal



secretary (home) as members. It was bestowed with powers to take decisions by a simple

"However, this simple majority has enabled the bureaucrats to override the CM's decisions, effectively granting them unchecked power over the authority's operations. Consequently, the Chief Minister's voice, representing the will of the elected government and the people of Delhi, finds itself in the minority within the NCCSA," the CMO said in the statement.

During the June 29 meeting, Kejriwal expressed concerns over pending transfer-posting proposals and issued directives for request transfers of women officers. He also recorded objections to the removal of "competent officers" from the Education Department, the statement

Eleven women officers had requested for transfers on sympathetic grounds, it said, adding the chief minister supported it, noting that working women handle both office and home, and therefore their pleas must be considered

The statement claimed the two bureaucrats did not oppose the CM's stand during meeting. "However, regrettably, when finalizing the minutes of the meeting, the Chief Secretary and Principal Secretary (Home) callously overturned all of the Chief Minister's decisions, proceeding with their own agenda

As a result, the 11 women officers have been denied transfers despite compelling reasons, and competent officers are being removed from the Education Department, jeopardising the progress made thus far, the statement noted.

"The National Capital Civil Service Authority has been reduced to a complete farce with bureaucrats dictating their own will and overturning CM's decisions," the statement said, alleging a "carefully orchestrated" plan to undermine Delhi's education revolution and impede the elected government's achievements. It is functioning under the stated chairpersonship of the chief minister even though none of the decisions made by it align with the CM's endorsement, the statement said.

"In the same meeting, the Chief Minister proposed that the posting requests made by Ministers Saurabh Bharadwaj and Raaj Kumar Anand be recommended by the Authority. However, the bureaucrats again took advantage of their majority and refused to entertain the matter in the meeting," it said.

The first meeting of the NCCSA was held on June 20. Addressing a press conference following the first meeting of the NČCSA, Kejriwal had termed the delay in approving of minutes a "farce" and a "conspiracy to not let the elected government do any work in Delhi."

He claimed that through the NCCSA, the Centre wants to make it look like the body takes important decisions for Delhi mutually. But in reality, that is not the case, he had claimed.

The Centre's National Capital Territory of Delhi (Amendment) Ordinance came a week after the Supreme Court handed over the control of services in Delhi — excluding police, public order and land — to the city's elected government.

Act against officers responsible for death of man, Atishi tells LG

In yet another case of electrocution, a labourer was electrocuted while working at an under-construction building on the premises of the Lok Navak Îai Prakash (LNIP) Hospital on Sunday morning.

After the victim got the electric shock, his co-worker took him to the emergency ward of the LNJP hospital around 9 am where he was declared brought dead, a senior

police officer said. The incident site was inspected by forensic experts and a crime team of the Delhi Police, the officer said, adding that necessary legal action will be initiated.

The deceased has been identified as Suieet Kumar, a resident of Samastipur in Bihar. the police said.

According to a senior doctor of the LNJP Hospital, the labourer got electrocuted at the construction site of a 22storeyed building that is being built between the GB Pant and LNJP hospitals.

The site is owned by the Public Works Department and once the building is ready, it

Bullet train project: 3 river bridges built in 1 month in Guj

Making a significant progress, the National High-Speed Rail Corporation Limited (NHSRCL) has constructed three river bridges in a period of one month for the Mumbai-Ahmedabad High-Speed Rail (MAHSR), also known as the bullet train pro-

Sunday, the NHSRCL said that all these bridges are in Gujarat and are located between Bilimora and Surat stations of the bullet train.

The first river bridge was completed on Purna river in Navsari district. The 360-mlong bridge consists of nine full span girders. Continuous monitoring of high and low tides from Arabian Sea was done during the construction. The foundation work was challenging as water level in the river would rise 5-6 m during high tides, it added.

The second river bridge was completed on Mindhola river, also in Navsari district. It is 240-m-long and has six full span girders

The third river bridge was completed on Ambika river, again in Navsari district.

This 200-m-long bridge has five full span girders. The construction of the third bridge was a challenging task as there was a steep slope of the river bank and underground rocky strata during piling, the NHSRCL said.

In total, there will be 24 river bridges on the MAHSR corridor in Gujarat and Maharashtra, of which 20 are in Gujarat and four are in Maharashtra. So far, four river bridges have been completed for the MAHSR corridor in the past six months.

The longest river bridge (2.28km) will be constructed on Vaitarna river in Maharashtra, another 1.2-km-long bridge is being con-structed on Narmada river, In the statement, Rajendra

Prasad, Managing Director, NHSRCL said that construction of bridges over the rivers is very challenging and meticulous planning is required.

During the construction of bridges over Mindhola and Purna rivers, the tides from the Arabian sea were closely monitored.

"Our engineers worked at a height of 26 m for the construction of the bridge over Ambika river," he said

High-speed trains on Mumbai-Ahmedabad High Speed Rail Corridor will operate at a speed of 320 km/hour covering a distance of 508 km and 12 stations

There will be 35 trains per day in one direction, with a frequency of 20 minutes in peak hours and 30 minutes in non-peak hours.

The total length of the bullet train corridor is divided into three states/UTs - 156 km in Maharashtra, 4 km in Dadra and Nagar Haveli and 384 km in Gujarat.

The work on the country's first bullet train started in 2017 September Ahmedabad, Gujarat. Prime Minister Narendra Modi and former Japanese Prime Minister late Shinzo Abe jointly laid the foundation stone for the project.

The IMD data showed some other states such as Uttar Pradesh. Maharashtra, Karnataka, Jharkhand, Andhra Pradesh and Telangana also received less rainfall than what is normal for June, the first month of the southwest mon-



soon season.

The south peninsula received 45 per cent less rainfall; Central India received 12 percent less rainfall and east and northeast India's rain deficient is 20 percent in June.

"The monthly rainfall averaged over the country as a whole during July 2023 is most likely to be normal (94 to 106 per cent of LPA) and most probably within the positive side of the normal," IMD Director

General Mrutyunjay Mohapatra had said on Friday. The phenomenon of warm-

ing of the equatorial Pacific Ocean, called the El Nino conditions, are expected to develop in July. El Nino is known to suppress monsoon rainfall.

Mohapatra said during most of the recent El Nino years, June rainfall has been within the normal range. "In 16 of the 25 years when

June rainfall was below normal, July rainfall has been reported normal," he had said.

He said 377 weather stations across the country reported heavy rainfall events - 115.6 mm-204.5 mm per day - in June, while 62 stations reported extremely heavy rains, amounting to more than 204.5 Mohapatra had said the

March-to-June summer season saw heatwave conditions across 281 meteorological sub-division days (MSD), the third highest after 578 MSDs in 2010 and 455 MSDs in 2022. If one meteorological sub-division reports heat wave conditions, it is considered as one MSD.

The weather office said during July, normal to above normal maximum temperatures were likely over most parts of the country except some areas of northwest and peninsular India.

NIA raids multiple places in 3 States in 'Ghazwa-e-Hind' case

The National Investigation ▲ Agency (NIA) on Sunday conducted raids at multiple locations across three States in connection with 'Ghazwa-e-Hind', a radicalised module, being run by Pakistan-based suspects

A total of five locations, one in Darbhanga and two in Patna, both in Bihar, one each in Surat (Gujarat), and Bareilly (Uttar Pradesh), were raided by the NIA in the case at the premises of the suspects, the NIA said.

The NIA said incriminating materials, including digital devices (mobile phones, memory cards), SIM cards and documents were seized during the searches.

The case came to light after the arrest of Marghoob Ahmad Tahir of Danish alias Phulwarisharif area of Patna district by the Bihar Police, which registered it as FIR number 840/2022 on July 14, 2022.

The NIA took over the case and re-registered it on July 22, 2022. Marghoob was chargesheeted on January 6, 2023 under various Sections of the Indian Penal Code (IPC) and Unlawful Activities (Prevention) Act.

'The accused was found to be

a member of the Ghazwa-e-Hind module, which was operated by Pakistan-based operatives, with the objective of radicalizing impressionable youth for the establishment of Ghazwa-e-Hind over the Indian territory," the NIA said in a statement.

Investigations revealed that Marghoob was the administrator of a WhatsApp Group 'Ghazwae-Hind', created by a Pakistani national Zain. He had added many Indians, Pakistanis, Bangladeshis and Yemeni nationals to the Group with the aim of establishing sleeper cells in the country for carrying out terrorist activities, the agency said.

The accused had created various social media groups of the 'Ghazwa-e-Hind' on WhatsApp, Telegram and BiP Messenger. He had also created another WhatsApp group in the name of 'BDGhazwa E HindBD' and had added Bangladeshi nationals to it, it said.

Further investigations revealed that various suspects involved in the case were in contact with Pakistan-based handlers and were engaged in propagating the idea of Ghazwa-e-Hind. Further NIA investigations in the case are in progress,

study has cautioned. The authors of the study published in JAMA Network said that excessive gestational weight gain can increase the risks of development of diabetes and other com-

The conclusion followed after meta-analysis of almost 100 studies involving almost 35,000 expectant mums and it was found that interventions from allied health professionals was most effective for controlling prenatal weight

"Pregnant women may be better supported by trained dietitians to control weight gain during pregnancy, " said the research team including maternal health expert Professor Shakila Thangaratinam from the University of Birmingham.

Spanning 30 years of international evidence, the researchers found that between 6 and 20 sessions on a one-to-one basis were

Campaign to identify eligible couples for family planning

 ${f I}$ n an attempt to bring down the Prayagraj district's Total Fertility Rate (TFR) from 2.4 to 2.1, the officials of the Health department have taken up an extensive campaign to identify eligible couples for family planning under the population stabilisation fortnight exercise. Ironically, Prayagraj is the most populous district of state and its TFR is more than state of UP

(TFR) of a population is the urban pockets including FST (that would be born to a female over their lifetime if they were to experience the exact current age-specific fertility rates through their lifetime they were to live from birth until the end of their reproduc-District Programme

Manager (National Health Mission) Vinod Kumar Singh said, "After Prayagraj being placed as most populous district in the state as per the census authorities of the Health department have taken up an extensive campaign to identi-ty eligible couples (those couples who have completed their families) in all 21 blocks and urban pockets of the district to promote family plan-

ning. He said, "Basic health workers i.e. ASHA, ANMs and Aganwadi workers are knocking the doors to identify eligible couples in villages, blocks and urban areas and convincing them for family planning methods to restrict

tion of eligible couples will be done till July 10.

Singh said "After the identification of eligible couples and maintaining eligible couple registers, the Health department will take up the use of safe and secure family planning methods, both temporary and permanent, including family stabilisation treatment, NSV, IUCD, PPIUCD and Antara among eligible couples. Singh said "The department has also set an estimated level of The total fertility rate achievements block wise and (4,800), PPIUCD (1,123) and Antara (2,989)

A senior health official said, "We are persistently approaching and convincing eligible couples telling them the benefits of small family." He said, "Health officials are exhibiting various methods of family planning and awakening masses about reproduction rate, child health and HIV."

Health officials said counselling is an important factor to convince eligible couples for family planning methods and teams of doctors will be doing the same during the fortnight at government hospitals and community health centres.

Interestingly, health workers concerned are focusing on high fertility areas for population stabilisation fortnight. Health authorities are focusing on efforts to create awareness and persuade eligible couples to have smaller families for the betterment of health of mother, child and the entire

contributed to the lowering of fertility rate includes improving literacy levels, empowerment of women, delaying of the first child birth, enhancement in the compensation package for sterilisation, encouraging male participation in sterilisation and involving village level community health workers in promoting family planning. Meanwhile, health officials also laid stress over pre-marital counselling for to-be-married couples regarding family size and gap between two children. There should also be councometo hospital either for immunisation or for treatment of children and counselling and services of postpartum intrauterine contraceptive device (PPIUCD) before discharging them from maternity wards.

Although women are a step ahead in adopting family planning measures, officials of the Health department are now promoting and encouraging males for no-scalpel vasectomy (NSV), terming it a safe and sound method for family planning. In fact, the department has come up with 65' (advantages) of NSV, including scalpel-less, stitch-less, safe, sound, simple and short formu-

Recent riots bring to the fore the ugly face of racial discrimination

s the tempers ease, unease settles in France after almost a week of rioting that started after the alleged gunning down of Nahel, a boy of Algerian descent by a French policeman for allegedly not having a driver's license and breaking the signal. French President Emmanuel Macron has appealed for calm amid heavy police deployment. France is far from being the peaceful country that it once used to be. A simmering discontent in its streets often erupts in violent protests which this time took the shape of a full-fledged riot. France, known for its rich cultural heritage and vibrant society, has recently experienced a wave of riots that have captivated the world's attention. From the streets of Paris to the suburbs of Marseille, protests and violent clashes have disrupted the tranquillity, raising questions about the underlying causes and motivations behind these events. One of the primary causes fuelling the riots in France is social inequality and economic discontent. While France enjoys a high standard of



living, there is a stark divide between different segments of society. Many protesters argue that the Distribution of wealth and opportunities is heavily skewed, leaving a significant portion of the population struggling to make ends meet. point of view has been projected in the national dailies that love jihad, and the societal reaction to it has become so frequent that it has become a leading cause of death among Indian youth. Right through history, India has not had an imperialistic or colonizing mindset and record. Yet, influence overseas is important, more so as the world is proceeding towards becoming a village.

Was it not desirable to see our Prime Minister being sought after by American President (s), seeking the vote of Indian immigrants who have become citizens of the United States of America? In case we are apprehensive of a brain drain, preventing or discouraging emigration is hardly the step to resort to. We have a population huge enough to be able to absorb emigration of any size. What we do not have in adequacy are the educational facilities, in quantity as well as quality to educate and train the young population.

In fact, in the basket of education, we should include the teaching of foreign languages. For example, it is believed that at the current rate of decline in population, there would be no Japan lett in another nunarea years. Our aspiring youth should consider learning how to live and flourish in Japan. As far as population goes, Russia has already

fallen to becoming a country smaller than Pakistan.

Industrial collaboration helps scientific research



National Research Foundation (NRF) bridges the gap between the research instituions and the industry

¬he recently approved National Research Foundation (NRF) Bill, 2023 will be a landmark decision in facelifting Indian science. The passage of this bill will allow for the creation of National Research Foundation (NRF) to nurture, grow, and promote R&D and encourage a culture of research and innovation across India's academic institutions. The National Research Foundation (NRF) is supposed to facilitate cooperation between various sectors, including the private sector, academic institutions, government agencies, and research organisations. Even though Indian researchers do world-class research and are at the top in the number of scientific publications, there is hardly any industrial contribution to our research. This has badly affected the credibility of our scientific community.

Most of the time our researchers do research either to fulfil the minimum requirements of their doctoral program or to satisfy the needs of the funding agencies. Public respects science only



They are not at all concerned whether a scientist has highimpact publications or not.

Whatever great things our researchers do in their labs, if it's not delivered to community people they start criticizing the scientific community. It's not always possible for scientists to develop products out of their research. For example, many labs that are undertaking fundamental research, especially in areas like ecology, systematics, cell biology etc. may not directly contribute to the development of products. But these types of research also have wide applications for humanity and we need to promote researchers

working in basic science. The research will have to reach only when some industry takes the research output when scientific research finds for developing a product. Whether it is the 'Chitra Heart-valve' developed by Sree Chitra Thirunal Institute of Medical Sciences and Technology or 'Jeevani' developed by Tropical Botanical Garden and Research Institute or any product that we see in the market, e.g., food products, medicines, home appliances etc, is the output of scientific research.

Premier research institutions and universities have long been collaborating with industries, in fact, many companies closely monitor the discoveries from these labs. But for lesser-known institutions finding an industrial partner is mostly a difficult task, even if they do credible research. With NRF this gap will be minimized. Out of the allocated ?50,000 crore for the NRF the government plans to raise ?36,000 crore through investments from industries and philanthropists, while the remaining amount will be funded by the government. The industrial collaboration will not only bring financial support to the institutions but also helps in generating more

employment opportunities in research and development. Even though industrial

collaboration will bring a lot of benefits to the scientific community, the government should check the overinfluence of industries in research. Most of the time industries will prefer to support research that involves a marketable product. This may change the research culture in the country affecting basic science research, that may not pro-

duce a product immediately. The government should give strong support to people who are working on basic sci-ence research also. Basic science research is the fuel to run the applied research. Without a strong foundation in basic science, neither the country nor the industry can prosper. Many Nobel-winning discoveries were carried out as basic research, but later they found applications in a wide range of areas. The policymakers should make sure that the industrial collaboration envisioned in NRF should not hamper our strong research foundation in basic science, the fruits of which we enjoy today in various fields of our life.

Sir —TS Singh Deo's elevation as the first Deputy Chief Minister of Chhattisgarh just a whisker away from the Vidhan Sabha elections is being billed as a masterstroke by many. Back in 2018, Bhupesh Baghel and TS Singh Deo were known as the 'Jai-Veeru' of Chhattisgarh politics. The suave Singh Deo with his princely demeanour and the rustic farmer Baghel swept the elections, reducing the Bharatiya Janata Party to an unimaginable tally.

Strong regional leaderships create a typical dilemma for national parties such as the Congress and the BJP. Balancing this essential need for strong leadership with the imperatives of party decorum is not an easy task. Mr Baghel has created a combat model- in the BJP in the heartland, which the Congress could seek to replicate in other comparable regions. But Congress can ill-afford to let success devour it. The history of the party in the State is instructive. Under the late Ajit Jogi, the first Chief Minister of the State, the party wilted as it alienated communities and its leaders. Mr Baghel's leadership was a critical factor in the revival of the party, but so were the contributions of several others, known and unknown. For it to retain power in the State, the Congress will have to hold all of them together. Mr Singh Deo's elevation is, hence, a first step in the right direction. There is more to be done, including a renewed outreach to tribal communities. But at least the Congress seems ready to project a united front in Chhattisgarh.

Agroforestry boosts agricultural ecology





Agroforestry not only improves the ecology of the agricultural domain but can salvage the economic and social condition of farmers

groforestry in simple terms is a "sustainable land-use management system" that combines the cultivation of food crops (annuals) with woody perennials (such as trees, shrubs, palms, bamboo etc.) and/or livestock on the same land-manage-

The path to the introduction of agroforestry was in fact paved by the Forest Policy itself when it declared that the community's requirement, not possible to be provided through the recorded rights and concessions on the forests, should be met by social forestry outside the reserved forests. The diversion of good and productive agricultural lands to forestry was discouraged highlighting the need for increased food production, it simultaneously emphasized that forests should not be looked upon as a source of revenue. It rather professed to encourage farmers, particularly small and marginal ones, to grow on their marginal/degraded lands wood species required for industries. The policy further advocated that the farmers be supported by forest-based industries with inputs including credit, constant technical advice, harvesting and transport services, and even by the adequate strengthening of the research base for better outputs.

The forest policy declared that the

derivation of direct economic benefit from forest must be subordinated to the need for environmental stability and maintenance of ecological balance, an overriding imperative for the sustenance of ecosystem services that support crop production and humanity. The overall attempt was towards strengthening agricultural systems along with appropriate diversification to meet the growing needs and expectations of the country and its economy. Forest, the foster mother of agriculture, had to play its role in a subtle but definite way.

India's Agroforestry Policy 2014

acknowledges that agroforestry is the only alternative to meeting the target of increasing forest or tree cover to 33 per cent of its geographical area, as envisaged in the National Forest Policy 1988. It describes agroforestry as an ecologically based natural resource management system that sustains production and has the potential to improve ecosystem services through carbon storage, reduction in damage to forests, conservation of biodiversity, and soil and water conservation enabling agricultural and to withstand extreme weather events like floods and droughts, and climate change. The emphasis on Agroforestry perhaps also came as a response to the statement in National Agriculture Policy 2000 which said, "Agriculture has become a relatively unrewarding profession." It stressed, "Farmers will be encouraged to take up farm/agro forestry".

The field situation, however, shows that economic considerations have pushed agriculture in a big way towards industrial agriculture which, in its present exploitative form, is robbing the future generations of their entitlement to resources that they are not here to defend. Intensive sugarcane cultivation dependent on water mining in the Marathwada region of Maharashtra is a case in point. Agroforestry is conspicuously different from this. As a land use system with long-term sustainability and relatively lower risks, its true potential of providing unyielding support to the economy and well-being of our farmers is yet to be realized. The operationalization of site-specific treatment models; duly developed using

local species combinations within the broadly conceptualized agri-Silvi, agri-horti, and agri-silvi-pasture systems in combination with animal husbandry; remains to be firmly institutionalized.

The Agroforestry policy outlined several obstacles that plagued agroforestry in the country. Some of these have been attempted to be addressed but a lot has still to be done. Some of the learnings from the field may help in taking future action on various aspects.

On the regulatory framework CREDIT aspect, while the Policy recommended the creation of simple mechanisms/procedures to regulate the narvesting and transit of agro forestry produce, the Tree Felling Regulation Acts in many states have been amended to exempt species mostly grown on private lands. Interestingly, as per the India State of Forest Report 2021 by the Forest Survey of India, the tree cover outside the recorded forest area is a significant contributor (721 sq. km) to the increase of 2,261 sq. km of total forest and tree cover in the country. The impact of generously removing 'Bamboo' from the definition of the tree under the Indian Forest Act 1927 just with the objective of deregulating the transit of farm-grown bamboo, however, provides a lesson. The result is the decriminalization of bamboo felling even in the Reserved Forest areas and a loss of 10,594 sq. km of bamboo-bearing area in the country as per this report. Further, there are reports from Maharashtra where farm-grown farm-grown bamboo is inputs, buying back of outputs and

difficult to sell because of the easy availability of bamboo from forests on account of unregulated removals in the name of community forest rights under the Forest Rights Act 2006. Needless to say, prior to legal interventions all possible implications on the ground must be

Better and farmer-friendly institutional credit and insurance are a must for promoting agroforestry. The major issue of non-participation of small farmers needs optimization of farm productivity coupled with the creation of a mix of livelihood opportunities and mechanisms to address gestation and prevailing perception of high-output monoculture systems must be replaced by multiple-produce-based sustainable options provided by agroforestry. Over 30 research centres of the ICAR involved in agroforestry research, with the adoption of the latest technologies, have a crucial role to play in this regard apart from the extension wing of the agriculture department.

To raise agroforestry taken up by small farmers at economies of scale, the pathbreaking example created in villages of Palamau district of Jharkhand using 'Chakriya Vikas Yojana' to aggregate the farm-related interests of farmers (including that of absentee landlords) in a transparent manner is certainly replicable. In many areas, support can be got from industries including Ayurvedic Drug Manufactures for the supply of

marketing. Certification of farmgrown produce and a pro-actively functional canalizing agency at export points will go a long way in providing better markets to the practitioners of agroforestry. The returns can also be augmented by connecting agroforestry initiatives with REDD+.

India has taken a great step by notifying the draft Green Credit Programme Implementation Rules, 2023. The concept of the Green Credit Programme in the country has identified activities for increasing the green cover as eligible for credit by naming it 'Tree Plantationbased Green Credit'. In addition, all entities registered for 'Accredited Compensatory Afforestation' as per MoEFCC guidelines, are registered with the Green Credit Registry under the Programme. This should give a boost to tree plantations under agroforestry. Needless to say, maintaining fungibility across the eight sectors identified for the programme is going to be extremely essential for sustaining the programme.

Agroforestry has a tremendous potential of not only salvaging the economic and social condition of farmers but also promises to improve the ecology of the agricultural domain making it sustainable and climate change resilient. The most crucial points, however, especially while promoting and dealing with agroforestry models adopted by farmers will be to ensure integrity, and transparency so that real benefits for local communities and biodiversity are guaranteed.

The term "Thing" in "Internet of Things" is used quite broadly. For example, a thing within the IoT could be a person with a heart monitor implant, a pet with a biochip transponder, a vehicle that has built-in sensors to alert the driver when tire pressure is low — or any other natural or manmade object that an IP address can be assigned to, thus gaining the ability to transfer data over a network.

As a result, it is becoming increasingly easy to create opportunities to directly inte-

The Internet of Things helps people live and work smarter, as well as gain complete control over their lives. In addition to offering smart devices to automate homes, IoT is essential to business. IoT provides businesses with a real-time look into how their systems really work, delivering insights into everything from the performance of machines to supply chain and logistics operations.

IoT enables companies to automate processes and reduce labour costs. It also cuts down on waste and improves service delivery, making it less expensive to manufacture and deliv-

transparency in customer transactions. As such, IoT is one of the most important technologies of everyday life, and it will continue to pick up steam as more businesses realize the potential of connected devices to keep them compet-

Over the last few years, the concept of IoT has become a vital role player across various industries. More and more businesses now look to integrate its many benefits into their network infrastructures. As per Comptia, by 2030, 500 billion gadgets will be connected to the internet. Statistics on how fast technology is advancing reveal that users will connect half a trillion devices to the internet by 2030. As per Data Reportal, 42. 5 billion people are using the internet in 2022. Statistics show that 63% of the world's population uses the Internet. Data collected by Statista reveals that Denmark, UAE, and Ireland have the highest internet penetration rates. Internet growth stats show that in 2022, Denmark, Ireland, and the UAE have overtaken the US as the number one country when it comes to internet penetration. In 2020, America had a 90% rate. Unrest continues in France, mayor's home attacked

oung rioters clashed with police into early on Sunday and targeted a mayor's home with a burning car, injuring members of his family, as France saw a fifth night of unrest after the police killing of a teenager. Overall violence, however, appeared to lessen from previous nights.

Police made 719 arrests nationwide by early on Sunday following a mass security deployment aimed at quelling France's worst social upheaval

The crisis posed a new challenge to President Emmanuel Macron's leadership and exposed deep-seated discontent in low-income neighborhoods over discrimination and lack of opportuni-

The 17-year-old whose death on Tuesday spawned the anger was laid to rest Saturday in a Muslim ceremony in Nanterre, a Paris suburb where emotions over his loss remain raw. He has been identified publicly only by his first name, Nahel.

As night fell on Saturday, a small crowd gathered on the Champs-Elysees to protest his death and police violence but met hundreds of officers with batons and shields guarding the avenue and its boutiques. In a less chic Paris neighbourhood, protesters set off firecrackers and lit barricades on fire as police shot back with tear gas and stun grenades.

A burning car hit the home of the mayor of the Paris suburb of l'Hay-les-Roses. Several schools, police stations, town halls and stores have been targeted by fires or vandalism in recent days but such a personal attack on a mayor's home is

Mayor Vincent Jeanbrun said his wife and one of his children were injured in the 1:30 a.m. attack while they were sleeping and he was in the town hall monitoring the violence.

Jeanbrun, of the conservative opposition Republicans

party, said the attack represented a new stage of "horror and ignominy" in the unrest, and urged the government to impose a state of emergency.

Regional prosecutor Stephane Hardouin opened an investigation into attempted murder in the attack, telling French television that a preliminary investigation suggests the car was meant to ram the house and set it ablaze. He said a flame accelerant was found in a bottle in the car.

Prime Minister Elisabeth Borne went to l'Hay-les-Roses to meet Jeanbrun along with Interior Minister Gerald Darmanin and other officials, and promised that "we're going to do everything to bring order back as soon as possible."

Macron planned to hold a special security meeting Sunday evening with Borne, Darmanin and the justice min-

Skirmishes erupted in the Mediterranean city of Marseille but appeared less intense than the night before, according to the Interior Ministry. A bolstered police contingent arrested 55 people there. Nationwide arrests were

lower than the night before. Darmanin attributed that to "the resolute action of securi-

More than 3,000 people have been detained overall since Nahel's death. The mass police deployment has been welcomed by some frightened residents of targeted neighbourhoods and shop owners whose stores have been ransacked — but it has further frustrated those who see police behaviour as the core of France's curruent crisis.

The unrest took a toll on Macron's diplomatic standing. On Saturday, a day before he was scheduled to depart, he postponed what would have been the first state visit to Germany by a French president in 23 years.

Hundreds of police and firefighters have been injured in the violence, although authorities haven't said how many protesters have been hurt. In French Guiana, an overseas territory, a 54-year-old died after being hit by a stray bullet.

No police officers were injured.

On Thursday, about a dozen people were detained in the Belgian capital, Brussels, and several fires were brought under control.

n't comply with traffic stops were fatally shot by French police last year, and three this year, prompting demands for more accountability. France also saw protests of police violence and racial injustice after George Floyd's killing by police in Minnesota.

Four security personnel killed in Balochistan

A t least four security person-nel and a terrorist were killed in an exchange of fire between them in Pakistan's restive Balochistan province on Sunday.

The attack took place in Dhana Sar area in the province.
Sherani Deputy

Commissioner (DC) Bilal Shabbir confirmed the fatalities, adding that the exchange of fire between the security forces and the terrorists continued for almost two hours.

Three police officials and security personnel were killed in the attack in the Sherani subdistrict, Shabbir said, adding that a terrorist was also killed.

DC Shabbir added: "The companions of the injured terrorists succeeded in taking them away. The body of the dead terrorist has been handed over to the CTD (Counter-Terrorism Department).

'The terrorists were well armed and they attacked the checkposts after which the police and security responded and the firing lasted for some two hours," he said.

"One security personnel was also injured but is out of danger," Shabbir said.

He further said that the bodies of those killed have been taken to Zhob District Headquarters Hospital.

Stating that law enforcement agencies have cordoned off Dhana Sar and the surrounding areas, the DC added that the CTD has collected evidence from the incident's site and has initiated its probe.

Meanwhile, Sherani District Health Officer Dr Daulat Khan has said that a state of emergency has been put in place at the Zhob Civil Hospital and that all hospital staff had been called to duty despite the weekend.

Balochistan Chief Minister Mir Abdul Quddus Bizenjo condemned the "rocket attack and firing" on the checkposts and expressed his grief on the killing of the four security per-

He also lauded the police's and the FC's efforts in killing one terrorist. "The terrorists cannot demoralise the security forces by their cowardly actions," he said in a statement.

'The sacrifices of the security forces are a beacon for the nation. The security forces are ensuring the security of the country and the nation with their firm determination and courage," Bizenjo added.

However, no one immediately claimed responsibility for the attack.

Pakistan has seen an uptick in terror activities, especially in Khyber Pakhtunkhwa and Balochistan, after the outlawed TTP ended its ceasefire with the government in November

A day ago, a police constable was injured in a hand grenade attack at the "smart" police station of Karachi.

On June 24, a police official was killed and two more were injured in a suicide attack on a police van in Balochistan's

Meanwhile, Pakistan police on Sunday arrested a senior commander of the banned Tehreek-e-Taliban Pakistan (TTP) and thwarted a terror attack on law enforcement agencies in Multan of Punjab province. Counter Terrorism Department (CTD) of Punjab Police said that they received a tip-off that a top TTP commander was present in Multan following which a joint operation of the CTD, police and an intelligence agency was launched.

"During the operation, the raiding team surrounded the whereabouts of the terrorist in Multan and arrested him. He has been identified as Kamal and shifted to an unidentified location for interrogation," the CTD said. It said Kamal was an "important commander" of TTP in south Punjab who was in charge of the outfit's operations in the region. He wanted to target the security personnel

Baltimore mass shooting: 2 dead, 28 injured

Two people were killed and 28 were wounded in a mass shooting in Baltimore on Sunday morning, including three who are in critical condition, police said. Baltimore

Department Acting Commissioner Richard Worley confirmed there were a total of 30 victims during a press coning took place just after 12:30 am at a block party in the Brooklyn Homes area of South Baltimore in the 800 block of Gretna Avenue, Worley said.

All of the victims were adults. Nine victims were transported by ambulance and 20 victims walked into area hospitals with injuries from the shooting, Worley said.

"I want those who are

responsible to hear me, and hear me very clearly," Mayor Brandon Scott said at the scene. "We will not stop until we find you, and we will find you. Until then, I hope that every single breath you take, that you think about the lives that you took, think about the lives that you impacted here tonight." No arrests were made immediateafter the shooting. Scott asked anyone with information to come forward to assist investigators locate the "cowards" who were responsible for the shooting. "Treat this as if it were your family," Scott said.

Man pleads guilty to killing Indian-origin girl

London (PTI): A Tunisian man who had been charged with the murder of Indian-origin student Sabita Thanwani at her university accommodation in the Clerkenwell area of north London in March last year has admitted to her killing in court.

Maher Maaroufe, 23, pleaded guilty to manslaughter by reason of diminished responsibility during a hearing at the Old Bailey court here on Friday and will be sentenced in September.

The court heard how Thanwani, 19, was found under the sheets with a cut to her throat on March 19 last year. According to court reports, the pros-

ecution described how Maaroufe and him days later. Thanwani had been in a relationship prior to the morning of the killing. They were at the student accommodation when a neighbour overheard various noises and screams coming from the room and called emergency services.

A post-mortem examination gave Thanwani's cause of death as sharp force trauma to the neck

Before the police arrived at the scene of the killing, the suspect had left the building but as he did so he was seen by offis wearing a balaclava, the court was told.

The Metropolitan Police had issued an urgent manhunt for Maaroufe and charged

At this week's hearing, he appeared by video link from high-security psychiatric hospital Broadmoor for the hearing and the prosecution accepted the manslaughter plea.

Maaroufe also pleaded guilty to a charge of assault by beating an emergency worker for head-butting a police officer during his arrest last year. In court, he was assisted by an Arabic interpreter and was remanded back into custody.

In a statement released at the time of her death, Thanwani's family described the student as "our angel" and said she had a "radiant smile and incredible heart".

Russia launches first drone strike on Kyiv in 12 days

fter a relative lull, Russia **A**launched a drone attack early on Sunday on Ukraine's capital, Kyiv, officials said. It was the first such attack of the war in 12 days.

All of the Iranian-made Shahed exploding drones were detected and shot down, according to Serhii Popko, the head of the Kyiv city adminis-

In addition to the city itself, the surrounding Kyiv region was targeted. Kyiv regional Gov. Ruslan Kravchenko reported that one person was wounded by falling

debris from a destroyed drone. Officials in the Ukrainian capital didn't provide an exact number of drones that attacked the city. But Ukraine's air force said that across the country, eight Shaheds and three Kalibr cruise missiles were launched by the Russians.

Further south, a 13-year-

overnight shelling of Ukraine's partially occupied southern Kherson province, said Oleksandr Tolokonnikov, spokesman for the Ukrainian administration of the province.

Ukrainian President Volodymyr Zelenskyy visited the Black Sea port city of Odesa on Sunday — the day the country honours its navy -

commander, discuss prospects for the development of a naval drone and missile program, as well as present awards to service members.

In Russia, local officials reported that air defense systems shot down a drone over the Belgorod region, which borders Ukraine, while the neighboring Kursk region faced shelling attacks. No casualties or damage were reported.

Following the drama of Wagner chief Yevgeny Prigozhin's rebellion last week Russian authorities remained defiant. Vyacheslav Volodin, speaker of Russia's lower house of parliament, the State Duma, said Sunday that Russian President Vladimir Putin came out of this situation "having strengthened his position even more both in the country and in the world."

Russian society, he said, "having passed this test, has shown its maturity." According

to Volodin, there was "not a single example of someone supporting the rebellion."

But Gen. Sergei Surovikin, the deputy commander of the Russian group of forces fighting in Ukraine, was believed to have been detained days after the mutiny.

It's not clear whether Surovikin, who has longtime links to Prigozhin, faces any charges or where he is being held, reflecting the opaque world of the Kremlin's politics and uncertainty after the revolt.

Writing on Telegram, Volodin said that the Russian president "did everything to prevent bloodshed and confusion," including explaining to Wagner fighters "the real state of affairs." "(Putin) suggested that those who want to defend Russia continue their service with weapons in their hands. As far as I know, many of them agreed to this," Volodin said.

In addition, the speaker of the State Duma said that he had

Russia faced in the past, affirming that if "someone like Putin" had been leading the country in 1917 and 1991, there wouldn't have been a revolution in Russia, and the USSR wouldn't

have collapsed. But independent observers and analysts say that Putin may come out politically weakened after first announcing that Wagner would face harsh repercussions, only to later say that the group's forces would-

n't face prosecution. Prigozhin was also allowed to leave Russia for Belarus.

Polish Interior Minister Mariusz Kaminski said Sunday that Poland would send 500 police officers to join 5,000 border guards and 2,000 soldiers already on the country's border with Belarus. It follows an announcement earlier this week that Poland would strengthen defences on its eastern border after the relocation of Wagner fighters to Belarus.

'Haiti urgently needs international help'

Secretary-General António Guterres visited Haiti on Saturday and again called on foreign governments with strong security forces to help the struggling country fight a

surge in gang violence.

The appeal was made after Guterres met with Prime Minister Ariel Henry, civil society leaders, UN staff and the heads of various political parties during his one-day

"Now is not the time to forget Haiti or weaken our solidarity with its people," he said.

Guterres met with reporters at Haiti's international airport in Port-au-Prince, who pressed him on whether an international security force would be deployed as requested by the prime minister last October.

Guterres said he spoke about the issue with Henry, as well as the need to hold cred-

"I am not here to tell Haitians what to do. I am here to listen to them and to encourage them to build consensus as broadly as possible to move the transition process forward," he

Henry, who has been running the country since the July assassination of President Jovenel Moïse, has been under pressure to hold elections. But experts have noted it is impossible to do so given the current level of violence in the country, with gangs controlling an estimated 80% of the capital

There are no democraticalelected institutions left in Haiti, with the country failing to hold legislative elections since October 2019.

"Haiti must return to democratic order as soon as possible," Guterres said.

He also said Haiti urgently needs more humanitarian

aid as poverty deepens and starvation cases spike. Gangs are preventing the movement of goods and people and controlling access to water, food and health care as civilians attempt to fight back via a violent uprising.
"I felt all the exhaustion of

population that has been facing for too long a cascade of crises and unsustainable living conditions," Guterres

"One in two people in Haiti live in extreme poverty, face hunger and lack regular access to drinking water.

Guterres' visit came just days after the UN's human rights expert in Haiti visited the country and also called for an international security force and a weapons embargo.

Guterres is scheduled to attend a summit Sunday in Trinidad and Tobago held by Caricom, a Caribbean trade

Trump's rally draws thousands in South Carolina 15,000 people had gathered by

Former President Donald Trump on Saturday marked a return to the large-scale rallies of his previous presidential campaigns, speaking to thousands gathered in the streets of a small South Carolina city on a blazing day ahead of the July

4 holiday.
"There's nowhere else I'd rather be to kick off the Fourth of July weekend than right here on Main St, with thousands of hardworking South Carolina patriots who believe in God, family and country," Trump said to a roaring crowd standing on asphalt as temperatures climbed into the 90s.

It wasn't immediately clear how many people had gathered in the streets of downtown Pickens, a small city in South Carolina's conservative Upstate of around 3,400 residents. Law enforcement officials told some media outlets that around

11 a.m., two hours before Trump's remarks.

The heavily Republican area is a popular one for GOP hopefuls as they aim to attract support for South Carolina's first-in-the-South presidential

In recent months, other candidates including Florida Gov. Ron DeSantis, former Vice President Mike Pence and biotech entrepreneur Vivek Ramaswamy have all held events in the Upstate, as well as the two South Carolinians in the race: former Gov. Nikki Haley and Sen. Tim Scott. But none drew a crowd like

Trump, whose appearance effectively shuttered Pickens' quintessential southern down-Contrasted with his 2016

and 2020 campaigns, which drew thousands to rallies in states across the country, Trump's 2024 effort has been



markedly different. Earlier this year, instead of addressing voters in a gymnasium or airplane hangar, Trump held his first South Carolina campaign event inside the Statehouse in Columbia, rolling out his state leadership team at an invitation-only gathering in an ornate lobby between the Iouse and Senate chambers.

In other states, the former president has focused his efforts on smaller events, including a series of speeches before state party organizations, as he works to bolster his standing with delegates and local officials.

This was only Trump's second large rally of the 2024 campaign. In March, he rallied in Waco, Texas, disparaging the prosecutors then investigating him on hush-money charges on which he was later indicted

- and predicting his vindication.

A planned outdoor rally in Iowa in May was canceled due to tornado warnings.

The rallies are also expensive to put on, although Trump has continued to bring in mil-lions in fundraising, after both the New York indictment and also federal charges related to his retention of classified documents after leaving the White

Syrian air defence missile explodes over Israel



Beirut (AP): Israel carried out airstrikes on areas near the central Syrian city of Homs early Sunday causing material damage but no casualties, the Syrian

military said in a statement. A Syrian anti-aircraft missile exploded over Israeli territory, the Israeli military said, prompting another round of strikes.

Syrian state media quoted an unnamed military official as saying the air defenses shot down some of the missiles fired by Israeli warplanes flying over neighboring Lebanon.

Israeli authorities did not comment on the airstrike on Homs. But the military said one of the Syrian air defense missiles exploded over Israeli territory without causing any damage. Israeli police said the rocket's remains landed in the southern Israeli city of Rahat.

In response to the rocket. Israeli jets struck the air defense battery from where the anti-aircraft rocket was launched. The military said it also struck other targets, without elaborat-

Israel, which has vowed to

stop Iranian entrenchment next door, has carried out hundreds of strikes on targets in government-controlled parts of neighboring Syria in recent years, but it rarely acknowledges them.

The last suspected Israeli airstrike on Syria was on June 14, near the capital Damascus that left one soldier wounded.

Israel has also targeted the international airports in Damascus and the northern Syrian city of Aleppo several times over the past few years, often putting it out of commis-

Within days, Sierra Leone President Julius Maada Bio declared that his government would decriminalize abortion "at a time when sexual and reproductive health rights for women are being either overturned or threatened."

But some US-based organizations active in Africa were emboldened, especially in largely Christian countries. One is Family Watch International, a nonprofit Christian conservative organization whose anti-LGBTO+ stance, anti-abortion activities and "intense focus on Africa" led to its designation as a hate group by the Southern Poverty Law Center.

In April, Family Watch International helped to develop a "family values and sovereignty" meeting at Uganda's presidential offices with lawmakers and other delegates

from more than 20 African countries. The organisation's Africa director also is advocating for his country, Ethiopia, to revoke a 2005 law that expanded abortion access and dramatically reduced maternal mortal-

"It's kind of like the gloves Efforts to legalise and make are off," Sarah Shaw, head of advocacy at UK-based MSI national provider of reproductive health services, said in an

In a September speech to the African Bar Association, the president of Family Watch International, Sharon Slater, alleged that donor countries were attempting a "sexual social recolonisation of Africa" by smuggling in legal abortion along with sex education and LGBTQ+ rights.

"Sexual rights activists know if they can capture the hearts and minds of Africa's children and indoctrinate and sexualize them, they will capture the future lawyers, teachers, judges, politicians, presidents, vice presidents and more, and thus they will capture the very heart of Africa," Slater claimed.

limits Saturday, saying unverified accounts will temporarily be restricted to reading 600 posts per day, while verified accounts will be able to scroll through up to 6,000.

After facing backlash, he tweeted that the thresholds would be raised to 800 posts for unverified accounts and 8,000 for verified accounts before later settling on 1,000 and 10,000 tweets, respectively.

The crackdown began to have ripple effects, causing more than 7,500 people at one point Saturday to report problems using the social media service, based on complaints registered on Downdetector, a website that tracks online out-

Leading Taiwanese firms looking at relocating production bases to India

PTI TAIPEI eading Taiwanese technol-Logy firms are looking at relocating their manufacturing bases to India to bring down their exposure to the Chinese market, top policymakers in the Taiwan government have said, amid the self-governed island's increasingly tense rela-

tions with China. Deputy Minister for Taiwan's National Development Kao Shien-Quey said there is huge scope for collaboration between New Delhi and Taipei in areas of emerging and critical technologies including manufacturing of semiconductors and electronics equip-

In an interaction with a group of international journalists, she said major Taiwanese technology giants are looking at India as a key destination to strengthen their global supply

Kristy Tsun-tzu Hsu, the director at premier policy think-tank Taiwan ASEAN Studies Centre at Chung-Hua Institution of Economic Research, described India as an important country for Taiwan and said Taiwanese companies operating in China are looking at "decoupling" the global supply chain from that country while maintaining it for the domestic consumers.

Leading Taiwanese companies are increasingly looking at relocating their production bases from China to countries in Europe, North America, the US and India in view of Washington's trade dispute with Beijing and the Chinese military's increasing muscle-flexing around Taiwan

The relationship between China and Taiwan has become increasingly strained after US House Speaker Nancy Palosi's visit to the island in August last

India is keen on having production facilities of leading Taiwanese chip producers including Taiwan Semiconductor Manufacturing Corporation (TSMC), the world's largest chipmaker whose clients included Apple.

"With the larger context of global supply chain restructuring and the 'China plus one' strategy, I am sure that we will see an acceleration of collaboration between the two sides in the field of semiconductor and information and communica-

tion industry," Shien-quey said. It is learnt that a sizable number of Taiwanese companies are going to set up produc-

tion bases at two industrial parks in India which are being set up exclusively for leading industries from Taiwan. Talks are in the final stages

for a Taiwanese semiconductor company to set up a manufacturing facility in India, an official said on condition of unanimity. Taiwan produces over close

to 70 per cent of the world's semiconductors and over 90 per cent of the most advanced chips that are required for almost all electronic equipment such as smartphones, car components, data centres, fighter jets and AI technologies.

The 'China-Plus-one' strategy aims at encouraging businesses to expand their operations outside of China while maintaining their presence in that country.

"We are actively promoting

the diversification of the production bases of the Taiwanese companies and we would like them to move their production bases to other countries with a like-minded value system," Shien-quey said.

Tsun-tzu Hsu said the Indian economy is significantly large and the view is that it can provide some opportunity for Taiwan to change its trade dynamics with China.

"It is not only about trade. It is more about strategic collaboration. Our companies were considering moving to India even before the beginning of the US-China trade war because the Indian economy is so large that it can provide some opportunity to Taiwan to change the dynamics with China and reduce its depen-

dence on China," she said. Tsun-tzu Hsu said the

Taiwanese government has been trying to negotiate a trade deal with India to expand the trade basket. Taiwan-based Foxconn,

which is Apple's largest suppli-

er, has an iPhone manufactur-

ing facility in Tamil Nadu. The company is now setting up another iPhone production facility in Karnataka that is expected to start production by April next year.

New Delhi and Taipei inked a landmark bilateral investment pact nearly five vears back that seeks to protect Taiwanese investment in India.

Exporters are expected to flag issues like extending greater support to participate in global exhibitions and fairs; avaidating proportions to expediting negotiations to conclude free trade agreements with the UK, Canada, Israel and GCC (Gulf Cooperation Council); and allowing industry double weighted deduction on salary to professionals to retain talent in India.

Exports declined for the fourth-consecutive month by 10.3 per cent year-on-year to USD 34.98 billion in May, while the trade deficit widened to a five-month high of USD 22.12 billion, according to the ministry data.

Cumulatively, exports during April-May this fiscal contracted by 11.41 per cent to USD 69.72 billion, while imports declined 10.24 per cent to USD 107 billion.

Demand slowdown in major markets, high inflation in developed economies and the Russia-Ukraine war are impacting the country's exports.

Further, he suggested that facilitation centres for free trade agreements, as they would become one-stop points of information on all FTA's by India and aim to reach out to exporters for developing markets in FTApartner countries.

"These centres will facilitate a better understanding of the provisions of the FTA in goods, services and invest-ments, and could help the Indian industry to better utilise the existing FTAs and reap the benefits from preferential liberalisation through capacity building programmes as well," Budhia said.

Investments in expanding cold chain networks can open up export opportunities for sectors like agriculture, horticulture and pharmaceuticals, he said.

Over 12k fake entities in GST; CBIC plans **Diesel sales fell** in June as biometric authentication, tighter return filing

→BIC is working on biorisky entities under GST as it looks to crack down on fraudsters who are misusing the PAN and Aadhaar of other people to obtain GST registration, CBIC chief Vivek Johri

Johri further said that the tax authorities are also discussing some more tightening in the GST return filing system to limit the scope of claiming Input Tax Credit (ITC), when taxes have not been paid by suppliers in the supply chain.

The biometric authentication of authorised representatives or directors or partners of a company will be made for new registration applications and existing businesses registered under Goods and Services Tax (GST) if tax officers have a suspicion that the entities are being set up only to fraudulently claim ITC.

Also, geo-tagging of all entities is being planned by the officers of the Central Board of Indirect Taxes and Customs (CBIC) to authenticate that the address provided during GST registration is the place from where the entity operates, Johri told reporters.

A pilot on biometric authentication and geo-tagging is already underway in a couple of states, and depending on the results and evaluation of



digital infrastructure requirements, the project will be launched pan India.

We are trying to see how we can tighten the system further...We have been using OTPbased authentication earlier. Now, we are going to go in for biometric authentication also. Which would mean that in suspicious cases, persons will be asked to go to an Aadhaar centre to have their biometrics verified," Johri said.

The CBIC chief further said that during the ongoing drive against fake registration, GST officers have identified around 12,500 bogus entities, which were used to claim fake ITC and defraud the exchequer.

Johri said there are certain locations where fake entities are rampant, like Delhi, Haryana, and Rajasthan. Certain parts of Gujarat, Noida, Kolkata, Assam, Telangana, Tamil Nadu and Maharashtra also have fake businesses with GST reg-

Sectors, in which fake entities are, include metal or plastic scrap and waste paper.

"We are also finding that it is being generated for services. So, manpower services and advertising services have instances of fake billing," Johri

With regard to controlling fake ITC claims, Johri said the tax authorities have tightened the system but there is still some latitude for taxpayers to edit how much ITC they will be able to claim in GSTR-2A.

That is there because concerns were raised by trade the supplier doesn't upload invoices on time, and there are some invoices for which they have already made the payment, but they are not able to take credit because they are not uploaded, he added.

"We have allowed some editing facilities. We will see how we can tighten that so that the scope for passing certain ITC is reduced," Johri added.

US Open champion Alcaraz made the last 16 at Wimbledon in 2022 in only his second appearance at the tournament.
