Yamuna inundates Delhi

Commuters rue mile-long jams, police issue traffic advisories

As water from the Yamuna spilled onto the roads of the national Capital on Thursday, traffic movement was hit hard with passengers getting stuck for hours at several routes and many roads got waterlogged.

Besides, traffic diversions also led to chaos on the road. In many areas, people were seen driving knee-deep in water on the streets of Delhi.

According to the police advisory, traffic movement has been impaired on Mahatma Gandhi Marg — between the IP flyover and the Chandgi Ram Akhara and the Kalighat Mandir and the Delhi Secretariat — and on the Outer Ring Road between the Wazirabad Bridge and the Chandgi Ram Akhara.

There is no restriction on vehicles carrying essential services such as food items and petroleum products.

The commuters have been advised to avoid the roads



and plan their journeys accordingly, it said.

The rainwater has spilled onto the Ring Road from Majnu Ka Tila up to Rajghat and adjacent areas, affecting traffic on the Ring Road. Interstate buses from Haryana, Pradesh, Himachal Chandigarh, Jammu and Kashmir, Uttarakhand will stop at the Singhu border instead of the ISBT-Kashmere Gate, the police said.

The entry of heavy goods vehicles has been banned from the borders in Singhu, Badarpur, Loni and Chilla as a precautionary measure, they said, adding that traffic from Ghaziabad will be diverted to Road Number 57



Schools, colleges, Govt offices shut

New Delhi: The DDMA on Thursday directed that all schools, colleges and government offices for non-essential services in the city be closed till July 16 as water of the raging Yamuna inundated several areas of the national capital.

As the Yamuna waters spilled into more areas of Delhi and rescue efforts intensified, Chief Minister Arvind Kejriwal said private establishments across the city have been advised to allow their staffers to Continued on Page 2 work from home.



Delhi stares at drinking water shortage

New Delhi: The national Capital is staring at a drinking water shortage as the Delhi Government decided to cut down supply by 25 per cent following the closure of three water treatment plants due to the rising level of the Yamuna. Chief Minister Arvind Kejriwal, who visited the Wazirahad water treatment

Wazirabad water treatment plant, warned of rationalising water supply to deal with "acute shortage". "The decision was taken due to an increase in the Yamuna water level.

4 kanwariyas killed in road accident

Two trucks collided head-on in outer Delhi early Thursday, leaving five people, including four 'kanwariyas', dead while 14 others injured, police said.

A call about the accident at Siraspur GTK road was received at 12.44 am, they said.
The truck driver of the

offending truck who fled the spot was later held from Sanjay Gandhi Transport Nagar, Samaypur Badli, they added.

The deceased pilgrims have been identified as — Sandeep Kumar (32), Rajat (24), Aryan (19), Jagminder Balhara (56). Truck driver Raju (37) who was referred to LNJP hospital died during the treatment, police said. Continued on Page 2

Modi gets red carpet welcome in France

The discussions aimed to revitalize and strengthen India's longstanding and proven strategic partnership with the prominent European nation. Upon his arrival earlier in the day, Prime Minister Modi received a special gesture from Prime Minister Borne at the airport. A ceremonial welcome and Guard of Honour were extended to him as a mark of respect.

During his first engagement, Modi had a productive meeting with Senate President Larcher. The leaders deliberated on various issues of mutual interest and reached an agreement to enhance India-France cooperation in multiple areas, as stated by the Prime Minister's Office. The PMO reported, "PM @narendramodi held fruitful talks with PM @elisabeth_borne in Paris. The leaders reviewed various facets of the India-France partnership as well as discussed measures to further strengthen the ties between both countries."

The Prime Minister's two-day visit also includes extensive discussions with President Emmanuel Macron and his participation as the Guest of Honour in the French National Day celebrations. Furthermore, Prime Minister Modi interacted with children and members of the Indian diaspora upon his arrival at the hotel in Paris. The enthusiastic Indian community members chanted 'Bharat Mata ki Jai' as they greeted the Prime Minister, showcasing their admiration and support.

BJP leader dead during Patna stir, party blames police caning

ABJP leader in Bihar on Thursday died while taking part in å "Vidhan Sabha march" against the State's Nitish Kumar Government, evoking allegations from senior party leaders that he was "killed in a brutal lathi

charge".

The party's Jehanabad district general secretary Vijay Singh was brought in an unconscious state to the Patna Medical College and Hospital where he died, PMCH Superintendent Dr I S Thakur said. Union Minister of State for Home Nityanand Rai, a former State BJP president, told reporters that the death of Vijay Singh during the protest march was a "sacrificial offer-

ing".
"Besides, thousands of BJP workers have been injured, some of them seriously, while lending their voice to the State's students and youngsters The injured include many women and members of Parliament and the state legislature," alleged Rai, who rep resents the Ujiyarpur Lok Sabha seat.

Officials were tight-lipped about the cause of the death of Singh, who was said to be in his 40s, though the district administration in Patna came out with a brief statement asserting that "no injury marks" were found on his

body.

The statement claimed Singh was found "in an unconscious state on the roadside in Chhajju Bagh locality" from where he was taken to PMCH. the state's largest government

hospital.
"He was admitted to the ICU but died during treatment," the PMCH superintendent said. The cause of the death could not be ascertained till post-mortem examination is conducted, another PMCH official said.

Congress has been instructed padyatra and focus on raising issues such as atrocities against women, including the Ankita murder case, as well as various scams, to confront the BIP. Rahul said in a social media

Coal scam: Ex-RS MP, media baron, ex-Coal **Secy convicted**

Delhi court on Thursday Aconvicted seven accused, including former Rajya Sabha MP and media baron Vijay Darda and ex-Coal Secretary HC Gupta in a case related to irregularities in the allocation of a coal block in Chhattisgarh. In the 13th conviction in

the coal scam, the scandal which rocked the erstwhile Manmohan Singh Government, Special Judge Sanjay Bansal also convicted Darda's son Devender Darda, two senior public servants KŚ Kropha and KC Samria, M/s JLD Yavatmal Energy Pvt Ltd and its Director Manoj Kumar Jayaswal. The court held the accused guilty of criminal conspiracy (punishable under Section 120-B of IPC) and cheating (punishable under section 420 of IPC), and under relevant sections of the

Prevention of Corruption Act. The judge will hear argument on the quantum of punishment on July 18. The court accepted the submissions made by senior Public Prosecutor AP Singh that the CBI was able to

observers and to end the internet shutdown. The resolution was passed by a show of hands on Thursday after a debate on the issue on Wednesday evening. India's Foreign Secretary had categorically stated on Wednesday that they had reached out to the European

Parliamentarians and had conveyed to them that this was India's internal matter and needed no intervention. The EP resolution has asked the Indian Government to pre-empt any further escalation. It also calls on authorities to grant unhindered access to the area by journalists and international observers and to end the internet shutdown

The EP resolution also asked the Government to repeal the Armed Forces Special Powers Act (AFSPA) in line with the recommendations of the UN Universal Periodic

Pawar, Praful meet Shah amid tussle over portfolios

A midst a stand-off over port-folios between the Shiv Sena (Shinde faction) and the Nationalist Congress Party (NCP), the latter being a new entrant in the Maharashtra coalition Government, NCP leaders Ajit Pawar and Praful Patel met with Union Home Minister Amit Shah and senior BJP leaders late on Wednesday night to discuss the issue.

The tussle over key portfolios has persisted since the swearing-in of Ajit and eight other NCP legislators as Ministers in the Maharashtra Government on July 2 after a split in the Sharad Pawar-led

The NCP has been insisting on the finance and water resources portfolios, which the Shiv Sena (Shinde faction) strongly opposes. The stalemate over the allocation of portfolios continues Ajit, along with senior leaders Praful, Chhagan Bhujbal,

and Sunil Tatkare, left the NCP with a significant number of MLAs and MLCs, staking a



He mentioned that there might be some issues in the allo-cation of portfolios, as they were distributed by the BJP and Shiv Sena when they formed the government last year.

Shah underlines threats emanating from cyber criminals

Warning the global community about security challenges which have evolved from "dynamite to metaverse" and "hawala to crypto currency", Union Home Minister Amit Shah on Thursday urged G20 countries to rise above conventional boundaries to act against such crimes.

Speaking at the 'G20 Conference on Crime and Security in the Age of NFTs, AI & Metaverse', he underlined the threats emanating from cyber criminals using darknet, metaverse, deepfakes, ransomware and toolkit-based misinformation campaigns and strategic targeting of critical information and financial sys-

Without taking names, Shah said some anti-social elements and global forces are using technology to cause economic and social harm to citizens and governments.

mation and data flow from an economic perspective, but now it is important to understand the aspects of crime and security, and find a solution," he

Shah said such activities are a national concern as they directly impact national security, law and order, and the economy. If such crimes and criminals have to be stopped, we have to think and act by rising above the conventional geographic boundaries, he

"Although technology is a positive development in bringing human beings, communities, and countries closer, there are also some anti-social elements and global forces that are using technology to cause economic and social harm to citizens and governments," he

The home minister sug-

ing across borders like bringing uniformity in laws of all countries, developing a response mechanism under different laws of the countries, harmonising bench marks, best practices and regulations, and greater coordination among cyber agencies of all coun-

"An integrated and stable approach to cyber security policies will facilitate interoperability, increase trust in information sharing, and reduce the agency protocol and resources gaps. The need of the hour is to share 'real-time cyber threat intelligence among member countries with active support from industry and academia to secure the nation's critical infrastructure,

Cooperation in the investigation of cross-border cyber crimes through joint efforts to build a 'peaceful, secure, detergested a slew of measures to act rent and open' information



and communication technology environment is extremely necessary today, the Home Minister said.

Shah said our internet vision should neither be one of excessive freedom threatening the very existence of our nations nor one of the isolationist structures such as digital firewalls.

"Many countries have become victims of cyber attacks and this threat is hovering over all the major economies of the world. According to World Bank estimates, cyber attacks could have caused losses of around USD 5.2 trillion to the world during 2019-2023. The use of crypto currency by malicious threat actors further complicates its detection and pre-

The home minster also suggested that in line with the United Nations Convention on the Criminal Use of Information Communication Technology,

He said Computer Emergency Response Teams (CERTs) must be strengthened to deal with emerging technologies.

There should be a 24X7 cyber securty mechanism in place for an effective 'predictive preventive - protective and recovery' action. Time has come to build a 'Transparent and Accountable Al (Artificial Intelliegence) and Emerging Technologies Governance Framework' to ensure responsible use," he said.

Shah said given the rise in cyber crime involving digital currency, there is a need for a "dedicated common channel" among the nations to prevent such financial irregularities.

He said third-party verification of NFT (non-fungible token used by block chains and crypto currency) platforms will

Citing the country's steps to counter cyber criminals, Shah said India has set up certain open-access digital infastructure models which have become examples in the world

"India has developed Aadhaar Model for digital identity, UPI mode for real time fast payment, Open Network for Digital Commerce (ONDC, and Open Health Service Network, among others. The world today needs a new model for digital public infrastructure to facilitate the flow of information and finance. This will facilitate the countries of the world to digitally empower their citizens,

The home minister said the Indian government under Narendra Modi has worked towards outlining a uniform cyber strategy, real-time reporting of cyber-crimes, capacity building of LEAs (law enforcelytical tools and setting up a national network of forensic laboratories, ensuring cyber hygiene, and spreading cyber awareness to every citizen.

"The Crime and Criminal Tracking Network and System (CCTNS) has been implemented in all police stations of the country. The Government of India has established the Indian Cyber-Crime Coordination Center (I4C) to ensure a comprehensive response against cyber crime," he said.

Shah added that India has created world's largest training programme in cyber security through massive open online courses platform called the 'Cy Train' portal.

'We aim to create a 'Cyber Success World' and not a 'Cyber Failure World'. Together, we can harness the potential of these technologies while ensuring a secure and prosperous digital future for all," he said.

'IT Rules against fake news sort of diktat' It does not give opportunity to justify or defend content: HC

The Bombay High Court on Thursday said the recently-Information Technology Rules that empower the Centre to act against fake, false and misleading information on social media was "sort of a diktat" as it does not give an opportunity to justify or defend the content.

A division bench of Justices Gautam Patel and Neela Gokhale sought to know what constitutes a government business under the amended rules as it referred to the recent political developments in Maharashtra where "one party is moving to the other". The bench also questioned as to why under the amended rules, the government has taken the 'loco parentis' (regulation or supervision by an administrative authority) only for content

pertaining to government business and not for every information or content posted on social

bunch of petitions challenging the amended IT rules. Standup comedian Kunal Kamra, the Editors Guild of India and the Association of Indian Magazines filed petitions in the high court against the rules and termed them as arbitrary, unconstitutional and that it would have a chilling effect on the fundamental rights of cit-

The bench while hearing arguments being made by advocate Shadan Farasat for the Editors Guild of India, asked what constitutes as government business under the rules. "Take for example the present political climate in Maharashtra...one party moving to the other...is that gov-

The court would continue hearing the matter on July 14. On April 6 this year, the Union government promulgated certain amendments to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, including a provision for a fact-checking unit to flag fake, false or misleading online content related to the government.

The three petitions sought the court to declare the amended rules unconstitutional and direct the government to restrain from acting against any individual under the rules.

The commuters have been advised to postpone travel plans to low-lying areas in view of the high alert issued by the administration. In case travel is unavoidable, the police have asked commuters to adhere to the advisory

Siddhart Srivastav, an advocate, said he managed to cover a mere four to five kilometres in three hours. "I left my home in Ghaziabad in Uttar Pradesh around 8.30 am for Tis Hazari Court. It took me three hours to enter Delhi through GT Road where traffic was chock-a-block. Now, I am looking for a U-turn to go back home," he said.

Delhiites also took to Twitter to lament the traffic woes. The traffic was heavy at Maujpur Babarpur near Azadpur, where a commuter claimed to have been stuck for almost two hours, near GTB Hospital, Dilshad Garden, Vivek Vihar and Anand Vihar.

The visuals on social media also depicted huge snarls on NH-24 and Sarai Kale Khan. Water from the overflowing Yamuna reached ITO, a key route for commutes from east to central Delhi and Connaught Place. There was also heavy traffic congestion at Vikas Marg.

In a tweet, the Delhi Police said, "Due to the rising water levels of the Yamuna river, the traffic coming from Shahdara on GT Road towards ISBT, Kashmere Gate, has been diverted from Seelampur T-point via Keshav Chowk - Karkardooma Court - Road No 57- NH-24.'

"Movement of traffic is Oncoming traffic from restricted on both the carriver water. Kindly avoid these stretches," it said in another

According to the police,

traffic movement has been affected on Outer Ring Road (Rohini to ISBT) - movement is being allowed only towards GTK Road. On GTK Road to ISBT (Sonepat side), traffic movement is closed and diverted to the other side. From GTK Road to Azadpur under Mukarba Chowk flyover, traffic is being diverted towards Rohini.

Similarly, traffic movement has been affected near the Singhu border and is being diverted to Kundli-Manesar-Palwal (KMP) Expressway. At Mukarba Chowk, vehicles are being diverted to Peeragarhi Chowk and the Narela side.

At Bhalswa, traffic is being diverted to Peeragarhi and the Narela side while passenger buses from Haryana and Punjab will terminate at the border, the police said.

"Due to the rise in water level of the Yamuna river, traffic on Pusta Road from Shamshaan Ghat, Geeta Colony to Old Iron Bridge, Gandhi Nagar, has been diverted towards Raja Ram Kohli Marg or Master Plan Road to reach Swami Dayanand Marg and then to

GT Road, Shahdara," it said. It also tweeted that the traffic will remain heavy at the Kalindi Kunj red light and Road No 13A, Jasola Vihar, due to restrictions in movement of traffic by the Uttar Pradesh Police on the carriageway from Kalindi Kuni towards Noida for the Kanwar Yatra. The traffic at Jasola was also heavy.

Through the resolution, Members of the European Parliament (MEPs) called on the E.U. to make human rights prominent in its dialogue and relationship with India — a point that was repeatedly raised during the pre-vote debate.

The process brought together an unlikely mix of left and right parties which also approved two other resolutions on rights in relations with India. It is a great democracy, but it has to be a better democracy," said MEP, Pierre Larratourou (Group of the Progressive Alliance of Socialists and Democrats). He also recommended that EP demand that respect for human rights is included in the India-EU trade partnership. The Indian government has yet to respond to the EP resolution.

In addition, the DAC approved the proposal to lay down guidelines for achieving in all categories of capital acquisition cases. It will help in achieving 'Aatmanirbharta' in critical manufacturing technologies and life-cycle sustenance of defence platforms and equipment through indige-

nous manufacturing. It was also learnt France also agreed to arm the air independent propulsion (AIP) equipped Scorpene submarine with a naval cruise missile, which has double the range of SCALP air to ground missile carried by Indian Air Force

(IAF) Rafale fighters. Upgraded from the SCALP missile, the naval version has a range of over 1,000 kilometers when launched from a submarine and goes up to 1,400 kilometers when launched from a warship. The turbojet powered cruise missile is sub-sonic and remains sub-surface before taking to the skies while approaching the target and then annihilating the potential enemy threat on ground.

The missile is being used by the French Navy on board

its frigates since 2017 and onboard its Barracuda class submarines from 2022. The missile can also be used on Scorpene class submarines after slight technical modifications of the torpedo tubes.

The Pioneer earlier this submarines will be constructed at the Mazagon Docks, Mumbai where the two countries earlier built six Scorpene class submarines now named Kalvari class of submarines. It will be a government to government deal like the naval version of Rafale jets.

The three additional Kalvari class submarines will be fitted with air independent propulsion (AIP), which has been designed by the Defence Research and Development Organisation(DRDO)but will be tested and validated by the French Naval Group. The AIP gives longer endurance to a normal diesel attack submarine and allows it to remain submerged for over a week without the need to surface to charge its batteries.

As regards the Rafale Marine jets, they will be deployed on aircraft carriers INS Vikrant and INS Vikramaditya. The proposed Rafale deal includes 22 singleseater and four double-seater trainer versions.

The spacecraft will be launched using the GSLV Mark 3 (LVM 3) heavy-lift launch vehicle. Known as the 'Fat Boy' for its ability to carry heavy payloads, the LVM3-M4 rocket will carry the Chandrayaan-3 mission. Lost everything: Flood-hit people

In March, her home was demolished in an antiencroachment drive and now, her shanty on the bank of a swollen Yamuna is underwater. "Everything is lost again," says Beena Devi, who has been moved to a relief camp along with her family from a slum in the Raighat area.

Some utensils, essentials and quilts was all the 57-yearold, her husband, three children and daughter-in-law could carry out of their house as authorities raced to evacuate them and hundreds of families on Tuesday as the water levels in the river rapidly started rising, above the danger mark.

Sitting at the ITO relief camp, Devi recalled how in March bulldozers razed her

She said not only her fam-

ily but many have lost their source of livelihood and income. The Delhi government has set up relief camps tents supported by wooden poles -- on roadsides in areas along the Yamuna, and around 7,500 people have been evacuated to these camps. However, many com-

plained of poor facilities and arrangements.In a camp near the Yamuna Bridge, Tarawati, who has a farm at the Yamuna floodplains, said the flood has destroyed both her farm and her 'juggi' (shanty). "We get food twice a day but there is no toilets here. We have to find places and have to sometimes go behind trees to relieve our-

who was evacuated four days ago. Sangeeta, who was evacuated three days ago with her family, also complained of lack of toilets and explained the difficulties women have to face, At the ITO camp, Devi said, "We are not getting proper food and water at the relief camp". She also claimed that women are forced to go outside due to lack of toilets.

Omprakash (35), who is staying at the Yamuna Bridge camp along with his mother, wife and four children, said he and many others have been living near the Yamuna river for years and farming is their only source of livelihood.

'We can't leave, everything is here. Our fields are here. If we don't farm how would we earn money? We haven't faced many problems in the camp, at least we get food two times a day," he said.

Red Fort closed due to swelling Yamuna

According to Suman Gupta of Nigambodh Ghat Sanchalan Samiti, which manages operations at the crematorium, there are about 120 conventional platforms, six CNG-based platforms and six Mokshda platforms. Nigambodh Ghat is considered a pious place and many people prefer to cre-mate their loved one at this site next to Yamuna river, he said.

Prime Minister Narendra Modi has said India has always stood for peaceful resolution of differences through dialogue and diplomacy and expressed concern over the impact of the ongoing Ukraine conflict especially on the countries of the Global South.

He asserted that the conflict must end. In an interview $to\ French\ newspaper\ Les\ Echos,$ he also said India has always stood for respecting sovereignty of all nations while replying to questions about an "aggressive" China. Modi on Thursday left for France where he will be the Guest of Honour at the Bastille Day celebrations. To a query on China and if its massive investment in its

"This is more important than ever for maintaining mutual trust and confidence. We believe that it is through this that a positive contribution can be made towards lasting regional and global peace and stability," Modi added.

On the Russia-Ukraine conflict, the prime minister said he has spoken several times with President Vladimir Putin of Russia and President Volodymyr Zelenskyy of willingness to support all gen-uine efforts that can help bring this conflict to an end. "India's stand has been clear, transparent and consistent. I have said that it is not an era of war. We have urged both sides to resolve issues through dialogue and diplomacy," he said.

pandemic now face energy, food and health crisis, economic slowdown, inflation and rising debt burden. The conflict must end," he said.  $W^{ith \, several \, countries \, factoring \, "crushing \, debt \, crisis," }_{united \, Nations \, (UN)}$ Secretary-General Antonio Guterres has said the G20 Summit to be hosted under India's Presidency provides an opportunity to take action on debt relief and reform the global financial system.

Speaking at the launch of a UN report 'A World of Debt' late Wednesday, Guterres said, "Some 3.3 billion people almost half of humanity - live in countries that spend more on debt interest payments than on education or health." He also said "Half our world is sinking into a development disaster, fuelled by a crushing debt crisis," he said.

Guterres said that because most of these unsustainable debts are concentrated in poor countries, they are not judged to pose a systemic risk to the global financial system. "This is a mirage," he warned, adding that 3.3 billion people is more

than systemic risk.

"It is a systemic failure. Markets may seem not (to) be suffering – yet. But people are. Some of the poorest countries in the world are being forced into a choice between servicing their debt or serving their people," the Secretary-General

mit hosted by President Macron of France generated other important proposals. The upcoming G20 Summit is an opportunity to take these ideas forward," Guterres said. India assumed the year-long presidency of the G20 on December 1, 2022, and is hosting over 200 meetings and related events in

cities across the country.

These events will culminate in a Global Leaders' Summit in New Delhi on September 9-10, later this year, to be attended by over 40 Heads of State, Heads of Government and international organisations.

A G20 Leaders' Declaration is expected to be adopted at the conclusion of the New Delhi Summit, stating "Leaders' commitment towards the priorities discussed and agreed upon during the respective ministerial and working group meet-

New Delhi: The NIA Special Court here on Wednesday sentenced four persons to 10 years of imprisonment in the Indian Mujahideen (IM) conspiracy case relating to the plot hatched by Pakistan-backed terrorists to trigger bomb blasts across

"The four accused were in close association with IM members, including Pakistanbased key accused Riyaz Bhatkal and Yasin Bhatkal, based in India. They had done reconnoitering of important places, including Hyderabad and Delhi, and had also procured explosives as well as arms and ammunition," the NIA said in a statement.

The case relates to the conspiracy hatched by the members of the Indian Mujahideen (IM), which is responsible for carrying out various blasts in the country, including Varanasi blasts of March 2006, Mumbai serial blasts of July 2006, UP courts serial blasts at Varanasi, Faizabad and Lucknow in November 2007, Hyderabad twin blasts of August 2007, besides the Jaipur serial blasts,

Delhi serial blasts and the Ahmedabad serial blasts in 2008. IM was also behind the Chinnaswamy, Bengaluru Stadium blast of 2010 and the Hyderabad twin blasts of 2013.

The accused, identified as Danish Ansari (Darbhanga, Bihar) Aftab Alam (Purnea, Bihar), Imran Khan (Nanded, Maharashtra) and Obaid-Ur-(Hyderabad, Telangana), were convicted on July 7 under Unlawful Activities (Prevention) Act in the NIA case. They had been arrested between January and March 2013. Under the quantum of sen-

tence pronounced on Thursday, the Special Judge also imposed a fine of Rs 2,000 on accused Danish Ansari and Rs 10,000 on Aftab Alam. The Special Court had earlier framed charges against the four, along with seven others, on March 31, 2023. The other seven have been identified as Yasin Bhatkal, Asadullah Akhtar, Zia-Ur-Rehman, Tehsin Akhter and Hyder Ali. The trial against them is continuing, the agency added. PNS

The traditional soft stone The traditional products are attracting the global markets today as their trade exports have reached close to around Rs 12 crore, courtesy to the promotion given to this one of the Geographical Identification (GI) products from this holy city by the government. The beauty of this masterpiece was seen when one of its items was presented to Prime Minister Narendra Modi by Chief Minister Yogi Adityanath at the Wajidpur public meeting last week. The District Malaria Officer said that dengue is a deadly infectious disease which is spread by the bite of infected female Åedes aegypti mosquitoes. "A single infected mosquito can infect many people with dengue. The risk of dengue starts increasing only during the rainy season. Dengue spreading mosquitoes bite only during the day. Its mosquitoes thrive in stagnant and clean water such as cooler water, clogged drains and veillance. Rapid Response drains. Dengue can easily occur

in people with low immunity. That's why there is a need to be very careful, alert and aware about it," he said, informing that since January 2023 till date, about 1,500 rapid tests for dengue have been conducted in the district in which none was found positive.

On the other hand, he said that about 67,564 people were tested for malaria with blood slides, in which 12 were found positive. All these patients have recovered. The facility of testing for dengue, malaria etc is available at all the government hospitals and urban and rural health centres of the district.

A bloody win

Charges of rigging and violence in Bengal panchayat polls put a question mark on the electoral process

■ n time with the Calcutta High Court's directive for the West Bengal State Election Commission as well as the state and Union governments to address allegations of violence and malpractices, the Trinamool Congress (TMC) has emerged triumphant in West Bengal panchayat elections. The election results reveal that the TMC remains dominant, securing over 35,000 panchayat seats out of the total 63,229 seats. In contrast, the Bharatiya Janata Party (BJP), the main contender, could only secure around 10,000 seats, while the CPI(M)-Congress alliance managed to win approximately 6,500 seats. The BJP, as the primary Opposition party in the Assembly, has suffered a setback and is unlikely to win any Zila Parishads. The Left and Congress, who formed an alliance for the election, have performed slightly better compared to their complete defeat in the 2021 assembly elections. The TMC's landslide victory in the rural body elections, viewed as a test for the 2024 Lok Sabha election, is expected to significantly



boost the confidence of the party. The election, held on July 8, has been marred by violence, allegations of rigging, and judicial intervention starting from the announcement of the polling date to the nomination filing and vote counting. Several cases have been filed by opposition parties, accusing the West Bengal State Election Commission (WBSEC) of electoral malpractices and bias.

While the TMC considers the verdict a triumph for the rural people of Bengal, Opposition leaders have raised doubts about the results and alleged malpractices at the counting center. Numerous incidents of malpractice have been reported, including the violence,

and intimidation of opposition counting agents by TMC supporters. For BJP, the performance in the panchayat elections raises questions about their mission to win 35 out of the 42 Lok Sabha seats in West Bengal in the general election. In the previous Lok Sabha and Assembly elections, the BJP emerged as the main Opposition in West Bengal. However, this time, the party performed poorly in the strongholds of several prominent leaders. Not only the BJP, but also the other opponents of the TMC, the Left and Congress, struggled to achieve success. Nevertheless, this victory comes at a heavy cost, casting doubt on the democratic process itself. The panchayat elections have been among the bloodiest, resulting in the loss of at least 40 lives. The state election commission and administration faced criticism for their failure to prevent malpractices. In many areas, ballot papers were dumped in drains, and opposition agents were subjected to physical assault and threats by TMC workers, often with the assistance of the police, at the counting centers. Many Opposition candidates and counting agents lodged complaints of harassment, intimidation and violence while numerous ministers, MLAs and leaders were observed inside the counting centers. Widespread allegations have been made against the WBSEC, accusing them of operating in a biased manner.

The nationalist writer par excellence

orn on June 27, 1838, into a Brahmin family, Bankim Chandra Chattopadhyay (Chatterjee) was the face of the Bengal Renaissance, an exemplary novelist, and the man who gave India, her National 'Vande Mataram'. Chattopadhyay was, in fact, the pioneer of Bengali literature that blossomed later through laureates like Rabindranath Tagore, Sarat Chandra Chattopadhyay, Mahashweta Devi and many others. He is also often hailed as the father of the modern Indian novel. His works, crafted during the colonial era, reveal a deep exploration of socio-political themes that played a significant role in shaping Indian nationalism and fostering social consciousness. Chattopadhyay's writings not only depicted the struggles and aspirations of the Indian people but also served as a clarion call for unity, self-empowerment, and cultural resurgence of a sleeping nation, that much needed to be awakened.

One of his early works Bangadarshan' a monthly literary magazine became what Bankim Chandra wanted, a medium of communication between the educated and uneducated classes. 'Bangadarshan' stopped publication in the 1880s, but was revived in 1901 and Rabindranath Tagore - who was 23 years younger than Bankim – became its editor.

It was Rabindranath Tagore who later wrote that "Bankim Chandra had equal strength in both his hands, he was a true 'sabyasachi' (ambidextrous). With one hand, he created literary works of excellence; and with the other, he guided young and aspiring authors. With one hand, he ignited the light of literary enlightenment; and with the other, he blew away the smoke and ash of ignorance and ill-conceived notions."The colonial rule had profoundly impacted Indian society, leading to a sense of cultural subjugation and disillusionment. Chattopadhyay's writings emerged as a response to this, providing a voice to the aspirations of the people and nurturing a spirit of resistance against the

Chattopadhyay's literature "Kapalkundala" and "Devi



tray the country's historical past, replete with valour, heroism, and pride. Through his characters, he emphasizes the need for Indians to reconnect with their roots, embrace their native traditions, and reclaim their sense of identity, thereby fostering a deep sense of nationalism. His novels expose the exploitative nature of British rule, the economic oppression faced by the Indian peasantry, and the cultural erosion inflicted upon the nation. "Anandamath," set in the background of the 'Sanyasi Rebellion' (late 18th century) when Bengal was facing a famine - too unveils the atrocities committed by the colonial regime and instils a fervent desire for independence among readers, igniting the

Historians, psychologist and theorists like RS Sharma, Romesh Chunder, Dipesh Chakrabarty, and Ashis Nandy respectively, has emphasized Chattopadhyay's contribution in shaping Indian nationalism. While Nandy argues that Chattopadhyay's literature presented an alternative narrative to British colonialism and offered a sense of cultural pride and identity to the Indian people, Sharma points to how they shed light on the economic exploitation faced by the peasantry and the oppressive nature of British rule. Scholars have also explored the influence of Chattopadhyay's writings on Mahatma Gandhi, who in his autobiography "The Story of My Experiments with Truth," acknowledged the impact of Chattopadhyay's novel "Anandamath" on his political philosophy and the concept of Satyagraha. Chattopadhyay's literature, with its depiction of sacrifice and devotion to the cause of freedom, resonated deeply with Gandniji's ideals of peace

IS SCO GOING RUDDERLESS?

Has SCO lost its direction in the wake of changing geo-political realities

The Shanghai Cooperation Organisation (SCO) meeting held last week. virtually hosted by India reflects the analogy of humans with elephants in a dark room. Each of the major partners constituting SCO, China, Russia and India decided to have its take on the beast in the room, with very little convergence. India hosted the summit virtually, lasting only for two hours, which drew sharp responses from Chinese academia and think tanks. Chinese President Xi Jinping during his video speech was quoted as saying "We should truly respect each other's core interests and major concerns, and firmly support each other's endeavor for development and rejuvenation. We should keep in mind the overall and long-term interests of our region, and make our foreign policies independently. We must be highly vigilant against external attempts to foment a new cold war or campbased confrontation in our region. We must resolutely reject any interference in our internal affairs and the instigation of 'color revolutions' by any country under whatever pretext,"

There were tons of references to India being pulled into Western camps by the US. The Chinese national mouthpiece Global Times carried a quote from Qian Feng, director of the research department at the National Strategy Institute at Tsinghua University where he expressed concerns regarding "the US is using its Indo-Pacific strategy to drive a wedge between China and its neighbouring countries; and Washington is moving to pull over India, trying to dilute the organization's cohesion." PM Modi's state visit to the US was mentioned, as one more attempt by the US and as a threat to China since it aimed to prop up India in the Indo-Pacific region. Another Chinese mouthpiece the China Daily carried a long piece praising several initiatives of President XI Jinping. An Uzbek expert on international relations was quoted showering praises on China's Belt and Road Initiative which is fostering closer infrastructure, and economic and trade ties among Asian, European and African countries.

India has long contested the opaque funding of the Belt and Road



Initiative and has refused to be part of it. PM Modi in his remarks at the SCO summit said "Strong connectivity is crucial for the progress of any region. Better connectivity not only enhances mutual trade but also fosters mutual trust. However, in these efforts, it is essential to uphold the basic principles of the SCO charter, particularly respecting the sovereignty and territorial integrity of the Member States. Following Iran's membership in the SCO, we can work towards maximizing the utilization of the Chabahar Port. The International North-South Transport Corridor can serve as a secure and efficient route for landlocked countries in Central Asia to access the Indian Ocean." The emphasis on respect for territorial integrity without mentioning BRI didn't go down well with the Chinese.

Meanwhile, India stuck to the new pillars of cooperation for SCO members, it created under its presidency on startups and innovation, traditional medicine, youth empowerment, digital inclusion and shared Buddhist heritage. India has a leadership position in almost all of these areas, except, the startup innovation space where China may have a lead.

At a median level, filtering the observations from either camp along the fault lines it seemed SCO has lost its relevance as a regional body, given the changed dynamics of the member countries. Some may point out that the inclusion of Iran in the group makes SCO bigger and has now got itself a strong member in West Asia. However, the big three, Russia, China and India have much to reconcile. India would not be in a position to have any meaningful dialogue with China, till the military situation on its borders is resolved and ground forces retreat from combative positions. An economically weakened Russia may not be the best bet for India, especially, given the closer ties Beijing seems to have with Moscow. The changed dynamics are sure to impact SCO and its members.

Reassess the efficacy of the PLI scheme

Production Linked Incentive Scheme (PLI) could pave the way for a self-sustaining manufacturing ecosystem but exports should not be based on imported products



ake in India" was introduced in September 2014, which could not boost the manufacturing sector in the six fiscal years FY15-FY20. Further to push 'Make in India' to 'Aatamnirbhar Bharat', the flagship Production Linked Incentive (PLI) scheme was introduced on 21 March 2020, to speed up production, increase exports and curb imports. But does it work? An outlay of Rs 1.97 lakh crore for 14 sectors, including automobile, telecom and textile, is to be released. Historically, the first disbursement under PLI came only in September 2022 – as approved by the "Empowered Committee" under NITI Aayog. More than half of the time of this five-year PLI scheme has been covered, now it is time to look at the impact and effectiveness

National account statistics show that manufacturing value added was 17.3% of gross value added (GVA) in FY2015, which increased slightly to 17.7% in FY23. Over the past nine fiscal years since FY2015, it has increased value added in production by 6% on average compared to 5.6% of GVA's. At this rate of contribution and value-added growth, manufacturing is not driving economic growth in any significant way. In addition, the share of manufacturing jobs is declining - from 12.1% in 2017-18 to 11.6% in 2021-22. Contrary to the promise to create 6 million new jobs in five years, there are no official figures to show how many jobs have been created. There is no post facto study to measure the impact or effectiveness of the PLI.

Initially, PLI was offered into three sectors, but it has expanded to 14 sectors, and the three new sectors - leather, e-bikes and toys - are expected to occu-

py a total of 17 sectors. Although expanding to new sectors is a holistic and inclusive approach, it is an empirical truth that incentives have an extraordinary impact on shaping economic behaviour and must be designed for the public good. The inefficiency may not serve the purpose.

ONLY 1.5% OF THE FUND WAS PAID OUT

After more than three years, a recent PLI review by the Ministry of Commerce and Industry shows that out of Rs 1.97 crore allocations, only Rs 2,900 crore (1.5% of allocations) has been disbursed by the end of FY23 for eight sectors such as large-scale electronics manufacturing, IT hardware, bulk drugs, medical devices, pharmaceuticals, telecommunications and network products, food processing and drones and drone components. The bulk of the incentives went to only three sectors large-scale electronics, pharmaceuticals and food products. There are zero disbursements in 6 sectors – steel, textiles, batteries, white goods, solar panels and automotive.

CLAIM GAME

Following the review, the Department of Promotion of Industry and Internal Trade (DPIIT) under the Ministry of Commerce and Industry said, "India's flagship PLIs have attracted investments worth Rs 62,500 crore in sectors such as mobile manufacturing, pharmaceuticals,

medical devices and food processing. resulting in incremental production/sales of over Rs 6.75 lakh crore; creating 3.25 million new jobs and increasing exports by Rs 2.56 lakh crore by March

The ministry's statement also said that "sectors for which the PLI scheme exists have seen increased FDI inflows between FY22 and FY23 – pharmaceuticals and pharmaceuticals (46%), food processing (26%) and medical devices (91%) and that the PLI scheme has 'transformed' India's export basket from traditional commodities to high valueadded products such as elec-

PLI FOR MAKE IN INDIA OR ASSEMBLE IN INDIA?

While the DPIIT says PLI "has led to an increase in value added in the electronics sector and manufacturing by 23% and 20% respectively, no study or data analysis supports this. Ideally, it should be genuine 'Made in India', not 'Assembled in India'.

Former RBI Governor Raghuram Rajan recently revealed in one of the articles, "Has India become a mobile phone manufacturing giant?", which claims that there is no value addition in India, just assembling smartphones. Rajan claimed that "net exports" were "still very negative" and had not increased substantially since

An analysis of India's trade data shows that exports of electronic goods have grown in recent years, but imports have grown much more, widening the trade deficit for such goods from -\$30.6 billion in FY15 to -\$53.7 billion in FY23.

INSUFFICIENT MONITOR-

After the previous round of PLI review, the NITI Aayog, tasked with evaluating publicly funded projects and schemes, was to provide real-time progress and monitor the PLI. In its 2021-22 annual report, the Aayog said it was "developing a PLI dashboard to monitor PLI scheme Since the PLI is listed on increased investment, production, exports and employment generation, this dashboard was meant to track changes in these areas. However, the dashboard is still unavailable.

THE WAY FORWARD

The PLI system is rightly intended to create scope for improving competitiveness. However, exports should be produced through local resources rather than imports to make the payoff seem worthwhile. To strengthen India's manufacturing capacity and reduce import dependence in key sectors, it is time to reassess the effectiveness and impact of the PLI scheme in practice, which could be closely monitored. If supported by effective implementation, PLI could pave the way for a self-sustaining manufac-

Risk mitigation is a must for the success of PPP

Risk assessment and management is the key to the long-term sustainability and bankability of PPP projects to ensure their profitability

Public Private
Partnership (PPP) projects are both capitalintensive and long-term projects. There are good possibilities that these projects may not progress as planned i.e., these are risky projects. The reasons may or may not be under the control of project heads. The likelihood and impact of each event are different and together these two factors dictate the level of delay or cost over-run which may have to be planned for. Thus, the project risks are a function of the likelihood of the occurrence of that event and the level of its impact on the project. The project will be considered risky whenever the likelihood and impact of various risks is more or at least one of these is of high-

There are numerous risks in a project ranging from internal risks (assumption risk, design risk and technical risk) to external risks (government action, Interest rates, demand). Project risks are primarily identified inter alia from analysis of historical project

and development of the project, work breakdown structure of the project, process flow charts of the project, network diagrams, brainstorming and Delphi techniques. Once the risks are identified, risk assessment is undertaken. It is based on a meticulous analysis of the likelihood and impact of each risk. The risks are then prioritized, consequences studied, and mitigation measures planned. The top three risks are quite ubiquitous in all infrastructure projects.

The first and foremost

risk is the Financing Risk. The PPP projects are capitalintensive projects, and the concession period usually runs into decades. Many of these need support through 'Viability Gap Funding'(VGF)

they have to earn a 'Return on Investment'(ROI). To arrive at the quantum of finance needed detailed financial modelling is prepared keeping minimum assumption risk. A credible 'Detailed Project Report'(DPR) is thus essential as it will minimize the assumptions by undertaking various project-specific studies and leave little scope for speculation. This risk is normally owned by a private partner. A suggested mitigation plan could be based on incorporating mezzanine debt or preferred equity.

The second important risk is Demand Risk. Also called traffic risk, it has been the bane of many transportation projects turning

to make them 'bankable' as Correct estimation of the current traffic and credible projections for the future are important to estimate the need for VGF today and the profitability of the project in future. There are well-established and mature techniques available today for traffic study and fair statistical modelling can be undertaken. It is advisable that not only the study outcomes be retested for ascertaining the need for VGF but also for possibilities of revenue growth. Benefit Cost Ratio (BCR) be estimated after due study of the target population for impact on economic activity, travel demand and behaviour pat-terns. Usually, this risk is shared between the public

The third key risk is MAGA Risk (Material Adverse Government Action Risk) which arises due to political, regulatory, monetary policy and change of law events. For a specific PPP project, there will be many more angles of MAGA risk and a holistic analysis must be undertaken and necessary safeguards be built into the concession agreement. Once identified and prioritized, the risk mitigation planning is undertaken by way of either transferring the risk to the party who can handle it best, drawing insurance against a specific risk or changing the project plan to avoid/reduce the risk or making contingency plans after accepting the risk. All the time be careful to plan for the risk involved in managing the risk i.e., have a contingency plan for a particular contingency plan which you may make for mitigating that particular risk.

Pak receives **\$1.2** bn from IMF: FM

The IMF has transferred USD 1.2 billion to Pakistan, Finance Minister Ishaq Dar said on Thursday, a day after the global lender approved a USD 3 billion bailout programme for the cash-strapped country.

International The Monetary Fund (IMF) had signed a Stand-by Agreement at the end of June to provide Pakistan a short-term loan for a period of nine months and its executive board formally approved the USD 3 billion bailout programme on Wednesday to support the government's efforts to stabilise the country's ailing econ-

It said that the board approved the bailout package for the country for an amount of USD 2.25 billion Special Drawing Rights (SDRs) reserve funds that the institution credits to the accounts of its member nations, which amounts to about USD 3 bil-

On Thursday, Finance Minister Dar announced that the global lender had transferred USD 1.2 billion to the State Bank of Pakistan.

Addressing the media, Dar said when the Standby Arrangement (SBA) was finalised, it was decided that USD 1.2 billion would be given upfront while the "balance amount" of USD 1.8 billion would be handed over after two reviews in November and February.

"I want to share the information that the upfront payment of USD 1.2 billion, the IMF has transferred it to the State Bank of Pakistan's (SBP) account," he said.

The finance minister said that the IMF's Executive Board had approved the SBA with Pakistan and noted that this was a nine-month programme under which Islamabad would



The Army said that two terrorists were also killed in the shootout, for which no group has claimed responsibility.

The Sui attack followed a raid by terrorists on a military installation in Zhob Garrison early on Wednesday, wherein nine soldiers and five militants were killed.

Soldiers countered an initial attempt of terrorists to sneak into the facility, and in the ensuing heavy exchange of fire, terrorists were contained into a small area at the boundary.

The intense shootout in Zhob also resulted in the death of a female passerby and left five other civilians injured, the ISPR added.

"A clearance operation by Security Forces is underway to apprehend remaining two terrorists as well," the statement said, adding that the security forces were determined to thwart all such "ghastly attempts at destroying peace' in Balochistan. A little-known militant

roup - Tehreek-e-Jihad Pakistan - claimed responsibility for the Zhob attack in a statement without providing

This is the heaviest singleday loss suffered by the military in Balochistan, as before this, in February 2022, ten personnel were killed in a fire raid in the Kech district.

Balochistan Chief Minister Mir Abdul Qudoos Bizenjo condemned the attack on the Zhob garrison and paid tribute to the Pakistan Army for thwarting it by taking swift action. He offered his condolences to the families of the dead and said, "Pakistan Army is the guarantor of peace and security in the region."

Pakistan has been facing an uptick in attacks by the out-Pakistan and Baloch separatists in Balochistan and Khyber Pakhtunkhwa provinces.

Pita falls short in parliamentary vote for PM

 $T^{\text{he head of the progressive}}_{\text{Thai political party that}}$ outpaced its rivals to a surprise first-place finish in May's general election failed on Thursday in his initial bid to have Parliament name him the country's new prime minister. The vote of a joint session of the 500-seat House of Representatives and 250-seat Senate saw Pita Limjaroenrat win 324 votes in the first round of balloting, short of the majority of 376 needed to become prime minister.

His Move Forward Party finished first in the May 14 election and afterward assembled an eight-party coalition that together had won 312 seats, a healthy majority in the lower house.

But strong opposition in the Senate, whose members are overwhelmingly conservative and generally opposed to the reformist platform of Pita's party, seemingly doomed his chances in the first vote. Only 13 senators supported Pita's bid, while 34 voted against him and 159 abstained.

Pita told reporters afterwards that he "accepted" the



vote but was not giving up. He said the result was below expectations and thanked those senators who voted for him.

The biggest area of disagreement between the liberals backing Move Forward and the deeply conservative Senate is the campaign pledge of Pita's party to amend a law that makes defaming the royal family punishable by three to 15 ars in prison.

The monarchy is sacrosanct to members of Thailand's royalist establishment, and even minor reforms that might improve and modernise the monarchy's image are anathema to them. Move Forward's coalition partners also have not endorsed the proposed legal change, and other parties ruled out joining the coalition because of the idea.

Much of the debate that preceded Thursday's vote concerned the lese majeste law, also known as Article 112, which critics say is abused for political purposes.

The inconclusive finish to Thursday's voting sets the stage for another ballot, which is expected next week. Whether Pita will make a second effort, or step aside to let a nominee from another party in his coalition try their luck was not immediately known.

Some opponents explicitly said his party's stand on the 112 issue was the reason they would not vote for a government led by Pita. The Pheu Thai Party, the second biggest in the coalition holding 141 House seats, could step up and try to win support from enough sena-

Pheu Thai used to be the royalist establishment's top rival. The party is closely affiliated with former Prime Minister Thaksin Shinawatra, a billionaire populist who was ousted in a 2006 military coup, in part because his popularity rubbed royalists the wrong way. But the party is anxious to

get back into power, and less strident in supporting a reformist agenda that conservatives deem radical, though it would be considered moderate in Western countries.

Should Pheu Thai fail to successfully push through a prime minister candidate, the coalition would have to consider taking on new members.

Pita, regardless of how the prime minister issue is settled. faces additional challenges.

On Wednesday, the state Election Commission said it concluded there was evidence that Pita had violated election law, and referred his case to the Constitutional Court for a ruling. If the court accepts the case and finds him guilty, he could lose his House seat, get kicked out of politics and face a prison

There had been fears since even before the election that Thailand's conservative ruling establishment would use what its political opponents consider to be dirty tricks to cling to

For a decade-and-a-half, it has repeatedly utilised the courts and supposedly independent state agencies such as the Election Commission to

issue controversial rulings to cripple or sink political oppo-

The alleged violation involves undeclared ownership of media company shares, which are banned for Thai lawmakers. Political scientist Thitinan Pongsudhirak describes the charge and other legal complaints against Pita as "bogus" and something many people, especially voters who backed him, would be unwilling to tolerate.

"It all depends on how far the royalist conservative establishment wants to go after Pita and prevent a democratic outcome," he said. Depending how they are resolved, the efforts to block Pita and Move Forward could prove dangerous and cause Thailand unnecessary pain, said Michael Montesano, a Thai studies expert who is an associate senior fellow at Singapore's ISEAS-Yusof Ishak

"At the end of the day, the political system and those who would dominate need to move into closer correspondence with the realities of Thai society and with the aspirations of its younger, well educated members," Montesano said.

Sunak: UK visa fee hike to meet higher costs

The fees and health surcharge paid towards the UK's statefunded National Health Service (NHS) by visa applicants from around the world, including Indians, are set to rise "significantly" to meet the country's public sector wage increase, Prime Minister Řishi Sunak said on Thursday. The British Indian leader,

who was under pressure to accept the recommendation of an independent review of pay for teachers, police, junior doctors and other public sector workers, confirmed a hike between 5 and 7 per cent across the

board. However, he stressed that this would not be met with higher government borrowing for fear of further stoking high inflation and therefore the costs would need to be found else-"If we're going to prioritise

paying public sector workers more, that money has to come from somewhere else because I'm not prepared to put up people's taxes and I don't think it would be responsible or right to borrow more because that worse," Śunak told reporters at a Downing Street press conference. "So, what we have done are two things to find this money.



The first is, we are going to increase the charges that we have for migrants who are coming to this country when they apply for visas and indeed something called the Immigration Health Surcharge (IHS), which is the levy that they pay to access the NHS," he said. "All of those fees are going to go up and that will raise over GBP 1 billion, so across the board visa application fees are going to go up signifi-cantly and similarly for the IHS," he added.

Sunak reiterated this was "entirely right" as these fees have not been increased recently and the government believes it is appropriate given that the hike.The second action to meet the country's higher wage bill is about asking government departments to "reprioritise". He

UK government offers workers pay raises in bid to end strikes

The British government has agreed to offer millions of public sector workers pay raises in a bid to end an array of strikes, including a five-day walkout from doctors in the early part of their career in Britain's publicly funded health

Prime Minister Rishi Sunak confirmed Thursday that the government was accepting the recommendations from pay review bodies, that will see police get a 7% rise, 6.5% for teachers and 6% for the junior doctors, who commenced their strike early Thursday.

He said the offer is "final" and that there will be "no

more talks on pay."

In what is being described as the longest-ever strike in the National Health Service, many of the tens of thousands of doctors in England are making the case for a 35% pay bump.

So-called junior doctors, those who are at the early National Health Service in the years after medical school, started their latest strike at 7 am, with many of them making their case for a 35% pay rise in picket lines outside hospitals across England.

Kim vows to boost North Ukraine repels large Russian missile, drone attacks **Korea's nuke capability**

North Korean leader Kim Jong Un vowed to further bolster his country's nuclear fighting capabilities as he supervised the second test flight of a new, powerful intercontinental ballistic missile designed to strike the mainland United States, state media reported Thursday.

Kim's statement suggested North Korea would ramp up weapons testing activities to expand its arsenal in response to recent US steps to enhance its security commitment to ally

On Thursday, in an apparent show of force against North Korea, the US flew a nuclearcapable B-52 bomber to the Korean Peninsula for joint aerial exercises with other US and South Korean fighter jets.

"(Kim) clarified again that there will be no change and vacillation in the strategic line and policy of (the North Korean) government to steadily accelerate the development of more developed, effective and reliable weapon system," the Korean Central News Agency

Kim said North Korea is compelled to bolster the country's "nuclear war deterrent" because the security environment on the Korean Peninsula "is being seriously threatened by the hostile forces every

The Korean Central News Agency reported Kim's comments a day after the launch of the Hwasong-18, which was first test-fired in April and which Kim has called the most powerful weapon of his nuclear

The road-mobile ICBM has built-in solid propellant, which makes it more difficult to detect in advance than liquidfuelled missiles

KCNA said the launch was meant to reconfirm the technical credibility and operational reliability of the missile. Kim called the launch "another important stride" in efforts to boost the North's strategic forces, KCNA said.

There is work ongoing with a number of economies, including the UK, on intellectual property (IP) rights and modernisation in an effort to improve Indian protocols, Union Minister of Commerce and Industry Piyush Goyal has said.

Responding to questions from a gathering of Indianorigin chartered accountants (CAs) from the UK Chapter of the Institute of Chartered Accountants of India (ICAI) at the conclusion of his London visit on Wednesday evening, the minister - a qualified CA -covered a range of topics including IP rights and corporation tax to environmental, social and corporate governance (ESG).

He said the process to harmonise with international standards is high on the government's agenda because integrating with world thinking on standards and IP is important for the fast-paced growth of

With the UK we are working on IP rights or IP modernisation. Our effort is to improve the Indian protocols around intellectual property rights and areas associated with it, but I feel it will have to be a little more gradual process," said Goyal.

"Similarly, we are working very actively on quality standards in India. The BIS (Bureau of Indian Standards) for non-food products and FSSAI (Food Safety and Standards Authority of India) on food products are trying to develop standards. Wherever it's possible, we are trying to harmonise also with international standards. But it's not possible in everything...We are roughly at about 90 per cent of our standards harmonised with what is generally accepted standards," he said.

"But I can assure you we are conscious that if we have to develop our economy at a fast pace, we'll also have to integrate ourselves with the world thinking on standards, on intellectual property. Though it may be a process, we are moving very rapidly and hoping to become a preferred destination for other countries. So, it's very high on our agenda," he added.

The minister forecast that over the next three or four years, Indian standards will be seen as world class and accepted across the world.

While he veered away from any direct reference to the ongoing India-UK free trade agreement (FTA) while 'negotiations are on", the minister mentioned that the issue of transfer pricing was among the matters that had emerged as part of efforts to find wider solutions in the trade talks.

Unsecured lending products growth among highest, credit card NPAs shoot up: Report

Credit card non-performing assets rose 0.66 per cent to 2.94 per cent as of March 2023, a credit information company said in a report on Thursday.

The report, which comes amid heightened concerns on the riskier unsecured loans portfolios from the regulator, also said that such products like credit cards and personal loans grew the fastest, the report by Transunion Cibil said.

On the asset quality front, credit card balances unpaid for over 90 days stood at 2.94 per cent, which is a 0.66 per cent jump over the year-ago period, while the same for personal loans improved by 0.04 per cent to 0.94 per cent, it added.

From a loan growth perspective, outstanding balances on credit cards grew 34 per cent in the year to March 2023, and personal loans were up 29 per cent. Loan against property, a product typically used by small businesses for funding needs,



was the fastest-growing retail product with a 38 per cent rise, according to the report.

Interestingly, home loans considered by many as the mainstay of retail lending were the slowest at 14 per cent, which can be indicative of the impact of the rate hikes.

If one were to consider only the three months to March, home loans stayed flat by a value perspective, but were down 11 per cent by volumes, indicating an increasing propensity among home buyers for expensive properties where the loan ticket sizes are

The exchequer would get an estimated additional revenue of Rs 20,000 crore annually following the decision of the GST Council to levy 28 per cent tax on full bet value on online gaming, said Revenue Secretary Sanjay Malhotra on Thursday.

The GST Council has unanimously decided to impose 28 per cent tax on online gaming, casino and horse racing etc, he said adding that the government will pursue all cases in the Supreme Court for recovery of erstwhile tax demands.

He said the online gaming industry is currently paying only 2-3 per cent GST which is even less than 5 per cent tax applicable on food items consumed by a common man.

"One of the members, in fact, in the GST Council pointed out that the way the online gaming companies are paying



per cent of GGR, which works out to only about 2-3 per cent, even lower than the tax rate of 5 per cent levied on many of the food products consumed by the very common people," Malhotra told PTI in an inter-The exchequer last year

(FY2022-23) collected only Rs 1,700 crore GST which could have been Rs 15,000-20,000 crore had the tax been levied on the full value.

"But this (tax by online

The council earlier this week clarified that GST should be paid at 28 per cent on the full face value of bets. He further said that wher-

ever there is tax avoidance or evasion those aspects will certainly be looked into and those taxes will be recovered, he

"As you may be aware we are also going to challenge the decision of the High Court in the Supreme Court. So, our decision to collect taxes at higher rates will of course also depend on the outcome of the judgement in the Supreme Court. Unless and until we have a judgement in our favour, we will not be in a position to recover the taxes at the higher rates," he said.

On the possibility of review following concerns expressed by the online gaming industry, Malhotra said, "The council was very unanimous. It has taken this decision after due deliberation. It has taken this decision after consultations with the industry. There was long consultation as you are aware that this decision has been pending for the last two to three years.

Whether this decision will be reviewed, he said, "The decision has just been taken. I really do not think. Of course, it is for the council to decide. I really doubt (it) because this decision has been unanimous and the decision has been taken as I mentioned after due consultation and deliberation. So, I don't think there is any chance of a review as early as

On whether the high tax rate would prompt undesirable entities to operate from offshore, Malhotra said it would be a challenge but there are means available with the gov-

Sebi comes out 'stricter timeline' for disclosure of material events

Vapital markets regulator Sebi on Wednesday came out with a "stricter timeline" for disclosure of material events or information by listed companies and introduced criteria for determining the materiality of The new framework will

become effective from July 15, the Securities and Exchange Board of India (Sebi) said in a circular.

Under the framework, the regulator asked listed companies to disclose family settlement agreements, which can impact the management and control of such firms to stock exchanges. These agreements need to be disclosed within 12 hours in case a listed entity is a party and within 24 hours where the listed entity is not a party. Further, for material events or information which emanate from the listed entity, including those related to acquisitions, Scheme of Arrangement, consolidation of shares, and buyback of securities, the timeline for disclosure by the entity has been reduced from 24 hours to 12 hours.

In case of information that emanates from a decision taken in a meeting of the board of directors, the disclosure needs to be made within 30 minutes from the closure of such meet-

Besides, the timelines have been fixed 24 hours from the occurrence of the event in case the information is not emanating from within the listed entity. This included a revision in rating, fraud or defaults by a listed entity, its promoter, directors; restructuring in relation to loans from banks, one time settlement with a bank and winding-up petition filed by any party / creditors.

With regard to criteria for determining the materiality of



events, Sebi said that one of the criteria is the omission of an event, whose value or the expected impact in terms of value, exceeds the lower of 2 per cent of turnover, or 2 per cent of net worth as per the last audited consolidated financial statements or 5 per cent of the average of absolute value of profit or loss after tax, as per the last three audited consolidated financial statements of the listed entity.

The regulator clarified that "average of absolute value of profit or loss is required to be considered by disregarding the 'sign' (positive or negative) that denotes such value as the said value is required only for determining the threshold for 'materiality of the event and not for any commercial consideration".

If a listed entity does not have a track record of three years of financials, like in case of a demerged entity, the average may be taken for the number of years as may be available. Sebi also came out with

guidance on when information can be said to have occurred for disclosures under the LODR (Listing of Obligations and Disclosure Requirements) In certain instances, the

disclosure would depend upon the stage of discussion, negotiation or approval and in other instances where there is no such discussion, negotiation or approval required --in case of natural calamities, disruptions etc, Sebi noted..




