Athrough Manipur's Churachandpur following the release of a disturbing video showing two women being paradeď naked by a mob. The incident has drawn widespread condemnation, including from the Supreme Court, which expressed deep distress and termed it "unacceptable in a constitutional democracy."

The Supreme Court bench led by Chief Justice DY Chandrachud, took cognisance of the video and ordered the Centre and Manipur Government to take immediate action. The Union Home Secretary and the State Chief Secretary have been asked to file affidavits apprising the court of the actions taken. The next hearing is scheduled for

Amid heavy downpour, over a thousand people donning black attire assembled at Ground

Churachandpur and marched towards Peace Ground in Tuibong, demanding a separate administration. The protesters held banners with messages such as "Rally for separate administration," "Please recognise our separation from Manipur," and "Too much tribal blood has flowed, separation is the only solution."



Slogans like "We want total separation," "Long live tribal unity," and "Biren government down down" echoed through

This peaceful protest came in the wake of the distressing video that has deeply affected the nation. Numerous organisations, civil societies, political leaders, and Bollywood celebrities have voiced their condemnation, calling it an affront to humanity. Chief Minister N Biren Singh and others have called for strict punishment for the perpetrators.

INDIA ASHAMED Manipur shoots up Massive protest over Manipur video; Parliament's temp

The first day of the Monsoon Session of Parliament commenced on a stormy note on Thursday with the Opposition raising a din in Lok Sabha and Rajya Sabha on the Manipur violence issue leading to quick adjournments and finally for

While the Government on the floor of both Houses said it is ready to discuss the issue as a short-duration discussion, the Opposition repeatedly said it wanted all proceedings to be suspended before taking up the Manipur issue

A united Opposition demanded a suo motu statement from Prime Minister Narendra Modi and sought to know why the PM remained mum on the crisis now which is almost three months.

During the customary conversation between the PM and UPA chairperson Sonia Gandhi, the latter demanded an immediate discussion on Manipur to which Modi is believed to have conveyed that it will be taken up in due

Several Opposition members, including Congress President Mallikarjun Kharge, had given notices in their respective House demanding a

The lower House was first adjourned in the morning soon after obituaries references by Speaker Om Birla and as Opposition members sloganeered on the Manipur crisis.

"We have made it clear that we are ready for a discussion on Manipur in both Houses. Manipur is a sensitive issue. The Home Minister will reply to the discussion in detail," said Parliamentary Affairs Minister Pralhad Joshi

He said Shah will reply to the debate. Joshi said Deputy leader in Lok Sabha Rajnath Singh has already given a sim-

ilar assurance in this regard. Opposition MPs were continuously shouting slogans like "Manipur Manipur" and "Manipur is burning".

As Opposition members continued raising slogans even when it assembled for the postlunch session, Kirit Solanki who was chairing proceedings, adjourned Lok Sabha for the day within a few minutes while Joshi was reiterating the Government's readiness to hold a debate on Manipur.

A similar ruckus was witnessed in Rajya Sabha when in the morning Chairman Jagdeep Dhankhar informed the members that the Chair has accepted eight notices by members for a short-duration discussion under rule 267.

Leader of the House Piyush Goyal said the Government has no objections and was ready for a discussion on Manipur.

duration discussion, Congress president and Leader of Opposition in Rajya Sabha Mallikarjun Kharge raised objections and said all the business of the House be suspended first and their notices for a discussion on Manipur under Rule 267 be taken up.

"How the Leader of the House suddenly gets up and says we are ready for a discussion. We have given notices under Rule 267 for suspending all other business of the House and then take this up. Let the prime minister give a statement and we will discuss," Kharge told the chairman after which the House was adjourned due to sloganeering opposition members in the morning.

PM condemns Manipur horror, pledges justice

UMonsoon session of parliament on Thursday, Prime Minister Narendra Modi condemned the horrific incidents of sexual atrocities in Manipur, declaring that such actions could never be forgiven, and the guilty would not escape jus-

In his first address on the Manipur issue since the outbreak of violent clashes in the State, the Prime Minister called upon all State Chief Ministers to prioritise the "safety of women" and take necessary measures to protect them.

Speaking to reporters at the Parliament House premises, Modi expressed deep shock and anguish over the distressing video from Manipur, which showed women being disrobed and humiliated by rioters and

anti-social elements. "As I stand next to this temple of democracy, my heart is filled with pain and anger. The Manipur incident is a shame for any civilised nation.



The entire country has been shamed," he said in his customary address ahead of the start of the two houses, which

were later adjourned for the day due to the gravity of the He vehemently condemned the "disturbing inci-

dent" and assured the nation that those responsible for such heinous acts would face the full force of the law.

'The video showing atrocity against women in Manipur is the most shameful. I am pained and angered by the incident, and I assure the people of the country that the guilty will not be spared and

SC to appoint DERC head on ad-hoc till CM-LG row sorted

The Supreme Court made strong observations on Thursday regarding the ongo-Arvind Kejriwal-led Aam Aadmi Party Government and Delhi Lieutenant Governor (LG) V K Saxena over the appointment of the Delhi Electricity Regulatory Commission (DERC) chair-

The court expressed anguish that nobody seems to care about the "headless" institution and stated that it will take action to appoint a DERC chairperson on an ad-hoc basis while pending a decision on the Delhi Government's plea contesting the LG's power to make

such an appointment. A bench comprising Chief Justice D Y Chandrachud and Justices P S Narasimha and Manoj Misra emphasised the need to resolve the issue promptly, especially after the failure of the LG and the Chief Minister to reach a consensus despite the apex court's direc-

The court proposed the appointment of someone on a



"pro tem basis" to the post and stated that it will have to conduct some groundwork, consult relevant parties, and obtain their consent.

During the hearing, the bench suggested that both sides provide names of three to five former judges of the Delhi High Court without indicating who suggested which names. The court expressed its willingness to pick one name from the list provided. Senior advocates Harish Salve, representing the LG, and Abhishek Singhyi, representing the Delhi Government, were involved in the proceedings.

Senior advocate Salve informed the court that the apex court can name somebody for the position, and upon agreement from both parties. the appointee can be assigned as the DERC chairperson. However, the court reiterated that the appointment could



only proceed with mutual con-

Solicitor General Tushar Mehta, representing the Centre, emphasised the importance of a functioning DERC and supported the court's proposal to appoint someone to the post on

an interim basis. The Supreme Court expressed its concern about the state of the institution and urged the involved parties to rise above political disagreements and focus on the essential work of governance away from public scrutiny. The court stated that it will find potential candidates and consult former judges of the High Court before making the appointment. The next steps in the matter will be taken as per the court's direc-

Chinese manjha kills girl riding with dad

seven-year-old girl died AWednesday after a glasscoated kite string got tangled around her neck, leaving a deep cut, in the Guru Harikshan Nagar, Paschim Vihar area of Delhi. The Delhi Police said the girl was with her father, mother, and elder sister on a motorcycle on her way to a swimming class when the accident took place.

The girl was sitting in the front, followed by her father, who was riding the bike, while her 13-year-old sister and mother were riding pillion, a senior police officer said.

On Wednesday, a PCR call was received at 7.27 pm in Paschim Vihar West Police Station regarding the death of a girl due to a suspected Chinese manjha (thread coated with glass particles used for



flying kites), the officer said. The information was received from Sri Balaji Action Hospital, police said. A case under sections 304A

(causing death by negligence) and 188 (disobedience to order duly promulgated by public servant) of the Indian Penal Code has been registered and investigation is underway, the officer said.Delhi Police on Thursday took to Twitter and asked people to inform them if anyone they know is selling or jha. "Is Chinese manjha being sold, manufactured or used near you? Let's stop it togeth er! Inform us on 112 and cooperate with us in its prevention. Your identity will be kept confidential," police tweeted in

Chinese maniha or any form of glass-coated thread has been banned in Delhi since 2017, following a Delhi Government notification on January 10, 2017. The National Green Tribunal too has manufacturing Chinese man- imposed a similar ban on the

use of nylon or synthetic thread material for kite flying. It prohibits the production, storage supply, importation, sale, and use of all forms of manjha, with the ban in place in order to prevent harm to humans, birds, and other animals as well as the environment. The notification permits flying kites only with a cotton thread free from any materials designed to increase its sharpness or strength. In Delhi, the people most

affected by the use of the illegal Chinese manjha are those on two-wheelers. In most cases, death is sudden because of excessive blood loss. Not just humans, birds too

have fallen victim to the glasslaced threads used for flying kites. The People for the Ethica Treatment of Animals (PETA) said that they got around 1,500 calls every year in connection with injuries to birds.

5-judge SC bench to hear Delhi Ordinance

CJI issues directive on protocol facilities, highlights need for judicial discipline

In an unprecedented move, Chief Justice of India DY Chandrachud, taking cognisance of the summoning of a Railway Official by Registrar of Allahabad High Court Justice Gautam Chaudhary on charges of dereliction on part of Indian Railways, has said that protocol facilities to Judges should not be used in a manner that is liable to result in inconvenience to others or to bring public criticism of the judicia-

In a direction to all the High Court to avoid any confrontation with likewise establishments, the CJI has remarked that Judge of the High Court does not possess disciplinary jurisdiction over railway personnel.

"Hence, there was no occasion for an officer of the High Court to call for an explanation from the railway personnel "to be placed before His Lordship



What has happened in Manipur, "is a matter of shame," Banerjee said, blaming the Centre for fanning the riots in the North-Eastern State. Banerjee's reaction came after a video showing two women being paraded naked in public by a crowd of miscreants went viral.

In all, 150 to 170 people were initially feared trapped under the mountain of debris of 17 out of a total 48 houses that got buried after a downpour-triggered landslide wreaked havoc in Irshalwadi, a hill-top tribal village of a population of 228 people that is in the hilly terrain and is inaccessible by a pucca road.

The rescue and relief work which started within a couple hours after the landslide that took place at around 10.30 pm – continued till 6 pm on Thursday.

The village had recorded 499 mm of rainfall from July 17 to 19, 2023. The population of the village is 228. There are in all 48 houses in the village. As many as 25 to 28 families are affected in the landslide".

Talking to media persons at the affected village, Shinde announced an ex gratia of Rs 5 lakh each to the next kin of the deceased and free treatment for those injured in the incident. "To relocate and accommodate the 48 families displaced by the mishap, we have ordered 50 containers. We will rehabilitate them properly at a different place at a later stage," he said.

While the chief minister himself visited the mishap, deputy chief ministers Devendra Fadnavis and Ajit Pawar are monitoring the situation from Mumbai.

Shiv Sena (UBT)'s leader of Opposition Ambadas Danve, Aditya Thackeray, state Congress President Nana Patole and other leaders visited the mishap site and offered all cooperation to the state government and the local peo-

Fireman dies of heart attack

In an unfortunate mishap, a fire officer attached to a Belapur brigade station of the Navi Mumbai Municipal Corporation (NMMC) died of a heart attack on Thursday morning, while climbing to the hilltop village of Irshalwadi village in Khalapur taluka of rain-ravaged Raigad district where a massive landslide took place late on Thursday night.

Identifying the deceased fire officer, NMMC chief fire offi

cer Shirish Aradwad said: "Shirish was an assistant station officer attached to the Belapur fire station in Navi Mumbai. He was amongst the first batch of rescuers who were sent to Irshalwadi village. While climbing the narrow and steep path to the hilltop village, Shirish collapsed after he suffered a heart attack. He died immediately after that".

The Constitution excludes three entries of List II (state list) related to police, law and order and land from the control of the Delhi Government, it said.

"What you (Centre) have effectively done is that the Constitution says barring three entries, Delhi Legislative Assembly has the power. But, the Ordinance takes away Entry 41 (services) (of List II) also from the power. That is the effect of Section 3A of the Ordinance" the bench said. Senior advocate Harish Salve, appearing for Lieutenant Governor VK Saxena, referred to previous judgments and said for a union territory the state list becomes a concurrent list and hence Parliament has the power to legislate. Salve justified the termination of the services of 437 independent consultants appointed by the Delhi Government by the orders of the LG. The Delhi Government made "rank illegal appointments" of undeserving persons, who happened to be Aam Aadmi party workers, and they were terminated by the LG, and for that the ordinance was not needed at all, he said.

Senior advocate Abhishek Singhvi, appearing for the Delhi Government, said the reference of the case to a constitution bench was not needed as the matter can be decided by a three-judge bench. The senior lawver said the ordinance violated Article 239AA (which deals with special provisions with respect to Delhi) of the Constitution as it diluted the power of the elected Government.

Man dies of electrocution

The enquiry confirmed that he died due to electrocution while using a treadmill at the facility. Keshav, a witness present at the gym during the incident, mentioned that Saksham sat between two treadmills to take a rest when he fell down after getting shocked. Attempting to help, Keshav also received an electric shock but managed to turn off the power switch before receiving medical attention and surviving.

Despite immediate efforts, there was no response from Saksham, and he was taken to the hospital unconscious. Anubhav Duggal, the person running

the gym, has been arrested. The police reviewed CCTV footage, revealing that Saksham was exercising on the treadmill when the accident occurred. A forensic science laboratory team confirmed that the treadmill's metal parts were carrying electric current.

A case has been registered under IPC sections 287 (negligent conduct with respect to machinery) and 304A (causing death by negligence) at KN Katju Marg police station, according to DCP Sidhu.

Saksham's Mahesh Pruthi, shared that his son had a BTech degree from Delhi and was employed at an MNC in Gurugram. The family was notified of the accident

when Saksham's emergency contact was reached through his phone. Despite efforts to save him, doctors informed the family that Saksham had died from the electric shock. Saksham had recently been promoted to a managerial position in June.

The family learned from colleagues at the gym that similar incidents had occurred in the past, and complaints to the gym management had gone unheeded. Mahesh believes this negligence led to the loss of his son, who had been going to the gym for the last few months.

Saksham's friend, Navdeep Dhawan, mentioned that he had resumed his workout routine after a short break. In response to the inci-

dent, the Delhi Gym

Association advised its members to promptly check the earthing connection and ensure no loose wires were present at

their establishments. All electrical points were to be inspected by electricians, and other measures were to be taken to prevent such incidents in the future. The association's vice-president, Chirag Sethi, attributed the incident to a fault in the treadmill's electrical wiring. Don't sell NSAIDs without prescription: Govt to chemists

The Delhi government's Department of Drugs Control has written a letter to the president of All Chemist Associations of Delhi to avoid the sale of nonsteroidal antiinflammatory drugs (NSAIDs) like Aspirin, Ibuprofen and Diclofenac without the prescription of a regular medical practitioner. The department has advised retail chemists to refrain from over-the-counter sale of these medicines with immediate effect until further

'They (chemists) are also advised to keep records of stocks of painkiller drugs falling under this category. Stringent action will be taken against retail chemists if found flaunting this advice," the let-

According to department officials, these medicines destroy platelets in human blood. The Health department will take action against any retail chemist found flouting this advice. With the rise of vector-borne diseases such as



Modi silent on Manipur, sign of weak leader: Kejriwal **STAFF REPORTER** NEW DELH

Delhi Chief Minister Arvind Kejriwal Thursday said the video of two women being paraded naked in Manipur has shaken the conscience of the nation, and urged Prime Minister Narendra Modi to take strict action to restore peace in the state. The chief minister termed the

government's lack of response as "shameful, disgraceful, and criminal," and called for immediate and thorough criminal investigations into the matter.

"It has often been seen that PM Modi is quiet on such incidents. It is the sign of a weak leader. A courageous leader comes out in the front. It doesn't happen that they shut themselves in a room.

He has been silent (on the issue)," the AAP chief said. Tension mounted in the hills of Manipur after a May 4 video surfaced on Wednesday showing two women from one of the warring communities being paraded naked by a few men from the other side. The video was doing the rounds on the eve of a planned protest march



announced by the Indigenous Tribal Leaders' Forum (ITLF) on Thursday to highlight their plight. Responding to a media query after an official event at the Thyagaraj Stadium, Kejriwal said "The video that went viral has shaken the conscience of nation.

It is criminal and extremely shameful that there has been violence in the state for more than two months but the government did not take any action. It is with extreme sadness that I have to say that Manipur (government) and Centre are responsible for this."

Kejriwal also slammed

the state government over the incident. "Now that the video went viral only one person has been arrested. The faces of the accused are visible. This shows

government's criminal con-spiracy, negligence and collu-sion," he alleged. When asked about the growing echo for Manipur Chief Minister N Biren Singh's resignation, he said, "For me, the first priority is to restore peace in the state in whatever way possible. I don't want to do politics over it since it's a very sensitive matter. The prime minister has to come forward to take responsibility. Strict steps have to be

Even a delegation from Manipur kept waiting for him but he did not meet them." "Not only is this video horrific, but it is heart-rending. The whole country watched the kind of behaviour that the women were meted out. It was worse than how animals are treated. But the BJP is not tak-

Delhi's AAP Government's failure to implement the National E-Vidhan Application (NeVA) aimed at digitalising the Legislative Assembly has come under scrutiny, as it remains the only Assembly in the country yet to initiate the digitisation process, even after four-and-a-half years since the project's inception.

NeVA, launched in 2015 by the Central Government, aims to make Legislative Assemblies across India paperless and digitally efficient. The initiative has been adopted by all 37 Legislative Assemblies and Councils in the country, except for Delhi.

In 2019, the Central Government proposed to fully



fund the NeVA project for Delhi, providing both financial and technical assistance. Government in Delhi decided to develop the application independently, allocating a budget of Rs 20 crore for the purpose. Despite this intention, the project has made no progress,

leading to growing concerns over the delay and lack of action. The Ministry of Parliamentary Affairs' Secretary addressed the issue, writing to the Lieutenant Governor (LG) Secretariat, seeking intervention to expedite the implementation of the NeVA project in Delhi.

The LG Secretariat subsequently forwarded the request to the Principal Secretary (Law, Justice & Legislative Affairs) of the Government of the National Capital Territory of Delhi (GNCTD) for necessary

Earlier this year, the Ministry of Parliamentary Affairs had also written to the Delhi Chief Secretary, urging the government to adopt Project NeVA, highlighting the 100% funding available for the Union Territory of Delhi for its implementation.

The letter emphasized that the project's digitalization of Vidhan Sabha and other associated services would lead to significant cost savings for the government of Delhi and enhanced convenience for legislators and the general public. In January 2019, the Delhi Assembly had decided to "optout" of the NeVA project, expressing its intention to develop the eViddhan project independently using its allocated budget.

Despite acknowledging the urgency to digitize and adopt electronic means of communication, the Delhi Assembly and the Delhi Government have yet to take any concrete steps towards initiating the project since 2019.

The delay in implementing the NeVA project has raised concerns about the efficiency of the AAP Government in utilizing available resources to ensure the digitalization and modernization of the Legislative Assembly.

Railways adopts ways to link popular areas with station name

R ailway stations across the country will soon be identified with both their established names and local popular names, along with those of their satellite cities.

For example, when booking journey tickets for New Delhi Station, the reservation platforms will display options like Indraprastha and Noida. Similarly, when booking

for Patna, supplementary locations like Gol Ghar, Rajgir, and Pataliputra will be available on the websites or apps for inquiries related to these sta-

This new approach aims to improve journey planning and provide a personalized passenger experience during ticket booking on the website and mobile app. Currently, 175

popular cities/areas have been mapped with 725 stations, and this facility will be available from Saturday onwards. Tourist destinations such as Kashi, Khatu Shyam, Badrinath, Kedarnath, and Vaishnodevi have also been linked to their nearest railway stations.

The railway officials state that this initiative will be beneficial for passengers searching for journeys between specific

When people search for a journey from Mumbai to Mathura, they will be given options for nearby stations and trains for Agra or Tundla en route, making the journey planning process easier and increasing berth availability.

"This approach of linking popular areas with station names will provide great passenger convenience, as it helps identify small stations with

popular cities/areas. The railway will not only prompt the station name but also the right place while planning the journey. Small stations will be linked with popular cities/areas, such as Sarnath being linked with Banaras, Sabarmati linked with Ahmedabad, and Panvel linked with Mumbai," explained a senior railway official.

Moreover, this initiative also includes linking satellite cities to their connecting railway stations, like Noida being linked to New Delhi. Sometimes, local or popular names differ from the official railway station names, leading to confusion during journey planning. Cong constitutes election | DGCI warns doctors, patients against cough syrups containing pholcodine

The country's top drugs reg-ulator, Director General Controller of India (DGCI), has issued an advisory asking doctors, medical professionals, and patients against using pholcodine-containing cough syrups and cold medication after the World Health Organization (WHO) raised an

The DCGI has asked doctors to suggest an alternative to patients for treating their symptoms. The WHO's advisory for healthcare professionals and regulatory authorities highlighted the risks of anaphylactic reactions associated with the use of pholcodine-containing products.

The global agency said that people who have consumed pholcodine-containing cough and cold remedies within the last 12 months before undergoing surgical procedures involving general anesthesia with neuromuscular blocking PNS | agents (NMBAs) may be susceptible to severe allergic reac-

DCGI Raghuvanshi said that the matter was referred to the Subject (Antimicrobial & Antiviral) to seek expert opinion on the safety alert published by WHO on prior use of pholcodine containing cough syrups and cold remedies and risk of perioperative anaphylactic reactions to NMBAS for any regulatory interventions required on the

"To verify whether the patients scheduled to take general anesthetics (NMBAS) have taken pholoodine containing cough syrups in the previous 12 months and also be aware of

anaphylactic reactions in such patients," he said in the advisory. Raghuvanshi advised consumers or patients to "exercise caution" when considering the use of pholcodine-containing cough and cold remedies.

'If you have taken Pholcodine-containing cough and cold remedies within past 12 months and are scheduled for a procedure involving general anesthesia, it is essential to report this information to your healthcare professional prior to procedure," he said.

The WHO, in a medical product alert issued on March 31, said that the European Medicines Agency's (EMA) pharmacovigilance risk assessment committee reviewed all available evidence including post-marketing safety data, information from third parties such as healthcare professionals and final results of a French multicentre case-control study comparing pholcodine exposure within a year before anaesthesia between patients with NMBA-related peri operative anaphylactic reactions.

NIA arrests another PFI man in Bihar case troversial videos on social **Busted ISIS module**

▲ Agency (NIA) has made another arrest in the Bihar case related to the banned Popular Front of India (PFI), bringing the total number of arrests to 15. Yaqub Khan alias Sultan, a 22-year-old resident of District East Champaran, Bihar, was apprehended in NIA Case No. 31/2022/NIA/DLI, which involves the investigation of unlawful and antinational activities of PFI cadres and members, as per the NIA statement.

During the investigation, it was learned that Yaqub Khan served as an expert arms trainer for the PFI and conducted numerous training sessions to further the outfit's aggressive and violent agenda. He facilitated the procurement of arms and ammunition to target youth from a particular community for revenge, thereby fueling communal hatred. Additionally, he uploaded conmedia to incite enmity among been on the run since the houses of PFI syndicate members were raided and searched in February of the current year. Following the ban on PFI by the Centre, he remained in contact with the FIR named accused Reyaz Moarif, and his associates Md Belal alias Irshad and Afroz. Moreover, he communicated with his Dubai (UAE) based associate Md Sajjad Alam via WhatsApp.

After concealing himself initially in Bettiah district of Bihar, he later stayed with another accused, Md Irshad Alam, in Pokhara, Nepal, who was arrested in this case on March 18. Subsequently, he moved to Mumbai, where he resided with another aunt at Dharavi and a friend. Returning to Bihar in April 2023, he continued to hide with friends, associates, and relatives in East Champaran, Sitamarhi, and Muzaffarpur districts.

New Delhi: The National Investigation Agency (NIA) on Thursday claimed that it has achieved a major success in busting a Kerala ISIS module and averted communal terror attacks in the Southern State after it arrested an accused from a hideout in Tamil Nadu and searched four locations in Thrissur and Palakkad districts of Kerala.

"The National Investigation Agency (NIA) has averted possible terror attacks on places of worship and leaders of certain communities by busting an ISIS module based in Kerala," the NIA said in a statement. 

Fiery Monsoon session

It is likely to be one of the stormiest sessions with many controversial Bills and the Manipur issue

t is most likely to be the last Monsoon session of the Modi Government as elections would be held by May next year. The stage is set for yet another round of clashes between the Narendra Modi government and a newly united Opposition over a host of issues. Spread over 23 days with 17 sittings, the session begins in the old building and is later expected to move to the new building where it will conclude on August 11. The biggest issue to be debated, of course, would be Manipur which has been on the boil for over two and a half months and still burning. The Opposition would make all efforts to corner the government for its failure to quell the violence there. Of course, the Government will have the respite that Rahul Gandhi will not be there to question it. The government plans to take up seven Bills for consideration and passage and introduce 21 new draft legislations, including the Digital Personal Data Protection Bill and the Government of National Capital Territory of Delhi



(Amendment) Bill. So far, there is no mention of a Bill on the Uniform Civil Code in the tentative list of legislative business, though rumours are rife that Government plans to table such a Bill in this session. Though an all-party meeting was called to ensure that Parliament functions smoothly, its chances are rather slim, especially since the government has avoided Manipur on national and international fora. Bills that will be taken up for consideration and

passing are The Biological Diversity (Amendment) Bill, 2022, The Jan Vishwas (Amendment of Provisions) Bill, 2023, The Multi-State Cooperative Societies (Amendment) Bill, 2022, The Repealing and Amending Bill, 2022, The Mediation Bill, 2021, The Digital Personal Data Protection Bill, 2023, The Government of National Capital Territory of Delhi (Amendment) Bill, 2023. The last two are going to be fiercely debated. The GNCT Bill seeks to replace the contentious ordinance that curtails the powers of the elected state government on bureaucrats posted in Delhi. The ordinance effectively nullified the Supreme Court judgment that gave the Delhi government greater legislative and administrative control over civil services matters. This issue related to the Delhi ordinance is likely to dominate proceedings in both Houses. For months, Delhi CM and Aam Aadmi Party (AAP) chief Arvind Kejriwal has been preparing for pushback on the ordinance in the Rajya Sabha. The AAP stands a good chance to stonewall the Bill if the Congress backs it. The Congress has announced that it will back the Delhi government as the ordinance "curtails constitutional rights and responsibilities of the elected government". So it is going to be all thunder and lightning at this Monsoon session.

Israel-Palestine strife: Military is no solution



Rather than a military solution, thorny issues such as water management and Jerusalem's status must be addressed at the UN for lasting peace

he multiple attacks by the Hamas, retaliations, the latest army operation carried on in Jenin Camp to drive out militants and the ongoing skirmishes between Palestinians and Israel resulting in huge casualties have further dusted off any hope of peace and negotiation. The announcement of nine settlements in the West Bank during February 2023 has been widely criticized by Palestinians and raised concerns about the possible forebodings of a third Intifada. The first major retaliation was launched by Palestine in 1978 and the second in 2000. Despite recent attempts by the US, Egypt and the UN to seek an immediate solution to the crisis West Asia continues to sit on Powder Keg. There are chances of conflict spilling over the communities within Israel which can turn out to be pernicious and may end up flaring it up further. This also brings forth a major

question: how to resolve regional conflicts so deeply interwoven in acrimonious past? perhaps this is high time each side takes a cue from the emancipation of a renowned Scottish Philosopher David Hume's enlightenment discourse. As he once conceded "Difference is the essence of humanity. Difference is an accident of Birth and it should therefore never be the source of hatred or conflict. The answer to difference is to respect it. Therein lies a most fundamental principle of Peace and respect for diversity". These are not merely a part of clichés but have an in-depth meaning of conflict resolution. The continuous need for peace and a common platform for negotiation has exposed the painful process of conflict and a complete trust deficit resulting in the upsurge of clashes.

While people in the region expecting for both sides to accelerate plan formulation towards peace and improving means of production, economic aggrandizement, income, and employability the reality appears to elude chances of negotiations till a breakthrough is made. As many as 2559 civilians and over 206 soldiers have died in the nasty con-



The present crisis is the outcome of a combination of factors, deeply interwoven in the complicated period of the conflict in West Asia ever since 1948. Although in the past on many occasions the İsraeli Government has designed a series of policies aimed at quick results, the Hamas took the extreme step of working against the peace proposals. Recently a third party (Egypt-supported) brokered peace and reconciliation efforts have been agreed upon by Hamas but the coming days will test the sustainability of such efforts. The history of past third-party mediations has not yielded positive results. In these circumstances, the solution to West Asia depends on the extent to which the present leadership of both sides can negotiate with each other. further, the mounting Israeli strikes on the Gaza Strip

INDIA-FRANCE CAN BE A POTENT FORCE

Together, the two countries can be an effective balancing power in the Indo-Pacific

Prime Minister Narendra Modi undertook another high level to India's west, less than a month after his state visit to the US. The visit to France last week is a reminder of the changing geopolitics, aligned with 21stcentury realities. If several rounds of vegetarian meals hosted by America's top leadership, the second chance to address a joint session of the US Congress were a teaser, France upped the game by bestowing the Grand Cross of the Legion of Honour, the highest civilian and military honour on PM, not to forget the proud Indian tri-services marching on Champs- Elysees. It is a reminder to India steadily taking the rightful place in the global order, specifically, when it comes to the Indo-Pacific region, to an extent catalysed by the presence of China, whose aggressive manoeuvres in the Indian Ocean region and beyond are forcing new alliances and partnerships.

It is significant that even though India hasn't clearly articulated its Indo-Pacific strategy, unlike France and US, there was a joint statement released during the PM's Paris visit. The note mentioned "Our countries believe in a free, open, inclusive, secure and peaceful Indo Pacific region. Our cooperation seeks to secure our own economic and security interests; ensure equal and free access to global commons; build partnerships of prosperity in the region; advance the rule of international law; and, working with others in the region and beyond, build a balanced and stable order in the region, with respect for sovereignty and territorial integrity.

A mention regarding PM Modi's envisioned SAGAR ((Security and Growth for All in the Region) and President Macron's vision of the security and cooperation being aligned, was made, to highlight the key glue for the 25-year-old India-France relationship. France has always partnered with India on the premise of strategic autonomy. This goes well for India, as it doesn't impose conditions for bilateral cooperation. It takes away the uncomfortable "Us vs Them ", narrative, providing the breathing space for a healthy friendship to take life. That the India-France relationship has stood the test of time, such as France not imposing sanctions on India in the aftermath of nuclear tests, or not criticising India for its non-committal stance on Ukraine, is well documented.



The current roadmap extends the partnership to bring a larger bunch of partner countries located in the vast Indo-Pacific region under a comla. The joint statement read "We will continue to work together to extend development cooperation to countries in the region, including in Africa, the Indian Ocean Region, South Asia, Southeast Asia and the Pacific. We will strengthen our plurilateral arrangements with Australia and UAE and build new ones in the region. We will strengthen our cooperation in regional forums such as the Indian Ocean Rim Association, the Indian Ocean Naval Symposium, the Indian Ocean Commission, the Djibouti Code of Conduct, the ADMM+ and ARF."

India and France are already working on a trilateral platform with Australia and UAE, and plan to expand the net on most critical areas of maritime cooperation, security, climate change etc to a wider bunch of nations impacted in the region. These nations while not as large, economically or areawise, as compared to India hold strategic spots in the extended Indo-Pacific expanse, which India loosely defines as ranging from US east coast to the African west coast. This region also controls/hosts some of the most heavy traffic sea routes, through which billions of dollars' worth of goods are traded across the world China is increasingly getting aggressive in the Indian Ocean region, slowly building strategic military bases by coercion (most often) in some of these smaller island nations threatening territorial sovereignty of many countries. A joint collaborative approach between India and France, taken together with a vision for the next 25 years augurs well to act as an effective balancing power.

Human-tiger clash: Beyond the stripes





The overall increase in population doesn't indicate that all is well on the tiger conservation front; serious efforts are needed for tiger population recovery

igers (Panthera tigris) are one of India's most iconic and charismatic species, known for their majestic presence in the wild. It has 53 tiger reserves covering an area of 75,796 sq. km and houses nearly 70% of the world's wild tiger population. Prime Minister's message in the Status of Tiger 2022 Report by the National Tiger Conservation Authority (NTCA) quotes from Mahabharat: "Nirvano vadhyate vyaaghro, nirvyaaghram chainplate venom" which means 'If there is no forest, then the tiger gets killed; if there is no tiger, then the forest gets destroyed."

The total estimated tiger population

in India increased from 2,967 in 2018 to 3,167 in 2022 with a 24.5% increase in the Shivalik Hills & Gangetic Plains, 12.4% in Central Indian Highlands & Eastern Ghats, and 11.4% in North Eastern Hills & Brahmaputra Plains landscape while the Sunderbans and Western Ghats Landscapes recorded a decrease of 12% and 16%.

Tigers with remarkable adaptability

expanded into new areas in the states of Madhya Pradesh and Maharashtra. This expansion signifies positive progress, but the conservation scenario in many regions is disturbing. Local tiger populations have become extinct in areas like Sri Venkateswara National Park of Andhra Pradesh, as also in Kawal Tiger Reserve of Telangana, Satkosia of Odisha, and Sahyadri of Maharashtra. The states of Jharkhand, Odisha, Chhattisgarh, Telangana, and Andhra Pradesh require serious conservation efforts for tiger population recovery. The small and genetically unique population of tigers in Simlipal of Odisha requires prioritized conservation inputs.

The biodiversity-rich protected areas within the Western Ghats as also in adjacent areas show a reduction in tiger population with decreases reported in the Wayanad landscape of Kerala, BR Hills of Karnataka, and border regions of Goa and Karnataka. Other regions like Sharavathi of UP and Mookambika and Bhadra of Karnataka also show substantial tiger occupancy declines. Although the Periyar landscape's population is stable, tiger occupancy has gone down outside of Periyar. In Kanyakumari and Srivilliputhur one notices local extinctions of tiger populations. The landscape of North Eastern Hills and Brahmaputra remains secure but the Sundarbans landscape, a mangrove ecosystem, shows a decline. Since tigers' presence in a forest indicates a thriving ecosystem, declines in their population and extinctions are a matter of extremely serious concern.

The overall increase in population at the national level doesn't indicate that all is well on the tiger conservation front in India. Central Indian landscape witnesses the highest level of conflict between tigers and humans. The high tide of development in the western Ghat region has resulted in increased habitat destruction and even conflicts. Deforestation caused by encroachment, land-use changes, and infrastructures has fragmented forests and damaged wildlife corridors in many areas causing hindrances to wildlife movement. In addition, unregulated grazing, over-harvesting of minor forest produce, forest fires, illegal hunting, defaunation, exotic species plantations, and climate change implications

The conflicts translate into cattle kills, human kills, and tiger kills by revenge-triggered poisoning and poaching with the lucrative trade in tiger body parts also contributing in a major way.

Apart from the area-specific sociocultural, socioeconomic, and socioecological aspects leading to conflicts; politics before and after is all-pervasive. In 2021-22 the number of humans killed by tigers was 31 while the number of tiger deaths was 110 and 13 tigers were captured.

Some recently legislated statutory instruments are likely to make the threats more intense. The free and unlimited access to minor forest produce collection due to non-specification of its 'extent' in the community right titles recognized by District Level Committees (DLCs) under the Forest Rights Act 2006 (FRA) coupled with the considerably scattered pockmarks of agriculture regularized inside forests add to the frequency of human and wildlife interaction.

Many DLCs, violating primarily sections 3(1)(i) and 4(3) of the Act, have illegally granted management rights over tiger reserve areas to Gram Sabhas. Notable ones are 5,544 ha. in the Dhamtari district of Chhattisgarh; 781 ha. in the Navegaon Nagzira sanctuary of Maharashtra; 12,527 ha. to 10 villages in core and buffer areas of Achanakmar and Sitanadi Udanti of Chhattisgarh; and sizeable areas of Tansa and Biligiri of Maharashtra and

have increased the instances and Karnataka respectively. Rights are granted similarly outside the national parks and sanctuaries (PAs) also that sustain tigers and their prey base populations. Ironically, not a single 'critical wildlife habitat' has been declared despite FRA providing for the

> The decriminalization of offences like cattle trespass, and bamboo felling in the reserved forest by excluding it from tree's definition under the Indian Forest Act 1927 are going to impact habitats adversely and increase human-wildlife interaction. The proposed relaxations and exclusion of areas by Forest Conservation Bill 2023 are going to increase the potential, area coverage, and implications of numantiger conflict.

> While we cannot depend on selected pockets showing growth in populations today, the current trend calls for urgent action to restore populations and prevent the extinction of small tiger populations. With tigers getting extinct, the entire ecosystem would suffer a domino effect. The conservation efforts must include restoration of habitats, increasing ungulate populations, and planned reintroduction of tigers in zero to low-density areas along with well-designed strategies to contain human-tiger conflict. Unplanned reintroductions and habitat modifications must be avoided as they may raise tiger populations but force tigers into human-dominated landscapes. Measures such as eco-friendly construction techniques, mitigation structures, lower mining

impacts, and rehabilitation of mining sites will reduce conflicts in all areas. Keeping wildlife corridors functional by creating conservation reserves and community reserves will allow gene flow between tiger populations ensur-

ing their long-term survival.

Tigers must get more and relatively inviolate spaces to survive. Improving the stakes of local people in the long-term sustenance of forests and wildlife can make this happen. Locals will prefer tiger conservation if they can relate the reduction in crop depredation to the control of ungulate populations by tigers. Eco-tourism is another definite way to unlock regular and substantial cash flows in local people's iavour. A profitable engagement as stakeholders with tour operators and hoteliers will make them support tigers.

Simultaneously, sustainable benefits from the collection, value addition and marketing of minor forest produce like mahua flowers, seeds, barks, leaves etc. from non-PAs will support forest conservation. Carbon financing for cultivating trees on their fragmented agricultural patches having poor productivity promises yet another opportunity to create a win-win situation for people as well as habitats. Appropriate statutory and financial support, stronger but sensitive enforcement agencies, timely compensations, and changing conclusively the mindset of 'Your tiger killed my cattle' will enable India to write a better future for tigers and the ecological treasures they rep-

Opportunities may not be cognizable to most people; and in many situations, perceived as risky. Thus, how people perceive different opportunities and their willingness and abilities to pursue them have a crucial impact on any entrepreneurial journey. Therefore, in this context, we can say that entrepreneurship is an extremely personal journey, of people's ability to recognise opportunities, envision opportunities and pursue them by taking risks.

Let us take an example of vision. Vision is nothing but a projection of an entrepreneur's mind where he breathes life into an opportunity, giv-

to exploit the same. Make no mistake that all visions are accurate. Many times, entrepreneurs make judgment errors in valuing an opportunity. The opportunity may not be worthy or may not be valuable in its existing form.

Risk and return generally have a linear relationship. This means that if one takes a higher risk, his return can be potentially higher. While taking risks for a future higher gain can be safely predicted in an established business, it may not be as straightforward in entrepreneurship. Since, most of the time, in biotechnology, the product was a bio-organism, there was no clarity about product patents. Over the years, things started falling into place, including the patent rules. Keeping external factors like high capital requirements aside, the ability of an individual to work in an ambiguous and risky environment is to be noted.

In 1973, Cohen and Boyer discovered recombinant DNA technology, which jump-started the biotechnology industry. While Cohen collaborated

Swanson and created Genentech, Boyer remained in academia. Here again, human factors kick in and these entrepreneurs with higher optimism and greater tolerance for risk, contribute to the variation in risk-tolerance behaviour across the entrepreneurs' pool. So, an individual's ability to not get discouraged in the face of low success and willingness to progress despite these odds is also crucial for an entrepreneurial journey.

Surprisingly, research shows that individuals with high tolerance to ambiguity find unpredictability appealing instead of frightening. The wheels of the entrepreneurial journey also run on the higher achievement needs of entrepreneurs. Since many there are several cases where any industry, when in its with venture capitalist entrepreneurs have a greater

requirement to show achievements, they generally involve themselves in activities that entail greater individual skills and a hands-on approach.

Their actions are resultoriented, they seek clear feedback on performance. This individual character is known to be a strong differentiator between an entrepreneur and an employee. Overall, all these above-mentioned individual entrepreneurial characteristics can be summed up into one major trait of independence. Entrepreneurs' desire to be independent in taking control of their own lives, judgements and responsibilities; be it pursuing opportunities that may not be visible to others or being responsible for their outcomes, plays an everimportant role.

Iraq orders expulsion of Sweden's envoy

 \mathbf{I} raq's prime minister ordered the expulsion of the Swedish ambassador from Iraq and the withdrawal of the Iraqi charge d'affaires from Sweden on Thursday as a man desecrated of a copy of the Quran in Stockholm with permission from Swedish authorities.

The diplomatic blowup came hours after protesters angered by the planned burning of a copy of the Islamic holy book stormed the Swedish Embassy in Baghdad early Thursday, breaking into the compound and lighting a small

Online videos showed demonstrators at the diplomatic post waving flags and signs showing the influential Iraqi Shiite cleric and political leader Muqtada al-Sadr before a planned burning of the Islamic holy book Thursday in Stockholm by an Iraqi asylumseeker who burned a copy of the Quran in a previous demonstration last month.

Following the incident, the Swedish Embassy announced that it had closed to visitors without specifying when it would reopen.

Iraqi Prime Minister Mohammed Shia al-Sudani said in a statement after meeting with security officials that Iraqi authorities will prosecute those responsible for the arson as well as referring "negligent security officials" for investigation. However, the statement also said that the Iraqi government had informed its Swedish counterpart on Wednesday that Iraq would cut off diplomatic relations should the Quran burning go forward.

Hours later, Sudani announced the ordered expulsion of the Swedish ambassador.

The announcement came after two men held an anti-Islam protest on a lawn about 100 meters (300 feet) from the Iraqi Embassy in Stockholm.

One of them, identified by Swedish media as Salwan Momika, an Iraqi Christian living in Sweden, stepped on and



kicked the Quran, but didn't set it on fire.

Momika also stepped on and kicked an Iraqi flag and photographs of Sadr and of İran's supreme leader, Ayatollah Ali Khamenei.

About 50 people including journalists and a handful of counterdemonstrators who chanted religious slogans watched the demonstration from behind police barricades as plainclothes and uniformed officers stood by.

Following the protest and Sudani's announcement, the head of Iraq's Media and Communications Commission announced it had suspended the license of Swedish communications company Ericsson to operate in Iraq.

Before the planned protest Stockholn dozens of men climbed over the fence at the complex containing the Swedish Embassy in Baghdad, Video footage showed men trying to break down a door, setting a fire and standing, some shirtless in the summer heat, inside what appeared to be a room at the embassy, an alarm audible in the background.

Others later performed predawn prayers outside of the embassy. As dawn broke, police and other security officials gathered at the embassy as firefighters tried to douse the flames from the ladder of a fire truck. Some demonstrators still stood at the site, holding placards showing al-Sadr's face, apparently left alone by police. The Swedish Foreign Ministry said in a statement

that its staff were safe. "We condemn all attacks on diplomats and staff from international organizations," the ministry said.

"Attacks on embassies and diplomats constitute a serious violation of the Vienna Convention. Iraqi authorities have the responsibility to protect diplomatic missions and diplomatic staff." Swedish Foreign Minister Tobias Billström called the attacks "completely unacceptable" in a statement and said the ministry would summon Iraq's charge d'affaires in Stockholm, slamming Iraqi authorities for "seriously failing" in their responsibility to protect the embassy and its personnel.

The Finnish embassy in Baghdad is adjacent to the Swedish embassy, in an area enclosed by blast walls.

Finland's ambassador to Iraq, Matti Lassila, told the Finnish public broadcaster YLE that the staff of the Swedish and Finnish embassies were proactively evacuated Wednesday and were uninjured.

Iraq's Foreign Ministry also issued a statement condemning the attack and promising to hold the perpetrators accountable, without explaining how it allowed the breach to happen or identifying who carried out the assault.

'China doesn't want a trade war with US'

China does not want a trade war with the United States but will retaliate against any further US restrictions on technology and trade, the Chinese ambassador to the US said. Ambassador Xie Feng criticised US curbs on the sale of microchips and chipmaking equipment to China that were imposed last year by the Biden administration. Beijing has described the measure as part of an effort to "contain" China.

"China does not shy away from competition, but the def-inition of competition by the US side I think is not fair," Xie said Wednesday at the Aspen Security Forum, a security and foreign policy conference in Aspen, Colorado.

'The United States is trying to win by keeping China out," he said, referring to measures to curb US technology

cations giant Huawei over secu-

"This is like restricting the other side to wear outdated swimwear in a swimming contest while you yourself (are) wearing a Speedo," he said.

China earlier this month imposed export curbs on two key metals used in computer chips and solar cells, a measure widely seen as retaliation for the US restrictions on microchips. Earlier this year, Beijing restricted sales of products from Micron Inc., the biggest US producer of mem-

"Definitely it's not our hope to have a tit for tat," Xie said. "We don't want a trade war, technological war. We want to say goodbye to the Iron Curtain, as well as the Silicon Curtain." Xie's comments come as Washington and Beijing are trying to patch up their rela-

tionship, which has hit new lows in recent months over a slew of issues including a suspected Chinese spy balloon that flew over US territory and tensions over trade, technology, human rights and China's claim to Taiwan and much of the South China Sea.

As part of efforts to mend ties, three top US officials visited Beijing in recent weeks. John Kerry, the US special envoy on climate, concluded talks on Wednesday with Chinese officials on ways to combat climate change and restore high-level cooperation between the two countries.

He was preceded earlier this month by Treasury Secretary Janet Yellen. Last month, Secretary of State Antony Blinken travelled to China on a visit focused on reopening communication channels between the two countries and reviving stalled

Xie said China is "eager"

to have a "stable, healthy relationship" with the US. He said immediate "concrete" improvements could include increasing the number of passenger flights between China and the US which were heavily curtailed during the pandemic - and renewing the countries' cooperation agreement on science and technology. On the issue of the Ukraine war, Xie reiterated Chinese officials' talking points that Beijing respects countries' sovereignty and ter-ritorial integrity but also acknowledges "legitimate and reasonable security concerns." China says it is neutral in the conflict, but in practice it has shown Russia support by organising frequent state visits and joint military drills with Moscow.For self-governed Taiwan, which China considers a breakaway province, Xie said

One dead, 48 injured in suspected gas explosion

One man died and at least 48 people were injured after a suspected underground gas explosion ripped open roads and flipped vehicles in the heart of South Africa's biggest city, authorities and emergency services said on Thursday. Firefighters found the man's body under a vehicle. The cause of the blast at evening rush hour Wednesday in downtown Johannesburg remained unclear. The company that supplies gas to that part of the city said it did not believe its underground pipelines were responsible, as authorities first thought. An investigation was

brought in specialists to determine what other underground pipes or cables there were in the area and if there was a threat of another explosion or gas leak. "We are still searching for the source," said Panyaza Lesufi, the premier of the Gauteng province, where Johannesburg is located.Firefighters discovered the body of the man in a nighttime search of the blast area, Emergency Management Services spokesperson Robert Mulaudzi said on Twitter.Lesufi said 12 people remained in several Johannesburg hospitals for medical treatment. The

other 36 people who were hurt had been discharged, he said.

Some people were evacuated from the area Wednesday night due to fears of a second explosion or that multi-story buildings in a downtown section of the city might collapse. Lesufi said "the damage is extensive." However, people returned to the busy area in Johannesburg's central business district on Thursday morning, either to go back to their homes or get to work.

Authorities estimated that an area covering five city blocks was damaged and at least six roads were affected. At least 34 vehicles were damaged, with some of them flipped on their sides or lying on top of other vehicles.Others had tumbled into gaping crevices that appeared in the middle of roads as the damage resembled a scene from an apocalyptic movie. The explosion happened just before 5.45 pm on Wednesday, Lesufi said, just as many people were gathering on the streets to catch a minibus taxi home, one of South Africa's most common commuting methods. Most of the damaged vehicles were minibus taxis.

Eyewitnesses said some people were sitting in the buses when the explosion threw them into the air.

China ready to fix stalled ties with US: Xi tells Kissinger

President Xi Jinping on Thursday told Henry Kissinger that China is ready to discuss the "correct way" to halt the slide of its relations with the US and sought the help of veteran American diplomat to fix the ties as he did 50 years ago by establishing diplomatic ties between the two countries.

Kissinger, the former US Secretary of State, who turned 100 in May this year remained the most influential figure in Beijing since his successful pingpong diplomacy in 1971 pitting Communist China against its ideological mentor the then Soviet Union tilting the Cold War balance of power at that time. Successive Chinese Communist Party leaders turned to him for guidance on the trajectory of China's ties with the UŚ which helped Beijing to expand its economic and diplomatic clout in the world, until in the last 10 years when the American leaders began identifying China as a major threat as it emerged as the world's secondlargest economy and major military power next only to the US. The ties hit rock bottom with tough anti-China policies perused by both Donald Trump and the current Joe Biden



and tech bans besides the formation of influential strategic groupings like Quad, consisting of the US, India, Japan, Australia, and AUKUS comprising Australia, US and UK, which China says are aimed at containing its rise. Kissinger's current visit to Beijing comes after the trips by US Secretary of State Antony Blinken and Treasury Secretary Janet Yellen this month besides Washington's top climate envoy John Kerry's tour to recalibrate the stalled relations.Xi, who in stark contrast avoided meeting with the visiting US officials, however, drove to the opulent Diaoyutai state guest house in Beijing to meet Kissinger and sought his help to

Villa Five of the Diaoyutai guest house where Xi met Kissinger was where the centenarian met the Chinese leaders during his first visit to Beijing in 1971 to establish ties with China under Richard Nixon's Presidency. Fifty-two years ago, at a crucial turning point in China-US relations, Chairman Mao Zedong, Premier Zhou Enlai, President Richard Nixon and Kissinger, with remarkable strategic vision, made the right choice to seek cooperation between China and the United States, kicking off the process of normalization of bilateral relations, Xi said in his meeting with the centenarian who officials say is on a "private trip".

UK doctors walk out

Thousands of senior doctors in England began a 48-hour walkout on Thursday to demand better pay and conditions, paralysing hospitals and leaving only emergency care covered.

The severe disruptions are the latest in months of industrial action by public sector workers amid UK's ongoing cost-of-living crisis. They come just two days after junior doctors staged the longest strikes in the history of the state-funded National Health Service.

Thousands of operations and appointments have been cancelled, and health officials say the impact of the latest round of strikes to hit the country's public health system is likely to be the biggest yet, because almost no work can be done at hospitals unless it's supervised by a senior doctor.

Senior doctors, known as consultants in the UK, will only be "on call" for urgent work such as critical cancer care until Saturday morning.

The Conservative government has offered a 6 per cent pay increase to the doctors, but the British Medical Association, the doctors' union, called this "derisory". It said doctors have seen

real-term take-home pay fall by more than a third over the last 14 years, and accused authorities of refusing to engage in negotiations

Union executive Dr Vishal Sharma said that many in his profession felt "undervalued overworked". and "Consultants will stand on the picket lines today, because we are angry and at rock bottom. We never wanted to be forced into taking this huge step," Sharma said. "Ministers

Thousands of | Yellen visits Vietnam, seeking to build ties

 $T^{\text{he US considers building}}_{\text{strong economic and secu-}}$ rity ties with Vietnam a priority, US Treasury Secretary Janet Yellen said Thursday as she met with Vietnamese officials in a visit aimed at fortifying America's relations across Asia.

Yellen arrived in Vietnam after visits to Beijing and to India, where she attended financial meetings of the Group of 20 major industrial economies.

"The United States considers Vietnam a key partner in advancing a free and open Indo-Pacific," Yellen told Vietnamese Prime Minister Pham Minh Chinh, according to remarks provided by the US Treasury Department.

A "free and open Indo-Pacific" refers to the latest iteration of broad U.S. diplomacy aimed at cultivating stronger ties with other countries in the region to counter China's growing sway among its neigh-

"Vietnam is also a close economic partner, with our two-way trade reaching record highs last year and the United States serving as Vietnam's largest export market," Yellen said. "It is a priority for our administration to deepen our economic and security ties with Vietnam in the months

and years to come." Yellen briefly sat atop a bright green scooter during a visit to a factory in Hanoi's lush green suburbs, where Selex Motors, a five-year-old Vietnamese startup, makes EV scooters and batteries. Climate change poses an existential threat to the world but also provides a "key economic oppor-tunity" and way to build "greater resilience into our economies," she said, describ-

ing the facility as "impressive." Yellen said the US is committed to mobilising USD 15 billion to support Vietnam's adoption of renewable energy as a part of the Just Energy



Transition Partnership or JETP a financial promise made by the Group of Seven advanced economies to help the country phase out its reliance on fossil fuels. Such projects have offered similar incentives to South Africa and Indonesia.

Speaking earlier to a group of business women and economists, Yellen said she was encouraged by growing investments in Vietnam in industries including computer chips and renewable energy.

Yellen's visit is part of concerted US efforts to balance China's growing influence in

the Indo-Pacific. Earlier this year, Secretary of State Antony Blinken visited Vietnam weeks after the 50th anniversary of the US troop withdrawal that marked the end of America's direct military involvement in Vietnam. He pledged to boost relations to new levels.

Diplomatic relations between the two countries were only restored in 1995. Since then, bilateral trade has grown, reaching a high of \$138 billion in goods trade last year.

"We have worked closely to address the legacies of the war," Yellen said.

China's border is less than 60 miles (96 kilometres) from Hanoi and Vietnam, like many of China's neighbours, has had maritime and territorial disputes with Beijing in the South China Sea. The two sides fought a brief war in 1979. But China is Vietnam's biggest trading partner.

Russia aims more retaliatory strikes

 $R^{\text{ussia pounded Ukraine's}}_{\text{southern cities with drones}}$ and missiles for a third consecutive night Thursday, keeping Odesa in the Kremlin's crosshairs after a bitter dispute over the end of a wartime deal that allowed Ukraine to send grain through the key Black Sea port. The strikes killed at least two people in Odesa. In Mykolaiv, a city close to the Black Sea, at least 19 people were injured, including a child, Ukrainian officials said.

Russia has targeted Ukrainian critical grain export infrastructure since it vowed "retribution" this week for an attack that damaged a crucial bridge between Russia and the Moscow-annexed Crimean Peninsula. Russian officials blamed that strike on Ukrainian drone boats.

The strikes on Ukraine's grain export infrastructure have helped drive up food prices in countries facing

UN Secretary-General Antonio Guterres said the end of the deal would result in more human suffering, with potentially millions of people affected.The grain deal provided guaranteed that ships would not be attacked entering and leaving Ukrainian ports, while a separate agreement facilitated the movement of Russian food and fertiliser.

The Russian military on Thursday described its strikes on Odesa, a city whose downtown area is described by the United Nations' cultural agency UNESCO as possessing "outstanding universal value," as

In January, UNESCO added Odesa's historic center to its list of endangered World Heritage Sites, with UNESCO Director-General Audrey Azoulay saying the "legendary port that has left its mark in cinema, literature and the arts." Despite multiple Russian artillery attacks and airstrikes during the war that began in February 2022, Odesa had not previously been subjected to the heavy barrages that have targeted other towns and cities Ukraine's south and east.

The Russian Defense Ministry said in a statement that it targeted "production shops and storage sites for unmanned boats" in Odesa and the nearby city of Chornomorsk.

In the Mykolaiv area, the Russian military claimed to have destroyed Ukraine's fuel infrastructure facilities and ammunition depots.

Neither sides' claims could be independently verified.

The previous night, an intense Russian bombardment using drones and missiles damaged critical port infrastructure in Odesa, including grain and oil terminals. The attack destroyed at least 60,000 tons of grain.

In what appeared to be a tit-for-tat move, Ukraine's Defence Ministry announced that as of Friday, all vessels in the Black Sea heading to Russian ports "may be considered by Ukraine as such carry-

associated risks." That may result in higher insurance costs for those ships.

Russia's Defence Ministry said earlier this week that Moscow had formally declared wide areas of the Black Sea dangerous for shipping and warned that it would view any incoming ship as laden with weapons, effectively announcing a sea blockade.

The European Union's foreign affairs chief condemned Russia's targeting of grain storage facilities.

"More than 60,000 tons of grain has been burned," Josep Borrell said in Brussels on Thursday, regarding Moscow's recent tactics. "So not only they withdraw from the grain agreement ... but they are burning the grain."

German Foreign Affairs Minister Annalena Baerbock said at the same meeting that ing military cargo with all the the EU is involved in international efforts to get Ukrainian grain to the world market.

'The fact that the Russian president has canceled the grain agreement and is now bombing the port of Odesa is not only another attack on Ukraine, but an attack on the people, on the poorest people in the world," she said.

"Hundreds of thousands of people, not to say millions, urgently need grain from Ukraine.

Sanaullah in the press conference lent credence to the confessional statement by Khan's ex-principal secretary Azam Khan accusing the 70-year-old cricketerturned-politician of using a cipher from Pakistan's mission in the US to gain political mileage and build an "anti-establishment narrative" on the back of the "confidential" document and assailed the former prime minister. The FIA in a notice to Khan asked the PTI chief to appear before the bureau here on July 25 in connection with the cipher probe, Dawn News reported."If he does not cooperate during the inquiry stage, he could face possible arrest. Following the investigation, the FIA will make recommendations based on evidence regarding those who are complicit and against whom criminal cases should be filed," Sanaullah said.

Court acquits Pak PM in money laundering case

An accountability court in Pakistan acquitted Prime Minister Shehbaz Sharif and his family members on Thursday in a multi-million-dollar money laundering case after the anti-corruption agency failed to provide any solid evidence against them. "An Accountability Court

acquitted Prime Minister Shehbaz, his wife Nusrat, his son Hamza and daughter Javaria in the PKR 7 billion money laundering case filed by the National Accountability Bureau (NAB) in 2020," a court official told PTI. The official said the court acquitted the premier and his family members after the NAB failed to provide any solid evidence against the suspects regarding the laundering of millions of dollars abroad, especially to the United Kingdom. The official further said the court, however, declared another daughter of the premier, Rabia Imran, a proclaimed offender and issued her an arrest warrant.

Rabia had left for the UK since she was named in the case. The corruption case was filed by the NAB in 2020 during the tenure of Imran Khan's Pakistan Tehreek-e-Insaf (PTI) government. The Sharif family termed the case a political victimisation. In October last

Kremlin defends decision not to let Putin attend BRICS Summit

The Kremlin on Thursday defended its decision ▲ not to let President Vladimir Putin travel to South Africa next month to attend the BRICS Summit in person, saying Moscow has done this before and the Russian leader will still be able to exchange views with his counterparts from the grouping online. "We are talking about full participation. It will be both the president's address and — if necessary — participation in an exchange of views," Kremlin Spokesman Dmitry Peskov said in response to a request to specify the format of Putin's participation.

BRICS includes Brazil, Russia, India, China and South Africa. The association's 15th summit will be held in Johannesburg, South Africa, on August 22-24. It will be the first BRICS Summit to be hosted in person since the emergence of the COVID-19 pandemic and the subsequent global restrictions. Russian Foreign Minister Sergey Lavrov will personally represent Russia at the event. President Putin is facing an arrest warrant from the International Criminal Court's (ICC) for alleged

Lavrov has on many occasions represented the country at international events, Foreign Ministry Spokeswoman Maria Zakharova said, adding that Moscow has adopted this practice in the past. "It's up to us to decide and a decision has been made.

This practice has been used more than once," she said, commenting on Putin's decision not to attend the summit in person.

When asked if the move stemmed from the ICC arrest warrant against Putin, Zakhrova warned against looking for "hidden meanings.""Russia takes part in many international events this way, like many other countries," she added.On March 17, the ICC issued arrest warrants for Putin and Russian Presidential Commissioner for Children's Rights Maria Lyova-Belova, alleging that they were responsible for "unlawful deportation" and transfer of population, including children, from Ukraine to Russia. Moscow has said that since Russia was not party to the ICC Rome Statute, the court's decisions were legally void for the country. On Wednesday, South African Presidential Spokesman Vincent Magwenya told Russia's state-owned TASS news agency that Pretoria and Moscow took into consideration South Africa's obligations under the Rome Statute when deciding on the form of President Putin's participation in the BRICS summit in August."The commitment to South Africa's successful hosting of the summit, the historic nature of this upcoming BRICS summit, and a recognition of South Africa's legal obligations to the Rome Statute guided the deliberations over the participation of Russia during the summit," Magwenya said in response to a question.

Weak loans of banks to fall to 3-3.5% of gross advances by March 2025: S&P

S&P Global Ratings on Thursday projected Indian banking sector's weak loans will decline to 3-3.5 per cent of gross advances by M\arch 31, 2025 as structural improvements and good economic prospects would support the resilience of financial institutions. In its mid-year global bank outlook, S&P said India's economic growth prospects should remain strong over the medium term, with GDP expanding 6-7.1 per cent annually in fiscal years 2024-2026.

India to remain the fastestgrowing economy in Asia-Pacific, and the fastest-growing large economy globally, it said.

"We project the banking sector's weak loans will decline to 3-3.5 per cent of gross loans by March 31, 2025 on the back of structural improvement, including healthy corporate balance sheets, tighter underwriting standards, and improved risk-management practices," S&P Primary Credit Analyst Deepali Seth Chhabria said.

balance sheets and higher demand should boost bank loan growth, but deposit growth would lag. "The small and midsize enterprise sector and lowincome households are vulner-

able to rising interest rates and

high inflation. But we believe that interest rates in India are unlikely to rise materially. This should limit the risk for the country's banking industry," Chhabria said.



New Zealand claim historic win in WC opener



The reigning U-20 world champion Panghal and U-23 Asian champion Sujeet Kalkal had slammed the ad-hoc committee's decision as unjust and unfair and asserted that they are capable of beating Bajrang and Vinesh if they are pitted against them in the trials.



The duo were, however, not present at the IOA Bhawan. The IOA ad-hoc panel, led by Bajwa, had on Tuesday
