Tn a major organisational re-Jig with an eye on the 2024 Lok Sabha and Maharashtra Assembly polls, Nationalist Congress Party (NCP) chief Sharad Pawar on Saturday appointed his daughter & party MP Supriya Sule and senior party leader Praful Patel as

NCP's working presidents. Pawar sprang a surprise on former Deputy Chief Minister and his nephew Ajit Pawar by not vesting him with any responsibility in the party.

Pawar made a formal announcement about the appointment of Patel and Sule working presidents on a day when the party entered the 25th year of its formation.

The appointments of Patel and Supriya were in line with the indication that Pawar had given after he resumed his office as the NCP chief on May 5 after an 80-hour-long highvoltage drama witnessed in his party — which saw hun-dreds of party workers going

on a spontaneous agitation, party leaders meeting him to convince him to take his resignation and a search committee appointed by the NCP chief himself rejecting Pawar's decision and asking him to con-

tinue in the post. Pawar had then said he would bring in major organisational changes and develop new leadership within the party. "In the coming days, I will concentrate on bringing about organidational changes, developing new leadership, and taking the party's aims and ideologies to the people in a big way," he had said.

As per Pawar's announce-ment, Patel has been appoint-

ed as the party's chairman of Economic Affairs and in-charge of States of Madhya Pradesh, Gujarat, Rajasthan, Jharkhand and Goa and also the Rajya Sabha.

Supriya appears to have got a better deal than Patel in terms of responsibility vested with her, as she has been appointed as the chairperson of the party's Central Election authority and she will be incharge of the crucial State of Maharashtra and also the States of Haryana and Punjab.

Besides heading the NCP's women, youth and student wings, she will also in-charge of party in the Lok Sabha. **Continued on Page 2**





evident that the Lieutenant Governor has not sanctioned or approved even a single project related to Yamuna cleaning. The ongoing attempts to steal credit for the hard work and dedication of the Delhi Government are unwarranted and unjust," Bhardwaj stated.

Bhardwaj's statement came a day after the LG Secretariat issued a press release stating that the biological oxygen demand (BOD) levels in the Najafgarh drain, which accounts for approximately 70 per cent of wastewater dis-charge into the Yamuna, had decreased by 33 per cent compared to the previous year. The LG office official asked

Bhardwaj to refrain from this unnecessary mudslinging, especially at a time when after 08 years of total inaction on his and his government's part, things had started to look better for the Yamuna and the people of Delhi.

The reduction was attributed to the intervention of a high-level committee headed by Saxena. Biochemical oxygen demand (BOD), an important parameter to assess water quality, is the amount of oxygen required by aerobic microorganisms to decompose organic material present in a water body

A BOD level of fewer than 3 milligrams per litre is considered good.

Challenging Saxena to provide evidence of any new projects or initiatives he had initiated before taking credit for the government's work, Bhardwaj has also laid stress on the fact that all the progress on the front of Yamuna cleaning is taking place as per a comprehensive six-point action plan announced by the CM in November 2021.

This proactive initiative laid out key steps to address the core problems affecting the

river, including increasing STP treatment capacity, in-situ treatment of major drains, upgradation of CETPs to handle industrial waste, linking community toilets and JJ clusters to the sewage system, expanding household sewage connections, and desilting and rehabilitating the sewerage system.

He dismissed the claims made by the LG's office as base-less and misleading, pointing out that the LG does not have the financial authority to approve projects in the Delhi Jal Board (DJB) or the Irrigation and Flood Control Department (IFC).

Bhardwaj also accused the LG office of falsely presenting minutes of meetings and presentations from the DJB and IFC, deceptively claiming them as the sole achievements of the LG.

"Regrettably, the Lieutenant Governor's office

has been misrepresenting the initiatives undertaken by the Delhi Government as his own. The LG office copies minutes of meetings and presentations from departments such as DJB and IFC, and presents them falsely claiming that these projects are the sole achievements of the Lieutenant Governor.

It is important to note that the Lieutenant Governor lacks the financial authority to approve any projects in the DJB or IFC. The ongoing attempts to claim credit for the work already initiated by Kejriwal and the Delhi Government are baseless and misleading," he

Mini reshuffle in Modi Cabinet likely before LS polls: Sources

A 'mini Cabinet reshuffle' hand-in-hand with organisational revamp in the BJP is expected in the run-up to the Lok Sabha poll which are barely 10-11 months away.

According to sources, the 'limited exercise' may take place before Prime Minister Narendra Modi's US visit from June 21 to 24.

Indications for changes in the Union cabinet and the party organization at the central and state levels rose after a series of meetings (since last one-week) of BJP top leaders including union home minister Amit Shah and Party President JP Nadda.

Similarly, the departure signal (the signal provided to dispatch the train from the station) for run-through trains should be taken off only after the first train has occupied berthing portion (when berths are all lined up at their set loca-

tions). "These should be applica-ble for all Up and Down direc-tion trains," says the Joint Procedure Order of Disconnection Reconnection for Signalling gears issued jointly by the Signalling and the Traffic departments of the Railway

Board. This is the third such orders on signalling issued by the Railway Board since the accident which is now being probed by the CBI.

weeds in a large way can help solve hunger and malnutrition issue besides slowing climate change impacts in low and middle income countries (LMIC) including in coastal regions of Africa and Southwest Asia, a team of researchers has said after mapping the potential of farming of the 34 commercially important nutritious marine plant species using the Global Biosphere Management Model.

The study from the Friedman School of Nutrition Science and Policy at Tufts University which has been published in Global Food Security, noted that producing and selling seaweed could boost incomes for farmers in the said region which are on the brink of facing food threats in view of growing population and climate change threats.

India, on its part, with a huge coastline of 1600 km is already pushing for cultivation of this underwater plants, eyeing its commercial and environmental potential as a nutritious food and a building block for commercial products including animal feed, plastics, fibres, diesel and ethanol. Around 844 species of sea-

weeds have been reported from Indian seas, their standing stock is estimated to be about 58,715 tonne (wet weight). Of the total 844 seaweed species, Indian sea is home to around 434 species of Red Algae, 194 species of Brown Algae, and 216 species of Green Algae.

Patrick Webb, the Alexander McFarlane Professor of Nutrition at the Friedman School and senior author of the study along with his team members said that a more sustainable alternative to raising

livestock, seaweed cultivation requires no land, freshwater, or chemical fertilizers, and could become particularly profitable as demand for nutrient-rich seaweed products grows around the world.

Those profits would mean more buying power for those households and communities who produce, process, package, and export the microalgae, which in turn would translate into healthier diets.

The other authors were Natalie Somers, N23, and Shakuntala Thilsted, who works for the Consultative Group on International Agriculture Research and won a 2021 World Food Prize for research and innovation in aquaculture and food systems. The team reviewed research papers, existing databases, United Nations and World Bank Group reports, and more.

"One of the biggest problems of food insecurity in LMICs is the unaffordability of healthy diets," said Webb. There are roughly 3.5 billion people in the world who can't afford a healthy diet even if they choose local foods at local prices

For many of those people, cultivating and selling seaweed would lead to higher incomes and improved nutrition through purchases on the market.

Navy carries out mega op with 2 aircraft carriers, submarines, 35 combat planes Sea, demonstrating its formi-

In one of the biggest demon-strations of its combat prowess in recent years, the Indian Navy has carried out a mega operation in the Arabian Sea that involved two aircraft carriers, multiple frontline warships, submarines and over 35 combat planes amid China's increasing presence in the Indian Ocean region.

The Indian Navy said the "seamless" operational integration of the two aircraft carriers — INS Vikramaditya and newly-inducted INS Vikrant, as well as the accompanying fleet of ships and submarines, is a "powerful testament" to the capabilities of its sea-based air power and India's role as the preferred security partner in the Indian Ocean and beyond.

The twin carrier CBG (carrier battle group) drills were held recently, officials said without divulging the specific date of the exercise.



The Navy said the demonstration of the naval prowess underscored India's commitment to safeguarding its national interests, maintaining regional stability, and fostering cooperative partnerships in the maritime domain, in comments also seen as an indi-

rect message to China. The two aircraft carriers were the centre-pieces of the exercise as they served as floating airfields for operations of a wide array of aircraft, including MiG-29K and choppers such as MH60 Romeo, Kamov and Advanced Light helicopters, officials said.

'The Indian Navy has undertaken the twin-carrier CBG operations with more than 35 aircraft in the Arabian

A carrier battle group or carrier strike group is a mega naval fleet comprising an aircraft carrier, accompanied by a large number of destroyers, frigates and other ships. A spokesperson for Ukraine's southern operational command, Natalia Humeniuk, said two children and a pregnant woman were among those wounded. In Ukraine's northeast, a 29-year-old man was killed as more than 10 drones targeted the Kharkiv region, its governor, Oleh Syniehubov reported Saturday. He added that at least three other civilians were wounded.

In the Poltava region further west, there was damage to a military airfield struck overnight during a Russian drone and missile attack, local Gov. Dmytro Lunin reported. Lunin said no one was hurt. As of Saturday morning, there was no additional comment from the Ukrainian army or officials on the extent of the damage.

The Ukrainian air force said that during the night, it had shot down 20 out of 35 Shahed drones and two out of eight missiles "of various types" launched by Russian forces.

Tsai also pledged that her government would promote policies to safeguard maritime and border security after inspecting an anti-terror drill in Kaohsiung city in southwestern Taiwan. "The safer Taiwan is, the

safer the world is," she said. Tsai's remarks came as the democratic island faces

increasing military threats from China, which sees Taiwan as a breakaway province to be retaken by force if necessary.

The island has never been part of the People's Republic of China, but Beijing says it must unite with the mainland. Beijing also has intensified its battle to win away Taiwan's diplomatic allies since independence-leaning Tsai took office in 2016.

In March, Honduras established formal relations with China, becoming the latest in a string of countries to break diplomatic ties with Taiwan.

An explosion at a rocket and explosives plant in Turkiye caused a building to collapse on Saturday, killing all five workers inside, an official said.

The explosion occurred at around 8.45 am at the compound of the state-owned Mechanical and Chemical Industry Corporation, on the outskirts of the capital, Ankara, Gov. Vasip Sahin told reporters.

Sahin said the explosion was likely to have been caused by a chemical reaction during the production of dynamite. Prosecutors have launched a formal investigation, he said.

Gray smoke was seen rising from the compound as ambulances and fire trucks rushed to the area, private NTV television reported.

Shop and house windows in surrounding areas were shattered by the force of the blast, the report said. Family members rushed to the compound for news of their loved ones, the station said.

Facing sanction, Johnson quits as UK lawmaker

 $F_{\mathrm{Boris}}^{\mathrm{ormer}}$ UK Prime Minister Boris Johnson shocked Britain on Friday by quitting as a lawmaker after being told he will be sanctioned for misleading Parliament. Johnson quit after receiving

the results of an investigation by lawmakers over misleading statements he made to Parliament about "partygate," a series of rule-breaking government parties during the pandemic

In a lengthy resignation statement, Johnson accused opponents of trying to drive him out — and hinted that he might try to return.

"It is very sad to be leaving Parliament — at least for now, he said

Johnson said he had "received a letter from the Privileges Committee making it clear - much to my amaze-



ment - that they are determined to use the proceedings against me to drive me out of Parliament.

He called the committee investigating him a "kangaroo court." Their purpose from the beginning has been to find me guilty, regardless of the facts," Johnson said.

The resignation will trigger special election to replace Johnson as a lawmaker for a suburban London seat. Johnson, whose career has

rescheduling, we have no such plan on our menu. We will not go for rescheduling multilater al debt. We will make the payments on time and when they become due. I don't think it is a dignified way to go and tell them that we cannot pay," he said. Dar said negotiations could be pursued with bilateral lenders for extending the repayment period, which existed as an option and could be explored after the budget process. "Backloading the principal and focusing on debt servicing could be considered for bilateral debt rescheduling," he said. Dar also clarified that there was no issue with the domestic debt, and the government would not go for its rescheduling. The minister admitted that the country faced deep and steep economic vulnerability but added that the government successfully overcame it and prevented further economic decline.

Adding that the country would be put back on the road to progress, Dar said the first objective would be to reach the 2017 economic indicators when Pakistan become the 24th economy in the world.

Thief Economic Adviser V Anantha Nageswaran on Saturday said that the government is on the same page with the Reserve Bank of India on the GDP growth forecast for the current financial year which is 6.5 per cent.

RBI Governor Shaktikanta Das announced at the end of the monetary policy committee (MPC) meeting on Thursday that the GDP growth forecast for 2023-24 has been pegged at 6.5 per cent, a tad higher than the April forecast of 6.4 per cent.

Speaking at a session organised by Bharat Chamber of Commerce here, Nageswaran said, "Both the ministry of finance and the RBI are on the same page with the growth forecast for the current fiscal which is 6.5 per cent with risks evenly balanced. The domestic economic growth momentum is strong enough to overcome

external risk factors". "We also benefit from lower oil prices and overall domestic macroeconomic stability," he said

The CEA said that during the last financial year, real GDP

growth was 7.2 per cent, which was lower than the 9.1 per cent registered in the previous fiscal. "However, I feel that the growth for the last fiscal will be

much higher than 7.2 per cent," lageswaran said.

The CEA to the government said that India was the fastest growing among major economies with all high-frequency parameters for April signalling a good start during the first quarter of the current fiscal.

With exports of goods and services as a percentage of GDP pegged at 23.5 per cent during the last financial year, the highest since 2015, private consumption and gross capital formation had increased in the last financial year after the pan-

demic. "Private consumption has been mainly driven by urban consumption, contributed largely by the release of pent-up demand," he said.

Speaking sectorally, Nageswaran said on agriculture that though there are concerns about the El Nino effect, the water reservoir storage is adequate in the country and enough availability of seeds and fertiliser stock is comfortable.

IGA IS QUEEN OF FRANCE Iga Swiatek battled past Karolina Muchova 6-2, 5-7, 6-4 to win her third French Open title on 'History hovering' over Djoker

Saturday and become the first woman to successfully defend the Roland Garros title since 2007

The 22-year-old Swiatek is just the third woman in the Open era to win each of her first four Grand Slam finals, the Pole adding to her 2020 and 2022 titles in Paris and last year's US Open triumph.

Monica Seles and Naomi Osaka are the only other players to accomplish the feat.

Swiatek, the world number one from Poland, is also the youngest woman to claim backto-back French Open titles since Monica Seles in the early 1990s. Justine Henin was the last

woman to win successive Roland Garros crowns when she captured her third in a row and fourth in total 16 years ago.

"I know I have said this every year, it isn't really about the performance, I really love being here - it's my favourite place on tour," said Światek.

Swiatek's latest coronation caps another dominant two weeks on the clay in Paris, where her record stands at 28 wins and two losses in five visits. Muchova, at 43 in the world, was the fourth lowest ranked woman to reach the French Open final, her first championship match at a major.

"This was so close and yet so far, that's what happens when you play one of the best, Iga, said a tearful Muchova, who was told only last year by doctors she may never play tennis again.

The unseeded Czech came into the final having won all five matches in her career against players in the top three -- four of them at Grand Slams -- after stunning Aryna Sabalenka in the semi-finals.

The Balasore train tragedy highlights the urgent need for substantial improvements in critical aspects of railway safety, writes DEEPAK KUMAR JHA

he Balasore train tragedy, which unfolded on [Date], stands as a chilling testament to the critical importance of stringent safety measures within the railway industry. The tragedy underscores the need to explore the urgent lessons that must be heeded to prevent similar incidents in the future.

The Gare de Lyon Train Crash (France, 1988)

The Bihar Train Disaster (India, 1981)

On June 6, 1981, the Bihar Express collided with a freight train near the village of Saharsa in Bihar, India. The collision, caused by a signaling error, led to a massive fire engulfing multiple train coaches. The tragedy claimed the lives of an estimated 800 passengers, making it one of the deadliest train accidents in history. This incident underscored the importance of effective signaling systems and rigorous safety checks to prevent catastrophic collisions.

The Tangshan Train Collision (China, 2008)

On April 28, 2008, two highspeed trains collided near the city of Tangshan in Hebei Province, China. The collision occurred due to a signaling failure, causing six train cars to derail and four others to overturn. The accident resulted in the loss of at least 72 lives and left hundreds injured. This incident highlighted the significance of regular maintenance and technological advancements in ensuring the safe operation of highspeed rail networks.

Tragically, the incident claimed the lives of 56 people and injured more than 50 others. This disaster emphasized the importance of rigorous safety inspections, proper maintenance procedures, and emergency response protocols within train stations.

The Balvano Train Disaster (Italy, 1944)

On March 2, 1944, during World War II, a train carrying hundreds of passengers stalled inside the Balvano Tunnel in southern Italy due to mechanical issues. With no ventilation and extreme cold temperatures, carbon monoxide poisoning claimed the lives of an estimated 426 passengers. This tragedy shed light on the need for adequate ventilation systems, regular equipment checks, and emergency protocols to ensure passenger safety, even in unforeseen circumstances.

The Awash Train Derailment (Ethiopia, 1985)

On January 7, 1985, an overcrowded passenger train derailed near Awash, Ethiopia. The accident occurred when the train attempted to cross a bridge with weakened supports, causing several carriages to plunge into the river below. The derailment resulted in the loss of approximately 428 lives. This incident highlighted the importance of infrastructure maintenance, including regular inspections and timely repairs, to prevent catastrophic accidents.

CBI PROBE— However, instead of uniting in the pursuit of justice and improved safety measures, the tragedy has become entangled in a web of political controversy surrounding the investigation by the Central Bureau of Investigation (CBI). This unfortunate politicization of the Odisha train tragedy has taken the focus away from desperately needed reforms in India's railway system.

One of the major points of contention was the demand for a CBI

The opposition suspects that the CBI may be influenced to make it look like a case of sabotage to absolve the Modi government of any blame for the accident.

The constant bickering and blame game between political parties created an atmosphere of mistrust and suspicion, undermining the credibility of the investigation and potentially delaying justice for the victims and their families.


The repercussions of this political posturing are far-reaching. While politicians engage in finger-pointing and rhetoric, the essential issues remain unresolved. The critical safety reforms required in India's railway system, such as upgrading outdated infrastructure, improving signaling systems, enhancing training programs for railway personnel, and strengthening regulatory oversight, are pushed to the back burner.

The victims and their families, who should be at the forefront of the discourse, find themselves sidelined in the political spectacle. Their anguish, grief, and demand for justice are overshadowed by political grandstanding. The tragedy that unfolded in Odisha deserves a comprehensive and unbiased investigation, devoid of any political influence, to ensure justice and provide closure to the affected families.

It is crucial to separate the investigation process from political maneuvering and prioritize the implementation of safety reforms. The Odisha train tragedy serves as a painful reminder that the focus must remain on preventing such incidents in the future rather than scoring political points in the present. By prioritizing safety over politics, the government can demonstrate its commitment to the welfare of its citizens and work towards building a robust and secure railway infrastructure.

LF: A POOR MAN'S DISEASE

In this concluding part, doctors from AIIMS Delhi's Dept of Surgical Disciplines tell ARCHANA JYOTI that Lymphedema, a build up of lymph fluid that causes swelling in a part of the body is not only due to cancer or cancer treatment. It can be also due to filarial parasites which is transmitted to humans through mosquito bites. The infection is usually acquired in childhood with painful and disfiguring visible manifestations appearing much later in life, often in the form of enlargement of body parts causing pain, severe disability, and associated stigma

WHAT IS FILARIASIS?


Rilariasis is a vector borne disease caused by small parasites which enters the body through a mosquito bite and reside in the lymphatic system or the subcutaneous tissues. Lymphatic filariasis impairs the lymphatic system and can lead to the abnormal enlargement of body parts like the arms, legs, and genitals. Acute infection may present as fever, redness and swelling of the affected limb or genitals, presence of painful red streaks over the limb, swollen and painful lymph nodes. Skin infections of the affected region are common. Repeated attacks result in severe swelling of the lower limbs and/or genitals with thickened 'elephant-like' skin, i.e; 'elephantiasis'.

This may cause long term disability and disfigurement to the patient. In some cases, it

DR JYOTI SHARMA can also affect the eyes and cause problems with vision. The treatment consists of medical therapy with Diethylcarbamazine (DEC) or Ivermectin, which kill these parasitic worms and alleviate the symptoms. Preventive measures mainly rely on mosquito control and protection from mosquito bites. Strategies include using mosquito repellents, wearing protective clothing, sleeping under mosquito

nets and environmental measures to prevent mosquitoes from breeding. It is one of the most debilitating diseases. Four States (UP, Odisha,

Telangana, and Bihar) account for more than 60% Lymphedema cases, while four States (Odisha, Jharkhand, UP and Bihar,) account for over 80% Hydrocele cases

CONTRIBUTION OF FILARIASIS TO LYMPHEDEMA


E arliest structural change in filarial infection is block-age of lymphatic channels by the nests of adult worms residing in lymphatic chan-nels. Once this lymphatic damage progresses, stasis of lymph tends to occur in the dilated vessels due to incompetence of the unidirectional valves in them. Stagnation of lymph encourages growth of bacteria invading the region. Any interference with the skin integrity of the affected region like injuries, fungal or bacterial infections, fissuring of the skin, favour entry of pathogenic bacteria {mainly streptococci} into the tissues and are responsible for the acute attacks of dermato-lymphangio-adenitis commonly

seen in filarial limbs Lymphedema of extremities is a common chronic manifestation of filariasis, which on progression results in elephantiasis. Usually the lower limbs are involved, upper limbs, male genitalia and rarely breasts in the females may also be affected. Affected parts get swollen.

In advanced stages of lymphedema, the skin is thickened and thrown into folds, often with hypertrichosis, black pigmentation, nodules, warty growth, intertrigo in the webs of toes or chronic nonhealing ulcers. Fungal infections in the interdigital region and in deep folds are a common finding in advanced lymphedema.

The drug treatment for filar-iasis involves the use of medications to kill the worms causing the infection.

- 1. Diethylcarbamazine (DEC): This drug is effective against both microfilar-ia and adult worms. The typical dose is 6mg/kg given for 14 days.
- 2. Ivermectin: Ivermectin is another medication used to treat filariasis, often given in combination with DEC. This drug acts directly on the microfilaria and is used

Patients coming for lym-phoedema surgery undergo a pre-anesthetic check-up before surgery where thorough general and physical examination is done, investigations checked and instructions for fasting given. Also, patients are asked to quit smoking and avoid taking aspirin or herbal medications before surgery. When patients are taken to the operation theatre, venous cannulation and attaching blood pressure cuffs in the affected limb are avoided.

Regional anesthesia like spinal or epidural anesthesia is given in surgeries involving lymphoedema of lower limbs where a drug is injected into the back through a needle to numb the lower limbs and the patient is awake and pain free during surgery. Many patients prefer general anesthesia technique where patients are put to sleep throughout the surgery using drugs injected into the vein or inhaling some drug through mask and pain relief during and post-



Anti-BJP Opp front faces internecine challenges

The recent Karnataka Assembly election results have proved to be a shot in the arm for the Congress, which has been starved of power at the Centre for the past nine years. The party, elated by its success, is now hoping to replicate the Karnataka victory in the forthcoming Assembly elections in Rajasthan, Madhya Pradesh, and Chhattisgarh. Besides, the Congress's Karnataka message that the BJP, which has ruled the country for the past nine years, has lost its supposed invincibility, has inspired all regional parties to take the initiative to cobble together a front that can serve as an antidote to the BJP in the 2024 parliamentary elections.

However, knitting together a viable Opposition front appears to be no easy task. Bihar Chief Minister and Janata Dal (U) supremo Nitish Kumar has initiated efforts to bring together all Opposition leaders under one umbrella to discuss and formulate plans for a strong Opposition front against the BJP. West Bengal Chief Minister Mamata Banerjee (Trinamool Congress), Telangana Chief Minister K Chandrasekhar Rao (Bharat Rashtra Samiti), and other non-BJP Chief Ministers such as Kerala Chief Minister Pinarayi Vijayan (CPM), Tamil Nadu Chief Minister MK Stalin (DMK), and Karnataka Chief Minister Siddaramaiah (Congress), all seem interested in challenging the ruling BJP and making their common foe, Prime Minister Narendra Modi, to use the Shakespearean lingo, feel that "uneasy lies the head that wears a crown." (King Henry IV- Part 2).

Originally scheduled for June 12, 2023, in Patna, Nitish Kumar's planned meeting has been postponed. He insists that the leaders of Opposition parties themselves, not their representatives, must attend the Opposition roadshow and wants to involve the Congress as the main actor in the planned extravaganza. However, with Rahul Gandhi and his mother Sonia Gandhi currently abroad, Congress president Malligarjun Kharge wants the meeting to be postponed, and thus June 23 has been set as the new date for the event.



Jammu & Kashmir and president of the National Conference Farooq Abdullah met with former Prime Minister and JD(S) president Deve Gowda in Bangalore. This meeting has sparked speculation about a possible Opposition front. However, Abdullah has stated that the meeting did not hold any political significance.

The efforts to build a forceful and viable Opposition front face challenges. Currently, Opposition leaders are divided on the question of leadership within the proposed front. Leaders like Mamata Banerjee and Chandrasekhar Rao view the proposal that projects the Congress as the shepherd of the flock with skepticism. Additionally, in some States, the Congress is in Opposition to the ruling parties that have aligned with the anti-Modi camp. For example, in Kerala,

Trinamool Congress versus Congress versus CPM; and in Tripura, it is the CPM versus the Congress.

The Congress is clearly a rival for Andhra Pradesh Chief Minister YSR Jagan Mohan Reddy. The YSR Congress, led by Jagan Mohan Reddy, and the TDP, led by Chandrababu Naidu, though at odds with each other, both support the BJP, ruling out their participation in the anti-BJP movements.

Sharad Pawar, once a dissident leader in the Congress who established his own Nationalist Congress Party in 1999, has expressed his support for the efforts to galvanise Opposition against the BJP. However, he has not yet revealed his specific plans.

Parties like Apna Dal (S) in Uttar Pradesh, the Akali Dal in Punjab, and the AIADMK cannot be expected to rally behind

have aligned themselves with the BJP. Odisha CM Naveen Patnaik, being non-committal on the matter, may not join the anti-BJP bandwagon.

Thus, the unity of non-BJP leaders seems uncertain. It is said that a few leaders are considering the idea of an Opposition front without the Congress. Nonetheless, it all feels like a repetition of the various anti-establishment initiatives taken in the years leading up to the new millennium. A sense of déjà vu hangs over the current political environment.

Looking back to the early 1970s, the vociferous slogan of 'Indira is India and India is Indira' symbolised the narrative of Congress invincibility and the 'TINA' (There Is No Alternative) factor. Prime Minister Indira Gandhi, following the Machiavellian political theory ('The Prince'), knew when to be ruthless and when

the 1950s, the all-powerful Congress ensured that no other party emerged as a challenge and cracked down on parties such as the Communist Party of India, PSP-SSP (Socialist), and Akhil Bharat Hindu

Mahasabha. despite However, Congress's dominance, some Opposition parties started gaining strength, reminiscent of the story of David and Goliath. In the 1970s, the Nava Nirman movement led by Jayaprakash Narayan and JB Kripalani laid its foundation, eventually bringing together all those opposed to Indira Gandhi, including Morarji Desai, Jagjivan Ram, Charan Singh, Vajpayee, Advani, Madhu Dandavate, George Fernandes, Raj Narain, and others. This hodgepodge of parties, including Congress (O), Socialist Party of India, Bharatiya Jana Sangh, and Lok

the supposedly invincible Congress out of power in 1977. The DMK and the CPM supported the coalition.

The catalysts for their success were the infamous Emergency imposed by Indira Gandhi in 1975 and her aggressive persecution of all Opposition leaders.

However, differences emerged within the Janata Party, particularly between the Bharatiya Jana Sangh (the predecessor of the present-day BJP) and other factions, leading to the party's decline and the Congress, led by Indira Gandhi, regaining power in the 1980 general elections.

Subsequently, the monolithic Congress rule continued until 1989 when the National Front (NF) was formed as an alternative to the Congress. The NF, led by a coalition of parties, including the Janata Dal with NT Ramarao (Telugu

Prime Minister, aimed to challenge the Congress's hegemo-ny. Chandra Shekhar (Janata Dal president) succeeded VP Singh as Prime Minister. Regional parties such as the DMK in Tamil Nadu, NTR's TDP in the then composite Andhra Pradesh, and the Asom Gana Parishad in Assam represented the NF, while the Left parties supported it.

Later, the United Front (1996-98) emerged as a significant anti-ruling party movement, bringing together parties such as Janata Dal, Samajwadi Party, DMK, TDP, AGP, Left Front, and TMC, among others. This 13-party coalition installed HD Deve Gowda (Janata Dal S) as the Prime Minister, followed by IK Gujral. Although the BJP became

the single largest party in the 1996 general elections, it could not secure the majority to sustain its government, which lasted only 13 days. As a result, the United Front, a coalition of several parties, took power, but its regime collapsed in 1998.

The BJP, which had only two MPs in 1984, has since grown by leaps and bounds and now boasts 303 MPs. It first came to power in 1999 but lost its status as the ruling party to the Congress in 2004. The NDA, led by the BJP, had to wait for a decade to regain power in 2014. Consequently, the Congress has been out of power for nearly a decade.

Now, as the Congress looks to regain power in 2024, similar to its return to the throne in 2004 after eight years of defeat, the outcome depends on the discussions among opposition parties, primarily regional ones. Will the anti-BJP front be led by the Congress or exclude it? Democracy requires at least two equally powerful parties for its survival. As the famous American comedian Bob Hope once said, "No one party can fool all of the people all of the time; that's why we have two parties." In conclusion, the current

political landscape in India can be likened to the conflict between the Guelphs and the Ghibellines in medieval Italy, with the BJP and the Congress being the main rivals.

Nuclear secrets: Trump indictment takeaways

The federal indictment against Donald Trump accuses the former president of illegally hoarding classified documents at his Florida estate after leaving the White House in 2021, and then scheming and lying to thwart government efforts to recover them.

Justice Department prosecutors brought 37 felony counts against Trump in the indictment, relying upon photographs from Mar-a-Lago, surveillance video, text messages between staffers, Trump's own words, those of his lawyers, and other evidence.

An aide to Trump, Walt Nauta, was charged as a co-conspirator with six felony counts.

Trump says he is innocent and has decried the criminal case — the second indictment against him in a matter of months — as an attempt by his political opponents to hinder his 2024 campaign. He is expected to make his first court appearance on Tuesday in Miami.

Here are key takeaways from the indictment unsealed Friday:

What are the charges ?

Trump faces 37 felony counts, including 31 counts of willful retention of national defense information under the Espionage Act. Other charges include: conspiracy to obstruct justice; corruptly concealing a document or record; concealing a document in a federal investigation; and making false statements.

Each of the willful retention counts pertains to a specific classified document found at Mar-A-Lago marked "SECRET" or "TOP SECRET." Topics addressed in the documents include details about US nuclear weapons, the nuclear capabilities of a foreign country and the military activities or capabilities of other countries.

The conspiracy charges deal with Trump's alleged attempts to hide documents from his lawyer or federal investigators. The false statement charges stem from Trump causing his lawyer to tell the FBI that no more classified documents were at Mar-a-Lago but then the FBI later found more than 100 documents during an August 2022 search.

The most serious charges carry potential prison sentences of up to 20 years each. But judges have discretion and, if convicted, first-time offenders rarely get anywhere near the maximum sentence. Being a former president would also likely be a major consideration in any sentencing.

What is the alleged conspiracy to obstruct justice?

The indictment accuses Trump and Nauta of conspiring to hide the secret documents from the grand jury, which in May 2022 issued a subpoena for him to turn them over.

The conspiracy allegation included a suggestion from Trump that his lawyer falsely tell investigators that the former president didn't have any more classified documents at Mar-a-Lago. It also involved moving boxes to hide the secret documents from Trump's lawyer, and suggesting that Trump's



lawyer hide or destroy documents that investigators were seeking. The indictment says that, at

Trump's direction, Nauta moved about 64 boxes of documents from a Mar-a-Lago storage room to the former president's residence in May 2022. He then returned "approximately 30 boxes" to the storage room on June 2 — the same day

Trump's legal team came to examine the boxes and search for classified documents to return to the government, the indictment says.

Nauta had a brief phone call with Trump before returning those boxes, the indictment says. Neither Trump nor Nauta told the former president's lawyers that Nauta had moved any of the storage room con-

tents, the indictment says.

Is Trump accused of sharing classified information?

The indictment alleges that Trump showed classified documents to people who didn't have security clearances on two occa-

The court papers detail a meet-

ing Trump had in July 2021 with a writer and publisher about an upcoming book. Trump told the pair "look what I found" and showed them what he described as a senior military official's "plan of attack," according to an audio recording of that conversation obtained by investigators.

Trump acknowledged during that meeting that the document was "highly confidential" and "secret information," the indictment says. He also says that he could have declassified the document if he was still president.

"Now I can't, you know, but this is still a secret," he said, according to the indictment.

A few months later, Trump showed a representative of his political action committee a classified map of a foreign country while discussing a military operation in the country that was not going well, the indictment says. Trump acknowl-edged that he shouldn't be showing the map to the person and told him not to get too close, prosecutors allege.

What evidence do prosecutors have?

In addition to the audio recording, prosecutors also relied upon text messages between Trump employees, photos of boxes of documents stored in various rooms throughout Mar-a-Lago and details about conversations between Trump and his lawyers that were memorialized by one of them.

In one conversation with his

lawyers, Trump said, "I don't want anybody looking through my boxes." Trump also asked one of his lawyers if it would be better "if we just told them we don't have anything here," the indictment says.

Photographs in the indictment show boxes stacked on a stage in a ballroom as well as in a bathroom. Another shows boxes that spilled over in a storage room, including a document marked "SECRET/REL TO USA, FVEY," which means information releasable only to members of the "Five Eyes" intelligence alliance of Australia, Canada, New Zealand, the United Kingdom and the United States.

Where will the case be heard?

While Trump's first court appearance on Tuesday is expected to be in front of a magistrate judge in Miami, the case was filed in West Palm Beach - about 70 miles to the north. The case was assigned to Judge Aileen Cannon, a Trump appointee, who issued rulings favourable to him last year and expressed repeated skepticism of Justice Department positions.

Cannon was broadly criticised

last year for granting the Trump legal team's request for a special master to conduct an independent review of the hundreds of classified documents seized from his Florida property last year. The move, which temporarily halted core aspects of the Justice Department's investigative work, was overturned months later by a three-judge panel of a federal appeals court.







Awareness levels of mind

he laws of Karma – life driven by cause-effect chain - implies that existence as such needs to be seen in continuation. It means that memory impressions from the past birth will influence the ongoing course of life. In this scheme of things, the going at this moment is the culmination of doing and undoing in the past. And seeded in the doings at this moment, is the way future is likely to unfold. All through the run of life, what we come across, small or big, good, or bad, their impressions make their presence in our memory bank. These imprints have future ramifications in terms of mind's working. In apparent terms, most of the memory impressions from the past may not be directly accessible, but they continue to have their bearing on mind's functionalities.

It is again pertinent to recall here that the singular 'fundamental element of consciousness' commonly available to one and all, grants us with the 'power of knowing'. But to what extent the 'consciousness element' manifests on a being, or how much one would avail of in applied sense, would vary from person-to-person, according as each mind is inherently framed. The subconscious relates to subtle



level of mind, which primarily draws its succour from impressions of immediate past and the persistent desires. This state is comparable to dream state of experience. Like dreams, during this state too, though not operating in visible terms, inlaid impressions keep chasing within the mind. It, however, remains the prerogative of the conscious mind, whether to translate the callings of subconscious into action on visible plane, or leave them aside. So, the subconscious obeys the conscious. Sub-conscious also contains such impressions as would be needed for quick recall to one's asking, like some-
