

# **Biparjoy touches down, batters Kutch**

2 dead, 3 hurt; 1 lakh shifted from coastal dists to safer places; power lines damaged, areas flooded; PM Modi reviews situation

### PNS AHMEDABAD/NEW DELHI

Strong winds and heavy rain battered the coasts of Kutch and Saurashtra as Cyclone Biparjoy made landfall near Jakhau Port in Gujarat on Thursday evening after churning across the Arabian Sea for over 10 days. Power failure was reported in many areas, and low-lying areas near the sea were flooded.

According to India Meteorological Department (IMD) the landfall process completed by midnight.

A cattle-rearer duo of father and son died while trying to save their goats stuck in a flooded ravine in Bhavnagar district on Thursday. Three individuals were injured in Devbhoomi Dwarka district when a tree fell on them, according to a State Minister. In anticipation of Biparjoy's landfall, approximately 1,00,000 people residing in coastal districts were relocated to safer locations

Prime Minister Narendra Modi spoke to Gujarat Chief Minister Bhupendra Patel over the phone on Thursday night and enquired about the situa

tion in the State. IMD Director General Mrutyunjay Mohapatra explained that the landfall process had commenced as dense convective clouds entered Kutch and Devbhumi Dwarka districts, with the process continuing until midnight.

Landfall refers to a cyclonic storm moving over land after being over water. Biparjoy, with an eye approximately 50 kilometres in diameter, is moving at a speed of 13-14 kilometres per hour, and it is estimated to take around five hours for the wall cloud and eye to completely cross over to

## land.

The impact of the cyclone was evident as strong winds uprooted numerous trees and electric poles near Jakhau and Mandvi towns in Kutch. Tin sheets and plastic shades were also blown away by the destructive wind force.

However, as of 7 pm, there were no reports of any loss of life, according to Gujarat Minister of State for Home Harsh Sanghavi. In Devbhoomi Dwarka

district, three individuals were injured due to a fallen tree and are currently receiving treatment. Ground-level teams comprising the Gujarat police,

National Disaster Response Force (NDRF), and the Army are working in various parts of Dwarka to clear uprooted trees and electric poles. The IMD issued a state-

ment in Ahmedabad, stating that the "very severe cyclonic storm Biparjoy" is centered over the north Arabian Sea but is approaching the Saurashtra coast with wind speeds of 115-125 kilometres per hour, gust-ing up to 140 kilometres per hour.

In response to the cyclone's potential for extensive damage, authorities evacuated approximately 100,000 people from vulnerable areas in coastal districts of Gujarat following a timely warning from the IMD. This marks the second powerful storm to hit the state in three years, with Cyclone Tauktae striking in May 2021.

To tackle the situation, 15 NDRF teams, 12 State Disaster Response Force (SDRF) teams, and personnel from the Indian Army, Navy, Air Force, Indian Coast Guard, and Border Security Force have been deployed for relief and rescue operations.

The IMD had previously issued warnings of very heavy to extremely heavy rainfall in several districts, including Kutch, Devbhumi Dwarka

Jamnagar, Porbandar, Rajkot, Morbi, and Junagarh. Additionally, the cyclone was expected to cause an "astro-nomical tide" with a storm surge of 2-3 meters, which could inundate low-lying areas in Kutch, Devbhumi Dwarka, Porbandar, Jamnagar, and Morbi during the landfall.

Due to the severe sea conditions, characterised by waves reaching heights of 10 to 14 meters, all activities in the northeast and adjoining eastcentral Arabian Sea, including oil exploration, ship movement, and fishing, have been suspended.

## When all fail, **HAM** radio only medium

As powerful cyclone Biparjoy, packing wind speeds up to 140 kilometres per hour, threatens to cripple communication networks after landfall on the Gujarat coast on Thursday evening, authorities have turned to HAM radio for smooth exchange of information.

Learning from past experiences, Gujarat State Disaster Management Authority (GSDMA) has deployed six HAM radio teams, two of them in Kutch, and mobile units for seamless communication after Biparjoy hits the shore near

Jakhau port. HAM radio is considered a reliable mode of messaging during emergencies when wirelines, mobile phones and other traditional terrestrial means of communication fail. Also known as amateur radio, HAM radio involves the use of radio frequency spectrum for noncommercial exchange of mes-

"GSDMA has deployed six teams with HAM radio units where the impact of the cyclone will likely be the most. Of them, two are in Kutch," Kausal Jani, HAM radio operator of GSDMA, told PTI.

During a cyclone, when all communication networks fail and electricity is not available. HAM radio works, he said. "It does not require any mobile tower or internet to make calls," he explained.

## Deal to buy 30 Predator drones OK'd ahead of Modi's state visit to US

In a significant development, the Indian Defence Ministry granted approval on Thursday for the long-awaited procure-ment of 30 Predator armed drones from the United States, valued at nearly 3 billion dol-lar dollars. This decision comes iust davs before Prime Minister Narendra Modi's scheduled State visit to Washington, where he is expected to engage in discussions with President

Joe Biden, with a particular emphasis on access to critical and highend technology from the US. The Pioneer

on June 15 had highlighted that in addition to the Predator drones

deal, India and the US are likely to collaborate on the joint production of GE-414 fighter jet engines for the domestically manufactured Tejas light combat aircraft. Both nations are expected

to explore opportunities for the joint manufacturing of armoured personnel carriers, ammunition, and other advanced defence equipment. Several crucial defence-related announcements are anticipated after talks between Modi and Biden

The approval for the armed drones deal was granted by the Defence Acquisition Council (DAC), chaired by Defence Minister Rajnath Singh on Thursday. However, the final clearance for the deal rests with the Cabinet Committee on Security (CCS), led by the Prime Minister.

The Predator drones, also known as MQ-9B Sea Guardians, are manufactured by General Atomics in the United States and have proven to be highly effective in com-

capable of targeting enemy assets with remarkable accuracy. The acquired drones will be utilised for long-range surveil-lance along India's borders and maritime regions. Sources have revealed that the Indian Navy will receive 15 drones, while the remaining will be distributed to the Army

India currently operates two unarmed Predator drones, which were leased and have been instrumental in assisting the Navy with monitoring activities in the Indian Ocean region. ground missiles. With an endurance of over 27 hours and an operational ceiling of up to 50,000 feet, the drone can carry a payload of 3,850 pounds (1,746 kg), including 3,000 pounds (1,361 kg) of external stores.

It is also capable of accom-modating multiple mission payloads.

Apart from India, the United States Air Force, Department of Homeland Security, NASA, Royal Air Force, Italian Air Force, French Air Force, and Spanish Air Force have all incorporated Predator drones into their respective defence forces.

The Karnataka Cabinet on Thursday decided to repeal the anti-conversion law introduced by the previous BJP Government. The Government plans to introduce a Bill for this purpose during the upcoming legislature session, scheduled to commence on July 3.

HK Patil, the Minister of Law and Parliamentary Affairs, informed reporters after the Cabinet meeting, "The Cabinet discussed the anti-conversion Bill. We have approved the Bill to repeal the changes that were

brought in by them (the BJP Government) in 2022. It will be tabled during the session starting from July 3." The BJP reacted sharply to

to any extent to hurt Hindus", Ravi alleged. The Karnataka Protection

of Right to Freedom of Religion Act, commonly known as the anti-conversion law, was enacted in 2022 despite Opposition from the Congress party.

The act aimed to safeguard the right to freedom of religion and prohibit unlawful conversions through means such as misrepresentation, force, coercion, allurement, or fraudulent methods.

It prescribed imprisonment ranging from three to five years and a fine of ₹25,000 for violations. In cases involving minors, women, and individuals from Scheduled Castes and Scheduled Tribes (SC/ST), the offenders could face imprisonment for three to ten years and a fine of not less than Rs 50,000

The law also provided for compensation of up to ₹5 lakh to individuals who were coerced into converting. Additionally, mass conversions could result in a jail term of three to ten years and a fine of up to Rs 1 lakh. It declared marriages solely intended for


unlawful conversions or vice versa, where one spouse converts to another religion before or after marriage, null and void. Family courts or courts with jurisdiction over such cases were responsible for adjudicating petitions filed by either party involved.

## PM to attend Ram Temple consecration; Ayodhya aims for global beauty: Yogi

Uttar Pradesh Chief Minister Yogi Adityanath on Thursday announced that Prime Minister Narendra Modi will attend the idol consecration ceremony at Ayodhya's Ram Lalla Temple in January. The CM highlighted the ongoing development projects worth ₹32,000 crore in Ayodhya, aiming to make it one of the world's most beautiful cities, a State Government statement quoting him said.

When one of the key milestones, the installation of Ram Lalla in the new temple takes place in January "after a wait of 500 years", Ayodhya's significance on a global scale will increase, he said, adding that the Prime Minister is scheduled to attend the event. Ram Lalla is the idol of Lord Ram, in his *Continued on Page 2* | five-year-old avatar.



"Ayodhya holds a special place in the hearts of millions of people. The people have a strong sense of Lord Ram's presence in their lives, and the construction of the temple will be a manifestation of their devotion and belief," Yogi said at the programme organised to celebrate the completion of Government at the Centre. The CM set a target of lighting 21 lakh lamps during

the upcoming Deepotsav and called for lighting of lamps in every household of Ayodhya, in addition to the ghats, math-linked temples, Suryakund, and Bharat Kund. "The preparations for this should commence from now itself as it sets the stage for the arrival of Lord Ram to his home next year," he said.

Yogi also underlined the Government's efforts in improving Ayodhya's infrastructure. Adityanath said that within the next four to six months, roads in Ayodhya will resemble Delhi's Kartavya Path.

"In the past, the city road and rail networks were poor. However, due to recent development, the journey from Gorakhpur and Lucknow to Ayodhya, which previously took five to six hours, can now be completed in just one hour," he said.

## No ties with MVA in Maha: KCR | DST: Indigenous scaffold from

Telangana CM bats for structural, qualitative change, brushes aside UCC 'hungama'

Telangana Chief Minister K Chandrasekhar Rao on Thursday said his Bharat Rashtra Samithi will not enter into an alliance with the opposition Maha Vikas Aghadi in Maharashtra and asserted his party will fight every seat in the state in the civic, Assembly and general elections.

He also spoke on the Law Commission seeking the views of religious bodies on the Uniform Civil Code and accused the ruling dispensation in the country of "bringing dharma gurus into politics"

Addressing a press conference after inaugurating his party's office, the first in Maharashtra, on Wardha Road here, he said polls must be held using ballot papers instead of electronic voting machines (EVMs). Queried on whether his party would forge an alliance with the MVA, comprising the Shiv Sena (UBT), Congress and



the Nationalist Congress Party, he said, "We have seen so many fronts, United Front, National Front but these were not adequate. Hence, we are preparing the BRS agenda.'

"Any party which agrees with the BRS agenda for structural change can come with us," he said, adding the BRS was not thinking of any alliance as "we will not need an alliance at all".

Asked about the alleged misuse of Central agencies like the Enforcement Directorate and Income Tax department, Rao said political parties are a pillar of democracy and must



not be harassed in such a way BRS will be the agent of 'qualitative change" in the country and its expansion plans will involve Uttar Pradesh, Chhattisgarh, Punjab and Haryana after Maharashtra, he said. The country's economy was

in a bad shape under the present (Narendra Modi) dispensation and every section of society was unhappy, he claimed.

In order to catch up with the world, the country needs to make "some structural change in respect of Constitution, judiciary, economic reforms, social reforms, electoral reforms, administrative governance system", the Telanagana CM said. Queried on talk about a

Uniform Civil Code in the country, he said, "From where they (Central government) are bringing dharma gurus into politics? Dharma gurus must run mutts and do puja. They (ruling dispensation) are doing hungama by infiltrating into this.

The Law Commission on Wednesday initiated a fresh consultation process on the UCC by seeking views from stakeholders including public and recognised religious organisations. On being asked about whether the BRS was the B-team of the BJP, the Telangana CM said such talk does not bother him. "It has now become a fashion in the country to call a party which is coming forward successfully as B, A or C team. Let them say whatever they want to, our work will be for the benefit of the people," he claimed.

# mammalian organs developed

'It will help rapidly heal skin wounds at low-cost with minimum scarring, lower import bill'

ndia has finally got its indigenously-made scaffold from mammalian organs, an animal-derived product that can rapidly heal skin wounds at low-cost with minimum scarring. Developed by a team of scientists led by Professor TV Anilkumar from the Sree Chitra Tirunal Institute for Medical Sciences and Technology (SCTIMST), an autonomous institution of the Department of Science and Technology (DST), the medical product 'Cholederm' has been given approval from the Drug Controller General of India (DCGI).

Though the concept of using animalderived materials as advanced wound care products is not new, indigenous technology was so far not available for fabricating quality products that satisfy the requirements of the DCGI. It is also hoped that this will help cut down import bill as so far the product is being purchased from abroad. It is expected that with the introduction of Cholederm to the Indian market, the treatment cost can be reduced from Rs 10,000 to Rs 2,000- making it more affordable to the common man. "Membrane forms of the



scaffold, identified as Cholederm, healed different types of skin wounds including burn and diabetic wounds in rats, rabbits, or dogs faster than similar products currently available in the market with minimal scarring as proved by several in-depth laboratory investigations focusing on Type I and Type III collagen," said an official from the DST.

The team unravelled the probable mechanism of the healing reaction and showed that the graft-assisted healing was regulated by anti-inflammatory (pro-regenerative) M2 type of macrophages. Indeed, the scaffold modulated or mitigated the scarring reactions in subcutaneous, skeletal muscle, and cardiac tissues.

"Considering the stringency of the compliance requirements for Class D Medical Devices as per the 2017-Medical Device Rules and the general belief among stakeholders that development of animal-derived Class-D Medical Devices is not practical in India, this is a milestone achievement for the Institute, especially the research team as well as Alicorn Medical," said Dr Harikrishna Varma, the Head Biomedical Technology Wing of the institute. The research has been published in the

journal Comparative Medicine. The scientists also said that usage of the gallbladder of pigs, normally a slaughterhouse waste without any monetary value in a highly value-added raw material for the biopharmaceutical industry can boost income of the pig farmers.

However, as the application of membrane forms of the scaffold for treating cardiac injury was found to be cumbersome, the scientists are developing injectable gel formulations of the scaffold that permits transvenous on-site delivery of the scaffold and for surface modification of polymeric medical devices.

Unfortunately, Aam Aadmi Party workers, farmers and sarpanchs are being intimidated, threatened and cases are being filed against them," he added.

The BJP and the JJP contested elections by abusing each other and later entered into a "Thugbandhan" and duped the people of the State, he stated. "The present Government has neither given good schools nor hospitals in the State and the State is number one in corruption, unemployment and crime," he added.

Significantly on Thursday, Congress general secretary Randeep Singh Surjewala too attacked Haryana Deputy Chief Minister and JJP leader Dushyant Chautala, saying though he talks of being a sympathiser of farmers, he was "clinging" to power for his self interests.

He also termed the BJP-JJP coalition Government in the State as "anti-farmer" and said farmers have to struggle to get minimum support price (MSP) for their crops.

The social media post by the Spear Corps of the Indian Army, whose operational area Manipur falls, said the "domination of fringe areas and higher reaches underway by long duration selfcontained columns" was being enforced.

The security forces redoubled their efforts in the wake of an attack on a Kuki village in the Khamenlok area bordering Imphal East and Kangpoki districts in the early hours of Wednesday, where 9 people died and 10 more were injured in a gunbattle which ensued between the miscreants who attacked the village and villagers.

More than 100 people have lost their lives in the ethnic violence between Meitei and Kuki community people in Manipur that broke out a month ago. The state has imposed a curfew on 11 districts and banned the internet in a bid to stop the spread of rumours in the state.

Clashes first broke out on May 3 after a 'Tribal Solidarity March' was organised in the hill districts to protest against the Meitei community's demand for Scheduled Tribe (ST) status.

Meiteis account for about 53 per cent of Manipur's population and live mostly in the Imphal Valley. Tribals - Nagas and Kukis constitute another 40 per cent of the population and reside in the hill districts.

self the country's "king" for life. Delhi BJP president Virendra Sachdeva dismissed Bharadwaj's claims as baseless. Highlighting the alleged theft of ideas, Bharadwaj stat-

ed, "Not only is there a leadership crisis in the Congress, but there is also a crisis of ideas. Its connection with the people has ended

The oldest party in the country has started stealing ideas and manifestos from the newest party in the country (AAP). The word 'Guarantee' has also been copied from us."



Bharadwaj pointed out instances where the Congress reportedly replicated AAP's initiatives, including the free bus rides for women in Himachal Pradesh and Rajasthan.

He criticised the Congress for opposing AAP's schemes in the past but implementing similar programs in other states. The AAP leader men-

## Coaching institute inferno Students use ropes, smash windows to escape death

NEW DELHI

A massive fire broke out on Thursday at a four-storey coach-ing centre in the northwest Delhi's Mukherjee Nagar area, resulting in injuries to 22 students. In a desperate attempt to escape, students of the coaching institute resorted to smashing windows, using ropes, and seeking help from ladders as the fire engulfed the top floor of the building. massive fire broke out on Thursday at a four-storey coach-

The Delhi Fire Service Director, Atul Garg, received a call about the fire at 12.27 pm and immediately dispatched 11 fire tenders to the scene. Garg reported that approximately 10-12 students sustained minor injuries while panicking and descending via ropes. He assured that there were no major casualties and that all students had been successfully rescued. Mukherjee Nagar is a renowned coaching hub for government job aspirants.

Preliminary investigations suggest that the fire originated from the meter board installed on the fourth floor of the building. The building, consisting of a ground floor and four additional floors, became the stage for a daring rescue operation captured in a video shared by the fire department. Firefighters can be seen saving the lives of people, primarily students, through the windows while smoke billows out from the top floor.

In their bid for survival, terrified students utilized ropes on the opposite side of the building to evacuate the premises. The video depicts trapped students emerging from the top floor one by one with the aid of ropes. Some students even threw their bags and assisted one another during the rescue operation.

A large crowd gathered on the ground floor, with many onlookers recording videos of the incident on their mobile



phones. Garg added, "The firefighting operation has been successfully concluded, and so far, no major injuries have been reported.

Neha Mangal (19), a recent enrollee at the coaching institute, described the ordeal, saying, "There was smoke in the classroom, and I sustained burn injuries on both hands. We managed to open a window and descended using an AC wire."

"During the incident, the class was being conducted on the fourth floor. As news of the fire spread, some students escaped through the terrace. The staff members helped us flee the fire. I sustained minor injuries but managed to reach the terrace and escaped through an adjacent building," recounted another student named Moolchand.



Taking to Twitter, Kejriwal shared a list of qualifying students from Delhi government schools in the past few years.

The tally of students from Delhi government schools who cleared NEET-UG saw a jump of over 40 per cent this year, with 1,074 of them qualifying the test. In 2022, 648 students from Delhi government schools cleared NEET. In 2021 and 2020, 496 and 569 students cleared the exams respectively

"Wow. More than 1000 students from Delhi govt schools qualify NEET. This could not even be imagined just a few years back. Congrats to all students, parents and



teachers," Kejriwal tweeted.

A total of 11.45 lakh candidates out of 20.38 lakh have qualified the examination, up by 48 per cent from last year. NEET-UG is the qualify-

The Delhi Police has arrested a 24-year-old man was arrested for allegedly uploading obscene videos and pictures of his ex-girlfriend on social media to defame her and create pressure on her family to get her to marry him.

The accused, Kumar Avinash, a resident of Saket, also posted mobile phone numbers of the victim and her mother on social media, police said.

In a police complaint lodged on June 6, the victim alleged that she had been receiving messages and calls from unknown numbers since June 1 and found out later that someone had created her fake profiles on Instagram, Facebook and other social media platforms.

Obscene videos and pictures of the victim had also been posted on these social media platforms, the police said. Deputy Commissioner of Police

(Shahdara) RohitMeena said the accused was arrested after analysing technical data and tracing IP addresses of the fake IDs.

During interrogation, Avinash disclosed that he and the victim studied in the same college and were in a relationship. However, the woman parted ways with him as her family did not approve of their rela-tionship, he said.

"The accused wanted to be in a relationship with the victim, so he uploaded her obscene pictures and videos on social media platforms using fake IDs. He thought this would put pressure on her family and due to the defamation, they will get her to marry him," the officer said.

A laptop and two mobile phones used by the accused in the commission of the crime have been recovered and further investigation is underway, the police said.

Modi to seek info on safety protocol, road map for preventing repeat of Balasore train tragedy

Prime Minister Narendra Modi will hold a meeting Railway Minister with Ashwani Vaishnaw and the entire Rail Board on Friday to address the concerns regarding safety and security measures in the wake of the Balasore train tragedy, which claimed the lives of around 300 people and left many seriously injured.

The Prime Minister intends to be informed about the safety protocols in place and the Railway's road map for preventing such mishaps in the future.

While the Central Bureau of Investigation (CBI) and Commissioner Rail Safety are conducting their independent investigations into the triple train tragedy, Modi, during his visit to the accident site in Odisha earlier this month, had unequivocally stated that those responsible for the inci-

dent would not be spared. "Strictest action will be taken against those found guilty in the train accident incident. No one will be spared," the PM had declared on June 4.

The crash on June 2 involved the Bengaluru-Howrah Superfast Express, the Shalimar-Chennai Central Coromandel Express, two trains carrying approximate-

A senior railway official, without revealing the details of the scheduled PM-Rail meeting, mentioned that several infrastructure projects are currently underway with stringent targets. It is essential to sensitize officers and staff in the field about the importance of maintaining the integrity of the signaling system for the sake of safety. Vaishnaw had suggested signal interference as a possible cause of the tragic crash.

The Ministry's presentation and briefing to the Prime Minister will include updates on the ongoing investigations and measures taken to fill vacancies across the railway sector. Opposition parties have raised concerns about the number of vacant positions

Sources have indicated that the status report will also cover instructions given to officials to develop plans for making the railway network completely tamper-proof against external elements. dent. Additionally, the Ministry had instructed zonal railways

a focus on locking, interlocking, and signaling arrange-ments, which concluded on June 14.

Railway sources revealed that in April, the signaling staff was reprimanded by the Railway Board for taking shortcuts when reconnecting signaling equipment after maintenance work without proper testing of points. The board's letter dated April 3 stated that five such incidents had been reported from various railway zones.

"The signaling gears were reconnected by signal and telecom staff without proper testing of points after blocks for switch/turnout replacement, wrong wiring during preparatory works, attending signal failures, etc.," the letter highlighted. "Such practices reflect a dilution of manual and codal provisions. The same is a potential hazard to safety in train operations and needs to be stopped," it stat-

Expressing dissatisfaction with the signaling department, the board noted that these incidents indicate a failure to improve the ground situation despite repeated instructions. Signaling staff members continue to adopt shortcut methods for clearing signals without checking correspondence from the sites or properly exchanging disconnection or reconnection

Agroup of esteemed acade-micians affiliated with the NCERT books has expressed their frustration and demanded the removal of their names from the textbooks, citing the jeopardizing of their collective creative effort. This comes shortly after political scientists Ýogendra Yadav and Suhas Palshikar wrote to the NCERT, requesting the exclusion of their names from the textbooks.

These academicians have been members of the Textbook Development Committee (TDC), responsible for oversee-ing the NCERT textbooks.

In a letter addressed to the Director of the National Council for Educational Research and Training (NCERT), Dinesh Saklani, 33 academicians have signed their names, including notable figures such as Kanti

the vice-dean at the National University, Singapore; Pratap Bhanu Mehta, former vice-chancellor of Ashoka University; Rajeev Bhargava, former director of CSDS; Niraja Gopal Jayal, former professor at JNU; Nivedita Menon, professor at JNU; Vipul Mudgal, head of civil society watchdog Common Cause; KC Suri, former professor at the University of Hyderabad associated with Gitam University, and Peter Ronald deSouza, former director of the Indian Institute of Advanced Studies.

The controversy surrounding the removal of various topics and sections from NCERT textbooks last month has sparked outrage, with the Opposition accusing the BJP-led Government of engaging in a "whitewashing" exercise. The NCERT initially referred to the omissions as a possible oversight

based on expert recommendations. It also mentioned that the textbooks were scheduled for revision in 2024 when the Curriculum National Framework (NCF) comes into effect. However, the NCERT later changed its stance, stating that "minor changes need not be notified."

"In view of the substantive revisions made to the original texts, rendering them essentially different books, we find it difficult to associate our names with them... We now fear that this collective creative effort is under threat," expressed the academicians in their letter to the NCERT.

The textbooks were the outcome of extensive discussions and collaborations among political scientists representing diverse perspectives and ideological backgrounds. They were originally designed to impart rledge about India

# **3 DEAD, MANY HURT AS BOMBS, BULLETS FLY HC orders immediate deployment** of CAPF for Bengal rural elections

continuing civil-war like violence between Trinamool Congress workers and those of the other Opposition parties consumed three lives besides injuring dozens of others in a single day the Calcutta High Court on Thursday ordered deployment of central forces ahead of the forthcoming panchayat elections with immediate effect.

The order passed by the Division bench of Chief Justice S Sivagnanam tends to come as a major embarrassment for the Mamata Baneriee Government and the State Election Commission (SEC) which had earlier been asked by the same court to deploy "forthwith" central forces in only seven politicallysensitive districts.

## Sexual assault on woman in ladies compartment of Mumbai train

Opp raises issue of women's safety in wake of series of crimes in last few days

## TN RAGHUNATHA MUMBAI

Ahorrendous sexual assault on a 20-year-old girl by a 40-year-old porter in the ladies compartment of a running sub-urban train on Thursday sparked a public uproar over the issue of women safety in the country's commercial capital even after the accused was arrested within eight hours after the incident.

Coming as it did on the heels of the rape and murder of a girl in a hostel at Marine Lines in south Mumbai and the macabre Mira Road murder of a woman by her live-in partner, the alleged sexual assault on a girl on a running Harbour Line suburban train prompted the Opposition Maha Vikas Aghadi (MVA) to pillory the Eknath Shinde-Devendra Fadnavis Government over the issue women's safety and the breakdown of law and order in the State

Taking serious cognisance of the sexual assault incident, the Maharashtra State Commission for Women (MSCW) on Thursday sought a report from the Chhatrapati Shivaji Maharaj Terminus (CSMT) police on the incident. The sexual assault, which took place on Wednesday, brought back the most unpleas-ant memories of the rape of a 12-year-old mentally challenged girl by a drunken man on a suburban train between Churchgate and Borivli on the intervening night of August 14-15, 2002 and the sexual assault perpetrated by a man in a coach reserved for handicapped passengers and cancer patients on the night of April 5, 2018

The disturbing incident which saw a girl student being sexually assaulted by a railway porter on running train soon after the Panvel-bound local



departed from the CSMT on Wednesday morning - has come as a big shock to the lakhs of suburban commuters, especially women, travelling by the Central, Western and Harbour suburban railway networks.

The girl was on her way from Mumbai to Belapur in the satellite township of Navi Mumbai to appear in an examination when the incident took place on board the Panyelbound train immediately after it left CSMT at 7.27 AM on Wednesday. After the girl raised an alarm, the accused porter jumped off the train at the Masjid station.

Acting swiftly, the joint teams of the Government Rail-way Police (GRP) and Railway Protection Force (RPF) arrested the accused -- Nawaz Khan -within eight hours of the incident.

Talking to media persons, Deputy Commissioner of Police Manoj Patil said it was a case of sexual assault. "Immediately after the incident was reported, we began investigations and arrested the accused within hours," he said.

After the incident was reported, teams of GRP, Railway Protection Force (RPF), crime branch and Mumbai Police personnel launched a manhunt for the accused. "We examined footage of CCTV cameras inside and outside the Masjid station. We identified the accused and arrested him at around 4 PM," a senior police official said.

The accused was on Thursday produced before a city Magistrate's court which remanded him to police custody for six days.

Meanwhile, MSCW chairperson Rupali Chakankar direct-ed the CSMT Police Station to investigate the incident and submit its report to the women's

#### "Lakhs of women travel daily by suburban trains. There is a need to ensure their safety. We have asked the police and other authorities to take safety precautions to ensure against repeat of such incidents, Chakankar said.

Describing the incident as outrageous" and "very disturbing" the newly-appointed NCP Working President Supriya Sule said; "This is very disturbing and the issue of security in Mumbai local trains has once again come to the fore... Criminals have no fear of the law in Maharashtra due to the inaction of the Home Department," said Sule, demanding the strictest punishment to the accused for the

heinous crime. Maharashtra Mahila Conress president Sandhya Savvaakhe wondered whether "the State Government, Home Department and the police in Maharashtra are alive or not".

"This shameful incident comes barely a week after the rape-cum-murder of a student in the (Savitridevi Phule Women's Hostel). The recent incidents show a growing trend of violence against women in Mumbai," Savvalakhe said.

Savvalakhe said that while the country's PM keeps showing the green flags to new trains, the infighting between the Shiv Sena-BJP in the State leaves them with no time to govern and ensure law and order, and demanded that "they must wake up now".

Condemning the incident, Leader of Opposition Ajit Pawar questioned the efficiency of the State home department - headed by Deputy Chief Minister Devendra Fadnavis himself - "in view of the alarming increasing crimes and violence against women in the past few days".

## Police make 5th arrest in Raut brothers' threat case

Within days after death threats were handed out to Shiv Sena (UBT) Rajya Sabha member Sanjay Raut and his brother and MLA Sunil Raut, the Mumbai police on Thursday arrested a political activist Mayur Shinde, considered close to them, taking the total number of arrests in the case to five.

The Kanjur Marg police who are investigating the case, produced Shinde before a city court which remanded him in police custody till June 19.

On his part, BJP leader Nitesh Rane, son of Union Minister Narayan Rane, claimed that a drama was enacted by Raut himself to spoil the repu tations of Deputy Chief Minister Devendra Fadnavis, who hold the State Home portfolio.

"This is Mayur Shinde, who has apparently been arrested by Mumbai police for giving death threats to Shree 420 and his brother Mini 420 ! The call recording that was played in the media was between Sunil Raut n his own Mayur Shinde! Golmaal Gang!," Nitesh tweet-

ed The motive behind the death threats handed to Sanjay Raut and his brother Sunil has not been established yet. The accused Shinde had earlier posted photos and videos with Sunil Raut Acting on a complaint lodged by Sunil Raut with the Kanjurmarg Police Station, the police had earlier arrested four persons last week

Shinde's arrest comes five davs after the Raut brothers received the telephonic death threats.

## **Manipur mayhem**

It is unfortunate that violence in the Northeastern state continues unabated

backlash by villagers against an armed group that had been repeatedly attacking their hamlets in Manipur's Kangpokpi district over the past few days culminated A their harmets in manipuls is range only about the state's worst bloodshed in a single clash since the ethnic conflict erupted on May 3. In the bloodiest incident nine people lost their lives while 10 were wounded. Manipur is a culturally diverse state, home to several ethnic communities, including the Meiteis, Nagas, and Kukis. Historical and social divisions among these groups have led to sporadic violence and conflicts over resources, territorial claims, and political representation. Manipur has witnessed the emergence of various insurgent groups, each with its own ideological agenda. These groups often resort to violence leading to a vicious cycle of retaliation and counter-violence. Besides, unemployment, lack of economic opportunities, and inadequate infrastructure have contributed to the sense of frustration and disillusionment among the youth of Manipur. These socio-economic fac-



tors create an environment where violence becomes an outlet for expressing grievances and seeking attention. Add to this the political superstructure which widens the schism for electoral gains. Frequent changes in political leadership and the absence of stable governance have impeded effective policymaking. Political instability creates a fertile ground for violence to persist and thrive. What is disturbing is that many insurgent groups are acting from Myanmar which compounds the problem.

Imphal Valley occupying about 10% of the land area of the state is mainly populated by the Meitei people. The surrounding hills are inhabited by Kukis in the south-

ern portion and Nagas in the northeastern portion. The Meiteis make up 53% of the population. The tribal population, consisting of predominantly Christian Kukis and the Nagas, forms about 40% of the state's 3.5 million people. They reside in the reserved hill regions consisting of the rest of the 90% of the state. However, the Meiteis dominate political power in the Assembly and get the lion's share of Government benefits. Tribal groups complain that the government spending is concentrated in the Imphal Valley. The trouble this year started when the state government in Manipur began efforts to remove illegal immigrants from settlements in reserve forest areas. Officials have stated that illegal immigrants from Myanmar have been settling in Manipur since the 1970s. Tribal groups have said that illegal immigration is a pretext under which the Meitei population wants to drive the tribal population from their lands. In February 2023, the BJP state government began an eviction drive in districts of Churachandpur, Kangpokpi and Tengnoupal, declaring the forest dwellers as encroachers. 
# India is a 'Union', not a federation



To create a federation on the lines of the USA was never intended, it would have been grave mistake had we done so

everal political figures and writers, including some foreign ones, have alleged that India is on a path of "anti-federalism" or centralism. However, they have coolly overlooked that over the last nine years, not once has Article 356 been used by New Delhi. Earlier, it was used 56 times when state governments were dismissed when the Centre decided that a particular state government was unfit to govern, or actually if it did not like particular state governments. Article 356 states: (1) if the President, on receipt of a report from the Governor of a State or otherwise, is satisfied that a situation has arisen in which the Government of the State cannot be carried on in accordance with the provisions of this Constitution, the President may be Proclamation (a) assume to himself all or any of the functions of the Government of the State and all or any of the powers vested in or exercisable by the Governor or anybody or authority in the State other than the Legislature of the State; (b) declare that the powers of the Legislature of the State shall be exercisable by or under the authority of Parliament. (c) make such incidental and consequential provisions as appear to the President to be necessary or desirable for giving effect to the objects of the Proclamation. Including provisions for suspending in whole or in part the operation of any provisions of this Constitution relating to anybody or authority in the State.

One prime minister used Article 356 to dismiss state governments 49 times! Not a single voice then alleged that federalism was in danger, or forced centralism. Far from any outcry about democracy or federalism being imperiled, the selfappointed watchdogs of democracy, namely the media, academia and intelligentsia chose to remain silent or look the other way during the rampant assault on state governments for not toeing the line of the central disensation of those times. worse is the fact that segments of the media were complicit in the misuse of political authority. It would be a big opportunity to upgrade India-US bilateral ties

historic one-of-its-kind state visit is slated for Indian Prime Minister Narendra Modi when he lands on the East Coast of the United States next week. The rush hour traffic of high profile leaders from both countries crisscrossing Washington and New Delhi to iron out a meaningful outcome document, the choice of venues during Mr Modi's visit to the US and the number of events being planned, including many for the first time, suggest that America is walking the extra mile to pull India into close friends' club. This is a departure from the cold war-infused reluctance of having warm ties, which India and the US have witnessed for nearly 4 decades.

The oldest democracy and the largest democracy chose partners on either side of the cold war aisle as trusted, till things started moving a decade and a half back. The US shed its reluctance of allowing India into the exclusive nuclear group, thereby providing access to high-end technology, Delhi around the same time had started realising the benefits of a free economy and therefore, the need to shed its old socialist ideological alliances. The 15-year journey has been, dotted with milestones each upgrading the bilateral relationship.

In the run-up to the state visit, with a promise of being the most significant and full of meaningful business outcomes, Secretary of State, US, Antony J Blinken while addressing the Idea of India summit commented "We are here almost literally on the eve of what we believe will be a historic state visit by Prime Minister Modi - one that will further solidify what President Biden has called the 'defining relationship' of the 21st century." He went on to highlight that the bipartisan approach to India's relationship has been consistent during the last years of the Clinton administration, through the Bush administration, Obama administration, and Trump administration, with an extra push coming in from the ongo-



ing Biden administration.

The aim is to bring India as a key player and close friend of the USA in the overall geo-political strategy with a sharp focus on the Indo-Pacific, where China is a growing threat to both nations, which was read out clearly in the Secretary of State's speech. He said "We see the importance of the partnership in a shared commitment to addressing regional and global challenges - promoting health security, working with our Quad partners to build a free, open, secure, prosperous Indo-Pacific where people, where goods, where ideas can travel freely and rules are applied fairly. I have witnessed India's constructive leadership on these issues up close these last two and a half years, and I see it in their ambitious agenda at this year's G20; in our new I2U2 group with India, with Israel, with the UAE, the United States; and in probably more than a dozen meetings that I've had with my counterpart, my colleague, my friend, Foreign Minister Jaishankar.' The emphasis on economic ties marks a new chapter for the bilateral where the US values India as an important economic ally, which over time could prove to be one the most crucial partnerships. Statistics like \$191 bn of trade between the US and India last year, robust investment by American companies in India and vice versa creating millions of job opportunities spanning from Kolkata to North Carolina and beyond, are all set to get a leg up, with the upcoming state visit. The preparatory meetings by Defence Secretary US. National Security Advisor US, a visit by Finance Minister, India, Railways IT and Communications Minister, External Affairs Minister India and several high-level officials from India visiting the US in the recent past are sure to push the numbers higher. The industry stakeholders are cheering for a \$500 billion bilateral trade which will further create jobs in both countries. All eyes are now on Mr Modi in New York and Washington, next week.

e are in the 75th year of independence and have grown from 30 crore in 1947 to 142 crore in 2023. People are happy that the country has got a new swanky Parliament building. some slokas of Rig Veda which mentions it as a thriving republican form of Government in India. There are slokas in Rig Veda which stated that there were self governing bodies in the villages' and Republican congregations. However, over the years the systems of kings and power brokers ruled the roost but even then there was a Panchayat (council of five persons) system of governance in each village and it continued in one form or the other. But during the Medieval period and thereafter village feudalism started becoming stronger and became further strong in the British period when the county's resources were exploited by the British and poverty got accen-tuated and compounded by many famines

In the recent modern system, the principles of democratic gov-

So while assessing the Indian democracy we must look at the way we conform to the core values of Liberty, equality and fraternity in our governing system. On the positive side we have achieved a semblance of stability of governance with well-entrenched, fair and independent electoral proceedings; have ensured self-sufficiency in food grain production through the Green Revolution, increased life expectancy from 32 years in 1947 to 70 years in 2022, Eradication of Polio, Space, Nuclear and other Technologies including medical science, Gender equality, Education, Milk production through white Revolution and a robust Defence structure.

However, there are many negative fallouts of democracy that a country of immense diversity is facing and for which the people as well as the political parties are equally responsible. More than 80 per cent of politicians as well as people are not bothered about the real tenets of democracy and how to practice it. This is the only country in the world where citizenship can be obtained with fake documents and even Aaadhar cards are made by procuring such documents. The reason for this is the lack of genuine commitment among the citizens, bureaucracy and political class for ensuring the national integrity and protecting its heritage. These documents obtained fraudulently are then used for getting voter identitv cards. One of the conditions for a voter's id is that the applicant should be ordinarily a resident of the locality where he wants to register as a voter. This condition is, however, never seriously examined with the results that several foreigners have become Indian cit-

izens and vote bank politics is seriously compromising the national interests. It ultimately foments social tensions and had created serious problems of security of the country and law and order-related issues. Take the example of the recent Manipur riots.

Till a few decades ago the population of Chuda Chandpur District was only sixty thousand but now it is several lakhs and unusually high due to the influx of Kuki and Naga tribes from Myanmar. The crossborder drug peddlers are one of the root causes of disturbance in Manipur and the vote bank politics have led to more and more influx of foreigners not only in Manipur but all over India. The Assam agitation was the fallout of the settlement of foreigners. In Uttarakhand foreigners and outsiders are taking advantage of migration in the hills and settling in large numbers threatening the culture and ecology of the fragile border state. We talk about foreign interference like George Soros's funding to destabilize the Indian government and Hinderberg publishing a report on Adani which led to the share market crash of Adani share but we must remember why only Asian and African countries are targeted by them. It is because we have chinks in our society and democracy in which we do not hesitate to take the help of outsiders to settle scores with opponents and ever since the telecast of our parliament's proceedings began that provides fodder for them to intervene in our affairs All political parties must ponder over and learn good things about other countries' parliamentary protocols and work for the welfare of our people and make India a true world power.

n preparation for the upcoming 2024 Lok Sabha elections, both the Samajwadi Party (SP) and Bharatiya Janata Party (BJP) in Uttar Pradesh are intensifying their efforts to gain the support of the Other Backward Classes (OBCs). Recognizing the significant influence of OBC voters, both parties are formulating strategies to secure their backing and consolidate their respective support bases.

The OBC category, which originated from the Mandal Commission report, consists of diverse castes and does not form a cohesive "political community." The OBCs can be classified into three groups based on caste and class criteria such as social status, income, and education. The first group includes a relative-

grouping, as desired by the SP. In a recent rally held in Ghazipur district on June 10, the BJP sought to appropriate Maharaja Suheldev, a legendary king from Shravasti, as an OBC icon. This event was part of the BJP's broader strategy to consolidate its non-Yadav OBC vote bank.

Ghazipur was a strategic choice for the BJP's outreach to the Rajbhar community, considering that the party faced electoral challenges in the district during both the 2019 Lok Sabha elections and the 2022 Assembly polls. The Samajwadi Party is countering the BJP's efforts by planning conferences and conducting cadre training camps as part of the Lok Jagran Abhiyan. Their central demand is for a castea common backward class based census in Uttar Pradesh,

The Metropolitan Police said Keven Antonio Lourenco De Morais, previously referred to as a Brazilian national, has been remanded in police custody to appear at Uxbridge Magistrates

Court in London. Two other people, one man and a woman, arrested in connection with the murder investigation at the crime scene have now been released with no further action.

"Keven Antonio Lourenco De Morais, 23, of Neeld Crescent, Wembley was charged on Thursday, 15 June with the murder of Tejaswini Kontham and the attempted murder of a second woman," the Met Police said in a statement. On Tuesday, Met Police officers attended a flat in Neeld Crescent, Wembley, along with the London Ambulance Service and found Tejaswini and another woman, aged 28, suffering from knife injuries. "Despite the efforts of

emergency services, Tejaswini sadly died at the scene. Her family has been informed," the

police said. It led to a man-hunt for prime murder suspect De Morais, who was later arrested in the Harrow area of north London.

The second victim of the knife attack has been named locally as Akhila, also from India who remains in hospital but is said to be out of danger. The Indian National Student Association (INSA) UK issued a statement to say that she remains in a state of shock following the attack, which claimed the life of her friend. "On behalf of Indian students in the UK, we convey our sincere condolences to her family and friends and pray that her soul rests in peace," INSA UK said in a statement with reference to Tejaswini.

## Man attacks 2 women in Germany killing one

Berlin (AP): A tourist died after a man attacked her and a companion near Neuschwanstein castle in southern Germany, author-ities said on Thursday. The incident near the popular tourist attraction close to the Austrian border happened on Wednesday afternoon. Prosecutors in nearby Kempten said the two women, age 21 and 22, had met the 30year-old suspect - who also had gone to the castle as a tourist for the first time shortly beforehand. The attack took place near the Marienbruecke, a bridge over a gorge close to the castle that offers a famous view of Neuschwanstein, German news agency dpa reported. Authorities said the three apparently took a path to a viewpoint, where the man attacked the younger woman.

nation "The GDP for the first quarter of 2023 at the constant price has declined to Rs 3,114,187 million from Rs 3,519,400 million in the first quarter of 2022. The year-onyear GDP growth for the first quarter of the year 2023 has been reported as 11.5 per cent of negative growth rate," the statistics department said in a statement. While the agricultural sector had expanded by 0.8 per cent, the industry and service sectors had declined by

23.4 per cent and 5 per cent respectively during this quarter, it added.

In 2022, the economy had contracted by over 7 per cent as the economic difficulties forced people to take to the streets with protests across the island nations that also led to the ouster of Sri Lanka's powerful Rajapaksa family from politics.

In March, an agreement was struck with the International Monetary Fund (IMF) for a nearly USD 3 billion bailout pending debt restructuring with creditors.

Until the IMF facility, the island's economy was assisted by an aid package of USD 4 billion from India.

The Indian credit lines for fuel and essential imports provided relief to the public protesting against the government for its mishandling of the nation's economy.

## Pope joins imam in making calls for peace

#### **AP** UNITED NATIONS

Pope Francis and a leading Sunni imam made calls for peace as the UN Security Council met Wednesday to discuss the importance of "human fraternity" and condemn the hatreds that kindle conflicts. The pope, who is in hospital recovering from abdominal surgery, sent a statement saying that a third world war is being fought "piecemeal" and with the potentially catastrophic effects of nuclear weapons "the time has come to say an emphatic 'no' to war".

Sheikh Ahmed al-Tayeb, the grand imam of Al-Azhar, the 1,000-year-old seat of Sunni learning in Cairo, said in a virtual briefing that human fraternity was the key to global peace, a point he and the pope had made in a joint document released in 2019.

The UAE chose the importance of human fraternity in bringing peace as a centrepiece of its presidency of the council



this month. After the appeals by the pope and grand imam and council speeches, members adopted a resolution recognising that hate speech, racism, xenophobia, intolerance, gender dis-

crimination and acts of extremism "can contribute to driving the outbreak, escalation and recurrence of conflict". The resolution, co-sponsored by the UAE and the United Kingdom, urges all countries and organisations to condemn these acts and work to

prevent them. It was adopted unanimously even though some of the council's 15 members have been accused of some of the same actions they are condemning.

## Pope sends Benedict XVI's former aide back to Germany

Rome (AP): Pope Francis has fired the longtime aide to the late Pope Benedict XVI from his Vatican job and ordered him to

return to his native Germany, the final chapter in a very public falling out that culminated with the aide's tell-all memoir that was highly critical of Francis.

The Vatican confirmed that Archbishop Georg Gaenswein had officially ended his job as prefect of the papal household as of Feb. 28. A statement issued Thursday while Francis was in the hospital recovering from abdominal surgery said the pope had ordered Gaenswein to return to Freiburg, Germany, his diocese of origin, by July 1. While all papal secretaries usually return to their dioceses of origin following the death of the

pope they served, the Vatican's announcement betrayed some of the ill-will that had developed between Francis and Gaenswein

Francis gave Gaenswein no new assignment, and at 66, he is nearly a decade too young to retire. Speculation about Gaenswein's future had swirled following Benedict's Dec. 31 death and deepened a week later with the publication of the archbishop's memoir, "Nothing But the Truth." In the book, Gaenswein recounted his life serving Benedict . He revealed palace intrigues, settled old scores and cast Francis in a unfavourable light, puncturing the curated notion that the cohabitation of two popes, one active and one retired, had been a happy one

## Former Harvard morgue manager stole brains, skin and other body parts

Aformer manager at the Harvard Medical School morgue, his wife and three other people have been indicted in the theft and sale of human body parts, federal prosecutors in Pennsylvania announced on Wednesday.

Cedric Lodge, 55, of Goffstown, New Hampshire, stole dissected portions of cadavers that were donated to the school in the scheme that stretched from 2018 to early 2023, according to court documents. The body parts were taken without the school's knowledge or permission, authorities said, adding that the school has cooperated with the investigation.

Lodge sometimes took the body parts — which included heads, brains, skin and bones - back to his home where he lived with his wife, Denise, 63,

and some remains were sent to buyers through the mail, authorities said. Lodge also allegedly allowed buyers to come to the morgue to pick what remains they wanted to buy. Bodies donated to Harvard Medical School are used for education, teaching or research purposes. Once they are no longer needed, the cadavers are usually cremated and the ashes are returned to the donor's family or buried in a cemetery.

In a message posted on the school's website entitled "An abhorrent betrayal," deans George Daley and Edward Hundert called the matter "morally reprehensible." They said Lodge was fired May 6.

"We are appalled to learn that something so disturbing could happen on our campus a community dedicated to healing and serving others," the deans wrote. "The reported incidents are a betrayal of

## **Pro-Khalistani activist** Chinese premier Li meets Prez dies in UK hospital

#### PTI LONDON

vtar Singh Purba alias AKhanda, a prominent pro-Khalistani activist who was involved in the attack on the Indian High Commission in London, died at a hospital in the city of Birmingham on Thursday morning after a pro-longed illness, a UK-based Sikh organisation said in a statement.

Sikh Federation UK, which has styled itself as one of the largest Sikh organisations based in the UK, said Avtar Singh was terminally ill with blood cancer. He was on a life support system for the last few days Wanted in conspiracy to kill Sukhbir Singh Badal (President of Shiromani Akali Dal-B), former Punjab DGP Sumedh Singh Saini and senior advocate Rajwinder Singh Bains, Avtar Singh was allegedly involved in terrorist activities in the UK by joining the banned Khalistan Liberation Force (KLF) remnants active in Britain and other countries.

Avtar Singh, who initially went to UK in 2007 on study visa but later took asylum there in 2012 and never returned since then, was linked to anti-India activities including the attack on the tricolour at the High Commission of India in London earlier this year - allegations that he had denied. His family still resides in Purana in Moga district.

"It is with the greatest sadness that we share the shocking news that the young Panthic Activist Bhai Avtar Singh Khanda (35) has passed away in a Birmingham hospi-



tal this morning," Jaspal Singh, National Press Secretary of Sikh Federation UK, said in a statement.

The organisation went on to attack the Indian authorities for running a "hate campaign" against Avtar Singh and his family because of his close family ties with pro-Khalistani activists Deep Sidhu, who died in a road accident in February last year, and and Amritpal Singh, a radical preacher who is currently in an Indian jail. He was one of the mentors

of Amritpal Singh and was funding him all along. He had also helped Amritpal in evading arrest from police for over one month. After the arrest of Amritpal, Avtar had formed a committee of foreign based Khalistani elements to run the affairs of 'Waris Punjab De'.

Avtar Singh was son of slain Khalistan Liberation Force terrorist Kulwant Singh Khukhrana, who was killed in an encounter. He was learnt to March 19.

# Greece boat tragedy: Search on for hundreds feared missing

#### AP KALAMATA (GREECE)

Rescue ships fanned out on Thursday in search of hundreds of migrants feared missing after their overcrowded boat capsized and sank as they tried to reach Europe. At least 78 people died.

Rescuers saved 104 passengers from a fishing boat that sank in deep waters off Greece's coast while trying to travel from Libya to Italy, but authorities fear that hundreds of others may have been trapped below deck.

If confirmed, that would make the tragedy one of the worst ever recorded in the central Mediterranean. "The chances of finding

Wellington (AP): New Zealand's economy has dipped into recession as higher interest rates take their toll, new figures released Thursday show.

Gross domestic product fell by 0.1 per cent in the March quarter, following a revised 0.7 per cent fall in the previous quarter, Statistics New Zealand said. That fulfils the nation's definition of a recession, which is at least two consecutive quarters of negative growth.

The slowdown comes after New Zealand's central bank raised its benchmark interest rate 12 straight times to 5.5 per cent as it tries to tame inflation. The rate is at its highest level

expensive for people to borrow money for homes, cars and other purchases. The Reserve Bank of New Zealand has indicated it doesn't plan to raise the rate any further for now and that its next move will be a cut.



determinant of fiscal strength and the credit profile will be debt affordability and in particular the proportion of rev-enue absorbed by interest payments," Moody's said.

India has a relatively high level of general government debt, estimated at around 81.8 per cent of GDP for 2022-23, compared with the Baa-rated median of around 56 per cent.

The country also has a low debt affordability, in terms of general government interest payments as a percentage of revenues, which for India is estimated at 26 per cent for 2022-23, compared with the Baa median of around 8.4 per cent.



"At 26 per cent currently it is a large proportion, which, if not further addressed via a continued broadening of the revenue base, will remain an important constraint on the government's ability to provide more support for growth and address developmental needs," Moody's added. According to the data released by the commerce ministry on Thursday, key export sectors recording negative growth include petroleum products, gems and jewellery, engi-neering goods, ready-made gar-ments of all textiles and chemicals.

Imports also declined 6.6 per cent, six-month in a row, to USD 57.1 billion against USD 61.13 billion in the same month last year, the data showed.

The trade deficit in May 2022 stood at USD 22.13 billion. The last high was in December 2022, when the gap was USD 23.89 billion. Cumulatively, exports during April-May this fiscal contracted by 11.41 per cent to USD 69.72 billion, while imports declined 10.24 per cent to USD 107 billion.

Briefing reporters on the data, Commerce Secretary Sunil Barthwal said headwinds still continue at the global trade front as there is a "whole lot of" recession and slowdown in many countries. The fall in economic growth in certain developed markets has impacted import demand, he said, adding there is also low demand in OECD nations. India's top oil and natural gas producer ONGC has signed a pact with the nation's largest oil refining and fuel marketing Indian Oil company Corporation (IOC) for exploring opportunities in the petrochemicals business.

Oil and Natural Gas Corporation (ONGC) and IOC "signed a memorandum of understanding (MoU) to explore downstream opportunities, especially in petrochemicals, both greenfield projects and through acquisitions," ONGC said in a tweet.

ONGC, which produces two-thirds of the nation's oil that is refined into fuels like petrol and diesel and more than half of gas that is used to make fertilisers and turned into CNG, already has two downstream petrochemical plants through subsidiaries.

As nations transition away from polluting fossil fuels to low carbon sources of energy like hydrogen and use of electricity to power automobiles, oil companies the world over are rein venting themselves.

Crude oil, which is currently refined in refineries to produce petrol and diesel, is to be directly converted into petrochemicals that form building blocks for a range of plastics, paints, detergents and tires. domestic equities.

The demand for petrochemicals in India is projected to grow exponentially as the per capita consumption was much lower world average.

Last month, Oil Minister Hardeep Singh Puri stated at a conference that the chemical market in India is projected to grow to USD 300 bil-lion this decade from USD 178 billion.

India is expected to account for more than 10 per cent of the world's growth in petrochemicals, a press statement issued by the Press Information Bureau (PIB) on May 19 quoted him as saying.



Ange Postecoglou's first game in charge of Tottenham will be away to Brentford.

Bournemouth host Europa Conference League winners West Ham, and Everton, looking to avoid a third straight rel-

egation scrap, begin at home to Fulham. City, who finished five points clear of Arsenal last season, travel to the Gunners' Emirates Stadium in early October

Old Trafford will host the first Manchester derby since City matched United's Treblewinning feat of 1999 at the end of that month, with the champions meeting Jurgen Klopp's Liverpool in late November. The schedule, returning to normal after the 2022/23 season

## Croatia stun hosts Netherlands to reach Nations League final

#### AFP ROTTERDAM (NETHERLANDS)

Bruno Petkovic and Luka Modric struck in extra time to fire Croatia into the Nations League final with a 4-2 victory over hosts the Netherlands on Wednesday. Zlatko Dalic's side, who reached the World Cup semi-finals last year, moved a step closer to earning their first ever trophy and demonstrated once again they are extra-time specialists.

Andrej Kramaric and Mario Pasalic netted in the second half after Donyell Malen sent the Dutch ahead, but Noa Lang snatched a 96th-minute equaliser to force an additional half hour. However Petkovic got away from Frenkie de Jong and drilled home from outside the box to decisively put Croatia ahead eight minutes into extra time, and Modric wrapped up the win with a penalty.

The Nations League represents one of the last chances for Croatia's elder statesmen, including Real Madrid midfielder Modric, to taste international triumph.

"It's a victory for the Croatian people, we beat the Netherlands in front of their fans, Croatia has one more medal -it's impossible, unreal, but she deserves it," Croatia coach Dalic told his country's Nova TV.

"Nothing upset the team, they know what they are play-



ing for, above all, Croatia. You endure everything for Croatia.

"This is one of our biggest victories, to win 4-2 on their ground, we were losing, we conceded in the 96th minute.

"Surely this is a victory which will go down in history.' Croatia have only suffered

one defeat in their last 16 matches, to World Cup winners Argentina, and quashed the Netherlands' bid to win their first competition since the 1988 European Championship. Ronald Koeman's side fin-

# **ASIA CUP TO BE HELD** IN HYBRID MODEL

#### PTI NEW DELH

Ending months of speculation around Asia Cup, the Asian Cricket Council (ACC) on Thursday announced that the tournament will be staged in a hybrid model with four games in Pakistan and nine in Sri Lanka from August 31 to September 17.

The deadlock over the staging of the 50-over tournament was broken last week when the Jay Shah-led ACC accepted Pakistan Cricket Board's hybrid model of conducting four non-India games in Pakistan. The hybrid model was proposed as the BCCI had made it clear that it won't send its team to Pakistan due to the longstanding geo-political tensions between the two countries.

"We are delighted to announce that the Asia Cup 2023 will be held from 31st August to 17th September 2023 and will see the elite teams from India, Pakistan, Sri Lanka, Bangladesh, Afghanistan and Nepal, compete in a total of 13 exciting ODI matches. "The tournament will be hosted in a hybrid model with four matches being held in Pakistan, and the remaining nine matches being played in Sri Lanka," said the ACC in a statement.

The 2023 edition will feature two groups, with two teams from each group qualifying for the Super Four stage. The top-two teams from the Super Four stage will then face off in the final.

India, Pakistan and Nepal have been bracketed in one group while Sri Lanka, Bangladesh and Afghanistan form the other group.



## Eng ultra-attacking approach faces tough examination against Aus

The highly-successful ultra-L attacking approach adopted by England ever since Ben Stokes and Brendon McCullum took over as captain and head coach in 2022 faces its toughest examination when the muchanticipated Ashes against recently-crowned World Test Championship winners Australia kickstarts at Edgbaston from Friday. During the next six weeks

that promise excitement, thrill and tension in equal measure, England, who have won 11 of 13 matches under Stokes and McCullum, will be put to a relentless Test at home to see if they can retain their style of play which has given them immense success, having not lost a series

One can anticipate that the five-game series will be closer than it was in 2021/22 when Australia thrashed England 4-0 in their home. In England's bat-

ting line-up, they have the zeal and belligerence of Ben Duckett, Zak Crawley, Ollie Pope, Joe Root and captain Stokes himself. The timely return of Jonny Bairstow further boosts the explosive batting line-up.

But England have potential issues in the bowling line-up. All-rounder Moeen Ali has also come out of Test retirement and is confirmed to play as England's frontline spinner after Jack Leach was ruled out due to a lower back stress fracture. With Ali straightaway playing a Test match after two long years, there are doubts over how he will fare, especially with him averaging 65 with the ball against Australia in Tests.

There will be doubts over the fitness of James Anderson and Ollie Robinson, who will be playing Ashes after missing the Test against Ireland due to groin and ankle niggles, while Stokes' ability to bowl due to a nagging left knee issue is also under

cloud. Australia are also mulling their bowling options, with Scott Boland's five wickets in the 2023 World Test Championship Final giving him an edge over an injury-prone Josh Hazlewood, as Mitchell Starc, captain Pat Cummins and Nathan Lyon

give a settled look. With the bat, Australia boasts of top three Test batters in Marnus Labuschagne, Steve Smith, and Travis Head, though their opening pair of David Warner and Usman Khawaja needs to step up as well.

In the current cricketing era where franchise T20 leagues are mushrooming faster than the speed of light, the Ashes has always ensured that cricket fans get their share of excitement and fast-paced action from Test cricket. This time around, public imagination will be captured yet again when England's exhilarating approach will face off against the dominant mindset of Australians
