

Heatwave in 3 States claims over 100 lives

With temp at 40+ degrees, UP saw 54 deaths, eastern Bihar reported 44 fatalities

The scorching heatwave sweeping across Uttar Pradesh (UP), Bihar, and Odisha has claimed around 100 lives over the past three days. As temperatures soared above 40 degrees Celsius in multiple regions, northern UP recorded 54 deaths, while eastern Bihar reported 44 fatalities.

The Ballia district hospital has been hit particularly hard, with the death toll reaching 54 due to heat-related incidents, including an additional 20 fatalities reported in the last 24 hours. Meteorological officials have issued a yellow alert for intense heatwave conditions in parts of UP, raising concerns about the well-being of the population.

Dr SK Yadav, the Medical incharge, revealed that over the past three days, approximately 300 people have been admitted to the district hospital for various ailments, with 54 people succumbing to the severe heat con-

ditions. The high number of deaths in Ballia has prompted the UP Government to initiate an investigation, leading to the transfer of Chief Medical Superintendent Diwakar Singh. "We have ordered a probe to

determine how so many people died within a short span of time in Ballia. A team of doctors from the health directorate will investigate the cause of these deaths.

> We have an ample stock of medicines, and the Government will ensure proper treatment for patients," stated Brijesh Pathak, the Health Minister.

In response to the crisis, doctors and healthcare workers have had their leave cancelled, and health workers in rural areas are actively engaged in addressing the situation. Additional beds have been made available in the

emergency ward to accommodate the influx of patients. The district hospital administration has established a 15-bed special ward in compliance with the district administration's instructions. Most of the admitted patients are aged 60 and above, exhibiting symptoms such as high fever, vomiting, diarrhea, breathing difficulties, and heart attacks. *Continued on Page 2*

Fear looms over Bengal panchayat elections

Candidates being threatened to force them to withdraw nominations SAUGAR SENGUPTA 📕 KOLKATA

A wave of fear has gripped districts in Bengal ahead of the forthcoming panchayat elections, as Opposition can-didates face intimidating tactics to force them to withdraw their nominations. The alleged Trinamool Congress muscle-men, who failed to prevent Opposition candidates from filing their nominations through force, have resorted to symbolic threats and acts of violence.

With June 20 being the last date for the withdrawal of nominations, Opposition candidates have started receiving ominous messages in the form of white robes, sweets, scented sticks, and white garlands. These items hold symbolic meaning, as white robes or sarees are typically worn by widows. Threatening letters sent to candidates have contained messages like, "See you at the funeral... Advance condolences... Ask your husband to withdraw the nomination. Minati, the wife of a CPI(M) candidate in Nadia district,

One assailant owed money to their brother

In a shocking incident, two sisters were shot dead in Dr Ambedkar Basti located in South Delhi's RK Puram in the early hours of Sunday. The brutal attack was a result of an argument over a loan of Rs 10,000 given by their brother. The critically injured victims,

identified as Jyoti (30) and Pinky (29), tragically lost their lives during treatment at Safdarjung Hospital. Three individuals, named Arjun, Dev and Michael have been arrested in connection with the case, according to the police.

A grainy video captured by local residents shows the terrifying moment of the shooting. Gunshots can be heard amidst a barrage of abuse, while the footage also reveals the gunmen firing their weapons before fleeing the scene. Continued on Page 2

Al tracking social media abuse identifies 300 people from Qatar World Cup posts

Aproject using Artificial Intelligence (AI) to track social media abuse aimed at players at the 2022 World Cup identified more than 300 peo-ple whose details are being given to law enforcement, FIFA said on Sunday.

The people made "abusive, discriminatory, or threatening posts (or) comments" on platforms like Twitter, Instagram, Facebook, TikTok and YouTube, soccer's governing body said in a report detailing efforts to protect players and officials during the tour-nament played in Qatar.

The biggest spike in abuse was during the France-England quarterfinals game, said the final report from a project created jointly by FIFA and the players' global union FIFPRO. It used AI to help identify and

Players and teams were offered moderation software that intercepted more than 2,86,000 abusive comments before they were seen.

The identities of the more than 300 people identified for posting abuse "will be shared with the relevant member asso ciations and jurisdictional law authorities to facilitate realworld action being taken against offenders," FIFA said.

"Discrimination is a criminal act. With the help of this tool, we are identifying the perpetrators and we are reporting them to the authorities so that they are punished for their actions," FIFA President Gianni Infantino said in a statement.

Sonam Wangchuk, a promi-nent engineer whose life inspired a character in the Bollywood blockbuster "3 Idiots", on Sunday began a seven-day hunger strike here in support of his campaign for the protection of the fragile envi-ronment of Ladakh.

Wangchuk's 'climatic fast' -- the second time in the past six months — comes a day ahead of talks between the Ministry of Home Affairs and a six-member joint delegation of Leh-based Apex body and Kargil Democratic Alliance (KDA) who are seeking full statehood, constitutional safeguards under sixth schedule, separate Lok Sabha seats for the two districts and recruitment and job reservation for the youth of Ladakh.

He shared that the emergency ward is receiving five to six patients per hour, and despite concerted efforts, the death toll continues to rise, raising alarm among the public and officials alike.

The scorching heatwave has plunged Ballia into a state of despair, leaving residents fearful of venturing outside. The streets wear a deserted look as people seek refuge from the extreme temperatures. This unprecedented situation has shocked the community, as the district has never witnessed such a high number of heat-related fatalities. "I have never seen people dying in such large numbers due to the heat," lamented a concerned resident.

Ballia, along with central and eastern UP, continues to grapple with oppressive heat. On Sunday, the district experi-

enced a maximum temperature of 43 degrees Celsius, surpassing the normal range by five degrees. With a relative humidity of 25 per cent, the impact of the heat



As panic ensues, one woman can be seen lying on the ground.

According to the police, a group of 15 to 20 armed men arrived at Ambedkar Basti in RK Puram, Southwest Delhi, around 4 AM. They knocked on a door and pelted it with bricks. Despite their continuous attempts, when nobody opened the door, they eventually left. However, the attackers returned when the homeowner Lalit, who they were seeking, stepped out of the house with his two sisters to inquire about the incident. They opened fire suddenly, resulting in the tragic deaths of the sisters. Lalit was also grazed by a bullet but managed to escape. He informed the police that he had a financial dispute with a local individual named Dev.

Manoj C, the Deputy Commissioner of Police (South-West), stated that the police received a distress call at 4:40 AM from the RK Puram police station, reporting the shooting of the caller's sisters. Preliminary investigations revealed that the assailants targeted Lalit, the victims' brother, due to a monetary dispute. The prime accused and his two associates were arrested in connection with the incident," he added.

The incident has sparked a political controversy in the national Capital. Delhi Chief Minister Arvind Kejriwal took a swipe at Lieutenant-Governor (L-G) VK Saxena, asserting that Delhi would have been the safest place if the law and order situation were under the

jurisdiction of the Aam Aadmi Party (AAP) instead of the L-G. Kejriwal expressed condolences to the victims' families and criticised the handling of the law and order situation. His comments drew a sharp response from Delhi BJP leaders, including Union Minister Meenakshi Lekhi, who claimed that Kejriwal lacks understanding of the law.

According to the family, the attack followed a heated argument between Lalit, their brother, and individuals who had borrowed money from him. Lalit had demanded the return of the loan, leading to the altercation. Later that night, the borrowers arrived at the house with the intention of harming Lalit, but the sisters intervened and were tragically shot instead.

Hours after two sisters were shot dead in South West Delhi's RK Puram area early on Sunday over Rs10,000 owed to their brother by the assailants, Chief Minister Arvind Kejriwal flayed the BJP and the Centre over the "poor" law and order situation in the national Capital and said Delhi would have been safer if law and order was "under the AAP Government instead of LG."

His comments, however, drew a sharp reaction from Delhi BJP leaders including Union Minister Meenakashi Lekhi, who claimed that Kejriwal does not understand the law.


Pradesh have experienced daily power outages in the ongoing month of June. The findings are based on responses from over 14,000 respondents located in 56 of the 75 districts of the state. As many as 100 people have died due to extreme heat in Uttar Pradesh and Bihar in the last three days. While 54 people have died in Uttar Pradesh, 44 people have lost their lives due to the extremely hot weather in Bihar.

According to the survey, 94 per cent of households in Úttar Pradesh surveyed say they have been facing power outages daily in June. Also, 65 per cent of those surveyed in Uttar Pradesh are facing power outages three or more times on average every day, it claimed.

Overall in Uttar Pradesh, six per cent of the respondents stated that they have no knowledge as "we have 24X7 power backup", the survey found.

In Gautam Buddh Nagar district (Noida), 86 per cent of households surveyed confirmed experiencing daily power out-ages this month, with 35 per cent of them saying the outages last more than two hours, according to the survey.

On average, 43 per cent said they experienced power outages at their homes once or twice a outages.

points... personal points I just shrug it. When 'I' gets pushed, and that I is not me, but 'India'... That sense that you are not given respect and people are condescending, some times ambush you," Jaishankar added. Earlier, he had accused the

United Kingdom(UK) of not meeting the obligation of providing security to the diplomats of the Mission, which is expected of a country where a high commission or a consulate is located.

"On the flag and the security of the high commission, in this particular case in the UK whenever any country sends an embassy anywhere abroad, it is the obligation of the receiving country to provide security for a diplomat to do his work.

It is the obligation of the receiving country to ensure the embassy or the high commission or the consulate and their premises are respected. These obligations were not met," Jaishankar said at an event organised by Bengaluru South MP Tejasvi Surva.

There's bad news for HIV **I** patients. Researchers have revealed that although current therapies such as current antiretroviral therapy (ART) can successfully block the HIV virus from replicating further, the pathogen can lie dormant in the brain.

"Discontinuation of treatment can reignite the progression of infection to AIDS," as per a study published in the Clinical Ìournal of Investigations.

As a part of its life cycle, the human immunodeficiency virus-1 (HIV) inserts a copy of its DNA into human immune cells. Some of these newlyinfected immune cells can then transition into a dormant, latent state for a long period of time, which is referred to as



Investigations, confirms that microglial cells, which are specialised immune cells with a decade-long lifespan in the brain, can serve as a stable viral reservoir for latent HIV.


'We now know that microglial cells serve as a per-sistent brain reservoir," said first author Yuyang Tang, Assistant Professor of Medicine in the Division of Infectious Diseases and member of the University of North Carolina HIV Cure Center.

IIT Advanced Results Announced: **IIT** Hyderabad Zone Dominates

The results of the highly anticipated IIT Advanced exam were announced on Sunday, opening doors for successful candidates to secure coveted spots in the 23 prestigious Indian Institutes of Technology (IITs) across the country.

According to the results, the maximum number of candidates have qualified from the IIT Hyderabad zone, followed by the IIT Delhi zone and the IIT Bombay zone. Among the top 500 candidates, 174 belong to the IIT Hyderabad zone, while 120 and 103 candidates hail from the IIT Delhi zone and IIT Bombay zone, respectively.

Vavilala Chidvilas Reddy from the Hyderabad zone clinched the top rank in the JEE-Advanced, the entrance exam for IITs. IIT Guwahati, the conducting authority of this year's JEE-Advanced, reported that Reddy secured an impressive score of 341 out of 360 marks. Nayakanti Naga Bhavya Sree, also from the IIT Hyderabad zone, emerged as the top female candidate with a score of 298 marks.



Remarkably, six out of the top 10 rank holders are from the IIT Hyderabad zone. The second rank was secured by Ramesh Surya Theja from the Chemistry Hyderabad zone, followed by Rishi Kalra from the Roorkee

zone. Raghav Goyal (Roorkee), Addagada Venkata Sivaram (Hyderabad), Prabhav Khandelwal (Delhi), Bikkina Chowdhary Abhinav (Hyderabad), Malay Kedia (Delhi), Nagireddy Balaaji Reddy (Hyderabad), and Yankanti Pani Venkata Maneedhar Reddy (Hyderabad) achieved subse-

quent ranks. In addition to the Indian candidates, 13 foreign candidates and 155 Overseas Citizens of India (OCI) have also qualified the exam. The rank list criteria, as explained

by a senior official from IIT Guwahati, takes into account the aggregate marks obtained in Mathematics, Physics, and

Candidates must meet both subject-wise and aggregate qualifying marks to be included in the rank list.

This year, the exam featured a lower percentage of negative marking, with more questions without penalties. These changes instilled confidence in the students, resulting in a higher cutoff, explained the official

A total of 1,80,372 candidates appeared for both papers in the IIT-JEE Advanced, of which 43,773 candidates successfully qualified. Out of the qualifiers, 36,204 were male students, while 7,509 were female students.

ess than a month after he Less than a month and was expelled from the Congress, former MLA Ashish Deshmukh on Sunday rejoined the BJP ahead of the next year's Lok Sabha and Maharashtra Assembly elections. Deshmukh was inducted back into the Bharatiya Janata Party (BJP) in Nagpur in the presence of Maharashtra Deputy Chief Minister and senior party leader Devendra Fadnavis and the party's State unit president Chandrashekhar Bawankule.

Ahead of the 2014 state Assembly elections, Deshmukh had joined the BJP. He contested that election and won from the Katol Assembly seat in Nagpur district, defeating his uncle and Nationalist Congress Party (NCP) nominee Anil Deshmukh.

However, he resigned from the BJP in 2018 following differences with the party leadership and later joined the Congress. He was the Congress nominee against BJP's Devendra Fadnavis from Nagpur South West seat in the 2019 Assembly polls.

The Congress last month expelled Deshmukh over his public statements against the party leadership. He had said Congress leader Rahul Gandhi should apologise to the OBC community over his "Modi surname" remarks.



Think rationally

The 'rationalisation' of NCERT books has sparked a heated debate about its very rationale

he NCERT's exercise to rationalise its text books has led to the deletion of references including passages on the theory of evolution, references to the Cold War, the Mughal courts, and industrial revolution, the 2002 Gujarat riots, the contribution of agriculture to the Indian economy, and a section on challenges to democracy. The changes were made during a syllabus rationalisation exercise carried out by the council to reduce the burden on students given the Covid-19 pandemic. For the record, the pandemic is officially over. Now, Yogendra Yadav and Suhas Palshikar, whose names were mentioned in the NCERT textbooks of political science as chief advisors, have urged NCERT to drop their names as they feel textbooks have been "mutilated beyond recognition". Taking a cue from the duo, 33 more academics have asked the NCERT to take their names off the revised textbooks. Meanwhile, more than 100 academicians have alleged that their counterparts who wanted their names



to be dropped from the textbooks were trying to capture media attention, and seem to have forgotten that textbooks are an outcome of collective intellectual engagement. They maintain that the school curricu-

lum has not been updated for nearly two decades. In recent years, concerns have been raised regarding the BJP and the Rashtriya Swayamsevak Sangh (RSS) attempting to rewrite the history and curriculum of India. The RSS has been accused of pursuing a revisionist agenda aimed at shaping the narrative of India's past and moulding the education system to align with their ideological views. Allegedly, they have sought to modify textbooks to

present a version of history that emphasises Hindu nationalist perspectives and downplaying the contributions of minority communities. This has led to heated debates, as many argue that such revisions undermine academic integrity and promote a narrow understanding of the country's diverse history. The BJP and RSS advocate for a concept known as "cultural nationalism," which seeks to promote a homogenous understanding of Indian culture based on Hindu traditions and values. This emphasis on cultural nationalism is distorting the inclusive and pluralistic fabric of India's society. They have attempted to reinterpret certain historical events and figures to fit their ideological framework. This includes attempts to rewrite the narrative surrounding India's independence movement, downplay the role of certain freedom fighters, and selectively highlight aspects that align with their ideological agenda. Critics argue that this revisionism undermines the nuanced understanding of history and hinders the development of critical thinking skills among students. The curriculum changes have raised serious concerns about the politicisation of education and the distortion of historical narratives. It is crucial to have an inclusive education and and a nuanced understanding of the past to have a vibrant democracy.



When 'Sulekha' inked freedom



The legacy of the 'Swadeshi Fountain Pen' and 'Sulekha Ink' lives on. We owe so much to the courage and resilience of our freedom fighters

ecently on June 14 a tweet by Damayanti Datta on Satish Chandra Dasgupta the scientist and inventor of the 'Swadeshi Fountain Pen Ink' - which was later named "Sulekha" by Gurudev Rabindranath Tagore – caught my attention. In the tweet, Damayanti pointed to June 14, 1932, when Mahatma Gandhi had requested Dasgupta to create a 'Swadeshi Fountain Pen' ink. This ink went on to become part of our childhood and school days too. Chelpark was a much later - but popular - edition to this brigade.

The concept of a portable writing instrument with an ink reservoir can be traced back to ancient times. However, it was not until the 19th century that the fountain pen, as we know it today, started to take shape. Initially, fountain pens were imported from Europe and used primarily by the British ruling class in India. However, as the nationalist movement gained momentum, Indians began to question their dependence on foreign goods and sought to devel-

op indigenous alternatives. Mahatma Gandhi recognized and gave a clarion call to the Indians - the importance of selfreliance in challenging British domination. He advocated for the use of indigenous products and actively discouraged the use of imported goods. In this case, the use of fountain pens - being an integral part of education and communication - was seen as a symbol of this dependence on foreign powers. Gandhi's persuasive words inspired many individuals, including Satish Chandra Dasgupta, to take up the cause of manufacturing indigenous fountain pens.

In response to Gandhi's call for self-reliance, Dasgupta established a manufacturing unit in Calcutta in the 1920s, aiming to produce pens that would rival their foreign counterparts. He assembled a team of skilled artisans and engineers and began experimenting with various

Is opposition to GM crops emotional?

griculture and human civilization have Levolved side by side. Early reports of farming can be seen during the predynastic period around 5000-3000 BCE. Archaeological evidence from the Indus Valley civilization points to agriculture during 2,500 BCE. During the passing of the period from predynastic to the present era we could see a lot of changes in human civilization. The cultivation practice that we have been following is also evolving. People have been cultivating crops for thousands of years, transporting them to new regions of the planet, and modifying them to fit their requirements at every stage

of the process. The discovery of laws of inheritance by Gregor Medel in the 1800s made hybridization a popular tool in crop improvement, where we cross-bred various varieties of the same species. With the discovery of the structure of DNA in 1953 and subsequent developments in molecular biology scientists have started applying various molecular tools in plant breeding. In the 1980s, sci-



entists also developed techniques for engineering novel features by mixing and matching DNA from various plant and animal species through genetic engineering, popularly known as transgenic or genetically modified organisms (GMOs).

Throughout our history, we can see that we have modified our crop plants using the latest available scientific knowledge during the time. It's important to note that while there is opposition to GM crops, there are also proponents who highlight potential benefits such as increased crop yield, reduced pesticide use,

and enhanced nutritional content Some of the concerns raised by the public may be worth debating. But all these concerns are relevant to traditional breeding also. Since

for such a long time, nearly all crops grown today have been genetically improved, whether through domestication, selective breeding, hybridization, radiation or chemicals, or changes made directly to plant genes by

humans. When we implemented the green revolution in the country, along with food security, it also led to the depletion of many of our indigenous varieties and species of plants and also led to pollution through the large-scale use of fertilizers and pesticides. It also threatened the existence of many

microbes and animal species. This practice is still being

followed by our agriculture community. Still none of the so-called 'activists' opposed the unhealthy practice being followed. Then why is this stiff opposition to GM plants, when GM plants and products are already in our ecosystem and even in our bodies, that have entered indirectly through adulterat-

ed products? It's worth noting that

the scientific consensus supports the safety and potenpeople have been farming tial benefits of GM crops.

Food is needed for human survival and with diminishing agricultural lands we cannot rely solely on traditional breeding or indigenous varieties.

Of course, government agencies need to take steps to effectively conserve the gene pool of our traditional varieties. We need to prevent the cultivation of not only GM crops but also domesticated or hybrid varieties. In this way, we can conserve our gene pool for the future.

Blindly opposing the fruits of modern science like genetic engineering or recombinant engineering will harm even the survival of the human race on this planet.

Of course, instead of bringing GM under the monopoly of corporate companies, the government should promote GM cultivation through its agencies like KVKs or through agriculture departments. This will help in gaining public confidence in accepting this novel technology.

For instance, from 1993 to 2010 humans pumped 2150 gigatonnes of groundwater equivalent to more than 6 millimetres of sea level rise. Groundwater depletion is a universal phenomenon. It can be slowed down only when sustained and dedicated efforts are made for decades.

In the alternative as advised by Dr. Ambedkar in the constituent assembly; the uniform Civil Code may be enacted with a proviso that it will only apply to those who agree to be controlled by it. It would be feasible for the government as well to maintain fraternity and tranquillity if the uniform Civil Code accommodates the freedom of choice as it was done in the case of the Special Marriages Act 1954. Uniformity must not be confused with unity that happens only with inclusiveness and not by imposing something on a community against their will.

The Income Tax Department has successfully used technology to reach out to the assesses in non-intrusive ways

major factor that has helped the Modi – government keep up the tempo of investment in building infrastructure and other development activities and continues with welfare schemes in desired measure without causing any slippage in fiscal deficit target has to do with a steep rise in tax collection.

The gross tax revenue (GTR) - including total direct tax collection, proceeds from Goods and Services Tax or GST, customs and excise duty - net of refunds - surged from around Rs 21,11,000 crore during the financial year (FY) 2019-20 to Rs 30,50,000 crore during 2022-23 - an increase of about 50 per cent. Even as GTR during 2020-21 lan-guished at around Rs 22,17,000 crore (courtesy of Corona pandemic), a major boost came during 2021-22 and 2022-23. Unlike in the past when invariably, the revised estimate (RE) or the actual number for the relevant year would fall short of the budget estimate (BE), in these two years, the position reversed with the RE/actual exceeding the BE that too by a substantial margin.

During 2021-22, the RE of GTR at Rs 25,20,000 crore (RE includes actual for the 10 months up to January 31, 2022 and estimate for the remaining two months of the FY i.e. February and March; it is mentioned in the budget for the following year i.e. 2022-23 present-ed by the Union Government on February 1, 2022) was Rs 300,000 crore higher than the BE of Rs 22,20,000 crore. The 'actual' albeit for all 12 months of the FY at Rs 27,10,000 crore turned out to be even higher than the RE of Rs 1,90,000 crore.

Thus, the actual GTR during 2021-22 was a whopping Rs 490,000 crore higher than the BE. For 2022-23, the finance minister, Nirmala Sitharaman had set a target (read: BE) for GTR at Rs 27,60,000 crore. Against this, the RE (as given in the budget for 2023-24 presented on February 1, 2023) at Rs 30,40,000 crore was Rs 280,000 crore higher. The 'actual' at Rs 30,50,000 crore was even higher than the RE by Rs 10,000 crore. When compared to the BE, the actual was higher by a huge Rs 290,000 crore. In May 2022, the government

announced a cut in central excise duty (CED) on petrol and diesel to give relief to consumers from the high prices of these fuels resulting in a revenue loss of about Rs 90,000 crore. But, for this, actual GTR during 2022-23 would have been even higher at Rs 31,40,000 crore exceeding the BE by Rs 380,000 crore. The reason for this spectacular performance is primarily two-fold. First, during 2021-22, nominal GDP (taxes being levied as a percentage of the value of income-generating activities in different sectors that make up the GDP, and their collection increases in tandem with it) grew by 18.4 per cent which was 4 per cent higher than 14.4 per cent growth assumed at the time of arriving at the BE. Likewise, during 2022-23, nominal GDP grew by 15.9 per cent which was 5.6 per cent higher than the 10.3 per cent growth assumed in the budget. The other factor has to do with the tax-GDP ratio. For any given level of nominal GDP, if this ratio is higher, that would lead to higher tax collection.

of 10.7 percent. If one were to apply this ratio to the actual nominal GDP value for 2022-23 (around Rs 27200,000 crore), GTR would come to Rs 2910,000 crore. Against this, the actual GTR was Rs 30,50,000 crore. Divide this by actual nominal GDP, we get the tax-GDP ratio of 11.2 per cent which is higher than what was assumed in the budget. Likewise, the actual tax-GDP ratio during 2021-22 was 11.5 per cent against 9.9 per cent assumed in the budget. In short, the unprecedented surge in tax collection isn't just due to an increase in economic activity as manifested in higher growth of GDP but

the process policy-driven, ease of doing business, simplification of rules, speeding up clearances, cutting bureaucratic red tape, use of technology in delivering services, sector-specific policy reforms, boost to start-ups and MSMEs (micro small and medium enterprises), measures to attract foreign investment and so on.

On the taxation front, major reforms measures include a steep reduction in corporate income tax (CIT) rate to 15 per cent for new manufacturing enterprises and to 22 per cent for existing firms; a reduction in the personal income tax (PIT) with emphasis on doing away with exemp tions and deductions; abolition of dividend distribution tax (DDT). As for indirect taxes, the Goods and Services Tax (GST) regime has been rationalized and restructured from time to time with a focus on reducing the tax burden and ease of doing business. While these have combined to give a push to GDP, relentless efforts have been made by the tax authorities - in both direct and indirect taxation - to ensure

refund of tax paid by a supplier on purchase of inputs) claims.

These measures ensure that businesses at all levels in the supply chain are under the department's gaze on a real-time basis enabling timely action. During 2022-23, the Directorate General of GST Intelligence (DGGI) detected GST evasion of over Rs 100,000 crore. The efforts continue at a vigorous pace as may be seen from a recent nationwide crackdown by the GST authorities which has resulted in the detection of tax evasion of Rs 30,000 crore. As a result, the indirect tax to GDP ratio has gone up from 4.7 per cent during 2019-20 5.2 per cent during 2022-23 On the direct tax front, the Income Tax department has successfully used technology to reach out to the assesses in non-intrusive ways; for instance, by sending e-mail reminding them to file a return if not already or generating an 'auto-populated' form a form in which income of the assesses from various sources is pre-filled. In particular, intensive and extensive use of 'data analytics' and 'artificial intelligence' has prompted assesses to report their income accurately thereby avoiding short payment. As a result, the direct tax to GDP ratio increased from 5.3 per cent during 2019-20 to 6 per cent during 2022-23. This being higher than the indirect tax to GDP ratio of 5.2 per cent shows that the government is moving towards a more progressive taxation structure.

ental health is often stigmatized, and many people are reluctant to speak up about their mental distress due to the fear of judgment and shame. On 6th June, Shahid Kapoor in an interview with 'Humans of Bombay' said, "living a slightly schizophrenic reality until I met my wife." One can only imagine how problematic that statement is on its own. The colloquial use of mental illness to explain one's life events further reinforces the stigma already strongly associated with mental health in a country like ours.

According to the National Institutes of Health, 2021, the stigma attached to mental health reduces the chances of someone reaching out for

ments mitigate the severity of a matter of lifestyle', 'experiencing mental health problems as a unique story, and 'mental illness as socially situated

Language is a very important tool in shaping and upholding our thoughts and ideas. When discussing mental health the need for responsible language is highlighted frequently in several studies. Derogatory terms and casu-al language regarding mental health can increase discrimination against individuals with mental illnesses (Clement et al., 2015). The colloquial use of terms like "OCD", Bipolar", "Anxiety" or "Depression" tends to associate negative behaviour rather than clinical definitions. This leads to a biased gerous', 'mental wellbeing as perception of when individ-

uals receive diagnoses related to these disorders.

It is funny to see how depression is referred to as the "common cold" of mental disorders. Only if people truly cared to understand the life-threatening effect of depression, would it do all of us some good. In India, Bollywood has a significant impact on people. People are always awed by the luxurious lifestyles of the celebrities. Netherland and Coliver (2018) explored through a study the effects of stars disclosing their mental health struggles and journey on public attitudes and concluded that such disclosures reduce stigma and encourage help-seeking behaviour.

Blinken holds talks with China FM

On a mission to cool soar-ing bilateral tensions, US Secretary of State Antony Blinken on Sunday held extensive talks with his Chinese counterpart Qin Gang on a range of issues, including the Taiwan issue and the Ukraine war. Blinken arrived here this morning and held an extended round of talks with Qin, besides attending a state dinner.

Blinken's two-day visit to Beijing comes ahead of Prime Minister Narendra Modi's state visit to Washington and his meeting with US President Joe Biden on June 22.

The talks are expected to include deepening defence cooperation and firming up the Quad alliance of the US, India, Australia and Japan, which China alleges is aimed at containing it.



Rifering high numbers of military casualties as Ukraine fights to dislodge the Kremlin's forces from occupied areas in the early stages of its counteroffensive, British officials said Sunday. Russian losses are probably at their highest level since the peak of the battle for Bakhmut in March, UK military officials said in their regular assessment.

According to British intelligence, the most intense fighting has centred on the southeastern Zaporizhzhia province, around Bakhmut and further west in Ukraine's eastern

Donetsk province. While the update reported that Ukraine was on the offensive in these areas and had "made small advances," it said that Russian forces were conducting "relatively effective defensive operations" in Ukraine's south.

The Ukrainian military said in a regular update on Sunday morning that over the previous 24 hours Russia had carried out 43 airstrikes, four

Early June disruptions to Outlook were cyberattacks: MS

In early June, sporadic but serious service disruptions plagued Microsoft's flagship office suite - including the Outlook email and OneDrive file-sharing apps — and cloud computing platform. A shad-owy hacktivist group claimed responsibility, saying it flood-ed the sites with junk traffic in distributed denial-of-service attacks.

Initially reticent to name the cause, Microsoft has now disclosed that DDoS attacks by the murky upstart were indeed to blame.

But the software giant has offered few details - and did not immediately comment on how many customers were affected and whether the impact was global. A spokeswoman confirmed that the group that calls itself Anonymous Sudan was behind

In October, some US airport sites were hit. Analyst Alexander Leslie of the cybersecurity firm Recorded

Pakistan Senate passes Bill to Punjab anti-graft body limit disqualification period

Opp says attempt to ensure Nawaz Sharif's participation in polls

PTI ISLAMABAD

Pakistan's Senate has passed a bill to ensure no parlia-mentarian is disqualified for a lifetime, a move termed by the Opposition as an attempt to clear the way for former premier Nawaz Sharif's return to the country and his participa-

tion in the upcoming elections. Nawaz Sharif was disqualified in 2017 by a five-member bench of the Supreme Court. In 2018, he became ineligible to hold public office for life

after a Supreme Court verdict. The 73-year-old former premier has been living in London since November 2019 for medical treatment after a Pakistani court allowed him a four-week reprieve. Nawaz Sharif, who has

served as the prime minister of Pakistan for three non-consecutive terms, was serving sevenyear imprisonment in the Kot Lakhpat Jail in Lahore in the Al-Azizia corruption case before he left for London.

The Senate on Friday passed the bill seeking to limit the disqualification of lawmakers to five years with ret-rospective effect, the Dawn newspaper reported.

The move comes a day after Pakistan Prime Minister Shehbaz Sharif urged his elder brother Nawaz Sharif, the PML-N supremo, to return from London and lead the poll campaign of the party in the general election and become the premier of the nation for a record fourth time.

A copy of the bill presented in the Senate on Friday included an amendment to Section 232 (Qualifications and Disqualifications) of the

Election Act, 2017.

The amendments say that a person's eligibility to become a member of parliament will be decided according to the crite-ria set under Articles 62 and 63 of the Constitution.

The amendment added that the procedure, manner and duration of disqualifications and qualifications should be as specifically provided for in relevant provisions of Articles 63 and 64 of the Constitution.

Where no such procedure, manner or duration has been provided for therein, the provisions of this Act shall apply," it added. Any person disqualified through a court decision will be disqualified for a maximum of 5 years starting from the day the verdict is announced. Disqualification under Article $62(\hat{1})(f)$ will not extend beyond five years.

Senate also passed amendments giving the right of announcing the date of elec-tion to the Election Commission of Pakistan.

The Opposition termed it "person-specific legislation" and an attempt to ensure Nawaz Sharif's participation in the upcoming elections.

The earlier two attempts by the PML-N-led coalition govt to reverse the lifetime disqualification of a person have failed.

The Supreme Court is hearing two legislations, including "The Supreme Court Review of Judgments and Orders Bill 2023" and the law to limit the Chief Justice's powers. These legislations were also termed as an attempt to reverse Nawaz Sharif's life-

At least two killed, 26 missing in Nepal floods, landslides



Kathmandu (PTI): At least two people were killed and 26 others went missing as floods and landslides triggered by monsoon rains wreaked havoo in eastern Nepal, officials said on Sunday. A man was found dead and 21 others working at the under-construction Super Hewa Hydropower Project in Chainpur Municipality-4 have gone missing, the Kathmandu Post newspaper quoted police officials as saying.

Deputy Superintendent of Police Birendra Godar said it is yet to be ascertained whether the workers moved to a safer location following the flood or were swept away by Hewa River, the report said. In the neighbouring Panchthar dis-trict, a 9-year-old girl died after her house was swept away in a landslide. Five villagers of Chainpur have also gone missing after flooding in the area, police said. Preliminary investigation suggests the flood occurred after landslides at Chainpur Municipality-4 and Panchkhapan Municipality-9 blocked the river, the report added. Weather forecasters have warned heavy rains would continue in Nepal in the coming days, and issued alerts over rising water levels in rivers. Nepal is at the beginning of its monsoon season, which typically begins in June and ends in October.

Will move ahead on judicial overhaul plan after talks crumble: Israeli PM

Tel Aviv (AP): Israeli Prime Minister Benjamin Netanyahu said Sunday his government intends to move ahead on contentious plans to change the country's judicial system after talks aimed at finding a compromise solution appeared to

be crumbling. The government's plans to overhaul the judiciary plunged Israel into one of its worst domestic crises ever earlier this year. Negotiations between the government and opposition parties somewhat alleviated the crisis with attempts to find a middle ground over proposed changes to the country's justice system. Those talks were jolted last week over a crisis surrounding the powerful

regular committee responsible for picking the country's judges. Opposition leaders said negotiations were frozen until the committee is formed.

At a meeting of his Cabinet on Sunday, Netanyahu said the opposition wasn't negotiating seriously and that his gov-

ernment would move ahead cautiously on the overhaul. "We will begin, this week, practical steps. We will do them in a measured way, responsibly, but in accordance with the mandate we received make corrections to to the justice system," he said. Netanyahu put the overhaul on hold in March after mass protests erupted in opposition

Minister Benjamin Netanyahu said on Sunday that he opposes any interim agreement reportedly being negotiated between the US and Iran over its nuclear programme.

relentless wave of violent Acrime within Israel's Palestinian minority is turning cities and towns into bloody battlefields, exasperating a community feeling increasingly forsaken by Israeli authorities. Anger over the mounting insecurity is directed at Israel's government and its ultranationalist minister in charge of police, Itamar Ben-Gvir, Critics say that with his history of anti-Arab rhetoric, he cannot be trusted to combat the rising scourge.

The skyrocketing violence lays bare the deep inequities in Israeli society, with Arabs facing years of discrimination that activists say laid the groundwork for the unabating bloodshed.

More than 100 people have

been killed in violent crime in Arab communities this year, nearly three times higher than at the same time last year, according to the Abraham Initiatives, a group that promotes Jewish-Arab coexistence and safe communities.

It also is more than three times the murder rate in the majority Jewish sector, according to official figures, despite Arabs making up just a fifth of the country's population of 9.7

million Authorities say they are trying their best. But activists see a direct link between the soaring figures and Prime Minister Benjamin Netanyahu's government.

The coalition, which includes ultranationalist factions with anti-Arab hues, took

office in late December.

The head of one of those parties, Jewish Power's Ben-Gvir, has made racist remarks and before entering politics was convicted of incitement to violence and support for a Jewish terror group.

As national security minister, he now oversees the country's police force.

Will a person who is busy making racist comments against Arabs protect them," said Thabet Abu Rass, codirector of the Abraham Initiatives. "We are citizens of this country. We deserve to feel secure like anyone else in this country. And that is his responsibility.

Official: EPR for circular economy in discussion to incentivise recycling

To promote a circular econ-omy and reduce waste, the Indian government is discussing the use of policy instruments like Extended Producer Responsibility (EPR) to incentivise recycling, a senior mines ministry official said. Under the Sustainable

Development Goals (SDG) 2030 initiative, the Ministry of Mines and the Ministry of Steel have issued recycling frameworks aimed at developing the recycling sector using advanced technology to achieve resource efficiency and carbon neutrality.

"The government has issued recycling frameworks intended to develop the recycling sector using advanced technology to achieve resource efficiency and carbon neutrality. Further policy instruments like EPR are under discussion stage, which will incentivize recycling in the country," Joint Secretary,

(MRAI), has urged the government to review the 18 per cent

GST on metal scrap and reduce it to 5 per cent to promote a circular economy and ecosystem. Shah further highlighted that to achieve a target of 300 million tons of steel production by 2030, the government must implement lucrative policies to promote investment in the recycling sector. Scrap or recycled steel makes up 22 per cent of India's steel production.

Satwik, Chirag clinch historic doubles title

India's dynamic duo of Satwiksairaj Rankireddy and Chirag Shetty scripted history by winning the men's doubles title at the Indonesia Open here on Sunday, becoming the first pair from the country to claim a Super 1000 event.

The Indians outwitted the Malaysian world champion duo of Aaron Chia and Soh Wooi Yik 21-17, 21-18 in an intense contest that lasted 43 minutes.

"We had prepared very well for this event. We knew the crowd will be supporting us. They have supported us all week. This has been amazing week for us. We played amazing badminton today. We didn't have good head-to-head record against them, so wanted to play one point at a time and it fetched the result for us," said Satwiksairaj after the match.

Satwiksairaj and Chirag gained initiative midway through the first game and they never really gave a sniff to their fancied opponents since then.

In the second game as well, the Indian pair did not allow their opponents to break free and a four-point streak kept them ahead of the curve.

The Indians seemed to be in for a facile victory when the Malaysians nullified four match points to come within sniffing distance of their opponents. However, Satwiksairaj and



Chirag, the world No. 6 pair, who won a gold medal at the Birmingham Commonwealth Games and bronze at the world championships last year, could not be denied when the score read 20-18 in their favour, and this time they converted the match point to script a magnificent win.

The magnitude of the result can be gauged from the fact that this was the first time Satwiksairaj and Chirag are beating Aaron and Soh in 11 attempts.

In fact, the triumph of Satwiksairaj and Chirag in the Indonesia Open is quite unparalleled as they are the first doubles Indian doubles pair to land the title while Saina Nehwal (2010, 2012) and Kidambi Srikanth (2017) had earlier bagged the singles crown in Jakarta.

The Indian pair is the first doubles team from the country to clinch a Super 1000 title while they also stand as the first ones to win the set of S100, S300, \$500, \$750 and \$1000 events from the country.

Earlier, the 2022 world championships bronze medallists had become the first ever Indian pair to reach the final of any Super 1000 tournament after a sensational comeback to get the better of the Korean combination of Kang Min Hyuk and Seo Seung Jae 17-21, 21-19 21-18 in a thrilling semi-final.

The Indians, who were also Asian champions, defeated the current world champions in less than an hour.

Chirag was outstanding at the net with his speedy interceptions and defence, and was one of the main reasons behind the Indian pair pulling off the match



Italy seal Nations League bronze against Netherlands

Ttaly sealed a third-place fin-Lish in the Nations League finals on Sunday, with a 3-2 win over disappointed hosts the Netherlands.

Ronald Koeman's Dutch side started the week determined to win their first trophy since 1988's European Championship but they fell short on home territory in both matches, losing the semi-final against Croatia on Wednesday.

Federico Dimarco and Davide Frattesi struck first half goals for Euro 2020 winners Italy in Enschede as the Netherlands started slowly.

Steven Bergwijn pulled one back with 20 minutes remaining but Juventus forward Federico Chiesa quickly restored Italy's advantage to ensure they would take bronze, despite Georginio Wijnaldum pulling another goal back. Koeman has now lost three

of his four games since being reappointed Netherlands coach in January.

Inter Milan defender Dimarco sent a searing strike into the top corner after

Giacomo Raspadori teed him up neatly in the sixth minute. Neither player started in the semi-final defeat by Spain

on Thursday, as Italy coach Roberto Mancini made several changes and returned to his favoured 4-3-3 formation.

It paid off, with Italy netting the second through Frattesi, one of only four who also faced La Roja from the outset.


