Wearing a customised white yoga T-shirt, Prime Minister Narendra Modi took centre stage on Wednesday as he led the 9th International Day of Yoga celebrations at the United Nations headquarters in New York. Joined by the resi dents of the city, celebrities, and dignitaries, Modi hailed yoga as a practice that transcends boundaries and emphasised its universal appeal, free from copyrights and royalties.

The event created a vibrant atmosphere around the UN headquarters, with a gentle breeze and mild sunlight adding to the historic occasion. Commencing with the chanting of "Om", the participants engaged in yoga asanas and breathing exercises, guided by skilled instructors. Volunteers were on hand to assist yoga enthusiasts in maintaining correct postures and following the instructor's cues.

The UN lawn was trans formed into a sea of yellow yoga mats, while LED screens showcased captivating videos depicting the rich cultural heritage of India. Prior to the session, Modi paid tribute to Mahatma Gandhi, with a bust of the revered leader installed in the North Lawn during

India's tenure as president of the UN Security Council. The yoga celebration led by Prime Minister Modi at the UN headquarters created the Guinness World Record for participation of people from

In a strong response to China's move to block a United Nations proposal to designate Pakistan-based Lashkar-e-Taiba (LeT) leader Sajid Mir as a "global terrorist," India has expressed its disappointment, stating that it demonstrates a lack of genuine political will to combat terrorism. Mir is wanted for his involvement in the 2008 Mumbai terror attack.

China's decision to block the proposal, co-designated by India and moved by the United States, came as a setback on Tuesday. The proposal aimed to blacklist Mir under the 1267 Al Qaeda Sanctions Committee of the UN Security Council, subjecting him to asset freezes, travel bans, and an arms embargo. China had previous-ly paused the proposal in September.

In a strongly-worded state-ment, Prakash Gupta, joint secretary at India's permanent mission in New York, criticised the failure to ban terrorists due to "petty geopolitical interests," suggesting a lack of gen-uine political will to address the terrorism challenge.

Gupta emphasised the need to avoid double standards and the justifications of "good terrorists versus bad terrorists," emphasising that terrorism is terrorism without any justifications. He ques-

Referring to the 2008 Mumbai terror attacks, Gupta highlighted their impact on the global counterterrorism architecture and the collective con-science of the world's largest democracy. He played an audio clip of Mir instructing terror-ists from Pakistan during the attacks, illustrating his role in the heinous act. The Mumbai attacks

involved ten heavily armed assailants who carried out urban warfare, resulting in the deaths of 166 innocent individuals, including 26 foreigners. Gupta lamented the lack of justice for the victims, noting that Mir is listed as a proscribed terrorist under Indian and international laws.

Expressing concern about the failure to list established terrorists under the Security Council's sanctions regime Gupta questioned the genuine political will to fight terrorism

Eleven days after Nationalist Congress Party (NCP) chief Sharad Pawar appointed the party's senior leader Praful Patel and his daughter-MP Supriya Sule as the party's working presidents, a side-lined NCP leader and his nephew, Ajit Pawar, said here on Wednesday that he had no interest in continuing as the Leader of the Opposition (LoP) in the Assembly. Instead, he preferred to accept any responsibility within the party.

Speaking at a function organised to mark the NCP's 25th foundation day, Ajit told the party leadership, "I am not interested in continuing in the post of the leader of the Opposition in the State Assembly. Relieve me of the Opposition leader's post and give me any post in the party. will do justice to the party's post.

Ajit's statement, which came as a surprise to Sharad Pawar and other party leaders, is being interpreted in State political circles in two ways. First, through his statement, he wanted to express his dissatisfaction over the manner in which he was sidelined by the NCP chief in the organisational restructuring that took place on June 10, the day when the NCP entered its 25th year of exis-

Secondly, by requesting any post, Ajit has sent a message to the party leadership that he should be considered for the State party president's position, replacing Jayant Patil, who has been the State NCP president for the past five years. Patil has continued in the state party chief's role despite a stipulation in the NCP's constitution that no leader holding a party post should be replaced after a tenure of three years.

Despite speculation that he is angling for the State party chief's position, informed party



The UN underlined that yoga is an ancient physical, mental and spiritual practice that originated in India. The word "yoga" is derived from Sanskrit and means to join or to unite, symbol ising the union of body and consciousness. Today it is practised in various forms around the world and continues to grow in popularity

Recognising its universal appeal, in December 2014, the UN proclaimed June 21 as the International Day of Yoga. The draft UNGA resolution establishing the International Day of Yoga was proposed by India and endorsed by a record 175 member states. The proposal was first introduced by Prime Minister Modi in his address during the opening of the 69th session of the UN General Assembly.

Earlier in a video message on the occasion of the International Yoga Day, Modi said India has always nurtured traditions that unite, adopt and embrace and made a fervent appeal to eliminate contradictions, hurdles and resistances through yoga. Modi said Indians have welcomed new ideas, conserved them and celebrated the country's rich diversity.

"We have to eliminate our contradictions, blockages and resistances through Yoga. We have to present the spirit of 'Ek Bharat, Shreshtha Bharat' as an example to the world," Modi said

Modi also said the International Day of Yoga was special this year as researchers at India's research stations in the Arctic and Antarctica too were participating in the celebrations. UN Secretary-General Antonio Guterres, in his message for Yoga Day, said yoga unites people. "It unites body and mind, humanity and nature and millions of people across the globe for whom it is a strength v and peace.

Rain inundates LG slams delay in setting G'gram, causes rules for PDS social audit

 $E^{\rm ven}$ after a decade of the Benactment of the National Food Security Act (NFSA), 2013, the National Capital Territory of Delhi is yet to establish rules for conducting establish rules for conducting a "social audit" into the func-tioning of its Public Distribution System (PDS) and Fair Price Shops. Delhi Lieutenant Governor VK Saxena has flagged the "delay" by the Arvind Kejriwal Government in framing rules for conducting a social audit into the functioning of the public distribution system and fair price shops.

These rules, mandated under sub-section 2 of Section 40 of the NFSA, aim to ensure transparency and accountability in the distribution of subsidized rations through the Act and PDS. Approving the file, Saxena expressed disappointment over the "sheer inaction" on the part of the Government, highlighting its failure to prioritise the framing of rules necessary for a corruption-free and



equitable distribution of rations

to the most vulnerable sections of society. The LG's note to the Chief Minister criticised the unex-

plained delays in framing the rules, and an instance of a file being returned after a year without any justification. Over the past five years, the proposal from the department has been returned on at least nine occasions for various reasons.

The Centre had recently issued a warning to the Delhi Government, stating that if the rules are not framed by June 30, 2023, the central assistance for intra-state transportation expenses and FPS dealers' margin will be withheld. In response to this ultimatum, the Kejriwal Government has submitted the relevant file to the LG on

Subsequently, the LG granted approval for publishing the draft rules, inviting public suggestions and comments. These pending rules encompass various provisions,

including the identification of false beneficiaries, ensuring the timely provision of highquality rations to eligible individuals, empowering vigilance committees in the social audit process, conducting verification drives, implementing CCTV camera surveillance, SMS-based monitoring, mandatory electronic weighing, maintaining proper stock levels at FPS, and providing relevant information to citizens.

"It is noted that on one occasion, the file was returned by the Minister after passage of one year without any explanation for the delay whatsoever. During the past five years itself, beginning June, 2019, the Minister has returned the proposal of the Department at least on nine occasions for one reason or the other," the LG wrote.

June 6, seeking approval for the In a letter dated June 1, 2023 notification of the rules. the Secretary of the the Secretary of the Department of Food & Public Distribution, Ministry of Consumer Affairs wrote to the Chief Secretary of Delhi, highlighting the failure to notify the rules under sub-section 2 of Section 40 of the NFSA.

The Ministry conveyed its decision to withhold central assistance if the rules are not framed and notified by June 30, 2023. Additionally, the Parliamentary Committee on Subordinate Legislation (CoSL), comprising members from political parties, including the Opposition, has granted an extension until the same deadline for the notification of rules, expressing concern over the delay.

Reacting to the develop-ment, the AAP Government sources said, "Rather than issuing daily press releases against the elected Government and creating hurdles for the Government, it would have been better if the LG concentrated on law and order situation, which is his primary job".

ED busts hawala, illegal Forex network in Kerala

PNS NEW DELHI

The Enforcement Directorate on Wednesday Enforcement said it has seized Rs 2.90 crore cash in foreign and Indian currencies, following raids on 14 locations in Kerala against a network of hawala operators and illegal Forex dealers in the State.

The searches under the Exchange Foreign Management Act (FEMA) were conducted following inputs that hawala operations were being conducted at these premises in the guise of Forex money exchange, gifts, textile, jewellery and ready-made garments shops, the ED said.

Hawala denotes illegal and fraudulent monetary trans-actions through both banking and non-banking channels.

Currencies of 15 countries worth about Rs 1.50 crore and "unaccounted" Indian currency of about Rs 1.40 crore, generated from illegal foreign currency exchange, were seized during the operation, the agency said.

Some of the entities that have been identified by the ED as "key players" in the alleged



hawala network and were covered as part of the search were Suresh Forex, Ettumanoor Forex, Dubai Forex, Sangeetha Foreign Exchange, Crescent Trading, Hana Trading, Fornas Forex Pvt Ltd and their key managerial persons.

These persons and entities conducted an illegal exchange of foreign currency and were also involved in arranging cross-border payments to Dubai, the USA and Canada through hawala, bypassing legal banking channels, , the ED alleged.

The operators "admitted" illegal Forex dealings without

taking KYC (know your customer) or issuing bills. The voice memos and WhatsApp conversations retrieved from the devices of these persons revealed the modus operandi of the hawala operations which runs into crores of rupees, it

Additional data retrieved from more than 50 mobiles and electronic devices seized during searches is being analysed with the help of forensic experts for further operational analysis and to identify the larger racket of cross border hawala and the beneficiaries, the agency added

Bishnoi's key crony arrested by NIA

The National Investigation Agency (NIA) on Tuesday arrested a key associate of incarcerated gangster Lawrence Bishnoi. The arrest was made in connection with the accused's alleged involvement in harboring members of the Lawrence Bishnoi terror syndicate, who are implicated in various criminal cases, including the RPG attack on the Intelligence Headquarters of Punjab Police in Moĥali

The arrested individual. identified as Vikas Singh, hails from Lucknow, Uttar Pradesh. He stands accused of providing shelter to Deepak Surakhpur and Divyanshu, residents of Faizabad, who executed the RPG attack on the intelligence headquarters in Mohali in May 2022. According to the NIA, Vikas has admitted to accommodating Deepak Surakhpur and Divyanshu multiple times, allowing them to stay in his house in Village Devgarh, Janpad Ayodhya, and his flat at 77/04 A Block, Gomti Nagar Vistar, Lucknow, UP. Vikas Singh is already fac-

ing charges in 10 criminal cases, including murder, attempted The CBI on Wednesday ques-tioned suspected middle-man Sanville Adrian D'Souza for over eight hours on the second day in a case of alleged attempted extortion of Rs 25 crore from actor Shah Rukh Khan for



Holding sway

PM Modi's US visit is an opportunity to bolster the US-India relation and send a stern signal to China

rime Minister Narendra Modi is on his maiden US State visit. His visit has garnered significant attention and anticipation. The Prime Minister has used his stay to meet not only the US administration but a plethora of American businessmen and think tank. His meeting with Elon Musk, the CEO of Tesla has left many guessing about the outcome. The visit has the potential to become a defining moment in US-India relations, fostering closer ties between the two nations. It goes without saying that In the US system the businesses play a vital role in the policy framework and the administration is very careful in calibrating its moves keeping in mind the impact it would have on businesses in the US. Thus, Prime Minister Modi's meetings with influential leaders and business magnates during his US visit is a step in the right direction and underscore the growing importance of India on the global stage. Engagements with Elon Musk, a visionary entrepreneur, albeit little off tangent, serve as a testament to India's com-



mitment to fostering innovation and technology-driven growth. Such interactions create a positive framework for bilateral cooperation in areas such as renewable energy, space exploration, and advanced manufacturing, bolstering economic ties between the two nations. Whether or not Tesla would actually come to India is difficult to say right now as it would depend upon many factors but it certainly opens up the avenue for its entry here. Besides, Prime Minister Modi's visit also showcased the strong partnership between the US and India in addressing shared challenges, including climate change, cyber security, and terrorism.

However, in the realm of diplomacy no event takes place in isolation but has to be evaluated in a larger perspective that encompasses multiple regional and global players. India's relations with Russia and China should be evaluated in light of changing geopolitical dynamics. While the US-India partnership has witnessed remarkable growth, it does not necessitate a deterioration of India's relations with Russia and China. India has historically maintained diplomatic balance, engaging with various nations to advance its strategic interests. Prime Minister Modi's visit to the US does not undermine India's partnerships with Russia and China; rather, it adds a new dimension to its foreign policy architecture. But this assertion is not free from its limitations. How would China view and react to this visit only China can say and so goes for Russia which is coming closer to China and forming an axis against the US led Western alliance. If Russia takes a strong exception to the PM's US state visit, then India could be in the dock. India depend on Russia for defence supplies in a big way. It also encompasses energy partnerships, and diplomatic support. India's approach to international relations has always been about maintaining a delicate balance between various global powers. It should be India's endeavour to have good relations with the US without annoying Russia or china.



A new chapter in India-US relations



The desire of the political leadership of the two countries to build a strong relationship is based on regional, domestic, and strategic factors

he transformation of the India-US relationship from estranged democracies to a strategic partnership has been a defining movement of the 21st century, with the two countries having witnessed significant cooperation in several areas of common interests. While successive Indian Prime Ministers and US Presidents have played pivotal in cementing the ties, Prime Minister Narendra Modi and President Joe Biden have also taken a slew of measures in this regard. Therefore, the upcoming state visit of Prime Minister Narendra Modi to the US on June 21-24 is viewed as a historic movement in the relationship.

Modi will become the first Indian Prime Minister to address a joint session of the US Congress for a second time, reiterating to US leaders that a resurgent India is committed to working together with the United States in ensuring peace, security and development in South Asia and other parts of the globe. Undoubtedly, one of the major shifts that have been observed in the relationship is an unprece-dented political willingness in both countries to engage each other. This can be gauged from regular interactions between the senior Indian and US political leaders on a wide range of bilateral and multilateral issues.

Of course, the desire of the political leadership of the two countries to build a strong rela-tionship has not developed in a vacuum. In fact, there is a milieu of structural, domestic, leadership and other drivers responsible for the transformational shift in bilateral ties.

One such driver is the shared security challenges facing New Delhi and Washington. There is a growing sentiment among US security officials and experts that, given its economic slowdown, its involvement in the Russian-Ukraine war, as well as security crises in the Indo - Pacific, the Middle East, and other regions, it is not possible for the United



India is concerned by China's position on disputed territories and by the growing nexus between Beijing and Islamabad. New Delhi feels that the presence of the United States in South Asia would help maintain the balance of power in its favour. The Modi government also knows it cannot aggressively pursue military modernisation without access to advanced US weaponry and technology. Modi's ambitious 'Make in India' initiative would also not be successful without the active participation of the American defence industry, given its expertise in the field. Isolating Pakistan internationally for failing to adequately address terrorism also requires New Delhi to sustain security

Logistic Exchange Memorandum of Agreement (LEMA), the Communication and Information Security Memorandum (CISMOA) and the Basic Exchange and Cooperation Agreement (BECA). With the aim of boosting technology cooperation, the two countries have also signed the Initiative for Critical and Emerging Technologies (iCET). The US policy towards Pakistan and terrorism has also undergone a marked shift to placate India's security concerns. These developments in turn have also led to a sharp rise in India's defence imports from the US from less than US\$ 1 billion in 2008 to US\$ 21 billion in 2021. The signing of an agreement between General Electric (GE) and Hindustan Aeronautics regarding the

also finalise a defence deal to buy 30 MQ-9 armed drones.

Economic interests are another driver of the relationship. While the volume of bilateral trade has reached US\$ 190 billion, the two countries have set a goal of taking it to \$500 billion in the next few years. For that to happen, the two countries have established an India-US Investment Initiative as well as an Infrastructure Collaboration Platform. Sure, the above account of encouraging trends however does not blind us to the challenges that the relationship has continued to face. The Biden administration's reluctance to restore India's status under the Generalised System of Preferences (GSP) and the two countries divergent approaches in the agriculture and dairy sectors are a set of obstacles facing the relationship. The two sides also have differences in Myanmar, Iran, and Afghanistan. The US continues to feel uneasiness with the idea of India's strategic autonomy. Thus, with the visit by Modi to Washington, one hopes that both countries would be able to address these issues to realise the full poten-

FIRSTCOLUMIN COMFORTABLE LIFE AND A LITTLE PROGRESS

was recently asked about life's goals. My answer was: "Comfortable living and a little progress". Why is that? Aren't there unlimited possibilities? Shouldn't we aim for the moon? The answer to both these questions is a firm no. Let us see the big picture. We are forever doing 'karmas' with our bodies, minds and words. These bring 'karmaphalas' both good and bad. Forest Conservation Amendment Bill 2023 (FCAB) reiterates India's commitment towards realising 'Net Zero Emission' by 2070

aw is the primary instrument for the implementation of policy. The Forest Conservation Act 1980 (FCA) amendment was enacted for regulating the diversion of forest land for non-forestry purposes. The skillfully drafted preamble of Forest Conservation Amendment Bill 2023 (FCAB)once again reiterates India's commitment towards realizing the national targets of Net Zero Emission by 2070; main-tenance and enhancement of forest carbon stocks through ecologically balanced sustainable development; Nationally Determined Contribution target of creating carbon sink of additional 2.5 to 3 bil-lion tons of CO2 equivalent by 2030; increase in the forest and tree cover to onethird of its land area with an enhanced growth trajectory; maintaining country's important tradition of preserving forests and their bio-diversity; and enhancing forest-based economic, social and environmental benefits including livelihoods of forest-dependent communities. The preamble also indicates the need for provisions relating to the conservation, management and restoration of forests, maintenance of ecological security, carbon neutrality, etc. It does make a pious reading

and a great impression. Succinctly and surely, the preamble sums up the Government's intentions and the purpose of FCAB. When one starts giving a closer look at the provisions expected to serve the preamble's key contents, one notices that what they leave out is much more than what they cover. In this context, it also becomes imperative to look for the effect of FCA.FCA managed to reduce the diversion of forest in just a few decades from 1.43 lac ha to 15000 ha annually. At the same breadth, one may like to add that FCA fostered seething discontentment among a class of influential political and social circle of resourced human civilized class, who believed in the quick development of nonresilient eco-fragile infrastructures and who further believed in resource-hungry neoliberalism. The FCA, in its core spirit, notwithstanding some implementation issues increasing with time, attempted to serve public good and environmental sustainability, particularly in the face of climate change impacting all walks of life.

Examining from the above perspective, one finds that because FCAB is restricting the categories of forest land covered by the FCA and also simultaneously exempt ing, through an express provision, certain other forest lands from its coverage; huge stretches of forest lands of the country go out of the regulatory system prevalent for permitting non-forestry use of forest lands. For example, huge chunks of the proposed Reserve Forest areas (under Section 4 of the Indian Forest Act 1927) and many areas critical for the integrity of ecosystems and biodiversity including the life and livelihoods of local communities become vulnerable to land-use change. Examples of such lands left out are sacred groves, unclassed forests, zudpi jungle, paisari lands, oran lands, gairans or gochars, etc. and the related provisions clearly militate against the twin objectives of creating carbon sink and increasing forest and tree cover using the instrument of FCAB. With the growing population, expanding economy, and impacts of unsustainable practices and climate change; whether the remainder can fulfill the eco-services needs of the country is (The writers are former anybody's guess.

While it is apparent that the inclusion of Clause 1A (1)(b) is, prima facie, an attempt to undo the order dated 12.12.1996 of the Supreme Court of India in T.N Godavarman vs Union of India that had brought control on mindless diversion of many ecological-ly important areas, the proposed relaxation for many areas including the largest chunk of 100 km strip all along the international boundary of the country is worth examining.

Out of a total of 37 river basins in the country, those appurtenants to the international boundary is two in the north, one in the northeast, ten on the east coast side, and seventeen on the west and northwest. Studies have found that vegetation cover is the most important parameter for their ecosystem resilience. Currently, with 60% forest cover in its basin, only the

address ground-level issues and leaves wounded susceptibilities so far as locals are concerned. Water and agricultural security for the populations in our border, as well as other areas mentioned in the exemption-related clause, being a matter of serious concern, the proposal to ease the diversion of forest lands deserves reconsideration.

A snapshot of the field situation in regard to compensatory afforestation in lieu of the diverted forest area is revealed by the CAG report no. 21 of 2013. It shows that a total of 1,14,877.26 ha. Forest land was diverted in the country during 2006 -12 whereas non-forest land received in exchange (Odisha did not provide data and Jharkhand's data post-2002) was just 23,246.80 ha. The issue of site quality of the non-forest land offered for 'compensating the losses due to diversion notwithstanding, it's a fact that compensatory afforestation is often taken up on forest land itself due to a generously issued 'non-availability of non-forest land certificate' by the collectors. Quite recently also earmarking of non-forest land in Haryana and Madhya Pradesh in lieu of forest land diverted in Great Nicobar raises questions on the philosophy of 'compensating' ecological losses. In such a situation, the efficacy of the principle of 'ease of doing business' for achieving the mandated objectives of FCAB appears questionable. The experience gained in the case of blanket exemption given to recognition of rights under the Forest Rights Act 2006 (FRA) provides some insights. In the absence of a clearance system under FCA, forest land virtually lost its status. With no penalty clause, section 3(2) of FRA is manipulated to fit our country.

in ineligible cases and FCA is skillfully circumvented. In the last 15 years, a total of 18.5 lakh hectares of forest land stands diverted for self-cultivation and habitation. They exist in 22 lakh mostly un-demarcated patches, ever ready to get multiplied and expanded. Recently Maharashtra recognized 33,154 such pockmarks in the 15th year of implementation.

The history of exemptions and bourgeoning applicant-specific guidelines must make us wiser. The handling of exceptions and provisions of discretionary powers sprinkled in the FCAB, in addition to the newly inserted Section 3C, needs a professionally oriented and much stronger forest bureaucracy since unwanted relaxations will be to the peril of integrity of our ecosystems.

We, as part of the comity of nations, have entered a point in time when the Doctrine of Non-Regression of Environmental Laws (that they must not be diluted in any manner) should reign supreme. Accordingly, provisions of FCAB be modified to align with its preamble and strengthen the FCA. An efficient institutional framework can improve its implementation. Various ministries, agencies, and people seeking clearances should, in accordance with Articles 48(A) and 51A (g) of the Constitution, support the forestry sector in maintaining the ecological security of the country. An approach focusing on the suste-nance of cultural and traditional values in the background of India's traditional reverence for forests will go a long way to support conservation and sustainability. The task is not too big considering the need for and importance of securing a better ecological future for

Russia must pay, says UK PM

 $B_{\mathrm{Sunak}}^{\mathrm{ritish}\,\mathrm{Prime}\,\mathrm{Minister}\,\mathrm{Rishi}}$ opened the Ukraine Recovery Summit here to say that "Russia must pay" for the destruction inflicted on its European neighbour as he announced UK government loan guarantees worth USD 3 billion.

Sunak praised Ukraine's "ingenuity and defiance" and attacked Russia for trying to destroy the country's energy grid, which he said is back online and even exporting

energy. The two-day summit is being jointly hosted with Ukraine in London as part of efforts to mobilise international support in favour of the country in its ongoing conflict with Russia "It's clear that Russia must

lawful routes to use Russian assets," said Sunak in his opening address.

'The British government will continue to play its full part and I'm proud that today we're announcing a multi-year commitment to support Ukraine's economy. Over three years, we will provide loan guarantees

"generous" guarantees to support the people of Ukraine at a critical moment.

"The UK's support is backed by a major signal of intent from world-leading businesses, with more than 400 companies, from 38 countries, with a combined annual revenue of over USD 1.6 trillion, pledging to back Ukraine's recovery and reconstruction in the wake of Russia's illegal invasion," said the Indian-origin World Bank chief.

"The World Bank Group is designed to do hard things like helping people rebuild their lives after the devastation. With this support, we will keep delivering on that mission and help Ukrainians imagine a life after the war," he said.

Sunak also announced the launch of a new "UK-Ukraine TechBridge" to foster investthey've inflicted. So, we're President Ajay Banga wel-working with allies to explore comed the UK government's support for green energy as

part of a collective effort with global allies and revealed that the International Monetary Fund (IMF) is putting USD 15 billion into Ukraine over four years, as part of a USD 115 billion commitment by the G7.

"This is a vibrant, dynamic, creative, European country that refuses to be subdued. So together with our allies, we will maintain our support for Ukraine's defence and for the counter-offensive.

We will stand with Ukraine for as long as it takes as they continue to win this war," added Sunak.

He then welcomed "friend" Ukrainian President Volodymyr Zelenskyy virtually to the summit, who once again made a case for full membership of the military alliance North Atlantic Treaty Organisation (NATO) saying that Ukraine is already a key part of European defence.

Allies pledge billions to rebuild Ukraine

The World Bank has estimated the cost of the reconstruction at more than USD400 billion, a figure rising daily alongside the human toll of Russia's invasion.

Politicians from Europe and the US vowed that Russia would one day be made to pay for the destruction — though officials acknowledged that day is some way

European Commission President Ursula von der Leyen announced 50 billion euros (USD 55 billion) in support through 2027, while Britain pledged 240 million pounds (USD 305 million) in aid and 3 billion pounds (USD 3.8 billion) in World Bank loan guarantees for Ukraine. Germany announced a further 381 million

euros (USD 416 million) in humanitarian aid.

Ukraine President Volodymyr Zelenskyy, who addressed delegates by video, said his country needed action, not just pledges.

Russia downs 3 drones near Moscow Suspects it was attack by Ukraine

 $T_{\rm Moscow}$ as they approached the warehouses of a local military unit, Moscow region Gov. Andrei Vorobyov said on Wednesday, in what could be the latest attempt by Ukraine to strike targets inside Russia during the early stages of Kyiv's most recent counteroffensive.

They came down near the village of Lukino, administratively part of the city of Moscow, Russian media reported.

The wreckage of a third drone was reportedly found about 20 kilometers (12 miles) away. No damage or casualties were reported.Russia's Defence Ministry claimed it was "an unsuccessful attempt at a terrorist attack" by "the Kyiv regime" on its facilities in the Moscow region, adding in a statement that all three drones were brought down by electronic jamming.

Ukraine, which usually doesn't confirm attacks on Russian soil, made no immediate comment about the downed drones. Previously, Ukrainian officials have emphasised the country's right to strike any target in response to Russia's invasion and war that started in February 2022. In December, Moscow claimed it had shot down drones that targeted military air bases in the Saratov and Ryazan regions in

western Russia. Other drones have report edly flown deep into Russia multiple times. Since February, when a UJ-22 crashed 100 kilometres (60 miles) from Moscow, Ukrainian drones have repeated-ly approached the Russian capital.

Last month, a drone attack jolted the Russian capital, though it caused only slight damage, in what appeared to be one of Kyiv's deepest and most daring strikes into Russia. It was the second reported strike on Moscow that month after Russian authorities said two drones targeted the Kremlin. At that time, Russian President Vladimir Putin said Moscow's air defence "worked in a satisfactory way," but added it was "clear what we need to do to plug the gaps" in the system.

Kremlin spokesman Dmitry Peskov, confirming Wednesday's drone attack, said only that "the means of combatting drones did their job.

Meanwhile, train traffic was disrupted on the Crimean Peninsula on Wednesday, according to its Russianinstalled governor Sergei Aksyonov.Aksyonov didn't say what caused the disruption, but some Russian media outlets reported that the rail lines were blown up overnight in apparent sabotage operations.

EU countries agree on new sanctions against Russia

Brussels (AP): European Union countries on Wednesday agreed on a new package of sanctions against Russia for its war against Ukraine. Sweden, which currently holds the rotating EU presidency, said that the package includes measures aimed at countering sanctions circumvention and individual listings.

Details of the measures will be unveiled later this week when the sanctions are officially adopted by written procedure. The EU had previously imposed 10 rounds of sanctions on Russia since President Vladimir Putin ordered his forces into Ukraine on February 24, 2022. Banks, companies and markets have been hit — even parts of the sensitive energy sector. More than 1,000 officials are subject to asset freezes and travel bans. Much work has involved closing loopholes so that goods vital to Putin's war effort don't get through. However, it is the first time that plans have been announced to target trade via other countries, apart from sanctions against Iranians alleged to be supplying drones to Russia.

"After a brief argument from Khan's counsel, the ATC granted him pre-arrest bail till uly 7 in both cases and asked him to submit surety bonds worth PKR 100,000," a court official told PTI.

After securing bail, Khan moved to the Lahore High Court (LHC), where he sought an extension to his protective bail in the case of the murder of a senior Supreme Court lawyer in Quetta

Widespread violence erupted in Pakistan after the former premier was arrested by paramilitary personnel inside the Islamabad High Court on May 9. He was later released on bail.

According to PTI, law enforcement agencies arrested over 10,000 party workers across Pakistan, mostly from Punjab. 

In its letter issued on Tuesday, the HEC said that it had "caused concern and disadvantageously affected

complete disconnect from our socio-cultural values and an erosion of the country's Islamic identity," the letter read.

Óne such instance that has caused concern was the fervour exhibited in marking [the] Hindu festival of Holi...This widely reported/publicised event from the platform of a university has caused concern and has disadvantageously

affected the country's image," the letter said. In one of the videos circulating on social media on the March 8 event, students can be seen dancing and throwing colours in the air as loud music plays in the background. "While there is no denying

the fact that cultural, ethnic, and religious diversity leads towards an inclusive and tolerant society, that profoundly

The students need to be apprised to be aware of the self-

serving vested interests who use them for their own ends far from the altruistic critical thinking paradigm," the HEC letter read.

The letter advised higher ducation institutions (HEIs) to prudently distance" themselves from all such activities obviously incompatible with the country's identity and societal values'

It said that HEIs had the 'ultimate responsibility to polish and nurture the exuberance of youth into learned, mature, and responsible citizens - ready to take on the reins of the country and play their role in nation building"

The HEC director said the notification was not a "ban" on such celebrations.

Singapore is considered a "prized target" by terrorists who have been increasingly targeting youths, Deputy Prime Minister Lawrence Wong said on Wednesday, underlining the need to have strong community leaders to inoculate Singaporeans against extreme ideologies.

Speaking at the Religious Rehabilitation Group's (RRG) 18th annual retreat, Wong said that while terrorism may not be at the top of many Singaporeans' minds, the threat of radicalism and extremism remains high.

"This includes Singapore, which is considered a prized target by terrorists. There is a need to inoculate Singaporeans against extreme ideologies, Wong was quoted as saying by Channel News Asia.

The RRG was formed in 2003, after Singapore authorities arrested members of the Jemaah Islamiyah group.

Global terrorist groups like ISIS (Islamic State of Iraq and Syria) and Al-Qaeda continue to rebuild their strength and "remain determined to sow disorder and chaos" by conducting attacks in other countries, said Wong.

The groups have become more sophisticated at using digital platforms like social media to spread propaganda and incite followers to conduct attacks.

"This has not only made extremist material easier to access, but it has also accelerated the process of radicalisation to a matter of months, or even weeks, because all of this now takes place behind a computer screen and it is much arder to detect," he said. He said that terrorist

groups have been increasingly targeting youths who are more impressionable and susceptible to influence. Apart from traditional social media channels, they have started to exploit online music streaming sites



and gaming platforms that are popular with young people. Since 2015, the Internal

Security Department (ISD) has issued ISA orders to 11 selfradicalised Singaporeans below 21. Some of them started their process of radicalisation from as young as 14 years old, he noted.

Before 2015, there was only one case of youth radicalisa-

tion. "The threat has also gone beyond Islamic extremism because we have seen a broader range of radical extremist and violent groups active in spreading their ideologies

online," said Wong. For example, one of the 11 youths was a 16-year-old Protestant Christian who had planned to conduct attacks against Muslims at two mosques in Singapore, after he imbibed far-right extremist ideology, he pointed out.

"What all this means is that extreme and violent ideologies can radicalise any Singaporean, regardless of age, regardless of race or religion," said Wong. "And this has serious impli-

cations for our society. The extremist and terror threat is far more insidious now, it can reside within our own communities. It will seek to exploit our racial and religious differences

in attempts to divide us." It will not be possible to 'completely insulate" Singaporeans from everything online, said Wong."So, our approach must be to inoculate Singaporeans against extreme ideologies," he added.

During Blinken's visit, China reiterated its strong objections to US support for the self-governing island

Beijing claims as its own territory. The US has also sought to block China's access to cuttingedge computer chip manufacturing technology that could be used for military purposes and accused Beijing of stealing American intellectual proper-

In his comments at the fundraising event for his 2024 re-election campaign, Biden said he believed the balloon incident had caught Xi

"That's what's a great embarrassment for dictators, when they didn't know what happened. That wasn't supposed to be going where it was. It was blown off course up through Alaska and then down through the United States. And he didn't know about it," Biden said. "When it got shot down, he was very embarrassed. He denied it was even there."

Despite their sharp political divide, the countries continue to have deep economic and cultural links. Bilateral trade

passed \$690 billion last year and an estimated 300,000 Chinese are believed to be studying in the US, shoring up American institutions that have come under financial pressure. After meeting with Xi on Monday, Blinken acknowledged entrenched differences. We have no illusions about the challenges of managing this relationship. There are many issues on which we profoundly, even vehemently, disagree," he said.

Xi sounded a similar note but suggested the rivalry could be overcome.

'The competition among major countries is not in line with the trend of the times and cannot solve the problems of the United States itself and the challenges facing the world," he told Blinken.

"China respects the interests of the United States and will not challenge or supplant the United States. Similarly, the United States should also respect China and not harm its legitimate rights and interests."

Japan's Kishida to attend NATO leaders' summit Stresses need for dialogue with China

Japanese Prime Minister Fumio Kishida on Wednesday announced plans to visit Lithuania next month to attend a NATO leaders' summit as his country steps up cooperation with the Western organisation amid China's increasingly assertive military

activity. Kishida stressed the importance of dialogue with China in order to develop "constructive and stable" relationship with Beijing while his country cooperates with its key ally, the United States. He said the state of US-China relations are crucial to international peace and stability.

At a news conference marking the end of a fivemonth long parliamentary session, Kishida said reinforcing diplomatic and security measures were among his top policy priorities in the first half of this year.

The goal he said, is "to raise Japan's presence in the interna-tional society, to defend the peace of our country and the people's lives.

Japan has been strengthening ties with NATO against the backdrop of the war in Ukraine and concerns that it may embolden China's already assertive military activity in East Asia. The prime minister said he will join NATO leaders at the July 11-12 summit in Lithuania at the invitation of the organization. He said he also will visit NATO headquarters in Belgium. Discussions are also underway

Japan. Describing the current security environment of the global community as "the most severe and complex" of the postwar era, Kishida vowed to 'fully utilise diplomatic tools" to contribute to the peace and stability of the global community while serving Japan's national interest.

Kishida said Japan will cooperate with the United States on China policy, while encouraging Beijing to fulfil its responsibility as a global power

to observe international rules and order.

Japan is increasingly concerned about China's coercive activity in the region, especialy around Japanese-controlled disputed East China Sea islands that Beijing also claims. "It is important to continue making effort to have close dialogue at all levels, including myself, and in that process I will consider my possible visit to China, though nothing has been decided right now," Kishida said.

His comment comes on the heels of US Secretary of State Antony Blinken's meeting earlier this week with Chinese President Xi Jinping in Beijing, where they agreed to stabilise their countries' deteriorated ties but fell short of resuming military-to-military contacts aimed at avoiding mishaps and

conflict over Taiwan. Kishida also stressed the importance of dialogue with North Korea, and reiterated that he is stepping up his effort toward achieving a possible summit with leader Kim Jong Un on the decades-old issue of abductions of Japanese nation-

als by Pyongyang. The issue was only partially resolved and North Korea has never provided a full account for those still believed

to be held. With many families of the abductees growing older, resolving the problem has become an increasingly urgent human rights issue, Kishida said

Bucharest (AP): Andrew Tate, a social media personality known for expressing misogynistic views online, appeared on Wednesday at a court in Romania, where prosecutors have charged him with rape, human trafficking and forming a criminal gang to exploit women. Tate and his brother,

Tristan, who is also charged with the offenses, arrived Wednesday at a court in the capital Bucharest, flanked by six bodyguards.

Prosecutors have also filed charges against two Romanian women in the case. Romania's anti-organised crime agency alleged that the four defendants formed a criminal group in 2021 "in order to commit the crime of human trafficking" in Romania as well as

the United States and Britain. The agency alleged that seven female victims were misled and transported to Romania, where they were sexually exploited and subjected to physical violence by the gang. One defendant is accused of raping a woman twice in March 2022, according to the statement.

Tate, 36, has resided in Romania since 2017. The former professional kickboxer has repeatedly claimed Romanian prosecutors have no evidence and alleged the case is a political conspiracy to silence him.

Asked by reporters "how much money have you made from trafficking women?" outside court ahead of Wednesday's hearing, Tate snapped: "Zero."

Missing submersible: Desperate search for 5 aboard

AP BOSTON

Canadian military surveil-Alance aircraft detected underwater noises as a massive operation searched early Wednesday in a remote part of the North Atlantic for a submersible that vanished while taking five people down to the wreck of the Titanic. A statement from the US

Coast Guard did not elaborate on what rescuers believed the noises could be, though it offered a glimmer of hope for those lost aboard the Titan as estimates suggest as little as a day's worth of oxygen could be left if the vessel is still functioning.

Three vessels arrived onscene Wednesday morning, including The John Cabot, which has side-scanning sonar capabilities and is conducting search patterns alongside two other vessels, the Skandi

Vinland and the Atlantic Merlin, the Coast Guard tweeted

Meanwhile, questions remain about how teams could reach the lost submersible, which could be as deep as about 12,500 feet (3,800 metres) below the surface near the watery tomb of the historic ocean liner.

Newly uncovered allegations also suggest there had been significant warnings made about vessel safety during its development.

Lost aboard the vessel are pilot Stockton Rush, the CEO of the company leading the expedition. His passengers are a British adventurer, two members of a Pakistani business

family and a Titanic expert. The Coast Guard wrote on Twitter that a Canadian P-3 Orion had "detected underwater noises in the search area."



Searchers then moved an underwater robot to that area to search. However, those searches "have yielded negative results but continue"

The data from the P-3 aircraft has been shared with our US Navy experts for further analysis which will be considered in future search plans," the Coast Guard said.

The Coast Guard statement came after Rolling Stone, citing what it described as internal US Department of Homeland Security emails on the search, said that teams heard "banging sounds in the

The Canadian military said it provided a patrol aircraft and two surface ships, including one that specialises in dive medicine. It also dropped sonar buoys to listen for any sounds from the Titan. Rescuers have been racing against the clock because even under the best of circumstances the vessel could run out of oxygen by Thursday morning.In addition to an international array of ships and planes, an underwater robot had started searching in the vicinity of the Titanic and there was a push to get salvage equipment to the scene in case the





5G seen accounting for 57% of mobile subscriptions in India by 2028 end: Ericsson report

he 5G subscription in India is estimated to have reached about 10 million by 2022 end, and is seen accounting for about 57 per cent of mobile subscriptions in the country by the end of 2028, making it "the fastest growing" 5G region globally, according to Ericsson Mobility Report.

With the launch of 5G services in October 2022, the major 5G Indian market is witnessing huge network deployments under its Digital India initiative, it observed.

The geopolitical challenges and macroeconomic slowdown in some markets notwithstanding, communications service providers globally are continuing to invest in 5G, the June 2023 edition of the Ericsson Mobility

Report revealed. "5G subscriptions in India reached about 10 million by end of 2022 and are estimated to account for about 57 per cent of mobile subscriptions in the country by the end of 2028, making it the fastest growing 5G region globally," it said.

The fifth generation mobile subscriptions are growing in every region and forecast to top 1.5 billion globally by the end of

The uptake of 5G subscriptions in North America has been stronger than expected in previous forecasts. The region

had the highest 5G global subscription penetration at 41 per cent at the end of 2022.

Global mobile network data traffic continues to rise with the monthly global average usage per smartphone expected to exceed 20 GB by the end of 2023. The report also highlighted

the continued revenue growth in leading 5G markets.

'The global adoption of 5G technology has surpassed one billion subscriptions, bringing positive revenue growth for communications service providers in leading 5G markets," Fredrik Jejdling, Executive Vice President and Head of Networks, Ericsson, said.

In the past two years, the 5G introduction in the top twenty markets has resulted in a seven per cent revenue boost, Jejdling said, underlining a strong link between the increase in 5G subscriptions and service

revenue. Globally, around 240 communications service providers (CSPs) have launched commercial 5G services and about 35 have deployed or launched 5G standalone (SA).

The most common 5G services launched by service providers for consumers are enhanced mobile broadband (eMBB), Fixed Wireless Access (FWA), gaming and some (Augmented Reality and Virtual Reality) AR/VR-based services, such as training and education.



Stokes 'devastated' by defeat in Ashes opener

Ben Stokes said he felt "devastat-ed" by England's dramatic two-wicket defeat in the first Ashes Test at Edgbaston but insisted his aggressive approach could yet secure a series win over Australia. An unbroken ninth-wicket stand

of 55 between Australia captain Pat Cummins and Nathan Lyon on Tuesday's final day proved decisive in a see-saw contest as the tourists chased down a target of 281.

This was just England's third defeat in 14 Tests since captain Stokes joined forces with coach Brendon McCullum last year. The duo's policy of all-out attack, dubbed 'Bazball' in honour of

McCullum's nickname, came after a run of just one win in 17 Tests under former England skipper Joe Root. England signalled their intentions

right from the start at Edgbaston, with Zak Crawley driving the first ball of the match for four. And with England bidding for a

first Ashes series win since 2015, Stokes had no qualms about his approach. "I am devastated we've lost that

game but in terms of what it's done for the series, it's hard to not be too disappointed because it has set up a

great series," he said. "It's not a psychological blow at all.

"We've lost but if you look at the way we've played, compared to how the last few Ashes series have gone, it proves what we're capable of doing against Australia.

"Losing sucks but the way we applied ourselves literally from ball one proves we're able to stand up to Australia... We've got four games left and that's what we're going to be concentrating on.

All-rounder Stokes defied convention by declaring on the opening day with England 393-8 in their first innings after Root's first Ashes hundred in eight years.

England, however, might still have won had they taken all their chances and a few batsmen pressed on in a second innings where there were several scores in the 40s but no major contribution.

An unapologetic Stokes said of his declaration: "I'm a captain who saw it as an opportunity to pounce on Australia. The way in which we played and took Australia on actually allowed us to be able to do that.

"If we didn't declare, would we have got that excitement like we did at the end? I'm not 100 percent sure but I'm not going to be looking back at this game as what ifs. We just didn't manage to get over the line."

Australia, England penalised for slow over-rates

Australia and England have been fined 40 per cent of their match fee and penalised two ICC World Test Championship (WTC) points each for maintaining slow over-rates during the first Ashes Test in Birmingham.

Andy Pycroft of the ICC Elite Panel of Match Referees imposed the sanctions after the teams were ruled to be two overs short of their targets after time allowances were taken into consideration, according to the ICC release.

"Captains Pat Cummins and Ben Stokes pled guilty to the offence and accepted the proposed sanctions, so there was no need for formal hearings. On-field umpires Ahsan

PCB's likely chairman Ashraf rejects 'hybrid model'

PTI ISLAMABAD/NEW DELHI

The likely new chairman of Pakistan Cricket Board (PCB) Zaka Ashraf has rejected his predecessor Najam Sethi's much-publicised "hybrid model" for the upcoming Asia Cup, which is slated to be held in Pakistan and Sri Lanka in September.

"The first point is that I had rejected the hybrid model (for Asia Cup) in the past itself because I do not agree with it. The board of the Asian Cricket Council had decided that it should be held in Pakistan, then we should host it," Ashraf said during a press conference in the Pakistan capital on Wednesday.

Ashraf's comments could also put Pakistan's World Cup participation in a limbo and it is expected that the BCCI will

also play hardball and there wouldn't be any middle ground if they back-track from what was agreed upon by members of Asian Cricket Council (ACC)

With the ACC executive body approving the hybrid model, if Ashraf doesn't change his stand, the Asia Cup could be held without Pakistan as a five-nation tournament.

"The Asia Cup model has been accepted by ACC and there would be no change. Ashraf is free to say whatever he wants," an ACC board member told PTI.

Ashraf is one of the two nominees for the PCB chairman's post handpicked by Prime Minister Shahbaz Sharif, who is the patron-in-chief of the board and the man who has the final say in appointment. As of now, Ashraf's appointment

is just a formality. The hybrid model was

accepted by the ACC, headed by BCCI boss Jay Shah, after India made it clear that it won't travel to Pakistan due to the prevailing geo-political situation.

It was decided that four



games will be held in Pakistan with the host country playing their group league match against Nepal and three other games involving Sri Lanka, Bangladesh and Afghanistan would also be scheduled in

However, things changed dramatically in the last 48 hours after Sethi announced on twitter that he is quitting.

"I don't want to be a bone of contention between Asif Zardari and Shehbaz Sharif. Such instability and uncertainty is not good for PCB. Under the circumstances I am not a candidate for Chairmanship of PCB. Good luck to all stakeholders," Sethi had tweeted.

Ashraf, a banker by profession, has earlier been the PCB chairman.

During his media interac-

tion, Ashraf said that he doesn't like the idea of inconsequential games being held in their country when they have got hosting rights.

"All the main matches are happening outside (of Pakistan). (Teams like) Nepal and Bhutan are going to play in Pakistan - which is not fair for Pakistan. I do not know what the board has decided previously, I do not have the access

to the information. "I will check, whatever is doable in the shortest possible time, will do that for the betterment of Pakistan," he said. Ashraf also said that the

World Cup issue is yet to be sorted which could mean that the release of schedule will be delayed further.

There are challenges lined up ahead for Pakistan, there are many pending issues, the Asia

Cup is there, then the World Cup, the team's preparations, a lot of issues. I do not want to speak against anyone because I have not (yet) taken over, Ashraf said while not wanting to say anything about Sethi.

'Once I take over, will see what the scenario is. I always take media along, I do not hide anything. We have to work for the betterment of Pakistan, we have a clear conscious.

It is understood that Pakistan's demands to play World Cup matches at a neutral venue will not be accepted by either the BCCI or the ICC at any cost, and now Ashraf's tough stance on Asia Cup could spoil relations further.

It may be noted that the last time India and Pakistan were engaged in a bilateral series in 2012, Ashraf was the PCB chairman.
