Modi bats for UCC

BJP won't adopt a policy of appeasement but satisfaction of all, says PM

Prime Minister Narendra Modi on Tuesday took a stinging swipe at the Opposition by describing their unity bid as "guarantee" for corruption and batted for the introduction of the Uniform Civil Code (UCC), saying, "How will the country be able to run with such a dual system?"

Modi maintained that the BJP would not adopt the policy of "tushtikaran" (appease-ment) but that of "santhushtikaran" (satisfaction) of all communities and criticised them for supporting triple talaq. Speaking about the alleged "discrimination" faced by the backward Muslims when the BJP was not in power at the Centre, he said, "Those who do vote-bank politics have destroyed Pasmanda Muslims and they did not get any ben-

Modi regretted that there was no discussion on the plight of the Pasmanda Muslims in the country who are not treated equally but considered lowly and untouchable and were discriminated against for endless generations by their more privileged brethren and were exploited by the "vote-bank

said even the Supreme Court has advocated for the Uniform Civil Code, but those practicing vote-bank politics are opposing it. While drawing attention to what he said was the "vote-bank and appease-ment politics," Modi sought to affirm that "the BJP is working for 'Sabka saath, Sabka vikas' and giving Muslims all benefits of Government schemes like PM Ayushman Bharat and PM

Talking about the Uniform Civil Code, Modi said, "We are seeing that work is being done to instigate such people in the name of Uniform Civil Code. If there is one law for one member in a house and another for the other, will the house be able to run? So how will the country be able to run with such a dual system?

Awas Yojna."

The Prime Minister further your sons, daughters, and

grandchildren, then vote for the BJP and not any family-oriented parties," he said.

In the interactive session with the BJP workers in Bhopal where Chief Minister Shivraj Singh Chouhan and BJP president JP Nadda were also present, Modi was asked by a BJP worker about the Opposition parties' bid for unity vis-à-vis the BJP to which he replied saying, "You seem to be very angry with them, but you need to sympathise with them...daya

karni chahiye."

He said the Opposition parties are "more restless and worried today than they were in 2014 and 2019 elections. Aaj jo chatpatahat aap Opposition mein dekh rahain hain vo pahle nahin thi," Modi

"Those who used to be staunch enemies of each other are today prostrating before each other...they are worried and scared, which signals that voters have already made up their minds to elect the BJP again in 2024 Lok Sabha polls," said Modi amidst heavy clapping and slogan-shouting.

CAG special audit now into CM house fix up

Centre issued order after May 24 letter by Delhi L-G

The Comptroller and Auditor General (CAG) of India will conduct a special audit into alleged "irregularities and violations" in the "recon-struction" of Chief Minister Arvind Kejriwal's official bungalow at Flag Staff Road.

The Union Home Ministry has recommended the special CAG audit taking note of a May 24 letter by Lieutenant-May 24 letter by Lieutenant-Governor VK Saxena which pointed out "gross and prima facie financial irregularities" in the "reconstruction" of the Chief Minister's official residence. A massive controversy broke out in April this year after it was revealed that over Rs 52.71 crore had been spent to renovate the Chief Minister's official residence.

In his letter to the MHA, Saxena said the "alleged irreg-ularities" were highlighted by the media after which Delhi's Chief Secretary submitted a factual report on April 27 and then again on May 12. "The reports detailed deviations, violations from rules, regulations and guidelines by the Public Works Department and the Delhi Government in the name of renovation of the Chief Minister's residence", he said. According to the reports of the Chief Secretary, a fullfledged construction/re-construction of a new building was carried out by the PWD in the name of renovation, the L-G's letter said. *Contd on Page 2*



BJP is desperate, CAG probe last year found no financial irregularities: AAP

The Aam Aadmi Party (AAP) criticised the Central Government's decision to initiate a Comptroller and Auditor General (CAG) audit into the reconstruction expenses of Delhi Chief Minister Arvind Kejriwal's official residence. The party accused the Bharatiya Janata Party (BJP) of resorting to desperate measures due to their anticipated defeat in the 2024 Lok Sabha elections and said a CAG investigation was conducted last year, revealing no evidence of financial irregularities.

The reconstruction of the Chief Minister's residence had previously sparked a

political battle in the capital city, with the BJP demanding an investigation into the mat-ter and the AAP claiming that the house was in a dilapidated state as it was constructed in 1942

Expressing strong displeasure, the AAP issued a statement saying, "This move by the Modi Government reeks of desperation as the BJP anticipates an inevitable defeat in the forthcoming 2024 general elections. Regarding the CAG inquiry into the reconstruction expenses of the Chief Minister's residence, it is important to note that it was already conducted last year, revealing no evidence of financial irregularities."

White House condemns online harassment of scribe by Indians

WSJ reporter had posed question on democracy in India during Modi-Biden joint Press conference

Siddiqui had posed a question on democracy in India during a joint Press conference with Prime Minister Narendra Modi and President Joe Biden in Washington last

White House National Security Council Coordinator for Strategic Communications, John Kirby, addressed the issue during a media interaction late on Monday in Washington. Kirby stated that the White House was "aware of the

Diwali a school holiday in NYC

NEW DELHI/NEW YORK

New York City has officially declared Diwali as a school holiday, recognising the cultural significance of the festival and celebrating the diversity of its residents, including the Indian community. Mayor Eric Adams announced the decision, describing it as a "victory" for the city and its various communities.

Mayor Adams expressed pride in the passage of the Bill by the State Assembly and the State Senate, stating his confidence in the Governor's approval. Speaking from City Hall during a special announcement, he said, "This is a victory, not only for the men and women of the Indian community and all communities that celebrate Diwali, but it's a victory for New York.'

New York Assembly Member Jenifer Rajkumar, the first Indian-American woman elected to a New York State



office, highlighted the longstanding efforts of the South Asian and Indo-Caribbean community in securing this recognition. She emphasised that Diwali would now be enshrined as a school holiday in law, underscoring the importance of the occasion for over 600,000 Hindu, Sikh, Buddhist, and Jain Americans across New York City.

Rajkumar celebrated the broader significance of the decision, stating, "Today, we proudly say that Diwali is not ust a holiday. It is an American holiday, and the South Asian community is part of the American story.



Though the Chief Minister made no direct remark on Prime Minister Narendra Modi's speech at Bhopal from where he attacked the Trinamool Congress — an important part of the '19-party anti-BJP alliance - for its alleged involvement in a plethora of scams that could breach Rs 24,000 crores mark, Banerjee said the BJP leaders were feigning secular by reaching out to the minority communities sensing defeat in the parliamentary

Mamata was addressing a panchayat election rally at Ĵalpaiguri in North Bengal. "The next Lok Sabha polls will be held in February-March ...



which means the BJP government will not last beyond that period," because their antipeople policies and vindictive approach had angered the entire nation. 'Sleep disorder, insomania can increase risk of stroke'

Deople suffering from insom-P nia or any type of sleep dis-order may be more likely to have a stroke, according to a study published in the journal Neurology. The study revealed that the connection between insomnia symptoms and stroke was particularly strong in individuals under the age of 50. Those who experienced five to eight symptoms of insomnia had nearly four times the risk of stroke compared to people with no symptoms. Participants with more

than five symptoms of insomnia had a 51% increased risk of stroke, while those with one symptom had a 16% increased However, the researchers

emphasised that the study does not establish a cause-and-effect relationship between insomnia



symptoms and stroke; it only demonstrates an association.

'There are many therapies that can help people improve the quality of their sleep, so determining which sleep problems lead to an increased risk of stroke may allow for earlier treatments or behavioral therapies for people who are having trouble sleeping and possi-bly reducing their risk of stroke later in life," Wendemi Sawadogo, from Virginia Commonwealth University in the US,

The AAP further stated that the decision to initiate a fresh CAG audit is a clear reflection of the BJP's frustration, paranoia, and authoritarian tendencies. The party accused the BJP of being troubled by its successive electoral defeats in the Delhi Assembly polls and asserted that the CAG's move is an attempt to tarnish the reputation of Delhi's honest Government. The mandatory and prerequired sanction of the Building Plans in terms of applicable building bylaws were not obtained from the Building Committee of the PWD till now, according to the letter, based on the reports. "Initially the proposal was

to provide additional accommodation in the residence of the Chief Minister, however later on the proposal was approved by the Minister for an entirely new construction after demolition of the existing building," it said. The initial cost for construction work was Rs 15 to Rs 20 crore, the report said, adding that it was inflated from time-to-time, it said.

₹2 lakh tunnel loot | CM raps LG, says 'jungle raj' prevailing in Capital case solved, 7 held

With the arrest of seven people, the Delhi Police have successfully solved a robbery case that occurred inside the Pragati Maidan tunnel in the national Capital over the weekend. The incident, captured on CCTV cameras, involved four armed robbers on motorcycles forcefully stopping a car and stealing a black bag from it before fleeing the scene.

The victims of the robbery were identified as Patel Sajan Kumar, a delivery agent for a private company, and his associate. They were en route to Gurugram with a bag containing Rs 2 lakh in cash when the four robbers on two motorcycles intercepted their cab, brandishing firearms, and snatched the money at gun-

The accused have been identified as Usman Ali alias Kallu, Irfan, Sumit alias Akash, residents of Burari; Anuj Mishra alias Sanki, a resident of Bhalaswa Dairy; Kuldeep alias Lungad, a resident of Jahangirpuri; Pradeep alias Sonu, a resident of Baghpat in Uttar Pradesh; and Amit alias Bala, a resident of Loni in Ghaziabad in Uttar Pradesh, police said. They were following the taxi and chose to stop it inside the tunnel as they had a higher chance of success to execute the robbery. People usually do not stop in tunnels and drive through them at speed, according to police.

In order to alleviate his financial burdens, he devised a robbery plan and enlisted the help of his cousin, Irfan, Anui Mishra, also known as Sanki, Kuldeep, alias Lungad, and Sumit, alias Akash, were recruited as additional accomplices. Sumit, a vegetable vendor, accompanied Usman during the reconnaissance mission around Chandini Chowk, while Anuj, a mechanic at the

The accused individuals initially failed to find a suitable target in the Chandni Chowk area on June 22 and June 23. However, on June 24, they identified a person whom they believed was carrying a bag filled with cash and followed him to the Pragati Maidan tunnel. CCTV footage of the incident captured four men intercepting a car within the tunnel. As the car came to a stop, two helmet-wearing individuals disembarked from their motorcycles.

One approached the driver's side while the other targeted the rear door, with all of them brandishing their pistols. The robbers quickly fled the scene on their motorcycles, absconding with the black bag containing Rs 2 lakh in cash. Stolen motorcycles were utilized by the accused to execute their plan. Through diligent examination of the CCTV footage and other vital clues, the Delhi Police successfully apprehended all those involved in the robbery scheme and seized two motorcycles, a firearm, and Rs 5

Delhi Lieutenant Governor VK Saxena has written a letter to Chief Minister Arvind Kejriwal expressing his concerns regarding the delayed administration of the oath of office to Justice (Retd.) Umesh Kumar, who has been appointed as the Chairperson of the Delhi Electricity Regulatory Commission (DERC).

The LG has highlighted that Justice Kumar had confirmed his availability for the oath ceremony starting from June 26, 2023, onwards, but the process has not yet been initiat-

Emphasizing the importance of following the prescribed constitutional and statutory provisions, the LG has pointed out that the President has already appointed Justice Kumar as the Chairperson of DERC through a duly notified Gazette notification on June 21, 2023. The next step, as mandated by the relevant statutes, is for the Minister-in-Charge of Power to administer the oath of office to Justice Umesh Kumar.

The Department of Power,



under the direction of the Minister (Power), approached Justice Umesh Kumar on June 26, 2023, and he expressed his keenness to assume his responsibilities and made himself available for oath-taking from June 27 to June 29. The LG said that considering June 29 was a public holiday and the Power Minister was not available on June 30, the oath could have been administered on either June 27 or 28, instead of the proposed date of July 3, which

Justice Kumar disagreed with. The LG emphasised that while the Minister of Power is responsible for administering the oath of office and secrecy to the Chairperson and Members of DERC, this responsibility did not grant unlimited discretion to

Haryana Real Estate Appellate Tribunal (HREAT) has recovered Rs 39.88 crore while the Haryana Real Estate Regulatory Authority (HRERA), Gurugram has recovered Rs 8.61 crore from errant developers and refunded buyers over the last four years from 2019 to May

The authority has been pursuing concerned offices of district collectors for carrying out the recovery process.

According to a HRERA document, it has refunded a total of Rs 39,88,44,778 crore to buyers from 2019 to May 31, while the buyers have received Rs 8, 61,19,277 crore through the HRERA court from 2020 to May 31. The HRERA authority said that they had also issued warrants to different promotors during the recovery process.

Meanwhile, the HRERA, Gurugram announced that it has pronounced more than 7,000 judgments within five years.

While the builder of the

apartment complex has sealed the main gate of the unsafe Tower F, two families continue to stay in the tower. In a letter to the district

administration the Chintels Paradiso builder has asked for an intervention in the matter and get the two families to vacate the Tower F flats. The District Town Planner (DTP) said that a team will visit the housing society on Wednesday.

Some towers, including Tower F, of the society were declared unsafe by the authorities after two persons died last year when Tower D partially collapsed.

Earlier in May, district authorities issued a notice asking residents to vacate towers E and F within 15 days. Two other towers have also been declared unsafe.

As a precautionary measure, the developer of Chintels



Paradiso has barricaded Tower F and has issued an alert for all residents of the society to avoid going near the unsafe tower. The builder said in its letter to the district administration that the "sagging" balcony poses a serious threat but despite repeated requests, two families continue to stay in the unsafe tower.

"Ít has come to our notice that the balcony of F 403 is sagging and poses a serious threat to residents' movement. As per your directions no repair should be carried out in structures. Keeping the safety of residents in mind we are cordoning off the F tower area," the letter reads.

"In case of any mishap, we should not be held responsible as all precautions have been taken to make sure residents avoid use of the affected area," it fencing has also been done around the tower so that no one can go near the area surrounding the unsafe tower.

"Despite repeated requests two families are still living in the F tower. We request you to intervene in interest of their safety and immediately get the flats vacated," the developer said in In response, a district administration official said they

will visit Chintels Paradiso on

Wednesday. "We got the letter from the builder and our team will go to the society tomorrow and find the reason the two families are not vacating the flats," DTP (enforcement) Manish Yaday said. Meanwhile, Jitender Malik,

a resident who is yet to vacate his family's Tower F flat said he will vacate it in a week even though there are "no issues" with the flat. He said it is painful to vacate the house without any alternative accommodation or compensa-

Total length of NH increased by 59% in last nine years: Gadkari



Cashless treatment facilities for CGHS expanded

It eliminates the need for them to submit individual reimbursement claims and follow up for

approvals," Bhushan said. With this new initiative, the CGHS beneficiaries will have direct access to state-of-theart treatment facilities at these medical institutions, without the hassle of making upfront payments and seeking reimbursements from the CGHS.

Last week, the Union finance ministry approved the cadre review proposal for the group 'C' Tradesmen cadre of the ITBP, with the creation of 984 new head constable posts for these ranks by re-calibrating the existing strength, sources said.

There are eight tradesmen cadre categories in the ITBP - tailor, cobbler, gardener, cook, water carrier, barber, washerman and sweeper (safaikarmi). The ITBP secures the Indo-China frontier.

The total number of such

tradesmen was 7,097 in the 90,000 personnel strong force and their strength will remain the same after this cadre restructuring, they said. The final proposal that has

been approved by the government has abolished some existing posts and used them to create promotion posts in the rank of head constable for five cadres.

The tradesmen cadre is considered the backbone of any operational or administrative unit of the paramilitary forces including the ITBP as they ensure that the combat troops are battle or task ready all the time and in any security theatre, officials said.

They move and remain with the combat units at both forward and rear locations. These personnel are also combatised to meet

Monsoon is here

The changing monsoon patterns in India represent a complex challenge

his year the monsoon has reached different parts of the country in a new pattern. In many areas, it rained heavily in two days. The Indian Meteorological Department (IMD) has said that heavy rain is expected in 25 states in 48 hours. Usually, the monsoon reaches Mumbai by June 11 and Delhi by June 29. But this time the monsoon reached both the metro cities on the same day. With monsoon rains lashing across the country, the policymakers would be taking a sigh of relief as one of the most unpredictable weather phenomena has not taken them for a ride this year. The monsoon patterns have exhibited significant changes, bringing both challenges and opportunities for the agricultural sector and the nation's overall economic stability. Call it climate change or our wrongdoing to nature that monsoon has increasingly been erratic over the years. Over the years, there have been noticeable alterations in the monsoon's behavior, with variations in its onset, duration and

The delayed onset and erratic rainfall pose risks such as water scarcity, crop failures and reduced yields. Traditional crops,

such as rice and wheat, are particularly vulnerable to these climate shifts. This necessitates the development and adoption of climate-resilient crop varieties, better water management techniques and efficient irrigation systems to ensure food security and sustainable agriculture. While the changing monsoon patterns present challenges, they also create opportunities for diversification in the agricultural sector. Farmers are increasingly exploring alternative crops and agricultural practices that are better suited to the evolving climate conditions. For instance, drought-resistant crops like millets, pulses and oilseeds are gaining prominence as they require less water and exhibit resilience against climatic variations. This diversification can contribute to a more sustainable and adaptive agricultural system, reducing dependence on a few staple crops and enhancing the resilience of rural livelihoods. Farmer education and awareness about climate-smart practices, such as conservation agriculture and watershed management, are crucial for enhancing adaptive capacities at the grassroots level. Furthermore, the Government should formulate necessary policies to incentivise sustainable land use practices, afforestation and the preservation of water bodies.

ndia and US have taken one giant step in defence technology transfer and upgrade that makes their Global Comprehensive Strategic Partnership approach an alliance but allows India to preserve its strategic autonomy. In 1971 India joined USSR in an alliance that curiously mentioned India's strategic autonomy. India is on the cusp of a transformative revolution in national defence and security incorporating change in an adhoc fashion. As a founder member of the Defence Planning Staff which is the forerunner of the current Integrated Defence Staff, I have watched India undertake defence reforms in fits and starts and piecemeal. But a different beginning was made in the mid-1980s with a firm foundation for initiating and incorporating change systematically and logically against a strategic canvas.

The DPS integrated tri-service team carried out an elaborate evaluation of the Strategic and Technological Environment comparable to the contemporary Strategic Defence and Security Review (SDSR). From that evaluation emanated the 15-year Defence Plan which was referred to by then Defence Minister KC Pant in Parliament. It was the first time ever that an Integrated Defence Plan was devised. Another milestone was the significant change that occurred in national security policy following the Kargil Review Committee Report in 2000. Sadly its recommendations were implemented in bits and parts.

Although many defence reviews and several task forces have made piecemeal recommendations, no holistic review or any White Paper has been sought nor presented in Parliament. To date, parliament has not called on the government to do an SDSR which is mandatory in all democracies. When a new government takes up office in Whitehall UK, it is required to present SDSR or whenever the strategic environment changes, like in Ukraine, the government presents an Integrated Review or an war stocks upgraded to 20 days Integrated Review Refresh, as done recently in the UK. Fast forward to 2019. A Defence Policy Committee was created under NSA Ajit Doval which was expected to write the National Security Strategy (NSS) (equivalent to SDSR). He was elevated from MoS to Cabinet rank but NSS remained a mirage. From NSS hatched the National Defence Strategy. Till then, the Defence Ministers' Operational Directive was the Magna Carta. It was written by the Army's Military Operations Directorate and refined by the MoD. The last one was signed by Defence Minister AK Antony in 2009. Another was attempted in 2015. It contained orders for a two-front war to be fought for 30 days on an intense scale and 60 days normally. In 2013, Army Chief Gen VK Singh created a storm by writing to then Prime Minister Manmohan Singh that war stocks were sufficient for just 10 days of intense war. In 2020 the Operational Directive was fine-tuned with

– two-front, Cold start, nuclear or conventional - were decided without an strategic review.

The CDS was announced at the end of 2019 along with establishing the Department of Military Affairs, planning for integrated theatre commands and associated inter-service procedural changes, atmanirbharta in defence and the Agniveer recruitment scheme in 2022. These were groundbreaking changes. Further, the criteria for selecting CDS were changed after the first incumbent Gen Bipin Rawat died in an accident. His replacement was curiously a retired threestar General; the first time in the history of CDS appointments anywhere that someone who had not been a service chief was appointed to the job. Before being elevated to four-star rank and CDS, Gen Anil Chouhan worked with Mr Doval as security advisor to National Security Council Secretariat. The selection from a contrived system was baffling. The revolutionary reforms implemented since 2019 were unaccompanied by any inkling of a strategic assessment. No NSS nor NDS was forthcoming or expected.

Kerala's infamous material alteration



Universities in the State, once famous for their quality, have fallen into an abyss from where it is difficult to salvage their dignity

¬he acronym MA stands for Master of Arts, a postgraduate degree awarded by universities across the world in literature, humanities or arts. Some universities offer an M A degree in Mathematics. But if the trend in Kerala is any indication, the term M A stands for Material Alteration. The last name is a phrase from the Negotiable Instruments Act that governs rules and regulations dealing with the acceptability of Bank cheques.

One is likely to ask what Material Alteration has to do with the postgraduate degrees awarded by the universities in Kerala. The sad fact is that the universities in the State, well known once for their standards and etiquettes have fallen into an abyss from where it is difficult to salvage their dignity and quality. The last 14 days saw more than six cases of students fabricating fake M-A, M.Com and Ph D Degrees from various colleges that come under the jurisdiction of Kerala University and Mahatma Gandhi University.

All the students were leaders and activists of the Students Federation of India (the students' wing of the



academic and professional qualifications themselves were under the shadows of clouds, came out in the open and declared that these were isolated incidents to which one need not give any importance. M V Govindan, the party's Kerala secretary, issued a stern warning to the media persons asking them not to write anything against the SFI or the CPI-M. SRSB makes push to achieve SDGs



The Sustainability Reporting Standards Board (SRSB) feels that environment issues must be incorporated into a company's strategies and operations

rganizations that adopt sustainability reporting get a competitive edge in a market where consumer awareness is rising, in addition to helping the world's efforts to address urgent environmental and social concerns. Investors give due importance to ESG aspects in their decision-making processes, and consumers are expecting more goods and services from businesses that exhibit ethical and sustainable business practices. Governments and regulatory organizations are also stressing the need of achieving sustainable develop-ment and enforcing higher reporting stan-

As a statutory body, the Institute of Chartered Accountants of India (ICAI) regulates the profession of Chartered Accountants in India. A strong tradition of public service and economic development has distinguished the ICAI as the world's leading body of knowledge for accountancy. With the mission to formulate comprehensive and globally comparable standards for measuring and disclosing non-financial information about an entity's progress towards the UN Sustainable Development Goals (SDGs) 2030, the ICAI constituted the Sustainability Reporting Standards Board (SRSB) in February 2020. Several initiatives have been launched by the Board over the years to revolutionize the ideology behind sustainable reporting such as the introduction of Sustainability Assurance Engagement Standards, certificate courses on BRSR reporting, social audit standards, etc.

In May 2021, SEBI made a notable shift towards the adoption of the Business Responsibility and Sustainability Reporting (BRSR) framework in recognition of the need for a more comprehensive and integrated approach towards sustainability reporting. The BRSR framework acknowledges that sustainability issues should not be ignored or considered as a side issue, instead, they ought to be thoroughly incorporated into a company's overall operations and strategies by acknowledging the connection between sustainability and commercial performance. BRSR framework focuses on transparency and comparability. Organizations can give stakeholders reliable information about their sustainability practices by adopting a standardized approach to reporting and can also better streamline decision-making, increase transparency, and align sustainability with their core business strategy. This makes it possible for stakeholders to assess the sustainability performance of various businesses and make educated decisions.

The sustainability board of ICAI has come out with an innovative approach towards measuring an organ's ISAR ion maturity towards BRSR. On 18th March 2021, SRSB launched its Sustainability Reporting Maturity Model (SRMM Version 1.0") as a grading/scoring methodology for Business Responsibility and Sustainability Reporting (BRSR) released by the Ministry of Corporate Affairs (MCA) as part of its initiatives to build the sustainability ecosystem in the nation. This maturity model records an organization's progress towards sustainability reporting through four distinct degrees of sustainability maturity. The model integrates the most recent international trends and advancements in sustainability reporting. To increase the effectiveness of the model, the SRSB collaborates extensively with a variety of stakeholders including academics, civil society organi-

from around the nation. Based on the changes brought in by the SEBI BRSR circular, SRMM Version 1.0, was further updated to Version 2.0 by the board. To assist organizations in implementing the SRMM, the SRSB has also set up a network of training and support facilities. It is also creating several tools and resources to assist organizations with their sustainability reporting.
The SRMM offers organizations

looking to improve their sustainability reporting practices several advantages. SRMM is a self-assessment tool that gives organizations a clear structure and path so they can evaluate where they are now and where they need to improve. Organizations can efficiently prioritize their tasks and allocate resources by assessing their maturity level, which provides them with insights into their strengths and limitations. Secondly, the model also encourages organizations to go up through the levels, promoting the maturity of sustainability reporting. The approach helps organizations gradually improve their reporting procedures and incorporate sustainability into their primary business strategy by outlining a clear path. The model has four unique stages, each of which corresponds to a different level of sustainability report-ing maturity. All 4 levels are defined based on the overall range of scores that a corporate entity has scored within a fiscal year using the BRSR scoring system. The SRMM has a total score of 300 points divided across all the sections of BRSR. By assigning a score of 75 out of 300 to leading indicators, firms are encouraged to set goals for achieving them. Each maturity level depicts the current state of sustainability reporting and motivates the company to achieve a higher stage as the new reporting cycle begins. A company may use the SRMM scoring mechanism to self-assess its BRSR reports and assign a score for each parameter reported as per the format given in SRMM which will fur-ther decide the maturity stage of reporting achieved by the company. The SRMM document released by SRSB clearly defines the methodology for calculating a company's score. As the current BRSR format is general and is applicable to all sectors, therefore, it might be a possibility that certain indicators are not applicable for a particular type of industry, e.g., if the concept of "Extended Producer Responsibility" is not applicable to a particular industry, then the grand total score would be reduced by 3 and will become 297 and further the maturity level will be calculated as a percentage of the score achieved out of score applicable. This feature of SRMM makes it even more useful.

A company scoring up to 25% falls in the first stage or the Formative stage of SRMM. This stage implies that the company is in the nascent stage of reporting and is still outlining the fundamental facts and identifying the need and responsibility of BRSR. These companies are actively trying to collect data and establish policies related to sustainability. A company scoring more than 25% and up to 50% falls under the Emerging stage which is the 2nd stage in the SRMM. Level 2 organizations tend to be more aware of the importance of BRSR and have a strong mechanism for reporting the same, but these businesses are constantly working towards enhancing and establishing the current internal control system and collecting data for disclosures.

Level 3 or the Established Stage is achieved when a company has a BRSR score of more than 50% and up to 75%. These organizations have established business strategies and functional systems for reporting BRSR parameters efficiently. Such organizations are actively involved in compliance functions and are more focused on improving and accelerating the qualitative aspects of their business.

A company with a score of more than 75% qualifies for the highest level of sustainability reporting maturity - Level 4 and is in the stage of leading by example. At this level, sustainability is deeply ingrained in the culture and ethos of the company. Organizations actively work to have a beneficial social, environmental, and economic impact. They demonstrate creativity and adopt cutting-edge sustainability trends and best practices. Companies that are a part of Level 4 are constantly involved in innovative methods so as to enhance their disclosures and work towards becoming a market leaders. As they advance through the levels, organizations become industry leaders in sustainability reporting, link sustainability with their core business strategy, enhance transparency and accountability, and create value. The SRMM is a useful tool in the effort to create a company environment that is more ethical and sustainable.Offering a road map for improving their sustainability reporting practices, it aids organizations in prioritizing their efforts. It encourages organizations to develop from fundamental compliance to more sophisticated and integrated reporting practices as it leads them through the four degrees of maturity. Organizations can improve their knowledge of where they stand right now and the steps necessary to advance to higher levels of sustainability reporting maturity by using the SRMM. By measuring sustainability performance, setting targets, and monitoring progress, organizations can improve their environmental, social, and economic impact. Considering this, it is a call to action for businesses to adopt the SRMM and work towards a more responsible and sustainable future. Organizations may increase their credibility, fulfil stakeholder expectations, and help the world's sustainability goals by putting

Rural girls are yet to attain computer literacy

Many schools in rural areas have computer infrastructure, but it is often insufficient to provide proper computer education to the students, especially girls

In today's era of advanced technology, where Artificial Intelligence (AI) and digital innovations are transforming lives, it is disheartening to acknowledge that several remote villages in India still lag behind, lacking even the most basic digital literacy. Talking about remote hilly villages in Uttarakhand, the privilege of knowledge and access to digital literacy still remains elusive, especially for girls. One such village is Selani, located in the Garur block of Uttarakhand, where Kumari Mamta, an adolescent girl, faces numerous challenges in accessing com-

However, due to her lack of computer skills, Mamta and her friends find themselves dependent on the distant CSC for their basic

Mamta lamented, "In order to have computers in our village, we first need a reliable network. Currently, even filling out a simple form for college or other courses requires us to travel long distances. Unfortunately, we often miss deadlines due to lack of information or money completing higher secondary education, the career options for girls diminish significantly as we are not provided with computer education. Furthermore, we do not have any facilities nearby to access digital services and learn. Consequently, girls are frequently compelled into early marriages, with limited choices available to them." Lack of access to comput-

ers may seem like a minor problem, but its impact on people's lives, particularly girls living in rural areas, is significant. Acquiring basic computer skills can empower these girls, providing them with access to knowledge that allows them to make informed decisions. Moreover, computer literacy to cover travel expenses. After opens up opportunities for

completed their education.

According to a recent report, digital literacy rates among women in India are significantly lower compared to men, with only 23% of women being digitally literate compared to 59% of men. One of the primary reasons for this disparity is the lack of access to digital infrastructure and opportunities, particularly in close proximity to where girls live. As a result, they are unable to acquire the necessary skills and knowledge in this field, leading to the mentioned data.

Sangeeta Devi, a mother of an adolescent girl from the village, highlights the challenges faced by girls in pur-suing digital literacy. "Due to

employment once they have sible to send girls from the village to the towns for computer classes. However, establishing a computer centre within the village would greatly facilitate their learning process. This would provide a convenient and safe envi-ronment for girls to access digital education, empowering them with valuable skills for the future," Sangeeta shared.

Kumari Asha Dosad, another teenager from the village, expressed her frustration about the current situation. "It has been two years since I completed 12th grade, and I find myself sitting at home with no prospects for the future," lamented Asha. Like many others, Asha aspires to achieve something meaning-

any way forward. She understands that computers can be powerful tools for acquiring knowledge, but unfortunately, she and her fellow villagers have no means to access this valuable resource. Despite their strong desires, they have been unable to accomplish anything due to the lack of opportunities.

Neelam Grundy, a development practitioner from the region, similarly highlights the significance of digital literacy for adolescent girls. She believes that it is crucial for them to possess this skill set as it empowers them and makes them selfreliant. "While women and girls in cities have multiple opportunities for selfreliance, those in rural areas safety concerns, it is not fea- ful in her life, but she can't see rarely have such prospects.

Several factors contribute to this disparity, including the lack of educational opportunities, gender-based discrimination, and the absence of free and accessible computer literacy programs. Consequently, girls in rural areas are deprived of holistic development," expressed

Many schools in rural areas have computer infrastructure, but it is often insufficient to provide classes to the students. As a result, some students, who have the facilities and consent from parents can acquire the knowledge by going to centres in the towns. While the rest who lack such privileges remain entrenched in an unyielding cycle of adversity.

'Sharif, Zardari meet in UAE over Pak polls, seat sharing'

ormer Pakistan prime min-Former Pakistan P. mer president Asif Ali Zardari have reportedly met in the UAE to consult and decide on the timing of the next general elections in the country and "their respective share" in the future set-up, a media report said on Tuesday.

The meeting between Nawaz Sharif, the supremo of Pakistan Muslim League-Nawaz (PML-N) and Zardari, the co-chairman of the Pakistan Peoples Party (PPP), both parties a partner in the ruling coalition Pakistan Democratic Movement (PDM), happened in Dubai on Monday afternoon to hammer out a consensus on a number of key issues like finalising names for the caretaker set-up and deciding who will get what key position if the two partners win the next elections, the Dawn News reported.

"The uncertainty surrounding the next general elections may end soon after detailed deliberations by the top leadership of the two main coalition partners in the federal government are concluded in the UAE," said the report, citing sources.

Insiders said that it was decided that elder Sharif of PML-N and Zardari of PPP, would "talk directly" on these issues instead of allowing a prolonged debate "at the lower level", which would be a waste of time.Pakistan, currently in the throes of a major political as well as economic crisis, started preparations for the general elections with a meet ing of the election commission recently. The PDM is also fighting the challenge posed by former prime minister Imran

The current National Assembly will complete its five-year term on August 12 and the fresh general election must be conducted within 60 days as laid down in the

Constitution of Pakistan. A PML-N insider said that the main agenda of the Sharif-Zardari meeting was elections in October or beyond.

"If the elections are held at their scheduled time, then the caretaker set-up in the centre will be of the PPP and PML-N's choosing after taking Maulana Fazlur Rehman on board, of course," the source was quoted

Monday saw the first meeting between the two sides, and it is expected that these huddles will continue until a consensus can be evolved on three major issues: a date for the general elections, the shape of the caretaker set-up and deciding whether to contest elections independently or make some seat adjustments, the report said. The two leaders strongly condemned cross-border terrorism, and the use of terrorist proxies and "called on Pakistan to take immediate action to ensure that no territory under its control is used for launching terrorist attacks.

In an interview with CNN on Thursday, Obama reportedly said if India does not protect the rights of "ethnic minorities", there is a strong possibility at some point that the country starts pulling

Defence Minister Rajnath Singh and other senior ministers have slammed Obama for his statement, saying, "He (Obama) should also think about how many Muslim countries he has attacked (as US president)".

Netanyahu: China invited me for visit

Tsraeli Prime Minister Benjamin Netanyahu said on Tuesday that he has received an invitation for an official visit to China, but did not disclose whether or when the trip would take place.

The Israeli leader made the announcement during a meeting with visiting members of the US Congress. The invitation follows several recent overtures by Beijing to increase its diplomatic footprint in the region and comes at a time of heightened friction between the Biden administration and Netanyahu's ultranationalist and ultra-Orthodox government.

Netanyahu's office said the projected visit" to China would be his fourth as prime minister. It said it notified the Biden administration, which has a rocky relationship with China, about the invitation last month. It declined to comment on pos-

sible dates for the trip.
China has taken a more strident role in Mideast diplomacy in recent months, brokering a deal to restore ties between Israel's archenemy, Iran, and Saudi Arabia in April and hosting Palestinian President Mahmoud Abbas in Beijing earlier this month.

Israel and China have close economic relations, but Israel's diplomatic and security ties with the US have precluded closer collaboration with China.


Netanyahu, Israel's longestserving prime minister, returned to power in late 2022 after forming a coalition with ultranationalist and ultra-Orthodox allies, the most hardline and religious government in Israel's 75-year history. After launching an attempted overhaul of the country's judiciary in January while Netanyahu is on trial on corruption charges, the government has faced weekly mass protests as well as criticism from Washington. In light of that contentious judicial overhaul, as well as the government's aggressive advancement of West Bank settlements, Netanyahu has not yet been invited for a White House visit. Such visits are normally standard practice for Israeli leaders.

Hipkins visits China to boost economic ties

New Zealand Prime Minister Chris Hipkins discussed his country's interest in boosting economic ties with China during a meeting with Chinese President Xi Jinping in Beijing on Tuesday.

Hipkins said the focus of his meeting with Xi was to "reaf-firm our close economic relationship by supporting businesses (to) renew their connections with Chinese counterparts and helping grow new ones to support New Zealand's economic recovery."

Hipkins is on a five-day visit to China, his first since becoming prime minister in January, along with a business delegation representing areas including tourism and education.Before starting his visit, he described New Zealand's relationship with China as a "critical part of our economic recovery."New Zealand officially entered a recession this month after its economy contracted for two consecutive quarters. Officials



say China is key to three of New Zealand's engines for post-pandemic economic recovery: exports, tourism and education.

China is New Zealand's largest export market, and Wellington over the years has managed to maintain warmer ties to Beijing than some of its Western allies. New Zealand has issued critical statements about China's human rights and foreign policy practices, but has generally experienced less friction with China than other countries in the region such as

Australia. Xi praised "the great importance" of China-New Zealand ties, saying Hipkins' visit was "very meaningful," according to the official Xinhua News Agency.

Earlier in the day, Hipkins attended a meeting of the World Economic Forum in the Chinese port city of Tianjin alongside other foreign officials and joined a signing ceremony for four New Zealand exporters and their Chinese counterparts, according to a statement from his office.

China's economic growth accelerating: Li Qiang

Beijing (AP): China's No. 2 leader said Tuesday that economic growth accelerated in the latest quarter and expressed confidence it can hit the ruling Communist Party's official target of 5 per cent for the year.

Premier Li Qiang, speaking at a conference in the eastern city of Tianjin, gave no figure for the three months end ing in June but said it was faster than the previous quarter's 4.5

The world's second-largest economy rebounded from 2022's unusually weak 3 per cent growth following the end of anti-virus controls on travel and business activity. But that faded faster than expected. Consumer and factory activity weakened in May and record-setting youth unemployment spiked up.
"It is expected that the

second quarter will be faster than the first quarter," Li said

at the World Economic Forum "We expect to achieve the economic growth rate of about 5 per cent determined at the start of the year."

Private sector forecasters expect China's economic output to grow by at least 5 per cent this year, but some have cut their outlooks following May's weak activity.

UN: Taliban takeover in Af claims over 1k civilian lives

¬he United Nations said Tuesday it has documented a significant level of civilians killed and wounded in attacks in Afghanistan since the Taliban takeover — despite a stark reduction in casualties compared to previous years of war and insurgency. According to a new report by the U.N. mission in

Afghanistan, or UNAMA, since the takeover in mid-August 2021 and until the end of May, there were 3,774 civilian casualties, including 1,095 people killed in violence in the coun-

That compares with 8,820 civilian casualties — including 3,035 killed — in just 2020, according to an earlier UN

The Taliban seized the country in August 2021 while US and NATO troops were in the final weeks of their withdrawal from Afghanistan after



two decades of war. According to the UN report, three-quarters of the attacks since the Taliban seized power were with improvised explosive devices in "populated areas, including places of worship, schools and markets," the report said. Among those killed were 92 women and 287 children. The figures indicate a significant increase in civilian harm resulting from IED attacks on places of worship — mostly belonging to the minority Shiite Muslims compared to the three-year

The statement also said that at least 95 people were killed in attacks on schools, educational facilities and other places that targeted the predominantly Shiite Hazara community. The statement said that the majority of the IED attacks were carried out by the region's affiliate of the Islamic State group — known as the Islamic State in Khorasan Province — a Sunni militant period prior to the Taliban group and a main Taliban rival.

Hancock: UK was ill-prepared for pandemic because resources were diverted to Brexit'

Britain was ill-prepared for a pandemic partly because government resources had been diverted away from pandemic planning to brace for a possibly chaotic exit from the European Union without a deal, the UK's former health secretary told an inquiry on Tuesday

Matt Hancock also said officials had to scramble to source protective equipment, set up mass testing and contact tracing systems "from scratch" once the coronavirus pandemic broke out because the UK's planning attitude was entirely geared towards how to clear up after a disaster, not prevent it".

"The doctrine of the UK

was to plan for the consequences of a disaster — can we buy enough body bags? Where are we going to bury the dead?" Hancock said.

"Large-scale testing did not exist and large-scale contact



tracing did not exist because it was assumed that as soon as there was community transmission, it wouldn't be possible to stop the spread, and therefore, what's the point in contact tracing?" he added.

That assumption was

"completely wrong" and a olossal" failure, Hancock said.

Hancock acknowledged that an official pandemic preparedness board paused its work in 2018 to 2019 because resources were moved away to a "disorganised Brexit". Britain's government was

consumed in 2019 with the possibility of crashing out of the EU without a deal on the departure terms in place. A bitterly divided Parliament rejected then-Prime Minister Theresa May's Brexit plan three times.The UK eventually left the trade bloc in 2020. As health secretary,

Hancock became one of the best-known politicians in Britain as he led efforts to halt the spread of the coronavirus before he was forced to quit in June 2021, when he was caught breaking social distancing rules with an aide. Pictures of him kissing the aide in government offices were splashed across front pages at the time.

Hancock has previously faced criticism about the UK's COVID testing measures and how authorities failed to manage the spread of the pandem-

The UK had one of the highest COVID-19 death tolls in Europe, with the virus recorded as a cause of death for almost 227,000 people. Hancock said an emotion-

al sorry on Tuesday to all those who died and were affected. "I'm profoundly sorry for

each death that has occurred. I also understand why, for some, it will be hard to take that apology from me," he said.

Earlier, Hancock was confronted by members of the group COVID Families for Justice who held up pictures of relatives who died in the pandemic as he arrived at the inquiry in central London. The wide-ranging inquiry, led by a retired judge, aims to investigate the UK's preparedness for the coronavirus pandemic, how the government responded and what lessons can be learned for the future.



The Justice Department's ■ watchdog said on Tuesday that a "combination of negligence and misconduct" enabled financier Jeffrey Epstein to take his own life at a federal jail in New York City while he was awaiting trial on sex trafficking Inspector General Michael

Horowitz cited the federal Bureau of Prisons' failure to assign Epstein a cellmate after his previous one left and problems with surveillance cameras as factors in Epstein's death.

Horowitz also said that Epstein was left in his cell with too many bed linens, which are a security issue and were used in his suicide.

The inspector general issued a report detailing find-



ings of his investigation into Epstein's August 2019 death, the last of several official inquiries into the matter. He reiterated the findings of other investigations that there was no indication of foul play, rebutting conspiracy theories surrounding the high-profile death. Horowitz echoed previ-

ous findings that some members of the jail staff involved in guarding Epstein were overworked. He identified 13 employees with poor performance and recommended charges against six workers. Only the two workers tasked with guarding Epstein were charged, avoiding jail time in a plea deal after admitting to falsifying logs. The report comes more than four years after Epstein took his own life at the Metropolitan Correctional Centre while awaiting trial on sex trafficking and conspiracy It also comes weeks after




CAD narrows to 0.2% of GDP in Q4 FY23

India's current account deficit narrowed to \$1.3 billion or 0.2 per cent of the GDP in the January-March quarter of FY23, mainly due to moderation in the trade deficit and a robust increase in services exports, RBI data showed on Tuesday.

However, for the 2022-23 fiscal, the current account balance recorded a deficit of 2 per cent of GDP compared to 1.2 per cent in 2021-22.

"India's current account deficit (CAD) decreased to USD 1.3 billion (0.2 per cent of GDP) in Q4:2022-23 from USD 16.8 billion (2.0 per cent of GDP) in Q3:2022-231, and USD 13.4 billion (1.6 per cent of GDP) a year ago [Q4:2021-22]," as per the RBI's 'Developments in India's Balance of Payments during the Fourth Quarter (January-March) of 2022-23'.

The sequential decline in CAD in the fourth quarter of 2022-23 was mainly on account of a moderation in

Regarding BoP during 2022-23, the RBI said the current account balance recorded a deficit of 2.0 per cent of GDP in 2022-23 compared to a deficit of 1.2 per cent in 2021-22 as the trade deficit widened to USD 265.3 billion from USD 189.5 bil-

lion a year ago. Net invisible receipts were higher in 2022-23 due to an increase in net exports of services and net private transfer receipts, even though net income outgo was higher year-on-year.

Net FDI inflows at USD 28 billion in 2022-23 were lower than USD 38.6 billion in 2021-22.

The fiscal year also witnessed a depletion of USD 9.1 billion of the foreign exchange reserves (on a BoP basis).

Slowdown in India's start-up story: Unicorn additions fall to 3

New additions in the coveted unicorn list declined sharply in 2023, indicating a slowdown in the Indian startup ecosystem, a report said on Tuesday.

India added only three unicorns — startups having a valuation of over \$1 billion in 2023 against 24 in the yearago period, as per the ASK Private Wealth Hurun Indian Future Unicorn Index 2023. The slowdown in unicorn

additions is indicative of a "slowdown in India's startup ecosystem", the report -- which comes amid a slowdown in investor interest in what is being termed as "funding winter" -- said. The overall number of unicorns also declined to 83 from 84 in the year-ago peri-

ASK Private Wealth's chief executive and managing director Rajesh Saluja said unsustainable business models adopted by startups have led to a dip in valuations but stressed

that funding to the right companies continues

Hurun India's chief researcher Anas Rahman Junaid, however, said that the Indian startup story has high potential and he sees the overall number of unicorns in India touching 200 in the next five

He said China has over 1,000 unicorns and if India were to grow economically, startups will be very important.

Junaid said the overall number of startups in the list, which has startups valued at over USD 250 million, stands at 147 in 2023 compared to 122 in the year-ago period.

A total of 18 companies got

dropped off the list last year, but there were over 40 new additions as well, as per the report. Saluja said the overall funding to the startups on the list grew by 6 per cent to USD 18.8 billion.

Junaid explained that Hurun used regulatory filings and interviews with startup investors to arrive at the valuations and then subsequently make the index of unicorns (valued at over USD 1 billion), gazelles (valued at over USD 500 million which are likely to turn unicorns in three years) and cheetahs (valued at USD 250 million likely to turn unicorn in five

observed over the time the number of issuers that are non-cooperative with CRAs (Credit Rating Agencies) have increased, with a vast majority of INC issuers being unlisted and small entities.

In this regard, to provide enhanced transparency and information regarding noncooperative issuers to various



stakeholders, market participants and investors, Sebi said, CRA shall disclose two lists of issuers who are non-cooperative with the CRA, separately for securities that are listed, or proposed to be listed, on a recognised stock exchange, and

The list would be disclosed

in a prescribed format and the disclosure would be updated on a daily basis, the Securities and Exchange Board of India (Sebi) said in a circular.

The new circular will be applicable with effect from July , 2023, it added.

Under the rules, every CRA has to carry out periodic reviews of all published ratings during the lifetime of the securities, unless the rating is withdrawn. However, in case a client does not cooperate with the CRA, the CRA is required to carry out the review on the basis of best available information or in the manner spec-

weather of Chennai and on a track expected to be on the slower side and support spin, India would hope to trouble the Australians with their spin attack on October 8.

Sehwag urges India to win WC for Kohli like 2011 batch did for Tendulkar

 $D^{\text{rawing inspiration from its}}_{\text{last World Cup triumph,}}$ India is looking to win the upcoming tournament for Virat Kohli like the batch of 2011 won it for Sachin Tendulkar, feels former opener Virender Sehwag.

Since winning the 2011 World Cup which Kohli was a part of, India have won only one ICC event — the 2013 Champions Trophy — and their wait for lifting a trophy in another global event has now lasted more than a decade.

"We played that World Cup rld Cup, and it was a great exit for Sachin paaji," Sehwag said during an ICC event to announce the World Cup schedule.

"Virat Kohli is (now) in Sachin Tendulkar's shoes. The way he plays, he talks, he looks after the others and the way he plays cricket with his passion, he is the one now. Everybody is looking to win this World Cup for Virat Kohli," he added.

"Virat Kohli is the same now. Everybody will look to win the World Cup for him. He always gives more than 100 per cent. I think Virat Kohli is also looking (forward) to this World Cup. "(About) 100,000 people will watch you at the Narendra Modi Stadium in Ahmedabad. Virat knows how the pitches will behave. I am sure he will score a lot of runs and he will do his best to win the World Cup for

Sehwag said India are favourites to win their blockbuster clash against Pakistan on October 15 in Ahmedabad because they can handle pressure



comparatively better.

Sehwag said, "I feel that now India handles the pressure that is why they win whereas Pakistan have a burden that they haven't won against India. In the 1990s, they were good at dealing with pressure but after 2000, India soak it better. "If any player says that they don't feel pressure, I don't think it's right. We used to say it too but at the end of the day, we know it's an India versus Pakistan game and emotions run high," he said.

Sehwag said players from countries like England and Australia tend to do well if the wickets are good but the same players struggle against spin.

"A player from the subcontinent has a better idea (of playing spin) than someone coming from outside," he said, adding end up playing a final before the final if they meet in the semifinals. Sri Lankan spin legend Muttiah Muralitharan said since the World Cup is in the subcontinent, spinners will have a big role to play and agreed with Sehwag that India, England, Australia and Pakistan could be the favourites for the semifinals.

"I am looking forward to the India-England match. That will be a tough match. England is playing really well at the moment. India is one of the favourites in my mind because they are playing at home and they know the conditions really well. They know how to win in India," said Muralitharan, adding that Adil Rashid would be his pick as the most success-

TA7hen is Jasprit Bumrah team? Neither the injured pacer nor the ones working on him have a definitive answer to that.

But the good news is that Bumrah has bowled seven overs in a day at the National Cricket Academy (NCA) nets, a development that will bring smile to the Indian fans looking forward to the 2023 World Čup with optimism. The schedule for the mega event was released in Mumbai on Tuesday.

Bumrah had undergone surgery for a recurring back niggle in New Zealand in March and since then he has been on the recovery path. Bumrah has last played for India during the home T20Is against Australia in September, 2022. So, will he be able to make a comeback during the T20I series against Ireland or in the Asia Cup?

"For an injury of this nature, it is not wise to set any timeline as constant monitoring is necessary. But it can be said that Bumrah is recovering well and he has bowled seven overs at NCA nets. It is a steady increase

in his workload from the light workouts and bowling sessions of the initial period. "He will play next month, and there will be a close assessment of his fitness then," a source tracking the development told PTI.

Ramji Srinivasan, former strength and conditioning coach of Team India, said extreme care should be taken while bringing back Bumrah.

"He should not be hurried. Playing practice matches at the NCA is a good step as it will help tune his body to the demands of a match. But he should be made to play in some actual (domestic) matches before bringing him to top level cricket.

The demands of international cricket are different and the body should be absolutely ready to take that amount of workload. Recovering from stress fracture is a delicate exercise and Bumrah should be allowed maximum recovery time," Ramji told PTI. KL Rahul and Shreyas Iyer, who have also been recuperating at NCA, are also progressing as expected, though no specific timeline has been set for their return as well.

The Pakistan Cricket Board (PCB) is still apprehensive about sending its team to India for the ODI World Cup but International Cricket Council (ICC) is "confident" that the Babar Azam-led team will compete in the 50-over showpiece.

The ICC on Tuesday announced the fixtures for the October 5-November 19 tournato not schedule their matches in Chennai and Bengaluru against specific teams.

PCB did not want to play Afghanistan on a spin-friendly track in Chennai and also wanted to avoid facing Australia in Benglauru. As part of the announcement in Mumbai, it was confirmed that Pakistan will lock horns with India in Ahmedabad on October 15 and take on Australia (October 20) and Afghanistan (October 23) at pre-decided venues.

Soon after the announcement, the PCB made it clear that its participation in the ODI World Cup will be subject to government clearance.

"Our participation in the World Cup and us playing in Ahmedabad on October 15 or in Mumbai if we qualify for semi-finals will all be dependent on government clearance," said

a PCB official. The PCB official said the government has not yet issued any NOC to the PCB to travel to India and since it was a sensitive issue, the Board can only move forward after getting clear directives from its government. 'We have already informed

the ICC that our participation in the tournament or any issues over venues is linked to firstly the PCB getting clearance from the government to travel to India," the official said.

Pakistan have a signed participation agreement to compete and the world governing body "100% expects them to be there and has had no indications to the contrary'

"All members have to abide by the rules and the laws of their country and we respect that. But we're confident Pakistan will be in India for the men's cricket World Cup," an ICC spokesperson told PTI.

Pakistan last played in India in 2016 in the T20 World Cup. The two teams play each other in the ICC events and Asia Cup due to the tense relations between the two countries.

The ICC not entertaining Pakistan's request to relocate two matches was on expected lines as it usually addresses concerns over venues on potential security threat and not on cricketing grounds. With the elections for the post of PCB chairman now postponed at least until July 17, it remains to be seen how the Board reacts to the World Cup

schedule announcement. With the Balochistan High Court issuing a stay order against the holding of elections for the Chairman's post on Monday on petitions filed by two former members of the PCB's cricket management committee, confusion reigns in Pakistan cricket at the moment.

After Najam Sethi's resignation, the Board is being run by interim chairman Ahmed Shehzad Farooq Rana. Zaka Ashraf, nominated for the chairman's post, has to win votes of the Board of Governors to officially take charge of the key post.

England call up Tongue in all-pace attack for 2nd Ashes Test

Seamer Josh Tongue has replaced Moeen Ali in England's team for the second Ashes Test against Australia at Lord's. Spinning allrounder Moeen suffered a burst blister on his right index finger in the narrow two-wicket defeat in the series opener at Edgbaston.

Worcestershire paceman Tongue, 25, is preferred to the express pace of Mark Wood — whose career has been blighted by injuries — for the match, which starts on Wednesday.

Seamer Chris Woakes and legspinner Rehan Ahmed were also overlooked in preference of Tongue, who impressed with a maiden fivewicket haul on his debut against Ireland earlier this month.

"We needed to get to Lord's first and see what conditions we were faced with," England captain Ben Stokes said on Tuesday.

"We wanted to play Mark Wood but we felt while he could definitely start the game, we felt an extra week of build-up and loading him would give him a better chance to play fully from Headingley (third Test)

"And we brought Tonguey into the team as a like-for-like with Woody. I'm looking forward to seeing Tonguey continue his great start he had against Ireland here.

"Me and Mark are great friends, we go back a long way...I spoke to him about how I'd want him to operate in this game and he was very honest with me. He wasn't sure if he'd be able to give what he's known for throughout this Test match. So the decision was made to allow him to keep building his body up to give himself the best opportunity to go out from Leeds onwards to play a full

nament begins Thursday when hosts Zimbabwe play Oman. The top two finishers in the Super Six will qualify for the World Cup in India in October and November.
