INDIA'S GREEN GLORY

elangana has emerged as India's glory. Thanks to the pace at which it had regained its lost allure as a granary, the land is being looked upon as an enchanting paradise today. Horticulture gardens and plantations that stretch lushly on either side of the highways and rural roads are unusual of its past and they are the visible reality of its quick transformation. Consecutive failure of monsoons, recurring drought, mounting debts, and the unending story of farmers' suicides were once the order of the day. It is altogether a different story now.

Haunted by money lenders, thousands of families of farmers and farm workers deserted their homes and farms and moved to distant towns and cities in search of fresh meadows. Devoid of livelihoods, people were forced by the wretched conditions they lived in and many preferred to sell agricultural lands for a song. There were instances where lands were traded off for milch animals as the scarcity conditions that persisted for long years rendered farming the most baneful activity.

The lands had no takers those days and people pinned no hope on them. But today agricultural lands are the most sought-after. A piece of land has turned dearer than a nugget of gold. Costing no less than Rs 25 lakh to Rs 50 lakh an acre anywhere in the State, there is hardly any seller. Even in the remotest pockets, vast tracts of land are seen lying verdant even under the harsh sun.

Close on the heels of a bumper harvest of Yasangi they had towards the end of April last, farmers are busy again with brisk activity in preparation for the ensuing Vanakalam season. The agrarian crisis was the most talked about in the history of the region. But now, there is a drastic decline in the number of suicides and those ending lives by suicides had not much to do with farming. The loan waiver extended by the State by writing off Rs 17,35L47 crores of crop loan taken by the 40,74,522 farmers 2014 to 2018 came in handy for restoring the dwindled fortunes of the peasant community. Outstanding crop loans of up to Rs.1 lakh per farmer family as on December II, 2018 were made eligible for waiver. In the annual budget for 2023-24, an allocation of Rs 6,385 crores has been made to clear crop loans.

The extortionist groups that nurtured the practice of funding in kind by collecting 50 to 100 kgs of produce from each farmer right in their khallas in the extremist-affected areas have no trace today. Peace that prevailed all over the State with stable administration and effective law and order resulted in unfaltering progress that helped in shaping up country's most envied as well as the much craved for Telangana model.





Rejuvenation of water bodies under Mission Kakatiya not only improved water availability, but also helped in recharging ground water across the State. Mission Kaykatiya was launched for the restoration of all irrigation tanks, kuntas, anicuts, and check dams in 2016. Under the programme 27,819 tanks were taken up and 21,633 of them were restored with an expenditure of Rs 5,464 crores. With capital outlay of about Rs 3,825 crores, a total of 1,200 check dams were proposed on 4th to 8th order streams to capture run-off and regenerated water in such minor sources. The initiative was intended to ensure the rejuvenation of the streams and also to prevent sedimentation in the reservoirs. It was intended to develop the State irrigation sector with a holistic approach, Providing real-time status of works on projects and App based progress reports, the project monitoring system (PMS) was developed.

'Power-packed' performance

hen Telangana was carved out of Andhra Pradesh in 2014, it was a power-deficit State, with industrial consumers facing power holidays of up to three days in a week and no supply during peak hours. Domestic and commercial consumers faced up to six hours of power cuts. There were power cuts for 12 to 16 hours in villages, 8 to 12 hours in mandal centres. 6 to 10 hours in district centres and even in capital Hyderabad.

The farm sector had erratic supplies as against the promise of seven hours per day. Farmers' suicides were common due to debts. The rulers in undivided AP even predicted that Telangana would plunge into

darkness once a separate State was carved out and that there would be no development.

However, in less than a year, power cuts were lifted in the new State, and quality power was supplied to all sectors. The government ensured that there were no power cuts, a round-the-clock power supply was available for domestic, commercial, and industry, and a nine-hour supply to the agriculture sectors.

There was a peak power demand shortage of 2,700 MW. However, within a few years, the State turned things around and by the end of 2019-20, Telangana turned into a power surplus State. It was because of the sustained efforts and focus

laid by Chief Minister K Chandrashekhar Rao on the power sector that Telangana could become a power surplus State that managed to increase the contracted installed power ca-pacity from 7,778 MW in 2014 to the current 18,567 MW. The State government invested Rs. 39,321 crore for strengthening the Transmission and Distribution network in the State in

the last nine years, Today Telangana is managing to supply 24-hour free power to agriculture and uninterrupted power supply to both domestic and industrial sectors. Power consumption has increased substantially in commercial and industrial sectors due to quality power supply without any power cuts. For all those who said there would be total darkness in Telangana, this growth story is an eye-opener.

Due to the availability of power and pro-industrial policies of the government, business houses have started trusting the government and several multinational and Indian companies have opened their facilities in the State and invested billions of dollars.

In order to provide uninterrupted power supply to farmers, the Telangana government in January 2018 launched 24X7 power supply to the State's 2.3 million farmers free of cost, and today, the number has increased to 27.20 lakh agriculture consumers. To increase its power production capacity, the Telangana State Power Generation Corporation Limited, commissioned four units of Bhadradri Thermal Power Station (4x270MW 1080MW), and efforts are being made to commission two Stage-I units and synchronise one Stage-II unit of the 5×800 MW Yadadri Thermal Power Station by June 2023.

The remarkable progress made in the power sector in Telangana has caught the attention of the nation. Today Telangana is setting an example to other States in the country for registering rapid progress in electricity in a short time.

Empowering the marginalised

Various schemes and initiatives by the TS government have addressed the needs of the downtrodden helping them lead a better life

he Telangana government has taken inclusive growth to the next level by implementinst a range of welfare schemes benefiting all sections of society. These initiatives by the Chandrashekhar Rao government are aimed at improving the lives of the poor, marginalised, and vulnerable, and empowering them to lead a better life by addressing their needs.

Through the implementation of these unique schemes, the State government succeeded in reversing decades of injustice done to these sections of society and providing them with a level playing field with others. While some of these schemes are meant to give hope for a better life, others are aimed to empower these marginalised and vulnerable sections.

The Bharat Rashtra Samiti (BRS) government spent a whopping Rs 2.29 lakh crore for social welfare in the last nine years. In terms of annual expenditure for social welfare, Telangana stands first among all other major States. As against Telangana's Rs 33,443.14 crore allocated in 2022-23, the budget allocation for social welfare in Uttar Pradesh was Rs 24,420 crore, Kar-nataka Rs 22,337 crore, and Raiasthan Rs 15,563 crore. In 2023-24 fiscal, Telangana allocated Rs 35,547 crore for all welfare departments which is three times more than Rs 10,007 crore sanctioned in 2015-16.

Kalyana Lakshmi/ Shaadi Mubarak

To promote social inclusivity and provide financial support to underprivileged couples, the Telangana government launched the Kalyana Lakshmi/Shaadi Mubarak scheme. Under these schemes, eligible brides from economically backward sections are entitled to receive financial aid of up to Rs 1,00,116 for their wedding expenses. This initiative not only ensures that every bride has a memorable wedding ceremony but also helps alleviate the burden of wedding expenses for economically disadvantaged families. Further, it brought much-needed social reform as the number of young women continuing their studies up to the legal age of 18 increased significantly

BC Welfare

To provide quality education to children from backward classes, the Mahatma Jyothiba Phule BC Welfare Residential Educational Institutions Society is operating 294 schools and 16 degree colleges, with a sanctioned strength of 1.65 lakh students. The number of beneficiaries and expenditure also increased over the years, with a total of 6,08,283 beneficiaries and Rs. 2,117.62 crore spent between 2015-16 and 2022-23.

The government also sanctioned the construction of 41 BC Community Atma Gourava Bhavans, allotting land in Ranga Reddy and Medchal-Malkajgiri districts, involving Rs. 95.25 crore. In addition, free electricity supply of 250 units has been provided to laundries and dhobi-ghats run by the washermen community and hair-cutting salons run by the Nayee Brahmin community. The government provided economic support of a total Rs 460.39 crore for 1,75,647 beneficiaries through BC Corporation.

ST Welfare

The State government has taken significant steps over the last nine years to support and uplift the Tribal community in the State. Prominent among them is reservation enhancement. The Chief Minister increased reservations for Scheduled Tribes (STs) from 6 percent to 10 percent in educational institutions and government services. This move ensures better representation and socio-economic upliftment of the tribal population. Under ST sub plan government spent Rs 43,936.32 cr in 9 years

Further, ST Thandas (hamlets) were upgraded into gram panchayats, benefiting 2,156 ST hamlets. Special provisions worth Rs 300 crore were made for the construction of gram panchayat buildings, covering 2,168 ST gram panchayats which are now receiving dedicated funds. Investments in education have yielded positive outcomes, with all schools converted to English medium. Several ST students quali-IIT, NIT/IIIT, and medical colleges across India.

Minorities Welfare

The Telangana government is committed to the welfare and upliftment of minorities. It has implemented various schemes for social, economic, educational, and institutional development among minorities. The budget allocation and expenditure for minority welfare increased over the years wherein a total of Rs 8,580.68 crore was spent over the last nine years. The government also established 204 minority residential schools, which have been upgraded to junior colleges. Under the Chief Minister's Overseas Scholarship Scheme, 2,174 students received scholarships of Rs 397.87 crore to study abroad. The government also took up renovation, construction, and repair of important buildings, including heritage sites and religious institutions. Projects such as the renovation of the Mecca Masjid and the construction of Christian Bhavan and Christian graveyards are underway.

SC Development

Telangana Dalit Bandhu is a flagship government programme aimed at economically uplifting the Scheduled Castes (SC) community and empowering them by providing financial assistance. Each eligible household will receive a grant of Rs 10 lakh without any bank linkage, enabling them to start a trade or business of their choice. The scheme has been implemented in various constituencies and districts, with a provision of Rs 4,441.00 crore in the financial year 2021-22. During the FY 2022-23, Rs17,700.00 crore was allocated towards Dalit Bandhu by fixing a target of 1,500 units per Assembly constituency (excluding Huzurabad Assembly constituency to other mandals/millages which were taken up in saturation mode for implementation of the scheme).

The Scheduled Castes Special Development Fund Act was enacted to ensure the allocation of 15.45% of the total State scheme funds for the welfare and development of SCs in Telangana. Since 2014-15, an expenditure of Rs 92,640.41 crores was



Telangana, from the days when the IT Hub was all about just one Cyber Tower in Madhapur, leading to IT Towers in multiple districts, an entire IT Corridor, the world's marquee companies here and the State becoming the IT powerhouse of the country, was not slow and steady, but fast and steady. The recent US and UK tour of IT Minister KT Rama Rao showed how Telangana was now a name to reckon with in the global IT arena as multiple companies announced their Telangana plans.

Hyderabad is also gradually becoming a hot favourite. From Amazon Web Services to Microsoft Azure, the State is now home to several hyper scale and edge data centres, having its own Data Centre Policy right from 2016. Access to dual power grids, low-cost power supply and a highspeed fiber network are just some of the factors that have drawn these data centre majors to Telangana. In fact, earlier this year, IT major Microsoft announced three more data centres in Telangana in addition to the three data centres that were announced last year. In early 2022, Microsoft



yderabad is the second largest base for corporate giants like Amazon, Google, Meta, Apple, Microsoft, Uber, Qualcomm, Micron and many others in the world. In fact, Amazon's world's largest campus is not in Seattle but in Hyderabad. Telangana, especially Hyderabad is home to more than 1.500 multinational companies.

Save for Microsoft, many of these corporates have set up their campuses or units in Telangana in the last nine years. More importantly, they are not BPOs or KPOs, most cutting-edge technological work in maps, AI, Machine Learning etc happens at these campuses.

Aerospace and defence sector

Amazon's exclusive cargo airline Amazon Air was launched in Hyderabad for a foray into the country in an attempt to enable faster deliveries to its customers. It also became the first e-commerce company in India to launch a dedicated air cargo network. In the aviation and defence sector, Telangana has a strong private sector industry with over 25 large companies and over 1000 MSMEs. The Aerospace and defence ecosystem in the State has witnessed unprecedented growth in the past five years. Original Equipment Manufacturers such as Lockheed Martin, Boeing, Safran, Tata, GE, Aviation, Pratt and Whitney, Honeywell, and Collins Aerospace have invested in Telangana and have set up their units. TASL will be producing these doors at a new facility in Hyderabad using cutting-edge robotics and automation technology and each shipset will include two cargo doors

Global defence aerospace player Lockheed Martin and India's Tata Group have inked an agreement for the production of fighter plane wings at their joint venture Tata Lockheed Martin Aerostructures Ltd (TLMAL) in Hyderabad. According to Lockheed Martin, the Memorandum of Understanding (MOU) envisions production of 29 fighter wing shipsets, with an option of additional shipsets, with deliveries commencing in 2025.



Making it clear that her party will not enter into an alliance with the BRS, YSRTP President YS Sharmila said the BJP has been singing a duet with KCR and that the Congress had sold itself out to KCR.

after the elections or not. What is the guarantee that the Congress would not become a supply company for KCR?" she

She said that two years are over after she launched the YSRTP and that she had floated a party in Telangana as the Congress and the BJP were sleeping. She said that only the YSRTP took up public causes

when national parties slept. "I am the only one question-

ing the excesses of KCR standing by the people. I walked 3,850 km not to merge my party with another party. It is not right to undermine my hard work, insult me, and YS Rajasekhar Reddy in the name of merger," she said and made it clear that the YSRTP will contest alone. "I will field candidates in all constituencies on my own and we are readying candidates for elections," she added.

She said political parties which are hoping for alliances have to answer what is the need for an alliance with the Congress which sells itself to others. Voting for the Congress is nothing but voting for the BRS, she said.

She said that the BRS will not get more than 30 seats and that there is no guarantee that the Congress will not become a supplying company to KCR

Upadhyay was hit on her left thigh and was admitted to a private hospital in Patna after the incident, they added.

"No complaint was lodged regarding this incident. I have also come to know about it from social media. Further information is being gathered," said Nasruddin Khan, the Station House Officer (SHO) of Janta

Her condition is now stated

to be stable. Condemning it, Art and Culture Minister Jitendra Kumar Rai told PTI that celebratory firing was a criminal offence and people must understand it.

"Î have been informed about it. It's highly condemnable and action must be initiated against the accused. People must know that celebratory firing even with licensed guns at public gatherings, religious places, weddings or other functions is a criminal offence. The accused must be punished," he said.

"I am sure that the police will examine how the incident took place, who all were involved in the firing, and how the gunshot was fired," he added.

Despite repeated attempts, Upadhyay's family could not be reached for a comment.

GST mop-up crosses Rs 1.5 lakh crore

GST collections crossed Rs 1.50 lakh crore for the third month in a row, recording a 12 per cent increase in May at over Rs 1.57 lakh crore, according to the official data released on Thursday. The collections, tax experts said, reflects a continuation of the good economic performance across states witnessed since last year.

The gross Good & Services Tax (GST) revenue collected in the month of May, 2023 is Rs 1,57,090 crore of which Central GST is Rs 28,411 crore, State GST is Rs 35,828 crore, Integrated GST is Rs 81,363 crore (including Rs 41,772 crore collected on import of goods) and cess is Rs 11,489 crore (including Rs 1,057 crore collected on import of goods), a

"The revenues for the month of May 2023 are 12 per cent higher than the GST revenues in the same month last year," the ministry said.

During the month, revenue from import of goods was 12 per cent higher and the revenues from domestic transactions (including import of services) are 11 per cent higher than the revenues from these sources during the same month

May is the third month in a row that tax collections from goods sold and services rendered have crossed Rs 1.50 lakh crore. In April GST revenues had touched a record high of Rs 1.87 lakh crore, while in March it was Rs 1.60 lakh crore.May is the 14th month in a row when monthly GST revenues came in more than Rs 1.4

Too bullish to be true

Morgan Stanley has painted a rosy picture of the economy, but it omits some key indicators

\rceil overnment and Bharatiya Janata Party supporters must be happy over the recent report by Morgan Stanley, the global financial services firm. "This India is different from what it was in 2013. In a short span of 10 years, India has gained positions in the world order with significant positive consequences for the macro and market outlook," it said. "India has transformed in less than a decade." This is surely a vote of confidence for Prime Minister Narendra Modi and his economic policies. The report has highlighted 10 big changes that have taken place since 2014. Bringing down the corporate tax rate at par with the same in other major economies and heavy infrastructure investment are among the top supply-side policy reforms, Morgan Stanley said. The soaring collection of goods and services tax (GST) and the growing share of digital transactions as a percentage of GDP indicate the formalisation of the economy, it added. Other pluses, according to Morgan Stanley, are direct transfer of sub-



sidies to accounts of beneficiaries, the Insolvency and Bankruptcy Code, flexible inflation targeting, focus on foreign direct investment (FDI), Government support for corporate profits, a new law for the realty sector, and MNC sentiment at multi-year high. Manufacturing and capital spending as a percentage of GDP has continuously risen, Morgan Stanley said, adding export market share is projected to more than double to 4.5 per cent by 2031.

Much of what Morgan Stanley has said is correct, but at places optimism seems a bit excessive. It seems to have overlooked a few facts. For instance, FDI inflows into the country fell by 16 per cent to \$71 billion on a gross basis in the last fiscal, though

the decline has been attributed to weak global factors. Similarly, manufacturing remains a laggard; its share continues to languish at 16-17 per cent of the country's GDP. The Government has made big claims about the potential of industrial growth; it launched ambitious programmes like Make in India and the production-linked incentive or PLI scheme for several sectors. And yet, manufacturing's share in GDP is no different than it was in 2011, the year in which the National Manufacturing Policy was announced with the target to make the share go up by 2022. Then there is the issue of jobs; the economy is not able to generate quality employment. This reflects in consumption patterns. The sales of luxury products are zooming, whereas the items used by common people like kitchen appliances are not doing as well. Growth accelerated to 6.1 per cent in the fourth quarter of 2022-23, and for the entire fiscal it was upwardly revised to 7.2 per cent. For 2023-24 too, India is likely to grow by over 6 per cent, and will be the fastest growing big economy. The Government must persist with reforms and ensure the more supply-side bottlenecks are removed so that the fruits of growth and development are equitably distributed.



'DRESS CODE' FOR TEMPLES

FIRST COLUMN IMPORTANCE OF PM MODI'S US STATE VISIT

Domestic politics aside, there is much at stake for PM Modi's upcoming state visit to the US

rime Minister Narendra Modi would be on a high-profile visit to the United States later this month. The state visit would be the first for the PM, and for the president of the USA and the second during his current tenure, as a host. This visit is happening against the backdrop of many high-profile visits by Indian and American diplomats, secretaries and ministers setting the ground, plank by plank, in what could be one of the most significant milestones in the India US bilateral relationship. The last such fillip to the relationship came in the period from 2005 to 2009 when India went nuclear and, US keeping aside its domestic political reservations and ally concerns (read Pakistan), eased India into the nuclear club, finally culminating in, then Prime Minister Manmohan Singh's state visit to the US. A state visit is the highest level of honour and prestige accorded bilaterally, and is considered to be the top-notch level in diplomatic relationships.

Prime Minister Modi's scheduled state visit was supposed to have been preceded, by his meeting with US President Joe Biden, at least thrice in less than a month. These included bilateral meetings during G7, to which India was invited, a meeting in Papua New Guinea and a QUAD leaders' summit before culminating in a state visit. However, President Biden had to cut short his trip to the Pacific Ocean Island nation and Australia, due to domestic issues, leading to a few hurried meetings on the sidelines of the G7 in Japan.

The domestic environment for both India and the US is just warming up, to what would be an extremely hot and noisy space for the world's oldest and largest democracy. India and the US face general elections next year and the domestic political climate, if not decibels, are already exceeding tolerable limits. Moving forward it would be unbearable and rough. This casts the dice for these leaders, both of whom are seeking re-election (PM Modi for the third term and President Biden second term), to make it worthwhile for their respective constituencies, which will send them back to the top posts. The US president would have to ensure that his voters, if not the congress and some of his colleagues, see the value of upgrading the India-US bilateral relationship, despite, India's conspicuous silence on Ukraine (except for It is not a time for War statement), close relations and dependencies on Russia and some uncomfortable questions regarding human rights, religious freedom etc.

Indian Prime Minister on his part would like to take the spectacle quotient a tad higher than the Howdy Modi, grand concerts event, when



PM Mod and then President Donald Trump, jointly addressed thousands of Indian Americans in Houston. The PM would expect a significant outcome from the state visit, albeit the cheering crowds, public events would definitely be a part of the package. The PM who was recently on a visit to Australia and Pacific island countries, where he got a rock stars welcome, addressed large cheering crowds in packed arenas and was even called "the boss" by the Australian PM. The Indian American groups are also prepping up for PM Modi's visit, as many of them are expected to participate in some key official ceremonies at the white house, including witnessing the 21-gun salute and perhaps yoga sessions led by Indian PM on International World yoga day on June 21st.

It would be worth remembering that PM Modi's visit would also follow opposition leader Rahul Gandhi's ten days trip to the US, where he interacted with a wide array of stakeholders, civil society, think tanks etc on questions surrounding Indian democracy. The larger questions regarding shrinking space for democratic manoeuvre and political opposition in India, which have been brought out by the opposition leader during his earlier visits to UK etc and which have led to some influencer groups doubting Indian democratic credentials, could have been contained, by the time PM Modi lands in the US. Domestic politics aside there is much at stake for PM Modis' upcoming state visit to the US.

Whether one is the top man or the so-called bottom man, there is always an element of decision-making vested in the role



ne of the critical components of decision-making is the ability to decipher decision spaces. Consider the example of a doorkeeper. By any standards, it is a lowly rank and humble in many ways. Yet, in times of knocking at the door, that position becomes more important than that of the Chairman himself. It is the doorkeeper's decision to let somebody in or keep him out. It is a power loaded with security concerns and at times with grave implications of time, life and death. Consider a situation where somebody is ill, and a doctor has been summoned in the late hours of the evening to the building to take care of the ailing person.

The doctor does not get a security clearance, but his entry into the building is critical. Like anything else, there is a risk involved, and somebody may be impersonating the doctor; there may be a rogue doctor or the doctor himself may be very impatient—the possibilities are several. The judgement of the gatekeeper and the judgement to be exercised on the spot make him the kingpin, not only for the moment of the act but indeed for much else, besides.

The derivation is obvious: everyone needs to have effective decision-making skills. The story goes that King Shivaji approached his Rajgad Fort near Pune, in the early hours of the morning after

a long long ride and wanted to enter the Rajgad Fort. He had enemies at his heels. The head of security of the fort had it from the king (Maharaj) himself (in this case, Shivaji Maharaj) that no entry into the fort before dawn.

The airline flies to San Francisco, New York, Newark, Washington and Chicago in the US and to the cities of Vancouver and Toronto in Canada.

Rising risk appetite may hit banks' credit profiles

A rise in risk appetite among Indian banks highlights the importance of assessing individual banks' ability to withstand expected and unexpected balance-sheet stress as part of the analysis of their intrinsic creditworthiness, said Fitch Ratings in a report.

Banks' loan growth over the financial year ended March 2023 (FY23) reached 15.4 per cent, the highest since FY12.
"We believe, this partly

reflected pent-up credit demand following the Covid-19 pandemic, as well as strong nominal GDP growth, and we expect some normalisation in FY24," the global rating agency said on Thursday.

However, rapid loan growth and higher exposure to certain asset classes are also likely to indicate greater risk appetite and could affect risk profiles, it said, adding increasing risk appetite reflects in part banks' efforts to boost returns after funding costs rose over 2022, even as they manage asset



growth relative to capital.

Notably, credit card lending and personal loans exposure rose to 10.2 per cent of system loans by FY23, from 7.5 per cent in FY18, it said.

'We view such unsecured categories as most vulnerable to potential stress, though exposures among our rated entities remain manageable, and improvements in risk controls and loan-book granularity should help to reduce risks associated with any future

asset-quality deterioration relative to previous cycles. We also expect tighter regulatory supervision to slow unsecured lending in the year ahead," it

Exposure to non-bank financial corporations (NBFCs) within the services sector has also risen, from 6.5 per cent of total system loans in FY18 to 10.5 per cent in

Funding pressures and assetquality risks among NBFCs

have receded since that sector underwent a stress period in 2019. These loans are also typically to well-established private and state-owned entities, so carry less risk than unse-

cured lending. However, NBFCs, like banks, are also increasing their risk appetite. It expects banks to continue to lend to the sector, but at a slightly slower pace as more banks run up against regulatory sectoral concentra-

Centre buys 262 lakh tonnes of wheat at MSP

PNS NEW DELHI

The Centre has purchased 262 lakh tonnes of wheat so far this year at minimum support price (MSP) and paid about Rs 47,000 crore to farmers.

Wheat procurement during the ongoing Rabi Marketing Season (RMS) 2023-24 has progressed smoothly. The progressive procurement of wheat in the current season till May 30 is 262 lakh tonnes, which has already surpassed last year's total procurement of 188 lakh tonnes by 74 lakh tonnes," the Food Ministry said in a statement.

About 21.27 lakh farmers have already benefitted from the ongoing wheat procurement operations with a minimum support price outflow of about Rs 47,000 crore, it The Rabi marketing season

runs from April to March. However, the bulk of wheat procurement is done between April and June. Wheat is a major rabi (winter-sown) crop.

Major contribution in the procurement has come from

three states of Punjab, Madhya Pradesh and Haryana, with procurement of 121.27 lakh tonnes, 70.98 lakh tonnes and 63.17 lakh tonnes, respectively.

The ministry attributed the rise in procurement to relaxation in quality specifications of wheat affected due to untimely rains, the opening of procurement centres at village/panchayat level, carrying out procurement through co-operative societies/ Gram Panchayats/Arhatias etc in addition to designated procurement centres.

On rice procurement, it said that "a quantity of 385

procured till May 30 during the Kharif crop of Kharif Marketing Season (KMS) 2022-23 with another 110 lakh tonnes yet to be procured. Further, a quantity of 106 lakh tonnes of rice has been estimated to be procured during the Rabi crop of KMS 2022-23".

KMS runs from October-September.

The combined stock position of wheat and rice in the Central Pool is over 579 lakh tonnes (wheat 312 lakh tonnes and rice 267 lakh tonnes), which has placed the country in a comfortable position to meet its requirements of food



Spurious cotton seeds racket busted, two arrested

Inter-state spurious cotton seeds racket was busted by SOT LB Nagar Zone and Choutuppal police. The police seized 2.2 tons of spurious seeds all worth about Rs 70

The accused Gaddam Ravindra Babu and Ravi Prasanna Kumar were nabbed near Divis water plant, under the limits of Choutuppal police station while they were transporting the spurious cotton seeds from Nagpur to sell the same to gullible farmers.

The police filed Cr no 285/2023 U/S Sec 420 R/W IPC, clause 3(1) of seeds (Control) order-1983, sec 7 of EC act 1955, Sec 7 and 19 of Seeds act 1966, sec 15(1) of environmental protection act -1986 of Choutuppal PS.

The accused Ravi Prasanna Kumar is a native of Mylavaram, Krishna district and since last 10 years he is a running a fertiliser shop in the name of Navatha Agro Division Seeds and Fertilisers shop at Choutuppal. He came in contact with Ravindrababu who was into illegal trade of spurious seed. Then he wanted to earn easy money and decided to procure the banned BT-III cotton seeds from one Gaddam Ravindra Babu and sell the same to needy farmers

with a promise of high yield. Ravindra Babu migrated from Palnadu district to Kuhi village near Nagpur about 8 years back and doing agriculture by taking 60 acres of land on lease, with an intention to earn huge easy money within a short span. He indulged in procuring and sale of spurious BT-III/ HT cotton seed.

He has good knowledge that sale of BT-III/HT cotton seeds are banned by the Government of Telangana.

He used to procure the spurious seeds from one Narasimhulu, resident of Madanapalle in Chittoor district and transporting it to Kuhi near Nagpur, Maharashtra, and from there he was selling the same to seed traders of Telangana, Maharashtra and Andhra Pradesh states illegally.

Man strangles wife to death for refusing sex

A man strangled his wife to death in a fit of rage after she refused to engage in sexual activity with him. The details of the crime emerged when the autopsy report confirmed the cause of death. The police managed to solve the case 10 days after the crime occurred. The accused, Jatavath Tarun (24), admitted to the police that he had strangled his wife, Jhansi (20), following her refusal. Originally

Nagarkurnool district, the couple had entered into a love marriage in 2021. Tarun worked as an auto-rickshaw driver and had moved to Hyderabad with his wife and their family resided in Khaja Bagh in the IS Sadan division. The couple have a two-year-old son, and Jhansi had given birth to a daughter on April 16.

According to Tarun's statement to the police, on the night of May 20, he expressed his desire to engage in sexual activ-

ity. However, Jhansi informed him that she was too tired. Despite her refusal, Tarun persisted and began to force himself upon her. When Jhansi started shouting, Tarun covered her mouth with his hand. This act resulted in a lack of oxygen, causing her to lose consciousness and foam at the mouth. Panicked by the situation, Tarun alerted his relatives, who rushed Jhansi to Owaisi Hospital. However, the doctors pronounced her dead upon arrival.

The police transferred the body to the Osmania General Hospital for an autopsy. Initially, Tarun remained silent about the cause of his wife's death. However, based on a complaint filed by Jhansi's father, Nenavath Rekiya, a case was registered at Saidabad police station. It was only during further questioning by the police that Tarun confessed to the crime. Consequently, the police arrested him, and he was subsequently remanded to judicial

The left-arm spinner, however, said that the focus is on hitting the right spot irrespective of the ball used.

"We switch from white

ball to red ball. It is a similar switch to go from SG to Dukes, you have to use your talent and skill. You have to execute your plan, your bowling rhythm. Irrespective of the ball, if you bowl a good ball at a good spot, it works.

"So, that's what we're doing. Since the match is in England, which is different from India, we are planning what lines and lengths will work here. The same thing in practice, we are good to go."

'Conway has caught Williamson bug to keep learning'

Former New Zealand spinner John Bracewell believes charismatic batter Devon Conway has caught the "Kane Williamson bug" to keep learning from past mistakes and making rapid improvements in his batting technique.

Conway, a late entrant into the New Zealand setup at 29, took the cricketing world by storm by smashing a double hundred on Test debut against England in 2021 to become only the seventh batter to do so in the longest format.

Conway, now 31, also played a vital role for Chennai Super Kings in only his second IPL season, scoring six half-centuries and aggregating 672 runs with a highest of an unbeaten 92 and an average touching 52.

His opening partnerships with Ruturaj Gaikwad formed the cornerstone of CSK's record-equalling fifth title. The all-format New Zealand cricketer was third on the IPL's Orange Cap list behind Shubman Gill and RCB's South African skipper Faf du Plessis.

"I think he's been an absolute magician in terms of his adaptability to all three formats, his skillset and his (growth)," Bracewell, who

played 41 Tests garnering 102 wickets and 1000-plus runs, told Sen Radio.

"I like the way he's becoming a better cricketer all the time, so he's obviously caught the Kane Williamson bug of being a learner, not a guy that actually just sits there and relies on being talented," said the 65-year-old. Conway has so far amassed 1212 Test, 508 ODI and 632 T20I runs, and Bracewell believes the cricketer can rival the best in the business.

"His game is just continuing to progress and that's something that Kane Williamson had introduced into the New Zealand side along with (former wicketkeeper) BJ Watling. "That's something that

"That's something that Devon Conway's picked up and moved forward with him taking it to another dimension."

Bracewell believes Conway will play a huge role during the ODI World Cup, scheduled to be held in India in October-November this year, given that Williamson would unlikely have recovered completely from an ACL injury he suffered in the IPL.

"He's one of a series of components, but he's certainly an important one," said

Oz need to be wary of Pujara, Kohli: Ponting

Australia head into the WTO final against India wary of their dismal Oval record

As Australia begin preparations for the World Test Championship final against India, the men from Down Under would be eager to put their past struggles at The Oval behind them.

In over 140 years of Test cricket in England, Australia have had one of the worst records at The Oval, which will host the final from June 7 to 11 between the top two Test sides.

Australia, who played at The Oval in 1880 in what was the first-ever Test in England, have managed a mere seven wins from 38 Tests at the famous South London venue, putting their success rate at the venue at 18.42 per cent, their poorest across England.
