# BJP's 'look-east policy' yields good returns

#### **BJP** retains Tripura, to form alliance Govt in Nagaland, and Meghalaya

**DEEPAK K UPRETI** NEW DELHI

 $T^{\text{he "look-East policy" of the BJP has paid off again with the saffron party and its allies}$ retaining power in both Tripura and Nagaland. They are also set to be back in the Meghalaya coalition government led by the National People's Party (NPP).

The BJP, part of the ruling coalition in all three North-Eastern States, has come back to power in Tripura with the Indigenous Peoples Front of Tripura (IPFT) and in Nagaland with the Nationalist

In Nagaland, its longest serving Chief Minister Neiphiu Rio, is set to come back to the top office for the record 5th

The NDPP and the BJP have improved their tally in Nagaland from the last time. The state also has got a woman MLA — 60 years since it attained statehood. Hekani Jakhalu, from BJP's ally NDPP, has won from Dimapur-III seat. The 48-year-old lawyeractivist was among four women of the total 183 candidates who contested the Nagaland assembly elections. Jakhalu defeated Lok Janshakti Party's Azheto Zhimomi.

In Meghalaya, Chief Minister Conrad Sangma-led NPP has emerged as the single largest party and expected to be in the saddle with the backing of the BJP and other parties.

Though BJP's decision to go it alone in Meghalaya did not pay good dividends, the party has opened up backchan-

Sangma's NPP which is short of the halfway mark with 26 of the state's 60 seats. The BJP contested all 60 seats in Meghalaya but won only a couple of them.

The Congress, which once held a strong position in the North-East, failed to make a mark in all the three States. The biggest setback for the party

was in the multi-cornered contest in Meghalaya where it scored in single digit while the party was the single-largest in The saffron party's second

consecutive win in Tripura is

significant, as five years ago it had almost negligible presence in the Left-run State. The party has beaten anti-incumbency and defeated the Left-Congress coalition hands down.
Tripura Chief Minister Manik Saha, who is tipped to get a second term, defeated Congress's veteran leader

Ashish Kumar Saha by a margin of 1,257 votes from Town Bardowali despite detractors within his own party predicting a "tough time" for him in the prestigious constituency.

In Tripura, the debutant Tipra Motha, led by the royal scion Pradyot Kishore Manikya Debbarma, made an impressive debut with over 12 seats. He

#### 'Arrangement till Parliament passes law for selection'

 $I^{\mathrm{n}}$  a landmark judgment, the Supreme Court on Thursday ruled that the appointment of Election Chief Commissioner (CEC) and the Election Commissioners (ECs) will be done by the President on the recommendation of a committee, comprising the Prime Minister, the Leader of the Opposition in the Lok Sabha and the Chief Justice of India, to maintain the "purity'

of the electoral process. The five-judge constitu-KM Joseph also said the "unrelenting abuse" of the electoral process over a period of time is the "surest way to the grave of democracy".

In a democracy, the "purity of election" must be maintained or else it would lead to "disastrous consequences", the bench said. The direction on the EC appointments will continue to hold good till a law on the issue is made by Parliament, said the verdict.

As of now, the CEC and the ECs are appointed in terms of Article 324 of the Constitution by the President on the recommendation of the Centre.

The apex court said if the



Leader of the Opposition in the Lok Sabha is not there, then the leader of the single largest Opposition party will be in the committee to select the CEC and the ECs.

The bench delivered its verdict on a petition filed by noted lawyer Prashant Bhushan and other pleas seeking a appointment of the CEC and

"We declare that as far as the appointment to the post of the CEC and the ECs are concerned, the same shall be done by the President of India on the basis of the advice tendered by a committee consisting of the Prime Minister of India, the Leader of the Opposition in the Lok Sabha and in case there is no such leader, the leader of the largest party in the Opposition in the Lok Sabha having the largest numerical strength and the Chief Justice of India," Justice Joseph said, while reading out the operative part of the judgment.

## **Twitter introduces new 'violent speech' policy**

Twitter CEO Elon Musk on Thursday said Twitter is a platform where writers and leaders spend their time, even though a "few other social networks" are actually bigger. works" are actually bigger.

His comment came after Twitter announced that it has updated its rules on "violent content and similar language", and has now "officially launched" its "Violent Speech" policy. The rules appear very similar to guidelines against violent threats that the company had on its books before Elon Musk took it over.

Among the updates, Twitter expanded its policy to include a ban on "coded language," which is often referred to as "dog whistles," used to indirectly incite violence. It also added a rule that prohibits "threatening to damage civilian homes and shelters, or infrastructure that is essential to daily, civic, or business activi-

## 18 CRPF-RAF companies sent to Punjab to boost security

 $P_{\text{Bhagwant Mann on}}^{\text{unjab Chief Minister}}$ Thursday met Union Home Minister Amit Shah and said the Centre and the State will work together on the law and order issue, even as about 1.900 personnel of the CRPF and its specialised anti-riot unit were being dispatched to the State for strengthening the security

The two leaders discussed the law and order issue. Mann told Shah about the circumstances leading to the Ajnala incident, sources said.

On February 23, self-styled Sikh preacher and Khalistan sympathiser Amritpal Singh and his supporters, some of them brandishing swords and guns, broke through barricades and barged into a police station in Ajnala on the outskirts of the Amritsar city, extracting an assurance from the police that his aide and kidnapping case accused Lovepreet Singh would be



The chief minister said in tweet in Punjabi that the "Centre and Punjab will work together on the issue of law and

Official sources added that the Union home ministry last week also directed the deployment of 18 companies to Punjab for "aid of the state government during law and order

Out of the 18 contingents, eight are drawn from the antiriot Rapid Action Force (RAF) while the rest are regular ones. The overall strength of these companies is around 19,000

These companies have been initially tasked to be deployed in Punjab between March 6-16 and their stay could be extended after consultation between the state and the Centre, the sources said.

They said the companies will assist the state police in security duties during the three-day Sikh festival of 'Hola Mohalla' that will be celebrated between March 8-10.

The chief minister said he had discussed with the home minister the issue of drones and drugs along the border. He said the issue of shifting

the barbed wire along the border was also discussed. Mann said he has asked Shah to release Punjab's stalled rural development fund soon.

The central government officials said the Union Home Ministry is "closely monitoring" the situation in Punjab in the wake of renewed activities of some Khalistani support-

The Punjab Police said on February 24 that the demonstrators had used the holy Guru Granth Sahib as a shield and attacked police personnel in a cowardly manner, leaving six of them injured. Lovepreet Singh walked out of jail on February 24.

Dubai-returned Amritpal Singh was last year anointed head of 'Waris Punjab De' which was founded by actor and activist Deep Sidhu who died in a road accident in February last year.

The event was held at Moga's Rode, the native village of slain militant Jarnail Singh Bhindranwale.

With wet market being perceived as the source of Covid-19 virus that swept the world for the last two years, the World Health Organisation (WHO) has warned tourists visiting countries with bird flu cases to avoid farms, wet markets and any areas where animals are slaughtered to ward off

risk of any spillover of the virus. The WHO advised regular hand washing and good food safety and food hygiene practices. However, it warned against the application of any travel or trade restrictions to countries with a bird flu out-

The agency also suggested people in close contact with poultry to get vaccinated against seasonal human flu, to reduce the risk that H5N1 could recombine with a human

This comes after an 11year-old girl in Cambodia died after contracting the avian influenza A (H5N1) virus.

## Combination drug therapies effective against scrub typhus, reveals study

n a largest-ever randomised In a largest-ever random-controlled trial on the treatment of severe scrub typhus in India, a team of researchers has found that instead of the current single-drug therapies, treatment' (using a combination of drugs) is more effective for treating the miteborne infectious disease. As combination therapy quickly controlled bacterial growth within the first week of infection, severe disease may have been prevented and the resolution of symptoms might have quickened, said the study published in The New England Journal of Medicine.

Caused by the bacteria, Orientia tsutsugamushi, the infection primarily affects rodents and is transmitted to humans (zoonoses) by the larvae of trombiculid mites. However, despite being a serious public health threat in India with an increasing number of cases in recent years, it and burdensome scrub typhus is in the country, notes health experts. The 19-year-old woman was allegedly gang-raped by four men from her village on September 14, 2020. A fortnight later, she died at a Delhi hospital. She was cremated in the middle of the night in her village near Hathras. Her family members claimed that the cremation, which took place well past midnight, was without their consent and they were not allowed to bring home the body one last time. Several politicians, including Congress leaders Rahul Gandhi and Priyanka Gandhi Vadra, slammed the Adityanath gov-"hurried" cremation.

There were standoffs with UP Police when the two leaders, along with other party members, headed for the victims' village. The visit took place only on the second attempt. In another episode linked to the Hathras incident, Kerala journalist Siddique Kappan and his companions were arrested when he was on his way to the district, the move triggering another row. The UP Police claimed that he was linked to radical organisation People's Front of India and was trying to incite violence. After two years in jail, he was recent ly released on bail.

The relations between the two countries are the most tense in the past 60 years since the brutal clash at the Galwan Valley on June 15, 2020. Both the sides have held 17 rounds of military level talks besides several rounds at the diplomatic level to restore peace in the border areas. Îndia has all along maintained that status quo ante as existing before May 2020 has to be restored for normalising relations with China.

It is the first meeting between Jaishankar and Qin after the latter became the Chinese Foreign Minister in December. The talks came nearly eight months after Jaishankar held a meeting with the then Chinese Foreign Minister Wang Yi in Bali on the sidelines of a G-20 meeting.

During the one-hour meeting on July 7, Jaishankar had conveyed to Wang the need for early resolution of all the outstanding issues in eastern Ladakh. The External Affairs

Minister had told Wang that the relationship between the two countries should be based on "three mutuals" - mutual respect, mutual sensitivity and mutual interests.

On February 22, India and China held in-person diplomatic talks in Beijing and discussed proposals for disengagement in the remaining friction points along the LAC in eastern Ladakh in an "open and constructive manner". The meeting took place under the framework of Working Mechanism for Consultation Coordination on India-China

Border Affairs (WMCC).

## JNU rescinds harsh new rules Panel for blocking illegal mobile for students after VC steps in

Amid criticism,
Jawaharlal N Nehru University (JNU) on Thursday withdrew a notice that stipulated students can face a fine of Rs 50,000 for violence, abuse and protesting on campus. Interestingly, JNU Vice-Chancellor (VC) Santishree Pandit claimed that she was not aware that such a document was prepared and released.

"I was not aware of such a circular. I am in Hubli for an international conference. The Chief Proctor did not consult me before releasing the document. I got to know about it through newspapers.

That is why, I have withdrawn it," Pandit said. In a notification, Chief Proctor Rajnish Kumar Mishra said, "In view of administrative reasons, the notification dated 28.2.2023 in respect of rules of discipline and proper conduct of students of JNU is hereby withdrawn. directions of the Hon'ble Vice-

This comes after the 10page document drew a sharp reaction from students and teachers, who termed it dra-

The document titled 'Rules of Discipline and proper conduct of students of JNU' had laid out punishments for different kinds of acts like protests and forgery, and procedures for proctorial enquiry and recording a statement.

The punishment ranged from a fine of Rs 5,000 to Rs 50,000 or rustication and cancellation of admission. According to the now-withdrawn rules, a student might face a fine of Rs 50,000 for physical violence, abuse and manhandling towards another student, staff, or faculty mem-

According to the nowdeleted document, the rules came into effect on February 3.

This has been issued on the It came after the university witnessed a slew of protests over the screening of a BBC documentary. The rules document stated that it has been approved by the Executive Council, the highest decision-making body of the university.

Punishments were listed for 17 "crimes", including blockage, indulging in gambling, unauthorised occupation of hostel rooms, use of abusive and derogatory language and committing forgery. The rules also mention that a copy of the complaints will be sent to the parents.

It proposed punishments for all acts of violence and coercion such as gheraos, sit-ins or any variation which disrupts normal academic and administrative functioning and/or any act which incites or leads to violence.

A fine of up to Rs 20,000 would have been levied.

According to the old rules, for gheraos, demonstrations and sexual harassment, the proposed punishments were cancellation of admission, rustication and expulsion.

An Executive Council member, who did not wish to be named, has said the matter was not discussed at length in the EC meeting and "we were told that the rules have been created for court matters" Another Executive Council member Brahma Prakash Singh said: "The university might have planned to streamline the process and prepare a full document but it should have been discussed in the EC meeting properly.

Some of the rules are absurd." The Akhil Bharatiya Vidyarthi Parishad's JNU secretary Vikas Patel on Wednesday termed the new rules "authoritarian ('tughlaqi')' while asserting that the old code of conduct was sufficiently effective. He demanded a rollback of this "draconian' code of conduct.

# usage in Delhi jails gets LG nod

 $D^{elhi\,Lieutenant\text{-}Governor}_{\text{(L-G)}\ VK\ Saxena\ has}$ approved the formation of a high-level committee to suggest ways of addressing illegal and unauthorised telephone communication in the national Capital's prisons.

The 10-member panel, headed by Director General (Prisons) Sanjay Baniwal, has been instructed to submit its recommendations within a month. The other members are experts and scientists from IIT-Madras, IISc-Bangalore, Defence Research and Development Organisation, C-DOT and officers from the Intelligence Bureau and the Special Protection Group.

"The committee will explore suitable jamming solutions emerging in the market (in addition to the existing infrastructure) and their testing in prisons to check their effectiveness in blocking incoming/outgoing calls, SMS



premises," a Raj Niwas official said. In Tihar, the country's largest prison which houses close to 18,000 undertrials, there is not a single mobile phone jammer that is capable of blocking 4G signals. Between 2008 and 2012, 31 mobile phone jammers were installed in Tihar and Rohini jails. These jammers were effective in blocking 2G and 3G services. However, after the introduction of 4G services, these became ineffective, he said. As a result, the annual maintenance contracts for these 31 jammers were not renewed after November 2016. Subsequently, a committee constituted under the then-

Director General (Prisons) pro-

posed and decided on an alter-

Towers for Harmonious Call Blocking System (T-HCBS), for blocking 2G/3G/4G signals. This system was chosen for its ability to block 5G signals as well, the official said. This system entailed installing one or more "special towers" on the jail premises.

The T-HCBS, which follow a hybrid approach to jamming, were installed in various Delhi prisons. However, despite being effective to a large extent, the system could not prevent telephone communication in totality, the official explained. These towers were also blocking calls and data services of the general public in residential areas around the prisons, he

"It was also learnt that if the dominant T-HCBS or the second layer tower fails to generate signals, the third layer tower can also provide signals to execute calls and, therefore, 100 per cent call blocking could not be achieved," he

non-coverage of dark areas, shadow areas, multi-path propagation, fading and atmospheric conditions, among others also affected the T-HCBS's functioning.

To address these concerns,

based on the actual situation on the ground, officials felt a need to explore other existing and emerging solutions to curb the use of mobiles and SIM cards in the prisons and to ensure that no communication is possible on the premises, he added.

A cell phone is a prohibited item inside prison, but it is smuggled by prisoners when they go out for court hearings. The prisoners even hide the phone in their body cavities and take it inside.

There are many instances prisoners swallowing cell phones to smuggle it inside. Apart from this the phones are also thrown by accomplices of the prisoners from main road, outside prison complex, inside

### Kejriwal hails SC's verdict on CEC's appointment

The AAP on Thursday hailed the Supreme Court ruling on the appointment of election commissioners as "historic", saying it will help strengthen democracy with an impartial functioning of the poll panel.

Delhi Chief Minister Arvind Kejriwal hailed the Supreme Court decisions on commissioners and matters involving the business empire of industrialist Gautam Adani as landmark orders. "Truly landmark orders by Hon'ble SC on both EC and Adani issues. We welcome both the orders," Kejriwal said in a tweet.

For a long time, questions were being raised on the functioning of the Election Commission (EC), the AAP's national spokesperson Sanjay Singh told a press conference here, reacting to the apex court's decision.

The Supreme Court has ruled that the appointments of the chief election commissioner and election commissioners will be made by the president on the advice of a committee comprising the prime minister, the leader of opposition in the Lok Sabha and the chief justice of India.

A five-judge Constitution bench headed by Justice KM Joseph, in a unanimous verdict, held that this norm will continue to hold good till a law on the issue is enacted by Parliament.

The journalist (39) working with a TV news channel claimed she lost Rs 66,000 which she had to pay to the "customs office" in Mumbai to help the suspect whose "euro one lakh cash" got seized upon landing in India, they said.

The suspect identified himself as Manvik Bukka, a plastic surgeon who was born in Pune but is now based in the Netherlands.

"We first came in contact on January 16, 2023 on the Bumble dating app. We started chatting and he also introduced me over the phone to his mother.

"He left on January 31, 2023 from Amsterdam and landed in Mumbai on February 1. I got a call from someone from the customs office and she said that Manvik brought around 1 lakh euro cash in India which was seized," the journalist stated in the FIR.

"Manvik asked me to transfer Rs 45,000 as customs fees and Rs 50,000 as conversion fees to transfer money into an Indian account that is his SBI account.

"I gave Rs 66,000 but fell short and could not give more," she added.

The complainant said she was later informed that the authorities had to send Manvik back to Amsterdam on February 2 and after landing he was in touch with her till February 6 but thereafter she

did not get any message or call

A Noida police official said the FIR has been lodged under Indian Penal Code section 420 (cheating) and under provisions of the Information Technology Act at the Sector 20 police station.

## Delhi Police arrests man for giving 'triple talaq' to wife

The Delhi Police has registered a case against a man for allegedly pronouncing instant "triple talaq", an offence under a law enacted in 2019 to protect Muslim women from this menace, on his wife.

Efforts are being made to arrest the accused, a property dealer, who has been absconding since the incident came to the fore, police said. On July 7, 2022, the 52-year-old accused allegedly abused and shouted "Talaak- Talaak- Talaak" before throwing his wife out of the

house, police said. The matter came to light after the woman, aged 50, approached officials at Bhajanpura police station in northeast Delhi with a complaint of domestic violence against her husband.

According to the police, the woman who has six children from the wedlock stated in her complaint that her husband left her and married a transgender which was amica-

bly terminated under social pressure from their community. However, her husband later married another woman and is residing somewhere in Kardampuri. "He was later pressuring her to vacate the house and also threatened her of dire consequences. On July 7, 2022, her hus-

band abused her and shouted "Talaak- Talaak before throwing her out of the house," said a senior police officer quoting the complainant.

Deputy Commissioner of Police (Northeast) Joy Tirkey said the victim's complaint was sent to Crime Against Women for counselling. Accordingly, on the basis of her complaint, a case under section 4 of The Muslim Women Protection Of Rights On Marriage Act has been registered at the Bhajanpura police station and further investiga-

tion in the case is in progress. On August 1, 2019, Parliament approved a bill that proposed making "instant "triple talaq" a criminal offence.

## DGCA officer kills self, wife follows suit later

A<sup>37</sup>-year-old senior Directorate General of Civil Aviation (DGCA) officer and his wife allegedly died by suicide at their home in South Delhi's Defence Colony on Wednesday. The deceased were identified as Ajay Pal Singh and Monika, 32, residents of Hudco Place in South Delhi. Singh worked as an operations manager at the DGCA, said the

The police received a PCR call regarding a possible suicide at a flat in Block-3A, Transit Camp Hudco Place, at 2.49 am. The call was made by Ajaypal's friend Ashish Tiwari, a resident of Mahavir Enclave in Palam. When the police reached the spot, they found Monika lying

unconscious with froth oozing from her mouth. She was taken to Safdarjung Hospital, where she was declared dead, Deputy Commissioner of Police (South) Chandan Chowdhary said. Her neighbours revealed that Ajaypal allegedly committed suicide earlier in the night. He was an operation officer at the Directorate General of Civil Aviation cell near Ior Bagh metro station, Chowdhary said. Monika had allegedly

found Ajaypal in an unconscious state and taken him to a hospital, where he was declared dead. Later, she came home, consumed a poisonous substance and killed herself, the police said. The couple got married on November 26. No suicide note was recovered

from the house and no foul play is suspected, the police said. Their neighbours told the police that they used to have frequent arguments. Ajaypal's elder brother Yogendrapal said he last spoke to him on Wednesday. They used to fight often

over petty issues. My brother used to tell me about their fights. I spoke to him around 1 pm on Wednesday when he was in office. He told me that everything was going smooth-"I asked him to come home

emerge as the single largest party with 21 seats, but could not hold on to its MLAs and failed to form government then. The major loss of face was however in Tripura, where the Congress alliance with Left could not catapult itself beating the anti-incumbency against BJP that closely managed to

Which means of the 180 assembly seats that went to polls in the three states last month, also the first electoral battle of 2023, Congress could win only 8. Icing on the cake for Congress came from the win of Sagardighi assembly bypoll in West Bengal, Kasba Peth in Maharashtra and Erode East in Tamil Nadu. ## Cong-Left alliance stuns TMC in Sagardighi bypolls

**SAUGAR SENGUPTA** KOLKATA

The Sagardighi by-polls in Murshidabad district on Thursday saw the Congress-Left alliance handing down a stunning defeat to the ruling Trinamool Congress barely a year and a half after it roared back to power in the State Assembly elections in 2021 with 212 out of 294 seats reducing the Left-Congress to a naught for the first time post Independence.

Congress' Byron Biswas trounced his nearest rival Debashis Banerjee of the TMC by a whopping margin of 23,000 votes. While the Congress polled 47.35 percent votes as against TMC's 34.94 percent --- a good 5 percent less than what it got in 2021 --- the BJP which had secured about 23 percent votes in 2021

stopped at 13.94 percent votes. Biswas, bagged 87,667

votes, while Debasish Banerjee of the TMC garnered 64,681 votes. BJP's Dilip Saha received 25,815 votes.

In 2021 the Left and the Congress contested from Sagardighi separately. A strong Left bastion since 1978 before falling into the TMC hands, Sagardighi went to the Congress for the first time since 1972 prompting party Lok Sabha Leader and Pradesh Congress president Adhir Chowdhury to say that Thursday's result was the "beginning of the end of Mamata Banerjee in Bengal." Arithmetically the TMC

which won Sagardighi by 50,000 votes one and a half year ago was in deficit of 73,000 votes compared to what it got in 2021, psephologists said



adding "a ruling party losing a by-election is anything but normal ... which means Sagardighi could well be a trend-setter for the coming

Curiously the TMC's defeat comes barely a few months ahead of the crucial panchayat elections and little more than a year before the 2024 general polls.

Curiously as Sagardighi comes barely a few months after top TMC bosses like Partha Chatterjee and Manik Bhattacharya going to jail on charges of large-scale corruption in school recruitment jobs. It also comes after self-styled TMC "don" --- of neighbouring Birbhum district

member Ánubrata Mondal going to jailon charges of cattle smuggling. Sagardighi results assume

importance against the backdrop of the fact that 65 percent of the voters here belong to the minority community which in respect of the entire State has otherwise been voting ---almost en bloc --- for Mamata Banerjee ever since 2014 general elections.

Reacting to the Thursday's triumph Chowdhury said, "the results here show that Mamata Banerjee is not invincible and that she also can be vanquished ... The message given by the people from this by-election that harder days are going to come for the TMC and that Sagardighi is going to be the

trend setter in times to come." He however said that the

people at ground level could have united against the "TMC's large-scale corruption hooliganism and arrogance which might have seen that many supporters of the TMC or even the BJP might have given vote to us."

Her usual self the Chief Minister however refused to concede defeat saying the Sagardighi was the product of an unholy alliance between the Congress, Left and the BJP. This is an immoral alliance between the Congress, CPI(M) and the BJP which got 22 percent votes in 2021 but transferred 8 percent vote share to the Congress," Banerjee said adding her party would in any case continue to tow the Ekla Chalo line.

"We will not ally with any party in 2024 and contest the elections on our own," Banerjee

## Maha Cong wins bypoll in BJP stronghold

The ruling BJP suffered ■ major jolt in Maharashtra on Thursday, as the Congress a constituent of the Opposition Maha Vikas Aghadi (MVA -- snatched away from it its traditionally stronghold seat of Kasba Peth constituency in Pune in the State Assembly by-poll after a gap of 27-long years.

However, in what came as a consolation, the BJP retained the neighbouring Chinchwad Assembly seat for which the bypoll was held along with that of

Ravindra Dhangekar - who was the joint candidate of the MVA -- romped home in Kasba Peth constituency with a comfortable margin of 10,950 votes against the BJP candidate Hemant Rase. While Dhangekar polled 73,194 votes, the BJP's Rasane secured 62,244 votes.In Chuinchwad, BJP's Ashwini Jagtap, widow of former sitting MLA, trounced the Opposition NCP candidate Nana Kate by a handsome

margin of 36,070 votes. While Ashwini polled 1,35,494 votes, Kate managed to get 99,424 votes.

Independent candidate and rebel Uddhav Thackeray-led Shiv Sena nominee Rahul Kalate --who had been supported by the Prakash Ambedkar-led Vanchit Bahujan Aghadi - played a role of a spoil sport for the NCP candidate, walked away 40,075 votes. Had Kalate not contested the by-poll, the NCP had a chance winning the seat.

The two Assembly by-polls have been necessitated by the death of Kasba Peth's sitting MLA Mukta Tilak --greatgrand-daughter-in-law of the freedom-fighter Bal Gangadhar Lokmanya Tilak – and



Chinchwad's sitting legislator Laxman Jagtap from Chinchwad, both from the BJP.

Today's was the second occasion when the Opposition MVA has won a by-election ever since hands with the Eknath Shinde-led Shiv Sena and toppled the Uddhav Thackeray-led MVA government in June last year. Earlier, in November last year, the MVA-backed Shiv Sena candidate Rutia R. Latke had an easy walk-over in the Andheri East Assembly by-elections.

"The state government will provide Rs 5 lakh compensation each to the wives and children of both the deceased. An amount of Rs 1 lakh each will be provided as cash whereas a fixed deposit of Rs 4 lakh each will be done so that the dependent families do not face any problem in the education and marriage of the kids," he told reporters.

The chief minister had met the family members of Junaid and Nasir at a temporary arrangement made near a helipad in Ghatmeeka village. He was accompanied by

Tourism Minister Vishvendra Singh, Minister of State for Education and local MLA Zahida Khan, Congress state unit chief Govind Singh Dotasra, Chief Secretary Usha Sharma and DGP Úmesh Mishra. Nasir (25) and Junaid alias Juna (35), both residents of Ghatmeeka village in Bharatpur district of Rajasthan, were allegedly abducted by cow vigilantes on February 15 and their bodies were found inside a burnt car in Loharu in Bhiwani in Haryana on the morning of February 16.

Nasir is survived by his wife, while Junaid is survived by his wife, six children and a mentally challenged brother.

Gehlot also said that he will talk to his Haryana counterpart Manohar Lal Khattar take the incident with utmost seriousness as it is of similar nature to the incident that happened in Udaipur



where a tailor was hacked to death. He said his government is committed to arresting the accused at the earliest and submit the charge sheet. Such a crime deserves nothing less than death penalty, he said.

District and Sessions Judge, Gaya, Manoj Kumar Tiwari, also slapped Ram Chandra Yadav alias Kirani with a fine of Rs 3.05 lakh, holding him guilty under the Terrorist and Disruptive Activities (Prevention) Act and Sections 302 (murder) and 307 (attempt to murder) of the IPC.

Kirani was named in the massacre that took place in Bara village of Gaya district on February 12, 1992, when 37 upper caste Bhumihars were butchered by the Maoist Communist Centre (MCC).

Central Bihar hogged the limelight in the 1980s and 1990s for a chain of retributive



guerrillas and private militia of upper caste landlords.

The Bara massacre had been described by the MCC as "revenge" for killing of dalits elsewhere by the 'Savarna Liberation Front', one of the many upper caste militias that had cropped during the time, the most notorious being the 'Ranvir Sena', which was held responsible for the Laxmanpur Bathe massacre of Jehanabad,

where 67 dalits were killed. Kirani's counsel Tariq Ali told reporters after the verdict that "we are not satisfied and look forward to challenging the trial court order before the Supreme Court, since TADA cases cannot be heard by high

## **Lotus blooms**

BJP's performance in NE shows that Modi's charisma and Amit Shah's political acumen are unmatched

he Bharatiya Janata Party has once again shown its electoral prowess, this time in the North East. The fact that it seems to be retaining Tripura on its own is quite creditable. As in other states, the saffron party removed Biplab Deb as chief minister last year. Deb had played a key role in the BJP's victory in the state in 2018, but he didn't excel as chief minister. Worse, his loose remarks often attracted ridicule. For instance, in April 2018, he claimed the internet existed during the Mahabharata period. The BJP realised his inadequacies; and it was nimble-footed enough to replace him in May last year with Manik Saha. By the way,



Saha has been able to retain his seat in the Town Bardowali constituency. Former royal scion Pradyot Kishore's Tipra Motha Party doesn't seem to have damaged the prospects of the BJP, even though the new party did get a good number of seats. The BJP has already said that it would accept all demands of Tipra Motha, except for Greater Tipraland. In Nagaland too, the BJP, in alliance with the local partner NDPP, was marching towards victory at the time of the writing of these lines. Only in Meghalaya has the saffron party not been able to do very good. On the whole, however, the BJP should be satisfied, for it has not just been able to retain Tripura but also made its presence felt in the region.

It may be mentioned here that in the North East, apart from the local parties, it was only the Congress and, in some parts, the Left that were politically strong. Against this backdrop, the saffron party has done a commendable job in the region. It is likely to spread its influence, and this may also be by partnering with local parties. The local parties have always been keen to have good relations with the Central Government and whichever party runs it. Besides, the BJP will rely on its own cadre and that of Rashtriya Swayamsevak Sangh. The Hindutva party may also undergo ideological and political moderation because of its experience in the North East—particularly its bovine nationalism. Consider this: in July 2021, Meghalaya minister and BJP member Sanbor Shullai encouraged the people in his state to eat more beef than chicken, mutton and fish. Some of the rough edges of the BJP may get smoothened; this will be good for the party as well as the country. Concomitantly, results of the Assembly elections in the three North Eastern states show that the decline of the Congress continues unabated. Despite the enthusiasm party leader Rahul Gandhi's Bharat Jodo Yatra instilled in the hearts and minds of the cadre, the GOP has failed to translate that enthusiasm into votes at least in these three states. For the nth time, it has been demonstrated that the charisma of Narendra Modi and the political acumen of Amit Shah are unmatched. The Modi juggernaut marches ahead.

ndians and India's politics are getting a lot of attention from foreign press and individuals/institutions having vast resources at their disposal. ## **FIRST COLUMN 'WAR IS SLOWING DOWN ECONOMIC GROWTH'**

The G20 meeting stresses the interdependence of world security and economy

The G20 finance ministers and central bank governors meeting in Bengaluru last week, brought almost every important eco strategy policy maker, around the globe to sit across the table to deliberate on key policy issues. It also laid bare the interdependent nature of security and economic issues, the globe faces today. In the heart of the difference between the US-led alliance of nations and the Russia sympathising nations, lay two controversial paragraphs with strong condemnation of the ongoing war in Ukraine.

Paragraph 2 from the chair's summary, released at the end of the meeting read "Since February 2022, we have also witnessed the war in Ukraine further adversely impact the global economy. There was a discussion on the issue. We reiterated our national positions as expressed in other fora, including the UN Security Council and the UN General Assembly, which, in Resolution No. ES-11/1 dated 2 March 2022, as adopted by majority vote (141 votes for, 5 against, 35 abstentions, 12 absent), deplores in the strongest terms the aggression by the Russian Federation against Ukraine and demands its complete and unconditional withdrawal from the territory of Ukraine. ... G20 is not the forum to resolve security issues, we acknowledge that security issues can have significant consequences for the global economy." Ideally, there would have been a joint press communique but, due to the severe objection from Russia and China, regarding the two paragraphs, it was converted into a chair's summary. The summary meanwhile highlighted risks of slow global growth, inflationary trends, a resurgence in newer variants of the pandemic and the vulnerabilities of several emerging markets due to tightening financial conditions.

India managed to push ahead with its stated agenda of bringing about reforms in the functioning of Multilateral Development Banks, in a nimble



way, by including several small but effective tangible outcomes in the chair's summary. The summary tasked the expert group under India's G20 presidency to present a report in the next couple of months on the "World Bank's Roadmap for evolving the Bank's mission, operational approach, and financial capacity within their country engagement model and ..other MDBs to report on their efforts to address similar challenges." The world banks' role, functions, goals and impact on national economies have come under severe criticism in the past several years, which was hugely aggravated during the pandemic. India has been championing multilateral institution reforms, to reflect the changing dynamic of the geopolitical landscape and the rise of several economic powerhouses, especially in Asia.

The G20 finance ministers will seek a roadmap from the international financial architecture working group on implementing the recommendations of the G20 independent review, of the multilateral development banks, within India's G20 presidency tenure. Similarly, India managed to stay firm on it being the torch bearer of the global south, by getting the right verbiage included in the summary, of maintaining a strong global financial safety net, with a strong quota-based and adequately resourced International Monetary Fund. The debt vulnerabilities of many low and middle-income countries, many of whom are or sitting on the fence before going bankrupt could create chaos in the global economy. India unilaterally has extended relief to its southern neighbour Sri Lanka.

Clearly, India did manage a good show at the first meeting of finance policymakers, but the underlying differences over security issues related to Ukraine prevented it from being the picture-perfect finish. India has to keep in mind these sensitivities as it proceeds with the remaining 200plus meetings around G20, especially those with huge strategic interests such as external affairs, security and finance. It would be a tightrope that India needs to walk on, one step at a time like it has been doing for the last two years.

With a view to leveraging the benefits of the latest and emerging technologies in the solution-production-distribution chain, a provision has been made in this budget for the skill development of youth in new-age disciplines like Coding, Artificial Intelligence, Robotics, Mechatronics, Internet of Things and 3D Printing, Drones, etc. under PMKVY 4.0. This will help elevate the quality of human excellence in tune with the demands of an ever-evolving technology-driven economy. The budget provides for the setting up of 30 Skill India International Centres across the country to help promote interdisciplinary research for developing cutting-edge applications

Concurrently, the provision for setting up three centres of excellence for Artificial Intelligence will help develop youth with competencies to leverage new technologies for innovations in different spheres of human endeavour. The target of training 47 lakh youths in 3 years under PMKVY 4.0, National Apprentice Scheme, on-the-job training in partnership with industry in new-age courses is indeed a commendable decision as it will help create a huge pool of technically skilled youth to turn India into an IT superpower. Additionally, the decision to extend the stipend to 47 lakh youth under the National Apprenticeship Promotion Scheme through direct transfer benefits will help boost employability and the practical application of skills. This will also promote the integration of critical thinking and problem-solving capabilities through a dynamic and diverse curriculum. One hundred fifty-seven nursing colleges will be attached to the existing 157 medical colleges that will help overcome the shortage of trained health workers as was felt during the Corona pandemic.

This will also leverage the benefits of AI in all spheres of human indulgence. Facilitating states to provide access to national digital library resources will increase the enrolment ratio in rural India, besides restoring the tast-awingling reading nabits. The online training platform is yet another initiative to help train youth in a unique and speedy manner. These will help create a conducive learning environment and nurture communication and creative skills among students.

The provision for professional development of teachers through reskilling and up-skilling on critical components like curriculum design, development, enrichment, transaction, innovative pedagogy & assessment and ICT implementation for ensuring access to quality learning has been made for the first time. District Institutes of Education & Training will be revitalised into vibrant institutes of excellence for empowering teachers with these attributes. The decision to recruit 38,000 teachers for 740 Eklavya Model Residential Schools is an intelligent decision for the delivery of uniform quali-

ty education across the nation.

The vision of NEP2020 to make education equitable and inclusive will be furthered with the setting up of the National Digital Library along with physical libraries at panchayats and wards. This move shall make quality content accessible to millions of needy learners across the country and will help cope-up with the learning loss accrued owing to corona pandemic. Concurrently, this is also an initiative to ensure ageappropriate reading material to inspire people to resume studies that they abandoned due to socioeconomic reasons.

Facilitating students to learn English and regional languages in partnership with non-governmental organisations will improve their understanding of culture and its local and regional variants. National Book Trust and Children's Book Trust are to ensure the availability of books in regional languages.

These budgetary provisions are expected to fast-track the implementation of NEP 2020 and achieve its end objectives of transforming the extant education system into a learner-centric system relevant for the 21st Century and reaping the benefits of the demographic dividend of 'Amrit Kaal Peedhi' and helping them become champions of Amrit Yatra. ## Make public places accessible to the disabled

Wholesome accessibility continues to elude persons with disabilities in India

isability inclusion is a matter of justice and investment in our common future and shared prosperity. However, there has not been much change in our attitude or ground realities regarding facilitating the accessibility of persons with disabilities in India after 75 years of Independence. It shocked many when former Prime Minister Dr Manmohan Singh was moved from the front row of the Rajya Sabha to the last. Dr Singh (90), now uses a wheelchair and his 'ease of mobility' was cited as the reason for this change in the allocation of his seat in the Upper House of Parliament. This issue brings back the focus on the challenges of accessibility for the disabled. It is important to take a pause here and imag-



address the issues around disability. Still, as the former PM's case suggests, there are yawning gaps when it comes to universal access in public places. For decades, disability has been viewed as an alsodo subject. Yet governments as Similarly, railway stations and well as other stakeholders have airports have been upgraded to taken many initiatives to make these more accessible.

All this work, in compliance with the Rights of Persons with Disabilities Act 2016, is good, but only addresses a part of the problem. In addition to ensuring compliance with provisions of this progressive Act, we need to concertedly work towards a focussed push on expanding infrastructure support, institutional remodelling of our work culture, continued mass awareness and sensitization programs, sustained policy dialogues and capacity building for people employed in the disability sector. The first and foremost task is to expand accessible infrastructure. NCERT's 8th All India School Education Survey (AISES) brought some startling facts on schooling facilities for children with disabilities. Out of a total of 58,76,273 teachers, only 1.32% (80,942) teachers have received any kind of training in inclusive education. Out of the total schools in the country, only 10% have handrails, 4% have adapted labs and 8% have adapted toilets. Out of 12,99,902 schools, Braille books are available in 89,145 (6.86%), Braille Slate and Stylus in 88,775 (6.83%), Taylor Frame in 88,399 (6.80%), Abacus in 1,08,441

(8.34%), Hearing-aid in 94,882 (7.30%), Computer and Software in 1,00,334 (7.72%) and Audio-visual in 1,09,647 (8.44%) schools. This lack of accessibility is acting as a major hurdle in the holistic growth of disabled children and has led to children and parents opting for open education. The nation's poor track record in enabling employment for disabled people is another area of concern since this is intricately linked with the issue of accessibility. The RPWD Act mandates a 4 per cent reservation in government jobs for disabled people. However, the record may be dismal - in the Central government, for instance, against 2036 appointments in 2018, the figure went down to 1709 in 2019, and 1375 in 2020. Add to this, the nomic, cultural, and political

rigid criteria of employment for disabled people resulted in many vacant posts. With reasonable accommodation, enabling an accessible work ecosystem, and assistive technologies, many persons with disabilities can be included in the workforce. This involved addressing the attitudinal barriers towards disability in society, deep-rooted stigma,

and stereotypes.
An NCPEDP-Javed Abidi Fellow carried out an independent audit of various tourist spots of Rishikesh, the Yoga Capital for the world and Deĥradun in Uttarakhand to check for accessibility. It found loopholes in accessing tourist spots by persons with disabilities. Persons with disabilities are important to our socioecoecosystem. Unfortunately, they do not get what they need to live a dignified life. However, for them, the ease of living remains a distant dream. The social model of dis-

ability focuses on the interaction between a person and their environment, thereby highlighting the role of society and various institutions - government and private - in combating the stigma attached to people with disabilities. Private sectors, government procurements, and tenders - do not adhere to the accessibility needs of persons with disabilities. Unless we create a culture that supports, promotes, and includes disability in all aspects of life, the vision of building a truly accessible. inclusive, and self-reliant India seems very far off.

## Haley: Pak home to over a dozen terrorist groups

Indian-American Republican presidential candidate Nikki Haley has said that Pakistan is home to at least a dozen terrorist organisations and it should not receive any aid from the US, ramping up her attack on America's adversaries.

The 51-year-old two-term Governor of South Carolina and the former US Ambassador to the United Nations formally launched her 2024 presidential bid last month.

"Pakistan is home to at least a dozen terrorist organisations. #CutEveryCent," Haley tweeted Wednesday.

Over the past few days, Haley has been speaking on US foreign policy and asserting that the US should not give any financial assistance to countries that are friends and allies of China and Russia.

On Sunday, Haley in an op-ed in the New York Post wrote that if voted to power, she will cut foreign aid to countries like China and Pakistan which hate America. In an interview with Fox News on Sunday, she repeated her pledge to cut US foreign aid to countries that are friends and followers of Russia



and China, the two adversaries

Haley, who announced her candidacy on February 14 is all set to appear at Conservative Political Action Conference as a star speaker along with her former boss and former pres-

ident Donald Trump.

As per the schedule, she will speak on Friday morning

and another presidential candidate Vivek Ramaswamy is scheduled for Friday afternoon. According to Haley, the Biden administration resumes military aid to Pakistan, though it's home to at least a dozen terrorist organisations and its government is deeply in hock

to China. She said that as the US

ambassador to the UN, she strongly supported then-president Donald Trump's decision to cut nearly USD 2 billion of military aid to Pakistan because that country supported terrorists who kill American

rorists who kill American troops.

"It was a major victory for our troops, our taxpayers and our vital interests, but it didn't go nearly far enough. We've still given them way too much in other aid. As president, I will block every penny," she added.

Randhawa to immigrant Punjabi Sikh parents, Haley is the third Indian-American to run for the US presidency in three consecutive election cycles. Bobby Jindal ran in 2016 and Vice President Kamala Harris in 2020.

Days after Haley announced her White House bid, Indian-American tech entrepreneur Ramaswamy, another Republican, also launched his 2024 presidential bid. Before entering the presidential ballot, Haley has to win the Republican Party's presidential primary which will start in January next year.

The next US presidential election is scheduled to be held on November 5, 2024.

UN Secretary-General António Guterres spoke to reporters during a rare visit to Baghdad, his first in six years, ahead of this month's 20-year anniversary of the 2003 U.S.-led invasion that toppled

Saddam Hussein.

The years that followed Saddam's overthrow saw widespread sectarian violence and the rise first of al-Qaida in the region and later, the extremist Islamic State group, which at one point controlled wide swaths of territory, including Iraq's second-largest city, Mosul. "We recognize that the challenges Iraq is facing did not arise overnight," Guterres said, speaking at a news conference alongside Iraqi Prime Minister Mohammed Shia al-Sudani. "They are the product of decades of oppression, war, terrorism, sectarianism and foreign interference."

He praised the formation of Iraq's new government in October, after a yearlong political stalemate, and the country's "ambitious and forward-looking reform agenda." He also pledged U.N. Support for systematic governance reforms and for measures to address Iraq's looming water crisis, which experts expect to be exacerbated by climate change.

Guterres commended Iraq for repatriating its citizens from northeastern Syria, particularly from al-Hol camp, which holds tens of thousands of women and children — primarily the wives, widows and children of IS fighters - in what human rights groups have described as dangerous and squalid living conditions.

"It may have taken two times, but it was worth the trip," Bowen said. They will replace a US-Russian-

cation and advanced technology, Sarah al-Amiri, said the long mission "provides us a new venue for science and scientific discovery for the country."

The Emirates already have a spacecraft orbiting Mars, and a mini rover is hitching a ride to the moon on a Japanese lander. Two new UAE astronauts are training with NASA's latest astronaut picks in Houston.

Saudi Prince Sultan bin Salman was the first Arab in space, launching aboard shuttle Discovery in 1985. He was followed two years later by Syrian astronaut Muhammed Faris, launched by Russia. Both were in space for about a week.

Al-Neyadi will be joined this spring by two Saudi astronauts going to the space station on a short private SpaceX flight paid by their government.

"It's going to be really exciting, really interesting" to have three Arabs in space at once, he said last week. "Our region is also thirsty to learn more."

### Next gen Tesla car to cost half

AP DETROIT

Tesla says it will cut the cost of its I next generation of vehicles in half, largely by using innovative manufacturing techniques and smaller fac-

CEO Elon Musk and other executives outlined the goals during a 3 1/2-hour investor day presentation at Tesla's Austin, Texas, headquarters Wednesday as they presented the company's third master plan.

The changes could bring the cost of a new generation of vehicles to around \$25,000. Many investors were hoping to catch a glimpse of the next generation vehicles, but Musk said they wouldn't be shown until a proper product unveiling.

"We'd be jumping the gun if we answer your question," about the new vehicles, he told an analyst.

Shares of Tesla fell nearly 6% in after-hours trading during the presentation that ended just after 8 pm Eastern time.

Musk announced that Tesla plans to build a new factory in Mexico near Monterrey. Company executives said it will not take production from any other factories, where Tesla expects to expand production. They said the Mexican plant would build the next generation of vehicles, which also will be built at other factories.

It's likely that the next generation vehicles will be smaller than the current ones to bring the prices down, but that wasn't clear from the presentation. Many automakers build smaller vehicles in Mexico to save on labor costs

Officials blame the problem on recent bad weather in Spain and North Africa, saying the shortages could persist for up to a month. But many people were quick to point out that ther European countries don't seem to be suffering the same challenges, leading some to wonder if it was a consequence of Britain's divorce from the A look at some of the factors con-

tributing to what one European broadcaster has called Britain's "vegetable

**COLD WEATHER, HIGH ENERGY BILLS** Unusually cold temperatures in

Spain and heavy rain and flooding in Morocco — two of the biggest tomato suppliers to the UK — have led to poor yields and are cited as the primary cause of the shortage.

In Spain, farmers blame recent freezing temperatures following record heat and dry conditions last year. Heat and drought in Europe last year also are affecting vegetable harvests in other countries, including Germany.

Separately, the Netherlands, another major tomato producer, has seen a drop in output because skyrocketing energy bills tied to Russia's war in Ukraine meant many growers couldn't justify the cost of turning on the LED lights in their greenhouses this winter. Vegetable growers in the UK Have reported that they, too, were forced to leave their greenhouses empty. Richard Diplock, managing director at the Green House Growers based in southern England, said his energy costs are some six times higher compared with previous winters.

#### **BLAMING BREXIT**

The shortages in Britain — and contrasting pictures of full vegetable shelves in supermarkets in mainland Europe — led to a degree of Brexit schadenfreude in some EU news outcosts associated with Brexit have played a part, though they stress it's not a main factor.

"One hypothesis for fewer exports to the UK Is that if supply is constrained, why would you go to extra paperwork (to export to Britain)?" said Michael Winter, a professor of agricultural change at the University of Exeter. "If transaction costs are greater for exporting to one country compared to another, that's going to dictate where you go.'

#### **SUPERMARKET PRICING**

Farmers say another factor is how Britain's biggest supermarkets have sought to stay competitive by keeping prices as low as possible even as food costs have spiked, a major driver of inflation that's at the highest levels in

Germany, there are no empty shelves, but the prices for fresh vegetables have shot up massively. British supermarkets are reluctant to pay more or charge customers so much, Diplock said.

#### "WHERE'S THE INVESTMENT?" Even if energy costs hadn't risen so

much, British growers would not come close to making up for the shortfalls in imported produce, Diplock said. During the winter, domestic UK Production only accounts for 5% or less of tomatoes and cucumbers sold in British supermarkets.

The National Farmers' Union has warned for months that overreliance on imported fresh produce leaves the UK vulnerable to unpredictable weather events and other external factors like the war in Ukraine.

## Russia accuses Ukraine of UK navy seizes Iranian missiles in Gulf of Oman sabotage, but Kyiv denies

 $R^{ussian}$  officials accused Ukrainian saboteurs of crossing into western Russia and attacking local villages on Thursday, an accusation that Ukraine denied, warning that Moscow could use the claims to justify stepping up its own assaults in the ongoing war.

The exact circumstances of the incident reported in the Bryansk region were unclear, including what the strategic purpose of such an attack might be.

If confirmed, it would be another indication following drone attacks earlier this week that Kyiv could be stepping up pressure against Moscow by exposing Russian defensive weaknesses, embarrassing the Kremlin and sowing unease among Russian civilians.

Russian President Vladimir Putin blamed Ukrainian "terrorists" for an incursion, claiming that they deliberately targeted civilians, including children.

"It was yet another terror attack, another crime," Putin said during a video call. "They infiltrated the area near the border and opened fire on

While Russian war hawks have expressed dismay about a sweeping mobilization of soldiers, the Russian leader's comments Thursday's didn't appear to signal any such moves.

Putin said the attack in the Bryansk region, which he blamed on "neo-Nazis", confirmed that Russia did the right thing by launching its 'special military operation" in Ukraine. "I repeat again: They will not succeed and we will finish pushing them out," he

Putin is set to chair a weekmeeting of his Security Council on Friday. Asked by reporters whether the attack in Bryansk could warrant a change in the status of the conflict, Kremlin spokesman Dmitry Peskov responded with a coy "I can't say for now." Peskov said that Putin can-

celed a planned trip to southern Russia set for Thursday and was receiving reports on the situation from the regional gov-Thursday's apparent incur-

sion came just days after Putin ordered the Federal Security Service to tighten controls on Russia's border with Ukraine.

Ukrainian presidential adviser Mykhailo Podolyak described the Russian reports as "a classic deliberate provo-

people to justify the attack on another country (and) the growing poverty after the year of war", he tweeted, suggesting that the attack was the work of Russian partisans.

Amid conflicting initial reports, Russia's Federal Security Service said fighting with the sabotage unit was taking place in the Bryansk

The Federal Security Service was quoted by the Russian state Tass news agency as saying that "activities to eliminate armed Ukrainian nationalists who violated the state border" were underway.

Tass, citing Russian law enforcement, reported earlier that the saboteurs were holding up to six people hostage. The local governor said the group had fired on a vehicle there, killing one man and wounding a 10-year-old child. Tass reported, citing an

unnamed security official, that two villages in the Bryansk region — Sushany and Lyubechane — were under attack by "several dozen armed fighters".

Alexander Bogomaz, the governor of the Bryansk region, which borders Ukraine, said the group fired on a vehicle in Lyubechane, killing one man and wounding a child. He also said that a Ukrainian drone struck a house in the Sushany setting it ablaze.

On Tuesday, drones that the Kremlin said were launched by Ukraine flew deep inside Russian territory, including one that got within 100 kilometers (60 miles) of Moscow.

Ukraine's military intelligence representative, Andrii Cherniak, saw the Russian claims as evidence that it is facing what Kyiv alleges is an uprising among its own disgruntled people.

"This was done by the Russians, Ukraine has nothing to do with it," he told The Associated Press. Cherniak noted that a

group calling itself the Russian Volunteer Corps had claimed responsibility for the attack in a video where they urge Russians to rebel. The Russian Volunteer

Corps describes itself as "a

volunteer formation in the Armed Forces of Ukraine". Little is known about the group and it's not immediately clear if the group indeed has any ties with the Ukrainian military. Nor was it clear from the Corps statement what action it took and what specific objectives it wanted to achieve.

The British navy seized anti-tank missiles and fins for ballistic missile assemblies during a raid on a small boat heading from Iran likely to Yemen, authorities said Thursday, the latest such seizure in the Gulf of Oman.

The seizure by the Royal Navy comes after other seizures by French and US Forces in the region as Western powers increase their pressure on Iran, as it now enriches uranium closer than ever to weaponsgrade levels. It also comes as regional and international powers try to find an end to the yearslong war gripping Yemen, the Arab world's poorest country, and as Iran arms Russia in its war on Ukraine.

The raid took place Feb. 23 after an American aircraft detected a small boat heading from Iran, with a helicopter from the Royal Navy frigate HMS Lancaster giving chase to the vessel, the British Defense Ministry said. The boat tried to reenter İranian territorial water, but was stopped before it could.

Inside the boat, British troops found Russian 9M133 Kornet anti-tank guided missiles, known in Iran as "Dehlavieh," the U.S. Navy's Mideast-based 5th Fleet and the British navy said. Those weapons have been seen in



other seizures suspected to be from Iran and bound for

Also on board were small fins that the US Navy identified as jet vanes for medium-range ballistic missiles. Iranian components have helped build a missile arsenal for Yemen's Houthi rebels, who have held the country's capital, Sanaa, since 2014.

A United Nations resolution bans arms transfers to Yemen's Iranian-backed Houthi rebels. Tehran long has denied arming the rebels, despite physical evidence, numerous seizures and experts tying the weapons back to Iran.

This seizure by HMS Lancaster and the permanent presence of the Royal Navy in the Gulf region supports our commitment to uphold international law and tackle activity that threatens peace and security around the world," British Defense Secretary Ben Wallace said.

Vice Adm. Brad Cooper, the commander of the American 5th Fleet, said in a statement that this was the "seventh illegal weapon or drug interdiction in the last three months and yet another example of Iran's increasing malign maritime activity across the

Iranian state media did not immediately acknowledge the seizure. Iran's mission to the United Nations did not immediately respond to a request for comment. The war in Yemen has

## Hungary delays vote on Sweden, Finland's NATO accession bids

 $H^{ungary\ has\ further\ delayed}_{a\ vote\ on\ ratifying\ Sweden}$ and Finland's NATO accession bids, according to an updated schedule published on Thursday on the National Assembly's website, the latest in a series of postponements that have frustrated Western allies.

The delay, which pushes the vote back by two weeks to the parliamentary session beginning March 20, comes as Hungary remains the only NATO member country besides Turkey that hasn't yet approved the two Nordic countries' bids to join the Western military alliance.

Hungary's populist prime minister, Viktor Orban, has said that he is personally in favour of the two countries joining NATO, in Stockholm and Helsinki have 'spread blatant lies" about Hungary which have raised questions among lawmakers in his party on whether to approve the bids. In a radio interview on February 24, Orban confirmed that Hungary would send a parliamentary delegation to Sweden and Finland to seek "clarification" on such issues before the ratification could come to a vote in

parliament. "It's not right for them to ask us to take them on board while they're spreading blatant lies about Hungary, about the rule of law in Hungary, about our democracy and about life here," Orban said. "(How) can anyone want to be our ally in a military system while they're shamelessly spreading lies about Hungary? So let's stop for a friendly word and ask them how this can be." ## **GDP** growth may exceed 7% this fiscal, says CEA

hief Economic Advisor V CAnantha Nageswaran on Thursday expressed hope that the GDP growth for the current financial year will exceed the projected 7 per cent in view of the expected revision of high frequency data.

On Tuesday, the second advance estimate released by the National Statistical Office (NSO) maintained the growth projection of 7 per cent as was projected in the first advance estimate which was released in

"Given the high frequency indicators and the pace at which they are recovering, I do believe that the current year's (GDP numbers)... Are more likely to (be) revised upward than downward," he said here. Real GDP or GDP at

Constant (2011-12) Prices in the year 2022-23 is estimated at Rs 159.71 lakh crore as against the first revised estimate of GDP for the year 2021-22 of Rs 149.26 lakh crore.

The growth in real GDP during 2022-23 is estimated at 7 per cent as compared to 9.1 per cent in 2021-22, the NSO had said. The growth slowed to 4.4 per cent in the October-

December quarter, mainly due to a contraction in the manufacturing sector, as per the data released by the NSO.

On Tuesday, the NSO revised GDP growth data for the past three years -- 2019-20, 2020-21 and 2021-22 -- and also released the second advance estimate of GDP for

While the growth rate for 2021-22 has been revised up by 40 basis points to 9.1 per cent from 8.7 per cent, the GDP for 2020-21 too has been revised upwards to (-) 5.8 per cent from (-) 6.6 per cent.

For 2019-20 also, the growth has been revised upwards to 3.9 per cent from

Nageswaran said the rising interest rates need not necessarily be a cause of lower growth but simply reflects the

fact that there is healthy underlying demand for credit.

Real interest rate is not very high at the moment, he said adding there is pent up demand in certain sectors.

About rural inflation remaining high, he said it doesn't take into account the fact that bulk of the population may be getting their essential food grains at zero cost.

On the economic benefit of digitisation, he said that digital transactions enable increase in formalisation. "My guesswork is that it is

adding between 30 and 50 basis points per annum to the provisional GDP... Nobody has yet done the proper estimation of what the digital infrastructure is adding to the overall potential economic growth (and) that needs to be worked out," he said.


## Grow more millets to help address malnutrition, small farmers told

Narendra Singh Tomar on Thursday urged small and marginal farmers to grow more millets, which can help address malnutrition in India and the

Millets like ragi and jowar are grown with less water but has high nutrition. However, these miracle cereals were kept out thinking it was poor man's

In his inaugural address at the annual 'Krishi Vigyan Mela' here at Pusa campus in the national capital, Tomar said millets are grown by small and marginal farmers, and not by big farmers. Amid the problem of malnutrition and challenges of climate change, India took the lead and the current year is being celebrated as the international year of millets across the world, he added.

According to Tomar, millets are not only high in nutrition but also fetch good price for farmers, and it will be good for small and marginal farmers, who comprise 80 per cent of



the total farming community in

"We are eating well but not nutrition rich food... There is a problem of malnutrition not only in India but in many parts of the world. We can address the malnutrition problem by growing more millets," Tomar noted.

India is a major millets producing nation. If huge demand is created for millets and millets-based products, income of small and marginal farmers can be enhanced, he said, and added the government is making efforts to create the market for millets and encourage value-addition.

To brand them beyond poor man's food', the government took a cautious decision of naming eight types of millets as "Sree Anna", indicative of having better nutrition than wheat and rice, he said.

For export of Indian millets, the minister said the government plans to facilitate participation of exporters, farmers and traders in 16 International Trade Expos and Buyer-Seller Meets (BSMs).

The Delhi High Court on Thursday said it is "amaz-¬he Delhi High Court on ing" that two elected Governments have set up Delhi Metro Rail Corporation (DMRC) which now says it has no money to pay the arbitral award to the Reliance Infrastructure-owned Delhi Metro Express Private Limited (DAMEPL).

The court asked the competent authority of DMRC to attend the proceedings so that a holistic view can be taken regarding the funds available with the corporation. "I have before me two sovereign and elected governments who have set up this corporation and we are told that it has no money to honour the award," Justice Yashwant Varma said while listing the matter for further hearing on Friday.

The high court was hearing



an execution petition filed by DAMEPL against the DMRC over the arbitral award passed in its favour on May 11, 2017.

An arbitral tribunal had ruled in favour of DAMEPL, which had pulled out of running the Airport Express metro line over safety issues, and accepted its claim that running the operations on the line was not viable due to structural defects in the viaduct through which the train would pass.

Hearing the submissions advanced by the counsel for Central and Delhi government, which are stakeholders in DMRC, that they are not liable

## Power prices expected to remain firm next fiscal amid higher demand: Crisil

 $P^{\text{ower prices are expected to}}_{\text{remain firm next fiscal on}}$ the back of elevated demand growth of 5.5-6 per cent, and the demand is set to close this fiscal up 9.5-10 per cent over 8.2 per cent last fiscal, a report said on Thursday.

The fears of a heat wave has seen the short-term power prices soaring by a full 151 per cent. This was on the back of a 42 per cent on-year spike in prices in February, Crisil said in a report.

The demand growth would mark a decadal high rate of growth and almost double the 20-year average of 5.2 per cent, the report added.

The report noted that demand growth weighed in at

7.7 per cent in February and averaged 10 per cent for the 11 months of the current fiscal despite a high base of fiscal 2022 due to extreme weather events and robust industrial and manufacturing activity.



## jokovic eyes elusive gold at Paris Olympics

Novak Djokovic is hoping the Paris 2024 Games will be his most successful Olympics to date, as he continues to chase the gold medal that has so far eluded him.

After notching an impressive straight-sets victory over Dutch world number 39 Tallon Griekspoor on Wednesday to reach his 13th Dubai quarter-final in as many appearances, Djokovic spoke about his ambitions for the Olympic Games next year.

"I hope that I'll be able to play healthy for next year's Paris Olympics," said Djokovic, whose best showing at the Games so far came in 2008 when he won bronze in sin-

gles.
"It's going to be played on clay at Roland Garros, I'm familiar with those grounds, so I hope that the best Olympic result for me will come there.

Two of Djokovic's 22 Grand Slam titles have come at Roland Garros, in 2016 and 2021.

With a far more straightforward display compared to his opening round in Dubai, Djokovic extended his undefeated run this season to 14-0 — and his overall winning streak to 19 matches - with a 6-2, 6-3 victory over Griekspoor, who is one of the most improved players on tour these past two months.

It was a clean performance from Djokovic, who dropped just two points behind his first serve and fired 29 winners against a mere six unforced errors.

"It's been a great evening for me tonight. Yesterday I really had to work hard to get a win," said fivetime Dubai champion Djokovic, who squeezed past world No.130 Tomas Machac with a third-set tiebreak victory in the first round. "Tonight I think right from the

Djokovic broke at the start of the match before play was interrupted due to light rain. The brief delay did nothing to disrupt the top seed's rhythm though, as he comfortably scooped the opening set in



But life happens, you make mistakes... It is all about how you pick yourself up from there," Jemimah said.

IN unchanged squad for the two-Test series against Sri Lanka at home that recently defeated England by just one run at Wellington. New Zealand Cricket (NZC) on Thursday announced a 13-member squad under captain Tim Southee for the series beginning on March 9, with no surprises, although rookie seamer Jacob Duffy, legspinner Ish Sodhi, and injured pace bowler Kyle Jamieson have been excluded.

Former captain Kane Williamson will continue to be the batting mainstay along with Tom Latham, Henry Nicholls, Devon Conway, Daryl Mitchell and Will Young, while Tom Blundell will keep wickets dur-

While reigning World Test champions New Zealand are out of contention for a berth in the WTC final, Sri Lanka are still in with a chance and a 2-0 sweep for the Islanders could help

It will be only the second

The matches will be played on August, 17, 19 and 20, with the venues yet to be confirmed.

On Veeb Dhull's Pradesh top-order after Yash Dhull's quick half-century took Rest of India to a commanding 484 on the second day of the Irani Cup, here on Thursday.

Saini (2/15) looked in good rhythm and generated fair bit of pace on a dead track to peg MP back before Yash Dubey (53 batting) and Harsh Gawli (47 batting) added 97 runs for the unbroken fourth wicket to take the hosts to 112 for 3 in

their first innings at stumps.

In a match like Irani Cup, the national selectors usually don't just look at the numbers but also at specific players with specific purpose.

One such player is Saini, who missed the entire Ranji Trophy season due to abdominal muscle strain and had to undergo extensive rehabilitation work at the National Cricket Academy (NCA).

Asked to bowl in the second session of the day, he did hurry the MP batters with pace and movement off the track.

It was Bengal seamer Mukesh Kumar (1/27), who got the first breakthrough for the Rest as he angled one across for debutant southpaw Arham Aquil (0), who clearly didn't look ready for this level dur-



ing his brief stay at the crease.

He didn't look happy with the caught-behind decision but had to trudge back without troubling the scorers.

Saini then got into the act as he bowled beautifully on the off-stump channel and just got enough movement to force the batters to play his deliveries.

A hint of an away movement saw MP skipper Himanshu Mantri jab at the delivery and Dhull, nicely warmed up and alert at second slip, pulled off a good
