# 'India transitioned from democracy to autocracy'

### Congress not among signatories of letter

After former Delhi Deputy Chief Minister Manish Sisodia's arrest in the excise policy case, nine leaders of eight political parties on Sunday wrote to Prime Minister Narendra Modi, accusing his Government of misusing the office of Governor and Central agencies to target the Opposition parties and their

However, no Congress leader was among the signatories. According to sources, the letter was written at the behest of Delhi Chief Minister Arvind Kejriwal and Telangana Chief Minister K Chandrasekhar Rao. The letter said that India has "transitioned from being a

democracy to an autocracy. Apart from Kejriwal, the other signatories of the letter were Punjab Chief Minister Bhagwant Mann of the Aam Aadmi Party (AAP), West Bengal Chief Minister Mamata Banerjee of the Trinamool Congress (TMC), Rao of the

Bharat Rashtra Samithi (BRS), National Conference (NC) leader and former Jammu and Kashmir Chief Minister Farooq Abdullah, Nationalist Congress Party (NCP) leader Sharad Pawar, former Maharashtra Chief Minister Uddhav Thackeray, Samajwadi Party (SP) chief and former Uttar Pradesh Chief Minister Akhilesh Yadav, and Bihar Deputy Chief Minister Tejashwi Yadav of the Rashtriya Janata Dal (RJD).

This highlights divisions in the Opposition camp. The letter seems to be a signal of the alliance of political parties for the 2024 Lok Sabha polls.

Remarking on the role of the Governors, the Opposition leaders alleged that their offices in the country are "frequently hindering the governance of the State" they are sent to.

Pointing at Assam Chief Minister Hemant Biswa Sarma and other BJP leaders Mukul Roy, Narayan Rane and Apart from the Congress, the JDS, the JD(U), and the CPM did not sign the letter. Suvendu Adhikari, the Opposition leaders said that the probe against the corrupt politicians who joined the Bharatiya Janata Party (BJP) has been delayed. The leaders alleged that the

timings of the lodging of cases against and arrests of the Opposition leaders "coincided with elections" which makes it clear that the action taken was "politically-motivated". "The blatant misuse of

central agencies against the members of the Opposition appears to suggest that we have transitioned from being a democracy to an autocracy," the letter said.

### India's personal income doubled since 2014-15

NSO data good news but uneven income distribution remains challenge, say **Economic experts** PTI NEW DELHI

India's per capita income in nominal terms doubled to Rs 1,72,000 since 2014-15 when the Narendra Modi-led NDA came to power but uneven income distribution remains a challenge, say economic experts.

As per the National Statistical Office (NSO), the annual per capita (net national income) at current prices is estimated at ₹1,72,000 in 2022-23, up from ₹86,647 in 2014-15, suggesting an increase of about 99 per cent. In real terms (constant prices), the per capita income has increased by about 35 per cent from ₹72,805 in 2014-15 to ₹98,118 in 2022-

"You are looking at GDP in current prices, but if you account for inflation, the increase is much less," said noted development economist Jayati Ghosh on doubling of per capita income in nominal

She further said distribution is critical. "Most of this increase has accrued to the top 10 per cent of the population. By contrast, median wages are



falling, and possibly even lower in real terms," said the former JNU Professor. Echoing the sentiments, Nagesh Kumar, Director, Institute for Studies in Industrial Development (ISID). said per capita incomes have increased in real terms and they do reflect rising prosperity.

"However, the point to be noted is that per capita income is an average income of Indians. The averages mask the rising inequalities. Rising concentration of incomes at the high end means incomes of those at the lower rung of the income ladder may not be changing much," he said.

As per the NSO data, the per capita income dipped during the Covid period, both in real and nominal terms. However, it has picked up in 2021-22 and 2022-23. Former director of premier economic research institute NIPFP Pinaki Chakraborty said as per the World Development Indicator data base, average growth of India's per-capita income in real term for the period from 2014 to 2019 was 5.6 per cent per

### Anti-India posters in Geneva: In first, Navy to hold India summons Swiss envoy

Taking exception to "malicious anti-India" posters displayed in front of the United Nations (UN) building in Geneva recently, New Delhi on Sunday summoned the Swiss Ambassador here to lodge a strong protest.

The Swiss Ambassador Ralf Heckner conveyed to the Ministry of External Affairs (MEA) that he would convey India's concerns to Berne with all the seriousness it deserves.

Most of the posters, according to a video widely shared on social media, feature slogans opposing the alleged oppression of minorities and women in India.

"The Secretary (West), MEA, today called in the Swiss Ambassador and raised the issue of unfounded and malicious anti-India posters in front of the UN building in Geneva," said a source.

The envoy said the posters in Geneva are part of the space provided to all, but in no way



endorse the claims, nor reflect the position of the Swiss Government

The posters appeared in a square in front of the UN office in Geneva soon after the start of the latest session of the UN Human Rights Council (UNHRC).

One of the posters, as depicted in the widely shared video, states, "Women in India are treated as slaves"

Another claims child marriages are a "serious violation of child rights in India", and yet another states, "Indian Christians facing State-sponsored terrorism"

Most of the posters feature slogans in English and French. A tent put up nearby had more posters, including two that said, "India no to terror attacks on minorities" and "India stop

burning churches". A few more posters were focused on Dalits and one stated, "Indian Dalits children of a lesser god".

Similar posters have been put up in the past during sessions of the UNHRC. It is understood that the External Affairs Ministry decided to act on Sunday after the video shared on social media got more than a million views

## Commanders' meet aboard INS Vikrant

The Navy, for the first time, will start its commanders' conference from the recentlyinducted indigenously-built aircraft carrier INS Vikrant. Defence Minister Rajnath Singh will address the inaugural session of the meet onboard the carrier on Monday off the coast of Goa.

The aircraft carrier was commissioned into the Navy by Prime Minister Narendra Modi in September last year. India now has two aircraft carriers, including INS Vikrant and Russian-built

Vikramaditya. As regards the Commanders' meet, it is held twice a year where the top echelon of the force reviews the operational readiness in the maritime domain. The situation in the strategically important Indo-Pacific and the Indian Ocean will be discussed



in detail in the backdrop of China adopting an aggressive stance there in the upcoming meet. Giving details of the fiveday conclave beginning Monday, Navy officials said here on Sunday the conference serves as a platform for Naval Commanders to discuss important security issues at the military-strategic level as well as interact with senior Government functionaries through an institutionalised forum. The novelty of this year's conference lies in the fact that the first phase of the Commanders' Conference is being held at sea, and for the first-time, onboard India's first indigenous aircraft carrier, INS Details on P4

## Drunk passenger wets himself, co-flyer suffers

#### **American Airlines** bars student from flying with it

In yet another incident of pee-Ling during a flight, a passenger was taken into custody on Sunday for allegedly urinating on a fellow passenger on a New York-New Delhi American Airlines flight in a "drunken" state. The Directorate General of Civil Aviation (DGCA) has also sought a detailed report from American Airlines, while the accused passenger has been barred by the airline from flying in future.

This is the third such incident in the last few months where a flyer relieved himself on a fellow passenger in an ine-briated state. The incident allegedly took place on flight number AA292, which took off from New York at 9.16 PM on Friday and landed after 14



hours and 26 minutes of flying at the Indira Gandhi International Airport (IGIA) at 10.12 PM on Saturday. The accused, identified as Arya Vohra, 21, who was travelling in flight AA292 from New York to Delhi is a student at a US University.

He urinated on a US citizen on March 4 while he was drunk. The student perhaps involuntarily urinated while he was asleep due to the effect of alcohol. The leak somehow fell on a fellow passenger. According to Civil Aviation Rules, if a passenger is found guilty of unruly behaviour,

besides action under criminal law, he will be banned from flying for a particular time period, depending on the level of the offence.

Sources said the airline has submitted a report about the incident to the DGCA. The airline seems to have handled the situation professionally and taken all appropriate action. DCP (IGI) Devesh Kumar Mahla said a complaint of peeing on co-passenger has been received from American Airlines against one person, who is a resident of Defence Colony in Delhi.

## Sania bids teary adieu to tennis

#### Ace sportswoman ends her career at place where it began

With "happy tears", Indian tennis leg-end Sania Mirza on Sunday ended her path-breaking journey as a player at the place where it all began. By playing in exhibition matches featuring Rohan Bopanna, Yuvraj Singh and her 'best friend' Bethanie Mettek Sands, Sania finally said goodbye to her illustrious career at the Lal Bahadur Tennis Stadium, the venue where she signalled her arrival on the big stage with a historic WTA singles title triumph nearly two decades ago.

The exhibition games were watched by eminent personalities, including Union Law Minister Kiren Rijiju and former India cricket team captain Mohammed Azharuddin. Having arrived at the venue

in a swanky red car, the 36-year-old Sania was greeted by cheering fans that also included prominent personalities. ## **Nagaland heading** for Opp-less Govt

Despite having one of the highest number of political parties, new Nagaland Government is heading towards an opposition-less Government with almost all parties extending unconditional support to NDPP-BJP alliance which won the elctions held last month.

In the State Assembly elections, for which results were declared on March 2, the prepoll alliance partners – NDPP-BJP won 25 and 12 seats respectively, totaling 37 in the 60-member House.

Other political parties, including NCP have won 7 seats, NPP - 5, LJP (Ram Vilas), Naga People's Front (NPF) & RPI (Athawale) – 2

Independents – 4. This is the first time that Nagaland is witnessing the victory of so many political parties in the State Assembly elections. LJP(RV) and RPI (Athawale) are newbies in the State politics.

While the NDPP-BJP is yet to stake a claim for Government formation, they have received unconditional support from other political parties to continue their second innings. LJP (Ram Vilas), RPI (Athawale), JD(U) have already submitted letters of support to the alliance partners, sources

NCP, which is the third single largest party, submitted a letter extending 'unconditional' support on Saturday to the Neiphiu Rio-led NDPP, newly

Mhonbemo Humtsoe told PTI on Sunday. Similarly, NPF general secretary Achumbemo Kikon, who is also one of the newly elected MLA, said that though a final decision has not been taken, the party, which has two members, is "likely to extend support to the Government"

With all political parties supporting winning NDPP-BJP alliance, Nagaland will have another all-party Government. In the past, in 2015 and 2021 opposition-less Governments were formed during ongoing term of a Government, but this would be first ever Assembly which is set to be an opposition-less one even before House has been Syndicate of illegal timber sale busted in U'khand

Using digital tracking and electronic surveillance, Uttarakhand tax authorities have busted a group of traders who would float fake firms to give a legal cover to their illegal trade of timber and its products and evade GST worth crores of rupees, officials said on Sunday.

The Uttarakhand GST

department launched an expansive search and seizure operation — named 'Operation D Day-Rising Woods' -- to unearth the racket in Jaspur area of Udham Singh Nagar district, they said.

Udham Singh Nagar is considered one of the biggest timber markets and timber and its products are supplied across the country from here. The investigators suspect the involvement of people from other states such as Uttar Pradesh, Haryana, Delhi, Bihar and Rajasthan. The operation involved 27 teams with more than 300 tax

cial technology experts and they raided 27 commercial establishments and residences of transporters, advocates and chartered accountants.

The investigators, who have been tracking these illegal networks for the past nine months, found multiple firms in the name of a single person with the sole purpose of defrauding the tax authorities.

They believe the accused had worked out a plan to cheat the GST regime, since its implementation in 2017, by providing legal cover to the fake companies to show procurement of raw materials from the black market. The investigators suspect the involvement of bank officials in helping them with opening accounts without a

proper KYC process. The network involved 25 to 30 key people working in collusion with each other, officials said. Speaking to PTI, Ranveer Singh, a joint commissioner of the Special Investigation

operandi was first to float fake firms which worked on paper only. Companies dealing in timber were sourcing raw materials from the grey market and using these fake firms as their genuine suppliers by getting purchase orders and bills from them. They paid input tax credits to these fake firms which caused a huge loss to the government."

"During the initial investigation, it was found that a syndicate was involved in creating fake firms by misusing the documents of others and allegedly causing huge loss of revenue," Singh said.

He added that the nexus was involved in passing on fake input tax credits by generating fake invoices without the actual supply of goods to Bijnor, Rampur, Moradabad, Saharanpur of Uttar Pradesh and Yamunanagar in Haryana. Prima facie, the turnover is estimated to be over Rs 100 crore

# CBI torturing Ashram flyover extension to open today **Sisodia: AAP**

#### 'Pressuring him to sign documents with false charges'

AP national spokesperson Saurabh Bhardwaj Sunday claimed the CBI was "torturing" senior party leader Manish Sisodia and pressuring him to sign papers containing false

The federal probe agency arrested Sisodia on February 26 for allegedly not cooperating in the investigation into the Delhi excise policy case and being evasive on questions from investigators. A special CBI court on Saturday extended the custody of Sisodia till March 6.

On February 28, Sisodia resigned from the Arvind Kejriwal-led cabinet.

According to officials, the agency wants to utilise Sisodia's custody to locate the crucial missing file containing legal opinions on the expert committee recommendations on the excise policy, which remains untraceable even now.
"Manish Sisodia is being



tortured by the CBI and being pressured to sign the documents containing false charges framed against him. CBI has no evidence against Sisodia. They never mentioned any evidence is missing. They raided his residence but found nothing, Bhardwaj told reporters here on

Sisodia, who was produced before the court on Saturday on the expiry of his five-day CBI custody, claimed that he was "sitting for eight to nine hours and answering the same questions again and again" and termed it "mental harassment".

To this, the judge, who had in the last hearing directed the CBI not to use the third degree on the accused, told the probe agency not to ask the "same questions again and again". "If you have something new, ask him," the judge said.

## 'Centre should increase city's share of water'

AP's national spokesper-son Saurabh Bhardwaj, who will soon be joining the Delhi cabinet as a minister, said that the city's population has risen manifold since 1994 but its water share has remained unchanged and asked the Centre to increase it.

Bhardwaj said the priorities of the AAP government are infrastructure and providing clean water to the residents in Delhi, apart from education and health. "We are trying to beautify

stretches of Delhi with street furniture and creation of walking and sitting spaces. At 10 places, one-kilometre-long stretches have been redeveloped. Now the plan is to extend it to the rest of Delhi," he told PTI in an interview.

Bhardwaj, who is also the vice-chairman of the Delhi Jal Board, said they have promised that before the next election, Yamuna will be cleaned.

The sewage that goes into Yamuna we will trap it and through different sewage treatment plants and release clean water into the river. Human waste flows into drains from all unauthorised colonies and then from those drains, it flows into the Yamuna. It is not only against environmental norms but all the waste goes into a pious river," he said

Apart from ensuring a clean Yamuna, another issue that Delhi is grappling with is



limited sources of water.

"It is something (water share of Delhi) that was decided in 1994 and since then the population has grown. We have requested the Centre that our share of water should be in proportion to the population.

"See, it is not Delhi's pop-

ulation. Delhi is a mini-India where people from other states like Uttar Pradesh, Haryana and Bihar have settled. So we should get that share of water from India. We have been asking the Centre for it," he explained. The senior leader said

that as a minister, his priorities will be to make government departments more accountable to the people and ensure greater convenience in the public-government interface.

Bhardwaj and Atishi's names were sent by the Delhi government to LG VK Saxena for their elevation as Cabinet ministers, following the resignations of Manish Sisodia and Satyendar Jain, who were arrested in different cases of alleged corruption.

The 43-year-old reminisced about the time before he

In an advisory issued to all the 15 police districts, the special branch directed them to take the help of religious leaders and local volunteers to prevent stunt biking during the night of March 7-8.

It cited past events when young men from areas such as Jafrabad, Seelampur, Welcome, Trilokpuri, Okhla and Jamia Nagar visit India Gate, Connaught Place and other areas in New Delhi district and perform dangerous stunts on two-wheelers and even on three and four wheelers.

In 2019, during the night of Shab-e-Barat, some people had

### Bamboo crash barriers' installation planned on highways, expressways

To reduce the use of metallic, fibre, concrete etc in fencing crash barrier along the highways expressways and roads, an innovative way to use home-grown bamboo as crash barriers is being planned in large scale which will also earn carbon credits and translate into large scale employment opportunities both in rural as well as urban

With the India will become the world's first country to develop environmental friendly and pure natural crash barriers out of bamboos. The Nitin Gadkari led Road Transport and Highways Ministry has christened it a rustic lingo as 'Bahu Balli', where Bahu stands for Strength and Balli is Bamboo pole. The word has been picked similar to the word south India blockbuster Bahubali.

A prototype, bamboo crash barrier has been installed within a radius of 200 meters on the Vani-Warora highway in Nagpur area of Maharashtra. The 200-meter-long bamboo crash barrier has been installed on a highway connecting Chandrapur and Yavatmal districts in Maharashtra.

Road Transport and Highways Minister Nitin Gadkari described it as a special achievement for the country in the direction of self-reliant India. He said that this crash barrier is the right alternative to steel and it also does not harm the environment.

Road Ministry officials said the crash barrier has been installed only after testing the strength. Its strength has been tested in government institutions like the National Automotive Test Tracks (NATRAX) at Indore. "The barrier was then subjected to a fire rating test at the Central Building Research Institute (CBRI) in Roorkee, in which it received a Class 1 rating. The Indian Road Congress also recognized this," said the offi-

Bamboo barriers are being described as a better step



towards Atmanirbhar Bharat and environmental protection. "Actually, it is a good alternative to steel barriers. While recycling value of steel or fibre crash barriers is 30-50 percent, while the recycling value of bamboo barriers is 50-70 percent," added the official.

Bamboo crash barrier has been made from the bamboo species Bambusa balcooa, which has been treated with creosote oil. It has a coating of recycled high-density polyethylene (HDPI). This is also likely to give a boost to rural industry and employment for the ever growing demand with the expansion, renovation and extensions of highways and expressways.

The Centre has been aiming to reduce carbon emissions in construction activities related to the road and highways infrastructure.

India has the 2nd longest road network in the world. Amongst the different types of roads, the National Highways extending to 1,44,634 km1 till date. Construction and maintenance of roads is known to be a source of CO2, which is over and above the CO2 emitted from fuel operated vehicles on roads.

"The new and improved state of the art NH replacing congested and often circuitous routes, however, can help avoid CO2 emissions by reducing fuel combustion in vehicles plying on them as well the constructions activ-

ities," explained the official.

# **Workers' safety: Bihar team satisfied with TN Govt**

"We are faced with a new challenge where the drugs and weapons are smuggled from Pakistan together. While the weapons are delivered to the terrorists, the major part of the drug proceeds are returned to handlers (across the border) and the rest shared by the peddlers. "The proceeds (from the drugs trade) are being utilised to keep terrorism alive (in Jammu and Kashmir)," the police chief told reporters here on the sidelines of the Jammu Marathon.

The 'Run for Fun' Jammu Marathon was organised by the police here as part of its civic action programme and drew hundreds of participants from all walks of life at Gulshan

Responding to a question on the seizure of seven kilogramme of heroin, over Rs 2.30 crore in cash and some arms and ammunition from the home of a notorious drug peddler in Mandi sector on March 3, Singh said a dozen major peddling rackets had been busted in the recent past.

"The probes unearthed interstate connections of drug



trafficking, especially connected to Punjab, and raids were conducted. We are also roping in the Narcotics Control Bureau and, like in the past, investigated various cases

"In this (Poonch) case, the entire module involved in the drug trafficking will be unveiled and stern action taken against those found involved," This was the second time

Niaka is the last village on the Indian side in Tarkundi sector of Manjakote tehsil and was witness of intense shelling before February 2021. Two women of the village died when a mortar shell from Pakistan hit their houses in the village in 2017.

## Adenovirus alarm: 94 kids die in 2 months in Bengal

Bengal, including capital Kolkata, continued to be in the grip of deadly adenovirus with scores of children succumbing to the diseases almost on an hourly basis, health department sources said asking the parents however to take precautionary measures instead of pressing the panic button.

Even as the adeno menace continued to spread its tentacles in newer areas at least six children succumbed to the deadly virus in a close span of seven hours at state-of-art BC Roy Hospital on Sunday morn-

The Sunday's deaths took the toll to 94 in past about two months, sources said adding these were the confirmed reports of adeno deaths and there could be many more unconfirmed adeno deaths. About 5,500 children all over the state have been infected by the virus Health department sources said adding the number could be even higher as many more children are getting cured without even visiting

the hospitals. Unlike corona which is RNA virus, Adeno is a DNA virus first isolated in the 1950s in adenoid tissue. These primary cell cultures were often noted to spontaneously degenerate over time, and aden-

The Health Department has issued advisory to the doctors to take special care of children --- especially those who are two years or younger --admitted with flu-like symptoms. Instances are also there that many children often 14-15-year-old are also getting infected and have to be hospitalized and put under life sup-

port system. The common symptoms of adenovirus are flu-like including cold, fever, breathing problems, sore throat, pneumonia, and acute bronchitis

So far, there are no approved medicines or any specific treatment-line to treat the virus, doctors said adding standard symptomatic treatment using paracetamol is advised. Antibiotics may be given

### Path to progress

PM Modi's continued emphasis on infrastructure development will boost growth and prosperity

rime Minister Narendra Modi rightly said on Saturday, "Infrastructure development is the driving force of the country's economy." He was addressing a post-Budget webinar. He is relentless in his focus on infrastructure development. This fact can be better comprehended if we look at the big picture of infrastructure—in a historical perspective. A close look will show that the conspicuous feature of prime ministers belonging to the Bharatiya Janata Party is their emphasis on infrastructure development. In 2001, Atal Bihari Vajpayee launched the Golden Quadrilateral Highway Project. Many experts and ahis detractors ridiculed him for his bold initiative. The biggest point of crit-



icism was: where is the money for this ambitious project? The criticism was not without substance, for the fiscal deficit as a proportion of gross domestic product or GDP was estimated at 5.5 per cent for 2000-01 and 5.1 per cent for 2001-02. The revenue deficit, which reflects the excess of current expenditure over the current receipts, was 3.2 per cent of GDP in 2001-02. Despite the criticism and the derision the idea of Golden Quadrilateral was treated with, it proved to be successful. It was carried forward by the Congressled UPA, though sluggishly. Which was not surprising given the UPA's Left-leaning policies. The UPA regime was excessively focused on entitlement-oriented, revenue-guzzling programmes.

It is not that the Modi Govt has disbanded the welfare state; quite the contrary, it has made welfare measures extremely efficacious by streamlining the delivery mechanisms. Technology has been deployed for this purpose. In fact, the efficiency of propoor measures has improved to such an extent that political analysts had to coin a new term for the beneficiaries—labharthies. This has also helped the BJP in various elections. At the same time, the Govt has persisted with its emphasis on infrastructure. So, in her Budget 2023-24, Nirmala Sitharaman hugely increased, third time in a row, capital investment outlays. For the next fiscal, capital expenditure has been pegged at Rs 10 lakh crore, which would be 33 per cent more than the one in 2022-23. This is a big sum, around 3.3 per cent of the country's GDP. The 'effective capital expenditure' would be to the tune of Rs 13.7 lakh crore if the provision for the creation of capital assets through grants-in-aid to states is also taken into account. Under Modi, infrastructure development has already made considerable progress, but he is impatient: "Now we have to improve our speed and move in top gear." The PM Gati Shakti Master Plan is a critical tool which will "change the face of India's infrastructure and its multimodal logistics." Commenting on the prevailing mentality that poverty is a virtue, PM Modi claimed that his present government has not only been successful in eliminating this mentality but also in making record investments in modern infrastructure. The good work should continue.

eb3 products and services are capable of providing digital solutions to real-world problems across multiple sectors - be it healthcare, public administration, law and order, entertainment, education... the list is endless. Web3 refers to a group of technologies including blockchain, virtual digital assets including NFTs, DeFi etc. It enables decentralisation and increases transparency, allowing users of the internet to retain ownership over their

The applications of this transformative technology are growing in popularity in India. According to a report on Web3 by KMPG, India ranks fifth worldwide in terms of consumer interest in blockchainbased products and services, after the United States, Indonesia, Japan and the Philippines. Over 5 lakh Indians (as of November 2021), many from the 'Gen Z' age group, have indicated an interest in non-fungible tokens (NFTs). More than half of consumers surveyed said that they are interested in both physical and virtual goods, and about 46% said that they would be willing to shop on the Metaverse.

**HEALTHCARE** 

The highly sensitive and personal nature of medical records demands a drastic change in the way the healthcare industry operates. Modern healthcare facilities operating under Web 2.0 have become data centres that control and monetise patient information a prospect that gives rise to serious ethical concerns. A decentralised patient information system under Web3 redirects the focus towards patients as central to the healthcare system and not merely a source of revenue. A Web3 healthcare metaverse, for instance, could allow patients to interact with doctors without relinquishing control over their personal information. This is a prime example of how distributed ledger technology (DLT) can be used to create a digital infrastructure where citizens' digital personal data and digital identity can be recorded on the blockchain in a democratic manner, with individuals in the driving seat vis-à-vis their own personal data.

sector is also making inroads into the metaverse, with companies like Tech Mahindra throwing their hat into the ring. Tech Mahindra is exploring use cases such as car dealerships, gaming centres, NFT marketplaces, and virtual banks and intends to provide an immersive metaverse experience for its customers. Hyperlink Infosystem - another multinational corporation headquartered in India – is looking to leverage its expertise in developing olications using blockchain, AI, metaverse, IoT and so on. LAW ENFORCEMENT

A most interesting new use case that has emerged recently is the use of DLT by crime investigation units in New Delhi. Officials are adopting blockchain in Delhi's Forensic Science Laboratory (FSL) for failsafe recording and storage of evidence obtained from crime scenes. This is part of a larger ongoing exercise by the Delhi Police to foster greater public trust in the criminal investigation

#### system. **EDUCATION**

Web3 and the metaverse are expected to impact the world of education and learning in a big way, through virtual campuses and 'gamified' learning experiences where students can unlock new chapters and earn points. ### **FIVE-DAY WEEK: BETTER LATE THAN NEVER**

Many countries have introduced shorter work weeks which are productive and cost effective



ank employees are finally getting their long pending demand of a five-day work week with the Indian Banks Association (Indian Banks Association (Ind sidering giving them fixed two days off every week. At present banks are closed on all Sundays and the second and fourth Saturdays in a month. According to media reports, the IBA and the United Forum of Bank Unions have tentatively agreed to implement a five-day workweek. This needs final approval by the Government. Currently, bank employees work on alternate Saturdays. However, with the new proposal in place, banks may remain closed on all Saturdays, leading to an increase in bank holidays. This move, if approved, will provide much-needed relief to bank employees who have been demanding a five-day workweek for a long time. According to reports, as per the new proposal in a five-day work week, the working hours will be increased for the bankers. This means that employees will need to work 40 minutes more every day from 9.45 am to 5.30 pm.

For the past many years, bank employees have been demanding a five day work week, as it is prevalent all over the world and also as it is prevailing in other segments in India. It is unexplainable why the bank management (read it as government) has taken so many years to concede the same, while the government itself has adopted a five day week.

Only the Banking department of the Reserve Bank of India works on the first and third Saturdays of the month and even here cash counters are not open to the public. This is kept so as in alignment with the commercial banks. Otherwise, in a way, RBI is also following five days a week for many of its functions. National Bank for Agriculture and Rural Development (NABARD), which has taken over the Agricultural credit functions of RBI, is also working five days a week. The Supreme Court of India has 193 working days a year for its judicial functioning, while the various High Courts function for approximately 210 days, and trial courts for 245 days. When the bank employees were struggling to convince the gov-



ernment to have a 5-day week, other developed countries are trying to experiment with a 4-day week. When a five-day week is adopted, various benefits accrue to the banks and the following are considered significant: Enhanced efficiency, Reduced absence rate, Enhanced enterprise competition, Retention of talents and Promotion of corporate image. Complete shutting of offices will also result in considerable savings on the cost of electricity etc. The following benefits may accrue to the employees also: Rest and recuperation leading to greater devotion, Enhance time with family, lesser travel to the office, the scope for further studies and improvement of knowledge. With increased holidays, people may travel more and this will boost the economy.

Indian banks have adopted core banking solutions long back. Most of the transactions can be done online without visiting the bank branch. Practically there is no need for customers to visit a bank branch nowadays. The International Monetary Fund has reported the achievement of India on the following lines (in Sep 2022) "India's digital payment volume has climbed at an average annual rate of about 50 per cent over the past five years. That itself is one of the world's fastest growth rates, but its expansion has been even more rapid—about 160 per cent annually—in India's unique, real-time, mobile-enabled system, the Unified Payments Interface (UPI). Transactions more than doubled, to 5.86 billion, in June from a year earlier as the number of participating banks jumped 44 per cent, to 330. Values nearly doubled in the same period. In addition, the RBI in March introduced a UPI for feature phones (older devices with buttons instead of touchscreens) that can potentially connect 400 million users in distant rural areas. Some customers who could visit the bank branch on Saturdays for their loan processing may not able to do so. Then some industries have peculiar requirements like construction industries which may need huge cash on weekends for payment of wages etc. would have to shift to online payments.

# Resurrecting three farm laws

Farmers will continue to be in distress as long as they are shackled by the state APMC laws

eports of a farmer from Maharashtra's Solapur getting a measly Rs 2.49 from the sale of 512 kg onions to a trader (for Rs 1 per kg on sale executed at the Solapur market yard, total sale value comes to Rs 512; after deducting labour, weighing, transportation and other charges adding to Rs 509.5, the net realization is Rs 2.49) in the district has led to all-round consternation.

Rs 2.49 is the net revenue from the sale of the crop; it isn't a profit. To arrive at it, we need to deduct from this the cost of producing 512 kg onions which includes the expenses on seeds, fertilizers, pesticides, irrigation, labour, cost of credit and so on. All of this amount (minus Rs 2.49) is the loss incurred by this farmer. It means an increase in debt and attendant disastrous consequences.

The condition of the majority of other farmers is no less precarious as their realization from sales at depressed prices is far from adequate to fully cover the cost. Juxtapose this with the retail price of an onion being as high as Rs 40 per kg in some markets (albeit domestic) and the current global scenario wherein there is an acute shortage in many countries, so much so, the authorities are forced to take recourse to the ration of its supply in supermarkets. The state of affairs is highly inequitable, unjust and unconscionable.

Who is responsible for this?

The small and marginal farmers (those with land holdings less than 2 hectares) who constitute about 86 per cent of the total number of land-owning farmers sell their crop produce on two outlets viz. Agricultural Produce Market Committee or APMC mandi (marketplace notified under the state APMC Act); (ii) 'private local market'.

The "Situation Assessment of Agricultural Households and Land and Livestock Holdings of Households in Rural India", SAS in short, released by the National Statistical Office (NSO), covering the period July 2018 to June 2019, reveals widespread dissatisfaction among farmers with the price realized from the sale of their produce. Their highest dissatisfaction is with sales in the APMC mandi followed by sales in the private local

The low price from sale in APMC mandi has to do with state laws undei which farmers can sell their produce only in 'designated' mandis. In the mandi, arthritis - the local term for commission agents (they arrange for auction and delivery of the produce) - and the licensed trader/buyer rule the roost. The duo ensures that the farmer gets a low price besides facing other adversities viz. rejections, weighing less, delayed payment, etc. Levies such as market fees, anthias commission, rural development cess (RDC) etc further add to their woes.

The capacity of APMC mandis is extremely limited; the majority of small and marginal farmers are forced to come to private local markets, where sales are legally barred. At these markets, they end up selling their produce to the very traders who dominate the APMC mandis, at throwaway prices. The latter has the blessings of corrupt bureaucrats and politicians (in many cases, they or their kin also masquerade as traders) and hence, won't face any action for violating

where FCI and other state agencies buy only 30 per cent of farmers' produce, for all other crops their purchase is minuscule. In the case of paddy and wheat, the percentage share is high essentially because these purchases are meant for feeding the beneficiaries/poor under the National Food Security Act (NFSA). Even so only 6 per cent of farmers – mostly rich with larger land holdings - get the benefit of government procurement.

There has been increasing clamour for the government to substantially hike purchases by its agencies (albeit at MSP), increasing coverage of crops under their procurement plans, legal guarantee for the purchase of all farmers' produce at MSP even by private trade and so on. All of this sounds like building castles in the air.

The government neither has the infrastructure – physical and administrative – nor the financial muscle to purchase, store and handle the mountain of crop produce all farmers offer for sale. Even if, it had, a fundamental question remains whether the State should

be involved in such activity. As for legal backing to MSP, the government can't force a private person to pay a certain price to the farmer. It won't pass judicial scruti-

The extant arrangements are far from addressing the concerns of the farmers. What then is the

#### They need to be liberated from the clutches of the state APMC.

The agri markets should be opened up and farmers allowed to sell their produce in other outlets as well. Towards this end, in 2017, Modi Government passed a Model Agricultural Produce and Livestock (Promotion and Marketing Facilitation) Law. Besides giving more options to farmers for selling, it provided greater flexibility to traders such as a 'single pan-State licence' for buying from anywhere in the State. But, the majority of the states showed no interest.

In September 2020, the Union government enacted three central farm laws. For this purpose, it invoked entry 33 of the Concurrent List in the Constitution - inserted vide an amendment in 1954 - which allows it to regulate inter-State trade and intra-State trade and enable the purchase of specified farm commodities directly from farmers anywhere in the country, even outside designated APMCs.

The laws fill the existing void by legitimising sales on all non-APMC platforms such as private traders, processors, aggregators, exporters and so on without dis-

turbing APMC mandis. These opened up unlimited opportuni-ties for farmers to sell their produce, thereby helping them get higher prices, which could even exceed MSP depending on the demand-supply scenario. They don't have to pay any levies for selling at non-APMC platforms and can save on transport costs in case the buyer picks up from their doorsteps.

The farmers could also enter into contractual arrangements with enterprises (private companies, cooperatives etc) that would not only give them an assured market at pre-set good prices but also the timely supply of quality agricultural inputs viz. Iertilizers, seed, pesticides etc and a package of good agronomic practices for securing higher yield and quality foodstuff.

Despite manifold gains including higher crop yield and remunerative prices and the laws holding a promise of doubling farm income (or even more), these triggered prolonged protests and demonstrations - mostly confined to Punjab, Haryana and Delhi. The intervention of the Supreme Court by staying their implementation in January 2021 and no decision despite having got a recommendation from a committee (set up by none other than itself) favouring these laws emboldened the protestors to continue with their stir. As a result, Prime Minister Narendra Modi was forced to announce the repeal of the laws on November

Hinduism. They are not religions in the strict sense of the word, but are, in fact, different and distinct social orders. Due to the fundamentals described above most by Jinnah's words — such a remerger is not desirable. We in India remember the year 1991, when Prime Minister Chandra Shekhar, assisted by the then finance minister Yashwant Sinha, was dispatching gold to London every day, as a pawn against an IMF loan. It was only when P.V. Narasimha Rao became prime minister and New Delhi was able to retry the situation, including getting India's gold back.

We also remember how, some 25 years ago, the Pakistani per capita GDP had overtaken its Indian counter-

part. Such ups and downs are the features of the history of many countries. No country merges with another at the advent of a doubt. In the case of Pakistan, such emotions may be understandable because it has undergone a demerger twice; once in 1947, from India and again in 1971, out of East Pakistan, which subsequently became Bangladesh. New Delhi should, therefore, not take the current emotional outbursts emerging from Pakistan seriously and should turn a deaf ear to such fleeting emotions.

The perennial problem of India is not the issue of the two religions Hinduism and Islam. The inescapable syndrome is the contrasting systems of logic, upon which the two faiths are based. Islam, as well

were founded and followed based on a system reminiscent of deductive logic. This branch of logic begins with an assumed premise. In religion, this premise is the assertion that there is only one good and then the logic follows flawlessly. In sharp contrast, the spine of Hinduism is inductive logic, which begins with facts on the ground and moves upwards to a conclusion. This may not be a singular postulate, but merey an agreement to disagree. In light of the difficulties, it would be useful to recount Dr B.R. Ambedkar who had written that from 1920 onwards, India suffered a continual civil war (and in fact, continues to do so). Surely, India should not risk a repeat of that misfortune all over again.

# China sets GDP target to 5% for '23

hina on Sunday set a five oper cent growth target for 2023 as the country's rubberstamp Parliament commenced its annual session which also heralded a new era for Xi Jinping's presidency as he began an unprecedented third fiveyear term.

Premier Li Keqiang, 67, the No. 2 ranked leader after Xi and is widely regarded as far less powerful than his predecessors, signed off his 10-year stint by presenting his last work report to the National People's Congress (NPC) in which China, the world's secondlargest economy, set a five per cent growth target for 2023, lowest in decades.

He also firmly warned of "escalating" external attempts to "suppress, and contain" China. "The term of this government is about to come to a close," said Li, as he began his 39-page address to NPC, the national legislature, outlining the decade-old achievement of his administration which included seismic changes in China and its relations with the

The NPC during the session will herald new official appointments at the top expected to be packed with Xi's loyalists many of whom were elected along with him at the last October's once-in-a-fiveyear Congress of the ruling Communist Party of China (CPC). The session formally heralded the beginning of the 'unprecedented' third five-year term for Xi.

The Congress, besides electing Xi, 69, for an unprecedented third term also chose most of his loyalists for key bodies consolidating his power at all levels.

Li, an economist and a contender for the post of General Secretary of the CPC in 2012 along with Xi, settled for a number two position

hina on Sunday hiked its defence budget by 7.2 per cent, marginally higher than last year, to 1.55 trillion yuan (about USD 225 billion), marking the eighth consecutive year of increase in its military spending.

"At home, the foundation for stable growth needs to be consolidated, insufficient demand remains a pronounced problem, and the expectations of private investors and businesses are unstable", he said.

"Corruption remains a common problem in some fields, sectors, and localities," he said, adding that "we must face these problems and challenges squarely, make every effort to make improvements, and do all we can to live up to the people's trust."

### CPN objects to SC order against PM Prachanda

Nepal's ruling CPN (Maoist Center) on Sunday objected to the Supreme Court's order to its administration to register writ petitions against Prime Minister Pushpa Kamal Dahal "Prachanda" for claiming responsibility for 5,000 deaths during the decade-long insurgency in the country.

In a press statement, party's General Secretary Dev Gurung said that the order passed by the joint bench of justices Ishwor Prasad Khatiwada and Hari Prasad Phuyal on Friday has drawn serious attention of the CPN (Maoist Center).

"We deplore such activities that are directed against the achievements of secularism, inclusiveness and democratic republic system, guaranteed by the Constitution of Nepal," the statement said.

"At a time when the Truth Reconciliation Commission and Commission for Disappearance are doing its work under transitional justice, such activities will pose a serious threat to the peace process," it added.

On January 15, 2020, CPN (Maoist Center) Chairman Prachanda had said that as the leader of the Maoist party that led the decade-long insurgency, he would take the responsibility for the deaths of 5,000 people and that the state should take responsibility for the remaining deaths.

"I am accused of killing 17,000 people, which is not true. However, I am ready to take the responsibility of killing 5,000 people during the conflict," Prachanda said while addressing a Maghi festival celebration event Kathmandu. He added that the rest of the 12,000 were killed by the feudal regime.



Advocates Gyanendra Aaran and Kalyan Budhathoki, who are also conflict victims, filed separate writ petitions at the Supreme Court demanding that Prachanda be investigated and prosecuted for his state-

The administration, however, in November last year refused to register them, claiming that the issue was related to transitional justice and the Truth and Reconciliation Commission was dealing with the cases.

On Friday, the Supreme Court ordered its administration to register writ petitions against 'Prachanda' for claiming responsibility for 5,000 deaths during the insurgency. Due to busy schedules and

#### **Ukraine ally Kallas fights** for re-election in Estonia

Tallinn: Polling stations have opened in Estonia for a general election that the center-right Reform Party of Prime Minister Kaja Kallas, one of Europe's most outspoken supporters of Ukraine, is a favourite to win.

She faces a challenge from the populist opposition EKRE party that is seeking to limit the Baltic nation's exposure to the Ukraine crisis and is blaming the government for citizens' economic misery.

Over 900,000 people are éligible to cast ballots Sunday to pick representatives to Estonia's 101-seat Parliament, or Riigikogu, from a range of nine political parties. National security in the wake of neighboring Russia's assault of Ukraine and social-economic issues, particularly the rising cost of living, have been the main themes of the election. Kallas, 45, has emerged in the past year of war as one of Europe's most outspoken supporters of Ukraine. a second term, with her standing enhanced by her international appeals to impose sanctions on Moscow. A Baltic nation of 1.3 million people that borders Russia to the east, Estonia broke away from the Soviet Union in 1991 and has taken a clear Western course, joining NATO and the European Union. ### Sunak clampdown on illegal migration

 $B_{\text{Sunak}}^{\text{ritish Prime Minister Rishi}} \\ \text{on Sunday}$ announced a clampdown on illegal migration with a new proposed law to tackle the issue of migrants crossing over into the UK illegally and dangerously in small boats from across the English Channel.

The British Indian leader had made cracking down on UK's sea border with neighbouring France among his top priorities for the year.

Along with his Indian-origin Home Secretary Suella Braverman, the Sunak-led government is now planning to table the legislation in Parliament next week to address the issue.

"Make no mistake, if you come here illegally, you will not be able to stay," Sunak told the 'Sunday Express' newspaper.

"I have made the issue of illegal migration one of my top five priorities – pledging to stop the boats once and for all. Illegal migration is not fair on British taxpayers, it is not fair on those who come here legally and it is not right that criminal gangs should be allowed to continue their immoral trade. I'm determined to deliver on my promise to stop the boats,"

According to the newspa-per, Sunak believes he has found the answer to a problem which has dogged the government for the past four years after weeks of work carried out in relative secrecy by senior aides in the UK Home Office and at No. 10 Downing Street.

The group has now drawn



up new laws to slam a "brake" on any abuse of human rights laws that allows illegal migrants to escape deportation from the UK.

It is hoped the new law will stop activist lawyers using the right to family life and legislation created to combat modern slavery to stop their clients being deported.

Braverman wrote in the 'Sun on Sunday' to say "enough is enough" and that the British people want the issue solved.

They're sick of tough talk and inadequate action. We must stop the boats. That's why myself and the Prime Minister have been working flat out to bring forward necessary and effective laws which will tackle this problem, once and for all," she writes.

She adds: "It has to be that if you come here illegally you will be detained and swiftly removed. Our laws will be simple in their intention and practice – the only route to the UK will be a safe and legal route

"So far, [Opposition] Labour has opposed every effort to bring a stop to illegal migration. They are not serious about tackling the issue that is only becoming ever more serious and allows criminal gangs to exploit vulnerable people. The Prime Minister and I will do whatever it takes. You can

judge us by our actions."

The law is expected to give powers to the Home Secretary to remove anyone who arrives on a small boat "as soon as reasonably practicable" to Rwanda, with which the UK clinched a bilateral agreement, or a "safe third country".

Sunak and Braverman are also expected to travel to Paris towards the end of next week for talks with French President Emmanuel Macron to explore an enhanced agreement over the issue of small boats crossing over from Calais in France

to Dover in England.

### Comments to erase village 'inappropriate': Netanyahu

Israeli Prime Minister Benjamin Netanyahu said the remarks by a key Cabinet ally calling for a Palestinian village to be erased were inappropriate in a Twitter thread on Sunday, after the US demanded that he reject the statement.

In the thread, posted in English

shortly after midnight, Netanyahu did not appear to condemn the remarks outright and implied that the ally, Finance Minister Bezalel Smotrich, Netanyahu thanked Smotrich for

later walking the comments back and "making clear that his choice of words" was "inappropriate." The bulk of the thread urged the international community to seek con-

demnations from the Palestinians over



attacks against Israelis. It appeared to be his first public

response to Smotrich's remarks since they were made on Wednesdav.

Netanyahu's Twitter thread underlines how the Israeli leader has had to balance the ideologies of the far-right members of his government with the expectations of Israel's chief ally, the United States.

Smotrich is the head of one of several ultranationalist parties that help make up Netanyahu's government, its most right-wing ever.

For the first time, United Nations members have agreed on a unified treaty to protect biodiversity in the high seas - nearly half the planet's surface - concluding two weeks of talks in New York.

The UN Convention on the Law of the Sea came into force in 1994, before marine

biodiversity was a well-established concept. An updated framework to protect marine life in the regions outside national boundary waters, known as the

but previous efforts to reach an agreement had repeatedly stalled. The unified agreement treaty was reached late Saturday.
"We only really have two

major global commons - the atmosphere and the oceans," said Georgetown marine biologist Rebecca Helm. While the oceans may draw less attention, "protecting this half of earth's surface is absolutely critical to the health of our

Trusts who observed the talks in New York, said, "This is a once in a generation opportunity to protect the oceans - a major win for biodiversity." The treaty will create a new

body to manage conservation of ocean life and establish marine protected areas in the high seas. And Clark said that's critical to achieve the UN Biodiversity Conference's recent pledge to protect 30% of the planet's waters, as well as its land, for conservation.

The treaty also establishes ground rules for conducting environmental impact assess-



ments for commercial activities in the oceans.

"It means all activities planned for the high seas need to be looked at, though not all will go through a full assess-ment," said Jessica Battle, an oceans governance expert at the Worldwide Fund for Nature. Many marine species including dolphins, whales, sea turtles and many fish - make long annual migrations, crossing national borders and the high seas. Efforts to protect them - and human communities that rely on fishing or tourism related to marine life have previously been hampered by a confusing patchwork of laws. "This treaty will help to knit together the different regional treaties to be able to address threats and concerns across species' ranges," said

That protection also helps coastal biodiversity and economies, said Gladys Martínez de Lemos, executive director of the nonprofit Interamerican Association for Environmental Defense focusing on environmental issues across Latin America.

# Will ban US companies from trading with China: Vivek

announced his decision to enter the 2024 race to the White House last week, noted that he was inspired by former president Donald Trump, 76, and his "America first" vision.

It is time to identify the issues and work aggressively towards them, Ramaswamy said during his address to the Conservative Political Action Conference (CPAC) -- the top annual event of the Republican

Party and its support base -- on Saturday. It was his first major address from the national stage of the CPAC. In his 18-minute speech, Ramaswamy said "three secular religions have America in a chokehold today' The first of them is this

'woke racial religion" that says someone's identity is based on his skin colour. "That if you are black, you

are inherently disadvantaged. That if you are white, you are

it is a religion. It does not match up to reason, it matches up to religion. And then it makes the same move as the first religion," Ramaswamy said.

The third one is the climate religion in America that says that "we have to fight carbon emissions at all costs in the United States while we shift those same carbon emissions to places like China," the Indian-American entrepreneur said.

"...Even if you believe in this religion, you would have embraced nuclear energy, which is the best form of carbon-free energy production known to mankind".

"And yet these people

oppose nuclear energy. What is really going on is that the climate religion has about as much to do with the climate as the Spanish Inquisition had to do with Christ, which is to say nothing at all. It is about power, dominion, control, punishment and apologising for what we have achieved in this country and the modern West as we know it," Ramaswamy said amidst applause from the audience. ## Trump eyeing 2nd term

Former US president Donald Trump cast himself on Saturday as the only Republican candidate who can build on his White House legacy but shied away from directly critiquing his potential

directly critiquing his potential rivals, including Florida Governor Ron DeSantis.

Trump, giving the headlining address at the annual Conservative Political Action Conference, told a cheering crowd that he was engaged in his "final battle" as he tries to return to the White House.

'We are going to finish what we started," he said. "We are going to complete the mission. We are going to see this battle through to ultimate vic-

Though DeSantis, seen as Trump's biggest potential rival, is frequently a subject of namecalling and other attacks in Trump's social media posts and interviews, he was not mentioned directly in Trump's address before conservative activists, who earlier in the day

applauded when an old video clip of the Florida governor

was shown in a montage.
While CPAC was once a must-stop for candidates mulling Republican presidential runs, DeSantis and other major likely contenders skipped this year's gathering amid scandal and as the group has increasingly become aligned with Trump.

The former president's enduring popularity with this segment of voters was on display throughout the conference this week. Some attendees wore Trump-themed outfits, with "MAGA" hats and sequined jackets.

Members of his family and his presidential administration were swarmed like

celebrities in the hallways and dominated the list of speakers. The handful of other potential and declared candidates not named Trump who spoke received only tepid applause.

And the annual CPAC straw poll, an unscientific survey of attendees, found Trump the top choice to be the party's nominee, with 62 per cent support, trailed by DeSantis at 20 per cent and businessman Perry Johnson, who announced his long shot bid at the conference, with 5 per

Nearly all -- 95 per cent of the respondents -- said they approved of Trump's performance as president.

Ahead of his speech, Trump told reporters that he would continue his third presidential campaign even if indicted. He is under investigation by prosecutors probing his efforts to overturn the results of the 2020 election in Georgia and by the US Justice Department, as well as his handling of classified documents, among other issues.

A team of Islamabad police on Sunday reached Lahore residence of ousted prime minister Imran Khan to arrest him in the Toshakhana case, but returned after assurance from his legal team that he will appear before the court on

Pakistan Tehreek-e-Insaf (PTI) vice chairman and former foreign minister Shah Mahmood Qureshi said there is no mention of "arrest" in the warrants as an Islamabad sessions court has asked him to appear before it on March 7 in the Toshakhana case.

The 70-year-old cricketerturned politician, who has been recovering from a gunshot injury from an assassination attempt in Wazirabad last year, has thrice skipped indictment hearings in the case.

The Pakistan Tehreek-e-Insaf (PTI) chief has been in the crosshairs for buying gifts, including an expensive Graff wristwatch he had received as the premier at a discounted price from the state depository called Toshakhana and selling them for profit.

The court issued a nonbailable arrest warrant against Khan last week and adjourned repeated failure to appear before the court.

Meanwhile, Lahore police have closed the main road leading to the Zaman Park residence of Khan by placing containers. Riot police and water cannons are currently present near Khan's residence. His party fears that police may raid Khan's house anytime. However, it said the party workers will foil any such attempt.

Punjab Inspector General of Police Dr Usman Anwar said in a statement that Punjab police would cooperate with Islamabad police to implement the court's order regarding Khan's case. He, however, did not say that police are going to arrest Khan.

"Punjab police will help Islamabad police in implementing the court's order," he

Khan claimed "they" wanted to kill him while on the way to his court appearance. "They have made yet another plan to kill me during a court appear-

ance," he alleged.
"I will write to the chief justice of Pakistan telling him that 74 false cases have been registered against me. I have a threat to my life from those who are supposed to protect me," he said, in an indirect reference to the establishment. Take an example of crim-

inals like (Prime Minister) Shehbaz Sharif and (Interior Minister) Rana Sanaullah who were involved in killing people and an attempt on his life (in Wazirabad in November last year)," he said. Khan also named "Dirty

who is also the daughter of Khairat el-Ghoniem of the Egyptian Coordination Shater, long seen as the Brotherhood's

most powerful leader, was sentenced to 10 years on charges that also included disseminating false news on allegations of rights abuses by security forces.

lawyer and activist, was handed a fivevear sentence. The court added a five-year pro-

bation period at the end of each sentence of those convicted, which includes a travel ban and an order to regularly report to a police station. Amnesty International and other

rights group have decried the arrest of the 14 and said their trial reflected "gross violations of their right to a fair

Sunday's verdicts are not subject to appeal and only the country's president has the authority to pardon or throw out the sentences.

Rights groups have repeatedly criticised mass sentencings, common over the past years in Egypt in trials related to the Brotherhood or dissent, and called on authorities to ensure fair trials. Egypt's government has in recent vears jailed thousands, mainly Islamists, but also secular activists involved in the 2011 Arab Spring uprising that toppled the country's longtime autocratic President Hosni Mubarak.

## Iran schoolgirl poisoning crisis escalates

#### The attacks have raised fears that other girls could be poisoned for going to school

crisis over suspected poi-Asonings targeting Iranian schoolgirls escalated on Sunday as authorities acknowledged over 50 schools were struck in a wave of possible cases. The poisonings have spread further fear among parents as Tehran has faced months of unrest.

It remains unclear who or what is responsible since the alleged poisonings began in November in the Shiite holy city of Qom. Reports now suggest schools across 21 of Iran's

30 provinces have seen suspected cases, with girls' schools the site of nearly all the inci-

The attacks have raised fears that other girls could be poisoned apparently just for going to school. Education for girls has never been challenged in the over 40 years since the 1979 Islamic Revolution. Iran has been calling on the Taliban in neighbouring Afghanistan to have girls and women return to school.

Interior Minister Ahmad Vahidi on Saturday said without elaborating that investigators had recovered "suspicious samples" in the course of their investigations into the incidents, according to the staterun IRNA news agency.

He called for calm among the public, while also accusing the "enemy's media terrorism" of inciting more panic over the alleged poisonings. However, it wasn't until the poisonings

received international media attention that hard-line President Ebrahim Raisi announced an investigation into the incidents on Wednesday

Vahidi said at least 52 schools had been affected by suspected poisonings. Iranian media reports have put the number of schools at over 60. At least one boy's school reportedly has been affected. Videos of upset parents and schoolgirls in emergency rooms with IVs in their arms have flooded social media.

Making sense of the crisis remains challenging, given that nearly 100 journalists have been detained by Iran since the start of protests in September over the death of 22-year-old Mahsa Amini. She had been detained by the country's morality police and later died. The security force crackdown on those protests has seen at least 530 people killed and

19,700 others detained, according to Human Rights Activists in Iran. Attacks on women have happened in the past in Iran, most recently with a wave of acid attacks in 2014 around Isfahan, at the time believed to have been carried out by hardliners targeting women for how they dressed. Speculation in Iran's tight-

ly controlled state media has focused on the possibility of exile groups or foreign powers being behind the poisonings. That was also repeatedly

alleged during the recent protests without evidence. In recent days, Germany's

foreign minister, a White House official and others have called on Iran to do more to protect schoolgirls — a concern Iran's Foreign Ministry has dismissed as "crocodile tears." However, the US Commission on International Religious Freedom noted that Iran has "continued to tolerate attacks against women and girls for months" amid the recent

"These poisonings are occurring in an environment where Iranian officials have impunity for the harassment, assault, rape, torture and execution of women peacefully asserting their freedom of religion or belief," Sharon Kleinbaum of the commission said in a statement. Suspicion in Iran has fallen on possible hard-liners for carrying out the suspected poisonings.

Iranian journalists, including Jamileh Kadivar, a prominent former reformist lawmaker at Tehran's Ettelaat newspaper, have cited a supposed communique from a group calling itself Fidayeen Velayat that purportedly said that girls' education "is considered forbidden" and threatened to "spread the poisoning of girls throughout Iran" if girls' schools remain open.

### One killed, three arrested in Philippine Governor's killing

**D**olice have killed one suspect and arrested three others in the brazen shootings that killed a central Philippine provincial governor and eight others, including poor villagers seeking aid from the political leader, officials said Sunday.

The killing of Negros Oriental Governor Roel Degamo at his home on Saturday by at least six men armed with assault rifles and wearing military-like camouflage uniforms and bullet-resistant vests was the deadliest in a series of attacks on politicians in recent weeks in the country.

President Ferdinand Marcos Jr. condemned the killing of Degamo, who backed him in the presidential election last year, and said his "government will not rest until we have brought the perpetrators of this dastardly and heinous crime to justice."

Degamo was meeting poor villagers who were seeking medical and other help when the armed men walked calmly into his residential compound in Pamplona town and opened

They fled in three SUVs,

which were later abandoned in a nearby town and from which about 10 men were seen fleeing, according to police reports. At least 17 others, includ-

ing a doctor and two army soldiers, were wounded, police said.

Police quickly set up road checkpoints and later Saturday arrested three suspects, including two former army soldiers, and killed one in a clash as they chased the gunmen. A number of rifles and a pistol were recovered from the suspects, police said without elaborating or disclosing if they have determined a motive for the attack. Degamo, a longtime politi-

cian, initially lost the race for Negros Oriental's governorship in last year's elections but was later installed governor after filing a court petition. He said a few years ago without elaborating that he had received death threats in the province, which has a history of bloody political conflicts and communist insurgencyrelated violence. Degamo's killing under-

scores that even local politicians are not immune from high-profile gun violence that has persisted despite the government's pledge to combat it. Last month, Gov. Mamintal Alonto Adiong Jr. of

southern Lanao del Sur province was wounded and four of his bodyguards killed in an attack on their convoy.

# Health and the 'Amrit Kaal' Budget initiative

¬he Minister of Finance, Government of India, unveiled the Union Budget for April 1, 2023-March 31, 2024 on February 1, 2023. The Amrit Kaal Budget (as it is commonly known) may be the first step towards India's global agenda of Vasudeva Kutumbakam. And what better way than to start with healthcare for all through Government-run initiatives and close cooperation with

the public sector.

The National Health Mission (NHM) envisages the achievement of universal access to affordable, equitable, and quality healthcare, which is responsive to the populace's needs. To strengthen Îndia's public health system, including the various medical and nursing professionals that compose such a system, the Economic Survey for 2023-24 highlights the rising importance of public healthcare.

The Budget seeks to set up 157 nursing colleges with the already proposed medical colleges, increasing the number of medical and nursing professionals to cater to the ever-demanding nature of an efficient public health system while attempting to eliminate health setbacks such as sickle cell anemia by

The Department of Health and Family Welfare (DOHFW) will be allotted Rs 86,185 crores. However, records have registered a failure to fulfill its earlier targeted estimate of Rs 83,000 crores for the Sidharith Shankar previous Budget for the DOHFW, which resulted in a drastic reduction to a more realistic assessment of approximately Rs 76,000 crores.

The Economic Survey mentions the rise in health sub-centers, primary and communihealth centers. However, it fails to consider the

Rural Health Statistics 2021-22, which establishes that the number of nurses or medical professionals was considerably low to almost non-existent, rendering the healthcare service in rural areas negligible. If this were to continue due to a shortfall in the allocation of the estimated Budget, the proposal to establish nursing colleges would remain merely a number, requiring not only a revision in the Budget



estimate but probably also a revision in the number of nursing colleges proposed to be established.

The NHM was allocated rs 29,085 crores, which is considerably lower than the Rs 37,000 crores allocated in 2022-23, thereby raising doubts on the success of the Mission's agenda of quality healthcare for

In the pharmaceutical sector, facilities in select Indian Council of Medical Research (ICMR) Labs will be made available by public and private medical college faculty and private sector research and development (R&D) teams to encourage

pharmaceutical research and innovation will be launched through centers of excellence. The pharma industry would be encouraged to invest in R&D in specific priority areas. The Budget has allocated INR 2980 crores for this select purpose. This may further result in curtailing imports of active pharmaceutical ingredients, which remain

collaborative research and innova-

tion. A new program to promote



higher than their exports despite PLI (Production Linked Incentive) schemes for their manufacture.

Yet another important priority of every pharmaceutical set-up is a robust regulatory mechanism.

With the negative press, following incidents in The Gambia and Uzbekistan, the Government has allocated Rs 651.97 crore to strengthen the drug regulatory system, set up new testing laboratories, and upgradation of existing laboratories, amongst other positive steps to make India the

pharmacy of the world. This move is likely to improve the manufacturing and testing

processes, but it can only do so if coupled with more current legislation, considering the concepts of good manufacturing practices, stringent regulation of clinical trials, and a clear distinction between drugs, cosmetics, and medical devices (including software as a medical device).

Winston Churchill once remarked, "The discoveries of healing science must be the inheritance of all, and disease must be attacked."

Overall, while the Amrit Kaal Budget does prioritise improved health systems in its blueprint for a prosperous, just, and self-reliant India, the need of the hour is ensuring an increased number of nursing professionals, the elimination of sickle cell anaemia, as well as a public-private model towards healthcare, without compromising the Budget estimate. Else, the Amrit Kaal Budget, insofar as health care is concerned, may not prove to be Amrit!

## **Govt to check imports** of substandard goods

To come up with 58 quality control orders in next six months

PTI ■ NEW DELHI

The Government will come 1 up with as many as 58 quality control orders (QCOs) for products such as aluminium, copper items and household electrical appliances in the next six months, in a move aimed at containing import of the substandard goods and boost domestic industry, a senior government official said.

The department for promotion of industry and internal trade (DPIIT) is working hard to promote manufacturing of high quality products in the country.

"Since 1987, only 34 QCOs have been issued. But now we are coming up with 58 QCOs in the next six months. The main objective is to stop import of sub-standard goods. These mandatory norms will be for domestic and foreign players, Joint Secretary in the DPIIT



Sanjiv told PTI.

There will be 315 product standards under these orders. The items, under these orders, cannot be produced, sold/traded, imported and stocked unless they bear the BIS (Bureau of Indian Standards)

"These QCOs will be notified within a year after following due process," he added. He said that the move

would also help in providing

global markets for domestic goods. In order to facilitate smooth implementation of these orders, particularly for micro and small industries, provisions for additional time periods to get BIS licences and upgrade their testing facilities are being contemplated, he

Similarly, exemption to very micro units (investment in plant and machinery up to Rs 25 lakh) is being contemplated on a case to case basis. "With the notification of

CCOs, manufacturing, storing and sale of non-BIS certified products are prohibited as per the BIS Act 2016," the official said

The violation of the law can attract a penalty of up to two years of imprisonment or with fine of at least ₹2 lakh for the first offence which increases to ₹5 lakh minimum for the second and subsequent offences.

#### **Govt removes** import duty on whole Tur

The Government has removed the basic customs duty of 10 per cent on whole Tur or pigeon peas as part of steps to check the local prices of the lentil. In a notification dated March 3, the Central Board of Indirect Taxes and Customs (CBIC) said import duty on Tur (whole) will be 'Nil'. The reduced duty is effective from March 4. However, import of tur,

other than whole tur, continues to attract basic customs duty of 10 per cent. The exemption to whole tur import duty comes amidst lower tur production estimates in the country.

Tur production is pegged lower at 3.89 million tonnes in the 2022-23 crop year (July-June) from 4.34 million tonnes in the previous year as per the initial projection made by the agriculture ministry. Fearing shortage, likely Government in January said it has made an advance plan to import about 10 lakh tonnes higher quality of tur dal.



# Delhi Capitals thrash RCB by 60 runs

hafali Verma and Meg Lanning slammed attacking fifties, while left-arm pace bowler Tara Norris grabbed a five-wicket haul as Delhi Capitals thrashed Royal Challengers Bangalore by 60 runs in their Women's Premier League opener, here on Sunday.

Norris destroyed the RCB lineup, returning figures of 5/29 after Delhi Capitals had put up an imposing 223 for two at the Brabourne Stadium.

Chasing the mammoth 224, the Smriti Mandhana-led side were restricted to 163 for eight in 20 overs.

Earlier, thanks to opener Shafali and Australian skipper Lanning's fine knocks of 84 and 72 runs respectively, DC posted WPL's second successive 200-plus score. Mumbai Indians notched 207 for five before bowling Gujarat Giants out for 64 in the inaugural WPL fixture on Saturday.

While the young India opener played some breathtak-



her 84-run knock, which came off just 45 deliveries (10 fours, and four sixes), Australia skipper Lanning was more clinical in her shots, smashing 72 off 43 balls (14 fours) as the duo destroyed left RCB bowling in a tailspin.

Indian batting sensation ■ Shafali Verma, who returned to form with an aggressive fifty, credited her senior partner Australian skipper Meg Lanning for calming her "nerves" as Delhi Capitals secured a 60-run win over Royal Challengers Bangalore in their WPL opener here on Sunday

Delhi Capitals piled up an imposing 223 for two on a batter-friendly track with openers Shafali (84) and Lanning (72) toying the RCB attack.

"I was a bit nervous at the start. The experience of playing with Lanning was good, she's a good friend of mine and she told me to be responsible with the bat," Shafali said at the post-

match presentation ceremony. Shafali managed just 102 runs with a best of 33 not out in the recently-concluded Women's T20 World Cup where India made a semifinal

"We just wanted to play good shots and play according to our strength. You feel happy when you get to a landmark, yes, happy with the total," she said about their strategy.

Delhi Capitals skipper Lanning said she was always confident of their batting prowess and was relieved that their bowling also came off well after defending the target on a

"We were thinking about (our) bowling but we weren't too concerned about the batting," Lanning said.

### In Indore, we doubled down on what we set out to achieve, says Andrew McDonald

Australia head coach Andrew McDonald has admitted that visiting teams need to be "near perfect" to challenge India in their own backyard, something they sought in Indore by "doubling down" on what they had set out to achieve initially.

Hammered by the hosts inside three days in the first two Tests of the Border-Gavaskar trophy, Australia fought back strongly to claim the third match on an Indore pitch that offered vicious turn and variable bounce. "You have almost got to be near perfect against India in India. I think this game (Indore Test) besides that 6 for 11 was near perfect," McDonald was quoted as saying 'ESPNcricinfo'.

According to McDonald, the team's success in the Indore Test showed there is a core group of players who are learning what it takes to win in the subcontinent and can help the side taste greater success in the future."Everyone's journey starts at some point in time on the subcontinent, and I think there's a core group of players that will come back here more experienced and, in theory, better equipped for the challenges.

conditions that probably aren't relatable to any other subcontinent tour over time, so it's always a different challenge when you do arrive here.'

He said Australia lost the chance to retain the trophy due to one hour of chaos in the second Test in Delhi.

However, on a pitch rated "poor" by the ICC, the visitors rode on star off-spinner Nathan Lyon's 11-wicket match haul to humble the visitors by nine wickets and confirm their place in the World Test Championship (WTC) final.

Chasing a near-impossible 437 for victory, MP were bowled out for 198 in 58.4 overs as the match ended during the opening session of the fifth day.

With the so-called resultoriented and under-prepared pitches for the ongoing Border-Gavaskar Trophy receiving a lot of flak, the Gwalior track was a throwback to the days when there used to be help for every department of the game.

There were four tons scored in the match, 40 wickets fell and pacers and spinners had equal say during the course of the game. A case in point is the MP
