Naatu Naatu, Elephant Whisperers script Oscar history

Naatu Naatu", the irrepressible, fun number from the film "RRR", and documentary short "The Elephant Whisperers" made Oscar history for India on Monday with one Academy Award each, the two wins showcasing cinema beyond Bollywood and the growing might of the Indian non-feature segment.

This is the first time two India-made productions have bagged the cinema world's biggest prize. Dancers took over the stage at Los Angeles' Dolby Theatre, recreating the hugely popular hook steps from the four-minute Telugu track, and actor Deepika Padukone introduced the song to loud cheers

It was not just a night for India. The 95th Academy Awards will also be remembered for recognising Asian tal-ent with "Everything Everwhere All at Once" bag-

ging seven awards, including Best Film, Best Director for Daniel Scheinert and Daniel Kwan, Best Actress for Malaysia's Michelle Yeoh and Best Supporting Actor for Vietnamese American Ke Huy

"All That Breathes", Shaunak Sen's climate change documentary set in Delhi, lost out to Canada's "Navalny" on Russian dissident leader Ålexei Navalny in the Documentary Feature category.
The win for "Naatu Naatu",

"Naacho Naacho" in Hindi, composed by MM Keeravaani and penned by Chandrabose in SS Rajamouli's blockbuster film, is the fourth non-English song to win an Oscar in the category and the first song in foreign language since "Jai Ho" in 2009 to bag the prize.

"Naatu Naatu" is as much a jubilant chorus as was "Jai Ho", the foot-tapping number by AR Rahman and Gulzar from the British film "Slumdog

As news of the Oscar win came in, "Naatu Naatu" was the

"The Elephant Whisperers", by Kartiki Gonsalves and Guneet Monga, which explores the bond between humans and an abandoned elephant calf in a Tamil Nadu sanctuary, is India's first win in the Documentary Short category. "Smile Pinki" and "Period. End of Sentence", both set in India, had also won in the same category but they were foreign productions. Gonsalves dedicated her

The Supreme Court on Monday said the Ministry of Defence cannot take law in its own hands by issuing communication on payment of One Rank-One Pension (OROP) arrears to pensioners of the armed forces in four installments.

During the Monday hearing, the Attorney General submitted that the Centre has paid to some pensioners and will be paying the rest of them one installment of OROP arrears by March 31, but needed some more time for further disbursement.

the petitions seeking legal validation of same-sex marriages claiming they will cause a "complete havoc" with the del icate balance of personal laws and accepted societal values.



Winter nights' haze in Delhi in 2019 caused by biomass burning: Study "The exhaustive research

study conducted by Indian Astudy content (IIT) Delhi and Kanpur, along with researchers from Paul Scherrer Institut (PSI) Switzerland and University Helsinki, Finland, and the Central Pollution Control Board (CPCB), found that high amount of particulate pollution in Delhi during the winter nights in 2019 was caused by biomass burning.

The study, published in Nature Geoscience journal, was conducted in Delhi during the winter months of 2019



and molecular composition of ambient aerosols and gases were measured.

"Delhi often experiences

pollution also termed as haze. However the exact reasons behind their formation was hitherto unknown

unearthed the reason behind the severe haze events experienced during winters in Delhi which is one of the world's most-populated cities," said Sachchida Nand Tripathi, from IIT Kanpur who was the principal investigator in the study "The uncontrolled biomass

burning for residential heating and cooking in the Indo-Gangetic plain gives rise to ultrafine particles, affecting the health of five per cent of the world's population and impacting the regional climate," he

Govt seeks Parliament nod to spend additional ₹1.48L cr

PNS NEW DELHI

The Government on Monday sought the approval of Parliament to spend an additional Rs 1.48 lakh crore for the current financial year 2022-23 as part of the second batch of supplementary demands for grants.

Of the total, an additional fund of Rs 36,325 crore is being sought for payment towards fertiliser subsidy, said the second batch of supplementary demands for grants tabled in the Lok Sabha by Minister of State for Finance Pankaj Chaudhary.

This includes additional subsidy outgo of Rs 21,000 crore for P&K (phosphorus and potassium) and Rs 15,325.36 crore for urea.

In addition, the Government has pegged the fund requirement for additional transfers to the Universal Service Obligation Fund (USOF) at Rs 25,000 crore.

When its turn came, Padukone found herself pausing at least thrice to let the cheers subside. "Do you know 'Naatu Naatu'? Because, if not, you are about to," she said. And the dancers from different ethnicities took over, kicking their legs, tap dancing and moving in perfect sync against the backdrop of Ukraine's presidential palace where the song was shot

in the film. On stage were singers Rahul Sipligunj and Kaala Bhairava.

Once over, the audience, including the who's who of Hollywood and world cinema, gave them a standing ovation.

It took more than 100 variations and many months of rehearsals before the moves were finalised, choreographer Prem Rakshith told PTI.

This is the third major international recognition for the Telugu song after Golden Globe and Critics Choice Award wins. "RRR" (Rise Roar Revolt), a pre-independence fictional story, follows two real-life Sitarama Raju (Ram Charan) and Komaram Bheem (Jr NTR) - in the 1920s. It was released in Telugu, Tamil, Hindi and

"Naatu Naatu" celebrates the inclusive spirit of dance and bonhomie and features Charan and Jr NTR matching steps to its catchy rhythm.

The film's team described the win as a "surreal moment". "We're blessed that #RRRMovie is the first feature film to bring INDIA's first ever #Oscar in the Best Song Category with #NaatuNaatu! No words can describe this surreal moment. Dedicating this to all our amazing fans across the world. THANK YOU!! JAI HIND!" read the

Whatever wins up there, an Indian thing, is going to raise the profile of India. I love that song," Rahman told PTI ahead of Oscar 2023.

"Congratulations @mmkeeravaani garu and @boselyricist garuAs predicted and well deserved ..Jaiho to both of you and the #RRR team!! #RRRatOSCARS," he tweeted after the Oscars. He also congratulated the makers of "The Elephant

The Netflix documentary bested "Haulout", "How Do You Measure a Year?", "The Martha Mitchell Effect" and "Stranger at the Gate" to scoop the trophy.

India has never won an Oscar in the International Film category or the Best Foreign Film as it was known earlier. Bhanu Athaiya was the first Indian to win the Oscars after she was conferred the Academy Award for Best Costume Design in Richard Attenborough's "Gandhi", which bagged eight trophies in 1983.

Directing legend Satyajit Ray was conferred an honorary Oscar in 1992, just a month before his death

At the same time, it said the onus is on Pakistan to create such a conducive environment. Constitution Bench to take call on same-sex marriage

The bench, also comprising Justices PS Narasimha and JB Pardiwala, said this is a matter which is important enough to be decided by a constitution bench of five-judges.

"Having due regard to the broader context of the petitions before this court, the inter-relationship between the statutory regime and constitutional rights, we are of the considered view that it would be appropriate if the issues raised are resolved by a constitution bench of five-judges of this court...," the bench said while referring to Article 145 (3) of the Constitution, while terming it a "very seminal issue".

Won't revise power subsidy scheme but will simplify it: Atishi

Delhi Power Minister Atishi on Monday said that the Delhi Government has no plan to revise its power subsidy scheme and it will continue without any restrictions of sanctioned load to consumers.

The Minister said that the Delhi Electricity Regulatory Commission (DERC) had issued a statutory advice to the Delhi Government in 2020, asking it to consider restricting electricity subsidy to the poor and needy consumers. "The DERC withdrew the advisory on January 6 this year, saying the issue did not fall under its jurisdiction," she added.

Last week, Lieutenant-Governor (L-G) VK Saxena asked Chief Secretary Naresh Kumar to direct the Power Department to place the DERC



Ministers and take a decision within 15 days. "The Prime Minister wants to discontinue the power subsidy in Delhi and forced Delhi L-G to obstruct Kejriwal Government's power subsidy by hook or by crook. The L-G is pressurizing the Power Department to withdraw power subsidy based on flawed legal advice," said Atishi adding that the AAP Government is committed to ensure round-the-clock power

She also said the Government will "simplify" the process for consumers applying for subsidy or giving it up. Last year, Chief Minister Arvind Kejriwal declared that only those who apply for the subsidy will get it.

The consumers have to apply online as well as offline to get a 100 per cent subsidy on consumption of 200 units per month and 50 per cent subsidy (up to Rs 800) on monthly con-

Atishi alleged that the L-G's instruction hinted at "malafide intent" to create hurdles in the Kejriwal Government's work. She added that around 95 per cent domestic power consumers who earlier availed subsidy have applied for it so far. She justified the power subsidy, saying the Government's revenue has increased and its budget size has gone up from Rs 30,000 crore in 2015 to Rs 75,000 crore at present. "Also, Government decides consumption by the people and what electronic gadgets they use and puts restriction on it.

The Government has just given an opportunity to those who want to give up subsidy," she said. "In order dated 06.01.2023, DERC had recalled its micro a brice to Delki say." its prior advice to Delhi government on curtailing power subsidy to consumers having connections of fixed load above 5kW or 3kW.

After detailed examination of various legal provisions of Electricity Act 2003 and SC judgments, DERC had concluded that it has no legal basis or jurisdiction to advise the Delhi government on withdrawal of subsidy," Atishi added. With the President's nod, the salaries and allowances of Delhi MLAs and Ministers have been increased by more than 66 per cent. According to a notification from the Law Department of the Delhi government, the MLAs will now get Rs 90,000 every month, an increase from A notification to this effect

was issued by the Delhi government. The hike comes after a gap of 12 years. This comes after a proposal was sent to the president clearing the way for increased salary to the lawmakers of the city.

The Delhi Assembly, in July last year, had passed bills pertaining to the hike in pay for the MLAs claiming that they were the lowest-paid lawmakers in the country. Their monthly basic salary

has been increased from Rs 12,000 to Rs 30,000. Their constituency allowance has been raised from Rs 18,000 to Rs 25,000, while the conveyance allowance has been hiked from Rs 6,000 to Rs 10,000. The telephone allowance has been hiked from Rs 8,000 to Rs 10,000, while the



secretariat allowance has been raised from Rs 10,000 to Rs 15,000. The overall pay of the ministers, Speaker and Deputy Speaker, chief whip, and the leader of opposition has been increased from Rs 72,000 to Rs 1.70 lakh per month. Their monthly basic salary has been raised from the current Rs 20,000 to Rs 60,000.

constituency Their allowance has been raised from Rs 18,000 to Rs 30,000, sumptuary allowance from Rs 4,000 to Rs 10,000 and daily allowance of Rs 1,500 from the existing Rs 1,000.

They will also get a secretariat assistance of Rs 25,000. Besides they will also get reimbursement of annual travel with family up to Rs 1 lakh that

was earlier Rs 50,000. Rent-free furnished accommodation of Rs 20,000 per month, free use of car with driver or monthly Rs 10,000 as conveyance allowance (earlier Rs 2,000), and free medical treatment.

Dog attack: NCPCR seeks report from MCD over death of 2 siblings

The National Commission for Protection of Child Rights (NCPCR) has summoned MCD Commissioner Gyanesh Bharti and sought an action taken report from him over the death of two brothers reportedly by stray dogs in southwest Delhi's Vasant Kunj area. Two brother, aged seven and five, were mauled to death by stray dogs in a forest area in Ruchi Vihar in separate incidents over two days.

Meanwhile, a team from People for Animals (PFA), an animal welfare organisation founded by BJP MP Maneka Gandhi, conducted a spot investigation into suspected dog-attack cases at Vasant Kunj and said the incidents were "misreported" with dogs being "blamed" for the attacks "without any evidence". In a letter to to Bharti said

it considers it "appropriate to issue summons to your offices to physically appear before the commission on Friday along with action taken reports of the incident". The police have said they have written to the MCD to take appropriate measures to curb the dog menace. Ambika Shukla, a trustee at



PFA, claimed that the incidents were not "subjected to careful scrutiny". Shukla said, "In the Vasant Kunj case, most of the locals have testified that they never saw dogs harming any

What we are seeing is a few incidents from different times and places being tied together to create the impression that such instances are common or frequent when, in fact, they are rare abnormalities, which is why they are news.

She further said each incident is "different" and must be analysed in terms of its particular circumstances. "Instead, what we are seeing is hype and hysteria being whipped up to trigger reactions of hate and intolerance that help neither



humans nor animals," Shukla

According to the PFA team's findings, there is a "lack of evidence" to confirm these incidents as cases of dog attack. Even bite marks, if present, cannot be taken to be any indication of cause of death as there is an equal possibility of those being caused post death.

There has to be a clinical forensic determination for that. Without a proper police and medical enquiry, it is irresponsible for anyone to issue any statement regarding the tragic deaths of the two children," the PFA said. The organisation said its volunteers visited the area and met the family members and neighbours of the deceased children.

'Fired' hotel staffer in Goa attacks Delhi couple with swords

New Delhi: A tourist family from Delhi is said to have been attacked with swords and knives by locals in the Anjuna region of Goa. The tourists were staying at a resort called "Spazio Leisure" when they were viciously attacked by some out-

One of the family members, Jatin Sharma, posted information about the incident on his Instagram account. According to a woman in another video in the post, who was narrating the incident with the injured man by her side, said they checked into the Spazio Leisure Resort in Goa's Anjuna and had a small altercation with the staff which they reported to the manager who fired the concerned staff member. After this incident, the staff allegedly called his accomplices, who gathered outside the resort and attacked the family members with knives and swords, they said.

Meanwhile, the Goa police has arrested four people, and charged them with attempt to murder. A preliminary enquiry has also been initiated against the investigating officer after accusations from victims that

the police went soft on attackers. Goa Chief Minister Pramod Sawant condemned the incident and said "anti-social" elements were behind it. "I have directed the Police to take the harshest action against the perpetrators," he said. A 47-year-old Ashwini

Kumar Chandrani, a resident of Delhi, was assaulted by the "gang residents" of Anjuna with fist blows, kicks, belts, baseball bat, and knife at around 5 pm on March 5, causing him and family members injuries, the police said, adding that the family filed a complaint against one Roshan and other unknown persons. The main accused, Roshan, was a receptionist at the resort. According to reports, Anjuna Police said that during the course of investigation, they found that the assault was with knife and other weapons on vital parts of the body, hence section 307 of the Indian Penal Code (attempt to murder) was invoked. With help of CCTV footage, the police have identified accused in the assault and arrested Roshan, Nyron, Joseph Lobo, and Kashinath Vishvor

Minister of State for Defence Ajay Bhatt, replying to a question in Rajya Sabha last month, said the value of production undertaken by private companies and state-run defence manufacturers in 2021-22 was Rs 86,078 crore while the amount was Rs 88,631 crore in 2020-21 and Rs 63,722 crore in 2019-20.

The value of production was Rs 50,499 crore in 2018-19 and Rs 54,951 crore in 2017-18. "The government has set the target of achieving defence manufacturing worth Rs 1,75,000 crore including defence exports of Rs 35,000 crore by the year 2024-25, Bhatt said.

The Minister also said the value of defence exports in 2021-22 was Rs 12,815 crore while it was Rs 13,398 crore till March 6 in the current fiscal. To a separate question, he said the modernisation of armed forces to meet future challenges is a continuous process based on the long-



term integrated planning

"The annual acquisition plan is formulated annually based on inputs from the services and is based on identified threats and inter-service prioritisation and emerging technologies," Bhatt said. The minister said there has been a consistent increase in the share of the capital acquisition budget. "An amount of Rs 1,24,408.66 crore has been

earmarked for capital acquisi-2022-23, which has been increased to Rs 1,32,727 crore for the year 2023-24," Bhatt

"Further, the DRDO has undertaken 50 mission mode and technology development projects worth Rs 23,722 crore in the last three years for development of indigenous weapons and technologies," he said. Replying to another

query, Bhatt said the Indian Navy has opened all branches to women at graduate level entries. The branches are executive, engineering, electrical and education.

The number of women who have applied for recruitment under the executive branch is 3,941, the number for engineering wing is 360, electrical is 652 and 411 have applied for education wing.

SIPRI: India world's largest arms importer for last five years

m aced}$ by two hostile neighbours namely China and Pakistan, India continued to be the world's largest arms importer for the last five years. Moreover, Russia, France and Israel were the main exporters of weapons and allied equipment to India, the annual report of the prestigious Stockholm International Peace Research Institute (SIPRI) said on Monday. The second biggest importer is Saudi

Noting these two points, the Swedish think tank also said even though Indian remained the biggest importer from 2018-2022 its imports dipped by 11% between 2013-17 and 2018-22.

Among the exporters of weapons to India, Russia was the largest supplier of arms to India in both 2013–17 and 2018-22, but its share of total Indian arms imports fell from 64% to 45% while France emerged as the second largest

supplier between 2018-22, the SIPRI report said. As per latest SIPRI data, among the top 10 arms exporters for the period 2018-22, India was the biggest arms export market to three countries — Russia, France and Israel and the second largest export market to South Korea. India was also the third largest market for South Africa which was ranked 21 in the list

Russia accounted for 45% is India's imports followed by France (29%) and the US (11%). At the same time, India was the third largest arms supplier to Myanmar after Russia and China accounting for 14%

of arms exporters.

"India's tensions with Pakistan and China largely drive its demand for arms imports. With an 11% share of total global arms imports, India was the world's biggest importer of major arms in 2018–22, a position it has held for the period 1993-2022. It retained this position even though its arms imports dropped by 11% between

SIPRI said.

The decrease can be attributed to several factors including India's slow and complex arms procurement process, efforts to diversify its arms suppliers, and attempts to replace imports with major arms that are designed and produced domestically."

The report noted that Russia's position as India's main arms supplier is under pressure due to strong competition from other supplier states, increased Indian arms production and, since 2022, the above-mentioned constraints on Russia's arms exports related to its invasion of Ukraine.

"India's arms imports from France, which included 62 combat aircraft and four submarines, increased by 489% between 2013-17 and 2018-22. France therefore displaced the USA to become the second largest supplier to India in 2018–22," the report said.

Just under two thirds of Russian arms exports went to three states in 2018–22 —

2013-17 and 2018-22," the India (31%), China (23%) and Egypt (9.3%). India was also the largest recipient of Russian arms in 2013–17, but exports to India decreased by 37% between the two periods.

In contrast, exports to China (+39%) and Egypt (+44%) increased within the same time frame, the report said while noting that Russia made no deliveries to Egypt in 2021-22 and the volume of deliveries to China in 2020-22 was at a much lower level than in 2018-19. "It is likely that order volumes from these two states will reduce in the coming years," it stated.

Arms imports by Pakistan increased by 14% between 2013-17 and 2018-22 and accounted for 3.7% of the global total with China supplying 77% of Pakistan's arms imports

While the global level of international arms transfers decreased by 5.1%, imports of major arms by European states increased by 47% between 2013-17 and 2018-22 in the backdrop of war in Ukraine.

India's engagement with China is complex, reveals MEA report

With tension persisting in Ladakh for the last more ment with China is "complex' and its attempts to unilaterally alter the status quo along the Line of Actual Control (LAC) in eastern Ladakh starting from April-May 2020 seriously disturbed the peace and tranquility in border areas, the Ministry of External Affairs (MEA) said in its annual report for 2022 on Monday.

relationship," the report said. "However, starting from

April-May 2020, the Čhinese side undertook several attempts to unilaterally alter the status quo along the LAC in the Western sector, which seriously disturbed the peace and tranquility along the LAC in the Western sector and impacted the development of the relationship," it said. The government refers to eastern Ladakh as the Western sector. The MEA said both sides

have agreed to resolve the issues along the LAC in eastern Ladakh through peaceful dialogue and that discussions have continued with the Chinese side to achieve complete disengagement from all friction points and full restoration of peace and tranquility in the India-China border areas at an early date. "However, the continued unilateral attempts by

development of the bilateral China to change the status quo have impacted the bilateral relationship since then," it

"The two sides continued to make some progress in the resolution of the issues along the LAC in Eastern Ladakh. Continuing with disengagement in Pangong Tso in February 2021 and in the Gogra area in August 2021, this year, disengagement was achieved in Gogra-Hot Springs (PP-15) in Eastern Ladakh (September 2022)," the MEA

Stating that there are still some outstanding issues that need to be resolved, the report said "India has maintained its engagement with the Chinese side both through diplomatic and military channels to resolve the remaining issues at the earliest so as to restore peace and tranquility in the border areas. It said External Affairs Minister S Jaishankar held a meeting with the then Chinese foreign minister Wang Yi during the latter's visit to India on March

"The two ministers exchanged views on the border situation along the Line of Actual Control (LAC) in Eastern Ladakh. The minister conveyed to Wang Yi that restoration of normalcy will require a restoration of peace and tranquility," the report

The report also mentioned the meeting of the two foreign ministers in Bali on July 7 last on the sidelines of a G-20 meeting. During the meeting, Jaishankar called for an early resolution of all the outstanding issues along the LAC in eastern Ladakh and reiterated the need to sustain the momentum to complete disengagement from all the remaining

25 AAI airports earmarked to be leased between 2022-2025

total of 25 airports have Abeen earmarked for leasing over the years between 2022 and 2025. The Airports Authority of India (AAI) has been earmarked for leasing over the years 2022 to 2025 airports under the National Monetization Pipeline (NMP) which include Bhubaneshwar, Varanasi, Amritsar, Trichy, Indore, Raipur, Calicut, Coimbatore, Nagpur, Patna, Madurai, Surat, Ranchi, Jodhpur, Chennai, Vijayawada, Vadodara, Bhopal, Tirupati, Hubli, Imphal, Agartala, Udaipur, Dehradun and Rajahmundry. The information was provided by the Ministry of Civil Aviation in a written reply to Rajya Sabha. India has 148 operational airports including 137 airports,

two water aerodromes and nine heliports. Earlier, AAI has leased out eight of its airports namely Delhi, Mumbai, Ahmedabad, Guwahati, Jaipur, Lucknow, Mangaluru and Thiruvananthapuram through Public Private Partnership (PPP) for operation, management and development on long term lease basis.

Out of these, Delhi and Mumbai airports were handed over in 2006. During the last five years i.e. from 2017-18 to 2021-22, AAI has received revenues of approximately Rs. 5500 crore from Delhi Airport and Rs. 5174 crore from Mumbai Airport. In a written reply to Rajya Sabha, Minister of State in the Ministry of Civil Aviation Gen. (Dr) V. K.Singh (Retd) said that the six airports recently awarded (PPP), Mangaluru,

Guwahati, Jaipur and Thiruvananthapuram have been handed over to the Concessionaires on 31.10.2020, 02.11.2020, 07.11.2020, 08.10.2021, 11.10.2021 and 14.10.2021 respectively.

Till February, 2023, AAI has received concession fees of approximately Rs. 896 crore from the concessionaires for these six airports.

Further, AAI has also received an amount of approximately Rs.2349 crore in the form of upfront fee towards the capital expenditure incurred by AAI at these airports. reverse recovery of ozone layer: Study

New Delhi: A study has warned that huge smoke emitting from wildfires in the last few years threatens to slow and even reverse the recovery of the Ozone, a protective cover shielding the Earth from the Sun's damaging ultraviolet radi-

The Researchers from the Massachusetts Institute of Technology (MIT) in the US noted that a wildfire can pump smoke up into the stratosphere, where the particles drift for over a year. The wildfires in various regions are being fueled by climate change that is making the atmosphere drier and warmer. The study has come at a time when India is battling razing fires in Goa forests and at a Kochi's waste plant. However,

nal Nature, focused on the smoke from the "Black Summer" megafire in eastern Australia, which burned from December 2019 into January 2020. But India too has report-

ed wildfires in the recent years The study noted that while an international agreement to ban CFCs in 1987 had helped the hole in the ozone is gradually shrinking, but in 2021, the hole above Antarctica began to swell once again – a year after the devastating megafires that burned 60 million acres of vegetation in Australia.

The findings help explain why there seems to be such a lag effect on the ozone layer's thickening following wildfire activ-

The Supreme Court on Monday dismissed a plea seeking a copy of the CBI report on closure of its preliminary enquiry in the dis-proportionate assets case against former Uttar Pradesh Chief Ministers Mulayam Singh Yadav and his son Akhilesh Yadav.

The CBI had told the apex court in 2019 that since "no prima facie evidence" of commission of a cognisable offence was found against Mulayam and his two sons- Akhilesh and Prateek- the Preliminary Enquiry (PE) was not converted into a criminal case/FIR, and as such, no enquiry was conducted in the matter after August 7, 2013. A bench of Chief Justice DY Chandrachud and Justices PS Narasimha and

judgements dated March 1, 2007 and December 13, 2012, the CBI has closed its preliminary enquiry on August 7, 2013 and submitted its report on October 8, 2013 to the CVC. This application has been filed in 2019 after six years. There is no merit in the application and hence it is dismissed.

The top court pointed out that former Uttar Pradesh Chief Minister Mulayam Singh Yadav had passed away and asked petitioner Vishwanath Chaturvedi as to what remains in the case. Counsel for the petitioner said the proceedings against Mulayam have been dropped but allegations are also against his sons-Akhilesh and Prateek.

Senior advocate Kapil Sibal, appearing for Akhilesh and Prateek, said the CBI filed

the closure report after conducting the preliminary enquiry and said no case is made out for registration of a regular case. SC orders removal of mosque from Allahabad HC premises

The Supreme Court on The Supreme Court on Monday directed authorities to remove a mosque from the premises of the Allahabad High Court within three months, telling the petitioners opposing the demolition that the structure stood on a terminated lease property and they can't claim it as a matter of right to continue.

The petitioners, Waqf Masjid High Court and UP Sunni Central Waqf Board, had challenged a November

2017 Allahabad High Court order, which had given them three months to move the mosque out of the premises. The apex court dismissed their plea on Monday.

A bench of Justices MR Shah and CT Ravikumar, however, allowed the petitioners to make a representation to the UP government for allotment of land nearby for the mosque. Bench told the petitioners that the land was a lease property, which was terminated, and they can't claim it as a matter of right to continue. "We further grant three months time to

demolish the construction in question by the petitioners and if the construction is not removed within a period of three months from today, it will be open for authorities including the high court to have them removed or demolished," the bench said.

stumbled upon a "gold mine" after recovering two mobile phones of Shantanu Banerjee an arrested TMC leader and Hooghly district board member, the ED advocates said that at present the total money value which was earlier fixed at Rs 110 crore was hovering around Rs 350 crore.

With two heavyweight leaders of the ruling Trinamool Congress-former Cabinet Minister Partha Chatterjee and influential legislator Manik Bhattacharyaarrested by Central agencies and protests and public outrage intensifying by the day, the Trinamool Congress appears to have its back against the wall.

TMC to raise Adani, inflation issues in Parliament

"Our party chief may go to Delhi in the end of March, a party leader said adding during her visit to the Capital she would attend Kejriwal's meeting.

Banerjee is also likely to meet former Uttar Pradesh Chief Minister and Samajwadi Party chief Akhilesh Yadav in Kolkata when he comes to the

city to take part in an SP organizational meeting later this

When asked as to whether the two leaders would have any preliminary round of talks regarding 2024 general elections, a TMC leader who is also a State Minister said, "TMC and Mamata Banerjee will play a definite and decisive role in the general elections together with SP and other likeminded parties."

When asked as to whether the Congress and the Left would fit into her scheme of things, the leader said "it is for the Congress and the Left to decide whether they want to sink together or float and swim with the mainstream Opposition parties."

The Chief Minister is known to have told her party leaders to up the ante against the BJP Government in Delhi on a host of issues like the alleged Adani scandal and its impact as also rising inflation and unemployment, sources said.

'The Adani issue has impacted the national economy and the economics of large PSUs ... the Government must account for that," the TMC leader said adding, Banerjee had also asked the leaders to take up the Women's Reservation Bill in Parliament and State Assemblies which was lying for clearance in the Lok Sabha.

Besides, Banerjee has directed her party leaders to raise the issue of "misuse of central agencies," against the opposition parties and holding back of

NIA holds searches in Srinagar in ISIS Kerala module case

The National Investigation Agency (NIA) on Monday said it conducted searches in Srinagar in the ISIS Kerala Module case. The NIA searched the

premises of Uzair Azhar Bhat, who is suspected to have been part of the conspiracy. The NIA conducted searches at Bhat's house in Karfali Mohalla, Srinagar and seized digital devices which are being examined, and further investigations are in progress, the NIA said in a statement.

In 2021, the NIA had started investigations into Mohammed Ameen alias Abu Yahya of Kadannamanna, Mallapuram (Kerala), who had been running nels on different social media platforms, such as Telegram, Hoop and Instagram.

Through these channels, Ameen was propagating violent Jihadi ideologies of ISIS and was radicalizing and recruiting new members to this ISIS module," the NIA said in a statement.

He and his associates had even identified certain individuals for targeted killings. They had also made plans to undertake Hijrah to Jammu and Kashmir for engaging in terrorist acts and had raised funds from various sources for this

"During the probe, it was found that Mohammad Ameen was in touch with Deepthi Marla of Kerala, a converted Muslim, married to Anas Abdul Rahiman of Mangalore," it said. In 2015, Marla had gone to

Dubai to pursue studies where she met Mizha Siddeeque and both women developed an inclination towards ISIS, it said.

In 2019, they tried to do Hijrah to Khorasan and reached Tehran, Iran. After reaching Tehran, their contact with ISIS operatives based in Khorasan could not be established.

The duo returned to India, Ameen, Obaid Hamid Matta, Madesh Shankar alias Abdullah and others, and made plans to undertake Hijrah to ISIS-administered territory. In January 2020, she went to Srinagar to meet Obaid to plan the Hijrah and stayed in Srinagar for one week, it said, adding that one of the common contacts between Marla and Matta was Bhat, who is suspected to have been part of the conspiracy.

494 convicted out of 8.7K charge-sheeted in Assam child marriage crackdown

Amere 494 people out of 8,773 people who were charge-sheeted for child marriage and POCSO cases in Assam have been convicted since 2017, Chief Minister Himanta Biswa Sarma said on Monday. The Elephant Whisperers and RRR's song 'Naatu Naatu' have won Academy Awards

The Elephant Whisperers winning the Academy Award for Best Documentary Short and RRR's song 'Naatu Naatu' for the Best Original Song is surely good news for Indian cinema. It would delight every Indian who believes that their country's soft power has an enormous potential. The two works that have won the awards are as diverse as India is. The Elephant Whisperers is a documentary about a tribal Bomman and Bellie who take care of orphaned baby elephants named Raghu and Ammu, almost becoming a family in the process. RRR (Rise, Roar, Revolt), on the other hand, is a SS Rajamoulidirected fantasy — replete with dance, drama, musical extravaganza, and action—about the friendship of two revolutionaries fighting against British rule in the 1920s. Quite expectedly, the Oscar wins have generated euphoria among not just RRR fans but also movie buffs. In her Instagram post, Alia Bhatt, who was associated with RRR, was ecstatic.



Ajay Devgn, who acted in RRR, tweeted, "As it is often said, cinema speaks a universal language. Congratulations to the teams of RRR and The Elephant Whisperers for their #0scar wins. It's a proud moment." More congratulatory messages would follow, for the awards are an international recognition of Indian artists' creativity, diligence, and determination. They have proved that originality can shine on its own; it need not depend on reputation. In fact, it was for the first time that three Indian productions got nominated for the Academy Awards. Also, actress Deepika Padukone was among the presenters.

While this is the time to celebrate the achievements of Indian cinema, this should also be the

moment when the powers that be, public intellectuals, film critics, and others should ponder over the future of cinema in the country. Our political masters would be jubilant over the success of the winners, but they should remember that the success is not because, but in spite of, the system they (politicians) have made. Filmmakers, other artists, indeed all people in the country have to endure a system that is scornful of, if not antithetical to, creativity. Demands can be made—and are often made for a ban on any song, joke, movie, book, etc., that some politician or the other find inconvenient. Often they initiate official action against the song, films, etc., they don't approve of. Worse, the action could be unofficial; members of the front organisations supported by the ruling party at the Centre or in a state can wreak havoc at the film set of a movie that their political overlords don't like—with no consequences for the violent offenders. Then there are blackmailers and attention-hungry activists who go to any length to campaign against any movie or song. Always keen to give publicity to such characters are some news channels. Hence the puerile, indeed sickening, debates on the look of Ravan and the attire of Hanuman. It is time those who matter decided not to suppress freedom of expression on grounds of 'hurt sentiments.'

Pak: bitten by its own creations



The terror groups, once supported by the Pakistan establishment, have become its nemesis, compounding its myriad problems

n Pakistan, religion not only offers a collective identity, and sovereign rationality, but this existential underpinning also affords to flirt creatively with religion as a distinct state activity. Such a fixation with religiosity has bred an inevitable industry i.e., religious extremism or terrorism. External Affairs Minister S Jaishankar refers to it as the 'basic industry' of Pakistan. Nurtured exclusively for 'export purposes' across the Line-of-Control (LOC), Durand Line or even the Iran-Pakistan border - it led the former Prime Minister Imran Khan ('Taliban Khan') to concede that some 30,000 to 40,000 terrorists had trained and fought in "some part of Afghanistan or Kashmir" and were now in Pakistan. The most famous export brand from this industrial hub is the polylithic 'Taliban' that was dutifully incubated, nurtured and thrust upon its internationalistic task.

As per Human Rights Watch, Pakistan's hand in the Taliban is, "distinguished both by the sweep of its objectives and the scale of its efforts". Pakistani journalist and regional expert, Ahmed Rashid noted the staggering levels of Pakistani efforts, "between 1994 and 1999, an estimated 80,000 to 100,000 Pakistanis trained and fought in Afghanistan", on the side of the Taliban! It can be argued that it was an investment that paid off well (initially) in terms of fructifying Islamabad's much-cherished dreams of 'Strategic Depth' in Afghanistan, with the coming of the first Taliban government (1996-2001). Irrespective of the cancerous ideology and puritanism that it was breeding that was sure to spillover across the Durand Line, Pakistan kept its parleys with shadowy elements of the Taliban even during the 'War on Terror' (when it had supposedly reneged and declared war on the Taliban). The Americans were frustrated with the Pakistani doublespeak and the short-lived joy of Pakistani brass was visible to all when Kabul fell yet again on 15th August 2021. Surreal images of Pakistani ISI chief Lt Gen Faiz Hameed smilling and sippling tea with the roughshod Taliban in town amidst the ruin of Kabul declaring a nonchalant, "Don't worry, everything will be okay", is



Hillary Clinton's muchignored forewarning to the Pakistanis of keeping snakes in the backyard under the misplaced assumption that they would only bite the neighbours was to come true with the metastasizing of its export products i.e., terrorists, within Pakistan itself. One such offshoot of the original Pak-created Taliban was Baitullah Mehsud who created a new organisation to fight the US presence in Afghanistan, albeit, with one additional objective i.e., resistance to the Pakistani State. His outfit added a telling 'P' to the standard nomenclature of the Taliban when it called itself Tehreek-e-Taliban Pakistan or TTP. Suddenly products made exclusively for export purposes went out of Pakistani control and got themselves a domestic purpose and market - Pakistan soon came under attack from its own creation.

Longtime warrior and Afghan spymaster (Head of Afghanistan's National Directorate of Security), Amrullah Saleh, who went on to become First vice President (now self-styled 'Acting President' in the resistance movement) has lived to tell Pakistani fate. Amrullah tweet-

ed mockingly, "Tehrik Taliban (TT) is a Pakistani brand exclusively for export. Per military law it shouldn't be used internally. The problem is just with the P in the TTP. Should the TTP assure Rawalpindi that it is ready to fight elsewhere then within minutes the brotherhood will be restored". Amrullah states the obvious of a rogue strain within the Pakistani brand that has become its nemesis. This is the same Amrullah who had tweeted three days before Kabul fell i.e., on 12th Aug 2021, "The official name of the Taliban for the last 20 years Has been "Quetta Shura". Quetta is a Pakistani city & capital of Balochistan province. @sanctionPakistan". Valiant Amrullah was only calling the bluff of the real power behind the picture of marauding Taliban, though his pleas to 'sanction' Pakistan went obviously unheeded and it took nature to take its own Frankenstein course, to turn its back on the Pakistani narrative.

Pakistan Institute of Conflict and Security Studies (PICSS) recorded Jan 2023 as the most violent month with 44 recorded terror attacks and 134 fatalities. Last month was even more chilling with 80 policemen perishing in a sinular mosque attack and brazen other attacks on Police stations and outposts. Ironically, portents of a seemingly 'Reverse Strategic Depth'

are looking for the Pakistanis, with the Tehreek-e-Taliban Pakistan attacking Pakistani State with utter impunity and an undiscussed shadow of 40 million Pashtuns on the Pakistani side of the Durand Line, as opposed to just 16 million on the Afghan side, of its

unrecognised Durand Line. Today, Tehreek-e-Taliban Pakistan's (TTP) leader is Noor Wali Mehsud (4th 'Emir') who too was part of the original Taliban and has since redirected his ire at Pakistan. Mehsud alluded to the religious texts to contextualise and posit TTP's inextricable linkages to the principal Taliban movement, according to the teaching of Islam, the victory of one Muslim is necessarily helpful for the other Muslim. But how the victory of the Afghan Taliban will prove helpful for the Pakistan Taliban, time will tell". The 'P' in the TTP is already paining unbearably for the Pakistanis.

Poverty, population proscribe progress

To be in the fast lane of growth we must eradicate poverty and control population growth

e it a Progress Positive with a pragmatic shift auguring positive development or a pyrrhic one; wise men depict that growth with equity (ethics) connotes progress and as such growth trajectory gets influenced by the waxing and waning of the impact of poverty and population growth. Development is a process that procreates growth as well as progress and positive change. The concept is closely associated with physical, socio-economic, environmental and demographic factors. Whereas progress is associated with a movement, especially towards an objective and it has manifestations like technological progress, scientific progress and socio-economic progress.

In Amartya Sen's words 'no nation has grown out of poverty to prosperity without taking care of the basic needs of its people.

Modern definition projects poverty not just as relative but also as absolute. It is stated that poverty connotes failure to achieve certain minimum capabilities or lack of capability which is absolute

(Amartya Sen). Therefore development economics with microeconomic analysis and measurement of the wellbeing of the poor is being focused on in modern times.

Poverty hinders growth and affects the progress (and development) of the nation with predicaments of the impecunious affecting growth factors like per capita income etc.

The rapidly growing population and its upsurge transform a growing economy into an economy of mass unemployment as well as low employment. All the major theories of the population like Malthusian theory, Optimum theory of population (Edwin Cannan) and Theory of

demographic transition interpret the correlation between population growth and development. Malthusian theory harangues eloquently about the negative impact of population growth. Needless to say, rapid population growth precipitates unemployment and other associated problems like lack of shelter and housing, the poor living conditions of the poverty-stricken people and food insecurity etc. The decrease in individual income and dwindling of resources with scanty access to financial resources by the vulnerable group accentuate the problem.

Is seen poverty and rapid population growth pose and seem to be Siamese or conjoined twins, both symbiotic to each other and as such form the vicious cycle of poverty. The rapid growth of the population witnesses the waxing of the number of

poverty-affected people, as has been mentioned supra. Last but not least pessimism also affects the economy at the micro level with households reducing current demand and firms posting fewer job vacancies. Fear of higher future costs reduces incentives for firms to lower prices. Pessimism as such in economics can be stated as a tendency to see the bad side of the thing or to expect the

worst in any situation. Any concept of allaround progress and development (Vikash) has to start with the eradication (vinash) of poverty, along with control of population growth. Closing the eyes to harsh realities doesn't stop its occurrence rather it provides the impetus to proliferate. Prophylactic action with accurate perception is always preferable to a curative one as it saves time, stops consequential damages and nips the repercussions.

Things are clear that unless and until we eradicate poverty higher economic growth would remain a chimaera. The task at hand is to eradicate poverty and control population growth.

While the first task is on the anvil, the second has to be given a kick-start. If these two problems are not squarely addressed, no matter how much effort we may put in, the result would remain much to be desired.

THE SAGA OF NON-**VIOLENCE IN ACTION**

Salt Satyagraha was a landmark march that paved the way for future nonviolent protests



inety three years ago on March 12, 1930, one of the greatest movements to awaken the country and her citizens began. The ground was prepared by a 60-plus man with a staff in hand when he decided to foot march from Sabarmati to Dandi to break the unjust salt tax imposed by the British. Mahatma Gandhi had indeed given a clarion call for world sympathy in this "Battle of right against might".

Gandhi had begun the march with 78 of his satyagrahis barring different age groups to cover a trek of 385.6-kilometres; across 47 villages; over 24 days and nights, starting from Sabarmati Ashram in Ahmedabad and ending in Dandi in coastal Surat - from March 12 to April 6 - in a nonviolent march towards freedom. Seeing this enthusiasm of the swaying crowd that joined Mahatma Gandhi in villages to villages that he traversed during the Salt March, Pt. Jawaharlal Nehru expressed, "It seemed as though a spring had been suddenly released."



It is noteworthy to reflect that Mahatma Gandhi wrote his first article on 'Salt' as early as February 14, 1891. He was twenty-two. The article appeared in The Vegetarian, where he described the utter poverty of his fellow country-men who lived on bread and salt, a 'heavily taxed article' (Source: The Collected Works of Mahatma Gandhi, 1894-96, Vol. I. (Ahmedabad, 1958), pp.24ff.) Similar views appeared time and again from him during his sojourn in South Africa. It was also in Hind Swaraj that he wrote: "The salt-tax is not a small injustice". Therefore, the object, 'salt', too was carefully chosen that was directly linked with the survival of the people and it had roused the conscience of a sleeping nation towards a non-violent struggle. Mahatma Gandhi clearly understood that salt was the only relish that the teeming poor in Indian villages could afford for their monotonous diet and that it was perhaps the greatest necessity of life and taxing it increased the burden.

Given his personal life of extraordinary simplicity and his identification with his countrymen, through this Salt March, Gandhiji inspired and motivated the teeming millions to follow him. Secondly, Gandhiji utilized this moment (read march) to target issues of the 'caste divide' in the villages en route. This was evident as he chose to stay in the so-called 'untouchable' quarters and drew water from the well there for his wash. By also staying at Sirajuddin Vasi's (better known as Shiraz Abdulla) place a powerful message of brotherhood was sent. Thirdly, he inspired women to lead for the first time. From Kasturba Gandhi, his wife, to Sarojini Naidu the Parsi social worker Mithuben Petit, to other women leaders like Kamaladevi Chattopadhyay, Hansa Mehta, Amina Tyabji, and Rukmini Lakshmipathy, the women led the protest at other places and broke the salt law and also courted imprisonment. Finally, this saga of non-violence in action was demonstrated by the nonviolent satyagraha as they faced the brutality of the oppressors with patience and steadfastness, especially at Dharasana, 25 miles south of Dandi. The amazing self-discipline of the satyagraha in the face of repressive violence was demonstrated.

Gandhi embodied the tradition of pilgrimages and added his values of spiritualism to it that he had imbibed through this travel across the length and breadth of the country. He had said that his feeling was like that of the pilgrims of Amarnath or Badri-Kedar. This small voice had expounded the glories of freedom and the beauties of moral life. It was almost like a mythical quest for a pilgrim. Mahatma Gandhi immersed himself deeply in this role of nonviolent struggle, leading his nonviolent forces to a triumphant moral victory. He believed that "Nonviolence is like the radium in action". As Mahatma Gandhi stood up with a lump of salt in one hand and said, "With this, I am shaking the foundations of the British Empire," there were around 60,000 to 100,000 marchers behind him. This was because Mahatma Gandhi was able to touch the 'Soul', 'Soil' and 'Society'" and embrace them in his constructive actions.

Let FDI in retail come from the front door

Allowing FDI in retail would be in the best interest of consumers as this will enable all retailers to compete with one another on equal terms



ollowing complaints from consumers and traders against "widespread cheating and unfair trade practices" by e-commerce marketplaces such as Amazon and Flipkart, the Union government intends to amend consumer protection rules to bar these firms from (i) selling their private labels on their platforms; (ii) make them liable for frauds committed by a seller; (iii) prohibit them from having their logistics chain for supply-chain management.

The marketplace is a platform where vendors sell their products to consumers even as its owner merely acts as a facilitator by providing services such as booking orders, raising invoices, arranging the delivery, accepting payments, handling rejections, etc. He can't hold inventory or undertake direct selling. As per the guidelines issued in early 2016, the government had allowed 100 per cent FDI under the marketplace model.

Amazon and Flipkart have come under this model and together invested over US\$10 billion in setting up supply-chain logistics. They have indulged in a vast array of practices that are detrimental to sellers on their platform as well as to consumers.

to address their concerns, on July 2020, the Department of Consumer Affairs (DCA), in the Ministry of Consumer Affairs, Food and Public Distribution, issued the Consumer Protection (e-commerce) Rules, under Section 101 of the Consumer Protection Act, 2019. The rules bar affiliated entities from selling on a marketplace, restrict 'flash sales' (such sales involve instant, heavily discounted, timebound sale offers), and disallow sellers from using the name or brand associated with that of marketplace e-commerce entities for the promotion of goods.

On June 21, 2021, the DCA came up with an amendment to the rules to restrict business-to-business, or B2B, sales (this is to prohibit transactions between the owner of the marketplace and seller on his platform) in e-commerce and a provision to prevent 'abuse of dominant position' by ecommerce firms. The government sought stakeholders' views on these amendments.

These were not pursued as during intermenstrual consultations, the department for the promotion of industry and

internal trade (DPIIT) - nodal authority for dealing with FDIrelated issues - expressed concerns that some of the changes in the rules would go beyond consumer protection and impede the flow of foreign investments in the sector. It was also felt this would impact existing investments.

Now, those amendments have been resurrected with some more being added to the list such as prohibiting e-commerce giants from having their logistics chain for sup-

This time again, the process of giving effect to the amendments is unlikely to be taken to its logical end. Things will simply be allowed to linger on. This is because the government while allowing FDI in the marketplace left some loopholes in the guidelines which keep coming to haunt it whenever it tries to go for a course correction.

In 2016, while permitting FDI in e-commerce, it prescribed two conditions. First, the entity cannot permit more than 25 per cent of total sales on the marketplace from one vendor or its group companies. Two, it cannot directly or indirectly influence the sale price. Without any mention as to who the vendor is, a firm linked to the marketplace either its subsidiary or a joint venture (JV) with an Indian company is eligible. As for the second condition, it

is not easy to establish that the marketplace owner has manipulated the sale price. Thus, contrary to the stated intent of the policy, these norms permitted e-commerce majors as direct sellers, albeit through their subsidiary/JV. No wonder, Amazon established a JV Prione Business Services (PBS), in collaboration with an Indian entity owned by Narayan Murthy of Infosys. PBS in turn owned a firm Cloudtail India Pvt Ltd which was a "preferred" seller on Amazon's marketplace.

In this backdrop, notwithstanding much ado about the foreign

giants indulging in anti-competitive behaviour in a host of manifestations such as preferred often related sellers, deep discounts, abuse of dominance and so on, the fact remains that the 2016 guidelines provided for the possibility of a total of four sellers on the e-commerce platform (based on a threshold of 25 per cent of total sales for each seller) who could all be related to the owner of the platform.

Amazon and others were not doing anything wrong in so far as the rule book on FDI was concerned. Meanwhile, on December 26, 2018, the Commerce Ministry issued a clarification saying: "The owner of the marketplace or its subsidiary or its JV with an Indian company can't have ownership of the seller." Moreover, "a seller on the platform can't source more than 25 per cent of its inventory from a firm connected with the latter."

The marketplace owner could get around both the clarifications: first, by having less than 50 per cent shareholding in the seller firm, they can argue that they have no control (albeit majority) over the latter, and second by its wholesale arm restricting supplies to the seller within the 25 per cent threshold.

The clarification has done little to rein in the hold of e-commerce majors in direct selling to consumers to the detriment of small traders. For instance, only three dozen firms out of the 400,000 sellers on the Amazon platform account for 67 per cent of sales on it.

Apart from pleading with the overnment, small sellers/traders have also taken the legal course. A most talked about case relates to a complaint by Delhi Vyapar Mahasangh (DVM) on January 13, 2020, with the Competition Commission of India (CCI) alleging anti-competitive behaviour by Amazon Seller Services (it operates an e-commerce marketplace) and Flipkart Internet.

DVM argued that Amazon and

Flipkart had entered into exclusive sales agreements with smartphone makers to sell certain phones through a small number of preferred sellers. It also alleged that they had given preferential treatment to certain sellers by giving them higher search rankings and offering to pay for part of the discount that such sellers would offer during key sales periods such as Flipkart's Big Billion

Days and Amazon's Prime Day. The CCI agreed with DVM's contention and ordered a probe. Amazon and Flipkart approached the Karnataka High Court (KHC) with a plea to quash the CCI order. The KHC refused to quash it, which prompted the duo to challenge the order in the Supreme Court (SC). In August 2021, the SC dismissed their applications and ordered that "the CCI Director General will complete the probe and submit the findings to the commission which will pass final orders.

Even if the CCI-DG establishes anti-competitive behaviour by Amazon, the matter will be neac ing for interminable litigation. The issue has to be sorted out by none other than the government itself. It can't drastically alter the rules (it is intended through 2021 amendments) as it will be tantamount to overturning the 2016 guidelines. It will be viewed as a retrospective change of policy and send a wrong signal to foreign investors. If it continues with the status quo, small traders will continue to face unfair treatment.

The government can get out of the mess if it dispenses with the marketplace and legitimises 100 per cent FDI in online retail. It should also allow 100 per cent FDI in offline retail sans riders (at present, 51 per cent is allowed in this segment subject to onerous riders). This will enable all retailers, online or offline, big or small, to compete with one another on equal terms.

What Opposition-free Govt really means for democracy

Nagaland's Opposition-free government shows that the space for the Opposition in state assemblies is shrinking

fter the recent Assembly results, all parties in the tiny State of Nagaland formed an Opposition- free government to get a share in the power pie. All the parties unconditionally supported the ruling alliance, and all parties were in the Government with no Opposition.

It isn't the first time Nagaland has chosen an Opposition-free government. In 2015 and 2021, there were such governments, but this was the first-ever Assembly where there was no opposition party even before the elected members had been sworn in.

The stakeholders justified their decision in their plea to bring all sections together for Naga's political solution. The State faces serious development challenges attributed to long

years of insurgency. This complete lack of Opposition shows the convulsions of s democracy in its worst form.

The ruling NDPP (Nationalist Democratic Progressive Party)-BJP (Bharatiya Janata Party) alliance retained power for a second straight term. In the 60member House, the BJP won 12 seats, and its ally NDPP got 25. Independents won four and Nationalist Congress Party 7. Congress, which ruled the State earlier, did not open its account in the current or the previous Assembly. To explain the historical perspective, the Naga movement, the longestrunning insurgency in the country, began during the British regime and continued even after independence. In 1997, the Centre signed a ceasefire agreement with the National Socialist Council of Nagalim (NSC-IM), the largest rebel group.

Prime Minister Narendra Modi renewed the negotiations after he came to power in 2014. As a result, the Naga peace accord was signed to end the six-decade-old insurgency on 3 August 2015. All the parties formed an Opposition - free government before that.

The Government's interlocutor for Naga Peace Talks, R. N. Ravi, signed it on behalf of the Government of India. Lt. Isak Chishi Swu, Chairman and Thuingaleng Muivah, General Secretary, signed on behalf of the NSCN in the presence of Modi. For a second time, in 2021, the NPF and Independents joined the NDPP-BJP alliance are many reasons for the numbers that could only come

to seek a collective solution to the Nagaland problem and formed an Opposition -free vernment.

However, as the circumstances differ, the Nagaland experiment cannot be extended to other States or the Centre. Suppose such a thing happened at the national level? Our Founding fathers would shiv-

Former Chief Justice of India N. V. Ramana, addressing Rajasthan Assembly before his retirement, expressed concern over the diminishing space for the Opposition in legislative bodies. He lamented that the laws were passed without detailed deliberation and

called for a robust, vibrant, active Opposition. As a larger question, there

declining Opposition space within the state Assembly. They include an increasing number of dynastic leaders, lack of debate in the Legislature, absence of a good counter-narrative, and their adoption of an obstructive

The BJP has been aggressive in its expansion. Modi and his deputy Amit Shah worked feverishly to expand the party. Even nationally, the opposition space has been systematically eroded in the last decade, mainly after Modi took over.

In contrast, the main political party, the Congress, unable to protect its turf, has continuously declined in its electoral performance. The Left Parties, too, face a similar situation. The regional leaders needed the

through alliances with these national parties. Above all, the Opposition parties needed an alternate vision and an engaging narrative to check the ruling BJP.

While drafting the Constitution, our founding fathers went into all aspects, including the role of the Opposition. Ideally, in genuine parliamentary democracies, governments and oppositions have equal obligations and responsibilities to the people who elected them to represent their interests. There is no democracy without Opposition, and theoretically, at least, it is as powerful as the Government. However, the success of democracy depends on the constructive role of the opposition parties as they pro-

vide an alternate viewpoint.

They also scrutinize and challenge the ruling parties and hold them accountable for their actions. Opposition is strong when people join it. Today, it is ordinary Índians who are performing the role of a formal Opposition to the Government. The effectiveness of the Opposition lies in raising the right questions. Any opposition party, civil society group, any organization willing to engage with the issues can be a vehicle for opposition politics.

The moral of the story is that democracies can survive authoritarians; they cannot survive the absence of vigorous Opposition. It performs a restraining role and constantly challenges the Government of the day by promising a viable

Xi vows to build military into 'Great Wall of steel'

SAUDI-IRAN DIPLOMATIC **COUP AFTERMATH**

President Xi Jinping on Monday vowed to build China's military into a "Great Wall of steel" to protect the its sovereignty and developmental interests as he sought a bigger role for Beijing in global affairs, days after brokering a Saudi Arabia-Iran detente, regarded as a diplomatic coup.

Speaking for the first time since the rubber-stamp Parliament last week approved his precedent-breaking third term as head of state, Xi called on the nation to uphold the leadership of the ruling Communist Party of China (CPC) headed by him.

"This is my third time assuming the lofty office of president," Xi, 69, said at the closing ceremony of China's national legislature, adding that "the trust of the people is the biggest driving force for me to move forward, and it is also a heavy responsibility on my shoulders". He pledged that he would "faithfully perform the duties entrusted by the Constitution" and would "never

let down the great trust" of all Chinese people.

"Security is the bedrock of

development, while stability is a prerequisite for prosperity," Xi said Xi also called for efforts to advance the modernisation of China's defence forces and build the people's armed forces into a "Great Wall of steel" that is capable of effectively safeguarding national sovereignty, security and development

Xi's reference to the Great Wall was significant as the mammoth structure, with a total length of more than 20,000 km, was built over centuries by China's emperors to protect their territory. It also came amidst growing tensions between China and the US and some neighbouring countries. Xi is regarded as the 'core leader' of the party very much like the party founder Mao Zedong. He was endorsed by the

rubber-stamp Parliament last week as the President and head of the Central Military Commission (CMC) the high command of the Chinese mil-

itary, marking the beginning of his new five-year term.

He was elected as the head of the CPC for an unprecedented third term in October last year, the only leader to have more than two five-year terms after Mao. He was the only leader to have a third five-year term while all his predecessors retired after two five-year

In his speech at the NPC closing ceremony attended by about 3,000 legislators Xi said, China will play an active part in the reform and development of the global governance system to advance the implementation of his initiatives the Global Development Initiative (GDI) and the Global Security

Initiative (GSI) which aims to expand Beijing's diplomatic role in the world.

His comments came in the backdrop of China clinching a Saudi-Iran deal, regarded as a diplomatic coup, to end their years of hostilities and restore diplomatic ties.

Also speculation is rife that Xi is planning a visit to Russia next week to meet President Vladimir Putin to discuss a negotiated settlement to end the Ukraine war.

Russia's state-run Tass news agency quoted Kremlin Spokesman Dmitry Peskov as saying that "as a rule, announcements of official foreign visits are made synchronously, by mutual agreement".

China, Saudi Arabia and Iran on last Friday reached a deal that includes the agreement to resume diplomatic relations and reopen embassies and missions within two months.

The deal reached after talks in Beijing from March 6 to 10 was regarded as a major achievement for China in expanding its global outreach and countering the US influence, especially in the Middle

Last week, in unusually direct remarks, Xi accused the US of leading Western countries to "contain and suppress" China and bring it "unprecedented severe challenges.

A key agenda for the legislative session is to provide a strategy to cut reliance on the US. As part of that plan, the central government proposed to raise R& D spending by 2 per cent in 2023 to 328 billion yuan (USD 47 billion).

Also on March 5, China hiked its defence budget for the 8th consecutive year with a 7.2 per cent increase to USD 225

On Taiwan, which China claims is part of it, Xi said China is actively promoting the peaceful development of cross-Strait relations, resolutely opposing external interference

separatist activities, and firmly advancing the process of national reunification.

He also promised to continue the one-country two system formula to develop Hong Kong despite the crackdown to subdue pro-independence forces in the former British colony under China's new security law.

Stressing that China will make concrete efforts to advance high-standard opening up, Xi said the country will not only leverage global markets and resources for its own development but also promote the development of the whole

He also called for building China into a great modern socialist country and advancing national rejuvenation.

From this day forward to the mid-21st century, the central task of the entire CPC, and all Chinese people will be to build China into a great modern socialist country in all respects and to advance the rejuvenation of the Chinese nation on all fronts, Xi said.

The relay baton of building a great modern socialist country and advancing national rejuvenation has been historically passed on to our gener-

difficulties but concedes the economy faces challenges. He acknowledged that achieving the 2023 gross domestic product (GDP) growth target of around five per cent for this year on the current high base of China's He reiterated China's comeconomic output is not an easy task and requires redoubled efforts.

Playing down the importance of GDP, he said most people do not keep their eyes

on GDP growth all the time.
China, the world's second-largest economy, last year reported a three per cent GDP, the lowest in decades and the target of about five per cent set for this year by Li Keqiang in his work report on March 5 is also the lowest in recent years.

What people care more about are the things that happen in everyday life like housing, employment, income, education, medical services, and the environment, Li said.

He also pointed to signs of improvement, saying the economy will break through the wind and waves and sail towards a brighter future as China's development is supported by multiple advantages, including a vast market, a complete industrial system, abundant human resources, solid foundation for development, and institutional strength. The government will step up efforts to foster a business environment that is mar-

ket-oriented, law-based and internationalised, treat companies of all types of ownership as equals, and protect the property rights of enterprises and the rights and interests of entrepreneurs in accordance with the law, Li told a press conference.Commenting on China's crackdown on business during the past few years, including on e-commerce giant Alibaba and tech companies besides the detention of a star banker Bao Fan for questioning has created a fear psychosis in China's private sector, Li said the government's commitment to the development of the private sector is unequivocal and



The protests began in September over the death of a 22-year-old woman named Mahsa Amini after she was detained by the country's morality police.

Cohen to testify before grand jury in Trump hush money probe

AP NEW YORK

Donald Trump's former lawyer and fixer Michael Cohen is expected to testify Monday before a Manhattan grand jury investigating hush money payments he arranged and made on the former president's behalf. Cohen's impending grand jury appearance was confirmed by two people familiar with the matter who were not authorised to speak publicly about grand jury proceedings and did so on condition of anonymity.

Cohen's closed-door testimony is coming at a critical time as the Manhattan district attorney's office closes in on a decision on whether to seek charges against Trump. A Trump loyalist turned adversary, Cohen is likely to provide critical details about whatever involvement the Republican presidential candidate may have had in the payments, made in the final weeks of the 2016 campaign, to two women who alleged affairs with him. Cohen has given prosecutors evidence, including voice recordings of conversa-

sages. He also has recordings of a conversation in which he and Trump spoke about an arrangement to pay the other woman through the supermarket tabloid the National Enquirer.

Prosecutors appear to be looking at whether Trump committed crimes in how the payments were made or how they were accounted for internally at Trump's company, the Trump Organisation.

One possible charge would be falsifying business records, a misdemeanour unless prosecutors could prove it was done to conceal another crime. No former US president has ever been charged with a crime. Appearing Monday on ABC's 'Good Morning America," Trump lawyer Joseph Tacopina said it is unlikely that the former president will accept an invitation, extended by prosecutors last week, to testify before the grand jury.

"We have no plans on participating in this proceeding," Tacopina said. "It's a decision that needs to be made still. There's

Biden seeks to assuage fears after SVB collapse

President Joe Biden on Monday sought to reassure jittery Americans that they can have confidence that the US banking system is "safe" and vowed stricter bank regulation after a string of bank failures raised concerns about the nation's financial stability.

The president's early morning comments came after US bank regulators spent the weekend working on a plan to shore up the public's confidence in the soundness of the financial system and limit spillover effects following the closing of the Silicon Valley Bank last

"Americans can rest assured that our banking system is safe. Your deposits are safe," Biden said from the Roosevelt Room of the White House. Taxpayers will not bear any losses from the move, which will be funded by fees regulators charge to banks, he said. The banks' leaders will be fired, he added.

Biden in his address allayed fears, directly explaining what he has instructed his administration to do to protect small businesses and workers in the wake of regulator shutdowns of both Silicon Valley Bank and Signature Bank over the last

few days. The California-based



HSBC to buy UK subsidiary of Silicon Valley Bank

London (AP): The UK Treasury and the Bank of England have "facilitated the sale" of Silicon Valley Bank UK to HSBC, ensuring the security of 6.7 billion pounds (USD 8.1 billion) of deposits. British officials worked throughout the weekend to find a buyer for the UK subsidiary of the California-based bank that failed last week. "This morning, the government and the Bank of England facilitated a private sale of Silicon Valley Bank UK to HSBC," Treasury chief Jeremy Hunt said in a Tweet. "Deposits will be protected, with no taxpayer support. I said yesterday that we would look after our tech sector, and we have worked urgently to deliver that promise." HSBC said it will acquire Silicon Valley Bank UK Ltd for one pound.

Silicon Valley Bank (SVB), the 16th largest bank in the United Insurance Corporation (FDIC) States, was closed on Friday by the California Department of

as its receiver.

It was the largest failure of Financial Protection and a US bank since the financial Innovation which later crisis in 2008. It came after SVB

to plug a loss from the sale of assets affected by higher interest rates. Word of the troubles led customers to race to withdraw funds leading to a cash crisis. Authorities on Sunday also said they had taken over Signature Bank of New York, which was seen as the institution most vulnerable to a similar bank run after SVB. "Every American should feel confident that their deposits will be there if and when they need them," President Biden said. "Let me also assure you. we will not stop at this. We'll do whatever is

Investors in the banks however, will not be protected, the president said, and management will be fired.

"They knowingly took a risk, and when the risk didn't pay off, investors lost their money. That's how capitalism works," Biden said. Customers "have access to their money as of today. That includes small businesses across the country that bank there and need to make payroll, pay their bills and stay open for business," Biden said, adding that no losses will be suffered by the taxpayers.

"Instead, the money will come from the fees that banks pay into the deposit insurance fund," he explained.

Putin may visit India for G20 summit

Moscow (PTI): Russian President Vladimir Putin may attend the G-20 summit in India in September, but no decision has yet been made, his spokesperson said on Monday.

"It cannot be ruled out," Kremlin Spokesman Dmitry Peskov said when asked if Putin's participation in the summit in India in September was being considered. But no decision has been made yet," Peskov was quoted as saying by the state-run Tass news agency. "Russia continues its full participation in the G20 format, we intend to continue it," Peskov added.

The Russian delegation at the G20 leaders' forum in Bali, Indonesia last year was headed by Foreign Minister Sergey Lavrov. In 2020 and 2021 Putin attended the G20 summits via video link. The G20 Leaders' Summit is scheduled to be held on September 9 and 10 in New Delhi.G20 or the Group of 20 is an intergovernmental forum of the world's major developed and developing economies.

The members represent around 85 per cent of the global GDP, over 75 per cent of the global trade, and about two-thirds of the world population. The grouping comprises Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the UK, the US and the European Union

44 dead as Cyclone Freddy pounds Malawi, Mozambique

An unrelenting Cyclone Freddy that is currently battering southern Africa has killed at least 44 people in Malawi and Mozambique since it struck the continent for a second time on Saturday night, authorities in both countries have confirmed.

At least 39 people in Malawi's commercial hub of Blantyre have died with several others missing or injured, the city's chief executive officer told The Associated Press on Monday. Authorities in Mozambique reported that five people were killed in the country since Saturday.
The deaths in Malawi

include five members of a single family who died in Blantyre's Ndirande township after Freddy's destructive winds and heavy rains demolished their house, according to a police report. A three-year-old child who was "trapped in the debris" is also among the victims, with her parents among those reported missing, authorities also said.

"We suspect that this figure will rise as we are trying to compile one national report from our southwest, southeast and eastern police offices which cover the affected areas," Malawi police spokesperson Peter Kalaya told the AP.

The cyclone lashed over Mozambique and Malawi over the weekend and into Monday. It's the second time the record



breaking cyclone — which has been causing destruction in southern Africa since late February — made landfall in mainland Africa. It also pummelled the island states of Madagascar and Reunion as it traversed across the ocean.

The cyclone has intensified a record seven times and has the highest-ever recorded accumulated cyclone energy, or ACE, which is a measurement of how much energy a cyclone has released over time. Freddy recorded more energy over its lifetime than an entire typical US hurricane season. Freddy first developed near

Australia in early February and travelled across the entire southern Indian Ocean. Its set to be the longest-ever recorded tropical cyclone. The UN's weather agency has convened an expert panel to determine whether it has broken the

1994 of 31 days. Freddy made landfall in the seaport of Quelimane in Mozambique on Saturday where there are reports of damage to houses and farmlands, although the extent of the destruction is not yet clear. Telecommunications and other essential infrastructure are still cut off in much of the affected Zambezia province, impeding rescue and other humanitarian efforts.

French weather agency Meteo-France's regional tropical cyclone monitoring centre in Keunion warned Monday that "the heaviest rains will continue over the next 48 hours" as Freddy barrels on.

Mozambique's central provinces and Malawi have been identified as especially vulnerable to "floods and landslides in mountainous areas" by

Peshawar (PTI): A Pakistani security official was killed while four were injured on Monday when unidentified militants attacked a police van deployed to protect the population census team in the restive Khyber Pakhtunkhwa province, the second such attack in the province in less than a week.

The armed terrorists opened fire at a police mobile team on duty with the population census team in Tank district's Kot Azam area in the province, a police official said.

Sensex, Nifty plunge to five-month low

Over contagion fears from US bank failure

Benchmark stock indices Sensex and Nifty declined for a third day on the trot to close at five-month low levels on Monday due to a massive sell-off in banking, finance and auto stocks triggered by fears of potential contagion from the biggest bank failure in the US since 2008.

Unabated flight of foreign capital and a weak domestic currency amid global rate hike fears added to the gloom, traders said. Falling for the third straight session, the 30-share BSE Sensex plunged 897.28 points or 1.52 per cent to settle at 58,237.85, the lowest closing level in five months. Only one Sensex stock ended higher while the rest 29 dropped.

The index opened higher and later rose by 375 points to touch a high of 59,510.92 in early trade amid positive Asian markets. However, bears gripped the markets and the index tanked over 1,400 points from the day's high to 58,094.55.

The NSE Nifty tanked 258.60 points or 1.49 per cent to end at a five-month low of 17,154.30, with 45 of its scrips ending in the red.

FM: E-rupee worth over ₹130 cr in circulation

Digital or e-rupee worth over Rs 130 crore is in circulation on a pilot basis as of February 28, finance minister Nirmala Sitharaman said on Monday.

The Reserve Bank of India (RBI) had launched pilots in digital rupee in the wholesale segment (e-W) on November 1, 2022 and in the retail segment (e-R) on December 1, 2022.

Nine banks, viz., State Bank of India, Bank of Baroda, Union Bank of India, HDFC Bank, ICICI Bank, Kotak Mahindra Bank, Yes Bank, IDFC First Bank and HSBC, have been participating in the digital rupee wholesale pilot, Sitharaman said.

"As on February 28, 2023, the total digital rupee - Retail (e-R) and digital rupee - wholesale (e-W) in circulation is Rs 4.14 crore and Rs 126.27 crore, a written reply in the Lok Sabha. The e-R is in the form of a

digital token that represents legal tender. It is being issued in the same denominations that paper currency and coins are currently issued. It is being distributed through financial intermediaries, i.E., banks. Users can transact with e-R through a digital wallet offered by the participating banks and stored on mobile phones/devices.

The e-pilot for retail segment was launched on December 1, 2022 in 5 select locations in closed user group for making Person to Person (P2P) and Person to Merchant (P2M) transactions. The onboarded merchants comprise various segments like tea vendors, fruit sellers, street side and sidewalk vendors (including migrant fruit vendors selling on pavement opposite RBI's head-

Sebi to auction 66 properties of Saradha Group

Auction on April 11 to recover investors' money

Markets regulator Sebi on Monday said it will auction 66 properties of Saradha Group on April 11 at a reserve price totalling Rs 32 crore to recover money raised by the firm from the public through illicit schemes

The properties to go under the hammer include land parcels located in West Bengal, the Securities and Exchange Board of India (Sebi) said in a

The regulator said that the e-auction will be conducted between 11 am and 1 pm on April 11, 2023. The total reserve price of these properties is pegged at about Rs 32

Sebi has engaged Quikr Realty to assist it in sale of the properties and appointed C1 India as the e-auction provider.

The development came after the Calcutta High Court passed an order in June 2022, whereby it directed Sebi to proceed with the auction of properties of Saradha Group of Companies. The entire exercise was directed to be completed within three months.

Saradha Group, a consortium of over 239 private companies, allegedly ran chit fund operations in West Bengal, Assam and Odisha and raised around Rs 4,000 crore from 1.7 million depositors before it collapsed in April 2013.

As per the notice, the reg-ulator said bidders should make their own independent enquiries regarding the encumbrances, litigations, attachments and acquisition of liabilities of the property put on auction, prior submitting their

"The purchaser shall participate in the e-auction on his own behalf and no third party intervention, like authorized agent/representative, would be permitted. The successful bidder shall bear the charges/ fee payable for transfer of the property in his/her name. All taxes shall be borne by the purchaser," the notice said.

In September 2022, the regulator said that it will auction 69 properties of Saradha Group of Companies on November 1 at a reserve price of Rs 30 crore.

Rupee falls 10 paise to close at 82.16 against **US** dollar

RBI may hike benchmark lending rates by 25 bps in April policy: DBS Research

¬he Reserve Bank is likely to I hike benchmark lending rates by 25 basis points in its bi-monthly policy next month to bring down inflation within the central bank's comfort zone, DBS Group Research said on Monday.

To contain the rising prices, the RBI has hiked interest rates by 250 basis points since May last year. The latest rate hike of 25 basis points in February took the benchmark policy rate to 6.50 per cent.

In an online session on 'Growth resilience and sticky inflation, DBS Group Research Executive Director & Senior Economist Radhika Rao said the RBI may hike interest rates by 25 basis points in April and maintain a hawkish bias as

retail inflation is still high. Retail inflation in January spiked to 6.52 per cent against 5.72 per cent in December last

Rao, however, said inflation caused by supply-side constraints cannot be dealt with by monetary policy alone and is not enough to tackle inflation.

"Weather conditions are important for farm output. The local weather agency has said in the next 3 months you could see high temperatures... The upcoming monsoon in June-July would be a crucial period. Weather...Would be important for inflation and farm output as the sector employs about 45 per cent of the population," Rao said. She said inflation is still on the higher end of the target.

The taxpayer can reply to the tax department giving explanation for the mismatch or can file updated returns if they feel the mismatch flagged in e-verification notice is correct.

In the club's first game after being charged with corruption by Spanish prosecutors, Barcelona shut out the noise and took another step towards their first title since 2019.

The Catalans secured their 19th clean sheet in 25 La Liga games this season as they held on to earn their ninth 1-0 win of the season, keeping second-

place Madrid at arm's length after the champions beat Espanyol on Saturday.

Medvedev rolls on at Indian Wells

Daniil Medvedev, no fan of the slow hard courts of Indian Wells, nevertheless came out on top in a back and forth battle with Ilya Ivashka on Sunday to push his ATP win streak to 16 matches.

Medvedev, the world number six who is coming off three straight titles at Rotterdam, Doha and Dubai, said his 6-2, 3-6, 6-1 third-round victory over 85th-ranked Ivashka was a "matter of a few points."

Medvedev lined up a fourth-round meeting with Germany's Alexander Zverev, the former world number two who is seeded 12th as he works his way back from the torn ankle ligaments that ended his 2022 campaign at the French Open. Zverev said he felt fortunate to come out with a 7-5. 1-6, 7-5 victory over Finland's Emil Ruusuvuori, who Zverev judged "the much better player" in the third set.

TSURENKO WITHDRAWS

Australian Open champion Aryna Sabalenka of Belarus reached the fourth round at Indian Wells by walkover on Sunday as Ukrainian qualifier Lesia Tsurenko pulled out of their scheduled match.

Organizers said Tsurenko cited "personal reasons" for yet another withdrawal.

No further details were given, and there was no indication that the Russian invasion of Ukraine last year - which has resulted in Russian and Belarussian tennis players from being barred from competing under their national flags was a factor.

Indeed, Tsurenko has now lost by retirement or walkover in nine of her 18 tournaments dating back to Indian Wells last

She gave up a semi-final walkover at Canberra this year and gave up quarter-final walkovers at Eastbourne and Portoroz, Slovenia, last year. Sabalenka, whose first

Grand Slam title in Melbourne was part of a perfect 13-0 start to the year that ended in the quarter-finals at Dubai, had breezed into the third round with a 6-2, 6-0 victory over Evgeniya Rodina.

She next faces former French Open winner Barbora Krejcikova, who ousted China's Wang Xinyu 6-2, 6-7 (1/7), 6-2. Krejcikova beat the top three players in the world on the way to the title in Dubai last month, climbing 14 places in the WTA rankings to 16th.

TSURENKO WITHDRAWS

American Jessica Pegula still finds it "weird" to think of herself as the world's number three player, but she doesn't feel any particular pressure to live up to the ranking. The American said her ability to compartmentalize keeps her focused on each match — just as it helps her take it point by point in the kind of comeback win she needed Sunday to reach the fourth round of the Indian Wells combined WTA and ATP Masters 1000 hard court tournament.

World C'ship due to visa issue

Having lost all hope of secur-ing an Indian visa to compete at the Women's Boxing World Championship, starting here on Wednesday, Kosova boxer Donjeta Sadiku has questioned International Boxing Association's (IBA) decision to grant the event's hosting rights to India. Uncertainty looms large over Sadiku's participation at IBA's flagship event since the Indian government is yet to grant her visa.

India does not recognise Kosovo — a disputed territory in South Eastern Europe. Sadiku said Kosovo's Sports Ministry is trying to get in touch with the Indian government but it seems she will have to miss the presti-

gious tournament yet again. This is not the first time Sadiku has faced such a situation. The 2022 lightweight World Championship bronze medallist boxer has been denied the Indian visa twice before, which led to her missing the 2018 women's World Championship in Delhi and the Youth Women's World Boxing Championships in Guwahati respec-

tively.
"I don't know why IBA allowed India to organise this championship, knowing that India didn't allow me participate there in the past."

"This is the third time that the India government is not allowing me to participate in world boxing championship.
I'm very disappointed, as I've trained very hard and I was very motivated to take a medal in

Indian shuttlers face uphill task in quest for All England glory

 $R^{\rm eturning\ from\ injuries\ and\ battling}_{\rm indifferent\ form,\ Indian\ shuttlers}$ will have to play out of their skins to end the country's agonising wait for a title at the All England Championships beginning here on Tuesday.

It has been 22 years since India won the coveted title when Pullela Gopichand (2001) followed the legendary Prakash Padukone (1980) to achieve the honour.

While Lakshya Sen came close to securing the crown when he reached the final in the last edition and Saina Nehwal was runners-up in the 2015 edition, other Indians, including twotime Olympic medallist PV Sindhu, couldn't go beyond the last-four in the prestigious event.

This time around, things will only be tougher as both Sen and Sindhu, since returning from a long injury layoff, had subdued starts to the new season, having made early exits in Malaysia and India Open.

World No. 12 Sen is coming into the event after a shock loss to world No. 41 Christo Popov of France in the first round of German Open, while Sindhu, in a desperate measure, has parted ways with Korea's Park Tae-sang a few weeks ahead of the event.

Sen will face "Mr. Consistent" Chou Tien Chen of Chinese Taipei, seeded fifth, while Sindhu will be up against tricky Chinese Zhang Yi Man,

who has a 1-1 record against her. The former world champion is expected to meet fifth seed He Bing Jiao of China if she crosses the opening hur-dle, while nemesis and third seed Tai Tzu Ying of Chinese Taipei could be her likely opponent in the quarters.

If there is one Indian who could be the dark horse, it is world No. 9 HS Prannoy, who has been consistent



and has registered some big wins against top players, the latest being Malaysia's world No. 4 Lee Zii Jia at the Badminton Asia Mixed team championship (BATC) in February.

Prannoy will open his campaign against Chinese Taipei's Wang Tzu Wei, while Kidambi Srikanth, who also has been struggling for some time, is pit-ted against France's Toma Junior

While none of the singles players are seeded this time, Satwiksairaj Rankireddy and Chirag Shetty will hope to live up to their sixth seeding, especially after their nemeses and first-round opponent Marcus Fernaldi Gideon and Kevin Sanjaya Sukamuljo of Indonesia pulled out at the last

INDIA QUALIFY FOR WTC FINAL, WIN B

n an uneventful day of cricket, India qualified for the World Test Championship (WTC) final and clinched the Border-Gavaskar Trophy for the fourth successive time after the fourth and final match against Australia ended in a drab draw, here on Monday.

India's spot in the WTC final against Australia was locked before the post-lunch session when Sri Lanka lost the Christchurch Test to New Zealand by two wickets as Kane Williamson's magnificent hundred steered his side to one of the most thrilling wins in Test

Australia were 175 for 2 in 78.1 overs in their second innings with a lead of 84 runs when the two teams agreed to settle for a draw. India have now beaten Australia by an identical 2-1 margin in the last four series -2017 (home), 2018-19 (away), 2020-21 (away) and now 2023 at home.

It was a 'Memorable Monday' for India as a country in both performing arts and sports with 'RRR's song 'Natu Natu' getting the Oscar for the best song and Elephant Whisperers winning the 'Best Documentary

By the afternoon, cricket added to the list of global accomplishments and now Rohit Sharma would love to break the decade-long ICC Trophy jinx.

DRAW WAS ONLY RESULT

With a featherbed of a track on offer, which former Australian opener Mark Waugh sarcastically said can host a "22-day Test match", an outcome favouring either side was almost impossible, with only two completed innings in four days

For Australia, it was important that their batters made the best use of the flat surface without being under pressure as they had already qualified for the WTC final. Travis Head (90 off 163 balls) will certainly put pressure on David Warner when he comes back while Marnus Labuschagne (63 not out, 213 balls) also did well.

The Indian team could feel chuffed after back-to-back WTC final qualification but head coach Rahul Dravid and captain Sharma would know well that Australia will be a different proposition in the final where the track will certainly not aid the

"We just qualified at lunchtime today. I wasn't counting my chickens before they hatched. We'll celebrate this for starters," Dravid said after the Test match.

"It is going to be a challenge. There's going to be a lot of logistics involved given the IPL final is only a week before the WTC final. We'll think about it.'

The WTC final will be played at The Oval in London from June 7-11, while the IPL ends on June 1.

Regarding the Test series against Australia, Dravid was most impressed by the Indian team's ability to fight back from extremely difficult situations.

"Whenever we were under pressure with our backs to the wall we had to respond and we always found that. It's one of the heartening things about coaching this team," Dravid told the official broadcaster

Star Sports.
"Rohit led the way in the first Test with a brilliant hundred and it was bookended by Virat Kohli's brilliant 186. In the middle we had performances from (Ravichandran) Ashwin, (Ravindra) Jadeja, Axar (Patel), Shubman there. I've probably missed out a few. I think our fight stood out."

India won the first two Tests in Nagpur and Delhi while Australia pulled one back in Indore as each of the first three matches of the series lasted two and half days on spiteful turning tracks.

But the pitch on offer for the seriesdeciding fourth Test was good for batting as Australia made full use of winning the toss to post a big total with centuries from Usman Khawaja (180) and Cameron Green

"The expectations that I have for myself as a player are more important to me," Kohli told the official broadcasters after being adjudged Player of the Match.

"I am not in a space now where I will go out and prove someone wrong. I also need to justify why I am there on the field," Kohli, who now has 75 international centuries,

"I think in Test cricket I wasn't able to play with my tempo and template that I have played with for the last 10years for awhile now. So that was the one thing I was trying to do. I felt like I was batting really well from the first innings in Nagpur. Kohli admitted he was

not in his own in the Test format so he had to apply himself harder. Kohli faced 364 balls in his knock of 186 and scored only 60 runs in boundaries.

It was a deliberate ploy as India had a batter short in their XI after Shreyas Iyer pulled out because of a back injury.

"We lost Shreyas to injury and were a batter short. So, we decided to play time. We focused on batting long.
"We focussed more on

batting as long as possible for the team. I did that for periods but not to the capability that I have done in the past.

"From that perspective I was disappointed but there was belief there that I was playing well and if I got an opportunity on a decent wicket then I can make a big one," he con-

🖊 ane Williamson was hailed As "world class" after New Zealand's record Test run-scorer orchestrated a dramatic lastball win over Sri Lanka on a rain-disrupted final day in Christchurch on Monday.

The thrilling triumph at the Hagley Oval scuppered Sri Lanka's chances of making the World Test Championship final, handing the spot to India.

In a helter-skelter finish,

the only Sri Lankans not guarding the boundary for most of the closing 10 overs were the bowler and wicketkeeper as New Zealand chased down their target of 285. Having lost eight wickets and on a day limited to 53 overs, skipper Tim Southee paid tribute to his star batsman William-

The former captain finished 121 not out and ran a bye

match in a remarkable conclusion, to go with New Zealand's one-run victory over England a fortnight ago. "Seeing how calm he is out in the middle keeps us calm as well," Southee said as New Zealand celebrated another famous, nail-biting win. "The guys were very trust-

ing in what he was going to do and alongside Daryl (Mitchell) for most of the day it was a great partnership that got us in that great position.

"He's a world-class player and world-class players are able to perform in different conditions." Visiting captain Dimuth Karunaratne said that fielding errors let his side down, particularly dropping the talisman Williamson on 33.

"We had a good chance to win, unfortunately we are the losing side," he said.
