India a Hindu Rashtra: RSS Virus on prowl; 150%

Hindu Rashtra is cultural concept, no law required for its validation, asserts Hosabale

RSS general secretary Dattatreya Hosabale on Tuesday said India is already a "Hindu Rashtra", which is a "cultural concept" that does not need to be established by the Constitution.

On the conclusion of the three-day meeting of Akhil Bhartiya Pratinidhi Sabha (ABPS) at Haryana's Panipat district, the RSS General Secretary also said the Sangh does not approve of "same sex marriage", saying marriage can only take place between per-

sons of opposite genders. He also criticised Congress leader Rahul Gandhi for his critical comments against

Indian democracy and said he should be speaking "more responsibly". "About Hindu Rashtra, we

have been saying for the last 100 years that it's a cultural concept, not theoretical," he said, while replying to a question on the issue at a Press conference

"State and nation are two different things. A State is that which is established by the Constitution. It is State power,"

"Nation is a cultural concept. Bharat is already a Hindu Rashtra. It doesn't need to be made a Hindu Rashtra (by law)," he added.

"We are already a Hindu

nation," he said conclusively. Claiming that many have tried to "distort" the history of India and Hindutya over the years, the RSS has resolved to speed up measures to bring a change in the narrative and restore the country's prestige.

He accepted that there are "some drawbacks in our society like untouchability."

On the same sex marriage, Hosabale said his organisation agrees with the Centre's view on same-sex marriage and maintained that marriage could only take place between persons of opposite genders.

No let-up in ruckus over

petitions seeking legal valuation of same-sex marriages, claiming they will cause a "complete havoc" with the delicate balance of personal laws and accepted societal values.

On Monday, the Supreme Court referred the pleas seeking legal validation of same-sex marriages to a five-judge con-

marriages to a five-judge con-stitution bench for adjudica-tion, saying it is a "very seminal issue'

The RSS General Secretary said that in Hindu way of life "marriage is a samskar not enjoyment or a contract where two individuals live together, establish family for betterment of the society and not for the self only.

On Rahul's critical and controversial comments abroad on the Indian democracy and the RSS, Hosabale recalled the imposition of emergency by the Congress when he said, "I and many others went to Jail", and questioned his ethical right to speak about Indian democracy.
The RSS leader also said

The Centre has opposed in the Supreme Court a batch of petitions seeking legal validathat while the Congress was speaking about weakening democracy in India, his own party has won in some States. Hosabale said the Congress leader should be expressing himself "more responsibly". "He is going by his agenda," he added and went on to say that Rahul's forefathers too had attacked the RSS.

In London, Rahul recent-ly had termed the RSS a "fundamentalist organisation" that has changed the nature of the democratic contest in India by capturing the country's insti-

On another question, the RSS leader said Sangh is not thinking of bringing women in the "Sakhas" where many sports activities are conducted

Hosabale said the RSS meeting discussed ways to bring "social harmony" as also need to bring "population imbalance" in the country.

By the centenary year in 2025 the RSS has set the aim of expanding 'Sakhas' to one lakh and preparations for that have begun, he said.

SC junks Govt plea for more aid to Bhopal gas survivors

PNS NEW DELHI

The Supreme Court on Tuesday dismissed dismissed Government's curative plea seeking an additional ₹7,844 crore from the Union Carbide Corporation's (UCC) successor firms like Dow Chemicals to extend higher compensation to the victims of the 1984 Bhopal gas tragedy that left over 3,000 people dead and caused environmental damage.

The apex court also slammed the Centre for not framing an insurance policy for the victims in terms of its undertaking given to the court earlier and termed it as "gross

negligence". "The responsibility was placed on the Union of India being a welfare State to make up for the deficiency and to take out relevant insurance policies. Surprisingly, we are informed that no such insurance policy was being taken out. This is gross negligence on the part of the Union of India and in breach of the directions issued by this court in review judgment. The Union cannot be negligent on this aspect and then seek a prayer to fix the responsibility on the UCC," the

A five-judge Constitution bench headed by Justice Sanjay Kishan Kaul said there was no rationale by the Centre to rake up the issue two decades after the settlement. The SC said ₹50 crore lying with the RBI for the victims shall be utilised by the Union of India to satisfy pending claims of victims. The bench said the Union of India's claim for a top up has no foundation of legal principle. "Either a settlement is valid



Stating that each village in the country has its own distinct and unique identity, a Parliamentary panel has come out with a unique proposal seeking setting up a National Culture University with its headquarters in Delhi and affiliated colleges in each State.

"Such educational institutions may also perform research work on Vedas, Upanishads and other historical texts and languages," said the panel headed by Rajya Sabha MP V Vijayasai Reddy in its report tabled in Parliament recently.

The panel also urged the Union Culture Ministry to explore "the viability of replication of the State of Unity model (in Gujarat) in other

lenges faced in cultural diplomacy efforts are language barriers, lack of awareness and understanding of Indian culture, and limited resources, India needs to address these issues by investing in language training programmes, cultural awareness campaigns, and increasing funding for cultural diplomacy initiatives, suggested the panel. In the past five years, the Ministry has spent ₹85.69 crore

Govt to give tabs, smart phones to 2 crore youths, says UP Minister

Uttar Pradesh government has made a provision of ₹3,600 crore in the budget for free distribution of tablets and smart phones to the youth of the state, Cabinet minister Nand Gopal Gupta said here on Tuesday. He said the Yogi Adityanath government is committed to distributing two crore tablets and smartphones to the youth since it retained power in 2022.

The minister also slammed previous non-BJP governments in the state of making tall claims and false promises ahead of elections but never fulfilling them, as he participated in a programme to distribute tablets and smartphones to 650 students at the Gautam Buddha University in Greater Noida.

"Chief Minister Yogi Adityanath has taken a historic decision to provide free tablets and smartphones to two crore youth of the state. A provision of Rs 3,600 crore has also been made in the annual budget.

"Other parties make tall claims and promises in elections, but after elections all the claims and all the promises go into cold storage. Our government does not make claims, it makes resolutions," Gupta said.

The 28-year-old pregnant woman who had suffered three miscarriages was crestfallen when she was informed about the heart condition of the foetus in her womb, doctors at the hospital said.

However, the woman was determined to continue with the pregnancy and agreed to allow the doctors carry out the procedure on the foetus' heart.

"A team of interventional cardiologists along with doctors from the Department of Obstetrics and Ġynaecology at AIIMS performed the procedure termed balloon dilation in the obstructed valve of the heart. Under the procedure which was performed under the guidance of ultrasound, a needle was inserted in the heart of the foetus and then using a balloon catheter, the obstructed valve was unclogged," a senior doctor said.

"The whole procedure had to be done very swiftly. It was very challenging. We managed to do it in around one-and-half minutes," the doctor said.

"With this reshaping procedure, hopefully the foetus' heart will develop better. Both the foetus and the mother are stable and are being monitored closely," the doctor added.

Others found guilty were Vijay Gokhle, the then managing director of UCIL, Kishore Kamdar, the then vice president, J N Mukund, the then works manager, S P Choudhary, the then production manager, K V Shetty, the then plant superintendent and SI Quereshi, the then production assistant. However, all the eight convicts were granted bail.

Delhi's power demand may peak to 8,100 MW

Delhis peak power demand may cross the 8000 megawatt (MW)- reaching up to 8100 megawatt (MW)-for the first time in late June or early July during this summer. Earlier, in 2021, Delhi's peak power demand had clocked 7323 MW, 6314 MW in 2020 and 7409 MW in 2020.

Delhi Power Minister Atishi reviewed the Delhi Governments "Summer Action Plan for uninterrupted power supply during the peak season on Tuesday. According to power discoms, peak power demand in BRPL area of South and West Delhi, which had clocked 3389 MW and 3118

2022 and 2021 respectively, is 2023. On the other hand, in expected to reach around 3570 BYPL area of East and Central

Delhi, the peak power demand, which had reached 1752 MW and 1656 MW during the summers of 2022 and 2021 respectively, is expected to touch around 1880 MW this year.

According to Bombay Suburban Electric Supply (BSES) officials, the discoms— BSES Rajdhani Power Limited (BRPL) and BSES Yamuna Power Limited (BYPL) — are geared-up to source adequate electricity to meet the power demand of over two crore residents in the city.

These arrangements include long term PPAs and banking arrangements with other states including Tamil Nadu, Kerala, Meghalaya, Himachal Pradesh, and will get up to 630 MW (BRPL upto 330 MW, BYPL upto 300 MW) of power through banking arrangements, officials said.

Additionally, BSES Rajdhani will also procure upto 500 MW through bilateral contract. In case of any unforeseeable contingency, BSES discoms will buy shortterm power from the exchange, depending on the time-slot. Adding to these efforts are

the advanced load-forecasting statistical and modeling techniques, which use Artificial Intelligence and Machine Learning to help the discom accurately forecast the power demand. Interestingly,

1500 megawatt will come from green energy which includes around 888 MW of solar power from Solar Energy Corporation of India (SECI), 486 MW of wind power, 40 MW from Waste-to Energy. BSES efforts in ensuring reliable power are also being helped by 130 MW + of roof-top solar installed on roof-tops in South, West, East and Central Delhi.

Delhis peak power demand had breached the 7000 MW for the first time – peaking at 7016 MW in 2018. This expected peak power demand of around 8100 MW is an increase of around 280% over the peak power demand of 2879 MW in 2002. In a related develop-Delhi Power Minister

Atishi reviewed the Delhi governments Summer Action Plan for uninterrupted power supply during the peak season on Tuesday. During the meeting, officials informed her that peak power demand may reach 8100 MW this year and they are well prepared to meet the increasing power demand in the com-

The meeting was attended by senior officials of the Power department and three DISCOMs, where officials briefed the newly appointed Power Minister about their preparation for the upcoming summer season.

Reviewing the plan, Atishi said that it is the Delhi governments priority to ensure uninterrupted 24x7 power supply during the peak summer season to the people of Delhi.
The Delhi government is

fully prepared to ensure that people get electricity without power cuts, even during the peak summer season. Like every year, we will follow the Zero Power Cut Policy this year too, she said.

Following the review, Atishi instructed the officials to tie up additional power with the power companies and ensure the maintenance and upgradation of power substations and power lines. This will help the government deal better during the peak load season and address the needs of peo-

Taking a serious note on I massive traffic jam, Delhi PWD Minister Atishi on Tuesday convened a meeting with senior department offi-cials to resolve the immense Delhi Flyover causing a lot of inconvenience in the prime south Delhi colony areas that serve as the main arterial road. The traffic restrictions on the newly commissioned Ashram-DND flyover extension also came up for discussion.

Atishi directed the officials to identify alternative ways to decongest the flyover as soon as possible and complete the maintenance within a

In this regard, she instructed the officials that daily reports be made available regarding the same. This will ensure a fast pace of work.

Maintenance work is going on at the Chirag Delhi flyover and a part of the flyover has been closed for the same. According to PWD officials, it will take nearly 50 days for them to complete the maintenance work. PWD is responsi-

After taking a right turn on Ring Road, they can go ahead from Moolchand via Lala Lajpat Rai Marg to GK or Nehru Place.

From the IIT flyover, commuters can go towards AIIMS via Aurobindo Marg. From there, reach Moolchand via Ring Road and take a right turn at the red light and go towards Nehru Place or Greater Kailash

From Nehru Place to AIIMS or Defence Colony commuters going from Nehru Place to IIT, AIIMS, Dhaula Kuan or Defense Colony, take right turn from under the Nehru Place flyover to Lala Lajpat Rai Marg and reach Defense Colony via Moolchand.

Take a left turn from Moolchand red light and go towards AIIMS and Dhaula Kuan via Ring Road. From AIIMS, take a right turn on Aurobindo Marg and go

Expedite desilting of 200 km sewer: LG to DJB fronts has been undertaken in

Delhi Lieutenant Governor VK Saxena on Tuesday directed the Delhi Jal Board (DJB) to expedite desilting of the entire 200 km length of trunk / peripheral sewer lines; desilting of 90 kms sewer lines to be completed by June, 2023. At the third High Level

Committee (HLC) chaired by the Lt Governor for the rejuvenation of Yamuna river, officials told that proper desilting of around 200 kilometres of Delhis sewer line network is the biggest challenge being faced in the cleaning of the Yamuna. The HLC was formed by the National Green Tribunal (NGT). While work on various

a time-bound manner with the goal of concrete achievements by June 30, when the NGT will take stock of the progress, the biggest "road block and challenge" being faced is the desilting of approximately 200 kilometres of trunk and peripheral sewer lines, according to an official statement."Gross inaction and neglect on the part of the Delhi Jal Board (DJB), which had not undertaken any desilting work for the past 8-10 years, had resulted in the sewer

lines getting choked. The sewer lines were choked up to 80-90 per cent with not only sewage but also boulders and municipal solid waste, the statement said. While 90.34 kilometres of sewer lines were projected to be cleaned by June, the remaining 110 kilometres were expected to be cleaned by September. The LG directed officials to take up the desilting work on a mission mode and complete it within the stipulated time frame, the statement said.

It was pointed out at the meeting that the level of pollution in the Yamuna on various perimeters has gone down in the last two-three months, especially due to interventions in the Najafgarh Drain, the statement added.

Addressing officers, the Lt. Governor said that, it was owed to the future generations that we handed over a clean Yamuna to them, a Yamuna that our forefathers had inherited.

Naxal violence fell 77% in 12 yrs: MHA

Union Home Ministry on Tuesday informed Lok Sabha that the Naxal violence in India has decreased by 77 per cent over the past 12 years and the number of deaths in related incidents has also reduced by 90 per cent during the same period.

Union Minister of State for Home Nityanand Rai said the geographical spread of Left Wing Extremism (LWE) related violence has significantly reduced and only 176 police stations of 45 districts reported related violence in 2022. In 2010, at least 465 police stations of 96 districts had reported LWE-related violence.

Replying to a written question, Rai said the number of LWE-related deaths (security forces and civilians) has reduced from an all-time high of 1005 in 2010 to just 98 in



2022. Minister said the decline in geographical spread of violence is also reflected in the reduced number of districts covered under the security related expenditure (SRE)

He said 126 districts were covered under the SRE scheme in 2010 but that number came down to 90 in April 2018 and further to 70 in July 2021. Rai said the security situation in Jharkhand has improved considerably and the existing secu-

India among top 10 most polluted countries in 2022: World Air Quality Report

India was ranked eighth on the list of most polluted country in 2022, dropping three places from the previous year, with Chad, Iraq, Pakistan, Bahrain, and Bangladesh being the five most polluted countries in the world.

Interestingly, as per Swiss firm IQAir in its 'World Air Quality Report", released on Tuesday, there are six Indian cities in the top 10, 14 in the top 20,39 in the top 50, and a staggering 65 in the top 100 up from 61 in the previous year.

In the list, Lahore in Pakistan and Hotan in China is the top most polluted cities followed by, Rajasthan's Bhiwadi is in third place and Delhi ranked fourth. According to report, Delhi's PM2.5 level is almost 20 times the safe limit.

Among the other metros, Kolkata is the most polluted after Delhi, but by a wide margin. Chennai is relatively the cleanest with pollution 'just' 5x the WHO's safe level. In fact, the only metros where pollution levels saw an uptick over the average since 2017 are Hyderabad and Bengaluru.

The annual average PM2.5 level, as per the World Health Organization (WHO) guidelines, should be $5 \mu g/m3$ or less but India's annual average PM2.5 level in 2022 was 53.3 μg/m3, more than 10 times the safe limit and only slightly lower than the 2021 average of 58.1. Rajasthan's Bhiwadi was the most polluted city in India, with annual PM2.5 levels of 92.7 µg/m3, and 60 percent of



Indian cities included in the report experienced at least seven times higher annual PM2.5 levels than the WHO guideline.

Delhi and New Delhi are both in the top 10, based on a new classification. The ranking is based on the level of PM 2.5, a pollutant closely tracked by scientists and health experts. The data from 131 countries is taken from over 30,000 ground-based monitors, either government or non-government operated.

As per the report, In India, the transportation sector causes 20-35 per cent of the PM2.5 pollution while other sources of pollution are industrial units, coal-fired power plants and biomass burning.

Delhi has so far been the most polluted capital in the world and the report made a distinction between 'greater' Delhi and New Delhi capital. Both are in the top 10 and the infamous distinction of being the world's most polluted capital goes to Chad's N'Djamena. National Capital's peripherals-· Noida, Ghaziabad, Gurugram and Faridabad have seen a decline in pollution levels.

IAF to open 39 military airports, 9 landing grounds for civilians

s domestic air travelers As dollieste all trending upwards after the COVID pandemic, the Indian Air Force (IAF) has decided to open up 39 military airports and nine advance landing grounds for civil usage. The move will help to enhance the connectivity to far-flung areas considered as remote for civilian usage but also help to promote tourism.

"Towards the common good envisaged by enhanced regional connectivity, the #IAF has earmarked 39 military airfields and 9 Advance Ldg Grounds for use by civil aircraft. This Joint User Airfield scheme now gives access to areas that were earlier considered remote," said IAF in a tweet on Tuesday.

According to officials, the AAI will utilise these IAF airfields to operate civil flights under the RCS UDAN scheme. The MoD is handing over approximately 40 acres of land for development of civil terminals and necessary airfield infrastructure for commencing



RCS flights, said the MoD. As many as 23 airports regularly used by civil airlines, are IAF or Navy bases.

Landing in Pune, Goa, Srinagar or Chandigarh, even frequent fliers seldom realise they are at a military base, even if they notice IAF fighters parked at a distance. Their plane parks in what

is called a "civil enclave", where passenger facilities like checkin counters and baggage collection are located.

Earlier in June last year, the IAF announced that seven more military airports would increase their contribution to civil aviation by giving working assistance and land to the Airports Authority of India

Accordingly, the IAF provided permission and handed over the defense land operated by the Ministry of Defence to the Airports Authority of India (AAI) at seven locations in Bagdogra, Darbhanga, Adampur, Utarlai, Sarsawa, Kanpur, and Gorakhpur.

With international air travel to and from India on a path of swift recovery, Indian carriers are cashing in, expanding their collective market share by passengers — to a sevenyear high, shows an analysis of data for the December quarter (October-December 2022), released by the Directorate General of Civil Aviation (DGCA).

The cumulative market share of Indian carriers by passengers carried on international flights was 43.5 per cent in October-December 2022 up from 39.2 per cent in the corresponding period of 2019, the last full quarter of regular operations before Covid froze the aviation industry.

Lakhimpur violence: SC asks Sessions Judge to apprise it of future developments in trial

The Supreme Court on 1 Tuesday said the trial in the 2021 Lakhimpur Kheri violence case, in which Union Minister Ajay Kumar Mishra's son Ashish is among those facing prosecution, is not "slow paced" and directed the concerned sessions judge to keep apprising it about the future developments of the trial.

The Bench of Justices Surya Kant and J K Maheshwari observed though it is not monitoring the trial but it is having an "indirect supervision" on it.

A Bench said the interim direction contained in its January 25 order, by which it had granted eight-week interim bail to Ashish Mishra in the case, shall continue to operate. Advocate Prashant Bhushan,



representing the victim families, told the Bench that about 200 prosecution witnesses have to be examined and he is concerned about the "slow pace of the trial".

The trial is not slow paced. We have received three letters from the trial judge," the bench observed, adding it had gone through the contents of the letters received from the First Additional District and Sessions Judge, Lakhimpur Kheri. The top court said as per the letters, examination of three

witnesses is over while crossexamination of one of them is going on. "We are not using the word monitoring but we are having indirect supervision on the trial and we will do that," it said, adding, "Let us continue with the same status for some more time."

On October 3, 2021, eight people were killed in Lakhimpur Kheri district's Tikunia after violence erupted when farmers were protesting against the then Deputy Chief Minister Keshav Prasad Maurva's visit to the area.

According to the Uttar Pradesh Police FIR, four farmers were mowed down by an SUV in which Ashish Mishra

was seated. Following incident, the driver of SUV and two BJP workers were allegedly lynched by angry farmers. A journalist also died inviolence.

 \mathbf{I} t's three years since the Covid-19 swept the world, but new signs of medical problems due to the virus continue to emerge with a team of researchers in a latest study now saying that the infection can cause "prosopagnosia," also known as face blindness i.e. difficulty in recognising faces and navigational problems.
The study, published in

the journal Cortex, is the first to report "prosopagnosia," following symptoms consistent with a range of neurological problems. Normally, Prosopagnosia can result from stroke, traumatic brain injury



erative diseases. Some cases are congenital or present at birth, in the absence of any brain damage. However, the researchers at the Dartmouth College in the US study has found that if Covid can cause a range of neurological problems, including the loss of

ments in attention, memory speech, and language, known as 'brain fog", it can also cause face blindness. The researchers happened to investigate the case of a 28-year-old Annie, a customer service representative and a part-time portrait artist. They noted that Annie, who

was diagnosed with Covid in March 2020 and suffered a symptom relapse two months later, was having difficulty with face recognition and navigation. "When I first met Annie, she told me that she was unable to recognise the faces of her family," said lead author Marie-Luise Kieseler, a graduate student in the department of psychological and brain sciences and member of the Social Perception Lab at Dartmouth. Annie now relies on voices to recognise people that she

knows. She also experienced

ooking defensive and anx-Lious as never before, Bengal Chief Minister Mamata Banerjee on Tuesday nearly broke down in a Government programme and begged reprieve for those thousands of people who had illegally obtained jobs in lieu of cash in Government schools and were getting the pink slip in hordes following High Court (HC) orders.

Boy dies in borewell; 9-hr rescue op futile

Relief to Govt

The SC verdict in the review of Bhopal gas case has gone against Govt, but it has brought the much-needed closure


The Supreme Court's verdict on the petition seeking more compensation from Union Carbide for the 1984 Bhopal Gas Case may be seen as a setback for the Centre, but in reality it is a much-needed closure to the huge human tragedy in India. The fact that it took almost four decades to reach a closure speaks volumes about not just the infamously tardy pace of the judicial process but also the institutionalised anti-business narrative and Leftist biases of public discourse. The SC pointed out that a settlement can be set aside in cases where it is vitiated by fraud. But "no such fraud has been pleaded by the Union of India. And their only contention relates to a number of victims, injuries caused... not contemplated at the time the settlement was affected." Much has been said and written about the criminal negligence by Union Carbide that resulted in the gas leak which killed thousands of people and adversely affected the health



of tens of thousands. The criticism is much deserved. Had the bosses of the American multinational corporation behaved responsibly, the tragedy could have been averted. In June 2010, a Bhopal court convicted all the eight accused guilty under Sections 304-A (causing death by negligence), 304-II (culpable homicide not amounting to murder), 336, 337 and 338 (gross negligence) of the Indian Penal Code. Chairman Warren Anderson escaped; his escape is still shrouded in controversy. But the eight persons who were convicted included former Union Carbide chairman Keshub Mahindra, managing director Vijay Gokhle, vice-president Kishore Kamdar, works manager JN Mukund, production manager SP Choudhary, plant superintendent

KV Shetty, and production assistant SI Quershi. But what about the culpability of the politicians and bureaucrats who didn't enforce safety precautions on Union Carbide?

It is instructive to note that the Manmohan Singh government, which was forced to follow the agenda of Left-leaning activists, had set up a ministerial panel in the wake of the verdict. These activists and others appear to speak for the poor, victims of the system, etc., but their ulterior motive is a persistent jihad against businesses, especially foreign companies. Unsurprisingly, the Congress-led and Left-inspired United Progressive Alliance government demanded not action against the guilty government officials concerned but the extradition of Anderson. It wanted the case to be reopened and Union Carbide's successor companies made to pay an additional Rs 7,844 crore to the victims since, it argued, the scale of damage to human lives and the environment could not be estimated properly at the time of the settlement in 1989. The constitutional Bench of the apex court rightly said, "If it is reopened, then it may open a Pandora's Box and will be detrimental to the claimants." The review petition by the UPA regime was a painful legacy for the Modi Government, just like retrospective taxation. Thankfully, the SC has removed it.

AAP Govt pushing Punjab into debt



Punjab Budget fails to stem the state's slide to financial bankruptcy

he Aam Aadmi Party (AAP) came to power in Punjab by promising the moon to the people. The Arvind Kejriwal-Îed political outfit has earned the tag of a party of freebies from economic commentators. The Punjab Budget presented by Finance Minister Harpal Singh Cheema fails to stem the slide of the state to financial bankruptcy.

Cheema has tried his best to play to the gallery by proposing a budget of Rs 196,462 crores while stating that it's 26 more than Rs 1,55,869 crores in the financial year 2022-23. The proposed expenditure expansion is not backed by revenue growth. The AAP-led government is further pushing Punjab into debt through increased borrowing. Punjab is already deep into debt. The Reserve Bank of India in its report on the state of the financial health of a few states has expressed concerns about the prevailing situations.

This is captured in the official data, as the revenue deficit has spiked from 1.99 per cent in 2022-23 to 3.32 per cent. Consequently, the fiscal deficit has zoomed from 3.78 per cent in 2022-23 to 4.98 per cent proposed for the 2023-24 fiscal. The situation has further aggravated the financial situation of Punjab, as the Goods and Services Tax (GST) collections remained at Rs 19,000 crore against a target of Rs 20,550 crore in the current fiscal. This accounts for a shortfall of Rs

Punjab is yet to come out with an industrial policy as promised by the AAP government even while industrialists are visiting Uttar Pradesh and other states in search of alternative investment opportunities. Economic activities seek peace and tranquillity as a precondition. But the Punjab government's evident neglect of the law-and-order situation is making a negative impact on economic activities. This has been

documented by the state Budget. Against the target by the state government of Rs 95,378 crores in revenue receipts, Punjab could manage just a net of Rs 93,563.21 crores. This is being bridged by additional borrowings. The Central government has already flagged that Punjab's debt situation is worrisome. Independent economists have for years been calling for corrective measures. But the incumbent Punjab government is paying the least regard to the well-being of the future generations of Punjab by pushing the state further into a debt trap.

The ability of state agencies to collect revenue is under severe stress. This can be seen in the performance of the transport department. Punjab Roadways could earn only Rs 90 crores against a target of Rs 335 crores set by the state government. Similarly, urban development revenue is also short by Rs 69 crore as the government could collect only Rs 200 crore.

Already, the youth in Punjab are battling an extraordinary unemployment situation, making them vulnerable to falling victim to drug cartels and organized armed gangs.

This is being reflected in the state of education as the state against the promise of enhancing 100 schools to the status of institutions of eminence has just added 13 more numbers, while the actual world could take place only in the case of four schools in the last year. It must be stressed that the AAP is running the government in Punjab now for almost one year.

On the health front, the attempts to be ciever by repackaging the Central gov-ernment's 'Ayushman Bharat Health and Wellness Centres' into 'Mohalla Clinics'. The

state government is just trying to be clever to misguide the people in the state. The status of Punjab being a debt-laden state has begun showing the impact on several fronts. The state is not able to modernize the police. The organized armed gangs are equipped with automatic assault rifles. The police step back from the gangs whose writ run large in the

In a survey of 30.46 lakh beneficiaries in Punjab conducted by the Department of Social Security, Women and Child Development, it was found that the number of beneficiaries dipped by a whopping 90,248. The state government failed to undertake the construction of houses for the economically weaker sections last year. But that has not stopped the AAP government from making a promise to build 10,000 houses in this fiscal. The performance of the state government on environmental management, solid waste management and several Punjab Budget has made other areas remains abysmal, making the state cut a sorry figure on the national stage.

University Grants Commission (UGC) has launched a policy framework- "Mulya Pravah -Guidelines for Inculcation of Human values Professional Ethics in Higher Educational Institutions". It emphasizes that stakeholders of an institution, be they faculty, students, administrators or others, should be guided by the core values like integrity, dedication, trusteeship, sustainability, inclusiveness, commitment, respectfulness, harmony and belongingness.

Moreover, education is a subject in the concurrent list of the Constitution and the majority of schools are under

iurisdiction State/Union Territory (UT) Governments, it is for the respective State/ UT government to take appropriate action to impart the moral education to the students of their schools.

The ministry had constituted a committee under the chairmanship of Prof. H.R. Nagendra on 15th January 2016 for making recommendations on Yoga Education in Universities to give the students a calming feeling while studying. The committee submitted its report in April 2016 and prescribed a curriculum for Yoga courses in its recommendations.

The University Grants Commission (UGC) has informed that it has recognized the studies in Yoga at the Graduation and Post Graduation levels. The UGC has also introduced Yoga as a new National Eligibility Test (NET) subject from January 2017 UGC-NET onwards. Further, as per the All India Survey on Higher Education (AISHE) Portal 2019-20, 131 Universities are offering Yoga related courses.

Ith digital infrastructure continually developing in the healthcare space in the country, there has been an accompanying need to train the healthcare workforce adequately. Digital training of healthcare professionals has become increasingly important in recent years as the world strives towards achieving sustainable development goals.

The United Nations Sustainable Development Goals (SDGs) were established in 2015 as a universal call to action to ensure healthy lives and promote well-being for all at all ages, end poverty, protect the planet, and ensure peace and prosperity. Digital training can play a significant role in reducing the skill gap. Courses like Basic Life Support (BLS) comprising Cardiopulmonary Resuscitation (CPR) and related programs like Advanced Cardiovascular Life Support (ACLS) and Pediatric Advanced Life Support (PALS) can prepare healthcare professionals at all levels.

The lack of standardized healthcare practices hampers the objective of achieving SDGs which can lead to disparities in care and negative health outcomes. Digital training can provide healthcare professionals with a consistent, evidence-based approach to patient care. Investing in digital training programs for healthcare professionals can help to ensure that the SDGs are met and we are on track towards achieving our goals.

RBI's fresh approach 1s promising

RBI is now making economic policies that are based on domestic realities. It is no longer towing the policies of central banks in the West



he US has once more bailed out a failed bank. Silicon Valley Bank (SVB) had about \$209 billion in assets. It was hailed as one of the best US banks. The California-based financial institution was known as a new-age banking institution with high technology quotient. Over a period, SVB drove the startups to dizzying heights with ease of access to funds, enabling venture capitalists to ride the bandwagon of a fastfaced capitalist play to chase the topline.

In 14 years, the US had to bail out another banking institution. The SVB collapse is stated to be the second biggest in US banking history and the first major collapse after the Lehman Brothers went broke. The principal reason for the SVB collapse is cited as the rush of the depositors to withdraw their money. The SVB had to sell its bonds at heavy discounts after taking major haircuts. The SVB collapse is linked to the rate hikes

The US Federal Reserve remains hawkish. The rate hikes have been gressive, and the peak rate is now threatening to top six per cent in the US. The commentaries coming from the US Federal Reserve give hints of a long string of hikes in the next few months. The high rate regime makes the financial institutions vulnerable as the gaps between the deposit and lending rates become narrow while reducing margins for the banks to stay healthy.

Israel's Prime Minister Benjamin Netanyahu has moved fast to check on the likely impact on the startups. Israel is a global startup leader. Union Minister for IT and Electronics Rajeev Chandrashekhar has also said that he would take stock of the potential exposure of the Indian startup ecosystem to the failed SVB. Over time, we will know the full extent of the impact on the world economy and also India about the failure of the SVB to survive the rate hike spiral in the US.

In India, the immediate memory of a banking institution going broke is of the Yes Bank. The Reserve Bank of India and

the government worked in tandem to stabilize the situation. The State Bank of India had stepped into the situation with equity and capital infusion to instil confidence among the customers of Yes Bank. Within a short period, Yes Bank is now looking healthy and is on the path to normalcy. But the Yes Bank had gone broke for reasons not associated with the

SVB collapse.

The Indian parliament stepped in to establish a robust financial market regulatory architecture to build an ecosystem to ensure that there are no lapses on the part of the board of management to compromise on the banking principles. Satisfactorily, no banking institution after the Yes Bank has shown signs of distress even while there had been a few cases of the cooperatives. With the unveiling of the Ministry of Cooperatives and measures of the RBI, rural banking is also largely now in safe nands.

But it's worthwhile to examine and study if the monetary policy of India is indeed coming out with the right recipe to deal with the macroeconomic challenges faced by the country. The RBI is mandated by parliament to manage inflation. Under the amended law, the RBI is also mandated to ensure that inflation stays in a range, and the Central Bank is liable to inform parliament if the ceiling is breached for three successive months.

But the last two sessions of parliament didn't show any signs of the lawmakers being worried about the ability of the RBI to manage inflation within the mandated range. Winter and the first half of the budget sessions of parliament were largely washed out on account of the ruckus in the two Houses.

offer empirical evidence that its stance of hiking rates is working to cool down inflation. There is ample evidence for a contrarian position that the monetary policy obsessed with hiking rates doesn't work. Some of the leading economic thinkers the world over have warned that the Central banks globally by sticking to their singular obsession to hike rates would take the people into a long spell of recession.

Europe is already in the grip of a recession. The US is almost at the stage of recession. India is the only economy growing at about seven per cent. China sunk to a three per cent growth rate. Can India afford to arrest its growth rate by squeezing out capital for businesses?

It's also worthwhile to ask why the RBI is part of the global herd mentality of the Central banks. Aren't the people who constitute the RBI monetary policy committee (MPC) still holding close to their hearts the 19th-century economic worldviews? Are the MPC members really on board with the government's resolve for a selfreliant India? Empirically, answers appear to be disappointing.

Medium and small enterprises (MSMEs) are facing the heat of capital inadequacy. Debt servicing is robbing them of their working capital. The appetite to take a fresh working capital loan is fast reducing. India certainly doesn't have the comfort of the developed world to compromise its growth prospects by blindly following the S Federal Reserve.

The old mindset among the people was to save for the future. Today's mindset is to spend and enjoy life. Unlike the popularity of the national savings schemes, Kisan Vikas Patra of the last century, the equity market, pension It's pertinent to ask the RBI to funds, and mutual funds are now

popular among most of the people in the country. The RBY MPC actions are completely opposed to the new-age investment and savings mantra of the people, which are also being encouraged by the new income tax regime. The RBI needs urgently to smell changes and breathe fresh air. The tightening of mon-etary policy is a surefooted recipe to arrest Indian growth. India's demographic dividend prospects

may stand compromised.

The US and the developed world are guilty of taking the easy route to deal with the Covid-19 pandemic. They resorted to printing money. They flooded their markets with cash. India treated the path of reason and maturity. We didn't print cash. We insulated the vulnerable from the risks of the pandemic with schemes such as the Pradhan Mantri Garib Kalyan Anna Yojna. We came out with production-linked incentive (PLI) schemes to give a new direction to the economy. When we didn't copy the developed world in dealing with the economic consequences of the Covid-19 pandemic, why should we toe the line of their Central banks by raising the policy rates?

Now that the MPC of the RBI is now showing signs of an independent economic worldview it's incumbent upon parliament to discuss issues threadbare. Parliament must ponder why India lacks a 25-year plan for policy rates. Not only the small and marginal industries but also the middle class must be protected from the high-interest rate regime, which has already burdened them with high EMIs. The RBI MPC must not remain static in their ways. The world is changing fast. We must embrace agility. Smell the change, RBI!

The Radio Festival included radio practitioners from all three sectors viz All India Radio (AIR), Commercial and Community Radios covering plenary, panel discussions and dialogues on various development issues. One

The Radio Festival was 'Preserving culture: Folk Music and Indigenous Languages'.

Community radios are more localized than AIR and Commercial Radios. They enable communities to become both producers and listeners of their content, generating programming that is more specific and relevant to the needs and interests of communities. Community radio is a significant medium because it functions as a dynamic archive of the cultural traditions of communities. It provides a platform for local artists to showcase their talent and promote and preserves local languages and indigenous traditions. In our world of pervasive globalised

of the important themes of knowledge systems, community radio stations, embedded in the cultural landscape of the communities in which they operate, offer meaningful, localised ways of heritage conservation.

Garhwal, comprising seven districts of Uttrakhand, is known for its rich and diverse cultural traditions. In most villages, folk music traditions such as jagar (an all-night-long ritual performance accompanied by dhol damaun (used collectively, they are drums made from copper, wood and animal hide) and daunri thaali (a plate-like percussion instrument]), Bagadwali (a folk music tradition which chronicles the story of a local hero, Jeetu Bagadwal) and Pandwali (the music that er audience.

accompanies Pandav Nritya, a dance based on the story of Pandavas

Mahabharata) are kept alive by dedicated artistes from the community. Despite possessing a lot of talent, due to economic constraints and lack of exposure, the local artistes were unable to reach out to an audience beyond their immediate community. This void was filled up by Mandakini ki Aawaz, which emerged as the first operational community radio from the Rudraprayag district. Since its inception, Mandakini ki Awaaz was driven by the desire to give Garhwali artists, musicians and performers a platform that was easily accessible and one that would help them reach out to a larg-

Madhuri and many more artists like her in different parts of the country are the perfect examples of the roles played by community radios in nurturing local talent.
An avid singer, Madhuri

was encouraged by communitv members to record something. She sang a few Garhwali songs. Her voice became popular among listeners in the radio's listenership area within a short span, transforming the young 13-year-old into a popular singer. Another artiste who could reach a wider audience through the radio station is Bhagirath Negi, a Bagadwali

Despite his talent, he was not known outside his village. He got an opportunity of recording a few Bagadwali songs which were broadcast on Mandakini ki Awaaz, after which he was invited to other villages to give performances. Now, he not only performs his music but also helps community members to organise Bagadwali performances.

For most of the operational community radios, the prohibitive fees are a deterrent to playing copyrighted music. However, this disadvantage has fostered a symbiotic relationship between local artists and the station: while the station relies on community members for producing content, local artists have an accessible broadcast medium that foregrounds their skills

Imran tells party to continue struggle even if he is killed

In the video message, Khan urged his supporters to come out for real freedom as police arrived to arrest him. "They think that after my arrest, the nation will fall asleep. You have to prove them wrong," 70-year-old Khan said in the video.

"God has given me everything, and I am fighting this battle for you. I have been fighting this battle all my life, and I will continue to do so," he said.

"If something happens to me and I am sent to jail or if I am killed, you have to prove that you will struggle without Imran Khan and not accept the slavery of these thieves and of the one person who has been making decisions for the country," he

Meanwhile, the party's deputy leader Shah Mahmood Qureshi said that the PTI leadership is ready to find out a "possible way out" to avert bloodshed. "Show me the warrant. I will first read and understand it. Then, I will speak to Imran Khan and my lawyers," he told the police.

Khan's party moved the Islamabad High Court against the arrest warrants issued in the Toshakhana case. Islamabad High Court Chief Justice Aamer Farooq fixed the hearing for Wednesday while rejecting the party's request to conduct the hearing today. The plea has been fixed for hearing tomorrow (March 15) despite the objections raised by the registrar's office, Khan's lawyer Ali Bukhari

Interior Minister Rana Sanaullah, however, said that officials would arrest Khan in accordance with the court's directives and produce him in court. The official Twitter handle of the party earlier urged supporters and workers to gather outside the residence and 'remain peaceful'. A large number of PTI workers equipped with clubs and sticks were present outside Khan's residence to resist the police action. The police blocked all roads leading to the house of the PTI chairman by placing containers and riot personnel took positions to launch the operation.

Maryam: IMF treating Pak like a colony

"Because of this today we are begging for Rs 1 billion," the 49-year-old leader said. She drew the comparison of her father Nawaz Sharif's government with that of Khan, saying the cricketer-turned-politician was "launched to destroy the country".

Maryam, who is the daughter of former Pakistan prime minister Nawaz Sharif, has launched several attacks on Khan for selling off gifts presented to him when he was the prime minister and has accused him of pushing Pakistan to the brink of default.

She also said Imran should be arrested. "Why is he hiding behind the party workers? He again wants to become the prime minister. I ask what he has done that they make him

Russian missile hits Ukrainian apartment building; 1 killed

A Russian missile struck an apartment building in the centre of Kramatorsk on Tuesday, killing at least one person and wounding seven others in one of Ukraine's major city strongholds in its eastern Donetsk region as it fights against Moscow's invasion, officials said. President Volodymyr Zelenskyy posted a video showing gaping holes in the facade of the low-rise building that bore the brunt of the strike. The Ukrainian general prosecutor's office and regional Gov. Pavlo Kyrylenko also reported on the attack, posting photos of the building with mounds of rubble in front of it. The impact damaged nine apartment blocks, a kindergarten, a local bank branch and two cars, Kyrylenko said. The war, which erupted after Russia's launched its full-scale invasion in February 2022, has brought

Tuesday's victims were among at least seven civilians killed and 30 wounded in 24 hours, Ukraine authorities said. They included a 55-year-old woman killed when a Russian shell hit her car Tuesday in a border town in northeastern Ukraine. "Russian troops are striking residential buildings, schools and hospitals, leaving cities on fire and in ruins," Kyrylenko, the regional governor, said on Ukrainian television.

"The Russians mark each metre (yard) of their advance in the region not only with their own blood, but also with the (lost) lives of civilians." Kramatorsk houses the local Ukrainian army headquarters. Ukrainian authorities say it has been regularly targeted by Russian shelling and other attacks in the past.

A missile strike on the city's train station last April, which Kyiv and much of the

blamed on Moscow, killed several dozen people and wounded more than 100.

Russia had welcomed a Chinese peace proposal to end the fighting, but Kremlin spokesman Dmitry Peskov said Tuesday that Kyiv's refusal to have talks leaves Moscow with only military options. Beijing has said it has a "no limits friendship" with Russia and has refused to criticize Moscow's invasion, or even refer to it as an invasion. "We must achieve our goals," Peskov told reporters.

Meta to lay off another 10k staff

Racebook-parent Meta on Tuesday said it will lay off another 10,000 workers and will not fill another 5,000 positions, announcing the second round of significant job cuts by the tech major in four months. The latest move comes after Meta slashed approximately 13 per cent of its workforce, or 11,000 jobs in November last year, in the single largest round of cuts in the company's history.

In a Facebook post on Tuesday, CEO Zuckerberg said the job cuts will take place "over the next couple of months." "We expect to announce restructurings and layoffs in our tech groups in late April, and then our business groups in late May," he wrote. In a "small number of cases, it may take through the end of the year to complete these changes," he said. The grim news for the tech indus-try came days after the Silicon Valley Bank, which catered to start-ups, collapsed. "Overall, we expect to reduce our team size by around 10,000 people and to close around 5,000 additional open roles that we haven't yet hired," Zuckerberg

As of September 2022, 87,314, per a securities filings. With 11,000 job cuts announced in November and the 10,000 announced on Tuesday, it would bring the firm's headcount down to around 66,000, according to

Meta is among the big tech companies to undergo layoffs amid higher inflation, recession fears and pandemic-induced demand. Earlier this year, Amazon, Google-parent Alphabet and Microsoft have announced major job cuts impacting tens of thousands of tech workers across the globe. Shares of Meta rose more than 6 per cent in early trading on Tuesday following the announcement.

UK Govt's aid watchdog critical of 'fragmented' approach to India funds

The UK government's independent aid watchdog on Tuesday delivered a strong critique of the country's "fragmented" approach to the development assistance for India over recent years, which between 2016 and 2021 and makes India a "substantial recipient" of bilateral aid.

Independent Commission on Aid Impact (ICAI), which is tasked with the scrutiny of the UK government's official aid to countries, notes in its India Country Portfolio Review that it would be a surprise to many to see UK aid to India continuing at a high level despite a shift in the relationship in 2015 – in keeping with the Indian government's preference for a partnership of equals, rather than a traditional donor-recipient relationship. According to the ICAI assessment, India remains the largest recipient of UK development investment in

"The UK's aid to India is now very different to that provided a decade ago. The UK no longer offers financial supdoes it fund direct poverty reduction interventions in the

Hate crime in US increased by 12 per cent in 2021: Report

Hate crimes in the US increased by about 12 per cent in 2021, the Federal Bureau of Investigation (FBI) has said, highlighting that 64.5 per cent of victims were targeted because of race or ancestry In an update of its annual

report issued on Monday, the FBI also said that 43.2 per cent of the total crimes recorded were related to intimidation. "Nationally, reported hate

crime incidents increased 11.6 per cent from 8,120 in 2020 to 9,065 in 2021," the FBI said, adding that the updated dataset for 2021 includes all law enforcement agency hate crime incident reporting

The updated hate crime dataset reports involve 10,840 incidents and 12,411 related offences. Over 10,500 singlebias incidents involved 12,411 victims, the report said. A per cent distribution of victims by



bias type shows that 64.5 per cent of victims were targeted because of the offenders' race/ethnicity/ancestry bias, 15.9 per cent were targeted because of offenders' sexualorientation bias and 14.1 per cent were targeted because of the offenders' religious bias, the report said. There were 310 multiple-bias hate crime incidents that involved 411 victims. Of the 8,327 hate crime offences classified as crimes against persons in the updated

2021 dataset, 43.2 per cent were intimidation, 35.5 per cent were simple assault, and 20.1 per cent were aggravated assault. Nineteen rapes and 18 murders were reported as hate crimes. The remaining 70 hate crime offences classified as crimes against persons were reported in the category of other. Of the 3,817 hate crime offences classified as crimes against property, 71.2 per cent were acts of destruction/damage/vandalism, it said.

Murugan's novel 'Pyre' longlisted for Booker Prize

Indian author Perumal **▲** Murugan's Tamil novel 'Pyre' is among 13 books from across Asia, Africa, Europe and Latin America to make it to the longlist of the International Booker Prize 2023, announced by the Booker Prize Foundation here on Tuesday.


Murugan, 56, makes it to the prestigious list with his 2016 book "Pyre", translated from Tamil by Aniruddhan Vasudevan, becoming the first Tamil writer to make it to the longlist of 13 works.

"Pyre", tells the tale of an intercaste couple who elope, setting in motion a story of terrifying foreboding. The coveted literary prize, won last year by Geetanjali Shree and translator Daisy Rockwell for the first-ever Hindi novel 'Tomb of Sand', is awarded annually for a work of fiction written originally in any language, translated into English and published in the UK or Ireland. The GBP 50,000 prize money is shared between the writer and translator of the winning work, which will be declared this year on May 23. Murugan, based in Salem in Tamil Nadu, described "Pyre' as a very important book of his. "Just a few minutes back someone broke the news to me. I am very happy, and this is a great acceptance of my writing... 'Pyre' deals with honour killing. Honour killing is a very big problem in our country, I hope more people get to know about this issue after this recognition," Murugan told PTI over the

The Tamil Nadu-born author, scholar and poet has written 10 novels, five collections of short stories and four anthologies of poetry. He won the Sahitya Akademi's Translation Prize for his novel 'Madhorubhagan', translated by Vasudevan as 'One Part Woman'. "Perumal Murugan is a great anatomist of power and, in particular, of the deep, deforming rot of caste hatred and violence. With flashes of fable, his novel tells a story specific and universal: how flammable are fear and the distrust of others," Booker's prize judging panel noted.

US, UK, Australia agree on nuclear submarine project

Bid to counter China's aggressive behaviour

The United States, Australia and the United Kingdom have announced a nuclear-powered submarine deal, a step aimed at countering the Chinese aggressive behaviour in the resource-rich Indo-Pacific region and ensuring that the region remains "free and open." Under the Aukus agreement, Australia will first receive at least three nuclear-powered submarines from the US.

The announcement was made after US President Joe Biden, UK Prime Minister Rishi Sunak and Australian Prime Minister Anthony Albanese attended a summit meeting in San Diego on Monday and asserted that the move is to keep the Indo-Pacific region "free and open." "With the support and approval of the Congress, beginning in the early 2030s, the United States will sell three Virginia-class submarines to Australia with the potential to sell up to two more if needed, jumpstarting their undersea capability a decade earlier than many predicted," Biden said in the presence of Australian Prime Minister Albanese and British Prime Minister Sunak. As part of the announcement, the US has also pledged a total of USD 4.6 billion over the next few years to build its submarine construction capacity and to improve the maintenance of its Virginia-class submarines. "This state-of-the-art conventionally armed nuclear-powered submarine will work — that will combine the UK submarine technology and design with the American technology," he said.

The Indo-Pacific is a biogeographic region, comprising the Indian Ocean and the western and central Pacific Ocean, including the South China Sea. India, the US and several other world powers have been talking about the need to ensure a free, open and thriving Indo-Pacific in the backdrop of China's rising military manoeuvring in the region. China claims nearly all of the disputed South China Sea, though Taiwan, the Philippines, Brunei, Malaysia and Vietnam all claim parts of

Beijing has built artificial islands and military installations in the South China Sea. Australia's future SSN, which Biden described as "SSN-AUKUS", will also be a state-of-the-art platform designed to leverage the best of submarine technology from all three nations.

Commitment to global security: Sunak

AUKUS nuclear submarines to be built in the British shipyards is a "tangible demonstration" of the country's commitment to global security, Prime Minister Rishi Sunak said on Tuesday. The AUKUS pact, which is a trilateral alliance between the UK, US and Australia, is seen as a counter to an aggressive China in the strategic Indo-Pacific region, which included its claim over most parts of the disputed South China Sea.

Sunak, who is in San Diego with US President Joe Biden and Australian Prime Minister Anthony Albanese, said the conventionally-armed nuclear-powered submarine dubbed the 'SSN-AUKUS' will be built in British shipyards. "The AUKUS partnership, and the submarines we are

SSN-AUKUS will be based upon the United Kingdom's next-generation SSN design while incorporating cutting-edge US submarine technologies and will be built and deployed by both Australia and the United Kingdom. "Beginning this year, Australian personnel will embed with US and UK crews on boats and at bases in our schools and shipyards. We will also begin to increase our port visits to Australia. In fact, as we speak, the nuclear-powered submarine, the USS Asheville, is making a port call in Perth,"

"And later this decade, we will be establishing a rotational presence of the US and UK nuclear-powered subs in Australia to help develop the workforce

building in British shipyards, are a tangible demonstration of our commitment to global security," Sunak said, in a statement released by Downing Street. "This partnership was founded on the bedrock of our shared values and resolute focus on upholding stability in the Indo-Pacific and beyond. And I am hugely pleased that the plans we have announced today will see pioneering British design expertise protect our people and our allies for generations to come," he said. It follows the refreshed Integrated Review of its foreign policy tabled in Parliament, which highlights that the so-called Indo-Pacific "tilt" of the 2021 review is now a permanent pillar of the UK's policy and that the AUKUS pact a key element of that pillar.

Australia is going to need to build and maintain its fleet," he said.

Describing it as a new chapter in the relationship between the three countries, Albanese said this is a friendship built on their shared values, commitment to democracy, and a common vision for a peaceful and prosperous future.

'The AUKUS agreement, we confirm here in San Diego, represents the biggest single investment in Australia's defence capability in all of our history, strengthening Australia's national security and stability in our region; building a future made in Australia with record investments in skills, jobs, and infrastructure; and delivering a superior defence capability into the future," he said.

Death toll climbs as cyclone slams Malawi, Mozambique

An unrelenting Cyclone Freddy that is currently battering southern Africa has killed at least 56 people in Malawi and Mozambique since it struck the continent for a second time on Saturday night, authorities in both countries have confirmed. Local police said 51 people in Malawi, including 36 in Chilobwe in the financial hub of Blantyre in the centre of the country have died, with several others missing or injured. Authorities in Mozambique reported that five people were killed in the country since Saturday. The deaths in Malawi include five members of a single family who died in Blantyre's Ndirande township after Freddy's destructive winds and heavy rains demolished their house, according to a police report. A three-yearold child who was "trapped in the debris" is also among the victims, with her parents among those reported missing, authorities also said. "We suspect that this figure will rise as we are trying to compile one national report from our southwest, southeast and eastern police offices which cover the affected areas," Malawi police spokesperson Peter Kalaya told the AP. The cyclone lashed over Mozambique and Malawi over the weekend and into Monday. It's the second time the record-breaking cyclone which has been causing destruction in southern Africa since late February — made landfall in mainland Africa. It also pummelled the island states of Madagascar and Réunion as it traversed across



The cyclone has intensified a record seven times and has the highest-ever recorded accumulated cyclone energy, or ACE, which is a measurement of how much energy a cyclone has released over time. Freddy recorded more energy over its lifetime than an entire typical US hurricane season. Freddy first developed near Australia in early February and travelled across the entire southern Indian Ocean. It's set to be the longest-ever recorded tropical cyclone. The UN's weather agency has convened an expert panel to determine whether it has broken the record set by Hurricane John in 1994 of 31

Freddy made landfall in the seaport of Quelimane in Mozambique on Saturday where there are reports of damage to houses and farmlands, although the extent of the destruction is not yet clear. Telecommunications and other essential infrastructure are still cut off in much of the affected

Zambezia province, impeding rescue and other humanitarian efforts.French weather agency Météo-France's regional tropical cyclone monitoring centre in Réunion warned on Monday that "the heaviest rains will continue over the next 48 hours" as Freddy barrels on. Mozambique's central provinces and Malawi have been identified as especially vulnerable to "floods and landslides in mountainous areas" by weather monitors.

Much of the damage experienced in Malawi is in homes built in areas prohibited by law such as in mountainous regions or near rivers where they are battling landslides, unprecedented flooding and rivers bursting their banks. The cyclone has forced the

Malawian government to suspend schools in 10 districts in its southern region "as a precautionary measure". Freddy is expected weaken and to exit back to sea on Wednesday, according to Météo-France.

My country safer than US, says Mexican President

Mexico City (AP): Mexico's president claimed Monday that his country is safer than the United States, a week after two US citizens were killed and two kidnapped and later rescued in the border city of Matamoros. President Andres Manuel Lopez Obrador said US travel warnings and reports of violence in Mexico were the result of a conspiracy by conservative politicians and U.S. media outlets to smear his administra-

Despite López Obrador's assurances that Mexico was safe for travel, the FBI confirmed last week that three other women from the small Texas town of Peñitas have been missing in Mexico since late February. "Mexico is safer than the United States," López Obrador said at his morning news briefing. "There is no problem in traveling safely in Mexico." Mexico's nationwide homicide rate is about 28 per 100,000 inhabitants. By comparison, the U.S. homicide rate is barely one-quarter as high, at around 7 per 100,000.

The president brushed off continued concern over vio-

Currently, the U.S. State Department has "do not travel" advisories for six of Mexico's 32 states plagued by drug cartel violence, and "reconsider travel" warnings for another seven states.

"This is a campaign against Mexico by these conservative politicians in the United States who do not want the transformation of our country to continue," López Obrador said.

Thina will reopen its borders to Ctourists and resume issuing all visas on Wednesday after a three-year halt during the pandemic as it sought to boost its tourism and economy. China is one of the last major countries to reopen its borders to tourists. The announcement on Tuesday came after it declared a "decisive victory" over COVID-19 in February.

All types of visas will resume from Wednesday. Visa-free entry also will resume at destinations such as Hainan island as well as for cruise ships entering Shanghai that had no visa requirement before COVID-19. Foreigners holding visas issued before March 28, 2020, that are still valid will be allowed to enter

Visa-free entry will resume for foreigners entering Guangdong in southern China from Hong Kong and Macao. The

certificates or negative COVID-19 tests would be required, but Foreign Ministry spokesperson Wang Wenbin told reporters on Tuesday that China had "optimized measures for remote testing of people coming to China from relevant countries", allowing pre-boarding antigen testing instead of nucleic acid testing.

"All these have been well implemented, and the epidemic risk is generally controllable," Wang said at a daily briefing. The move would "further facilitate the exchange of Chinese and foreign personnel," according to the notice posted on the websites of numerous Chinese missions and embassies

China had stuck to a harsh "zero-COVID" strategy involving sudden lockdowns and daily COVID-19 testing to try to stop the virus before abandoning most aspects of the policy in December amid growing opposition.

'Govt taking steps to make Sensex, Nifty fall India \$5 trillion economy'

The government on Tuesday I informed the Rajya Sabha that it is taking steps to make India a USD 5 trillion economy earlier than the International Monetary Fund's forecast year of 2026-27.

The IMF's World Economic Outlook earlier said the size of the Indian economy will increase from USD 3.2 trillion in 2021-22 to USD 3.5 trillion in 2022-23 and cross USD 5 trillion in 2026-27.

"The government has been taking steps to make the country a USD 5 trillion economy at an early date," Minister of State for Finance Pankaj Chaudhary said in a written reply to the Upper House.

Observing that the outbreak of the COVID pandemic in 2020 and the Russia-Ukraine conflict in 2022 has impacted the world output, increased inflation in several countries and raised uncertainty in the world economy, he said, "lower uncertainty in the global economic outlook will help India become a USD 5 trillion-dollar economy

Some of the important mea-



in the past to boost economic growth include the making of the National infrastructure pipeline of projects, push to capital expenditure, implementation of the Production Linked Incentive (PLI) scheme, finalisation of the National Monetization Pipeline of public sector assets and formulation of National Logistics policy, he said.

The minister further said that capital expenditure will be speeded up by PM Gatishakti for integrated planning of infra-

ject implementation across all concerned central ministries, departments and state govern-

The Union Budget 2023-24, Chaudhary said, "further sustains the growth momentum with an increase in capital investment outlay for the third year in a row by 33 per cent to Rs 10 lakh crore (3.3 per cent of

The other initiatives to boost the economy include enhanced outlay for PM Awas Yojana, the

Blocks Programme covering 500 blocks for saturation of essential government services; an increase in agriculture credit target to Rs 20 lakh crore with a focus on animal husbandry, dairy and fisheries; and setting up of Agriculture Accelerator Fund to encourage agri-startups by young entrepreneurs in rural areas, among others.

The minister also said that the direct capital investment by the Centre is being complemented by the provision made for the creation of capital assets through grants-in-aid to states. The 'effective capital expenditure' of the Centre is budgeted at Rs 13.7 lakh crore (4.5 per cent of GDP) for 2023-24, he said, adding "the newly established Infrastructure Finance Secretariat will oversee the increase in private investment in infrastructure".

In order to improve logistics performance, he said, one hundred critical transport infrastructure projects for last and first-mile connectivity for ports, coal, steel, fertiliser, and food grains sectors have been identified and will be prioritised for development.

Sensex tumbled 2,447 points or 4.1 per cent while Nifty tanked 711 points or 4.6 per cent in the four days to Tuesday.

Analysts said relentless foreign capital outflows, investors junking riskier assets ahead of the US Fed policy decision and fears of interest rate hikes to stifle global economic recovery have hit the market sentiment. Mahindra & Mahindra was

"The selling continued while the degree of ambiguity over the US Banks reduced due

to supportive measures announced by the US FED. The underlying issue of the market is high-interest rates, which will continue to wreak havoc in the world economy. "However, the disruptive development in the US Banks and a slowing economy have created a precursor to presume that yields will peak in the near future, supported by a change in monetary policy from hawkish to neutral, which will diminish the worries of long-term investors," Nair said.

Asia-Pacific markets tumbled and European markets were mixed on Tuesday, after sharp losses seen overnight on Wall Street as investors grappled with the fallout of failed banks in the US and an uncertain path forward for monetary policy, said Deepak Jasani, Head of Retail Research, HDFC Securi-

Rupee falls 26 paise to 82.49 against **US** dollar

The rupee declined by 26 paise to 82.49 (provisional) against the US dollar on Tuesday amid stronger dollar, negative sentiment in the domestic equity market and unabated foreign fund outflows.

At the interbank foreign exchange, the domestic unit opened lower at 82.27 against the dollar and traded between the range of 82.24 and 82.50 during intra-day. It finally settled at 82.49 (provisional) against the American currency.

This is the second consecutive day of decline in the Indian currency. On Monday, the rupee settled at 82.23 against the US dollar.

Jateen Trivedi, VP Research Analyst at LKP Securities, attributed the fall in rupee to the spillover fears after the collapse of the Silicon Valley Bank in the

"The Rupee fall continued as the Silicon Valley Bank in the US has spread concerns over the spillover fears after its collapse and in line with Asian peers. Rupee this time, fell below 82.48 levels which were last seen on 3rd March 23.

'Most APAC fin institutions not to be hit by US bank failure'

Most Asia Pacific financial institu-tions are not exposed to the failed US banks and are not as susceptible to large losses from debt security holdings as Silicon Valley Bank was, Moody's said on Tuesday.

On March 12, US regulators closed Signature Bank, just two days after shutting Silicon Valley Bank, following mass withdrawals of customer deposits from these regional banks.

Moody's Investors Service said these events are likely to result in a tightening of liquidity in debt markets globally as investors grow wary. However, the impact will be limited for most rated financial institutions in Asia-Pacific (APAC) because of structural

"Also, most APAC institutions are not exposed to the failed US banks, and only a handful of institutions has immaterial exposures. Finally, most institutions are not as susceptible to large losses from debt security holdings as Silicon Valley Bank was," Moody's

The US-based rating agency said rated banks in APAC structurally have stable funding and ample liquidity.

They are mostly funded with customer deposits, while their market borrowings are modest at about 16 per cent of their total assets on average.

Their business depositors are well diversified across different sectors, with no rated bank in the region being heavily exposed to technology companies. Also, APAC banks' deposits are generally not heavily concentrated on single clients.

Most banks in the region are subject to liquidity coverage ratio (LCR) requirements that are aimed at ensuring banks hold ample high-quality liquid assets to get through stressed funding conditions, such as deposit



In most systems in APAC, banks' investments in held-to-maturity (HTM) instruments are generally not substantial relative to tangible common equity, unlike the case of Silicon Valley Bank, which suffered substantial unrealized losses from its large HTM investments, the agency added.

Signature Bank, New York, which lent mostly to the crypto industry was shut down by the regulators on Sunday after there was a run on their deposits.

Besides, the failure of Silicon Valley Bank last week left many startups, tech companies, entrepreneurs and VC funds nervous and jittery. SVB, the 16th largest bank in the United States, was closed on Friday by the California Department of Financial Protection and Innovation which later appointed the FDIC as its receiver. SVB was deeply entrenched in the

tech startup ecosystem and the default bank for many high-flying startups.

Its abrupt fall marked one of the largest bank failures since the 2008 global financial crisis. The bank failed after clients -- many of them venture capital firms and VC-backed companies that the bank had cultivated over time - began pulling out their deposits, creating a run on the bank.

The UK government announced on Monday that it has facilitated London-based banking major HSBC to buy the embattled UK arm of Silicon Valley Bank for 1 pound, securing the deposits of more than 3,000 customers worth around 6.7 billion pounds.

Coal India ready to meet dry fuel demand from power sector

Amid early onset of summer and a pick-up in industrial demand for electricity, stateowned CIL on Tuesday said it is geared up to meet the demand of dry fuel from the power sec-

The public sector coal producer also expressed hope to supply 156 million tonnes of coal to the power sector during April-June quarter of FY24. This would be 25.6 per cent of the enhanced annual dispatch target of 610 million tonnes (MT) slated for the sector in 2023-24

"Coal India Limited (CIL) is optimistic about supplying 156 million tonnes of coal to power sector during April-June '23 quarter amid concerns over spike in coal demand," the coal behemoth said.

CIL, which accounts for over 80 per cent of domestic coal fuel to the electricity generating

Factors in favour of CIL are a strong 68 MT coal stock buildup expected at its pitheads by the

end of current fiscal, which as of Monday was 57.3 MT. Also, the maharatna firm will scale up its production into

a higher orbit maintaining the pace on the back of an unprecedented 700 MT output, which it is on course to achieve by the end of FY23. "Even after despatching the planned coal to power utilities in the first quarter of FY24, CIL is likely have a healthy 50 MT coal stock at its pitheads by June'23 end," said a senior official of the company in a statement.

Wholesale inflation eases to over 2-yr low of 3.85% in Feb

Food items remain costly

The wholesale price-based inflation declined to l over two-year low of 3.85 per cent in January on easing prices of manufactured items, fuel and power, even though food articles remained expensive. This is the ninth straight month of decline in the rate of wholesale price-index (WPI) based inflation. The WPI inflation was 4.73 per cent in

January and 13.43 per cent in February, last year. "Decline in the rate of inflation in February 2023 is primarily contributed by fall in prices of crude petroleum & natural gas, non-food articles,

food products, minerals, computer, electronic & optical products, chemicals & chemical products, electrical equipment and motor vehicles, trailers & semi-trailers," the commerce and industry ministry said on Tuesday.

The 3.85 per cent WPI inflation is the lowest since January 2021, when the rate of price rise on wholesale basis was 2.51 per cent.

The decline in the rate of price rise was mainly due to a favourable base effect, economists said, adding that going forward, softening commodity prices would help ease WPI inflation further.

Although inflation in manufactured items softened, in the case of food articles it rose to 3.81 per cent in February, from 2.38 per cent in January. Inflation in pulses was 2.59 per cent, while in vegetables was (-)21.53 per cent. Inflation in oil

seeds was (-)7.38 per cent in February 2023. Fuel and power basket inflation eased to 14.82 per cent, from 15.15 per cent in the preceding month. In manufactured products it was 1.94 per cent, against 2.99 per cent in January.

The deceleration in WPI comes in line with the dip in retail inflation, data of which was released on Monday. Consumer price index based retail inflation declined to 6.44 per cent in February from 6.52 per cent in January.

A major ingredient for the industry is natural essential oils which attract higher import duty compared to fragrances, the end product. We have sent several representations to the government to correct this anomaly by increasing duty on finished fragrance compounds which will protect the domestic industry'

The present duty structure is detrimental to the domestic industry, Kothari claimed.



Warner remains in Oz plans for WTC final: McDonald

ustralia opener David Awarner will compete in the upcoming ODI series against India, having recovered from his elbow injury, coach Andrew McDonald confirmed on Tuesday.

Warner struggled in the two Tests he played against India, scoring 26 runs from his three innings before being substituted out of the second match in Delhi due to concus-

He then returned home to recover from a hairline fracture in his elbow. "He (Warner) is coming

back (to India) for the one day series, he's recovered from his injury," Australia head coach Andrew McDonald said here.

McDonald said Warner is even in the frame for the World Test Championship final against Rohit Sharma's men in

'At the moment Dave's fully in our plans for the World Championship,' McDonald said of Warner, who has scored 8158 runs from 103 Tests at an average of

The 36-year-old has also scored 6007 runs from 141 ODIs at an average of 45.16.

McDonald also confirmed that in-form opener Usman Khawaja, who made 180 in Australia's first innings in the drawn fourth Test here, has been cleared of structural damage to his lower leg which he injured while fielding on the penultimate day on Sunday.

"The scans are pretty positive ... so he gets some time to rest up now and look forward the World Test Championship," McDonald said of Khawaja.

"I'm sure there'll be a bit of rehabilitation around that, but McDonald said.

at this stage nothing structural or anything that will keep

him out for long."

The WTC final at the Oval will be played just a few days after the end of the Indian Premier League (IPL) but McDonald said Australia will be prepared well.

"It will be squeezed, pretty much straight on the back of the IPL," he said.

"We'll head to England with plenty of time to prepare over there. We've got things that are almost in place for that - we'll be well prepared."

Of the front-line bowlers

Australia are likely to deploy in England for the WTC final and the Ashes that follow, only injured quick Josh Hazlewood rounder Cameron Green are signed to take part in the IPL that begins on March 31.

Warner is the other probable member of Australia's UK touring party who will also spend the coming months playing white-ball cricket in India.

"We are continually talking to our senior players with what they have coming up, juggling the schedule that's in front of

"We are staring down 274 days on the road – 144 for the red-ball team, 130 for the white-ball team. So there's going to be some give and take within that."

McDonald admitted that the defeat in the second Test in Delhi where Australia suffered a batting collapse, losing eight wickets for 28 runs in barely an hour, was the moment when hopes of a historic series win evaporated.

"It's a proud group and they'll see it as a missed opportunity. Not many teams come here and get the opportunity like what was presented in Delhi, and if it had been oneall (after Delhi) who knows how the series goes from there,"
