Rahul convicted for 'all thieves Modi' jibe

Surat court gives Rahul 2-year jail, suspends sentence for 30 days; verdict stirs debate on possible disqualification judgment 'erroneous'

ongress leader Rahul Gandhi was on Thursday sentenced to two years in jail by a Surat court in a 2019 criminal defamation case over his "all thieves have Modi as the common surname" remark, in a setback to the Lok Sabha MP who faces the risk of disqualification. Rahul made the remarks during a rally in Karnataka's Kolar during the Lok Sabha poll campaign.

The defamation case was filed by BJP MLA and former Gujarat Minister Purnesh

The court of Chief Judicial Magistrate HH Varma, which held 52-year-old former Congress president guilty under IPC sections 499 and 500, also granted him bail and suspended the sentence for 30 days to allow him to appeal in a higher court. Rahul can escape immediate disqualification as a member of Parliament if the appellate court suspends the conviction as well as the two-year jail term

As the conviction ahead of the 2024 Lok Sabha elections set off a political slugfest and posed another challenge to Rahul with a bearing on his political future, the Congress said he will file an appeal.

Rahul could have limited his speech to Prime Minister Narendra Modi, Nirav Modi, Vijay Mallya, Mehul Choksi, and Anil Ambani, but he "intentionally" made a statement that hurt individuals carrying the Modi surname, and thereby committed criminal defamation, the court said in its 168-page order. Rahul was present in the court when the ver-

dict was pronounced. Rahul took to Twitter to give his initial reaction by quoting Mahatma Gandhi in a tweet in Hindi about truth and non-violence. "My religion lence. Truth is my God, nonviolence the means to get it. -Mahatma Gandhi."

In another tweet, he paid tributes to freedom fighters

BJP: Should Rahul have freedom to abuse others

The BJP on Thursday asserted that the law has to take its course if Congress leader Rahul Gandhi abuses people and slammed the Congress over its criticism of his conviction in a defamation case, asking whether the opposition party wants "complete freedom" for him to "abuse" others.

Taking objection to Congress president Mallikarjun Kharge's comment that judges were "changed" in Rahul's case and maintaining that it also calls for the "contempt of court", the BJP on Thursday alleged that Rahul was sowing "seeds of hate" by his unbridled com-

The BJP, however, skirted the question on the disqualification of Rahul's Lok Sabha membership following the court conviction, saying it was the prerogative of the House Speaker.

Addressing a press conference here, BJP leader and for-

mer law minister Ravi Shankar Prasad said there is yet another defamation case in Bihar filed by the party leader Sushil Kumar Modi against the Congress leader.

Taking exception to Congress president Mallikarjun Kharge's questioning the court's order by saying that "several judges hearing the matter were changed," Prasad said it means that the Congress does not believe in the judiciary and the rule of the law.

"It is a serious issue of contempt [of court] also," Prasad said and added that it was "grossly unfair" on the part of Kharge to make such com-

The BJP leaders cautioned Rahul against making defamatory remarks, saying the Congress leader will find himself facing "more troubles" if he "He is sowing seeds of hate by his comments," said the BJP leader, adding the law will take its course if Rahul abuses people.

Khalistani violence unacceptable, says UK Foreign Secy

In the first high-level condemnation of violent incidents by alleged Khalistan supporters in London, UK Foreign Secretary James Cleverly has said his country will review security at the Indian High Commission there following

"unacceptable" acts of violence. He also asserted the British Government takes these matters "very seriously" and would "robustly" respond to such incidents. These assurances were given by him late Wednesday. He also said "acts of violence towards staff at the Indian High Commission in London are unacceptable and I have made our position clear to the High Commissioner Vikram Doraiswami".

Around 2,000 protesters waving so-called Khalistan flags descended upon the Indian mission in London on Wednesday for a planned demonstration and hurled objects and chanted slogans amid a heightened security presence and barricades.

Unlike the violent disorder on Sunday when the Indian High Commission came under attack, the protesters were barricaded across the road.

The protesters, including turbaned men, and some women and children, had been bussed in from different parts of the UK and chanted pro-



Khalistan slogans.

In a statement, Cleverly said the British Government takes such matters very seriously and would "robustly" respond to the attack as it works with the Metropolitan Police to make changes needed to ensure the security of the mission's staff.

'Details of 17 cr Indians leaked, gang arrested'

massive data breach that Ahas implications for national security was unearthed by Cyberabad Police here, who arrested seven people of a gang allegedly involved in the theft and sale of sensitive data of the government and important organisations, including details of 2.55 lakh Defence personnel as well as the personal and confidential data of about 16.8 crore citizens across the coun-

The accused persons were found selling more than 140 different categories of information, which include sensitive information such as details of defence personnel and the mobile numbers of citizens and NEET students, among others, Cyberabad Police Commissioner M Stephen Raveendra told reporters here on Thursday. Seven data bro-

police said adding that the accused had been operating through three companies (call centres) in Noida and other places. So far it has been found that the accused sold data to at least 100 fraudsters, who used it for committing cyber crimes. Investigations are still on, police said.

Sensitive data of defence personnel containing their ranks, email ids, place of posting, etc was found available with the accused, Commissioner Raveendra

"This will have serious national security implications. The data of defence and government employees can be used for espionage; to impersonate them and commit serious offences that may jeopardise national security. We are in process of finding out how this data got leaked and who are insiders who are doing it,"

kers were arrested from Delhi, he added. The arrested accused were selling the data through a contact details directory service provider and similar platforms, police said, adding that during the course of the investigation it was found that the accused had sold data of 50,000 citizens for as low as Rs 2,000.

Notices will be sent to the service providers and they will be examined and legal action will be initiated against them also, police said. "When any individual calls toll-free numbers of service providers for any sector or category related confidential data of individuals, their query is listed and sent to that category of service providers.

Then these fraudsters contact the clients and send them samples. If the client agrees to purchase, they make payment and are provided data," police said, explaining modus

"The opposition parties had even turned down the EC's plans to make a demonstration about the remote-EVMs. There is doubt amongst voters on EVMs. Earlier, they used to say EVM is a stand alone machine, but now they are saying the names of candidates can be added through the internet," the former Madhya Pradesh chief minister said.

Sibal said no other country uses EVMs for elections, then why should the machines be used in India. Sibal and Singh brushed

aside questions on whether they doubted the electoral victories of opposition parties where EVMs were deployed for the conduct of polls. "We have decided to move the Election Commission one last time. We want to hear from the Election Commission on our concerns. If the EC does not address our concerns, we will take political action," Sibal said, without elaborating.

Digvijay Singh said Citizens Commission on Elections chaired by retired Supreme Court judge Madan Lokur had raised doubts about EVMs and petitioned the Election Commission but had received no response from the

Govt 'corrupt' remark, Congress writes to CBI

The Congress on Thursday wrote to CBI Director Subodh Jaiswal asking the probe agency to question Home Minister Amit Shah over his remark describing Sangma the Conrad Government in Meghalaya in its previous term as corrupt, and to investigate that claim.

In a letter to Jaiswal, Congress chief spokesman Jairam Ramesh stated that Shah in his public speech on February 17, 2023, said the then government of Meghalaya was the most corrupt government in the country'

"Shah is also the Home Minister of India. In his capacity as the home minister, he would surely have had access to information and facts that led him to this conclusion," he said. For some inexplicable

reasons, the home minister, who is also the former national president of BJP, has failed to act upon the information about the corrupt practices and instances of the then Meghalaya government, Ramesh said in the letter dated March 21 which he tweeted Thursday.

"Therefore, in the highest national interest, we urge you to summon Shah and ask him to submit all the information and facts that led him to the stated assessment and investigate the matter," he said.

"We also urge you to investigate if the Home Minister of India was under any undue duress from his party or other forces, to suppress the information related to the corruption of Meghalaya, in order to enable his party BJP to support the same chief minister after recent Meghalaya elections," the Congress leader said.

Nikah halala: SC to form bench...

"I will consider it. At an appropriate stage, I will constitute a constitution bench," the CJI responded. "Around 1per cent of the global cases being reported in India as of now. Active cases stand at 7,600 right now. 966 cases being reported on a daily basis, on average. Avasthy told reporters that the Sector 113 Police Station was alerted about a robbery at a flat in Arania society in Sector 119 on the intervening night of March 20 and 21.

"The three people (the couple and the businessman) had come to the police station in an inebriated condition. They requested a medical test. The medical test was done and it showed minor injuries with all three. The next day they filed a loot complaint," the officer said.

When police investigated the case, they found that the businessman, Virendra Malik, who is also one of the complainant in the matter, was invited by Ajit alias Rahul Singh and his wife Mahi to their apartment.

"The couple had roped in four more people to stage the



robbery at their home and one of them, identified as Ankur Payal, has been arrested," he said. During the staged episode, the "robbers" made off with some gold jewellery worn by the businessman and also administered him some narcotics which left him unconscious for more than 24 hours, According to police, a

India, so far, has refrained from voting against Russia on the Ukraine issue in the United Nations General Assembly and the United Nations Security

The BJP on Thursday appointed four new State presidents, including Lok Sabha MP C P Joshi in the pollbound Rajasthan and OBC leader and MLC Samrat Choudhary in Bihar.

Besides these two states. BJP president J P Nadda also appointed Manmohan Samal, a former state minister, as the head of the party's Odisha unit, while Delhi working president Virendra Sachdeva was elevated as its chief.

Soon after the announcement of his appointment the BJP's new Bihar unit chief asserted that securing all 40 Lok Sabha seats of the state next year and ensuring an "absolute majority" for his party in the assembly polls of 2025 will be his top priorities.

Currently the Leader of the Opposition in the state legislative council, Chaudhary, who was a minister in the Nitish Kumar government till the JD(U) leader remained with NDA, also did not deny that by hedging its bets on him, the BJP has sought to make a dent



in the "Luv-Kush" base of the Bihar chief minister.

Choudhary (54), whose standing within the BJP has steadily risen after joining the party in 2018, comes from the politically important Kushwaha community.

He replaces Lok Sabha MP Sanjay Jaiswal at the helm of the Bihar BJP.

In the poll-bound Rahasthan, Joshi (47), will replace Satish Poonia, an MLA from Jaipur's Amber constituency, and the appointment comes close on the heels of veteran Rajasthan BJP leader Gulab Chand Kataria being eased out of active politics following his appointment as Assam governor.

In the backdrop of with-drawal of general consent for CBI probe by many States, a Parliamentary committee has underscored that the existing law governing the federal probe agency has "many limitations" and there is a need to enact a new legislation to define its status, functions and powers. The department-related

Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice said that according to the provisions of the DSPE Act, the consent of the state government is a prerequisite for any investigation by the CBI and as on date, nine states have withdrawn the general consent.

The central probe agency

was established in 1963. It is governed by the Delhi Special Police Establishment (DSPE) Act, enacted to regulate the functioning of the special police establishment set up in 1941 to investigate cases of bribery and corruption involving purchases and supplies



"The Committee feels that the Delhi Special Police Establishment Act has many limitations and therefore, recommends that there is a need to enact a new law and define the status, functions and powers of the CBI and also lay down safeguards to ensure objectivity and impartiality in its functioning," it said.

The panel said that vacant posts in the CBI are not being filled up at the required pace and recommended that "every effort should be made to fill up vacancies at the earliest". A total

of 1,709 posts are vacant in the CBI against its sanctioned strength of 7,295.

The Committee is of the opinion that vacancies in the cadres of executive ranks, law officers and technical officers will unquestionably increase pendency of cases, hamper the quality of investigation and ultimately impact the effectiveness and efficiency of the agency," the report said. The panel further recom-

mended that the Director of CBI should monitor the progress made in filling up of vacancies on a quarterly basis and take necessary measures to ensure that the organisation is sufficiently staffed.

On being asked about the reasons for delay in filling up of vacancies, CBI informed the committee that it is not receiving sufficient nominations of officers from Central Armed Police Forces (CAPFs) and state police which have traditionally been a major source of induction, particularly up to the rank of inspector in the organisation, it

Women taking hormonal contraceptives at higher risk of developing breast cancer: Study

 $W^{omen\ taking\ hormonal}_{contraceptives\ whether}$ oral pill, IUD, implant, or injection have a 20 to 30 per cent higher risk of developing breast cancer than those who do not use them, according to a recent study published in the journal PLOS Medicine. The study, however, also confirmed, like others, that the risk of breast cancer declines

The researchers who carried out the study stressed that the increased risk of breast cancer needs to be weighed against the benefits of hormonal contraceptives, including the protection they provide against other forms of female

Previous studies have established an increased risk of breast cancer from two-hormone, or combined, contraceptives that use both estrogen and progestogen.

While the use of progestogen-only contraceptives has been on the rise for well over a decade, little research had been performed previously on their links to breast cancer. The study found that the

risk of a woman developing breast cancer was about the same for hormonal contraceptives using both estrogen and progestogen as for those

using just progestogen. The findings are similar to those published previously, including in a vast 1996 study.

Taking into account that the likelihood of breast cancer increases with age, the authors of the study calculated how much absolute excess risk is associated with hormonal contraceptives.

For women taking hormonal contraceptives for a period of five years between the ages of 16 to 20, it repre-

sented eight cases of breast cancer per 100,000, they said. Between 35 and 39 years old, it was 265 cases per 100,000.

"Nobody wants to hear that something that they're taking is going to increase their risk of breast cancer by 25 percent," said Gillian Reeves, a professor of statistical epidemiology at the University of Oxford and a coauthor of the study.

"What we're talking about here is a very small increase in

"These increases in risk for

breast cancer have to, of course, be viewed in the context of what we know about the many benefits of taking hormonal contraceptives," she added. "Not just in terms of birth control, but also because we know that oral contraceptives actually provide quite substantial and long term protection from other female cancers, such as ovarian cancer and endometrial cancer.

Not Gandhian

Rahul claims to be Mahatma's admirer but doesn't follow in his footsteps while talking about his opponents

nongress leaders are angry that former party president Rahul Gandhi has been convicted in a 2019 criminal defamation case. A court in Surat on Thursday, finding him guilty, sentenced him to two years in jail for his rhetorical remark "why all thieves have Modi surname." It was surely in bad taste. How on earth could a senior leader condemn a large section of people just because they share their surname with Prime Minister Narendra Modi? Rahul's first reaction to the verdict was a tweet quoting Mahatma Gandhi: "My religion is based on truth and non-violence. Truth is my God, non-violence the means to get it. — Mahatma Gandhi." But then there is nothing on record to suggest that Gandhi ever slandered anyone; he was such a gentle soul that he never even used harsh words for his detractors, let alone calling them thieves. This is despite the fact some of his adversaries were extremely critical of him;



yet there was rarely, if ever, loss of cordiality. It was Subhas Chandra Bose, the most outspoken critic of Gandhi's methods against the British, who conferred the title of the Father of Nation on Gandhi. Therefore, Rahul's methods of opposing Modi and his Government are not exactly Gandhian. It is the right and the duty of Opposition leaders to take the government of the day for its sins of omission and commission, but that should not include slander, libel, and calumniation. Mahatma Gandhi, for one, never stooped to that level, and yet he defeated the greatest empire mankind has ever seen, the empire in which the sun never set.

"The complainant has not suffered any kind of pain or loss, and the accused has never been found guilty of any crime before and has not sought any mercy or forgiveness from anyone," Rahul Gandhi's lawyer told the court. Bharatiya Janata Party MLA (Surat West) Purnesh Modi is the complainant; with the surname 'Modi,' he can justifiably claim to be victim of slander. Besides, as a people's representative, he cannot be unaffected by statements defaming his party's top leader, Narendra Modi. It is true that Rahul Gandhi has never been convicted of any illegality, but that does not give him the licence to slander anyone he chooses to. The Surat court's verdict is likely to send a stern message to not just Congress leaders but the entire political class: criticism should never descend to the level of abuse and aspersion. It is unfortunate that in the last few years the level of political debate has fallen considerably. Politicians of all parties, while commenting on their opponents, often use words and terms which are best avoided. They also hurl wild allegations at their adversaries. Delhi Chief Minister and Aam Aadmi Party boss Arvind Kejriwal and his cronies, for instance, did such things with impunity — till finance minister Arun Jaitley sued them and forced them to apologise. Now, with Rahul Gandhi's conviction, we can hope that there would be some decency and decorum in politics.

Several countries in Asia, Africa, Latin America and other parts of the world even after constituting the largest share of the global population were without a collective voice on the international stage. The Global South is facing the consequences of climate change. In India, the Global South discovered

under the Indian presidency a voice that could negotiate with the developed world on equal terms. In this context, the G20 this year is giving the utmost importance to the issue of climate change. India has shown the world with the International Solar Alliance (ISA) that the energy transition to clean sources is not a matter of choice but a matter of urgency. With the Indian presidency of the G20, the developed world will be persuaded to share capital and technology for energy transition at an accelerated pace.

The world is currently facing the consequences of the war in Ukraine. Sadly, few countries have not taken sides in this war. India remains the voice of sanity in such a tough time. Satish was as adorable off screen as he was on screen. His simplicity and amicable personality made him a true friend one could bank upon

atish ji, as I used to call him, really shocked us a day before he shared his photographs taken at Shabana Azmi - Javed Akhtar's home at a holi party. Suddenly, we are hit by news that the veteran actor, filmmaker, and producer has gone.

Don't understand where to start. So many incidents and so many sweet memories. I started my career with this company many years ago. He always appreciated me and gave me unconditional love. Whenever, and wherever, I invited him to attend the newly formed film festivals, if he was not a filmmaker, he was always present there.

Whenever I followed up with an artist, he always appreciated it. A few years ago, at the Osian's-Cinefan Asian Film Festival in Delhi, he mentioned, "this Santanu used to follow up with such affection, constantly, and whatever date and time I gave him, he always called me then. It would be easier for others to say forget it, but he never does that. It is his politeness that attracts us to attend his events." In this case, we showed The Brick Lane directed by Sarah Gavron, based on Bangladeshi-origin writer Monica Ali. I have shown the film at innumerable film festivals with the honorable presence of Satish ji. Once travelling to Meerut to attend a film festival, he was very happily informed that he had been blessed with a baby girl. I have seen the tremendous joy on his face. Usually,

don't dig into the personal lives of the artists I am dealing with. Neither did I read the gossip news, that's why I didn't know of the news, and I told him that, but he never felt guilty about it. KISHIDA IN INDIA, XI IN RUSSIA

The strengthening of the Indo-Pacific strategy

his week marked two significant developments in Asia. Each of the two powerful leaders from Asia, albeit with differing approaches, developed their own agendas for shaping the geopolitics of the region as they moved westward. The first was Japanese Prime Minister Fumio Kishida's state visit to New Delhi, where he talked about the revised Indo-Pacific strategy, an older version of which Japan has been pursuing diligently for nearly one and half decades. The second was the state visit of Chinese premier Xi Jinping, to the Russian capital, the first major visit by any significant global leader, since the Russian invasion of Ukraine where it was a reiteration of growing Sino-Russia bonds, for a better Eurasia.

In many ways, Japan, more specifically, ex-PM Shinzo Abe, was the author of the Indo-Pacific strategy, nearly fifteen years ago, when he articulated the conjoined at the hip, future, for all nations dotting the Indian and Pacific oceans. In his now famous speech to the Indian Parliament in 2007, titled "The confluence of the two seas", a blueprint for the now-established geopolitical strategy for many nations in the Indo-Pacific was outlined. Incidentally, during the same speech, Abe made the point about broader cooperation between the largest democracies in Asia. This point later on emerged as the QUAD, comprising the US, Japan, Australia and India.

In several pitches during the intervening years, made to various region-



al groupings and multilateral forums, Abe continued to push on his vision of a free and open Indo-Pacific founded primarily on three pillars. Pillar 1 emphasises the need for the establishment of the rule of law, freedom of navigation by air and sea and free trade for the region. Pillar 2 emphasises economic prosperity by promoting broader regional connectivity through building roads, ports, and digital linkages as well as creating the human bridge through increased people-to-people connectivity. This pillar also looks at the harmonisation of trade rules thereby facilitating more access to each other's goods and services. The third pillar focuses on peace and security in the region. It has a clear focus on maritime security, law enforcement, prevention of terror activities, sharing intelligence, providing disaster relief etc. In spite of this, it took Japan years of patient pitching before the Indo-Pacific became the focus of US and EU foreign policy. It got the attention it deserved, with the changing geo-strategic situation in 2020, which showcased the vulnerabilities of relying on a China-monopolised critical supply chain system and the stiff restrictions imposed by China due to its zero Covid policy. China wasn't willing to cooperate with other nations during disaster. Japan was particularly shocked at the state visit of Vladimir Putin to Beijing, right before he invaded Ukraine, which established the "no limits friendship" between Russia and China.

It was almost a moment, which sharply divided the world into blocks that supported Russia and China and one that was led by the US and western allies. Although not a 21st-century version of the cold war yet, this rift will continue to dictate global affairs for some years. The Sino-Russia partnership has also empowered China, as it can utilise a second UN security council permanent member, Russia, to push its agenda through multilateral platforms. Meanwhile, observing the Russian invasion of Ukraine, China can reevaluate its strategy regarding unilaterally changing geographical boundaries with several neighbouring nations (including India).

The two-state visits, therefore assume significance, as the first one. reiterates India and Japan's commitment to deepening their engagement for an open safe, transparent rules-based Indo-Pacific while reiterating their commitment to increased cooperation with regional groups such as ASEAN. It re emphasised the centrality of India to Japan's Indo-Pacific strategy, particularly in a year when Japan is the chair of G7 and India has the G20 presidency, two significant platforms for cooperation and future road mapping. The conference in Moscow, has raised enough concerns across global capitals, to further energise their Indo-Pacific strategies.

Sardar Patel, Scindia and Swaraj



Maharaja Jiwajirao Madhorao Scindia of Ujjain and Gwalior became Patel's friend and assisted him in unifying Indian states



r Rajendra Prasad observed on May 13, 1959, how the legacy of Sardar Patel was being sidelined. He mentioned how Sardar Patel had been forgotten, but he also acknowledged that there was a prominent individual in India who was standing in support and appreciation of Sardar Patel, when many found it unneeded. This man was Scindia, the then Maharaja of Ujjain and Gwalior or, as he was called, HH Maharaja Jiwajirao Madhorao Scindia of Ujjain and Gwalior.

He was later on to become a close friend of Sardar Patel and his close aide VP Menon. He played a positive role in ensuring the unity of India and was made the first Rajpramukh of Madhya Bharat province after Independence of India. Prasad said, "Even Sardar Patel's portrait in the Parliament House is the gift of a ruling Prince [Gwalior]. Let us not, therefore, run away with the thought that his services are any less valuable because we choose not to recognise them."

This admiration of Scindia for Patel was oniy naturai. The Manaraja was inspired by his ancestor Mahadji Scindia, who is known for being the most important man in the latter half of the eighteenth century in South Asia (as per Historian Henry George Keene in entire Asia), ensuring the unity of the subcontinent when not just the Afghans but the British were also looking to occupy the throne of Delhi.

Famous political philosopher James Mill acknowledged the danger to the existence of the British in India if Mahadji Scindia lived longer, and after Mahadji Scindia died, Colonel George Bruce Malleson, author of Final French Struggles in India and on the Indian Seas, called him the most farsighted statesman India had ever produced.

Mahadji Scindia prevented a likely partition of India by the Durrani Afghan Empire of Ahmad Shah Abdali and his son Taimur, when in 1771 Scindia conquered Delhi. He extended his de facto empire all the way to the areas of present-day northern Pakistan, the then subas of Lahore and Attock. He also defeated the British at

Wadgaon, Sirsi, Prayagraj, Kolaras, Shivpuri, Sarangpur, and many other places. This sent a clear message to Indians that, if united, they can easily defeat the British.

Jiwaji was well aware that what Patel was doing was actually substantially similar to Mahadji Scindia's work. He felt an attachment to the project of national integration, and the persona of Sardar Patel. A friendship to unite India

After a couple of months of the death of Maulana Azad in 1954, his oil painting was installed in the Parliament House. But there was no oil painting of Sardar Patel in Parliament, even four years after his death. This was disappointing and preposterous despite his immense contributions to India.

Maharaja Scindia of Gwalior, who was present in parliament when Maulana Azad's portrait was installed, noticed how the legacy of his late friend was being sidelined. He pointed this out to President Rajendra Prasad. Rajendra Babu immediately gave his approval, after which Maharaja Scindia started making the necessary arrangements to get Sardar's picture put up in the Parliament House.

Scindia spent a significant amount of money from his personal funds in order to paint Sardar's portrait. The President took prompt action to get the picture installed in Parliament House. On the occasion of unveiling the portrait of Sardar, Scindia offered tributes to Sardar Patel. Talking about Sardar Patel, Maharaja Jiwajirao Scindia said, Here is the man whom I once hated. The man who later terrified me is shown here. Here is the man whom I admire and love.

While Sardar Patel had once mentioned in a letter to Jiwajirao Scindia, "I would like to thank you and Her Highness for the hospitality and consideration extended to us during our stay in Gwalior. All of us were overwhelmed by the attention bestowed on us by both of you. By vacating your palace for our sake, you won our hearts completely. I am afraid we imposed a great deal of strain on both of you, but you cheerfully put up with all this. We shall always carry the most pleasant recollections of our visit to Gwalior."

The intensity of love and admiration that Maharaja Jiwajirao Scindia and Sardar Patel had for each other is manifested from these statements

Sardar Patel came to Gwalior to meet Maharaja Scindia not alone but with his daughter Maniben. As mentioned in the paragraph before, Maharaja Scindia vacated his palace for them. It was Sardar Patel that Scindia invited to inaugurate the first medical college of Central India, Gajra Raja Medical College, on December 5, 1948. When states like Bhopal were planning with Jinnah to Baikanise India, Scindia and Patel stressed the need for Indian unity that they should work for.

Jawaharlal Nehru once said that the Gwalior state of Scindia had full capacity and resources to remain an independent country. However, it never worked in that direction because, as per Nehru, of the patriotism of Maharaja Scindia and his utmost respect for India. Nehru was right when he said this, since India then had only five princely states that were substantial and prosperous enough to be entitled to a 21gun salute. Scindia's Gwalior was one of them. Scindia helped Sardar for Swaraj

The help that Maharaja Scindia gave to Sardar Patel and the sacrifices he made for a united India were many. He decided to support Patel wholeheartedly in his nationalist endeavour to unify India. Menon has documented Scindia's help to Sardar. This was when several other

princely states were looking forward to furthering their interests with the help of Pakistan, specifically Bhopal. Menon writes in his book *The* Story of The Integration of Indian States that Maharaja Scindia was the first among the rulers of the five 21gun-salute states to agree to integration, a step which was motivated by the good of the country.

Menon wrote about Jiwaji: "He has always moved with the times. He had announced his intention to grant a responsible government as early as December 1946, and in May 1947 he readily gave his support to an interim government of popular representatives as well as a constitution-making body.

The Government of India had got Rs 74 crore from the merger of more than five hundred princely estates; out of that, Rs 54 crore was the contribution of Maharaja Scindia according to Rajmata Vijaya Raje Scindia.

According to Menon, the rulers of Gwalior were not prone to extravagance. Expressing his gratitude to the generous contribution by the Maharaja, Patel had said in the Lok Sabha, "The people who are opposing the Privy Purse for the erstwhile kings, they do not know that this amount will accrue only from interest on the contribution made by Maharaja Gwalior."

The government won't have to give anything from its treasuries, according to Rajmata Vijaya Raje Scindia. Scindia and Sardar also mentioned the threat of China to India long before the 1962 India-China war. They shared a realistic approach to international relations. Unfortunately, the role of Patel and the Scindias of Gwalior in uniting India was downplayed. But, under the new dispensation of Prime Minister Narendra Modi, India is recognising the ignored and less

On the World Tuberculosis Day today, let us resolve to make TB history

hether we have escaped from the scourge of tuberculosis or not, there is probably hardly a family that has not had to do something with this dreaded disease, said Jawaharlal Nehru. The effects of this deadly disease have been tormenting our country for ages-and continue to do so.

The existence of the disease dates back to the Vedas. It has been described as Kshayaroga in the Vedas, meaning 'to decay'. It wasn't until 1882 that Robert Koch discovered the causative agent for TB, which led to the World TB Day being observed annually on March 24.

Tuberculosis, commonly known as TB, is an infectious

disease that has been a significant public health issue since time immemorial. It remains a significant global health threat, with an estimated 10 million cases occurring every year. Unfortunately, India has the highest TB burden across the globe, with 2.69 million cases and 4.5 lakh deaths every year. Shockingly, 40 per cent of the Indian population is infected with these bacteria.

Types of TB

TB can manifest in two forms, pulmonary and extrapulmonary. Pulmonary TB symptoms include cough, fever, chest pain, shortness of breath, bloody expectoration, loss of weight, and appetite, but these symptoms are nonspecific. Diagnosis is con- cut this chain. The govern-

challenging to diagnose. TB is highly contagious, with people with active pulmonary TB potentially infecting 5-15 persons per year through close contact. How to STOP tuberculosis Combating TB is an arduous and perplexing task due to multiple deep-

rooted issues. Understanding and solving these issues requires efforts from all stakeholders. Doing so requires the following.

Let us understand what

the STOP technique is.
S- Stigmas: Stigmas against tuberculosis have existed for centuries and continue in the 21st century. Women fear verbal abuse, a failed marriage, and social isolation, while men fear disclosing the disease to friends, loss of jobs, or discrimination at the workplace. A study showed that more than 2 lakh people lost follow-up in the national TB program

after diagnosis. When patients feel better during treatment, they may skip or ignore the number of failure and drug resistance progression.

O- Outreach: At the community level, there is a connectivity deficit between the needy and the programmes curated for them, hindering contact with services.

P- Prevention: Poor application of preventive measures like cough etiquette, nutrition, health education, ventilation, and counseling fuels the spread of TB.

Counseling about the disease, drugs, and treatment duration is essential to tackling the increasing prevalence of tuberculosis. Community participation in framing slogans and messages for TB and sensitisation for the programme can also help. Interventions involving pills, leading to treatment psychological and nutrition-

al aspects for families and patients are necessary. Addressing stigmas by leaders, influential members, or celebrities in the community can help alleviate stigmas. Although TB remains a

significant public health threat globally, with India carrying the highest burden, following effective preventative measures can help curb the spread of the disease. It is imperative to note that to 'STOP' the spread of TB will require concerted efforts by all stakeholders, from the government to individuals in communities. By addressing stigmas, ensuring treatment adherence, promoting outreach, and focusing on prevention, we can combat TB and work towards a healthier world.

Hungary not to arrest Putin | China against US military in Philippines

uthorities in Hungary Awould not arrest Russian President Vladimir Putin if he were to enter the country despite him being the subject of an international warrant for alleged war crimes in Ukraine, a Hungarian official said Thursday.

Gergely Gulyas, chief of staff to Hungarian Prime Minister Viktor Orban, said during a news conference in Budapest that arresting Putin would contravene Hungarian law because the country has not promulgated the statute of the International Criminal Court into its legal

The court, which is based in The Hague, Netherlands, last week issued an arrest warrant for Putin that accused him of personal responsibility for the abductions of children from Ukraine. Gulyas said the statute of the ICC, of which Hungary is a member state, was in con-Hungary's Constitution, and that arresting Putin would therefore violate Hungarian law. Orban's government has not yet taken a position on the warrant, but Gulyas said he considered it

"I think these decisions are not the most fortunate because they lead toward escalation and not toward peace," he said. The chances of Putin facing trial in The Hague are highly unlikely because Moscow does not recognise the ICC's jurisdiction or extradite its nationals. However, the warrant could limit the Russian leader's ability to travel to the tribunal's 123 member nations, which could arrest him in accordance with the warrant.

The United States denied Chinese claims on Thursday that its military had driven away an American guided-missile destroyer from operating around disputed islands in the South China Sea. in an the South China Sea, in an incident that comes as tensions in the region between the two powers continue to rise. The US Navy's 7th Fleet said that a statement from China's Southern Theatre Command that it had forced the USS Milius away from waters around the Paracel Islands — called Xisha by China — was "false."

"USS Milius is conducting routine operations in the South China Sea and was not expelled," said Lt. j.g. Luka Bakic in response to a query from The Associated Press.

Launch of 3D-printed rocket fails on debut

A rocket made almost entire-ly of 3D-printed parts made its launch debut Wednesday night, lifting off amid fanfare but failing three minutes into flight — far short of orbit. There was nothing aboard Relativity Space's test flight except for the company's first metal 3D print made six years ago.

The startup wanted to put the souvenir into a 125-milehigh (200-kilometre-high) orbit for several days before having it plunge the such the having it plunge through the atmosphere and burn up along with the upper stage of the rocket. As it turned out, the liftoff from Cape Canaveral

Space Force Station and separated as planned. But the upper stage appeared to ignite and then shut down, sending it crashing into the Atlantic.

It was the third launch attempt from what once was a missile site.

Relativity Space came within a half-second of blasting off earlier this month, with the rocket's engines igniting before

Germany plans to buy more than 100 Australian-made combat vehicles as it moves ahead with plans to modernize its armed forces, the government said on Thursday.

German and Australian

officials signed an agreement to cooperate on the procurement of the new combat reconnaissance vehicles, based on the Boxer family of armored fighting vehicles and equipped with a 30-millimeter gun. The aim is for deliveries to start in 2025, the Defence Ministry

It didn't give a price for the purchase. However, it said the money will come from a special 100 billion-euro (USD 108 billion) fund for the modernisation of the military that Germany approved after Russia invaded Ukraine last year.

The new vehicles will replace the German army's Wiesel 2 armoured vehicles, the Defence Ministry said.

Germany's military is widely acknowledged to be suffering from years of neglect and in particular from aging, poorly functioning equipment.

The German government has faced criticism for making a slow start to spending the special fund, but has said that 30 billion euros has already been committed to

Zelenskyy visits front-line areas

Ukraine's president on Thursday made his third visit in two days to areas that have felt the brunt of Russia's war, with a trip to the southern Kherson region that was retaken from the Kremlin's forces, and as a senior Kyiv commander hinted that a brewing Ukrainian counteroffensive could come "very soon."
Ukraine took back control

of the Kherson region's capital, also called Kherson, at the end of last year, pushing out the Russian occupiers who had captured the city in the weeks full-scale invasion more than a

The Dnieper River now marks the front line in the region, which is still partially occupied.

While in Kherson on Thursday, Volodymyr Zelenskyy met with local security officials and inspected infrastructure damaged by Russian strikes, his office said.

On Wednesday, Zelenskyy visited Kharkiv, the country's second-largest city in northeastern Ukraine. Kyiv's troops recaptured Kharkiv from the Russians last September as part of the same monthslong counteroffensive that won back Kherson

Wednesday, Zelenskyy met with troops in

the eastern Donetsk region, stopping by a hospital to see wounded soldiers and giving state awards to the defenders of Bakhmut, a wrecked city that is now a symbol of Ukraine's dogged resistance against Russian President Vladimir Putin's ambitions.

Zelenskyy's 48 hours of visits far from Kyiv — and close to the front line — came as improving weather sets the stage for possible new offensives by both sides.

The biting winter weather, followed by mud as the ground thawed out, have prevented major changes on the battlebeen deadlocked in recent months. Ukraine is now starting to receive modern weapons, including tanks, from its Western allies, who are also training Ukrainian troops to use them.

Russian forces have been digging in where they hold territory in the four provinces that Moscow illegally annexed in September — Donetsk, Kherson, Luhansk, and Zaporizhzhia. Putin has made it clear he wants to have control there.

Ukraine's ground forces commander said on Thursday that Russian forces are "exhausting themselves" in their grinding push to take Bakhmut, giving Kyiv a window of opportunity for a coun-

Pentagon: Budget | readies US for possible China confrontation

The US military must be ready for possible confrontation with China, the Pentagon's leaders said Thursday, pushing Congress to approve the Defence Department's proposed USD 842 billion budget that would modernize the force in Asia and around the world.

"This is a strategy-driven

"This is a strategy-driven budget — and one driven by the seriousness of our strategic competition with the People's Republic of China," Defence Secretary Lloyd Austin said in Appropriations subcommittee

Pointing to increases in new technology, such as hypersonics, Austin said the budget proposes to spend more than USD 9 billion, a 40 per cent increase over last year, to build up military capabilities in the Pacific and defend allies.

The testimony comes on the heels of Chinese leader Xi Jinping's visit to Moscow, amid concerns China will step up its support for Russian President Vladimir Putin's war on Ukraine and increasingly threaten the West. China's actions, said Gen. Mark Milley, chairman of the Joint Chiefs of Staff, "are moving it down the path toward confrontation and potential conflict with its neighbours and possibly the United States.

S Korean min in Japan to discuss North Korea

Japan and South Korea almost simultaneously dropped their export claims against each other on Thursday in the latest sign of improving ties.

Japan's Ministry of Economy, Trade and Industry announced that effective Thursday the country would lift export controls of three key semi-conductor-related materials imposed in 2019 against South Korea, while Seoul said it would drop its complaint with the World Trade Organisation over the issue.

The two sides had agreed to the plan as part of their and the announcement came a week after their leaders agreed to work past their troubled history and mend ties so they can better respond together to growing regional threats.

The announcement came hours after South Korea's unification minister and senior Japanese government officials reaffirmed their close cooperation in response to North Korea's escalating missile threats at a rare meeting.

Kwon Youngse is in Tokyo for talks with Japanese ministers and top governing party officials, becoming the first unification minister to do so in 18 years. His trip comes on the heels of South Korean President Yoon Suk Yeol's summit with Japanese Prime Minister Fumio Kishida last

week, when they agreed to resume regular visits and launch high-level talks on security, trade and other issues.

Kwon and Japanese Foreign Minister Yoshimasa Hayashi agreed that North Hayasni agreed that North Korea's repeated ballistic mis-sile firings, which have occurred at an unprecedented pace, are a "serious and pressing threat to regional security and a clear and grave challenge to international society," according to a Foreign Ministry statement.

The two ministers confirmed their close cooperation in response to North Korea's nuclear and missile threats.

At the outset of the talks, Hayashi said last week's summit was "a great success" and praised Yoon's leadership toward improving bilateral relations. Hayashi also said he was "delighted to meet with Minister Kwon without delay."

Kwon, in response, said the process of improving ties has just begun and that he believes further efforts by the two governments can help bolster their

healthy relations. He said North Korea's nuclear and human rights issues represent a problem not only for South Korea but also for the international commu-

nity. He said it is also necessary for his country to strengthen ties with Japan to tackle those

Jerusalem (AP): Israeli security forces killed a Palestinian militant during a raid in the northern West Bank on Thursday, Palestinian health officials said, the latest escalation of violence in what has been the deadliest start of a year for Palestinians in the occupied territory in more than two decades. Israeli forces stormed into the northern city

of Tulkarem, home to an emerging militant group with ties to the armed offshoot of the nationalist Fatah party. The Palestinian Health Ministry said that 25-year-old Amir Abu Khadija was shot multiple times in the head and legs. The Tulkarem branch of Fatah's Al Aqsa Martyrs' Brigades claimed Abu Khadija as its leader.

The Israeli military said Abu Khadija was wanted for recent shooting attacks on Israeli settlements and security forces. Troops raided his hideout apartment in Tulkarem and shot and killed Abu Khadija when he drew his gun, the military said, adding that the army confiscated an M-16 assault rifle and the car he allegedly used to carry out drive-by shooting attacks. Security forces said they also arrested

another member of the militant group.

The militant group said Abu Khadija died in an "armed clash" with Israeli forces.

The ECP said that it "hereby withdraws the election programme and fresh schedule will be issued in due course of time with poll date on October 8."The assemblies in Punjab and the Khyber Pakhtunkhwa provinces were dissolved on January 14 and 18 respectively by the erstwhile govern-ments of Khan's party. The ECP said the decision was



According to the ECP, it contacted the interior and finance ministries for a meeting on March 9, where the special secretary of interior had said that "free, fair and peaceful elections are not possible due to deteriorating law and order situation, charged political environment and serious threats to political leaders."

The finance secretary had cited a paucity of funds and the ongoing financial crunch as a reason for a lack of funds for the elections.

During a heated session, 58-year-old senior Conservative Party MP insisted the events that came under the purview of the scandal were "essential" during the lockdown period as Downing Street doubles up as a workplace and residence.

"I believe it was absolutely essential for work purposes," he said when questioned about a particular event in November 2020. Johnson said the meeting, which happened while social distancing rules were in place, was "necessary" because two senior members of staff were about to leave "in potentially acrimonious circumstances".

is about workers' rights, women's rights, queer rights, and civil rights," said Wahab after introducing the legislation. "We want to ensure organisations and companies do not entrench caste discrimination in their practices or policies, and in order to do that we need to make it plainly clear that discrimination based on caste is against the law," she told reporters at a news conference in Sacramento, California. Small business' NPAs declined in Sept 2022

Quarter saw fall despite high credit growth: Report

PTI ■ MUMBAI

¬he Non-Performing Assets (NPAs) from the small businesses segment have witnessed a decline in the September quarter of this fiscal despite high credit growth, a report said on Thursday.

The micro, small and medium enterprises' (MSME) NPAs declined to 12.5 per cent as of September 2022, as against 13.9 per cent in September 2021, after the devastating second wave of the Covid-19 pandemic, the report by Transunion Cibil said.

The overall disbursements, which excludes loan renewals, grew 24 per cent during the quarter, led by an over 54 per cent in the micro industries segment which have a credit exposure of up to Rs 1 crore, the credit information company said.

The average loan size for the micro segment increased by 34 per cent, and to the small segment by 4 per cent, Cibil said, adding that the same was down 1 per cent in the case of businesses classified as medium primarily because of the emergency credit-linked guarantee scheme loans made during the pandem-



When it comes to credit demand from the MSME segment, which is very crucial for the economy as it supports a bulk of the jobs and has big contributions to the GDP and also exports, there was high activity,

CIC said. Demand for MSME loans, which is measured in terms of the number of commercial credit inquiries, accelerated to about 1.7 times the demand of two years ago during the pandemic, Cibil said.

The total MSME exposure for lenders was up by 10.6 per

cent at Rs 22.9 lakh crore as of September 2022, the CIC said, adding that this excludes Rs 2.5 lakh crore of loans which it classifies as doubtful and the ones in loss category because they have not been paid for over 720

As of now, the top-10 States account for nearly three-fourths of the overall credit to MSME, the company report said. Guiarat saw the maximum growth at 15 per cent, while States like Maharashtra, Karnataka, Delhi and Tamil Nadu were between 6-8 per cent growth in portfo-

Diversified conglomerate ITC Limited is going for climaterisk modelling to identify the hotspots owing to extreme wea-Sanjiv Puri said on Thursday.

Puri said that a team of experts is engaged in this job of modelling comprising big data

Speaking on the sidelines of a CII event, Puri told reporters: "ITC is trying for a climate risk modelling to identify the hotspots. Then steps will be taken to mitigate these issues. A team of experts is working using big data analytics".

Puri said ITC had already done this in 2020 on a macro basis, adding that this exercise will now be conducted on a granular basis and site-specific for its food business.

"Some years back, we had started to work on climatesmart agriculture. After a few years, nearly 70 per cent of the villages where ITC is working with the farmers will be covered The farmers will benefit from high yields resulting in better farmers' incomes," he said.

Puri said this practice will also reduce the emission of greenhouse gases (GHGs).

ITC is working on popularising millet-based products in all categories of its food business in the next few months. Millets are able to withstand extreme weather conditions and are also nutritious, Puri added.

Referring to commodity inflation, Puri said it is cooling off now.

The ITC chairman said presently urban demand is growing at a fast pace while rural demand is expected to pick up. Earlier, he said that the

company has been reporting on the triple bottom line for sustainability on environmental, social and social aspects. "Inclusive and sustainable

growth is the key to long-term success. It is also important how the supply chain adapts to extreme weather conditions," he added.

According to Puri, it is important to bring resilience to agriculture. He also said the energy transition from coal to renewables will involve social and financial costs as well.

"As part of a multipronged approach to address this problem through technical solu-tions, regulations, directions



and close monitoring a meeting with all access providers on the development and implementation of UCC detect solutions by them will be held under the chairmanship of P.D Vaghela, Chairman TRAI...On 27th March 2023," TRAI said in a

UCC is a major source of nconvenience to the public and impinges on the privacy of individuals, the regulator noted.

Govt to exercise green shoe option for HAL OFS; likely to raise ₹2,800 cr

The Finance Ministry on Thursday decided to exercise the green shoe option as the offer-forsale of Hindustan Aeronautics Ltd (HAL) has 4.5 times on day one.

"Offer for Sale (OFS) of Government shares in HAL got great response on day one. Issue subscribed 4.5 times of base size at a clearing price above the floor price by non-retail investors. Government has decided to exercise the green shoe option. Retail investors get chance to bid tomorrow," DIPAM Secretary Tuhin Kanta Pandey said in a tweet.

The OFS comprised of base issue size of 1.75 per cent or 58.51 lakh shares, with an option to retain over-subscription of an equal quantum.

The Government on Wednesday proposed to sell up to a 3.5 per cent stake in HAL at a floor price of Rs 2,450 a share, if fully subscribed, the OFS would fetch about Rs 2,800 crore to the exche-

On the first day of OFS, shares of HAL closed 4.87 per cent down at Rs 2,497.40 each on BSE. The floor price is at a discount of around 6.7 per cent over the closing share price of HAL on

The Government currently holds 75.15 per cent of HAL, which is a Central Public Sector Enterprise (CPSE) under the Defence Ministry. The proceeds from HAL OFS would add up



to the government's disinvestment kitty for the current fiscal.

The Government has so far mopped up Rs 31,106.64 crore from disinvestment and share buyback in CPSEs.

The Government had last month pegged lower revised estimates of disinvestment revenue estimates for the current fiscal at Rs 50,000 crore, against the budget target of Rs 65,000 crore.

Aasked the Ministry of Statistics and Programme Implementation to recruit more field officers in the National Sample Survey Organisation (NSSO) on mission mode for more accurate data collection. The Parliamentary Standing Committee on Finance in its 58th Report on Demand for Grants (2023-24) of the Ministry expressed concern over the shortage of manpower in the Ministry, especially in the senior and junior statistical cadre. The report was tabled in Parliament on Thursday.

NITU, <u>NIKHAT TO FIGHT FOR GOLD</u>

Prominent Indian pugilists Nitu Ghanghas and Nikhat Zareen produced monumental 11 produced monumental displays to record contrasting victories and reach the finals of the Mahindra IBA Women's World Boxing Championship at the Indira Gandhi Sports Complex here on Thursday.

With three consecutive Referee Stops Contest (RSC) wins under her belt, Nitu (48kg) continued her remarkable run at the tournament against the reigning Asian champion Alua Balkibekova of Kazakhstan with a hardearned 5-2 win on points after the bout was reviewed. Having suffered a defeated against the Kazakh in the quarter finals of the last World Championships, the 22-year-old Indian had a point to prove this time round.

Both pugilists were neck and neck in all three rounds and while Balkibekova kept Nitu throughout the bout, the 2022 Commonwealth Games champion kept her cool to get the better of her opponent. The southpaw smartly landed accurate punches and showcased immense grit to reach the finals of the competition for the very first time.

Nitu will now take on the 2022 Asian Championships bronze medallist Lutsaikhan Altantsetseg of Mongolia in the final on Saturday.

Contrary to Nitu's fiercely contested bout, Nikhat (50kg) had an easy day at the office as she continued her quest for back-to-back World Championships gold medals by outpunching the veteran Rio Olympics bronze medallist Ingrit Valencia of Colombia and securing a 5-0 win. Being at the top of her game, the 26-year-old star pugilist utilized her quick movement and stellar strength to control the bout from the

She maintained her composure going into the next few rounds and dominated the bout, giving her Colombian opponent no chance to



make a comeback and sealed the win by unanimous decision. Nikhat will now face the two-time Asian champion Nguyen Thi Tam of Vietnam in the final on Sunday.

Later tonight, the Tokyo Olympics bronze medallist Lovlina Borgohain (75kg) and three-time Asian medallist Saweety Boora (81kg) will be competing in their respective semi-finals bouts. While Lovlina will face the 2018 World Champion and two-time Olympics medallist Li Qian of China, Saweety will square off against Emma-Sue Greentree of Australia.

The on-going prestigious event is witnessing the participation of 324 boxers, including several Olympic medallists, from 65 countries fighting for the titles in the 12 weight categories. The tournament has a massive prize pool of INR 20 crore.

Since boxing doesn't pay much in Australia, boxers have to take up fulltime jobs to keep their sporting \bar{d} ream alive. But working 40 hours a week and also training six days a week takes a toll on the body

"It's really hard because we have to work in Australia, we are not full-time athletes. We are expected to perform in sports but also work full-time. It's very difficult working 40 hours a week and training twice a day, six days a week.

India bagged a silver and a bronze in the ISSF Pistol/Rifle World Cup, with the air pistol mixed team pair of Varun Tomar and Rhythm Sangwan clinching the second spot, while the pair of Rudrankksh Patil and R Narmada Nithin securing the third spot in air rifle event here on Thursday.
India have taken their

medals tally in the competition to four, including one gold, a silver and two bronze. China won both the gold

medals on offer on day two of the competition at the MP

Varun, following his individual bronze-winning effort in air pistol on Wednesday, teamed up with Rhythm to give a tough fight to the Chinese pair of Qian Wei and Liu Jinyao, before going down 11-17 in the air pistol mixed team goldmedal round.

In the initial stages of the final, it looked like the Chinese would enjoy a cakewalk, but the Indians made a strong comeback, going from 7-15 to 11-15 before the Chinese clinched the 15th series to seal the gold.

Earlier in the qualification round, Qian and Liu had topped the nine-team field with a score of 586, while Varun and Rhythm had finished second with 581. "We all try our best and keep

our best foot forward and silver is a medal as well. Gold would have been great but we are happy that we got a silver and we will try to better next time," said Rhythm, one of the most promising pistol shooters in the country, having won four junior team and individual gold medals at the 2021 World Championships in Lima.

"There was pressure obviously, but then we had a really good match — the competition was so good and we quite enjoyed it," said Narmada after the match.

Rudrankksh said there was no lack of motivation even if they did not win gold.

"We were just asked to focus on our process and if we would have got gold we would have been motivated, but the bronze motivates us even more to do better next time," he said.

The second Indian pair in the event — Hriday Hazarika and Tilottoma Sen — shot 628.1 in qualification to finish ninth.

The Chinese team of Huang Yuting and Sheng Lihao won gold, defeating Hungary's Istvan Peni and Denes Eszter 16-2.

Emma Raducanu faces more Einjury worries after exiting the Miami Open in the first round and saying she will seek fresh input on her troubling painful wrist.

Canadian Bianca Andreescu beat Raducanu 6-3, 3-6, 6-2 on Wednesday in a clash of two former US Open champions which produced some moments of quality from the British 20-year-old.

But Raducanu was visibly troubled by her wrist and after leaving the court she said that it was time to consider whether it was no longer an injury she could simply try to play through. "It's something I have been managing for some time. I just need to review after this tournament really and figure out what my next

steps are," she told reporters.

"We have been managing it, keeping on top of it. I'm able to play in the short-term. But the current solutions aren't very viable longterm," she added.

The wrist problem will be particularly frustrating for Raducanu



an upward trend with her run to the last 16 at Indian Wells.

Since winning the US Open in sensational fashion in 2021, Raducanu has been plagued by injuries and fitness problems and they show no signs of ending any time soon.

The 32-year-old Suryakumar was trapped by Australian left-arm pacer Mitchell Starc in the first two ODIs. The team management backed him and included him in the playing XI for the series-decider here on Wednesday, but he was again dismissed first ball, this time by left-arm spinner Ashton Agar.

"He (Suryakumar) played only three balls in the series. I don't know how much you can look into it. He got three good balls," Rohit said after India lost the third and final ODI by 21 runs to concede the series 1-2 to Australia.

"(On Wednesday) I didn't think it was that great a ball. He just chose the wrong shot. He should have, maybe, come forward. He knows best."

Suryakumar has featured in 23 ODIs after his debut in July 2021, scoring 433 runs at a below-par average of 24.05. Rohit said Suryakumar was

Rohit doubts any national team player will opt out of IPL to manage workload

Indian team's growing injury list is "concerning" but captain Rohit Sharma doubts any player will opt out of the IPL games to manage workload when the high-profile T20 league begins on March 31.

From Jasprit Bumrah to Shreyas Iyer, the number of injured national team players is mounting, and Rohit said the onus is on the IPL franchise owners and players themselves to manage workload ahead of the ODI World Cup the country is hosting in October-November.

"It is concerning. We are missing the players who are actually the playing XI players," Rohit said after India lost the third ODI against Australia by 21 runs on Wednesday to concede the series 1-2.

"They (players) are all adults. So they have to look after their body and just if they feel that it's getting a little too much, they can always talk about it and have a break in one or two games. I doubt (if) that will happen but...," the captain said without mincing

Following the IPL which ends on May 28, the Indian players will get little over a week to get ready for the World Test Championships final to be played at the Oval in London from June 7. Rohit said the Indian team

management has given "indications" to the IPL franchise owners about workload management of the players, keeping the 50-over showpiece in

"It's all up to the franchises now. The franchises own them (the players) now, so we've given some indications or some kind of borderline

"At the end of the day it's up to the franchise and, most importantly it's the players, they have to take care of their

While India missed the services of Bumrah for the entire bilateral series against Australia, Iyer's back injury resurfaced during the fourth

and final Test in Ahmedabad and he missed the subsequent three ODIs. "Honestly, everyone is trying their best to get everyone on the park. We've been focusing a lot on management of the players, which is why we have to rest certain players at certain point of time," the captain said.

"From our side, we could do our best in terms of handling them. But, I am not a specialist to tell you why recurring injuries are happening. The medical team of ours is look-ing into all of this and making sure that, come the World Cup, we've got our best 15

players ready."

Iyer first felt discomfort on his lower back last December and then missed the ODI series against New Zealand at home and the opening Test against Australia.

Iyer, who captains Kolkata Knight Riders, is likely to miss some games of the IPL due to the recurring injury.

"Obviously when you play so much cricket injuries are bound to happen. So not looking too much into it ... what's available to you, what's in your hand, you can control that, and we are just trying to control all of that," Rohit said.

"Players are frustrated as well. They want to play, they don't want to miss out. So it's a little sad, but at the end of the day, you cannot really do too

Rohit said the medical team is doing everything possible to ensure the well being of the players.

"I can see, and I can vouch for it, that the people working behind the scenes are working really hard with all these players, and freakish injury can happen at any point in time, like Shreyas (Iyer) was the

"He was sitting the whole day and he just went to take a knock and the injury happened to him. And there's nothing you could do about it, the only thing we can keep in mind is managing players and giving them enough breaks. And I think from our side we're

Bairstow to miss entire IPL Livingstone cleared: Report

 $P^{\text{rolific England batter Jonny}}_{\text{Bairstow will miss the entire}}$ IPL this year as his cricket board refused to grant him No Objection Certificate (NOC) to play in the high-profile T20 league beginning on March 31, according to a report.

The 33-year-old Bairstow is recovering from a leg injury he sustained in September last year.

The England and Wales Cricket Board (ECB), however, cleared all-rounder Liam Livingstone, who is coming back after recovering from his knee and ankle injuries, to play in the IPL.

Punjab Kings had bought Livingstone and Bairstow for Rs 11.50 crores and Rs 6.75 crores respectively during the IPL auc-

tion.
"Punjab Kings have some bittersweet news as England and Wales Cricket Board (ECB) has cleared Liam Livingstone for participation in the upcoming Indian Premier League (IPL) but has stopped Jonny Bairstow from taking part," a report in cricbuzz said on Thursday.

"...Given the long injury

to issue him (Bairstow) the NOC for the season, which kicks off on March 31.'

Bairstow missed England's T20 World Cup-winning campaign and Test tours of Pakistan and New Zealand after sustaining multiple fractures following a freak slip on the golf course in September 2022. Bairstow, who underwent

surgery on his his broken leg and dislocated ankle in October last, is expected to be up and running in a couple of weeks' times, according to the report. The 29-year-old Livingstone too had a stop-start season in 2022 after hurting his ankle during the Hundred tournament in the UK. He has been out of action since the Rawalpindi Test last December because of injuries.

He was part of the Lanca-shire County Cricket Club's offseason training recently in Dubai. The report also said that Sam Curran, who was the most expensive buy at the IPL auction earlier this year, will be available for Punjab Kings, who splurged Rs 18.50 crore for the fast bowl-

India lost the third and final ODI by 21 runs in Chennai on Wednesday to concede the series 1-2 to Australia, and batting legend Gavaskar said Rohit Sharma's men could be up against the same opponents in

the 50-over World Cup which the country is hosting in October-November.

"Of course, now the IPL starts (March 31). This (series defeat) shouldn't be forgotten. India sometimes makes the mistake of forgetting this, but this one shouldn't be because in the World Cup, we may face Australia again," said Gavaskar on Star Sports.

Shubman can be future leader for Gujarat Titans: Solanki

 \mathbf{Y} oung India opener Shubman Gill has "smart cricketing brain" and can emerge as leader of the Gujarat Titans in the future due to his conduct and work ethics, said the IPL team's director of cricket Vikram Solanki on Thursday.

Gill has become an integral part of the Indian side over the last six months or so given his all-round performances which includes a double century against New Zealand in ODIs. He also had a successful outing with the Gujarat Titans in their title-winning cam-

paign last year. While Pandya is set to continue as GT skipper in their second IPL season, Gill is also being seen as a leader within the core group.

"Shubman is a leader in his own right for the simple fact that he takes on a lot of responsibility. In my mind, it is not important that you play with an asterisk next to a player's name," Solanki told reporters

during a virtual media session on Thursday.
"Shubman adapted the leadership role last year,

by his conduct, by the way he goes about, with his professional attitude towards the game.'

The right-handed batter finished just four runs behind Gujarat Titans captain Hardik Pandya in the list of highest run-getters, smacking 432 runs in 16 matches at 132.32 with four fifties.

"Do I think that Shubman will be a leader in the future? Yes absolutely, but no decision has been made about that as yet. He has leadership qualities and is very mature who has an abundant amount of talent," Solanki said.

"He has a very smart cricketing brain and we will continue to have conversations with Shubman and invite his opinion on every decision we make.'

According to the new IPL playing conditions issued by BCCI, "Each captain shall nominate 11 players plus a maximum of 5 substitute fielders in writing to the IPL Match Referee after the toss.'

Solanki, the former England international, said the new rule will change dynamics of the IPL.

We will just have to wait and see. It is going to be an interesting change to the dynamics, it might bring (forth) some tactical decisions to be made. But essentially the way we are looking at it at the

moment is that you can name your eleven or a bigger squad of 15 after the toss and that has a different bearing on it.

"Initially we are starting to have discussions around it but it will bring an interesting dynamic to the IPL this year. It will be interesting to see how different teams adapt to the rule.

Solanki said there are no injury concerns in the Gujarat Titans squad with star batter David Miller being the last player to join the squad.

Miller will miss the opening game against Chennai Super Kings due to national commitments. "In terms of preparations, all teams are on the

same page. We are setting out to give ourselves the best opportunity of giving a good account of ourselves. Chennai will be no different, we are no different. Chennai will be in equal amounts of pressure as us in that first game.'

With India hosting the ODI World Cup in October-November, workload management of the key national players will be important. Mohammad Shami is one such player, who is

coming into the IPL after playing three Tests and as many ODIs against Australia and Solanki said that the franchise will monitor the India pacer. "He was quite outstanding for us last year. You

just have to wait and see what the situation is, we have to be respectful of the fact that fast bowling is a very demanding job," Solanki said.

"He is coming off a lot of cricket, we got to make sure we do the best for Mohammad Shami so that he can, in turn, do the best for Gujarat Titans. He will be one of those players we will monitor carefully with every preparation, every resource so that he is in best possible place for every game."
