# Din in House: 11 TDP **MLAs suspended**

Eleven TDP MLAs were suspended from the House for the fourth consecutive day by Assembly Speaker Tammineni Sitaram on Saturday for one day. The House proceedings started with question hour, soon after the question hour began, the TDP legislators proposed an adjournment motion to discuss details of Chief Minister Jagan Mohan Reddy's visit to Delhi.

Kancharla Srikanth won the Prakasam-Nellore-Chittoor Graduates' constituency Legislative Council election, said an official on Saturday.

Counting of the votes for the biennial poll started at 8 a.m on Thursday and continued till 2 a.m on Saturday, in which Srikanth defeated his near-

est competitor Shyam Prasad Reddy Pernati by a majority of 34,110 votes, said the official.

Out of 2,48,360 votes, Srikanth bagged 1,24,181 and Pernati 90,071 votes, said the returning officer and Chittoor District Collector M Hari Naravan.

Polling for eight MLC seats - three Graduates, two Teachers and three local Authorities' constituencies - in

# Freak rain, strong winds deal a severe blow to farmers

Even as the mango growers are affected by low yields this year, strong winds and unseasonal rain in the wee hours of Saturday have made matters worse for them with extensive damage to the existing crop in the erstwhile Krishna district.

Mango is the major horticultural crop in Krishna district, with the area under the crop being 62,270 hectares. Most of the orchards are old and unproductive. Due to the lack of yield, mango harvesting could not be sped up in Krishna district and farmers are ready to harvest mangoes by the end of March.

Meanwhile, the untimely rain with strong winds caused them to fall to the ground. Mango farmers are worried about a huge loss for them and they are worrying about their investments in mango gardens. In some areas of the district, branches of the mango trees were broken and fell and



scores of mangoes fell on the ground.

According to mango farmers, untimely rains accompanied by strong winds, have occurred across the district. A large number of mangoes fell to the ground. Heavy rainfall has been recorded in the combined Krishna district that caused loss for the mango farmers. Unexpected strong

they are gearing up for special pujas on the occasion of the upcoming Ugadi. On that day, traders performed 'Dastram' and started their mango business activities.

"After harvesting the man-goes, farmers are selling their yield to traders at Rs 50,000 per

However, the prices may dip," said a farmer Madu Sivaramaiah. "Buyers are coming from Maharashtra, Rajasthan, Madhya Pradesh, Haryana, New Delhi, and other states. The mango harvesting will continue up to the end of June," he said.

He said that the mango yield is low this year. If the prices do not increase, farmers may lose heavily, he said.

Another mango farmer D Venkateswara Rao from Nuzvid said that despite the farmers taking quality mangoes to the market, the prices have fallen due to the untimely rain. The situation will continue for more than one week,

The prime minister also unveiled a customised postal stamp and Rs 75 currency coin to mark International Year of Millets celebrated this

Hyderabad-based ICAR-Indian Institute of Millets Research was also declared as a Centre of Excellence. Speaking about the food security challenges faced by the world, Modi said: "We are aware that the world today is facing two types of challenges. On one hand, there is a Global South which is concerned about food security for the poor, on the other hand there is Global North where diseases related to food habits is becom-

ing a serious problem. On one side, there is a challenge of food security and on the other side the problem of food habit. Both sides have

# It remains "very fragile": EAM on LAC situation of understandings and even





Adequate rest, simple home-cooked fresh food, and proper hydration are advised for recuperation at home, doctors tell THE HEALTH PIONEER


he health experts said that the first sign of influenza virus is usually a high fever, which begins about four to five days after exposure to the virus and lasts 10 to 15 days. A runny nose, a cough, red and watery eyes, and facial swelling can develop in the initial stage. They added that people at higher risk of developing complications include children younger than 5 years, people 65 years and older, pregnant people, and people with certain long-term health conditions like asthma, diabetes, heart disease, weakened immune systems, and neurological or neuro-developmental problems.

Dr Jugal Kishore Director Professor and Head of Department of Community at Safdarjung Hospital, Delhi said that precaution is a key word. It is crucial to avoid crowded places, travel only if necessary, practice good hand and respiratory hygiene, and seek medical advice if symptoms persist for more than two days.

"There is a surge of H3N2 cases in the region now, but the severity of such cases is less.

What is the H3N2 virus? According to the World Health Organisation (WHO), seasonal influenza is an acute respiratory infection caused by influenza viruses. There are 4 types of seasonal influenza viruses, types A, B, C and D. Influenza A and B viruses circulate and cause seasonal epidemics of disease. Influenza A viruses are further classified into subtypes according to the combinations of the hemagglutinin (HA) and the neuraminidase (NA), the proteins on the sur-

face of the virus. How Does The Virus Transmit? H3N2 Influenza virus transmitted mainly through infected droplets created when infected pigs

The World Health Organisation, too, recommends that the most effective way to prevent infection with any virus is to get vaccinated and follow prevention measures: "Maintaining at least a 1-metre distance from others, wearing a well-fitted mask when keeping your distance is not possible, avoiding crowded and poorly ventilated places and settings, opening windows and doors to keep rooms well ventilated and cleaning your hands frequently." It also advises that people should follow the advice of your local authorities on getting influenza and Covid-19 vaccines".

As per the World Health Organisation (WHO), cancer is the second most common cause of death globally with cases increasing every year in India as in the world.

Looking at cancers occurring in females, globally breast cancer tops the list followed by colorectal and lung cancers whereas in India, breast cancer is the leading and cervical cancer is the second most common cancer followed by ovary, head neck and colorectal cancers.

When it comes to cancer prevention, it is important to understand the risk factors for these diseases. Breast cancer

occurs more commonly in urban population then rural, pointing towards the westernization and changes in lifestyle that is contributory. Also the reproductive habits have changed in India. The older a woman is when she has her first full-term pregnancy, the higher her risk of breast cancer, no/fewer children, no breastfeeding. Poor genital hygiene, multiple births, multiple sexual partners are causative for cervical cancers. Consumption of saturated fats, processed foods, red meat, sedentary lifestyle being risk factors for breast and colorectal, as well as ovarian cancers to some extent. Smoking, tobacco chewing, alcohol are leading cause for head, neck and lung cancers. Family history is another important factor in breast, colorectal and ovarian cancers in few cases.

Amongst risk reduction/ cancer prevention strategies that need to be followed, the first and foremost is leading a healthy lifestyle which means, no addictions, healthy diet with adequate



fibers, fruits and vegetables, minimal processed food, low red meat, avoiding constipation. Also moderate amount of exercise in our daily routine for around 30 minutes is recommended to maintain a healthy weight and keep many diseases away, not just cancer. Healthy reproductive habits and good genital hygiene, having children timely, limiting the number of births, avoiding high risk sexual behavior is equally important.

Following a routine of get-ting yourself tested regularly, termed as screening for breast and cervical cancers should be done by all females. Mammo-

graphy for breast cancer should be undertaken at the age of 45 years, thereafter done once in two years, till the age of 74 years as per USPSTF. Also PAP Smear for cervical cancer should be done for all sexually active females once in 3 years till the age of 65 years. These are simple tests which can detect very early lesions, sometimes even before they become cancerous. Screening for colorectal cancers using a test called colonoscopy is recommended for all those touching 45 to 50 years, done once in 5 to 10 years till the age of 75 years. In case of a positive

family history, these tests should

start 10 years earlier than the

Another very effective preventive tool available for cervical cancers is HPV vaccine for all girls, starting at the age of 9 years and given as two doses till 15 years or three doses till the age of 26 years. We need to educate our daughters to be aware of their bodies and start breast self-examination once a month to understand what is normal for their body and to consult a doctor in case they notice or feel any abnormality. Breast self-examination should to be done by all females on a regularly basis once a month

after their periods starts. Head neck cancers would most of the times present with a non-healing ulcer, pain or difficulty in swallowing. These complaints should be addressed by an expert at the earliest. With increasing pollution and smoking in females, lung cancer in females is also on increase.

To summarise, cancer in women is largely preventable by following a healthy lifestyle, regular screening tests, timely vaccination and self-examination.



DR RP PARASHER CMO (Ayurveda), MCD

As per Ayurveda, a state of Aequilibrium of Vata, Kafa and Pitta in the body denotes health. When any of the three increases or decreases, we may fall ill. Kafa is deposited all over the body during the winter season. The warmth of spring melts the kafa which is the cause of diseases like cough, cold, asthma and other ailments of the respiratory tract. That's why the level of immunity is lowered during change of season and people, especially the children & the elders fall ill easily. People, whose lungs have become weak due to corona infection, are more prone to catch the viral infection. Such types of patients are also facing problems like breathlessness and low levels of oxygen. Since it is a droplet infection, it spreads very fast. If a kid suffering from H3N2 infection attends school, he may spread the infection to a large number of students. Similarly if one member of a family gets infected, the whole family is likely to fall till.

How to avert the infection: Keeping a vigil on feeding and living habits will definitely avert the infection. Observing covid appropriate behaviour is necessary which includes wearing of masks, regular cleaning of hands, avoid hands shake, etc. Cold drinks, ice creams and refrigerated items must be avoided. Do not consume items of cool temperament like rice, kadhi, curd, cauliflower peanuts, arhar daal, etc.

Never use cold water just after consuming fried foods. In case of viral infection, alum or saline gargles in warm water will help to reduce inflammation of the throat and the respiratory tract. Tulsi, Ginger, clove, pippali, cinnamon bark and kali mirch boiled in water, milk or tea will also give relief. Hot soups of tomato and other seasonal vegetables will increase immunity on one hand and reduce inflamother hand. Fruits like Amla, Giloy, Anjir, resins, grapes and oranges will provide immunity and strength to the body.

Ayurvedic treatment: Ayurvedic drugs are capable of treating the infection within three to five days. Medicines like Sitopaladi churan, Talishadi churan, Laxmivilas Ras, Kafketu Ras, Sanjeevani Vati, Sudarshan ghan vati, Trilokyachintamani ras, Sameerpannag ras are quite effective to treat the infection. Chyavanprash, Vasa Avleha, Agastya Haritki provide relief in cough and cold within a few If chewed, Aladi Vati,

Lavangadi vati and Vyoshadi vati provide instant relief in cough. Ayurvedic cough syrups containing Tulsi, vasa, jufa, pippali, mulethi, somlata, kantkari are quite effective and safe even in children and elders.

own Syndrome (DS) is a condition in which extra genetic material causes delays in the mental and physical development of a child. One of the most common genetic disorders, the condition is characterised by the presence of an extra 21st chromosome. It is not a disease and there is no way to prevent it. More and more countries are banning TikTok citing data security risks. Should users be worried that the app will be wiped off their phones, writes HALELUYA HADERO

ikTok is once again fending off claims that its Chinese parent company, ByteDance, would share user data from its popular videosharing app with the Chinese government, or push propaganda and misinformation on its behalf.

China's Foreign Ministry on Wednesday accused the United States itself of spreading disinformation about TikTok's potential security risks following a report in the Wall Street Journal that the Committee on Foreign Investment in the US — part of the Treasury Department — was threatening a US ban on the app unless its Chinese owners divest their stake.

So are the data security risks real? And should users be worried that the TikTok app will be wiped off their phones?

#### WHAT ARE THE CONCERNS ABOUT

Both the FBI and the Federal Communications Commission have warned that ByteDance could share TikTok user data — such as browsing history, location and biometric identifiers — with China's authoritarian government.

A law implemented by China in 2017 requires companies to give the government any personal data relevant to the country's national security. There's no evidence that TikTok has turned over such data, but fears abound due to the vast amount of user data it, like other social media companies, col-

Concerns around TikTok were heightened in December when ByteDance said it fired four employees who accessed data on two journalists from Buzzfeed News and The Financial Times while attempting to track down the source of a leaked report about the company.

#### **HOW IS THE US RESPONDING?**

White House National Security Council spokesperson John Kirby declined to comment when asked Thursday to address the Chinese foreign ministry's comments about TikTok, citing the review being conducted by the Committee on Foreign Investment.

Kirby also could not confirm that the administration sent TikTok a letter warning that the US government may ban the application if its Chinese owners don't sell its stake but added, "we have legitimate national security concerns with respect to data integrity that we need to observe."

In 2020, then-President Donald Trump and his administration sought to force ByteDance to sell off its US assets and ban TikTok from app stores. Courts blocked the effort, and President Joe Biden rescinded Trump's orders but ordered an in-depth study of the issue. A planned sale of TikTok's US assets was also shelved as the Biden administration negotiated a deal with TikTok that would address some of the national security concerns.

In Congress, US Sens. Richard Blumenthal and Jerry Moran, a Democrat and a Republican, wrote a letter in February to Treasury Secretary Janet Yellen urging the Committee on Foreign Investment panel, which she chairs, to "swiftly conclude its investigation and impose strict structural restrictions" between TikTok's American operations and ByteDance, including potentially separating the companies.

At the same time, lawmakers have introduced measures that would expand the Biden administration's authority to enact a national ban on TikTok. The White House has already backed a Senate proposal that has bipartisan support.


#### HOW HAS TIKTOK ALREADY BEEN

RESTRICTED? On Thursday, British authorities said they are banning TikTok on government-issued phones on security grounds, following similar moves by the European Union's executive branch, which temporarily banned TikTok from employee phones. Denmark and Canada have also announced efforts to

block it on government-issued phones. Last month, the White House said

it would give US federal agencies 30 days to delete TikTok from all government-issued mobile devices. Congress, the US armed forces and more than half of US states had already banned the

#### WHAT DOES TIKTOK SAY?

TikTok spokesperson Maureen Shanahan said the company was already answering security concerns through "transparent, US-based protection of US user data and systems, with robust third-party monitoring, vet-

ting, and verification." In June, TikTok said it would route all data from US users to servers controlled by Oracle, the Silicon Valley company it chose as its US tech partner in 2020 in an effort to avoid a nationwide ban. But it is storing backups of the data in its own servers in the US and Singapore. The company said it expects to delete US user data from its own servers, but it has not provided a timeline as to when that would

TikTok CEO Shou Zi Chew is set to testify next week before the House Energy and Commerce Committee about the company's privacy and datasecurity practices, as well as its relationship with the Chinese government.

Meanwhile, TikTok's parent company ByteDance has been trying to position itself as more of an international company — and less of a Chinese company that was founded in Beijing in 2012 by its current chief executive Liang Rubo and others.

Ťheo Bertram, TikTok's vice president of policy in Europe, said in a Tweet Thursday that ByteDance "is not a Chinese company." Bertram said its ownership consists of 60% by global investors, 20% employees and 20% founders. Its leaders are based in cities like Singapore, New York, Beijing and other metropolitan areas.

#### **ARE THE SECURITY RISKS LEGITIMATE?**

It depends on who you ask. Some tech privacy advocates say while the potential abuse of privacy by the Chinese government is concerning, other tech companies have data-harvesting business practices that also

exploit user information. "If policy makers want to protect Americans from surveillance, they should advocate for a basic privacy law that bans all companies from collecting so much sensitive data about us in the first place, rather than engaging in what amounts to xenophobic showboating that does exactly nothing to protect anyone," said Evan Greer, director of the nonprofit advocacy group

Fight for the Future. Karim Farhat, a researcher with the Internet Governance Project at Georgia Tech, said a TikTok sale would be "completely irrelevant to any of the alleged 'national security' threats" and go against "every free market principle and norm" of the state department's internet freedom principles.

Others say there is legitimate reason for concern.

People who use TikTok might think they're not doing anything that would be of interest to a foreign government, but that's not always the case, said Anton Dahbura, executive director of the Johns Hopkins University Information Security Institute. Important information about the United States is not strictly limited to nuclear power plants or military facilities; it extends to other sectors, such as food processing, the finance industry and universities, Dahbura

#### IS THERE PRECEDENCE FOR BANNING **TECH COMPANIES?**

Last year, the US banned the sale of communications equipment made by Chinese companies Huawei and ZTE, citing risks to national security. But banning the sale of items could be more easily done than banning an app, which is accessed through the web.

Such a move might also go to the courts on grounds that it might violate the First Amendment as some civil liberties groups have argued.

#### **China appeals for** fair treatment

China appealed Friday to other governments to treat its companies fairly after Britain and New Zealand joined the United States in restricting use of TikTok due to fears the Chinese-owned short video service might be a security

Governments are worried TikTok's owner, ByteDance, might give browsing history or other data about users to China's government or promote propaganda and disinformation.

"We call on the countries concerned to recognize the objective facts, effectively respect the market economy" and provide "a non-discriminatory environment" for all companies, said foreign ministry spokesperson Wang

Wenbin. TikTok is one focus of conflicts between China and other governments over technology and security that are disrupting processor chip, smartphone

and other industries. Legislators and employees in New Zealand's Parliament will be prohibited from having TikTok 's app on phones, the government said Friday. Britain announced a ban Thursday on TikTok on all government phones.

India has banned TikTok and dozens of other Chinese apps, including the WeChat message service, on security and privacy grounds.

The United States also has imposed restrictions on access by Chinese companies to processor chip and other technology on security and human rights

The Chinese government accused Washington of spreading false information about TikTok following a report by The Wall Street Journal that US authorities were considering a ban if ByteDance doesn't sell the company.

The ruling Communist Party blocks most internet users in China from seeing TikTok and thousands of social media and other websites. ByteDance operates a sister short-video service, Douyin, that can be seen in China.

#### Why is it so dangerous to take Darien Gap?

First of all, it is a long mountainous tract. Therefore, for many, it becomes really difficult to survive while journeying. The emigrants die in the Darien Gap and their remains are neither recovered nor reported by anyone.

Fifth, rape and other violence are rampant in this jungle tract.

of the International Organization of Migration (IOM), the number of people who crossed the tract doubled in a year in 2022. Sources from the Panama Government say nearly 2,50,000 people entered the country from South

1,33,000 in the year 2021. The number Venezuelans who crossed this Gap increased over 50 times in 2021 and reached up to 1,55,327 in 2022. It is followed

by other countries such as Ecuador, Haiti and Cuba.

In a seminal report brought out by Massachusetts Institute of Technology (MIT) in 2021, it was found that economic concerns force people from Central America to the US. Some of the top countries from where the maximum number of emigrants crosses over to America are El Salvador, Guatemala and

Honduras. The report "Charting a New Regional Course of Action: The Complex Motivations and Costs of Central America Migration"

clearly says 89 per cent of the people consider the US as the first choice of migration. It is found that about 55 per cent of the emigrants took the help of illegal routes and they spent nearly \$7,500 per attempt to emigrate. Once they immigrated to their dream land, their home countries also start earning in the form of foreign

remittances Astonishingly, these Northern Triangle countries force people to immigrate mainly because of economic precariousness, crime, violence and finally, corruption propelled by government agencies. Again the two years of Covid-19 pandemic has led to the

these nations to the US. In comparison to 8 per cent in 2019, almost 43 per cent of the people considered emigrating in 2021.

Further food insecurity is one of the major reasons that

compels people to leave their Central American homes. The World Food Programme (WFP) launched by the UN in the year 1961 to alleviate poverty finds that almost 6.4 million people suffered from food insecurity in Honduras, El Salvador and Guatemala in 2021, up from 2.2 million in 2019. This rightly underlines that more and more people are considering migration as the only option to find a better life.

It has been reported that messages and social media outlets like Facebook, WhatsApp, etc, have become the main sources for the emigrants when they plan their "Hope Trip" towards the north i.e. the US. Many of them also upload videos in TikTok to inspire fellow emigrants and also to warn them about the possible risks en route to the

Ironically, these voyages are difficult for both the emigrants and the refugees as the bordering nations have tightened their controls on the check posts. And this has forced them to take the help of informal and dangerous routes through criminal agents by paying huge sums of money. Emigrants risk death on their long and arduous journey to the blessed land of the US.

Today, the Darien Gap is opularly known as the deadly extension of the US border. The US Government is putting all its efforts to fortify it so as to stop the migrants from crossing into its mainland. But now the question is where these poor and helpless people will go? They see no future in their lands. Only hope for them lies in reaching the US.

It is time to address the vulnerabilities in the Darien Gap. The governments concerned and human rights groups need to encourage emigrants and the refugees to take the formal route to save the precious human lives.

# Iraqis see signs of hope 20 years after US invasion

Half of today's population in Iraq are not old enough to remember life under Saddam Hussein. In interviews from Baghdad to Fallujah, young Iraqis deplored the chaos that followed Saddam's ouster, but many were hopeful about nascent freedoms and opportunities, writes John Daniszewski

 $A_{young\ Iraqi\ men\ and}^{long\ the\ Tigris\ River,}$  bullish. Conversations start with bitterness about how the women in jeans and sneakers danced with joyous abandon on a recent evening to a local rapper as the sun set behind them. It's a world away from the terror that followed the US

invasion 20 years ago. President George W Bush called the US-led invasion launched March 20, 2003, a mission to free the Iraqi people. It threw out a dictator whose rule kept 20 million people in fear for a quartercentury. But it also broke a unified state in the heart of the Arab world. About 300,000 Iraqis were killed between 2003 and 2023, along with more than 8,000 US military, con-

tractors and civilians. Half of today's population are not old enough to remember life under Saddam Hussein. In interviews from Baghdad to Fallujah, young Iraqis deplored the chaos that followed Saddam's ouster, but many were hopeful about nascent

freedoms and opportunities. In a chandeliered reception room, President Abdul Latif Rashid, who assumed office in October, spoke glowingly of Iraq's prospects. Perception of Iraq as a war-torn country is Associated Press: "Iraq is rich; peace has returned."

If young people are "a little bit patient, I think life will improve drastically in Iraq." Most Iraqis aren't nearly as

US left Iraq in tatters. But speaking to younger Iraqis, one senses a generation ready

to turn a page. Safaa Rashid, 26, is a writer who talks politics with friends at a coffee shop in Baghdad's Karada district. After the invasion, Iraq lay broken, violence reigning, he said. Today is different; he and like-minded peers freely talk about solutions. "I think the young people will try to fix this situation."

Noor Alhuda Saad, 26, a PhD candidate and political activist, says her generation has been leading protests decrying corruption, demanding services and seeking inclusive elections — and they won't stop until they've built a better Iraq.

Blast walls have given way to billboards, restaurants, cafes, shopping centres. With 7 million inhabitants, Baghdad is the Middle East's second-largest city; streets teem with com-

In northern and western Iraq, there are occasional clashes with remnants of the Islamic State group. It is but one of Iraq's lingering problems. Another is corruption; a 2022 audit found a network of forfrozen in time, he told *The* mer officials and businessmen stole \$2.5 billion.

# How a warrant for Putin puts new spin on Xi visit to Russia

PNS WASHINGTON

Chinese President Xi Jinping's plans to meet with Russian President Vladimir Putin in Moscow next week highlighted China's aspirations for a greater role on the world stage.

But they also revealed the perils of

global diplomacy: Hours after Friday's announcement of the trip, an international arrest warrant was issued for Putin on war crimes charges, taking at least some wind out of the sails of China's big reveal.

The flurry of developments which followed China's brokering of an agreement between Saudi Arabia and Iran to resume diplomatic relations and its release of what it calls a "peace plan" for Ukraine came as the Biden administration watches warily Beijing's moves to assert itself more forcefully in international affairs.

US President Joe Biden said on Friday he believes the decision by the International Criminal Court in The Hague to charge Putin was "justified."

Speaking to reporters as he left the White House for his Delaware home, he said Putin "clearly committed war crimes.

While the US does not recognise the court, Biden said it "makes a very strong point" to call out the Russian leader for his actions in ordering the invasion of Ukraine. Other US officials privately

expressed satisfaction that an international body had agreed with Washington's assessment that Russia has committed war crimes and crimes against humanity in Ukraine.

Asked about the Xi-Putin meeting, Biden said, "Well, we'll see when that meeting takes place.'

The Biden administration believes China's desire to be seen as a broker for peace between Russia and Ukraine may be viewed more critically now that Putin is officially a war crime suspect, according to two U.S. officials. The officials, who spoke on condition of anonymity because they were not authorized to speak to the matter pub-



licly, said the administration hopes the warrants will help mobilize heretofore neutral countries to weigh in on the

A look at the Xi-Putin meeting and how it may be affected by the warrant.

#### WHAT IS THE SIGNIFICANCE OF XI MEETING WITH PUTIN?

The visit to Russia will be Xi's first foreign trip since being elected to an unprecedented third term as China's

It comes as Beijing and Moscow have intensified ties in steps that began shortly before Russia's invasion of Ukraine with a meeting between the two leaders in Beijing during last year's Winter Olympics at which they

declared a "no limits" partnership. Since then, China has repeatedly sided with Russia in blocking international action against Moscow for the Ukraine conflict and, US officials say, is considering supplying Russia with weapons to support the war.

But it has also tried to cast itself in a more neutral role, offering a peace plan that was essentially ignored. The meeting in Moscow is likely to

see the two sides recommit to their partnership, which both see as critical to countering what they consider undue and undeserved influence exerted by the US and its Western

In the immediate term, the ICC's warrant for Putin and one of his aides is unlikely to have a major impact on the meeting or China's position toward Russia. Neither China nor Russia nor the United States or Ukraine has rat-

ified the ICC's founding treaty. The US, beginning with the Clinton administration, has refused to join the court, fearing that its broad mandate could result in the prosecution of American troops or officials.

That means that none of the four countries formally recognises the court's jurisdiction or is bound by its orders, although Ukraine has consented to allowing some ICC probes of crimes on its territory and the US has cooperated with ICC investigations.

In addition, it is highly unlikely that Putin would travel to a country that would be bound by obligations to the

If he did, it is questionable whether that country would actually arrest him. There is precedent for those previously indicted, notably former Sudanese President Omar Bashir, to have visited ICC members without being detained



# Sea level rise could sink significant parts of deltas

Relative sea level rise, caused by local drivers, together with global sea level rise, could cause significant parts of the world's largest deltas to fall below the rising sea before the turn of the century, according to a new

Relative sea level rise also takes into account sinking lands which amplify the effect of rising seas.

Local drivers such as groundwater pumping and extraction of hydrocarbons creates subsidence, and coastal vegetation, which can provide some protection, is lost to make space for farmland and tourism.

Scientists of the Stanford University-led study have found overwhelming evidence that it is not sea level rise, rather sinking land, that puts global deltas most at risk.

While climate change is increasingly recognized as a risk to coastal livelihoods and global wealth and security, this is only one part of the story.

This is of great importance for managing river deltas, according to Rafael Schmitt, lead author of the study, a lead scientist with the Stanford

Natural Capital Project.

"It is often not rising seas, but sinking land due to human activities that puts coastal populations most at risk," said

"Our research highlights that this relevant global risk is grossly understudied for all but very few coastal regions," said Schmitt. Little is known about local and regional drivers of relative sea level rise.

So, Schmitt's study set out to identify key drivers of land loss and vulnerability across the world's major deltas, and the knowledge gaps impeding more sustainable delta management, for specific deltas and on a global scale.

Under natural conditions, deltas are subject to a number of factors that together create dynamic but stable systems.

For instance, sediment supplied from upstream river basins builds new land even when sea levels are rising. Sediment supply is also critical to offset the effect that the recent, unconsolidated delta land compacts continuously under its own weight.

Today, all of these processes are out of balance.

River deltas are cut off from

their natural sediment supply by dams and reservoirs, and the little sediment still reaching deltas cannot spread because of artificial levees and dikes.

The livelihoods of millions of people who live in river deltas, among the world's most productive lands, are at risk.

Created where large rivers meet the ocean and deposit their natural sediment load, river deltas are often just a few meters above sea level.

While they make up less than 0.5 per cent of the world's land area, river deltas contribute more than 4 per cent of the global GDP, 3 per cent of global crop production, and are home to 5.5 per cent of the world's population.

All of these values are highly vulnerable to imminent global environmental change, the study said.

Of course, climate mitigation is important to curb global sea level rise.

However, fighting overuse of local natural resources in river deltas and their contributing basins would have much greater and more immediate effects, posing both an opportunity and a responsibility for coastal nations, the study said.

# Odour molecule could help decipher sense of smell

Scientists have created the first molecular-level, 3D picture of how an odour molecule activates a human odorant receptor, a crucial step towards

The scientists help break a longstanding impasse in our understanding of olfaction and the 3D picture created has implications for fragrances, food science, and beyond.

The model, created by scientists at University of California San Francisco (UCSF), US, is poised to reignite interest in the science of smell.

The findings have been published in the journal Nature.

Odorant receptors, proteins that bind odour molecules on the surface of olfactory cells, make up half of the largest, most diverse family of receptors in our bodies. A deeper understanding of them paves the way for new insights about a range of biological process-

Smell involves about 400 unique receptors.

Each of the hundreds of thousands of scents we can detect is made of a mixture of different odour molecules. Each type of molecule may be detected by an array of receptors, creating a puzzle for the brain to solve each time the nose catches a whiff of some-

"It's like hitting keys on a piano to produce a chord," said Hiroaki Matsunami, professor at Duke University and a



close collaborator of Aashish Manglik, associate professor,

Matsunami's work over the past two decades has focused on decoding the sense of smell. "Seeing how an odorant receptor binds an odorant

fundamental level," said Matsunami. We haven't been able to map olfaction, because without a picture, said Manglik, we didn't know how odour molecules

would react with their corre-

sponding odour receptors. To create the 3D picture, the study said, Manglik's lab used a type of imaging called cryoelectron microscopy (cryo-FM), that allows researchers to see atomic structure and study

But before Manglik's team could visualize the odorant receptor binding an odorant, they first needed to purify a sufficient quantity of the recep-

the molecular shapes of pro-

Odorant receptors are noto-

riously challenging, some say impossible, to make in the lab for such purposes.

Manglik Matsunami teams looked for an odorant receptor that was abundant in both the body and the nose, thinking it might be explains how this works at a easier to make artificially, and one that also could detect water-soluble odorants, according to the study.

They settled on a receptor called OR51E2, which is known to respond to propionate - a molecule that contributes to the pungent smell of Swiss cheese.

But even OR51E2 proved hard to make in the lab, the study said.

Typical cryo-EM experiments require a milligram of protein to produce atomiclevel images.

However, co-first author Christian Billesbolle, a senior scientist in the Manglik Lab, developed approaches to use only 1/100th of a milligram of OR51E2, putting the snapshot of receptor and odorant within reach, the study said.

# British Muslim analyst found guilty of terror charges

A British Muslim financial analyst influenced by extremist Islamist ideology has been found guilty of multiple terrorism related offences by a UK court after his laptop led police to dangerous bomb-making plans.

Asad Bhatti, from Redhill in Surrey, south-east England, was arrested and which a search was carried out at an address in the area which revealed a makeshift bomb-making facility.

Surrey Police said the 49-year-old, of South Asian origin, was found guilty of two counts of possessing an article for the purpose of terrorism, contrary to Section 57 of the UK's Terrorism Act 2000. He was also found guilty of three counts of making or possessing an



explosive substance under suspicious circumstances contrary to Section 4 of the UK's Explosive Substance Act at the Old Bailey court in London on Friday.

be sentenced for the crimes at the same court on April 25.

'The case against Bhatti was strong, old Bailey court in London on Friday. I am glad the jury found him guilty
Bhatti remains in custody and will today," said Detective Chief

Superintendent Olly Wright, Head of Counter Terrorism Policing South East (CTPSE) in Surrey.
"There was clear evidence of his

extreme Islamist ideology and the danger he posed. He clearly hated those whom he considers do not follow his version of Islam, and he made a range of derogatory comments towards those he considers to be unbelievers'," he

Bhatti was investigated by officers from the CTPSE after he had taken his laptop into a shop to be fixed and a member of staff found some concerning file titles, which he reported.

Upon further investigation by CTPSE, some documents were discovered suggesting whoever was using the device had an interest in explosives and making explosive devices.

# Washington turns to Wall Street for help to rescue dying bank

The scene was reminiscent of the last financial crisis, nearly 15 years ago: Faced with a blossoming emergency in the banking sector, worried regulators and policymakers in Washington turned to Wall Street for help.

The anxiety this week centred on First Republic Bank in San Francisco, which was once the envy of the banking sector, with its wealthy and well-travelled clientele. Now the bank was reeling after some of those customers withdrew billions of dol-

As early as Tuesday, it became clear to policymakers that the First Republic needed to be rescued or it could fail, two people

briefed on the matter told The Associated Press, speaking anonymously because they were not authorized to discuss details.

The result was a swift agreement among the nation's leading banks to lay aside competitive instincts to come to First Republic's aid. With Washington greasing the wheels, a coalition of lenders put USD 30 billion in uninsured deposits into the California-based bank as a show of support.

The money gives First Republic a lifeline while it reportedly seeks a buyer. Regulators hope it also bolsters confidence in the health of the broader banking system.

The recent turmoil in the banking industry isn't on par



with the crisis that sparked the Great Recession from 2007 to 2009. But after Silicon Valley Bank and Signature Bank failed and were seized by the federal government, the industry's over-

seers worried about more dominoes falling.

Treasury Secretary Janet Yellen discussed the idea of supporting First Republic with other bank

regulators the Federal Reserve,

Corp. and the Comptroller of the Currency. Together they concluded that some sort of private rescue package was needed to prevent the crisis from worsening. Among the first calls made by Yellen and other policymakers was to Jamie Dimon, the chairman and CEO of JPMorgan Chase & Co. There may have been a sense of d i vu: Back in 2008, Dimon was the go-to banker for Washington to find private solutions for that bank-

the Federal Deposit Insurance

ng crisis. "We have our marching orders," Dimon reportedly said after the call with Yellen. He then proceeded to build a coalition of banks willing to place deposits with First Republic.

# Distant exoplanets could harbour life in 'terminator zones': Study

"Terminator zones" on distant exoplanets, or zones where the "day' side of the planet meets the "night" side, could potentially harbour extraterrestrial life, according to a

new study. Astronomers from University of California, Irvine (UCI), US, describe "terminator" as the dividing line between the day and night sides of the planet, which have one side that always faces its star and one side that is always dark.

Terminator zones could exist in that "just right" temperature zone between too hot and too cold, they said in the study.



"These planets have a permanent al researcher in the UCI day side and a permanent night Department of Physics & side," said Ana Lobo, a postdoctor- Astronomy who led the new work

published in The Astrophysical

Lobo added that such planets are particularly common because they exist around stars that make up about 70 per cent of the stars seen in the night sky - so-called M-dwarf stars, which are relatively dimmer

than our Sun. 'You want a planet that's in the sweet spot of just the right temperature for having liquid water," said Lobo, because liquid water, as far as scientists know, is an essential ingredient for life.

This is a planet where the day side can be scorching hot, well beyond habitability, and the night side is going to be freezing, potentially covered in ice. You could have large glaciers on the night side," Lobo said.

According to the study, Lobo alongside Aomawa Shields, UCI associate professor of physics & astronomy, modelled the climate of terminator planets using software typically used to model our own planet's climate, but with a few adjustments, including slowing down planetary rotation.

One key to the finding, Lobo added, was pinpointing exactly what kind of terminator zone planet can retain liquid water.

If the planet is mostly covered in water, then the water facing the star, the team found, would likely evaporate and cover the entire planet in a thick layer of vapour. But if there's land, this effect

shouldn't occur.

"Ana has shown if there's a lot of land on the planet, the scenario we call 'terminator habitability' can

exist a lot more easily," said Shields. "These new and exotic habitability states our team is uncovering are no longer the stuff of science fiction Ana has done the work to show that such states can be climatically

stable," said Shields. The study believes it is the first time astronomers have been able to show that such planets can sustain habitable climates confined to this terminator region.

Historically, researchers have mostly studied ocean-covered exoplanets in their search for candidates or habitability.

However, this study could increase the options life-hunting astronomers have to choose from.

We are trying to draw attention to more water-limited planets. which despite not having wide-spread oceans, could have lakes or other smaller bodies of liquid water, and these climates could actually be

very promising," Lobo said. "By exploring these exotic climate states, we increase our chances of finding and properly identifying a habitable planet in the near future, said Lobo.
