Kharge to take call on next K'taka CM

Congress may opt for rotational chief ministership to keep both hopefuls Siddaramiah, Shivakumar happy

DEEPAK KUMAR JHA

s anticipated the newly-A elected Congress MLAs on Sunday authorised party president Mallikarjun Kharge to pick the next Chief Minister of Karnataka.

Sources within the top leadership of the party told *The Pioneer* that the Congress has no choice but to adjust by opting for rotational Chief Ministers for two-and-halfyears each, in the five-year tenure of the Government. "Both are important — former Chief Minister K Siddaramiah for being the old warhorse and an acceptable caste leader while Karnataka Congress chief DK Shivakumar burnt the midnight oil to wrest power from the BIP in the just-concluded polls," confided a leader who is privy to the discussions.

Amidst sloganeering by party workers loyal to the probables - Siddaramiah and Shivakumar — the scheduled Congress Legislature Party (CLP) meeting at a private hotel in Bengaluru passed a unanimous resolution authorising the party chief to pick its leader. Sources also said both the factions — Siddaramiah and Shivakumar — are also discussing the relevance of rotation postings as the commitment made on the same lines in Chhattisgarh was never ful-

When Bhupesh Baghel was appointed the CM in 2018 then rival TS Singh Deo, who is a Cabinet Minister in Chhattisgarh, is believed to have been promised elevation to the CM's post after two-andhalf-years but that did not happen and the State is now preparing for the term-end Assembly

polls.

Hiccups were reported at the end of the half tenure when Deo and Baghel had to camp in Delhi and at one point the Government was in jeopardy.

This has been a precedent in the Congress for decades that in the process of formation of Governments, the CLP ultimately authorises the party president to nominate the CM. The Congress scored a thumping win in the May 10 Assembly polls as it secured 135 seats out of 224, while the BJP bagged



Seat sharing talks soon

Having decided to contest the 2024 Lok Sabha and Assembly polls as a grand alliance, the three constituents alliance, the three constituents of the Maha Vikas Aghadi (MVA) — Shiv Sena, NCP and Congress — will be holding seat-sharing talks soon. At a joint meeting held at NCP chief Sharad Pawar's south Mumbai residence the leaders of the three MVA constituents decided to contest the forth-coming Lok Sabha and Assembly polls as an alliance. Also, they decided to initiate seat-sharing talks among them in the coming weeks.

Interacting with media persons along with State Congress president Nana Patole and Shiv Sena (UBT) leader Sanjay Raut, State NCP chief Jayant Patil said at the meeting that the leaders discussed the Congress' victory in Karnataka, the Supreme Court verdict on the crisis in Shiv Sena in June last year and future plans of the three MVA constituents in the run-up to the Lok Sabha polls in the State.

Patil said the three MVA parties would hold seat-sharing negotiations for the Lok Sabha and Assembly polls in the coming weeks. "As it happened in Karnataka, we expect to perform well in both the Lok Sabha and Assembly polls in Maharashtra," Patil said. While the Lok Sabha polls will be held

in May next year, the State Assembly will in the normal course be held in October 2024. Patole said there is a lot of anger against the ruling BJP among the people. "The people vented their anger against Prime Minister Narendra Modi and Union Home Minister Amit Shah in the Assembly polls in Karnataka... We intend to hold a fourth Vajramuth (iron fist) rally in Pune where we intend to felicitate the Chief Minister of Karnataka," Patole

said. Raut denied that there is any rift within the MVA and said. "The Karnataka Assembly poll outcome should be seen as a victory of the Opposition parties in the country.

"The Congress' victory will have a positive impact on polls in Maharashtra. The BJP will suffer a massive debacle in Maharashtra as well. The MVA constituents will soon arrive at seat-sharing arrangements for both Lok Sabha and Assembly

The Karnataka election results have triggered a fresh war of words over the leadership issue in 2024 between the Congress and the Trinamool Congress (TMC).

While the Congress Lok Sabha Leader Adhir Chowdhury has claimed that no party other than the Congress can lead a united Opposition against the BJP and that "only the Congress being a pan-Indian party can unite the Opposition," the TMC continues to insist on its "one against one" theory implying regional parties will have to be given upper hand in areas

Centre pushes DPSUs, India Inc towards Atmanirbharta

Import of 928 items banned to promote domestic Defence industry

Giving a push to Indian public sector undertakings (PSUs) and the industry to attain self-reliance quickly, the Government has banned import of 928 items thereby saving Rs 715 crore. These items will be procured from the

Indian industry.
This was the fourth such list of items to be issued in the last two years restricting import of weapons and or systems or sub-systems, Defence Ministry officials said here on Sunday. Giving details of the latest ban, they said the fourth list is in continuation of the previous three that were released in



December 2021, March 2022 and August 2022 respectively. These lists contain 2,500 items which are already indigenised and 1,238 (351+107+780) items which will be indigenised within the given timelines.

Of 1,238, some 310 items (1st list- 262, 2nd list- 11, 3rd list - 37) have been indigenised, so far. They said in order to promote 'Aatmanirbharta' in Defence and minimise imports by Defence Public Sector Undertakings (DPSUs), the Ministry of Defence has approved fourth Positive Indigenisation List of 928 strategically-important Line Units Replacement (LRUs)/Sub-systems/Spares & Components, including high-

end materials and spares, with worth Rs 715 crore. The DPSUs will under-

take indigenisation of these items through different routes under 'Make' category and inhouse development through the capabilities of MSMEs and private Indian industry, thereby providing impetus to the growth in economy, enhanced investment in Defence and reduction in import dependence of DPSUs. In addition, this will augment the design capabilities of the domestic defence industry by involving academia and research institutions. The DPSUs will soon initiate procurement action for these notified items.

The four lists restricting imports covers sensors, ammu nition, towed artillery guns, short-range surface-to-air missiles, cruise missiles and offshore patrol vessels, next-generation corvettes, airborne early warning systems, tank engines and radars. *Contd on Page 2*

Govt to do ₹300-cr equity infusion in Allianco Air

The Government of make an equity infusion of The Government is set to Rs 300 crore in regional carrier Alliance Air, which is facing financial headwinds, according to a senior official. Alliance Air. earlier part of Air India, is now owned by AI Assets Holding Ltd (AIAHL), a special-pur-pose vehicle formed by the central Government.

The disinvestment-bound Alliance Air operates around 130 flights daily. In recent months, there have been instances of strikes by pilots to protest against non-restoration of salaries to the pre-Covid level and non-payment of allowance, among other issues. The Finance Ministry has approved an equity infusion of ₹300 crore into Alliance Air, the senior Civil Aviation Ministry official said. Specific



'Alliance Air' brand are operated by Airline Allied Services, which changed its name to Alliance Air Aviation Ltd. The company's authorised capital is ₹2,000 crore and the paid-up capital is ₹402.25 crore, as per the latest data available with the Corporate Affairs Ministry.

Alliance Air, which saw its net loss widen to ₹447.76 crore in fiscal 2021-22, has been grappling with financial woes. The carrier's cash loss widened to ₹224.18 crore in the financial year ended March 2022.

Google to expand its Dark Web monitoring tool to all mail users

Google has announced that dit will expand its Dark Web monitoring to all Gmail users in the US and later to international markets. The Gmail users will now be able to run scans to see if their Gmail address appears on the Dark Web and receive guidance on what actions to take to protect themselves

Previously, only available to Google One subscribers in the US, the Dark Web scan feature will be available to all Gmail users in the next few weeks. "We'll soon be expanding access to our Dark Web report to select international markets," the company informed. Google Core services SVP, Jen Fitzpatrick, said that the com-



Centre to monitor progress of startups funded by it: Min

The government has proposed the setting up of a mechanism to oversee the nurturing and progress of startups as their numbers have risen to more than a lakh, Science and Technology Minister Jitendra Singh said on Sunday.

He said such a mechanism will closely follow the growth of Startups, see how to sustain them so that they do not lose out, especially those that have received technical and financial support from the Government.

Singh was addressing the valedictory function and Awards Ceremony of the National Technology Week Exposition at Pragati Maidan

The minister said over the years start-ups have witnessed a shift from IT to Biotech and Earth Sciences as new opportunities have opened in Oceanography. He also debunked myths surrounding startups."One is age factor, I have seen a scientist setting up a startup after retirement; second is higher qualification, you just need to be an innovator, having an inherent quest for creativity," Singh said.

SC trashes appeal of ex-ISRO scientist against dismissal from service

The Supreme Court has junked a scientist's plea challenging his dismissal from service by ISRO, saying the space agency was justified in suspecting his honesty and integrity on account of his unauthorised association with a South Korean institution involved in rocketry research, a strategic subject of his employer.

The apex court was hearing the special leave petition of V R Sanal Kumar, a former scientist at Vikram Sarabhai Space Centre (VSSC) of the Indian Space Research Organisation in Thiruvananthapuram against the order of his dismissal from service which was upheld by the Central Administrative Tribunal and the Kerala High Kumar, who had joined the

ISRO in 1992, was dismissed with effect from September 1, 2003 under the Department of Employees' Space (Classification, Control and Appeal) Rules for joining Andong National University, South Korea and assisting Prof H D Kim, Head of School of Mechanical Engineering, without permission from his employer.

Upholding the decisions of CAT and the Kerala High Court, a bench of justices M R Shah and CT Ravikumar said, "It is not the mere unauthorized absence of the appellant that actually weighed with the authority and evidently, the

organization is perfectly justified in casting suspicion on the honesty, integrity, reliability, dependability and trustworthiness in view of the factual situation obtained in this case...

"..... Besides entertaining the stand that his unauthorized association with foreign institution, especially in the area of propulsion, which is a strategic research and development subject in the organization and based on which the nation's rocketry and ambitious launch vehicle programs are/were advancing, was a matter of concern for the security of the

It said when such conduct of a scientist in a sensitive and strategic organisation comes to light, then the decision to impose dismissal from service cannot be said to be "illegal or absolutely unwarranted." It noted Kumar's unauthorised association with a foreign institution in the area of propulsion-a strategic research and development subject in ISRO and based on which the nation's rocketry and ambitious

launch vehicle programs were advancing-was a matter of concern for the security of the

The bench said it did not find any reason to interfere with the high court's judgment dismissing the challenge against the CATs order. "The appeal, therefore, must fail and accordingly, it is dismissed, however, without any cost," it

The bench also noted the submissions of Kumar, according to which he was a high-profile scientist with a specialisation in rocket propulsion with proven credentials at par with NASA scientist.

"He would further state that he is second to none in the space programme and is having all potential to become the Chairman of ISRO and is the best suitable candidate for the post with immediate effect," the bench noted.

The top court said the facts of the case revealed that Kumar, without permission from the competent authority, went to South Korea and joined Andong National University, where he assisted a professor who was the head of the school of mechanical engineering and continued his association with the foreign institution involved in the research on rocketry.

It said Kumar was repeatedly advised not to have any contact with any external agency, such as the university, without permission from appropriate authorities in ISRO.

| Woman kills | **Doctors remove 6.5-cm** tumour from man's food pipe at hospital

30-year-old man has A³⁰-year-old man has received a new lease of life after undergoing a challenging surgery for removal of a large tumour from his food pipe at a hospital here, doctors said on Sunday. The patient was recently admitted at Sir Ganga Ram Hospital (SGRH) with difficulty in swallowing, where, after investigations, doctors found a "large tumour of the size of 6.5 cm", bulging in the food pipe region, they said.

The hospital, in a statement on Sunday, claimed that this was "one of the largest tumours removed endoscopically in India". According to Anil Arora, chairman, Institute of Liver Gastroenterology Pancreatico Biliary Sciences, at the hospital, "We recently removed a large submucosal

food pipe (oesophageal leiomyoma -- a tumour arising from the muscular layer of oesophagus and protruding into the lumen causing dysphagia) in the 30year-old male patient".

These types of large tumours are traditionally removed by surgery which has far more morbidity and is associated with longer hospital stay, the doctors said. The procedure used for this patient is known as "submucosal tunnelling and endoscopic resection (STER)", the hospital said. According to Dr Shivam Khare, consultant, Department of Gastroenterology, at SGRH, "In the STER procedure, firstly we injected saline at the base of the tumour that helped us lift the tumour, and create a tunnel all around it, by dissection of fibrous tissue around it, and in separating it from all layers of food pipe".

Deputy Commissioner of Police (Traffic) Anil Kumar Yadav said the campaign has been effective and learnings from it will be implemented in future to further enforce traffic rules in Noida and Greater

"The campaign has been effective but we have identified some (traffic violation) hotspots where we will continue enforcement of traffic rules," Yadav

"At some places where we have identified wrong-lane driving due to structural issues, we will be communicating with the Noida authority to resolve those issues," he said



Indian Navy test | Odisha's Millet Mission may go global soon

The Odisha Government's much-touted Odisha Millet Mission (OMM) launched in 2017 may go global soon with the World Food Programme identifying it as one of the best practices that can be replicated in other States in India and other countries in Africa as part of South-South collaboration.

Back home, it recently added yet another feather in its cap with the UNDP and Niti Aayog hailing it as 'Model of Millets in India.' It has been included in the compendium 'Best practices in social sector: A compendium, 2023" jointly prepared by the UN body and the country's top think tank. The document was

The Compendium also notes that "World Food Programme identified OMM as one of the best practices that can be replicated in other states and other countries in Africa as part of South-South Collaboration."

The OMM, which was launched with an aim to revive millets on farms and plates, simultaneously focusing on production, processing, consumption, marketing and inclusion of millets in government schemes, was initiated in 30 blocks covering 7 districts in 2017, then extended to 84 blocks covering 15 districts by

This is further scaled up to 143 blocks in 2022 covering 19 districts, reaching out to 1.18 Lakh farmers covering 54,495 hectare.

SC to hear plea of lawyers body for action against VP, Rijiju over remarks on judiciary

The Supreme Court is scheduled to hear on Monday a plea of Bombay Lawyers Association (BLA) against Union Law Minister Kiren Rijiju and Vice President Jagdeep Dhankhar over their remarks on judiciary and the collegium system for appointment of judges.

The lawyers' body has moved the top court challenging the Bombay High Court's February 9 order dismissing its plea on the ground that it was not a fit case to invoke the writ jurisdiction under Article 226 of

As per the apex court website, the appeal of the BLA is listed for hearing before a bench comprising Justices Sanjay Kishan Kaul and Ahsanuddin Amanullah.

The Bombay Lawyers Association (BLA) had claimed that Rijiju and Dhankhar showed lack of faith in the Constitution with their remarks and conduct. It had sought orders to restrain Dhankhar from discharging duty as the vice president, and Rijiju as the cab-



inet minister for the central vernment.

In an appeal, the lawyers body said the "frontal attack not just on the judiciary but the Constitution' by the two executive officials has lowered the prestige of the Supreme Court in

Rijiju had said the collegium system of appointing judges was "opaque and not transparent". Vice President Jagdeep Dhankhar had questioned the landmark 1973 Kesavananda Bharati judgement that gave the basic structure doctrine.

Dhankhar had said the verdict set a bad precedent and, if any authority questions Parliament's power to amend the Constitution, it would be difficult to say "we are a democrat-

"It is submitted that the Petitioner herein filed the PIL before the High Court of Judicature at Bombay praying therein to declare the Respondent no 1 and 2 as disqualified candidates to hold any constitutional posts of Vice President and Minister of the Union Cabinet, respectively, based on their behaviour, conduct and utterances made in public," the petition has said.

The two constitutional functionaries, it said, showed lack of faith in the Constitution by their conduct and utterances made in public and by attacking its institutions, including the Supreme Court, and showing scant regard for the law laid down by the Supreme Court.

"The conduct of Respondent Nos 1 and 2 appeared to have shaken public faith in the Supreme Court and the Constitution," it said.

inflammatory diseases, ageing, says Study

A protein called ASC2 in the bats that helps it develop extraordinary immune defense against pathogens like Covid-19 and Ebola can play a key role in fighting inflammatory diseases and ageing in humans, a team of scientists has said.

The research, published in the journal Cell, is focused on multi-protein complexes called inflammasomes that are responsible for the overactive inflammation that causes serious symptoms in many diseases.

The team discovered that a bat protein called ASC2 has a powerful ability to inhibit inflammasomes, thereby limiting inflammation.

Bats have attracted great attention as a likely reservoir of the SARS-CoV-2 virus responsible for the Covid-19 pandemic. But this unique ability to host yet survive

have a very positive impact on human health if we can understand and exploit how they achieve this," said Professor Wang Lin-Fa, at Duke-NUS Singapore's Emerging Infectious Diseases (EID) Programme.

The study "suggests that the high-level activity of ASC2 is a key mechanism by which bats keep inflammation under control, with implicaviral infections could also tions for their long lifespan

and unique status as a reservoir for viruses," explained Dr Matae Ahn, Researcher at the EID Programme.

The bat protein, tested in mice, showed good results. Expression of the bat protein in genetically-modified mice dampened inflammation and reduced the severity of the diseases driven by various triggers, including viruses,

Examination of the ASC2 protein in detail identified four amino acids in the molecule that were key to making the bat protein more effective at dampening inflammation than its corresponding human

This provides valuable insight for the development of drugs that can mimic the anti-inflammatory effect of the bat protein.

The next step for the team is to investigate the potential of their findings for treating humans.

'We have filed patents based on this work and are exploring commercial partnerships for drug discovery. We are hoping to develop a new class of anti-inflammatory drugs for inflammasome-driven human diseases,

Prof Wang said.
Prof Wang strongly believes that it is time to focus on the more promising aspects of what makes bats special "to help fight the human diseases of the future."

Satraps matter

Congress won handsomely in Karnataka but this may not have a great impact on 2024 general poll

■he biggest takeaway from the Bharatiya Janata Party's defeat in the Karnataka election is that strong state leadership is important in Assembly polls. It is true that the BJP has won without a chief ministerial face in the past but it does not mean that it can happen all the time. Prime Minister Narendra Modi and Home Minister Amit Shah make an excellent election-winning duo, but the saffron party must realise that it cannot rely on Modi all the time. The problem, however, is that the big two are not very fond of all state leaders. This was the reason that they ensured the exit of the BJP's strongest state leader, BS Yediyurappa. This was despite the fact that Yediyurappa was the architect of the saffron party's rise in Karnataka—the only southern state where the BJP is a party of some consequence. His forced exit did not go down well with his own community, Lingayats. With about



17 per cent of the state's population, they are a big vote bank, and have been favourably inclined towards the BJP. Other Lingayat stalwarts like former chief minister Jagdish Shettar and former deputy chief minister Laxman Savadi were denied tickets. Shettar rebelled and joined the Congress. Though he lost the election, such developments were not taken kindly by the community. The community is said to have a major influence in 78 Assembly constituencies. The Congress reportedly won in 54 such constituencies.

Another takeaway is about the diminishing appeal of divisive issues that political parties espouse frequently—the issues like those of hard

Hindutva and of Mandalite leaders. Former Karnataka chief minister Basavaraj Bommai, apparently in a bid to establish his Hindutva credentials, focused on hijab, halal meat, love jihad, land jihad, etc. The BJP top brass also tried to conflate Bajrang Dal with Bajrang Bali. But everything, including emotive issues, has a use-by date. Besides, the governance deficit is not very easy to be filled with an excess of sanctimoniousness and sentimentalism. There were serious charges of corruption against the Bommai government; sloganeering and red herrings could not whitewash its alleged misdemeanours. It must be mentioned here that the lessons must be learnt from the result of Karnataka election by not just the BJP but also the Congress and other Opposition parties. The high command culture can damage all parties. Similarly, recourse to high-flown rhetoric, mindless populism, and social justice divisiveness can be harmful to not just the nation but also the parties and leaders espousing them. As for Karnataka election's on the general poll next year, BJP detractors would like to call it the beginning of the end of the Modi regime. But just as one swallow doesn't make a summer, a loss in a state doesn't mean that the BJP's election machine has become rickety: 2024 will be another year.

SCO must be free from Chinese influence


To be effective, Shanghai Cooperation Organisation needs to come out of Chinese influence and push its own cherished goals, writes Sumit Jha

he meeting of the foreign ministers of the Shanghai Cooperation Organisation (SCO) in the Indian city of Goa took place on 4-5 May to review the progress of the grouping. In doing so, Indian External Affairs Minister S. Jaishankar proposed the New Delhi declaration and four joint statements on cooperation on de-radicalisation strategies, promotion of millets and sustainable lifestyles to address climate change and digital trans-

True, since its creation in 2001, SCO has expanded its size by inducting more countries as members and observers. Efforts have also been taken to institutionalize the grouping. In turn, SCO has become the largest organisation in terms of geographic scope and population, covering approximately 60% of the area of Eurasia, 40% of the world population. Moreover, with the presence of three major world powers - China, Russia, and India - as well as some oil and gas rich countries -Turkmenistan, Kazakhstan, and Kyrgyzstan, the eight-member organisation is seen to play a crucial role in shaping the nature of regional and global politics.

However, even a cursory glance at the functioning of SCO revels some fundamental limitations facing the organisation. One such structural problem is China's intent to dominate SCO. After all, the creation of SCO lies in China's desire to improve ties with Asia to achieve its interests in the post-cold war era. Thus, the Shanghai Five (China, Kazakhstan, Kyrgyzstan, Russia, Tajikistan) was formed in 1996 to enable China to resolve border problems with its Central Asian neighbours, Beijing's political, security and economic interests led to the creation of SCO. More to the point, China's foreign policy objectives have had a profound impact on the philosophy and objectives of SCO.

Consequently, China lost no time in recognising the Taliban regime in Afghanistan and Beijing is also contemplating the possibility of including Kabul as a member of SCO. On the other hand, China

China has also brazenly violated the SCO charter that talks about respecting sovereignty, territorial integrity of member states, non-use of force or threat of its use in international relations and seeking no unilateral military superiority in adjacent areas. One example in this regard is its efforts to undermine India's sovereignty over the Indian state of Jammu and Kashmir through the China-Pakistan Economic Corridor. But China's bullying behaviour is not limited to only SCO member countries.

Another limitation facing SCO is the uneven economic benefits that China has succeeded in garnering from other member countries. More to the point, China enjoys surplus trade with all member countries of SCO. China's imports and exports with other member countries of the Shanghai Cooperation Organization (SCO) touched a new high of \$250 billion in 2021-2022. This trend confirms the imperialistic tendency of China.

China's assertive posturing contradicts SCO aims to move towards developing a democratic and equitable international political order. In fact, one issue on which Beijing can easily be cornered is the lake of democratic space in China and the Chinese Communist regime's attempt to under-

mine the liberal- democratic

international order. Of course, other member countries of SCO are fully aware of China's clandestine purpose. India has in fact questioned China's move to undermine SCO's fundamental principles. But New Delhi finds itself alone on this matter in the groping. The dependence of Russia on China due to the Russian invasion of Ukraine has further strengthened China's position in the SCO.

Hence, amid high expectations from this region grouping towards promoting peace, security, and development in Eurasia and beyond, the immediate challenge facing SCO is to free itself from China's clutches. Only time will tell if it will

Notwithstanding the fast pace of development of health care and infrastructure in India, the maternal mortality rate remains a cause for concern. It is incumbent upon the Centre to upgrade India's primary health centres with investment by way of personnel and funds. The WHO mandate of 8 antenatal checks of a pregnant woman has to be scrupulously adhered to. Care of a mother and child does not end in staff and medicines. Potable water and an uninterrupted supply of electricity are essential for unhindered care. As the nation has successfully recovered from the pandemic, it is time for healthcare personnel to focus on mother and child.



India needs to adopt smart protein to feed its growing population

With smart protein being the key to feeding 10 billion people by 2050, India must catch up with the global smart protein landscape

-t's not every day that leaders from around the world List together to share a meal. Yet, last year, at the United Nations COP27 conference, when senior officials from Indonesia, Singapore, Cambodia, Malaysia, and other countries gathered around the table to share some delicious chicken, it wasn't the company that made the dinner special - it was the food. It was Good Meat's cultivated chicken, grown directly from animal cells, that gave the officials their first taste of a future of food that underpins the climate goals that are at the

very heart of the conference. That clever piece of chicken is what we call smart protein – part of a category of pioneering foods made from plants, microorganisms, or

cells that provide a viable alternative to animal-derived meat, eggs, and dairy. As of today, fermentation-derived and cultivated protein products (like the GoodMeat chicken) are not commercially available in India, the plant-based sector boasts 400+ products and 60 brands. While the sunrise sector is brimming with potential and optimism, there is a widening chasm in its startup ecosystem. On the one hand, a handful of entrepreneurs have been able to push through their challenges and bring a stellar product to the market - one that resonates with the mass market. On the other hand, some entrepreneurs continue to push forward in the industry one step at a time but are yet to build relevance shortage of skilled talent, and

and a loyal customer base.

While these entrepreneurs have different destinations, they encounter similar obstacles in terms of forming a strong founding team, accurately assessing market and technical viability, fundraising from investors, and developing a strategic business plan. For a first-time entrepreneur, it is daunting to unravel the legal, financial, and commercial processes of setting up a startup on its own. This complexity only increases in a nascent sector like smart protein where the underlying ecosystem is still being built from the ground up.

This often leads smart protein entrepreneurs to face unique industry challenges like unclear regulatory policies,

lack of market sizing data. Yet, the most critical bottleneck is the lack of R&D infrastructure required at the lab, pilot, and large manufacturing scale to convert experimental solutions into market-ready products. While the food processing sector in India is well established, there is limited availability of equipment required for conducting novel food R&D and running pilot

Often, even the limited pieces of equipment are spread across universities and research parks and gated by levels of bureaucracy, complex partnership agreements, and high lab fees. Needless to say, as most startups at this stage are self-funded, they don't have the capital or volumes

ties or hire talent that can operate them.

While this may paint a grim picture, let's not forget that the smart protein sector is already home to a rapidly growing cohort of resilient startups. To multiply this number and move towards a future of sustainable food, the need of the hour is to bridge the gap between the two kinds of entrepreneurs and create structures that can improve the ease of setting and scaling up smart protein startups.

Ask any early-stage smart protein startup what they need and you'll get a similar laundry list: technical mentorship, infrastructure access, skill enhancement, capital from investors, and entrepreneurial support. Though this might required to set up their facili- feel like a big ask, several

organizations and industry experts have stepped up to embrace the challenge and are committed to providing a significant leg-up to these startups. There are nearly 900+ accelerator programs active in India with little to no focus on this growing industry. Their mandate is often restricted to fintech, healthcare, climate tech, SaaS and logistics star-

This leaves early-stage smart protein startups to compete for limited spots in sectoragnostic programs that aren't able to support all their requirements of technical expertise and food innovation infrastructure. One niche program that aims to fill this gap is the India Smart Protein Innovation Challenge (ISPIC). While these initiatives are a good start, they are only that. With smart protein being the key to feeding 10 billion people by 2050, nearly a sixth of whom will be Indian, there's much work to be done to support the right innovators and bring India up to speed with the global smart protein land-

To truly create an industry capable of transforming how the future of food is made, decision-makers in India too, need to gather around a table over a smart protein meal. They too, need to acknowledge food technology solutions to the ecological crisis and commit to turning 'food for thought' into actual food. After all, how exciting would it be to serve plant-based keema and biryani at COP28?

'Aim to liberate areas occupied by Russia'

Ukrainian President Volodymyr Zelenskyy said on Sunday that his country is preparing a counteroffensive designed to liberate areas occupied by Russia, not to attack Russian territory. Speaking during a news conference with German Chancellor Olaf Scholz in Berlin, Zelenskyy said Ukraine's goal is to free the territories within its internationally recognized borders. The Washington Post cited previously undisclosed documents from a trove of US intelligence leaks suggesting that Zelenskyy has considered trying to capture areas in Russia proper for possible use as bargaining chips in peace negotiations to end the war launched by Moscow in February 2022.

This would put him at odds with Western governments who have insisted that weapons they provide must not be used to attack targets in Russia.

Asked about the report, Zelenskyy said: "We don't attack Russian territory, we liberate our own legitimate territory.

"We have neither the time nor the strength (to attack Russia)," he said, according to an official interpreter. "And we also don't have weapons to spare, with which we could do this.

"We are preparing a counterattack for the illegally occupied areas based on our constitutionally defined legitimate borders,

which are recognized internationally,"

The Ukrainian president is visiting allies in search of further arms to help his country fend off the Russian invasion, and funds to rebuild what's been destroyed by more than a year of devastating conflict.

A Luftwaffe jet flew Zelenskyy to the German capital from Rome, where he had met Saturday with Pope Francis and Italian Premier Giorgia Meloni.

It was his first visit to Berlin since the start of the war and came a day after the German government announced a new package of military aid for Ukraine worth more than 2.7 billion euros (USD 3 billion), including tanks, anti-aircraft systems and ammunition.

Zelenskyy thanked Scholz for Germany's political, financial and military support, saying the country is now second only behind the United States in providing aid to Ukraine — and joked that he is working to make it the biggest donor.

"German air defense systems, artillery, tanks and infantry fighting vehicles are saving Ukrainian lives and bringing us closer to victory. Germany is a reliable ally! Together we are bringing peace closer!" he wrote on Twitter after the meeting.

Scholz said Berlin has so far given Kyiv some 17 billion euros in bilateral aid and that it can expect more in future.

"We will support you for as long as

Russia to end the war by withdrawing its

After initially hesitating to provide Ukraine with lethal weapons, Germany has become one of the biggest suppliers of arms to Ukraine, including Leopard 1 and 2 battle tanks, and the sophisticated IRIS-T SLM air-defense system. Modern Western hardware is considered crucial if Ukraine is to succeed in its planned

counteroffensive against Russian troops.

Zelenskyy said one reason for his latest visit to allied capitals was to forge a "fighter jet coalition" that would provide Ukraine with the combat planes it needs to counter Russia's air dominance. to counter Russia's air dominance.

Germany has said in the past that it doesn't have the F-16 jets Ukraine needs and Scholz responded to questions about possible plane deliveries by referring to the anti-aircraft system it has provided to Kyiv. 'That's what we as Germany are now

concentrating on," he said. In Ukraine, officials on Sunday denied that the country had anything to do with the downing of two Russian helicopters close to the border the day before.

In a joint statement after their meeting, Scholz and Zelenskyy said they support efforts to bring those responsible for atrocities in Ukraine to justice and noted the International Criminal Court's arrest warrant for Russian President Vladimir

Frank-Walter Steinmeier, Germany's head of state, who was snubbed by Kyiv last year, apparently over his previous close ties to Russia, causing a chill in diplomatic relations between Ukraine and Germany. Since then, both Steinmeier and Chancellor Olaf Scholz have visited Ukraine. After meeting Scholz and other senior officials at the chancellery, the two leaders flew to the western city of Aachen for Zelenskyy to receive the International Charlemagne Prize, awarded to him and the people of Ukraine.

IN OTHER DEVELOPMENTS:

Zelenskyy's chief aide, Andriy Yermak, said Sunday that five civilians died in Ukraine's southern Kherson region when an unexploded Russian shell blew up.

Overnight, Russia launched a "massive" attack on Ukraine with Iranian-made Shahed explosive drones, which left more than 30 people wounded, according to the Ukrainian military.

Eighteen of the 23 drones were shot down, but those that got through, and wreckage from those intercepted, damaged 50 apartment buildings, private homes and other buildings, the military said without providing further details. Russia also hit the western city of Ternopil and southern an unspecified number of civilians.



Imran Khan slams Pakistan Army

Pakistan's former prime min-ister Imran Khan hit out at the country's powerful army in his first address after an Islamabad court set him free, saying it should be ashamed of jumping into politics and could form its own political party. Addressing the nation

from his Lahore home on Saturday, Khan took strong exception to the Inter-Services Public Relations (ISPR) allegations against him and said the spokesperson of the army's military wing was not even born when he represented Pakistan in the world.

"I kept Pakistan's flag high world over. Never has ISPR made such a statement. You should be ashamed of yourself. You have jumped into politics. Why don't you make a political party," Khan said in an hour-long maiden speech after the Islamabad High Court gave him blanket relief in all 145 cases registered against

His remarks came in response to ISPR Director-

General Major General Ahmed

Sharif Chaudhry's statement in which he called Khan a "hyp-

"Listen to me Mr DG ISPR...you were not even born when I was representing my country in the world and earning a good name for it. You need to be ashamed of yourself for calling me a hypocrite and anti-Army," he said in a harsh

A triumphant Khan returned to his Zaman Park home in Lahore on Saturday after having locked himself in the Islamabad High Court (IHC) premises for hours for granted bail on Friday.

Before leaving for Lahore, the 70-year-old Pakistan Tehreek-e-Insaf (PTI) chief hit out at the "imported gov-ernment for kidnapping" him despite the IHC granting him bail in all cases.

The 70-year-old Pakistan Tehreek-e-Insaf (PTI) chief also tore into Pakistan's Army chief General Asim Munir and blamed him for his "abduction" after a court set him free.

In a major relief to Khan, the Islamabad High Court on Friday granted him protective bail for two weeks in a corrup-

tion case and barred the authorities from arresting the former Pakistan prime minister in any case registered any-where in the country until Monday.

During Khan's address, video clips were shown of how army trucks dropped 'unidentified' plainclothesmen, who joined PTI protesters and provoked them to unless vio voked them to unleash violence and ransack public prop-

Khan distanced himself from violent protests that erupted in the wake of his arrest on Tuesday from IHC premises by Pakistan Rangers, asserting that "violence and vandalism is not my philoso-

Khan's arrest triggered unrest in Pakistan that continued till Friday and led to several deaths and dozens of military and state installations being destroyed by the protesters. For the first time in Pakistan's history, the protesters stormed the army headquarters (GHQ) in Rawalpindi and also torched a corps commander's house in Lahore.

China, Russia increasing military collaboration, Japan FM warns

Japanese Foreign Minister Yoshimasa Hayashi expressed concern on Saturday about Russian and Chinese military cooperation in Asia and said the security situation in Europe could not be separated from that in the Indo-Pacific region since Moscow's full-scale invasion of Ukraine.

Speaking at a meeting of European and Indo-Pacific foreign ministers in Sweden, Hayashi said Russia's war in Ukraine had "shaken the very foundation of the international order" and must face a united response by the international community.

"Otherwise, similar challenges will arise in other regions and the existing order which has underpinned our peace and prosperity could be fundamentally overturned," Hayashi said.

Japan firmly backs Ukraine in the war but China says it remains neutral while declaring a "no limits" relationship with



Moscow and blaming the US and NATO for provoking the

Japanese Prime Minister Fumio Kishida visited the Jkrainian capital, Kyiv, in March at the same time as Chinese President Xi Jinping met Russian counterpart Vladimir Putin in Moscow. Hayashi accused Beijing

of "continuing and intensifying its unilateral attempts" to change the status quo in the East and South China seas by force and increasing its military activities around Taiwan.

"In addition, China and Russia are strengthening their military collaboration, including joint flights of their bombers and joint naval exercises in the vicinity of Japan,"

Hayahshi said.
China, which claims most of the South China Sea as well as Japanese-held islands in the East China Sea, says it has the right to defend its sovereignty and development interests.

Hayashi also warned that North Korea was "escalating provocations" in the region by conducting ballistic missile launches "with a frequency and in a manner that are unprecedented".

He joined dozens of ministers from the European Union and the Indo-Pacific region for the meeting just north of the Swedish capital. China was not invited to the talks.

"Since the aggression of Russia to Ukraine, the security actions were underway to counter the extremists. ty situation here in Europe and the security situation in the Pacific are not separable," Hayashi said as he arrived.

The detention of a mayoral **I** candidate belonging to the Greek minority in Albania has raised tensions between the two neighbouring countries. Greece's Foreign Ministry

Syria's main insurgent group seeks to move away from al-Qaida past

The leader of an insurgent **I** group that rules much of northwest Syria rose to notoriety over the past decade by claiming deadly bombings, threatening revenge against Western "crusader" forces and dispatching Islamist religious police to crack down on women deemed to be immod-

Today the man known as Abu Mohammed al-Golani is trying hard to distance his group, Hayat Tahrir al Sham, known as HTS, from its al-Qaida origins, spreading a message of pluralism and religious tolerance.

As part of the rebranding, he has cracked down on extremist factions and dissolved the notorious religious police. For the first time in more than a decade, a Mass was performed recently at a longshuttered church in Idlib

Al-Golani told a recent gathering of religious and local officials that Islamic law should not be imposed by force. "We don't want the society to become hypocritical so that they pray when they see us and don't once we leave," al-Golani said, pointing to Saudi Arabia, which has relaxed its social controls in recent years after decades of strict Islamic rule.

The pivot comes at a time when al-Golani's group is increasingly isolated. Countries that had once backed insurgents in Syria's uprising-turnedcivil-war are restoring rela-tions with Syrian President Bashar Assad.

Saudi Arabia, a one-time Assad foe, reversed course and led a push resulting in Syria's return to the Arab League last week, after 12 years of regional isolation.

Even Turkiye, the main remaining state backer of



armed opposition groups in Syria, has signalled a shift.

This week, the Turkish foreign minister met with his Syrian counterpart in Moscow, the first such meeting since 2011. The foreign ministers of Russia and Iran, Assad's main allies, also attended.

The meeting marked a significant step toward Damascus and Ankara restoring ties, even as the presence of Turkish troops in northwest Syria remains a sticking point.

At the same time, the United States considers HTS a terrorist group and has offered a USD 10 million reward for information on al-Golani's whereabouts. The United Nations also designates it a terrorist organisation.

Earlier this month, the US and Turkiye jointly slapped sanctions on two people who allegedly raised money for mil-

itant groups, including HTS.
Al-Golani rose to prominence in the early months of the Syrian uprising in 2011, when he became the leader of al-Qaida's branch in Syria, known at the time as the Nusra

Militants and top officials from Osama bin Laden's al-Qaida flocked to the group's base of operations in northern Syria, where many of them were later killed in US strikes.

Israel-Gaza clash: Thaw after days of fighting

fragile ceasefire between AIsraeli forces and militants in the Gaza Strip appeared to be holding on Sunday after a five-day clash that killed 33 Palestinians and two people in Israel

The latest round of Gaza fighting was sparked on Tuesday when Israeli jets killed three top commanders from the Islamic Jihad militant group in response to earlier rocket launches from Gaza. Those killings set off a barrage of militant fire and the conflagration threatened to drag the region into another all-out war until an Egyptian-brokered ceasefire took hold late Saturday.

While the calm appeared to bring a sense of relief to Gaza's 2 million people and hundreds of thousands of Israelis who had been largely confined to bomb shelters in recent days, the agreement did nothing to address the underlying issues that have fuelled numerous rounds of fighting between Israel and Palestinian militant groups in the Gaza Strip over the years.

veyed the latest damage caused to their surroundings, with gaping holes left in the apartments serving as what Israel said were hideouts for the six senior Islamic Jihad members killed during this round.

Gaza's main cargo crossing with Israel reopened Sunday after warnings that keeping it closed would force Gaza's sole power plant to shut down, deepening a power crisis.

Israel was gradually lifting restrictions on residents in southern Israel, which had borne the brunt of the rocket fire. Israeli officials expressed satisfaction with the latest battle, having killed at least six members of Islamic Jihad's top brass in what it says were pinpointed strikes based on solid intelligence.

But at least 13 of those killed in Gaza were civilians, among them children as young as 4 years old, as well as women. Prime Minister Benjamin Netanyahu said the targeted attacks on the militants' hideouts would reverberate around the region.

Throughout the fighting, Israel's repeated airstrikes targeting Islamic Jihad and its command centers and rocketlaunching sites showed no signs of stopping the rocket fire, prompting Islamic Jihad to declare victory and sending cheering Palestinians out into the streets late Saturday.

The Israeli military reported over 1,400 launches throughout the fighting, with some rockets reaching as far as the Tel Aviv and Jerusalem

Israeli jets struck more than 400 targets, according to a preliminary military tally, which also showed about a fifth of the rockets were misfired and landed in Gaza, while most of the rest were either intercepted or landed in open areas. An 80-year-old woman and a Palestinian labourer who was working inside Israel were killed by rocket fire. A Palestinian human rights group said three people, including two children, were killed in Gaza by errant rockets. It was the latest in a long series of battles between Israel and

since the Islamic militant group Hamas seized control of the seaside territory in 2007.

Israel and Hamas have fought four wars, and there have been numerous smaller flareups as well. The more powerful Hamas

has praised Islamic Jihad's strikes but remained on the sidelines during the latest round of fighting, limiting the scope of the conflict.

As the de facto government held responsible for the abysmal conditions in the blockaded Gaza Strip, Hamas has recently tried to keep a lid on its conflict with Israel. Islamic Jihad, on the other hand, a more ideological and unruly militant group wedded to violence, has taken the lead in the past few rounds of fight ing with Israel. Saturday's deal did not address many of the causes of the repeated fighting, including Israel's ongoing blockade of Gaza, the large arsenals of weapons possessed by Hamas and Islamic Jihad and Israeli policies in the occupied West Bank and east Jerusalem.

Erdogan's leadership in balance as polls close in Turkiye

The election could grant Erdogan, 69, a new five-year term or unseat him in favour of the head of an invigorated opposition, Kemal Kilicdaroglu, who has promised to return Turkiye to a more democratic path. If no candidate receives more than 50 per cent of the vote, the race will be determined in a May 28 run-off.

Voters also elected lawmakers to fill Turkey's 600-seat parliament, which lost much of its legislative power under Erdogan's executive presidency. If his political alliance wins, Erdogan could continue governing without much restriction. The opposition has promised to return Turkey's governance system to a parliamentary democracy if it wins both the presidential and parliamentary ballots.

Opinion surveys indicated the increasingly authoritarian leader entered the election trailing a challenger for the first

time. Erdogan has ruled Turkey as prime minister or president since 2003. Pre-election polls gave a slight lead to Kilicdaroglu, 74, the joint candidate of a six-party opposition alliance who leads the centerleft, pro-secular Republican People's Party, or CHP.

Voting began at 8 am (0500 GMT) and polls closed at 5 pm (1400 GMT). Under Turkiye's election custom, news organisations are barred from reporting partial results until an embargo lifts at 9 pm (1800 GMT). There are no exit polls.

More than 64 million people, including 3.4 million overseas voters, were eligible to vote in the elections, which come the year the country will mark the centenary of its establishment as a republic. Voter turnout in Turkiye is traditionally strong, reflecting citizens' continued belief in democratic balloting.

Yet Turkiye has seen the suppression of freedom of expression and assembly under Erdogan, and it is wracked by a steep cost-of-living crisis that critics blame on the government's mishandling of the economy. Turkiye is also reeling from the effects of a powerful earthquake that caused devastation in 11 southern provinces in February, killing more than 50,000 people in unsafe build-

Stained glass window shows Jesus Christ with dark skin, stirs questions about race passages in which women, also

Warren (US): A nearly 150year-old stained-glass church window that depicts a darkskinned Jesus Christ interact-Testament scenes has stirred up questions about race, Rhode Island's role in the slave trade and the place of women in 19th century New England society.

The window installed at the long-closed St Mark's Episcopal Church in Warren in 1878 is the oldest known public example of stained glass on which Christ is depicted as a person of color that one expert ĥas seen.

"This window is unique and highly unusual," said Virginia Raguin, a professor of humanities emerita at the College of the Holy Cross in Worcester, Massachusetts, and an expert on the history of stained-glass art. "I have never seen this iconography for that

The 12-foot tall, 5-foot wide (3.7 meters by 1.5 meters) window depicts two biblical

painted with dark skin, appear as equals to Christ. One shows Christ in conversation with Lazarus, from the Gospel of Luke. The other shows Christ speaking to the Samaritan woman at the well from the Gospel of John.

Obesity speeds up loss of immunity from Covid vaccines: Research

Cambridge (UK): COVID vaccines are very effective, but for some groups they don't generate as strong an immune response. These groups include older adults and people with weakened immune systems, for example due to cancer or other medical conditions. They tend to already be at heightened risk from COVID.

Likewise, obesity - and its association with several other conditions such as type 2 diabetes, high blood pressure and chronic kidney disease - leads to an increased risk of severe COVID. The effect of obesity on COVID vaccine effectiveness, however, has not been well understood. But our new study in Nature Medicine finds obesity is linked to faster loss of immunity from COVID

vaccines. We know people with obesity have an impaired immune response to other vaccines including those for influenza, rabies and hepatitis.

antibodies which recognise the spike protein, a protein on the surface of SARS-CoV-2 (the virus that causes COVID) that allows it to attach to and infect our cells. The vaccines also prime immune cells called T cells to protect against severe COVID if we do contract the

Because immunity acquired after two doses wanes in the months afterwards, many countries have elected to administer booster vaccines to maintain immune protection, particularly in vulnerable

Several studies have suggested that following COVID vaccination, antibody levels may be lower in people with obesity than in the general population.

Earlier in the pandemic, we assembled a team of researchers from the University Cambridge and the University of Edinburgh to

called EAVE II, the University of Edinburgh team, led by Aziz Sheikh, examined realtime healthcare data for 5.4 million people across Scotland. In particular, they looked at

hospitalisations and deaths from COVID among 3.5 million adults who had received two vaccine doses (either Pfizer or AstraZeneca). They found that people

with severe obesity, defined as a body mass index (BMI) over 40, had a 76 per cent increased risk of hospitalisation and death from COVID after vaccination compared to those with a BMI in the normal range. The risk was also moderately increased in people who were obese (a BMI between 30 and 40) and those who were underweight (a BMI

lower than 18.5). The risk of severe disease



after the second vaccine also began to increase more quickly among people with severe obesity (from around ten weeks post-vaccination) and among people with obesity (from around 15 weeks) compared with people of a normal weight We studied 28 people with (from around 20 weeks). severe obesity attending

Our team conducted experiments to characterise the immune response to a third dose, or booster, of mRNA COVID vaccines (those made by Pfizer and Moderna)

in people with severe obesity.

Addenbrooke's Hospital in Cambridge, and measured antibody levels and function as well as the number of immune cells in their blood post-vaccination. We compared the results to those from 41 people of a normal weight.

Although antibody levels were similar in samples from all participants before booster vaccination, the ability of antibodies to work efficiently to fight the virus, known as "neutralisation capacity", was reduced among people with severe obe-sity.In 55 per cent of people with severe obesity we either couldn't detect or quantify neutralisation capacity, compared to 12 per cent of people with normal BMI.

This might mean COVID vaccines induce lower quality antibodies in people with obesity. It's possible the antibodies are not able to bind to the virus with the same strength as in people of a normal weight.

After a booster, antibody

ty was restored to the same level as those of normal weight. However, using detailed measurements of B cells, which are responsible for antibody production and immune memory, we found that these immune cells developed differently in the first couple of weeks after vaccination in people with obesity. By repeating measurements of immune responses over time, we could see antibody levels and function declined more rapidly after the third dose in people with severe obesity.

WHAT DOES THIS MEAN? There were some limita-

tions in both parts of the study. For example, BMI data was only collected once in EAVE II and therefore we cannot exclude changes in BMI over time. Also, the number of people included in our in-depth immunology study was relatively modest.

COVID vaccines doesn't seem to be as robust or long-lasting in people with obesity. With severe obesity affecting 3 per cent of the ÚK population and 9 per cent of the US

Nonetheless, immunity from

population, these findings have important implications. First, COVID boosters may be particularly important for this group. Our study also highlights the need for more

targeted interventions to pro-

tect people with obesity from severe COVID. Evidence shows weight loss of at least 5 per cent can reduce the risk of type 2 diabetes and

other metabolic complications of obesity. Interventions that can lead to a sustained reduction in weight (such as lifestyle modification, weight loss drugs, and bariatric surgery) could similarly improve COVID outcomes. Weight loss may likewise improve vaccine responses, but we need more research to investigate.

Adopt early warning system: NHB to HFCs

 $R_{ ext{finance firms NHB has}}^{ ext{egulator for housing}}$ asked housing finance companies with asset size of over Rs 1,000 crore to adopt an early warning signals (EWS) framework to check financial frauds and also to prevent accounts from turning into non-performing assets.

National Housing Bank (NHB), in a recent circular, said analysis of the frauds reported by the housing finance com-panies (HFCs) has revealed that the reasons behind accounts being identified as fraud accounts are seller impersonation, submission of fake income/ employment documents, submission of fake title deeds, a collusion of the builder and borrower. It has also been observed that such deficiencies are identified only when the borrower stops paying the EMIs after the disbursement of the loans, NHB said.

"It has been therefore decided that an Early Warning Signals (EWS) Framework should be adopted by the HFCs



so that an alert is triggered before the account turns into non-performing asset (NPA) or declared as a fraud account," it

NHB circular further said that tracking of the EWS must be integrated with the credit monitoring process in the systems of the HFCs so that it becomes a continuous activity. Through the EWS framework, HFCs will be encouraged to take into account fraud risks in their risk management practices. NHB has asked the housing finance companies to place the circular before their boards for information and to devise

The regulator has also suggested an indicative list of EWS for corporate and project loans.

NPCI seeks tie-ups for intl acceptance of RuPay debit card

National Payments Corporation of India Payments (NPCI) is exploring options for further tie-ups to strengthen turther tie-ups to strengthen the global acceptability of RuPay debit cards. Currently, RuPay cards are accepted at the points of sale (PoS) machine powered by Discover of the US, Diners Club, JCB of Japan, Pulse and Union Pay of China.

This needs to be strengthened, and NPCI is working in this direction so that users of RuPay cards are at par with those using Visa or Mastercard, sources said. In March 2012, RuPay went global by tying up with Discover Financial Services to bring international services to Indians.

It has strengthened its network capabilities by launching RuPay JCB Global Card in association with JCB International Co Ltd in July 2019. The RuPay JCB Global card can be used at RuPay card accepting points in India and JCB card accepting points out-



Commerce and ATM. RuPay, a product of NPCI, is the domestic card payment network of India, with wide acceptance at ATMs, POS devices and ecommerce websites across India. Earlier this year, the Union Cabinet approved a scheme worth Rs 2,600 crore for the promotion of RuPay debit cards and low-value BHIM-UPI (Bharat Interface for Money- Unified Payments

Under the scheme, the banks are provided financial incentives to foster Point of Sale (PoS) devices and e-commerce transactions using RuPay and UPI. The scheme is aimed at building a robust digital payment ecosystem and promoting UPI Lite and UPI123PAY as economical and user-friendly digital payment options.

Changes in anti-money laundering law can hamper FDA facilitation: CAs

Chartered accountants are seeking clarifications on the finance ministry's recent notification on extending the ambit of anti-money laundering law as it can adversely impact ease of doing business and facilitation of foreign investments

According to industry sources, chartered accountants (CAs) and company secretaries often act as formation agents for foreign companies setting up businesses in India and often provide their own address for communication in the ini-

They also act as resident directors of the foreign company trying to establish presence in the country and also operate bank accounts on behalf of their clients.

Industry sources said there is no way that an accountant can know whether the money that an investor is bringing into India is bonafide or laundered money and verify its source. In view of the pending review by the global watchdog on terror financing and money laundering scheduled later this year, the



finance ministry has in recent months tightened and expanded the scope of the Prevention of Money Laundering Act (PMLA). As part of the exercise, chartered and cost accountants and company secretaries have been included in the ambit of the PMLA, if they undertake specified activities

on behalf of their clients. These transactions include buying and selling of properties; management of bank accounts or other assets; and management of the companies, limited liability partnerships or trusts. In another notification, the ministry said that entities and individuals working as 'formation agents', or acting as

would be covered under PMLA provisions. It would also apply to individuals or entities who provide a business address or correspondence address for a company/LLP/trust.

According to industry sources, the activities mentioned in the notifications are performed by CAs for foreign companies trying to start their business in India. "Chartered accountants cannot check the money trail for companies bringing money to India to start business. It is the job of Financial Intelligence Unit (FIU) and RBI to check the source of investment," a source

According to sources, the chartered accountants are in touch with the finance ministry and seeking guidance on the recent changes in the antimoney laundering law.

At the most, a monetary penalty may be imposed on CAs and not the strict provisions of the PMLA law as several of these activities are part of the temporary hand-holding and accounting support required for facilitating foreign

Strong macro outlook, good earning season bring FPIs to Indian shores

 Γ oreign investors have shown strong buying interest in Indian equities in May and invested more than Rs 23,152 crore in the first fortnight due to lower chances of further rate hikes by the US Federal Reserve, a strong domestic macro outlook and a good earning season.

With this, now Foreign Portfolio Investors (FPIs) have become net buyers of equities in 2023 so far by attracting Rs 8,572 crore, data available with the depositories showed.

Going forward, FPI flows should remain robust for the rest of the month as the global risk on the environment continues for some more time given that major macro data like the US non-farm payroll numbers and CPI numbers have been mostly in line with market estimates, Manish Solutions, Sanctum Wealth,

"Since the rupee is strong and the dollar is expected to decline in the near term, FPIs are likely to continue buying in India. The improvement in India's macros also favours continued inflows into India,' VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said.

According to data from the depositories, FPIs invested a net sum of Rs 23,152 crore in Indian equities in the first fort night during May 2-12. ED, SEBI, RBI on trail of three top brokers for fraudulent trade

Three top brokers of the country have come under the scanner of multiple regulatory and enforcement agencies, including for suspected money laundering and fraudulent trading activities amounting to several thousands of crores of rupees, senior officials said on Sunday.

The officials also said that the three brokers, whom they refused to identify citing the ongoing nature of the investigations, have also been found to have been connected to PEPs (politically exposed persons) and the role of a key family member of a senior political leader in a key industrial state is also being investigated.

The investigations have been underway for 4-5 years on multiple fronts against the three top brokers, who head organisations with businesses spread across multiple segments of the capital markets tor including brokerage, investment advisory services, portfolio management, asset management fund and non-banking financial services.

The agencies and regulators involved in the investigations so far include the Securities and Exchange Board of India (Sebi), the Reserve Bank of India (RBI) and the Enforcement Directorate (ED), while these three have now made references for bringing in the CBI into the picture due to the suspected involvement of PEPs, the officials said. While suspected money laundering activities facilitated by the capital market brokers have always been under the scanner, this could be the first major case of some top-ranking brokerage

and financial services sector players being caught for the web of complex financial market transactions they weave to hide their money laundering activities, they added.

The investigations have involved scrutiny of multi-layered financial and banking transactions, transfer of funds to and from several tax havens, call data records and also social media conversations.

Requests were also sent to several foreign jurisdictions for administrative assistance on identifying the trail of fund transfers amounting to thousands of crores of rupees. While some such jurisdictions, including Switzerland, have already responded, the affect-ed parties have challenged any information sharing citing con-

fidentiality clauses As per the laws prevailing in various countries, the concerned banking or financial institutions give an opportunity to their respective clients with any foreign country.

The officials said the three brokers first came under the scanner for their role in a case involving a spot commodity exchange but soon they were found to be engaged in largescale money laundering activities, including for their brokerage and fund management

The scope of the investigation was expanded after some politically connected persons were found to be involved, they added. In most cases, it was Sebi that suspected a possible money laundering angle in the activities of these brokers and accordingly, the matter was flagged to other agencies and departments for further investigations

Hero MotoCorp set to roll out record number of products this year: CEO

New Delhi: Hero MotoCorp is gearing up for highest ever model introductions this fiscal as it looks to consolidate market share especially in the premium bike segment, according to the company's CEO Niranjan Gupta. SEBI floats consultation paper for regulating all web-based platforms

watchdog Sebi ĥas floated a consultation paper for regulating all web-based platforms offering fractional ownership of real estate assets to protect small investors.

Such fractional ownership of real estate assets is proposed to be brought as Micro, Small and Medium REITs under Sebi's Real Estate Investment Trusts rules. The proposed regulatory framework would help develop the real estate market, provide investor protection measures and lead to an orderly development of this sector and the market, Sebi said in its consultation paper.

Typically, fractional investment of real estate through fractional ownership platforms (FOPs) is an investing strategy in which the cost of acquisition of real estate is split among several investors, who invest in

purpose vehicle (SPV) established by an FOP. Such SPVs purchase real estate assets. FOPs allow investors to own a certain percentage or fractional share in the real estate asset through the securities issued by the SPVs. Some FOPs are operated by real estate agents or brokers (before the property is purchased) and as property managers thereafter. Sebi noted that there has

been a mushrooming of webbased platforms offering fractional ownership of real estate assets in the past 2-3 years. These platforms provide investors with an option to invest in buildings and office spaces, including warehouses, shopping centres, conference centres etc. The minimum investment on these FOPs ranges from Rs 10 lakh to Rs 25

Netherlands emerges as key trading partner of India in FY 2022-23

The Netherlands has emerged as India's third largest exports destination after the US and UAE during 2022-23 on account of a surge in shipment of goods such as petroleum products, electronic items, chemicals, and aluminium goods, according to the data of the commerce min-

India's trade surplus with the Netherlands has also increased from USD 8 billion in 2021-22 to USD 13 billion in 2022-23. The Netherlands has taken over major destinations such as the UK, Hong Kong, Bangladesh and Germany, the data showed. India's exports to the Netherlands rose by about 48 per cent to USD 18.52 billion during 2022-23 as against USD 12.5 billion in 2021-22. In 2021-22 and 2020-21, the out-

European country stood at USD 12.55 billion and USD 6.5 billion, respectively. The exports are registering healthy growth continuously since 2000-01, when India's exports to that nation was USD 880 million.

Further, in 2021-22, the Netherlands was the fifth largest destination for Indian exports as against ninth in 2020-21.

Federation of Indian Export Organisations (FIEO) Director General Ajay Sahai said the Netherlands has emerged as a hub for Europe with efficient port and connectivity with the EU through road, railways and waterways. In the calendar year, India's exports to the country increased to USD 18.1 billion in 2022 from USD 5.5 billion

Netflix plans to cut \$300 mn in spending this year: Report

San Francisco: Streaming giant Netflix is reportedly slashing its spending by \$300 million this year, including related to hiring.

According to a new report from The Wall Street Journal, one of the reasons behind the spending cut is that Netflix delayed its plans to crack down on password sharing from the first quarter to the second quarter this year. It means that the revenue Netflix expected from the move is now shifted to towards the second half of the year, the report said.

The company urged staff earlier this month to be sensible with their spending, including in relation to hiring, but noted that there would not be a hiring freeze or additional layoffs," the report added. The streaming company launched its crack down on password sharing in Canada, New Zealand, Portugal and Spain earlier this year.
