# 7 more parties ready to attend new Parl launch

Attendees' number increases to 25; BJP urges Opp to show 'big heart' as Cong steps up attack on Govt

In a major relief for the BJP-led NDA Government, seven more parties have accepted the invitation to attend the inauguration of the new Parliament building, raising the number of parties sched-uled to attend the launch ceremony to 25, even as the Congress-lead Opposition par-ties have intensified their attack on the Prime Minister and the Union Government. The Congress accused the Prime Minister of being "megaloma-niac" and the Government of

being "arrogant.

These seven non-NDA parties — BSP, Shiromani Akali Dal, Janata Dal (Secular), Lok Janshakti Party (Ram Vilas), YSR Congress, BJD and TDP — account for 50 MPs in the Lok Sabha, and therefore their participation will help the NDA blunt the Opposition's charge that the inauguration of new Parliament building is just a government event.

As the political row over As the pointed row over the opening of the building on May 28 escalated, the BJP hit back alleging the Opposition parties have decided to boycott the inauguration just because it has been built at the initiative of Prime Minister Modi. However, the BJP appealed to

the Opposition parties to attend the "historic day" of its inauguration by showing "big heart". Nineteen Opposition parties, including Congress, Left, TMC, SP, AAP, have come together to jointly announce the boycott of the inauguration ceremony, saying they find no value in a new building when the "soul of democracy has been sucked out".

been sucked out".

BSP president Mayawati called the Opposition boycott inappropriate and welcomed the inauguration of the new Parliament building by Prime Minister Modi. She also said the Opposition should have thought about "tribal borous".

the Opposition should have thought about "tribal honour" when it fielded a candidate against Murmu and denied her an unopposed election.

The Telugu Desam Party (TDP) on Thursday said it will take part in the inauguration of the new Parliament building with party chief N Chandrababu Naidu instructing Rajya Sabha MP Kanakamedala Ravindra Kumar to represent the party. Kumar to represent the party. The JD(S) supremo and former prime minister Deve Gowda too said he would attend the inauguration.

Congress lashed out at the ruling BJD and its president, Odisha Chief Minister Naveen Patnaik for "abiding" with Modi on all occasions, includ-



ing the new Parliament building the new Parliament build-ing inauguration. The BJD hit back accusing the Congress of doing politics over a non-issue and raised questions over its role during the presidential election.

They have also protested the decision that Prime Minister Narendra Modi will inaugurate the building, claiming this was an insult to the highest constitutional office of the President of India. rndia's ambitious cheetah population revival programme faced a setback as two more India-born cheetah cubs have died at the Kuno National Park (KNP) in Madhya Pradesh, a forest official said on Thursday.

With this, the number of cheetah cubs that have died at the KNP rose to three, while three of the 20 adult cheetahs translocated from South Africa and Namibia have also died at the park.

A cub's death had been reported in the park on May 23. The two other cubs also died on the same day, on Tuesday afternoon, but their deaths were reported only on Thursday.

The official did not disclose the reason behind not informing about the deaths of these two cubs on the same day. The KNP houses cheetahs translocated from Namibia and South Africa as part of an ambitious project to revive their population in India after the species



became extinct in the country

seven decades ago.
As per an official release, after the death of a cheetah cub on May 23, the forest department's monitoring team kept an eye on the movements of female cheetah Jwala and her remaining three cubs.

Iwala, earlier known as Siyaya, gave birth to four cubs in the last week of March after being translocated from Namibia in September last

The monitoring team found on May 23 that the condition of her remaining three cubs was not good and decided to rescue them for treat-

# New feat: MiG-29K performs night landing on INS Vikrant

The Indian Navy achieved another milestone by undertaking maiden night landing of its MiG-29K fighter jet on indigenously designed and built aircraft carrier INS Vikrant on Wednesday, Navy officials said here on Thursday.

Giving details of the landing in pitch dark conditions considered to be demanding, they said this landing was indicative of Navy's impetus towards "aatmanirbharta". This challenging night landing trial also demonstrates the resolve, skill and professionalism of the Vikrant crew and the naval pilots, they added.

The Indian Navy shared the video of the maiden night landing on Twitter. The all-weather fighter is seen landing on the flight deck of INS Vikrant in pitch darkness.

Defence Minister Rajnath

Singh congratulated the Navy for undertaking a successful night landing and said, "This

remarkable achievement is a testimony to the skills, perseverance and professionalism of the Vikrant crew and Naval pilots. Kudos to them."

Landing fighter jets on a normal runway is different compared to landing on a flight deck of an aircraft carrier due to the shorter length of the deck. While landing on the flight deck of an aircraft carrier, the pilot lowers the tail hook of the jet and aims for an arresting wire, which traps the aircraft and has the strength to bring its speed from 250 km/hr

"Night trap" means landing on an aircraft carrier during night-time and is considered even more challenging for naval aviators as the aircraft carrier is moving at a speed of 40-50 km/hr and the pilots have to keep the jets speed relative to the carrier.

The MiG-29K jet is part of INS Vikrant's fighter fleet. The supersonic fighter jet has a top speed of Mach 2 (two times the speed of sound) and can pull up to 8G (eight times the force of gravity) and can climb to an altitude of over 65,000 feet.

# **Dynastic parties reneged on high-speed trains: PM**

World looks at India with great hope, Modi says; flags off Delhi-Dehradun Vande Bharat Express

While flagging off the Delhi-Dehradun Vande Bharat Express here, Prime Minister Narendra Modi said on Thursday that parties which ruled the country for many years and made tall claims of introducing high-speed trains could never get out of the con-

straints of dynastic politics.

He also said the budget for expansion of the railway infrastructure in Uttarakhand now stands at ₹5,000 crore. Before 2014, it was less than ₹200

crore, he said, addressing the launch event of the first Vande Bharat train for Uttarakhand

via video conference. "India of the 21st century can prosper even faster by modernising its infrastructure. Parties in power for a long time

earlier did not realise this. Their focus was on indulging in scams and corruption. They could not get out of the constraints of dynastic politics. They also made tall claims about high-speed trains but years went by and nothing happened," Modi said. He said for the first time, there is a Government in the country which has the intention ("niyat"), policy ("niti") and dedication ("nishtha") required to achieve develop-

Referring to his just-concluded tri-nation visit, Modi said the world looks at India with great hope. "The way we have strengthened our economy, battled poverty and dealt with the challenge of Covid-19 raised the world's confidence in India. People from other countries want to come to India and understand it," he said.

"And this is a great opportunity for a beautiful state such as Úttarakhand," the Prime Minister said.

Recalling his remark made in Kedarnath in 2022 in which he had said the decade belongs to Uttarakhand, the prime minister said the Vande Bharat Express train and a plethora of other road, rail and ropeway infrastructure projects are set to drive the state in that direction. Continued on Page 9

# Vande Bharat in 3 avatars: Chair car, metro, sleepers

PNS ■ DEHRADUN /NEW DELHI

A mid the ongoing success and popularity with demands across for the new age Vande Bharat Trains, the Centre on Thursday announced for three versions of the semi-high speed trains — Vande Chair Car, Vande Metro and Vande Sleepers — by the end of this fiscal year.

Railway Minister Ashwini Vaishnav said in the next three to four years, railway tracks will be upgraded to support the maximum speed of 160 km/h of Vande Bharat trains. While the Vande Chair cars will be put on tracks for the same day end to end journey to cover a distance of 500-600 km one way, the Vande Metro will be used for local rail network services as the name suggest, while the Vande Sleepers will be long distance full air conditioned with all modern specifications on board.

"There are three formats of Vande Bharat —Vande Metro for less than 100 kilometre, Vande Chair Car for 100-550 kilometre and Vande Sleepers for a journey beyond 550 kilometre. These three formats will be ready by February-March (next year)," Vaishnaw said after the launch of Dehradun-Delhi Vande Bharat.

On the occasion Vaishnaw said every State will get a Vande Bharat train by mid-June. The production of these trains is being expedited, the Minister said. The Vande Bharat indigenous semi-high speed trains, which are being prepped to replace Shatabdis. Rajdhanis and local trains, are being made at the Integrated Coach Factory in Chennai.

"Old tracks were designed to support speeds between 70 and 80 km/h. Around 25,000-35,000 kilometre of tracks are being upgraded to support speeds of 110 km/h, 130 km/h and 160 km/h. It will be done in the next three to four years.

# Hazratganj shooting accused held

With the arrest of a youth, police claimed to have worked out the Hazratganj shooting case, the victim of which is still recuperating at a hospital.

Shani Singh of Narhi locality had a long-standing enmi-ty with the victim, Pramod Gupta of Gwari locality in Gomti Nagar, and he shot at the latter to avenge his insult and death of his sister, who had committed suicide ten years ago, DCP (Central) Aparna Rajat Kaushik said.

However, she did not explain it further and said

Shani had been detained by a team of police who worked in sync with the sleuths of the surveillance cell.

'The team also recovered a country-made pistol from the accused's possession," she said.

The DCP said a case for attempt to murder was registered against Shani and further probe was underway. Shani executed the crime singlehandedly in the light of the CCTV footage recovered from the site, she added.

The DCP said that the accused confessed to his crime and disclosed that Pramod was responsible for his sister's death. Sources said Pramod was



close to Shani's family and latter's sister set herself ablaze at her house in 2010.

"After the death of Shani's sister, their parents lost trust in people and stopped socialising. Her mother had been sick since then until she died recently. Shani was of the view that Pramod was the reason for his family's woes, and he was planning to kill him," the sources

Pramod was closing his shop when Shani reached there and opened fire. Locals had said that 4-5 shots were fired. Initial reports had revealed that the victim suffered two gunshots; one in the jaw and the other in the waist. He was admitted to Civil hospital but was later referred to KGMU

Trauma Centre. Meanwhile, a woman, identified as Prabha Gautam of Chhattisgarh, ended her life at a rented house in Chinhat locality on Thursday. She was staying there with her fiancé,

Shubham of Barabanki. Reports said that she took the extreme step around 9 am.

On being informed by the control room, police reached the scene. "Her family members rushed the woman to RML hospital where she was pronounced dead," the police

In a similar case, a 38-yearold man, identified as Lavkush of Sikrauri village, was found hanging in the bathroom at his house in Dubagga police station area on the intervening night of Wednesday and Thursday. His wife Phoolmati informed police about the

# Munawwar Rana hospitalised Gymming, smoking a lethal combo: Doc

Smoking before and after working out could be a lethal combination and lead to cardiac arrest, according to head of the cardiology department of Ram Manohar Lohia Institute of Medical Sciences Dr Bhuwan Chandra Tewari.

"I have seen youngsters smoke before going to the gym and also after working out. People who go to the gym think that they are fit and can smoke. They feel that working out would negate the ill-effects of smoking. But the fact is no amount of exercise can undo the damage caused by smoking. It is always better to avoid smoking or quit if you do. Those who smoke or chew tobacco have a tendency of viscosity of blood and they have dehydration with further smoking. The tendency of the blood to clot is higher in such people. Those who smoke before or after working out have a higher risk of cardiac arrest, with perspiration also causing dehydration," he said.

Dr Tewari also had a word of advice for those going to the gym and overdoing it. "People should not overdo it and ensure they are properly hydrated. People should not just focus on building muscle mass but also do some aerobic activities. One should not go for bodybuilding just for show-off," he said.

He also pointed out that many of the gym-goers take supplements having steroids, which may be hazardous for their health. A high-protein diet at home will help," he

"Exercises should be done in moderation. We get patients in the age group of 18-25 years with good muscle mass, and may of them are smokers. Most of the time when we do angiogram, we find blood clotting due to stickiness caused by smoking and dehydration," he

pointed out. "In these patients, the vessels remain normal and it is only the clot in the arteries that creates the problem. When we take out the clot, we find that there is no baseline disease. Smoking causes irritation of blood vessels and the tar as well as other compounds which go into the lungs and the blood can cause a heart attack. It can also result in deaths," he added

# 26 components available in blood bank of KSSSCI

Lucknow (PNS): The blood bank which has recently become functional in the transfusion department of Kalyan Singh Super Speciality Cancer Institute has the provision for 26 blood components. Dr Anju Dubey, assistant professor at the department, said there are very few centres in the country which have the licence for 26 blood components and KSSSCI is one of them.

"We had applied for the licence and procured the equipment & man power. A joint inspection was carried out in March. We had applied for the license for blood and 26 special components, including plasma, platelets, bone marrow, single-donor platelet, and single-donor plasma. The blood

Further, KSSSCI has written to the National Health Mission (NHM) for Nucleic acid Amplification Testing (NAT) technology at the blood bank, which will help in pro-viding the safest blood to patients.

Dr Dubey said KSSSCI director Dr RK Dhiman has written to the NHM for the financial support for NAT facility. She said they have a strength of 15 people, including two senior residents who are MD in transfusion medicine. She said there is a voluntary donation camp and volunteers turn up in large numbers to donate blood.

She added that according to chief medical superintendent Dr Anupam Verma, blood can also be taken by patients from other hospitals.

"For this, the patients have to register with the hospital first. In case they do not have a donor, we can arrange for voluntary blood donors for them. We currently has 25 units of blood," she said.

# Iulsipur station to undergo facelift

Lucknow (PNS): The Tulsipur station in the Gonda-Barhni-Gorakhpur loop block of North Eastern Railway (NER), Lucknow division, will be upgraded under the Amrit Bharat Yojana. A master plan has been prepared for the purpose and it will be implemented in a phased manner.

PRO, NER (Lucknow), Mahesh Gupta said the action plan includes development of circulating area of the main entrance of Tulsipur station and beautification with local art and culture, upgradation of platform surface, station facade and advanced lighting, coach guidance system, train display board, digital clocks, passenger announcement system, solar plant, water cooler, air-conditioner, glow signboards, etc. "Tenders have been opened for the project," he said.

Meanwhile, the catering team of the commercial wing of Northern Railway conducted a surprise checking of unauthorised vendors in train numbers 15904 (Chandigarh-Dibrugarh Express) and 12598 (Mumbai-Chhatrapati Shivaji Maharaj Terminus Gorakhpur Antyodaya Express) at the Lucknow station on Thursday.

"A thorough checking was done on arrival of these trains and five vendors were found selling biryani, food packets and beverages unauthorisedly. As they could not show any authorisation letter or pass, they were handed over to the Railway Protection Force," Senior DCM (NR, Lucknow) Rekha Sharma said.

### Rape accused attempts suicide; family alleges assault by policemen Budaun (PTI): Police on

Wednesday said a rape accused brought for questioning at Ughaiti Police Station here was rushed to a hospital after he allegedly attempted suicide.

The family members of the man have alleged that he was strangulated in custody by cops.

Superintendent of Police (SP) OP Singh said Panna Lal, an accused in a rape case, was brought for questioning at Ughaiti Police Station on Tuesday night. He attempted suicide inside the bathroom of the police station by trying to hang himself using his

pants. "The accused was rescued and rushed to hospital from where he was further referred to a hospital in Bareilly district by doctors," he said.

Lal's family members, however, have alleged that he was strangulated by policemen inside the police station after he failed to arrange a bribe of Rs 10,000.

'The policemen at the station demanded a bribe of Rs 10,000 from my brother. They tortured and tried to strangulate him when he refused to pay the bribe," Rishi Pal, brother of the accused said. The SP has denied the allegations of bribery and said Lal's condition is out of danger in the hospital.

# No hike in power tariff | Chief Minister launches 'Samarth 2023'

Tn a big relief to electricity consumers, power regulator UP Electricity Regulatory Commission (UPERC) has not hiked the power tariff for the current fiscal 2023-24.

The power regulator has not increased the power tariff for the fifth year in a row. The last revision in power tariff was done in 2018-19.

The development also assumes much significance in the run-up to the Lok Sabha polls due next year.

UP Power Corporation Limited (UPPCL) and its five wholly owned subsidiaries had sought a tariff hike of 18-23 per cent in their annual revenue requirement (ARR) petition filed before the power regulator in January this year.

The new tariff order will come into force as soon as approved by the government and notified by the UPPCL.

In a big relief for the power consumers of Noida, the power regulator has slashed the tariff by 10 per cent in its tariff order for 2023-24 issued on Thursday. The RP Goenka group-owned Noida Power Company Limited is the licensee power distributor in Noida. The maximum power tariff for Noida will be Rs 6.50 per unit.

The power tariff for urban consumers for consumption from 0-150 units per month will remain unchanged at Rs total expenditure shown by it in the ARR.

sumption of 151-300 units will be Rs 6 per unit and Rs 6.50 for consumption of 300 units and

The tariff for the urban BPL (below poverty line) consumers will be Rs 3 per unit for consumption up to 100 units per month.

For the rural area consumers, the tariff for consumption from 0 to 100 units per month will be Rs 3.35 per unit, Rs 3.85 per unit for consumption of 101-150 units, Rs 5 per unit for consumption of 151-300 units and Rs 5.50 per unit for consumption of 300 and above units per month.

There is no change in tariff for unmetered power connection which will be Rs 500 per kilowatt.

The power consumers, especially in the urban areas, will thus continue to pay their electricity bills as per the ear-

The electricity regulator, which held separate public hearings in all distribution companies, junked the proposal put forth by the UPPCL for a hike between 18 per cent to

Announcing the tariff, UPERC Chairman RP Singh and commission members BK Srivastava and Sanjay Kumar Singh said that the tariff had not been increased as the UPPCL failed to justify the

The power regulator has also directed the UPPCL to ensure that the electricity meters are installed at the residences of all power employees. Despite the repeated orders of the power regulator for the last over 10 years, the power employees have resisted the installation of meters at their

residences The UPPCL had proposed revenue requirement of Rs 92,564 crore for 2023-24. The UPERC however approved Rs 86,579 crore. While the UPPCL in its ARR had projected the requirement of purchase of 141 billion units, the power regulator approved only 133.45 billion units. The regulator also slashed the line loss of 14.90 per cent projected by UPPCL, to 10.30 per cent.

A senior official in the UPERC said that there was no justification for increasing the tariff since the UPPCL was not able to justify any rise in expenses. The official said the reduction in line losses would make a significant contribution to the overall revenue collection by the UPPCL.

Avadesh Verma, member of the state Energy Advisory Committee, said UP was the only state in the country where the power tariff had not been hiked for the last five years.

He said the UPPCL had been demanding the tariff revision every year but the power regulator had rejected the

# CM to officials: Give top priority to redressal of public problems

n a high-level review meeting after win-Ining the urban local bodies' polls, Chief Minister Yogi Adityanath directed senior district administration officials to expedite the public hearing programmes and give top priority to redressal of public problems.

The chief minister asked the officials to be sensitive to the public issues and said their conduct formed the basis of the trust of the common man in governance. "The satisfaction of the public will be the standard of excellence of your performance,"

The chief minister gave these directions in a high-level review meeting of the Home department through video conferencing. He gave the necessary guidelines to the senior government officials, as well as senior administrative and police officers posted at the district, range, zone and divi-

According to an official communique, make Thana Diwas and Tehsil Diwas more effective and resolve the complaints before the next Thana Diwas/Tehsil Diwas.

"Ensure that the public is aware of these hearing dates. The cases coming up in the meeting should not remain pending at all. Officers posted in the field at every level should take night rest at their posting area only. Do not reside in other areas. Senior officers should make surprise inspections to make sure this arrangement is being followed," he directed.

The chief minister said all officers having direct contact with the public like divisional commissioners, district magis-

trates, district police chiefs, DIOS, BSA, and district supply officers should meet the general public in their offices, listen to their complaints/problems and settle them on the basis of merit. He said camp offices should be used only after office hours or on holidays.

The chief minister pointed out that in many districts, the pace of development works was extremely slow and the officers should regularly review the ongoing development works so that the work was completed in a time-bound manner. "The accountability should be fixed by appointing nodal officers regarding development works," he added.

The chief minister said a few months ago, through dialogue, the government was successful in removing loudspeakers from religious places and this move was appreciated all over the country. Yogi said during recent district visits, he had noticed that loudspeakers were being reinstalled in some districts and this was not acceptable. He asked the officials to immediat tact and make communication with the people concerned and ensure removal of

all loudspeakers. He stressed that illegal taxi stands, bus stands, rickshaw stands should not operate in any district of the state as they encouraged illegal recovery which was used in anti-social activities.

The chief minister said district-level Udyog Bandhu meetings should be held regularly and the district magistrate and district police chief should attend these meetings to solve the problems of entrepreneurs. "Not a single case of entrepreneurs should remain pending. It should be given top priority," he said.

The chief minister said stringent action should be taken against those elements who molest daughters and women. He asked officials to identify such miscreants and to increase foot patrolling in which senior officers should also partici-

The chief minister stressed on stern action against manufacturing and sale of illicit liquor. He said policemen who were addicted to drugs should not be given any field responsibility and they should be identified and terminated from service.

He said district magistrates and superintendents of police should maintain constant dialogue and contact with the local public representatives. "Pay attention to their suggestions. Their letters should be disposed of quickly on the basis of merit,"

The chief minister asked the officials to strictly prohibit noise pollution and make sure to adhere to the Supreme 'ourt's directives in this regard dialogue with the DJ and music system operators before any function. No one should be allowed to spread chaos," he said

The chief minister said all the 17 municipal corporations of the state and Gautam Buddha Nagar had to be made 'smart' and 'safe' cities.

"Communicate with everyone. Connect CCTV camera to ICCC. Connect the first major municipality and nagar panchayats near the headquarters of every district with the campaign of safe and smart city," he said. The chief minister asked the officials to start preparations for flood

# A raids in terror

Investigation Agency (NIA) conducted searches at two locations in Úttar Pradesh in the Bhopal terror funding case involving the proscribed organisation Jamaat-ul-Mujahideen Bangladesh (JMB).

The raids, conducted on Wednesday, were aimed at exposing further the links and conspiracies of the 10 already arrested accused who have been charge-sheeted in the case by the NIA court. 'Six of the arrested accused are

Bangladeshi nationals and are active JMB cadre," the NIA said, adding that they had entered India illegally without any valid document, and had acquired false and forged Indian identity documents with the help of their sympathisers in India. 'Wednesday's searches at the premis-

es of various suspects led to the seizure of several digital devices (mobile phones), SIM cards, bank passbooks and identity documents. The documents, currently under examination, relate to suspicious transactions related to the transfer of funds by the accused," the NIA said.

The NIA investigations have revealed that all the 10 arrested accused were involved in influencing, radicalising and motivating vulnerable Indian Muslim youth to take up violent jihad against the democratic system of governance in the country.

'They had been circulating incriminating jihadi literature, inflammatory videos and statements and endorsing, justifying and glorifying the terrorist acts of the various banned terrorist organisations, including JMB, Al-Qaeda and the Taliban," the anti-terror agency said.

"They were conspiring to align with terrorist organisations to achieve their ultimate goal of establishing a Sharia-based Islamic rule in India through the pursuit of 'violent jihad," the NIA said, adding that they had grand plans of creating a pan-India network to pursue their objective and, along with their co-accused, had successfully established bases in various states, including Uttar Pradesh, Madhya Pradesh, Bihar, Tripura, West Bengal and

The NIA registered the case on April 5 last year under various sections of the Unlawful Activities (Prevention) Act and the Foreigners Act of 1946. It was initial-

# NSI joins hands with leading sugar groups

PIONEER NEWS SERVICE KANPUR

The National Sugar Institute (NSI) in pursuit of developing alternate feedstocks for production of ethanol has joined hands with leading sugar groups, Balrampur Chini Mills Ltd and Dalmia Bharat Sugar Mills Ltd to undertake trials for intercropping of sweet sorghum with sugarcane. The trials of five varieties of sweet sorghum, CSH22SS, SS74, SS84, Phule Vasundhara and ICSSH28 provided by ICAR- Indian Institute of Millets Research, Hyderabad, earlier conducted at institute's farm indicated average yield of sweet sorghum and ethanol production potential to be about 50-55 tonnes per hectare and 45-50 litres per metric ton of sweet sorghum. NSI Director Prof Narendra Mohan said the institute had taken trials for intercropping of sweet sorghum with sugarcane crop between the two rows of sugarcane plantation sweet

sorghum was being grown at Gonda and Shahjahanpur districts with the help of these sugar companies. He said while growing sweet sorghum and sugarcane in the same field this will help sugarcane farmers to get higher income from the same field. It will also be possible to get more ethanol per hectare of land. He said the sugarcane farmer's income per hectare is expected to increase by 35 per cent while the ethanol production potential may also increase by around 30 per cent, he said. Further, although, sugar beet is a crop for cold climatic conditions, yet the institute was exploring the possibilities of growing it in north India during the period November to April when the temperatures were favourable. The NSI had taken trials of three varieties, LS6, LKC2020, IISR COMP at the institute farm. While the beetroot yield has been about 60-80 tonnes per hectare, the ethanol yield has been found much higher than sugarcane

and was of the order of 80-100 litres per ton of beet root. The two crops sweet sorghum and sugar beet were not only short duration crops of four-five months but also require much less water than sugarcane and hence we look forward developing these crops as potential crops for ethanol production. He said the NSI will be able to address various challenges by working with other institutes like ICAR and ICAR-Institute of Sugarcane Research, Lucknow.

# LIC registers 10.90 pc increase in TPI

The Board of Directors of Life Insurance Corporation of India (LIC) approved and adopted the standalone and consolidated financial results for the year ending March 31, 2023. It released the key highlights of LICs standalone results. The official statement issued on Thursday said for the year ended March 31, 2023, the LIC registered an increase of 10.90 per cent in the total premium income (TPI) at ₹4,74,005 crore as compared to ₹4,27,419 crore for the previous year ended March 31,2022. In terms of market share measured by First Year Premium Income (FYPI) (as per IRDAI) the LIC has maintained its leadership in Indian life insurance business with a market share of 62.58 per cent for FY 2022-23. Further (as per IRDAI) the total FYPI for LIC grew by 16.67 per cent from ₹1.98 lakh crore in FY 2022 to ₹2.32 lakh crore in FY 2023. The Profit after Tax (PAT) for the year ended March 31, 2023 was ₹36,397.40 crore as compared to ₹4,043.12 crore for the previous year ended March 31, 2022. The profit for FY 2022-23 comprised an amount of ₹27,240.75 crore (net of tax), which is pertaining to the accretion on the Available Solvency Margin, transferred from non-par fund to shareholders account. The Board of Directors have recommended a dividend of ₹3 per share translating to a dividend payout of ₹1,897crore. On an Annualised Premium Equivalent (APE) basis the total premium was ₹56,682 crore for the year ended March 31, 2023 as compared to ₹50,390 crore for year ended March 31, 2022 representing a growth of 12.49 per cent year on year. For the FY 2023, 68.22 per cent (₹38,667 crore) was

accounted for by the Individual Business and 31.78

per cent (₹18,015 crore) by the Group Business. The individual business APE grew by 8.70 per cent year on year during FY 2023. Also within the individual business on an APE basis the share of par products and non- par product was 91.11 per cent and 8.89 per cent respectively. For FY 2023 the group APE (₹18,015 crore) grew by 21.57 per cent over the previous year ending March 31, 2022 (₹14,818 crore). For the year ended March 31, 2023, the persistency ratios on premium basis for the 13th month and 61st month were 77.09 per cent and 61.80 per cent, respectively. The comparable persistency ratios for the corresponding year ended March 31, 2022, were 75.59 per cent and 61 per cent, respectively. For the year ended March 31, 2023, the persistency ratios on number of policies basis for the 13th month and 61st month were 64.28 per cent and 49.86 per cent, respectively. The comparable persistency ratios for the previous year ended March 31, 2022, were 63.45 per cent and 49.86 per cent, respectively. Therefore the 13th month persistency has improved both on premium basis and on policy basis while the 61st month persistency has improved on premium basis. The Assets Under Management (AUM) increased to ₹43.97 lakh crore as on March 31, 2023, as compared to ₹40.85 lakh crore on March 31, 2022, registering an increase of 7.65 per cent year on year. The Yield on Investments on policy holders funds excluding unrealised gains was 8.29 per cent for year ended March 31, 2023, as against 8.55 per cent for year ended March 31, 2022. The solvency ratio for the year ended March 31, 2023 is 1.87 (before considering the proposed final dividend of ₹3 per share for FY23 ) and will be 1.86 (after consideration of the proposed final dividend for FY23) as against 1.85 for the year ended March 31, 2022. The Value of New Business (VNB) (gross) for the year ended March 31, 2023, was ₹11,553

crore as against ₹9,920 crore for the previous year ending March 31, 2022 representing an increase of 16.46 per cent. The VNB margins for the year ended March 31, 2023, were 16.2 per cent (net) as compared to 15.1 per cent (net) for year ended March 31, 2022. The gross VNB of the individual business was ₹7,571 crore and for group business was ₹3,982 crore for year ended March 31, 2023. The gross VNB margins for the individual and group business were 19.6 per cent and 22.1 per cent, respectively. Within the individual business, the par business, non-par business (including Linked business) had gross VNB margins of 14.6 per cent and 70.4 per cent, respectively. The Indian Embedded Value (IEV) of the corporation has been determined as ₹5,82,243 crore as at March 31, 2023 as compared to ₹5,41,492 crore as at March 31, 2022 and ₹5,44,291 crore as at September 30, 2022. Therefore the IEV had grown by 7.53 per cent on a year on year basis.

# **Cell culture facility in AU** becomes operational

A state-of-the-art cell culture facility has become operational at the Centre of Biotechnology of Allahabad University. This specialised cell culture facility has been established at the laboratory of Prof Awadh Bihari Yadav of the centre. The facility is designed for the growth and maintenance of cells in in vitro. It provides a controlled environment where animal and human cells can be cultured and manipulated for various purposes, including research, drug development, biotechnology and medical applications.

The key components of an animal cell culture facility,

CO2 incubators, single cell counters, a centrifugation machine and a phase contrast inverted microscope. In the past different animals such as rats and rabbits were used in laboratories to test effects and harmful effects of drugs which would unfortunately often result in the death of animals.

"Additionally, due to strict regulations regarding the use of animals in research, scientists face numerous challenges in developing new tests and cell culture-based assays have proven to be among the most reliable to overcome this limitation. This facility will expedite cell culture-based

foster collaboration with researchers both within and outside the university", said Yadav while talking to mediapersons.

An animal cell culture facility holds numerous applications in various fields. Initially, this facility will enable us to study the effects of drugs, plant extracts, and nanomaterials on the A549 lung cancer cell line.

The harmful effects of drugs, therapeutic molecules and nanomaterials will be assessed after exposure to the A549 lung cancer cell line.



# Unedifying

By boycotting the inauguration of the new Parliament building, the 20 Opposition parties have not covered themselves in glory, notwithstanding their loud rhetoric. In a joint statement, 19 Opposition parties said that the President is not only the Head of State in India but also an integral part of Parliament as she summons, prorogues, and addresses it. "Yet, the Prime Minister has decided to inaugurate the new Parliament building without her. This undignified act insults the high office of the President, and violates the letter and spirit of the Constitution. It undermines the spirit of inclusion which saw the nation celebrate its first woman Adivasi President." While their argument is not without merit, the accompanying bombast—"undignified act," violation "of the Constitution," undermining of "the spirit of inclusion"—is unwarranted and unnecessary. The Opposition's conduct would have been dignified and praiseworthy had it slammed the Government without boycotting the inauguration. After all,



the event is about Parliament and Indian democracy, not about Prime Minister Narendra Modi's participation in it. One has to be viscerally anti-Modi to believe that his Government has disrespected President Droupadi Murmu. We should not forget that she became President during Modi's tenure as Prime Minister. The Opposition is making a mountain out of a molehill. In general, the Opposition—indeed the entire political class—must acknowledge the fact that there are ways of expressing one's displeasure over something other than boycotts and bans.

If the Opposition has not reacted appropriately to the inauguration of the new Parliament building, the Government too has not shown great sagacity in han-

dling the issue. And this is not just about propriety and this particular instance. Its continuously aggressive stance towards the Opposition has generated a great deal of divisivesness in our polity. Till a few years ago, many foreign observers were impressed by the fact that politicians in rival parties had good interpersonal relationships; they would fight fiercely each other in Parliament and in public debates, but remained friends otherwise. Healthy dialogue and good relations are also needed because politicians have to interact and work together all the time. For example, there is considerable interaction between the Centre and States, and often both are run by different parties. Unfortunately, the interparty bonhomie is diminishing rapidly. This has also had an effect on public discourse and political debate, which are increasingly becoming bitterer and dirtier. From the Bharatiya Janata Party's perspective, its recent rise in political strength and the concomitant rise in assertiveness seem to be bringing various Opposition parties together. Fear is a very strong sentiment; it can work as an effective glue in politics. It has united 20 parties over the Parliament inauguration issue; it can do more in the foreseeable future.

# A fairy tale that is Neither the Oppn nor the Govt has covered itself in glory over the inauguration of new Parliament The Ketala Story




The Kerala Story has been making waves ever since it opened in theatres but its content is far from reality, it is a fantasy at best

he central theme of the film revolves around three girls who fell victim to "manipulative conversion" to Islam that practically destroyed their lives. The main protagonist is Shalini Unnikrishnan, a convert to Islam. She narrates her ordeal from her prison in Afghanistan, of how she once wanted to become a nurse but was brainwashed and manipulated by religious vanguards, turned into an ISIS terrorist and sent on her way to Syria.

It is loosely based on the accounts of three women from Kerala who converted to Islam and travelled with their husbands to join ISIS in Afghanistan between 2016 and 2018, along with two other women and their husbands. Their husbands were killed in the fighting and these women remain in an Afghan prison. Incidentally, only one of these women, Nimisha Nair alias Fathima Isa, was Hindu and married to a Christian, who subsequently converted to Islam as well. The other two women were Christians before their conversion. Government of India has refused to repatriate them as they remain hardcore adherents of ISIS philosophy, unlike what has been depicted in the

While it has been alleged there are many more such people in prison in Afghanistan, official records only point to four. Recently, Mr Amit Malviya, head of the BJP IT Cell, wrote on Twitter that "love Jihad is real and dangerous. Our girls are being lured away and used as cannon fodder for radical terror organisations. We can bury our heads in the sand, like an ostrich, at our own peril. It will engulf the rest of us sooner than we think. The Kerala Story is a grim reminder of what lies ahead if we don't act now".

Taken at face value this may seem truly scary, but the truth is it has no basis in fact and is aimed at spreading fear and consolidating votes. Comparison of census data from 2001 and 2011 shows that the Hindu population in Kerala, for example, declined from 56.16% to laws related to personal mat-54.73%, or 1.43%, while the ters such as marriage, divorce, increased from 24.70% to all citizens, regardless of their 26.56% or 1.86%. A simple religion interpolation, at existing growth rates, suggests that the Muslim population would equal that of the Hindu population only by the last decade of this cen-

tury. Unlikely, as growth

rates overall are on the decline. If anything, in the coming years Kerala's problems will not be about religion, but managing migrants from other states that keep its economy ticking!

# Terrorists are using newer ways of executing their acts

The world is reeling under the shadow of terrorism. Middle East and North Africa were worst hit in 2022, write SUNIL GOYAL & DIMPLE KHOKHAR

ince the turn of the mil-Slennium, few topics have shaped the global discourse as much as terrorism. Following the 9/11 attacks in New York, on September 20, 2001, the U.S. president at the time, George W. Bush, declared a "War on Terror" and sent America to war with Al-Qaeda. The USA first invaded Afghanistan in 2001 to evict the Taliban regime and to chase Osama Bin Laden. Then, two years later, the country invaded Iraq due to highly disputed claims about the regime of Saddam Hussein positing weapons of mass destruc-

tion. Many commentators argue that, rather than solve the problem, the War on Terror served only to validate the use of terrorist tactics, and that it threw these countries into further chaos. The Global Terrorism Index is an annual ranking produced by the Institute for Economics and Peace. As even the definition of terrorism is hotly debated, it is essential to highlight that the methodologies used to measure terrorism are also contested. The Global Terrorism Index ranks 163



countries on four indicators weighted over five years. These four factors are the number of terrorist incidents per year, the number of fatalities caused by terrorists per year, the number of injuries caused by terrorists per year, and the total property damage caused by terrorism per

The global terrorism index systematically ranks countries of the world according to their terrorist activity.

As per the data released by Statistica, in 2022, Afghanistan ranked first on the global terrorism index with a score of 8.82 points, making it the country most affected by terrorism on Earth. The ranking also shows that Afghanistan suffered

terrorist attacks and the highest number of fatalities from terrorist attacks. Although terrorism is a worldwide ly concentrated in certain areas of the world. The area that saw the highest number of terrorist attacks in 2022 was the Middle East and North Africa. According to Institute for Economics and Peace, the terrorism Index in India decreased to 7.43 in 2021 from 7.67 in 2020. Terrorism Index in India averaged 7.65 Points from 2002 until 2021, reaching an all-time high of 8.12 Points in 2011 and a record low of 7.22 Points in

India Terrorism Index - values, historical data and charts was last updated in May of 2023. A report based on the Global Terrorism Index noted India has a number of lowlevel conflicts in some of the border areas but the vast majority of the country's population lives outside of these India was among the 25 worst terror-hit countries but also among 56 of the 120 nations surveyed with no respondents selecting war and terror

from the highest number of daily safety, according to the 10th edition of the Global Terrorism Index (GTI).The international community holds a collective view that problem, its victims are high-terrorism in all its forms and manifestations must be condemned. There cannot be any exception or any justification for any act of terrorism, regardless of the motivations behind such acts. We also recognize that the menace of terrorism cannot be and should not be associated with any religion, nationality, civilization or ethnic group. However, in spite of the

progress we have made to tighten the legal, security, financing and other frameworks to combat terrorism, terrorists are constantly finding newer ways of motivating, resourcing and executing acts of terror. Unfortunately, there are also some countries that seek to undermine or subvert our collective resolve to fight terrorism. That cannot be allowed to pass.

# Who will end the free-run of freebies?



Political parties don't want freebies to go. It is their much-cherished tool to harness votes. And they know it works like a charm



n the just concluded assembly elections in Karnataka, the grand old party (GOP) Congress had promised five guarantees viz. Gruha Jyoti, Gruha Lakshmi, Sakhi pro-gramme, Yuva Nidhi, and Anna Bhagyain

Having got a decisive mandate to form the government, Congress pledged to approve all the five guarantees in the very first meeting of the Cabinet. The big question is: is it worth spending so much of

The guarantees are intended to be a welfare scheme. Under it, the government should ensure that (i) the assistance goes to a person who is desperately in need (one who is poor or very poor); (ii) it should be given for a 'limited period' after which she should stand on her own and (iii) the scheme should be funded in a manner such that it doesn't destabilize the

Under Gruha Jyoti, the GOP promisto provide 200 units of free electricity a month for every single household (HH) in the state. The very idea is abhorrent. It presumes that every HH is so poor that it can't afford to pay even Rs 1000 a month being the cost of 200 units of electricity @ Rs 5 per unit.

Further, in the absence of any mention of 'for how long', it is assumed that free supply will continue for the full term of this government i.e. 5 years. The scheme will impose a 'needless' burden on the state exchequer for that long.

It will also strain the finances of power distribution companies which will have to supply zero tariff power to all HHs on behalf of the state government and won't get paid by the latter in time or paid less or not paid at all as is the case in many states who are already supplying power free or at concessional tariff.

Under Gruha Lakshmi, Every Woman head of a house will get two thousand rupees a month. This again is bizarre! Going by the manifesto, even a billionaire woman is eligible. Distributing money in this manner is a sheer waste of scarce resources. The GOP says "We are keeping the money in the hands of women to

ensure that they're in control and in charge of their own life".

The idea of empowering the woman is fine. But, we must not forget the context. For schemes like PM Awas Yojna where houses are built for the poor and the ownership is vested with the woman head, this makes eminent sense. But, to give money to all and sundry and then trumpet about women's empowerment looks ridiculous. The Sakhi programme under which free bus tickets for all women to travel in Karnataka are provided too suffers from the same absurdity.

Under Yuva Nidhi, the government will provide support to the Youth of Karnataka for two years by paying Rs 3,000 to unemployed graduates and Rs 1,500 to unemployed diploma holders every month. Prima facie, this may be in sync with the principle of extending support to a person who needs it. But, it can't be divorced from the economic status of the family she belongs to. If an unemployed youth belongs to a rich family which can take care of her during the difficult period i.e. when she remains without a job, there is no need for state support.

State support should be given only if the unemployed youth is from a poor HH. That apart, while choosing the beneficiary, the government must ensure that she is not self-employed. The manifesto doesn't talk of any of these riders. Finally, under Anna Bhagyain, the GOP has promised to give 10 kgs of rice per person per month to BPL families. Such families are already getting 7 kg of food per person per month under the National Food Security Act or NFSA (2013).

Redeeming these guarantees will cost around Rs 62,000 crore a year which is even higher than the States' fiscal deficit or FD (excess

of expenditure over receipts) of Rs 60,500 crore during 2022-23. Unless there is a cut in expenditure under some head or an increase in receipt for an equivalent amount, the FD would be Rs 122,500 crore. Expressed as a share of the state gross domestic product (SGDP) this would go beyond 5 percent against the 3 percent ceiling fixed under Fiscal Responsibility and Budget Management (FRBM) Act.

The guarantees don't follow the cardinal principles of a welfare scheme. These are neither directed to the needy nor have any ter-minal date and will have a destabilizing effect on the budget. These benefits distributed by Congress using public money for garnering votes are known in common parlance as 'freebies'. The menace has gripped most of the political parties that use freebies as the key to winning elections.

Emboldened by its victory in Karnataka, the GOP will use freebies even more brazenly in state elections slated towards the end of 2023 as also during general elections in 2024. This will force others including the ruling BJP to offer similar or even more tempting allurements (already, BJP top brass has started galvanizing its thought process in that direction). This rat race will have devastating implications for the finances of both states and the Centre.

### Is there any way this menace could be reined in?

To get an answer, let us look at a judgment of the Supreme Court (ŚC) in S Subramaniam Balaji vs the Government of Tamil Nadu & Ors delivered way back in July 2013. It has been observed that the distribution of freebies of any kind influences all people. "İt shakes the root of free and fair elections to a large degree." This would have led any logical person to believe that the SC would give a strict direction to stem the rot. But, what followed was a lameduck order.

The SC had held that promises in the election manifesto cannot be construed as "corrupt practice" under the Representation of People Act (RPA), or any other prevailing law and, hence, distribution of freebies can't be stopped when the ruling party uses public funds for this purpose through the passage of Appropriation Acts in the state

In the same order, it directed the Election Commission of India (ECI) "to frame guidelines that could govern the contents of the election manifesto of all the recognized political parties as when it had acted while framing guidelines for general conduct of the candites, meetings, processions polling day, etc". Further "this can also be included in the model code of conduct - under a separate head for guidelines for election manifesto - for guidance of political parties and candidates".

### The ECI never came out with any such guidelines.

After a long hiatus, hearing a PIL seeking directions against 'freebies' on January 25, 2022, the SC observed "this is no doubt a serious issue. Budget for freebies is going above the regular Budget. This disturbs the level playing field". Its concern this time was more intense than it was in 2013. But, what about the action?

On August 3, 2022, the SC asked the parliamentarians to enact a law on curbing freebies but only after a committee set up by it examines all pros and cons. But, the majority of political parties don't want freebies to go away. It seems, India will have to live with this menace eternally.

# India to be a major player in the multipolar world

A multilateral world would be to India's advantage. It would also be welcome by the Global South which looks up to India for direction and leadership

here is a shift underway in the international system. The ongoing Ukraine conflict, the emergence of the Indo-Pacific as a centre for global politics, and the relentless rise of China have all resulted in a move away from a unipolar or bipolar world order to a multipolar one. This move is also one which suits India very well. As India positions itself globally as the leader of the Global South and a rising power, multipolarity assures India a position as one of the centres of power. This thought was very evident in the address made by External Affairs Minister Dr S Jaishankar at the recently held EU-India Pacific Ministerial Forum in Sweden where he pointed out that,

"The more European Union and Indo-Pacific deal with each other, the stronger will be their respective appreciation of multi-polarity. A multipolar world is feasible only by a multipolar Asia."

Prime Minister Narendra Modi's rather busy calendar is another indication in this direction. The G7 Summit in Tokyo which also saw a Quad Summit on the sidelines, a visit to Papua New Guinea and then Australia all tie in to this thought. The PM's muchanticipated visit to the United States next month, which is only the third State visit by a foreign leader in US President Joe Biden's tenure, will further cement not only India's growing stature on the world stage but also be a timely pointer towards multipolarity. It is a

shift India well understands and is cautiously working towards. The Ukraine crisis has

hastened this change. While the US and its Western allies have and continue to routinely condemn Russia over its actions, India has stuck to its guns and played it according to her interests. There was much pressure on India during the first few weeks of the conflict to censure Russian actions but the fact that India did not do so and eventually it also brought about a change in Western attitudes has been a fine diplomatic victory for India. In March last year Biden had termed India's response to the Ukraine conflict as 'somewhat shaky'. But with time the messaging out of Washington changed with a gradual accep-



tance of India's position. India has consistently abstained from the United Nations at resolutions

brought in by the Western world against Russia. This has helped India retain an old friend. About half of India's military supplies come from Russia. Courtesy of the Ukraine conflict, India's trade

with Russia is at a record high. Despite the never-ending critique, India continues to buy oil from Russia. It is also worth remembering here that Russia used its veto power in the United Nations Security Council (UNSC) many times when resolutions on Kashmir were tabled. The fact that India has done this fine balancing act, of maintaining and strengthening ties with both the US and Russia, makes it a unique power centre in itself.

Another point in the study is, of course, the Quad (a grouping of the US, India, Japan and Australia). It would not be an overstatement to say that the Quad today is one of the most influential groupings in the world of geopolitics. It is also essentially a only result in a closer China-

forum to check China. As the politics of the Indo-Pacific take centre stage in the world, India becomes an even more valuable ally not just to the US, but to the entire Western

For India, China remains the biggest worry. China's aggressive behaviour at the border and its expansionist agenda in the South China Sea have almost every world leader worried. The Úkraine conflict has also seen another related development and that is the tightening of embrace between China and Russia. And that is unlikely to make India comfortable. That somewhere again takes us back to the argument that for India, censuring Russia over the Ukraine conflict would Russia nexus. Both Russia and China are wary of the West and critical of a world they feel is dominated by Western ideals and nations. The US-China trade wars and the sanctions against Russia by the Western powers have helped consolidate that feeling and what one sees is the beginning of an anti-West Block.

A multilateral world would be to India's advantage and would also be welcome by the Global South. One of the end games of course would be a much-needed change in the structure of the UNSC and a permanent seat for India. That would also be more representative of the present world. The beginnings have been made but it's still quite a long road ahead.

# Praveen Sood takes charge as CBI's new Director

Thereafter, a scheme for the distribution of fortified rice, containing prescribed micronu-

trients -- iron, folic acid, Vitamin B12 -- was launched on October 2021 in a phased manner to address the problem of anaemia among

women and children. Khera alleged the Modi government rolled out fortified rice under the Food Security Act despite "failed" pilot projects and multiple warnings by experts, government officials, FSSAI and Niti Aayog advisors.

### **Octogenarian Howrah Bridge** to undergo health check!

The 80-year-old iconic Howrah Bridge, which connects the twin cities of Howrah and Kolkata over the Hooghly river, will undergo a detailed health checkup after a gap of 11 years, said a top official of Kolkata port that maintains the structure.

The comprehensive health checkup of the cantilever bridge will be done in consultation with IIT Madras, Kolkata port chairman Rathendra Raman said. The proposed exercise will be taken up in addition to the routine maintenance of the bridge, he said. "We have decided to conduct an in-depth study on the health of the Howrah Bridge, which hasn't been done for over a decade. This study will provide us with valuable insights on how to improve the bridge's lifespan," Raman said on Wednesday.

A comprehensive health checkup of the bridge was previously conducted 11 years ago, with the expertise of RITES, another official said. The Howrah Bridge, also known as Rabindra Setu, with 405 metres in length and 21.6 metres in width, is considered a symbol of Kolkata since its inauguration in 1943. The bridge was taken up for construction after a commission under the chairmanship of Sir R N Mukherjee in

1926 recommended a suspension bridge of a particular type to be built across the Hooghly river. The port authorities had already started working to scrap the bituminous road surface on the 80-yearold structure and a new layer would be laid to reduce the bridge's load. The National Technology Centre for Ports, Waterways & Coasts (NTCPWC), a division of IIT Madras, will advise the authorities for the comprehensive study, the port chairman said.

Raman stated that if necessary, another expert consultant would be appointed to assist the port authorities in the initiative. Every day, the Howrah Bridge facilitates the passage of approximately 80,000 vehicles and 400,000 pedestrians, becoming an integral part of their daily lives. Recognising the bridge's immense importance, the Kolkata port, now known as Syama Prasad Mookerjee Port, aims at securing its future and preserving the technological marvel, another senior official

The scope of the study is yet to be finalised but experts would closely examine issues such as corrosion and fatigue that the bridge had been facing, he said. "The goal is to identify effective strategies to address these challenges and to ensure the longevity of the bridge," the official added.

Using a new visualisation tool known as false fluorescent neurotransmitters, neuroscientists at The University of Queensland have discovered how vitamin D deficiency affects developing neurons in Schizophrenia, a serious mental health disorder. In a nutshell, the study, which comes a day after World Schizophrenia Day is marked, highlights the importance of vitamin D in brain development and the potential impact of deficiency on the onset of the mental condition.

Schizophrenia is associated with many developmental risk factors, and while the precise neurological causes of the disorder

remain unknown, the mental health disorder is associated with pronounced change in the way the brain uses dopamine.

Professor Darryl Eyles and his team analysed the functional changes in presynaptic dopamine uptake and release in the presence and absence of vitamin D. "What we found was that the

altered differentiation process in the presence of vitamin D not only makes the cells grow differently but recruits machinery to release dopamine differently," Professor Eyles said. Using the new visualisation tool, the team could then analyse the functional changes in presynaptic dopamine uptake and release in the presence and absence of vitamin D. They showed that dopamine release was enhanced in



cells grown in the presence of the

hormone compared to a control. "This is conclusive evidence that vitamin D affects the structural differentiation of dopaminergic neurons," Professor Eyles concluded.

The team is now exploring whether other environmental risk well-being." factors for schizophrenia, such as stress or drug exposure, can also affect the development of paminergic neurons.

Founder-director and senior psychiatrist from Manasthali, Dr

Jyoti Kapoor, who is in no way related to the said study stressed on early professional diagnosis and treatment by mental health professionals for managing schizophrenia. "People suffering from the condition are often isolated and stigmatized in society, making it challenging for individuals to feel understood and accepted. When family and community show kindness and compassion towards individuals living with schizophrenia, it creates a supportive environment that can positively influence their

measures to reduce stigma around this mental illness. "It lifts the lid on the challenges that thousands of people with Schizophrenia from all over the world have to encounter on a day-to-day basis," he said. On its part, the DEPwD observed the World Schizophrenia Day, through the institutions associated with it conducted various events at more than 30 places across India.

These included panel discussions by experts, street play, poster making and quiz competitions, webinars on early intervention in the mental disorders with perspectives from a Psychologist and psychiatrist, display of vocational stalls showcasing products made by persons with schizophrenia among a few others.

# 1 dead, 1 hurt in fresh Manipur riot

One person was killed and another injured in a fresh violence between suspected militants and a group of people in an area bordering Bishnupur and Churachandpur districts in strife-torn Manipur, police said on Thursday.

Toijam Chandramoni, 30, was shot dead during the vio-lence on Wednesday, and Leichombam Abungnao, aged 22, was injured when suspected militants opened fire at the group of people, mostly comprising those who were displaced during the recent ethnic clashes in Churachandpur and tool shelter in a relief compact took shelter in a relief camp at Moirang in Bishnupur, the officer said.

There were reports that militants late Tuesday night torched the houses of some villagers at Toronglaobi in Bishnupur district, he said. "The villagers and those living in the Moirang camp were angry over the burning of their houses. As these people came to know that militants could torch a school located in an area near Thamnapokpi in Bishnupur and Kanganthei in Churachandpur, they went to the locality.

"Once, they reached the spot, militants opened fire at them, leaving two persons injured. One of the two succumbed to his injuries when he was taken to a hospital," the senior police officer said. Following the violence, the authorities clamped curfew for

This was the first time a minister's house was attacked during the ongoing ethnic violence between Meitei and Kuki community people in state that started three weeks ago.

Army and paramilitary forces have been deployed to control the situation in state. "A closer examination of Jain's medical condition reveals a troubling array of ailments. He suffers from acute lumbar pain, causing vertigo and chronic lower back pain due to a slipped disc. The pain radiates throughout his lower limbs, leaving him with a constant tingling sensation and decreased mobility," it said. The AAP claimed that Jain

has become extremely weak and finds it difficult to walk.

'Due to his religious beliefs, Jain has been living only on fruits and raw vegetables in jail. Suffering from severe muscular loss. Jain has lost 35 kgs while in prison," the party said

"Suffering from sleep apnea, he sleeps at night with the assistance of a BiPAP machine which continuously pushes air into his lungs," the party added. A senior jail official said around 6 am on Thursday, under-trial prisoner Jain slipped in the bathroom of oom of the hospital of central jail number-7, where he was kept under observation for general weakness.

He was examined by doctors and his vitals were found normal. Jain was referred to the DDU Hospital as he complained of pain in his back, left leg and shoulder, the official

### **I-T** waiver for retirees' leave encashment hiked to ₹25L

**T**n line with the Budget announcement, the Finance Ministry on Thursday hiked the tax exemption limit for leave encashment upon retirement for private sector salaried employees to ₹25 lakh. So far, the tax exemption on leave encashment for non-govern-ment employees was ₹3 lakh which was fixed in 2002, when the highest basic pay in the government was ₹30,000 per

The Central Board of Direct Taxes (CBDT), in a statement, said the aggregate amount exempt from income tax under section 10(10AA)(ii) shall not exceed the limit of ₹25 lakh, where any such payments are received by a nongovernment employee from more than one employer. The increased limit for tax exemption on leave encashment on retirement or otherwise of non-government salaried employees to Rs 25 lakh with effect from April 1, 2023.

holders to Delhi after the end of my two-month long Jan Sanyog Yatra," he said.

Launching a scathing attack on the Prime Minister Banerjee who is also the nephew of Chief Minister Mamata Banerjee said "when came to power he showed us the dreams of Acchey Din (good days) but ended up in giving us inflation, unemployment, social tension and notebandi ... they are again making people to stand in queues for exchanging notes (read Rs 2,000 notes) ... but this time the people will stand in queues not to change notes but to change the government... there will be no notebandi ... now there will be

Alleging that the Centre had blocked all the State's dues -from MNREGA to PM housing funds - Banerjee said, "enough is enough we will not take their (BJP's) arrogance and brow-beating ... now the time has come to pay back." ### EW FEAT: MIG-29K PERFORMS NIGHT LANDING ON INS VIKRANT

Earlier, the naval version of the indigenously-built light combat aircraft successfully landed on INS Vikrant in February as part of the sea trials. LCA Teias is the first fixed-wing aircraft to land on the flight deck of Vikrant.

The 45,000-tonne aircraft was built at a cost of Rs 20,000 crore and was commissioned in September last year. It will be ready for fighter jet operations in the next few months. INS Vikrant has the capacity to hold 30 fighter jets and helicopters. At the commissioning ceremony of the vessel, Prime Minister Narendra Modi called it a "floating city" and that it is a reflection of India becoming self-reliant in

The flight trials on board INS Vikrant involve the Russian-origin MiG-29K fighter jets that use the ski-jump to take-off from aircraft carrier and are recovered by arrestor wires or what is known as STO-BAR (short take-off but arrested recovery).

Twelve MiG-29Ks are likely to be deployed on Vikrant and it will operate a new deck-based fighter that the navy is looking to buy as an interim measure to meet its requirements before the indigenous fighter jet is ready in a few years. The navy's other aircraft carrier, INS Vikramaditya, operates MiG-29K fighters. LCA (navy) landed and took off from Vikramaditya for the first time in August

"More than Rs 16,000 crore are being spent on the Rishikesh-Karnaprayag rail project, which will be completed in two-three years," Modi said, adding, "Work on the Tanakpur-Bageshwar rail link project will also start

soon."

The Prime Minister also mentioned the efforts underway to upgrade the facilities for Char Dham pilgrims.

"Char Dham Yatra is already breaking records every year. There are few states in the country that draw such a large number of pilgrims every year. It is a blessing and a challenge too. In order to make tackling this challenge easier, infrastructure projects are being launched in Uttarakhand," he said.

In his address earlier, Railway Minister Ashwini Vaishnaw said a modern train like the Vande Bharat Express, which is equipped with state-of-the art facilities, is a big gift to the people of Uttarakhand and reflects the prime minister's love for them.

The Vande Bharat Express reduces the journey time between Dehradun and Delhi to four-and-a-half hours from the six hours and 10 minutes it takes on the Shatabdi Express.

The Vande Bharat has eight coaches, all of them chair cars with 360-degree swivel seats. The train is equipped with CCTV cameras, Divyangjan-friendly washrooms, seat numbers in braille script, passenger information and infotainment systems in every coach among others.

Éighteen such trains are operational in the country at present.

"Modi has plans to bring about changes in the Indian Penal Code (IPC), Criminal Procedure Code (CrPC) and the Evidence Act in the spirit of the Constitution to increase the conviction rate which will help in the delivery of criminal justice," he added.

Policing can be divided into three parts: law and order situation, crime investigation and ensuring justice by punishing the guilty, the Home Minister said. This is not the age of using third-degree measures or force on the accused but there

are scientific ways of collecting evidence through psychology, fingerprints and DNA profiling and we need experts for these," he said.

The conviction rate in the country is low at 50 per cent and this is mainly due to lack of evidence or witnesses turning hostile which creates hurdles for the police in submitting chargesheets in the court, he added.

"We have decided to strengthen the forensic infrastructure, upgrade and modernise the laboratories, set up regional forensic laboratories and also district-level mobile forensic laboratories," Shah said.

This will require manpower and generate employment opportunities while research and development in this sector will be intensified and implemented at the grassroots level, he said. The state-of-theart institute, which will be built over a 50acre campus, will provide training to the police, judiciary and forensic scientists of neighbouring countries. Around 3,000 to 5,000 graduates and postgraduates from the institute will emerge in different branches of forensic science, wildlife forensics, cyber security, narcotics, digital forensics, drone forensics, forensic psychology and forensics justice and law, he said. The first phase of the NFSU campus is expected to be completed by 2026 and the second by 2030 while classes will start this year at the temporary campus on the premises of the Gauhati Medical College

and Hospital (GMCH). Shah also launched an interactive web portal, the 'Seva Setu', of the Assam Police, developed jointly with the Central Forensic Science Laboratory (CFSL). It will enable people to lodge FIRs, missing persons reports and complete verification of tenants, paying guests and domestic helps without having to visit the police station.

Later in the day, while addressing a public meeting here after ceremoniously distributing 44,703 appointment letters to successful candidates for Assam government jobs, the senior BJP leader alleged that the Congress has a "negative attitude" and charged it with doing politics by boycotting the scheduled inauguration of the

Shah said that the BJP had promised to provide one lakh gov ernment jobs in Assam before the 2021 assembly polls and within two-and-halfyears, 86,000 jobs have been given and the rest will be given within the next six months. He alleged that during the tenure of earlier governments, only the followers of the ruling party used to get jobs in the State. "The BJP has brought in a transparent system, in which even the poor people's sons and daughters are getting jobs on the basis of their merit and talent. There is no favouritism or nepotism now," he

# 'Imran, wife can't leave Pak'

# 3 dead in central Japan attack

Three people including two police officers were killed in Nagano in central Japan on Thursday and a suspect with a rifle and knife was holed up inside a building, according to police and media reports.

A witness told NHK public television that a woman fell while being chased by the suspect, who then stabbed her with a knife and shot at two police officers as they arrived at the scene in a patrol car in Nakano city in Nagano prefecture.The witness said he asked the suspect why he attacked her, and he replied that he wanted to kill her, NHK said.

The three victims were taken to a nearby hospital, where the woman was later pronounced dead, police said. The two police officers also died, according to NHK. A fourth person who was injured could not be rescued because he was near the suspect, Kyodo News agency reported. Video on NHK

### Dar hints at end of IMF loan programme

Islamabad (PTI): Finance Minister Ishaq Dar has hinted that the IMF loan programme to Pakistan may expire on June 30 due to the "restricted time" for its revival but asserted that the cash-strapped country would not default, a media report said on Thursday.

Pakistan is in acute need of the USD 6.5 billion loan facility by the Washington-based International Monetary Fund (IMF) to stabilise its economy.

While speaking to a delega-tion of a regional business body on Wednesday, Dar said, "Our efforts are aimed at completing the second IMF programme in the country's history, although time has been restricted and the programme is ending on June 30," The Express Tribune newspaper reported.

He stressed that the delay was "unfortunate" and the review should have been completed earlier. Since 1958, Pakistan has signed 22 IMF programmes but failed to complete all, barring the 2013-16 facility, thanks to nearly 18 waivers from the global

Islamabad signed the cur-rent 36-month USD 6 billion Extended Fund Facility in July 2019, which, on request of the then-finance minister, Miftah Ismail, was extended by the IMF by nine months to June 30, 2023, and its size increased to USD 6.5 billion. Over the past almost four years, the programme has been derailed at least four times, including on two occasions during the tenure of the current coalition govern-ment, and the failure to complete it will further widen the trust deficit between the country and the financial world, the report said. The government has not yet come up with a credible alternative plan, which has created panic in markets as the Pakistani Rupee is trading in the range of PKR 308 to PKR 313 to a dollar

# South Korea, US troops hold large live-fire drills

The South Korean and US militaries conducted large live-fire drills near the border with North Korea on Thursday, despite the North's warning that it won't tolerate what it calls an invasion rehearsal on its doorstep. The drills, the first of five rounds of live-fire exercises through mid-June, mark 70 years since the establishment of the military alliance between Seoul and Washington. North Korea typically reacts to such major South Korean-US exer-cises with missile and other

weapons tests. Since the start of 2022, North Korea has test-launched more than 100 missiles, but none since it fired a solid-fuel intercontinental ballistic missile in mid-April. It says the tests are a response to expanded military drills between the US and South Korea, but observers say North Korea aims to advance its weapons development and then wrest greater concessions from its rivals in eventual

The ÚS-South Korean firing exercises, called "Combined annihilation firepower drills," are the biggest of their kind. The drills have been held 11 times since they began in 1977, according to the South Korean

Defence Ministry.
The drills involved 2,500 troops and 610 weapons systems such as fighter jets, attack helicopters, drones, tanks and artillery from South Korea and the United States, according to the South Korean Defence Ministry. The most recent exercises in 2017 drew about 2,000 soldiers and 250 weapons assets from both countries.

The drills simulated artillery and aerial strikes on front-line North Korean military facilities in response to an attack. The troops later practiced precision-guided attacks on simulated targets in the rear areas to "completely annihilate" North Korean military threats,

It said South Korea will seek to establish "peace through overwhelming strengthen" to counter North Korean threats.

North Korea didn't immediately respond to the start of the drills. Last Friday, its state media called the drills "a typical North Korea-targeted war rehearsal," saying it "cannot but take a more serious note of the fact" that the exercises are a few kilometres from its frontier. The North's Korean Central News Agency said the US and South Korea would face unspecified "corresponding responses" to the drills.

Earlier this year, the South Korean and US militaries conducted their biggest field exercises in five years. The US also sent the nuclear-powered USS Nimitz aircraft carrier and nuclear-capable bombers for joint exercises with South

Moon Seong Mook, an analyst for the Seoul-based Korea Research Institute for National Strategy, said North Korea could use the South Korea-US drills as a pretext to resume testing activities. He said domestic issues such as North Korea's push to increase agricultural production during the rice-planting season could still affect its decision on

"North Korea can't help feel some burdens over the South Korea-US joint firepower drills being held for the first time in six years and in the strongest manner," Moon said.

In a meeting last month, US President Joe Biden and South Korean President Yoon Suk Yeol announced steps to reinforce their deterrence capabilities such as the periodic docking of US nuclear-armed submarines in South Korea, strengthened joint training exercises and establishment of a new nuclear consultative group. Biden also issued a blunt warning that any North Korean nuclear attack on the US or its allies would "result in the end of whatever regime" took such action.

Kim Yo Jong, the powerful sister of North Korean leader Kim Jong Un, said the Biden-Yoon agreement revealed the two countries' "most hostile and aggressive will of action" against the North.

She threatened to further strengthen her country's nuclear doctrine, saying, "The pipe dream of the US and South Korea will henceforth be faced with the entity of more powerful strength."

# Chinese minister to hold talks amid disputes over tariffs

will hold talks with officials in the US this week amid sharpening disputes over tariffs and technology, his ministry said on Thursday. Communist Party's efforts to develop advanced chips for smartphones, artificial intelligence and other applications are stalled. In what was seen as retaliation, China's cybersecurity

watchdog on Sunday announced a ban on products from US memory chipmaker Micron Technology Inc. in some computer systems.

Administration of China said Micron products have unspecified security risks but gave no details.

The trade disputes have brought supply disruptions and caused billions of dollars in lost sales but are seen as necessary by the West to prevent Beijing from accessing technology with

military applications.
China has stepped up its threats to invade self-governing Taiwan, increased its military presence in the South China Sea to back its claims to the strategic waterway, and provided diplomatic and economic backing to Russia over its invasion of Ukraine. Their political differences, trade between China and the US topped USD 690 billion last year, while an estimated 295,000 Chinese students are enrolled in American colleges and universities.

### Russia signs deal to deploy tactical nuclear weapons in Belarus

Tallinn (AP): Russia and Belarus signed a deal on Thursday formalising the procedure for deploying Russian nuclear weapons on Belarusian territory. Control of the weapons will remain with Moscow. The move formalised the deal agreed on earlier by Russian President Vladimir Putin and Belarusian President Alexander Lukashenko.

previously Putin announced in March that his country planned to deploy tactical, comparatively short-range and small-yield nuclear weapons in Belarus. The inking of the deal comes as Russia braces for Ukraine's muchanticipated counteroffensive. Both Russian and Belarusian officials framed the step as driven by hostility from the West.

"Deployment of nonstrategic nuclear weapons is an effective response to the aggressive policy of countries unfriendly

### **Germany** eco shrinks, signalling recession

The German economy shrank **L** unexpectedly in the first three months of this year, marking the second quarter of contraction that is one definition of recession. Data released Thursday by the Federal Statistical Office shows Germany's gross domestic product, or GDP, declined by 0.3 per cent in the period from January to March. This follows a drop of 0.5 per cent in Europe's biggest economy during the last quarter of 2022.

Two consecutive quarters of contraction is a common definition of recession, though economists on the euro area business cycle dating committee use a broader set of data, including employment figures.

# Taliban may allow women to resume agency work

The head of a major aid **■** organisation said Thursday that the Taliban have agreed to consider allowing Afghan women to resume work at the agency in the southern province of Kandahar, the religious and political centre for the country's rulers.

The Taliban last December

barred Afghan women from working at nongovernmental organisations, or NGOs, allegedly because they were not wearing the hijab — the Islamic headscarf — correctly or observing gender segregation rules.

In April, they said the ban extended to UN offices and agencies in Afghanistan. There are exemptions in some sectors, like health care and education.

Jan Egeland, the secretarygeneral of the Norwegian Refugee Council, met officials



in the capital Kabul and Kandahar to persuade them to reverse the ban on the organization's female staff. "We have an agreement to

start immediate talks on a temporary arrangement that will enable our female colleagues to work with and for women and others in Kandahar," Egeland told The Associated Press. "If we get a provincial exemption in Kandahar, we should be able to replicate it elsewhere."

# 'Republicans pushing debt ceiling talks to the brink' | HK-flagged vessel blocks Suez Canal

House Republicans are pushing debt ceiling talks to the brink, displaying risky political bravado as they prepare to leave town on Thursday for the holiday weekend just days before the US could face an unprecedented default that could hurl the global economy into chaos. Speaker Kevin McCarthy said he's directed his negotiating team "to work 24/7 to solve this problem."

Arriving at the Capitol, McCarthy, R-Calif., said that "every hour matters" in talks with President Joe Biden's team as they work toward a budget deal. Republican are demanding spending cuts the Democrats oppose, and McCarthy said a deal could come together "at any

But it's clear the Republican speaker who leads a Trump-aligned party whose hard-right flank lifted him to power — is now staring down a potential crisis. Lawmakers are tentatively not expected back at work until Tuesday, just two days from June 1, when Treasury Secretary Janet Yellen has said the US could start running out of cash to pay its bills and face a federal default.

Fitch Ratings agency placed the United States' AAA credit on "ratings watch negative," warning of a possible downgrade because of what it called the brinkmanship and political partisanship surrounding the debate over lifting the debt ceiling. "This is a battle between extremism and common sense," said Democratic Rep. Katherine Clark of Massachusetts, the minority whip.

The Republicans, she said, "want the American people to make an impossible choice: devastating cuts or devastating debt default."

Weeks of negotiations between epublicans and the White House have failed to produce a deal - in part because the Biden administration never expected to be having to negotiate with McCarthy over the debt limit, arguing it should not be used as leverage to extract other partisan priorities. McCarthy is holding out for steep spending cuts that Republicans are demanding in exchange for their vote to raise the nation's borrowing limit. The White House has offered to freeze next year's 2024 spending at current levels and restrict 2025 spending, but the Republican leader says that's not

A Hong Kong-flagged ship briefly blocked Egypt's vital Suez Canal on Thursday morning, authorities said, the latest such incident in the busy waterway. According to Leth Agencies, a canal services company that oversees the waterway, the Xin Hai Tong 23 ran aground before dawn at the southern entrance to the canal, blocking four vessels. The ship was refloated by the Suez Canal Authority a few hours later, the company said, and normal traffic was restored.

decision on Asia Cup's fate will be taken on the sidelines of the IPL final, which will be attended by a host of top Asian Cricket Council (ACC) dignitaries, BCCI secretary Jay Shah said on Thursday.

Pakistan have the hosting rights for this year's Asia Cup but with BCCI deciding against sending its team to the neighbouring country without government permission, PCB chairman Najam Sethi had proposed a 'hybrid model' where they will organise at least four games on home soil and India will play their matches at a neutral venue.

It couldn't be confirmed whether Sethi has been formally invited for the IPL final.

'As of now, the decision with regards to hosting of Asia Cup hasn't yet been finalised. We are busy with IPL but the top dignitaries of Sri Lanka Cricket (SLC), Bangladesh and Afghanistan Cricket Board are coming to watch the IPL final. We will have a discussion and take a final decision in due



course," Jay Shah told PTI.

It has been learnt from ACC sources that Sethi's proposed hybrid model looks like a feasible solution although ACC had made no formal statements. According to the model, Sri Lanka, Bangladesh, Nepal and Afghanistan play

four preliminary matches in Pakistan and India would play all their games at neutral

The two India-Pakistan games will also be held in Sri Lanka although the PCB wants them in Dubai. The weather in UAE in September is not at all

# French Open 2023: Alcaraz, Djokovic on same half of draw

# Swiatek-Gauff could be in quarterfinals

arlos Alcaraz and the man he just Creplaced atop the rankings, 22-time Grand Slam champion Novak Djokovic, were placed in the same half of the French Open field in Thursday's draw and could face each other in the

Alcaraz is seeded No. 1 at a Grand Slam tournament for the first time and was automatically placed in the top section of the bracket. Djokovic is No. 3 and so could have ended up on either half - had he landed in the bottom, he and Alcaraz only could have met in the final at Roland Garros, where 14-time champion Rafael Nadal will be missing for the

first time since he made his debut at the clay-court major in 2005. Play begins Sunday.

Typically, the previous year's singles champions are invited to appear at the draw, so 2022 women's winner Iga Swiatek was present Thursday. Nadal, of course, was not. Still, he was the first player mentioned at the outset of the ceremony by French Tennis Federation president Gilles Morreton, who noted, "Unfortunately, he cannot play the tournament this year."

Swiatek did not appear to show any ill effects from the hurt right thigh that caused her to stop playing in the third set of her quarterfinal match in Rome last weekend.

She indicated almost immediate-



ly that the issue would not prevent her from competing in Paris, where she has won two of her three major trophies. "It's like my favorite tournament in the whole year, so I'm always excited to come back," said Swiatek, who has been ranked No. 1 for more than a year. "Before the tournament, I get this extra motivation to practice

harder, to make everything better." The draw put her in a potential quarterfinal against No. 6 Coco Gauff in what would be a rematch of last year's French Open final.

Alcaraz, who just turned 20, and Djokovic, who just turned 36, have played each other just once previously, in the semifinals of the Madrid Open in May 2022. Alcaraz won that one 6-7 (5), 7-5, 7-6 (5) — a day after beating Nadal in the quarterfinals, becoming the first player to defeat both Djokovic and Nadal at the same clay-court tournament. Alcaraz went on to collect the title there with a straight-set victory over Alexander

Zverev in the final. It was Zverev who ended Alcaraz's 14-match winning streak in the French Open quarterfinals last year. That was also the round where Nadal stopped Djokovic in a four-set, four-hour thriller. This time, the men's quarterfinals

by seeding would be Alcaraz, the reigning U.S. Open champion, against No. 5 Stefanos Tsitsipas, a two-time Slam finalist; Djokovic against No. 7 Andrey Rublev; No. 2 Daniil Medvedev, the 2021 U.S. Open winner, against No. 8 Jannik Sinner; and No. 4 Casper Ruud, runner-up at the French Open and U.S. Open last year, against No. 6 Holger Rune.

Other women's matchups in that round could be No. 4 Elena Rybakina, the reigning Wimbledon champion, against No. 7 Ons Jabeur, a two-time major finalist; No. 2 Aryna Sabalenka, who won the Australian Open in January, against No. 5 Caroline Garcia; and No. 3 Jessica Pegula vs. No. 8 Maria Sakkari.
