India Vanquishes the Proteas

On his 35th birthday in one of the game's iconic venues packed with the most exuberant fans, Virat Kohli equalled his idol Sachin Tendulkar's record of most ODI centuries with his 49th hundred, laying the foundation for India's 243run pummelling of South Africa in the World Cup on Sunday.

This, perhaps, was written in the stars.

Entering the Eden Gardens after a run of seven successive wins by his team, Kohli was up against an in-form and ambitious South African side seek ing to shed the choker's tag and win its maiden World Cup

But, by the time the game got over, South Africa were left bruised and battered after being bowled out for 83 in 27.1 overs as India consolidated its top place in the pecking order, with Kohli finally matching Tendulkar after the whole country waited for weeks in anticipation

Attempting to steel the thunder from Kohli was Ravindra Jadeja, who ended with excellent figures of 5/33.

Set an imposing target of 327 after Kohli's 121-ball 101 not out, Shrevas Iver's fluent 87-ball 77 and some fireworks towards the end by Suryakumar Yadav and Jadeja, the Proteas crumbled like a pack of cards.

India captain Rohit Sharma also deserves special mention for his 24-ball 40, putting South Africa on the back foot straight-

ty much the same but the Indian bowling was again at a different level altogether, running through the side with the same relentlessness and poten-cy they have been doing through the tournament.

South Africa were in dire straits in no time, tottering at 40/5 and then 67/7 as India had the match all wrapped up.

The menacing pace trio of Jasprit Bumrah, Mohammed Siraj, and Mohammed Shami was once again on the money before star all-rounder Jadeja did the star turn with his turn, bounce and accuracy.

Not content with his cameo with the bat (29 off 15 balls), Jadeja got the ball to behave in whichever way he wanted it to and finished with fine figures. The first to go was the in-from Quinton de Kock, who got an inside edge against Siraj after smashing him for a boundary. Losing De Kock was a big blow for the South Africans, and skipper Temba Bavuma too fell cheaply to continue his quest for one substantial knock in the showpiece, bowled by a beautiful turning delivery from

South Africa were three down inside the powerplay as Shami, with a good length ball that jagged away off the seam, induced an edge from Aiden Markram and KL Rahul completed a low catch.

Rassie van der Dussen thought he was saved when Shami's loud appeal for an lbw failed to

away with his attacking intent. When the Proteas' turn to bat came, the pitch remained pret-impress the on-field umpire but the Indian seamer and his wicket-keeping colleague wicket-keeping colleague Rahul's decision to review was vindicated when the technology showed that the ball would go on to hit the middle and leg stump.

South Africa bat deep but Jadeja, meanwhile, snared Heinrich Klaasen (1) and David Miller (11) to inch closer to a massive win, which was achieved when Kuldeep Yadav bowled Lungi Ngidi.

The match was over in South Africa's 28th over and with a lot of time still left to play. Earlier, the setting was ideal for

Kohli to equal Tendulkar's

record after missing the magic three-figure mark more than once in the tournament. He was dismissed for 95 and 88 against New Zealand and Sri Lanka but the Indian runmachine did not disappoint

the ecstatic full house at the Eden Gardens. The monkey was finally off his back in the 49th over when Kohli gently pushed Kagiso Rabada for a single. The century came off 119 balls with 10

fours, showing that Kohli toiled

hard for his runs.

For Kohli, the milestone ton came in 277 innings, while Tendulkar had brought up his 49th ODI century in 452 innings. A comparison, though, is not fair considering the different playing conditions in the two eras.

The relief was evident as he took his helmet off, kissed his bat, and saluted the crowd that gave him a standing ovation.

Canada in a Conundrum

Ottawa cannot stand against Delhi

anada's investigation into →the murder of a Sikh extremist has been tainted by a high-level Canadian official's public statements, India's High Commissioner to Canada Sanjay Kumar Verma has said as he asked Ottawa to provide evidence to back up its allegations.

In an interview with the Globe and Mail newspaper, Varma on Friday said there "is no specific or relevant information provided in this case for us to assist them in the investigation. "Where is the evidence? Where

is the conclusion of the investigation? I would go a step further and say now the investigation has already been tainted," Verma was quoted as saying by the newspaper. "A direction has come from

someone at a high level to say India or Indian agents are behind it," he said on Saturday, without naming anyone.

The ties between India and Canada came under severe strain following Prime Minister Justin Trudeau's allegations in September of a "potential" involvement of Indian agents in the killing of Khalistani extremist separatist Hardeep Singh Nijjar in the Canadian town of Surrey in

India had designated Nijjar as

India rejected the allegations as "absurd" and "motivated". Days after Trudeau's allegations, India temporarily suspended the issuance of visas to Canadian citizens and asked Ottawa to downsize its diplomatic presence in the country to ensure parity. Canada has withdrawn 41 diplomats and

India. Verma strongly denied Canada's allegation and said India made 26 requests to Ottawa over the past five or six years to extradite people, but Canada did not take any

He also spoke about security threats to him and other Indian diplomatic staff in the country. On Saturday, External Affairs Minister S Jaishankar in New Delhi said there is room for diplomacy to address the diplomatic row between India and Canada. He said both sides have been

in touch and hoped that a way would be found to resolve the row. At the same time, he asserted that "sovereignty and sensitivity" cannot be onewav streets.

"My hope certainly would be that we find a way...Sovereignty, sensitivity — these cannot be one-way streets. They may have their concerns. I have never ever with any country said that I am not willing to talk to them about their legitimate concerns," he said.

Only CNG, electric, BS VI vehicles from other States are allowed entry in the NCR areas. The fourth stage of the GRAP allow public, municipal, and private offices to operate at 50 per cent strength, with the rest working from home. The CAQM advised people, especially children, the elderly, and those with health

Technology will track terror

n order to prevent the terror accused out on bail from falling into the trap of their original handlers, the Jammu and Kashmir Police have introduced GPS tracker anklets to track down their movements. This is the first of its kind initiative taken by any police force across the country. ng to a Iammu and police spokesman the devices were introduced after a Special NIA Court, Jammu, passed an order directing the police to affix a GPS tracker anklet on a terror accused — the importance of which was highlighted by the prosecution department of the police. The GPS tracker anklet is a wearable device affixed around the ankle of the person to monitor and track

The device is already being used in Western countries such as the USA, the United Kingdom, South Africa, Australia and New Zealand to track the movement of accused persons on bail, parole, and house arrest and accordingly de-congests

The officials of the State Investigation Agency (SIA) of the J&K Police have introduced the GPS tracker anklet for monitoring of bail-out terror accused.

Giving details of the case, the police spokesman said in an FIR registered



Ghulam Mohd Bhat had applied for bail. During the pendency of the bail hearing, the accused sought to be released on interim bail. The accused is undergoing trial for being associated with different terrorist organisations and being involved in terror financing at the behest of the pro-scribed terrorist organisation Hizbul Mujahideen (HM).

In the Special NIA Court, Jammu, the importance of close monitoring of the terror accused and the stringent conditions for grant of bail under the UAPA, 1967, was highlighted by the prosecution department of Zonal Police Headquarters (ZPHQ), Jammu, the officials said.

"Finding merit in the submissions of the prosecution, the Special NIA Court, Jammu, was pleased to pass an order directing J&K Police to affix a GPS tracker anklet on the accused," they added.

Marine debris hits India's coastal economy

Marine debris with high buoyancy, such as bottles, rubber, household items, and plastic bags, carries along with it a large number of invasive species to the Indian shores, thus becoming a new source of threat to the livelihood of the locals, including fishermen already grappling with climate change impacts, overexploitation, sewage, and unregulated tourism, among others

The research published recently in Marine Pollution Bulletin by a team of Indian and foreign researchers while conducting a study in the southeast coast of India highlighted the threat that looms large on the Indian coastline of 7,516 km of which the mainland accounts for 5,422 km.

Nearly 250 million Indians live within a distance of 50 km from the coastal areas of India. "The results highlight the increasing risk of invasive species colonisation on plastics along the southeast coast of India. This is particularly worrying at a time when plastics are becoming a more and more common substrate for marine organisms, especially in India, which is one of the top countries contributing most to ocean plastic pollution.

"Our study thus serves as a call to immediate action to address plastic pollution and its related threats in India." explains Dr Blanca Figuerola, a member of the Medrecover Group and the last author of the study. The research team, led by the Institut de Ciències del Mar (ICM-CSIC) and the Sathyabama Institute of Science and Technology in collaboration with the University of (UB), Barcelona Abdelmalek Essaadi University (UAE), and the University of Oslo (UiO), had conducted a comprehensive examination of fouling organisms on various types of stranded litter, including plastic, glass, rubber, foam sponge, cloth, metal, and wood. They found a total of 3,130

impacts are documented and available only for 3 per cent of the known invasive species and unavailable/masked/underrepresented for the rest 97 per cent of invasive species in India. That's a huge knowledge gap," evolutionary biologist Alok Bang said in a report.

"Based on this global analysis, going by India's GDP, we must have spent about \$3.4 trillion on invasive species in the last six decades; going by India's population, we must have spent about \$1,700 trillion in the last six decades," Bang said as per

Dr Anna Sanchez-Vidal. Associate Professor in the UB

Department of Earth and Ocean Dynamics, member of the UB's Marine Geosciences Consolidated Research Group and co-author of the study published in the Marine Pollution Bulletin too called for effective waste prevention and management, education, and awareness campaigns to mitigate the introduction of invasive species via marine litter. Local and global stakeholders must come together to address this critical issue and protect the fragile marine ecosystems along India's southeast coast, he opined. The team has already warned

that plastic debris in the sea was contributing to the introduction and transport of nonnative marine species in the Catalan coast in a recent study. Coastal areas are already facing pressures such as climate change, overexploitation, sewage, nutrient pollution and recreation activities which can exacerbate the impacts of invasive non-native species, as per

Governor Arif slams Kerala Government for extravagant Keralayeen

A major stand off has erupt-ed between Governor Arif Mohammed Khan and Government of Kerala over the latter organising a week long extravaganza titled Keralayeem at a cost of Rs 30 crore when the State is reeling under severe financial crunch. "The Government itself is claiming that the State is witnessing major financial crisis. So there is no justification for holding this event at this juncture," Governor told media persons on Sunday in the sidelines of a private function where he was the chief guest. He lambasted the Pinarayi Vijayan-led CPI(M) government for squandering public money despite the Government submitting an affidavit in the Kerala High Court stating that the treasure is empty and the State has gone broken financial-

Governor's statement comes at a time when the Government of Kerala has moved the Supreme Court asking it to declare the former has failed in exercising his Constitutional duties. Responding to queries in this regard the Governor stated that the Government has failed to keep him abreast of their intentions and reason for passing such legislation. The Bills held by the Governor include the move to appoint former Chief Justice of Kerala Manikular as chairman of the State Human Commission in lieu of the services rendered by him and also the appointment of vice chancellors of the universities in the State.

Arif Mohammed Khan said that as per Constitution, the Government is bound to keep

Bills, it has got its own reasons and this I'll state in the Supreme Court. I have full trust in the country's apex court," he said. He also stated that the Chief Minister never meets him or calls him up. "When two of his ministers came to meet me with a request to speed up the clearance of the Bill, I had asked him for some clarification. They replied that the chief minister alone could answer it,"

NIA chargesheet against 7 accused in Pune ISIS terror module case filed

The National Investigation Agency (NIA) has filed a charge-sheet against seven ISIS members accused of being involved in a conspiracy to carry out terror attacks in different parts of the country, an official said on Sunday.

They were charge-sheeted here under various sections of the Unlawful Activities (Prevention) Act, the Explosive Substances Act, the Arms Act and the Indian Penal Code (IPC) in the Pune-based ISIS module case, the spokesperson of the federal agency said.

The official identified the charge-sheeted accused as "Moȟammad Imran-Mohammad Yusuf Khan alias 'Matka' alias 'Aamir Abdul Hameed Khan' and Yunus-Mohammad Mohammad Yakub Saki alias 'Adil' alias 'Adil Saleem Khan" of Ratlam in Madhya Pradesh; "Kadeer Dastagir Pathan alias 'Abdul Kadeer' and Seemab Nasiruddin Kazi" of Kondwa in Maharashtra's Pune; and "Zulfikar Ali Barodawala alias 'Lalabhai' alias 'Saif', Shamil Saquib Nachan and Aakif Ateeque Nachan" of Padgha in Maharashtra's Thane.

The accused were involved in collecting and raising funds for the Islamic State of Iraq and Syria (ISIS) with the intention to further its activities related to terror and violence, the spokesperson said.

The official said it was found that the accused organised ter-



rorist training camps, har boured known and wanted terrorists, and committed acts preparatory to the fabrication of improvised explosive devices

In addition, they were also found in possession of IEDs, firearms, and ammunition," the spokesperson said, adding that they had hatched a conspiracy to further the terrorist activities of the ISIS, with the intention to strike terror amongst the people and threaten the security, integrity and sovereignty of India.

'Investigations uncovered a larger conspiracy with international connections and the involvement of foreign-based ISIS handlers in the ongoing case. The investigation has unveiled a complex network of individuals committed to propagating the extremist ideology of the ISIS within India," the official said.

The official said the accused, as part of this network, also took

'The accused were also found to be collecting funds from various sources, both within India and abroad, to finance their terror designs and plans," the spokesperson said.

Primary schools shut till Friday as air remains hazardous

For classes VI onwards, the Heads of es VI onwards, the Heads of Schools shall have the option either to call students for physical classes or to have these classes conducted online depending on the digital infrastructure & readiness of the school to conduct online classes," stated in the order issued by the Directorate of Education. MANUAL SCAVENGING Strictly comply with SC ruling: HC to city Government, MCD



The Delhi High Court has directed the city Government and civic authorities to ensure compliance with the decision of the Supreme Court on strict implementation of law for eradication of manual scavenging.
A bench headed by Chief

Justice Satish Chandra Sharma observed that the top court has passed various directions on the issue, including enhanced compensation amount of Rs 30 lakh for sewer deaths and minimum ₹20 lakh compensation in case of permanent disabili-

ty.
"The apex court has issued various other directions to ensure that the practice of manual scavenging stands completely eradicated. The Government of NCT of Delhi, the Delhi Jal Board, the Municipal Corporation of Delhi and all other authorities are directed to other authorities are directed to strictly comply with the judgment delivered by the Hon'ble Supreme Court," said the bench, also comprising Justice Tushar Rao Gedela, in a recent order. "The apex court has enhanced the compensation amount for sewer deaths from Rs 10 lakh to Rs 30 lakh, and in case of sewer victims suffering disabilities, the compensation is to be fixed depending on the severity of the disabilities. The minimum

sewer victims suffering from disabilities has been fixed at Rs 10 lakh and in case the disability is permanent and renders the victim economically helpless, the compensation must not be less than ₹20 lakh," the court observed. The high court's order came on

Schoolchildren enact life journey of danseuse Sudha, athlete Arunima



Campaigning for Mizoram, 1st phase Chhattisgarh polls ends

ampaign for the first phase of Assembly elections that begins on Tuesday came to an end on Sunday evening for the single phase Mizoram Assembly elections and first phase Chhattisgarh with top political leaders including Prime Minister Narendra Modi shuttling for rallies between the north eastern state and the Chhattisgarh and another poll bound Madhya Pradesh which goes to polls on November 17. The other States which would vote in assembly elections this month are Rajasthan single phase on November 25 and Telangana on November 30.

Sending polling parties to the inaccessible and Maoist affected polling booths in the first phase of elections started on Sunday. 42 polling parties in Sukma district and 34 polling parties in Bijapur district were transported to the polling stations through helicopters. The second phase Chhattisgarh polls will be held on November 17 and counting for all is scheduled for December 3.

On the last day of the campaign, Modi visited Dongargarh, a pilgrimage spot, and met Jain seer Acharya Vidyasagar Maharaj. The PM also prayed at Maa Bamleshwari Devi tem-

Apart from Modi, Union Home Minister Amit Shah, Uttar

Adityanath and Assam CM Himanta Biswa Sarma campaigned in the first phase, while the Congress' bid to retain power was led by Rahul Gandhi, party president Mallikarjun Kharge, Priyanka Gandhi and Chief Minister Bhupesh Baghel.

In the 2018 Assembly polls, the Congress had won 17 out of the 20 seats that will go to polls in the first phase. The Congress has 71 seats in the 90-member House. The second phase of polls to 70 seats will take place on November 17, while results will be counted on December 3. The north eastern state Mizoram this time witnessed a high voltage campaign with



the political landscape shifting from bi-polar to multi-corner contest which saw presence of more national and regional parties in the electoral fray indicating a stiff fight across all constituencies. The ruling Mizo National Front

is banking on its achievements and "Zo" nationalism while the Congress is looking for a comeback by pushing the agenda of "Trang Puihna. The Zoram People's Movement is fighting for a new system of governance - "Kalphung Thar" while the BJP is pushing the agenda of Good Governance and Development. The new entrant Aam Aadmi Party is fighting on the plank of "Corruption Free Mizoram".

While Mizoram will go for a single phase of Assembly polls on November 7 to elect 40 members of the Mizoram Legislative Assembly, polling for the first phase in Chhattisgarh will be held in 20 assembly constituencies same day. Counting will take place on December 3 alongwith all other states where are elections are scheduled this

Meanwhile, incidents of Maoist violence have been reported in some areas of Bastar division. Maoists killed a BJP leader in Kaushalnar village of Maoistaffected Narayanpur district in Bastar division today evening while he was campaigning. The slain BJP leader was the district vice president of the party.

Panel likely to adopt draft reports on Bills to replace criminal laws today

A parliamentary committee Ascrutinising three bills to replace the existing criminal laws will meet on Monday to adopt draft reports, days after some Opposition members had sought an extension for the panel to go through the measures in greater detail. On October 27, the standing

committee on Home could not adopt the three draft reports as some Opposition members pressed for more time to study it. Some opposition members had urged panel chairperson Brij Lal to seek an extension of three months in its tenure and "stop bulldozing these bills for short-term electoral gain".

For making a robust legislation that serves the marginalised, the committee should not adopt a final report in the next



few days or in November. "We will be mocking the process of legislative scrutiny if we do so," an opposition MP had said in a communication, according to

However, BJP sources said the committee has engaged in an extensive consultation process and will meet its deadline of three months. The committee will now meet on November 6, according to a notice sent to members for adopting the three drafts. Sources said the panel may adopt the draft reports despite protests by some of its members from the opposition

Seeking a complete overhaul of

Home Minister Amit Shah had introduced in Lok Sabha during the Monsoon session three bills to replace the Indian Penal Code (IPC), The Code of Criminal Procedure, 1973 and the Indian Evidence Act, 1872 with Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Adhiniyam, respectively. The House later sent the bills

after their introduction on August 11 to the committee for scrutiny and asked it to submit its report within three months. Sources have said that the committee is likely to recommend a raft of amendments in the three bills but will be sticking to their Hindi names, something fiercely contested by opposition MPs, including from the DMK. They have demanded English names for the proposed laws as well.

Rajnath approves extension of rules for maternity, child care leaves for women in Armed forces

Defence Minister Rajnath Singh has approved a pro-posal for extension of the rules for maternity, child care and child adoption leaves for women soldiers, sailors and air warriors in the Armed Forces on a par with their officer counterparts. With the issuing of the rules, the grant of such leaves to all women in the military, whether one is an officer or any other rank, will be equally applicable. Giving details of this important

decision here on Sunday, defence ministry officials said the decision is in line with Rajnath's vision of inclusive participation of all women in the Armed Forces, irrespective

The extension of leave rules will go a long way in dealing with



social issues relevant to the Armed Forces. This measure is going to improve the work conditions of women in the military and aid them to balance the spheres of professional and family life in a better manner, they said.

At present, women officers get maternity leave of 180 days with full pay for each child, subject to a maximum of two children. Childcare leave of 360 days is granted in total service career (subject to the child being less than 18 years of age) to women officers, according to officials. Child adoption leave of 180 days is granted after the date of the valid adoption of a child below one year of age, they said. While Opposition members had echoed Moitra's view as they stormed out of the November 2 meeting, Dubey has accused Moitra of asking



questions in Lok Sabha to target the Adani Group at the behest of businessman Darshan Hiranandani in exchange for bribes.

He said it was Hiranandani who used her login to file questions from different places, mostly Dubai.

All five opposition members had stormed out of the November 2 meeting, alleging that Sonkar asked personal and indecent questions to her regarding her travels, hotel stay and telephone calls. She later alleged that she was

assembly elections in five states. The Congress on Saturday dubbed the BJP's manifesto for Chhattisgarh Assembly polls as a 'copy-cat'.

"For almost a year now, the Prime Minister has been criticising what he derisively called 'revdis', which the Congress called its 'guarantees' to provide relief and assistance to crores of families suffering from the Modi Government's insensitive and anti-people economic policies," Ramesh said in a social media post.

"Now, his party has shamelessly copied the Congress' 'guarantees' and has announced poll promises that would be termed in self-styled Vishwaguru's book as 'revdis'. The main difference is, not

BSF installs beehives on fence to check border crimes

In a unique experiment to stop instances of cutting the hedge for cattle smuggling and other crimes, besides generating livelihood for the locals, the Border Security Force (BSF) has installed beehives on the India-Bangladesh border fence in West Bengal. The first-of-its kind initiative was launched recently by the BSF's 32nd battalion in the border areas of Nadia district with an aim of ensuring border security and helping the local populace through apiculture as part of the Centre's 'Vibrant Village Programme'. India and Bangladesh share a 4,096-km frontier, with West Bengal accounting for about

Officials said Ayush ministry

has been roped in by the BSF for the project. The ministry has provided the borderguarding force with the beehives and required expertise to fix those on the alloymade "smart fence". The beehives on the fence will

be a deterrent for the smugglers trying to cut the fence as any such attempt will disturb the bees and a swarm attack of the bees can seriously injure them, a BSF official explained. Honeybees hover over flowers

to collect food and as pollinators, play a vital role in the production of many crops that are needed to feed the world's population. Bees are responsible for pollinating almost all crops worldwide, including fruits, vegetables and nuts. It has been estimated that without bees,



global crop yields could decrease by up to 35 per cent, the officials said, quoting Ayush ministry experts.

According to Sujeet Kumar, Commandant of the 32nd BSF battalion who conceptualised the idea, the force has

undertaken the initiative under the Centre's "Vibrant Village Programme" (VVP) and gone a step further by

requesting the Ayush ministry to provide it with medicinal plants that bear flowers and can be planted around these bee boxes so that the bees can pollinate in abundance.

The idea of tying beehives to the India-Bangladesh border fence was launched on November 2. The BSF will ensure that these bee boxes are accessible to the locals engaged in apiculture and there has been a very warm response from the villagers to this initiative," he said.

Officials said the border areas under the South Bengal frontier of the BSF in Nadia district are prone to cross-border crimes like cattle, gold, silver and narcotics smuggling, and there have been instances in the past when miscreants and smugglers have either cut or attempted to cut the fence for their illegal activities. While the exact numbers can-

not be disclosed, the bee boxes are being put on the fence using a wooden support frame at regular intervals and in smuggling-prone vulnera-ble areas, the official said, requesting anonymity. He said the Ayush ministry

has provided the BSF with saplings of medicinal plants like tulsi, ekangi, satmuli, ashwagandha, aloe vera and the force personnel, along with the locals, are planting those in the border areas. Mustard too is being planted and a public camp was recently held in Kadipur village of Nadia where the locals were informed that the honey that they extract from these beehives will be sold through the established setup and shops of

the BSF Wives' Welfare

Association. The profits made from the sale of the honey will go to the locals, the official

Ayush ministry officials have also told the BSF that the locals have informed them about the Mango trees in the area not bearing good-quali-ty fruits, but due to beekeeping in the border area, these plants could start producing good-quality fruits, which will help increase the income of the villagers. The BSF is the designated

¬he number of chikungun-1 ya cases has gone up to 258 this year in Sangam city due to higher exposure to the infection in urban areas, health officials said.

Figures of the Health department revealed that out of 258 cases, 255 cases were reported in urban areas while remaining three in rural areas.

District malaria officer (Prayagraj), AK Singh, said, This was the first time when cases of chikungunya were reported on UDSP (Urban Disease Surveillance Portal) in the city. As there was much more exposure to this virus from the last couple of months, it is spreading to some specific urban pockets.'

Eight localities of city west areas, including Kalindipuram, Mundera, Sulemsarai, TP Nagar and adjoining areas are already under the scanner of health

to humans when infected female mosquitoes bite them. Most commonly, the mosquitoes involved are Aedes aegypti and Aedes albopictus. These two species can also transmit other mosquito-borne viruses including dengue. They bite throughout daylight hours, although there may be peaks of activity in the early morning and late afternoon."

Senior medical officer, Dr Anupam Dwivedi said, "For protection during outbreaks of chikungunya, clothing which minimises skin exposure to day-biting mosquitoes is advised. Treatment is done on a case-to-case basis,"he added.

Those infected show symptoms within three to seven days after a mosquito bite. The virus can cause acute, subacute or chronic disease. Most patients get better within one to two weeks, while some may suffer joint and muscle pain for months.

"The patients had a set of concerning symptoms, including fever, joint pain, and skin rashes. Doctors said that to

address these health issues effectively, a proactive approach to prevention is recommended. This entails safeguarding oneself from vector-borne diseases, primarily transmitted by mosquitoes. Besides, individuals are encouraged to take precautions such as wearing full-sleeve shirts to reduce exposure to mosquito bites and utilising mosquito repel-lent as an additional protective measure," added Dwivedi.

Moreover, it is essential to collectively engage in environmental responsibility by eliminating stagnant water sources nearby as they serve as breeding grounds for disease-carrying mosquitoes, contributing significantly to the prevention efforts. Apart from this, weather conditions are optimal for virus and mosquitoes' survival due to easily available stagnant water and relatively warmer temperatures. Hence, there is an increase in the number of cases of chikungunya.

Atiq's benami property worth ₹ 12.42 crore detected

As soon as they come to notice, other illegally acquired properties will also be confiscated by taking action as per Section 14(1) of the Gangsters Act.

Gasping for breath

Delhi is practically unliveable for humans as air quality index breaches the 460-mark

t is barely winter yet, but Delhi's air has already turned so toxic that it poses a serious health risk for the National Capital Region (NCR) residents. The exist-Ing pollution levels may prove even fatal for bronchial patients. Birds and animals, suffering from breathing problems, are being brought to animal hospitals in large numbers. The National Zoological Park is giving its inhabitants diets with multivitamins to mitigate the impact of polluted air. The Capital's air quality index (AQI) has spiked beyond 400, with the recommended figure being less than 50, leading to smog amid a surge in farm fires and unfavourable weather conditions. The concentration of poisonous PM2.5 is over 80 times the WHO limit. The issue primarily stems from a combination of factors, including vehicular emissions, industrial pollution, construction dust and stubble burning. The onset of winter, which traps pollutants in a temperature inversion, only exacerbates it. Delhi's poor air



quality has won it the dubious distinction of being the most polluted city in the world. The city is choking, and the lip service by the Centre and Delhi Governments has achieved precious little. Under the Centre's air pollution control plan, all emergency measures, including a ban on polluting trucks, commercial four-wheelers and all types of construction are mandated to be initiated and enforced in the NCR if the AQI crosses the 450-mark.

The AQI in Delhi had already deteriorated from 415 at 4 pm on Saturday to 460 at 7 am on Sunday as toxic haze lingered over the NCR for the sixth consecutive day. Already, all primary schools have

been ordered shut till November 10. The worsening crisis is a stark reminder of the misplaced emphasis on procrastination rather than concrete action. It is high time for the authorities to recognise the gravity of the situation as their constituents endure the consequences of Delhi's alarming descent into the world's most polluted city. It is not only a matter of environmental concern but a public health emergency in NCR as Ghaziabad (410), Gurugram (441), Noida (436), Greater Noida (467) and Faridabad (461) have also reported very poor air quality. The hazardous pollution levels have compelled many to forgo their morning walks, sports and other outdoor activities. Parents are concerned as health experts say children breathe faster, taking in more pollutants. Indeed to close primary schools, by the government, is a step in the right directions but still it would have a debilitating effect on them. So far, almost non-existent efforts have been made to create awareness about the harmful effects of air pollution and the steps citizens can take to protect themselves and reduce their carbon footprint. Initiatives such as tree planting drives, car pooling and waste reduction can make a significant impact when adopted on a large scale. So when are we going to start?

We should be cognizant that such foreign propaganda is aimed at undermining trust in our democratic institutions. By spreading false or misleading information, these foreign actors sow doubt in the minds of businesses. Such attacks also tend to slow down political decision-making. But confident and resurgent India's perception of "capital" is unlike the socialist "rich villain" era. New India's aspiration and nationalism are also among the reasons why the allegations on the Adani Group did not stick

Both India and Israel have hostile neighbors. India can take a cue from Israel in defending its borders and sovereignty

ver since the brutal and dastardly attacks on Israel earlier in October, the Indian public- especially those who are conversant with the intricacies of this Arab- Israeli conflict- have been strenuously debating what the course of action should be. The sheer intensity of the surprise attacks on the Jewish state by diabolical terrorists was shocking. Indian Prime Minister Narendra Modi's explicit and equivocal support for Israel astonished many. The second official statement by the Government of India was a little more balanced as it underscored the importance of peaceful negotiations between Israel and Palestine. The question is what if the country witnesses something similar in magnitude to what transpired in Israel earlier in October?

People in India are no strangers to the scourge of terrorism. The gruesome atrocities inflicted by Hamas evoked mixed sentiments as many dwelled on past events. It was the year 2008 when Islamic terrorists unleashed horror and violence in the cosmopolitan city of



Mumbai. The targets also included the Jewish community when the perpetrators broke into Mumbai

Chabad House. Post the reprehensible terror attack which led to many casualties, inflamed speeches condemning the attacks were a frequent feature. Many thought that India's response would be punitive. But lamentably, nothing substantial took place. It was only in 2016, when India's patience threshold with Pakistansponsored Lashkar-e-Taiba and Jaish-e-Mohammad was breached, that the political establishment under the exceptional leadership of Modi, authorised limited cross-border strikes which involved Indian commandos crossing the Line of Control in Kashmir and conterror launch pads. Days earlier Pakistan sponsored terrorists had launched a terror attack on the Indian army in Uri situated in the restive state of Iammu and Kashmir. But unlike Israel, India's archenemy is a nuclear-armed

Many in India, praise how Israel defends its territory and sovereignty. It always has. As it prepares itself for a situation like the Yom Kippur war in 1973 where it is clearly in disharmony with the Arab world and the entire Muslim Ummah, the ramifications of such a discord will have profound security implications. Many here ask why India did not undertake a daring strike like 'Operation Opera' in 1981 when Israeli jets flew over enemy territories and struck Iraq's nuclear plant which was in its infancy. Plans were underway in India to strike Pakistan's nuclear plant Kahuta later in 1981 but the then Prime Minister shelved the plan due to mounting pressure. conomics is the crux of all human activities. It is the core of it all. Whether it is the necessities of food, clothing and shelter or other derived needs of humans resulting from complexities of institutional existence, money is at the centre of all activities and endeavours. And it has to be so— because it is the medium of exchange of all goods and services meant for the satisfaction of human needs and also human greed. Whereas human need is limited based on definite and finite requirements of a person, human greed knows no bounds. It is this human greed that drives humans to self-aggrandizement through all neans — more foul than fair

But economic greed is not the only vice afflicting humankind. It is the lust for power and hegemony that has led to scuffles, strife and wars. Wars today have an economic dimension much more than at any time in known world history, because of gross material technologies behind modern weaponry and more importantly the economic consequences of war.

So war costs money, big money and the destruction caused by war makes way for huge economic activity in the form of reconstruction, in which many persons or institutions gain monetarily. Many wars between nations in the past 100 years are characterized by exactly these features. So there is a sound economic reason for war, though the economic benefits of war may be heavily skewed in favour of a nation or institution. This is the stark reality of the times. Glib justifications are given for waging wars. And media houses actively collaborate and cooperate in propagating such justifications which are poor excuses or apologies for actual reasons.

The major wars of the 20th century —world wars 1 and 2 were fought for usurping states and expanding national territories. The world of the 21st century at present is on the precipice of another big war, which will involve many nation-states. Russia has been warring with Ukraine since February 2022. The war, which was expected to peter out in a few weeks, is still raging and doesn't seem to end any time soon. Continuous supply of arms and ammunition to Ukraine by the US and NATO countries and warfare equipment supplemental support to Russia by Iran overtly and China covertly kept the war on. The economic interests of all the above countries who thus backed Russia and Ukraine were behind this.

Twenty-one months into this protracted war, another war — in the Middle East, between Hamas in Palestine territory and Israel, with major countries losing no time in declaring support for either Israel or Hamas-Palestine. The big reason behind the Hamas attack on Israel was tacit and covert military support to Hamas by China, Iran and Russia whose short- and long-term economic interests were being served by such action. Diverting the attention of the US from the Taiwan Strait and Ukraine was in the politico-economic interests of China and Russia respectively. For China, the involvement of Israel will put the recently blueprinted India-Oman-UAE-Saudi Arabia-Jordan-Israel-Europe economic corridor project

in a quandary and reboot its tottering BRI. So, China is the greater gainer in inciting Hamas to this frontal attack on Israel. In general, wars continue to profit

the arms-selling countries that supply weapons to the warring countries.

The economics of war is not as simple as it is supposed to be by the countries planning or inciting wars. War leaves a terrible trail of death and destruction in its aftermath. It brings harm to all the actors involved in this game—the victor, the vanquished and the sideline supporters in a widely interconnected world. It also triggers a rat race in arms accumulation by the countries competing for territorial hegemony. It diverts resources overall from productive to nonproductive activities. Modern processes for the production of conventional and nuclear arms and much more so their usage inflict huge harm on the environment, an aspect which is, unfortunately, not seriously looked

The economics of war needs to be studied in a wider perspective than is done today. The economic cost of diverting valuable human and material resources from the positive and progressive activities that add value to human life to war preparedness and warmongering is humongous. This is not to say that countries should not spend on defence. But they should spend on military technologies that inflict the least harm on the common ecosphere and environment which is shared by all global countries. War also leaves huge adverse cultural effects on the countries involved directly or indirectly in it.

It promotes an atmosphere of distrust, fear, suspicion and insecurity rather than boosting fraternity and camaraderie. In other words, it undermines and disrupts peace. Inciting wars between nations also accentuates communal and sectarian friction and leads to riots and community conflicts inside nations, which detriment those nations economically. We have witnessed the economic fallouts of terrorism in many pockets across the globe—how it hinders investment and derails development. Since avenging is a natural human instinct, the nations inciting wars and terrorist activities have also faced the backlash of such actions and, of course, their adverse economic consequences. Such countries may have gained in the economic sense in the short term, but in the longer term, they will be put to huge loss. Hence, inciting wars is not an overall long-term profitable venture.

Let humanity of the present times collectively consider these important aspects and spend economic resources on national defence more prudently. Wars are destructive overall and economically regressive. A fresh new perspective on war economics and actions based thereon will make the world a better place

ferent types of Institutional memory within the Government into four cate-First is the Administrative and Legislative data, which includes government files, laws, regulations, gazette notifications, office memorandums, parliamentary questions, matters raised by elected representatives, court orders, procurement, human resources, etc. Second is data on citizens and benefipublic consultations, citizen grievances, and feedback, attributes of beneficiaries, etc. Third is the programmatic Data on surveys and studies conducted, data and knowledge on various programs and schemes, and last is more experiential and qualitative like Initiatives, Experiences, Qualitative data on ideas, experiences, failures, initiatives, and knowledge from media and civil society. The next challenge is search-

ability: to bind all the knowledge together through a common set of identifiers. The AoB rules define the distribution of various subjects, functions, and responsibilities among different ministries and departments of the Central Government. Within the ciaries, such as comments on framework of AoB rules,

Subject-wise work allocation. So, both these data points become like a hashtag that can be tagged to all different types of Institutional Knowledge. The Ministry of Health and Family Welfare has implemented the EPITOME Portal, a brainchild of Hon'ble Union Minister Dr Mansukh Mandaviya, which aggregates data on pending grievances and files, infrastructure projects, parliamentary matters, data on programs and schemes, tasks and vacancies, different ideas from citizens and officers all tagged with the Health Ministry's 300+ Subject areas. The Governments must create specialized teams or departments responsible for

capturing, curating, and dis-

Ministries also have their knowledge. One effective approach is establishing standardised templates for documenting projects, policies, and strategies.

These templates should include critical insights, challenges faced, and lessons learned. The Government can minimize information loss due to personnel changes by ensuring uniform documentation practices. In addition, a robust internal communication network should be established to facilitate the exchange of ideas and experiences among departments and individuals.

Regular workshops, seminars, and knowledge-sharing sessions can foster a culture of learning and collaboration. Platforms such as webinars, seminating institutional online forums, and internal

knowledge-sharing portals can play a pivotal role in promoting the exchange of ideas and experiences across the government ecosystem. Officers' valuable insights and experiences should be preserved as they retire or move on to new roles. When officers transition out of their roles, they should be required to provide detailed briefs on ongoing projects, challenges, and strategies. The Anubhav portal was launched in March 2015 at the behest of the Prime Minister for retiring government officials to leave a record of their experiences while in Government service. However, this mechanism must be institutionalised well to connect serving officials with the retired ones.

We must prioritise creating, managing, and transferring institutional knowledge. The approach will involve investing in technology, nurturing a culture of continuous learning, and implementing structured processes for capturing and disseminating insights. By adopting mentorship programs the Government can bridge the gap between retiring officers and their successors. Institutional memory is not an abstract concept but a tangible asset that can shape the trajectory of governance in India. As the nation marches, let us recognise that the past holds the keys to a more informed and prosperous future. We must harness the power of institutional memory to drive meaningful change, foster efficiency, and ensure that the legacy of knowledge endures the tests of time.

Warplanes strike Gaza refugee camp Israel rejects US push for a pause in fighting

Deir Al-Balah (Gaza Strip), Nov 5 (AP) Israeli warplanes struck a refugee camp in the Gaza Strip early Sunday, killing at least 40 people and wounding dozens, health officials said.

The strike came as Israel said it would press on with its offensive to crush the territory's Hamas rulers, despite US appeals for a pause to get aid to desperate civilians.

The soaring death toll in Gaza has sparked growing international anger, with tens of thousands from Washington to Berlin taking to the streets Saturday to demand an immediate cease-fire. Israel has rejected the idea of halting its offensive, even for brief humanitarian pauses proposed by US Secretary of State Antony Blinken during his current tour of the region. Instead, it said that Hamas was "encountering the full force" of its troops. "Anyone in Gaza City is risking their life," Israel's Minister of Defence Yoav Gallant said.

Large columns of smoke rose as Israel's military said it had encircled Gaza City, the initial target of its offensive. Gaza's Health Ministry has said more than 9,400 Palestinians have been killed in the territory in nearly a month of war, and that number is likely to rise as the assault continues

Airstrikes hit the Maghazi refugee camp in central Gaza overnight, killing at least 40 peo-ple and wounding 34 others, the Health Ministry said. It said first responders and residents were still digging through the rubble, hoping to find survivors.An Associated Press reporter at a nearby hospital saw eight dead children, including a baby, who had been brought in after the strike. A surviving child was led down the hospital corridor by an adult holding her hand, her clothes caked in dust, an expression of shock on her face.

Arafat Abu Mashaia, who lives in the camp, said the Israeli airstrike flattened several multi-story homes where people forced out of other parts of Gaza were sheltering.

"It was a true massacre," he said early Sunday while standing on the wreckage of destroyed homes.

Jerusalem (PTI): An Israeli minister from the far-right Otzma Yehudit party on Sunday said that dropping an atomic bomb on the Hamasruled Gaza Strip was "an option", prompting Prime Minister Benjamin Netanyahu to suspend him from government meetings indefinitely. In a radio interview, Jerusalem Affairs and Heritage Minister Amichai Eliyahu said that "there are no non-combatants in Gaza" and providing humanitarian aid to the Strip would constitute "a failure".

When asked if there are no non-combatants in Gaza in his view then if a nuclear attack on the Gaza Strip is "an option", Eliyahu responded, "That's one

His remarks infuriated members of both the ruling coalition and the Opposition, evoking calls to fire him from the government.

Following the uproar, Eliyahu backtracked from his statement, calling it a

"It's clear to anyone with a brain that the remark about the atom was metaphorical. We indeed must display a forceful and disproportional response to terror, which will clarify to the Nazis and their supporters that terrorism isn't worthwhile. This is the only formula with which democracies can deal with terror," he said. "Simultaneously, it is clear

that the State of Israel is obligated to do everything to return the captives alive and in good health," Eliyahu wrote in a bid to defuse tensions.

Minister Netanyahu suspended Eliyahu from government meetings indefinitely, the PMO

Eliyahu is not a part of the security cabinet involved in the wartime decision-making, nor does he hold sway over the war cabinet directing the war against Islamist Hamas, it said. Netanyahu called the remark "detached from reality".

Blinken meets Palestinian leader in West Bank

US Secretary of State Antony Blinken brought his frenetic Mideast diplomatic push on the Israel-Hamas war to the occupied West Bank on Sunday, meeting with Palestinian President Mahmoud Abbas in his latest bid to ease civilian suffering in the Gaza Strip and begin to sketch out a post-conflict scenario for the territory.

Blinken travelled to Ramallah for his previously unannounced visit in an armoured motorcade and under tight security just hours after Israeli warplanes struck a refugee camp in the Gaza Strip, killing at least 40 people and wounding dozens, health offi-

Despite the secrecy and the State Department refusing to confirm the trip until after Blinken had physically left the West Bank, protests erupted against his visit and US support for Israel as word of his arrival leaked. Aside from pleasantries, neither man spoke as they greeted each other in front of cameras and the meeting ended without any public comment. It was not immediately clear if the lack of words indicated the

meeting had gone poorly.
State Department spokesman Matthew Miller said Blinken reaffirmed the US commitment to the delivery of life-saving humanitarian assistance and resumption of essential services in Gaza made clear that Palestinians must not be forcibly displaced. Blinken and Abbas dis-

cussed efforts to restore calm and stability in the West Bank, including the need to stop extremist violence against Palestinians and hold those accountable responsible, Miller said, in reference to violence being committed by Israeli settlers. The meeting with Abbas, whose Ramallah-based Palestinian Authority has not been a factor in Gaza since Hamas took it over by force in 2007, came at the start of

Blinken's third day of an intense Middle East tour - his second since the war began with a surprise Hamas attack on Israel on October 7. Blinken had visited Israel and met with Israeli Prime Minister Benjamin Netanyahu on Friday before decamping to Jordan for meetings with senior Arab officials on Saturday. At each stop, Blinken has offered firm US support for Israel's right to defend itself but also stressed that it must adhere to the laws of war, protect civilians and increase humanitarian aid supplies to Gaza.

To do that, as well as to ease the flow of foreigners fleeing Gaza, he has made the case that Israel should implement rolling humanitarian pauses to its airstrikes and ground operations, something that Netanyahu has thus far flatly rejected. US officials believe that Netanyahu may soften his opposition if he can be convinced that it is in Israel's strategic interests to ease the plight of Palestinian civilians in

Hostage situation at Hamburg Airport ends, man in custody

The hostage situation at ■ Hamburg Airport ended Sunday afternoon, around 18 hours after a man drove his vehicle through the gates of the airport with his 4-year-old daughter inside, authorities said. The man was arrested and the girl appears to be unharmed.

Hamburg police tweeted that "the hostage situation is over. The suspect has left the car with his daughter. ... The child appears to be unharmed."

Police also said that "the man was arrested by the emergency services without resistance." The airport in the northern German city had been closed to passengers and flights cancelled since Saturday night when the man, who was armed, broke through an airport gate with his vehicle and fired twice into the air with a



news agency dpa. The man drove the vehicle just outside a terminal building and parked it under a plane.

Authorities said the man's wife had previously contacted them about a child abduction.

Police said that the 35-yearold man had his daughter inside the car after reportedly taking her by force from the mother in a possible custody

A psychologist had been negotiating with the man for 18 hours. Nobody was injured during the standoff after all passengers had evacuated the airport, police said.

The mother of the girl also arrived at the airport earlier on Police spokeswoman

Sandra Levgruen said that officers were checking whether the suspect "still has any explosive devices on him or with him or whether they are still in the car," dpa reported.

"We are currently assuming that he is unharmed, but he is still lying on the ground in the care of the police," she said.

More than 100 flights were cancelled and several planes vere rerouted.

Thousands of travellers have been affected by the standoff and hundreds were put up at hotels close by.

Radio anchor shot during Facebook livestream

Manila (AP): A radio anchor was fatally shot by a man inside his southern Philippine station on Sunday in a brazen attack that was witnessed by people watching the program live on Facebook. The gunman gained entry into the home-based radio station of provincial news broadcaster Juan Jumalon by pretending to be a listener.

BNP leader sent to prison, opp enforces transport blockade

court in Bangladesh on A Sunday ordered the imprisonment of opposition BNP leader and former home minister Altaf Hossain Chowdhury in a case filed over vandalism of the chief justice's residence during a clash between his party supporters and police that left two people dead. The direction of the Dhaka Metropolitan Magistrate Court came as clashes and clandestine arson attacks left dozens, including policemen, wounded and vehicles burnt amid a new 48-hour nationwide transport blockade called by the opposi-

Chowdhury, a former Air Force chief, was arrested by the elite anti-crime Rapid Action Battalion (RAB) from the suburban Tongi area.

Hours after his arrest, the court ordered that the Bangladesh National Party (BNP) vice chairman be sent to jail. Besides Chowdhury, several other leaders of ex-prime minister Khaleda Zia's BNP were arrested in connection with the deadly violence in two people, including a police-man, were killed and the city saw widespread clashes, including an attack on the chief justice's residence.

Police said they arrested 2,172 opposition leaders and activists last week under 89 cases of violence and sabotage in the capital alone, while media reports suggested that nearly 8,000 opposition figures were detained in a nationwide crackdown during the period.

BNP secretary-general Mirza Fakhrul Islam Alamgir, who is considered the de facto leader of the party, and his number two Amir Khosru Mahmud Chowdhury are among the leaders who are in prison to face the charges.

A 79-year-old ailing Zia, who was serving a 17-year prison term on two graft charges, is now technically under house arrest since her release under a special legal arrangement that debarred her from taking part in political activities. She, however, is now being treated at a specialised private hospital for multiple health issues.

Anisul Huq told reporters on Sunday that BNP leaders were "not arrested for political reasons, but for their involvement in criminal activities (and) it has ďo nothing to with politics"

BNP's senior joint secretary general Ruhul Kabir Rizvi in a virtual press conference said Prime Minister Sheikh Hasinaled Awami League government "has turned the country into a big prison" by arresting thousands of opposition leaders, workers and supporters.

Political tensions mount in Bangladesh as BNP and its farright allies like the Jamaat-e-Islami wage a street campaign demanding the resignation of the Awami League government to allow a non-party interim government to conduct the upcoming general elections in

The ruling party has declined to accept the demand saying elections would be held under the incumbent premier. Hasina has also rejected proposals for dialogue with the opposition by the US and other major Western countries, call-

tion. The opposition's fresh nationwide blockade came after the weekend of Friday and Saturday when rioters set on fire at least 11 buses, while violence in the past week saw the deaths of at least five people

across the country.

Three policemen on street patrol were wounded as unidentified people hurled handmade bombs in the capital's Uttara area.

Authorities deployed paramilitary troops to guard highways and maintain order in major cities and asked police and other security agencies to intensify vigilance against sabotage. On October 28, a police constable was hacked to death in Dhaka where political violence left some 200 people, including journalists, wounded as BNP called a grand protest rally and Awami League a "peace rally" in the national capital. The rival programmes resulted in clashes mainly between opposition protesters and police, who used rubber bullets, tear gas and sound grenades to control the

Russia test-fires intercontinental **ballistic missile**

Moscow (AP): The Russian military on Sunday reported a successful test launch of an intercontinental ballistic missile designed to carry nuclear warheads from a new nuclear submarine. The report comes as ten-

sions are soaring between Russia and the West over the fighting in Ukraine. Adding to those tensions, President Vladimir Putin last week signed a bill revoking Russia's ratification of a global nuclear test ban in a move that Moscow said was needed to establish parity with the United States. The Russian Defence Ministry said in a statement that the Imperator Alexander III strategic missile cruiser fired the Bulava missile from an underwater position in Russia's northern White Sea, and hit a target in the far-eastern region of Kamchatka. It wasn't immediately clear from the statement when the test launch occurred. The Imperator Alexander III is one of the new Borei-class nuclear submarines that carry 16 Bulava missiles each and are intended to serve as the core naval component of the nation's nuclear forces in the coming decades.

Afghans fleeing Pak lack water, food and shelter

Afghans fleeing Pakistan to avoid arrest and deportation are sleeping in the open, without proper shelter, food, drinking water and toilets once they cross the border to their homeland, aid agencies said

Hundreds of thousands of Afghans have left Pakistan in recent weeks as authorities pursue foreigners they say are in the country illegally, going door-to-door to check migrants' documentation. Pakistan set Oct 31 as a deadline to leave the country or else they'd be arrested as part of a new anti-migrant crackdown.

Afghans leave Pakistan from two main border crossings, Torkham and Chaman. The Taliban have set up camps on the other side for people to stay in while they wait to be moved to their place of origin in Afghanistan.

Aid agencies said Torkham has no proper shelter. There is limited access to drinking water, no heating source other than open fires, no lighting, and no toilets. There is open defecation and poor hygiene. UN agencies and aid groups are setting up facilities with thou-sands of people entering Afghanistan every day. Kayal Mohammad lived in the northwest Pakistani city of Peshawar for 17 years. He has five children and was deported to the

Afghan border almost a week ago. He told The Associated Press he wasn't allowed to take any household belongings with him. Everything he and his family own remains in Pakistan. His seven-year-old daughter Hawa weeps because she is cold. She drinks tea for breakfast from a cut-up plastic bottle and sleeps without a

Her father urged the international community for help. "We cannot ask the Taliban government," he said. "They have nothing because they are yet to be recognised as a government. There are families who have nothing here, no land, no home. They are just living under the open sky. No one is helping."
Thamindri Da Silva, from

the relief and development organisation World Vision International, said most people are moved to a dry riverbed once they have gone through their initial registration and processing at a transit centre.

People enter Afghanistan with just the clothes on their back because their watches, jewellery and cash were taken at the Pakistani border, she

Arshad Malik, country director for Save the Children, said many of those returning are coming back without education documents, making it difficult for them to continue their learning, as well as lacking the local Afghan languages of Dari and Pashto because they studied Urdu and English in Þakistan.

He warned that child labour in Afghanistan as well as their involvement in smuggling are likely to increase due to poverty as most returning families were among the poorest migrants in Pakistan. "Smuggling at Torkham by children was one of the concerns from the past, so the involvement of children in smuggling and illegal goods' transfer will increase," Malik said. The Taliban say they have committees working "around the clock" to help Afghans by distributing food, water and

blankets. Pope Francis in public remarks on Sunday at the Vatican decried the situation of "Afghan refugees who found refuge in Pakistan but now don't know where to go anymore". Afghanistan is overwhelmed by challenges, compounded by the isolation of the Taliban-led government by the international community. Years of drought, a beleaguered economy and the aftermath of decades of war have led to the internal displacement of mil-

Concerns have risen among the humanitarian community about the impoverished country being unable to support or integrate those currently forced to leave Pakistan.

At the time, pre-election polls had predicted a strong showing for the CHP's former leader Kilicdaroglu in what many saw as the opposition's greatest chance to unseat Erdogan since he took office in 2003. But Erdogan secured his third presidential term in a runoff vote. Ozel said in his winning speech Sunday that he would mobilise the party immediately to "compensate for the great sadness" of May's election defeat. Kilicdaroglu, 74, had led the party since 2010, and ever since, the CHP failed to win a single national election although it scored significant victories in local elections in 2019, taking a handful of major cities — including Ankara and Istanbul.

The former party head was criticized for not standing down after losing May's election.

A call for change at the top of the CHP was led by Istanbul Mayor Ekrem Imamoglu, one of the party's most prominent figures and an outspoken critic of the way the party ran May's election campaign. Others also complained that the secularist CHP established by Turkiye's founder Mustafa Kemal Ataturk - had become undemocratic, with too much power in the leader's hands. Ozel, 49, is a for-

mer pharmacist who was elected to parliament in 2011. He will lead the party in local elections in March in a bid to hold onto the cities it took five years earlier. "We will not stop, we will work, we will work shoulder to shoulder, we will regain all the municipalities we (currently) have, we will add new ones and together we will win a great victory," Ozel said.

Afghan farmers face losses due to ban on poppy cultivation

Islamabad (AP): Afghan farmers have lost income of more than USD 1 billion from opium sales after the Taliban outlawed poppy cultivation, according to a report from the UN drugs agency published on Sunday. Afghanistan was the world's biggest opium producer and a major source for heroin in Europe and Asia when the Taliban seized power in August 2021. They pledged to wipe out the country's drug cultivation industry and imposed a formal ban in April 2022, dealing a heavy blow to hundreds of thousands of farmers and day labourers who relied on proceeds from the crop to survive.

Opium cultivation crashed by 95 per cent after the ban, the report from the UN Office on Drugs and Crime said. Until 2023, the value of Afghanistan's opiate exports frequently outstripped the value of its legal exports. UN officials said the strong contraction of the opium economy is expected to have far-reaching consequences for the country as opiate exports before the ban accounted for between 9-14 per cent of the national GDP.

Afghans need urgent humanitarian assistance to meet their most immediate needs, absorb the shock of lost income and save lives, said UNODC executive director, Ghada Waly. "Afghanistan is in dire need of strong investment in sustainable livelihoods to provide Afghans with opportunities away from opium," she said. Afghans are dealing with drought, severe economic hardship and the continued consequences of decades of war and natural disasters.

The downturn, along with the halt of international financing that propped up the economy of the former Westernbacked government, is driving people into poverty, hunger, and addiction.

India's power consumption grew 9.4 per cent to around 984.39 billion units in the April-October period this fiscal compared to a year ago mainly due to improvement in economic activities and weather conditions.

Power consumption in the April-October period in fiscal year 2022-23 was 899.95 billion units, according to power ministry data.

Another indicator, peak power demand, was also higher at nearly 241 GW during the April-October period this fiscal against 215.88 GW in the same period in 2022.

The country's power consumption grew nearly 22 per cent to 138.94 billion units (BU) in October, showing a surge in electricity demand due to festivities and increased economic activities.

In the same month a year ago, power consumption stood at 113.94 BU, higher than 112.79 billion units recorded in October 2021, as per government data.



A spokesperson of Tata Power Delhi Distribution Ltd said, "In the last couple of months, electricity consumption has gone up substantially

In October 2023, the power consumption in Tata Power-Delhi Distribution Ltd area of operation went up by around 10.16 per cent to 845 MUs (million units), compared to 767 MUs in October 2022.

"The demand has remained higher mainly due to delays in winter onset this year. The festive activities in the month of October have also contributed to the demand phenomena,"

the spokesperson explained.

However, the spokesperson stated that due to mild summer this year, the electricity consumption during April-May was substantially lower in comparison to the same period last

The spokesperson pointed out that the demand started inching up since July due to extreme humid conditions.

The power ministry had estimated the country's electricity demand to touch 229 GW during summer. The demand did not reach the projected level in April-July due to unsea-

The peak supply, however touched a new high of 224.1 GW in June before dropping to 209.03 GW in July. Peak demand touched 238.19 GW in August. In September this year, it was nearly 241 GW.

Industry experts said power consumption was affected in March, April, May, and June this year due to widespread rainfall.

They said power consumption grew in August and September, mainly due to humid weather conditions and also perk up in industrial activities ahead of the festive season They stated that the double-

digit growth in power consumption in the month of October reflects the impact of festivities and better econom-

There were festivals of Navratri, Durga Puja and Dusshera in October.

The experts are of the view that power consumption growth will remain steady in coming months due to festivities and improvement in economic

India's power consumption grows | REITs, InvITs collect ₹18,658 crore in April-Sep on robust infra demand

Ctrong demand for infra-Structure investment, attractive returns, and favourable government policies have pushed fund mobilization through listed REITs and InvITs to Rs 18,658 crore in the April-September period of the current fiscal.

This came following a fund collection of Rs 2,596 crore through listed Infrastructure Investment Trusts (InvITs) in the entire 2022-23, although the amount mopped up through listed Real Estate Investment Trusts (REITs) was nil, data with the Securities and Exchange Board of India (Sebi)

Going forward, experts believe that trends seen in REITs and InvITs will continue in the second half of the year too.

'The fresh savings will continue similarly as has happened in the last six months, and the investments will continue to be towards InvITs as both the central government and the state governments continue to focus more on infrastructure development,"

Co-founder Associates, said.

IOC is the second PSU to have acquired a company in an solvency proceeding. In March this year, India's largest gas firm GAIL acquired insolvent private-sector chemical company JBF Petrochemicals for Rs 2,079 crore, helping the state-owned firm expand its footprint in the petrochemical

GAIL had outbid a consortium of IOC and Oil and Natural Gas Corporation (ONGC) in the insolvency process run by IDBI Bank to recover Rs 5,628 crore of dues to financial and operational creditors.

JBF was incorporated in 2008 to set up a 1.25 million tonnes a year capacity purified terephthalic acid plant at Mangalore Special Economic Zone. The plant, which is a backward integration project for JBF Industries' polyester plants, was commissioned in 2017 but stopped operations after the company defaulted on its loans in the same year.

Mercator Petroleum Ltd (MPL) was a wholly-owned subsidiary of Mercator Ltd. MPL is engaged in the business of petroleum exploration, development and production in India and abroad.

cent, gross domestic advances of the bank rose to Rs 1,83,122 crore at the end of September 2023, according to published quarterly numbers of public sector banks (PSBs).

It was followed by Indian Overseas Bank with 20.29 per cent growth, Central Bank of India (17.26 per cent growth) and UCO Bank with 16.53 per cent growth. The country's largest lender State Bank of India (SBI) stood at the seventh spot with 13.21 per cent rise in domestic advances growth.

Restrictions, PLI, quality norms helping cut import of certain non-essential goods

Steps such as curbs on inbound shipments of certain goods, production linked incentive scheme and mandatory quality norms are helping the country reduce imports of non-essential products such as TV, tyres, wallpaper and AC gas compressors.

These steps, among others like imposing antidumping and countervailing duties, have been taken to analyse and control non-essential imports and to augment domestic production capacity in import intensive sectors, an official said. According to an analysis of the commerce and industry ministry, import restrictions imposed on tyres helped cut

the inbound shipments by 74 per cent to USD 74 million in 2022-23 from USD 276 million in 2019-20. Calendar year wise, these imports declined to USD 36 million till July this year as against USD 353 million in

The government in June 2020 imposed import curbs on certain new pneumatic tyres used in motor cars, buses, lorries and motorcycles to promote domestic manufacturing and contain imports from countries like China.

Imports of wallpapers reduced by 77 per cent to USD 10 million during April-August this year from USD 44 million in the same month last year due to the launch of paper import

monitoring system (PIMS).

The ministry in October last year made import registration under PIMS mandatory for inbound shipments of 201 types of paper and paper boards such as wallpaper, glazed newsprint, handmade aper and tissue paper. Under this, an importer has to

provide advance information online about import of these papers and obtain a registration number. The government has a similar system for coal and steel imports. Similarly, implementing qual-

ity control order (QCO) for footwear has helped in reducing the imports by 54 per cent to USD 75 million during July-August this year from USD 163 million in the same period last year.

Djokovic wins a 3-set battle with Rublev to set up Paris Masters final

Top-ranked Novak Djokovic was made to fight for more than three hours by Andrey Rublev in their semifinal match before earning the right to play for a record-extending seventh title at the Paris Masters.

Djokovic overcame a slow start to rally past his Russian opponent 5-7, 7-6 (3), 7-5 and maintain his perfect record in the semifinals at the indoor tournament. The Serbian player will take on Bulgaria's Grigor Dimitrov in Sunday's final.

"Rublev was suffocating me like a snake suffocates a frog for most of the match," Djokovic said. "He was playing an extremely high level that he possesses, but today he was off the charts, honestly. I don't think I've ever faced Rublev this good."

Dimitrov overcame strong resistance from seventh-seeded Stefanos Tsitsipas with a 6-3, 6-7 (1), 7-6 (3) victory.

The road to the final has not been an easy one for Djokovic, who defeated defending champion Holger Rune in three sets came out on top of a three-set contest in the third round.

Martínez scores again in 2-1 win for Serie A leader Inter at Atalanta

Inter Milan consolidated its position at the top of Serie A and Lautaro Martínez boosted his lead in the scoring charts as the Nerazzurri won 2-1 at Atalanta.

Martínez doubled Inter's advantage in the 57th minute after Hakan Çalhanoglu's penalty had given the visitors the lead on a rainy evening in Bergamo. They were the first goals Atalanta had conceded at home this season.

It was Martínez's 12th league goal this season, double that of his nearest challengers - AC Milan forward Olivier Giroud and Napoli's Victor Osimhen. It was also the 33rd goal of the calendar year for Martínez,

who has been in lethal form since winning the World Cup with Argentina in December. Inter moved five points clear of second-place Juventus, which visits Fiorentina on Sunday and six above Milan after the Rossoneri's problems increased with a humiliating 1-0 loss at home to lowly Udinese.

Napoli remained seven points below Inter but moved up to fourth with a 2-0 win at bottom club Salernitana. The defending champion moved two points above Atalanta.

Red Bull's Perez gets some solace at sprint race of Brazilian Formula One Grand Prix

Perez's high speed in straight lines made the difference so he could leave both behind later. Formula One champion Max

Verstappen of Red Bull, who will start the race in pole position, won at Interlagos his fourth sprint race in the season and will add another eight points to his tally. McLaren's Lando Norris finished second, more than four seconds behind the Dutchman in the 24-lap

On 35th birthday, Kohli achieves 'dream' parity with Sachin

rirat Kohli gave his fans a perfect birthday treat when he finally struck his highlyanticipated 49th ODI century in an unbeaten innings of supreme patience and perseverance to power India to above-par 326/5 against South Africa in the World Cup here on Sunday

A frenzied response, South Africa's resurgence and the Kohli's missing maestro Sachin Tendulkar's recordequalling 49th ODI ton twice in three innings made an ideal setting to the match on Kohli's 35th birthday.

The Indian run-machine, who got out for 95 and 88 against New Zealand and Sri Lanka, did not disappoint the ecastic Eden full house giving a perfect icing on the cake to score the historic century on a difficult Eden track.

The monkey was finally off his back in the 49th over when Kohli gently pushed Kagiso Rabada for a single and followed it up with his usual quiet celebration nowadays.

It came off 119 balls with 10 fours, that summed up how Kohli toiled hard for the milestone.

on 101 facing 121 deliveries, it came in 277 innings, while Tendulkar brought up his 49th ODI century in 452 innings. The relief was well evident as he took his helmet off, kissed his bat,

and saluted the crowd giving a standing ovation with their smartphone flash guns lighting up the atmosphere.

The century seemed assured this time when Kohli crunched Rabada through covers in the previous overs to race to 97.

Barring Keshav Maharaj who bowled his full quota at a stretch, no other bowler could create an impact on an different looking Eden wicket that became slower as the game progressed and aided spin.

There was more setback for the Proteas as pacer Lungi Ngidi limped off and was unable to complete his over. Marco Jansen also looked wayward and leaked eight in extras.

Unlike any other day, the dry Eden pitch on a hazy overcast evening offered vicious turn and South Africa were quick to bring on their ace spinner Maharaj right after the

and Maharaj produced a classical left-arm spin to remove the in-form That ball dipped so much that it

So, to be sat here having had the tournament I've had is incredibly frustrating, but it doesn't shake your belief ""If I stop believing in myself, I've got to make sure I'm the last one that does that. You guys will give up on me a lot earlier than I'll give up on myself," he

"The wicketkeeper-batter was insistent that the burden of captaincy has nothing to do with his batting failure.

""No I wouldn't say the captaincy. It's something I've enjoyed that responsibility in T20 cricket and ODI cricket before this tournament. I felt like it's brought out a lot of really good things in my batting. So, it's been frustrating."

"The inability to score runs has been perplexing for Buttler himself given that he is famil-""I can't quite put a finger on why I'm not playing to the level I expected myself. I've played a

lot of cricket in India and played a lot of IPL cricket here so it's not as if I don't know the conditions or the grounds yes you know and as I say as a captain you want to lead from the front. ""So, of all the things that have happened on this trip, I'd say my own form has been my biggest frustration, because you want to lead from the front as a captain."

"With the top seven sides at the World Cup and hosts Pakistan set to qualify for the 2025 Champions Trophy, England, who are the bottom of the table, are at the risk of missing out on the tournament. They need to win their remaining two games against Pakistan and Netherlands for a shot at qual-
