
Court orders Punjab, Haryana, UP, Rajasthan to stop stubble fire as Delhi chokes

Amid a spike in pollution levels in Delhi and NCR, the Supreme Court on Tuesday directed Punjab, Haryana, Uttar Pradesh and Rajasthan to ensure crop residue burning was stopped "forthwith", saying it cannot let "people die" due to pollution.

Questioning the Delhi Government's odd-even car rationing scheme, which is aimed at curbing pollution and is scheduled to be enforced in the city from November 13 to 20, the apex court asked about its effectiveness and termed it "all optics".

"I am sorry, this is complete murder of the health of people, there is no other phrase I have," said Justice Sanjay Kishan Kaul, who was heading the bench which also comprised Justice Sudhanshu Dhulia.

Another bench of the top court comprising Justices AS Bopanna and MM Sundresh, which was dealing with the firecrackers ban matter, clarified on Tuesday that the top court's order banning firecrackers containing barium binds every state and was not just limited to Delhi and NCR. The Justice Kaul-led bench also took a stern view of States trying to shift blame to one

Expressing concern over wide-spread stubble burning which did not stop following paddy harvest, the bench said, "The concern is this... These farm fires are not stopping. What action the states are taking to stop the farm fires?'

"We want to stop all this. We don't care how you do it. It is your business how to do it. It must stop," the bench told the counsel, adding, "You have to stop it, whether by forceful action, sometimes by incentives, sometimes by other actions, but you have to stop it." "We cannot let people die because of this (pollution)," the apex court said, while referring to the health related issues being faced by people due to the alarming rise in pollution levels.

It said residents of Delhi have been grappling with health issues at this time of the year, year after year, because a solution to the problem has not been found.

"We direct the State Government of Punjab and for that matter, all other States adjacent to Delhi, which is Harvana, Rajasthan and UP ... to ensure that crop burning is stopped forthwith," it said.

The bench made the local station house officer (SHO) concerned, under the overall supervision of the chief secretary, responsible for stopping crop residue burning.

Senior advocate Aparajita Singh, assisting the court as an amicus curiae in the pollution matter, spoke of recent media reports about non-operational smog towers, which were installed to combat air pollution, in Delhi.

The bench, which asked the chairman of the Delhi Pollution Control Committee (DPCC) to remain present before it on the next date of hearing, said it wanted smog towers to be operationalised and asked the authorities to take immediate steps for it.

It also asked the Delhi Government to consider that only taxis registered in the city ply on roads here, saying a large number of taxis registered in other States were seen on roads carrying only one passenger. On the issue of crop residue

States pass the buck

The Arvind Kejriwal Government in Delhi and the Manoharlal Khattar Government in Haryana are engaging in a blame game as Delhi's air pollution reaches hazardous levels, with each side pointing fingers at the other for the current alarming state in Delhi and National Capital Region.

According to data from the Ministry of Agriculture, Punjab has reported 20,978 incidents of stubble burning, Haryana 1,605, Uttar Pradesh 1,439, and Delhi 3 between October 29 and November 7. Specifically on Tuesday, Punjab reported 1,515 incidents of stubble burning, Haryana 26, and UP 167.

On Tuesday morning, pollution levels in Delhi experienced a slight decrease and were categorised as "very poor" after five consecutive days of "severe" air quality. According to data from the Central Pollution Control Board (CPCB), Delhi's 24-hour average Air Quality Index (AQI) was recorded at 395 on Tuesday, showing a marginal improvement from the 421 recorded on Monday.

Additionally, several cities in neighbouring Haryana, Rajasthan, and Uttar Pradesh have also reported hazardous air quality.

AAP's national spokesperson Priyanka Kakkar has attributed the serious air pollution situation in Delhi to the Harvana Government. Kakkar stated that in Punjab, 50 to 60 per cent less stubble has been burned compared to last year, and the stubble currently being burned is located 500 kilometres away. Responding to the AAP's claim. Khattar has asked his Delhi counterpart to focus on protecting people from the worsening air quality in the national Capital.

BJP national spokesperson Shehzad Poonawalla said, "After the complete expose of the Aam Aadmi Party by the Supreme Court on Delhi's Air Pollution and Punjab stubble issue, Arvind Kejriwal should apologise for making Delhi a gas chamber and stealing our right to breathe fresh air over the last 8 years".

All that Kejriwal did was "blame others, including Diwali" for the rise in pollution levels in Delhi, he charged in a

Voters defy Naxal threat Act against deepfake

A mid reports of Naxalite violence and the call for boycott, a provisional turnout of around 71 per cent was recorded in the first phase of Chhattisgarh Assembly elec-Tuesday, while the single phase Mizoram Assembly elections passed off peacefully with over 77 per cent of 8.57 lakh electors exercising their franchise.

Votes will be counted on December 3 alongwith other states which go to polls this month at different intervals. With this the political fate of former chief minister and BJP leader Raman Singh Chhattisgarh Congress chief and MP Deepak Baij, and at least three ministers in the Bhupesh Baghel cabinet was

sealed in EVMs. The polling for the remaining 70 Assembly segments will be held in the second phase on November 17 and votes will be counted on December 3. Incidents of violence were reported from Sukma, Narayanpur, Bijapur and Kanker districts.

Four security personnel were injured in an encounter with

Residents of 126 villages in the Bastar division rejoiced as polling stations were set up for the first time in their villages since Independence in seven Left Wing Extremist (LWE) affected districts, a statement issued by the poll authority

She voted in the Narayanpur constituency. Family members of BIP leader Ratan Dubey, who was killed by Naxalites while campaigning for the party last week in Narayanpur district, also cast their votes. The Congress, which is seeking another term and the opposi-tion BIP which had ruled the state for 15 years before it was voted out by a huge margin in 2018 polls, are the main con-

tenders for power. Voting for 10 constituencies was held from 7 am to 3 pm in 10 seats and from 8 am to 5 pm in the remaining 10 segments under a thick security blanket of police and paramilitary personnel in the Naxalite-hit Bastar division.

"A 70.87 per cent voter turnout was recorded till 5 pm in the first phase of the Chhattisgarh elections on Tuesday. However, this figure may go up as the final data from several booths was yet to be received," a poll official said.

Additional chief electoral officer H Lianzela said the voting percentage of Mizoram is likely to touch 80 as final reports were yet to come from far-flung

In the 2018 State polls, the overall voter turnout was 81.61

per cent. Polling in all the 1,276 polling stations was peaceful, the official said, adding 174 candidates, including 18 women, are in the fray. Of the 11 districts, central Mizoram's Serchhip recorded the highest polling percentage of 84.49, followed by Hnahthial Aizawl district witnessed the lowest turnout of 73.09 per cent. South Mizoram's Siaha (76.41) and Saitual (75.12) also posted lower voting percentages compared to others, ECI data said.

The ruling Mizo National Front (MNF), main Opposition Zoram People's Movement (ZPM) and the Congress have fielded candidates in all 40 seats. The BJP is contesting 23 constituencies, while the AAP has nominated candidates in four Assembly segments. Besides, there are 27 independent candidates.

Technical glitches in EVM were reported from one polling station in Aizawl where Chief Minister Zoramthanga went to vote, another official said. The 510-km-long international border with Myanmar and the 318-km boundary with Bangladesh had been sealed ahead of the polling.

Deepfake is a digital method where users can replace one person's likeness convincingly with that of another using AI technology. The Ministry of Information Technology (IT) has asked all social media platforms, including X (formerly Twitter), Instagram and Facebook to remove morphed images within 24 hours of receiving a

complaint under the IT rules. À deepfake video of actress Rashmika Mandanna has been circulating on social media platforms. Netizens, including several bollywood stars led by megastar Amitabh Bachchan, claimed the video has been morphed and the actual video

As per the advisory, social media platforms should take all measures to remove or disable content which is in the nature of impersonation in an electronic form, including artificially morphed images of such individuals within 24 hours from the receipt of a complaint in relation to the content.

The advisory mentions that social media intermediaries shall observe due diligence, including ensuring the rules and regulations, privacy policy or user agreement and inform users not to host any content that impersonates another person.

Lockdown in Kerala Governor's kitchen

The adage "Ants eating fire" is frequently used in Kerala. It metaphorically signifies that individuals in lower hierarchies attempt to undermine and embarrass those in positions of power.

This scenario unfolded in the State to a point where the functioning of the kitchen in Raj Bhavan, the residence of the First Citizen of Kerala, was on the brink of shutdown. This would have necessitated the Governor to source food from nearby restaurants

"Governor Arif Mohammed Khan was on the verge of ordering his food from nearby eateries when the CPI(M)-led Kerala Government released a portion of the funds meant for Raj Bhavan. Had it not been sanctioned by the Government, we would have witnessed a scenario of the Governor having to procure from hotels," a source in Raj Bhavan told *The*

Besides the closure of Raj Bhavan kitchen, the State would have also seen the half a dozen vehicles including the Governor's official car coming to a grinding halt.

"This is because the Kerala State Civil Supplies Corporation's refuelling stations issued an alert that they may be forced to deny diesel to the Raj Bhavan vehicles as bills for many months were pending," said the source. The expenses incurred by the

Governor is quite low compared to that of his predecessors. The delay in the payment of the bills and the expenses for Raj Bhavan is being seen as an act of vengeance by the CPI(M) against Arif Mohammed Khan because of his uncompromising stance against corruption, nepotism and partiality to party leaders and their relatives and associates, said the Source.

The Kerala Government has filed a plea in the Supreme Court asking it to declare Arif Mohammed Khan has failed in discharging his responsibilities like signing the appointment orders of faculties and vice-chancellors shortlisted for appointment in the State's Universities.

Modi to chair virtual summit of G20 leaders on November 22

The Russia-Ukraine war, the Israel-Hamas conflict and the challenges facing the Global South are among key issues which are set to figure at the virtual summit of the G20 leaders on November 22 that would be chaired by Prime Minister Narendra

At the end of the G20 summit in New Delhi in September, India announced that it will hold a virtual meeting of the leaders of the grouping before the end of its presidency. India has already sent invitations to leaders of the G20 member nations for the virtual summit.

It is learnt that India will focus on its development agenda for the grouping with a focus on challenges being faced by the Global South or the developing countries. There will be no joint outcome document at the end of the summit.

Diplomatic sources said the Russia-Ukraine war and the Israel-Hamas conflict are set to figure at the deliberations. However, India is expected to



focus on its development agenda including initiatives in areas of digital public infrastructure, climate finance and

In the last few years, India has been positioning itself as a leading voice, flagging concerns, challenges and aspirations of the Global South or the developing nations, especially the African continent. In a related development, External Affairs Minister S Jaishankar on Tuesday hosted envoys of the G20 nations at the India International Convention Centre (IICC), named Yashobhoomi, in

In the interactions, he thanked the G20 member nations for their "whole-hearted" support to India's presidency of the grouping. "Delighted to host Ambassadors of G20 members, guest countries and international organisations at Yashobhoomi convention centre today. Thanked them for their whole-hearted support during our Presidency,' Jaishankar said on 'X'.

Like our G20 Presidency, this state-of-the-art convention and expo centre reflects the capabilities of Bharat. Confident it will be a great venue for prestigious international events in the times to

The G20 joint declaration unveiled on September 9 was seen as a significant diplomatic victory for India as it pulled off a breakthrough on the contentious Ukraine conflict amid apprehensions that the summit may not be able to release the document in view of sharp differences on the matter.

As the G20 president, India has been focusing on issues like inclusive growth, digital innovation, climate resilience, and equitable global health access with an aim to benefit the Global South. Al to predict person's risk of cardiac disease

mid the disturbing trend And the distancing ... arrest being recently reported from the country, a study has offered a ray of hope in artificial intelligence (AI) which, it said, may help predict and perhaps even address a person's risk to prevent future death.

This could offer a new move toward prevention and global health strategies, said the researchers of the study who had analysed electronic health records from 25,000 people who had died suddenly and 70,000 people hospitalised for cardiac arrest who did not die in Paris, France and Seattle, Washington. They used AI to build personalised health equations that identified each person's risk of dying from sudden cardiac arrest. The outcome holds impor-

tance for India too where the occurrence of heart attacks among young people has increased in recent years,



mainly owing to fast-paced lifestyle and changes in habits. Those who suffered severe Covid are also said to be vulnerable to heart attack.

The researchers of the study will present at the American Heart Association's Resuscitation Science

Symposium 2023 soon in Philadelphia. The event is a premier global exchange of the most recent advances related to treating cardiopulmonary arrest and life-threatening traumatic injury.

As per the researchers, they were able to develop a customized risk profile of each of the individuals, a tool they said could be used in the future to address individual risks before a person experiences cardiac arrest and may lead to preventing deaths.

Kejriwal recommends suspension of official for halting smog tower operation

According to sources, the file recommending the suspension of Kumar, a senior IAS officer and principal secretary (home) in the Delhi government, has been sent to Lieutenant Governor Vinai Kumar Saxena. However, the officials later said the matter had been placed before the National Capital Civil Services Authority (NCCSA) as the Lt Governor's involvement was not required at this stage. No immediate reaction was available from Kumar, who is also the principal secretary (home) and divisional commissioner in the Delhi government. Kumar is member secretary of the National Capital Civil Services Authority (NCCSA) headed



by the chief minister that takes a final call on disciplinary action against IAS officers in the Delhi government. Delhi Chief Secretary is the third member of the panel.

Delhi Transport Minister Kailash Gahlot on Tuesday said polluting vehicles were entering the city freely despite restrictions under GRAP stage IV being in place in view of hazardous air quality and directed officials to ensure proper checking at the borders. Restrictions under GRAP stage IV, including a ban on all kinds of construction work and the entry of polluting trucks into the capital, kicked in on Sunday after air quality in the capital dropped to "severe plus" (AQI above 450) levels.

"The pollution situation in Delhi is grave and has resulted in the imposition of GRAP- IV by CAQM. However, it has come to my notice that polluting vehicles are entering Delhi borders at odd hours from neighbouring states without any hindrance.

It appears that no checking is being done at the borders to restrict entry of such polluting vehicles into Delhi. It is requested that all agencies and departments be directed to ensure proper checking of polluting vehicles whose entry is restricted as per stage IV of GRAP," read the directive from Gahlot. He also noted that the Supreme Court was monitoring the pollution situation in Delhi very closely and cautioned that "any laxity in this regard may invite strictures".

Aday after announcing to implement Odd-Even formula for vehicles in the city from November 13, Delhi **Environment Minister Gopal** Environment Minister Gopal Rai said the government will first study the Supreme Court order and then go for the odd-even rule, after the Apex Court on Tuesday rapped government for the pollution situation in the National Capital and asked whether the odd-even scheme to ration the number of cars plying on the roads has ever been successful. "It's all optics," the Supreme Court observed a day after the Delhi government announced that the odd-even scheme would be back from November 13 to November 20.

Rai said he held a meeting with senior officers of the transport and environment departments and the traffic police to discuss the modalities of the odd-even scheme. 'But meanwhile we came across some observations made by the Supreme Court. So now instead of announcing the odd-even rules, we will go through the order/observations of the



Supreme Court. After studying them, we will incorporate them into the scheme," Rai

Amid worsening air quality in the national capital, the minister on Monday announced that the odd-even scheme will be enforced in the city from November 13 to 20. Rai said there are "very few" incidents of stubble burning in Delhi and the government has arranged free sprinkling of bio decomposers to keep it in check. The minister said the air pollution crisis needs to be tackled through the efforts and cooperation of all the concerned states.

The city government announced odd-even formula soon after the fourth and final stage of GRAP was announced on Sunday considering the air quality of the capital in the 'severe plus' cat-

egory. The Delhi government has decided to implement the Odd-Even scheme in Delhi from November 13 to 20. On Odd days, only vehicles with license plates ending in 1, 3, 5, 7, and 9 will be allowed to operate, and on Even days, vehicles ending in 0, 2, 4, 6, and 8 will be allowed.

Delhi has been battling deteriorating air quality for the past five days with physical classes of schools being shut until November 10. Nonessential construction work and an embargo on certain vehicles have been imposed as the qir quality hovered around the severe category.

Kejriwal should apologise for turning city into gas chamber: BJP

¬he BJP on Tuesday said the Supreme Court's directive on pollution is a slap on the face of Delhi Chief Minister Arvind Kejriwal and demanded that he apologise for turning the national capital into a gas chamber. This came after the top court,

earlier in the day, directed Punjab, Haryana, Uttar Pradesh, and Rajasthan to ensure that crop residue burning was stopped "forthwith", amid a spike in pollution levels in Delhi-NCR.

Reacting to the court's directive, BJP national spokesperson Shehzad Poonawalla said, "After the complete expose of the Aam Aadmi Party by the Supreme Court on Delhi's Air Pollution and Punjab stubble issue, Arvind Kejriwal should apologise for making Delhi a gas chamber and stealing our



right to breathe fresh air over the last 8 years". All that Kejriwal did was "blame others including Diwali" for the rise in pollution levels in Delhi, he charged in a post on X.

"This is like a slap on Arvind Kejriwal's face," BJP IT department head Amit Malviya wrote on X, Commenting on the court's directive to the Delhi government. He hoped that Kejriwal would now stop blaming "everyone under the sun, except his own government in Punjab and Delhi." "People in Delhi-NCR are forced to inhale poisonous air because of one ber," Malviya said in an apparent reference to Kejriwal. Leader of Opposition in Delhi

Assembly Ramvir Singh Bidhuri said after this strong criticism from the Supreme Court, Chief Minister Arvind Kejriwal has no moral right to remain in office. DU revises hike in fee for PhD programme

In a notification issued on Tuesday, the department announced that the fee has been reduced to Rs 17,118 from Rs 23,968 earlier.

Any excess payment already made by students will be adjusted at the time of the next payment, it added.

"As decided by the university, the revised fee for PhD scholars admitted with effect from the academic years 2023-34 will be Rs 17,118," the notification read.

Reacting to the announcement, a Delhi University Teachers' Association (DUTA) executive said the decision to partially roll back the fee hike is not satisfacto-

ry. "This revision is not satisfactory. We demand that the

University immediately reviews the decision," Abha Habib, DUTA Executive said. Earlier this month, several teachers pointed out that the English Department had hiked the fee for PhD scholars by 12 times when compared to Rs 1,932 last year. The Democratic Teachers' Front had written a letter to Vice Chancellor Yogesh Singh expressing concern over the fee hike and demanded its roll back, saying it will put stu-

Centre places additional security checks at Delhi, Punjab airports

Passengers travelling on Air India flights from airports in the national capital and Punjab will undergo additional security frisking and issuance of visitor entry tickets has been stopped at the Delhi airport till November 30 according to the latest order issued after a video threat by designated Khalistani terrorist Gur Patwant Singh Pannun. The Bureau of Civil Aviation Security (BCAS) issued a circular in this regard. The BCAS also sent the order to the Home affairs ministry (MHA). All Air India passengers at Delhi and Punjab airports will be put through a "secondary ladder point check", under which the airline staff frisk travellers and their hand luggage

ing the aircraft, according to an order issued by the Bureau of Civil Aviation Security on Monday. Entry of visitors to the terminal building of the Indira Gandhi International Airport and the sale of visitor entry tickets will also be banned.

"Issue of TAEP's (temporary airport entry pass) entry of visitors to the terminal building of the (Indira Gandhi International) airport (in Delhi) and sale of visitors entry tickets will be banned," the BCAS said in its order.

The BCAS said that the step was being taken as a precautionary measure following continuous threat messages shared by the central agencies regarding "threat to civil aviation installations over all India airport like airports, airstrips, airfields, air



force stations, helipads, flying schools and aviation training schools.

The regulatory authority said the security agency at the airport will have to mandatorily have the secondary ladder point check (SLPC). UK set to restrict marketing, sale of vapes to kids

Taking cue from India, the United Kingdom is all set to restrict the marketing and sale of vapes and similar products such as e-cigarettes and new age gateway products targeted at children. Applauding the move, experts, including doctors and child psychologists pinned hope that other countries will too follow the suit and save the users, mostly youth and teenagers from the deadly trap.

Earlier this month, the Union Health Ministry had issued a clarification to the Ministry of Civil Aviation, emphasizing the imperative for rigorous enforcement of the Prohibition of Electronic Cigarettes Act (PECA), 2019.

While PECA may not explicitly state the prohibition of individual e-cigarette or vaping device use, its overarching intention is to ban all aspects of these products including its consumption. PECA enforces a sweeping ban that encom-



tronic nicotine delivery systems, heat-not-burn products, e-hookahs and similar devices, said the experts.

Coach & TEDx Speaker, said "The lack of awareness surrounding the risks associated with vaping is a huge concern in many countries including India. Many school-going children are taking up vaping under the false assumption that it carries no risks or dantroubling because young individuals may unknowingly become addicted.

"Both children and their parents often remain unaware of the severe health consequences of vaping, as they perceive it as a harmless activity involving the inhalation of flavours like

apple or strawberry."
Dr Rajesh Gupta, Additional

India to bring secondary care hospitals under AMRSN ambit

ARCHANA JYOTI ■ NEW DELHI

 $R^{\hbox{\it ealising that Antimicrobial}}_{\hbox{\it Resistance Surveillance and}}$ Research Network (AMRSN) deployed in the tertiary care hospitals is failing to yield desired results as there has been no let up in the AMR cases being reported from clinical establishments across the country, India has decided to bring the secondary care hospitals too under the ambit of such a mechanism.

'The Indian Council of

Medical Research (ICMR) has taken the initiative to address the health issues posed by the antibiotic resistance superbugs by establishing AMRSN and implementing AMS programs in tertiary care hospitals. There are 20 regional laboratories from tertiary care hospitals in India to provide data and fix the number of isolates for each pathogenic group. However, it has been realized that such steps have been limited to tertiary care hospitals. 'Hence, the data collected

through these initiatives do not adequately reflect the comprehensive picture of AMR in the country, particularly from community healthcare settings. Hence, it's crucial to extend the reach of the existing initiatives to secondary care settings also," explained a scientist from the ICMR. However, since secondary care

hospitals in India are not wellequipped to document the patterns of local antibiograms and monitor antibiotic usage due to various factors like absence of good clinical microbiology lab, absence of skilled staff etc, it has therefore decided to expand the AMR surveillance and strengthen the AMS and infection prevention and control

(IPC) components in secondary care hospitals with support and facilitation from local or regional tertiary care hospitals already having surveillance system. As per the plan, the tertiary care

hospitals will work with the secondary level public and private sector hospitals and support their participation in the AMR surveillance and in implementing ICMR's AMS and IPC initiatives in the secondary level hospitals. In India, the health centres for secondary health care include District hospitals and Community Health Centre at block leveL.

To ensure real time monitoring and track progress of data, a centralized platform for data collection would be provided by the ICMR. The selected researchers shall be invited to develop a full research proposal and roll out the research project under the guidance of the ÍCMR, pointed out by the scientist. In its National Health Policy

2017, India has identified managing AMR as a key priority and since then various measures have been taken to curb the epidemic that is growing fast domestically as well as globally. According to a Lancet study, an estimated 1.2 million people died in 2019 from antibiotic-resistant bacterial infections. India faces a significant burden

from infectious diseases and ranks second in global antibiotic consumption, increasing by 47% from 2010 to 2020. Misuse and abuse of antibiotics is a key driver for development of AMR. Free over-the-counter availability and self-medication by the patients fuel this rise, said Dr Sangeeta Sharma, President, Delhi Society for Promotion of Rational Use of Drugs (DSPRUD).

Health dept alert for Diwali, Chhath Door-to-door distribution of

The district administration is I busy completing preparations for the successful organisation of upcoming festivals like Diwali, Bhai Dooj, Chhath and Dev Deepawali. Along with this, the Health department has also directed the district level government hospitals to ensure medical arrangements in case of emergency. In this regard, Chief Medical Officer (CMO) Dr Sandeep Chaudhary held a virtual meeting with the superintendents of divisional hospital and government hospitals here on

Tuesday. The CMO said that there is a possibility of air pollution increasing during these festival periods. "In such a situation, arrangements for treatment for respiratory patients should also be ensured," he said, adding that as the cases of communicable diseases are still being detected, effective action will be

taken on the basis of the guidelines given earlier for the control of communicable diseases, inter-departmental coordination, public participation, immunisation, surveillance and case based activities.

According to him, medical and health arrangements should be ensured. "Wide publicity should be given through various mediums like social media, print and electronic media regarding measures to prevent various communicable and infectious diseases and

In accordance with the instructions received from Principal Secretary (Health), Uttar Pradesh, the CMO said that emergency services should operate smoothly 24 hours in all hospitals and an adequate number of doctors and staff should be deployed for emergency services. "In particular, cases of burns due to firecrackers, road accidents due to consumption of alcohol, food poisoning and eye injuries etc may occur. Arrangements for proper treatment etc may be made for such cases. Along with this, beds should be reserved for respiratory and

burn patients," he said. Dr Chaudhary further said that all necessary testing and pathology equipment should be kept functional. Also, the programme managers of 108, 102 and Advanced Life Support (ALS) ambulance services were directed to ensure timely avail-

any emergency. All doctors and paramedical staff should not be granted leave during festivals except for unavoidable reasons. Necessary action should be taken in full coordination with the district administration. Availability of doctors at Community Health Centres (CHCs) should be ensured All doctors will maintain mutual coordination on the units, so that referral up and referral down can be done smoothly, he

The CMO asked to ensure in advance the functioning of adequate quantities of medicines and necessary equipment in all government hospitals. The doctors and paramedical staff engaged in emergency duty were directed to ensure that they perform medical work by being present in the hospital as per the prescribed dress code and time, so that no adverse situation arises in view of any emergency.



Unsafe bet?

Akhilesh Yadav targets Congress again; are the cracks in INDIA moving beyond repair?

In India, alliances are seen as a good move for political parties to pool their resources and increase their chances of electoral success. But INDIA, the 28-party Opposition ■ alliance formed to unseat the ruling BJP from the Centre in the 2024 Lok Sabha elections, seems to be going the exact opposite way. Not only is it still far away from chalking out a comprehensive strategy and seat-sharing plan against the saffron behemoth, its cohesion is actually waning and the differences within are growing. It is, however, no secret that keeping such alliances together can be a challenging task, especially if the member parties have only one thing in common — to make it to the Treasury benches. The recent fissures within INDIA, which include seat-sharing disputes, sharp criticism and name-calling, have raised questions about the prospects of it holding together. One of the early signs of trouble was the contentious issue of seat-sharing; even the third meeting for the purpose could not reach an understand-



ing. Though the Congress enjoys a national presence, it is unavoidably juxtaposed to regional parties in most States such as UP, Bihar, Maharashtra, West Bengal and Tamil Nadu. The Congress and these regional parties see each other as their main challengers. Now, if the Congress cannot downsize its seat share, the regional parties would not like it as it is their base and raison d'être.

A noticeable instance of discord within the INDIA bloc surfaced after JDU leader Nitish Kumar criticised the Congress for being so preoccupied with the Assembly elections in five States that it had little time to get the newly formed bloc moving. His criticism

can be seen as a manifestation of the frustration that regional leaders sometimes feel within national alliances. Another blow came when former UP Chief Minister and Samajwadi Party leader Akhilesh Yadav referred to the Congress as a "chaalu party." The use of such derogatory terms for a partner not only reflects the bitterness in the relationship but also serves as political ammunition for the ruling party. As regional leaders aim to assert themselves, they may resort to public criticism of their partners. These internal conflicts can erode the alliance's credibility and give voters a reason to doubt its ability to provide stable and effective governance. But when there is no escaping such challenges, only a positive approach and determined effort can tidy up mutual differences. A realistic approach is indeed required on the part of all parties concerned. The electoral math suggests that they have a better shot in 2024 if they can make the contest one-on-one by giving a common candidate. The constituent parties must strike a balance between accommodating each other's regional and caste-based strengths while ensuring that the distribution of seats remains equitable. Disagreements over seat allocation can lead to frustration and mistrust among the alliance partners.

Language: Emotional connect and more



Languages growing simultaneously in any society are a binding force. Language cannot be a reason for mutual exclusion and antipathy

ommunication is central to all living entities. Plants communicate; creatures and animals communicate; and, of course, human beings communicate. They communicate not only amongst themselves but also across different categories and species. The examples are many, the illustrations are numerous, hence, there is no need to over-emphasise this aspect of communication. The big concern is not with the act of communication but with the modes of communication. For example, the uses and anatomy of communication among plants are well mapped, but there are not many who attempted an extensive research study of plant communication.

There are some exceptions, especially in the form of references and awareness. Illustratively, Kalidasa, in his epic drama 'Abhigyan Shakuntalam', would have us believe that when Shakuntala was leaving the Tapovana' (the hermitage) of Sage 'Kanva', the creepers of the jungle wrapped themselves around Shakuntala to bid an emotional farewell. What Shakuntala said would probably never be known, but it was obvious that sentiments and expressions were involved. The creepers wrapped themselves around Shakuntala as a kind of embrace and communication medium. Like an electronic system, the system of communication points requires encoding and decoding, and there is a thought process behind it.

Plants don't make sound in the way that animals, insects or some other creatures do. This makes the act of communication between insects and animals somewhat more sophisticated. The chirp of the insects of one variety or another is an act of communication, as indeed is the howling, barking, whining, and such acts of the animals among themselves and across species. All these creatures make sounds through their throats and mouths, and depending on the kind of noise that comes out of the animal, it is encoded and decoded. There are sounds of fear, just as there are sounds of is the lack of standardisation



of the entity. A dog, for example, communicates in multiple ways and is capable of sounds of aggregation, mating, warning, and more. The sound of a dog varies from species to species and from one breed to another. It is another matter that not many texts have been scripted on this theme, and hence there is little available on the language of the dogs. Amongst human beings too, all races don't have a script, yet within the race, they communicate. The matter does not end there.

Amongst human beings too, as indicated, there are a large number of variations among those of human species that don't have a script for their language but still communicate with each other. The difficulty with such a situation

In the more evolved type of human species, a script is available, and after a period of practice, the script is comparatively evaluated. In the times of yore, there was a Roman script, there was a Dravidian script, a Devanagari script, and there were Chinese scripts; there may have been a few other scripts that are no longer alive but must have existed. As time passed and the human species moved, mother scripts of Latin, and Sanskrit, acquired prominence and thus many modern languages were sprouted under their impact. It is not clear how many human languages exist on the planet today or, for that matter, how many languages are dead

Literature, as we understand it, is available in some of the ianguages. The coming of writing was

another phenomenon. It is reported that in the earlier stages of writing, the writing

The growth of writing is a specialisation in its own right, it is not feasible to attempt to document different stages of writing here. Do not bomb the medical neutrality



The growing tendency of nation-states to ignore medical neutrality will bring a dark age upon human civilization

Al-Ahli Baptist Hospital in Gaza was bombed on the evening of October 17, 2023, killing between 100 and 300 individuals including caregivers and civilians who were either patients or escorting them. Just like in Yemen and Ukraine before no one was held accountable. No official was legally or administratively disciplined even for the sake of optics. Just a hollow and shallow performance of grief not even a condemnation from leaders of nation-states. In Gaza, multiple health care facilities have been hit by airstrikes. Danger looms over every hospital that is still functioning, including Al-Shifa Hospital, the largest in Gaza. Electric, fuel, drugs and water supply have been cut off to hospitals that have not been bombed yet. Strategic targeting of medical infrastructure is being used as a force multiplier to increase casualties of war. Violating the rules universally agreed upon and established in the Geneva Conventions, this attack goes

against the most sacred of



law of Medical Neutrality and Immunity. Hospitals and medical centres have always been a refuge for the injured seeking help and escaping the violence in surrounding conflict zones, it is important for the future of humanity that they remain so. This is not an isolated incident but only the recent one in the long list of brutal deaths of civilians like medical personnel and journalists that resulted from the direct actions of official government militaries instead of nonstate entities, either due to malfunction or malintent. More than 8000 are dead, more than 70% of that number are children, women and elderly. More than 20000 injured need trauma care. This number is additional to the regular disease load that exists in any population like infants requiring incuba-

ing dialysis, diabetics requiring insulin and various conditions requiring emergency surgeries in addition to the trauma cases being brought in because of airstrikes. Medical resources are stretched thin and grossly inadequate concerning increased needs. Medical workers have been working without respite, clean water, developing skin and gastro-

intestinal infections. Killing of Medical workers and bombings of hospitals further aggravate the situation. The blood of the injured who survived the bombing of their houses only to be killed in airstrikes on ambulances and hospitals will stain our collective conscience for a long time to come, as will the decision of the Indian government to abstain from the resolution of the ceasefire forwarded by Jordan. Collateral damage is not a magical word that makes the wanton murder of non-combatants trapped in a conflict zone legitimate or any less abhorrent. All human life is precious, more so to those who swore an oath to save it. Medical comshould question this growing tendency of governments to ignore these old but wise laws of humanity. Citizens of the world need to hold their elected representatives accountable who are letting it happen, lest Gaza become another Auschwitz.

These governments are care-

lessly and irresponsibly attacking this foundational pillar of human ethics and values on which human civilization as we know it stands. Terrorists are non-state actors but when nation-states and countries ignore established rules of engagement that keep us devolving into savages during conflicts, it brings us one step closer to a dark age that may be high-tech but still darker than any that mankind has suffered before. An age when the red cross of hospitallers, a shared symbol of identity and purpose for medical caregivers across the world and a sign of hope and relief for the sick and injured, a symbol holier to us than any

meaning.



OVERCOMING LUST, THE SPIRITUAL WAY

Stay away from sense objects which invoke lusty feelings in us

It must be, otherwise, you are in denial. Our bodies have been made such that lust of all kinds will affect us. The Bhagavad-Geeta has plenty of information about this very important subject, "The senses, the mind and the intelligence are said to be lust's seats. Through them, this bewilders an embodied person, covering his wisdom." (3.40), "The senses are said to be powerful, but the mind is more powerful than the senses.

The intelligence is more powerful than the mind, but that which is more powerful than even the intelligence is lust. (3.42) Sample some of our weaknesses: for sex, for tasty foods, for attractive sights, for hearing what pleases us, for talking unnecessarily, etc. Yes, a few of these will be dominant in a person, while others will be dormant. Males will most likely have a weakness for sex, while women may be/will be more attracted to clothes, jewellery, etc. Unfortunately, no one will be free from these.

A question may be asked: "Why were we made in this fashion?" For two reasons. The first is that the creation has to go on. These shortcomings keep us attracted to the material world. The second is our wanting it. It will be difficult, if not impossible, to find someone, who doesn't have a deep desire for some kind of lust, be it for power, fame, beauty, wealth, etc. We really cannot fault

This article is for those, who are troubled by this ever-present 'kama,' and, most importantly, who are honest enough to admit their weakness. They can be helped. Before I go into specifics of it, let us understand the true nature of kama from the Geeta. "It is lust only; it is anger only, born of the mode of passion. Lust is the one that devours, and is a great sinner.



Know this to be the enemy of the world." (3.37) "Just as fire is covered with smoke; just as a mirror is covered with dirt; and just as an embryo is covered with a womb, similarly, knowledge is covered with lust." Lord Krishna leaves no doubt about how dangerous lust is, when He states, "Lust, anger and greed are three doors to hell, which cause ruination of the soul. (16.21)

Having got a fair idea about the nature of kama, lets us understand how to deal with it. The very first lesson is to never underestimate lust. Rather we should err on the side of caution and overestimate it. Therefore, stay away from sense objects, which invoke lusty

As it is, we are highly susceptible to being corrupted. Why, then have anything to do with it? Yes, it is not possible to do so always but we must. External attractions make the mind weak, which is already highly vulnerable.

These and many other ideas will help somewhat, but all will fall woefully short. Why? Because the mind is seated inside us. One thinks that we are not hurting anyone and no one is wiser about our thoughts. This is a big mistake; we hurt ourselves quite badly. The mind, already a big enemy, becomes worse. The reality is that only God can help. I mean it. God has counselled us to kill this formidable enemy: He has stated, "Thus knowing this lust to be more powerful than the intelligence and steadying self by self, kill this difficult to conquer enemy in the form of lust." (3.43) Yes, but it is practically impossible to do it by oneself. We need God's help to get rid of the lust, which covers knowledge/wisdom.

Sanctions on Russia are counterproductive



In a globally interdependent world, actions that severely restrict the flow of goods and services across national boundaries are bound to be counter-productive



n a bid to punish Russia for its military action against Ukraine, in June 2022, leaders of G7 viz., the United States, Germany, France, Britain, Italy, Canada and Japan had vowed to explore the feasibility of measures to bar imports of Pussian oil at price above a cerimports of Russian oil at price above a certain level. In September 2022, their finance ministers (FMs) said:

"We confirm our joint political intention to finalise and implement a comprehensive prohibition of services, which enable maritime transportation of Russian-origin crude oil and petroleum products globally. Providing those services would only be allowed if the oil and petroleum products are purchased at or below a price (the price cap) determined by the broad coalition of countries adhering to and implementing the price cap."

On December 5, 2022, they set the price ceiling at US\$60 per barrel. It was meant to weaken Russia financially by undermining its ability to generate revenue from the export of petroleum products while ensuring that supplies to them (read: G7/EU) are not impacted. Unfortunately, things haven't

Russia is a dominant player in the global energy landscape.

It is the third-largest producer of crude oil with over 12 per cent share in global crude production and the second-largest exporter. In the case of natural gas (NG), it is the world's second-largest producer with a share of 10 per cent. In world export, its contribution is even higher at 25 per cent. When it comes to EU countries, their dependence on Russia is even higher, drawing 40 per cent of their NG supplies and 25 per cent of crude from it. Some countries in the bloc viz. Germany, the Netherlands and Poland, source a much higher percentage of their requirements from Russia.

In this backdrop, huge disruption in supplies from Russia caused by a deadly cocktail of economic and financial sanctions imposed by the EU countries (besides the USA); physical incapacitation in the supply chain and clogging of sea transportation routes – in the wake of military action

by the former against Ukraine in February - led to steep increase in the price of both crude oil and NG. As a result, the EU countries bought all their requirements at elevated prices as during that period, the price cap wasn't in force. This led to a huge increase in their import bill.
According to the Centre for
Research on Energy and Clean Air,
Russia received about 158 billion euros in revenue for the sale of oil, NG and coal from February to August 2022, more than half of which - some 85 billion euros worth - was from the EU. Russia's revenue increased even as overall export volumes dropped by 18 per cent compared with the corre-sponding period before the invasion

of Ukraine. Even after the cap came into force on December 5, 2022, the G7 bloc has achieved little in restricting Russia's earnings. As it is, fixing the ceiling price at US\$60 per barrel is laughable considering that the cost of producing oil is substantially lower, in fact, a fraction of this num-ber. Even if exports were made at this price (between December 2022 and June 2023, most of Russia's crude was selling at less than this price implying no violation), it would still be generating a lot of surpluses to keep its war machinery well-oiled.

Since, July 2023, the price has been above the cap, courtesy of reduced availability of oil worldwide as a result of Saudi Arabia and Russia cutting production by one million barrels per day (mbd) and 0.3 mbpd respectively over and above the cut agreed to in the meeting of OPEC + in April 2023. Russia has been able to benefit from this as well. For instance, according to S&P Global Platts, its key export grade crude sold at around US\$75 per barrel enabling it to garner oil income of US\$211 million a day during What has come in the way of G7 enforcing the cap?

The G7 wanted to enforce it by to deny Western-dominated ser-

er in Germany) needs to give a piece of paper to the service provider saying 'it has bought Russian crude at or below the cap. If the latter doesn't have this document, the G7 country will impose sanctions on that service provider. They feel confident, it will work because many vessel owners, traders and most insurers are based in the EU/USA; hence

What if the buyer refuses to provide requested price information or gives a fudged document mentioning a price less than the cap even though the purchase is at a higher price or hides the true origin of Russian oil, etc? In any of these scenarios, the G7 country won't be able to take any action as per their agreement 'Services providers can't be held liable for false pricing information provided by buyers and sellers'.

The sellers and buyers of Russian oil can use a host of other methods to circumvent the cap. For instance, the price can be set as oil leaves a Russian port, not what's paid by a refinery in, say, India. While the former can stay well within the US\$ 60 per barrel level, transportation costs and margins of trading companies (albeit Russian-affiliated) in countries

The Palestinian death toll has surpassed 10,000, the Health Ministry of the Hamas-run Gaza Strip said Monday, including over 4,100 minors. More than 2,300 people are missing and believed to be buried under the rubble of destroyed buildings, the ministry said. The ministry does not distinguish between civilians and combatants, and Israel says it has killed thousands of fighters. About 1,400 people in Israel have died, mostly civilians killed in the Oct. 7 incursion by Hamas. Israelis observed a moment of silence Tuesday in memory of the victims.

 $F^{\text{resh from a whirlwind tour}}_{\text{of the Middle East, US}}$ Secretary of State Antony Blinken shifted his intense diplomacy on the Israel-Hamas war to Asia on Tuesday with an appeal for the Group of Seven leading industrial democracies to forge consensus on how to deal with the crisis.

As he and his G7 counterparts began two days of talks in Japan, Blinken said it was critically important for the group to show unity as it has over Russia's war in Ukraine and other major issues and prevent existing differences on Gaza from deepening. "This is a very important moment as well for the G7 to come together in the face of this crisis and to speak, as we do, with one clear voice," Blinken told Japanese Foreign Minister Yoko Kamikawa, shortly after talks with Prime Minister Fumio Kishida.

The devastating monthlong conflict in Gaza and efforts to ease the dire humanitarian impacts of Israel's response to the deadly Oct 7 Hamas attack will be a major focus of the meeting. Yet with the Russia-Ukraine war, fears North Korea may be readying a new nuclear test, and concerns about China's increasing global assertiveness, it is far from the only crisis on the agenda.

In Tokyo, Blinken and foreign ministers from Britain, Canada, France, Germany, Japan and Italy will be seeking common ground in part to prevent the Gaza war from further destabilising already shaky security in the broader Middle East and seeking to maintain existing consensus positions on other matters. Kamikawa said Japan "unequivocally condemns" the Hamas' attack on Israel, supports US efforts to find a way forward and said that "solid unity between Japan and the US is especially critical at

this point."
"We appreciate the diplomatic efforts of the US in the recent situation between Israel and Palestine," she said. "You have our utmost support."

Those efforts include significantly expanding the amount of humanitarian aid being sent to Gaza, pushing Israel to agree to "pauses" in its military operation to allow that assistance to get in and more civilians to get out, beginning planning for a postconflict governance and security structure in the territory and preventing the war from spread-

Blinken described all of these as "a work in progress" and acknowledged deep divisions over the pause concept. Israel remains unconvinced and Arab and Muslim nations are demanding an immediate full cease-fire, something the United States opposes. There has also been resistance to discussing Gaza's future, with the Arab states insisting that the immediate humanitarian crisis must be addressed first.

Securing agreement from G7 members, none of which border or are directly involved in the conflict, may be a slightly less daunting challenge for

Yet cracks have emerged over Gaza, which has inflamed international public opinion. Democracies are not immune from intense passions that have manifested themselves in massive pro-Palestinian and anti-Israel demonstrations in G7 capitals and elsewhere. Last month in the UN

Security Council, France voted in favour of a resolution calling for a humanitarian truce in Gaza that was vetoed by the United States because it didn't go far enough in condemning Hamas' attack on Israel, which ignited the war. Britain abstained in that vote.

Several days later in the UN General Assembly, a non-binding US-Canadian resolution that would have condemned Hamas failed, while a separate resolution calling for an immediate cease-fire overwhelmingly passed. The US voted against the second resolution while France voted in favor. Britain, Canada, Germany, Italy and Japan all abstained. Britain's Foreign Secretary James Cleverly told a select group of journalists, including The Associated Press, that his government only supports a time and geographically specific "humanitarian pause" and not

'Cyprus has plan for humanitarian corridor to Gaza'

Nicosia (Cyprus): Cyprus will present its plan for a humanitarian sea corridor to Gaza when the Cypriot president meets other ÉÜ heads of state in Paris at an international donor conference for the besieged Palestinian enclave on Nov 9, an official said Tuesday.

Government spokesman Constantinos Letymbiotis told reporters the initiative to ship Mediterranean island will be discussed at length during the conference, which will also seek to address Gaza's pressing needs including water, electricity and fuel supply.

Last week, senior UN officials said the average Palestinian in Gaza was living on two pieces of bread a day, while only one of three water supply lines from Israel was operational. More than 1.5 million Palestinians have been displaced in Gaza by the Israeli offensive launched in the wake of Oct 7, when Hamas attacked Israel, killing 1,400 people.

Christodoulides said Tuesday the initiative aims for a "sustained, secure high-volume flow of humanitarian assistance to Gaza in the immediate, medium and long term". Ships would deliver the aid to Gaza from Cyprus' main port of Limassol, some 255 miles away (410 km).

Christodoulides said his government is working with neighboring countries including Israel, Egypt, Jordan and the Palestinian Authority as well as the US, France, the EU and the UN to set the initiative

Civilians fleeing Gaza's combat zone

What was once Gaza's busiest thoroughfare has become a terrifying escape route for Palestinian civilians fleeing combat on foot or on donkey carts. On their way south, those running for their lives said they raised their hands and waved white flags to move past Israeli tanks along the four-lane highway. Some reported Israeli soldiers firing at them and said they passed bodies strewn alongside the road. Many escaped with just the

clothes on their back. One woman, covered head-to-toe in a black veil and robe, cradled a toddler and clutched a black purse. A man walked alongside a covered donkey cart that transported his family. It was piled high with mattresses.

In the north of the Gaza Strip, Israeli ground forces backed by relentless airstrikes have encircled Gaza City, the base of Hamas' power, since the

weekend. They cut the strip in half and sought to drive Palestinians from northern Gaza as troops advanced. From early on in the war, now in its second month, the army has urged civilians to move south, including by announcing brief windows for what it said would be safe passage through Salah al-Din, which runs through the centre of the besieged enclave.

But tens of thousands of civilians have remained in the north, many sheltering in hospitals or United Nations facilities. Those who have stayed put say they are deterred by overcrowding in the south, along with dwindling water and food supplies, and continued Israeli airstrikes in what are supposed to be safe areas. Some said fear of the treacherous journey, following reports from other travellers about coming under fire, initially made them hesitate.

On Monday, Health Ministry in Gaza spokesperson Ashraf al-Qidra dismissed the Israeli offers of safe passage as

"nothing but death corridors". He said bodies have lined the road for days, and called for the International Committee of the Red Cross to accompany local ambulances to retrieve the dead.

Israel's military said that, at one point, troops came under Hamas fire when trying to open the road temporarily for civilians. Israel's Prime Minister Benjamin Netanyahu echoed the army's claims in an interview with ABC News broadcast late

"We are fighting an enemy that is particularly brutal. They are using their civilians as human shields, and while we are asking the Palestinian civilian population to leave the war zone, they are preventing them at gunpoint," Netanyahu said. The claims could not be verified independently.

During a four-hour evacuation window Sunday, fewer than 2,000 made the move, followed by about 5,000 on Monday, according to UN monitors. Some of those were from Gaza City and the adjacent Shati refugee camp, fleeing Monday after heavy Israeli bom-bardment there overnight.

"Last night was very diffi-cult," said Amal, a young woman who declined to give her family name due to safety concerns. She was part of a group of 17 people making the journey Monday. She said tanks fired near the group. Soldiers then ordered everyone to raise their hands and white flags before being allowed to pass.

Nour Naji Abu Nasser, 27 arrived Sunday in Khan Younis in southern Gaza. She described an hourslong frightening jour-"They fired at the sand around us. They wanted to scare us," she said, adding that she saw bodies lying along the road outside Gaza City. Once those fleeing the north had reached the evacuation zone, residents from the Bureij refugee camp along the highway offered water — a scarce resource in wartime Gaza — to the evac-

Britain's health service rolls out breast cancer prevention pill

Thousands of women at I increased risk of breast cancer are set to benefit from a riskreducing drug to be offered by Britain's National Health Service (NHS) after it was licensed for use to help prevent the disease, the state-funded health service announced on Tuesday.

Anastrozole, which has been used for many years as a breast cancer treatment, has today been licensed by the UK's Medicines and Healthcare products Regulatory Agency (MHRA) as a preventive option - which it is hoped could help prevent thousands of breast cancer cases in England.

The drug, which is offpatent, has been shown in trials to reduce the incidence of the disease in post-menopausal women at increased risk of the disease by almost 50 per cent.

mon cancer in the UK, so I'm delighted that another effective drug to help to prevent this cruel disease has now been approved," said UK Health Minister Will Quince."We've already seen the positive effect Anastrozole can have in treating the disease when it has been detected in postmenopausal women and now we can use it to stop it developing at all in some women. This is a great example of NHS England's innovative Medicines Repurposing Programme supporting the development of new ways for NHS patients to benefit from existing treatments," he said.

Scotland Yard urges protesters to call off Armistice Day march

London (PTI): Scotland Yard have issued an appeal to protesters planning demonstrations against the Israel-Gaza conflict on the streets of London this weekend to postpone their plans amid fears of criminal acts by breakaway groups on Armistice

The Police said on Monday that it held meetings with organisers from a range of groups to ask them to reconsider organising marches that coincide with the commemoration of Britain's war martyrs annually, on November 11.

However, the organisers have declined to postpone their plans for another demonstration in line with the past few weekends when thousands have marched through the streets of London. Several arrests have

been made for criminal offences with over 1,000 officers on duty to police the protest last weekend. 'The risk of violence and disorder linked to breakaway groups is growing," said Met Police Deputy Assistant Commissioner Ade Adelekan."This is of concern ahead of a significant and busy weekend in the capital. Our message to organisers is clear: Please, we ask you to urgently reconsider. It is not appropriate to hold any protests in London this weekend," he said. Both British Prime Minister Rishi Sunak and Home Secretary Suella Braverman have issued statements to say that it is "provocative and disrespectful" to hold protests as the UK marks Armistice Day - when commemorative wreaths are laid at the war memorials.

NATO freezes Cold War-era security agreement after Russia pulls out

NATO member countries that signed a key Cold War-era security treaty froze their participation in the pact on Tuesday just hours after Russia pulled out, raising fresh questions about the future of arms control agreements in

Many of NATO's 31 allies are parties to the Treaty of Conventional Armed Forces in Europe, which was aimed at preventing Cold War rivals from massing forces at or near their mutual borders. The CFE was signed in November 1990 as the Soviet bloc was crumbling but was not fully ratified until two years later.

NATO said that Tuesday's action by its signatory members was required because "a situation whereby Allied State Parties abide by the Treaty, while Russia does not, would be unsustainable".

Earlier in the day, Moscow said it had finalized its withdrawal from the treaty. The long-expected move, which the Kremlin blamed in part on NATO's continued expansion closer to Russia's borders, came after lawmakers in Moscow approved a bill proposed by President Vladimir Putin

US National Security Adviser Jake Sullivan said suspending the obligations by Washington and its allies will strengthen NATO's "deterrence and defense capacity by removing restrictions that impact planning, deployments, and exercises -- restrictions that no longer bind Russia after Moscow's withdrawal".

When it was signed, the CFE envisaged weapons limits for the Warsaw Pact and NATO, but the Warsaw Pact ceased to exist shortly after it was signed. Unsuccessful attempts were made to renegotiate its conditions.

Russia suspended its participation in 2007, and in 2015 announced its intention to completely withdraw. In February 2022, Putin sent hundreds of thousands of Russian troops into Ukraine, which also shares borders with NATO members that signed the CFE: Poland, Romania and Hungary.

Announcing Moscow's withdrawal from the treaty had been completed, the Russian Foreign Ministry blamed the US and its allies for the move as well as the West's allegedly "destructive position" on the treaty. "We left the door open for a dialogue on ways to restore the viability of conventional arms control in Europe," it said. "However, our opponents did not take advantage of this opportunity."

The ministry said that "even the formal preservation" of the treaty has become "unacceptable from the point of view of Russia's fundamental security interests," citing developments in Ukraine and NATO's recent expansion. NATO said its members remain committed "to reduce military risk, and prevent misperceptions and conflicts." It said the alliance will continue to "consult on and assess the implications of the current security environment and its impact on the security" of the

Top aide to Ukraine's military commander is killed by grenade given as birthday gift

Kyiv (**AP**) A top aide to Ukraine's commander in chief was killed by a grenade given to him as a birthday gift and not in a targeted attack, the interior minister said.

Mai Hennadii Chastiakov died in the tragic accident Monday that badly injured his 13-year-old son, Interior Minister Ihor Klymenko said on Telegram.

A colleague presented six new grenades as a gift to Chastiakov, who was a top aide and close friend to commander-in-chief Gen Valerii Zaluzhnyi, for his 39th birthday, Klymenko said.

Chastiakov was showing off the grenades to his family at home when his son took one and began twisting the ring.

"The serviceman then took the grenade from the child and pulled the ring, leading to a tragic explosion," Klymenko said.

Police are investigating the incident in the village of Chaiky in the Kyiv region.

The officer's death was the second fatal tragedy in less than a week for Ukraine's military.A Ukrainian brigade holding a ceremony in Zaporizhzhia to honor troops on Friday was struck by a Russian missile that killed 19 soldiers, one of the deadliest single attacks reported by Ukrainian forces.

The commander of the 128th Separate Mountain Assault Brigade, Dmytro Lysiuk, was suspended as authorities investigate why the Rocket Forces and Artillery Day event was held near the front line, where Russian reconnaissance drones could easily spot the gathering.

Australian leader calls for free trade to resume with China

Australian Prime Minister Anthony Albanese called for the "full resumption of free and unimpeded trade" with China in a meeting Tuesday with counterpart Li Qiang that marked the return of talks after a four-year hiatus.

A joint statement said the countries agreed to resume an annual leaders meeting, which had been halted by a sharp deterioration in relations during which China slapped tariffs and other restrictions on imports from Australia.

Ties have improved in the past year, and China has lifted some trade restrictions, which are estimated to have cost Australian exporters up to 20 billion Australian dollars (\$13 billion) a year. China has been a major market for Australia in a range of goods including coal, wine, beef, barley and lobsters. "We can grow the relationship while advancing our respective interests, if we wisely navigate when there are differences," said Albanese, the first Australian leader to visit

China in seven years. Li said China is willing to work with Australia to further strengthen dialogue and properly handle differences so that cooperation will be the main feature of their relations, China's official Xinhua News Agency said. Relations spiralled downward in recent years as the Australian government began to view China as a potential security threat.

Australia's parliament banned covert foreign interference in domestic politics, a move sparked by suspicion of Chinese interference. Soon after, the government banned Chinese-owned telecommuni-

40 die in heavy rains in Kenya and Somalia

Nairobi (AP): Heavy rains and flash flooding have killed at least 40 people and displaced tens of thousands in Kenya and Somalia, aid agencies have reported.

In Somalia, the government declared an emergency after the extreme weather killed at least 25 people and destroyed homes, roads and bridges. Emergency and rescue workers were trying to reach an estimated 2,400 residents trapped by floodwaters in the Luuq district of southern Somalia's Jubaland state. The UN Office for the Coordination of Humanitarian flooding along the Juba and Shabelle rivers and called for the evacuation of people living along the entire stretch of the

"The Somalia Disaster Management Agency is swiftly responding to the crisis, with plans to dispatch a flight to Dollow and transport two boats from Kismayo to Luuq and one to Baardhere to assist with evacuations," Hassan Isse, the agency's managing director, told The Associated Press.

"The magnitude of the current floods is likely to deteriorate in the next few days due to the emergence of more water from upstream in the Ethiopian Highlands," Isse said.

The heavy rains follow four consecutive years of drought that pushed Somalia to the brink of famine. In neighbouring Kenya, the Kenya Red Cross said the death toll had risen to 15 since the heavy rains began Friday, with the port city of Mombasa and the northeastern counties of Mandera and Wajir the worst affected.

"Accordingly, a show cause notice has been issued to Air India seeking their response for non-compliance to the provisions of the CAR," the DGCA said in a release.

There was no immediate comment from Air India about the show cause notice.

The regulator also said it is imperative to continuously strengthen the rights of the passengers and ensure that the airline operates under harmonised conditions in line with the best global practices. Domestic air passenger traffic has been rising in India, which is one of the fastest growing civil aviation markets in the world.

"It remains subject to foreign direct investment approval, as well as approvals from other regulators and competition authorincluding those from India's Directorate General of Civil Aviation, Ministry of Civil Aviation, and National Company Law Tribunal, and the Competition and Consumer Commission of Singapore," SIA Group said in a release on

Tuesday. While announcing the group's financial performance for the first half of the financial year 2023-24, SIA also said that when the merger is complete, it will get a 25.1 per cent stake in an enlarged Air India Group with a significant presence in all key Indian airline market seg-

Right after relinquishing the No. 1 ranking two months ago, Iga Swiatek couldn't help but worry

about trying to regain it. "It's hard not to think about stuff like that," she explained.

And then Swiatek realized it was better to set that sort of thing aside and, instead, simply focus on playing her best tennis - and her best is better than anyone else's at the moment. Swiatek earned her first WTA Finals title and clinched the year-end No. 1 ranking by overwhelming Jessica Pegula 6-1, 6-0 on Monday in the latest in a series of

dominant performances.
"Today was like a highlight of this mental (approach) - just being narrow with your head, only thinking about the right stuff," said Swiatek, a 22-year-old from Poland who is the youngest WTA Finals champion since Petra Kvitova was 21

Swiatek went 5-0 at the tour's seasonclosing championship, winning all 10 sets she played and ceding a total of just 20 games. That's the fewest by the winner at the event for the top eight women in tennis since the round-robin format returned in 2003.

"She clearly really wanted that ranking," Pegula said. "I mean, you could tell by the way she was competing here. ... She was, like today, crushing people.

Swiatek extended her winning streak to 11 matches and improved to 68-11 in 2023 with six trophies, including her



fourth career Grand Slam title at the French Open in June.



MAXWELL SNATCHES WIN FOR AUSTRALIA

GLENN'S SENSATIONAL DOUBLE CENTURY POWERS AUSTRALIA INTO SEMIFINALS

Battling pain and exhaustion, Glenn Maxwell conjured arguably the greatest knock (201 not out off 128 balls) in the history of limited overs cricket to singlehandedly propel Australia to a sensational three-wicket win over Afghanistan in the World Cup here on Tuesday.

With this, Australia became the third team to enter the semifinals.

Opting to bat, opener Ibrahim Zadran became the first Afghanistan batter to score a World Cup hundred and guided his team to 291

In reply, Australia were down and out at 91 for seven in the 19th over. That's when Maxwell decided to take charge and led an incredible comeback while adding 202 runs for the eighth wicket with skipper Pat Cummins (12 not out), who watched the mayhem unfolding from the other

In all, Maxwell smashed 21



boundaries and 10 sixes. Earlier, Zadran carried his bat through the innings and finished on 129 not out off 143 balls.

Afghanistan lost opener Rahmanullah Gurbaz for a 25-ball 21 but Zadran and Rahmat Shah stitched 83 runs for the second wicket to lay a good foundation before the latter was dismissed by Glenn Maxwell for a 44-ball 30 in the 25th over with the score reading

Unperturbed by the loss of few wickets at the other end, Zadran continued to accumulate runs at a decent rate to prop up his team against the five-time world champions.

Rashid Khan smashed unbeaten 35 off 18 balls towards the end

Among all Afghan players, Ibrahim Zadran spent the longest time with Sachin Tendulkar on the eve of their World Cup match against Australia, taking batting lessons from the all-time great. The one-on-one chat with the master had its effect, for the 21-year-old opener on Tuesday became the first player from Afghanistan to record a hundred in a World Cup match. Needless to say, Zadran thanked the batting great for his invaluable tips moments after reaching the landmark. Thanks to his brilliant knock of 129, Afghanistan posted a challenging 291 for five against an attack comprising Pat Cummins, Mitchell Starc, Josh Hazlewood and Adam Zampa. That he turned up in casuals on the match eve, instead of the training kit, didn't matter.
"I had a good chat with Sachin

Tendulkar. He shared his experience, and I said before the match that I will bat like Sachin Tendulkar. He gave me a lot of energy and confidence," he told the broadcaster following his 143-ball innings. Zadran's knock contained eight fours and three sixes, as it allowed Afghanistan to post a fighting total.

"I am feeling great to score Afghanistan's maiden hun-dred in (World Cup). I worked really hard for this tourna-

'I missed a hundred against Pakistan but made it today. I was talking to my coaching staff, and I told them I have a feeling I will get a hundred in next three matches," he added. On Monday evening, Tendulkar gave him tips about batting for longer durations and exploring more options while playing shots. The leg-end also told them to fix a goal (team goal).

Zampa is now the second in the list of leading wicket-takers of the ongoing World Cup, with 19 scalps from seven matches at an average of 17.15.

The star all-rounder sustained the injury on his left index finger while batting during Bangladesh's threewicket win over Sri Lanka at the Feroz Shah Kotla on Monday.

An X-ray examination after the game confirmed a fracture, ruling him out of the match against Australia, to be played in Pune on Saturday. Shakib was struck on his left index finger early in his innings but continued to bat with supportive taping and painkillers,' Bangladesh team physio Bayjedul Islam Khan was quoted as saying by the ICC.

"He underwent an emergency X-ray in Delhi after the game which confirmed the fracture on the left PIP joint. Recovery is estimated at three to four weeks. He will leave for Bangladesh today to begin

Ctitle defence dream, England will now set sights on restoring their pride and secure a berth in the 2025 Champions Trophy when they face a plucky Netherlands in the World Cup here on Wednesday.

England have cut a sorry figure, managing just one win from seven matches in the World Cup to slip to the bottom of the 10-team table.

The Netherlands are a tad better on ninth with two wins and four points.

Both teams are out of the reckoning for a semifinal spot. The 33-run loss to arch rivals Australia on Saturday was the final nail in the coffin for England. While the Dutch are also officially out of the race. But with ICC announcing that the top seven teams and hosts Pakistan will qualify for the 2025 Champions Trophy, there has been a scramble for the last few spots.

Champions four years ago, England have hit rock-bottom in this edition. No England team has ever lost so many games at a World Cup. Whatever could go wrong has gone wrong for the Three Lions and they are no longer



favourites even against minnows Netherlands.

To avoid the ignominy of missing the cut for the prestigious Champions Trophy, England must win their remaining two fixtures against the Netherlands and Pakistan.

But that's easier said than done as both confidence and form has deserted the ageing England side, which looked extremely dangerous on paper. The batting unit has failed miserably. Openers Jonny Bairstow and David Malan have struggled to give the kind of start expected of them while Joe Root's famed consistency too has deserted him.

Skipper Jos Buttler and the bighitting Liam Lingstone are also woefully out of form. For England to win, their batters need to fire.

The England bowling unit has performed a touch better but it is one dimensional and lacks

But, the Court of Appeal here suspended for 14 days the notification issued by Ranasinghe after Silva approached it for relief.
Officials of the Silva adminis-

tration said the court order tantamounted to the SLC being restored and they would resume operations as usual. Ranatunga visited the SLC headquarters on Monday to

take over the administration. The sacking of SLC was discussed at the cabinet meeting held here on Monday. President Ranil Wickremesinghe appoint-
