 $I^{\rm n}$ a cricketing spectacle that will be etched in the annals of history, India orchestrated a breathtaking victory over New Zealand in the ODI World Cup semifinal with 70 runs, unfolding a narrative of resilience, skill, and sheer brilliance. The Wankhede Stadium in Mumbai played host to a contest that transcended the realms of sport, capturing the imaginations of millions of fans worldwide. The stage was set for a clash of titans, and what transpired was

Uttarkarshi Team still unable to rescue

With precious time ticking away to save the lives of 40 labourers stranded in the under-construction tunnel in Silkvara of Uttarkashi since Sunday morning, the authorities have intensified the rescue operation.

in the plan to insert a steel pipe of 900 mm diameter in order to create an escape conduit for the trapped workers developed a snag the authorities have now decided to induct heavy equipment capable of drilling through the debris at a faster

This equipment was airlifted by three C1-30 aircrafts of Indian Air Force (IAF) to the Chinyalisaur airstrip located on India China border in Uttarkashi district on

Wednesday afternoon. The equipment is now being transported to the accident site and is expected to reach there on Wednesday night.

A team of experts has also reached the spot to operate the heavy but state of the art drilling

equipment. The director of the National Highways and Infrastructure Development Corporation Limited (NHIDCL) Anshu

Manish Khalkho told mediapersons at the accident site that the machine will speed up the task of drilling.

He said the pipe has already been inserted into the debris. The officer supervising the operation said once installed the heavy drill machine will be able to drill at a rate of four to five meter in an hour.

He expressed hope that the machine will be able to push the

steel pipe (which is broad enough for the workers to come out) in ten to twelve

hours. He said the rescuers are in contact with the trapped labourers by two pipes through which food and oxygen is being infused.

The officer said the rescue team is working round the clock to save the precious lives. Meanwhile, Uttarakhand Chief

Tuesday's landslide and slow performance of the drilling machine deployed earlier hampered efforts to insert steel pipes through the tunnel's debris to create the passage, the NHIDCL director added.

As Ashleen attains the title of the youngest author in her adopted country, Australia, her parents — Jasmeen Kaur and Amarjit Śingh — take great pride in highlighting every facet of their Indian heritage, rooted in Punjab's Hoshiarpur.

At the age of nine, Ashleen began shaping her dreams, and by the time she turned 11, she had successfully realised them. Over the past two years, she raised funds by collecting plas-

tic and glass bottles, diligently taking them to recycling sta-

Ashleen's parents told The Pioneer that she opened up her piggy bank, as well as planted and sold some yaccas, mangoes, guava and jacaranda plants online at her Sydney home. In her two years sojourn she did not take a single cent from her

parents.

Israel storms AI Shifa hospital in Gaza

Israeli forces raided Gaza's largest hospital early Wednesday, where hundreds of patients, including newborns, have been stranded with dwindling supplies and no electricity, as the army extended its control across Gaza City and the north.

Shifa Hospital has become a symbol of the widespread suffering of Palestinian civilians during the war between Israel and Hamas, which erupted after the militant group killed some 1,200 people and seized around 240 captives in a sur-prise October 7 attack into southern Israel.

The hospital is also at the heart of clashing narratives over who is to blame for the thousands of deaths and widespread destruction in the besieged territory. Israel accuses Hamas of using Palestinians as human shields. while Palestinians and rights

groups say Israel has recklessv endangered civilians as it seeks to eradicate the group. Mohammed Zagout, the director of hospitals in Gaza, said

Israeli tanks had entered the medical compound and that soldiers had entered buildings including the emergency and surgery departments, which house intensive care units. "The occupation forces stormed

the buildings," he said angrily over the phone. He said the patients, including

children, are terrified. "They are screaming. It's a very terrifying situation ... We can do nothing for the patients but pray. The Israeli military said it was

carrying out a "precise and targeted operation against Hamas in a specified area in the Shifa Hospital." It said it warned 'relevant authorities in Gaza' that all military activities within the hospital must cease. "Unfortunately, it did not." Israel says Hamas has a massive

beneath Shifa, but has not provided visual evidence, while Hamas and the hospital staff have repeatedly denied the allegations. Hours before the raid the United States said it had its own intelligence suggesting Hamas used Shifa and other hospitals, and tunnels beneath them, to support military operations and hold hostages. The military said the forces

raiding Shifa have medical teams and are searching for hostages as part of the opera-tion. Israeli forces also claimed control of several key buildings and a downtown neighborhood in Gaza City. Most of the hundreds of thou-

sands of people living in Gaza City and surrounding areas have fled after weeks of Israeli bombardments.

Hardly any aid has been delivered to the the north, which has been without power or running water for weeks.

37 passengers killed, 19 injured as bus falls into gorge in J&K

At least 37 passengers were killed and 19 oth-ers were injured when a private bus skidded off the road and rolled down into a 300-foot gorge in Jammu and Kashmir's Doda district on Wednesday. According to a police spokesman the ill-fated bus bearing registration No. JK02CN6555 met with an accident at around 11:50 a.m. at Trungal Assar in Doda. The rescue operations were carried out by the locals along with the teams of the SDRF and local

Several close relatives of the deceased passengers also arrived at the accident site to identify their loved ones.

The bus was on its way from Kishtwar to Jammu, Over 50 passengers were traveling on board at the time of the acci-

Out of 19, four critically injured passengers including two children were airlifted to Jammu



Medical College Hospital. Government Medical College hospital Superintendent Narinder Bhatial said, four injured passengers were shifted to ICU soon after their arrival via chopper from the Doda district.

Deputy Commissioner Doda, Harvinder Singh told reporters in Doda, that a very sad incident has happened in our dis-

trict. A bus in which 56 people were traveling met with an accident. There have been 37 casualties till now, and 19 are injured... Most of the bodies have been identified... We have checked all the things about the vehicle, its insurance, and service life. The driver is also dead, so there might be a chance that

the vehicle was not being dri-

year that after 2024 general elections there will be no TMC left in Bengal because after that the whole party will fall like a house of cards," the senior State leader said. Incidentally the BJP has about

71 MLAs in Bengal Assembly and needs about 77 MLAs to reach the magic figure in the

294-member House.
Though the leader refuse to see any connection between the Agencies acting against the so-called corrupt TMC leaders he emphatically said, "once you form a Government then automatically you will get the majority if you are short by a few seats.

On whether the BJP was already in contact with any targeted TMC MLA he said, "the BJP will not have to go to anyone ... they will come to the BJP after the general elections," adding as well that at least 50 TMC legislators were in touch with the saffron outfit. Referring to the BJP's claims political analyst BN

The BJP's campaign was virtually spearheaded by Prime Minister Narendra Modi who addressed four well-attended rallies for the second phase and targeted Chief Minister Bhupesh Baghel-led government over corruption, particularly the alleged Mahadev betting app scam and recruitment scandal, and

Union ministers Amit Shah, Rajnath Singh and Smriti Irani, BJP president JP Nadda, and Assam CM Himanta Biswa Sarma extensively campaigned for the saffron party, targeting Baghel over the alleged betting app scam and "religious" conversion, and accused the ruling Congress of indulging in appeasement politics.

The paramedic healthcare sector in the country is not only grappling with huge shortage of human resources but also competent professionals as the Union Health Ministry has for the fifth time extended the timeline for the States to constitute the State Allied and Healthcare Councils for six more months, citing ongoing elections and the difficulty in finding adequate experienced players in the specific catego-

In its latest notification issued early this month, the Ministry has clarified that "all the state governments/Union territories shall, as soon as may be but within two year and six months from the date of commencement of the National Commission for Allied and Healthcare Professions Act, 2021 constitute State Allied and Healthcare Councils".

In fact, the Centre's plans to set up the Councils in the States have failed to see the light of the since passage of the National Commission for Allied and Healthcare Professions Act, 2021. The Council for allied and healthcare professionals aims to establish a robust regulatory framework, which will play the role of a standard setter and regulator for allied healthcare, and professionals in the country.

Heat-related deaths likely to spike fivefold by 2050: Report

By mid-century ie 2050, the yearly heat-related deaths are likely to increase nearly fivefold the current numbers with people over 65 years old at higher risk if business as usual continues and there is no substantial progress on adaptation, a report of the Lancet Countdown on Health and Climate Change has warned. Heatwaves alone could lead to 524.9 million additional people

experiencing mod severe food insecurity by 2041-60, aggravating the global risk of malnutrition while there is an increased spread of life-threatening infectious diseases, with the length of coastline suitable for Vibrio pathogens expanding by 17-25 per cent, and the transmission potential for dengue increasing by 36-37 per

Vibrio pathogens are responsible for food-borne diseases such as cholera. With 1,337 tonnes of CO2 emitted every second, each moment of delay worsens the risks to people's health and survival, it said adding that the projections are an indication of what the future looks like because as "risks rise, so will the costs and challenges of adaptation."

The report has been prepared on the basis of the expertise of 114 scientists and health practitioners from 52 research institutions and UN agencies worldwide.

The report said that this was "substantially higher than the 38 per cent increase that would have been expected had temperatures not changed".

Despite such instances, the 2023 report found that the world is "often moving in the wrong direction", even as the 2022 Lancet Countdown report highlighted an "opportunity to accelerate the transition away

from health-harming fossil fuels in response to the global ener-

gy crisis".

of the world's 20 largest oil and gas companies will result in emissions surpassing levels consistent with the Paris Agreement goals by 173 per cent in 2040, an increase of 61 per cent from 2022, the report predicted.

Meanwhile, global fossil fuel investment increased by 10 per cent in 2022, reaching over \$1 trillion, with oil and gas extractive activities being supported through both private and public financial flows, the report found.

With little progress in transitioning to clean energy, the persistent use and expansion of fossil fuels will ensure an increasingly inequitable future that threatens the lives of billions of people alive today, it said. In this context, the transition to renewables can enable access to decentralised clean energy, which could help avoid deaths due to exposure to dirty-fuelderived, outdoor, airborne, fine particulate matter pollution as

Delhi continues to gasp for breath as the air quality in the national Capital following Diwali bash pushed the air quality index (AQI) to the cusp of the deep red "severe" zone. The poisonous haze in thickened on Wednesday with the average air quality index clocked 401 at 4 pm. It was 397 on Tuesday, 358 on Monday, 218 on Sunday, 220 on Saturday, 279 on Friday and 437 on Thursday. Areas such as ITO, RK Puram, Punjabi Bagh, IGI Airport, Dwarka, Rohini and AnandVihar reported the AQI of 427, 422, 432, 404, 416, 421. Neighbouring Ghaziabad (378), Gurugram (297), Greater Noida (338), Noida (360) and Faridabad (390) also recorded very poor air

The main contributors to air pollution in Delhi include vehicular emissions, industrial activities, construction dust, burning of crop residues in neighboring states, and various other sources.

Stubble burning incidents crossed the 30,000 mark in two months in Punjab which reported 2,544 fresh farm fires in the last 24 hours. Of these 2.544 farm fires. Bathinda witnessed maximum such cases at 356, followed by 318



in Moga, 264 in Barnala, 262 in Sangrur, 253 in Ferozepur, and 225 in Faridkot, according to Ludhiana-based Punjab Remote Sensing Centre data. Punjab had reported 67,020 and 45,464 stubble burning incidents in the corresponding period (September 15 to November 15) of 2021 and 2022 respectively.

Atishi inspects underground water reservoir, floodplain project in Palla

Delhi Water Minister Atishi on Wednesday inspected the underground water reservoir and floodplain project in Palla. The Kejriwal government is establishing an 8 MGD MGR that will ensure a water supply of 40 MGD of water daily at its full capacity in

During the inspection, Atishi directed officials to conclude the pending work promptly and initiate the operation of this reservoir. "The Kejriwal government's Palla Floodplain Project has been successful for the fourth consecutive year, resulting in an increase of up to 1.2 meters in the ground water level. Under this project, a pond spread across 26 acres recharged 740 million gallons of groundwater in the fiscal year 2022-23," the govern-

ment said in a statement. "The Palla Floodplain Project

spans 40 acres, featuring a pond on 26 acres designed to collect floodwater, utilized to enhance groundwater levels in Delhi. Under this project, the pond, spread across 26 acres, recharged 740 million gallons of groundwater in the fiscal year 2022-23." The Water Minister added.

Atishi shared that almost every year during the monsoon, the Yamuna River, which flows through the capital, experiences flooding, leading to millions of liters of water flowing from the Yamuna.

"In response, the Kejriwal government initiated the environment-friendly Palla Floodplain Project 4 years ago to collect the excess flood water from the river during the monsoon season, located near the Yamuna River in flood-prone areas. Under this initiative, a pond spanning 26 acres was created to collect floodwater. This water is being utilized to augment the groundwater in the capital," it

The Water Minister said, "To determine the quantity of the rise in groundwater levels, 33 piezometers have also been installed. The primary objective of the Palla Floodplain Project is to accumulate floodwater, allowing the year-round utilization of the stored water to enhance the groundwater level. The successful outcomes of this project demonstrate the rapid recharge of groundwater, affirming its effectiveness. This project will not only benefit Delhi but will also serve as an excellent example for states grappling with drought and water scarcity across the coun-

Project to install 200 tube wells in the Palla flood-prone area, with 60 tube wells already in place, will help alleviate water shortage in various parts of the city.

3 doctors, 1 quack held for involvement in surgeries of 2 patients who died

The Delhi Police on I Wednesday said three doctors and a fake doctor have been arrested for their alleged involvement in the surgeries of two patients who died in a clinic in south Delhi's Greater Kailash.

Police said the three doctors - Neeraj Agarwal, who runs the Agarwal Medical Centre, Jaspreet Singh and Agarwal's wife Pooja -- and former lab-oratory technician Mahender Singh were arrested on Tuesday.

Police said the accused were arrested following complaints received in October.

The attendants of the two patients had alleged that Agarwal and three others were

involved in performing surgeries of vital organs of various patients, without following proper medical procedure. According to the complainants, Agarwal is a physician, but performs surgeries as he possesses fake documents. On October 10, a woman from Sangam Vihar got a complaint filed at the Greater Kailash police station, alleging that on September 19, she took her husband to the Agarwal Medical Centre for the removal of his gallbladder

Before the commencement of the surgery, Agarwal said it will be performed by famous surgeon Jaspreet Singh. But before the surgery, he said Jaspreet Singh could not turn up due to some urgency and

Dr Mahender Singh will per-

The complainant stated that her husband's surgery was performed by Mahender Singh, Neeraj Agarwal and Pooja Agarwal. When the patient was brought out of the operation theatre, he complained of severe pain and was rushed to the Safdarjung Hospital where he was declared "brought dead".

According to Deputy Commissioner of Police (DCP) Chandan Chowdhary, Agarwal would take the help of non-qualified people, including his wife and former laboratory technician Mahender Singh, while performing surgeries and Jaspreet Singh would make fake surgery notes.

Curtains down on high decibel MP poll campaign

A total of 2,533 candidates are in the fray for the 230 Assembly seats in Madhya Pradesh, where the main battle for power is between the ruling BJP and the Opposition Congress. As many as 5,60,60,925 voters 2,88,25,607 males, 2,72,33,945 females and 1,373 third gender

when single phase voting opens from 7 am to 6 pm at 2,049 polling stations in the state. Congress, with 114 seats, emerged as the single largest

party after the 2018 polls and formed the government with the help of BSP, SP and independent MLAs under the leadership of Kamal Nath. However, the Nath regime collapsed in March 2020 after a rebellion by now Union minister Jyotiraditya Scindia and Congress MLAs loyal to him, paving the way for the return of the BJP government headed by Shivraj Singh Chouhan.

His assertions in the keynote address at the 2023 edition of the "Indo-Pacific Regional Dialogue" organised by the Indian Navy came in the backdrop of China's aggressive stance in the Indo-Pacific region.

Dhankhar said Indo-Pacific is faced with an explosive global scenario with many a cliff hanging situations. Calling for freedom for navigation and over-flight in accordance with established international Laws and Conventions, he stressed, "We seek a just global regulatory regime that respects the right over EEZ, for the sustainable and equitable exploita-



tion of marine resources and Sea-bed in high seas.' Mentioning that the world currently faces two serious conflagrations and there is no light visible at the end of tunnel, the Vice President called upon the experts to think out of box to find a solution. Underlining that greed of a

sovereign nation can only be contained if other nations come together, Dhankhar said collaborative security and innovative partnerships seem to be the way forward. "This is the only way out. No country can stand alone, there has to be action in togetherness," he emphasised.

He also said "You cannot negotiate peace from a position of weakness; you have to be strong on all fundamentals."

The Vice President also cautioned that non-state actors are the greatest negative interventions in the global peace efforts. He called for India's fair representation at United Nations Security Council(UNSC).

In his address, Navy chief Admiral R Hari Kumar said "We are traversing through a uncertain future.

The future of global commons hinges on cooperative efforts of

We can accomplish prosperity, security and growth for all, only if we collaborate in the maritime domain. This collaboration must be evolved through mutual understanding of opportunities and challenges. I firmly believe that the world is necessarily a maritime community, and oceans are our common heritage as well as destiny. In this endeavour, all of us have a key role to play." Underlining the importance of the Indo-Pacific, he said the region has some of the world's

most important sea lanes, with trade passing through choke points such as, Malacca Straits, Dondra Head, Gulf of Aden, etc. Further, nine of the ten busiest ports in the World are in the Indo-Pacific.

Additionally, this Region, being the most militarised in the world, further exacerbates the probability of ongoing flict. More than 50 warships of extra-regional forces remain deployed in the Indian Ocean Region for various missions, including for anti-piracy patrol off the Gulf of Aden, and the wider Indo-Pacific also has significant naval presence, the

Navy chief said. Owing to the increased presence of multi-national forces, and differing interpretations of international laws, there is this fear that the Region's 'Global Commons' can change to 'Contested Seas,' he said adding this contestation at sea, can have adverse consequences for security-physical, social as well as economic.

n two separate fire related Lincidents in trains, several passengers had a miraculous escape when a fire broke out in two coaches of the New Delhi-Darbhanga Special Express train near Etawah in Uttar Pradesh on Wednesday evening while three people were injured after firecrackers exploded onboard the Bhagalpur-Jaynagar Intercity Express train in Bihar.

In the fire incident in UP, four people suffered minor injuries. The fire broke out in two coaches of a passenger train headed to Darbhanga (in Bihar) from Delhi. Delayed cord clamping is now recommended routine practice for babies born at full term. However, whilst previous research showed potential benefit for premature babies,

studies found delayed clamping of the umbilical cord, clamped 30 seconds or more after birth, likely reduced the risk of death in premature babies by a third compared to those whose umbilical cord was clamped immediately after birth.

Naini Jail to get relief from burden of prisoners

Naini Central Jail is going to get relief from the burden of prisoners. The construction of the district jail has been completed by the Yogi government in this Naini area at a cost of Rs? 173 crore. The prisoners will be shifted from December.

The district jail built in Naini area will have more capacity of prisoners than all the district jails of Uttar Pradesh. This district jail, which has the capacity of 2,800 prisoners, is being constructed by Uttar Pradesh Government Construction Corporation Limited.

According to RS Rizvi, project manager of the organisation, this district jail has been built in an area of 65 acres. Two circles, 18 barracks, two quarantine cells, one women's barrack and one juvenile barrack have been constructed in the jail. The barracks have been given a two-storey shape. There are also two high security barracks in this district jail, in which 12 prisoners can be

also be the jail with most hitech facilities and security in the state. A sewage treatment plant has also been completed inside the jail.

Rizvi said a crèche has also in been built for the children of female prisoners. The entire district jail complex will be under surveillance system and CCTV surveillance.

The Central Jail Naini has the capacity to accommodate 2,060 prisoners. At present 4,596 prisoners and inmates are lodged in this jail. In view of the problems being faced due to the presence of prisoners and inmates in excess of the prescribed capacity, the need for construction of a new jail was felt as an alternative which the Yogi government has completed with the construction of the district jail.

Currently only undertrial risoners will be kept in District Jail Prayagraj whose number in Central Naini Jail is 2,870. Two deputy jailers, 26 constables etc have been deployed in the district jail. Tears of Gaza

The escalating humanitarian crisis calls for immediate and effective global intervention

he humanitarian emergency in Gaza is getting scarier by the hour as Israeli forces stand around Shifa Hospital, occasionally using their arsenal and exacerbating an already grim scenario. Reports of people dying inside the hospital compound — people dying inside a hospital where they are supposed to be nursed back to health, mind you! — have rung alarm bells, calling for immediate international intervention. Shifa Hospital, the biggest medical facility in Gaza, has become a focal point in the ongoing conflict. The presence of Israeli forces at its gates has heightened tensions and created a sense of desperation among civilians seeking refuge and medical assistance there. Even under international humanitarian law, any threat or attack on a healthcare institute raises serious ethical concerns. The siege has disrupted the hospital's functioning, preventing medics from providing assistance to those in need. This situation highlights the severe consequences of the conflict on the civil-



ian population, particularly on the most vulnerable, such as the sick, elderly and the injured. A documentary film, 'Tears of Gaza', was made by Norwegian director Vibeke Løkkeberg in 2010. At the time, the film came as an eye-opener on the atrocities faced by Palestinians in Israel-ruled Gaza since 1967. If that film were to be remade, it would be rechristened 'Tears of Blood in Gaza' as all hope has abandoned Gaza, where residents have been left out in the cold to stare at imminent death. Even the UN stands as a mute spectator of the genocide, which is nothing less than a crime against humanity. The situation has been complicated by the shock-

ing statement of Jerusalem Affairs and Heritage Minister Amichai Eliyahu, who has suggested that Gaza should be subjected to nuclear force. It is not only a morally reprehensible statement but also escalates a volatile situation, raising concerns about the potential for further violence. The Minister's statement has rightly drawn widespread condemnation, including calls for accountability and a revaluation of the international community's role in mediating the conflict. The world must respond promptly to the deteriorating situation in Gaza. Diplomatic efforts should be intensified to bring about an immediate ceasefire and facilitate humanitarian access to the affected areas. Humanitarian organisations must be allowed to operate freely, providing essential aid and medical care to the civilian population. The inflammatory rhetoric by Government members underscores the urgent need for de-escalation of armed conflict and diplomacy boost. International community, including organisations like the United Nations, must work towards securing immediate ceasefire and withdrawal of the Israeli army from the Gaza Strip as, by the army's own accord, the Hamas has been decimated which means there is no longer any rationale to carry on with its armed campaign.

Need to teach the country management



Not a single institute in the country teaches the art and science of managing a nation. Time we have specialised institutes for the country management


pproximately, there are A 4,000 management insutu-tions across the country, specialising in finance, human resources, modern communication, marketing, etc. Yet, not a single institution teaches management of the country. National management should have been considered the most important, affecting every citizen.

Management science emerged about a century ago, during World War I when German army officers analysed their army's efficiency. One study revealed an important fact—there were four non-combatants operational for one frontline soldier. In contrast, the British frontline fighting soldier had ten non-combatant personnel supporting him. Organisationally, the Imperial German Army was two-and-ahalf times more efficient than its British counterpart.

Other militaries also carried out similar studies, from which the phrase "tooth-to-tail ratio" was born; the teeth being the fighting soldier. Later, this entered the commercial world where employees were divided into revenueearning staff and others with general tasks.

Business management schools began taking off, especially after World War II, proliferating in the 1970s into hospitals, hotels, colleges and schools. Teachers became headmasters, professors became principals and doctors became superintendents. Jaslok Hospital in Mumbai was the first medical institution to be planned according to management prin-


For a long, administration was conflated with execution and/or management, with little realisation that the former's focus is discipline, whereas the latter's is result(s). This lack of awareness has brought down many countries' economies. More countries are mismanaged than managed properly. Bharat too was unaware, until 2014 that it had to be managed—call it governed—and not merely administered. India's first Prime Minister Jawaharlal Nehru deserves credit for being conscious of planning. He did not wait for the first parliament to be elected and established the Multinationals and non-resi-Planning Commission by a cab-



Bharat was governed better than countries in our immediate neighbourhood; most are on the verge of bankruptcy. China's example is unique. Its growth and development on the morrow of Mao Zedong's passing away have been undoubtedly phenomenal. His successor Deng Xiaoping's tenure was outstanding by any measure, but somewhere down the years, the exertions of the regime in Beijing violated a fundamental management principle. No economy should produce anything indefinitely unless there is a market. Ćhina believed its economy could grow by pegging its fortunes on the real estate industry. Its regime began with roads and airports and ended with residential apartments.

This building spree increased the need for cement, steel, bricks and other goods, also employing a large number of people as workers. Real estate became an engine of rapid growth and was pursued with gusto. Exports were built up with the growth of apparent financial surpluses.

Some national assets were exchanged in return for hard dents jumped onto this band-



wagon. Money was borrowed

through banks, through deficit

standing economics. They took no note of the fact that neither wing of their country, east or west, had much industry. During the Ayub Khan regime, Pakistan had some 22 elite and rich families who could supposedly propel the country's economy. Foreign aid into Pakistan began flowing and imports were liberal, making

indigenous manufacturing unnecessary. By 2016, aid from the USA virtually dried up and the generals did not know where to look for aid, except China. Beijing demands interest plus guarantees, including forfeiture of territory in the event of non-repayment.

Sri Lanka's story is different,

fundamental rules making the country suffer. Myanmar has been under military rule since 1958. Bangladesh has an inherently weak economy, while Nepal is yet to experience full development. Bharat has today been the best government since its independence. Before we conclude, we should draw readers' attention to the USA, a systemic rather than managerial success. Its constitution has given the country a unique structure with a separation of legislative, executive and judicial powers such that, within reasonable limits, no matter the quality of the individual governor(s), the country has

Electrification of last-mile mobility and logistics



A beginning can be made by providing gig workers with EVs. The Govt must support them and acknowledge their contribution to the economy

¬he electrification of mobility has been one of the most dominating themes of any strategic planning aimed at environmental protection and combating climate change. Yesterday, the Government of Delhi announced in principle clearance for the Delhi Motor Vehicle Aggregator and Delivery Service Provider Scheme that aims at 100% conversion of all bike taxis and electric bikes/2-wheelers deployed in last-mile delivery services to electric vehicles.

India's EV transition There are close to 9 million formal gig workers in India (2022 data), and Niti Aayog predicts that this number will rise to 23.5 million by 2030. A rising number of people eligible to work, and lack of employment opportunities for people in the corporate world as well as considerations such as lifestyle choices, work-life balance, flexible work hours etc are leading to a surge in the gig workforce in India. These are the people who constitute the extensive last-mile delivery community for large e-commerce providers such as Amazon,



Swiggy etc. Every day millions of packages are delivered by these personnel across almost every part of the country. Whether it is a package to deliver to a customer, food to deliver, medicines, or even sending a gift to a loved one in another part of the town, or providing a bike ride home to someone, these last mile logistics warriors play a multitude of roles for the service providers and consumers

It is the reliance on these gig drivers that has enabled ecommerce and food delivery platforms to build their business models. Since they are informal, and contractual hires, most of the gig drivers don't have regular employee privileges such as fixed salaries, medical benefits, and Flipkart, and food deliv- Provident Fund, paid leaves essentially be driving millions

and insurance etc. In most cases, they are the owners of the bikes they use for the delivery work and get paid for fuel and effort as per the company's terms and conditions. Essentially, they run the growth of these businesses, but they are the least protected, and the first to be exposed if the company decides to cut operational costs, or the authorities take restrictive positions such as banning bike-taxis in Delhi and Bengaluru etc.

Caring for the drivers The majority of the millions of gig workers operating in the bike taxi and last-mile delivery segments have purchased the vehicles out of their own pockets or by taking vehicle loans. They need to pay EMIs, pay for fuel, and then hopefully make enough money to earn a good living for themselves and their families. In such a scenario, the ongoing bike-taxi ban and the proposal to compulsorily convert all these vehicles to EVs can cause a major concern for the millions of existing and upcoming gig drivers. Environmental benefits notwithstanding, we could

of gig workers out of their only source of employment if they are forced to pay up for acquiring EVs at a time when they are already paying EMIs for their existing vehicles that they can't even use for work. Companies like Amazon, Swiggy, Zomato, Flipkart, Uber, Ola and others need to bring the gig workers under the coverage of certain employment benefits such as health and life insurance, and easy lending/financing for the EVs they are asked to pur-

When the gig workers are assured of getting steady incomes, and freed from the burden of paying higher EMIs, they will find it more viable to make the switch. The state and central governments also need to acknowledge the contributions and the critical nature of these gig workers. Laws and policies mandating minimum wages, and legal protection of their rights at par with other skilled or unskilled workforces covered under Indian labour laws, must be provided.



Trapped workers still struggling for life



The rescue of life by the search and rescue operation teams as well as the disaster management forces is continuing on the Brahmakhal-Yamunotri National Highway. After the collapse of some 30-meter tunnel parts out of a 270-meter

tunnel, an estimated 40 labourers were trapped in between. Despite multiple alarms from scientific reports that the state of Uttarakhand is ecologically fragile and sensitive to seismic activities caused by tectonic plate movement, the speed of construction had no breaks. Every few months, there have been reports of landslides, earthquakes, flash floods, cloud bursting, and land subsidence and sinking. The Tapovan power project, land sinking in Joshimath, a flash flood in Chamoli district, and now the tunnel disaster on the Brahmakhal-Yamunotri National Highway—all these incidents of loss of life and infrastructure had been recorded in just two years. AI: A double-edged sword we must live with



AI is one of the biggest technical advancements in recent times but it can pose a great danger to humanity by unleashing misinformation and deepfakes

fter its launch last year, the generative AI tool with astoundingly diverse capabilities, the ChatGPT, has taken the world by storm. Despite its immense capabilities to improve our lives and solve humanity's problems, it has made data scientists and governments deeply worried about its potential to create a tsunami of misinformation and an atmosphere of distrust. More ominously, it may endanger democracy itself by its potential to manipulate elections through fake news and false propaganda, making it difficult to distinguish truth from falsehood, and elections in the two largest democracies are due only

In March 2023, a thousand technology leaders warned in an open letter that AI posed a profound, existential threat to humanity that needed immediate regulation. The letter called for a six-month moratorium in developing powerful AI systems and called for a pause in AI development, urging that, "Powerful AI systems should be developed only once we are confident that their effects will be positive and their risks will be manageable." The pause would provide time to introduce "shared safety protocols" for AI systems and governments should step in to institute a moratorium, it added.

Swift government action was a slim possibility, as politicians have very little understanding of AI. However, this time at least some governments have taken the threats rather seriously. On 1st and 2nd November 2023, delegates from 27 governments around the world, as well as the heads of top artificial intelligence companies, gathered for the world's first "AI Safety Summit" at Bletchley Park in the UK, a picturesque venue north of London whose symbolism cannot be missed - it was home to Alan Turing during World War-II where machines devised to decode the Nazis' Enigma Code formed the first blueprints for programmable computers. Among the attendees were delegates from the UN, the USA, China, the EU, and India and tech leaders from OpenAI, Anthropic, Google DeepMind, Microsoft, Meta and XAI.

In 2021, European Union policymakers proposed a law, yet to be passed but designed to regulate AI technologies that might create harm including facial recognition systems, and requiring companies to conduct risk assessments of AI technologies to determine how their applications buid affect nealth, safety and individual rights. In 2022 alone, 37 regulations mentioning AI were passed around the globe; Italy went so far as to ban ChatGPT, but little global coordination was visible otherwise. This time, the conference delegates from different countries agreed to share a common approach to identifying risks and ways to mitigate them. The "Bletchley Declaration" issued on 1st November recognised the short-term and longer-term risks of AI, affirmed the responsibility of the creators of powerful AI systems to ensure that they are safe, and committed to international collaboration on identifying and mitigating the risks.

The proceedings were held in camera, but the British PM said that on 2nd November, the USA, EU and other "like-minded" countries had reached a "landmark agreement" with select cutting-edge AI companies that models should be rigorously assessed before and after they are deployed - an agreement not signed by China, which signed the "Bletchley Declaration" the previous day. The AI companies at the Summit

have agreed to give governments early access to their models to perform safety evaluations. Details are still sketchy, and the only thing we know is that both the UK and the USA would set up permanent bodies called AI Safety institutes to carry out safety evaluations and develop risk assessment guidelines for AI systems. The progress seemed to be limited, but global coordination seen at this level for the first time is a welcome feature to ensure that humanity can come together to counter the threats posed by the unlimited capabilities of AI. At the end of the Summit, the UK

which chaired the Summit, issued a statement summarising the discussions on various objectives. The major objectives of the Summit included developing a shared understanding of the risks posed by frontier Al technologies and the need for concerted action, triggering a process for international collaboration on the safety of frontier AI technologies and development of new standards to support AI-governance.

The consensus emerged on developing common and measurable international standards for safety and on governments' role in testing models, not just pre- and postdeployment, but earlier in the lifecycle of the model, including in training runs of Large Language Models. Delegates also shared the ambition to unlock the significant potential of frontier AI technologies with their potential to transform economies and societies - especially in improving healthcare, education and handling environmental problems inclusively.

Currently, a fragmented and incomplete understanding of frontier AI technologies marks their develop-

ment in different countries. Inclusivity means equitable realisation and distribution of the benefits of AI for all countries and across all groups, including minorities and marginalised ones; failure in this will create extreme inequality with disastrous consequences for the future. To mitigate risks, there is also a need for shared principles and codes and their standardisation.
Some progress has already been achieved in this, like the 2019 OECD Recommendation on AI, and the G7-initiated Hiroshima Process under the presidency of Japan, especially the Hiroshima Process International Guiding Principles and International Code of Conduct for Organisations Developing Advanced AI Systems. However, ensuring AI safety would require the convergence of multiple branches of activity, including skills, talent, and physical infrastructure. These are presently monopolised by advanced countries and tech giants, and without shared benefits and inclusivity, the risks cannot be mitigated. Presently there is a huge concentration of AI power within a handful of companies unwilling to let go of their stranglehold.

Profit-driven companies monopolising AI research are likely to lead to bad outcomes, and there is a raging debate about the open-sourcing of codes to address this problem. There are contrary views on this, with some pointing to the dangers of open-sourced codes in the hands of rogue state and non-state players, while others say that opensourcing of models can accelerate safety research. In regulating AI, there are different approaches followed by different countries which are competing with each other with different objectives. While

the US wants self-regulation by tech companies to promote innovation, the EU wants a risk-based approach. For China, socialist values, meaning political control, remain at the forefront of regulation. The EU's General Data Protection Regulation (GDPR), effective from 2018, focuses on the privacy of personal data, and how that data can be used by AI systems. The Digital Markets Act, which has also passed, focuses on competition and will target the largest cloud players, which are essential for AI systems. US regulation is focused primarily on containing China.

Given the breakneck speed at which AI is evolving, there is also the question of what to regulate. Tech firms want only a narrow regulation, limiting scrutiny to the most powerful frontier models.

Microsoft is calling for a licensing

regime requiring firms to register models that exceed certain performance thresholds. Some are advocating controlling the sale of powerful chips used to train the LLMs. The best option, as suggested by many experts, is to create a new global, neutral, non-profit international regulatory agency like the Intergovernmental Panel on Climate Change (IPCC) with adequate regulatory authority to guide, coordinate and control the development of frontier AI technologies with mandatory safety standards. Such a body must be represented by all governments with equal voting powers. That would mean involving all stakeholders, and the biggest obstacle to this would be the advanced countries and their tech companies which can make unlimited profits only so long as the others remain excluded from the cutting-edge AI technologies.

Tough issues loom over Biden, Xi meeting

Presidents Joe Biden and Xi Jinping head into their big meeting at a country estate on Wednesday hoping to stabilise US-China relations after a period of tumult, but the US president also is prepared to confront his counterpart on difficult issues such as trade, Beijing's burgeoning relationship with Iran and human rights con-

The two leaders, who will meet on the sidelines of a summit of Asian-Pacific leaders, last spoke a year ago. Since then, already fraught ties between the two economic superpowers have been further strained by the US downing of a Chinese spy balloon that had traversed the continental US and over differences on the self-ruled island of Taiwan, China's hacking of a Biden official's emails and other inci-

California for the annual Asia-Pacific Economic Cooperation forum, but will hold their oneon-one talks at Filoli Estate, a country house and museum about 25 miles (40 kilometers) south of San Francisco, according to three senior administration officials. The officials requested anonymity to discuss the location, which had not yet been confirmed by the White House or the Chinese government due to tight security.

Both men are seeking to show the world that while the US and China are economic competitors, they are not locked in a winner-take-all faceoff with global implications. Their relationship has been increasingly defined by differences over export controls, Taiwan and the conflicts in the Middle East and Europe.

Biden is expected to let Xi know that he would like China to use its sway over Iran to

that could lead to expansion of the Israel-Hamas war. The Biden administration also sees the Chinese, a big buyer of Iranian oil, as having considerable leverage with Iran, which is a major backer of Hamas.

Biden on Tuesday billed the meeting as a chance to get Washington and Beijing back "on a normal course corresponding" once again. But White House National

Council spokesman John Kirby said Biden was "not going to be afraid to confront where confrontation is needed on issues where we don't see eye to eye."

"We're also not going to be afraid, nor should we be afraid, as a confident nation, to engage in diplomacy on ways which we can cooperate with China - on climate change, for instance, and clean energy technology," Kirby said.

Biden will be focused on managing the countries' increasingly fierce economic lines of communication to prevent misunderstandings that could lead to direct conflict between the two powers.

While he's expected to defend US expansion of export controls on semiconductor chips, he also will assure Xi that the US is not trying to wage economic war with Beijing amid continuing signs that China's economy is struggling to recover from the disruptions of the pandemic.

Xi, meanwhile, is looking for assurances from Biden that the US will not support Taiwan independence, start a new cold war or suppress China's economic growth. He's also keen to show the U.S. that China is still a good place to invest. Even before their meeting,

there were some signs of a thaw: The State Department on Tuesday announced that the US and China — two of the world's biggest polluters had agreed to pursue efforts to ity globally by 2030, through wind, solar and other renew-

There was also hope for some concrete agreements to come out of the meeting Wednesday, including on reestablishing military-to-military communications that have largely gone dark since August 2022, and on efforts to curb illicit fentanyl, a synthetic opioid that is increasingly responsible for US drug overdoses. Many of the chemicals used to manufacture the drug come from China.

The APEC summit events already have attracted considerable demonstrations and more were expected Wednesday, including protests against Xi and against multinational corporations focused

Monetary Fund recently cut growth forecasts for China, predicting economic growth of 5% this year and 4.2% in 2024, down slightly from previous forecasts. Last month, Beijing released economic data that showed prices falling due to slack demand from consumers and businesses.

Biden, meanwhile, has taken pride in proving wrong a large swath of economists who predicted that millions of layoffs and a recession might be

needed to bring down inflation. The Labor Department said Tuesday that consumer prices rose at an annual pace of 3.2% annually, down from a June 2022 peak of 9.1%. Meanwhile, employers keep hiring and the unemployment rate has held below 4% for nearly two years.

Xi, after his meeting with Biden on Wednesday, will address American business executives at a \$2,000-per-plate dinner that will be a rare opportunity for U.S. business leaders to hear directly from the Chinese leader as they seek clarification on Beijing's expanding security rules that may choke foreign investment.

Foreign companies operating in China say tensions with Washington over technology, trade and other issues and uncertainty over Chinese policies are damaging the business environment and causing some to reassess their plans for investing in the giant market.

A senior Biden adminis-

reporters ahead of the meeting said one big reason why Xi decided to make the trip to the US was to send the message to American CEOs that China was still a good place to invest. The official spoke on the condition of anonymity under ground rules set by the White

asylum claims would be processed and, if successful, they would stay.

Britain's government argues that the Rwanda poliwill deter people from risking their lives crossing one of the world's busiest shipping lanes, and will break the business model of peoplesmuggling gangs. No one has yet been sent to the country as the plan was challenged in the courts.

Secretary of State Antony Blinken signed the 120-day waiver extension and it was transmitted to Congress on Tuesday, US officials said.

The move is likely to draw criticism from Iran hawks on Capitol Hill and elsewhere who believe the extension will reward Iran at a time when it is coming under increasing pressure to end its support for proxy groups, including Hamas, that are destabilising the Middle East.

There is roughly USD 10 billion in Iraqi payments for Iranian electricity currently being held in escrow accounts in Iraq, and the waiver will allow Baghdad to maintain its energy imports without fear of US penalties for violating sanctions on Iran. It will also keep in place a provision — included in the last 120-day waiver — under which portions of the electricity proceeds can be transferred to accounts in Oman and then converted to euros or other widely traded currencies for Iran to buy non-sanctioned products.

The officials, who spoke on condition of anonymity to discuss the decision-making process, said Blinken signed the waiver mainly because the administration doesn't want to cut Iraq off from a critical

source of energy.
But, they said the administration is confident Iran will not be able to use any of the money for nefarious purposes. They said a rigorous vetting process is in place to ensure that the cash can only be used for food, medicine, medical equipment, and agricultural goods.

Blinken visited Baghdad on November 5 and met with Iraqi Prime Minister Mohammed Shia al-Sudani during the course of a Middle East trip focused on the Israel-Hamas war and efforts to prevent it from spreading into a broader regional conflict.

China leads list of labour abusers

Hazardous, forced work conditions sometimes akin to slavery have been detected on nearly 500 industrial fishing vessels around the world, but identifying those responsible for abuses at sea is hampered by a lack of transparency and regulatory oversight, a new report concluded.

The research by the Financial Transparency Coalition, a Washington, DCbased nonprofit organisation that tracks illicit money flows, is the most comprehensive attempt to date to identify the companies operating vessels where tens of thousands of workers every year are estimated to be trapped in unsafe conditions.

The report, published Wednesday, found that a quarter of vessels suspected of abusing workers are flagged to China, whose distant water fleet dominates fishing on the high seas, traditionally lawless areas beyond the jurisdiction of any single country. Vessels from

Russia, Spain, Thailand, Taiwan and South Korea were also accused of mistreatment of fish-

Forced labour in the seafood industry is a rarely seen but common phenomenon, one increasingly recognised as a widespread human rights crisis," according to the report's authors. The Associated Press in 2015 uncovered the plight of thousands of migrant workers from Myanmar, Čambodia and Laos who were abused while employed on Thai vessels whose catch often ended up in the United States.

Globally, as many as 128,000 fishers face threats of violence, debt bondage, excessive overtime and other conditions indicative of forced labour, according to the UN's International Labour Organisation.

The current draft under negotiation would demand "immediate extended humanitarian pauses" throughout the Gaza Strip to provide civilians with desperately needed aid. It also would demand that "all parties" comply with international humanitarian law that requires protection for civilians, calls for special protections for children, and bans hostage-tak-

But the draft, proposed by council member Malta and obtained Tuesday by The Associated Press, makes no mention of a ceasefire. It also doesn't refer to Hamas' surprise attack on Israel on Oct. 7 that killed around 1,200 people and took some 240 others hostage. Nor does it cite Israel's retaliatory airstrikes and ground offensive in Hamas-ruled Gaza that the Gaza health ministry says has killed more than 11,000 Palestinians, two-thirds of them women and children.

St Petersburg (AP): A woman went on trial Wednesday in the bombing at a St. Petersburg cafe that killed a prominent Russian military blogger after he was given a bust of himself that later exploded. Darya Trepova, 26, is charged with carrying out a terrorist attack, illegal trafficking of explosive devices and forging documents in the April 2 blast at the cafe in which

Vladlen Tatarsky was killed and 52 others were injured.

She was arrested shortly after the bombing and faces up to 30 years in prison if convicted, according to Russian news reports.

Tatarsky, 40, was an ardent supporter of the Kremlin's military action in Ukraine and filed regular reports on the fighting from the front lines.

Imran completes 100 days in jail, party urges release, justice

s Pakistan's former prime Aminister Imran Khan completes 100 days in jail, his party on Wednesday urged the Supreme Court to ensure his immediate release and stop the trampling of the Constitution by the state.

"From being shot in an assassination attempt to his house being attacked, vandalised, tear gassed & now illegally incarcerated in a small cell while being denied access to justice, Imran Khan has stood on his principles and remained true to every word and claim of his," the Pakistan Tehreek-e-Insaf (PTI) party

Khan, 71, has been in the Adiala Jail, Rawalpindi after he was shifted there on September 26 from the District Jail Attock where he was taken after his arrest on August 5 following his conviction in the Toshakhana corruption case.

His close aide and former foreign minister Shah Mahmood Qureshi, 67, arrested in the cipher case, is impris-

oned in the same jail. Khan and Qureshi have pleaded not guilty to the charges.
"History will remember

Khan for standing on the right side when it mattered, along with over 10,000 other prisoners of conscience, and those who sacrificed their lives for Pakistan's Haqeeqi Azadi (real freedom)," the PTI statement

The PTI said Khan is being punished for sticking to his principles and due to his uncompromising nature and firm stance to restore the sanctity of the Constitution and uphold the supremacy of the rule of law in the country.

It demanded the immecricketer-turned-politician and said the process to crush Khan's party using state power should be abandoned immediately.

'The state had been trampling the Constitution, law and values under its feet for the last 20 months to break Khan's morale. He is being subjected to the worst cruelty, brutality and bullying, but all the tactics

Thunberg on Wednesday denied a public order offence after she was arrested last month at a demonstration against a major oil and gas industry conference in London. The 20-year-old Swedish

environmental campaigner was among more than two dozen people charged after protesters sought to block access to the luxury InterContinental Hotel in central London during last month's Energy Intelligence Forum, attended by some of the industry's top executives.

Thunberg was charged with breaching a section of the Public Order Act that allows police to impose limits on public assemblies. She and four other Fossil Free London protesters pleaded not guilty at Westminster Magistrates' Court on Wednesday.

Thunberg confirmed her details in court, but her address in Stockholm was not read out due to concerns over alleged threats she has received.

The protesters were granted unconditional bail ahead of a trial in London scheduled for February 2024.

The court hearing drew crowds of photographers and protesters from groups includ-



ing Greenpeace, who gathered outside the building chanting and holding banners reading "Oily Money Out" and "Make Polluters Pay." Thunberg and other cli-

mate protesters accuse fossil fuel companies of deliberately slowing the global energy transition to renewables in order to make more profit. They also oppose the British government's recent approval of drilling for oil in the North Sea, off the Scottish coast.

Thunberg inspired a global youth movement demanding stronger efforts to fight climate change after staging weekly protests outside the Swedish Parliament starting in 2018.

In July she was fined by a Swedish court for disobeying police and blocking traffic during an environmental protest at an oil facility. She had already been fined for the same offense previously in Sweden.

Commerce Ministry expects to issue 20,000 status holder certificates to exporters this year: DGFT

The Commerce Ministry, I which automated the process for issuance of exporter status certificates, is expected to issue about 20,000 such documents by the end of this year, a senior official said on

Wednesday. Director General of Foreign Trade (DGFT) Santosh Kumar Sarangi said this would be a big jump in the issuance of these certificates, and so far, they have issued over 40,200 statusholder certificates.

"There are another 2,000 applications, which are under scrutiny because of their prior history. But ultimately, those will

also get issued, and by the end of this year, we expect about 20,000 status holders to be recognised through this automated process," he told reporters here.

Last month, DGFT said that an exporter status certificate will now be issued based on the available electronic data, and traders will not have to apply to get the recognition.

These certificates provide certain privileges, including simplified procedures under foreign trade policy (FTP), priority custom clearances on a self-declaration basis, and exemption from compulsory negotiation of documents through banks and filing bank



guarantees for FTP schemes. Upon achieving prescribed export performance, status recognition as one, two, three, four and five-star export houses is accorded to the eligible applicants as per their export performance.

Sarangi said applications of exporters in the 'risk' category will be subjected to larger scrutiny. Exporters who default in fulfilling their export obligations are categorised as "risky' Now, the exporters are not required to apply to the office of the Directorate General of Foreign Trade (DGFT) for a Status Certificate, and the export recognition will be provided by the IT system based

on available Directorate General of Commercial Intelligence and Statistics (DGCIS) merchandise export electronic data and other risk parameters. Earlier, the exporters had to file

an online application along with an export certificate from a chartered accountant for a grant of status. The DGFT Regional Offices

are supposed to issue the certificate in three days.

Under the new arrangement no applications are invited from exporters, and the certification is granted every year in August based on annual export figures available with the partner government agency -

Exporters, who are eligible for a higher status based on additional export data relating to services export, deemed exports or double weightage to some entities like MSME, which is not getting captured in disaggregated form presently, can apply online for a status modification also at a later

The biggest increase in status certification is seen in the 1 Star category, which is the lowest category and requires an export performance of at least USD 3 million in the last three preceding financial years plus the three months of the current financial year.



ONGC to invest ₹1 lakh cr to set up 2 petrochemical plants

PTI NEW DELHI

India's top oil and gas producer ONGC plans to invest about Rs 1 lakh crore in setting up two petrochemical plants to convert crude oil directly into high-value chemical products as it prepares for energy transition, top company officials said on Wednesday.

ONGC pump out from below seabed and underground reservoirs, is a primary source of energy.

It is processed in oil refineries to produce petrol, diesel and jet fuel. With the world looking to transition away from fossil fuels, companies around the globe are looking at new avenues to use crude oil.

Petrochemicals are chemical products derived from crude oil and used in the manufacturing of detergents, fibres (polyester, nylon, acrylic etc.), polythene and other man-made plastics. At an investor call on the company's second-quarter earnings, Oil and Natural Gas Corporation (ONGC) Director (Finance) Pomila Jaspal said the firm is looking to build separate oil-to-chemical (O2C) projects. She, however, did not give

details. "We have plans to invest Rs 10,000 crore by 2028 or 2030 in two projects in two separate



states," said D Adhikari, Executive Director and Chief of Joint Ventures & Business Development, ONGC, on the investor call.

"Our plan is to raise petrochemical capacity to 8.5-9 million tonnes by 2030."

One project is likely to be set up by ONGC on its own and the other in a joint venture. The details were not shared in the

Demand for petrochemicals, the building blocks for plastics, fertilisers and pharmaceuticals, is projected to remain strong due to their wide range of uses across large industries, including construction, automotive and electronics. Strengthening its chemicals business will also help the state-run oil explorer

cut its reliance on the volatile oil market and improve profitability in the long run. ONGC already has two sub-

sidiaries -- Mangalore Refinery

and Petrochemicals Limited (MRPL) and ONGC Petro-Additions Limited (OPaL) that run petrochemical units at Mangalore in Karnataka and Dahej in Gujarat, respectively. While MRPL is a profit-making entity, OPaL has a "distorted" capital structure, Adhikari said. To correct this, the ONGC board has approved infusing Rs 18,355 crore capital in OPaL to raise its stake in the firm to over 96 per cent from the current 49.35 per cent, he said.

The Koreans and Asia's five other 2022 World Cup participants start their qualification campaigns to appear at the 2026 tournament on Thursday. None of the continental heavyweights are taking this stage lightly, with European-based stars such as Son, Kaoru Mitoma and Mehdi Taremi picked for their national teams to take on some of the conti-

nent's lower-ranked rivals. South Korea kicks off against Singapore in Seoul with Tottenham star Son and Wolves forward Hwang Hee-chan leading the attack. Both have been in excellent form in

the Premier League. Klinsmann is ready to play his strongest team, despite the fact Singapore is ranked No. 155, as he begins a bid for South Korea to qualify for an 11th successive World Cup.

"You have to take them very seriously," Klinsmann, who was appointed in February, told a news conference in Seoul. "Your mind has to be in the right place. We have to be very sharp from the first moment'

That's an approach that the Saudi Arabia and Qatar are also

The top two from each of the nine four-team groups will progress to the next stage of Asian qualifying, where they'll compete for one of the eight automatic spots at the World Cup -- double the continental quota available in 2022.

Klinsmann dismissed the idea that this makes the road to the 2026 World Cup in the U.S., Mexico and Canada any easi-

"All the teams that fight for a spot in the World Cup will fight even harder now," the former U.S. Coach said. "It will still be very difficult."

Japan has appeared at every World Cup since 1998 and, now ranked No. 18, is Asia's form team with six wins from its last six games, a run that includes a 4-1 win in Germany and a 4-2 win over Turkey. Head coach Hajime Moriyasu wants to use that momentum to get off to a perfect start in Osaka against Myanmar, ranked 140 places below at 158th, and then against Syria five days later on neutral turf We want to take six points

from these two games," Moriyasu, voted Asia's men's coach of the year, said. "We want to win and we want to give a performance that will allow us to build for the future. Australia also reached the knockout stage at the 2022 World Cup, pushing eventual champion Argentina all the way in the second round. BAVUMA CONFIDENT OF ENDING SEMIFINAL JINX

∢emba Bavuma was aware that Australia are not a "Mickey Mouse" team, but the South African captain on Wednesday sounded confident of his side's ability to defeat the five-time champions and end the Proteas' World Cup semifinals

Ahead of the last-four match here on Thursday, history is heavily stacked against the SA who have lost in the semifinals of the showpiece four times, with two of them coming against the Aussies.

"You know, we're not coming up against a Mickey Mouse team. Australia have a lot of experience and confidence in knockout games, so we've got to respect that," Bayuma said. Backed by some powerful batting performances, South Africa have been impressive in the league phase, but Bavuma said the semifinal would be a different ball game.

"I'd hate to say that we deserve to go through because of the way we played our cricket. I don't think that's the way

"But I think from our performances, from the processes that we've followed to get to this point, we'll continue to lean on that and we believe that will take care of the result in itself," he said.

However, that self-belief has not given way to overconfidence.

"A lot of people believe that this could be the year that we see ourselves within the final. As a team, individually we'd like nothing better than that. But we also respect the game of cricket," he said.



Bavuma said there is a sense of calmness in the dressing room unaffected by the adversities of 1992, 1996, 2007 and 2015 when they had endured semifinal heartbreaks.

"I guess they're all important in the semifinals. I think like you say with the way we've performed as a team it's obviously created a lot of positive sentiment but obviously high expectation," he said.

'There's a sense of calmness within the team and obviously the normal level of anxiety that you would expect of going into the game tomorrow. But I think we'll take a lot of confidence with our performances up until this point," he said. Personally, Bavuma was excited to play in a World Cup semifinal.

You want to treat it as just another game. But I guess you're forcing me to acknowledge that occasion. With that opportunity, I know it will mean a lot for the family and people back home.

"So far this tournament that we've played on, I've not seen any issue."

According to the report, a fresh pitch was originally planned for the first semifinal but now it will be played on an "used" surface to assist the home team's spinners, leading to pitch alteration. The report also claimed that if India make the final in

Ahmedabad, a slow pitch is expected at the Narendra Modi Stadium in Motera. As per the ICC's Playing Conditions for the World Cup, the host association is "responsible for the selection and preparation of the pitch" and there is no requirement that a knockout fixture must be played on fresh pitches. Incidentally, the pitch on offer for Thursday's semifinal at the Eden Gardens is also an used surface and hosted the England-Pakistan group phase match.

The only stipulation in their and Outfield Monitoring Process reads: "It is expected that venues that are allocated the responsibility of hosting a match will present the best possible pitch and outfield conditions for that match."

PSL could be moved to UAE or SA due to elections in Pakistan

🖰he Pakistan Super League The Pakistan Super Local De (PSL) next year could be moved to the UAE or South Africa if the PCB doesn't get the government's clearance to host the event in February-March due to general elections in the country.

The Pakistan Cricket Board (PCB) confirmed on Tuesday, after a meeting of the PSL general council here, that it would seek formal advice from the government on finalising the PSL-9 dates because of the general elections slated on February 8.

The PSL is generally held annually between Feb 19-20 and March 20-21. There has been talk in the PCB

that some officials and franchise owners are in favour of the PSL to be held in UAE or South Africa next year to avoid any interruption in the schedule of matches.

The argument being given is that even the BCCI had organised the IPL in South Africa and UAE in emergency situa-



tions, such as the elections in

The early editions of the PSL were held in the UAE because no teams were willing to play in Pakistan due to security con-

But since 2021, the PSL has been held entirely in Pakistan, even during the Covid-19 pan-

lenn Maxwell, whose Uthunderous knock against Afghanistan acquired the status of an epic, is on the mend and is available for the World Cup semifinal against South Africa, Australia skipper Pat Cummins said on Wednesday. Showing incredible will-power, Maxwell had battled severe and multiple cramps in his body to conjure up a magical unbeaten double century to take Australia past the finish line.

Maxwell needed time to recover and had missed Australia's last match against Bangladesh on November 11 in Pune.

"Glenn Maxwell is all clear. He is all good. He was a little bit sore yesterday. We get scans a lot of the time just to make sure that if there is something, we know what we're dealing with and fortunately it came back all okay. So he's fine," Cummins said ahead of the Maxwell took charge and lit up the Wankhede Stadium with his pyrotechnics on November 7


India's Anirban Lahiri will look to end his long title drought when he returns to the BNI Indonesian Masters golf tournament starting here on Thursday.
