

Top terrorist among 2 ultras killed in anti-infiltration operation in Uri

key terrorist launch com-Amander, active across the line of control in Pakistanoccupied Kashmir for over three decades, was among the two terrorists neutralised by the security forces during an antiinfiltration operation 'Kali' in the Uri sector of North Kashmir's Baramulla district, a senior army officer said on Thursday

Meanwhile, another encounter was going on at Samno, D.H. Pora area of Kulgam district till the time of filing the report. In Uri, the slain terrorist commander has been identified as Bashir Ahmad Malik while another killed terrorist was identified as Ahmad Gani

"His neutralization is a major blow dealt by us to the terror infrastructure across the line of control and its sympathizers and supporters," Col Raghav Commanding Officer 8RR told reporters during a press briefing in Baramulla.

Flanked by SP Baramulla, Divya D Col Raghav said, "The joint opera-



tion was launched in the early hours of 15 November on specific intelligence from "own sources and Special Branch, Srinagar, with respect to the likelihood of infiltration of terrorists across Line of Control in Uri sector". "Joint operation parties were deployed, and in the early hours of November 15, our surveillance tracked the movement of terrorists across

The Army Officer said that upon infiltrating, the terrorists were engaged, leading to an exchange of gunfire.

'Following the exchange, a detailed search of the area revealed numerous terrorist casualties, though the exact

areas in PoJ&K, opposite Rajouri in the South," an army official said.

Bashir Ahmad Malik was chiefly responsible for facilitating the infiltration of a number of terrorists who caused the death of many Indian citizens, both security forces personnel as well as civilians.

Referring to the repeated incidents of infiltration in the region Col Raghav said "We have a robust line of control security grid and we are on a high vigil. The Indian Army is well pre-

pared to defeat any such infiltration attempts and we will not let the enemy succeed with his devious designs," he added. He said the weather during the operation was inclement and the area of this operation was treacherous in terms of terrain. Earlier, on October 30, security forces had killed an infiltrator along LoC in north Kashmir's Kupwara district. On October 26, security forces foiled another infiltration bid and neutralised five Lashkar-e-Taiba (LeT) terrorists along the

LoC in the Kupwara district.

Uddhav accuses ECI of practising 'double standards' in implementing model code

Two days after his party flagged the issue of religious plank used by the ruling Bharatiya Janata Party (BJP) in the Madhya Pradesh Assembly polls, Shiv Sena (UBT) president Uddhav Thackeray on Thursday upped the ante by accusing the Election Commission of India (ECI) of practising "double standards" while implementing the model code of conduct for the poll, to favour the BIP to favour the BIP.

Citing how his late Sena supremo Bal Thackeray was disenfranchised in 1995 for six years for his communal speeches in the 1986 State Assembly bypolls, Uddhav demanded to know if the ECI – which had acted against his father for "pro-Hindutva" campaign --had changed its rules in acting those violating the model code of conduct

In his criticism of the ECI, Uddhav said that the ECI had failed to act against Prime Minister Narendra Modi for his appeal to the voters in the recent Karnataka Assembly polls to "say Bajrangbali ki jai while voting".
In the Madhya Pradesh



Assembly polls Union Home Minister Amit Shah had gone to town, promising the voters that if the BJP was voted back to power in Madhya Pradesh it "would take all the voters in the state" free of cost to Ayodhya for darshan at the upcoming Lord Ram temple there,

"Has the ECI changed the rules? Does the ruling BJP know about the changes made by the ECI and we don't?. The Election Commission should clarify whether what happened in 1986 was as per the rules or what is happening today is as per the rules. Then the ECI had concluded that the words used by the late Sena chief were corrupt practice. And my father came to be disenfranchised for six years in 1995," Uddhav said.

"We strongly believe that the model code of conduct has

around). If that is the case, we should know about it.... Giving the BJP a free hit and dismissing us as a hit wicket does not amount to holding free and fair elections," the Shiv Sena (UBT) president said.

Earlier in the day, the Shiv Sena(UBT) shot off a letter to the ECI, alleging that the double standards applied by the Commission were "intriguing" yet "understandable" since it is publicly perceived to be in alignment with the BJP's actions during elections or otherwise.

No end to row over Visva LG slams AAP Govts in Punjab, Delhi for Capital pollution woes

s Delhi's air quality oscil-As Deinis an quant, Salated between the 'very poor' and 'severe' categories throughout the day, Lieutenant Governor Vinai Kumar Saxena came down heavily on the AAP governments in Punjab and Delhi on Thursday, alleging that the former is playing 'truant" on the issue of stubble burning and the latter involved in "over-hyped events" like the odd-even road-rationing scheme, while the national capital is gasping for breath due to alarming levels of air pollution. Saxena also accused the Punjab government of "playing truant".

Setting the stage for a fresh confrontation between the LG's office and the Aam Aadmi Party (AAP) dispensation in Delhi, Saxena asserted that blaming others for the pollution problem will not help and the solution lies within the city itself. As the air quality of Delhi fluctuated between the "very poor" and "severe" categories on because unfavourable meteorological

conditions hindered the dispersion of pollutants, the LG highlighted that the problem can be mitigated by reducing the "dust that our unrepaired roads, unpaved pavements and construction sites cause" and curbing vehicular emissions. He said Delhi can do little to stop crop-residue smoke from other states and added that "blaming others should not be an alibi for gross inaction over the years". "We can do lit-tle to stop crop residue smoke from other states, apart from pleading with them. Despite states, especially Punjab, playing truant, we are, but petitioners for mercy. AQI yet hovers around 400, making the capital gasp," he said in a post on X. Responding to LG's statement,

the AAP government said the Arvind Kejriwal government has taken a slew of measures

over the past several years which has led to a significant improvement in the air quality as was appreciated in the Economic Survey 2022-2023 tabled in the parliament.

Stressing that firecrackers add to the menace, the LG said the most affected in this "gas chamber" are those who commute on roads to earn their daily bread. "The poor and the hapless living in slums and unauthorised colonies whose lungs are frying because they can't afford to sit at home and buy air purifiers.

The real solution to pollution in Delhi lies in Delhi itself. We can mitigate the choking smog by reducing the dust that our unrepaired roads, unpaved pavements and construction sites cause. We can employ effective means to curb our vehicular emissions," he added. "Since the deadly smog in 2016, this has become a recurrent issue subjected to nothing but platitude and

Smog towers not practical solution to curb air pollution: DPCC to NGT

The Delhi Pollution Control Committee (DPCC) has informed the National Green Tribunal (NGT) that smog towers are not a "practical solution" to curb pollution in the national capital mainly due to its enormous cost.

In the report, DPCC's senior scientist Nandita Moitra said the Delhi area, which is 1,483 sq km, may require more than 47229 smog towers costing Rs 11,80,725 crore (approx) plus a recurring cost of about Rs 15 lakh per month for each tower. It has also said that the two smog towers installed at Anand Vihar and Connaught Place have not been effective. The DPCC referred to reports

from the Indian Institutes of Technology (IIT) in Bombav and Delhi to highlight that within a 100-meter radius, a smog tower can only reduce pollution by 17 percent. The matter will be heard next on Given these findings, the com-

mittee has suggested accepting the results of the IIT's studies and using the already erected towers as museums for the dissemination of technical information about the control of air

In case 17% reduction in 100 m radius is to be considered favourable Delhi needs more than 40,000 such towers to cover its geographic area. This cannot be a practical solution and the result of the experiment should be accepted and Smog Tower already erected may be used for dissemination of the technical information about control of air pollution as museum," the DPCC's report said. Reduction of pollution by just 17 per cent within a 100metre radius at a capital cost of Rs 25 crore and a recurring cost of Rs 10 to 15 lakh per month is "not at all justified. It is not

undertaking an operation at the Al-Shifa hospital in Gaza City, Bagchi said the issue is not about one particular facility and that India has always underlined the need for following inter-

"The issue is not about one facility or a specific facility. India has always underlined the need for civilian casualties to be avoided, for humanitarian law to be observed, and to encourage any efforts to provide humanitarian relief to those caught in the conflict," he said.

"We have also, on the larger issue, talked about efforts to de-escalate the situation, deliver humanitarian assistance, our concern at the humanitarian (situation and) increasing civil-



Israel continued its operation at the Al-Shifa hospital in Gaza City on Wednesday night. Israel has been maintaining that the hospital was being used as a base by Hamas.

Hamas killed around 1,400 people in Israel and kidnapped more than 220 others. Around 11,500 people have been killed in Gaza in the Israeli offensive, according to the Hamas-run authorities in Gaza.

There has been mounting criticism of Israel for the death of a large number of civilians including women and children in Gaza in its military

We had also talked about how India had sent 38 tonnes of humanitarian relief materials. We are looking to send more assistance," he said. Bagchi noted that India strongly condemned the attacks by Hamas on Israel. MCC announces 'Special Stray Vacancy Round' for vacant NEET PG 2023 seats

The Medical Counselling Committee (MCC) has announced a 'Special Stray Vacancy Round for the vacant MD/ MS/ Diploma/ MDS Seats of AIQ and State Quota' round for NEET PG Counselling 2023, aiming to fill remaining postgraduate medical seats. As per the schedule, registration for the special counselling will begin from Friday.

The move follows concerns that despite NEET-PG 2023 Cut-off to zero, over 1400 seats for the NEET PG are yet to be filled. According to a statement issued here by the MCC, eligible candidates can apply through the official website, mcc.nic.in. The registration process will close on November 22, with the choice filling and locking period running from November 18 to November 22. Seat allotments will be revealed on November 24, and successful candidates must report to their allocated institutes between November 25 and November 30.

"All the NEET PG 2023 eligible candidates are hereby informed that to prevent wastage of precious medical seats, the Union Health Ministry has decided to conduct the Special Stray Vacancy Round. It is pertinent

to mention that this Special Stray Vacancy Round will be the last round for Postgraduate courses for this academic year i.e 2023," said the MCC in an official notice.

As per the statement, candidates without a seat in either the All India Quota or state quota are eligible, except those who didn't join seats allotted through MCC round-3 onwards while those candidates who fail to join their allotted seat in this round will forfeit their security deposit and be debarred from the NEET exam

the following year. Also, "data of allotted candidates in this round will be shared with states, and candidates allotted seats by MCC won't be allowed admission in state counselling." This round doesn't offer an opportunity for upgrade; candidates who joined in earlier rounds won't have a chance to upgrade their seats, clarified the notice.

In September, the Ministry had reduced to NEET-PG 2023 Cut-off to zero, for candidates to be eligible for counselling across all categories. As per the ministry, reducing the qualifying percentile for NEET PG 2023 to zero aimed to increase the pool of qualifying candidates but not dilute the merit system for admission to PG medical courses.

Trapped Workers Await Miracle India Faces Final

s rescuers continued their Aefforts on the fifth day to rescue 40 workers stranded by debris inside the under-construction Silkyara tunnel in Uttarkashi district of Uttarakhand on Thursday, authorities are also seeking the help of experts from Norway and Thailand who were involved in rescuing the junior football team from a cave in Thailand in 2018

A heavy-duty drilling machine bored through 12 metres of rubble of the collapsed tunnel on the Char Dham route in Uttarakhand on Thursday, raising hopes for the rescue of 40 workers trapped inside for over four days. Officials said in the evening that a six-metre section of a steel pipe had been inserted into the bored passage. Another section was being welded into it.

The plan is to insert 800 mm and 900 mm diameter pipes, one after the other, with the help of the giant drill till an escape passage is created for the workers stranded beyond the collapsed portion of the underconstruction tunnel.

After earlier attempts to drill through the debris failed due to mechanical issues, a more powerful drill, transported by three Indian Air Force aircraft, was assembled at the site and made operational on Thursday. Officials stated that the machine had started drilling, and a nine-metre stretch had been drilled by early evening, with the operation continuing.

Earlier in the day, Union Minister of State for Road Transport and Highways VK Singh visited the site of the mishap to check on the rescue

The authorities are doing their best, Singh said and expressed hope that all the stranded workers will soon be rescued safely. The Union Minister, who also spoke to some of the stranded workers, said that efforts are being made to expedite the rescue operation. The minister said the site where the tunnel is being constructed has been stable for the past four and a half years.

He said experts in the country and abroad have been consulted on the rescue operation.

In Dehradun, Chief Minister Pushkar Singh Dhami said Prime Minister Narendra Modi is constantly monitoring the situation. The Uttarakhand Government has decided to review all under-construction tunnels in the State, he said. 'We need such tunnels and many of them are being built in the state. We will review wherever they are being construct-

The victims might experience panic attacks because of being trapped in closed spaces for long, said Dr Ajay Agarwal, director, Internal Medicine AT

Fortis Hospital in Noida. Officials of the executing agency NHIDCL informed that all the workers stranded in the tunnel have adequate food, oxygen, and drinking water along with electricity supply. All the stranded workers are reported to be in stable condition. The officials hope to rescue the stranded workers at the earliest, but the actual time it will take to complete the rescue operation will depend on how the drilling operation goes. The 4,531-metre-long Silkyara

tunnel, under construction under the Radi Pass area, is to join the Gangotri and Yamunotri axis at a cost of ₹853.79 crore under the ambitious Char Dham project. Officials said that once complete, the tunnel will considerably benefit the pilgrims, providing all-weather connectivity and shortening the distance by 26 kilometres and one hour of travel time through steep, mountainous, and narrow roads prone to accidents and landslides.

Financial, cyber fraud within ambit of organised crime in proposed law

Major financial scams, ponzi schemes, cyber crimes, vehicle theft, land grabbing and contract killing will come under the ambit of organised crime in the proposed new criminal law, and if such offences result in the death of any person, the convict will be punishable with death or imprisonment for life.

The Parliamentary Standing Committee on Home Affairs headed by BJP MP Brijlal observed that the existing laws were inadequate to tackle many serious offences like organised kidnapping, land grabbing, contract killing, extortion as also many major financial scams and human trafficking, and lauded the proposed punish-ments as "very effective addi-

According to clause 9 of the Bharatiya Nyaya Sanhita (BNS), unlawful activity, including kidnapping, robbery, vehicle theft, extortion, land grabbing, contract killing, eco-



nomic offences, cyber crimes having severe consequences, trafficking in people, drugs, illicit goods or services and weapons, human trafficking racket for prostitution or ransom by effort of groups of individuals acting in concert, singly or jointly, either as a member of an organised crime syndicate or on behalf of such syndicate, by use of violence, threat of violence, intimidation, coercion, corruption or related activities or other unlawful means to obtain direct or indirect, material benefit including a financial benefit, shall constitute

It also explains that economic offences include criminal breach of trust; forgery, counterfeiting of currency and valuable securities, financial scams, running ponzi schemes, mass marketing fraud or multi-level marketing schemes with a view to defraud the people at large for obtaining monetary benefits or large scale organised betting in any form, offences of money laundering and hawala transactions. In Section 120A of the Indian

Penal Code, there is no explanation about organised crime.

Ministry of External Affairs(MEA)spokesperson Arindam Bagchi said India is engaged with the Qatari authorities on the matter and that the government will continue to extend all legal and consular assistance to the Indian nationals.

The eight Indians were on October 26 given death sentences by Qatar's Court of

First Instance. India described the ruling as "deeply" shocking and vowed to explore all legal options in the case.

Days later, an appeal was filed against the death sentence.

The case is currently in a legal process there. As we mentioned, an appeal has been filed in Qatar's Court of Appeal. We are also engaged with the Qatari authorities on the matter and we will continue to extend all legal and consular assistance (to them)," Bagchi said. "I would again urge everyone not to engage in speculation considering the sensitive nature of the case," he

The judgement in the entire process has been made confidential by the Qatari side.

"The appeal process is underway and we would hope for a positive outcome," Bagchi said, replying to a question on the matter at his weekly media briefing. He also described as "factually incorrect" some reports that suggested the appeal in the case has been

In its reaction to the ruling by the Qatari court, MEA last month said it is attaching "high importance" to this case

All of the former Navy officers had "unblemished stints" of up to 20 years in the Indian Navy and had held important positions including that of instructors in the force, former military officials had said.

In May Al-Dhara Global closed its operations in Doha and all those working there (primarily Indians) have since returned home.

In the past, the Navy had taken up the case of the former naval personnel with top brass of the government for securing their release.

Though it is not confirmed that the latest meeting discussed the West Asia crisis, the Ukraine war and Palestine conflict are two issues that cannot be brushed under the carpet. To put it in perspective, the US and China have diametrically opposing views on these conflicts but the latest meeting at least opens up a channel for dialogue. Biden and Xi engaged in over four hours of talks, marking their first face-to-face meeting in a year. The leaders aimed to address longstand-



ing issues and set the tone for stabilising strained bilateral ties. The meeting coincided with the annual APEC summit, emphasising the global significance of the discussions. One of the key outcomes was the commitment to restore military-to-military communications between the nations. The leaders agreed to reopen the channels severed following Pelosi's visit to Taiwan in August 2022. This signals a willingness to enhance dialogue and understanding in the military domain.

The discussions also delved into the sensitive issue of Taiwan, with Biden expressing concerns over China's substantial military buildup around the island.

He urged China to respect Taiwan's electoral process, particularly as the island is gearing up for presidential and parliamentary elections in January. Xi, on the other hand, emphasised Taiwan's integral connection to China and called for an end to arms sales to the self-ruled island. Yet another headway was made in the agreement to reopen military contacts which extends beyond high-level dialogues. It opens the door for engagements even at middle levels, allowing for interactions between military officials, including the US Pacific forces commander and his Chinese counterpart; the move is expected to facilitate operational engagements. In a joint effort to combat the opioid crisis, Biden and Xi reached an agreement to cooperate on tackling the source of fentanyl, a highly addictive synthetic opioid responsible for numerous drug overdoses in the US. China will target specific companies producing the chemicals used to manufacture the drug, reinforcing international collaboration on a critical public health issue. Biden raised concerns about the status of US citizens believed to be wrongly detained in China, emphasising the importance of human rights. The leaders engaged in a frank exchange on these issues, and this could herald a new era of openness.

Celebrating Kerala's 67 years of statehood

INDIA-US DIALOGUE FOCUSES ON CONFLICTS

Ample time was dedicated to the various battles raging across geographies

he recently concluded 2+2 dialogue between India and the US, underscores the warmth in the bilateral relations both countries have carefully nurtured in the last decade or so, in a bipartisan manner. It is by no means a coincidence that the dialogue took place, despite the US facing at least two, tough scenarios in Europe and West Asia, even as President Biden met his Chinese

counterpart on the sidelines of the APEC summit this week. The dialogue established beyond doubt that the way forward plan for both countries is a firm reiteration of the role Indo-Pacific players (without China) will have to warm up to.

A joint statement issued post the dialogue read, "The Ministers reaffirmed the importance of a free, open, inclusive and resilient Indo-Pacific and renewed their shared desire to consolidate their dialogue and collaboration through the Quad. They emphasised the important role of the Quad as a force for global good for the peoples of the Indo-Pacific. The Ministers look forward to India hosting the next in-person Quad leaders' Summit in 2024. The Ministers appreciated the ongoing efforts of the I2U2 countries to enhance food and energy security and improve the movement of people and goods across hemispheres. The Ministers also noted that the India-Middle East-Europe Economic Corridor will enhance connectivity between Asia and Europe and will unlock new potential for economic growth in the two continents. They welcomed the relaunch of consultations between the Indian Ministry of External Affairs and the U.S. Department of State on Africa, aimed at exploring potential trilateral cooperation in Africa. They also looked forward to convening the next round of East Asia Consultations between the Indian Ministry of External Affairs and the U.S. Department of State at an early date."



The dialogue dedicated ample time to the various battles raging across geographies, straining fragile multilateral balances, pulling down the financial systems of many developing countries, especially in the global South and pushing deadlines for the crucial conversations on climate change and the shift to cleaner energy. On Ukraine and Israel, it seems, India and the US have come to the same page as the statement read "The ministers expressed mutual deep concern over the war in Ukraine and its tragic humanitarian consequences." They again underscored the growing impacts of this war on the global economic system and food security, with consequences predominantly affecting the global South. Both countries further pledged to continue humanitarian assistance to the people of Ukraine and concurred on the need for post-conflict reconstruction in Ukraine. Noting horrific terrorist attacks against Israel, the Ministers reiterated that India and the United States stand with Israel against terrorism and called for adherence to international humanitarian law, including about the protection of civilians."

Meanwhile, US President Joe Biden met his counterpart Chinese President Xi Jinping, trying to diffuse the frostiness in the US-China relationship. China has chosen its sides on the geo-political chess board. It supports Russia's actions in Ukraine and is backing terrorists in West Asia. It would like to coerce fence-sitters to join its camp, vis a vis the US. India, like the US, faces a tough challenge, being in a democratic set-up, where they have to carefully articulate their foreign policy goals, while not hurting domestic influence groups. Both countries also face a tough electorate next year, as the incumbent federal governments seek re-election. The silver lining is that the business-as-usual attitude in the US India dialogue, signals a bright future for the bilateral relationship.

nder the shadow of violence and injustice, the Palestinian people face a heart-wrenching reality yet again. While Israel's actions are undeniably wrong, the collective assault and destruction inflicted upon Palestine could have been avoided without resorting to such brutal measures. uprisings, failing to comprehend the profound political and economic issues that had ignited them. The uprisings have resulted in a power vacuum in numerous regions of West Asia, which has been filled by extremist groups and authoritarian regimes. The United States' foreign policy in West Asia has been a significant contributor to the region's instability and requires significant rethinking.

In the current landscape, the question arises: What truly matters today? The hatred against Jews isn't about rallying against Israel but urg-ing for Arab unity in times of need. It's not about eliminating Israel but finding a compromise for both sides, granting a chance for those exploited as propaganda tools to live. Attacking Israel doesn't significantly contribute to the Palestinian struggle; while Israel is wrong, it's essential to recognise that they aren't the sole perpetrators. They are paying the price for the actions of older generations now gone. The Palestinian struggle to reclaim

independence has been further hindered by a multitude of internal obstacles, including disunity, corruption, and systemic irregularities. These factors have undoubtedly exacerbated the protracted and complex nature of the conflict, arguably to a greater extent than Israel's preemptive strikes and strategic manoeuvres.

The deeply entrenched disunity among Palestinian factions has been compounded by ideological differences, personal rivalries, and the meddling of neighbouring Arab nations, who have exploited the Palestinian cause to advance their political agendas. The Palestinians have become mere pawns in a game of regional power politics, their aspirations for self-determination sac-

Palestinian institutions fuels the flames of frustration and disillusionment, eroding public trust and legitimacy. Sectarian violence and human rights abuses tarnish the cause and complicate international support, rather than eliciting symbolic sympathy. These internal challenges intertwine with external factors like vested interests of neighbouring Arab countries, creating a labyrinth for the Palestinian people. The crisis in Palestine differs from Ukraine. Palestinians suffer not only from Israel but also from internal divisions and hypocritical Arab nations playing old colonial games. Yet, this is the first time in over 70 years, since the

Within hours of the Hamas attacks, Prime Minister Benjamin Netanyahu initiated a military operation on Gaza, resulting in over a month of emergency. The outcome may see Palestinian land diminishing into Israel. Criticising Israel's responses requires a recall of old political doctrines - a cruel attack doesn't demand a civilised counterattack. The ongoing conflict deepens crisis; the focus should be on resolution. Despite some analysts predicting the West's decline, this crisis presents an opportunity for the West to shift attention away from its ongoing international failures and the protracted conflict in Okraine.

Arab nations with economic power rarely invest in Palestine, offering few employment opportunities. Palestinian leaders compromise unity for power, neglecting plans to uplift the poorest. Have any Palestinian political leaders compromised national unity to secure their power, despite continuing to fight like Kilkenny cats? Undeniably, collective punishment won't solve problems. Killing indiscriminately won't succeed; history proves it wrong. They murdered and buried the innocent, believing them to be truly dead. But in time, they will realise that they were seeds, a truth they never comprehended. Ceasing fire is imperative, but it alone cannot heal the wounds of this conflict. Some time ago, the Reserve Bank of India and the Comptroller and Auditor General of India (CAG) published data in their respective reports about the increasing debt of the states due to freebies and have expressed concern over these freebie schemes and rising debt burden of the states. the target debt-GSDP (gross state domestic product) Ratio, in any state, should not exceed 20 percent. But as per CAG, in most of the states of the country, this ratio is much more than the targeted one. It reached 48.98 per cent in Punjab, 42.37 per cent in Rajasthan, 37.39 per cent in West Bengal, 36.73 per cent in Bihar, 35.30 per cent in Andhra Pradesh, 31.53 per cent in Madhya Pradesh, 27.80 per cent in Telangana, 27.27 per cent in Tamil Nadu and 26.47 per cent in Chhattisgarh. If the debt on state government enterprises and the guarantees given by the state government are also added, then by 2020-21 the debt to GSDP ratio in Rajasthan would be 54.94 per cent and in Punjab, it would be Management (FRBM) Act, 58.21 per cent. Pradesh also it has been estimated at 53.77 per cent, it is 47.89 per cent in Telangana and 47.13 per cent in Madhya Pradesh. When a province spends such a large proportion of its tax revenue on free schemes, not only capital expenditure on infrastructure would go down, due to increasing debt of the state governments, but social services like education and health as well as transport and other essential services will also be impacted. For the development of any state, it is imperative to increase investment in infrastructure. Lack of

infrastructure affects investment and hence the development of the state. Therefore, it is necessary to speed up the development of the country by curbing the free schemes offered by the states.

Impact on ratings Due to increasing debt the economic rating of the country is being impacted. If this continues, our country will not only have difficulty in getting new investments but our companies and government will also have to pay higher rates of interest on borrowing from foreign countries. That is, increasing debt is not only creating fiscal imbalance but is also affecting the ability of state governments to run welfare schemes and is also blocking the path for the development of the country and industry in particular.

Turkey has stalled ratifying Sweden's membership in NATO, accusing the country of being too lenient toward groups that Ankara regards as threats to its security, including Kurdish militants and members of a network that Ankara blames for a failed coup in 2016.

Turkey has also been angered by a series of demonstrations by supporters of the outlawed Kurdistan Workers Party, or PKK, in Sweden as well as Quran-burning protests that roiled Muslim countries

Turkish President Recep Tayyip Erdogan lifted his objection to Sweden's bid during a NATO summit in July and sent the accession protocol to Parliament for ratification last month. Turkey's reversal of its position came after Stockholm pledged deeper cooperation with Turkey on counterterrorism and to support Turkey's ambition to revive its EU membership bid. In addition, NATO agreed to establish a special coordinator for counterterrorism.

NATO requires the unanimous approval of all existing members to expand, and Turkey and Hungary are the only countries that have been holding out. Hungary has stalled Sweden's bid, alleging that Swedish politicians have told "blatant lies" about the condition of Hungary's democracy. It was not clear when the bill would reach the full assembly, where Erdogan's ruling party and its allies com-

mand a majority.


Spain's Pedro Sanchez reelected PM

Spain's acting Socialist prime minister, Pedro Sanchez, was reelected by a majority of legislators in a parliamentary vote Thursday, allowing him to form a new minority leftist coalition government.

Sanchez was backed by 179 lawmakers in the 350-seat lower house of parliament. Only right-wing opposition deputies voted against him.

The vote came after near-ly two days of debate among party leaders that centred almost entirely on a highly controversial amnesty deal for Catalonia's separatists that Sanchez agreed to in return for vital support to get elected prime minister again.

Sanchez won the vote after clinching the support of six smaller parties — including two Catalan separatist parties — in recent weeks, allowing him to achieve the majority of lawmakers needed



to be reelected and form another minority coalition government with the left-wing Sumar (Joining Forces) party.

Spain's inconclusive national elections on July 23 left a highly fractured parliament. The centre-right Popular Party received the most votes in the elections but

failed to get enough support to form a government because of its alliances with the far-right Vox party, which finished

The Socialists finished second with 121 seats. UNSC adopts resolution calling for humanitarian pauses throughout Gaza

United Nations (PTI): The called for humanitarian pauscalled for urgent humanitarian pauses and corridors throughout Gaza to allow unhindered humanitarian access in the strip, finally overcoming deadlock and adopting a resolution in the month-long Israel-Hamas

The 15-nation Council adopted a resolution on Wednesday that called for the immediate and unconditional release of all hostages held by Hamas and other groups, especially children, as well as ensuring immediate humanitarian access.

The Malta-drafted resolution was adopted with 12 votes in favour, none against and three abstentions from Russia, the United Kingdom and the United States.

The resolution calls for 'urgent and extended humanitarian pauses and corridors throughout the Gaza Strip for a sufficient number of days to enable, consistent with international humanitarian law, the full, rapid, safe, and unhindered humanitarian access" ian agencies and their implementing partners to facilitate the continuous, sufficient and unhindered provision of essential goods and services throughout the Gaza Strip.

The adoption of the resolution came after four failed attempts last month in the Council to take action on allowing humanitarian access in the Israel-Hamas conflict that broke out after the militant group attacked Israel on October 7. The resolution by the US

from terrorist attacks." Permanent Representative to the UN Barbara Ambassador Woodward said while the resolution is absolutely necessary, Britain "regrets" that the first resolution passed by the Council on the issue could not clearly condemn Hamas' terrorist attacks of October 7.

Nevada's attorney general investigating fake electors NATO membership in 2020 for Donald Trump Ankara (Turkey) (AP): The Turkish Parliament's foreign

Nevada's attorney general is investigating six Republican electors who submitted a document to Congress falsely declaring Donald Trump the winner of the 2020 presidential election, a person with knowledge of the case said Wednesday. It was not immediately clear if the ongoing probe was a criminal or civil matter. But the probe adds to official scrutiny of fake electors in several swing states won by President Joe Biden in 2020, including investigations in Georgia, Michigan and Arizona. Fake electors were charged in Georgia and Michigan, and Trump faces charges both in Georgia and in a federal investigation of his conduct related to the Jan. 6, 2021 Capitol riot. The person was not authorized to speak publicly and spoke to The Associated Press on condition of anonymity. Politico and NBC News first reported the existence of the investigation.

Ford, a Democrat, did not respond Wednesday to messages. He has said in the past that his office was cooperating and participating with a U.S. Justice Department investigation of the efforts to keep Trump in office. UK says its Rwanda migrant plan can still work after court defeat

m ritain's}$ interior minister said on Thursday that the UK government can revive its blocked plan to send asylumseekers to Rwanda without breaching international law, with the first flights taking off next year. Home Secretary James Cleverly said the government is "absolutely determined" to begin Rwanda deportation flights before a national election that must be called by the end of 2024.

Many legal experts said that's wishful thinking, and critics urged the government to ditch a plan they say is costing millions and harming Britain's international reputation.

On Wednesday, the UK Supreme Court quashed the government's plan, saying Rwanda is not a safe country

where migrants can be sent. Britain's top court said asylumseekers faced "a real risk of illtreatment" and could be returned by Rwanda to the home countries they had fled.

Despite the justices' unanimous verdict, the British government doubled down on the policy, which it says will deter people from around the world making life-threatening journeys across the English Channel in small boats.

Prime Minister Rishi Sunak said he would sign a treaty with the Rwandan government to close loopholes in the plan, including a block on Rwanda sending migrants home. The government says once that risk has been removed, it will pass a law through Parliament declaring

that Rwanda is a safe country. Sunak also said he was

prepared to "revisit" international relationships to remove "obstacles" if the deportation policy continues to be blocked. Some members of the governing Conservative Party want the prime minister to take the country out of the European Convention on Human Rights if the Rwanda plan is stymied. Cleverly said he believed the plan could take effect without Britain leaving the European convention. The only countries ever to quit the rights accord are Russia - which was expelled after invading Ukraine - and

"I don't believe that will be necessary," Cleverly told the BBC. "We are taking action to address the specific deficiencies in the judgment ... to make sure we are in conformity with international law." He said the government was confident that

"the legally binding treaty, which is binding on both countries, will be robust, will address the issues raised by the Supreme Court."

Legal experts were skeptical. Jonathan Sumption, a former UK Supreme Court justice who is known as a conservative, said the government's strategy "won't work" because the government was asking Parliament "to change the facts." "The courts have perused hundreds of pages of documents to arrive at this conclusion. For Parliament simply to say the facts are different would be constitutionally really extraordinary," Sumption told the BBC.

Refugee law expert David Cantor said if the government failed to heed the Supreme Court, it would set "a very dangerous precedent."

Xi invites Biden to join BRI in summit talks

hinese President Xi Jinping has invited his US counterpart Joe Biden to take part in his pet global initiative the BRI and expressed his readiness to take part in the Washington-backed multilat-

eral cooperate initiatives. The Belt and Road Initiative (BRI) initiated by Xi in 2015 in which China is reported to have invested over a USD trillion has been widely criticised by the US, India and other countries as several countries including Sri Lanka and Pakistan, its biggest beneficiaries, reeled under mounting debt burden. The US, India and many of the EU countries are not part of the

On the sidelines of the G20 Summit in New Delhi in September, Prime Minister Narendra Modi along with President Biden and other world leaders launched the India-Middle East-Europe Economic Corridor (IMEEC) to connect India, the Middle East and Europe with railways, shipping lines, high-speed data

cables and energy pipelines.
In his four-hour-long meeting with Biden on Wednesday on the sidelines of the Asia-Pacific Economic Cooperation summit in San Francisco, termed as "strategic and historic" by Chinese Foreign Minister Wang Yi, President Xi did not directly refer to the IMEEC but said, "China is also ready to participate in US proposed multilateral cooperation initiatives".

On the back foot, as the Chinese economy reeled under a prolonged slowdown with a flight of FDI and supply chains, Xi is on a charm offensive in the US to woo the "good times" of China-US ties

also seen as an effort to address apprehensions back home that the US and China were headed for a major confrontation.

Briefing the Chinese media on the Xi-Biden talks, Wang, who accompanied Xi, said "the two presidents had an in-depth exchange of views face-to-face. AReserve Bank Bulletin on Thursday said retail inflation has moderated due to monetary policy action and supply side interventions, but "we are not out of the woods yet and have miles to go".

An article on the state of the economy in the November Bulletin also noted that the global economy is showing signs of slowing down in the ongoing quarter as manufacturing languishes while services sector activity appears to have reached the end of its post-pandemic expansion.

Going forward, it said tightening financial conditions is a significant risk to the global outlook.

"In India, the momentum of the change in GDP is sequentially expected to be higher in Q3, 2023-24, with festival demand remaining ebullient,"

the article authored by a team lead by RBI Deputy Governor Michael Debabrata Patra said.

The authors said investment demand appears to be resilient with the government's infrastructure spending, an uptick in private capex, automation, digitalisation, and indigenisation providing a boost.

Referring to the headline inflation based on Consumer Price Index (CPI), the article said a combination of monetary policy action and supply side interventions guided inflation down from the high reaches to which it had climbed through the first seven months of 2022-23.

In fact, November 2022 was the first month when headline inflation dropped back into the RBI's tolerance band of 2-6 per cent in the whole cal-

FPIs' investment value in Indian equities rises 15% to USD 651 bn in Sept atr

 $T^{\text{he value of foreign portfolio investors' holdings in}}$ domestic equities reached USD 651 billion in the three months ended September 2023, which was 15 per cent higher than the year-ago period, according to a

Morningstar report. This could be attributed to the good performance of the domestic equity markets as well as strong net FPI inflows. According to the report, the value of FPIs' investments in Indian equities rose from USD 566 billion as of September 2022 to USD 651 billion at the end of September

On a quarter-on-quarter basis, the value of such investment rose 4 per cent from USD 626 billion recorded in the three months ended June this year. Despite the growth, FPIs' contribution to Indian equity market capitalisation fell marginally during the quarter under review to 16.95 per cent from 17.33 per cent in the previous quarter. Picking up from the June

tinued their buying spree in the Indian equity markets for the most part of the September quarter with a net infusion of USD 5.38 billion. Foreign Portfolio Investors (FPIs) pumped USD 5.68 billion into Indian equities in July on steady earnings growth recovery, stable macro fundamentals, and the challenges faced by the Chinese economy and concerns over its recovery. Additionally, the resilient state of the domestic economy and the markets amid global uncertainty also attracted foreign investors toward Indian equities.

However, the pace of investments from FPIs ebbed substantially in August to USD 1.48 billion on concerns on the global macro front on the back of higher crude oil prices and the resurfacing of inflation risks. "The firming up of bond yields in the US also led some foreign investors to drift away from riskier markets in favour of the greater certainty and better risk/reward profile of US Treasuries.

⊣he National Rifle Association of India (NRAI) will award just two bonus points to Olympic quota winners in fire-arm category and one to air weapons shooters after making a major amendment to its selection policy for the 2024 Paris Games. Earlier, an Olympic quota winner earned as many as 10 bonus points for clinching a World Championship gold, while a fourth-place finisher got five points. Similarly in World Cups, a gold medallist earned six bonus points, a silver medallist four and a bronze medallist two. These bonus points gave shooters who earned quota places for the country in events such as the World Cups, World Championships and Asian events, a huge advantage over other Olympic aspirants, who could not cover that gap in trials to select the squad for the

global showpiece. The federation, its hands tied by its own policy, was also left with no choice but to send athletes with the most points even when it knew they were not in the best

"We're going through a very, very difficult time right now, and it just felt right," said Aaron Morali, an Israeli fan who drove two hours from Vienna, Austria to watch the game. "We're Jewish, we're here ... It was very important for us to come here.

Some fans in the stands held up signs bearing the faces of Israelis kidnapped during the Oct. 7 Hamas assault inside Israel that killed around 1,200 people. As fears of antisemitic acts are on the rise across Europe, the security of the Israeli team was a decisive factor in bringing the rescheduled qualifying games to Hungary.

Hungarian Prime Minister Viktor Orbán, who has a holiday home only steps away from the 3,500-seat Pancho Arena in Felcsut, has long claimed that Hungary is one of the safest places in Europe for Jewish people, and maintains close relations with Israeli Prime Minister Benjamin

Netanyahu. As the game approached, heightened security transformed the ordinarily quiet village, making the presence of police and other security forces apparent to local inhabitants.

ROHIT THE LEADER DESERVES THIS WORLD CUP

ow many hundreds did Rohit Sharma miss in this World Cup? At least five if not more. But how many hearts did he win with his new found no-holds barred attacking approach? May be a billion.

With a perfect balance between head and heart, Rohit has taken India into the tournament final. The high-risk approach has cost him personal milestones but having put team above self, the 'Hit-Man' didn't deviate from his game-plan as he is on a mission to complete what he termed at the start as unfinished business'. He will be 36 years and 203 days old on November 19, a day which would possibly be his 'last dance' and effectively a last chance to win the coveted 50 over World Cup title.

The next 50-over World Cup is too far away and someone that oozes practicality from literally every bone of his body, it would be a long shot to think that at 40 he would be game to play 100over per day matches in 2027. Hence November 19, 2023, could be the 'Red Letter Day' in 16 and half years of Rohit's chequered career punctuated with lot of ups and downs.

"In the next two months, I want to create a lot of memories with this team," Rohit had told PTI



just before the Asia Cup.

And boy did he make some fabulous memories in last six weeks giving India its own customized version of 'La Decima (10 in Spanish and Italian) in this year's global cricket meet.

Nasser Hussain pointed out during his chat in Sky Sports what the Indian skipper had told Dinesh Karthik after the last

World T20 semi-final thrashing at the hands of eventual champions England.

"We need to change our approach," Rohit had told Karthik, who was part of that

squad. A change of approach is always a result of change of mindset and when the captain walks the talk, it becomes very easy for others to follow.

Dinesh Lad said.

When Rohit first became a fulltime skipper, in one of his earlier press meets, he had said a very pertinent thing.

"I won't tell anyone to do anything that I myself won't do," Rohit has said back then. But Rohit has always been like that, his childhood coach

"I remember an incident from his U-19 days. It wasn't from a game. We were all standing somewhere and there was this gleaming Mercedes parked on the other side of the road. Rohit looked at it for some time and said: 'Yeh main ek din kharidoonga (I will buy this car one

"I had to retort. I said, 'Rohit kya

paagal ho gaya hain tu. Abhi kuch khela hi naahi hain tune (Are you mad Rohit. You haven't

played anything yet)." Little did he realise that this was not an average 17-year-old. And in less than three years, he had a luxury car in his garage after the T20 World Cup triumph. Lad himself admits that he never realized that there was this bullish but quiet self confidence in his ward.

"He has always been selfless even when he would captain his school team. What you are seeing today isn't something that happened overnight. Forgetting about own milestones and playing the role for his team has been his forte," Lad said.

Lad said that after the initial high of 2007 T20 World Cup and the year-end CB Series in Australia, Rohit faced a lull between 2009 and 2011, with the lowest point being missing out on a World Cup selection.

'I remember him telling me, 'Sir, you won't have any complaints that I don't work hard. I will devote a lot of time on my game', he promised. And you can say, he has kept his promise," the proud coach said.

Those who come up through the ranks, facing a lot of hardships, know a lot about adjustments, and the Indian skipper is one such character.

The Shami Storm: **India's bowling** superstar in WC

As Mohammed Shami walked back to the top of his run-up, Virat Kohli geed the fans at the Wankhede Stadium to go full throat with their chants - Shaamii! Shaamii! They obliged merri-

It was a visible validation of Shami's status in this World Cup - India's superstar with the ball, the bowling equivalent of Kohli with the bat.

It wasn't just because of his immaculate effort against New Zealand on Wednesday night, but now Shami is a single man force de frappe, even ahead of Jasprit Bumrah.

His numbers do back that position. Shami has taken 23 wickets from six matches, including three fifers, at a mind-boggling strike-rate of 10.9, easily the best in this tournament on those two counts.

But then the numbers don't tell the whole story either. Shami was not even part of the playing 11 in the first four matches because of India's desire to field a batting allrounder at No. 8, an additional security measure to counter any top-order dysfunction. In line with that thought, R

Ashwin was included in the match against Australia, while Shardul Thakur played against Pakistan, Afghanistan and Bangladesh.

It required a force majeure -Hardik Pandya's injury against Bangladesh - for the Indian management to shake away their obsession.

They needed to find a batsman and bowler in place of absent all-rounder Pandva for the match against New Zealand at Dharamsala. Shami came to the picture then and made an instant impression against the Kiwis

with a five-wicket haul. It was also a huge credit to Shami's mindset to come back

from a frustrating time at the

sidelines and perform against top-class opposition. India's batting coach Vikram

Rathour said as much.

"Shami is a special bowler, and he is bowling really well. It was tough to get him into the team because of team combination. But he was in a great mind-space even when he was not playing," said Rathour. Shami chose the same opposition to make an impact on an even bigger occasion at Mumbai - the World Cup semifinals.

New Zealand were chasing 398 alright, but a smooth Wankhede pitch and deep batting line-up of the opposition meant that India could not afford to relax. They needed wickets to maintain the

pressure. Shami gave them the perfect start, dismissing Devon Conway and Rachin Ravindra caught behind by KL Rahul the former was snared with one that went away wee bit, while the latter fell to the one

that came in just enough. However, India were pushed onto the backfoot after Kane Williamson and Darvl Mitchell milked 181 runs for the third wicket. The Black Caps were more than a good shout away from the victory then.

India is the best team: Williamson

New Zealand captain Kane Williamson doffed his cap to pacer Mohammed Shami and the India team after his side was outplayed in the World Cup semifinal here, saying that the bowling stalwart was one of the best in the world and Rohit Sharma's side the "best team".

India crushed New Zealand by 70 runs to book their place in the final to be played on Sunday, with their opponents in the summit clash to be decided after the Australia-South Africa showdown in Kolkata on Thursday.

New Zealand could only manage 327 in 48.5 overs chasing magical seven-wicket spell for his unprecedented third fivewicket haul in World Cup matches.

Shami also took his tally to 23 wickets despite missing four matches at the start of the tournament to become the leading wicket-taker in the World Cup. "He has been incredible. He has only played probably half the games and he might be close to top wicket-taker (position) and coming on first change, behind two outstanding newball bowlers," Williamson told the media after the loss.

"He is, without a doubt, one of the top operators in the world and the way he moves the ball and he keeps bringing the stumps into play. It has been quite phenomenal, really, the amount of wickets he has got in such a small amount of games in this tournament.

That Indian team in all departments are firing without a doubt and I am sure they will be looking forward to their next opportunity in a few days' time," the Kiwi skipper added.



Terming India as the 'best team in the world', Williamson said it is "tough" on the opposition to see all home team cricketers playing their best cricket.

"They are the best team in the world and they are all playing tough. They have not missed a beat really," he said.

"To come into a semifinal, you go through your round-robin and you try and get to the stage and it starts again but the way they came out and played, yeah, shows the mindset that they have and the space that they are in," he added.

With Virat Kohli entering the record books by notching up his 50th ODI century and surpassing Sachin Tendulkar in the process, Williamson said it was tough to find words to describe the modern-day

great's brilliance.
"(I am) trying to find the words to describe it really, and not just that, actually the way he goes about it, it is about winning games for his team and he is getting close and there is a lot of attention and that comes with a lot of his suc-

cess," he said. "He is the best, isn't he? And he seems to be getting better, which is a worry for opposition all around the world, but you admire it," he added.

Kohli can break Tendulkar's 100 centuries record: Shastri

Star batsman Virat Kohli might now be holding the record for most ODI hundreds, but former India head coach Ravi Shastri firmly believed that the 35-year-old is well on his way to break another big landmark -- Sachin Tendulkar's 100 international hundreds.

Along with his 50 ODI centuries, Kohli also has 29 hundreds in Tests and one in T20Is for a total of 80 scores above 100. Kohli had broken Tendulkar's mark of 49 one-day hundreds against New Zealand in the World Cup semifinals here on Wednesday.
"Who would have thought when

Sachin Tendulkar got 100 hun-

dreds that anyone would come close? And, he's got 80; 80 international hundreds, 50 of them in the one-day game, which makes him the highest. Unreal," said Shastri during The ICC Review.

"Nothing's impossible because such players, when they start reeling off hundreds, then they score them pretty quickly. His next 10 innings, you might see another five hundreds.

"You have three formats of the game, and he's part of all those formats. To think that he still has three or four years of cricket ahead of him is simply mindboggling." Shastri was also in awe of Kohli's

ability to soak in the pressure. "I think his composure, his



body language, his calmness at the crease (in this WC). I have seen him come out in previous World Cups where he's like a cat on a hot tin roof.

"He wanted to get on with it straight away. None of that sort here. He's taken his time, marked his guard, soaked the pressure, given himself time, and understood his role of batting deep in the innings. He's just

a strict diet cardio and fitness control, he maintains his fitness at the top level, allowing him to run between the wickets freely. "One of the features of his batting has been his running between the wickets. The fact that he doesn't have to hit boundaries and sixes, he can run hard between the wickets because of his physical fitness. "That takes the pressure off him. New Zealand batter Daryl Mitchell was not surprised by India's aggressive brand of cricket in the World cup semifinals and credited the seamers for making the ball talk after his lionhearted effort had kept them alive in the daunting runchase. India captain Rohit Sharma set the tone with a brisk 29-ball 47 before Virat Kohli (117) scored his record 50th ODI century, Shreyas Iver scored 105 from 70 balls and Shubman Gill hit an unbeaten 80 to power India to a mammoth 397 for 4.

It was the highest total for any team in semifinals of World Cup contests. In reply, New Zealand folded for 327, led by Mtichell's

"That is the way they have

played throughout the World Cup," Mitchell told reporters after New Zealand's loss.

"(India are) pretty true to what they have been doing. No sur-prises there, we had plans to try and combat it but credit where credit is due, they played pretty well.

"Disappointed to not get across the line. (At the) halfway mark I was hoping it would dew up a little bit and we might be able to chase it down with 10 overs left. But credit to India. To make almost 400 and bowl the way they did, credit to them.'

Mitchell said India pacers led by Mohammed Shami, who claimed 7 for 57 to take his wickets tally in the World Cup to a high of 23, had the ball talking in the game. "All their seamers had the ball talking tonight. And in the first 10 overs have it swinging around and doing some things. They are all world class bowlers and there is a reason they are what they are," he said.

Like many other players at this venue who suffered cramps during the day-night games here, Mitchell too had to deal with the issue. At one stage, New Zealand appeared to be giving India a real threat but quick wickets in the middle coinciding with his cramps derailed them com-

pletely.
"There were a few things more than cramps that ensured we could not get over the line. Anytime a team puts on a total batting first, you need a lot of things going your way to be able to chase those totals down," said

"Looking forward to seeing you score heavily for Pakistan and that too from the best seat of non-striking end," said Iftikhar. There were talks of a rift in the Pakistan squad after their modest run in the World Cup, with a few players unhappy about the

announced his resignation as captain on his social media account, having rejected an offer by the PCB to just lead the side in red-ball cricket. He was appointed the skipper in
