Huge jolt for Congress Uttarkashi: A

ED seizes ₹752 cr assets in National Herald money laundering case

The Enforcement Directorate (ED) on Tuesday said it has attached immovable assets and equity shares worth about ₹752 crore as part of its ongoing money laundering investigation against the Congress-promoted National Herald newspaper and companies linked to it. The immovable assets that have been attached include the National Herald's office premises at ITO in Delhi, the Nehru Bhawan at Mall Avenue near Kaiserbagh in Lucknow and the Herald House in Mumbai, sources said.

The provisional attachment order came at a time Assembly elections in Chhattisgarh, Madhya Pradesh, Rajasthan, Telangana and Mizoram are in progress and the counting of votes is scheduled to be held on December 3.

The Congress called the agency action as "petty vendetta tactics" and dubbed the ED a "coalition partner" of the BJP which, it claimed, is staring at a certain defeat in the assem-

The federal probe agency alleged in a statement that in this case the shareholders and donors of the Congress were "cheated" by the office-bearers of AJL and the party. A provisional attachment order

has been issued by the federal



Prevention of Money Laundering Act (PMLA) against Associated Journals Ltd (AJL) and Young Indian (YI). The National Herald is published by AJL and owned by Young Indian Private Limited. Congress leaders Sonia Gandhi and Rahul Gandhi are majority shareholders of Young Indian, holding 38 per cent shares each.

In the statement, the ED said it has issued the order to provisionally attach properties worth ₹751.9 crore in the probe agency under the money laundering case being to the tune of ₹661.69 crore and

PMLA. Under the law, such a provisional order has to be approved by the Adjudicating Authority of PMLA in a time period of six months following which the ED can take possession of the attached properties.

"Investigation revealed that Associated Journals Ltd (AJL) is in possession of proceeds of crime in the form of immovable properties spread across many cities of India such as Delhi, Mumbai and Lucknow

Young Indian (YI) is in possession of proceeds of crime to the tune of ₹90.21 crore in the form of investment in equity shares

of AJL," it said. The Gandhis, Congress president Mallikarjun Kharge and party leaders Pawan Bansal, DK Shiyakumar (Karnataka Deputy Chief Minister) and his MP brother DK Suresh were questioned and their statements were recorded by the agency in connection with the case last year.

According to sources, they may be called again for questioning before the ED files a chargesheet in the case. The money laundering case

stems from a court order of the Delhi Metropolitan Magistrate that took cognisance of a private complaint against alleged irregularities in the National Herald's affairs on June 26, 2014. The court had held that seven accused persons and entities, including Young Indian, "prima facie" committed offences of criminal breach of trust under various sections of the IPC, including cheating and dishonestly inducing delivery of property, dishonest misappropriation of property and criminal conspiracy, the ED

"The accused persons hatched a criminal conspiracy to acquire properties worth hundreds of crores of AJL through a special purpose vehicle--Young Indian. AJL was given land on concessional rates in various cities of India for the purpose of publishing newspapers," the agency said.

It added that AJL closed its publishing operations in 2008 and started "using" the properties for commercial purposes,

it alleged. It said AJL had to repay a loan of ₹90.21 crore to All India Congress Committee (AICC), however AICC treated the said loan of ₹90.21 crore as nonrecoverable from AJL and sold it for ₹50 lakh to a newly incorporated company Young Indian "without" any source of income to pay even ₹50 lakh. "By their action, the sharehold ers of AJL as well as donors of Congress party were cheated by the office bearers of AJL and Congress party," the agency claimed.

After purchasing the loan of ₹90.21 crore from AICC, YI demanded either re-payment of loan or allotment of equity shares of AJL to it, the ED said. AJL, it added, held an Extraordinary General Meeting (EGM) and passed a resolution to increase share capital and issue fresh shares worth ₹90.21 crore to YI.

"With this fresh allotment of shares, shareholding of more than 1,000 shareholders was reduced to a mere 1 per cent and AJL became a subsidiary company of YI. YI also took control over properties of AJL," the agency said.

As the first visuals of the 41 workers trapped inside the Silkyara tunnel emerged ON Tuesday, officials said the focus of the multiple-agency rescue mission remains on digging horizontally through the debris of the collapsed stretch.

However, rescue workers continued to prepare for other options, including drilling from above the tunnel, to reach the workers trapped inside for nine

Horizontal drilling through the debris was put on hold last Friday afternoon after the heavy duty auger machine encountered a hard boulder. making rescue agency consider other approaches as well. But on Tuesday, remarks by National Disaster Management

Authority member Lt General (retd) Sved Ata Hasnain, Road Transport and Highways secretary Anurag Jain and Uttarakhand Chief Minister Pushkar Singh Dhami made it clear that resuming the operation was the main priority.

At the disaster site in Uttarakhand's Uttarkashi district, a video clip captured by an endoscopic camera sent in through a new six-inch wide pipeline brought hope to relatives who are camping there for days. The pipeline was pushed late Monday through 53 metres

of debris, the collapsed stretch of the under-construction tunnel on the Char Dham route. In the video released by the rescue agencies, the workers wearing yellow and white helmets are seen receiving food items sent to them through the pipeline and talking to each other. Officials watching them on a

Israel labels LeT terror group ₹4.7 lakh crore wedding windfall

In a gesture of solidarity with India in its fight against terrorism, Israel on Tuesday listed Pakistan-based Lashkar-e-Taiba (LeT) as a terror organisation ahead of the 15th year anniversary of the 26/11 terror attack on Mumbai that killed number of Israeli nationals.

"Despite not being requested by the Government of India to do so, the state of Israel has formally completed all necessary procedures and has satisfied all required checks and regulations to the result of introducing Lashkar-e-Taiba into the Israeli list of illegal terror organisations," the Israel Embassy said in a statement in New Delhi. Ten Pakistani terrorists entered south Mumbai areas through sea route, attacked a number of places, including Chabad House, a Jewish centre, and indiscriminately killed 166 people, including 18 security personnel, and a number of Israelis on November 26, 2008. "Lashkar-e-Taiba is a deadly

A fter the record-breaking sales during the Diwali festive season, which concluded with Chhath Puja, the upcoming wedding season from Dev Uthan Ekadashi on November 23 to December 15 is expected to generate business around 38 lakh weddings likely to be solemnised during this period.

Delhi region alone may host 3.5 lakh weddings, generating ₹1 lakh crore in the region. According to the survey by the Research & Trade Development Society of the Confederation of All India Traders (CAIT), popular wedding destinations in India encompass sought-after locations such as Goa, Jaipur, Kerala, and Shimla.

The prevailing wedding trends in India encompass destination weddings, themed weddings, and an increasing emphasis on eco-friendly celebrations. Last year, about 35 lakh weddings took place during the same



period, generating business worth ₹3.75 lakh crore.
According to the CAIT nation-

al president BC Bhartia and secretary general Praveen Khandelwal, about seven lakh weddings will be performed with an expense of ₹3 lakh, 8 lakh weddings with ₹6 lakh, 10 lakh weddings having an expense of ₹10 lakh, 7 lakh weddings with ₹15 lakh, 5 lakh weddings with ₹25 lakh,

50,000 weddings with ₹50 lakh, and next 50,000 weddings with an expense of ₹1 crore and

Australia, India juggle China ties

In an effort to further strengthen the bilateral ties between the two countries, India and Australia on Tuesday vowed here to deepen their economic and security partnership and stressed their shared commitment to a "free, open, inclusive and rules-based" Indo-Pacific region. ing to tension. For both Australia and India, China is the biggest trading partner, and China is also the biggest security concern. Australian Foreign Minister Penny Wong said this is a partnership which is "consequential for us, but it is crucial for our region".

Uttar Pradesh Congress Committee President Ajay Rai reiterated here on Tuesday that Rahul Gandhi would contest the 2024 Lok Sabha elections from Amethi constituency.

Addressing a news conference during his visit to the city, Rai said: "They (Gandhis) have been working for the people of Amethi for generations. Rahul ji will definitely contest from Amethi".

It may be recalled that Smriti Irani of the BJP had defeated Rahul Gandhi in Amethi constituency during the 2019 Lok Sabha by a margin of 55,120

However, Gandhi — who had also contested from Wayanad Lok Sabha constituency in Kerala — won and became an MP in 2019.

Tuesday was the second occasion when Rai spoke about Gandhi contesting the 2024 Lok Sabha polls from Amethi constituency. He had made a similar statement in Lucknow in August this year.

Ambani pledges ₹20K cr more investment in Bengal **SAUGAR SENGUPTA** KOLKATA

The Reliance Industries Chairman and MD Mukesh Ambani whose company has invested ₹45,000 crore in West Bengal, mainly in telecom business, on Tuesday announced an additional ₹20,000-crore investment over the next three Ambani said the fresh invest-

ment will be in the areas of digital life solutions, retail and bioenergy. "Bengal has been one of the largest investment destinations for Reliance... We plan to invest an additional ₹20,000 crore in Bengal in the next three years for enhancing digital life solutions, augmenting Reliance Retail footprint and on bio-energy," he said, adding, "Reliance will leave no stone unturned to accelerate Bengal's

Meanwhile politics invaded the realms of economics with Bengal Chief Minister Mamata Baneriee on Tuesday choosing to accuse the BIP Government of depriving Bengal of its dues even as she plunked the topic on an international podium meant to draw business investment in Bengal.

Even as the who's who of world business including delegates from 35 countries listened to her impromptu speech at the much touted Bengal Global Business Summit the Chief Minister said how her State had become a vicof the GST regime.

"Though I should not tell it here ... I am sorry to say that we are not getting our share in the GST which is a tax collected from our State but does not return to us ... the poor people have worked in the 100-days' work scheme

but are not getting paid for their labour ... still we are helping them out from our" limited resources, Banerjee said even as she listed the "game changers," (read achievements) that make Bengal an automatic choice for

the investors The Chief Minister on Tuesday inaugurated the seventh two-day world business summit in an apparent bid to draw investment in what the critics call an industry-starved State that thrive not on employment creation but on social schemes and doles.

'Poor diet ups risk of type 2 diabetes'

Poor nutrition or in other words unhealthy diet plays a dual role, contributing to both the risk of developing type 2 diabetes and impacting mental health, including anxiety and depression cause, a team of researchers has said as they batted for nutrition interventions that can aid in both of these health issues.

Though as per the US Centers for Disease Control, people with diabetes are two-to-three times more likely to have depression than people without, the understanding of the multifaceted relationship between nutrition, mental health, and DM has been revealed by the George Mason University researchers.

Two literature reviews from assistant professor Raedeh Basiri from the University show that poor nutrition plays a dual role, contributing to 2 diabetes and impacting mental health, including anxiety and depression. Conversely, a diet with a large number of processed foods was found to have a negative effect, increasing the susceptibility to type 2 diabetes, depression, and anx-

"Óur findings underscore the pivotal role of dietary choices in reducing the risks associated with both diabetes and



mental health.

The implications of these find ings extend beyond the scientific community, as they hold promise for informing public health policies, health care practices, and dietary recommendations that can positive ly impact the general population, said Basiri, the lead author

of the papers. Exploring Interrelationships between Diabetes, Nutrition, Anxiety, and Depression: Implications Strategies" was published in

for Treatment and Prevention with Mason Master of Science in Nutrition students Blessing Seidu and Mark Rudich as coauthors. "Ultimately, the research seeks

to empower individuals to make informed and healthpromoting dietary choices that can serve as a proactive strategy for the prevention and management of diabetes, as well as anxiety and depression," Basiri said.

Belly fat connected with Alzheimer's: Study PIONEER NEWS SERVICE **NEW DELHI**

vou have been coming up ■with many excuses to avoid physical activities that can help cut down fat around your belly, then this study may serve you as a wakeup call. A team of researchers has found that visceral fat around the internal organs located deep within the abdomen has been linked to alterations in the brain that can develop up to 15 years before the first signs of Alzheimer's disease. To identify Alzheimer's risks earlier, researchers assessed the association between brain MRI volumes, as well as amyloid and tau uptake on positron emission tomography (PET) scans, with body mass index (BMI), obesity, insulin resistance and abdominal adipose (fatty) tissue in a cognitively normal midlife population.

Amyloid and tau are proteins thought to interfere with the communication between brain

"Even though there have been other studies linking BMI with brain atrophy or even a higher dementia risk, no prior study has linked a specific type of fat to the actual Alzheimer's disease protein in cognitively normal peosaid Mahsa Dolatshahi, post-doctoral research fellow

with Mallinckrodt Institute of Radiology (MIR) at Washington University School of Medicine in St. Louis. "Similar studies have not inves-

tigated the differential role of visceral and subcutaneous fat, especially in terms of Alzheimer's amyloid pathology, as early as midlife," Dr. Dolatshahi said

For this cross-sectional study, researchers analysed data from 54 cognitively healthy participants, ranging in age from 40 to 60 years old, with an average BMI of 32.

The participants underwent glucose and insulin measurements, as well as glucose tolerance tests. The volume of subcutaneous fat (fat under the skin) and visceral fat were measured using abdominal MRI.

Brain MRI measures the cortical thickness of brain regions that are affected in Alzheimer's disease. PET was used to examine disease pathology in a subset of 32 participants, focusing on amyloid plaques and tau tangles that accumulate in Alzheimer's disease. The researchers found that a

higher visceral to subcutaneous fat ratio was associated with higher amyloid PET tracer uptake in the precuneus cortex, the region known to be affected early by amyloid pathology in Alzheimer's disease. This relationship was worse in men than in women.

The researchers also found that higher visceral fat measurements are related to an increased burden of inflammation in the

Capital stares at water crisis

DJB not getting funds, severe water crisis looming over Delhi: Atishi to LG

mid tussle with the Delhi Government offi-Acials, the national Capital may soon face severe water shortage, Water Minister Atishi warned on Tuesday, alleging that the finance department was not releasing funds to the Delhi Jal Board (DJB) despite several written orders. Seeking suspension and disciplinary action against Principal Secretary (Finance) Ashish C Chandra for stopping the funds, the Minister has appealed to Lieutenant Governor (LG) Vinai Kumar Saxena to intervene immediately and release the funds to the

Opening up yet another front against Chief Secretary Naresh Kumar, she accused him of not releasing funds to the DJB. Atishi in a letter to LG said the national capital might plunge

into a 'man-made' severe water crisis Finance Secretary Ashish C Verma has stopped all funds of DJB since August upon the Chief Secretary's advice. "Because of this funds aren't

being released; no money for salaries and routine work is being sanctioned, and all contractors have refused to work. This might lead to severe water crisis, dirty water, and sewer overflow in many areas; threat of epidemic & emergency-like conditions in the national capital," she said.

The allegation has set up the stage for a fresh bout of confrontation between the bureaucracy and the AAP government in Delhi

No immediate reaction was available from the chief secretary or the finance secretary over allegations by Atishi. However, sources in the planning department said that ₹1,598 crore was released to the



DJB in June.

More funds will be released "based on evidence of the progress of works and geotagging for ensuring that public funds are not being misappropriated", a source said.

According to sources in the finance department, the Government does not give funds to the DJB for salaries or repairs and maintenance. These are to be met from the DJB's own revenues. Also, running water and sewage treatment plants is the DJB's respon-

"So it is wrong to say that water supply or sewage treatment will stop," a source claimed.Delhi government provides loans and grants only for new works and funds are to be released based on the progress on the ground, the sources added.

"It is a very alarming turn of events that the Finance department of the Delhi Government has refused to release the funds that have already been allotted to the DJB in the Budget 2023-24 passed by the Delhi Legislative Assembly.

This is a routine governance procedure and never in the past has the Finance department raised so many objections to stall the release of routine instalments of the Grant-in-aid and Loan to DJB.

"Yet, this time, under the leadership of Ashish C. Verma, the Finance and Planning departments have been repeatedly posing new and different objections each time the previous objection is resolved

AQI in Pusa was recorded at 497, in Satyawati College at 478, in Anand Vihar at 440, in Punjabi Bagh at 404, in Delhi Institute of Too Engineering at 401,in Jahangirpuri at 433, in Shahdara at 402, in East Patel Nagar at 382, in Kohat Enclave at 366, in Lodhi Road at 315, in New Moti Bagh at 370.

NCR regions including Ghazia-bad (321), Gurugram (261), Greater Noida (318), Noida (331) and Faridabad (329) also recorded a dip in air quality. Expressing dissatisfaction with the action taken by authorities to control air pollution, the National Green Tribunal had directed them to "take all possible measures to ensure that the

quality of air improves in Delhi".

The committee's recommendation may now be taken into consideration by the 19-member National Syllabus and Teaching Learning Material



Group (CAG) for Social Science to develop Syllabi and Teaching-Learning material for the subject.

RRTS PROJECT

SC pulls up Delhi Govt for not providing its share of funds

PTI ■ NEW DELHI

The Supreme Court on Tuesday pulled up the Delhi government for not providing funds for the Regional Rapid Transit System (RRTS) corridors to Alwar and Panipat, and said if the dues were not paid with-in a week, the funds allocated by the AAP government for advertisements will be transferred to the project.

The RRTS project entails semihigh speed rail corridors con-necting Delhi to Meerut in Uttar Pradesh, Alwar in Rajasthan, and Panipat in Haryana.

The apex court said budgetary provision was something which the state government should look into but if such national projects were to be affected and money was spent on advertisements it would be inclined to direct that those funds be transferred for this project.

A bench of Justices Saniav Kishan Kaul and Sudhanshu Dhulia observed that on July 24, the counsel representing the Delhi government had assured the top court that payment would be made towards the pro-

"We are thus constrained to direct that funds allocated for

advertisement purposes will be transferred to the project in question," the bench said. "At the request of the counsel for

Delhi government, we keep this order in abeyance for one week and if the funds are not transferred, the order will come into operation," it said. While hearing the matter on July

24, the apex court had berated the Delhi government for "throwing its hands up" over the two RRTS corridors to Alwar and Panipat, and directed it to provide Rs 415 crore for the project within two months. On Tuesday, the bench was hearing an application raising the issue of non-payment of funds by the Delhi government for the project.

When the counsel representing the Delhi government said they needed to file a reply in the matter, the bench shot back, "What reply? You have not complied". "Why did you not comply? I told you that day, I will attach your advertising revenue. I am going to stay the advertising budget," Justice Kaul told the lawyer. The bench, which posted the matter for hearing on November 28, expressed its displeasure

COVID jab did not increase risk of sudden death, says ICMR study

NEW DELHI

Astudy by the Indian Council of Medical Research (ICMR) has said that COVID-19 vaccination did not increase the risk of sudden deaths among young adults in India reported in the past one year. Instead, it blamed factors such as being in the hospital for Covid in the past and certain behaviours like binge drinking and intense physical activity shortly before death for such mortalities, the study has said.

Titled "Factors associated with sudden deaths among adults

aged 18-45 years in India -- a multicentric matched case-control study", the study is under peer review and yet to be published. It was completed earlier this month, official sources said recently. Citing the ICMR study, Union Health Minister

Mansukh Mandaviya said at Gujarat's Bhavnagar had said that those who had earlier suffered a severe bout of Covid must not overexert themselves for a year or two to avoid heart attacks and cardiac arrests. Anecdotal reports of sudden deaths among healthy young

The study was conducted to investigate the factors contributing to sudden unexplained deaths among healthy

young adults in India.

For each case, four matched controls were selected based on age, gender and locality, the sources said. Investigators enrolled 729

cases and 2,916 controls and collected information from both the cases and controls about aspects, such as their medical history, behaviours like smoking, alcohol use and intense physical activity, whether they were hospitalised due to Covid and whether they were administered any vaccine

"COVID-19 vaccination did not increase the risk of sudden deaths among young adults in India. In fact, COVID-19 vaccination reduced the risk of sudden deaths among adults. "Factors that did increase the chances of sudden deaths included being in the hospital for COVID-19 in the past and certain behaviours like binge drinking and intense physical activity shortly before death. In summary, this research provides important insights into the factors contributing to sudden deaths among young adults in India," the study said.

Pointing the finger

Modi's poll campaign focuses on corruption and dynastic mindset of the Congress

s the time for polling in the next round of Assembly elections grows shorter, Prime Minister Narendra Modi has intensified his election campaign and is focusing on issues of corruption, dynastic rule and development. Recently, he took the Congress Government in Rajasthan to task, accusing it of putting corruption and dynasty over development. Modi's scathing attack on the Congress Government cantered on allegations of corruption, appeasement politics and family succession. He asserted that the Congress has been engrossed in appeasement politics, leading to the flourishing of individuals with a mentality inclined towards riots and terrorism. He linked the 'grand old party' and its allies to a campaign against women, especially after the introduction of reservation for women in legislative bodies. Highlighting the party's alleged anti-women stance, Modi labelled the Opposition grouping, the Indian National Developmental Inclusive Alliance (INDIA), as "ghamandiya" or arrogant; this term has become a recurring theme



in his speeches. It is customary and an accepted fact that any party would attack its opponents in election rallies. In fact, sometimes election campaigns turn venomous, which is taken with a pinch of salt, but these days it is a no-holds barred fight where no one is immune or sacrosanct. While lambasting the Congress for dynastic politics, however, Modi inadvertently drew attention to the presence of similar elements in his own party.

The BJP has not been immune to dynastic succession, and this observation adds a layer of complexity to his narrative. Critics argue that both major political parties in India grapple with dynastic tendencies,

making it a systemic issue rather than one confined to a specific party. If one were to analyse today's party organisation, several examples can fit the description of dynastic mindset. Rajnath's son Pankaj Singh, Amit Shah's son Jay Shah and Prem Kumar Dhumal's son Anurag Thakur can fit the description well. The latest in this regard is BY Vijayendra, the son of former Karnataka Chief Minister BS Yediyurappa, who has been appointed the BJP's Karnataka unit president. Modi also emphasised the reduction in direct taxes during the BJP's tenure, claiming significant savings for the taxpayer; he highlighted reduced mobile data prices. Underscoring the need for a Government prioritising development, Modi urged the people of Rajasthan to vote for a Government that would work towards progress. He positioned the BJP as the party that would lead Rajasthan to new heights in the 21st century. His attack on the Congress Government's alleged shortcomings might be true to an extent but he should also remember that people could like to draw parallels with the BJP-ruled States where things are no better. It is only for the voters to take a call on who they deem fit to rule them for the next five years. The States' electorate now faces the task of weighing such political claims and deciding the future trajectory of governance.

Adopt a realistic approach to infiltration



Illegal migrations can lead to social and political tensions in the host country which can be a real problem in the long run

he current times are not merely of wars and armed conflicts, but also of infiltration. Britain hosts illegal immigrants, which costs the country 8 million pounds a day merely to feed them. Due to a clash between Burma's rebels and the country's army, reportedly at least 50,000 if not a lakh Burmese have entered India and have penetrated up to Manipur and Mizoram, some up to as far as Delhi. One estimate says there are up to 175,000 illegal immigrants in the UK.

Ukrainians by the thousands have rushed into Poland over the last year and a half, while many others are knocking on Germany's doors. Being of European stock, they are not unwelcome, whereas the immigrants entering the UK are from Rwanda, and are positively unwanted. A third category of potential migrants are ready to flee the West Bank and the Gaza Strip in Israel and Hamas, but they are scrupulously unwanted by even the most zealous Islamic countries.

Europe, over the last decade or more, has been talked about as possibly becoming 'Eurabia' shortly. Yet, when many Syrians were fleeing their own country to escape bombing by their regime, several member countries of the European Union led by Germany, and then Chancellor Angela Merkel were ready to welcome them. Merkel might have perhaps been moved to sympathy by her own experience as an East German whose government killed thousands of its citizens for wanting to flee to the West.

India has suffered illegal immigrants from Bangladesh to the tune of some 20 million of the latter's citizens living illegally in India. As if this was not troubling enough, Pakistan has lately become sick with impending bankruptcy. It is reported that its not so well-off citizens survive on one meal a day. When even that meal disappears, would they not be tempted to dash the Indian The citizens of Pakoccupied Kashmir feel oppressed, and some of them feel that it is their right to become Indian cit-



(Hari Singh, the erstwhile princely ruler of Jammu & Kashmir) had acceded to India in 1947. It was the Pakistani Mujahideen who had occupied their territory forcibly. There is no counter-answer to this claim.

Books have been written on migration, some of which contend that most peoples of the world have migrated from somewhere at some stage of history. One notable book is Migrants by Sam Miller. India certainly attracted waves of migration over the centuries due to its prosperity compared with Central Asia. However, that does not justify further illegal entry into India.

An almost uninterrupted flow of migration into the European Union has been changing Europe's domestic politics since the last decade or even more. Today, Europe, and particularly Southern Europe is exposed and vulnerable to pressure to migration from the Middle East and North Africa, a region referred to as MENA.

Unlike the Republican Party and its leader Donald Trump, not everyone in the USA objects to migration from Cuba or Mexico. The reason may be that they are predomizens because their Maharaja inantly white. Nationality is whose hearts can beat together. On the other hand, there are US citizens who realize that allowing migration from any sundry country with varying racial stock will lead to conflict. Consequently, there is a growing reluctance to further immigration. But again, there is a divide between the Republicans and the Democrats, the latter generally favouring immigration as an addition to their votebanks.





Gone are the days when we had to wait to get our news from newspapers and TV channels. Today, we feed on a constant stream of unverified information from our social networking websites and our WhatsApp forwards. a digital signature that is embedded into a digital file to identify its originator or owner. This mark can be a code, logo, text or a unique sign that identifies the content's owner and also helps to prove its authenticity. A digital watermark has to be very creative, a way of altering a file that is not noticeable to the user. It might be difficult to embed a watermark within a text file. However, it is quite easy to do it for audio, video and image formats by changing a few bits, without making a noticeable difference in the music, movie or photo.Like watermarks on paper currency or documents, digital watermark helps distinguish between a real object and a fake one and also ascertain who owns it. It can track the online use of the file and warn the creator against unauthorised access and use. Digital watermarks can check the spread of fake images to some extent but cannot control it. Though digital watermark may not be a solution to deepfakes, it is an important tool to fight against piracy and unauthorised access and distribution of digital

With the invention of easy techniques to copy and share digital files, companies and businesses are facing a huge challenge to safeguard their valuable content and content creators. But if a watermark is embedded into the master copy of a DVD movie, then all copies of that disc carry unique identification. If a licence holder distributes them outside his authorised jurisdiction, the watermark provides a trace. Digital watermarking also ence to ethics in the business of

ing and monitoring its distribution and usage across various consumers and platforms. This can help them make more informed decisions about their marketing, advertising and distribution strategies. By ensuring that their content is protected from unauthorised use, businesses can maintain greater control their identity. Watermarking technolo-

gy is a simple solution that holds promise. But it may not be enough on its own. It is naive to accept this as a foolproof protection against piracy and deepfakes. It is very easy to remove a watermark that is toward the edge of an image; it can simply be cropped out of the picture. Further, there are apps available that can remove most marks in just a few clicks. This is why a digital watermark cannot offer complete protection. The Distill scientific journal defines AI Safety as "The goal of long-term artificial intelligence (AI) safety is to ensure that advanced AI systems are reliably aligned with human values — that they reliably do things that people want them to do."A sustainable solution to deepfakes should be able to balance the needs of AI companies with consumer rights and that will require a bouquet of practical solutions like a digital watermark.

That will require cooperation from online platforms and search engines to voluntarily decide to allow only those contents that bear a watermark. This is a larger issue and calls for strict adher-

Israeli troops battle militants across Gaza | Israeli airstrike on southern

(GAZA STRIP)

Israeli troops battled Palestinian militants in an urban refugee camp and outside the gates of a nearby hospital on Tuesday as the army expanded operations across northern Gaza, where residents have been without electricity, water or access to humanitarian aid for weeks.

The front line of the war, now in its seventh week, has shifted to the Jabaliya camp, a dense warren of concrete build ings near Gaza City that houses refugees from the 1948 war surrounding Israel's creation and their descendants.

Israel has been bombarding the area for weeks, and the military said Hamas fighters have regrouped there and in other eastern districts after being pushed out of much of

Fighting has also intensified outside the Indonesian Hospital on the outskirts of people on Monday. Health officials said on Tuesday that hundreds of patients and displaced people are trapped inside with dwindling supplies after some 200 were evacuated the day

The war sparked by Hamas' surprise October 7 attack into Israel has exacted a heavy toll on Palestinian civilians, particularly those who remain in the north after Israel repeatedly called on people to flee south

It's unclear how many people remain in the north, but the UN agency for Palestinian refugees estimates that some 160,000 people are still in its shelters there, even though it is no longer able to provide ser-Palestinians, about three fourths of Gaza's population, have fled their homes.

Hundreds of thousands of displaced people have packed into UN-run schools and other facilities across southern Gaza. As the shelters have overflowed, people have been forced to sleep on the streets outside, with little shelter from winter rains that have hit the region in recent days.

Across Gaza, there are shortages of food, water and fuel for generators to power basic infrastructure. There has been a territory-wide blackout

what it says are militant targets across Gaza, including in the southern evacuation zone, often killing women and children, and officials have said it may soon expand its operations in the south.

FIGHTING AROUND HOSPITALS

Tens of thousands of Palestinians in the north had sheltered in hospitals, but those have steadily been emptied out as the fighting has reached their gates, and most are no longer

Marwan Abdallah, a medical worker at the Indonesian Hospital near Jabaliya, said heavy fighting prevented ambulances from bringing wounded people in.

Munir al-Boursh, a senior Health Ministry official who said he was inside the hospital, told Al-Jazeera television by phone that Israeli forces had besieged it, forcing health workers to bury 50 bodies in the courtyard. "The situation is unimaginable," he said.

an Israeli shell struck the hospital on Monday, killing 12 people. Israel denied shelling the hospital, but said its troops returned fire on militants who targeted them from inside. Some 200 wounded

Putin, Xi and Gutteres to attend meeting on Israel-Hamas war

Russian President Vladimir Putin, Chinese President Xi Jinping and other leaders from the BRICS bloc of developing countries will hold a virtual meeting on the Israel-Hamas war on Tuesday, with United Nations Secretary-General Antonio Gutteres also partici-

The leaders of fellow BRICS members Brazil, India and South Africa, as well as of Saudi Arabia, Argentina, Egypt, Ethiopia, Iran and the United Arab Emirates, which are set to oin the bloc in January, will also take part, according to the office of South African President Cyril Ramaphosa. Ramaphosa will chair the 'extraordinary meeting" because of South Africa's position as current chair of BŔICS, his office said. It said the leaders are expected to deliver statements on the "humanitarian crisis" in Gaza and will likely adopt a joint statement.

The meeting comes a day after China's top diplomat hosted the foreign ministers of Saudi Arabia, Egypt, Jordan, the Palestinian Authority and Indonesia in Beijing, their first stop on a tour of UN Security Council permanent members. The meeting underlined China's longstanding support for the Palestinians and its growing geopolitical influence.

Navy plane overshoots runway and ends up in ocean, all 9 aboard safe **AP** ■ HONOLULU

A Navy plane flying in rainy weather overshot a runway on Monday at a military base in Hawaii and splashed into Kaneohe Bay, but all nine aboard were uninjured, authorities said. The Coast Guard responded, but rescue operations were quickly called off, said Petty Officer Ryan Fisher, a Coast Guard spokesperson. "It sounds like all parties involved were rescued," he said.

Marine Corps spokesperson Gunnery Sgt. Orlando Perez had no information about what caused the P-8A aircraft to go off the runway at Marine Corps Base Hawaii.

A photo taken by witness Diane Dircks showed the plane in water just offshore, a sight reminiscent of the 2009 Miracle on the Hudson" when a passenger jet piloted by Chesley "Sully" Sullenberger made an emergency landing on

The Honolulu Fire Department received a 911 call for a downed aircraft shortly after 2 p.m., spokesperson Malcolm K. Medrano said in an email. It was cloudy and rainy at the time. Visibility was about 1 mile (1.6 kilometres), said Thomas Vaughan, a mete-orologist in Honolulu.

N Korea launches rocket in what may be its 3rd attempt to put spy satellite into orbit

North Korea has launched a rocket in what may be its third attempt to put a spy satellite into orbit, according to South Korea's military. A rocket was launched late on Tuesday, the military in Seoul said, but no further details were immediately available.

In North Korea's two previous attempts, rockets carrying satellites failed because of technical reasons.

North Korea had vowed a third launch would take place sometime in October, but failed to follow through with the plan without giving any reason. North Korea says it needs

a spy satellite to deal with what it calls increasing US.-led military threats. South Korea retrieved debris from the first launch and called the satellite too crude to perform military reconnaissance. Japan's coast guard said North Korea between Wednesday and November 30. Pak court strikes down notification | SL's Parl passes 2024 budget to keep Imran in judicial lockup

The Islamabad High Court I on Wednesday declared null and void the official notification of the Pakistan government for the jail trial of former prime minister Imran Khan in the cipher case in which he is charged with leaking state

The two-member bench issued its reserved judgment on an intra-court appeal by the former prime minister against the single bench verdict of the same court that had turned down the Pakistan Tehreek-e-Insaf (PTI) chairman's appeal against his trial in the Adiala Jail in Rawalpindi.

The trial is being held in the Adiala Jail, where 71-yearold Khan has been kept since September 26 when shifted there from District Jail, Attock.

The Ministry of Law issued no-objection certificate (NOC) for the jail trial of Khan as requested by the Interior Ministry and special court Judge Abual Hasnat Zulqarnain on August 29.

Earlier in the morning, the



Islamabad High Court (IHC) panel of justices Miangul Hassan Aurangzeb and Saman Rafat Imtiaz heard the intracourt appeal of Khan and reserved the judgment after completing the hearing process.

According to the short verdict, the government's notification of August 29 to hold the jail trial of Khan was declared illegal. However, the court stated that there was no bar on the jail trial of an accused in case of extraordinary circumstances and it was up to the judge to keep such trial open or in-camera. The two-member bench

give a ruling in favour of a jail trial and the government following the ruling should issue a notification for the same.

The court also upheld the appointment of Judge Abual Hasnat Zulqarnain, who is conducting Khan's trial under the Official Secrets Act.

There was some confusion over the impact of the verdict on the fate of Khan's trial in jail as the court accepted the appeal on procedural and technical grounds.

Senior lawyer Yasin Azad told Samaa TV after the verdict that the jail trial came to a halt after the verdict but the government can address the lacunae in the procedure adopted for the trial. "The government can also file an appeal against the verdict in the Supreme Court," he said. He also said that the verdict has no impact on the proceedings adopted so far, meaning that Khan's indictment still stood intact.

However, lawyer Abid Zuberi stated that the court by rejecting the jail trial also nullified all the proceedings and jail trial. "The verdict has rejected the jail trial right from the beginning," he said.

Jehangir Jadoon, former Advocate General of Islamabad, said that the court granted the appeal on technical grounds because it rejected the procedure adopted by the government for Khan's jail trial. Some of the finer details will be cleared once the detailed judgment is issued," he said.

In March 2022, Khan and his foreign minister Shah Mahmood Qureshi were alleged to have violated the secrecy laws of the country while handling a communication (cipher) sent by Pakistan's embassy in Washington. The diplomatic cable reportedly went missing from Khan's pos-

The duo, who had claimed that the cable contained a threat from the United States to topple the PTI's government, was indicted on October 23. Their formal trial has begun with the recording of statements by the witnesses two

Sri Lanka's Parliament on Tuesday approved the 2024 budget, emphasising the need for tough reforms until the full recovery of the cash-strapped island nation's economy. Although Sri Lanka has managed to control its hyperinflation in the ongoing economic crisis, its economy is far from being fully recovered.

President Wickremesinghe, who is also the Finance Minister, on November 13 presented the budget emphasising awareness of the hard times that will continue until a full economic recovery can be achieved.

The Second Reading of the 2024 budget was passed in Parliament on Tuesday with 122 members voting for and 77 against it in the 225-member Assembly, Speaker Mahinda Yapa Abeywardena said.

Presenting the budget in Parliament, the President said that advancing a nation requires more than mere fairy tales. He recalled that the prolonged reliance on election promises by political parties has historically led to

the economic bankruptcy of the country.

The 2024 budget allocates funds to improve facilities for tourists, address housing issues in the country, including in the North, and improve domestic cricket.

'Violence in Kosovo unacceptable'

NATO Secretary General Jens Stoltenberg said Tuesday that the recent violent outbreaks in Kosovo were unacceptable and perpetrators must be brought to justice. "I count on all sides to

reduce tensions and to refrain from escalatory actions," he said during a visit to Serbia's capital Belgrade, after his stops in Bosnia and Kosovo, on the second day of his trip in Western Balkans,

Stoltenberg's trip reflects Western concerns over the stability of the volatile Balkan region that went through a series of wars in the 1990s.

Serbia and Kosovo witnessed a spike in tension following two violent incidents in May and September as the war raged in Ukraine. Western allies fear Russia could try to spur Balkan trouble to avert attention from its aggression on Ukraine.

In May, Serb demonstrators in northern Kosovo clashed with NATO peacekeeping troops. In September, a Kosovo policeman and three Serb gunmen were killed in a shootout after about 30 masked men opened fire on a police patrol near the Kosovo village of Banjska.

The two incidents have prompted NATO to beef up its peacekeeping presence in Kosovo. Stoltenberg said on Monday that NATO was considering deploying additional

peacekeeping troops.

The NATO head said in Belgrade that some of the 93 troops wounded in clashes with Serb demonstrators had "life-changing injuries." "This is unacceptable, the facts must be established. The perpetrators must face justice," said Stoltenberg. "I welcome that Serbia is prepared to cooperate in these efforts."

Stoltenberg also urged Serbia and Kosovo to engage "constructively" in a European Unionmediated dialogue that is aimed at normalizing relations between the former foes. Serbia does not recognize Kosovo's 2008 declaration of independence. Both Serbia and Kosovo have been previously warned by EU diplomats that refusal to compromise jeopardized their chances of joining the EU. Serbia's President Aleksandar Vucic said at a joint press conference with Stoltenberg that tensions in Kosovo were the result of increased pressure by the government there on the ethnic Serb

Pak court adjourns hearing of Nawaz's petition to revive appeals in graft cases

Pakistani high court on Aruesday adjourned till November 27 the hearing of former prime minister Nawaz Sharif's petitions to revive appeals against his conviction in the Avenfield and Al-Azizia corruption cases as he prepares to lead his party in the general elections. A two-member bench of

the Islamabad High Court (IHC), comprising Chief Justice Aamer Farooq and Justice Miangul Hassan Aurangzeb, took up the appeals for hearing and heard Sharif's counsel Azam Tarar and the legal team of the National Accountability Bureau (NAB).

The bench then adjourned the hearing until Monday and asked Tarar to present his arguments at the next hearing.
The 73-year-old three-time

prime minister returned to Pakistan on October 21 after about four years of selfimposed exile in London and was present in the court at the time of hearing. He is expect-



ed to lead the Pakistan Muslim League-Nawaz (PML-N) party in the general elections set to be held on February 8 next

Sharif arrived in court amid tight security. He was accompanied by his brother, ex-premier Shehbaz Sharif, and an entourage comprising senior PML-N leaders. The PML-N supremo was convicted and sentenced to 10 years in jail by an accountability court in the Avenfiled case in July 2018 for owning illegal properties in London

His daughter, Maryam Nawaz, was also sentenced to seven years in jail in the case but was acquitted in September 2022 along with her husband, Muhammad Safdar. The former premier was

also convicted in the Al-Azizia Steel Mills corruption case and sentenced to seven years in jail in December 2018 He challenged the sen-

tence, but the appeal process was halted as he was away in He was allowed to go to London in November 2019 on

medical grounds, and returned about four years later in October. The IHC declared him a proclaimed offender in both cases in December 2020. VThe former premier returned last month from London after about four years and approached the IHC to restore his appeals, which was duly

Li Qiang to attend virtual G20 leaders' summit

Beijing (PTI): China on Tuesday announced that Premier Li Qiang will attend the virtual G20 Leaders' Summit at India's invitation and hoped that the meeting will address global challenges through cooperation and make positive contributions to economic recovery.

The G20 virtual summit on Wednesday will take forward key outcomes and action points firmed up at the annual conclave of the grouping in September under India's presidency, the Ministry of External Affairs (MEA) in New Delhi said in

a statement. The summit will also delve into the impact of the Russia-Ukraine war and the Israel-Hamas conflict. It is also expected to push for the effective implementation of various decisions taken at the bloc's annual summit in New Delhi over two months

Germany's defense minister unveils more help for Ukraine with their lives," Pistorius said.

Terman Defence Minister Boris Pistorius vowed Tuesday to keep supporting Ukraine's efforts to win its war against Russia, pledging further military aid worth 1.3 billion euros (\$1.4 billion). The new support is to include further Iris-T SLM anti-aircraft missile systems as well as anti-tank mines and 155-millimeter artillery shells, German news agency dpa reported.

"We are talking about 20,000 additional shells," Pistorius said at a joint news conference with his Ukrainian counterpart, Rustem Umerov, in Kyiv, according to dpa.

Pistorius's unannounced trip to the Ukrainian capital came a day after U.S. Defense Secretary Lloyd Austin traveled to Ukraine and pledged American support "for the long haul," including an additional \$100 million in weapons from US stockpiles.

The visits appeared to be part of an international political effort to keep the war in the



public mind as other issues clamor for attention, including the Israel-Hamas conflict. Council

European President Charles Michel also arrived in Kyiv on Tuesday, which is the 10th anniversary of what Ukraine calls its Revolution of Dignity. That uprising brought momentous change for Ukraine, pushing it closer to the West and bringing confrontation with Moscow.

weeks after back-to-back earthquakes rattled the remote western mountain region killing over 150 persons, Nepal on Tuesday received the fourth tranche of emergency medical aid and equipment for the quake-affected families. "Fourth tranche of relief support comprising vital medicines & equipment for the earthquake-affected families reaches Nepal. India's humanitarian efforts continue to support people in Nepal," External Affairs Minister S Jaishankar posted on X along with photos of the relief material being handed over to Nepalese authorities

The latest tranche comes after five elderly people, including two women, who were staying in makeshift tents died last week due to harsh cold weather in Jajarkot district.

'Kabhi Khushi Kabhie Gham': UK **leader Starmer on FTA with India**

K's Opposition Leader Keir Starmer has described the ups and downs of the government's negotiations towards a free trade agreement (FTA) with India as 'Kabhi Khushi Kabhie Gham' and committed the Labour Party to pursuing an "always happy" bilateral relationship.

During his speech at a Diwali celebration in the Houses of Parliament complex in London organised by the British Indian think tank 1928 Institute last week, Starmer referenced the Bollywood box-office hit which translates as sometimes happy, sometimes sad. India and the UK are currently in the 14th round of FTA negotiations to bilateral trading partnership, with several expected completion points having passed.
"We will be rebuilding

Britain's reputation on the international stage and that means a new strategic partnership with India," said Starmer. "The Tories are working on

a free trade agreement, I think. It's all a bit stop-and-start. In fact, you could almost call the negotiations 'Khabi Kushi Khabhie Gham'. But Labour wants more than that - we want a deeper understanding. You can call it an always happy relationship. A relationship based on our shared values of democracy, aspiration and respect," he said.

The FTA talks began in January last year with Diwali



2022 set as the initial deadline by then prime minister Boris Johnson. Under the Prime Minister Rishi Sunak-led Tory government, no new timelines have been set but both sides are keen to get things signed off

before a general election year in India and the UK in 2024.

Meanwhile, the Opposition Labour Party, which is leading the opinion polls over the governing Conservatives ahead of the expected polls, is keen to

1.9 million strong Indian diaspora electorate.

"To British Indians, I want to express my admiration and respect for everything you do for our country. Without your efforts, this country would be diminished in so many ways,' said Starmer, who was joined by senior members of his shadow cabinet at the event last Wednesday.

Spalletti's plan for improving Italy after securing spot at Euro 2024

fter avoiding the dreaded playoffs, the "real work" starts now for Italy and coach Luciano Spalletti.

And that includes everything from drones and smartphone apps to dinners and difficult

Italy booked its spot in next year's European Championship with a 0-0 draw against Ukraine on Monday. A loss would have consigned the defending champion to the playoffs - a nightmare for a nation that missed out on the past two World Cups because of playoff defeats to Sweden and North Macedonia. Qualification was the minimum that was expected of Spalletti when he took over following Roberto Mancini's shock resignation less than a month before September's international

However, he started his tenure with a disappointing draw in North Macedonia before getting Italy back on track with a victory over Ukraine and playing like the Napoli team he had led to the Serie A title a few months previously.

'It's not easy to come in and immediately make the right choices, some things I learned after I started this new job and now I think I know a bit more, Spalletti said after Monday's match. "I came here to qualify,



not to find excuses if we didn't. "And the real work starts now, now I can really get working. When I accepted the role, I knew that I had to qualify."

With something to work toward next summer, Spalletti is planning more changes to the way the national team operates. He has already introduced an app that will allow the players to watch video lectures and tactical analysis even when they are away from the Italy training

He added on Monday that they will now also start training with a drone to ensure the Italy staff can upload the best possible images. Spalletti also has in mind a more

basic method for Italy to improve: getting to know his players. And he said he will not wait until the next international break in March to do so


"With the national team we want to try to get as close as possible to what happens at a club," Spalletti added. "We want to stay in contact, have the possibility to talk to each other and meet each other several times. I will go to watch team training sessions and then go for dinner with them to ask for their opinions.

We have serious players in this Italy team and I want to get to know them without that pressure of needing the result. Now I can get closer to them because they also have things to tell us."

To help his teams still further, Spalletti is hoping to schedule matches for March against tough opposition.

"I will ask for difficult friendly matches, the most difficult," he said. "That's also because many of these players need to get experience of playing against toplevel opponents, many of them don't play in European competition and so where would they build up this experience if not in these matches.

The last time Italy went to the European Championship after failing to qualify for the World Cup, it won the tournament beating England in the final at Wembley Stadium two years

The claim will come before an employment tribunal. Mendy last played for City in

Forld Cup winning skipper Pat Cummins, by his own admis-sion, has fallen in love with 50-over cricket all over again but the jury remains out on the future of the ODI format, whose relevance in modern-day cricket is being debated for some time now.

India is the heartbeat of world cricket and near-packed stadiums for majority of World Cup games over the course of 45-day long event was expected at the spiritual home of the game. It was not a surprise that India has delivered the most attended ODI World Cup

More than a record 1.25 million people thronged the stadiums but the same buzz and fanfare will most likely be missing when there is a bilateral series happening anywhere in the world including India.

The players and the purists love Test cricket while T20 is the format that enjoys unmatched popularity and is being used as a tool to spread the game The attention spans are shorter than

ever in the digital age and not all have the time and zeal to spend eight hours for an ODI game. The ICC event in India has shown that the format has plenty of takers if it is a world event but the bilateral ODIs don't

inspire the same confidence going That begs the question: Should ODIs



only be played in a World Cup year? If not, then should the format be tweaked on the advice of legends like Wasim

Akram and Sachin Tendulkar. The format is not high on priority for most teams with India featuring only in six ODIs next year and Pakistan don't have any match scheduled till November 2024 even though they host the Champions Trophy the follow-

ing year. During the World Cup, Akram opined that the format should be reduced to a 40 overs a side while Tendulkar wants to break the ODIs to four innings of 25 overs each to break the "monotony".

However, the comments of Cummins after the World Cup triumph on Sunday night were a good advert for the ODI format. Unlike the slam bang T20 format, ODI cricket is played in gears and does challenge the cricketers more. It is a challenge Cummins and his team enjoyed in a global event but the same can't be said about a bilateral contest.

"I must say, maybe because we won, I did fall in love with ODI again this World Cup. I think the scenario where every game really matters, it does mean a bit different to just a bilateral," he acknowledged.

"I mean, the World Cup's got such rich history, I'm sure it's going to be around for a long time. Yeah, there's so many wonderful games, so many wonderful stories within this last couple of months. So, I think there's definitely a place."

It will be used on a trial basis initially. The decision was taken at the International Cricket Council

(ICC) Board meeting here. The CEC agreed to introduce a stop clock on a trial basis in men's ODI and T20I cricket from December 2023 to April 2024. The clock will be used to

regulate the amount of time

taken between overs.

"If the bowling team is no ready to bowl the next over within 60 seconds of the previous over being completed, a 5-run penalty will be imposed the third time it happens in an innings," said the ICC in a state-

The ICC also made a change to its process of banning a pitch from international cricket.

'Changes to the pitch and outfield monitoring regulations were also approved, including a simplification of the criteria against which a pitch is assessed and increasing the threshold for when a venue could have its international status removed from five demerit points to six demerit points over a five-year period," the ICC added.



U19 World Cup moved from Lanka to South Africa

The ICC Board on Tuesday shifted the next year's men's Under-19 World Cup from Sri Lanka to South Africa, 11 days after the world governing body provisionally suspended the due to government interfer-

In fact it was Sri Lanka Cricket (SLC) that had reached out to ICC and notified about the government interference in the running of cricket in the country. SLC and the Sports Ministry have been at loggerheads for some time. The government has accused SLC officials of being involved in corruption and mismanagement.

"The U19 World Cup has been shifted to South Africa from Sri Lanka due to SLC's suspension. In fact, participating nations were apprised some days back after SLC got suspended. South Africa hosted the U19 WC in 2020. The decision got approval at ICC Board meeting in Ahmedabad," an ICC Board member told PTI. "Sri Lanka's bilateral and domestic cricket will not be affected by

SLC president Shammi Silva had recently warned that the country could lose the hosting rights of the U19 World Cup, scheduled to be held from government's interference con-In a statement released on

Monday, SLC had said," While SLC focuses on resolving the suspension issue, it appears that the minister of sports is pursuing a different agenda through media manipulation without pursuing legal avenues to address the allegations."
"This raises concerns about its

intention to influence public opinion and other stakeholders to achieve its objective of taking control of SLC through the misuse of his powers.

"SLC calls for a fair and unbiased examination of the facts and remains focused on its mission to uphold the integrity of cricket in Sri Lanka and is confident that the truth will prevail in due

Legendary coach Arsene Wenger on Tuesday committed himself to "digging out talent" in India and place the country on world football map, as he inaugurated the FIFA-AIFF academy here.

Former Arsenal coach Wenger currently serving as FIFA's chief of global football development, did not give any time frame when India would start producing "great players" but made it known that without proper grassroots development, the country will remain as it is

"Our project is to identify talent in India, to put the best talent together, give them a good coaching programme, give them a good education and a good level of competition and make them great players," Wenger

"Our huge effort is to dig out talent and make them as good as they can be," he said after witnessing the signing of MoU between the All India Football Federation (AIFF) and the Odisha government.

Fifty under-14 players — including 15 from Odisha — will be selected by the FIFA coaches in the first batch and they will get training at the academy for two

Odisha government will take care of the boarding, lodging, accommodation and education of the players, and FIFA will provide the technical know how and the coaches.

FIFA has already recommended Spain's Sergi Amezcua Fontrodona — who was previously involved with developing football in China as project director — to be the academy head coach for two years and an Indian will assist him for a few

A foreign assistant coach will be appointed in four-five months. "With such a huge population, the potential in India is huge, for you to be on top of the world. That is what we want to achieve together. How long will it take, I don't know," Wenger said.

"But one thing is for sure, if we don't educate we will be where we are at the moment. With the quality of education, you get great players. Our target is to develop top level players here and get India on the map among the best countries in the world, said the celebrated coach.

He emphasised the necessity of catching players young if the country wants to reach the top

"No country has more right over another country to be on the top of world. It's just down to edu-



cating your children (in foot-

"India is a country which has invested a lot in education. It is a job you have to learn like any other job. And unfortunately, it starts at a very young age, you cannot start playing football at 15 years of age, you have to start at 5 or 6 years of age."

Wenger made a round of inspection of the academy, which is up for running with top-class facilities. It was initially planned as an Odisha state football acade-

"We just visited the facilities, the qualities of infrastructure are great. We delegate our own coach and develop a system over the years

"Hopefully in the future, we will be rewarded if we do well. Our focus now is give this academy first and get the first players out

in three-four years who can play at the top later." Wenger and his team took stock

of the facilities at the academy like the dormitories, dining area, study rooms, coaches rooms and common areas. AIFF president Kalyan Chaubey said that India can qualify for the FIFA U-17 World Cup on merit

 through the players coming out of this academy. India had featured in the 2017 FIFA U-17 World Cup as host country. "Let us dream to qualify for the Under-17 World Cup on merit.

We must try to become one of the best in the U-17 age group and thereafter we can think of becoming one of the top countries in the world.

"We will get our best national team in under-17 category in the coming three years.

Odisha Sports Minister Tusharkanti Behera said he hoped the academy will produce players who will make the state and country proud.
