Rajouri gunbattle ends, top LeT terrorist killed

The Indian Army on Thursday neutralised both terrorists, including a top Lashkar-e-Tayyeba (LeT) commander, at the conclusion of a fierce 30-hour-long gunfight in the Baiimaal forest area of Dharmsal in Rajouri district. Meanwhile, another paratrooper succumbed to his injuries, taking the toll of fatal injuries among Army personnel to five.

So far, a total number of nine elite para commandos have sacrificed their lives in the Rajouri district alone this year Seventeen security personnel have been 'killed in action' since April 2023 in four similar strikes by the terrorists in Jammu and Kashmir. Captain MV Pranjal and

Captain Shubham Gupta, along with Havildar Abdul Majid, and two jawans Lance Naik Sanjay Bisht and Paratrooper Sachin Laur, sacrificed their lives in the line of duty during the two-day-long operation. According to a Jammu-based Defence spokesman, the mortal remains of the martyred Army personnel will be airlifted to their native places on Friday morning after receiving last respects from Lieutenant Governor Manoj Sinha and senior Army officers of the Northern Command and White Knight Corps.

Captain MV Pranjal from Mangalore, Karnataka, is survived by his wife, Aditi G Muddebihalkar. Captain Shubham Gupta from Agra is survived by his parents and a

younger sibling. Havildar Abdul Majid, from Ajote village of Poonch, is survived by his wife, Sagera Bi. Lance Naik Sanjay Bisht from Halli Padli in Nainital is survived by his mother, Manju Devi. Paratrooper Sachin Laur from Aligarh is survived by his mother, Bhagvati Devi.

According to official sources, the overnight gunfight resumed on Thursday morning.

Additional troops were rushed to the encounter site to maintain a tight cordon to prevent hiding terrorists from fleeing the area. The Army personnel also pressed drones to pinpoint the exact location of the terrorists hiding in the thickly forested area of Bajimaal.

The movement of the local residents in the area remained restricted due to heavy exchange of fire. The educational institutions remained

closed on Wednesday and Thursday during the operation. As the crack teams of the Indian Army tightened the cordon and zeroed in on the location of the terrorists at a

His associate has also been killed during the ongoing operation but his identity could not be ascertained immediately. The dead bodies of both the terrorists have been retrieved and taken for further medicolegal formalities by the police. According to police, Qari has been active in Rajouri-Poonch. along with his group since last According to security forces, Qari was also believed to be the mastermind of the Dangri & Kandi attacks in the region. The slain terrorist was sent to revive terrorism in the Pir Panjal region

According to Defence sources, Qari was an expert in handling IEDs and was operating from the natural caves.

He was also a trained sniper. During his stay in the upper reaches of Rajouri, the Lashkare-Tavveba commander frequently visited local places and often interacted with the local population. fronically, on November 19, his

visit to a local religious place in the Bajimaal area of Rajouri turned out to be his last outing. His cover was blown over as some of the local residents recorded his meeting with a group of women and later tipped off the security forces following which the operation was launched to flush them out. Jammu and Kashmir BJP chief Ravinder Raina on Thursday reached the Bajimaal area in Rajouri and condemned Pakistan's support to mercenaries to carry out an "ambush" on the Indian Army.

We condemn it. Some of our Army personnel achieved martyrdom in an ambush laid by the terrorists," Raina said.

Calling it to be a heartening incident, the BJP leader said, "Some people don't want peace and normalcy to prevail. They want to derail the movement of development. They want to trigger fear of psychosis. We have jointly fought them and failed them."

Delhi despite GRAP easing

As the air quality in Delhi continued to hover in the very poor category on Thursday, the Delhi Government decided to continue the ban on the BS3 and BS4 petrol and diesel cars despite GRAP-4 measures being relaxed by the Central

Delhi Environment Minister Gopal Rai said, "The way wind speed is low, scientists believe that it can improve further. The government has taken the decision that until air quality improves, GRAP 3 will continue in Delhi."


The minister added the restrictions under GRAP IV have been modified and now include a ban on BS 3 petrol and BS 4 diesel vehicles with All India Permit, which were allowed to enter Delhi earlier.

The Air Quality Index (AQI) crossed 400 in several places in Delhi at 9 am, but settled at 390 by 4pm, said the Central Pollution Control Board. At least 15 out of 38 monitoring stations of the Central Pollution Control Board recorded AQI in the "severe" category on Thursday, while 22 monitoring stations recorded AQI in the "very poor" category. NCR too reported unhealthy air. GRAP Stage III requires a total

halt to all construction and demolition operations, with the exception of critical government projects, mining, and stone crushing.

Delhi on Thursday recorded the season's lowest minimum temperature at 9.2 degrees Celsius, two notches below the season's average.

BS3 BS4 cars off limits in Uttarkashi rescue op too close still too far

The effort to bore through the debris of the collapsed Silkyara tunnel faced another setback on Thursday. The operation was once again paused as cracks emerged in the platform supporting the drilling machine, presenting a new challenge in the ongoing rescue mission for the 41 workers who have been trapped inside for 11

The setback occurred just hours after the operation resumed earlier in the day. The resumption followed a six-hour delay to address an obstacle, a steel girder obstructing the auger machine's path encountered late Wednesday night. This marks the third interruption in the drilling process since the multi-agency rescue mission commenced on November 12, prompted by the collapse of a section of the under-construction tunnel

along Uttarakhand's Char Dham route.

According to one official the drilling was stopped on Thursday to "stabilise" the platform on which the 25-tonne drilling machine is mounted. Some cracks apparently appeared in the structure, but there was no official confirmation. In the afternoon, a government

press statement in Delhi said minor vibrations were noticed at 1.10 pm and the auger was being pushed slightly back to "reassess the force to be applied". It said the operation will then restart. Before the setback, officials

of the operation ending during Thursday night, provided no more obstacles emerged during the drilling as it entered the last stretch of 10 to 12 metres. "I expect that in the next few hours or by tomorrow, we will

be successful in this operation,"

Rajasthan campaign ends

BJP challenges Congress on crime, appeasement, graft

The high-pitch electoral campaign in Rajasthan for the November 25 Assembly elections came to an end on Thursday evening with the BJP going all out to wrest power from the Congress, which is trying to end the anti-incumbency trend.

While the ruling Congress focused its election campaign on the works and performance of the Ashok Gehlot Government, its schemes and also banked on the promise of seven guarantees if the party retains power, the BJP attacked the Congress on issues of crime against women, appeasement, corruption and the paper leak. Rajasthan has 200 Assembly seats but polling will be held in 199 seats as the Congress candidate from Sriganganagar's Karanpur seat Gurmeet Singh Konoor passed away. There are 5,25,38,105 voters in the 199 Assembly constituencies.

The Election Commission has directed that any political person who is not a voter or candidate of that constituency or is not an MP or MLA cannot stay in that constituency after the election campaign is over.

Booming wedding season kickoff revs up business

 $B_{\text{nesses}}^{\text{ands, baja, and related businesses}} \ \text{had a hectic but} \\ \text{profitable} \ Thursday evening}$ as more than 40,000 weddings took place in the national Capital, marking the beginning of the marriage season from Dev Uthan Ekadashi. The day is considered the most auspicious for the solemnisation of marriages in India.

From the ghoriwala, tents, banquet halls, and jewellry to caterers, the marriage ecosystem brought in more than ₹10.000 crore on the first day. The Delhi region is likely to host 3.5 lakh weddings till December 15, generating a business of more than ₹1 lakh

Starting from November 23, Dev Uthan Ekadashi, the wedding season will continue till December 15. Stars align auspiciously on dates such as November 23, 24, 27, 28, 29, and December 3, 4, 7, 8, 9, and 15, drawing couples to tie the

Following a brief hiatus, mid-January will mark the onset of another phase of wedding festivities lasting till July 2023. Goods trade estimates show a diversified distribution with textiles and garments (lehnga, sherwani, sarees) constituting 10 per cent, jewellry at 15 per cent, electronics and consumer durables at 5 per cent, food items at 5 per cent, groceries and vegetables at 5 per cent, gift items at 4 per cent, and miscellaneous items at 6 per cent. The services sector is also expected to flourish, with allocations of 5 per cent for ban-

quet halls, hotels, and other



event management, 12 per cent for tent decoration, 10 per cent for catering services, 4 per cent for flower decoration, 3 per cent for travel and cab services, 2 per cent for photo and video shoots, 3 per cent for orchestra and band services, 3 per cent for lights and sound, and the remaining 3 per cent

for miscellaneous services. Rajesh Lochav, a city-based wedding planner, who himself is managing eight marriages, said if Delhi-NCR is divided into North, East, South and West, there are around 200 marriage venues, 5 per cent for farmhouses in every zone.

Every farmhouse has two-three

"Other than this, there are hotels, community centres, public grounds and lawns. When we get multiple requests for a particular date, and also find that our vendors are already booked on that same day, we figure out that it is a busy day," Lochav said.

However, challenges surfaced with a scarcity of ghoriwalas, bands, and banquet halls, impacting hundreds of wed-For commuters in Delhi , it was

just another day of crazy traffic, especially in the evening when the baraats were out on the roads. The traffic was at its peak between 7:30 pm and 9:30 pm as people took out marriage processions on main roads. Dhaula Kuan, Karkardooma, Chattarpur, Sardar Patel Marg, Anand Vihar, and ITO among others witnessed heavy traffic. Other areas like Punjabi Bagh, Subhash Nagar, Tilak Nagar in West Delhi also witnessed heavy traffic congestion due to marriages. Amid the ongoing marriage season in Delhi, the traffic police said they have deployed adequate number of personnel on the roads especially in specific parts of the city where banquet halls, hotels and community centres are

Vedic scholar and chairman of Astrology Science and Veda Gyan Committee Acharya Durgesh Tare said Dev Uthani Ekadasi is the day when lord Vishnu wakes up from his sleep, which is considered most auspicious day for marriages. Tulsi Vivah ceremony is organised with full rituals on this day which is auspicious for Hindus.

Confederation of All India Traders (CAIT) general secretary Praveen Khandelwal estimated a staggering ₹10,000 crore in wedding-related businesses on the day.

"Hotels, banquet halls, farm houses, public parks, community centres, dharamshalas and all other types of public places in all parts of Delhi have been booked well in advance due to fewer auspicious dates for marriages in November and December," he added.

The wedding industry saw a surge in bookings for venues, while wedding planners noted a rise in demand for various services like bands, catering, decoration, music groups, hotels and event management. This surge also offered temporary employment opportunities for college students during the wedding season.

Govt acts against Deepfake menace, law within 10 days

mid the concerns raised by A mid the concerns raised o_j Prime Minister Narendra Modi on deepfakes and misuse of Artificial Intelligence (AI), the Centre on Thursday announced to enforce new regulations within 10 days that may impose penalties on both creator and platform hosting deepfakes.

Addressing a press conference after a meeting with experts in the fields of Artificial Intelligence, social media plat-forms, and Nasscom, IT and Telecom Minister Ashwini Vaishnaw said, "Deepfakes have emerged as a new threat to democracy. These (can) weaken trust in society and its institutions. We will start drafting the regulations today itself and within a very short timeframe, we will have a separate regulation for deepfakes. Within the next 10 days, we plan to unveil a clear and actionable plan, structured around the four pillars."
Asked if there will be a change

in the existing rule or new law may be brought, he said, "We can bring this in the form of making amendments to the existing rules or we can bring a new set of regulations."

India has over 80 crore internet users, which are projected to cross 120 crore in two years. Deepfake is a piece of technology that leverages AI to alter a person's appearance, voice, or actions in a way that can be realistic and challenging to discern from authentic, unaltered content. Recent deepfakes have brought to the fore the urgency of a regulatory framework for AI in the new Digital India law.

Amid some celebrities reporting their faces being manipulated onto another video, new protection regulations being considered will look at measures including watermarking AI-generated content, deepfake detection, rules for data bias, privacy and guards against

Vaishnaw said the Centre would come up with actionable items on four pillars: detection of deepfakes, preventing the spread of such content, strengthening reporting mechanisms, and spreading awareness on the issue.

concentration.

"All stakeholders present at the meeting shared similar concerns regarding deepfakes. All social media platforms agreed to have extensive technology to detect deepfakes," the Minister said.

He said deepfake advertisements or misleading promo-tions are a threat that Indian society is facing currently.

'The use of social media ensures that deepfakes can spread rapidly in a more significant manner without any check and go viral. This is why we need to take urgent steps to strengthen trust in society and our democracy," he said.

Deepfakes shot into prominence after actor Rashmika Mandanna's face was found to have been used in an embarrassing video earlier this month.

Last week, Prime Minister Narendra Modi also warned about the threat deepfakes pose. Vaishnaw too had warned social media platforms would lose the immunity they enjoy under the "safe harbour" clause in the Information and Technology Act if they fail to take measures against deepfakes. The clause states that an online platform cannot be held accountable for the content shared on it by users. Next meeting on the subject will be held in the first week of December. Farmers to Shinde: Sell our organs to recover loans

n a shocking development, ten debt-trapped farmers from Goregaon village of Hingoli district in Marathwada region have written to Maharashtra Chief Minister Eknath Shinde, offering to "sell off" their body organs to clear the outstanding loans taken by them from local banks or private lenders.

In a letter written to the chief minister, the farmers have offered to "sell off" their eyes, liver, kidneys and other organs to raise funds to repay the loans from local banks and money lenders.

The ten deb-ridden who have written a letter to the chief minister are Deepak Kawarkhe (Rs. 3 lakh), Namdeo Patange (Rs.2.99 lakh), Dheeraj Mapari (Rs.2.25 lakh), Gajanan Kawarkhe (Rs.2 lakh), Rameshwar Kawarkhe, Ashok Kawarkhe, Gajanan Jadhav (Rs.1.50 lakh each), Dashrath Mule (Rs.1.20 lakh), Vijay Kawarkhe (Rs. 1.10 lakh), Rameshwar Kawarkhe (Rs.90,000).

Confirming the development, one of the signatory farmers Gajanan Kawarkhe said that he and other farmers from Goregaon had submitted the letter addressed to the chief minister to Sengaon tehsildar and the Goregaon police station to be forwarded to the state government. "They accepted our letter and agreed to forward letters to the chief minister. We have not yet received any response from the government yet," Kharake said. Kawarkhe said that apart from themselves, the wives, children and other family members of the farmers had also volunteered to sell their body organs, limbs, etc, to avoid continued harassment by local banks and private money lenders.

130 rescued from 24-storey Mumbai building on fire

s many as 130 residents Awere rescued and evacuated from a 24-storey building at Byculla in south Mumbai, after a major fire swept through the high-rise structure in the wee hours of Thursday.

Of the rescued residents, 11 persons who suffered acute suffocation have been admitted to the KEM, JJ and Nair Hospitals in the city. "The con-

dition of the hospitalised persons is stable," a spokesperson of the Brihanmumbai Municipal Corporation (BMC)

The fire broke out in the Building No 3 C Wing at MHADA Colony in the Rambhau Bhogle Marg at Ghodapdev at Byculla at 3.45 am.

The fire was initially confined to the electric meter cabin, electric wiring, electric cable and electric installations. It spread

to scrap material in electric ducts, garbage, and refuse material kept in duct rooms of first to the 24th floors of the building.

'Twenty persons were evacuated from the terrace, while 30 others were brought down from the 15th refuse floor. Another 80 persons were rescued from the 22nd refuse floor," a senior Disaster Management Unit official of the BMC said.

Akin to Jizya tax: Union Minister demands ban on halal products in Bihar Dharma. Yet its own leaders in

Union minister Giriraj Singh asked Bihar Chief Minister Nitish Kumar on Thursday to ban the sale of "halal-certified" products, calling it a "jihad" aimed at the "Islamisation of businesses".

Singh, who represents the Begusarai constituency in Bihar in the Lok Sabha, also shared on X a copy of a letter he wrote to Kumar on Wednesday, urging him to take a leaf out of the Yogi Adityanath government's book in neighbouring Uttar Pradesh.

'The sale of halal-certified products is akin to the Jizya tax that was imposed on non-Muslims in the medieval era. Previous governments of the Congress and its allies put up with this because of vote-bank concerns and politics of appeasement," the Union rural development minister said on Thursday

"The 'tukde tukde' gang has made it possible for such products to be available in every nook and corner of Bihar. Halal certification involves Quran, just like consecration through mantras in Hindu tradition.

'Sanatan Dharma is under attack. Unbridled sale of Halal products will pave the way for Sharia rule," he said, claiming that this phenomenon is also "linked to terrorist activities". Meanwhile, the ruling Janata Dal (United) in Bihar hit back at the Bharatiya Janata Party (BJP), accusing it of "hypocrisy" in matters like beef consumption.

"The BJP claims to be the

Inebriated 16 years old stabs teen 55 times, drags body through street

An apparently inebriated 16-year-old stabbed another teen more than 55 times, slit his throat, dragged the body through the street and did a jig while he carried out the grisly crime in East Delhi's Welcome Colony earlier this week, police said on Thursday.

Some of the horrifying details of the killing in Janta Mazdoor Colony on Tuesday were captured on CCTV, the 2.23 minute footage also showing the accused threatening those around him.

The accused, who was taken into police custody on Wednesday morning and has confessed, did not know the 17year-old who he had approached for money to buy biryani, officials said.

"We have already recovered the weapon used for murder. We are investigating from where he procured the knife," Deputy Commissioner of Police (northeast) Joy Tirkey said.

Nigambodh Ghat charging exorbitant fees, probe ordered

One of the oldest crematori-ums in Delhi-NCR, Nigambodh Ghat located on the banks of the Yamuna river at Kashmiri Gate, has been found charging exorbitant amounts for a speedy cremation and the firewood for funeral pyres, an official aware of the development said on Thursday. Mayor Shelly Oberoi has ordered an inquiry into this and asked for a report from officials. The matter came to light dur-

ing an inspection of the ghat by the mayor on Thursday. According to the Municipal Corporation of Delhi (MCD) official, several NGOs were found charging a hefty amount from the family members of the deceased in the name of last rites, violating the provisions of the memorandum of understanding that governs its functioning.

During her surprise inspection, people complained that extortion was being made from People said that stone plate in the names of the deceased are being installed by taking money illegally. Whereas such permission has not been given by MCD. MCD space is being



People are being charged up to Rs 5 lakh each for installing a name plate. Apart from this, the people present there told that money is also being taken in the name of VIP cremation.

The official said wood from peepal trees is being used for cremation for an additional amount of money. Peepal wood is prohibited. During the inspection, the

2 Uttarakhand natives arrested with 248 kg cannabis

"Besides the two accused, who hail from Udham Singh Nagar in Uttarakhand, one more person, who hails from Moradabad district in UP, is associated in the case but is at large. Efforts are on to arrest him also," the officer said. According to the police, 248 kg of ganja was found "hidden" underneath a stack of cables loaded on the truck, which had

'Establish safeguards for use of technology in legal proceedings'

Aparliamentary panel, which examined the three proposed criminal laws, has hailed the move to enhance the use of technology in legal proceedings but said the adoption of electronic means for communication and trials should proceed only after the establishment of robust safeguards. The Parliamentary Standing

Committee on Home Affairs, headed by BJP MP Brij Lal, also said enabling online or electronic FIR registration is a positive step forward but these should be allowed only through modes specified by the state. "The committee notes that the

Sanhita provides for acceptance of trials in electronic mode as provided in 'Clause 532' wherein all trials, inquiries, and proceedings may be held in electronic mode by production of electronic communication devices, likely to contain digital evidence, for investigation,

"Electronic communication includes communication through devices such as mobiles, computers, or telephone. The committee notes the enhanced technological integration in the Sanhita, emphasising increased utilisation of technology in legal proceedings, and considers it as a welcome change," it said.

According to Clause 532 of the Bharatiya Nagarik Suraksha Sanhita, "all trials, inquires and



proceedings under this Code -- including summons and warrant, issuance, service and execution thereof; holding of inquiry; examination of complainant and witnesses; trial before a court of session, trial in warrant cases, trial in summons-cases, summary trials and plea bargaining; recording of evidence in inquiries and trials; trials before high courts; all appellate proceedings and such other proceedings, may be held in electronic mode, by use of electronic communication or use of audio-video electronic means".

while the increased utilisation of technology offers numerous advantages, it also creates opportunities for manipulation and misuse. The collection and storage of electronic evidence raise concerns about data security and the possibility of unauthorised access or breaches, the panel said.

"The committee, therefore, recommends that the adoption of electronic means for communication and trials should proceed only after the establishment of robust safeguards to ensure the secure usage and authentication of electronically available data.

This will help safeguard the integrity of the justice system and ensure that justice is administered fairly and accurately," it said.

The panel said allowing any form of electronic communication for FIR registration can create logistical and technical challenges for law enforcement. Moreover, it could become difficult to track all the FIRs filed, especially if, for example, sending an SMS to any police offiinformation within the scope of

Clause 173. The Bharatiya Nagarik Suraksha Sanhita (BNSS-2023) bill was introduced in the Lok Sabha on August 11 along with the Bharatiya Nyaya Sanhita (BNS-2023) and the Bharatiya Sakshya Adhiniyam (BSA-2023) bills. The three proposed laws seek to replace the Code of Criminal Procedure Act, 1898, the Indian Penal Code, 1860, and the Indian Evidence Act, 1872, respectively.

With large hydel power projects being blamed for the disasters in the fragile zones of Himalayas and Northeastern States, the Government is working on a strategy to make the Small Hydro Power (SHP) Projects-- those plants which have a generating capacity of below 25 megawatt (MW)-- more environment-friendly. The move follows growing

protest from locals against several Small Hydro Power (SHP) projects in various States, with activists pointing out that the structures were being constructed without following environmental norms.

To begin with, the Union Environment Ministry may soon set up a committee for framing Standard Operational Procedure (SOP) for development of the SHPs in an ecofriendly manner. The committee will comprise members from Ministries from Environment, Jal Shakti, Power besides State Governments and expert institutions.

The TB ACF campaign was launched in the district under the National Tuberculosis Elimination Programme (NTEP) and Pradhan Mantri TB-Mukt Bharat Abhiyann. On this occasion, a public awareness rally was taken out from the CMO office premis-

The CMO said that all preparations have been completed to make the campaign successful. Thawing out

Israel and Hamas declare four-day cease-fire, but it is still a long road to lasting peace

fter being at each other's throat since October 7, besides causing untime-Aly death to thousands of civilians on both sides and putting global peace in grave peril, Israel and Hamas have showed wise counsel in agreeing to a four-day cease-fire. The truce, though temporary for now, is indeed a hopeful step towards de-escalation and fostering an environment conducive to further negotiations between the stubbornly warring sides. Realistically, it would be premature to say that this development would end the hostilities and normality would soon be restored. The Israel-Hamas conflict has a long, bloody and complex history, rooted in territorial disputes, historical grievances and differing political visions. Even the recent flare-up of violence was triggered by a series of events. The immediate provocation was of course the 500 rockets launched by Hamas, leading to the death of over 1,000 Israeli civilians. Israel lost no time in retaliating hard and



pummeled Gaza, not sparing even civilian targets like hospitals. The cycle of violence since then has resulted in significant loss of life and widespread destruction, prompting international concern and calls for a cease-fire. The cease-fire brokered by international mediators comes as a major respite. During these four days, both sides have committed to halting all military operations, including airstrikes and rocket attacks. The cease-fire is expected to provide an opportunity for humanitarian aid to reach those in need and for diplomatic efforts to gain traction.

While the announcement of even a temporary halt in hostilities is a positive sign, it is important to note that the underlying issues that fuel the conflict remain unresolved. The cease-fire serves as just a pause rather than a comprehensive solution to the deep-rooted problems plaguing the region for decades, but the world community has correctly welcomed it as it opens at least a window of opportunity for peace to return to West Asia. The UN and other diplomatic channels have played a crucial role in facilitating dialogue between Israel and Hamas. Efforts are underway to lay the groundwork for more extensive negotiations that could address the core issues of the conflict. The pause allows both sides to reassess their position and consider the broader implications of a continued conflict. International pressure is likely to intensify during this period, urging them to engage in meaningful dialogue and work towards a lasting solution. Despite the optimism surrounding the temporary truce, challenges remain: Deep-seated grievances, historical animosities and complex geopolitical realities pose significant obstacles. Achieving a comprehensive and sustainable resolution will require the commitment of all stakeholders as well as a willingness to make difficult compromises in the interest of long-term stability.

Calling names will not help



It's time leaders of the US and China stopped wincing or winking away from the real issues related to sustainable development goals

hina is said to be the closest to Russia in the last 70 years and was taken aback by the strength of the reaction of the West to the Russian invasion of Ukraine. That has led to an unexpected isolation of China on an international level, which the latter had not anticipated. Now it is trying to mend its ties with the US in order to boost its sagging economy. The US too looks towards safeguarding the interest of its big industrial houses and mending fences. The visit of the Chinese President to the US was a step in that direction.

Was the trip of Chinese President Xi Jinping aimed at earning U.S. policy concessions? Was it aimed at easing bilateral tensions which may allow more focus on economic growth? Did it look for a chance to woo foreign investors who now increasingly shun China? Was it aimed at convincing the US to look the other way while China tries to gobble up Taiwan? Was the trip successful in any of these endeavours? As the US President refused to back down on his earlier comment of calling 'Xi' a dictator, has the visit rather soured ties even more? Well, these are some of the questions the visit has thrown at the watchers of geopolitics across the world.

The reaction of US Secretary of State Antony Blinken to a comment by Joe Biden that he still considers Xi Jinping a dictator has brought to the fore answers to some of these questions. It apparently seems that the US wants to desperately improve economic ties with China because of its own compulsions, however, the political divide is too big to bridge. On one hand, the US has over a period of time scaled down from its earlier positions of 'Economic Decoupling' to 'Economic De-Risking' and now to 'Constructive Engagement', but the ideological and political divide with the Communist state of China persists. The stakes at the meeting were high, as the two global powers did not see eye to eye on various issues. The Uninese severed military-to-military contacts with the United States after the then-House of Representative Speaker Nancy Pelosi visited India has been out of this pow-



Taiwan in August 2022. The contact has been restored now to avoid miscalculations between the two militaries. Relations between the two countries have been frosty for some time now with China sending a spy balloon to hover over the US skies and Biden ordering it to be shot down. Many top Biden administra-tion officials have since visited Beijing and met with their counterparts to rebuild communication and trust which culminated in this visit by Xi Jinping to the US. However, the 'Dictator' remark by the US President has put things back to square one and that was clearly visible in the anguish of Blinken's reaction. China and the US have taken positions that are outrightly opposite of each other on various issues of strategic and military importance at various international forums including the United Nations.

War in the Middle East has furthered the divide between the two countries, as China continues to have strong ties with Iran, whereas the US continues to bomb Iran-backed forces. Convergence of Chinese and Russian ideology which is totally divergent to the NATO strategy is likely to further the gulf between the two countries in the days to come. The visit therefore has not effectively addressed any of these issues.

rightfully so, however as China continues to show greater presence in the Indo-Pacific, ing military assets can not be downplayed. For one thing, China of late has become restless and reactive which was rarely the case about a decade or two ago. Make no mistake, China is making moves that are typical of a country that has an authoritative ruler, irrespective of what Joe Biden may have said or not said. India needs to deliver on its commitment of not only being 'Atmanirbhar,' but also its endeavour to emerge as a global hub of manufacturing. Manufacturing in the defence sector would be the key in the years to come to provide stability to the Indian Ocean and the Indo-Pacific.

There are many positive things that have emerged from Xi's visit to the US. One of them is in the direction of environmental conservation. The US and China, two of the world's biggest polluters, agreed to pursue efforts to triple renewable energy capacity globally by 2030 through wind, solar and other renewables. China and the US would keep engaging at various forums and keep coming to stop-gap arrangements to suit each other's interest, but the bottom line remains that China is not a democracy and the will of the people of China is not truly

represented in its day-to-day functioning. China is ready to negotiate to make its economy recover and as soon as it recovers, the negotiations may become even more difficult. The bulk of the focus of Chinese negotiations as a run-up to the Xi-Biden meeting revolved around how China is the safest place for US compa-

nies to come and invest. It's time leaders of the US and China stopped wincing or winking away from the real issues related to sustainable development goals. It's also time when the larger good of humanity must take centre stage and a workable mechanism to stop wars and unrest is worked out.

The US and China should look at how the United Nations must become more relevant in conflict situations rather than working out how and what they can veto to suit each other's agenda. They should also keep in mind that there should be enough space for everyone to grow and prosper in this world not just the US and China. Maybe next time the two leaders should consider discussing how to stop unrest and terrorism of all kinds in the world rather than how much should corporate leaders pay to meet the head of a country.

Both are working closely to bring greater stability in the Indo-Pacific region

India and Australia got into a 2+2 dialogue this week, right after a heartbreak, for the World Cup hosts' and crowd favourites India, whose luck perhaps ran out on the 11th match/hour. India may have lost the World Cup to the mighty Australian cricket team, but it is back at the table to discuss business about the gated globalisation with Australia on the geoeconomic front.

India and Australia signed on an interim Australia-India Economic Cooperation and Trade Agreement (ECTA) last December. This set the stage for greater economic cooperation between the two countries from the QUAD group to shed their age-old inhibitions, and come together in the vast Indian Ocean Region against the bully in the backyard of China. Commenting on the signing of ECTA in December Union Commerce and Industry Piyush Goyal had said "There is a lot of potential for exporting finished goods to Australia, since they hardly manufacture anything, they are largely a raw material and intermediate producing country, we will get cheaper raw materials which will not only make us more competitive globally but also enable us to serve Indian consumers better; enabling us to provide more quality goods at more affordable prices.

Australia, which is largely dependent on imports, will benefit hugely, they will soon start seeing a lot more finished goods coming in from India, providing a huge amount of work and job opportunities in both goods and services, provided by Indian talent. The Agreement will also eliminate Double taxation on IT services which was making us less competitive and making us less profitable in the IT sector, the double taxation has now been removed by amending the law, and from 1st April, double taxation for the IT sector will be over, we will save millions and millions of dollars right now, and over a billion dollars going forward, maybe



5 - 7 years going forward, giving us competitive edge and also creating a lot many jobs. I appreciate the Australian government for being very sensitive and considerate, giving us full cooperation throughout the negotiations, especially in protecting the interests of the farmers and dairy sector of India.'

The ECTA is likely to be upgraded to a Comprehensive Economic Cooperation Agreement (CECA) which will provide more areas of economic play between Australia and India. The ECTA framework has already provided a huge fillip for Indian exports to Australia, where data reveals that nearly eight per cent of Indian exporters have utilised the concessional tariff lines available. This has also pushed India's exports to Australia by nearly 17% on a year-on-year basis, making India one of the important trade partners. This week the defence and external affairs ministers of both countries discussed in detail the expansion of bilateral defence cooperation, including intelligence sharing, maritime awareness and emerging technology, such as AI, and cybercrime cooperation. Foreign minister S Jaishankar highlighted post the dialogue, the message of stability Australia and India, closely working together are sending out in the greater Indo-Pacific region, where China is getting aggressive with many of its immediate neighbours. It was no surprise that the Philippines almost simultaneously was complaining of China's belligerent behaviour in the ocean, in their backyard, and reiterating the need to respect the United Nations Convention on the Law of the Sea.

India and Australia work closely as the QUAD countries along with the US and Japan, to bring greater economic and strategic cooperation for stability in the Indo-Pacific region. Each of the QUAD countries has strong bilateral relations among themselves too. With China threatening to unilaterally change the world order, especially through military and sophisticated technology use, the World Cup for geo politics in the Indo-Pacific would go to teams from countries (especially in QUAD) who work more

Giving a safe passage to delinquent SEZs



Development of Enterprise and Service Hubs (DESH) bill, gives a 'safe passage' to all those SEZ units that haven't been able to fulfill their export commitments

he government is planning to make a few amendments to the Special Economic Zones (SEZ) Act 2005 in the winter session of Parliament, with a view to giving more operational flexibility to units in these tax-free enclaves, especially when it comes to sales in the domestic tariff area

It had intended to overhaul the SEZ regime by bringing in the Development of Enterprise and Service Hubs Bill (DESH) announced in the budget for 2022-23. Since DESH is facing delays, the government is keen to address some of the concerns under the extant regime by making amendments. The SEZs policy was launched in 2000 followed by the passage of the SEZs Act (2005) by Parliament in 2005. Intended to attract Foreign Direct Investment (FDI) for facilitating rapid economic growth, the Act sought to establish certain designated areas within the territory of India (call them enclaves) which are subject to different economic regulations than other regions within the country.

An enclave is treated as a 'territory outside the customs territory of India' for the purpose of authorised operations in the SEZ. Such exclusive demarcation makes entities in these areas eligible for a host of fiscal incentives. An SEZ developer or a unit located therein gets a 100 per cent Income Tax (IT) exemption on export income for the first 5 years, 50 per cent for the next 5 years thereafter and 50 per cent of the ploughed back export profit for the next

As for indirect taxes, because SEZs are considered to be located in a foreign territory, all transactions with them are classified as exports and imports - in the same way as transactions with a foreign country say, Germany. Their tax treatment flows from this fundamental premise. Thus, any supply of goods or services or both to a SEZ developer/unit is considered as export hence, zero-rated under GST which means these supplies are exempt from levy of GST. The SEZ units don't also have to pay customs duties or other levies on imports like anti-dumping, countervailing safeguard duties etc.

The SEZ developers and units located therein are exempt from seeking licenses or other regulatory compliances for undertaking import/export (for instance, there is no routine examination by customs authorities of the cargos) which the enterprises in the Domestic Tariff Area (DTA) – an acronym for all units located within the territory of India other than SEZs – are normally sub-

SEZs are equipped with state-of-the-art infrastructure, including well-planned industrial parks, reliable power supply, transportation networks (railways, highways, waterways etc) communication systems, and other necessary utilities.

Against this paraphernalia of support systems, the government imposes an obligation on SEZs to achieve Positive Net Foreign Exchange (NFE) to be calculated cumulatively for a period of five years from the commencement of production.

It has been over a decade since the SEZ policy was launched. But, the performance of these SEZs over the years has been at par with, or at best marginally better than sections of DTA units when it comes to boosting foreign exchange inflows. The 262 operational SEZs set up over this period (against 425 approved of which 376 have been notified) currently have only 5,576

operational units and account for less than 20 per cent of the country's exports. More than 1 lakh acres of land within the current SEZs is still not occupied. The 2005 SEZ Act was brought in with the hope of making India a manufacturing powerhouse of the world, but it had very limited positive effects. Even as India's service sector continues to show appreciable growth, the manufacturing sector has been lagging, This is evident from the fact that during 2022-23, out of total exports from SEZs at US\$155.8 billion, services exports at US\$94.2 billion were 60 per cent while merchandise exports at US\$61.6 billion were 40 per cent.

The objective of the DESH Bill is to "set up development hubs for promoting economic activity, generating employment, integrating with global supply and value chains and maintaining manufacturing and export competitiveness, developing infrastructure facilities, promoting investments, including in research and development (R&D)".

These hubs will be further classified into enterprise and service hubs. While enterprise hubs will permit both manufacturing and service activities, service hubs will permit only service activities. The government plans to facilitate easier financing norms for activities in these hubs by giving them infrastructure status, at par with sectors such as roads, rail waterways, and

Existing ports, airports, inland container depots (ICDs), land stations, etc., are proposed to be

transformed into Development Hubs with a clear demarcation of processing and non-processing A comparison with the extant SEZ

Act will show that there is nothing new in the DESH except replacing the word 'SEZ' with 'hub'. It seems to be a case of 'old wine in a new bottle'. What then has prompted the government to come up with DESH?

To understand this, let us look at a key proposal in the proposed amendments to the SEZ Act. This is to treat sales by SEZ units in the DTA akin to imports from countries with which India has bilateru tree trade agreements (FIAs). Imports from FTA countries are subject to concessional/nil import tariffs. Currently, such sales are subject to the buyer paying the basic customs duty (import tariff) and Integrated Goods and Services Tax (IGŠT) applicable to the product concerned. besides other levies on imports like anti-dumping, countervailing and safeguard duties wherever applicable.

The existing provision is perfectly in order.

If the SEZ unit is unable to export and forced to sell in the domestic market, the very raison d'etre of giving it 'tax free' status disappears. Such sale in DTA has to be treated like any other sale and duty has to be paid. Charging concessional/nil duty – as proposed in the amendment – won't be logical.

Another provision in the new bill is expected to ensure tax intending to invest in these rebates/refunds/financial subsidies

to developers/companies in the hub, in a manner similar to the existing SEZs, but with no export compulsion NFE obligation. This too knocks at the foundation of giving the SEZ tax exemptions. If, the government doesn't insist on export obligations from these units then, how are they different from other units?

Tax-free status to SEZs with no export obligation will confer a fortuitous advantage on them. Instead of focusing on increasing exports, they will misuse tax exemptions for selling in the domestic market at the cost of units located in DTA that pay taxes. Another amendment in the SEZ Act seeks to make de-notifica tion norms for SEZs easier. De-notification is basically an approval granted to developers to opt out of the SEZ scheme after being part of it. When SEZs are denotified, the developers have to refund all duties and tax benefits. More than 100 cases of de-notification have been approved by the government since

One wonders whether in the garb of simplifying the process of denotification, the intent is to do away with the requirement of 'refunding all duties and tax benefits.

To conclude, it appears that the DESH bill/proposed amendments to the SEZ Act are intended to give SEZ developers and units located therein is to give a 'safe passage' to all those who haven't been able to fulfil their export commitments as also to make life easier for others

Cease-fire and hostage release expected to begin today

An agreement for a four-day cease-fire in Gaza and the release of dozens of hostages held by militants and Palestinians imprisoned by Israel appeared to have hit a last-minute snag. A senior Israeli official said it would not take effect until Friday, a day later than originally announced. The diplomatic breakthrough promised some relief for the 2.3 million Palestinians in Gaza who have endured weeks of Israeli bombardment, as well as families in Israel fearful for the fate of their loved ones taken captive during Hamas' Oct 7 attack that triggered the war.

Israel's national security adviser, Tzachi Hanegbi, announced the delay late Wednesday, without providing a reason. Negotiators were still "working to create the appropriate conditions" for the cease-fire and swap, according to Majed al-Ansari, a spokesman for the Foreign Ministry of Qatar, which played a key role in mediating with Hamas.

The Persian Gulf nation said early Thursday that a new time for the agreement to go into force would be announced "in the coming hours." It was originally set to begin Thursday morning. The US and Egypt also helped negotiate the deal.

RISING TOLL IN GAZA

The Health Ministry in Hamasruled Gaza, meanwhile, resumed its detailed count of Palestinian casualties from the war, saying over 13,300 have been killed. The figures do not include updated numbers from hospitals in the north, where services and communication largely broke down earlier this month, and the ministry says some 6,000 people have been reported missing and are feared to be buried under rubble. The ministry does not differentiate between civilians and militants in its death tolls. Israel says it has killed thousands of Hamas fighters, though it has presented no evidence for its count.

The ministry stopped publishing casualty counts as of Nov 11, saying it had lost the ability to do so because of the collapse of the health sector in the

'TRUCE WON'T END WAR'

The truce agreement had raised hopes of eventually winding down the war, which has levelled vast swaths of Gaza, fuelled a surge of violence in the occupied West Bank, and stirred fears of a wider conflagration across the Middle East.

Air raid sirens sounded across northern Israel on Thursday as Hezbollah said it had fired 48 Katyusha rockets from southern Lebanon. The barrage came after an Israeli strike killed five Hezbollah fighters, including the son of the head of the group's parlia-

The Israeli military said it was striking the sources of the launches. Israel and Hezbollah, which fought a monthlong war in 2006, have repeatedly traded fire across the border since the war in Gaza broke out.

Prime Minister Benjamin Netanyahu has vowed to continue the war against Hamas after the truce expires, with the goal of destroying the group's military capabilities, ending its 16-year rule in Gaza and returning all of the estimated 240 captives held in Gaza by Hamas and other groups.
"We will continue it until we achieve

all our goals," Netanyahu said, adding that he had delivered the same message in a phone call to US President Joe Biden. Washington has provided extensive military and diplomatic support to Israel since the start of the war.

Israeli troops hold much of northern Gaza and say they have dismantled tunnels and much of Hamas' infrastructure there. Israeli forces on Wednesday revealed what they said was a major Hamas hideout in a tunnel beneath

The territory's largest medical centre has been at the heart of a fierce battle of narratives over both sides' allegedly reckless endangerment of civilians. Hamas and hospital staff deny Israeli allegations that Shifa was used as a militant command centre.

The military said Thursday that it had detained Mohammed Abu Selmia, the director of Shifa, for questioning over his involvement in what it said

were "extensive" Hamas activities in the hospital. Gaza's Health Ministry called on international bodies to intervene and said it would no longer cooperate with the World Health Organisation in evacuating hospitals.

Earlier on Thursday, Israel had ordered the full evacuation of the Indonesian Hospital in the north, Dr Munir al-Boursh, a Health Ministry official inside the facility, told Al-

Fighting has raged outside the hospital for days, and hundreds of people have already been evacuated to the south. It was unclear if the arrest of Abu Selmia would affect those efforts.

Israel has threatened to launch wider operations in southern Gaza, where hundreds of thousands of people who fled the north have crammed into overflowing UN-run shelters with dwindling food, water and basic supplies. For Hamas, the cease-fire would provide an opportunity to regroup after weeks of apparently heavy losses. Hamas leader Yehya Sinwar, who is believed to be alive and in hiding in Gaza, is likely to claim the release of Palestinian prisoners as a major achievement and declare victory if the war ends.

HOSTAGES TO BE FREED IN STAGES

Under the truce deal, 50 hostages are supposed to be freed in stages, in exchange for the release of what Hamas said would be 150 Palestinian prisoners. Women and children would be released first, and Israel said the truce

would be extended an extra day for every additional 10 hostages freed. The return of hostages could lift spirits in Israel, where their plight has gripped the country. Families of the hostages have staged mass demonstrations to pressure the government to bring them home.

Qatar said the cease-fire would allow a "larger number of humanitarian convoys and relief aid" to enter Gaza, including fuel, but it gave no details on quantities. Israel cut off all fuel imports at the start of the war, causing a terri-tory-wide blackout and leaving homes and hospitals reliant on generators, which have also steadily been forced to

Israel's Justice Ministry published a list of 300 prisoners eligible to be released, mainly teenagers detained over the past year for rock-throwing and other minor offences.

The war erupted when several thousand Hamas militants stormed into southern Israel, killing at least 1,200 people, mostly civilians, and taking scores of hostages, including babies, women and older adults, as well as soldiers, for whom Hamas is expected to demand a large number of high-profile

BIDEN CALLS MIDDLE EAST LEADERS

US President Joe Biden called Prime Minister Benjamin Netanyahu of Israel, Emir Sheikh Tamim Bin Hamad al-Thani of Qatar and President Abdel Fattah al-Sisi of Egypt to discuss the latest situation in the Middle East following an agreement between Israel and Hamas on the release of hostages.

Israel and Hamas agreed on Wednesday to a temporary four-day ceasefire to allow the release of 50 hostages held by the militant group in Gaza in exchange for 150 Palestinian detainers and the entry of hymanitar detainees and the entry of humanitar-

ian aid into the besieged territory. The deal, once implemented, will be the first major diplomatic breakthrough and pause in fighting since the war began after Hamas attacked Israel on October 7. Biden on Wednesday spoke with Netanyahu to welcome the deal, the White House said in a readout of the call. The two leaders discussed the pause in fighting, which will allow neededhumanitarian assistance to enter into Gaza, it added. Netanyahu thanked Biden for his "tireless efforts" and those of his team to help broker the deal, the White House said.

"The two leaders agreed that the work is not yet done and the president assured the prime minister that he will continue working to secure the release of all remaining hostages.

The president further emphasised

the importance of maintaining calm along the Lebanese border as well as in the West Bank," it said.

Hezbollah fires rockets at Israel after airstrike kills 5

rhe militant Hezbollah I group fired more than 50 rockets at military posts in northern Israel on Thursday, a day after an Israeli airstrike on a home in southern Lebanon killed five of the group's senior

The waves of rockets sent over the border represented one of the most intense bombardments since Hezbollah started attacking Israeli posts in the country's north at the beginning of the Israel-Hamas

Hezbollah has said that by heating up its actions on the Israel-Lebanon border, it is easing pressure on the Gaza Strip, where Israel's crushing aerial, ground and naval offensive has left more than 13,300 Palestinians dead and caused wide destruction in the sealedoff enclave. The war was triggered by

an October 7 Hamas attack on southern Israel that left about 1,200 people dead, most of them civilians, and resulted in about 240 hostages getting taken to Gaza.

An agreement for a fourday cease-fire in Gaza and the release of dozens of hostages held by the militants and Palestinians imprisoned by Israel, was set to take place on Thursday but appeared to have hit a last-minute snag. Hezbollah said in a series

of statements released Thursday that the volleys it fired toward Israeli posts included 48 Katyusha rockets that were directed at an Israeli army base in Beit Zeitem, about 10 kilometres south of the border.

The group said its fighters also struck tanks and locations where Israeli troops were taking positions.

The intense fire followed an Israeli airstrike on a house in Beit Yahoun, a village in southern Lebanon, that killed the five senior fighters, including Abbas Raad, the son of the head of Hezbollah's 13-member parliamentary bloc in Lebanon, Mohammed Raad.

The deaths bring the number of Hezbollah fighters who have been killed in seven weeks of fighting to at least 83.

Hezbollah leader Sayyed Hassan Nasrallah met in Beirut in Thursday with Iranian Foreign Minister Hossein Amirabdollahian. They discussed the ongoing war in Gaza and efforts to "stop the

Israeli aggression," as well as the situation at the tense Lebanon-Israel border, according to a statement released by Hezbollah.

Amirabdollahian warned in comments to journalists upon his arrival in Lebanon Wednesday that the ongoing Israel-Hamas war could "spiral out of control" if a truce does not last.

Iran-backed factions in Iraq, including the militant group Kataib Hezbollah, have carried out more than 60 and rocket or suicide drone attacks at bases housing US troops in Iraq and Syria. Kataib Hezbollah is allied with Lebanon's Hezbollah but the groups have different leaders.

The US military said on Thursday that one of its warships in the Red Sea shot down bomb-carrying drones launched from territory controlled by Yemen's Iran-backed Houthi rebels.

The American military's Central Command said the USS Thomas Hudner, an Arleigh Burke-class destroyer, shot down the drones early on Thursday morning. "The ship and crew sustained no damage or injury," Central Command

'Russian support enabled N Korea to launch spy satellite'

Couth Korea has concluded Sthat Russian support likely enabled North Korea to put a spy satellite into orbit for the first time this week, and will know whether it is functioning properly by early next week, officials said on Thursday.

The launch has deepened regional animosities, with both Koreas threatening to breach a past reconciliation deal and taking hostile actions along their heavily armed border.

After two launch failures earlier this year, North Korea said it successfully placed its "Malligyong-1" satellite into orbit on Tuesday night. South Korea's military has confirmed that the satellite entered orbit. but said it needs several more days to verify whether it is working properly.

In a closed-door briefing, South Korea's spy agency told lawmakers on Thursday that Russian assistance was likely the main reason the launch was successful, according to lawmakers who attended the meet-

The National Intelligence Service cited Russian President Vladimir Putin's earlier mention of a promise to support North Korea's satellite programme. It said it also obtained intelligence that North Korea had sent Russia the design and other data for its new "Chollima-1" rocket used in the two previous failed launches. The intelligence showed that Russia returned its analysis of the North Korean data, according to lawmaker Yoo Sangbum, who attended the NIS

briefing. South Korean Defence Minister Shin Wonsik told a separate parliamentary committee meeting on Thursday that Russia appears to have been providing technological assistance for North Korea's

The same satellite and rocket were used in all three launches. The two earlier attempts in May and August failed due to technical problems with the rocket.

There has been speculation that Russia is providing technological support for North Korea's satellite and other programs since leader Kim Jong Un travelled to Russia to meet Putin and visit key technology and military sites in September. The Kim-Putin summit was held at Russia's main space launch centre.

Asked whether Russia would help North Korea build and launch satellites, Putin told Russian state media at the time that "that's why we have come here." "The (North Korean) leader shows keen interest in rocket technology. They're trying to develop space, too," Putin said.

The US, South Korea and Japan accuse North Korea of obtaining high-tech Russian military technologies in return for supplying conventional arms for Russia's war in Ukraine. Both Russia and North Korea have denied the alleged deal.

North Korea said its Malligyong-1 satellite will begin its official mission on December 1. But it said the satellite has already transmitted images of military facilities in the US territory of Guam and that Kim saw them. North Korea hasn't released the

Many foreign experts are sceptical about the satellite's ability to take high-resolution images and whether it is militarily meaningful. After recovering debris from the first failed launch attempt, South Korea's military said the satellite wasn't sophisticated enough to perform military reconnais-

Indian workers dominate UK visa tally

Hundreds of police officers searched the properties of Hamas members and followers in Germany on Thursday morning following a formal ban on any activity by or in support of the militant group. The German government implemented the ban on November 2 and dissolved Samidoun, a group that was behind a celebration in Berlin of Hamas' October 7 attack on

Germany's domestic intelligence service estimates that Hamas has around 450 members in the country. Their activities range from expressions of sympathy and propaganda activities to financing and fundraising activities to strengthen the organization abroad.

"We are continuing our consistent action against radical Islamists," German Interior Minister Nancy Faeser said. "By banning Hamas and Samidoun clear signal that we will not tolerate any glorification or support of Hamas' barbaric terror against Israel."

The raids, which mostly took place in Berlin, were meant to enforce the bans and to further investigate the groups, the German interior ministry said in a statement. A total of 15 properties

were searched in Berlin and the states of Lower Saxony, North Rhine-Westphalia Schleswig-Holstein. In Berlin alone, more than

300 police officers carried out searches at 11 locations in order to seize evidence and assets. Seven searches were related to Hamas and four to Samidoun.

The searches mainly took place at the homes of supporters and the premises of a Palestinian association, German news agency dpa

'Fiery crash kills 2 at **US-Canada** bridge'

Niagara Falls NY (AP): A vehicle speeding toward a US-Canada bridge from the American side crashed and exploded at a checkpoint in Niagara Falls on Wednesday, killing two people and prompting the closing of multiple border crossings for hours. Authorities weren't sure what spurred the wreck but said there were no signs it was a terror attack.

Much remained unclear about the incident at the Rainbow Bridge, which stirred concerns on both sides of the border as the US headed into the Thanksgiving holiday. Both US President Joe Biden and Canadian Prime Minister Justin Trudeau were briefed soon afterward, and Trudeau excused himself from Question Period in the House of Commons to get further information, saying officials were "taking this extraordinarily seriously".

Anti-Islam populist wins big in Netherlands elections

nti-Islam populist Geert Awilders said Thursday he is ready to join the next Dutch coalition government after he surged to a huge election victory that marked a stunning lurch to the far right for a nation once famed as a beacon of tolerance. The result is sending shockwaves through Europe, where extremist rightwing ideology is putting pressure on democracies that now face the possibility of having to deal with the first far-right prime minister of the Netherlands.

"It is going to happen that the PVV is in the next Cabinet," Wilders said, using the Dutch abbreviation for his Party for Freedom. With nearly all votes counted, Wilders' party was forecast to win 37 seats in the 150-seat lower house of parliament, more than double the 17 the party secured in the last election. Wilders got a standing ovation, cake and sparkling wine when he met his lawmakers at the parliament building Thursday morning.
"Can you imagine it? 37

seats!" he said to cheers. Other political parties were holding separate meetings to discuss the election's outcome before what is likely to be an arduous process of forming a new governing coalition begins Friday.

Wilders' election programme included calls for a referendum on the Netherlands leaving the European Union, a total halt to accepting asylum-



seekers and migrant pushbacks at Dutch borders. It also advocates the "de-Islamization" of the Netherlands. He says he wants no mosques or Islamic schools in the country, although he has been milder about Islam during this election campaign than in the past.

One of the most prominent Muslim organisations in the Netherlands said it had received emails expressing support since the election result.

'That's reassuring," the Contact Group Muslims and Government said in a statement. "In addition, Mr Wilders has said that he will become prime minister of all Dutch people, regardless of their religion, sex or colour. The Netherlands is a state governed by the rule of law and we trust that it is a tolerant

In a statement on its website, the Dutch branch of Amnesty International said: "Yesterday human rights lost. A racist party won the Dutch get their nation back."

Although known for his harsh rhetoric, Wilders began courting other right-wing and centrist parties by saying in a victory speech that whatever policies he pushes will be within the law and constitution". His victory appeared based on his campaign to curtail migration — the issue that caused the last governing coalition to quit in July — and to tackle issues such as the Netherlands' cost-of-living crisis and housing shortages.

"I think, to be honest, very many people are very focused on one particular problem, which is immigration," voter Norbert van Beelen said in The Hague on Thursday morning.

In his victory speech, Wilders said he wants to end what he called the "asylum tsunami", referring to the migration issue that came to dominate his campaign. "The Dutch will be No. 1 again," Wilders said. "The people must

Peshawar (PTI): In a fresh wave of terrorism, nine people, including two soldiers, were killed and several others injured in four different terror incidents in restive tribal belts in northwest Pakistan. The bomb blast incidents occurred in North Waziristan, South Waziristan, and Bajaur tribal districts of the Khyber Pakhtunkhwa province on Wednesday, Inter-Services Public Relations (ISPR), the media wing of the army, and police said.

Two soldiers were killed as the terrorists attacked a convoy of the security forces in the Razmak area in North Waziristan district while in Wana in South Waziristan district, tribal elder Aslam Noor along with his two sons, and a local shopkeeper were killed as a bomb blast ripped through the shop. In Bajaur tribal district, three others, including the father of a local Jamiat Ulemae-Islam (JUI-F) leader, were killed and an equal number were injured in two separate blasts, police said.

In the first blast, two social activists were killed when a bomb exploded in a car while in the second incident, Sattar Khan Ustad, father of a slain JUI-F leader Amir ul Islam, was killed in a roadside bomb blast at Damadola in Mamond tehsil

There has been an uptick in terrorism incidents in Pakistan in recent months.

Imran asked to hold intra-party polls to retain bat symbol

Pakistan's election commission on Thursday ordered jailed former prime minister Imran Khan's Pakistan Tehreek-e-Insaf party to hold intra-party elections within 20 days to retain the bat as its poll symbol, according to a media report.

The Election Commission of Pakistan (ECP) said the Pakistan Tehreek-e-Insaf (PTI) did not conduct transparent elections as per the Constitution. In August, the commission had given a final warning to the PTI to hold the polls or it could be declared ineligible to obtain an election symbol. It had stated that the elections were due on June 13, 2021, under the party's Constitution but a year's extension had been granted.

Gohar Ali Khan, repre senting the PTI, had said the party elections were held before an amendment to its Constitution. However, the Chief Election Commissioner claimed that the PTI amended its Constitution on June 8, 2022, and conducted intraparty polls on June 10, 2022. Khan had also said the amendment in the party constitution was later withdrawn, the Dawn newspaper reported.

The polls organising authority had said it issued a final notice to the PTI in May 2022 to ensure the conduct of intra-party elections "on or before June 13, 2022 (extended date), with the observation that no further extension shall

be allowed".

Subsequently, the PTI submitted a copy of the amended party's Constitution that was deemed "insufficient" by the electoral body. In October, the ECP had reserved its verdict on the maintainability of a petition by the Istehkam-i-Pakistan Party seeking to take away PTI's 'bat' electoral symbol.

Days later, the PTI formal ly appealed to the electoral body to immediately issue a detailed written order regarding the intra-party elections and poll symbol allocation. The PTI had claimed that the ECP had accepted there had been a misunderstanding and that the elections were held on June 9, 2022.

WHO asks China for details after surge in respiratory illness among children Beijing/Geneva (PTI): The WHO on The WHO statement calling on infor-

Thursday said it has made an official request to China for detailed information on a spike in respiratory illnesses after the Chinese health authorities reported multiple infectious respiratory diseases with surging cases of mycoplasma pneumonia and influenza flu among children.

Earlier this month, Chinese experts also sounded an alert about the relapse of COVID-19 infections during the current winter season and asked elderly and vulnerable populations to get vaccinated. The World Health Organisation (WHO) in a statement issued in Geneva said it had requested China to provide additional epidemiologic and clinical information, as well as laboratory results from reports of clusters of pneumonia in children through the International Health Regulations mecha-

mation from China was seen as an attempt to secure official information in time unlike in 2019 when the global health body came under strong criticism for the delay in getting timely reports from Beijing on the breakout of the coronavirus, which later spiralled into a massive pandemic causing millions of deaths all over the world. "We have also requested further information about recent trends in the circulation of known pathogens including influenza, SARS-CoV-2, RSV and mycoplasma pneumoniae, and the current burden on health care systems," the WHO statement said. "WHO is also in contact with clinicians and scientists through our existing technical partnerships and networks in China," it

The statement by the global health body was in response to remarks by Mi

Feng, spokesman of the National Health Commission, at a news conference here on November 13 that as winter approaches, China has entered the peak season for respiratory illnesses, and different viruses or pathogens are circulating simultaneously. Efforts should be made to monitor the spread of mycoplasma pneumonia, COVID-19, influenza flu, as well as dengue fever and norovirus infections, to step up surveillance and early warnings so as to understand the spread of these viruses and their mutations," he said. Chinese health experts said mycoplasma pneumoniae a pathogen that commonly causes sore throat, fatigue, fever and a lingering cough that can last for months in children aged five and above — has drawn heightened attention this winter as hospitals nationwide have seen young patients swarming there

Premier England all-rounder Ben Stokes will miss the 2024 edition of the Indian Premier League (IPL) due to workload management, his franchise Chennai Super Kings announced on Thursday. Stokes had joined CSK ahe

IPL 2023 but played in only two matches as he was managing a troublesome knee injury throughout the course of the two-month long tournament. "England Test captain, allrounder Ben Stokes has made himself unavailable for IPL 2024 to manage his workload and fitness," CSK said in a statement on

their website on Thursday. "The Chennai Super Kings management is supportive of Ben in his decision to manage his workload with England playing a 5-Test series in India

before the IPL and then the T20 World Cup in June 2024," the

statement added CSK had acquired his services with a bid price of Rs 16.25 crore, making him the costliest buy of the franchise. Stokes had managed only 15 runs and bowled one over in two matches in 2023, focused on getting ready for the Ashes series which followed soon after.

Stokes came out of retirement from ODI cricket but defending champions England endured a dismal World Cup campaign, finishing seventh in a 10-team points table.

The 32-year-old Stokes missed the first three matches of the league stage but finished well with one century and two fifties towards the end

However, Stokes did not bowl in any of the six World Cup games. **PTI** ■ MUMBAI

India spinner Ravichandran Ashwin said Thursday Rohit Sharma "doesn't need to be taught to score hundreds", backing his captain to the hilt after his failure to convert a blazing start into a big score in the World Cup final against Australia attracted criticism. Rohit was in full flow throughout the tournament and the brisk starts that India enjoyed were largely due to his pyrotechnics at the top of the order. Scoring at an incredible strike rate of 125, he amassed 597 runs in 11 matches.

However, Rohit received criticism from some quarters after an adventurous attempt to hit Glenn Maxwell out of the ground in the final led to his dismissal for a 31-ball 47, which set a solid foundation but from where his team could not consolidate.

"Everybody says in hindsight that he would score 100 if he carried on, but it was his intent that made the team play in such a way. Rohit Sharma doesn't need to be taught to score hundreds — he has had quite a lot - but it is the intent which counts," Ashwin said.

vealed he was shell-shocked by Australia's decision to bowl first in the final last Sunday, but also praised Pat Cummins and selector George Bailey for reading the pitch at Ahmedabad

release the moisture, but holds it," Ashwin added. Ashwin explained why he was surprised by Australia's tactics,

but also added that India becoming a 'cricket hub' of the world due to the number of Indian Premier League gave the overseas players insights into pitches and conditions.

I was checking out if the pitch was disintegrating at the mid innings and I met George Bailey, the chairman of selectors and asked 'why didn't you guys bat first like you always do after winning the toss?" he said. "For that he answered back, 'we have played IPL and bilateral series for a long time now, and in our experience, the red soil disintegrates, but the black soil gets better to bat on under the



lights," Ashwin said.

'Dew is not a big impact in red soil pictures, whereas black soil pitches are good turners in the afternoon, but in the night, the pitch solidifies into a paata wicket and plays as though it is made of concrete," he contin-

Ashwin said, "I was flabbergasted listening to that, seeing all the bilateral series and India becoming a central hub of world cricket. They can read the pitch perfectly," he said. The ace Indian spinner laughed off the media reports that surfaced on the day of India's semifinal against New Zealand in Mumbai claiming that the pitch for the contest was change at the behest of the hosts.

"Journalists from other countries comment that the pictures have been changed and so on but it is clearly laughable. India is a unique country, different parts of the country have different soils," he said "Ahmedabad in itself has more

than 3-4 varieties of soil in the square so, what George Bailey said regarding the pitch made me spellbound, but Pat Cummins' execution needs to be applauded," he added. Ashwin said he had not

watched a fast bowler bowl to spinner, which Cummins executed perfectly against India in the final. "In the last 4-5 games leading up to the final, almost 50 per cent of the balls were cutters.
