Rescuers perseverance pays

All 41 workers trapped in Uttarkashi tunnel safely evacuated after 16 days

As the workers trapped in the Silkyara tunnel emerged on Tuesday night, a mix of smiles and expressions of gratitude and exhaustion adorned their faces, marking the end of their 17-day ordeal A collective sigh of relief swept across the nation. Outside the tunnel, loud cheers and slogans filled the air as people wel-comed the ambulances transporting the workers to community health centres, and locals took to the streets to share in the jubilation Anxious relatives who had

been camping in the area were emotional as they were united with the workers after days of uncertainty. Back home, many said they will celebrate Diwali now as the shadow of despair that had fallen on the families disappeared.

"Finally, God heard us. My brother could be rescued. I am with him in an ambulance on the way to hospital," Sunil, who was camping outside the tunnel in Uttarkashi, told PTI in a choked voice.

Sunil's brother Anil was among the three youths from Kherabera in Jharkhand who were trapped in the tunnel.

"All are fine and healthy. I have spoken to a few of them," said a rescue worker as media persons who staked out at the site

In a post on X soon after the workers were brought out of the Silkyara tunnel in Uttarkashi, the Prime Minister saluted the spirit of those involved in the operation and said their courage and resolve have given a new lease of life to

the 41 labourers.

"Everyone involved in the mission has created an amazing example of humanity and teamwork. It is a matter of great satisfaction that these friends of ours will meet their dear ones after a long wait," Modi said. Uttarakhand Chief Minister Pushkar Singh Dhami and Union minister VK Singh wel-comed the 41 workers with garlands, shook hands and embraced them, while the rescue teams and officials clapped. Families of the workers, most of whom are from Jharkhand and UP, were glued to television and phones after the news emerged that they could be recused any time. Sweets were distributed and crackers were burst at some places.

In Khirabeda, villagers distributed 'laddoos' after the successful rescue. Rajendra, Sukhram and Anil, all in their early 20s, from the village, were among those trapped inside the tunnel for 17 days. Sukhram's sister Khushboo said that everyone in their village

was celebrating.
According to Ram Kumar Bediya, a villager, a group of 13 people, between 18 and 23, had left Khirabeda on November 1 to work at the tunnel. When the disaster struck, three of them were working inside.

Curbs on vehicles lifted as air betters

As the air quality in Delhi and its surrounding areas marginally improved due to rain and favourable wind speed, influenced by a western disturbance affecting northwest India, the Commission for Air Quality Management in the National Capital Region and Adjoining Areas (CAQM) removed restrictions under stage III of the Graded Response Action Plan (GRAP) on Tuesday with immediate effect.

The Commission stated that the restrictions under the first and second stages of GRAP will continue. According to air quality forecasts from the India Meteorological Department (IMD) and the Indian Institute

of Tropical Meteorology, there is no indication that the average air quality in Delhi will reach the "severe" category in the upcoming days for which forecasts are available. The decision to revoke the third stage of the GRAP was

made at the subcommittee meeting held on Tuesday following an improvement in air quality, it said. The average Air Quality Index (AQI) in Delhi was 365 at 8 am on Tuesday, which reduced to 312 at 4 pm, showing improvement from 395 on Monday. Light rain was reported in national capital, while the minimum temperature settled at 14.2 degrees Celsius, four notches above the season's aver-

age, on Tuesday.
According to the IMD, the national Capital recorded 7 mm of rainfall in the last 24 hours till 8.30 am on Tuesday The wind speed improved to 20 kilometres per hour, aiding in

Telangana gears up for high stakes polls

The curtains came down on The curtains came at the month-long highpitched poll campaign in five States, with the last day of the campaign in Telangana on Tuesday. The State will go to polls on Thursday. The results, including those from the other Chhattisgarh, Rajasthan, and Mizoram), will be declared on

December 3. The State witnessed an electrified campaign by BRS, a highpowered BJP campaign led by Prime Minister Narendra Modi with several roadshows, and a high-stakes campaign by the Congress, looking forward to forming its first government after the State was bifurcated by the UPA government.

BRS has fielded candidates in all 119 seats. According to the seat-sharing agreement, BJP and Jana Sena are contesting in 111 and 8 seats, respectively, while Congress has given one seat to its ally CPI(M). Asaduddin Owaisi-led AIMIM has put up candidates in nine segments in the city. BRS is trying to retain power for a third consecutive term, while Congress has been fighting tooth and nail to wrest power from it.

The BJP has left no stone unturned to come to power. A total of 2,290 contestants are in the fray for the upcoming elections, including BRS supremo and Chief Minister K Chandrasekhar Rao, his minister-son K T Rama Rao, TPCC

president A Revanth Reddy, and BJP Lok Sabha members Bandi Sanjay Kumar, D Arvind, and Soyam Bapu Rao. KCR is and Soyam Bapu Rao. KCR is contesting from Gajwel and Kamareddy, and Revanth Reddy is contesting from Kodangal and Kamareddy. The BJP fielded its MLA, Etala

Rajender, from Gajwel, in addition to Huzurabad, where he is the incumbent legislator Apart from PM Modi, several

Union ministers, including Rajnath Singh and Amit Shah, Congress leaders Mallikrajun Kharge and Rahul Gandhi, campaigned for votes for their respective party candidates. The BRS campaign centered around the failures of the previous Congress regime and ongoing welfare measures for farmers and women.

Rao also highlighted his struggle to achieve Telangana statehood. Congress focused mainly on the alleged corruption of the BRS government while highlighting its "six guarantees." BJP's campaign emphasised the necessity of a "double engine government" and pointed to the "family rule" of KCR,

alleging corruption. To the embarrassment of the ruling KCR government, the National Dam Safety Authority gave an adverse report on the sinking of a barrage, which is part of the Kaleshwaram irrigation project, providing ammunition to the Opposition. Over 2.5 lakh staff will be engaged in poll duties for the Assembly polls, Chief Electoral Officer Vikas Raj said.

from 24 to 72 per cent. According to a report by the Association for Democratic Reforms (ADR), out of the 8,051 candidates analysed in five States who contested the Assembly elections, as many as 1.452 have criminal cases registered against them, while 959

are facing serious charges. For the 119-member Telangana Assembly, the ADR said it has the highest number of candidates with criminal records Between 24 per cent and 72 per cent of candidates from all major parties contesting elections in the State have declared criminal cases against them. The political parties have fielded candidates with criminal records ranging from 6 per cent to 72 per cent in Rajasthan. Of the 2,290 candidates in



> The figures are lowest for Mizoram, where between 3 per cent and 10 per cent of candidates from major parties have criminal records, and none of the candidates have declared cases related to crimes against women, attempt to murder, and murder.

In Chhattisgarh, out of 1,178 candidates analysed, 126 candidates have declared criminal cases, while 72 have serious cases against them.

Out of 2,534 candidates analysed in Madhya Pradesh, 472 candidates have criminal cases against them, while 291 have declared serious criminal cases. In Rajasthan, the report claimed that out of 1,875 candidates, 326 are facing criminal cases while 236 are facing serious criminal cases. The report also said that Congress, which fielded 677 candidates, has 268 candidates with criminal cases and 162 with serious criminal cases.

Gaza truce extended amid hostage release

truce between Israel and AHamas entered its fifth day on Tuesday, with the militant group promising to release more hostages to delay the expected resumption of the war and Israel under growing pressure to spare Palestinian civilians when

it renews its offensive. The sides agreed to extend their truce through Wednesday, with another two planned exchanges of militant-held hostages for Palestinians imprisoned by Israel. But Israel

has vowed to resume the war with "full force" to destroy Hamas once it is clear that no more hostages will be freed under the deal.

The Biden administration has told Israel it must avoid "significant further displacement" and mass casualties among Palestinian civilians if it resumes the offensive, and that it must operate with more precision in southern Gaza than it has in the north, according to US officials. The officials spoke on condition of anonymity under ground rules set by the White House.

CIA director William Burns and David Barnea, who heads Israel's Mossad intelligence agency, were in Qatar, a key mediator with Hamas, to discuss extending the cease-fire and releasing more hostages, a diplomat said on condition of anonymity because of the sen-

sitivity of the talks. A US official confirmed Burns was in Qatar, speaking anonymously because the director's travel plans are not publicized for security reasons.

US Secretary of State Antony Blinken is set to visit the region

India poised to become second largest egg producer

The survey report from the Ministry of Fisheries, Animal Husbandry, and Dairying indicated an upswing in the production of milk, eggs, and meat in the country. According to the report, the total milk production in the country is estimated to be 230.58 million tonnes in 2022-23, reflecting a 3.83 per cent increase over the estimates of 2021-22. The egg production is projected to be 138.38 billion, marking a 6.77 per cent rise compared to the previous year. This may make India the second largest producer of eggs.

Additionally, meat production is expected to reach 9.77 million tonnes, representing a 5.62 per cent increase over the previous year. The survey report is based on

the results of the Integrated Sample Survey (ISS), conducted nationwide in three seasons: Summer (March-June), Rainy (July-October), and Winter (November-February).

India continues to maintain its position as the largest milkproducing country globally. According to the report, the total milk production in the country is estimated at 230.58 million tonnes during 2022-23, reflecting a growth of 22.81 per

cent over the past five years, from 187.75 million tonnes in 2018-19. Furthermore, there has been a 3.83 per cent increase in production during 2022-23 compared to the estimates of 2021-22. In previous years, the annual growth rates were 6.47 per cent in 2018-19, 5.69 per cent in 2019-20, 5.81 per cent in 2020-21, and 5.77 per cent in 2021-22.

The milk production from exotic/crossbred cattle increased by 6.16 per cent, while that from indigenous or non-descript cattle rose by 6.13 per cent compared to the previous year. Additionally, milk production from buffaloes



compared to 2021, with indigenous buffaloes contributing 31.58 per cent of the total production, followed by 29.91 per cent from crossbred cattle. During 2022-23, the highest milk-producing state was Uttar Pradesh, accounting for 15.72 per cent of the total milk production, followed by Rajasthan increased annually by 6.77 per (14.44 per cent), Madhya Pradesh (8.73 per cent), Gujarat (7.49 per cent), and Andhra Pradesh (6.7 per cent). In terms of annual growth rate (AGR), Karnataka recorded the highest AGR at 8.76 per cent, followed by West Bengal at 8.65 per cent, and Uttar Pradesh at 6.99 per cent over the previous

The total egg production in the country is estimated to be 138.38 billion during 2022-23, marking a growth of 33.31 per cent over the past 5 years compared to the estimates of 103.80 billion in 2018-19. Furthermore, the production Bengal (20.10 per cent), fol-

cent during 2022-23 over 2021-22. In the past, the annual growth rates were 9.02 per cent in 2018-19, 10.19 per cent in 2019-20, 6.70 per cent in 2020-21, and 6.19 per cent in 2021-22. The contribution to the total

Lady Agniveer Uddhav accuses CM trainee commits suicide at INS Hamla

In a shocking incident, a 20-year-old female Agniveer trainee committed suicide by hanging herself in her hostel room at INS Hamla, an Indian Navy base at Malvani in north Mumbai on Monday.

Identifying the deceased female Agniveer as Aparna V Nair, the Indian Navy said here on Tuesday that she was undergoing training in Logistics (F&A) at the INS Hamla at the time of incident.

"Regret to inform the unfortunate incident of unnatural death of Aparna V Nair, Agniveer Logistics(F&A), age 20, at INS Hamla, Mumbai on 27 November 23. An inquiry has been ordered to investigate the incident. Indian Navy extends heartfelt condolences to the bereaved family," an Indian Navy spokesperson said. Confirming that Aparna had committed suicide by hanging herself, the Malvani police said: "Our preliminary investiga-tions have revealed that she had

ended her life due to some personal problems. She used a bed sheet to commit suicide in her hostel room".

The Naval officials and police said that she had joined the Agniveer training a fortnight

Police said that Aparna had come to Mumbai from Kerala and was staying in a hostel along with 15 to 20 girls

"When her roommate returned to the hostel room at 10.30 am, Aparna did not open the door despite repeated knocks. Her room partners alerted other hostel inmates and authorities who broke open the door and found Aparna's body. She was rushed to a nearby hospital where she was declared dead," a senior police official said.

We have a reason to believe that she had taken the extreme step due to some personal reasons. We are waiting for her family to come to Mumbai, after which we will record their detailed statement on what might have led to her committing suicide," the police officer said.

RERA lifts ban on registration of property after meeting LG

The Delhi Real Estate Regulatory Authority withdrew its September order directing sub registrars not to register properties in violation of building bylaws, hours after its top brass met Lt Governor V K Saxena on Tuesday, officials

After the circulation of the Delhi RERA order, the sub registrars of revenue department stopped registration of properties, although senior government officers claimed no order to this effect was issued by the department.

The Raj Niwas official said that the LG had received representations and complaints from MPs, MLAs, municipal councillors, civil society organisations, as well as general public on the problems faced in registration of sale deeds for properties being sold and bought. Delhi BJP president Virendra Sachdeva who had earlier raised the issue welcomed withdrawal of the RERA order saying the LG has fulfilled the hopes of Delhiites by getting it revoked. The September order of Delhi RERA had stated that as per the Unified Building Bylaws, 2016, and the Supreme Court order of March 14, 2008, the number of dwelling units was fixed to just three in case of plots mea-

SC seeks to know powers under which Centre wants to extend Delhi Chief Secretary's tenure

As the Centre on Tuesday submitted that it wanted to extend the tenure of the Delhi chief secretary who is due to retire on November 30, the Supreme Court sought to know under which power it can do so and quipped if it was "stuck with only one person" and didn't have any other IAS officer for the post.

The apex court asked the Central government to inform it on Wednesday about the grounds on which it wanted to extend the tenure of Chief Secretary Naresh Kumar by six more months. During a hearing on a Delhi

government's plea, a bench headed by Chief Justice DY Chandrachud suggested that Kumar should be allowed to superannuate and a fresh appointment should be made. At the same time, it also noted that the Centre held the power under the Government of National Capital Territory of Delhi (Amendment) Act to make the appointment and



This man is superannuating. Let this man superannuate. You make a fresh appointment," the bench said. The court was informed by Solicitor General Tushar Mehta, appearing for the Centre, that the government intends to extend the tenure of the existing person, who has been working for more than one-and-a-half year, for a limited period.

As he said even the term of a superannuated person can be extended if the government so wishes, the CJI said, "Are you stuck with only one person?". 'You want to make the appointment, make it. Don't you have any IAS officer who can be made chief secretary of Delhi? Are you so stuck on one IAS

prising justices J B Pardiwala and Manoj Misra said.

The law officer responded, "I am not stuck with only one person" but there were some administrative reasons. The top court asked the Centre to show the power under which it can extend the tenure of the chief secretary.

"Show us the power to extend. And show us what is the ground on which you want to extend. Otherwise, you can appoint whoever you want to, take instructions. "We are not holding you in any direction. You select any IAS officer of your choice who will come here and hold the position of chief secretary," said the bench, adding it will take up the matter on Wednesday.

The appointment of the chief secretary is the latest bone of contention between Chief Minister Arvind Kejriwal-led Delhi government and Lieutenant Governor (LG) V K Saxena who have been involved in a series of run-ins over var-

The bench was hearing a plea

against any move by the Centre to appoint, without any consultation with it, the new chief secretary or extend the tenure of the current top civil servant Naresh Kumar.

The Delhi government has questioned how the Centre could proceed with the appointment of the chief secretary without any consultation with it while the new law is under challenge. Senior advocate Abhishek Singhvi, representing the Delhi government, on Tuesday argued there was an absolute breach of communication, trust and faith between this chief secretary and the administration.

He said he was not asking to appoint a person of his choice but the Centre can choose from the senior most five IAS officers or let the LG and CM sit together and decide. On being asked by the bench as to for how long the Centre proposed to extend the tenure of the current chief secretary, Mehta said the decision appeared to be for six months, subject to the court's order.

Centre may introduce legal safeguards for health workers: Panel

Aparliamentary standing committee has said the Centre may consider introducing appropriate legal safeguards for healthcare workers, who at times face violence from relatives or attendants of patients. The Parliamentary Standing Committee on Home Affairs headed by BJP member Brij Lal, which examined the proposed three criminal laws, discussed a memoranda submitted by various medical associations requesting it to introduce provisions under Clause 115 of the Bharatiya Nyaya Sanhita (BNS) to penalise acts of violence against healthcare service personnel.

The committee, in its report, said it was submitted before the panel that unlike in any other professions, healthcare professionals are vulnerable to "violent attacks"by relatives of patients, in cases where patients die during treatment.

Such violent attacks against healthcare personnel are prevalent throughout the country some legal safeguards for the benefit of healthcare workers, the medical associations told the committee.

In its response, the Union Home Ministry said the general penal provisions are applicable to all and no distinction is made in the penal laws for any class of person. Everyone is equal in the eyes of law, the home ministry stressed.

The state is duty bound to protect life all its citizens, including doctors and professionals



like media persons, advocate, bankers, charted accountants, etc. Making a special provision for doctors and other health care professionals may give rise to similar demands from other professionals like media persons, advocates, bankers, charted accountants, the home ministry observed. The home ministry also

informed the committee that the Ministry of Health and Family Welfare has a proposal to introduce a 'Medical Professionals Act' to provide safeguards to healthcare workers against violent attacks, and that the home ministry would take an update from the Ministry of Health and Family Welfare on the same.

"After considering the concerns of the healthcare personnel, the committee opines that me government may conside introducing appropriate legal safeguards for healthcare workers,"the committee noted.

The Clause 115 of the BNS says: Whoever voluntarily causes hurt, if the hurt which he intends to cause or knows himself to be likely to cause is grievous hurt, and if the hurt which he causes is grievous hurt, shall be punished with imprisonment of either description for a term which may extend to seven years, and shall also be liable to fine.

NCR generates 78.8 lakh units of energy using solar power

The North Central Railway (NCR) generated 78.8 lakh units of energy using solar power in first seven months of the financial year 2022-23 with net revenue saving of Rs 3.27 crore achieved in six months through the use of solar energy. This has led to a reduction of 6,622 metric tonnes of carbon emissions.

In line with the national initiative on solar mission, the NCR has attached top priority to solar energy generation under the leadership of GM Satish Kumar. Under the guidance of PCEE AK Agrawal and due to excellent upkeep, close monitoring of operations of solar power plant and numerous innovative steps taken under Solar Mission-2022-23 by CEE (EEM) KM Singh, along with his team, the NCR generated 125 lakh units of electricity using solar power and a net revenue saving of Rs 5.2 crore in FY 2022-23.

Continuing the momentum this FY 2023-24 from April to October too, 78.8 lakh units of electricity has been generated by NCR in the first seven months of economy. Not



only it is a big leap towards a larger goal of environment protection as solar energy is a greener source of energy it has led to substantial savings in revenue too. Net revenue saving of Rs 3.27 crore has thereby recorded through the usage of solar power.

NCR has a total installed capacity of 11.13 MWp. While 185 kWp has been installed by the Railway, remaining 10949 kWp capacities has been installed by two major Solar Power Developers (SPD) Azure and ReNew on a PPP mode.

Among the major places where roof top solar plants have

been installed are GM and DRM office buildings, station buildings and workshops, besides training schools.

Besides 6,622 metric tonnes of reduction in carbon emissions has been achieved by NCR using solar power in these seven months.

Productivity of solar plants is measured in terms of Capacity Utilisation Factor (CUF). The NCR solar panels have recorded a CUF of 13.8 per cent during April-Oct 2023. In order to promote solar

energy, utmost importance is being given to maintenance of solar plants. Some of the steps

taken are: Monitoring of solar energy generation is being done for each plant, inverter wise. Daily monitoring, instead of monthly of energy and CUF per cent of plants is being done. Defective/ decommissioned plants due to roof repairs, inverters, cables, etc have been put right.

Solar diary introduced to SSEs for systematic documentation and focussed monitoring of energy and other important data in a structured manner.

GM Satish Kumar congratulated the team of officers and staff for sustaining the momentum in this field and called for adopting a focussed approach for augmenting the share of solar energy in its total non-traction electrical energy consumption.

1.34 MWp of roof top solar plants will be installed by NCR in the current financial year. Prayagraj division will be installing 0.75 MWp of solar plants while Jhansi and Agra divisions will add 0.4 and 0.19 MWp to the existing capacity respectively. These roof top solar plants are expected to be commissioned at various locations like railway stations, office/service buildings by December this year.

Give peace a chance!

The extended cease-fire in Gaza is a fine opportunity to reach stability in the region

The cease-fire has come as a godsend to the average Palestinian who finally got respite from flying mortar shells and some peace to get ration and medicines, which are luxuries in the conflict zone. The two-day extension of the cease-fire offers them a glimmer of hope and to international community the time to work backchannels for prolonged peace. However, as the Hamas and Israel have tentatively agreed to a break from hostilities, questions linger about the long-term prospects for stability. Will these additional two days lead to meaningful negotiations and a lasting peace, or is it merely a temporary pause before the bloody conflict resumes? The international community plays a crucial role in determining the trajectory of events and fostering an environment conducive to sustainable peace. The decision to extend the ceasefire by two days suggests a willingness on the part of both Hamas and Israel to explore avenues other than bombs, bullets and bloodshed. This respite provides an oppor-



tunity for de-escalation and opens a window for negotiations. However, the history of conflicts in the region raises scepticism about the durability of such agreements. The cease-fire extension allows for humanitarian efforts to take place, facilitating the delivery of essential supplies and medical assistance to those affected by the violence. Additionally, the pause in hostilities can pave the way for diplomatic initiatives, fostering an environment where both parties can address underlying issues through dialogue.

One of the bigger, though not direct, consequences of the Gaza conflict is the involvement of super powers in the fray. Now that the US and the West are with

Israel, China and Russia are throwing their weight behind the Hamas. This could have ominous consequences for the world; it is, therefore, in the interest of the world and not just of the people of Israel and Palestine that this conflict is made to peter out, at least for the time being. Key stakeholders, including the United Nations, regional powers and other influential nations, should actively encourage both parties to engage in meaningful negotiations, addressing the core issues that fuel the conflict. The international community should work collaboratively to ensure the delivery of aid, medical assistance and reconstruction support to alleviate the suffering of those caught in the crossfire. To prevent a return to square one after the ceasefire extension, sustained diplomatic efforts are required. The extension of the Gaza ceasefire provides a fleeting moment of hope for peace, but the international community must remain vigilant in guiding the path forward. By actively supporting diplomatic initiatives, addressing humanitarian needs and encouraging sustained dialogue, the world community can play a crucial role in ushering in lasting stability in the region. The alternative resuming hostilities — would only perpetuate the cycle of violence and deepen the suffering of those directly affected by the conflict.

Nepal in the throes of strategic choices



Nepal is exercising its strategic autonomy; distancing itself from the bullying Chinese dragon

epal is recovering from its long annual hangover after celebrating Dus-sehra and Tihar. It energises Nepal to face the winter and the new year Vikram Samvat 2080 but with one-third of Nepal in India and abroad with 1500 youth leaving Nepal every day. The rising standards of living and consumption are visible to me who has seen Nepal almost annually since 1959. Still, people are rich or very poor with the middle class small. People are happy except for the victims of the dengue and Jajarkot earthquake. Nepalese are happy with so little. When piped water, electricity, schools and hospitals reached the valleys or near the road network, people descended from the hills to avail man-made facilities, forfeiting nature's gifts to the hills. Hastily carved unmetalled roads have scarred the hills polluting the environment. Scooters, cars, motorbikes, trucks, tractors...anything with an engine moves along dusty tracks. Some people began returning to the hills. Last week Kathmandu news was

dominated by one man: businessman-politician and expelled from CPN UML, Durga Prasain. He threatened to bring into Kathmandu 10 lakh protesters to rally against former PM and CPN UML chief, KP Oli. He is facing legal action for bad debt on loans taken from state banks. The debt, he says, will be repaid when he is solvent. Prasian has roped in King Gyanendra who is patiently waiting in the distant hope that monarchy will be restored. The mood in the country for the return of loyalty is growing given the pathetic track record of the secular, federal, democratic republic of Nepal. It was the Prachanda-led decadelong Maoist civil war that dismantled the monarchy in 2008 which was ratified by the 2015 constitution. Gyanendra attended a Prasain-organised function in East Nepal at which he said: 'We never wanted Nepal to become a republic that sends 10 mn youth to the Gulf countries". Gyanendra is on a tight leash from the state although his daughter-in-law Himani is pop-



ernance provides. Appointed by the Supreme Court, the committee, which presented its report earlier this year, said 'Women in incarceration suffer the brunt of imprisonment far worse than their male counterparts, especially with regard to access to basic facilities, medical care and medical staff." GOVERNORS ABUSE NORMS

Sir — Raj Bhavans have become centres of inaction and retrogression in the states that are ruled by the opposition. Any other reading of Article would leave the Governor in a position to virtually veto the functioning of the legislative domain by a duly elected legislature. It added, "Such a course of action would be contrary to the fundamental principles of a constitutional democracy based on a parliamentary pattern of governance." According to Dr. PK Sen (Bihar), "the question is whether, by interfering, the Governor would be upholding the democratic idea or subverting it. It would really be a surrender of democracy." An appointee who holds office only during the president's pleasure cannot act in a way that is detrimental to the elected governments and people.

Need speedy judicial system

hile the Supreme Court (SC) plays a significant role in delivering justice, a corner-V stone of the Indian Judiciary System since independence has had a slow working methodology. Litigants and accused have to wait years for the closure of cases and judgement delivery. In most cases, victims do not get instant judgements, and for this reason, sometimes even victims and their families suffer outages in society. "Justice delayed is justice denied," therefore courts should give due consideration to the claims filed

The Indian Judiciary holds the highest pendency of cases and lacks a time frame for the disposal of litigation and appeals

At present, there are 79,813 cases pending before the 34 judges of the Supreme Court. That cleared depicts the need for constitutional reforms and revamping the structure of the top court to clear the pendancy of cases. The supreme court hears between the centre and the states and between states, rules on domestic and family cases, civil and criminal cases RTI (right to information) litigation, and provides legal and constitutional advice to the head of the state, i.e., the president. However, it creates burdens on the top court. Distributed or decentralised work mechanisms should be adopted by the judicial authorities for consistency and to ensure better judicial stability. To build the trust of society and its people, apparent and clear-cut constitutional idealism is

Yes, God empowers His devotees in many ways, as Arjuna was blessed, but these are His devotees, who are highly disciplined, and act as per God's plans.

So let us get some idea of absolute nature of God's powers, which are briefly described by Lord Krishna in the verse # 10.41 of the Bhagavad-Geeta, "Whatever there is opulent, effulgent or even energetic, all that you should know as produced from a fragment of My splendour." These famous examples will shed some light about the extent of God's powers. Starting with the light of the sun, what does Lord Krishna state, "I am light of the sun." (7.8) What happened when Arjuna promised to kill Jayadratha before sunset? He was to enter fire if he couldn't. What did Lord Krishna do? He protected his 'nimitta' (instrument) by restoring



the setting sun's light. As a result, there was daylight and Jayadratha came out from the protection of Kauravas; Arjuna killed him. Similarly, the Lord says that the heat of fire is from Him. (7.9) So, what happened when Seetaji entered fire in her fire test? She came out unscathed, because the heat of fire was withdrawn by Lord Rama. Another famous example is of Ashwathama using 'Brahmastra' on child Parikshit, who was at that time in the womb of his mother Uttara. What did Lord Krishna do? He simply made Brahmastra harmless by withdrawing its enormous power? He could because nothing is independently powerful, neither a person nor a weapon. If this was not so, there will be parallel power, which cannot be allowed, as this can cause disruption in the creation's functioning.

Before I go any further in describing God's unlimited powers, a question must be answered, which is, "Why does God not stop miseries heaped by a strong person on the weak? Does God not have such a power? He does but allows it. Why? Because we suffer due to our karmaphal. Others are just acting as mediums. In those cases, God remains aloof. Continuing about the extent of Lord's powers, Lord Krishna says that He is manliness of men (7.8), which is a traditional quality of being brave and strong. In the verse # 7.11, the Lord repeats this by stating that he is the strength of strong. However, in this verse, the Lord qualifies it by stating that such persons should be devoid of lust and attachment. If they are not, God will withdraw it from them. What happened to the most powerful man because of his lusty behaviour? I am referring to the last US President. Same could be said about Swami Vivekananda, whose brightness impressed one and all, wherever he travelled in the world. Where did this devotee of the highest order get his brightness? From God of course! I can go on, but the message is loud and clear. If we want the highest qualities, we must become devotees of God, otherwise we will always be inferior; God is ready to bestow upon us whatever is cherished by us. Source for everything superior is God only; He has all the powers.

Power differences in social groups are important in promoting group activities. Most people want power, and power has many benefits. However, power is a corrupting force in several instances.

The recent and short departure of Sam Altman from OpenAI and again returning to the company in the same post is a matter of surprise. However, founders being ousted from their organisations have been the larger picture for deliberations. This phenomenon is unfortunate, but not new. History has been witnessed with examples of visionary leaders who found themselves at odds with their boards or stakeholders, resulting in their removal. From the likes of Steve Jobs at Apple to Travis Kalanick at Uber, the stories are as varied as the industries

The Myth of Invincibility

The myth of invincibility continues. One common thread that ties together the stories of ousted founders is the perception of invincibility that often surrounds them. When a company is in its infancy, the founder is not just a leader but a symbol of the organisation's identity and purpose. However, as the company grows, the demands and challenges evolve, and the skills needed to lead a startup may not necessarily align with those required to steer a large corporation. Founders, especially those with a strong vision and personality, may find it challenging to adapt to these changing dynamics.

Sam Altman's exit for some days from OpenAI serves as a case in point. While he played a pivotal role in the organisation's early success, the need for a dif-ferent leadership style to navigate the complexities of a rapidly expanding enterprise may have become apparent. Boards and stakeholders, driven by a duty to ensure the company's long-term viability, might make the tough decision to part ways with the very leader who brought the company into existence.

The Ashneer Grover Saga
The story of Ashneer Grover, co-founder of Indian fintech giant BharatPe can be thought of in this context. It is another chapter in the book of ousted founders. In his case, the clash was not just about strategic direction but also about clashes of egos and leadership styles. However, Jobs' eventual return to Apple in 1997 and the subsequent resurrection of the company's fortunes showcase the rare scenario where a founder is reinstated to lead their creation once again. Job's story is a testament to the enduring impact of a visionary leader and the potential for redemption. However, it is worth noting that Jobs returned to Apple with a tempered approach and a willingness to collaborate, a stark contrast to his earlier stint. This suggests that even in exceptional cases, founders must evolve and adapt to the changing needs of their organisations.

Israel must work to avoid 'further displacement' of civilians in Gaza

The Biden administration has told Israel that it must work to avoid "significant further displacement" of Palestinian civilians in southern Gaza if it renews its ground campaign aimed at eradicating the Hamas militant group, senior US officials said. The administration, seeking to avoid more large-scale civilian casualties or mass displacement like that seen before the current temporary pause in the fighting, underscored to the Israelis that they must operate with far greater precision in southern Gaza than they did in the north, the officials said, briefing reporters on condition of anonymity under ground rules set by the White House.

Amid mounting international and domestic pressure about the rising Palestinian death toll, the White House has begun to put greater pressure on Israel that the manner of the coming campaign must be "carefully thought through," according to one of the offi-cials. The Israelis have been receptive when administration officials have raised these concerns, the official said.

Prime Minister Benjamin Netanyahu has made clear that Israeli Defense Forces will eventually restart military operations after the conclusion of the current, temporary cease-fire that has allowed for an exchange of hostages taken by Hamas for Palestinian prisoners held by Israel. The two sides agreed Monday to extend the truce for an additional two days and to continue swapping hostages for prison-President Joe Biden has

said he would like to see the pause - which has also allowed a surge of much-needed humanitarian aid to get into Gaza — continue as long as feasible. Secretary of State Antony Blinken will return this week to the Middle East as the U.S. hopes to find a way to extend the cease-fire and get more hostages released, the State Department said Monday. It will be his third trip to the region since Israel's war with Hamas began last month.

Family of infant hostage pleads for his release as truce winds down

Tel Aviv (AP): Kfir Bibas has spent nearly a fifth of his life being held in Tel Aviv on spent nearly a fifth of his life in Hamas captivity. The 10-month-old was abducted from his home in a southern Israeli kibbutz on Oct. 7, when Palestinian militants snatched about 240 people and dragged them to Gaza.

Kfir, the youngest captive, was among about 30 children who were taken hostage in Hamas' assault. Under a current temporary cease-fire, Hamas has released women, children and teens, but Kfir hasn't been included on the lists of those set to be freed.

With his red hair and toothless smile, Kfir's ordeal has become for many a symbol of the brutality of Hamas' attack. With most other young hostages already released, Kfir's fate and that of his 4-year-old brother, Ariel, are now a rallying cry for Israelis seeking the speedy release of all the hostages. A demonstration in

Still, Biden and top officials have also been clear-eyed about Israel's desire to continue operations focused on Hamas that over the last seven weeks have largely focused on the north. They have said they support Israel's goal of eliminating Hamas' control over Gaza and the threat it poses to Israeli civilians, but have grown more vocal about the need to protect the lives of Palestinian civilians. Hamas has been known to seek shelter among the territory's civilian population, and Israeli officials have released videos from northern Gaza of what they said are weapons stockpiles and firing locations placed among civilian infrastructure.

More than Palestinians have been killed since the war began on Oct. 7, roughly two-thirds of them women and minors, according to the Hamas-run Health Ministry in Gaza, which does not differentiate between civilians and combatants. More

US Secretary of State Asntony Blinken will return this week to the Middle East as the US hopes to find a way to extend a cease-fire in Gaza and get more hostages released, the State Department said. It will be his third trip to the region since Israel's war with Hamas began last month. Blinken will travel to Israel and the West Bank after attending Ukraine-focused meetings on Tuesday and Wednesday in Brussels and Skopje, North Macedonia, where foreign ministers from NATO and the Organisation for Peace and Security in Europe are gathering. Israel has agreed to pauses in its military operations in exchange for the gradual release of hostages taken by Hamas during its October 7 attacks on

after being held hostage by militant group Hamas in the Gaza Strip.

The agreement had been due to expire Monday but was extended for an additional two days, meaning the extension will be expiring just as Blinken is arriving in Israel.White House National Security Council spokesman John Kirby said Monday the US hopes to see the pause extended further, continuing to release hostages.

In Israel and the West Bank, Blinken will "discuss Israel's right to defend itself consistent with international humanitarian law, as well as continued efforts to secure the release of remaining hostages, protect civilian life during İsrael's operations in Gaza, and accelerate humanitarian assistance to civilians in Gaza", State Department spokesman Matthew Miller said in a statement. He said Blinken also will discuss the principles for a post-conflict Gaza, as well as the need to establish an independent Palestinian state and prevent the conflict from

In the occupied West Bank, Blinken is expected to see Palestinian Mahmoud Abbas. Blinken and other US officials have said they believe the Palestinian Authority should play a significant role in governing post-conflict Gaza. From Israel and the West Bank, Blinken will travel to the United Arab Emirates for discussions with regional leaders who will be in Dubai to attend the COP28 climate summit. Blinken has been engaged in furious diplomacy to try to prevent the Gaza conflict from spreading, expand the provision of humanitarian aid to Palestinian civilians in the territory, secure the release of hostages and arrange for for-eigners and dual nationals to leave Gaza overland to Egypt.

On each of his prior two trips, Blinken has travelled to Israel and Jordan multiple times. Between the two trips, he also made stops in Bahrain, Egypt, Iraq, Qatar, Saudi Arabia, Turkey and the UAE. Blinken will arrive in Israel

having just participated in an Organisation for Security and Cooperation in Europe foreign ministers meeting in Skopje. Russian Foreign Minister Sergey Lavrov has said he plans to attend the OSCE meeting, possibly setting the stage for a US-Russia confrontation there over Ukraine. In Brussels, Blinken will attend the two-day NATO gathering, which will include the first foreign minister-level meeting of the NATO-Ukraine Council, a body created by alliance leaders at their last summit to improve cooperation and coordination and help prepare Kyiv for eventual membership.

Sunak cancelled meeting over Elgin Marbles row: Greek PM

London (PTI): British Prime Minister Rishi Sunak has reportedly cancelled a planned meeting on Tuesday with his Greek counterpart, Kyriakos Mitsotakis, during a visit to the UK amid a deepening row over the return of the 'Elgin Marbles' .The ancient Greek sculptures from the Parthenon in Athens are among the controversial historic items which were brought to the UK by British diplomat Lord Elgin in the early 19th century - giving them

their English name. The Parthenon Sculptures now form part of the British Museum's collection and have long been demanded by the Greeks to complete their series at the Acropolis Museum in

The latest standoff is reminiscent of India's demands for the Koh-i-Noor diamond and other historic artefacts taken from India during colonial times. Most recently, the Maharashtra government signed a memorandum of understanding (MoU) with the Victoria and Albert Museum for a three-year loan of a set of 17th century 'Tiger Claws', or wagh nakh, believed to have belonged to Chhatrapati Shivaji Maharaj. It is destined for Mumbai's Chhatrapati Shivaji Maharaj Vastu Sangrahalaya (CSMVS) as part of Maharashtra's 350th anniversary celebrations of the coronation of

The UK-Greece standoff seems to have erupted after Downing Street claimed that it had been agreed that the issue would not be raised during any bilateral between Sunak and Mitsotakis, a claim denied by the

Greeks. On Sunday, the Greek Prime Minister told the BBC that having some of the Parthenon treasures in London and others in Athens was like cutting the 'Mona Lisa' painting in half. That seems to have triggered the row, as Mitsotakis then told reporters on Monday evening that he was "deeply disappointed by the abrupt cancellation" of his meeting with Sunak, which had been planned for Tuesday afternoon. "Those who believe in the correctness and justice of their positions are never hesitant to engage in constructive argumentation and debate," said the

Greek Prime Minister.

S Korea delays its spy satellite liftoff

South Korea has postponed the planned launch of its first military spy satellite set for this Thursday, officials said, days after rival North Korea claimed to put its own spy satellite into orbit for the first time.

Under a contract with SpaceX, South Korea is to launch five spy satellites by 2025, and its first launch using SpaceX's Falcon 9 rocket had been scheduled to take place at California's Vandenberg Air Force Base in the United States.

The South Korean Defence Ministry said in a brief statement on Tuesday the launch was delayed due to weather conditions. Ministry officials said the launch was tentatively rescheduled for this Saturday but it wasn't a fixed date.

South Korea currently has no military reconnaissance satellites of its own and partially resorts to US spy satellites to monitor moves by North Korea.

After two launch failures earlier this year, North Korea said it successfully placed its "Malligyong-1" spy satellite into orbit on November 21. South Korea said it has confirmed that the satellite entered orbit, but said it needs more time to verify whether it is working proper-

North Korea said on Tuesday leader Kim Jong Un reviewed imagery taken by the Malligyong-1 satellite of the White House and the Pentagon in Washington and US aircraft carriers at a navy base and a shipyard in Virginia. North Korea earlier said the satellite also transmitted photos of US military facilities in Guam and Hawaii

send high-resolution imagery and perform proper military reconnaissance

The North Korean launch invited strong condemnations from South Korea, the US, Japan and others. It violated UN Security Council resolutions that ban any satellite liftoffs by North Korea because they are considered disguised tests of the country's long-range missile tech-

Kim has said spy satellites would allow his country to better monitor its rivals and enhance the precision-strike capability of its nuclear-capa-

The satellite launch flamed animosities between the rival Koreas, with both nations taking steps to breach their previous military agreement meant to ease frontline military tensions.

Spy satellites were among the high-tech weapons systems that Kim has publicly vowed to introduce.

Since last year, North Korea has conducted about 100 ballistic missile tests in part of efforts to modernize its arsenal of weapons targeting South Korea and the United States.

In response, South Korea and the United States have expanded their military training and enhanced "regular visibility" of US strategic assets such as aircraft carriers, nuclear-capable bombers and a nuclear-armed submarine to the Korean Peninsula.

Haley argued former president Donald Trump causes too much chaos to be successful in a second White House term, reiterating her argument about the GOP front-runner at a large town hall in her home state of South Carolina.

The former governor and United Nations ambassador on Monday drew the largest crowd of her primary campaign so far as she tries to close the gap with Trump just weeks before the Iowa caucuses kick off the Republican nominating calendar.

Haley invoked her former boss saying, as she has before, that she believes Trump was "the right president at the right time" but that the time is now right for a new generation in US leadership. "I agree with a lot of his policies, but the truth is, rightly or wrongly, chaos follows him," Haley said. "We have too much division in this country, and too many threats around the world to be sitting in chaos once again."

About 2,500 people attended the event at a satellite campus of the University of South Carolina along the state's southern coast. Half that number watched her event from video screens outside the venue after it reached capacity. Hours ahead of Monday's start time, the line for attendees wrapped around the venue, which the campaign said had to be changed from its original location due to demand.

Her staff has cast her campaign as being on a rising trajectory and pointed to growing crowds in recent weeks as she gets new attention from voters and donors looking for a Trump alternative

Imran's trial to continue in Adiala jail in open court

His in-prison trial had been going in the high-security jail until last week when the Islamabad High Court (IHC) declared it null and void on procedural grounds and also declared that the proceedings conducted so far were vitiated.

Special Court Judge Abual Hasnat Zulqernain presided over the hearing on Tuesday at the Federal Judicial Complex (FJC) in Islamabad, where authorities failed to produce Khan, citing security reasons.

NATO is likely to name a new secretary general at its next summit in Washington in July. Former Norwegian prime minister Jens Stoltenberg has been the alliance's top civilian official since 2014. His term has been extended four times during the war in Ukraine.

We're going to have 32 countries. Keeping 32 countries together on any topic, it's a big challenge, and we need a consensus builder that can work with any and all allies, to move everyone forward in the same direction," Latvian Foreign Minister Krisjanis Karins told reporters at NATO headquarters. One of Stoltenberg's challenges is to help persuade Turkey, along with Hungary, to endorse Sweden's attempt to become NATO's 32nd member. NATO officials hope the issue will be resolved by the time US President Joe Biden and counterparts meet in Washington.

Karins was Latvia's prime minister for almost five years NATO prefers its secretaries general to have served in top government posts - and oversaw an increase in defense spending. He said his country will spend 2.4 per cent of GDP on defense this year, above the organization's target of 2 per cent. Russia remains NATO's historical adversary, and managing the alliance's approach to Moscow is a major test. "The next secretary has to have a clear vision on the future role of NATO, how it's going to expand, how it's going to be working to contain Russia," Karins said. He said it's important not to panic while acknowledging "the very real threat that Russia is" and to

work together to contain it. "It is doable," he said. "We can do it if we are calm but

very determined." With Russia locked in its war on Ukraine, the process of naming a new secretary general has become highly politicized. Estonia, Latvia, Lithuania and Poland have taken an unbending line in support of Ukraine, and this could make it difficult for one of their leaders to get the job.

Most NATO countries have been keen to name a woman to the top post. Estonian Prime Minister Kaja Kallas is considered a strong candidate. Danish Prime Minister Mette Frederiksen was thought to be a favorite after a meeting with Biden in the summer, but she later said she wasn't running. The president of the European Commission, Ursula von der Leyen, has ruled out her candidacy. Outgoing Dutch Prime Minister Mark Rutte is also a front runner.

NATO secretaries general are chosen by consensus. There is no formal procedure for naming them, and diplomats have said that no official vetting is currently being done. The organisation's top civilian official is responsible for chairing meetings and guiding sometimes delicate consultations between member countries to ensure that compromises are found so that an alliance that operates on consensus can continue to function.

The secretary general also ensures that decisions are put into action, speaks on behalf of all nations with one voice and rarely if ever singles out any member for public criticism.

Stoltenberg has managed to tread a fine line, refraining from criticizing members led by more go-it-alone presidents and prime ministers like former US President Donald Trump, Turkish President Recep Tayyip Erdogan or Hungarian Prime Minister Viktor Orban.

Baltic nations' FMs pull out of OSCE meeting over Russian foreign minister attendance

The foreign ministers of the three ■ Baltic states have said they will boycott a meeting by the Organisation for Security and Cooperation in Europe being held this week in North Macedonia, in objection to the participation of Russia's foreign minister.

The foreign ministers of Estonia, Latvia and Lithuania issued a joint statement on Tuesday saying they "deeply regret the decision enabling the personal participation" of Russia's Sergey Lavrov. "It will only provide Russia with yet another propaganda opportunity." Lavrov said on Monday he planned to travel to Skopje for the OSCE foreign ministers' meeting, a trip which would mark his first visit to a NATO member country since Russia invaded Ukraine. In September, he was in New York to attend the United Nations' annual gathering of world leaders. The 57nation OSCE was set up during the Cold War to help defuse tension between East and West. North

Macedonia currently holds the Tuesday, North Macedonia's foreign organisation's rotating presidency and its foreign minister invited Lavrov to the two-day meeting

starting on Thursday. "For the past two years we have witnessed how one OSCE participating state has actively and brutally tried to annihilate another," the Baltic foreign ministers said in their statement. "Let us be very clear: Russia's war of aggression and atrocities against its sovereign and peaceful neighbour Ukraine blatantly violate international law."

They also accused Russia of "obstructive behaviour within the OSCE itself," citing Russia's prevention of an OSČE presence in Ukraine and by blocking Estonia's chairmanship of the organisation in 2024. Lavrov's attendance at the Skopje meeting "risks legitimising aggressor Russia as a rightful member of our community of free nations, trivializing the atrocious crimes Russia has been committing," they added.

Speaking to reporters at NATO headquarters in Brussels on

minister, Bujar Osmani, said he believed he would be meeting Lavrov in Skopje. "Lavrov is not coming to Skopje, in a way. Lavrov is coming to the OSCE just as he went to (the) UN in New York a few months ago," Osmani said. "I won't be meeting him as the foreign minister of North Macedonia, but as the OSCE chairman in office." Asked what he would say to Lavrov, Osmani said: "I think the Russian Federation has violated (the) commitments of OSCE principles that we have voluntarily subscribed to 50 years ago."

"We have condemned the aggressor throughout our chairpersonship. And also we have turned (the) OSCE into a platform for political and legal accountability of the Russian Federation for its deeds in Ukraine, and we will continue to do so. And this is what I am going to tell to Mr. Lavrov as well."

There was no immediate reaction from the Russian Foreign Ministry to the statement by the three Baltic states.

Govt disconnects 70 lakh mobile involved in financial frauds

¬o check digital frauds, the government has disconnected 70 lakh mobile numbers so far involved in cybercrime or financial frauds, Financial Services Secretary Vivek Joshi said on Tuesday.

Emerging from a meeting to discuss issues related to financial cyber security and increasing digital payment fraud, Joshi who chaired the meeting, said banks have been asked to strengthen the system and processes in this regard.

More such meetings would take place, he said, adding the next meeting is scheduled in January. During the meeting, it was noted that 70 lakh mobile connections involved in cybercrime/ financial frauds reported through digital intelligence platforms have been disconnected so far.

About Rs 900 crore of defrauded money has been saved, benefitting 3.5 lakh victims, an official statement said. With regard to Aadhaar Enabled Payment System (AEPS) fraud reported recently, he said states have been asked to look into the issue and ensure data protection.

Earlier this month, Kolkata-based public sector lender UCO Bank reported erroneous credit of Rs 820 crore to account holders of the bank via Immediate Payment Service

During November 10-13, the bank observed that due to technical issues in IMPS, certain transaction(s) initiated by holders of other banks have resulted in credit to the account holders in UCO Bank without actual receipt of money from these banks. ÎMPS is a real-time interbank electronic funds transfer system without any intervention. The bank blocked the recipients' accounts and has been able to recover Rs 649 crore of the Rs 820 crore or about 79 per cent of the amount.

The state-owned bank is yet to clarify whether this technical glitch was due to human error or a hacking attempt. However, the bank has reported the matter to the law enforcement agencies for necessary action.

Ashneer says sorry, HC slaps ₹2 lakh fine over posts against BharatPe court's clerks' association.

The Delhi High Court on Tuesday imposed Rs 2 lakh as costs on BharatPe co-founder Ashneer Grover in the matter related to his alleged defamatory social media posts against the fintech company even as he tendered an apology for his con-

Justice Rekha Palli took on record the apology and the undertaking given by Grover but proceeded to impose costs on him, saying the "court cannot be

taken for granted". The judge, while dealing with a plea by Resilient Innovations Pvt Ltd - which owns BharatPe against Grover, said the court was "appalled" to note the "per-

sistent" and "blatant" violation of the earlier orders and assurances given by Grover in this regard. The plea forms part of a lawsuit by Resilient Innovations against former managing director Grover and others.

Taking into account that defendant no 2 is now filing an affidavit specifically undertaking not to post any such defamatory posts in future and is also apologising for his past behaviour, this court is inclined to close the matter at this stage by binding the defendant no 2 to his undertaking.

"This is, however, subject to a payment of costs of Rs 2 lakh, the court ordered.

The court directed that the amount shall be paid to the high Senior advocate Akhil Sibal, appearing for the plaintiff, argued that in spite of court orders asking the parties not to make offending statements and Grover's undertaking to this effect, he was posting defamatory content against the fintech company on social media.

The senior lawyer said that an earlier application by the plaintiff was also closed after an assurance was given by Grover who was now adopting a "shoot and scoot" strategy to publish his defamatory posts.

He urged the court to issue an injunction order restraining Grover from posting such con-

The counsel for Grover said he



was tendering an apology and undertaking to not post any offending posts in the future and the present plea may be disposed

He also suggested that the matter may be placed for mediation. Last year, Resilient Innovations filed the lawsuit against its former MD Ashneer Grover and his family members to restrain them from making allegedly defamatory statements.

The court had issued summons to Ashneer Grover, his wife and other defendants in the suit filed by the fintech firm which has accused the couple of misappropriating funds.

Grover resigned from the company in March 2022 and his wife was removed from her post.

In the suit, besides seeking to restrain the defendants from making defamatory statements. the company has also sought direction for payment of over Rs 88.67 crore along with interest towards the recovery of alleged misappropriated funds and damages caused to the reputation of the firm.

The company has earlier claimed before the court that Grover, his wife and other relatives were carrying out a "vicious and vitriolic" campaign against the company which has a large number of foreign investors. Besides Grover and his wife, the company has arrayed as defendants Deepak Gupta, Suresh Jain and Shwetank Jain - all rel-

atives of the couple who were

appointed in different posts in the company.
As an interim relief, the compa-

ny has sought a direction to the defendants to delete or remove within five days all statements, tweets, social media posts, books, re-tweets, hashtags, videos, press conferences, interviews and comments made against the firm. It also sought liberty to approach

social media platforms, media houses, publications and others for deletion of such material. On May 16, the high court asked all parties to avoid recourse to unparliamentary and defamatory publications

against each other.
The lawsuit is listed for the next hearing on December 13.

'Champions League prices best in Germany and worst in Scotland'

When charging travelling fans for Champions League tickets, German clubs give the best value to away teams and Scottish clubs the Celtic and Rangers routinely

charged visiting fans 70 euros (USD 77) — the UEFA-mandated maximum for the away section at Champions League games — last season while Baver Leverkusen asked for just 15 euros (USD 16.50), according to research published Tuesday by Football Ŝupporters Europe.

The FSE, UEFA's official fan liaison group, claimed safe standing areas for away fans at European games were key to driving down prices.

The average cost for fans to stand was 28% lower than at Champions League games seated areas.

euros (USD 130) five years ago before the Union of European Football Associations capped the ticket price for away fans. German clubs had four of the five lowest average away prices. Bayern Munich was the exception of the five German teams in the 2022-23 competition.

The FSE wants UEFA to keep up the pricing pressure next season when clubs are set to get more prize money and overall match revenue when the Champions League expands from 32 to 36 teams, with each playing eight games instead of six.

It is FSE's firm position that clubs have a responsibility to reward the loyalty of travelling fans and to facilitate affordable pricing, especially considering the increase of revenue for all clubs," Football Supporters Europe Executive Director Ronan Evain said in a statement. The price cap for away fans in the Europa League last season was 45 euros (USD 49) and the average cost was 29 euros (USD

excess hype often leads to broken Ehearts and hence it is always necessary to strike a balance, legendary Kapil Dev said on Tuesday in context of India's six-wicket defeat at the hands of Australia in the World Cup final earlier this month. The 1983 World Cup winning skipper said that the Indian fans should refrain from creating too much pressure and treat cricket just as another sport.

"Don't keep so much hopes that people end up with broken hearts. We need to keep a balance. Other teams also came to India to compete in the World Cup. We shouldn't create so much hype. We need to look at sports as sports only. Whoever plays good on the day, we need to respect that. We are too emotional," Kapil said on the sidelines of the inaugural tee off ceremony of Kapil Dev Grant Thornton Invitational golf tournament here.

India won 10 games, most of which were lopsided as contests, before Australia turned the tables on them at the Narendra Modi Stadium on November 19.

For past 10 years, India have lost seven knock-out games out of eight ICC tournaments that they took part between 2014 to 2023. Kapil doesn't know if the pressure of occa-

sion gets to them. "I think today's players can answer how much pressure they feel. We can only feel," he said. However there are shortcomings which needs to be taken care of, Kapil stated, without specifying what they were.
"If they (India) win it feels really good.

There are shortcomings which we need to address. It is not that you won't have shortcomings after a win. What's most important is to rectify them," the 63-year-old said.

He urged fans to celebrate what India achieved rather than what they missed out. "They (India) won 10 matches in a row. Is it not enough? We should look at other teams as well. We shouldn't compare anyone. What is important is to see whether they played good cricket or not. We



played very good cricket. Final day was not ours so be it," the 1983-World Cup-winning captain added. Kapil cited the examples of South Africa and defending champions England to prove his point.

"We should look at performance of other teams as well like, South Africa, England who were the defending champions, they finished last (sev-

Kapil also lauded Prime Minister Narendra Modi's gesture to visit the Indian dressing room and console the players after the final loss in Ahmedahad on November 19. "If the Prime Minister doesn't encour-

age, who will? He is the No.1 man in the country and if he supports, it feels good," he said. The former all-rounder also refrained from commenting on Virat Kohli and Rohit Sharma's future in T20

Internationals. This is selectors job and we should leave it to them. It is not good to comment on everything. They are responsible and what they feel good, they should do," he said.
