The ongoing push for India to secure a remarkable 100medal haul at the 2023 Asian Games is gaining momentum. So far, India has secured an impressive tally of 86 medals. On Thursday, three additional gold medals were added to India's count.

Indian archers made their country proud. The women's combine emerged triumphant in an edge-of-the-seat thriller while the men's outfit secured the top prize without fuss as Indian compound archers swept all three gold medals on offer in team events, further bettering their best-ever show at the Asian Games, here on Thursday.

The women's compound team edged Chinese Taipei by the thinnest of margins, securing the gold medal win by just one point with Jyothi Surekha Vennam, Aditi Gopichand Swami and Parneet Kaur shooting 60 out of 60 in the final round of a heart-stopping final. Having knocked out two-

time defending champions South Korea, the Chinese Taipei trio of Chen Yi-Hsuan, Huang I-Jou and Wang Lu-Yun fought till the end but the topseeded Indian team won 230-

The scores were locked 200-200 till the last set but the young Indian team that has two teenagers — Aditi and Parneet - remained ice-cool to find three more 10s in the final

It put the pressure back on



their opponents who were to shoot last and needed to match with three 10s to force a shootoff. But Chinese Taipei started off with a nine that sealed the gold for India.

Having conquered the world less than two months back, it also completed India women's compound team's domination by becoming the Asian champions.

In the afternoon session, the men's trio of Abhishek Verma, Ojas Deotale and Prathamesh Jawkar downed South Koreans 235-230 to seal their sixth medal in archery. India's second gold in

Deotale and Abhishek Verma are assured of a top-two finish by making it an all-India men's compound individual final.

India's previous best show in archery at the Asian Games was in Incheon 2014 where they had claimed one gold, one silver and one bronze.

In squash, veterans Dipika Pallikal and Harinder Pal Singh

Sandhu survived some anxious moments to clinch the mixed doubles gold, but Saurav Ghosal settled for singles silver as Indian squash players recorded their best-ever performance at the Asian Games.

Dipika and Harinder eked out a 11-10 11-10 win over Malaysian duo of Aifa Binti Azman and Mohammad Syafiq Bin Mohd Kamal in a tense 35 minute final to fetch India's second gold medal in squash at the ongoing event.

However, it was disappointment for India's top player Ghosal as he lost to Malaysia's Eain Yow Ng 11-9, 9-11, 5-11, 7-11 in a little over an hour. But that wouldn't take sheen out of India's brilliant

outing in the squash competition in Hangzhou, where they bettered the country's effort in the Incheon Games 2014.

India had won a historic gold in the men's team event nine years ago, with two silver and a bronze to boot with.

However, in the ongoing Games, India have won two gold, a silver and a bronze.

"I don't always remember what happens on court. It's a blur for both of us. We only remember the last point. We are more than happy. We are very proud of the fact we are here and won gold," Dipika said after the win.

Both pairs were neck and

neck in the opening game, with none of them able to hold on to the lead. Dipika kept fetching points with her fantastic forehand.

In wrestling, Indian teen sensation Antim Panghal humbled Tokyo Olympics medallist Bolortuya Bat-Ochir 3-1 to win a bronze medal but other Indian wrestlers struggled badly at the Asian Games here on Thursday.

The 19-year-old Antim bounced back after losing to two-time Japanese world champion Akari Fujinami in the quarterfinals in a superb manner as she did not let the Mongolian attack much in the women's 53kg bronze play-off. Antim saved the day for

the Indian contingent which badly needed a medal after Narinder Cheema (Greco-Roman 97kg), Naveen (Greco Roman 130kg) and Pooja Gehlot (women's 50kg) were ousted.

Pooja was outplayed 2-9 in the bronze medal bout by Aktenge Keunimjaeva, the Asian championship bronze

A lot was expected from Mansi Ahlawat (women's 57kg) too but she ended up losing her bronze play-off 'by fall' to Uzbekistań's Laylokhon Sobirova, who needed just 70 seconds to win the contest.

BJP, Congress declare poster war MP SANJAY SINGH SENT

With the election season on the horizon, the rivalry between the Congress and the BJP has spilled over into the virtual world, where both parties are engaging in a poster war targeting each other on social media

A day after the Congress posted a picture of Prime Minister Narendra Modi with the caption "The Biggest Liar" and another calling him a "Jumla Boy," who was "going to hit the election rally soon," the ruling BJP at the Centre on Thursday shared a poster portraying former Congress chief Rahul Gandhi as a "new age Randi Gandin as a new age Ravan," evoking strong criti-cism from the Opposition party, which termed it "unacceptable" and "downright dangerous."

In a sharp retort, the BJP shared the poster of Rahul with several heads with the title "Bharat Khatre Mein Hai — A Congress party production. Directed by George Soros.' "The new age Ravan is here. He is Evil. Anti Dharma. Anti Ram. His aim is to destroy Bharat," the BJP said on X.

Congress chief spokesper-

son Jairam Ramesh said it is intended to incite and provoke violence against the former Congress chief, whose father and grandmother were assassinated by forces that want to divide India.

Ramesh said, "It is one thing for the PM to give evidence daily of being a pathological liar and suffering from a narcissistic personality disorder. But for him to get his party to produce something this obnoxious is not just completely unacceptable but downright dangerous."
"We will not be intimidat-

ed," the Congress leader also asserted.

Indian Youth Congress president Srinivas B V posted another poster on X portraying Modi as "MODANAV."

"The new age MODANAV is here. He is Evil. Anti

Democracy. Anti Constitution. Anti People. Anti Humanity. His only aim is to destroy Bharat and the idea of INDIA," he said on X along with the poster titled "Hindustan Khatre mein hai — MODANAV. A Bharat Jumlebaaj Party production. Directed by Param Mitra

As the battle lines between the two main parties get drawn

in the run-up to the 2024 Lok Sabha elections, their leaders have intensified their attacks

against each other. The poster war between the two parties is likely to escalate further in the coming months as elections in five States and the general elections draw near. Earlier also, both the parties had launched cartoon strips against leaders of both the opposing parties on social media.

A day earlier, senior BJP leader and Assam Chief Minister Himanta Biswa shared images of Rahul's visit to Golden Temple and compared it with action on Punjab unrest by former PM Indira Gandhi, saying, "while grandmother sprayed bullets, grandson is doing seva."

AICC general secretary KC Venugopal said in a statement, "No words are enough to con-demn the shameful graphic on the BJP handle comparing Rahul to Ravan. Their nefarious intentions are clear; they want to murder him. He, who lost his grandmother and father to assassinations."

The Congress also reminded the withdrawal of SPG protection to the Gandhi family to score petty political points."

The Special Enforcement Directorate Court at Rouse Avenue on Thursday sent Rajya Sabha member and senior AAP leader Sanjay Singh to five days custody until October 10 in the case related to the Delhi excise policy scam.

being treated unfairly.

The ED alleged that the money was delivered by Sarvesh, an employee of Dinesh Arora. "There is a direct link to the proceeds of crime," the ED counsel told the court.

(Singh) on that statement." There are separate agendas. Dinesh is in their hands for the last one and a half years The statement was given earlier. Why is it being brought up now? Once you had the statement, you did not call me for an explanation. You want to

humiliate me by arresting me

(Singh)," Mathur said. am not so unknown that he (Amit Arora) did not remember my name while giving earlier statements. Dinesh also did not remember my name. What happened suddenly that he gave all the statements against me? They are spreading lies, and this investigation is baseless. If I am guilty, give me the harshest punishment. All I want to say is that there cannot be a different law for me. You are sitting on the chair of justice,"

Singh is the third high-profile arrest of the AAP leader in the excise policy case. AAP communications in-charge Vijay Nair was arrested in September 2022. Then Deputy Chief Minister and AAP leader, Manish Sisodia was arrested in February 2023.

AAP gheraos Mumbai ED office to protest Sanjay arrest

Unfazed by detention of several their senior city party leaders, the Aam Aadmi Party (AAP) workers staged a vehement protest in front of the office of the Enforcement Directorate (ED) in south Mumbai against the "illegal" arrest of their party MP and leader Sanjay Singh in the national capital.

In a massive crackdown on the party's senior leadership in the city ahead of their protest in front of ED's office, the city police had earlier in the morning detained Mumbai AAP chief Preeti Sharma Menon,

Mascrenhas, vice president Plus Varghese and 15 other party leaders from their homes across the metropolis.

Undeterred by the detention of their party leaders, hundreds of AAP workers – led by party's Mumbai unit working president Dvijendra Tiwari descended in front of the ED office in south Mumbai, carrying banners, posters and staged a noisy protest against the "illegal" "draconian" arrest of Singh. They raised vociferous slogans against the Narendra Modi government and demanded the release of their leader.

Officer booked after Rohingya woman gets domicile certificate in Kishtwar

Arevelation that a Rohingya woman (an illegal immigrant from Myanmar), staying in Kishtwar for over a decade after getting married to a local resident, has now obtained a domicile certificate and is also in possession of an Aadhar card has rattled the Union Territory administration in Jammu and Kashmir.

According to a preliminary investigation done by the Kishtwar police, the domicile certificate was issued to Anwara Begum, a resident of Dachhan three years ago in the month of September 2020.

To further investigate the matter and ascertain more facts in the case the Kishtwar police have lodged an FIR against one

of the senior Revenue Department officers, a local facilitator, for issuing a fake domicile certificate in the name of a foreign national.

Senior Superintendent of Police, Kishtwar Khalil Poswal while briefing media persons about the ongoing investigation in the case said, "We have registered FIR No. 22/2023 under Sections 467, 468, 471, 120-B and 420 IPC at Police Station Dachhan". All three including the accused, the issuing authority, and the one who facilitated the same have been booked," he

SSP Khalil Poswal said We have rushed a police team to seize the relevant documents so that they can be examined by forensic experts before proceeding ahead. No arrest has

been made, he clarified.

According to SSP Kishtwar, some members of the Rohingya community have been staying in the Dachhan area of Kishtwar for a long time. The Rohingya woman in question has been living in the Dachhan area for over a decade now.

chief secretary over death of patients in Government hospitals in Nanded T N RAGHUNATHA MUMBAI

Taking suo motu cognisance of the news reports about the deaths of a large number of patients in two State-run hospitals in Nanded and Chhatrapati Sambhaji Nagar districts in Maharashtra in a span of 24 hours, the National Ĥuman Rights Commission (NHRC) on Thursday issued a notice to the State chief secretary, seeking a detailed report within four weeks on the incident and the status of infrastructure and man power in the two hospitals.

In a development that came Court took a similar suo motu cognisance and scheduled a hearing in the matter on Friday, the NHRC took note of reports in the media that the patients had allegedly died in these hospitals "due to a lack of medical help and a shortage of essential medicines".

"The commission has observed that the contents of the media report, if true, amount to a violation of human rights relating to the life and health of the victims due to negligence by public authorities, which is a matter of concern,"

a statement put out by the

Through its notice to the State Chief Secretary, the NHRC asked the Maharashtra government to inform it about the action taken against the public servants responsible for maintaining the two hospitals and also let it know about the status of the relief and rehabilitation provided to the aggrieved families.

"The commission would also like to know about the steps taken or proposed by the State Government to ensure that such unfortunate deaths do not recur in the future," a statement Meanwhile,

Maharashtra Congress on Thursday demanded that the families of 100-odd patients, including newly born babies who died in the government hospitals of Nanded, Chhatrapati Sambhaji Nagar, and Nagpur — be paid a compensation of ₹10 lakh per affected family by the State Government.

A delegation of the State Congress, led by its president Nana Patole, met Maharashtra Governor Ramesh Bais and handed over a memorandum, also demanding that the Eknath Shinde Government be dismissed for "lack of basic medical services" in the Government-run hospitals.

Flying squad busts illegal de-addiction centre in Gurugram

A joint team of the chief min-ister's flying squad and the health department busted a drug de-addiction centre being run illegally in Gurugram area and arrested one of its operators. According to police, the accused charged ₹10,000 to 12,000 for a normal room, while ₹15,000 to ₹16,000 for a VIP room with facilities like AC room and LED screen TV. An FIR in this regard has been registered at Sector 5 Police Station,

They said that 31 drug addicts were found at the centre, which was being run without a doctor and addicts were given medicines by the operators. On the basis of a tip-off, a joint raid was conducted Wednesday night at a drug deaddiction centre named 'Nai Umeed', which was being run from house number 23 in New Amanpura colony, said Inspector Harish Kumar of the

CM's flying squad The drug addicts in the centre were being treated for liquor, smack, ganja, sulfa, chitta, heroin injection and other contraband for the last three years without a doctor, he said. The team during the raid arrested one of the operators identi-



fied as Vinay Rathi, a resident

of Jhajjar, Kumar said.
"During questioning, Vinay Rathi revealed that the drug de-addiction centre was being run for the last three years where medicines were also given to the addict patients inspector said. "Rathi revealed he runs this de-addiction centre along with Devendra Yadav and Naresh Gehlot," he added.

An FIR was registered against Rathi, Yadav, and Gehlot under sections 420 (cheating), 342 (wrongful confinement), 347 (confining for extortion), and 120-B (criminal conspiracy) of the IPC following a complaint filed by Deputy Civil Surgeon Keshav Sharma, police said.

All the patients were shifted to another drug de-addiction centre and Rathi was arrested a, they added. "We are questioning Rathi and conducting raids to nab his other two accomplices," said Sub-Inspector Jagmal, the investigating officer.

Sanjay arrest: BJP offers prayers, AAP protests

AAP protesters raising slogans against the BJP, met with police barricades as they marched towards the BJP headquarters with banners, raising slogans against the party at helm at the Centre. Senior leaders Gopal Rai and Atishi Jarnail Singh, Priyanka Kakkar and Reena Gupta were among those present at the

A scuffle broke out between AAP workers and the police after which some of them were detained. The

"We have made proper arrangements and there are enough police personnel. We do not want law and order to deteriorate at any cost. We have been constantly communicating with the cadre (of AAP),"

Earlier, addressing a press conference, senior AAP leader and Delhi Cabinet minister Atishi claimed that over 500 officers of the ED and CBI conducted raids at various places linked to the AAP leaders in the last 15 months but "haven't found a single evidence" against them.

'They raided Manish Sisodia's residence, offices and several other places but they couldn't find evidence of corruption of even a single penny. And now, Sanjay Singh has been targeted," she said.

SC observes lapses in liquor probe against Sisodia

Observing series of lapses in investigation, the Supreme Court on Thursday sought to know from the CBI and the ED whether there was any evidence of bribery which could implicate former Delhi Deputy Chief Minister Manish Sisodia in the Delhi Excise policy scam.

At one point the bench observed these kind of probes would collapse the case in trial stage during cross examination.

A bench of Justices Sanjiv Khanna and SVN Bhatti said that merely because lobby groups or pressure groups had called for a certain policy shift, would not by itself imply that corruption or a crime has taken place unless there is an element of bribery involved.

"We understand there is a policy change and everybody wants a change that will be beneficial for them. That will be there. If we say special groups are discriminatory ... without money consideration, it will not make out an offence ... If we go to that extent, there will be no pressure groups or even vested interests when a policy decision is taken then ... Some pressure

and conflict will always be there. Of course, bribes cannot be accepted," the bench observed, questioning the probe agencies.

He said the probes into fake cases waste time of everyone including the government and its agencies. "All should work for the progress of the country. Framing anyone in fake cases will not help the country to progress," he said.

7 teachers lose job for getting selection on forged documents

Delhi Lieutenant Governor Vinai Kumar Saxena ordered the termination of the seven Trained Graduate Teacher (TGT) and Post Graduate Teacher (PGT) teachers appointed at the Delhi Tamil Education Association in 2022 allegedly on forged documents. The Lt Governor also

approved a Central Bureau of Investigation (CBI) inquiry into their appointments following the recommendations of the Directorate of Vigilance (DoV). The DoV found that these appointments were made in collusion with the officials of the Directorate of Education and the school management.

Saxena has also asked for a scrutiny of records of recruitment at Government-aided schools over the last 10 years and constituted a committee to study the appointment process in these schools, the statement

The action by the LG came over recommendation of the Delhi government's Directorate of Vigilance that found an alleged "collusion" between the Education Department and the school management in the said appointments, it said.

No immediate reaction was available from the Education Department and the school management con-

While terminating the seven TGT and PGT teachers, the LG approved recommendation of the vigilance department for a CBI probe into their appointment at the Delhi



allegedly through use of forged documents, it said.

"The LG agreed with the proposal of the DoV, which found a prima facie collusion between the officials of Directorate of Education and the Delhi Tamil Education Association (DTEA), where 51 candidates were appointed on various posts in the year 2022.

"However, it was found that 7 selected teachers for TGT and PGT posts had submitted fake experience certificates," read the statement.

The forged experience certificate was crucial in securing the job as each year of experience gave one extra mark to the candidate, it stat-

As per the terms and conditions of Education Department, the school management was required to verify all the certificates of the selected candidates.

'While the certificates needed to be verified by seeking and obtaining appointment letters, details of payments made along with bank details, copy of attendance register of the school showing their attendance, none of these criteria was fulfilled by the school management," it

The matter was placed before the Delhi chief secretary who directed to carry out the physical verification of the experience certificates issued by the respective schools.

The experience certificates submitted by three candidates were found to be "fake" However, experience certificates of the remaining four candidates were verified by the respective schools, but not supported by documentary evidence, it said.

The CBI is already investigating a similar criminal case involving another gov-ernment-aided school, Vedic Sanskrit Senior Secondary School, Khera Garhi, in the capital where appointments were made on the basis of alleged "fake" documents, it

SC reserves verdict on 1998 judgement granting immunity to lawmakers from prosecution

A seven-judge bench of the Supreme Court on Thursday reserved its verdict on reconsideration of its 1998 judgment which had held that MPs and MLAs enjoy immunity from prosecution for taking bribe to make a speech or vote in legislature. The constitution bench

headed by Chief Justice DY Chandrachud reserved the verdict after hearing a battery of senior lawyers including General Attorney Venkataramani and Solicitor General Tushar Mehta. The larger bench is recon-

sidering the 1998 verdict delivered in the JMM bribery case by a five-judge bench by which the MPs and MLAs were granted immunity from prosecution for taking bribe to make a speech or vote in legislature.

The apex court is revisiting the judgement 25 years after the JMM bribery scandal rocked the country. Solicitor General Tushar Mehta, while arguing the matter, urged the court to not go into the immunity aspect under Article 105



and accepted by the lawmaker. It can be tackled under the Prevention of Corruption Act," the law officer said. "Neither the majority nor minority (judgement of 1998) examined the issue from this perspective. The short question, on

A Delhi court on Thursday allowed the applications of NewsClick founder Prabir Purkayastha and human resources head Chakravarty, arrested in a case lodged under anti-terror law UAPA over allegations that the news portal received money to spread pro-China propaganda, seeking a copy of the FIR.

Additional Sessions Judge

Hardeep Kaur directed the city police to provide the duo a copy of the FIR. A detailed order is awaited.

During the proceedings, the counsel for Chakravarty also sought in writing the



grounds for his arrest, asserting that it was a constitutional safeguard for the accused. The advocate cited some judgments of the Supreme Court and the Delhi High Court to claim that though the offences alleged against his client under the Unlawful Activities



(Prevention) Act (UAPA) were 'serious", there were no statu-

tory grounds for the prosecution to deny him a copy of the Purkayastha's advocate,

appearing through video-conferencing, argued it was the accused's right to get a copy of

Prosecutor Atul Shrivastava opposed the applications. He cited a Supreme Court judgment to say an accused has to first approach the police commissioner, who would then form a committee to consider the request.

The application filed by the accused were "premature" and they cannot "directly jump before the court", Shrivastava added. 

Unnecessary platelet transfusion may prove fatal, says CMO

hief Medical Officer (CMO) Dr Sandeep Chaudhary said that the lack of platelets is not the cause of death of dengue victims and unnecessary platelet transfusion may worsen the patient's health. "Platelet deficiency is not the cause of death in dengue patients," he instructed the private doctors, nursing home operators and government sector doctors.

"As per international standards, unless a patient's platelet count is less than 10,000 and there is no active bleeding, he/she does not require platelet is not the primary treatment for dengue," he said, adding that in fact, platelet transfusion does more harm than good to the patient if it is used in a patient whose platelet count is more than 10,000. According to Dr Chaudhary, the primary cause of death in dengue patients is capillary leakage, which caus-

es blood loss in the intravascular compartment and results in multi-organ failure. "In case of plasma leakage from the intravascular to the extravascular compartment, the patient should be transfused with fluids in the amount of 20 ml per kg body weight per hour and the same process should be continued until the difference between the upper and lower blood pressure exceeds 40 mmHg, or the patient urinates in sufficient quantity,"he said, adding that this is all that is needed to treat the patient; unnecessary platelet transfusions can worsen the patient's

However, some people may develop red and white mottled rashes followed by loss of appetite, nausea, vomiting, etc. Patients suffering from dengue should drink plenty of fluids. Paracetamol can be taken to reduce fever and ease joint pain. However, aspirin or ibuprofen should not be taken as they may increase the risk of

The India-Canada row escalates amid US endorsement of Nijjar killing allegations

■ n recent weeks, global diplomatic relations have seen a shake-up following the growing rift between the India and Canada Governments. The heart of the conflict lies in Canada's allegations of an 'Indian hand' in the killing of Hardeep Singh Nijjar, a prominent pro-Khalistan Canadian national and a named terrorist by India for his involvement in several violent crimes. The spat is harming the interests of both countries but Canadian PM Justin Trudeau is not letting go because his political survival currently depends on maligning India's name. Meanwhile, there has been a new turn in the case with the US stating that Canada's allegations are "serious," adding fuel to the fiery debate. State Department Principal Deputy Spokesperson Vedant Patel said, "We continue to be deeply concerned about the allegations referenced by Prime Minister Trudeau." He added, "It is critical that Canada's investigation proceeds and perpetrators be brought to justice; we also have publicly and privately urged the Indian Government to coop-



erate in the Canadian investigation." Nijjar was killed in British Columbia, Canada, by unidentified gunmen which Canada claims were Indian agents. Its intelligence agencies claim that there is credible evidence of Indian agencies' involvement in the murder, though it is yet to be shared with India.

The US statement has caught many by surprise, as it had previously maintained a neutral stance on the matter. This shift in the US position has raised eyebrows and intensified the dispute. The Indian Government has reiterated that it is not its policy to indulge in such acts and that it had no role in Nijjar's killing. The reason for the latest statement is best

known to the US Administration but it certainly is doing no good in resolving the deadlock between two friendly countries, both staunch US supporters. The US has of late shifted its weight in favour of India, ostensibly to counter Chinese influence in the Asia Pacific, and gone ahead with several technical and strategic bilateral understandings. If it goes on pointing the finger at India without any proof, that would result in strained relations and the US design of circumventing China in the region would suffer. Nijjar's killing, though tragic and unfortunate, should not be reason for any diplomatic faux pas. India and Canada should amicably resolve the issue together and cooperate in the ongoing investigation, to which the Indian side has assured full support. The deepening rift between India and Canada has broader implications for international relations, too. Canadian insistence on providing haven to terrorists in the name of supporting freedom and liberty could have far-reaching consequences for that country itself. Moreover, its act has already affected the Indian diaspora in a big way as it faces threats and slurs from the emboldened Khalistanis. Where Trudeau wants to go with anti-India posturing to salvage his falling ratings is his call, but the ramifications are fraught with grave danger for both countries.



India emerges as a voice of Global South-



India has been airing the concerns of the Global South vociferously; S Jaishankar's address at the 78th Session of UNGA was a case in point

ndia has tried to use consistently the forum of the United Nations not only in pursuing its foreign policy goals effectively but also in projecting itself as the advocate of the Global South. India's leadership quality was demonstrated in the 1972 Stockholm Conference on the Human Environment which made it possible for the Stockholm Declaration to embody several principles that protect the interests of the global south. The legacy of Stockholm carries even today when India's External Affairs Minister S. Jaishankar raised the issue of climate change, mobilising resources for sustainable development goals and reforming multilateral development banks at the 78th session of the UN on 29 September 2023.

This has to be seen in the context of the New Delhi Declaration of G20. The declaration set the direction of future negotiations on important economic issues including climate financing which has for the first time put a \$5.9 trillion figure to green financing requirements for developing countries, reforms in multilateral development banks, international taxation and sustainable development. Although this new green financing requirement does not generate legal obligations for the developed north, it amounts to underlining very clearly that in the context of urgency of restricting global average temperature below 1.5 degrees as compared to-industrial level, financial needs will have to enhance over and above 100 billion dollar mark. The requirement of mobilising 100 billion dollars per year by 2020 is the obligation on the part of the developed north.

India as an Advocate in the Context of Climate Change. One agenda item that India has used to position itself as the advocate of the global south is the issue of climate change. The latter is not only a serious environmental challenge but is also a serious economic and developmental concern, which also directly impinges upon realizing the goals of sustainable development. is placed to bear the brunt likewise of many developing countries more. Índia used its coalitional reach of the global south that the developed countries are historically responsible for climate change and their per capita emissions of greenhouse gases are very high as compared to developing countries. India's arguments relating to climate change galvanized adequate support of the global south in enshrining a regime of differentiation in the UN Framework Convention on Climate Change (UNFC-CC). The idea of differentiation expressed through the principle of common but differentiated responsibilities and respective capabilities (CBDR) has been held responsible for warding off pressure by the developed north that the developing countries should also bear greenhouse gas mitigation obligations. The formulation of the principle of CBDR is being interpreted as an Indian formula that corresponds between the northern advocates of common responsibilities and southern proponents of a main responsibili ty of the developed north. Although the regime of differ-

MICROPLASTICS IN CLOUD WATER

Sir — It is a well-known fact that plastics that were once considered a boon have turned out to be a bane. From the Earth's crust to the ocean's depths, their presence is ubiquitous. However, the latest study that took cloud water samples from Mount Fuji, Japan's highest peak, and Mount Oyama outside Tokyo last year has arrived at disturbing revelations. This must serve as an eye-opener that has the potential to spur mankind into immediate action. According to the latest report published in the Journal of Environmental Chemistry Letters, about nine varieties of microplastics, including polyethylene, polypropylene, and polycarbonate, have been found in the cloud water samples. Plastic particles less than 5 mm in diameter, referred to as microplastics, are slowly but steadily finding their way into our food chain. This is the first study to detect airborne microplastics in the free troposphere.

The U.N.E.P. states that at least 430 million tons of plastic are produced every year, and two-thirds of it ends up as waste, choking the air we breathe and disturbing even our oceans, biosphere, and lithosphere. The presence of 7 to 13 pieces of microplastics, measuring seven to 94 micrometers, in a liter of cloud water suggests that rainwater might also contain plastic. Scientists opine that if plastic air pollution is not addressed proactively, AMP (airborne microplastics) might trigger climate change and ecological risks. Their harmful nature has come to light, which can be detrimental to our health and can even poison everything that we eat and drink.

articipants in IMEC (India Middle East Europe Economic Corridor) are expected to meet next month to decide on the architectural framework for the historical infrastructure network physically and digitally connecting many countries. The IMEC was born during the G20 leaders summit in New Delhi in September and the ambitious targets it has set for itself make it one of the most powerful eco-political tools to counter

The MoU reads "Pursuant to this, the Governments of the Kingdom of Saudi Arabia, the European Union, the Republic of India, the United Arab Emirates (UAE), the French Republic, the Federal Republic of Germany, the Italian Republic, and the United States of America (the "Participants") commit to work together to establish the India - Middle East - Europe Economic Corridor (IMEC). The IMEC is expected to stimulate econom-



It has also asked the Government to "consider favourably the proposal to lower GST on raw materials in the interest of fertilizer manufacturing companies and ultimately farmers". Currently, raw materials (RMs) such as sulphuric acid and ammonia used in the production of fertilizers, attract GST at a much higher rate of 18 per cent against 5 per cent levied on fertilizers (albeit finished product).

The issue of further reducing GST on fertilisers was placed before the GST council in its 45th and 47th meetings in September 2021/June 2022, but it didn't recommend any reduction. Whether or not the GST Council will accede to the recommendation of the Standing Committee now, one can only wait and watch. Meanwhile, it is important to highlight three major flaws in the taxation of fertilizers.

First, given the critical role of fertilizers in ensuring food security, the Government controls their maximum retail price (MRP) at a low level, unrelated to the cost of production and distribution and reimburses the excess of the cost over MRP as a subsidy to the manufacturers. In the case of urea, the MRP is just about one-tenth of the cost whereas, in the case of non-urea fertilizers, the price is nearly one-third.

cost (9/10th in the case of urea and 2/3rd

in the case of non-urea fertilizers) is borne by the Government - using taxpayers' money - just to make fertilizers affordable to the farmers, it makes no sense to levy tax on those very products namely fertilizers and RMs used in their production. The taxes have the effect of increasing the cost of supplying fertilizers which has to be reimbursed as an 'additional' subsidy to the manufacturers.

It is a typical case of taking from one hand and giving back from the other. There is no justification whatsoever for levying any tax on fertilizers or RMs used for making

The second flaw has to do with taxing two major components of the fertilizer supply chain under two different regimes; one under GST and the other under the pre-GST regime. All finished fertilizers such as urea, dia-ammonium phosphate (DAP), muriate-of-potash (MOP) and so on are taxed under GST currently attracting a tax rate of 5 per cent. Most of the RMs used in the production of fertilizers are also covered under GST attracting a tax rate of 18 per cent on sulphuric acid and ammonia and 12 per cent on phosphoric acid.

However, natural gas (NG) which is used for the manufacture to impose a tax (or electricity duty) of all domestic urea (small quantities are used for making ammonia which in turn, is used for making non-urea fertilizers) is taxed under the pre-GST dispensation. Taxation of electricity, a utility intrinsic to the process of manufacturing fertilizers is also outside GST. This results in a much higher cost of these two major inputs than the cost if they were to be brought under GST.

At present, NG attracts 'nil' central excise duty (CED) on supplies to fertilizer plants and value-added tax (VAT) varying from a high of 24.5 per cent in Andhra Pradesh (AP) to a low of 5 per cent in Rajasthan. Then, there are other local taxes; for instance, the Gujarat government collects the "purchase tax" on that portion of inputs consumed for making urea that is sold outside the State. This leads to a cascading effect on the price of NG in

First, being outside GST, gas

companies viz. Oil and Natural Gas Corporation (ONGC), Oil India Limited (OIL) and so on, can't claim credit for the taxes paid on their purchase of inputs, consumables and equipment leading to higher prices. Second, the delivered price at the factory gate increases due to the levy of VAT, the impact being the highest in AP where the tax rate is 24.5 per cent. Third, the price fur-ther increases due to local levies.

Electricity too is outside GST. Further, its generation and distribution are exempt from the levy of Central VAT (CENVAT) and VAT. This results in a situation whereby power companies don't get any credit for taxes paid on inputs viz. equipment, stores and so on, used in its generation and distribution. This results in a higher cost of elec-

Further, under the Constitution, entry 53 in the State list of the Seventh Schedule empowers States on the sale and consumption of electricity, except when it is consumed by the Union Government or the Railways. For electricity duty, electricity companies don't get any offset. This further exacerbates the cost of power supplied to fertilizer

To put it briefly, whereas, taxation of finished fertilizer products and some inputs/RMs used in their making under GST is intended to lower the cost of making fertilizers available to farmers, taxing other major inputs viz. NG and power under the pre-GST regime militates against this objective.

The third flaw has to do with high taxes paid on inputs used in the manufacture of fertilizers as against the tax liability on the output (read: finished fertilisers) being much lower. This isn't just because of the much lower GST rate but also due to lower MRP. For instance, in the cost-based or market-determined case of urea apart from a tax rate of


5 per cent, the MRP is a mere 1/10th of the cost of supply. This results in an 'unabsorbed' input tax credit (ITC) as the output tax falls far short of input tax and there is no provision in the law whereby manufacturers can claim it. Hence, the Centre has to compensate fertiliser manufacturers for unabsorbed ITC using its fertiliser subsidy bud-

To conclude, considering that the cost of making fertilisers available to farmers (sans taxes) by itself is substantially higher than the price the Union Government wants them to pay, ideally it shouldn't levy any tax. Even if it wants to levy, all components in the supply chain have to be under GST and fertilisers and all inputs/RMs should be in the lowest tax slab of 5 per

While the tax rate on fertilisers is already 5 per cent (the Committee's recommendation to lower it further to say 1 per cent or 2 per cent would unnecessaril complicate an already unwieldy GST regime with multiple slabs), this will require lowering the tax rate on ammonia, sulphuric acid and phosphoric acid from their current high of 18 per cent/12 per cent to 5 per cent. The same rate should apply to NG and power after bringing them under GST.

As for the third flaw, the recommendation of the Committee to keep the tax rate on RMs lower than on fertilizers alone won't help. This is because the artificially low MRP has no linkage with the cost that results in low output tax liability visà-vis the value of tax paid on inputs in turn, resulting in unabsorbed ITC. To address this, the government should give subsidies directly to the farmers under the direct benefit transfer (DBT) mechanism and let manufacturers charge full

Philippines fights TB, one barangay at a time

Tuberculosis is rampant and underreported in the Philippines; now early detection by latest portable testing kits is helping its eradication

ever doubt that a small group of thoughtful, committed citizens can change the world; indeed, it's the only thing that ever has," said the famous anthropologist, Margaret Mead. Bearing testimony to this, a small group of people in the Bantayan Municipality of Cebu, Philippines, has changed the lives of many people affected by tuberculosis. TB, despite being curable, continues to be the deadliest diseases in high TB burden countries.

Carrying innovative new diagnostic tools for TB in plastic tubs, they went from islet to islet on pump boats, braving inclement weather, to screen and diagnose people with TB. This resulted in a tremendous increase in TB case finding upfront: a 316%

rise in new TB case detection, and a 1292% rise in screening of those with presumptive TB. Imagine the difference it can make in the Philippines' fight to end TB if such interventions can be scaled up and become a norm. As per the latest Global TB Report 2022 of the World Health Organization (WHO), out of the estimated 741,000 people with TB in the Philippines, only 321,600 were notified to the national programme, and over 60,000 lives were lost due to TB.

As of now, only 43 out of every 100 people with TB are reached by the TB services in the Philippines, and only 65% of those reached, get a WHOrecommended molecular test diagnosis, while the rest get a smear microscopy (which underperforms in TB diagno-

sis), or get treated without any bacteriological confirmation. As early and accurate TB diagnosis is the gateway to the TB care pathway (and breaking the chain of infection transmission), the Philippines has a two-fold task:- firstly, it must ensure that it is reaching out to all those with TB (and not just 43/100), and-secondly, it must use WHO recommended molecular tests to diagnose TB timely and correctly. This paradigm shift in TB diagnostics is a critical entry point, not only to the full spectrum of TB care cascade but also towards ending TB in the country.

When the WHO recommended point-of-care, decentralised, laboratory and battery-operated molecular test Truenat (made by Molbio Diagnostics), along with the ultra-portable and batteryoperated x-ray made by Fujifilm, was deployed in Bantayan islets, new TB case notifications, as well as treatment success rate, increased manifold. Using the latest and state-of-the-art diagnostic tools in the Philippines was made possible in 2022 by introducing the New Tools Project (iNTP) of the Stop TB Partnership and the United States Agency for International Development (USAID), which has helped in the rollout of a package of latest innovations in diagnostics, treatments, and digital health technologies to strengthen TB care in high burden countries. Bantayan is the largest municipality of Bantayan Island and it has 25 barangays (small townships) and one district hospital which

is understaffed and undersupplied. These areas are also marked as geographically isolated and disadvantaged areas (GIDA). Most of the people here are fisherfolk or farmers and their income is Pesos 300-350 (USD 6-7) a day.

"During September to October 2022, we were able to screen 1774 people with presumptive TB by bringing these tools right to their doorstep. Most of them cannot afford to travel to the mainland for diagnosis or treatment. So we brought TB point-of-care testing to their doorsteps and saw a very high increase in case detection as well as in treatment success rate," said Dr. Tinsay. "As TB diagnostic technology was brought to the people (and not the other way round), people were more

On that fateful day, Dr Samantha Tinsay and her team were en route to one of the islets with the diagnostics tools in tow. "We did not know that a storm signal had been raised, and that nobody should be travelling. We were working and could not have

stopped as patients were already waiting at the clinic," said the spirited Dr Tinsay.

Because of the introduction of new tools, TB case detection went up from 110 in 2021 to 458 in 2022. The number of people who got tested for TB also went up from 180 people in 2021, to 2506 people in 2022, an astronomical increase of 1292%. These new innovative TB diagnostic tools are very crucial in the fight against TB, especially for people living in geographically isolated and disadvantaged areas (GIDA). These tools can really help eradicate TB. Bringing these tools to the people in a country like the Philippines where TB is very rampant, will help end TB, one Barangay at a time," rightly said Dr Tinsay.

Imran approaches Pak court seeking suspension of trial court's verdict

Islamabad (PTI): Imran Khan on Thursday approached the Islamabad High Court (IHC) seeking suspension of the trial court's verdict in the Toshakhana corruption case more than a month after it suspended the jailed former prime minister's three-year sentence for concealing details of state gifts.

Khan, who turned 71 on Thursday, was arrested on August 5, 2023, and shifted to Attock jail after Additional District and Sessions Judge Humayun Dilawar sentenced him to three years in prison in the Toshakhana (national treasury gifts) graft case. The court had found the Pakistan Tehreeke-Insaf (PTI) chief guilty of "corrupt practices"

The Supreme Court later acknowledged "procedural defects" in Khan's conviction by the trial court.

On August 28, the IHC suspended Khan's sentence in the Toshakhana case but the PTI chief was not released because he was arrested in the cipher case for allegedly violating the Official Secrets Act by disclosing a cable sent by Pakistan's embassy in Washington last year in March. He has since cial remand, which has been extended until October 10.

On September 26, Khan was shifted to Adiala jail in Rawalpindi from Attock jail in Punjab province following the directives issued by the IHC. Last weekend, the police ramped up security in the vicinity of the Adiala jail by deploying elite commandos and setting up additional security pickets to ensure foolproof measures. In addition to working closely with Russia in the information space, China has attempted to enlist other close partners to counter unfavourable narratives, the State Department said in a report released here last week. Prominent among them is Pakistan, it said.

"With Pakistan, Beijing has sought to deepen cooperation on 'combating disinformation', including under the China-Pakistan Economic Corridor (CPEC) Media Forum," said the report.Beijing and Islamabad use the Media Forum to address what they view as propaganda and "malicious disinformation" and have launched initiatives like the "CPEC Rapid Response Information Network" and, most recently, pledged to launch the China-Pakistan Media Corridor

According to the State Department report in 2021, China sought to negotiate significant control over Pakistani media as part of the China-Pakistan Media Corridor, including establishing a jointly operated "nerve center" to monitor and shape Pakistan's information environment. The scope of the proposal, which does not appear Islamabad seriously entertained, and the fact that the mechanisms it detailed appeared to disproportionately benefit Beijing is notable as an explicit example of Beijing's ambition to assume direct control over a close partner's domestic information environment, it said.

China's draft concept paper called for China and Pakistan governments to establish a "nerve center" to monitor Pakistan's information environment by streamlining inputs from think tanks, opinion leaders, CPEC study centres, media organisations, PRC companies, and even local Confucius Institutes

'The proposed nerve centre would have relied on "three mechanisms" and "two platforms" to carry out this mission. The mechanisms would have provided means to convert important reports into Urdu products to sway popular opinion; provide PRC Embassy reports directly to Pakistan's official press release system; and monitor and respond to public criticism about the PRC," said the State Department.

The two proposed platforms called for the creation of a joint PRC-Pakistan authoritative system for "dispelling rumours" and a news feed application to promote approved news to the local market, it said. In its report, the State Department alleged that China spends billions of dollars annually on foreign information manipulation efforts. Beijing uses false or biased information to promote positive views of China and the Chinese Communist Party (CCP). At the same time, China suppresses critical information that contradicts its desired narratives on issues such as Taiwan, its human rights practices, the South China Sea, its domestic economy, and international economic engagement, it said.

'Crackdown on illegal immigrants not aimed at any nationality'

A day after the ruling Taliban in Afghanistan slammed Pakistan's decision to expel its undocumented nationals and termed it "unacceptable", Islamabad on Thursday clarified that its ongoing operation against illegal immigrants was not targeted against people of any particular nationality. On Tuesday, Pakistan's caretaker government set November 1 as the deadline for thousands of undocumented immigrants, including Afghan nationals, to leave the country or risk imprisonment and deportation as it intensified its crackdown against those involved in militancy and smuggling. Reacting to the develop-

ment, the ruling Taliban in Afghanistan on Wednesday said Pakistan's decision is "unacceptable". "The Pakistani side should reconsider its plan. Afghan refugees are not involved in Pakistan's security



Pakistan voluntarily, that country should tolerate them," spokesperson Zabihullah Mujahid said.

Replying to a question at the Foreign Office's weekly briefing here, spokesperson Mumtaz Zahra Baloch said the ongoing action envisages repatriation of individuals who have either remained in Pakistan beyond their visa or do not possess "valid" documents to stay

within parameters of its sovereign domestic laws to take action in this context," she said. At the same time, she said, the ongoing operation has nothing to do with the 1.4 million Afghan refugees that Pakistan has been hosting for decades "despite its own constrained economic situation". Pakistan's national policy on Afghan refugees "remains unchanged"; the spokesperson said.

Japan lifts tsunami advisory issued after earthquake

Tokyo (AP): Japan issued a tsunami advisory Thursday after a strong earthquake struck near its outlying islands in the Pacific Ocean, but lifted it about two hours later. No damage was reported.The advisory, the second-lowest of a fourstage warning system, asked people on islands in the Izu chain, which stretches south from the Tokyo region, to stay away from the coast and river

The USGeological Survey said a series of offshore earthquakes hit the area on Thursday morning. The strongest measured magnitude 6.1 and was located at a depth of 10 kilometers (6 miles), it

The quake was not felt on the islands or in the Tokyo region, but the Japan Meteorological Agency warned that a tsunami as high as 1 meter (3.2 feet) could hit the coasts of the islands.

Drone attacks in Syria kill officers, civilians

drone attack Thursday A struck a packed graduating ceremony for military officers in the Syrian city of Homs, killing an unspecified number of civilians and military personnel and wounding dozens of others, Syrian state television reported. Syria's military said in a statement that drones laden with explosives targeted the ceremony as it came to an end. They accused insurgents "backed by known international forces" for the attack, and said that some of the wounded were in critical condition, including women and children. They didn't specify the number of casualties and didn't accuse anyone in particular of carrying out the deadly strike. No group immediately claimed responsibility for the

Philippine boats breach Chinese coast guard blockade in faceoff

Two Philippine coast guard ships escorted the smaller supply boats, but it wasn't immediately clear whether the ships were blocked by the Chinese coast guard from coming closer to the Second Thomas Shoal where a small contingent of Filipino marines has stood guard for years aboard a longmarooned but still actively commissioned warship, the BRP Sierra Madre.

China also claims the shoal and has surrounded it with its coast guard ships and militia vessels to prevent the Philippines from delivering construction materials that Beijing fears could be used to reinforce the Sierra Madre and turn it into a permanent terri-



torial outpost.

"Despite attempts by a significant number of China coast guard and Chinese maritime militia vessels to block, harass, and interfere with the routine rotation and resupply mission," the two Philippine boats managed to deliver provisions to the Filipino forces at the shoal, a Philippine government body overseeing the disputed waters said in a statement late Wednesday. "The Philippines' resupply missions and mainte-

nance of BRP Sierra Madre are part of regular operations in ine with domestic and international law and ensures safety and well-being of our stationed personnel," the inter-agency body said.

It didn't provide other details of the Chinese coast guard's actions, which it has condemned in the past as dangerous maneuvers that have nearly caused collisions. and violated international safety regulations at sea.

"We want to develop relations with other countries on the basis of mutual benefits. For example, we have relations with India in diverse areas such as trade, transit, economy, culture and so on. In the same manner, China being one of our important neighbours we also do have the same kind of rela-

Russian strike on Ukranian cafe kills 49

Zelenskyy urges stronger Western support

t least 49 civilians were Akilled Thursday in a Russian rocket strike on a village store in eastern Ukraine, one of the deadliest attacks in recent months that came as Ukrainian President Volodymyr Zelenskyy attended a summit of around 50 European leaders in Spain to drum up support from the country's allies.

Zelenskyy denounced the attack on the store and cafe in the village of Hroza as a "demonstrably brutal Russian crime" and "a completely deliberate act of terrorism".

He urged Western allies to help strengthen Ukraine's air defences, saying that "Russian terror must be stopped".

"Russia needs this and similar terrorist attacks for only one thing: to make its genocidal aggression the new norm for the whole world," he said. "Now we are talking with European leaders, in particular, about strengthening our air defence, strengthening our soldiers, giving our country protection from terror. And we will respond to the terrorists.

Presidential chief of staff Andrii Yermak and Kharkiv Gov Oleh Syniehubov said a 6year-old boy was among the dead, adding that six other people were wounded.

The attack came as Zelenskyy was in in Granada in southern Spain to attend a summit of the European Political Community, which was formed in the wake of Russia's full-scale invasion of Ukraine in February 2022. "The key for us, especially before winter, is to strengthen air defense, and there is already a basis for new agreements with partners," he said in a statement posted on his Telegram channel.

Last winter, Russia targeted Ukraine's energy system and other vital infrastructure in a steady barrage of missile and drone attacks, triggering continuous power outages across the country. Ukraine's power system has shown a high degree of resilience and flexibility, helping

alleviate the damage, but there have been concerns that Russia will again ramp up its strikes on power facilities as winter draws

Zelenskyy noted the Granada summit will also focus on "joint work for global food security and protection of freedom of navigation" in the Black Sea, where the Russian military has targeted Ukrainian ports after Moscow's withdrawal from a UN-sponsored grain deal designed to ensure safe grain exports from the invaded country's ports.
The UK Foreign Office

cited intelligence suggesting that Russia may lay sea mines in the approach to Ukrainian ports to target civilian shipping and blame it on Ukraine. "Russia almost certainly wants to avoid openly sinking civilian ships, instead falsely laying blame on Ukraine for any attacks against civilian vessels in the Black Sea," it said, adding that the UK was working with Ukraine to help improve the safety of

Massachusetts shooting: Baby delivered after mother hit by gunfire

Holyoke (Massachusetts) (AP): A shooting claimed the life of a baby that was delivered after its mother was one of several people hit by gunfire during a fight on a downtown street in the western Massachusetts city of Holyoke, authorities said.

The pregnant woman was shot on Wednesday afternoon while seated on a public bus and taken to a hospital in critical condition, the Hampden District Attorney's Office said.

"The infant, who was delivered, and needed life-saving medical services, tragically passed away," it added.

Police responded to the shooting at 12.38 pm and said it appeared three male suspects were involved in an altercation before gunshots were fired.

All involved suspects were believed to have been identified, taken to hospitals, and are in custody, according to the District Attorney's Office. No further information was immediately given on their conditions. The names of the woman shot and of the people involved in the shooting haven't been released. State police spokesperson Dave Procopio said earlier that the shooting stemmed from "an altercation

among people on the street."

Pioneer Valley Transit Authority spokesperson Brandy Pelletier confirmed that one of the agency's buses was on its route when it was involved in a shooting incident but said there would be no further comment on the active

Equity benchmark indices Sensex and Nifty rebounded sharply on Thursday after sliding for the past two sessions, propelled by bargain hunting in capital goods, banking, and IT stocks amid a sharp correction in global crude prices.

An encouraging PMI data further bolstered sentiment, even as relentless foreign capital outflows trimmed gains, traders said.

The 30-share BSE Sensex climbed 405.53 points or 0.62 per cent to settle at 65,631.57. During the day, it rallied 527.16 points or 0.80 per cent to 65,753.20.

"The positive signal from the PMI data and the correc-

ed the market sentiment. While regarding RBI policy, positively, the market expects the interest rate to be hold-on as external demand outlook indicates muted trend fearing disinflationary trend in the future," said Vinod Nair, Head of Research at Geojit Financial

"Global markets steadied on Thursday rebounding from previous losses after a strong

RBI expected to retain benchmark rate: Experts

The RBI is expected to retain the benchmark rate of 6.5 per cent in its latest bi-monthly monetary policy review, amid inflation concerns and other global factors, experts said.

RBI Governor Shaktikanta Das-headed Monetary Policy Committee (MPC) started its three-day meeting on Wednesday, and the policy review will be announced on Friday morning.

"I think that between the last MPC meeting in August and this time, inflation has gone up, growth remains strong while global factors have turned a little adverse in the sense that the US Federal Reserve is still aggressive in its stance, which has led to hardening of yields. In this situation, the central bank is expected to maintain a status quo on policy rates in the ensuing policy," Crisil Chief

Economist D Joshi told PTI.

He said the RBI would focus more on inflation given that growth is strong right now, adding oil price movements need to be watched carefully,

"We believe that the interest rates will be on the higher side, which essentially means that we will not see any rate cut

The Reserve Bank has been mandated by the central government to ensure the Consumer Price Index (CPI)-based inflation remains at 4 per cent, with a margin of 2 per cent on either

Retail inflation jumped to a 15-month high of 7.44 per cent in July, as prices of vegetables and other food items spiked, according to official data.



Chief Economist of Bandhan Bank, Siddhartha Sanyal, said, "The global macroeconomic backdrop remains complicated with uncertainties around growth. This will prompt the MPC to stay watchful, with a likely guidance of rates to remain higher for longer.

"Nevertheless, softening in prices of agro commodities since August has offered the MPC some breathing space, which will allow it to refrain from any rate action at the

Founder and Director of CreditWise Capital Aalesh Avlani also said there will likely be no change in the policy rates on Friday

The RBI started increasing the policy rate in May 2022 in tranches, in the wake of the Russia-Ukraine war and took it to 6.5 per cent in February this year. Since then, it has kept the rate unchanged in the last three successive bi-monthly monetary policy reviews.

of Titagarh Rail Systems, Umesh Chowdhury, added: "The government's policies and capital spending have certainly fuelled infrastructure growth. 

and Morocco would all qualify automatically for the competition. Morocco, which was last week named as host for the 2025 Africa Cup of Nations, will become the second African country to host the World Cup after South Africa in 2010.
