President Droupadi Murmu on Tuesday conferred the prestigious Dadasaheb Phalke award upon famous actor Waheeda Rehman. She became the eighth woman artiste to receive the award, the highest recognition in the field of Indian cinema. The 85-yearold actor dedicated it to her "dear film industry" and its various departments.

The President presented the award to Rehman during the 69th National Film Awards ceremony, held at Vigyan Bhawan. The veteran, who received a standing ovation from the A-list gathering as she walked to the stage, said film-making is a collaborative process.
"I feel very honoured and

humbled... But whatever I have achieved today, it is because of my dear film industry. Luckily, I got to work with top directors, producers, filmmakers, technicians, writers, dialogue writers, music directors and musicians," Rehman said in her acceptance

The Supreme Court on Tuesday unanimously refused to accord legal recognition to same sex marriage under the Special Marriage Act, ruling that it is within Parliament's ambit to change the law for validating such union.

The top court, however, recognised equal rights for queer people and their protection, while calling for sensitisation of the general public so they don't face discrimination.

The apex court, while passing four separate verdicts, was unanimous in holding that there is "no unqualified right" to marriage, and same sex couples can't claim it as a fundamental right under the Constitution.

The bench headed by Chief Justice DY Chandrachud was critical of the Centre's stand that the pleas for legal validation of same sex marriage was reflective of an urban elitist concept.

Queerness is neither an urban nor an elite concept or characteristic, said the apex court, which pronounced the ver-dicts on 21 petitions seeking legal sanction for same sex marriages.

It, however, differed on certain aspects, especially on the applicability of adoption rules for queer couples.

The five judges bench comprising the CJI, and Justices Sanjay Kishan Kaul, S Ravindra Bhat, Hima Kohli and PS Narasimha concurred on the main issue

that the court can't accord legal validation to same-sex marriage under the Special Marriage Act, and said the task has to be performed by Parliament. However, Justices Bhat, Kohli

and Narasimha, in two separate judgments, differed with the CJI and Justice Kaul on certain legal aspects. The CJI said adoption regulations are held to be void as they

are discriminatory towards queer people and denied them the right to adopt as a couple. Differing with the CJI's opinion, Justice Bhat held that just because queer couples are not allowed to adopt a child does not mean that the regulations are void.

The LGBTQIA++ persons, who had won a major legal battle in 2018 in the Supreme Court which decriminalised consensual gay sex, had moved the apex court seeking validation of same-sex marriage and consequential reliefs such as rights to adoption, enrolment as parents in schools, opening of bank accounts and availing succession and insurance benefits. However, the SC left all these for Parliament to decide. The CJI, whose views were supported by Justice Kaul in a separate verdict, recorded the Centre's submission that it will set up a committee headed by the cabinet secretary to examine the administrative steps that could be taken for addressing "genuine humane concerns of same-sex couples without going into the issue of legalising their marriage.

The CJI said the court can't make law but only interpret it and it is for Parliament to change the Special Marriage Act. Agreeing with the views of the CJI and Justice Kaul, Justice Bhat said the Constitution does not grant a fundamental right to marry. At the outset, Justice Chandrachud said there are four judgments — by himself, Justices Kaul, Bhat and Narasimha— in the matter. Directing the Centre, states and Union Territories (UTs) to ensure the queer community is not discriminated against, the CJI said queer is a natural phenomenon known for ages and is neither urban nor elitist. Iustice Kaul said he agrees

"Non-heterosexual and heterosexual unions must be seen as both sides of the same coin," Justice Kaul said, adding legal recognition of non-heterosexual unions is a step towards marriage equality.

Sabarimala continues to plead

Sabarimala, the holy shrine of Lord Ayyappa, nestled amid the jungles in the Western Ghats, is back in the news and is expected to stir up a hornets' nest, even as the Constitution Bench of the Supreme Court is getting ready to hear the plea demanding the restoration of the ban on women's entry into the temple.

Adding to the woes of Lord Ayyappa devotees is the demand by a section of MLAs and MPs of Kerala, belonging to a particular community, that the Centre should take up the task of laying a railway track to Sabarimala ostensibly to facilitate the transportation of cannabis from the Western Ghats to the rest of the State. The demand for women's entry to the shrine has been made by Ranga Hari, former All India Baudhik Pramukh of the RSS,

the organisation that spear-

headed the agitation against the entry of women in the age group of 10 to 50 into the

"Off with Outgrown Customs", authored by Hari (93), states that reformation is inevitable in Hindu society. "Traditionalists have always opposed reformers, and it is a human phenomenon in human society. The great Indian poet Kalidasa has said that nothing is good only because it is old and nothing is bad only because it is new," Hari writes, quoting from Malaavikagnimithram, a play by Kalidasa Hari has also quoted

Malayalam's mystic poet Kumaran Asan, who exhorted the society to reform and change the rules. "Else those very rules will be your downfall," the author has quoted Kumaran Asan's explosive poem Duravastha written immediately after the Mappila Rebellion of 1922.

which was in vogue from time immemorial, was not to allow women to worship in the temple, citing that the presiding deity at Sabarimala was an

eternal Brahmachari. The apex court had passed a landmark judgment on September 28, 2018, in which it allowed the entry of women inside the Sabarimala Temple. The petitioners, Indian Young Lawyers Association, had contended that denial of permission to women for worshipping in the temple was violative of the Right to Equality and liberty. The association argued that the custom violates the Right to Equality under Article 14 since it is "derogatory to the dignity of women. Article 25 of the Constitution

states that "all persons are equally entitled to freedom of conscience and the right freely to profess, practice, and promote religion." The exclusion of female worshippers was a vio-

lation of such rights.

The verdict was pronounced by a Bench consisting of the then Chief Justice Dipak Misra, Justices Rohinton Nariman, DY Chandrachud, Indu Malhotra, and AM Khanwilkar. Following the Supreme Court verdict, the Kerala Government went all out to ensure the entry of women into the temple. Despite a massive agitation staged by hundreds of thou-sands of devotees across the State and the resistance under the leadership of Valsan Thillankery, the top RSS leaders in the State, the Kerala Police ferried women activists to the shrine, masquerading them as women cops. Fatima and Bindu Ammini, the women activists who made it to the shrine, are Maoists. Valsan Thillankeri, who spear-

headed the agitation against the Kerala Government's move to allow women into the shrine, told The Pioneer that there was no change in the stance of the RSS. "The Sangh as well as the women themselves are unanimous in their opposition to women entering the holy shrine. What Hari has written are his personal views," said Thillankeri. The book, written in

Malayalam, has been translated into English by eminent journalist and author Rama Chandran. Many scholars with whom The Pioneer spoke expressed their anguish over the views of Hari. "It is an ageold custom and tradition, and there is a scientific reason behind the decision to ban women devotees. A pilgrimage to Sabarimala itself is a ritual that needs stringent regimen," said Unnikrishnan Panicker, a Vedic scholar in Kerala's Parappanangadi. Many lives have been lost in police action on devotees who had thronged the shrine in 2018 demanding a ban on women.

Pichai informed the Prime Minister regarding Google's plans to improve financial inclusion in India by leveraging the strength and reach of GPay and UPI. He also emphasised Google's commitment to contribute to the development trajectory of India, the release said.

Prime Minister also invited Google to contribute to the upcoming Global Partnership on AI Summit, which will be hosted by India in December 2023 in New Delhi, it added.

damaged in lightning strike

Aportion of the ancient Ranbireshwar temple, built by Maharaja Ranbir Singh in 1883, was flattened after being struck by lightning amid heavy rains on Tuesday morning.

No loss of life or any other injury to devotees was reported from the temple premises. According to Mahant of the

Ranbireshwar temple, the incident took place around 9.30 am. At least three devotees were around and they immediately ran to safety as the ancient structure collapsed amid lightning and thunder.

The temple is located in the heart of the old city near Shalimar Road and is visited by a large number of local devotees and tourists from different parts of the country.
The temple houses idols of Lord



Shiva, his consort Parvati, and his son Ganesha; a huge singlestone Shivlingam inside the main temple attracts the devo-

A huge life-size metallic Nandi made of brass sits at the entrance of the main temple which faces the main idols.

The rare Ekadash Lingams made of Safatik (a special transparent white stone) were specially brought by Maharaja Ranbir Singh from Banaras.

A senior officer of the State Disaster Response Force (SDRF) supervising the debris-clearing first call was received by them around 9:40 a.m. on Tuesday. 'We rushed our teams to the temple premises and launched the operations to clear the debris. The SDRF teams also demolished the leftover portion of the front verandah of the temple complex to clear the debris".

Ashok Kumar Sharma, secretary of the Dharmarth Trust, accompanied Ajatshatru Singh, son of Dr Karan Singh to the temple premises to supervise the oper-

The temple authorities also advised the devotees to stay away from the temple premises till the time the security audit is completed and necessary repair works are carried out.

Mayor of the Jammu Municipal Corporation Rajinder Sharma also visited the temple premises to take stock of the rescue operations.

Hardcore Maoist held from Gadchiroli forest

 $\mathbf{I}^{ ext{n}}$ a severe blow to the supply chain of naxalites operating in north-eastern Maharashtra, the C-60 commandos of the Anti-Naxal Squad (ANS) and the Central Reserve Police Force (CPRF) personnel on Tuesday arrested a hard-core Maoist from Iaiawadi-Doddur forest area in Gadchiroli district of eastern Maharashtra. Acting on intelligence inputs,

a joint team of C-60 commandos and CRPF's 191 battalion zeroed in on and arrested hardcore Maoist named Messo Gillu Kawado (50), an Area Committee Member (ACM) associated with Maad Supply Team, when he was roaming around suspiciously in the Jajawandi-Doddur forest area. A resident of Rekhabhatal from Etapalli taluka of Gadchiroli district, Messo Kawado was wanted in murder of two village Patils in 2021 and 2022, burning of a mobile tower at Tadbaili in Kanker district of Chhattisgarh and two incidents of exchange of fire with C-60 commandos of the Gadchiroli police. He was carrying a cash prize of Rs 6 lakh announced by the Maharashtra government on his head. For a few years prior to 2017,

With outbreaks of zoonotic diseases like Nipah, rabies, Zika, African swine fever and Lumpy Skin diseases in cattle and the constant threat of Avian Influenza in various pockets in the country, the Centre is gearing up for enhanced zoonotic diseases surveillance at the humanwildlife interface.

Sudarshan Pant on Tuesday flagged the disturbing scenario saying that 75 per cent of newly emerging infectious diseases that have affected people over the last three decades are zoonotic in nature.

Pant was addressing the National Conclave on "Augmented Zoonotic Diseases Surveillance at Human - Prevention and Control of Snakebite Envenoming" to Stakeholders here.

Pant was echoing the views of the World Health Organization (WHO) that around one billion cases and millions of deaths each year are the result of zoonoses, in which pathogens jump from vertebrate animals to humans. And of the 30 novel human viruses that have been identified in the last three decades, a massive 75% originated in other animals.

In fact, recognizing the gravity of the surging zoonotic disease in India, the World Bank's Board of Executive Directors early this year approved an USD82 million loan to India towards the adoption of global best practices for animal

Vehicle aggregator policy approved to clean air

In a major decision aiming to cut down air pollution in the national Capital, the Arvind Kejriwal Government has approved a policy "the Delhi Motor Vehicle Aggregator and Delivery Service Provider Scheme 2023", mandating a time-bound transition of commercial vehicle fleets of aggregators, delivery service providers and e-commerce entities to zero-emission electric vehicles by 2030.

This makes Delhi the first state/UT in the country and among very few cities globally which works to create a frame work for regulating aggregatorand delivery service- operated vehicles within the national capital. Under the scheme titled, the Delhi Motor Vehicle Aggregator and Delivery Service Provider Scheme 2023, bike taxis, which were recently banned from plying in the

city, will also make a comeback. The policy aims to move towards full electrification of all transport modes by aggregators, delivery services, and ecommerce platforms (each engaging 25 vehicles or more) by 1 April 2030. The scheme envisages a phased conversion to electric vehicle (EV) fleets in the three-wheeler and fourwheeler segment and the twowheeler delivery service segment within the next five years. The file has been sent to the Lieutenant Governor for

approval. The scheme applies to aggregators, delivery service providers, or e-commerce entities operating within the National Capital Territory of Delhi. It will cover those with 25 or more motor vehicles (two Wheeler, three wheeler, and four wheelers excluding buses) in their fleet, who use a digital intermediary such as an app or web portal to connect



with consumers for their ser-

Terming it a significant milestone in Delhi's fight against pollution, Chief Minister Arvind Kejriwal said, " With this, Delhi has become the first state/UT in India, and among very few cities globally, to mandate a time-bound transition of commercial vehicle fleets of aggregators, delivery service providers and e-

employee held for triple murder case against PWD engineers

A 60-year-old ex-Navy employee who faked his death for 20 years was arrested by the Delhi Police Crime Branch for allegedly killing a relative and burning to death two labourers. He was nabbed from a house in Najafgarh. According to police, Balesh

Kumar was arrested from a house in Najafgarh where he was staying with his family having changed his name to Aman Singh. Balesh was 40 when he

allegedly killed his brother-inlaw, Rajesh alias Khushiram, over money in Delhi's Bawana area in 2004. He also allegedly had an illicit relationship with Rajesh's wife.

Police in 2004 arrested Balesh's brother Sundar Lal, who was also involved in Rajesh's murder, however, Balesh managed to give them a slip. According to Special Commissioner of



Yadav, Balesh, who was in a transport business then, escaped in a truck to Rajasthan.

There he set his truck on fire and burned two of his workers to death.

'Rajasthan Police during the course of investigation identified one of the persons as Balesh, while the other body remained unclaimed. The family members of Balesh also identified one of the bodies as his," Yadav said. Rajasthan Police closed the case assuming the prime suspect dead. After faking his death, Balesh fled to Punjab and managed to procure forged identity proof with the help of his family members and changed his name to Aman Singh.

"He remained in touch with his wife and managed to transfer his insurance claim benefits and pension from the Indian Navy to her. Also, the truck involved in the incident his brother Mahinder Singh, who allowed him to claim the insurance. He got insurance claim for the truck into the account of his wife," Deputy Commissioner of Police (Crime) Ankit Kumar said. Balesh then moved to Delhi's Najafgarh with his family and started living with them.

"On a secret tip-off, we managed to nab him from his house on Monday. During the interrogation, he confessed his involvement in the murder of his relative and two labourers from Bihar," Kumar said. The Delhi Police has informed its counterpart in Rajasthan's Jodhpur about Balesh's arrest and asked them to reopen the burnt truck case.

The Delhi Police claimed that Balesh had also stolen antique items in 2000 from Delĥi's Kota House and was booked for theft at Tilak Marg Police

The Delhi State Industrial Infrastructure Development Corporation Ltd (DSIIDC) has conducted a financial feasibility study for the long-standing proposal of the redevelopment of the Indraprastha bus depot, suggesting that the DSIIDC should keep a 50 per cent share of the built-up area, as opposed to the existing proposal of 40 per

It further said the redevelopment will be carried out at an estimated cost of ₹206 crore and a 13-storey building with a double basement for parking and other services will be constructed as part of the project. The DTC headquarters, whose building will also be rebuilt, is located adjacent to the bus depot.

Constructed in 1958, the headquarters and bus depot has needed repair for a long time. The bus depot has a capacity of housing 180 buses. The depot gets submerged every monsoon, officials said.

"The study suggested that the project will prove to be beneficial for the body only if they keep 50 per cent of the built-up area while the remaining is kept

Atishi finds drainage system on Bawana, Narela road inadequate during inspection

Delhi's Public Works Department (PWD) Minister Atishi on Tuesday inspected the Bawana-Narela and Bakhtawarpur-Palla roads. During the inspection, Atishi found that the existing drainage system on the Bawana-Narela road was inadequate, leading to waterlogging on the road at several locations, and causing damage to the road.

Additionally, encroachments on both sides of the road resulted in traffic issues. The minister reprimanded the officials responsible for the poor drainage system and immediately directed the desilting of the nearby drains and fixing of the outfall. She also instructed repairs to the road and drainage covers.

In the second part of the inspection on Bakhtawarpur-Palla road's initial sections, the PWD minister discovered that one side of the road had a drainage system, while the other side did not. In response, she instructed officials to explore the possibilities of creating new drains through a survey in this area. In Bakhtawarpur, due to the inadequate outfall of the exist-



ing drain in the front part of the road, the drain appeared to overflow.

The Minister directed officials to quickly conduct surveys of the roads and prepare redesign plans, with a primary focus on improving drainage in the redesign plan. Additionally, she instructed the development of green belts over the drain covers at several locations. A new drain is being prepared on the other side of the road.

Atishi reprimanded officials for the delay and instructed them to expedite the remainShe said that along with fixing the drainage system, the road's carriageway should also be improved.

The footpath should be repaired for the convenience of pedestrians, and special attention should be given to landscaping to enhance the road's beauty.

Ban firecrackers, allow only CNG, e-vehicles in NCR: Rai to Centre

STAFF REPORTER NEW DELHI

Delhi Environment Minister Gopal Rai on Tuesday demanded that the Centre impose a complete ban on firecrackers and allow movement of only CNG and electric vehicles in the entire National Capital Region in a bid to curb air pollution.

In a letter Rai requested the Union Environment Minister Bhupender Yadav to convene a joint meeting with the Environment Ministers of NCR States at the earliest so that an action plan can be prepared on the above point and the level of pollution can be reduced. Rai said the Delhi government

has taken numerous steps to curb air pollution during the winter season. "But these steps will not be effective until Harvana, Rajasthan and Uttar Pradesh deal with the sources of pollution in the NCR

Stating on the matter the environment minister mentions that due to these steps, a 30 percent reduction in pollution levels has been observed. The number of Good and Satisfactory days have risen to 200, which was only 109 in



A report by independent environment think tank Centre for Science and Environment shows that 31 per cent of Delhi's pollution comes from sources within the national capital while 69 per cent is from sources in NCR States, he said. Rai demanded that the Centre convene an emergency meeting to discuss solutions to factors contributing to air pollution in the national capital.

The states in the National Capital Region (NCR) should impose a complete ban on firecrackers and stubble burning in the entire region and allow only CNG and electric vehicles, the Delhi minister said.

"Many industrial units in NCR states are still running on polluting fuels. They should be immediately converted to piped natural gas. The heavily polluting brick kilns running in NCR states should be asked to adopt zig-zag technology to check pollution," he said.

Court raps police for filing chargesheet in riots case 'half heartedly'

Delhi court has come Adown heavily on the city police for conducting "further investigation" in a 2020 communal riots case after filing charge sheet in a "half-hearted manner" and asked the officer concerned to appear before it with a written expla-

Additional Sessions Judge Pulastya Pramachala was hearing the arguments on charges against three accused in the northeast Delhi riots case, where the FIR was registered by the Gokalpuri police station.

Noting that initially 25 complaints were clubbed in the case and the court in April last year had directed that only 17 complaints would be "entertained" in the present case, the court said the Investigating Officer (IO) had filed a new supplementary charge sheet on May 17, 2023, for prosecuting 22 complaints.

The IO's stand was based on the recording of fresh statements of some of the complainants to show that they had initially mentioned the

wrong date and time of the alleged rioting incidents at their premises, the court noted in an order passed on Monday. It said, "This is a very dis-

turbing trend of investigation, where after the filing of a charge sheet, IO records statement at any subsequent point of time as per his wish, even without seeking any permission from the court and in defiance of laws under Section 173(8) of Code of Criminal Procedure (CrPC)

Section 173(8) of the Code of Criminal Procedure deals with

It said even according to the new statements, the complainants did not claim to be eyewitnesses and while modifving the date and time of the alleged incidents, they referred to "some neighbours". Plans afoot to send Indian on Moon by 2040

PNS NEW DELHI

With the Chandrayaan-3 successfully landing spacecraft on the south pole of the moon and setting new bar for the Indian space enter-prises, Prime Minister Narendra Modi on Tuesday asked Indian Space Organisation (ISRO) to set up an Indian Space Station by 2035 and send the first Indian to the moon by 2040.

India's first human space flight-Gaganyaan- is now expected to take off in 2025, a PMO statement said after the Prime Minister held a meeting with the ISRO Chairman S Somanath here. The Gaganyaan mission entails sending two astronauts to low earth orbit.

Modi's directions for future missions came during a briefing by the ISRO Chairman on the progress of the 'Gaganyaan mission', which is to have its first demonstration flight of the crew escape system on October 21, and other initiatives.

During the meeting, the Prime Minister outlined the future of India's space exploration endeavours and urged scientists to work towards interplanetary missions, including a Venus



Orbiter Mission and a Mars Lander and also explore the moon in greater detail.

"Building on the success of Indian space initiatives, including the recent Chandrayaan-3 and Aditya L1 missions, the Prime Minister directed that India should now aim for new and ambitious goals, including setting up the 'Bharatiya Antariksha Station' (Indian space station) by 2035 and sending first Indian to the Moon by 2040," the statement

To realise this vision, the Department of Space will develop a roadmap for Moon exploration, it said.

ISRO's moon exploration plans will comprise a series of Chandrayaan missions, developing a new rocket - the Next Generation Launch Vehicle (NGLV), building a new launchpad and setting up human-centric Laboratories and associated technologies.

The Department of Space presented a comprehensive overview of the Gaganyaan Mission, including various technologies developed so far such as human-rated launch vehicles and system qualification.

Army to buy military systems to boost capabilities along LAC

In an effort to further enhance its operational capabilities in border areas, including Ladakh, where tension persists at the Line of Actual Control (LAC), the Army has rolled out a process to procure six fast patrol boats, eight landing craft assault (LCA) and 118 integrated surveillance and targeting systems.
The fast patrol boats are being

procured primarily for surveillance in large water bodies, including the Pangong lake in eastern Ladakh.

The Indian and Chinese troops are locked in an over three-year confrontation in certain friction points along the LAC in eastern Ladakh even as the two sides completed disengagement from several areas following extensive diplomatic and military

The Army has already issued the request for information (RFI) or initial tenders for procurement of the fast patrol boats, LCAs and integrated surveillance and targeting systems, sources said here on

areas.

Tuesday. The RFI for fast patrol boats said the vessels should be "rugged and versatile so as to facilitate seamless execution of small team insertion, surveillance, reconnaissance and patrolling" and that they should be capable of operating across a varying matrix of terrain and conditions.

It said the indigenouslydeveloped boats should have a maximum speed of 29 knots (at sea state level 2) with eight people on board.

The initial tender for LCAs said they are planned to be deployed for search and rescue operations in Creek area and river basins. It said the length of the LCAs should be between 13-14 metres and maximum speed not less than 20 knots. The LCAs are generally used for ferrying troops. The last date to respond to the initial tenders for fast patrol boats as well as the LCAs is November 28. The integrated surveillance and targeting systems are being procured for use by mechanised forces in border

According to the RFI, the systems are being procured under the 'buy Indian' category and they must have 60 per cent indigenous content.

ing of highway status and other important information that will help both the agencies and the highway users. The statement said the policy also provisions implementation of Digital Highways by developing integrated utility corridors along the national highways to develop optic fibre cables (OFC) infrastructure. While the ATMS equipment

will use OFC to communicate with the command and control centre, there are provisions in the policy for 5G-based communication in the future as the coverage increases, it said. Meanwhile Union Road Transport Highways Minister

Addressing the 'CRISIL India Infrastructure Conclave 2023', Gadkari said big players in the steel and cement industry are indulging in cartelisation to jack-up prices. The minister recalled that once upon a time, there were 50 big contractors who used to get contracts for road construction. "I felt that was not correct. (So) I liberalised the technical and financial norms, by which, today we have 600 big (road) contractors," he said.

According to Gadkari, the problem is that some of them quote prices below 30-40 per cent for highway construction projects. "We need to maintain the equilibrium between the quality and the cost. And that is also a big challenge," he

From Jessica to Arushi to now at least 19 underprivileged kids in the Nithari are of the NCR, there have been murders most foul discovered, but our learned courts at last tell us that the investigation does not prove that the suspects/accused did it. So they are let off with a rap on the knuckles. The investigators ---- transferred, promoted, retired or dead ---- face no accountability either. That seems to be the bane that has come to revisit us in the form of Allahabad HC's shocking decision on the Nithari murder accused, domestic help Surinder Koli and his master Moninder Singh Pandher. The incident, reported from Noida in 2005-06, took years for the horrifying details to come out. The Nithari murders were especially gruesome as they involved killing innocent children in cold blood; several dead bodies were recovered from a nearby drain. Many bodies had internal organs removed, hinting also at an



organised organ racket. But a botched-up investigation along with loopholes in the judicial system made sure that the perpetrators could go scot-free. Though Koli and Pandher were found guilty in 2009, the High Court has recently overturned the guilty verdict ostensibly because of lack of evidence and the testimony of alleged witnesses.

In the annals of Indian criminal history, the Nithari serial killings stand as a chilling testament to the depths of human depravity. The case shocked the nation as young women and children fell victim to unimaginable brutality. The Nithari killings were a series of abductions, sexual assaults and murders. The victims dis-

appeared without a trace, leaving their families in anguish and despair. As investigations progressed, the police unearthed gruesome evidence at the residence of Pandher and Koli. The house was a charnel house, revealing the ghastly remains of several missing persons. The CBI recovered many bodies and body parts from the nearby drain and it was thought that the case was foolproof against the prime suspects. But turns out that the scales of the blindfolded lady do not tilt equally for the influential and the underprivileged. Most victims were migrants from UP and Bihar, living on day's earnings and thus hardly had any say in the system or resources to pursue the case. The Nithari case is emblematic of the slow, convoluted and frustrating Indian justice system. The Nithari case is not just a local tragedy but a national shame. It epitomises the systemic issues that afflict India's criminal justice system, including lack of accountability, shortage of forensic resources and the inordinate delay in adjudication. It calls for immediate and comprehensive reforms within the Indian criminal justice system. Only then we can hope to prevent the travesty of justice from being repeated. This decision to acquit the prime suspects should stir society's collective conscience. If it does not, we are all as good

Hamas's resolve may survive IDF onslaught

n this page last week, a colleague expressed misgivings about the Israeli Defence Forces (IDF) resilience and wondered if the steel was blunted. No one has ever doubted the will, fighting prowess and potential of Israelis given their history of conflict, survival and incredible prosperity. Israel has almost similar experience in its conflicted history as our own: war on creation in 1948, a second bigger round in 1956 and full-fledged regional wars in 1967 and 1973.

IDF, like now, was caught with its pants down when Egyptians executed a cross-Suez offensive that hesitated allowing the counter-Canal riposte led by Ariel Sharon's Centurion Tank division and Squadron and Troop leaders like Chaim Erez and Benny Taran. In the 1973 war on the Syrian front, the hero was Avigdor Kahalani who later became Mayor of Tel Aviv and Minister of National Security. His book Heights of Courage is a prescribed reading for the Israeli military. He was worshipped by Armoured Corps officers who used to take a second oath near Mount Hermon on Golan Heights where a UN Indian Mechanised force is currently located.

And who will not remember Moshe Dayan, the toast of the 1948 Arab-Israeli war and Commander of Jerusalem Front? He became a legend: his eyepatch was replaced with the Jaffa orange in an ad proclaiming The Best. I was privileged to know Kahalani, Erez and Taran, all Armoured Corps, the sword in desert terrain. With the last two, we spent year-long training and friendship at Fort Leavenworth, US and Belgravia, UK. I visited Israel before India formally recognized it in January 1992. That travel is etched as the journey that commenced in Cairo where the Yom Kippur War was conceived. The taxi was driven by a retired Artillery Lieutenant Colonel from the Egyptian Army. We crossed the Suez and drove through Sinai still littered with debris from the 1967 and 1973 wars. The drive was punctuated with a vanquished Veteran's narration of victory turned into defeat. infiltrated by Islamic State last year, has opened a third front for the IDF where more than 300 Palestinians and 50 Israelis have been killed this year. But Hezbollah appears to be only shadowboxing. Iran is external enemy no 1. Both Iran and Israel have vowed to destroy each other and do not recognize the other's right to exist. Iran backs Syria, Lebanon and Gaza. Hamas has a stockpile of 130,000 rockets and missiles. It was only in 2012 that their accuracy improved and Israel devised the Iron Dome whose launch I witnessed. It is an expensive antidote to missiles but can distinguish which missile will hit populated areas. Its discrimination capacity makes it valuable.

against Hamas will be the fifth large-scale operation with the first launched in 2008 after Hamas took control of Gaza. Similarly, Israel has invaded Lebanon thrice - in 1978, 1982 and 2006.IDF has failed to deter Hamas and diminish Hezbollah. Its punitive strikes only degrade capability till their next rocket attack. This time IDF is tasked to permanently destroy Hamas and rescue the 199 hostages hidden in an under ground web of tunnels. This cordon and search operation can take months and become an abattoir. operation is not the reoccupation of Gaza. Israel is known to have exchanged 1,200 Palestinian prisoners for one soldier. Iran says Hamas will release hostages if air attacks cease. Ultimately the safety of hostages will constrain operations with IDF fighting on enemy terrain.

Hamas's daring incursion into Israel is a brilliant strategy but the barbarity and brutality of tactics shaming Chengis Khan. Hamas achieved total surprise and horrendous gains. This time they did 9/11 and Pearl Harbour combined, inflicting on Israel their highest losses since the Yom Kippur war.

It has already become the world's largest man-made humanitarian catastrophe that you and I watch on TV. But no one can stop the mauled Israelis from retaliation and the IDF from wreaking retribution by reducing Gaza to the stone age. Fingers crossed the Gaza Front does not spark Lebanon and the West Bank. IDF may destroy Hamas's capability to fight; but not its will to fight anoth-

State doles can put discoms at risk

Discoms will be profitable only when they are unshackled from state controls and electricity distribution is deregulated



ven as the Central government is making all-out efforts to remove the financial distress of power distribution companies or discoms (situated at the core of the power supply chain, they procure electricity from power generating companies or gencos and distribute it to the consumers) and restore them to robust health, actions of the state governments undermine these efforts. The financial distress of discoms arises fun-

damentally due to their inability to generate enough revenue to pay for the electricity they buy. For over two decades, they have been incurring losses year after year. They have funded these losses by borrowings from banks and other FIs apart from keeping bills pending. At the end of FY 2021-22, their total debt was Rs 620,000 crore. Discoms' inability to generate required revenue has to do primarily with two factors viz. aggregate technical and commercial (AT&C) losses - a jargon for power theft and shortfall in the average revenue realisation from the sale of electricity vis-a-vis the average cost of supply (cost of purchase, neeling and distribution), or the ACS ARR gap. During 2020-21, AT&C losses were 22.32 percent while the ACS-ARR gap was Rs 0.54 per kWh.

Both maladies arise due to constant meddling in the running of discoms by their owners namely the state governments. Power theft on such a massive scale is unthinkable without the complicity of the political establishment. People living in slum settlements/jhuggi clusters being a big vote bank, the party in power encourages unauthorized connections to enable their access to free power.

As for the second malady, the political brass orders discoms to sell a major slice of electricity to households (HHs) and farmers, either at a fraction of the cost of supply or even free (the state electricity regulatory commissions or SERCs which are mandated to fix tariff merely act as rubber stamps). Even as the state government promises to reimburse the differential amount to discoms, most states don't reimburse or do it partially and after con-

Given nearly a quarter of the revenue lost due to power theft and a substantial amount in subsidies remaining unpaid, the financial stress of discoms is inevitable. The politics of freebies now deeply entrenched in the system has exacerbated the already grim situation. Let us look at the developments in Punjab. Last year, amongst a host of freebies promised by AAP the most prominent was free electricity to households (HHs) for consumption up to 300 units per month.

Going by sheer common sense, the State should give help only to those HHs who can't afford to pay costbased tariffs. The way to go is to identify households whose income is below a threshold. AAP hasn't gone by this. Could it be presumed that only low-income HHs have consumption of fewer than 300 units? So, in essence, the assistance reaches only to those who can't afford it. A closer scrutiny would reveal that the approach adopted by the AAP government is mischievous. Its real intent was to give the dole to 'all and sundry'.

If a household consumes less than 300 units a month, it doesn't necessarily follow that it is a family with low income. For instance, there would be umpteen number of welloff/high-income old-age couples living alone who consume less than 300 units a month. Even for others, who consume more than this threshold, we see a dastardly trend of consumers applying for multiple connections within the same HH. For instance, a household consuming 900 units a month, gets three meters installed to keep consumption of each under 300 units thereby ensuring zero bill.

Reportedly, more than 100,000 meters have been bifurcated or trifurcated enabling even high-end consumers to avail of the free bonanza. As a consequence, cur-

rently almost over 95 per cent of power consumers in Punjab avail of subsidies. The swelling number of connections has increased the subsidy by Rs 125 crore per month on average. As a result, the total domestic subsidy for the current FY is now expected to be Rs 8,813 crore - Rs 1,500 crore higher than the initial estimate of Rs 7,313 crore.

In Delhi, where there is no charge for HHs consuming up to 200 units (HHs consuming between 200 and 400 units get a deduction of Rs 800 from their bill), the possibility of the majority of households availing of access to electricity - free of any charge - is not ruled out. The situation in other states won't be different. Given almost the entire population of the State - including the rich, millionaires, billionaires and so on, getting to enjoy the free bonanza, the burden of power subsidy is bound to gallop. Faced with budget constraints, the states will take increasing recourse to underpay ment and delayed reimbursement of subsidy dues to discoms.

Meanwhile, the Centre is dealing with discoms under a two-pronged strategy (i) forcing them to make timely payments and (ii) helping them cut AT&C losses and reduce the ACS-ARR gap. Under (i), it implemented late payment surcharge (LPS) and related matters Rules, in 2022. The LPS rules made it mandatory for discoms to clear their legacy dues as existing on June 3, 2022, in a time-bound manner in 12 equal monthly instalments (EMI) with the benefit of nonapplicability of the LPS after its implementation date. The same rules are also provided for timebound clearance of current dues failing, which will attract a power supply cut.

The pressure tactics have worked. The legacy dues of all stakeholders in the electricity supply chain viz.

power generating companies (gencos) and transmission companies (transcos) from discoms decreased from Rs 1,39,747 crore in June 2022 to Rs 69,957 crore in July 2023. Faced with the threat of LPS, the latter could have used loans taken from PFC and REC (out of Rs 130,000 crore sanctioned under 'Atmanirbhar Bharat Abhiyan') to

make payments to the former. As for (ii), under the 'Reforms-Linked, Result-Based Scheme for Distribution' (RLRBSD) launched in July 2021, the Centre has undertaken a massive investment of Rs 300,000 crore to improve the reliability and quality of the power sup-ply and enhance the efficiency of discoms. It has compulsory pre-paid and smart metering components to be implemented across the power supply chain, including in about 250 million households. The Scheme has yielded results.

The AT&C losses of discoms have one down from 22.32 per cent dur ing 2020-21 to 13.5 per cent during 2022-23. The ACS-ARR gap has also reduced from Rs 0.54 per kWh during 2020-21 to Rs 0.15 per kWh in 2022-23. A 9 per cent cut in AT&C losses is a stupendous achievement. It seems that pre-paid and smart meters have been installed, and power theft is almost eliminated. The Centre is keen that the ACS-ARR gap should be reduced to 'zero' by March 2025. This will require making power theft 'nil' and timely recovery of all subsidy dues from the States. But, this won't be possible if states continue with business as usual; it could even lead to erosion of the gains made in 2022-23. Modi's efforts would deliver only when (a) discoms are unshackled from state controls; (b) States give subsidies directly to the beneficiaries and (c) electricity distribution is deregulat-

The Israel-Hamas war: Where does India stand?

India's diplomatic stance, which supports a two-state solution, may necessitate a revision in light of the evolving dynamics of the conflict

hen the global economy is reeling under the crisis, the current geopolitical crisis in the Middle East has doubly heightened the level of inflation. This crisis emerged following the unexpected offensive launched by the Hamas against Israel, which subsequently led to Israel declaring war. Since Israel is a significant trading partner for India, the effects could be escalating.

With sheer surprise, the weekend's unexpected strike by Hamas on Israel has triggered a huge armed war in the Middle East. More than 2300 people have been killed in the fighting so far, and hundreds more have been held prisoners. Israeli Prime Minister has warned of a harsh response, so the situation is unlikely to

improve very soon. In this context, India, one of Israel's oldest and greatest allies, has expressed its support for the Jewish state and has pledged to assist in the time of crisis. India's Prime Minister has timely expressed shock and condemnation of the terror incident. Inflation throughout the world is possible if the terror attack and retaliation between Israel and Palestine escalate into a full-scale war. Belgian cops shoot suspect accused of killing two Swedes

Hours after the suspect disappeared into the night and a manhunt was launched in the Belgian capital, Interior Minister Annelies Verlinden posted on X, formerly Twitter, that "the perpetrator of the terrorist attack in Brussels has been identified and has died."

She thanked Belgium's intelligence and security services, as well as prosecutors, "for their swift and decisive action."

The man was shot in the Schaerbeek neighbourhood near where the rampage took place. The weapon used in the assault was recovered.

Amateur videos posted on social media of Monday's attack showed a man wearing an orange fluorescent vest pull up on a scooter, take out a large weapon and open fire on people getting out of a taxi.

He chased them into a building to gun them down. He was also filmed calmly loading his weapon as cars drove slow

ly by.

Questions remain unanswered over how a man who was on police files, thought to be radicalised and being sought for deportation was able to obtain a military weapon and launch such an attack.

"Last night, three people left for what was supposed to be a wonderful soccer party. Two of them lost their lives in a brutal terrorist attack," Prime Minister Alexander De Croo said at a news conference just before "Their lives were cut short in full flight, cut down by extreme brutality.

"The attack that was launched yesterday was committed with total cowardice," he said. Security was beefed up in

Brussels, particularly around places linked to the Swedish community, and at Belgium's southern border with France.

Not far from the scene of the shooting, the Belgium-Sweden soccer match in the national stadium was suspended at halftime and over 35,000 fans were kept inside as a pre-caution while the attacker was

Caroline Lochs, a fan from Antwerp, said the alarm left her "frustrated, confused, scared. I think everyone was quite scared.

At a news conference in Stockholm, Swedish Prime Minister Ulf Kristersson said that "everything indicates this is a terrorist attack against Sweden and Swedish citizens, just because they are Swedish."

He said the suspect had occasionally stayed in Sweden but was not on police files

"It's not an unusual pattern to move around," Kristersson added. "We have an openness in Europe, which is one of the important reasons why we need to keep an eye on the EU's external border because otherwise people can easily move between European countries."

Kristersson has been invited to Brussels to mourn the victims and pay tribute to the work of police at a commemoration ceremony on Wednesday, De Croo announced on X, saying: "We wish the people of Sweden strength and courage to get through these difficult times."

Sweden's foreign ministry said the two fatalities were men aged in their sixties and seventies. A third man, also in his seventies, was wounded and remains in hospital.

De Croo said the assailant was a Tunisian man living illegally in Belgium who used a military weapon in the attack. Federal prosecutors said later that the suspect was found after a witness spotted him in a

EU leaders seek harmony at virtual summit

The European Union leaders are trying to overcome the cacophony of different opinions and voices over the Israel-Hamas war into one single political hymn in an attempt to have a bigger diplomatic impact on the global stage.

Even if their summit on Tuesday is by virtual video con-

ferencing only, the attack in Brussels that left two Swedes dead last night further underscored the need to show a unified stance in the face of common threats.

Ever since the attack of Hamas on Israel on October 7, the EU has shown it is a group of 27 different nations and even their common institutions have sent out different messages, sowing confusion about the bloc's intentions and reaping international criticism.

Many member states feel that EU Commission President Ursula von der Leyen overstepped her authority by visiting Israel on Friday without a pre-agreed political message and then toed what many saw as an excessively pro-Israeli

"Foreign and security policy remains a responsibility of the member states," EU foreign policy chief Josep Borrell said Tuesday ahead of the the virtual summit. Von der Leyen's executive Commission maintains she is free to travel as she wants and express solidarity with a nation in need as she pleases, and will do so again if need be. Still, the unease was compounded because, for some, an EU insistence that Israel respect international law in its fight against Hamas was not expressed explicitly enough by von der Leyen.

"The position is clear: Israel has the right to defense, but this defense has to be developed in compliance with international laws and in particular humanitarian laws because war also has its laws,"

He insisted that it would be the main common message coming out of the summit.

On Tuesday, German Chancellor Olaf Scholz travelled to Israel for an impromptu visit. French President Emmanuel Macron said that he will travel to the region "as soon as I consider that we have a useful agenda and very concrete actions to drive forward."

Few other international crises divide the bloc like the Israel-Palestinian conflict.

Just last week in the wake of the Hamas attack, a commissioner at the bloc's executive branch announced that development aid meant to help the Palestinian Authority reduce poverty would be immediatey suspended. Hours later, the European Commission's position changed. It announced an urgent review of the assistance to ensure that no money is being misused. Since it is listed by the EU as a terror group, Hamas does not receive any such funds anyway.

Then on Saturday, the commission said it was tripling humanitarian aid to Gaza money meant to be used in times of crises or disasters.

Macron, a key player in Tuesday's summit, said that beyond supporting Israel's right to defend itself, he also has been able "to pass on warning messages calling for respect for humanitarian law, international law and civilian populations in Gaza and the West Bank, and for non-escalation of the conflict in Lebanon." "We remain extremely vig-

ilant and committed," he added. EU Council President Charles Michel said in announcing the summit that "the conflict could have major security consequences for our societies." He said that the leaders would look at ways to help civilians in Israel and Gaza caught up in the war and to work with other countries in the Middle East and Persian Gulf regions to try to prevent the conflict from spreading.

Three opposition parties that vowed to restore democratic standards in Poland together won over 54 per cent of the votes in the nation's weekend parliamentary election, putting them in a position to take power, according to a complete ballot count reported Tuesday. Poland's constitution now requires President Andrzej Duda to assess the new political alignment of forces and to appoint a new prime minister who is tasked with forming a government that will need parliament's approval, all within a set timeframe.

In a video statement, Tusk appealed to Duda, saying, "I would like to ask for energetic and quick decisions" and stress-



ing that "the winning democratic parties are ready to take over responsibility for governing the country any moment."

'People are waiting for the first decisions that will be the result of the elections" that took place Sunday, Tusk said.

Duda is an ally of the conservative Law and Justice party, which has been in power since

2015. His term runs until 2025. Law and Justice, which governed the country for eight

turbulent years, won slightly over 35 per cent of the votes, making it the single party with the most votes. But the party and its leader Jaroslaw Kaczynski lost their majority in parliament and appeared to have no way to hold onto

Turnout was nearly 75 per cent, the highest since Poland's return to democracy, surpassing even the level of 63 per cent in 1989, a vote that triggered

Tusk's success is all the more remarkable given that state media went into overdrive to portray him as a stooge of Germany and Russia. That portrayal, which appeared baseless, also won him much sympathy.

Greta Thunberg among detained climate activists

London (AP): Greta Thunberg was detained by British police on Tuesday alongside other climate activists who gathered outside a central London hotel to disrupt a meeting of oil and gas compaamong dozens of protesters who chanted "oily money out" and attempted to block access to the InterContinental Hotel on Park Lane, which is hosting the Energy Intelligence Forum.

The conference is hosting speakers, including the chief executives of Saudi Arabia's Aramco and Norway's Equinor, as well as the UK's energy security minister.

An Associated Press photographer saw Thunberg being led away by officers and taken into a police vehicle, along with about 10 other activists.

Earlier Tuesday, London's Metropolitan Police said five people were arrested on suspicion of obstructing a highway during the protest.

Protesters attempted to block access to the conference venue by sitting on the sidewalk by the entrance. They held aloft banners and chanted "oily money out" and "cancel the conference," while some lit yellow and pink smoke flares.

Greenpeace activists abseiled down from the roof of the hotel to unfurl a banner reading "make

is fueled by brokers who solicit fake customer reviews through social media platforms, encrypted messaging apps and other channels in exchange for money, free items or other benefits. Brokers can solicit positive reviews to boost sales for businesses or sellers. They can also also post negative reviews for competitors in order to tank their sales.

The two countries have forged an informal alliance against the United States and other democratic nations that is now complicated by the Israel-Hamas war. China has sought to balance its ties with Israel against its relations with Iran and Syria, two countries that are strongly backed by Russia and with which China has forged ties for economic reasons as well as to challenge Washington's influence in the Middle East.

Putin's plane was met by an honour guard as the Russian leader began his visit that is also a show of support for Chinese leader Xi Jinping's signature 'Belt and Road' initiative to build infrastructure and expand China's overseas praised the massive but loosey linked BRI projects.

"Yes, we see that some people consider it an attempt by the People's Republic of China to put someone under its thumb, but we see otherwise, we just see desire for cooperation," he told state broadcaster CCTV, according to a transcript released by the Kremlin on Monday. Putin begins China visit 'Russia sending more forces to eastern Ukraine city after assault slows'

 $R^{ussia\ is\ throwing\ more}_{units\ into\ its\ effort\ to\ take}$ a key eastern Ukraine city, Western analysts say, after apparent setbacks that have slowed its dayslong onslaught.

The attempt to storm Avdiivka, a heavily defended city that stands in the way of Moscow's ambition of securing control of the entire Donetsk region, is Moscow's most significant offensive operation in Ukraine since the start of the year, the UK defence ministry said Tuesday.

The Kremlin's push to claim Avdiivka comes after months of fending off Ukraine's counteroffensive, which Kyiv launched some 16 months after Russia's full-scale invasion. Both sides are looking for battlefield advantages ahead of winter. They are also looking to secure future weapons supplies for what is shaping up as a protracted war of attrition.

Kyiv officials said Russia mounted up to 60 attacks per day in the middle of last week

The Ukrainian defence ministry said Tuesday that Russia is nevertheless still attempting to encircle the city, with 10 attacks over the previous 24 hours. The UK defence ministry said Russia's effort to overrun Avdiivka "looks increasingly unlikely in the short term".

More widely, Russian forces launched six Shahed drones and one Kh-59 cruise missile over southern regions of Ukraine late Monday, Kyiv authorities said.

The Ukraine Air Force of Ukraine claimed to have intercepted all the targets, with no casualties or destruction reported. Ukraine struck two helicopter airfields near the Russia-controlled Luhansk and Berdyansk regions, the Air Force claimed. It was not immediately possible to verify the two sides' battlefield claims.

Ukraine uses **ATACMS** missiles against Russian forces for the first time

Washington (AP): A US official says the longer-range ballistic missiles long sought by Ukraine have been delivered quietly by the US and are being used on the battlefield against Russia nearly a month after President Los Bilden promised them to his Joe Biden promised them to his Ukrainian counterpart.

The official was not authorised to publicly discuss the matter before an official announcement and spoke Tuesday on the condition of anonymity. Ukraine's President Volodymyr Zelenskyy and other Ukrainian leaders have been urgently pressing the US to provide the Army Tactical Missile System, known as ATACMS. Their delivery to the war front was shrouded in secrecy, with the expectation that the first public acknowledgement would come when the missiles were used on the

Pakistan court adjourns Imran khan, Qureshi's indictment till October 23

The case pertains to a secret diplomatic document that Pakistan Tehreek-e-Insaf (PTI) chairman Khan used to criticise his opponents for allegedly orchestrating his ouster from power in April last

The document reportedly went missing from his possession. Khan's party alleges that the document contained a threat from the US to oust Khan from office.

Pak Army backs govt's decision to deport illegal foreigners

Islamabad (PTI): Pakistan's powerful army on Tuesday extended its full support to the government's decision to repatriate and deport all illegal foreigners, including Afghan refugees, from November 1 onwards. The caretaker government has set October 31 as the deadline for thousands of undocumented immigrants, including around 1.7 million Afghan refugees, to leave the country or risk imprisonment, deportation and forcible expulsion from November 1 as it intensified its crackdown against those involved in militancy and smuggling. Pakistan's decision has drawn widespread criticism, with organisations such as the UNHC for Refugees and Amnesty International calling on the government to rethink its plans. The Taliban-led govern-ment in Afghanistan has also expressed its reservations over the move. At the 260th Corps Commanders' Conference held at General Headquarters in Rawalpindi, top brass of the Pakistan Army resolved to fully support the federal governments decision to repatriate and deport all illegal foreigners from

'40 places of worship of Ahmadis destroyed in 2023 in Pakistan'

At least 40 places of worship of the Ahmadi minority community have either been attacked by radical Islamists or partially demolished by police in different parts of Pakistan during the first 10 months of this year, a body representing the persecuted group said on Tuesday. Ahmadis in Pakistan are usually referred to as Qadianis, which is considered a derogatory term for them. Pakistan's Parliament in 1974 declared the Ahmadi community as non-Muslims. A decade later, they were banned from calling themselves Muslims. They are banned from preaching and from travelling to Saudi Arabia for pilgrimage. "At least 40 incidents of desecration of our worship places have taken place this year between January and October in various parts of Pakistan. Of them, 11 occurred

in Sindh and the remaining in Punjab province," Amir Mahmood, an official of the Punjab chapter of Jamaat-e-Ahmadiyya Pakistan, told PTI.

In Sindh some Ahmadi In Sindh, some Ahmadi worship places came under attack by religious extremists who committed the offence with impunity as police remained silent spectators, he



said. While in most cases, radical Islamist party Tehreek-e-Labbaik Pakistan (TLP) attacked the Ahmadi worship places, in some incidents, police demolished minarets, arches and removed sacred writings from the prayer halls under the pressure of religious extremists, Mahmood said.

The TLP argues that Ahmadi worship places are similar to that of Muslim mosques because they have minarets. Mahmood said not a single case against the religious extremists has been registered so far for attacking and damaging the Ahmadi worship places. He also blamed Punjab's caretaker government for its complete failure to stop desecration of Ahmadi worship places in the province.

During its tenure, around 30 such incidents took place in the province, he said.

The Jamaat-e-Ahmadiyya

Pakistan said the situation is becoming worse day-by-day for the already marginalised

community.

"Ahmadis are facing persecution at the hands of the evil elements. The acts of desecration of the places of worship in various areas of Pakistan continues unabated. It is a new norm and the authorities are

doing nothing," it said. Earlier, the Human Rights Commission of Pakistan (HRCP) said the destruction of part of Ahmadiyya sites of worship is a brazen violation of the recent Lahore High Court judgment regarding the protection of Ahmadiyya sites of

"It demonstrates yet again that the community is being hemmed in systematically and deliberately by law enforcement and the religious far right alike. According to the 2014 Supreme Court judgment, the police are supposed to protect the community's right to practice its faith. The government must hold the perpetrators accountable, repair the damage and ensure that this does not recur again," the HRCP had said.

Child killed, 9 injured in hand grenade explosion Karachi (PTI): A child was

killed and eight others injured on Tuesday when a hand grenade exploded in Pakistan's restive Balochistan province.

According to police, a group of children belonging to a religious seminary were playing with the hand grenade when it exploded in the Zarchain area of Wadh city. The injured were immedi-

ately transported to a local hospital. Police and lawenforcement agencies cordoned off the area and launched detailed investigation. "This is not the first time

such an incident has taken place. Militants and separatists leave behind or drop such dangerous explosives and when children find them they end up being killed or injured," Wadh DSP Abdul Manaf said.

He said hand grenades were left behind by the militants and separatists operating in the province and in some cases even rocket launchers had gone off when found and children tried to play with

Indian former chief priest fails in appeal to cut jail term

former Indian chief priest A tormer inclination enter place at one of Singapore's oldest Hindu temples has failed in his bid for a lighter jail term for pawning the temple's gold jewellery for more than SGD 2.3 Kandasamy Senapathi, 39,

was sentenced to six years in jail by a district judge in May after he pleaded guilty to two charges of criminal breach of trust (CBT) and two charges of removing the benefits of his criminal activities from jurisdiction. Six similar charges were taken into consideration during his sentencing.

The Indian national was employed by the Hindu Endowments Board as a priest at the Sri Mariamman Temple in the central business district here from December 2013 until he resigned on March 30, 2020.

He would pawn a piece of jewellery that adorned statues of deities at the temple for cash and then return on another day to redeem the first piece of jewellery using a second piece of jewellery, according to The Straits Times newspaper.

On Tuesday, his lawyer,



Divanan Narkunan, argued before the High Court that the sentence imposed was manifestly excessive, the report said.

Divanan argued that the district judge had erred by focusing on the misappropriated sum stated in the charges without considering that the money obtained by Senapathi was merely a fraction of the total pawn proceeds.

The lawyer argued that although Senapathi received a total of SGD 2.3 million (USD 1.6 million), he had obtained only SGD 141,054.90 as benefits, as most of the pawn proceeds were used to redeem the jewellery and pay off the interest owed to the pawnshops.

Disagreeing with the lawyer, Justice Vincent Hoong pointed out that when Senapathi pawned the jewellery pieces, he received the proceeds, as reflected in the charges. The amount represented the value of the items misappropriated.

'Ĥow the appellant chose to use the pawn proceeds subsequently is irrelevant to determining the sum misappropri-ated in each of the CBT charges," the report quoted the judge as saying.

Noting that sums owed to

the pawn shops resulted from Senapathi's unlawful acts, the judge said, "This is simply a disingenuous argument."

Between 2016 and 2020, Senapathi pawned 66 distinct pieces of jewellery at various pawn shops on 172 occasions. He was caught when the COVID-19 pandemic struck in 2020, throwing the regular audit timing off and revealing

the missing jewellery. All the pieces of jewellery he pawned have since been returned to the temple. However, the sum of SGD 141,054.90, which was remitted, still needs to be recovered.

Afghan mob attacks Pak Customs, police and paramilitary rangers

Karachi (PTI): A mob of Afghans residing in Pakistan's biggest city attacked a team of Customs accompanied by police and paramilitary rangers after they carried out a raid to seize smuggled goods from a market in a main commercial area of the city.

November 1 onwards, the mili-

tary said in a statement.

A video, which has gone viral, shows dozens of Afghans armed with sticks running after the Customs officials and vehicles of the Police and Rangers on Tariq Road as they tried to carry out a raid during nighttime on Monday.

Tariq Road is one of the busiest commercial centres of Karachi and has numerous fabric and clothing shops in shopping malls and markets which are generally owned by Afghans, who have now settled down in the city after fleeing from their country. A source in the Customs vigi-

lance confirmed the incident and said the team had gone with police and rangers back up after confirmed intelligence reports that smuggled cloth and fabrics worth millions of rupees were being sold by Afghan shop owners on Tariq Road.

Many of the Afghan refugees in Pakistan have established successful businesses in Karachi and other parts of the country and mostly focus on clothes, fabrics, carpets, curtains, and rug businesses. They own or rent shops in nearly all the major commercial centres and malls of Karachi. Baidu unveils Ernie 4.0 Al model, claims that it rivals GPT-4

hinese search engine and artificial Cintelligence firm Baidu on Tuesday unveiled a new version of its artificial intelligence model, Ernie 4.0, claiming that it rivals models such as GPT-4 in the U.S. Baidu's CEO Robin Li demonstrated Ernie 4.0 at the company's annual Baidu World conference in Beijing. He said the model has achieved comprehension, reasoning, memory and generation, which uses algorithms to produce and create new content.

Li said that Ernie 4.0 was able to understand complex questions and instructions and apply reasoning and logic to generate answers to questions. "It is not inferior in any aspect to GPT-4," Li said, stating that the latest model was "significantly improved" compared to its original Ernie

In a live demonstration, Li prompted Ernie 4.0 to generate advertising materials including advertising posters and a marketing video. He also asked Ernie 4.0 to come up with a martial arts novel complete with characters with various personalities. Baidu is a frontrunner among a slew of Chinese companies racing to come up with artificial intelligence models, after OpenAI's ChatGPT took the world by storm last year. Beijing sees artificial intelligence as a key industry to rival the United States and aims to become a global leader Beijing-based Baidu started off as a

search engine firm and over the past decade has invested heavily in artificial intelligence technology such as autonomous driving and more recently, generative AI to stay competitive.

The company's Hong Kong-listed



shares fell 1.7 per cent Tuesday following the announcement. Baidu introduced its Ernie Bot in March. In August, it made the model available to the public. Ernie 4.0 is not yet available to the general public but

some people have been invited to try it. Li said Baidu plans to incorporate artificial intelligence technology into its search engine, maps and cloud drive services, and its business intelligence offerings for enter-prise customers. He did not give a timetable for that.

The technology can transform how certain products work. Baidu's search engine might generate a customized answer to a query instead of just providing a list of results and links.

China has recently sought to regulate the generative AI industry, requiring companies to carry out security reviews and obtain approvals before publicly launching their products. lakh crore on infrastructure between FY24 and FY30: Crisil

m ndia}$ will spend nearly Rs 143 lakh crore on infrastructure between fiscals 2024 and 2030, more than twice the Rs 67 lakh crore spent in the past seven financial years starting 2017, rating agency Crisil said on Tuesday

Of the total, Rs 36.6 lakh crore will be green investments, marking a five times rise compared fiscals 2017-2023, it added.

"India's infrastructure spending will double to Rs 143 lakh crore between fiscals 2024 and 2030, compared with 2017-2023, Crisil said in its Infrastructure Yearbook 2023.

Crisil Ltd managing director and CEO Amish Mehta said the agency expects India's gross domestic product to grow at an average 6.7 per cent through fiscal 2031 to be the fastestexpanding large economy.

"Per capita income is seen rising from USD 2,500 now to USD 4,500 by fiscal 2031, creating a middle-income country," he said, adding that this growth will be underpinned by massive all-round infrastructure development, with sharp focus on integrating sustainability."

While releasing 'CRISIL Infrastructure Yearbook 2023', which includes a unique national index CRISIL InfraInvex, Mehta said policy interventions and a conducive investment climate have aided the uptrend in the CRISIL InfraInvex scores across sectors. "Four of these - roads and highways, power transmission, renewable energy and ports have an overall score of 7-plus (out of 10), which underscores the pace of reforms and developments of the past few years," he added.

The rating agency noted that the next phase of infrastructure development will be marked by growth in the average ticket size of projects and a significant number of mega-scale projects. icy and regulatory interventions and focus on timely execution build an attractive case for various stakeholders to accelerate investments across infrastructure sectors, Crisil

The squad went directly to the airport and flew back to Sweden once they were allowed to leave King Baudouin Stadium, which was locked down for 21/2 hours for security reasons before officials began an evacuation process around midnight local time.

It was around 4 am local time when the last of the Swedish supporters — totaling about 650, according to the Swedish Football Association — left the stadium under police surveillance, along with some staff from the federation.

All hotels where Swedish supporters were staying were also guarded by police, the federation said

The Swedish FA confirmed to The Associated Press that the national-team players were now making their way back to

The suspect in the shooting was shot dead by police on Tuesday, Belgian Interior Minister Annelies Verlinden said, and the weapon believed to have been used by the man has been

recovered. Authorities had been searching for a 45-year-old suspected Tunisian extremist who was known to police and was living in Belgium illegally.

Swedish FA officials said information about the shooting incident, which also led to another Swedish national getting seriously injured and taken to hospital, reached them just before the match began and that Belgian authorities and police considered the game should be played because the stadium was viewed as the safest place for the Swedish

A decision was made to halt the match at halftime. Martin Fredman, the federation's head of security, said about 400 Swedish fans "received help during the evening and night. The cooperation between supporters, federations and authorities has worked very well in an extremely stressful situation, Fredman said

The AITA is contemplating action against Sasi Mukund for not wearing the official jersey during the Davis Cup tie against Morocco and has also introduced a players' code of conduct to ensure 'discipline' in

In the opening singles of the World Group II play-off tie against Yassine Dlimi on September 16, Mukund wore the jersey provided by his permade available by official Indian team sponsor 'OOK' after taking "permission" from skipper Rohit Rajpal.

To make matter worse, the jersey that Mukund wore had 'INDIA' spelt wrongly and the matter was brought to AITA's notice by the team sponsor. The team name printed on the back had an extra 'I'.

It may be mentioned that the official sponsor only provided the kit and no sponsorship money was given to either All Indian Tennis Association (AITA) or the players who were part of the tie that India won 4-1 in Lucknow last month.

AITA issued a showcause notice to Mukund on September 28, asking him to explain within seven days why action should not be taken against him for not wearing the official jersey and playing with a jersey that had India written wrongly.

On October 3, Mukund sent his reply to the national federation, saying that "shorts received from OOK were not comfort-

Mukund also wrote that he had taken prior permission from both captain Rajpal and and coach Zesshan Ali to wear the jersey that had his sponsor's



received eight T-shirts from his sponsor and unfortunately he picked the only one that had printing mistake. He also lamented that neither

the captain nor his teammates

noticed when he stepped on to the court. "I have immense respect for my country and I would never do something intentionally to tarnish its image," he wrote and

also apologised for the inadvertent mistake On October 13, the AITA communicated to Mukund that his explanation was not acceptable since the captain has denied giving him any permission and further asked him to clarify his

When contacted by PTI,

Mukund said captain Rajpal had indeed allowed him.

"There was no money involved. The players were not given any sponsorship fee for this tie. Only the kit was provided by the official sponsor. Captain Rajpal had understood this and allowed me," Mukund, who had lost his match to Dlimi, said.

"Usually the players are asked to sign a contract with the AITA for that one week if they are being paid for wearing that official kit. In this case, we did not sign any contract. My personal sponsor 'Indian Tree' pays me, so what's wrong in it. The pockets of the shorts were such that the ball were coming out. These are the reasons that the players lose interest in playing for the national team," he said. AITA Secretary General Anil

Dhupar said they have introduced a players' code of conduct for clarity and all players will be bound by it.

The players code of conduct is before the Executive Committee members. It will come into effect immediately. It is for all players, be it men's, women's, boys or girls," he said. Asked if they will indeed take

action against Mukund, Dhupar said,"Mukund has apologised but we are still discussing the matter'

Asked for his viewpoint, Davis Cup coach Zeeshan Ali said,"All players should be wearing only the official kit. During the Asian Games all the players and support staff wore the official kit only. Procedure has to be followed by all".

It is not the first time that an Indian player has preferred

playing with the kit that has his personal sponsor's name written. They do get paid for wearing the sponsor's name. If the match is telecast live, the amount increases

"The AITA had also introduced the system of paying the players for official sponsor's name. The initiative was taken by captain Rohit Rajpal. If you have to stop players from wearing the name of their personal sponsor during the Davis Cup, then you have to compensate, said a team source.

"In this case (Morocco tie), no sponsor was willing to pay any sponsorship money to the players and the AITA. Just the kits had arrived through OOK, it is difficult to even arrange for kits for Indian Davis Cup team," the source said, summing up the state of Indian tennis

Kusale now aiming for gold at Asian Championships

 $R^{ifle\; marksman\; Swapnil\; Kusale's}_{dream\;\; of\;\; winning\;\; an\;\; Asian}$ Games medal in Hangzhou might have gone sour, courtesy one poor shot, but that has not stopped him from aspiring for gold at the Asian Championships, scheduled to commence in Changwon, South Korea on October 22.

One of the best 50m rifle 3-positions shooter in the country, the 28vear-old Kolhapur marksman was leading by a huge margin in his event at the Asian Games recently before a rank bad 7.6 on the thirdlast shot in the finals saw him take a mighty tumble from No.1 to 5.

That effectively ended his hopes of winning even a bronze medal in the quadrennial continental showpiece as he finished fourth.

However, as the shooting team leaves for the Asian Championships, Kusale has put the disappointment on the back-burner and wants to concentrate on the next assign-

That shot... How did it go that way, I have absolutely no idea. It's a game basically. I still had two shots remaining and I focused on them. I just forgot that had I shot a poor score," said Kusale, one of the early birds to secure a Paris Olympic

quota place. "Initially, I was a bit shocked how it could happen to me. But without bothering about it much, how and why it happened, I prepared myself for the next two shots," said Kusale, who had bagged the 2024 Olympic quota by finishing fourth at the World Championships in Cairo last

Yes, it did strike me that I had missed the gold medal because of that one shot, but then I thought it can happen in this sport and I will concentrate on the next champi-

A similar last shot in the finals at the 2022 World Championships in Cairo had robbed him of a medal, but that disappointment was masked by the Olympic quota place



"It had happened to me at the World Championships in Cairo last year as well, but yes, I bagged an Olympic quota there and finished fourth, so that was the saving grace," said Kusale on the sidelines of a function organised by the National Rifle Association of India (NRAI) to felicitate the Asian Games medal

India returned home with 22 medals in shooting, their best ever performance at the Games.

"I was very deeply concentrating on the moment, too much focused and because of that, maybe, my entire process (went for a toss). It's something which I never anticipated I could do. I tried my level best to come back, but I still missed an individual medal.

Kusale, though, won the team gold along with Aishwary Pratap Singh Tomar and Akhil Sheoran.

Kusale, a junior TC with the Railways, says that world champion rifle shooter Tejaswini Sawant has helped him handle tricky situation while competing. Sawant, who also hails from

Kolhapur but now resides in Pune, had become world champion in 2010 in women's 50m rifle prone. 'Teju di (Tejaswini) has taught me how to handle different situations, etc. I have learnt from her and she has inspired me a lot over the years," said Kusale.

Kusale is also not surprised that his best pal" Akhil Sheoran too has bagged the second Olympic quota for the country at the World Championships in Baku, Azerbaijan just before the Asian Games.

The two have been competing together since 2012, when they were juniors, and Kusale said he cannot remember a national camp when they have not been room

'Akhil has been my roommate and best pal since 2012 since the time we were competing as juniors. We are like brother and both have won (Olympic) quota, albeit one year

keep their unbeaten run going in the tournament, Afghanistan, who shocked England by 69 runs, would be keen to create another big upset and put their campaign firmly on track in the showpiece event.

New Zealand are going great guns in the tournament, hav-ing won all three matches so far and are currently placed second on the points table, trailing India on net run rate.

On the other hand, Afghanistan had an inauspicious start to their campaign losing to Bangladesh and India before leaving Jos Buttler's England in a tizzy with a victory to be cherished for long in New Delhi on Sunday.

New Zealand will again be led by wicketkeeper-batter Tom Latham after their charismatic skipper Kane Williamson suffered a fracture on his left thumb during the match against Bangladesh and was ruled out for a few games.

Williamson, who had missed the opening two matches against England and the Netherlands — due to an ACL



injury suffered during IPL 2023, was looking good to strike a century after being out of action for more than five months. But the skipper's innings was cut short at 78 when he was struck on the thumb by a throw from the

outfield. Despite the huge setback, the Kiwis would be banking on their success so far to win their fourth game on the trot against an unpredictable Afghanistan, who played their

pacer Tim Southee finally gets a chance against Afghanistan, having recovered from a thumb injury, though his match fitness has remained an issue.

The Kiwis will rely heavily on their top order comprising Will Young, Devon Conway and Daryl Mitchell, while allrounder Rachin Ravindra, with his impactful performances across departments, will also be the player to watch.

Rohit best man to lead India to third WC title

A ustralian legend Ricky Ponting believes a "laid-back" Rohit Sharma is the ideal captain to lead India to their third ODI World Cup title, the second on home soil after the 2011 triumph.

With three convincing wins under their belt, India have made a perfect start to their World Cup campaign.

India defeated Australia by six wickets in their tournament opener, before registering emphatic eight and sevenwicket wins over Afghanistan and Pakistan to sit on top of the points table.

"He's very laid back, Rohit. Very laid back with everything he does. You can even see that by the way that he plays. He's a pretty laconic sort of batsman as well, and that's the way he is both on and off the field," Ponting told the ICC on Tuesday. Rohit took the captaincy reins from Virat Kohli in both the white-ball formats in

December 2021. And Ponting believes Rohit's character fits perfectly for the India job, allowing Kohli to focus on his batting.

Someone like Virat, who is a bit more heart-on-the-sleeve, and probably listens to the fans and plays up with the fans a little bit more, someone with his personality would probably find it a bit harder," the twotime World Cup winning Australia skipper said.

"But I think Rohit will be fine with it. He's a terrific bloke and has been a great player for a long time, and he's done a great job as leader of India."

The Men In Blue last won the World Cup when the tournament was jointly hosted by India, Sri Lanka and Bangladesh in 2011.

would definitely be there, but Ponting feels Rohit is the best man to deal with that.

'We can't sit back and say that the pressure won't get to them (India) at some stage, or it won't affect them, because it will, just with the enormity of the tournament.

Ponting said that with all bases covered, India are the team to beat in the ongoing showpiece. "I said from the start that I think they're going to be the team to beat. They've got a very

talented team," he said.
"They've got all bases covered with their fast bowling, their spin and their top-order, middle-order batting. They're going to be extremely hard to beat. But we'll see how they hold up under extreme pressure as well," Ponting concluded. India will next play Bangladesh

We regret squandering promising: Nissanka

Adisappointed Pathum Nissanka said anything close to 300 would have been a challenging total but Sri Lanka failed to sustain a promising start against Australia in a World Cup match here. Nissanka (61) and fellow open-

er Kushal Perera (78) gave Sri Monday, stitching a 125-run partnership but the Island nation suffered an unexpected batting collapse, losing all 10 wickets for just 84 runs to put up a below-par 209 on the board.

The Australians grabbed the opportunity with Josh Inglis (58) and Mitchell Marsh (52) scoring half-centuries each to take their side to a fivewicket win in 35.2 overs, their first victory in three matches.

"Despite our promising start, we deeply regret not being able to sustain it, resulting in us being limited to a score of 210



runs," Nissanka said at the post-match press conference. "On a wicket like this, I believe we should aim for a total closer to 300 runs, and this was a contributing factor for our

Nissanka's 61 off 67 balls was his second successive half-century in the tournament.

"I believe I've given my best for the team. I'm hopeful that I can contribute significantly by scoring substantial number of runs and playing substantial innings in the upcoming matches," he

Sri Lanka have lost three games they have played so far and need to win all their remaining six matches for a shot at the semifinals.

They next face the Netherlands here on Saturday.

"Our focus now is to learn from our mistakes and strive for strong performances in the upcoming matches. Our mental level is good. We hope to play well in these matches and win the remaining matches,

Nissanka said.

Shami's role is clear still no place in 'Perfect IX'

At times, the greatest of actors don't fit the character of a particular film and in director Rohit Sharma's 70 mm World Cup panorama, Mohammed Shami is that protagonist who is missing out on a meaty role.

Shardul Thakur, who has bowled a total of 8 overs in two games, is the fourth fast bowling option on a flat deck and if



it is a spin friendly track like the one in Chennai, R Ashwin comes in to the eleven in place of Thakur to complement Kuldeep Yadav and Ravindra

There seems to be crystal clarity even on the batting front. Unlike the 2019 edition, the lead up of which saw the number four position become a

game of musical chairs, Shreyas yer, if he is fit, is the clear choice in that position. Even though he oozes X factor, Suryakumar Yadav has to wait for his return.

Rohit Sharma has led from the front thus far and India look the team to beat in the World Cup. However, there are a few questions that need to be

answered. Can the team rely on Hardik as the third seamer? Should Shami not play in place of Thakur as the latter has not yet been required with the bat at number 83

Speaking to PTI, former chief selector MSK Prasad lauded the team's horses for courses

approach. "They are using horses for

courses and it is working fantastically well for the team. If you see they used Ashwin in Chennai and Shardul for the other two games (in Delhi and Ahmedabad). Last game, Shardul was not required as the others did the job (he bowled only two overs)," said the former India wicketkeeper.

Shami will come into picture if they want to rotate Siraj. Replacements are very clear right now, Sky will replace Shreyas if there is a need, Ishan will replace Gill at the top and Shardul will play if it is a flat deck. Aswhin will come in his place if it is a turning

Hardik lends a critical balance to the playing eleven but considering his fitness issues in the past, can he be expected to bowl 10 overs game after game as the third seamer if the need

"With Hardik, you can't expect him to bowl 10 overs in every game. The job that he is doing. Of bowling 5-6 overs per game, that is good enough. Team management seems to have absolute clarity on the role of every individual," added

Want to take more wickets: Zampa

 $P^{anned\ for\ his\ poor\ show\ in}_{the\ opening\ two\ World\ Cup}$ matches, Australia's sole frontline spinner at the World Cup Adam Zampa said that expensive figures don't bother him as he bowls to get wickets.

Australia found themselves in a precarious situation after suffering back-to-back losses against India and South Africa before notching up a fivewicket win over Sri Lanka on Monday.

Zampa, who has enjoyed a lot of success between the 2019 World Cup and the start of the ongoing edition, flattered to deceive in the opening two games, going for plenty of

"I'm very good at self-reflection. I look back on the first two games and I'll probably look at the last game as one where I could have made a difference there and made it easy for those other guys," Zampa said after Australia's win

"But yeah, the Indian game, I mean, we're under the pump defending 200 and I'm always going to be the guy who tries to get wickets. I'm not going to try and let the game peter out and let it go into nothing. So yeah, figures, whatever."

He registered figures of 0/53 and 1/70 against India and South Africa respectively for a combined figure of 1/123 in 18 "It's more about my attitude

and reflecting on that too. Did I bowl the ball where I wanted it to? Did I make the right decisions? Did I put my game on the line to try and make a difference? And that's how I think about it. "I don't really care about com-

couple of days.
"I had to do a fitness test before the game today. Yeah, I felt like adrenaline was going to get me through and a bit of Panadeine Forte (medicine). It was a tough one to get through today, but as I said, one of those random ones that will wear off in the next day or so."

Gurbaz reprimanded for breaching ICC's Code of Conduct

Afghanistan batter Rahma-nullah Gurbaz has been handed an official reprimand for breaching level 1 of the ICC Code of Conduct during their epic World Cup match against England.

Gurbaz was found to have breached Article 2.2 of the ICC Code of Conduct for Players and Player Support Personnel, which relates to "abuse of cricket equipment or clothing, ground equipment or fixtures and fittings during an International Match."

In addition to this, one demerit point has been added to Gurbaz's disciplinary record, for whom it was the first offence in a 24-month period.

The incident occurred in the 19th over of Afghanistan's innings, when after his dismissal, Gurbaz slammed his bat on the boundary rope and a chair.

Gurbaz admitted the offence



posed by Jeff Crowe of the Emirates ICC Elite Panel of Match Referees, so there was no need for a formal hearing. On-field umpires Rod Tucker and Sharfuddoula Ibne Shahid, third umpire Paul Reiffel and

fourth umpire Paul Wilson levelled the charge. Level 1 breaches carry a minimum penalty of an official reprimand, a maximum penalty of 50 per cent of a player's match

fee, and one or two demerit points Afghanistan had defeated England by 69 runs to create one of the biggest upsets in World

cup history.
