# **India: Canada Parity as per Vienna pact**

### **Trudeau says India's actions** contrary to international law

m mid}$  the ongoing diplomatic standoff between the two countries, on Friday, India rejected Canada's attempt to portray that the Vienna Convention on Diplomatic Relations was violated in seeking diplomatic parity, as Canada withdrew 41 of its diplomats from here. Canada also issued a travel advisory for its citizens in India, asking them "to exercise a high degree of caution due to the threat of terrorist attacks throughout the country

Canada's Prime Minister Justin Trudeau said on Friday that India's decision to revoke the diplomatic immunity of 41 Canadian diplomats is a violation of the Vienna Convention and it should worry all countries in the world, hours after New Delhi rejected Ottawa's attempt to portray the imple-

mentation of parity as a violation of international norms. Speaking at a press conference in Brampton, Ontario, he said the Indian Government was making it "unbelievably difficult" for life as usual to continue for millions of people in India and in Canada following the decision. "And, they're doing it by contravening a very basic principle of diplomacy...The government of India decided to unilaterally revoke the diplomatic immunity of 40

Canadian diplomats in India. This is a violation of the Vienna Convention. Governing diplomacy. This is them choosing to contravene a very fundamental principle of international law and diplomacy," he said. India's sharp reaction came hours after Canadian Foreign Affairs Minister Melanie Joly announced that the country had withdrawn 41 diplomats and their family members from India, following a threat to strip them of their diplomatic immunity by Friday.

"I can confirm that India has formally conveyed its plan to unilaterally remove diplomatic immunities for all but 21 Canadian diplomats and dependents in Delhi by tomorrow, October 20," Joly said in Ottawa late on Thursday.

Brushing aside her contention, the External Affairs Ministry said in New Delhi: "We have seen the Statement by the Government of Canada on October 19 regarding Canadian diplomatic presence in India. The state of our bilateral relations, the much higher number of Canadian diplomats in India and their continued interference in our internal affairs warrant parity in mutual diplomatic presence in New Delhi and Ottawa. We have been engaged with the Canadian side on this over the last month in order to work out the details and modalities of its imple-



The External Affairs Ministry added, "Our actions in implementing this parity are fully consistent with Article 11.1 of the Vienna Convention on Diplomatic Relations, which states the following: "In the absence of specific agreement as to the size of the mission, the receiving State may require that the size of a mission be kept within limits considered by it to be reasonable and normal, having regard to circumstances and conditions in the receiving State and to the needs of the particular mission."

The Ministry said, "We reject any attempt to portray the implementation of parity as a violation of international norms.

Tension flared between India and Canada last month following Prime Minister Justin Trudeau's allegations of the "potential" involvement of Indian agents in the killing of Khalistani extremist Hardeep Singh Nijjar on June 18 in British Columbia. India had designated Nijjar as a terrorist in 2020. New Delhi rejected the allegations as "absurd" and

Earlier on Friday, Canada also paused all in-person services at the consulates in Mumbai, Chandigarh, and Bengaluru and urged its citizens in these three cities to exercise caution. All Canadians in India have been asked to contact the High Commission in New Delhi in case they need assistance. The Canadian updated advisory added, "In the context of

recent developments in Canada and India, there are calls for protests and some negative sentiment towards Canada in traditional media and on social media. Demonstrations, including anti-Canada protests, could occur and Canadians may be subjected to intimidation or harassment. In Delhi and the National Capital Region, you should keep a low profile with strangers, and not share your personal informa-

Last month, India advised its citizens living in Canada and those contemplating travelling there to exercise "utmost caution" given growing anti-India activities and "politically-condoned" hate crimes in the

North American country. As regards withdrawing its diplomats from India, Joly said in their "unreasonable" request for diplomatic parity, India would only allow 21 diplomats and their families to maintain their diplomatic status, putting the others at risk of having their protections stripped arbitrarily, leaving them vulnerable to reprisal or arrest.

This means 41 Canadian diplomats and their 42 dependents were in danger of having immunity stripped on an arbitrary date, and this would put their personal safety at risk," she said at a news conference in Ottawa.

'The safety of Canadians and of our diplomats is always my top concern. Given the implications of India's actions on the safety of our diplomats, we have facilitated their safe departure from India," Joly said. "This means that our diplomats and their families have now left." Last month, India asked Canada to downsize its diplomatic staff in the country, parity in strength and rank equivalence in the mutual diplomatic presence. The size of Canadian diplomatic staff in India is larger than what New Delhi has in Canada. Calling India's action "con-

trary to international law and in violation of the Vienna Convention on Diplomatic Relations", Joly accused India of escalating the bilateral tensions, but Canada will not be

reciprocating.
"There is a fundamental principle of diplomacy, and this is a two-way street. It only works if every country abides by the rules," she said. 'A unilateral revocation of

diplomatic privileges and immunities is contrary to international law," Joly said. 'Threatening to do so is unrea-

sonable and escalatory. If we

allow the norm of diplomatic

immunity to be broken, no diplomats anywhere ... would be safe." "So for this reason, we will not reciprocate," she added. "Let me be clear, Canada will continue to defend international law, which applies to all nations and will continue to engage with India. Now more than ever, we need diplomats on the ground, and we need to talk to one another," Joly said. Joly announced the development "on the situation with India" alongside Immigration, Refugees and Citizenship Minister Marc Miller, who announced the shrinking of Canada's footprint to one-third

# **Mahua lawyer quits** after HC appalled at mediation attempt

# Namo Bharat defines journey of New India, says Modi

Prime Minister Narendra Modi said on Friday that the Namo Bharat train symbolises the journey of a "New India" and its new resolutions. He flagged off the Namo Bharat train on a 17-km stretch of the Transit System (RRTS) in Sahibabad

The Prime Minister mentioned that the 80-km stretch between Delhi and Meerut is "just the beginning". "Namo Bharat systems will be implemented in many parts of the country, generating employment opportunities," he added.

Highlighting that the crew of the Namo Bharat train comprises women, he said, "This is the symbol of growing women empowerment in India'

# Gaganyaan readies for pioneering human space flight

The launch of a single-stage liquid rocket on Saturday will signal ISRO's journey towards its ambitious human space flight programme, Gaganyaan, when the first crew module test to ensure the safety of astronauts will be conducted by the space agency

ISRO aims to send humans into space on a Low Earth Orbit of 400 km for a three-day Gaganyaan mission and bring them safely back to earth. Unlike other missions by the Bengaluru-headquartered space agency, ISRO would

attempt a successful launch of

its Test Vehicle (TV-D1), a

single-stage liquid rocket,

scheduled to lift off from the surised "external structure" first launch pad at this spaceport at 8 am on October 21. The Test Vehicle mission with

this Crew Module is a significant milestone for the overall Gaganyaan programme as a nearly complete system is integrated for a flight test.

The success of this test flight would set the stage for the remaining qualification tests and unmanned missions, leading to the first Gaganyaan programme with Indian astronauts, which is expected to take shape in 2025.

The Crew Module System is a habitable space with an Earthlike environment in space for the crew. It is of double-walled construction consisting of a pressurised metallic "inner structure" and an unpreswith "thermal protection sys-

tems" It houses the crew interfaces, life support system, avionics, and deceleration systems. It is also designed for re-entry to ensure the safety of the crew during the descent till touchdown. The Crew Module underwent various testing at ISRO centres before it was integrated into the launch complex in Sriharikota, located about 135 km east of Chennai. The entire test flight sequence on Saturday is expected to be brief as the Test Vehicle Abort Mission (TV-D1) will launch the Crew Escape Systems and Crew Module at an altitude of 17 km which are expected to make a safe touchdown in the sea, about 10 kms from the

However, for the Test Vehicle

Abort Mission 1(TV-D1), the Crew Module is an unpressurised version and it has the overall size and weight of actual Crew Module on the Gaganyaan mission. The Crew Module has all the

systems for deceleration and recovery, a set of parachutes among many others. In the first test flight on

# Plans drafted to clean Mumbai air Unique Bengal: Worshipping Muslim girl in Kanya Pujan

In several major preventive measures announced to bring down severe air pollution levels in Mumbai, the Brihanmumbai Municipal Corporation (BMC) on Friday evening made it mandatory for builders and developers to set up 35 feet high iron sheet enclosures on all 6,000-odd construction sites across the metropolis and wrap the entire building under construction with green cloth, jute sheet or tarpaulin.

Taking serious cognizance of the fact that on Tuesday, Mumbai's overall Air Quality Index touched 191, worse than that of Delhi's 84 and on Wednesday, the levels of inhalable Particulate Matter PM 10 crossed that of the national capital, the BMC announced several to arrest the increasing the air pollution levels in the country's commercial capital.

In an effort to supplement its efforts, the BMC also announced that on October 23, it would come out with Standard Operative Procedures (SOPs) /guidelines for ensuring better quality of air in Mumbai. Apart from making it mandatory for builders and develop-



ers 35-feet high iron sheet enclosures atop the construction and wrapping the underconstruction structures with green cloth, jute sheet and tarpaulin, the BMC also made provision of sprinkler systems and anti-smog guns within 30

days on all construction sites mandatory and decided to operate anti-smog guns on 50 to 60 major roads in the metropolis.

In another measure, the BMC announced that it would req-uisition experts to check polies - Tata Power Plant and Rashtriya Chemicals and Fertilizers Limited (RCF).

The idea breaks the tradition but is not new in itself. Rather it is an encore of what Swami Vivekananda did in 1998 by worshipping the daughter of a Muslim boatman as "Kumari" at the famous Kheer Bhavani Temple when he was travelling

This year around the Mritika Club of New Town has selected Nafisa, a girl, as their Kumari who will be worshipped as Mother Goddess human form on the Maha Navami Day.

"We have chosen Nafisa whose mother works in the house of one of us ...there is no better way to acknowledge divinity in

a person ... a divinity that manifests itself through the a Muslim girl," an organizer of the Mrittika Club women's "Kumari," says one of the orgacommittee said.

'If Swami ji could worship a Muslim girl more than a century ago, why can't we do it says Pratham Mukherjee, secretary of the Mritika Club.

Although Muslim families and youth of many parts of Bengal especially Kolkata's minority dominated areas have been participating enthusiastically in Durga Pujas, this will be the first time that a girl from the community is being worshiped as a living goddess.

Muslim priest Haji Illyas at Alimuddin Street hailed the effort: "In this time of provocations such affection ... such efforts for communal amity should be appreciated."

## **Kerala HC quashes Govt show cause** notice served on VC

Division Bench of the AKerala High Court on Friday quashed the show-cause notice issued by the Kerala Government to Prof Ciza Thomas, former principal Government Engineering College, Thiruvananthapuram for taking over the additional charge of the vice-chancellor of Dr APJ Abdul Kalam Technological University without the permission of the Government.

Prof Thomas ha assumed charges of the vice chancellor of the university under orders of Governor Arif Mohammed Khan following the Supreme Court verdict unseating the then vice chancellor Rajashree's appointment as null and void. The Governor, who is the chancellor of the University had appointed Prof Thomas as she was the most eligible person to hold the post. Though Prof Thomas had sought the permission of the CPI-M led Kerala Government to relieve Government Engineering College, Thiruvananthapuram, the latter sat over her plea till her retirement on 23 March 2023. The State Government had approached the High Court challenging the appointment of Prof Thomas as Vice Chancellor. But the High Court had ruled that the appointment was in line with the guidelines issued by the University Grants Commission and hence the plea by the Government was not tenable.

According to Prof Thomas, the Kerala Government started harassing her from the day she joined as v c of the technical university. She was served a show-cause notice by the Government for taking up the post of VC without prior

## Seven held for cheating 2,100 people across country of ₹4 crore on selling goods online

The Delhi Police has arrested seven persons who allegedly cheated more than 2,100 people across the country of more than Rs 4 crore on the pretext of selling goods online. The accused had been operating the racket for the last two years 'These seven people are directly linked with more than 2,100 complaints and 67 FIRs across the country registered against them till now," said Rohit Meena, Deputy Commissioner of Police (Shahdara district).

On October 7, Vijay Pahwa filed a complaint that he was cheated by a person he had contacted after getting his number from a website to buy an electric scooter online. "Pahwa paid a sum of Rs 1.15 lakh to them. Later the accused stopped responding to him and the complainant understood that he was duped. Following a written complaint, the cyber police of Shahdara lodged an FIR and started the investigation," said the DCP. Cyber teams collected various details and a raid was con-

ducted at Jain Nagar, Karala.

Four persons identified as



(28), Mohammad Suhail Ansari (26), and Ankit Yadav (26) were arrested, the police said in a statement.

The four used to create fake websites of popular companies which were "sold" to fraudsters at high rates to cheat people, police alleged. "Interrogation of these accused led us to more raids and further three men were arrested -Bihari Paswan (22) Ajeet Kumar Paswan (23), and Kanhaiya Kumar Mahto (19) from Bihar. We came to know that Ajeet and Bihari were 'calling agents' while Kanhaiya

Delhi Mayor Shelly Oberoi on Friday claimed that a court-appointed panel has "taken a decision to deseal" over 300 shops which were sealed in 2018 for alleged violation of norms. In a press conference, she described the move as a "Diwali gift" for the affected traders.

In 2018, 392 shops were sealed at the instance of a Supreme Court-appointed monitoring committee, she said. These garment shops were located in Lajpat Nagar-IV area and were sealed for carrying out "commercial activity in a residential area",

the mayor said. Now, after years of their struggle, the "monitoring committee has taken a decision to deseal" these shops, she told reporters, and said the move was "praiseworthy". A senior official of the MCD, when contacted, also said the decision to "deseal" these shops was taken by the monitoring committee. Mayor Oberoi also told reporters that these traders will have to



submit an undertaking and a few other documents to start the process.

"A supplementary lease deed which is executed by the L&DO, will have to be submitted, as also penalties and misuse charges to be paid to L&DO, besides conversion and parking charges, if due," Oberoi said. "One more certificate on structural stability will have to be submitted to the MCD.

After all these formalities are done, only then shops will be desealed," she told reporters. Meanwhile Delhi BJP

Spokesperson Praveen Shankar Kapoor has said that the traders of Delhi's Amar Colony who have been fighting a long legal battle to get their shops desealed are today extremely grateful towards the Union Minister Hardeep Singh Puri for giving them a big legal relief. "Even after a decision of Union Urban Development Ministry the legal process of obtaining Supplementary Lease Deed & payment of penalty charges to ensure desealing could have easily taken another 18 to 24 months," Kapoor added.

After January 1, 2025 the induction of only electric buses shall be allowed. No CNG-operated bus even if having BS-VI compliance shall be allowed to be inducted under this scheme," the draft of the scheme said.

# It is a step towards DTC privatisation, alleges BJP

Delhi BJP on Friday expressed concerns over the recent public transport policy by the AAP led Delhi Government pertaining to the proposal of Premium Aggregated Bus Service in the national Capital which is a step towards privatisation of Delhi Transport Corporation

Former Delhi BJP President and party's MLA Vijender Gupta said the current policies have been formulated with malafide intentions, favouring private bus operators at the cost of the state's primary public transport service, the Delhi Transport Corporation (DTC). Drawing attention to his efforts back in 2016, Gupta in a statement said that he had had lodged a complaint due to the fact that the policy was introduced without the requisite enabling provisions in the Motor Vehicles Act.

The zeal with which the Kejriwal Government is pushing for the rollout of this policy suggests possible vested interests," Gupta charged. Elaborating on the current

state of affairs of DTC, Gupta lamented the neglect it has suffered over the years, with the fleet largely comprising buses that are over 15 years old and in a deteriorating condition, rendering them unfit for daily

# Restored heritage structures at Mehrauli unveiled

The Mehrauli Archaeological Park now boasts of restored and conserved heritage structures including Balban's Tomb complex, which was once completely covered with weeds. The restoration and conservation works have been done on the principles of heritage conservation maintaining the authenticity and structural integrity of the structures. Also, suitable adaptive reuses have been proposed to ence and to preserve the historical and cultural value of heritage structures while giving them new functions and uses as per the global practice.

"The Master plan, 2021 and Unified Building Bye Laws, 2016 of Delhi immensely promotes the adaptive Re-use of historic buildings and this principle has been applied in the Park.

elhi Assembly Speaker Pelhi Assembly of Employers and Niwas Goel in a letter to Chief Secretary on Friday expressed his unwillingness to give consent for the transfer of three officers of Assembly Secretariat.

The letter of the speaker followed a clarification earlier this week by the Services department of the Delhi government to the Assembly Secretariat that three officers posted there have sought transfer and submitted applications in this regard.

Goel, in his letter to Chief Secretary Naresh Kumar, reiterated his earlier allegations that the Assembly officers were pressured by Services department officers to divulge committee proceedings,

threatening them with disciplinary action.

"I am, therefore, of the belief that the transfer applications of these three officers is a result of intimidation and coercion heaped on them through illegal and irrelevant show cause notices in Delhi Legislative Assembly matters," he wrote to the Chief Secretary.

The Assembly Secretariat officers, including its secretary, were issued show cause notice by the Vigilance Directorate of Delhi government in the matter of recruitment of fellows in August this year.

"As far as the transfer requests of the three officers are concerned, I am comprehensively disinclined to agree to their request, and accordingly the same may not be acceded to at this juncture," Goel said.

Designed by the Indian Navy's Warship Design Bureau (WDB), this ship is a hallmark of indigenous shipbuilding and is amongst the most techno-



logically advanced warships in

Being a guided missile destroyer with a displacement of 7,400 tons and an overall length of 164 meters, Imphal is a potent and versatile platform equipped with state-of-the-art weapons and sensors, including surface-to-air missiles, anti-ship missiles and torpedoes.

Powered by a Combined Gas and Gas (COGAG) propulsion set, comprising four gas turbines, she is capable of achieving speeds in excess of 20 ing speeds in excess of 30 knots (56 km/h).

The ship boasts of a high indigenous content of approximately 75% that includes Medium Range Surface-to-Air Missiles (BEL, Bangalore), BrahMos Surface-to-Surface Missiles (BrahMos Aerospace, New Delhi), Indigenous Torpedo Tube Launchers (Larsen & Toubro, Mumbai), Anti-Submarine Indigenous Rocket Launchers (Larsen & Toubro, Mumbai) and 76mm

(BHEL, Haridwar)

Imphal's keel was laid on 19 May, 2017 and the ship was launched into water on 20 April, 2019.

The ship had sailed out for her maiden sea trials on 28 April, 2023, and, ever since, has undergone a comprehensive schedule of trials in harbour and at sea, leading up to its delivery within a record timeframe of only six months.

The time taken to build Imphal and for her trials is the shortest for any indigenous destroy-

# Kovind to share next week roadmap on One Nation, One Election

In a communication to the parties, it has sought an interaction with them on a "mutually agreed date", sources said citing the letter. They said parties have also been given an option to send their views in writing in the next three months.

assembly polls to ensure both state and Lok Sabha elections are held together from 2029 onwards, the Commission may suggest reducing or enhancing the tenure of legislative assem-A mechanism is being devised

to ensure that once Lok Sabha and assembly polls are synchronised, voters go to the polling booth only once to cast their ballot for both the elec-

The sources said since assembly and parliamentary polls are Commission is working out modalities to see that voters do not go to polling stations more the two polls.

The Commission, they said, is of the view that assembly and parliamentary polls can be held together and it is only working out modalities for the smooth conduct of the gigantic democratic exercise.

# **Product QR codes** to help visually impaired take call

There's good news for the visually impaired persons in the country. The country's top food regulator, Food Safety and Standards Authority of India (FSSAI) has issued an advisory to the Food Business Operators to ensure the QR codes on product labels that encompass comprehensive details about the product, including nutritional information, allergens, manufacturing date, best before/ expiry/use by date, allergen warning, and contact information for customer inquiries.

A food QR Code is one that shares detailed information about a food product, helping the visually impaired people to make informed decisions before purchasing.

"It is pertinent to note that the inclusion of a QR code for the accessibility of information does not replace or negate the requirement to provide mandatory information on the product label, as prescribed by relevant regulations," FSSAI advisory said. However, the food regulalegal case filed in the Delhi High Court in May this year. Besides food products, the public interest litigation (PIL) in the court has sought QR codes on all medicinal products to make them accessible to visually impaired persons. A bench comprising Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad had issued a notice to the Centre, FSSAI, and Drugs Technical Advisory Board (DTAB) on a petition by The Kapila and Nirmal Hingorani



Foundation as well as Dr Smriti Singh and Shobhan Singh, both of whom are visually impaired.

Lawyer Aman Hingorani, representing the petitioners, had asserted that a smartphone can scan QR codes containing the requisite information about the product and convert it to speech format. The plea said that employing QR codes would increase the efficacy of medical care for visually impaired patients by reducing medication errors, incorrect dosages, unintended drug interactions and side effects. It can also combat the growing menace of counterfeit and substandard medicine.

"The visually impaired persons have the constitutional equality and the right to lead their lives with dignity and there remains huge scope for utilising the capabilities of smartphones and QR codes to help them identify products and access relevant product information," said the plea. The petition has urged directions to the Centre to secure effective access for visually impaired persons to medicines, food, cosmetics and other consumer products by taking comprehensive measures to affix QR codes on such products.

# 145 doctors convicted under PC-PNDT Act suspended by State Medical Councils: Ministry

# 9 days Naval exercise Milan to begin in February

▼ndia will host a mega nine-day naval exercise Lin February next year where 50 countries are likely to participate. Navies from the US, Japan, Australia, France, Bangladesh, South Korea, Vietnam, Indonesia and Malaysia are among the nations in the 'Milan' exercise to be conducted off Visakhapatnam from February 19 to 27, officials said on Friday.

The upcoming exercise will be the biggest multilateral military wargame to be hosted by India ever and it will feature large-force manoeuvres, advanced air defence operations, anti-submarine warfare and anti-surface drills, they said. It is learnt that all key participating nations will send their platforms and personnel for the wargame that will take place in the Arabian Sea. The drills would also feature in sub-surface and air domains.

The Milan is a biennial multilateral naval exercise which was initiated by the Indian Navy in

Originally conceived in consonance with India's 'Look East Policy', the exercise expanded in ensuing years with New Delhi's 'Act East Policy' and Security And Growth for All in the Region (SAGAR) initiative.

In 2022, 39 countries participated in Milan exer-

"The Milan 2024 is likely to witness the largestever participation to date with invites being extended to over 50 countries," Indian Navy spokesperson Commander Vivek Madhwal



He said it will be an action packed exercise featuring a wide-range of activities. The harbour phase of Milan will consist of maritime seminars, exhibition and city parade.

"Maritime patrol aircraft and submarines of friendly foreign countries would participate in the sea phase along with Indian Navy units," Commander Madhwal said.

They will involve large-force manoeuvres, advanced air defence operations, anti-submarine warfare and anti-surface warfare operations," he said.

The run-up to Milan is concomitant to India's G20 Presidency and the conduct of the exercise would yet again realise the 'G20 theme Vasudhaiva Kutumbakam' (the world is one family)," the Navy spokesperson said.

A mid-planning conference on Milan was hosted by the Eastern Naval Command on October 17 with participating friendly foreign navies. In the virtual conference, representatives of invited countries were briefed on events planned during the harbour phase and sea phase.

# **Proposal approved for creation** of Centre of Ageing at IMS-BHU

There is a wave of happiness at Institute of Medical Science, Banaras Hindu University (IMS-BHU) to know that the Union Cabinet has approved the proposal for creation of National Centre of Ageing (NCA) under National Programme for Health Care of the Elderly (NPHCE) at IMS-BHU. The same was communicated by a letter by Union Health Minister to Rajya Sabha MP Seema Dwivedi who has supported the proposal of creation of NCA at BHU.

Nodal officer of NPHCE and founder Head of Geriatrics Department, IMS-BHU, Prof

Anup Singh said that it is a matter of great pride and satisfaction to get this centre for IMS. He thanked the prime minister, union health minister and MP Seema Dwivedi and BHU administration for the same. He added that it's the vision of the PM to strengthen geriatric healthcare facilities for the elderly and to make them 'atmnirbhar' for health needs. The Ayushmann Bharat scheme will further strengthen it. Prof Singh said that as the geriatric population is increasing due to increased longevity so better health services are the challenges in future. "From life expectancy of 32 years in 1947 it has now increased to 70

years in 2021. It's estimated that elderly population will double by 2050. The central government has acknowledged this and started various programmes dedicated to elderly. The NPHCE is one of them and IMS-BHU was designated as a regional geriatric centre and Prof Anup Singh is its nodal officer in BHU. Under leadership of Prof Anup Singh, the Department of Geriatric Medicine was created in 2018 and within one year MD Geriatric course was started.The department has shown exponential growth in all areas of patient care, research and academics. "Acknowledging our efforts to develop geriatric

facility at IMS-BHU and need of a one point care facility for geriatric patients, the Union Health Minister approved our pending proposal of upgradation of Regional Geriatric Centre to 200-bed NCA under NPHCE," he said.

According to him, as per operational guidelines of NPHCE, the NCA will be a multi-storey building with OPD of multidisciplinary geriatric sub-specialties apart from special clinics like arthritis clinic, memory clinic etc, provision of elective surgery with modular operation theatre, separate diagnostic and radiological facility, rehabilitation services and day care and intensive care and private ward. Besides, the centre will help in capacity building and human resources development in field of geriatrics, post graduate MD geriatric seats will be increased from 3 to 15 with the increase in seats of senior residents and consultants and research in the field of geriatric and making guidelines for treatment specific for elderly.

"To develop a better healthcare system for elderly is the focus area of the PM and the creation of such a one point care facility for making the elderly self-reliant will be a boon for geriatric patients of UP and adjoining states," Prof

# MMDP kits given to patients

Under the National Filariasis Eradication Programme (NFEP), a Morbidity Management and Disability Prevention (MMDP) camp and testing campaign was conducted in cooperation with the Centre for Advocacy and Research (CFAR) at Chilbila Badagaon Primary Health Centre (PHC) here on Thursday. The programme was organised under the direction of Chief Medical Officer Sandeep (CMO) Chaudhary. The doctors of Banaras Hindu University (BHU) and their team also examined the patients and their families to study the previously identified lymphoedema filariasis (swelling in the arms, legs and breasts) patients.

The patients suffering from lymphatic filariasis (LF)were given MMDP kits for the care of the affected organs. Dr Amit Kumar Singh, in-charge of the Filaria Control Unit at Lal Bahadur Shastri (LBS) Hospital, Ramnagar, trained the patients on the use of MMDP kit. According to him, this disease not only makes the person disabled but also has a negative impact on the mental condition of the patient. "Symptoms of this disease are not visible in the beginning and



are seen after five to 10 years. To prevent this use a mosquito net while sleeping. Carrier mosquitoes can be avoided by maintaining cleanliness in and around the house and eliminating waterlogging," he said.
Dr Amit said that there is

no fear of infection in the parts affected by filariasis, mainly by maintaining cleanliness of the feet and by doing regular exercise and yoga, the swelling also reduces. "If carelessness is taken towards this, the organs start getting damaged and the problem increases," he said, adding that the necessary medicines should also be taken to stop it from increasing. He said that those who have swelling in their hands and feet or are affected by filariasis, there is leakage of water from their organs. In this situation, cleanliness of their affected body parts is very important. Therefore MMDP kit is being provided. This kit includes one tub, mug, bucket, towel, soap, anti-fungal cream etc. The members of the Filaria Patient Support Group (PSG) network are sensitising the community about filariasis. Along with this, the myths related to the disease are also being dispelled. Shivani, Trupti and Sunil, a team from the Biochemistry Department of BHU, took blood samples of filariasis patients and their family members, previously identified by the Health department. A survey was also conducted in the nearby area. This study will help in understanding lymphatic filariasis in depth, so that treatment of this disease can be found. # **Gimmer of Hope**

Finally, some humanitarian aid is reaching Gaza as Israel relents under world pressure

or more than ten days after the Israel-Hamas conflict started, its residents have endured the ravages of violence, scarcity of medicines, and inadequate access to basic necessities like water and food. Finally, some humanitarian aid begins to flow into Gaza, offering some relief to the residents of Gaza who desperately need it. After the categorical announcement by Prime Minister Netanyahu that no aid would be allowed inside Gaza, the situation had become very precarious. Now, after world pressure, mostly from the US and the West and some tough talking by the UN, aid is now reaching the residents of Gaza though it is still a trickle. With limited access to clean water, electricity, education, and healthcare, the people of Gaza have been trapped in an unending cycle of despair. It may be a while before a cease-fire can be enforced, but the recent influx of humanitarian aid signifies a positive shift in the international community's approach to this crisis. Various countries, including India, non-governmental organizations, and

the United Nations have stepped up their efforts to alleviate the suffering of the people in Gaza.

The dastardly attack on Al-Ahil Hospital has indeed jolted the conscience of the world community. Indeed, it is the medical aid that is most needed in this hour and that is what is hard to get. The only cancer hospital in Gaza is going to shut down anytime now as it is running out of fuel and medical supplies. Now that WHO trucks are ready with supplies that may come as muchneeded succour. The WHO has termed it as "a drop in the ocean of need," but it could be an icebreaker. The World Health Organization (WHO) has stated that five trucks loaded with medical supplies are ready to

enter Gaza through the border between Gaza and Egypt. This is a direct fallout of Biden's visit to Tel Aviv. Following what he described as "frank" discussions with the leaders of Israel and Egypt, US President Joe Biden revealed an agreement to permit aid to enter Gaza. Israel gave its consent to this arrangement while continuing its military operation. This anticipated aid delivery will be the first since Israel's declaration of a "complete blockade" on the besieged Gaza Strip, home to 2.3 million people. This blockade involved the interruption of electricity supplies and the cessation of food and fuel flows in response to a surprise attack by Hamas on Israeli territory on October 7, resulting in the reported death of at least 1,400 people. The United Nations has issued a warning regarding the dire humanitarian situation in Gaza, where over half of the population is living in abject poverty due to a 16-year blockade enforced by Israel. It is imperative that the momentum continues, and that diplomatic efforts are redoubled to address the political issues at the core of the conflict. In the face of ongoing adversity, this glimmer of hope may be the catalyst that brings some solace to the besieged people of Gaza and gives a chance to the world community to confront the reality of Gaza and strive for a peaceful future for its residents.

# Myanmar: Repression continues unabated




The Junta feels emboldened as the world's gaze shifts to Gaza; it continues with its savage war against its own people and persecuting its political opponents

vents in Myanmar have gone under the radar of global discourse with the latter's attention focused on the developments in West Asia—Hamas' terrorist attack on Israel and the latter's gruesome retaliatory strikes on civilians in Gaza—and the war in Ukraine. This is unfortunate. With the pressure of global disapprobation weakening with the shifting focus, the ruling junta continues with its savage war against its own people, persecuting its political opponents, and unleashing horrendous vio-

According to a report datelined May 11, 2023, in the website The Irrawaddy, the Junta continues to crush all political opposition, having dissolved at least 40 political parties including the National League for Democracy (NLD), led by Daw Aung San Suu Kyi. Members of the NLD, their families and supporters have been regularly attacked and killed since the coup on February 1, 2021, which prevented the NLD, which had swept the elections to the national parliament held on November 8, 2020, from forming government. At least 1,235 NLD members have been detained, 26 have died during interrogation or in detention, and 63 others have been killed unlawfully, according to a statement released by the NLD on March 29. Not just this. The United Nations High Commissioner of Human Rights reported, on June 28, 2023, that at least 3,452 people had been killed by the military and its allies since the coup.

According to the United National High Commissioner for Refugees' Operational Data Portal, the total number of internally displaced persons was 1,975,000 as last updated on October 9, 2023. The figure includes people fleeing the junta's attacks on villages and towns, air strike and persecution, those with arrest warrants in their names, young protestors and their parents hounded by the police, civilians providing financial support to the NUG, and civil servants invoived in the civil disobedience movement and so on. Understandably, repression of this magnitude and savagery has spawned armed resistance. Some porting the country's struggle



It has been attacking the Sit-Tat with increasing frequency and success. According to a report in The Irrawaddy, datelined October 18, 2023, it killed at least 28 Junta troops in incidents reported from Sagaing, Magwe, Mandalay, Bago and Tanintharyi regions in four preceding days. The Sit-Tat is also worried by drone strikes by the resistance forces. One of these, targeting the Myawaddy District Administration Department office in Karen State's Myawaddy Town killed five junta officials, including a district administrator and military battalion commander. Eleven policemen, including a superintendent, were injured. Not surprisingly, a brief released on September 5, 2022 by the Special Advisory Council for Myanmar, a group of international experts sup-

for democracy, said that the junta had stable control over only 72 out of the country's 330 townships, constituting only 17 per cent of Myanmar's land area.". The NUG and ethnic resistance organisations effectively controlled over 52 per cent of Myanmar's territory and 23 per cent was contested. Driven on the backfoot on the ground, the junta has increasingly resorted to air-strikes. Haley Willis and Weiyi Cai stated in a report in The New York Times of July 31, 2023, that there were nearly twice as many military airstrikes reported in April, May and June as in the first three months of the year. The maximum number of strikes in any month this year, 40, were in June. The average of 30 airstrikes per month up to now this year, has been the highest for any year of the conflict so far. The report quotes Anthony Davis, an analyst for the Janes group of military publications and an expert on the Myanmar military, as saying, that the military's strategy was to punish the civilian population for any perceived support to the oppo-

A special target has been the Sagaing Region in north-western part Myanmar, bordering India. It is a rebel stronghold where the mili-

tary's ground forces have had difficulty gaining territory. The worst airstrike since the coup on February 1, 2021, occurred in Pazigyi Village in the southern part of the region on April 11, 2023. The target of bombing and strafing by military jets and helicopters, was a gathering to celebrate the local resistance movements opening of an administrative office there. At least 170 persons, most of them civilians and at least 30 of them children, were killed. The military hardware for such attacks by the Sit-Tat, including military aircraft, comes from China, Russia and even some south-east Asian countries. Russia, according to its state news agency RIA, signed a contract in September, 2022, for the delivery of six Su-30SME fighter jets, to Myanmar. Two of these arrived last month. Since Russia and China are unlikely to stop delivering combat supplies, the only way to stop the aerial attacks is to deny aviation fuel supto Myanmar. plies Unfortunately, Western countries swearing by democracy, are hardly doing effective to stanch the flow.

#### **SR CITIZEN RAILWAY CONCESSION**

Sir—Senior citizens used to enjoy a discount on railway ticket fares until the year 2020. The administration provided a 60 percent discount on tickets for senior citizens aged 60 and above and a 50 percent discount for women aged 58 and above. This discount was applicable on all trains

across the railway network. However, in March 2020, Indian Railways discontinued this discount citing the reason as the COVID-19 pandemic. It has been quite some time since the end of the pandemic, but the railways have yet to address this issue. In response, the Union Railway Minister, in a reply to the Rajya Sabha, assured that the concession would be reinstated soon, but there has been no concrete timeline provided. Mr. Danve, the Minister of State for Railways, hails from Maharashtra, where there are 28 Lok Sabha members from the BJP. If all of them unite in requesting the railway minister, it is likely that the concession will be reinstated. It is worth noting that due to the absence of this discount, the Railways missed out on a significant amount of revenue, totaling Rs. 1491 crore in 2017-2018 and Rs. 1636 crore in 2019–20. Indian Railways, with its substantial revenue, discontinued the senior citizen concession, ostensibly to increase income. This raises the question of why the central government appears to be indifferent to the concerns of senior citizens, especially when other countries, including many in Europe, provide numerous benefits and discounts to their elderly citizens.

They asserted that granting LGBTQ+ people the right to marry is a legislative prerogative beyond the court's purview. The long-anticipated judgment left members and supporters of India's LGBTQ community disheartened, many of whom had gathered outside the court in anticipation. In a matter of hours, their hopes were dashed. While Tuesday's decision was

disappointing, the New Delhi court did accept the government's proposal to establish a special panel to investigate the provision of social and legal benefits to same-sex couples. This committee will examine measures addressing the genuine concerns of cohabiting same-sex couples in their daily lives, such as joint banking, insurance, pensions, property rights, and school admissions for children. The most disheartening aspect is the absence of specific timelines. Being reliant on a government committee without predefined dates feels like an endless wait." noted gay rights activist Sharif Rangnekar. India's Supreme Court acknowledged transgender individuals as a third gender in 2014, but Rangnekar highlighted the considerable time it took for state governments across India to enforce the court's ruling. The top court deliberated on over 20 petitions from same-sex couples and activists during proceedings held in April and May, which were broadcast live and garnered widespread attention throughout India.

## HARNESSING BREATH **FOR HEALTH**

By controlling the breath, we can influence our autonomic nervous system

ranayama, an integral part of yoga, is a practice that focuses on breath control. The word "pranayama" is derived from two Sanskrit words: "prana," meaning life force or energy, and "ayama," meaning control or expansion. This ancient practice has been passed down through generations and is believed to offer numerous physical, mental, and spiritual benefits. Beyond its long-standing tradition, modern science has begun to explore the physiological and psychological mechanisms behind pranayama.

#### The Physiology of Breath

Before we explore pranayama, it's crucial to understand the fundamental mechanics of breathing. Our breath is regulated by the respiratory center located in the brainstem. This center monitors the levels of oxygen and carbon dioxide in the blood and adjusts our breathing rate and depth accordingly. In a resting state, our body typically breathes shallowly and relatively fast. However, by consciously engaging in pranayama, we can manipulate our breathing pattern to achieve specific effects.

#### **Pranayama and the Autonomic Nervous System**

The autonomic nervous system (ANS) regulates involuntary bodily functions such as heart rate, digestion, and respiratory rate. It is divided into two branches: the sympathetic nervous system (SNS) and the parasympathetic nervous system (PNS). The SNS is responsible for the "fight or flight" response, increasing heart rate and alertness, while the PNS induces the "rest and digest" state, promoting relaxation.



Pranayama practices directly influence the ANS. Slowing down and deepening the breath, as seen in techniques like "diaphragmatic breathing" and "nadi shodhana" (alternate nostril breathing), stimulates the PNS. This results in reduced heart rate, decreased blood pressure, and a sense of calm. The conscious manipulation of breath is a powerful tool for managing stress and anxiety.

#### **Oxygen Saturation and Pranayama**

Pranayama techniques can also affect oxygen saturation in the blood. By taking slow, deep breaths, more oxygen enters the bloodstream, which can enhance overall vitality. This increase in oxygen helps to energize the body and improve cognitive function. Several studies have shown that pranayama can lead to higher blood oxygen levels and improved lung function, especially in individuals with respiratory conditions.

#### Balancing pH Levels

Pranayama can also influence the pH levels in the body. When you take slow, deep breaths, you release more carbon dioxide (CO2), which can lead to a mild respiratory alkalosis. Alkalosis can enhance cognitive function and induce a sense of calm. This is especially relevant when practicing "Bhastrika" (bellows breath), where rapid breaths lead to increased CO2 elimination.

#### **Mental and Emotional Benefits**

The science behind pranayama isn't limited to just the physical aspects. Numerous studies have explored the effects of pranayama on mental health and emotional well-being. Deep breathing techniques have been found to reduce symptoms of anxiety and depression by promoting relaxation and reducing the release of stress hormones like cortisol. The rhythmic and focused nature of pranayama practices also help improve concentration and mindfulness.

#### **Regulating Heart Rate Variability**

Heart rate variability (HRV) is a measure of the variation in time between successive heartbeats. Higher HRV is associated with a healthier cardiovascular system and improved resilience to stress. Regular pranayama practice has been shown to increase HRV, indicating a more adaptive and resilient autonomic nervous system. Improved HRV can reduce the risk of heart disease and enhance overall well-being.

# Rethink rationale for food subsidy

Most of its actions in implementing the food subsidy scheme are out of sync with the changing times and lead to leakages and corruption



he NITI Aayog has invited bids for a Central Coordinating Agency that can study the effectiveness of its National Food Security Subsidy scheme. The Agency will hold the mandate to suggest ways to better the scheme. It will also suggest 'whether, and how, the scheme can be rationalised or closed? However, the government's move to continue the supply of free food grains under the National Food Security Act (NFSA) beyond the current FY gives the contrary signal. In fact, most of its actions in implementing the food subsidy scheme are out of sync with the thought process of the Think Tank.

Under the NFSA, the Centre directs the Food Corporation of India (FCI) and other state agencies to procure food from the farmer at MSP (minimum support price) and organise its distribution to around 820 million people through a network of fair price shops (FPS) at the subsidized price (call it 'issue price') of Rs 2/3/1 per kg for wheat, rice, and coarse cereals respectively.

There are two types of beneficiaries. As part of the Antyodaya Anna Yojana (AAY), the poorest of the poor households get 35 kg of food grains per family (@ 7 kg per person in a family of five) each month. The number of families under AAY is 24 million, and the persons getting 7 kg cereals per month @ Rs 2/3/1 per kg are 120 million. The rest 700 million persons are eligible to receive five kg of cereals per month at the same price.

The excess of MSP paid to farmers and handling and distribution costs (HDC) over the issue price is reimbursed as a subsidy to the FCI and other state agencies. The money comes from the Union Budget's allocation for 'food subsidy'. The expenditure incurred by the Centre during the last four years under this head was 2020-21: Rs 529,000 crore; 2021-22: Rs 372,000 crore; 2022-23: Rs 287,000 crore; 2023-24: Rs 197,000 crore (budget estimate).

This adds up to a total of Rs 1385,000 crore. It includes Rs 390,000 crore spent on run-

April 2020 to deal with the unprecedented situation triggered by the Covid-19 pandemic, PMGKAY provided 5 kg of rice or wheat per person per month for "free" via the FPS, as well as 1 kg of pulses per family per month to around 164 million families covered under

Run for three months initially, the scheme got six extensions till December 31, 2022. On December 23, 2022, Consumer Affairs, Food and Public Distribution Minister Piyush Goyal announced the merger of the free part of PMGKAY with the regular food security schemes under NFSA. Pursuant to this, food is available to beneficiaries under the NFSA for free from January 1, 2023 to December 31,

There are several loopholes in the running of the food subsidy scheme. First, fundamentally, subsidised food is meant for the poor. The number of poor isn't more than 15 – 20 per cent of India's population. Yet, the number of beneficiaries under NFSA at 820 million works out to nearly 59 per cent of the population. Even as per the Shanta Kumar Committee (2015), the people eligible for subsidized food under NFSA shouldn't be more than 40 per cent.

Second, during the last five years, the number of people below the poverty line has declined by 135 million. This should have led to a corresponding reduction in beneficiaries under the NFSA. That hasn't happened. Far from that, the number could go up by nearly 100 million if one were to go by the Supreme Court directive to take into account the population during 2021 instead of the present coverage based on 2011 Census estimates. Third, are the beneficiaries so poor

cost of making it available (in the case of wheat, it is 1/15th)? Even the Shanta Kumar Committee wanted the non-AAY families to pay 50 per cent of the MSP. Fourth, the current issue price was specified in the NFSA legislation. The law enacted in 2013 froze these rates for three years. Since 2016, there has been no legal bar on increasing the price. Yet, the government hasn't bothered to increase despite a substantial increase in MSP.

Fifth, the ridiculously low price at which food is available in the supply chain is an open invitation to dubious operators to siphon off and sell in the open market raking in a moolah. This can't be prevented even if the administration is alert. Sixth, the initial idea under the Scheme was that FCI et al would buy only the quantity needed for meeting beneficiaries' requirements under NFSA plus maintain some 'strategic' buffer to meet emerto be an 'open-ended' procurement which it has become today. This has led to stocking problems, high costs, unsustainable rise in subsidies etc. The open-ended purchase has made India's position at WTO embarrassing as the system entails subsidy support to farmers in excess of the 10 per cent threshold for

developing countries.
As for the PMGKAY, it made sense during FY 2020-21, when economic activity got a big jolt due to Covid resulting in 'negative' growth in GDP by 6.6 per cent. However, its continuation during 2021-22 and 2022-23 when the economy rebounded with GDP registering growth of 8.7 percent and 7.2 percent respectively was unjustified. Discontinuation of PMGKAY from January 1, 2023, was the right move. However, the concomitant decision to provide free food grains under regular NFSA was unjustified.

The reasoning given by Piyush Goyal that this was "to shield the masses from shocks to the system at a time the economy was recovering in the aftermath of Covid crisis" doesn't cut the ice. This is because on top of two consecutive years of good growth, during the current FY, it is expected to register an impressive 6.3 per cent. Now, the government has given an indication that the free food scheme will continue not just till the end of the current FY but also beyond. This too is untenable.

The way to go is: to disband the existing system of subsidizing the price and give subsidies directly to the beneficiary under DBT. Under DBT, the state agencies need not buy, store and deliver food to the beneficiary; instead the latter buys from the market paying the full price say, Rs 30 per kg of wheat (of this, Rs 28 comes from the government as subsidy and Rs 2 from her

This will address all maladies afflicting the system. With DBT in place, the government can easily prioritize and undeserving persons won't get subsidies. There won't be any misuse or leakage as subsidized food doesn't enter the supply chain. It will also save on costs currently incurred on handling of grains by the agencies. All consumers will benefit from increased supplies and competition in the market. Finally, India won't face any problems at WTO as the system doesn't involve any subsidy to the farmers.

Unfortunately, this is a far cry. We don't even see baby steps such as deleting undeserving from the list of beneficiaries or small increases in price etc. The root cause lies in the political climate wherein the ruling party can't dare withdraw benefits already enjoyed by the beneficiaries; in fact, it is compelled to give

# Protesters in several countries demonstrate over airstrikes

¬housands of people in Muslim countries and beyond held demonstrations Friday in solidarity with Palestinians in the Gaza Strip, calling for an end to Israel's blockade and airstrikes in the wake of a brutal incursion into southern Israel by fighters from the Hamas militant group that rules Gaza.Demonstrators gathered in Iraq at the country's border crossing with Jordan; in locations across . Egypt; in Turkiye's capital Ankara and its most populous city of Istanbul; and in Indonesia, Malaysia and South Korea.A Tuesday night explosion at a Gaza City hospital tending to wounded Palestinians and residents seeking shelter was a prominent theme in some of the

demonstrations.

Thousands of Egyptians demonstrated in cities and towns across the North African country, in an expression of

the besieged Gaza Strip. In a rare move, the Egyptian government approved and even helped organise 27 locations for protesters to gather on Friday. Since coming to power in 2013, Abdel-Fattah el-Sissi's government has outlawed large public protests. Hundreds gathered in the courtyard of the Al-Azhar Mosque, the Sunni Muslim world's foremost religious institution, in central

In Turkiye, where the government has declared three days of mourning in solidarity with the victims of a blast at a Gaza hospital, thousands of people staged protests outside mosques following Friday prayers in Istanbul and in the capital, Ankara.In Istanbul, protesters affiliated with Íslamic groups waved Turkish and Palestinian flags, held up placards and chanted slogans denouncing Israel's actions in Gaza. "Stop the genocide!" and "Murderer Israel get out of

The US announced on September 27 that it was admitting Israel into the visa waiver programme, adding the country to a select group of 40 mostly European and Asian countries whose citizens can travel to the US for three months without visas. At the time, the US said Israelis could start travelling to America without visas as of November 30. In a news release, the Department of Homeland Security said the program was operational as of

# UK PM travels to Egypt for crisis talks

 $B^{\text{ritish Prime Minister Rishi}}_{\text{Sunak will travel to Egypt}}$ on Friday as part of his Middle East tour for crisis talks to prevent the Israel-Gaza conflict spilling over across the region. His talks with Egyptian President Abdel Fattah El-Sisi follow "productive" dis-cussions with Saudi Crown Prince Mohammed bin Salman in Saudi Arabia on Thursday.

I had an important and productive meeting with Crown Prince Mohammed bin Salman. We agreed on coordinated action to prevent further escalation in the region, provide vital humanitarian aid in Gaza and support stability, both now and in the long-term," tweeted Sunak after the meeting. Sunak "encouraged the

Crown Prince to use Saudi's leadership in the region to



support stability, both now and in the long-term", Downing Street said.

His stop at Riyadh followed a visit to Israel for talks with President Isaac Herzog and Prime Minister Benjamin Netanyahu during which he addressed a joint press conference with the

latter to reiterate that the UK stands with Israel in its "darkest hour".

"In all these conversa-tions the Prime Minister has stressed the imperative of avoiding regional escalation and preventing the further unnecessary loss of civilian life," said Downing Street. Sunak termed Hamas as

'pure evil" and also pushed Israeli leaders for progress in allowing humanitarian aid into Gaza, amid warnings of a humanitarian disaster.

The British Prime Minister is on a two-day visit to the Middle East since Thursday in an effort to prevent escalation of the conflict. It visit comes directly after US President Joe Biden's visit as world leaders step up efforts to prevent the conflict escalating across the wider

Biden said Israel had

been "badly victimised" and had a right to strike back against Hamas but also cautioned Israelis against being "consumed" by anger, urging them not to repeat the "mistakes" made by an "enraged" United States after the 9/11 attacks in 2001.

Sunak has declined to back Opposition calls from the Scottish National Party and some Labour MPs for a ceasefire to protect civilians, insisting Israel has a right to "act against terrorism".

UK Foreign Secretary James Cleverly told MPs on Wednesday that calls for ceasefires were "all well and good", but he had seen no evidence that one would be respected by Hamas.

The minister is also on a diplomatic trip of his own, meeting his Egyptian counter-part and is also due to visit Turkey and Qatar.

# Sunak's Tories suffer huge losses in two by-elections

British Prime Minister Rishi Sunak's governing Conservative Party suffered huge losses in two by-elections on Friday, losing to the Opposition Labour Party, which overturned a sizeable Tory majority in the seats of Mid Bedfordshire and Tamworth in England.

While Sunak is touring the Middle East for crisis talks over the Israel-Gaza conflict, Labour leader Keir Starmer declared that his party was "redrawing the political map."

Labour made history in Mid Bedfordshire by overcoming a 24,664 Tory majority to win the seat for the first time and pulled off a 23.9 per cent swing to Labour from the Tories in

Tory strongholds shows that people overwhelmingly want change and they're ready to put their faith in our changed Labour Party to deliver it," said Starmer.

By-elections ahead of a general election year are seen as reflective of the mood of the electorate and the governing Tories will be shaken up by the results.

The historic results mark the second-highest-ever byelection swing to Labour. With the Tories also trailing in the nationwide opinion polls, the results will be a welcome boost to Labour ahead of an expected general election in 2024.

Conservative chairman Greg Hands said the results were "disappointing" but blamed the out-

"Clearly for us, I think it is right that a number of our voters are unhappy with the government.

## China sends envoy to Middle East

Beijing (AP): China has sent an envoy to the Middle East to push for a cease-fire between Israel and Hamas in the latest sign of its ambition to play a larger role in the region. Envoy Zhai Jun's first meetings included one in Qatar with a Russian counterpart on Thursday as the two countries stake out a position at odds with the American approach. The two sides confirmed their "unwavering focus on closely coordinating efforts for the political settlement of this and other crises in the Middle East and North Africa region," Russia's Foreign Ministry said, according to the country's Tass state news agency.China, which sees the US as too pro-Israel, has said it opposes attacks on civilians but has not condemned the initial Hamas attack that started the latest war. Instead, it has called for an immediate cease-fire to protect civilians as Israel bombards Gaza before a pos-

sible ground invasion.

"We believe that when dealing with hot-spot issues in the international community, major powers should be objective and impartial," Chinese Foreign Ministry spokesperson Mao Ning said

Analysts say that China

wants to position itself as a mediator and exert its influence in the region as the US shifts its global attention elsewhere. But the latest Gaza war has drawn the US back in, with President Joe Biden visiting Israel this week.Zhai held meetings in Qatar with Mikhail Bogdanov, the Russian president's special representative for the Middle East and Africa, and with Oatar's minister of state for foreign affairs, Mohammed Abdulaziz al-Khulaifi, Mao said. She added that Zhai would travel to other Mideast countries but did not give any details on which ones or when.

## **US** military shoots down missiles as it faces growing threats in Middle East

**AP WASHINGTON** 

With tensions spiking in the Middle East, US forces in the region are facing increasing down missiles appearing to head toward Israel Thursday and American bases in Iraq and Syria were repeatedly targeted by drone attacks. The USS Carney, a Navy destroyer in the northern Red Sea, intercepted three land attack cruise missiles and several drones that were launched by Houthi forces in Yemen. The action by the Carney potentially represented the first shots by the U.S. military in the defense of Israel in this conflict.

Brig Gen Pat Ryder, Pentagon press secretary, told reporters the missiles were 'potentially" headed toward Israel but said the U.S. hasn't finished its assessment of what they were targeting. A US official

said they don't believe the missiles — which were shot down over the water — were aimed at the US warship. The official spoke on condition of anonymithat had not yet been announced.

But an array of other drone attacks over the past three days did target US bases, including one in southern Syria on Thursday that caused minor injuries. The rash of violence comes in the wake of an explosion at a Gaza hospital that killed hundreds of people, triggering protests in a number of Muslim nations. The Israeli military has relentlessly attacked Gaza in retaliation for the devastating Hamas rampage in southern Israel almost two weeks ago, but Israel has denied responsibility for the al-Ahli hospital blast and the US has said its intelligence assessment found that Tel Aviv was not to blame. In recent days, however, a number of militant groups across the region from Hezbolla to the Houthis have expressed support for the Palestinians and threatened have launched at least four drone attacks on U.S. military installations in Iraq and Syria where US troops train local defense forces and support the mission to counter the Islamic State group. The attacks fuel escalating worries in the US and the West that the war in Israel could expand into a larger regional conflict."That's exactly what we are trying to prevent," Ryder said. The most recent drone attack was Thursday at al-Asad Air Base in western Iraq. The Islamic Resistance in Iraq posted a statement claiming responsibility for the attack, saying they had fired a salvo of rockets at the base and "they hit their targets directly and precise-

# Space getting crowded with satellites

Melbourne Reports this week suggest a near-collision between an Australian satellite and a suspected Chinese military satellite. Meanwhile, earlier this month, the US government issued the first ever space junk fine. The Federal Communications Commission handed a US\$150,000 penalty to the DISH Network, a publicly traded company providing satellite TV services. It came as a surprise to

many in the space industry, as the fine didn't relate to any recent debris - it was issued for a communications satellite that has been in space for more than 21 years. It was EchoStar-7, which failed to meet the orbit requirements outlined in a previously agreed debris mitigation plan.

The EchoStar-7 fine might be a US first, but it probably won't be the last. We are entering an unprecedented era of space use and can expect the number of active satellites in space to increase by 700% by the end of the decade. As our local space gets

more crowded, keeping an eye on tens of thousands of satellites and bits of space junk will only become more important. So researchers have a new field for this: space domain aware-

THREE TYPES OF ORBIT, **PLUS JUNK** 

Humans have been launching satellites into space since 1957 and in the past 66 years have become rather good at it. There are currently more than 8,700 active satellites in various orbits around Earth. Satellites tend to be in

three main orbits, and understanding these is key to understanding the complex nature of space debris. The most common orbit

for satellites is low Earth orbit, with at least 5,900 active satellites. Objects in low Earth orbit tend to reside up to 1,000km above Earth's surface and are constantly on the move. The International Space Station is an example of a low Earth orbit object, travelling around Earth 16 times every day. Higher up is the medium

Earth orbit, where satellites sit between 10,000 and 20,000km above Earth. It's not a particularly busy place, but is home to some of the most important satellites ever launched - they provide us with the global positioning system or GPS.

Finally, we have very high altitude satellites in geosynchronous orbit. In this orbit, satellites are upwards of 35,000km above Earth, in orbits that match the rate of Earth's rotation. One special type of this orbit is a geostationary Earth orbit. It lies on the same plane as Earth's equator, making the satellites appear stationary from the ground.

As you can tell, Earth's surrounds are buzzing with satellite activity. It only gets more chaotic when we factor in space junk, defined as disused artificial debris in orbit around Earth. Space junk can range from entire satellites that are no longer in use or working, down to millimetre-wide bits of spacecraft and launch vehicles left in orbit. Latest estimates

suggest there are more than 130 million pieces of space debris, with only 35,000 of those large enough (greater than 10cm) to be routinely tracked from the ground. **HOW DO WE TRACK** 


#### THEM ALL? This is where space domain

awareness comes in. It is the field of detecting, tracking and monitoring objects in Earth's orbit, including active satellites and space debris. We do much of this with ground-based tracking, either

through radar or optical systems like telescopes. While radar can easily track objects in low Earth orbit, higher up we need optical sensors. Objects in medium Earth orbit and geostationary orbit can be tracked using sunlight reflected towards Earth. ## SL, IMF agree on disbursal of 2nd tranche of bailout package

Colombo (PTI): Sri Lanka and the IMF have reached a crucial staff-level agreement to release the second tranche of about USD 330 million out of the USD 2.9 billion bailout package which will help in the cash-strapped country's economic recovery.
The International

Monetary Fund in March this year approved a 48-month, ÚSD 2.9 billion extended arrangement under the Extended Fund Facility (EFF) to support Sri Lanka's economic policies and reforms. The IMF mission that visited Sri Lanka for the first review of the global lender-supported Extended Fund Facility programme for the country noted that despite early signs of stabilisation, full economic recovery is not yet assured.

"Sri Lanka will have access to SDR 254 million (about US\$330 million) in financing once the review is approved by IMF Management and IMF Executive Board," the IMF said in a release on Thursday. The release of the second tranche at the conclusion of the first review of the facility approved in March is subject to approval by the IMF executive board in the period ahead, it said.

The IMF however said despite showing early signs of stabilisation the "full econom-

ic recovery is not yet assured". It stressed, "Sri Lanka's external position has weakened as a result of prolonged debt restructuring discussions and reserve accumulation has slowed in recent months".

It said Sri Lanka needed to increase revenues and signal better governance by adopting needed tax measures". The IMF has urged for agreement with creditors for debt treatment. It said that delays in debt restructuring risk worsening the economic outlook for the

"We urge all official creditors to move forward and agree on an appropriate debt treatment in line with financing assurances they provided", the statement said. The IMF has noted that "inflation is down from a peak of 70 per cent in September 2022 to 1.3 per cent in September 2023, gross international reserves increased by 1.5 bn dollars during March-June this year, and shortages of essentials

# Ukraine, Russia assess resources as war heads toward another winter

Ukrainian President Volodymyr Zelenskyy said he spoke with President Joe Biden about future US support for Ukraine, and Russian President Vladimir Putin visited a military base near the invaded nation's border as the warring countries prepared for the winter and next year's combat operations.

Almost 20 months of war have sapped both sides' military resources. The fighting is likely to settle into positional and attritional warfare during the approaching wintry weather, analysts say, with little change along the more than 1,000-kilometre (600-mile) front line.

Zelenskyy said late Thursday he spoke to Biden by phone about "a significant support package" for Ukraine. Western help has been crucial for Ukraine's war effort.

The US president is expected to ask Congress on Friday for billions of dollars in military assistance for both Ukraine and Israel. Kremlin spokesman Dmitry Peskov said the latest US pledges to back Ukraine would bear no fruit in the war. "Mr Biden hasn't men-

tioned that all those efforts to deter Russia have proven inefficient," Peskov said. "They will remain inefficient in the future?

Zelenskyy also spoke Friday with German Chancellor Olaf Scholz, who "reasserted (Germany's) sustained and steadfast solidarity with Ukraine," according to the German government.

Putin visited late Thursday the headquarters of Russia's Southern Military District, which is located less than 100



Ukraine's southeastern border.

He was briefed on the war by the chief of the General Staff, Valery Gerasimov, the Kremlin said. With the scale of the Western aid Kyiv can expect going forward uncertain, and after a five-month-long Ukrainian counteroffensive that sapped Russia's reserves but apparently only dented its front-line defences, both countries are scrambling to replenish their stockpiles for 2024.

Ukraine has been expending ammunition at a rate of more than 200,000 rounds per month, according to Jack Watling, a senior research fellow at the Royal United Services Institute think tank in London.

"Sufficient ammunition to sustain this rate of fire is not going to be forthcoming as NATO stockpiles deplete, and production rates for ammunition remain too low to meet this level of demand," Watling wrote in an assessment published late Thursday.

Also, Russia is reported to be receiving supplies from Iran, North Korea and other countries. If Ukraine can keep up the pressure, it would further stretch Russia's already strained manpower resources, according to the Institute for the Study of War.

The think tank based in Washington said in its latest assessment that "Russian forces largely lack high-quality reserves and are struggling to generate, train and soundly deploy reserves to effectively plug holes in the front line and pursue offensive operations."


# RBI imposes ₹2.5 crore penalty on L&T Finance

The Reserve Bank of India on Friday said a penalty of Rs 2.5 crore has been imposed on L&T Finance Ltd for noncompliance with certain norms concerning non-banking financial companies (NBFCs).

After examination of reports following statutory inspection of the company, the RBI said it was revealed that the NBFC did not disclose to its retail borrowers, the gradation of risk and rationale for charging different interest rates to different categories of borrowers in the loan application form/sanction letter.

It also failed to notify the change in penal interest rate to borrowers, when it charged penal interest rate higher than what was communicated at the time of sanction, the RBI said.

"After considering the company's reply to the notice, additional submissions made by it and oral submissions made



that the charge of non-compliance... Was substantiated and warranted imposition of monetary penalty, to the extent of such non-compliance with such directions," it said.

The RBI also said penalty is based on the deficiencies in regulatory compliance and is not intended to pronounce upon the validity of any transaction or agreement entered into by the company with its customers.

## Sebi puts in place guidelines to improve governance, preparedness of qualified RTAs

¬apital markets regulator Sebi Capital markets regulated out with guidelines to strengthen governance of qualified Registrars and Transfer Agents (QRTAs) for handling disruption and improving preparedness by conducting periodic drills.

In its circular, the regulator has asked QRTAs to put in place a Business Continuity Plan (BCP) and Disaster Recovery Site (DRS) in a bid to ensure continuity of operations and maintain data and transaction integrity. Apart from DRS, all QRTAs are required to have a Near Site (NS) to ensure zero data loss.

Qualified RTAs — RTAs having more than 2 crore folios — are systemically important institutions as they provide the infrastructure necessary for the smooth and uninterrupted functioning of the securities market. As part of operational risk management, these QRTAs need to have a high level of resilience to provide essential facilities and perform systemically critical functions uninterruptedly in the securities market.

The new guidelines are aimed at "strengthening overall resiliency, the procedures at or governance of QRTAs for handling disruption, augmentation of systems and practices to achieve better Recovery Time Objective (RTO) and Recovery Point Objective (RPO), and to improve overall preparedness by conducting periodic announced/ unannounced drills.

Under the guidelines, Sebi said



DRS is required to have knowledge and expertise of various technological and procedural systems and processes relating to all operations such that DRS/NS (near site) can function at short notice, independently.

QRTAs need to have a sufficient number of trained staff at their DRS so as to have the capability of running live operations from the DRS without involving staff of the Primary Data Centre All QRTAs are required to constitute an Incident and Response Team (IRT) or Crisis Management Team (CMT), which will be chaired by the Managing Director (MD) of the QRTA or by the Chief Technology Officer (CTO), in case of non-availability of MD. case of non-availability of MD. Such a team will be responsible for the actual declaration of disaster, invoking the BCP and shifting operations from PDC to DRS whenever required. Sebi said that the disaster recov-

ery site should preferably be set up in different seismic zones and in case of certain reasons such as operational constraints, change of seismic zones, etc., a minimum distance of 500 kilometres needs to be ensured between PDC and DRS so that affected by the same disaster. In the event of disruption of critical systems, the QRTA will have to be within 30 minutes of the incident, declare that incident as 'Disaster' and take measures to restore operations, including from DRS within 45 minutes of the declaration of 'Disaster'. Accordingly, the Recovery Time

Objective — the maximum time taken to restore operations of 'Critical Systems' from DRS after the declaration of Disaster - will be 45 minutes. "QRTAs to also ensure that the

Recovery Point Objective (RPO) the maximum tolerable period for which data might be lost due to a major incident -- shall be 15 minutes," Sebi said.





They were quite unimaginative, and just kept feeding both Warner and Marsh, who preferred the ground route early on in his innings, with short balls which were effortlessly put away.

Australia notched up their 100 in the 13th over, 200th in the 30th over and 300 in the 41st over as their run machine marched forward inexorably. Warner brought up his hundred, fourth consecutive against Pakistan in ODIs, with a single off Mir, and the signature jumpand-punch celebration followed to the joy of a near full house of crowd, that encouraged both the

# England moves on from defeat to Afghanistan: Buttler

Defending champion England has had 'good conversations' in the aftermath of its ICC Cricket World Cup upset at the hands of Afghanistan, a defeat from which captain Jos Buttler claimed on Friday that the team has moved on from. Given England's longest batting lineup among all teams in the competition, a target of 285 did not appear threatening halfway through the game. But Buttler and his men folded meekly for 215, succumbing to their second loss in three matches.

"We had a few days to let the defeat sink in and moved on and focused. We had some good conversations and the energy and hunger around practice last night was very high," Buttler told the media here ahead of England's training session at the Wankhede Stadium.

England brought its talismanic allrounder Ben Stokes out of retirement for its World Cup defence, but he has missed all three matches so far due to fitness issues.

The intensity with which Stokes trained here on Thursday and also on Friday raised hopes of Stokes final-

ly getting his first game of this year's World Cup, but Buttler remained non-committal.

"I've got so many options within the squad selection, it is always tough, and you're working out the right balance, always venue-dependent as well, so (it has) been a good chance to see the wicket here today and gather a bit more information as well,"

Buttler said in reply.
"But obviously, Ben trained really well last night. It is great to see him back. He obviously brings a lot on the field and with his presence and leadership skills as well as someone



who is always good to turn to," added

the wicketkeeper-batter. Like England, South Africa too is

coming off an upset at the hands of the Netherlands in its previous assignment, and the outcome did surprise Buttler, who said Proteas have a balanced all-round side.

'Yeah, surprised. I think you are always surprised when those kind of things happen. No disrespect to the Netherlands. They played a fantastic game of cricket and deserved to win it. You always have to give credit to the opposition in that instance," Buttler said.

"The bookies' favourites, I'm sure, would have been South Africa on the day. But that is why sport is fantastic. It throws up these upsets.

"And, everyone is on the same field trying to compete and win the game, and you have to give credit to the opposition," he added.

Buttler was impressed with the way South Africa has gone about its business in this quadrennial event. They have been playing some real-

ly good cricket. Obviously, the top six is a very strong top six, and I think pace with the ball is one of their strengths," said Buttler.
