# MOST WANTED TERRORIST NABBED IN DELHI

In a breakthrough against the Pune ISIS module, the Delhi Police arrested three Islamic State terrorists on Monday. One of them is Mohammad Shahnawaz, also known as Shafi Uzzama, who had a reward of ₹3 lakh on his head. Shahnawaz was on the most wanted list of the National

Investigation Agency (NIA).

According to the Delhi
Police, the trio had been planning to carry out terror incidents in north India, taking instructions from handlers based abroad.

Addressing a Press briefing, Special Commissioner of Police (Special Cell) HS Dhaliwal, said, "Last month NIA declared award on three persons allegedly involved in blast cases. Among them, Mohammad Shahnawaz, the main accused, has been arrested with his two associates -Mohammad Rizwan Ashraf and Mohammad Arshad the run." Warsi.

Shahnawaz was arrested from Southeast Delhi's Jaitpur area on Sunday night. Ashraf and Arshad were nabbed from Lucknow and Moradabad in Uttar Pradesh, respectively. All the three suspected terrorists, who are engineers and have expertise in assembling bombs, were produced in a court earlier in the morning and have been sent to seven days of police custody.

While responding to media queries, Dhaliwal said, "Shahnawaz is a mining engi-

neer from Visvesvaraya Institute of Technology, and he had knowledge of blast mechanisms. He hails from Hazaribagh in Jharkhand. His wife, Basanti Patel, is converted to Islam and is now known as Mariam. She is currently on

Dhaliwal added that bomb making literature sent from Pakistan-based handlers and other incriminating materials recovered were Shahnawaz's hideouts.

He said initial interrogation revealed that these people conducted elaborate reconnaissance in Western Ghats, southern India, including Hubbali, Dharwad, and Ahmedabad in Gujarat to establish their hide-

They wanted to make their base in Western Ghats, the police said. During the investigation, it was revealed that they had been instructed to procure all items they needed locally so that external role in their work is not exposed.

Shahnawaz had managed to escape from the custody of the Pune Police. Last month, the NIA had released pictures of Shahnawaz, who was wanted in the Pune ISIS (Islamic State of Iraq and Syria) module case.

"The arrests were made following a tipoff from an arrested accused of another ISIS module in Delhi. Elementary plastic tubes, iron pipes, different types of chemicals, timing devices, etc, which could have been used in making explosive devices, were seized from Shahnawaz, along with a pistol and cartridges," the police

alleged.
Dhaliwal said the ongoing

behind such activities. Warsi, police said, is also from Jharkhand. He had completed a BTech in Mechanical Engineering from Aligarh University and was pursuing a doctorate from Jamia Millia Islamia in Delhi. Ashraf holds a BTech in computer science. Originally from Azamgarh in Uttar Pradesh, he had also trained as a cleric.

Earlier this month, the NIA had announced ₹3 lakh each for information about Shahnawaz and three other terror suspects: Rizwan Abdul Haji Ali, Abdulla Fajyaz Shaikh alias Diaperwala and Talha

Shahnawaz, Abdulla and Rizwan were radicalised into joining the ISIS mission over Telegram app, it is learnt. It is alleged that they were linked to an ISIS module at Pune in Maharsahtra. Maharashtra.

Initially dismissed as petty thieves, further questioning revealed their association with ISIS as part of a sleeper cell.

Shahnawaz, along with two accomplices named Mohammad Imran Mohammad Yunus Khan and Mohammad Yunus Mohammad Yakub Saki, faced arrest by the Kothrud police in Pune on July 18 after attempting to steal a two-wheeler. While the police were en route to their residence in Kondhwa, Pune, for a search operation,

Shahnawaz made a daring escape by leaping out of the police vehicle. Police uncovered that Khan and Saki, who originally hailed from Ratlam in Madhya Pradesh, were purportedly implicated in a different terrorism case registered in Rajasthan.

In this case, explosives were found inside a car back in March 2022. Both Khan and Saki carried a reward of ₹5 lakh each for information leading to their capture. On July 22, the Maharashtra Anti-Terrorism Squad assumed control of the investigation. As part of their probe, the ATS detained more individuals, including an IT engineer named Qadir Dastagir Pathan and SN Kazi in

# **Khalistanis lay siege to Indian mission in UK**

Agroup of pro-Khalistan protesters on Monday gathered outside the High Commission of India here, waving anti-India placards and chanting slogans amid strong Scotland Yard presence.

The protest, which was promoted by British Sikh groups on social media, was organised to draw attention to Canadian Prime Minister Iustin Trudeau's allegations last month of alleged Indian involvement in the killing of wanted terrorist Hardeep Singh Nijjar in Canada.

The allegation has been strongly rejected by the Ministry of External Affairs as "absurd and motivated".

"Sikhs will raise domestic issues, including the suspicious death of activist Bhai Avtar Singh Khanda," reads the

call for Monday's protest.

There were several uniformed Metropolitan Police officers on guard and patrolling on foot outside India House, which was cordoned off to restrict the small group of turbaned men and some women opposite the building outside Waldorf Hotel at Aldwych in

central London.

Several police vehicles also patrolled the area throughout the roughly two-hour-long demonstration during which the protesters made speeches in Punjabi and raised pro-

Khalistan slogans.
Earlier on Monday, the
Sikh Federation (UK) organised a press conference in London to announce a formal request being submitted to the Chief Coroner for England and Wales to open an inquest into the death of Avtar Singh Khanda, a pro-Khalistan UKbased Sikh activist who died in Birmingham in June.

"Given the timing of Khanda's death, and the fact that death threats had been made by those with connections to Indian politics before his death, his case is at the very least suspicious," said Michael Polak, the family's barrister.

Following speculation around the 45-year-old's passing earlier this year, the local West Midlands Police had stated that there were "no suspicious circumstances" surrounding the death. The official cause of death post-mortem was stated as acute leukaemia or blood cancer.

Earlier on Saturday, pro-Khalistan extremists blocked the Indian High Commissioner to the UK, Vikram Dorwaiswami, from entering a gurdwara in Glasgow. The Indian mission dubbed the incident "disgraceful" before reporting it to the UK government.

In a statement issued on Saturday, the High Commission of India in London said that three people from outside Scotland "deliberately disrupted" the visit on Friday evening, and one even attempted to violently force open the diplomatic vehicle as senior diplomats arrived at Glasgow Gurdwara Guru Granth Sahib on Albert Drive.

As they hurled threats and abuses. the Commissioner (HC) and Consul General of India (CG) decided to leave the premises to avert any further altercation. "On September 29, 2023,

three persons — all from areas outside Scotland — disrupted a planned interaction organised by the Gurdwara Committee for the community, the High Commissioner (HC) and the Consul General of India (CG)," said the High Commission of India statement.

# Caste survey opens can of worms

The Nitish Kumar-led Government in Bihar on Monday released findings of its long-awaited caste survey, dis-closing that Other Backward Classes (OBCs) and Extremely Backward Classes (EBCs) together make up a significant 63 per cent of the State's entire population.
The first Caste Census was

conducted during the British colonial era in 1872, with the

last one taking place in 1931.

The data which could spur demands for similar castebased census elsewhere is a key agenda of the Opposition INDIA bloc. And this could provide an advantage to Nitish and his alliance in the upcoming elections in the Hindi heartland, where caste-based politics holds significant sway.

The Congress, which is a major constituent of the Opposition grouping called INDIA, has welcomed the announcement while another Grand Alliance partner Lalu Prasad-led RJD has expressed satisfaction that their longstanding demand for a caste census has finally been fulfilled.

The Opposition BJP, how-ever, voiced dissatisfaction with the caste survey, stressing that it did not give an idea of the

"changed social and economic realities" over the years.

State BJP president Samrat Choudhary said his party had "given its consent" for the exercise and would make an assessment of the findings which have now been made public.

According to the data released here by Development Commissioner Vivek Singh, the State's total population stood at a little over 13.07 crore, out of which the Extremely Backward Classes (36 per cent) were the largest social segment followed by the Other Backward Classes at 27.13 per cent.

Backward caste politicians

have long claimed that the population of castes they represented numbered far more than the conventional wisdom based on the 1931 census, which was the last time a caste headcount was conducted and

released. The survey also stated that Yadavs, the OBC group to which Deputy Chief Minister Tejashwi Yadav belongs, were the largest in terms of the population, accounting for 14.27 per cent of the total.

Dalits, also known as the Scheduled Castes, accounted for 19.65 per cent of the total population in the State, which is also home to nearly 22 lakh (1.68 per cent) people belonging to the Scheduled Tribes.

Those belonging to the "unreserved" category, which denotes the proverbial "upper castes" who dominated politics carry out a caste census, it will till the Mandal wave of the 1990s comprise 15.52 per cent of the total population. Nitish said he will convene

a meeting of all the nine political parties with an electoral presence in the State legislature and the facts and figures will be shared with them.

RJD president Lalu Prasad said declaring the survey will set the tone for a nationwide caste census which will be undertaken if "We form the next Government at the

Both the leaders have played an instrumental role in the formation of the INDIA bloc, which affirmed its commitment to holding a caste census at a meeting it held in Bengaluru recently.

The survey establishes that the State's population is overwhelmingly Hindu, with the majority community comprising 81.99 per cent of the total population, followed by Muslims (17.70 per cent).

Christians, Sikhs, Jains and those following other religions as also the non-believers have a minuscule presence, together making up for less than one

per cent of the total population. The grand old party in recent months has pushed for

be conducted as soon as the Congress Government is formed so that every section

formed so that every section can get their right.
Interestingly the Congress in 2010 felt, being a secular State, should "discourage com-munity distinction". The Group of Ministers headed by the then Union Minister Pranab Mukherjee decided that caste census is not advisable.

Before that first Prime Minister late Jawaharlal Nehru took a stand against caste census while late Prime Minister Indira Gandhi too followed the

Nehru policy.
Another Congress stalwart
and former Prime Minister late Rajiv Gandhi had hit out at the VP Singh Government for implementing the Mandal Commission report on OBC reservations by saying it will divide the country.

The caste survey in Bihar was ordered last year after the Narendra Modi Government at the Centre made it clear that it would not be able to undertake a headcount of castes other than SCs and STs as part of the

## **Nobel for COVID saviours**

 $T^{\text{wo scientists won the Nobel}}_{\text{Prize in medicine on}}$ Monday for discoveries that enabled the creation of mRNA vaccines against COVID-19 and that could be used to develop other shots in the

Hungarian-born American Katalin Karikó and American Drew Weissman were cited for contributing "to the unprecedented rate of vaccine development during one of the great-est threats to human health in modern times," according to the panel that awarded the prize in Stockholm.

The Nobel panel said the pair's "groundbreaking find-ings... Fundamentally changed

our understanding of how mRNA interacts with our immune system."

Traditionally, making vaccines required growing viruses or pieces of viruses — often in giant vats of cells or, like most flu shots, in chicken eggs — and then purifying them before next steps in brewing shots.

The messenger RNA approach is radically different. It starts with a snippet of genetic code that carries instructions for making proteins. Pick the right virus protein to target, and the body turns into a mini vaccine factory. But simply injecting lab-grown mRNA into the body triggered an inflammatory reaction that usually destroyed it.

Szeged University in Hungary and an adjunct professor at the University of Pennsylvania, and Weissman, of the University of Pennsylvania, figured out a tiny modification to the building blocks of RNA that made it stealthy enough to slip past those immune defences.

Karikó, 68, is the 13th woman to win the Nobel Prize in medicine. She was a senior vice president at BioNTech, which partnered with Pfizer to make one of the COVID-19 vaccines. She and Weissman, 64,

Dr Paul Hunter, a professor of medicine at Britain's University of East Anglia, described the mRNA vaccines as a "game changer" in helping to shut down the coronavirus pandemic, crediting the shots

with saving millions of lives. "If it hadn't been for the mRNA technology, COVID would have been much worse... Vaccines generally were the turning point in slowing down COVID and the mRNA vaccines were just so much better than all the others," he said, noting that the main vaccine used in the UK, made by AstraZeneca, is barely in use

"We would likely only now be coming out of the depths of COVID without the mRNA vaccines," Hunter said.

Dr Bharat Pankhania, an infectious diseases expert at Exeter University, said that a major advantage of mRNA technology was that vaccines could be made in extremely large quantities since their main components are made in laboratories.

Pankhania predicted the technology used in the vaccines could be used to refine vaccines for other diseases like Ebola, malaria and dengue, and might also be used to create shots that immunise people against certain types of cancer or autoimmune diseases like lupus.

A programme was organised at the district collectorate where District Magistrate Surya Pal Gangwar hoisted the national flag and paid tributes to both the leaders.



A 25-year-old woman was beaten to death allegedly by her husband in Jankipuram police station area in the wee hours of Monday. ### CEA predicts UP to lead in electricity demand in 2024

PNS LUCKNOW

The Central Electricity Authority has predicted an unprecedented surge in electricity demand in Uttar Pradesh, exceeding 32,000 MW during the summer of 2024. Despite being categorised among the BIMARU states, Uttar Pradesh is expected to lead the country in electricity demand.

The demand in Uttar Pradesh is projected to reach 31,917 MW in 2024-25, according to a state-wise electricity demand forecast recently made by the Central Electricity Authority of India (CEA).

This year from June to September the peak restricted demand in UP had crossed

Avadesh Verma, a member of the UP Electricity Regulatory Commission advisory committee, said that the demand for electricity was steadily rising due to the rapid increase in the number of consumers. This growth was attributed to the new connections provided under the Central government's SAUBHAGYA scheme, which aims for 100% coverage of households with power connections in both rural and urban areas. In the last five years, Uttar

Pradesh has witnessed the provision of over 1 crore new

"The pace at which the power connections are increasing in the state, the demand in 2024-25 will be much more than what has been projected. To meet the surge in demand during the next summers, UP Power corporation should take up the job of strengthening the power distribution infrastructure and UP power transmission corporation should add new transmission capacity on war footing," said Avadesh Verma.

The projection by the CEA comes as an alert to the UPPCL, which is already struggling to cope with the galloping rise in demand for power, primarily eanate infrastructure.

UP, according to the forecast, is expected to experience the highest demand in September 2024. The state has been recording the highest demand in August-September for the last few years. The highest peak demand projected for 2024-25 is around 4,000 mw more than the highest peak demand recorded so far this

The demand in April 2024 has been projected at 25,379

mw, 28,291 mw in May, 29,853 mw in June, 30,581 mw in July, 31,585 mw in August and 31,917 mw in September.

In October 2024, the demand will come down to 24,929 mw followed by 19,413 mw in November and 22,277 mw in December. The peak demand in January, February and March 2025 has been projected at 23,868 mw, 20,686 mw and 21,956 mw, respectively.

Among other states that may record high peak demand in 2024-25 are Gujarat (24,047 mw), Tamil Nadu (20,806 mw), MP (19,686 mw) and Rajasthan (19,342 mw), as per the CEA projections.

A UPPCL official said the demand forecast made by the considering the fact that this year also the peak demand had already crossed 29,000 mw

As per a historical report prepared by the UP State Load Dispatch Centre (UPSLDC), the highest peak demand recorded in Uttar Pradesh in March 2011-12 was only 11,767 mw, which rose to 28,284 mw on July 24, 2023. The highest demand in 2021-22 was 23,867 mw in August and 26,589 mw in September 2022-23.

#### All villages to be connected with bus service by Dec

State for Transport (Independent Charge) of Uttar Pradesh Daya Shankar Singh has directed the officials of Transport Corporation and Transport department that as per the directions of Chief Minister Yogi Adityanath, all the villages of the state should be connected with transport services by December this year.

He said that the number of inhabited villages in Uttar Pradesh is 1,00,983 and that of gram sabhas is 59,163. He said that the Chief Minister has given instructions to serve the unserved villages by December. In accordance with the

instructions of the minister, a meeting was organised under the chairmanship of Principal Secretary (Transport) unserved villages with UPSRTC buses. All the divisional transport officers and regional managers of UPSRTC participated in the meeting in which it was decided to have a field survey to confirm the available information about unserved villages and make it error-free. The survey will be done jointly by the officials of the Transport department and UPSRTC.

The principal secretary said that information about notified routes is available with

Lucknow (PNS): Minister of UPSRTC and information about routes other than these is available with the Transport department. "The joint exercise and on-site survey of both will make the collection of information convenient and authentic. The survey work will be completed in a week," he said. The principal secretary said

that a minimum of two teams have been formed for each district. After compiling this report from the depot level, the regional managers/divisional transport officers will send this report to the headquarters by October 10. Meanwhile, the transport

minister said that while conducting the terrestrial survey and proposing the creation of a route, keep in mind that only villages at a maximum distance kilometer from the route concerned would be considered serviced. Separate bus services will be operated for villages beyond this distance. He said that it would be mandatory to combine the tehsil and district headquarters related to the operation of the bus service.

He issued instructions that keeping this in mind, the proposal for the routes should be prepared in such a way that the total distance of the proposed route does not exceed a 100

He kept the audience hooked throughout as he took them through the lost architectures and monuments of Lucknow with the help of a presentation which contained the archived pictures of old and lost monuments. "Lucknow is known for a limited number of buildings and edifices - Rumi Darwaza, Bada and Chhota Imambaras, and the Residency. The city, however, had several other architectural marvels, which have been described from time to time by various researchers. Unfortunately, many of those have lost their sheen, crumbled away due to apathy and neglect, or simply lost their original architectural features due to alterations and changes in usage

patterns," he said. "A third category of monuments consists of buildings or structures which had existed at some point in time but no trace of which can be found in present times. These marvels have been mentioned by writers and travellers but hardly documented or described in detail,

about their architectural features, purpose and eventual destruction. The most prominent among these was the medieval Macchi Bhawan, which was destroyed by the British to set up the KGMC (now KGMU). Other lost structures include the Jalalabad Fort and

Moti Mahal," he recalled. On what makes a building a monument, he said: "If it's not 100 years old, we don't call it a monument. Lost monuments are those which are completely lost or no longer in their original stricture. Around 500 heritage monuments in Lucknow that existed at some point of time have been identified. These may include palaces, gateways, graves, gardens, mosques,

# Non-violence strength | Woman among 6 killed over land dispute

**▼**n a sensational incident, just Adityanath hailed the law and order situation of Uttar Pradesh, six people, including a woman, were allegedly murdered in Deoria district over a longstanding land dispute between two families.

The incident triggered panic in the area, prompting police to deploy additional force there. Senior police officials, including Principal Secretary (Home) Sanjay Prasad and Special DG (Law and Order) Prashant Kumar visited the spot along with other senior officials and claimed to have detained 14 persons for interrogation so far.

The investigation revealed that the incident happened in Fatehpur village situated near the Rudrapur police station area of Deoria district. The dispute between the two families had been festering for several years, fuelling the animosity between them. Among the victims were former district panchayat Preliminary reports suggest

that the violence erupted when former district panchayat member Prem Yadav was beaten to death in Lehra Tola of Fatehpur Monday morning. Subsequently, an enraged crowd gathered at the house of the accused and murdered Satyaprakash Dubey in revenge. The fury of the mob did not subside there, as four innocent people from Dubey's family,

including his wife Kiran Dubev

(52), daughters Saloni (18) & Nandini (10), and son Gandhi (15), were also killed.

The mob did not spare Satyaprakash's 8-year-old child Anmol either and attacked him. His condition was said to be crit-

Chaos engulfed the entire village, prompting a swift response from the authorities. A huge number of police personnel were despatched to the scene to restore peace and collect crucial evidence. Special Director General of

Police, Law and Order, Prashant Kumar said that Yadav visited Satyaprakash's house where a heated argument between them resulted in the killing of the former and some of his family members by Satyaprakash's family using a sharp weapon. In retaliation, Satyaprakash's house was attacked by people from Prem's neighbourhood. The mob used sharp-edged weapons and also opened fire with country-made pistols to eliminate Satyaprakash's family.

Taking to X (formerly Twitter), Chief Minister Yogi Adityanath extended condolences to the kin of the deceased and said that the culprits would not be spared.

"I have directed the ADG, commissioner and IG to reach the spot and take stern action against the accused. I have also asked the district administration to provide for the proper treatment of the injured. The culprits will not be spared," he posted.

## **Opposition parties flay govt**

he Communist Party of India (Marxist-Leninist) will send a delegation to Deoria to prepare a ground report of the horrific incident of mass murder.

In a statement issued on Monday, CPI (ML) state secretary Sudhakar Yadav said that the Deoria massacre has shown a mirror to the UP government over its tall claims on law and

"Six people were murdered and the police and administration remained unaware of the incident. Only a few days back in Kaushambi, three member of a Dalit family were shot dead. In this case too, a land dispute claimed the lives of innocents as the district administration let the tension between both the parties escalate. While the embers of Kaushambi's incident are yet to die down, the Deoria incident has come as a chilling reminder. It seems that the UP has been caught in a trend of mass murders under the BJP government. The government has failed, but still it does not miss a chance to pat its back. The Deoria incident should be investigated and accountability should be fixed, the CPIML leader demanded.

Meanwhile, Communist Party of India (Marxist), UP unit, condemned

leaders claimed that the state was in the grip of viral fever and dengue. "People suffering from fever are dying due to lack of beds, doctors and nursing staff in hospitals. Despite doing rounds of three government hospitals in the state capital, a child suffering from fever could not get treatment and died," the leaders said.

They pointed out that in the prime minister's parliamentary constituency Varanasi, scores of patients were being returned from hospitals without being given treatment as

there was a lack of beds.
"The BJP government of Uttar Pradesh makes tall claims about health services but the ground reality shows that their claims are hollow," the CPI(M) said, demanding availability of adequate stock of medicines, additional beds, doctors and

nurses in hospitals. Meanwhile, in a scathing attack on the BJP government in UP over the Deoria incident, Aam Aadmi Party state incharge and MP Sanjay Singh said on Monday that the even on Gandhi and Shastri Jayanti, six people were brutally murdered, exposing the tall claims of the police and administration. Earlier, he paid tributes to Mahatma Gandhi and Lal Bahadur Shastri.

Singh said both the great

political figures are known for non-violence, love and brotherhood. "It is a sad day today as six people were brutally murdered in Deoria," he said, He also cited several other incident of crime.

"All the claims of the chief minister regarding law and order have been exposed. Is this the improvement in law and order that the CM talks about? The CM holds review meetings everyday, but now it is time for action to ensure law and order in the state," Singh

Spokesperson of Rashtriya Lok Dal's UP unit Ankur Saxena said that "the law and order mechanism in the state has virtually collapsed."

Congress also took to X to attack the Yogi Adityanath government. In a post from the official account of the UP Congress Committee, the party said, Six people have been killed in a land dispute in Rudrapur, Deoria. The law and order of the state has become so bad that even in small disputes, six people are killed openly without fear. There is neither fear of law, nor its respect."

"The Yogi government has transformed this state into such a crime zone that women sitting at home, children, youth and elderly people are not safe, the Congress said.

In the recent meeting, discussions centered around how to rekindle the trust of the Dalit community and garner their support once again in the 2024 elections.

UP boasts of a Dalit population of approximately 22%. Jatavs comprise 54% of the total Dalit population. The population comprises Pasi, Dhobi, Kori, Khatik, Dhanuk, and others.

The BJP acknowledges that the Dalits have consistently supported the party since 2014, leading to its continuous ascent to power. As for the Jatav vote bank, it is perceived as a core stronghold of Mayawati's Bahujan Samaj Party (BSP).

In the 2022 assembly elections, despite securing only one seat, BSP garnered 12% of the vote share, with Jatavs bank being its predominant voters. Consequently, the BJP is particularly keen on winning over this critical vote bank.

The objective is to connect with the residents of these settlements, understand their concerns, and address them effectively, thus strengthening the BJP's appeal within the Dalit community.

Additional Superintendent of Police Satyam said that Santram Rajpur (52) of Karhara area of Charkhari kotwali, committed suicide by hanging himself in his house in Khurd village.

Santram's brother Sandeep said that Santram was struggling with the financial crisis and also had to repay the loan of Rs 1.88 lakh. On Monday morning he had gone to the fields aand was deeply shocked to see the damaged groundnut crop.
Santram's brother, Sandeep,

mentioned that Santram was grappling with a financial crisis ad a loan of Re 1 88 lal to repay. On Monday morning, he had gone to the fields and was deeply shocked to see the damaged groundnut crop. He returned home and locked himself in his room and hanged

himself from the ceiling.

Meanwhile, the ASP said that 35-year-old young farmer Gulab Basor committed suicide by hanging himself in his house late night in Churari village of Kulpahar Kotwali on Sunday. However, the reason for the suicide is not clear. The police is investigating the matter.

In another case of suicide reported from Turra village in Panwadi area a dead body of 62vear-old farmer Dillipati Ahirwar was found hanging from a Chilla tree in Pathwa.

behind Dillipati's suicide. After the suicides, there is an atmosphere of panic in the district. ADM Ram Prakash said that revenue employees had

been instructed to assess the financial condition of all farmers and assistance would be provided to their families. Meanwhile, in the Akbarabad area of Dhanari in

Sambhal, a tragic incident occurred when a couple and their son were electrocuted by high-tension current while working on connecting wires in the electricity board. Farmer Shauraj Singh (45) died in the accident while his wife Bhuri (42) and son Ramkhiladi (18) sustained serious burns.

In a separate incident, a man was killed while another was seriously injured after being run over by a train while trying to cross a track, police said on Monday. Saheb Yaday (65) was killed on the spot after being hit by the Delhi-Varanasi Shiv Ganga Express at around 11:30 pm on Sunday at the Etawah railway station Guddu Ram was seriously injured while trying to save him, GRP incharge Shailesh Kumar said.

#### Govt's proactive measures helped in flood relief in UP PNS LUCKNOW

the CM said.

The Uttar Pradesh govern-I ment distributed 69,726 foodgrain packets and 4,65,048 lunch packets in the floodaffected districts of Uttar Pradesh and set up 1,310 flood relief centres across 84 tehsils in 20 severely affected districts. Additionally, over 2,647 medical teams were formed to provide essential healthcare services to people in the flood-hit districts.

Yogi had held a review meeting even before the onset of monsoon to prepare the administration for floods and conducted aerial and ground inspections later on to assess the damage and provide relief to people living in the flood-affected areas.

According to the data of the Indian Meteorological department, 13 districts of Uttar Pradesh have experienced excessive rainfall this year, exceeding 120 per cent of the expected rainfall, between June 1 and September 15. Most of these districts are situated in western Uttar Pradesh. Additionally, more than normal rainfall (120 to 80 per cent) has been recorded in 24 districts of the state, including those in western and central UP, and Bundelkhand. Meanwhile, 31 districts have

received normal rainfall, ranging from 40 to 80 per cent. On the contrary, seven districts have received less than normal rainfall, amounting to less than 40 per cent. Relief commissioner GS Naveen Kumar said that Chief Minister Yogi Adityanath had held a review meeting on flood relief efforts even before the onset of monsoon. During the meeting, the CM emphasised on the need for being prepared to provide comprehensive assistance to both people and livestock in the flood-affected areas.

Yogi further directed the officials to make thorough preparations in advance to minimise the loss of life. All these efforts resulted in massive relief works in the 37 flood-affected districts of the state, leading to minimal loss of life. The relief commissioner said that 37 districts experienced higher-thannormal rainfall, with 34 districts being directly impacted by floods. Among these, 20 districts faced particularly severe flooding, prompting urgent relief efforts. These heavily affected districts comprised 14 of western Uttar Pradesh, including Muzaffarnagar, Bijnor, Farrukhabad, Saharanpur, Agra, Amroha, Meerut, Baghpat, Mathura, Shamli, Badaun, Gautam Buddha Nagar, Shahjahanpur, and Ghaziabad.

Additionally, five districts in the Awadh region, including Barabanki, Kheri, Hardoi, Gonda, and Sitapur, were affected by floods. Purvanchal's Basti district also witnessed significant flooding. In order to provide relief to five lakh people residing in 1,287 villages across 84 affected tehsils in these districts, a total of 1,310 flood posts were established. Additionally, 2,647 medical teams were deployed to address medical-related issues. To ensure that flood victims did not face food shortages, 69,726 food packets were distributed during this period, along with 4,65,048 lunch packets.

Among the districts heavily affected by floods, Farrukhabad ranked first, with 75,453 people from 116 villages affected by it. In response, 52 flood posts were established and 1,003 medical teams were formed, he added.

### Semi-nude body of woman recovered

According to the information, Ram Bahadur, a resident of Denudha village in the Raipura police station area, works as a security guard in Rajkot, Gujarat. His wife, Rinki Gupta (30), used to reside at home with their three sons and brother-in-law Basant. On a fateful day, her sons had gone to a neighbour's house to play.

The police recovered the knife and sickle lying at the spot and sent the body for postmortem. The police are expressing suspicion on the family.

Meanwhile, in a horrific incident, the body of a 30-yearold woman was found in three pieces in a field on Sunday. The torso was wrapped in a mattress and stitched with a plas-

tic rope, while the legs were found in two trolley bags in a nearby paddy field.

The villagers, after experiencing a foul smell, informed the police. Barhaj circle officer reached the spot and sent the body for post-mortem. The victim's identity is yet to be ascertained.

Meanwhile, in another killing in Aligarh, a man died after being allegedly assaulted by his neighbours, whom he had accused of molesting his daughter, according to the police.

In another incident, a man killed his wife after she refused to transfer her ancestral land in his name. The police said that Akhilesh (27) of Nehru Nagar in Lalitpur, was detained for killing ĥis wife Aarti (24) on Sunday.

According to Lalitpur Superintendent of Police Mohammad Mushtaq, Aarti refused to transfer the land on Akhilesh's name. In a fit of anger, he struck Aarti with an iron tawa, leading to her death. The SP mentioned that the body was sent for a postmortem, and the accused was subsequently arrested.

## **Power play**

Mamata sends her troops to Delhi to embarrass the Centre over non-payment of dues

hile the BJP brass is busy formulating strategy for the upcoming Assembly elections in five States and meeting voters there, the wily West Bengal Chief Minister Mamata Banerjee has unleashed a 4,000-strong contingent in Delhi under her TMC MP and nephew Abhishek Banerjee's charge. Mamata's party leaders and cadres are here for a two-day protest rally to highlight the NDA Government's apathy towards non-payment of Central scheme funds to the State's workers. Interestingly, while the BJP is seeking action in the poll-bound States, Mamata has brought her fight right at its very doorstep and fired the Capital's political atmosphere. The rally has garnered attention for several reasons, ranging from demands for the release of funds to the TMC's clash with the Enforcement Directorate (ED). Another interesting point remains as to why Mamata chose to hold her mega show of strength in faraway Delhi and what the BJP feels about it. The two-day protest in Delhi was prompted by mounting concerns



over the Centre's alleged neglect of West Bengal's development and the delay in releasing funds for vital schemes like the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA). Thousands of TMC leaders and supporters descended on the national Capital with a resolute mission — to voice their grievances against the Central Government.

On Gandhi Jayanti, the TMC MPs embarked on a sit-in at Rajghat to highlight their dedication to the principles of Mahatma Gandhi. The peaceful rally followed with TMC supporters and MGNREGA job card holders marching together to air their concerns. However, it was not a smooth ride for the TMC cadres from

Bengal to Delhi, with them facing unexpected hurdles. Initially, a special train was booked for the TMC supporters and MGNREGA job card holders, along with the party's 'panchayat pramukhs'. But the Railway Ministry abruptly cancelled the train, forcing the TMC to arrange for private buses to transport its supporters. Adding to the intrigue, the Enforcement Directorate summoned Mamata's nephew and party's number 2 leader Abhishek Banerjee for questioning on October 3, coinciding with the rally. Abhishek, however, has chosen to ignore the ED summons. As the rally unfolds, the nation awaits the outcome of this high-stakes showdown between the prominent parties. Though Mamata is challenging the BJP in the Capital, she has a lot to answer to people in her home State as there have been alleged irregularities in the disbursement of MGNREGA salaries by her Government, besides numerous cases of misappropriation of such funds. Union Minister Smriti Irani has also questioned the rationale behind the rally as TMC has failed to ensure even the minimum wages to tea garden workers in North Bengal. The BJP Minister is currently in Bengal, where she met tea workers in Siliguri. On the other hand, Mamata is a strong leader in her State and an important member of the INDIA bloc; her message in Delhi is indeed something the BJP must be watching very carefully.

# BJP-AIADMK split: What next?



The AIADMK-BJP split does not augur well for the BJP which is trying hard to get a foothold in southern India

ould the split between the AIADMK and BJP be permanent? If so, this could hurt the BJP's chances of winning in Tamil Nadu since the AIADMK had supported them since J Jayalalithaa's passing in 2016. The decision to end its partnership with the NDA on a national and state level may put the BJP at a disadvantage.

The future political landscape could have an impact on the upcoming 2024 elections. It could cause a shift in power among Tamil Nadu parties and their alliances. This may result in the AIADMK losing the support of the Modi government, which has acted as a powerful ally.

According to experts, the separation between the BJP and AIADMK is expected to be temporary. The leaders of both parties have advised their members to refrain from making negative comments about each other. The BJP seeks more support in the Southern region and hopes to secure additional seats through partnerships.

Last week, former AIADMK minister Munuswamy announced that his party is severing ties with the BJP and NDA. He accused the BJP state chief, Annamalai, of deliberately tarnishing the reputation of respected party members, including former Chief Ministers CN Annadurai and Jayalalithaa.

The decision may have a significant impact on state and national politics. AIADMK is the lone major partner of the BJP at the national level. Previously, NDA included bigger parties like Shiv Sena, Akali Dal, Telugu Desam, and AIADMK. Still, now only AIADMK remains in the alliance. For the BJP, the loss is more significant. Despite earnest efforts, it has not established a substantial presence in Tamil Nadu — the power switches between the DMK and AIADMK since 1967. The AIADMK has ruled 30 out of their 50 years.

Tamil Nadu has two main political parties: AIADMK and DMK. AIADMK is a popular party with a large membership of two crore people, and it offers an alternative to DMK. The DMK



faced a tough challenge in winning over voters in Tamil Nadu. The Dravidian movement started by EV Ramaswamy Naicker has taken deep roots in the form of DMK and AIADMK parties. The party only secured 3% of the vote in the last Lok Sabha elections. In comparison, the two Dravidian parties had a solid 25% Since 2016, the AIADMK

party has experienced continuous defeats in all elections. It has no charismatic leaders like Jayalalithaa or founder MG. Ramachandran — both matinee idols. The party's performance in the most recent Assembly polls in 2021 decreased the seats won, from 136 to 75. The DMK-Congress coalition took control of the government. In the 2019 Lok Šabha polls, AIADMK only secured one seat, a significant drop compared to their previous 37. Meanwhile, the DMK coalition's seats increased from 0 to 39. ## Orders by Govt officers are for the larger good



It is imperative to abide by just orders promulgated by Govt servants in public interest and any objection to such orders, must be through legal channels

That we often come across is the law of contempt concerning courts. It may pertain to maligning the reputation of the judiciary or for that purpose obstructing the functioning of the court. The law of contempt concerning court has now been well established and the educated section across the country mostly have a rough idea about the same if they keep themselves informed by print or electronic media, including social media.

This article aims to bring into the limelight the less known and less discussed issue, which is disobedience of orders that are duly promulgated by government authorities. We have witnessed such orders during an unprecedented time of covid pandemic. As a citizen, we are at the centre of such orders. For brevity of our understanding, I should inform you that such orders are being promulgated under various acts, one such being the Epidemic Disease Act of 1897. Under the said act, Sections 2 & 2A, give powers to the state government and central government respectively to take such decisions and pass such orders which may help contain the infectious disease. Section 3 of the Epidemic

Disease Act imposes a penalty for disobeying any order or regulation made under this act. It makes the act of disobeying or abatement punishable under section 188 of the Indian Penal Code. For instance, if we take the step of price capping by the respective state governments on the treatment of COVID-19 in private hospitals, passing an order under this act or any other act for the time being in force, they impose a duty on private hospitals not to charge above the limits fixed by government authorities.

If private hospitals are charging more than the limit imposed by the government, they are inviting prosecution u/s 188 of the Indian Penal Code i.e., Disobedience to an

order duly promulgated by a the prescribed amount (as public servant. Bombay High Court in the case of HLA Shwe v. State of Maharashtra peeled section 188 and mentioned its ingredients as follows - The order must be duly promulgated by a public servant authorised to do so; The order directs the accused to abstain from certain acts; ministry that promulgated Accused was aware of such order; Accused disobeyed such order and lastly, such disobeying resulted in obstruction, annoyance or

This section is part of chapter X of IPC which deals with contempt of lawful authority of public servant. Prosecution under this is slightly different to that of other offences where the victim himself/herself reports the crime to police officials. Cognizance under this chapter X of IPC can only be taken under section 195 of the Criminal Procedure Code (CrPC) which requires a written complaint by a public servant concerned or of some other public servant to whom he is administratively subordinate. This means, that if a person 'X' is aggrieved that he has been charged more than

prescribed by the government during covid times) in a private hospital for Covid19 treatment, he cannot directly report that to the police station and ask the police to register FIR under section 188 of IPC, but he needs to report the same to the official or such order and it will be upon the written complaint of such ministry or official that an action can be brought against the private hospital under section 188 of IPC

In India, we very well know that crimes often are not reported by individuals because of a lack of awareness which further encourages the wrongdoer, initiative should be taken by the government to check the implementation of their orders. This can be done by audits and taking the views and experiences of the intended beneficiaries of those orders. Therefore, for a peaceful society to exist, it is imperative to abide by just orders promulgated by public servants and any objection to such orders, should only have legal recourse.

# Timeless traditions: Thathera metal craft



Thathera metal craft has been on the UNESCO list for almost a decade now, but the struggle of the artisans making these utensils continues



espite the UNESCO Intangible Cultural Heritage inscription of the thathera craft of Jndiala Guru since 2014, the financial and social condition of the craftsmen has not improved much. Recognising the cultural heritage worth of the 'thathera' metal craft in Jnadiala Guru, in its 9th session held in Paris in 2014, UNESCO 'Intergovernmental Committee (IGC) for the Safeguarding of Intangible Heritage' decided to inscribe the craft on its list. This is the first metal craft from India to find a place in UNESCO's Intangible Cultural Heritage list. Thus, not only Punjab but India should be proud of it. "But just the pride cannot feed the craftsmen and keep the craft vibrant", says a craftsman seeking anonymity.

S Hardev Singh of the 'father' community says, "The younger generation is opting out of this family profession because it neither earns money nor respect. Although Ayurveda recognises the advantages of eating in copper, bronze and brass utensils, the 'use and throw' cheaper alternatives are pushing it out of use". Instead of popular cosmetic measures, the government should take concrete steps of waiving taxes and continuing the old quota system of issuing scrap as the raw material directly and only to the working craftsmen to reduce the cost and prices of objects to face the competition. Further, it can help market the products as art pieces and utilitarian objects. The government can check the entry of middlemen who buy raw materials from the Indian Army on auction and then distribute them among the craftsmen to produce objects for them at low labour rates. "In the current practice, a craftsman has no claim of ownership of the product and after the day-long hard work earns only 500-600 a day", a craftsman quips. He asks, "Is this the value of skill or the wage of labour? How would my son like to pursue this profession"?



THE SCIENCE OF AYURVEDA IN INDIA **RECOGNISES** THE RELEVANCE OF THESE **METALS** FOR HEALTH

Recently, the Punjab government has declared the Thathera Bazar a Heritage street and built a gate at the street entry symbolising the value of the craft, but has neither waived off its share in GST nor taken any serious steps to help them improve their condition. The question is how the gate and the heritage street status would help if there were no craftsmen in the street.

The UNESCO recognition has, of course, created some hype in the media. Some agencies have succeeded in getting the study projects sanctioned adding to their profiles and justifying their jobs but have not advocated the case forcefully enough to deliver at the ground. Some art and craft dealers have tried to reap benefits by tagging the products with UNESCO recognition to sell them at premium prices while the craftsmen continue to work as labourers at low rates.

This is where the shoe pinches and the government should step in to save the craft, the craftsmen and the cultural heritage of the state. The thathera craft is practised at several other places in India but the uniqueness of the craftsmen in Jandiala Guru is their continuance as a community to practice the family tradition of handmade copper and brass utensils. The ten to twelve-generation tradition of fathers in Jandiala Guru and their craft is a journey of place and people in and through time. The knowledge systems transmitted from generation to generation and the continued relevance of their products to the people make the craftsmanship a 'living tradition', fulfilling the three-tier criterion of 'people, place and time' to identify the craft as the Cultural Heritage.

According to the Amritsar District Gazetteer of 1883, "Besides the city [Amritsar]...the only trade centre worthy of notice is the town of Jandiala, which is known for its manufacture of brass and copper vessels in which it has a brisk export trade"(p.117). If so, the trade perfected worthy of export must have started during the days of

Maharaja Ranjit Singh or before.
While the utensils are tangible objects, traditional knowledge, skills and its knowledge conventions tory. have been recognized in the UNESCO inscription. The craftsmen of Jandiala Guru use the conventional knowledge and skills of 'forging' instead of 'casting' metal to shape it as a utensil. Using the method of forging, they hammer the metal plates with the help of a mallet. After heating the plates in a small hand-driven furnace, they consistently thump and beat a plate to make it malleable and ductile.

Then the parts of a utensil are made by cutting, heating and curving the metal sheet; then these parts are joined with each other. There are five methods for joining of metals: soldering, brazing, flux, riveting and welding. The fathers of Jandiala Guru use brazing and riveting. Brazing is a process of joining two or more metals by pouring a molten filler metal into the joint. The utensils made from the metal sheets are then cleaned with diluted acid and scrubbed with tamarind water and sand. The whole process of polishing is carried out with hands and feet. This final process brings out the rich texture and colour of the metal. Finally, the utensils are ornamented with hand-engraved designs with patterns of delicate dents of small size and round shapes looking like small stars.

Utensils are art objects "produced not only for their use but also for their beauty possessing an artistic image which expresses their function". Thus the contribution of craftsmen to the development of culture and civilization, on the one hand, and to the fulfilment of utilitarian and aesthetic needs, on the and art are intangible. Pood insecurity, hunger and environmental degradation are being aggravated by food loss and waste, globally. The Food and Agriculture Organization of the United Nations (FAO) estimates that — in terms of economic value — 14 per cent of the world's food is lost from post-harvest up to, but not including, the retail level. In India, 4-6 % of cereal and 5-12 % of vegetables are being lost every year.

FAO on the fourth International Day of Awareness of Food Loss and Waste (IDAFLW), calls upon the need to adopt the Food Loss Index (FLI) methodology and monitor losses throughout the supply chain from production to consumption. In collaboration with FAO, IASRI-ICAR

has estimated the FLI for socio-economic factors. To India. These estimates are based on the three nationallevel surveys conducted by the Ministry of Food Processing Industries to estimate the harvest and post-harvest losses of major crops and commodities in the country. India has been a torchbearer for the world as the only country that has established a robust system of regular surveys for monitoring food losses. These surveys conducted in India have provided the foundations for the development of the FLI methodology globally and for the technical support, FAO provides to countries across the world.

Food loss is a recurring issue due to several causes stemming from different stages of the food supply chain and

interventions. Food loss is a global challenge. Countries must adopt the globally agreed methodology and measurement techniques for the computation of FLI which also provides a platform for global comparability and cross-learning opportunities. Reducing food loss will

help conserve resources and reduce the environmental footprint associated with food production and disposal. FAO firmly believes that India as the leader for the Global South can address this issue and demonstrate a way forward in reducing food loss that is essential to achieving efficient, inclusive, sustainable, and resilient agrifood systems for better production, better nutrition, better environment, and a better life, leaving no one behind.

"It has come to notice that Arsh Dala has formed an association with USA-based Gurpatwant Singh Pannun of



Sikhs for Justice. It has been learnt that Arsh Dala and Gurpatwant Singh Pannun have colluded to carry out suspicious activity in Gurdaspur in

Punjab," the report said. The dossier further said, "Previous activities of Gurpatwant Singh Pannun suggest that he might look to hoist pro-Khalistan flags and ings and other public places but his collusion with Arsh Dala this time suggests that they might try to carry out some ter ror activity."

Dala, according to the National Investigation Agency (NIA), has been operating from Canada for the last three-four years and allegedly executed many killings in Punjab over the last few years. "He has been guiding and commissioning

## Personal consumption, possession of e-cigarettes violation of law: Ministry

In the wake of no let up in cases of air travellers arriving with e-cigarettes at various airports in the country, Union Health Ministry has clarified that its personal consumption as well as possession of any such devices in any form, quantity or manner is in violation of the Prohibition of Electronic Cigarette Act (PECA) 2019.

The clarification was sent to the Ministry of Civil Aviation (MCA) last month, official sources said, adding it will strengthen the enforcement of the ban.

There has been cases of consification of vaping devices from travellers passing through Mumbai, Bangalore, Chennai, Kolkata, Delhi and Bhavnagar airports. The travellers argue that they had purchase them for personal use.

The ministry said that though there is no explicit mention of prohibition of individual use of e-cigarette in PECA, the law has been enacted to prohibit the production, manufacture, import, export, transport, sale, distribution, storage and adver-

tisement of e- cigarettes. "Therefore, possession of

e-cigarette within the country in any quantity is not possible without contravening the provisions of PECA, 2019," said Dr Pulkesh Kumar, Deputy Secretary, Ministry of The ban includes a pro-

hibition on all forms of Electronic Nicotine Delivery Systems, Heat Not Burn Products, e-Hookah and similar devices. The law was enacted in

the interest of public health and to protect the people from harm, the health ministry said. Despite heavy penalties

and imprisonment, e-cigarettes are reported to be widely available across a range of sources including tobacco vendors, general stores, and online providers.

The health ministry has also launched an online portal to facilitate reporting of violations under PECA. This portal will allow the ministry educational institutions.


## India scouting for indigenous POC test for antibiotic resistant typhoid strains

Grappling with two highly antibiotic resistant strains of typhoid fever, India is now scouting for indigenously developed improved point of care (POC) test that can help distinguish the duo variants so as to ensure effective management of the life-threatening dis-

In this connection, the Indian Council of Medical Research (ICMR) under the Union Health Ministry has invited expression of interest (EOI) from the manufacturers and research institutes for development of diagnostic In Vitro kits for diagnosis of the

drug resistant strains. The move follows concerns that existing typhoid diagnostic tests, such as the Widal test, TUBEX, Typhidot, and Test-It (KIT), have shown sub-optimal sensitivity and specificity to the two serovars namely Salomenella. Typhi (S.



Typhi) and Salmonella enterica serovar Paratyphi (S. Paratyphi) which have become resistance to many antibiotics.

Moreover, the S Typhi and Paratyphi strains are indistinguishable, thus making it crucial for clinicians to differentiate between them before starting antibiotic therapy due to their different antibiotic susceptibility profiles, said an ICMR scientist on the need for

next generation in vitro kits. There is an urgent need for indigenously developed, improved typhoid POC tests

that offer higher sensitivity and specificity. Such tests would enable healthcare professionals to promptly and accurately diagnose typhoid, leading to more appropriate and targeted treatment, which in turn, could result in better patient outcomes and reduced

While the morbidity and mortality of S. Typhi make it a greater public health concern, the increasing prevalence of S. Paratyphi in certain regions necessitates a next-generation

antibiotic misuse," further

added the scientist.

diagnostic test capable of detecting both the strains, she explained.

Improved disease diagnostics will support the government in guiding interventions program efforts to prevent the diseases, said the ICMR scientist on the need for the next generation detection kit.

"S. Typhi, the bacterium responsible for typhoid fever, has developed resistance to multiple antibiotics, including three firstline agents. India is bearing a high burden of the disease. It is estimated that there are 11-21 million cases of enteric fever worldwide each year, resulting in 120,000-160,000 deaths.

"Due to lack of proper diagnosis and heterogeneity of disease, the exact burden of disease is unclear but extrapolation of regional data estimates 586 cases per 100,000 personyears typhoid/paratyphoid inci-dence in India," said the sci-

# India to clock 6.5% growth in FY24: Rajiv Kumar

⊣he Indian economy will grow at around 6.5 per cent in the current fiscal as the country's macroeconomic situation is benefiting from the reforms that have been taken up in the last nine years by the Narendra Modi-led government, former NITI Aayog Vice Chairman Rajiv Kumar said on Monday.

Kumar further said that India needs and can grow at 8 per cent-plus as that level of economic growth is required to meet aspirations of the country's young population and to generate sufficient jobs for its workforce. "My growth projection (of

India's GDP growth in FY 2023-24) is 6.5 per cent. "And I think we can easily maintain this (growth) over the next few vears," he told PTI in an inter-

India's GDP growth in 2022-23 was 7.2 per cent, lower than 9.1 per cent in 2021-22.

According to Reserve Bank of India's projections, India's GDP is likely to grow at 6.5 per cent in the current fiscal year.

Kumar further said, "Macroeconomic situation India is benefiting from the reforms that have been implemented in the last nine years. Therefore, both the external macroeconomic balance as well as the domestic ones are in good

shape." He said that India's current account deficit is manageable, the country's foreign exchange reserves are sufficient to cover about 11 months of imports and the foreign direct investment flows are continuing.

On the domestic side,

Kumar said inflation is beginning to come down to the target levels and the government tax revenues have shown a good 16 per cent increase over last year. "So, this will take care of the fiscal situation and lead to fiscal consolidation. As a result of this improvement, the rating agencies have improved their ratings and JP Morgan has included India in its international bond indices," he said



According to Kumar, the only weakness that he sees is that the private corporate investment is not yet responding in the manner that "we would expect, but that also is beginning to improve as demonstrated by

the increase in bank credit growth over the last six months".

Expressing concern over decline of India's exports between April and August by about 11 per cent compared to the same period last year, he said,

tion which is that India's export performance is strongly correlated with the global trade perfor-

Kumar pointed out that as the global trade has weakened, India's exports performance has also weakened given the weak demand in Europe, the US and other developed economies.

"We have to change this. We must do whatever we can to ensure that our exports have a greater share of world markets," he said.

On some US-based economists' claim that India is overstating economic growth, Kumar said that the Ministry of Statistics and Programme

Implementation (MoSPI) must take a firm position and give enough reasons as to why they are using the wholesale price index (WPI) deflator and not the Consumer Price Index (CPI) as

"And that needs to be firmestablished once and for all," Kumar emphasised.

GDP deflator.

Meanwhile, India's real GDP growth was 7.8 per cent on a year-on-year basis in Q1 FY24, as per the Income or Production Approach.

Recently, former chief economic advisor Arvind Subramanian, in an article, argued that India's GDP is not measured from the expenditure side and measured only from the income side. This tends to over estimate GDP growth.

Last month, chief economic advisor V Anantha Nageswaran rejected criticism of "statistical discrepancy" in the first quarter GDP data, saying when the same statistical authority reported the severest contraction in the first quarter of 2020, the naysayers had called it credible as it suited their narrative.

The article by Nageshwaran was written in light of debates over India's economic performance and economist Ashoka Mody, a Princeton University professor, raising concerns regarding the country's GDP growth rate for the first quarter of the financial year 2023-24.

## Lava eyes 10% smartphone market share in 2 years with investment of ₹600 crore in R&D, marketing

Home-grown mobile devices maker Lava International expects to capture 10 per cent market share in under Rs 30,000-priced smartphone segment on account of up to Rs 600 crore investment in product development and marketing in the next two years, a senior company official said.

Lava International President Sunil Raina told PTI that at a time when several Indian mobile phone companies succumbed to the pressure of aggressive pricing of foreign players around 2016-17 coupled with challenges posed by demonetisation and GST implementation, Lava focussed on its

core strength and re-worked on the growth strategy.

The company relaunched its smartphone business with a small pause with focus on customer experience around devices and providing repair service at home, Raina said.

He said that the company has realised that technology has to be competitive for growth along with visibility. "With branding and product development, we will invest Rs

500-600 crore in the next two years with a large part of it will go in product development," Raina said.

He said that the company has decided not to load smartphones with bloatware — which are pre-loaded apps on mobile

"We have decided we will not put out any bloatware in the phone. We have taken some hit on what could have been earned from bloatware only because we don't want to compromise on consumer experience. I also believe that bloatware is going to be short-lived because consumers don't like it and what consumers don't like doesn't last long," Raina said.

He said that consumers are very unhappy about bloatware because they get irritated with unwanted advertisements, unwanted notifications and bloatware makes devices slow and very vulnerable to security

Raina said most of the brands are not providing software updates on the devices that patch security loopholes and improve performances of the

"In the last 2-3 years, we have not missed any single update," he said.

Raina said that the company has over 800 service centres but still decided to come up with "service at home" where the company sends engineers to the home of consumers for

"In Agni 2, we have gone a step ahead and started giving replacement at home if their is any hardware fault," he said.

While the India smartphone market has recorded continuous decline in shipment since April 2022, Raina said that with new strategy Lava's smartphone business grew over 200 per cent last year and this year it is growing

at the rate of 300 per cent.
"We expect to grow by 100 per cent on average in the next 2-3 years. Our plan is to get 10 per cent market share in sub-Rs 30,000 price range smartphones. Right now we have around 2 per cent share," he said.

Lava president said that the company will leverage its retail channel strength as well as boost online growth to meet the tar-

The company at present sells products through 1.2 lakh retail stores which largely include feature phones only. Lava claims to have 25 per cent share in the feature phone

segment. "We will fully leverage our offline strength. As of now we sell our product through 1.2 lakh retailers. Smartphones are not present in the entire 100 per cent of that universe. We will look at taking smartphones to most of the outlets and strong presence across all geographies in the country," Raina said.

Lava also plans to strengthen online business to meet its target. "Online earlier used to account for 10 per cent of our total sales. Now online contributes 25 per cent of our total which we will grow further,"

## Remarkable 5G adoption drives India's global speed ranking 72 places higher, says Ookla

The mobile download speeds in India have seen significant boost with launch of 5G services, and the country has climbed 72 places higher to clinch 47th spot in Speedtest Global Index, according to Ookla.

This puts India not only ahead of its neighbours like Bangladesh, Sri Lanka, and Pakistan, but also some G20 countries, such as Mexico (90th), Turkey (68th), the UK (62nd), Iapan (58th), Brazil (50th place), and South Africa (48th place).

India's speed performance has seen a 3.59 times increase since the introduction of 5G, with median download speeds

improving to 50.21 Mbps in August 2023, from 13.87 Mbps

in September 2022. This improvement has led to India's rise in the Speedtest Global Index, moving up 72 places, from 119th place to the 47th position," it said.

The 5G deployments have led to an improved overall user experience across all telecom circles with operators investing in backhaul infrastructure.

The launch of 5G technology by operators like Reliance Jio and Bharti Airtel has led to a substantial increase in 5G subscribers, and operators still have ambitious roll-out plans, with the deployment of a significant number of 5G base stations

across the country.

In fact, 5G has not only brought faster speeds but also higher customer satisfaction, as indicated by the Net Promoter Score (NPS), which shows that 5G users in India consistently rate their network operators more positively compared to 4G

#### Sebi extends deadline to confirm or deny market rumours

Capital markets regulator Sebi has extended the deadline for mandatory confirmation or denial of market rumours by listed companies.

The deadline has been extended for the top 100 listed companies by market capitalisation to February 1, 2024, from October 1 this year at present, according to the latest circular by the Securities and Exchange Board of India (Sebi).

Similarly, for the top 250 list-

ed entities, the rule will kick in on August 1, 2024, from the current requirement of April 1,

The rule is aimed at strengthening the corporate governance of listed entities. "It has been decided to

extend the effective date of implementation of...The LODR (Listing Obligations and Disclosure Requirements) rules for top 100 listed companies by market capitalisation to February 1, 2024, and for top 250 listed companies by market



capitalisation to August 1, 2024,' Sebi said.

Earlier in June, Sebi notified rules asking these listed companies by market capitalisation to confirm, deny, or clarify any market rumour reported in the mainstream media.

As per the disclosure requirements, these companies will have to "confirm, deny or clarify any reported event or information in the mainstream media, which is not general in nature and which indicates that rumours of an impending specific material event" are circulating amongst the investing public within 24 hours from the reporting of the information.



#### WhatsApp bans 74 lakh accounts in August

#### grows 10.7% to 140.49 billion units in September

The country's power consumption grew 10.7 per cent to 140.49 billion units in September mainly due to increased use of cooling appliances amid unusually humid weather conditions.

In the year-ago period, power consumption stood at 126.91 Billion Units (BU), higher than 112.43 billion units in September 2021, according to government data.

The peak power demand met — the highest supply in a day — rose to 239.97 GW in September. The peak power supply stood at 199.50 GW in September 2022 and 180.73 GW in September 2021.

The power ministry had

estimated the country's electricity demand to touch 229 GW during summer. The demand did not reach the projected level in April-July due to unseasonal The peak supply, however, touched a new high of 224.1

GW in June and before dropping to 209.03 GW in July. Peak demand touched 238.19 GW in August.

Spokesperson of the Tata Power Delhi Distribution Ltd, which supplies electricity to 70 lakh people in Delhi, told PTI that the demand has remained higher mainly due to unusually higher temperature levels this

The spokesperson said in the coming months, demand is expected to remain on the higher side due to festivities.

Power Delhi Distribution's power consumption was estimated at 1,110 MUs (million units), compared to 1,035 MUs in a year ago.

## Shriram General to diversify: Official

Shriram General Insurance has planned to diversify its product portfolio by focusing more on the non-motor segments like marine, fire, during the current financial year, a top official said. Motor insurance has been

the core of the business for the Jaipur-based firm accounting to about 92 per cent, company Chief Underwriting Officer Shashi Kant Dahuja said.

As part of the diversification plan, the company would launch new insurance products under the fire, marine, engineering segments, he said.

"The idea is to double our non-motor business to around 15 per cent in two to three years from the current 7-8 per cent," Dahuja told PTI in an interac-

The non-motor business was growing at 70 per cent, he To strengthen its presence in

the non-motor business, he said the company would launch products in cyber insurance, pay as you drive, theft and pet insurance, soon.

"As a business strategy we

don't want to be excessively dependent on one vertical and we also want to diversify our products slowly and increase our non-motor portfolio to 15 per cent over the next 2-3 years," he said responding to a query.

For the quarter ended June 30, 2023, Shriram General Insurance reported a profit of Rs 98 crore, up by 37 per cent over the corresponding quarter of last

The Gross Written Premium during the quarter under review was at Rs 560 crore, up by 39 per cent from Rs 401 crore registered in the same period of last year.

On the overall business growth targeted, he said the company has set a plan of growing 30 per cent during the cur-

rent financial year. "This year, we will grow the overall business by 30 per cent. The general insurance industry grew by 12 per cent between April and August this year, but our growth has been strong and



we hope the momentum continues for the remaining months," he said.

On the surge in electric vehicles in the domestic market, he said the sales of EV insurance policies were growing faster and the company issued policies worth Rs 82 crore during last financial year.

"EV is a good business for us. Last year, we wrote policies worth Rs 82 crore, while we have achieved that mark in the first six months of the current financial year, we expect Rs 200 crore in this segment, by the end of this fiscal," he said.

Dahuja said the company was also expanding its employ-ee base with plans to add 700 people during the current financial year.

"The growth in business will be driven by aggressive recruitment of employees and agents. We have 3,780 employees now and will recruit another 700 in the current fiscal," he explained.

The roof of a church collapsed in northern Mexico during Sunday Mass, killing at least 10 people and injuring around 60, authorities said as searchers probed in the wreckage throughout the night and into Monday morning looking for survivors and more victims.

Approximately 30 parishioners were believed to have been trapped in the rubble when the roof caved in, officials

Searchers crawled under the roof slabs and officials brought in dogs to help search for possible survivors.

The Tamaulipas state police said about 100 people were in the church at the time of the collapse.

# Tax cuts ruled out while inflation stays high

Britain's Treasury chief announced a hike in the national minimum wage on Monday, as the governing Conservative Party tries to persuade voters it is on the side of those who are struggling finan-

But Chancellor of the Exchequer Jeremy Hunt ruled out tax cuts, saying they would fuel inflation. "I do want us to have lower taxes," Hunt told Sky News before his speech. But he said "it's very difficult to see" it happening this year. happening this year. That message was not what

many Conservatives at the party's annual conference wanted to hear. Hundreds of them packed a room to applaud as former Prime Minister Liz Truss whose seven weeks in office plunged Britain's economy into crisis — demanded Hunt slash taxes in his fall budget next month. Hunt told the



ence that the hourly rate for workers 23 or older will rise in April from 10.42 pounds (\$12.70) to at least 11 pounds (\$13.40). The exact amount will be set after a recommendation by the Low Pay Commission, an advisory body. Hunt said that will mean a raise for more than 2 million workers.

Hunt also pledged to toughen the rules on social benefits in an attempt to stem the flow of working-age people out of the workforce, a trend that has accelerated since the coronavirus

"Those who won't even look for work do not deserve the same benefits as people trying hard to do the right thing," he said. The party is trying to sprinkle voterpleasing measures such as the pay increase at the conference, which may be the last before a national election due in 2024. But the government's spending power is constricted by the UK's sluggish economy and stub-bornly high inflation that hit double digits last year and now stands just below 7%. Voters are weary after years of political turmoil over the UK's exit from the European Union, the coronavirus pandemic and a cost-ofliving crisis fuelled by Russia's invasion of Ukraine last year. Prime Minister Rishi Sunak, who took office just under a year ago, is facing grumbling — and even open rebellion — from and lawmakers.

Sunak steadied the economy after his predecessor Truss crashed the pound and trashed Britain's reputation for fiscal prudence with her tax-slashing economic plans. She left office after just 49 days.

Many Conservatives doubt whether Sunak — the party's fifth leader since 2016 — can restore its popularity to the level that saw the party win an 80-seat majority in the 650-seat House of Commons in 2019. The prime minister then, Boris Johnson, resigned in mid-2022 amid scandals over his ethics and judg-

In recent weeks, Sunak has sought to take the initiative with a clutch of measures depicted as easing the economic burden on taxpayers. He has delayed a ban on selling new gas and diesel cars and watered down other green measures that he said imposed "unacceptable costs" on ordinary

#### 'At least 13 killed in Spain nightclub fire'

### Fire at Egypt police HQ injures 38

Cairo (AP): A huge fire broke out early Monday at a police facility in northeastern Egypt, injuring at least 38 people before firefighters were able to extinguish the blaze several hours later, authorities said. The cause of the fire, which ripped through the multistory police headquarters in the Suez Canal province of Ismailia, was not immediately

Interior Minister Mahoud Tawfiq, whose ministry oversees police forces, rushed to the site in the city of Ismailia, about 125 kilometres (77 miles) northeast of Cairo. He said a committee was set up to investigate the fire.

Hossam Abdel-Ghaffar, a spokesperson for the Health Ministry, said in a statement that 12 of the injured were treated at the site, while 26 others were taken to hospitals.

All but two suffered from

breathing difficulties; seven of the injured were treated and discharged, he said.

It was not immediately clear how many police were in the building at the time. Local media reported that the police building was severely damaged in the blaze.

## Smoky haze on Indonesia's island prompting calls for work from home

**AP** ■ PALEMBANG (INDONESIA)

More than 300 forest and peatland fires on Indonesia's Sumatra island caused hazy skies across the region on Monday, prompting government officials to ask people to work from home. The military, police and local government were working together to extinguish the fires, which were burning in 316 places across South Sumatra province, but their work was complicated by the extreme dry weather, said Iriansyah, the head of the South Sumatra Disaster Management Agency.

The smoky haze drifted from the fires toward Palembang, the capital of South Palembang province, causing unhealthy air conditions for the area's 1.7 million people. "There is a high potential for people to suffer from tial for people to suffer from respiratory tract infections, coughing, shortness of breath and eye irritation," said smoke from the Indonesian

Iriansyah, who like many Indonesians uses only one name. The government in South Sumatra last week called on schools to delay their opening time, as the haze tends to decrease during the day. But on Monday, the schools asked students to attend classes online, as the air quality had worsened and was categorised as "dangerous". "We are worried as the haze is getting worse in Palembang...Many children are sick and we can only pray that this disaster will pass quickly," Umi Kalsum, a private sector worker and mother, told The Associated Press on Monday.

Forest and peat fires are an annual problem in Indonesia that strains relations with neighboring countries. Smoke from the fires has blanketed parts of Indonesia, Singapore, Malaysia and southern Thailand. Some parts of

fires since last week. Malaysia's Environment Department chief Wan Abdul Latiff Wan Jaffar last week said the return of smog in some parts of the country was due to hundreds of forest fires in Indonesia. "Overall, air quality in the country has deteriorated," he said in a statement. "Forest fires that occur in the southern part of Sumatra and the central and southern parts of Kalimantan, Indonesia have caused haze to cross borders." But Siti Nurbaya Bakar, Indonesia's Environment and Forestry Minister, said in a statement on Monday there has been no transboundary haze from Indonesia to Malaysia. Satellite data from Indonesia's Meteorology, Climatology and Geophysics Agency shows that the haze in Indonésia was in several areas in Sumatra and Borneo islands. Wind direction in Indonesia is generally from southeast to

northwest-northeast.

The decision on the future of the building in Braunau am Inn, a town on Austria's border with Germany, was made in late 2019. Plans call for a police station, the district police headquarters and a security academy branch where police officers will get human rights

training. On Monday, workers put up fencing and started taking measurements for the construction work. The police are expected to occupy the premises in early 2026. A years-long back-and-forth over the ownership of the house preceded

the overhaul project. The question was resolved in 2017 when Austria's highest court ruled that the government was within its rights to expropriate the building after its owner refused to sell it. A suggestion it might be demolished was dropped.

The building had been rented by Austria's Interior Ministry since 1972 to prevent its misuse, and was sublet to various charitable organisations. It stood empty after a care centre for adults with disabilities moved out in 2011.

A memorial stone with the inscription "for freedom, democracy and liberty. Never again facism. Millions of dead remind us" is to remain in place outside the house.

The Austrian government argues that having the police, as the guardians of civil liberties, move in is the best use for the building.

## 'India will help maintaining sites connected to Gandhi in S Africa'

India will assist in maintain-Ling all sites connected to Mahatma Gandhi in South Africa, the Indian envoy here said on Monday as the world marked the 154th birth anniversary of the global peace

On the occasion of Gandhi Jayanti, High Commissioner Prabhat Kumar paid floral homage to the bust of Gandhi at the Constitutional Court premises here, which was once a prison where the Mahatma and his followers served sentences during their resistance to discriminatory laws.

Gandhi served four terms of imprisonment between 1908 and 1913 here, including his very first sentence in South

The bust was unveiled in 2012 by then-President Pratibha Patil when she paid a visit to South Africa. "In all my postings abroad, I have always <del>garlanded the statue of</del> Mahatma Gandhi and now in South Africa, where I am doing so for the first time, it is very special, because Gandhiji was here for 21 years," Kumar said.

After the garlanding, Kumar visited permanent exhibitions at the venue dedicated to the lives of both Gandhi and Nelson Mandela, who served 27 years as a political prisoner of the apartheid government before becoming South Africa's first democratically-elected president in May 1994.

The diplomat said he is also looking forward to attending the installation of a seven-foot statue of Gandhi at Tolstoy Farm, the once-thriving commune established by Gandhi about 30 km south of Johannesburg during his tenure as a lawyer in the city. After falling into complete

disrepair due to vandalism, only the foundation of Gandhi's original zinc and wood home was left, surrounded by tall grass, until interventions by Gandhian activist Mohan Hira and the Mahatma Gandhi



# INDIA MAKE QUARTERS IN ALL SIX TEAM EVENTS

ndian archers showed tenacity and authority in equal measure to storm into the quarterfinals in all the six team events of the Asian

Games here on Monday.

The Indians played five team elimination rounds and dropped just one set on way to their respective quarterfinal matches in both recurve and compound sections.

India have got a bye into the quarters by virtue of topping the qualifications in the women's compound team event.

India remained in contention in all five gold medals up for grabs in compound section with all the four archers — Ojas Deotale, Abhishek Verma, Jyothi Surekha Vennam and Aditi Swami — progressing to their respective individual quarterfinals in the afternoon session.

In the recurve section, Dhirai Bommadevara and Atanu Das advanced, while India's campaign ended in women's individual section, in the only blip of the day.

First, it was the top-seeded compound mixed team of Ojas Deotale and Jyothi Surekha Vennam, who showed the way as they dropped just one point from 16 arrows to eliminate UAE's Amna Alawadhi and Mohammed Binamro 159-151.

The duo will take on formidable Malaysia (No 8 seed) in the quarters, and thereafter, they should have an easy draw till the final.

pair duo of Atanu Das and Ankita Bhakat were at their resilient best and overcome a first-set deficit to defeat Malayasia in a three-setter.

The fifth seeded Indian duo of Das and Ankita rallied to beat the Malaysian team of Syagiera Binti Mashayikh and Muhamad Zarif Syahir Bin Zolkepeli 6-2 (39-38, 37-36, 39-33).

The Malaysia pair enjoyed a 2-0 lead with three 10s including one X in the first set. But, the experienced Indian duo bounced back with two 10s and went on to draw level, as the Malaysians crumbled under pressure.

The Malaysians hit the red-ring (8) once and went on to lose the second by a slender one-point margin.

There was more misery in store for the Malaysians who shot into the red ring thrice (8-8-8), while Das-Ankita drilled in three perfect 10s en route to a six-point win in the third

The Indian pair sealed the issue with three more 10s in the fourth set and set up a last-eight clash against the fourth-seeded Indonesians.

Should they overcome the Indonesian challenge, the Indians may run into the top-seeded Koreans in a potential semifinal clash in the Olympic-qualifying event.

There are six quota spots available from the Asian Games — the recurve mixed team winners and two archers ranked high in the individual events

## Rachin: From cheering for NZ at bar in 2019 to being part of 2023 World Cup batch

Rachin Ravindra found the night of July 14, 2019, one of the longest and hardest to endure as he watched New Zealand's heartbreaking defeat to England in the ODI World Cup final sitting in a Bengaluru pub. Ravindra, then all of 19

was on an annual trip to India with his father's cricket club and the roller-coaster experience of watching the final is still etched

in his memory.

New Zealand losing that final to England on the bound-ary count-back rule divides opinion to this day. Rachin, whose first name is inspired by the first names of Sachin Tendulkar and Rahul Dravid, remembers that night as it was yesterday.

As a budding cricketer dreaming to represent New Zealand one day, the Indian-origin circketer was shattered with the outcome of the game and the desire to represent New Zealand grew stronger. Cut to 2023, he is among the

fast rising cricketers in the New Zealand set-up. Primarily a batter, who also takes his left-arm spin very seriously, Rachin has already made a statement with a gutsy 97 as an opener in the World Cup warm-up against Pakistan here last week.

Born to Indian parents in Wellington, Rachin has a strong connect with the cricket mad nation with his family roots in Bengaluru. It was fitting that he made his Test debut in India two years ago and now he is set to make his World Cup debut

here.
"Looking back on my Test debut, it was a special and emotional time. Being able to play in India, the fanfare around the game here, to be able to experi-

ence that is pretty special.
"My parents come from

Bangalore and it is amazing to play a World Cup here," the 23vear-old PTI referring to the Kanpur Test which he was able to draw for his team while batting alongside number 11 Ajaz

From watching previous World Cup as a fanboy to now being part of the next one, it has been a pretty "cool" journey for Rachin.

"It is actually quite a story. My dad takes a bunch of age group boys to India (annually) and we were in Bangalore on a senior trip. We were watching the final (2019) in a stock exchange bar.

"I watched the whole final. It was unbelievable and such a rollercoaster experience with the high and lows of the game. Having Indian supporters around us was pretty cool. It is an experience I will never forget."

New Zealand is probably the most liked team on the planet but on that night, no pleas-antries were exchanged in that bar. A couple of days ago, New Zealand had ended India's run in the semifinals.

"All of us were New Zealanders, so we were massively going for the Black Caps but quite a few Indians were going for England, probably because of the emotional hangover from the semifinal.

'That created a nice little atmosphere there as we all know how the game went," recalled

Did he think then that he be part of the 2023 batch?

"It has been a great ride. You always think one day you might get a chance. Being a 19-year old at that time, few years into professional cricket, you have those dreams to be part of a World

Cup. It is pretty cool how it has come to fruition," he said.

#### Experience of cricket tours to India with my dad will come in

Rachin, who opens for Wellington back home but bats in the middle-order for New Zealand, feels the experience of playing age-group cricket around the country will help him in this World Cup as the team travels all around India for its nine league games.

"For sure. Any sort of experience playing in India goes a long way. Grateful for these tours of India in my younger days. Goes a long way in playing spin and how to bowl in these conditions, face different type of seamers on different wickets.

PGMOL, the referees' governing body in England, admitted Video Assistant Referee officials Darren England and Dan Cook failed to act after Luis Diaz' 34thminute strike at Tottenham on Saturday was wrongly disallowed for offside. Still images of the incident showed Tottenham's Cristian Romero playing Diaz onside.

The decision was made when the Premier League match was goalless but after Curtis Jones had been contentiously sent off following Darren England's intervention. Liverpool went on to lose 2-1, ending the game with nine players.

The officials were stood down from duty for the rest of the weekend but Liverpool says it will pursue the matter.



A statement read: "Liverpool Football Club acknowledges PGMOL's admission of their failures last night. It is clear that the correct application of the laws of the game did

not occur, resulting in sporting integrity being undermined. We fully accept the pressures that match officials work under but these pressures are supposed to be alleviated, not exacerbated, by the existence and implementation of VAR.

Liverpool said it was "therefore unsatisfactory that sufficient time was not afforded to allow the correct decision to be made and that there was no subsequent interven-

"That such failings have already been categorized as significant human error' is also unacceptable," the club's statement added. "Any and all outcomes should be established only by the review and with full transparency.

Liverpool said it need to explore its options, "given the clear need for escalation and resolution.

PGMOL had earlier acknowledged that "a significant human error" occurred in the first half of the game and said it would conduct a full review.
