

# SHOOTERS ADD TO GOLD HAUL MP Bidhuri faces

The men's 10m air pistol team continued India's success story at the Asian Games here, winning gold but two of the marksmen, who made it to the individual finals on Thursday, missed a medal.

The team of Sarabjot Singh, Arjun Singh Cheema and Shiva Narwal narrowly beat the Chinese team to take the top podium and earn India its fourth gold medal from the shooting ranges. With Thursday's success,

Indian shooters have so far won four gold, four silver and five bronze medals. The Indian trio's aggre-

gate score of 1734 was just one better than the Chinese team, which settled for the silver medal, while Vietnam, with a score of 1730, bagged the bronze

Sarabjot and Arjun also made it to the eight-shooter individual finals but finished fourth and eighth, respectively. Vietnam's Pham Quang Huy won gold with a score of 240.5, while South Korea's Lee Wonho (239.4) and Uzbekistan's Vladimir Svechnikov (219.9) took the silver and bronze,

respectively. Sarabjot, 21, finished fourth, scoring 199, while Arjun ended up eighth and last, exiting on the second elimination shot

It was another fruitful day for Indian shooters, with Sarabjot, who will be celebrating his 22nd birthday on Saturday, giving himself an eighth.

He would now be aiming to seal a 2024 Paris Olympics quota place at the Asian Championships in Changwon (South Korea) later this year. Meanwhile, Indian men's

and women's teams assured themselves of medals at the Asian Games after progressing to the semifinals of the squash events here on Thursday.

While the men's team blanked Nepal 3-0 in its final pool tie, the women were handed a 0-3 loss by Malaysia in their last pool B fixture. Both teams sealed top two spots in their respective pools to make the semifinals which guarantees them at least a bronze.

The Indian women's team began the day with veteran Joshna Chinappa enduring a 6-11, 2-11, 8-11 defeat to Subramaniam Sivasangari in 21 minutes. In the second match. Tanvi Khanna squandered a 2-1 lead before going down to Commonwealth Games gold medallist Aifa Binti Azman 9-11, 11-1, 7-11, 13-11, 11-5.

Lok Sabha Speaker Om Birla lodged by several MPs on the issue involving BJP member Ramesh Bidhuri's use of objectionable words against BSP's Danish Ali to the Privileges Committee, sources said on Thursday.

While Ali and several other Opposition MPs, including Congress leader Adhir Ranjan Chowdhury and DMK's Kanimozhi, wrote to the Speaker seeking action against Bidhuri, some BJP parliamen-tarians like Nishikant Dubey said the BSP member "incited" the South Delhi MP when he was speaking in the House and urged the Chair to look into this as well

Sources said Birla has sent all these complaints to the Privileges Committee headed by BJP MP Sunil Kumar Singh.

Bidhuri had made certain derogatory remarks, later expunged from records, targeted at BSP member Danish Ali on September 22 when he was speaking in the Lok Sabha during a discussion on the success of the Chandrayaan-3 mission. Defence Minister Rajnath

Singh, who was present in the House, expressed his regret at the ruling party MP's conduct.

As opposition parties rallied around Ali after a video of Bidhuri's remarks went viral triggering an outrage, the Lok

While Dubey condemned Bidhuri's conduct, he urged the Speaker to look into Ali's behaviour as well. Other BIP MPs echoed the view.

In a post on X on Thursday, Dubey thanked the Speaker for referring the matter to the committee.

"It was possible because the BJP has a majority in Lok Sabha," he said, as he cited several previous incidents to assert that no committee was formed to probe these issues and nor was anyone punished.

# **Green Revolution Icon passes away**

The new generation may not be aware of it but India had a recent past when the then Prime Minister of the country himself had asked the people to skip a meal daily so that the country's hunger could be satisfied to a certain extent.

The Prime Minister was none other than Lal Bahadur Shastri and the country was undergoing severe drought caused by deficient Monsoon and low productivity of the seeds and soil

"We were leading a ship to mouth existence. Every day ships laden with wheat given by the USA under its PL-480 programme would arrive in Indian ports to feed the crores. Those were the days when India was dependent on the wheat offered by the USA," Professor MS Swaminathan, who breathed his last on Thursday morning, used to recall

Kumbakonam-born Swaminathan was 98 and is survived by three daughters, Soumya, Mathura and Nitya. His wife Mina predeceased him.

Swaminathan, a plant geneticist by training, returned to India to work for the Indian Agricultural Research Institute and he had a dream of developing high yield varieties of rice and wheat, the staple food of

the sub-continent's population. Along with Dr Norman Borlaug, the Nobel Laureate and with the political patron-age extended by C Subramaniam, the then food and Agricultural Minister of India, Professor Swaminathan launched the Green Revolution, which was the launched foundation stone of India's self-reliance in food production.

Within a decade, India became a food surplus State from a food deficient country. Having resolved the issue of food shortage, Professor Swaminathan turned his attention to other areas about which the then political leadership was ignorant. He drew the attention of the policy makers towards the poor mortality rate of women and children because of the shortage of nutritious food.

Professor Swaminathan also alerted the Government of It was the time when the day about LBW, the low

birth weight, of the newborn. "Every third child born in

India and several South Asian countries is characterised by low birth weight. The LBW children, resulting from maternal and foetal undernutrition, suffer setbacks in brain development and several serious health problems in adult life. Such enforced handicaps at birth represent the cruelest form of inequity in the emerg-ing knowledge age," he had warned in 1999.

Had the Governments of the day listened to his words, India would have experienced the Amrit Kaal long back. For Professor Swaminathan, agricultural research was not something to be confined to the laboratory. He was at home interacting with farmers, fishermen and agricultural workers to get first hand information about their grievances and problems.

He travelled to Orissa and Wayand in Kerala to study the traditional style of farming operations. The credit for informing the world about the vast collection of conventional rice seeds under the possession of tribals in Orissa should go to him only. It was his vision to set up pulse and cereal villages across genetically modified seeds, Professor Śwaminathan stayed away from all controversies.

He held the view that "if there are reservations against the GM foods and inter linking of rivers, we should try to address the apprehension in the



## **Anurag raps Rajasthan** Government over rape of minor

Union Minister Anurag Thakur on Thursday slammed the Rajasthan government over the rape of a minor in the poll-bound State and wondered why Congress leaders Sonia Gandhi and Rahul Gandhi are not talking about the incident.

Responding to questions here, Thakur also claimed that crime against women is on the rise in Rajasthan, where more than 34,000 cases have been registered for such crimes.

"Take the figures of the last five years for Rajasthan. More than two lakh cases of crime against women have been regis-

tered," he said. lhaku Congress leaders Sonia Gandhi, Rahul Gandhi and Priyanka Gandhi never lost an opportunity to flag cases of crime against women in other states, but were silent on Rajasthan, "which ranks number one in such crimes". "Congress government is shielding criminals, women are insecure in Rajasthan where 16-17 cases of rape and crime against women are registered every day," the senior BJP leader said. Thakur said last time Rahul Gandhi visited Banswara, a Dalit girl was raped, murdered and thrown in a well in nearby Bhilwara. "Then too, he did not visit that place," he said. "If such incident happens in other states, Congress leaders are the first to tweet, but Rajasthan is number one in rape cases, and crime against women and Congress leaders are silent," he said.

Delhi communa however, rapped the Delhi Police for "incomplete investigation" of three additional complaints that were clubbed with the case, and referred the matter to the Deputy Commissioner of Police (DCP) concerned to make an appraisal of the "moonshine investigation" conducted by the Investigating Officer (IO).

Additional Sessions Judge Pulastya Pramachala was hearing a case against Firoz Khan and Mohammed Anwar, who were accused of being part of a riotous mob that committed vandalism and loot at a godown in Karawal Nagar on February 24, 2000. They were also accused of attempting to set

the godown on fire. The local police had reg-istered an FIR on the complaint of Chhidda Lal Tomar, the owner of the godown. Three complaints filed by Mukhtiyaz Ali, Eshak and

Kafil Ahmed were later clubbed the case. The court said in a recent order there was "prima facie" evidence that the two accused were part of a riotous mob that committed various offences at Tomar's godown.

It ordered framing charges against the duo for various offences, including rioting, unlawful assembly, theft, mischief by fire or explosive substance, house



an order duly promulgated by a public servant. The court, however, said the probe in the three additional complaints remained incomplete.

"I find that there is no complete evidence collected by IO in respect of incidents taking place at the shops of Kafil Ahmed, Eshak and Mukhtiyaz Ali. The investigation qua these three complaints remained incomplete,"

## **Bhagi retains DUTA prez post** Atishi raps BJP for deplorable state of MCD school



We are really looking forward to it," he said. Last year over 1.2 million Indians visited the United States. Indians now represent over 10 per cent of all visa applicants worldwide, includ-

ing 20 per cent of all student visa applicants and 65 per cent of all H&L-category (employ-

ment) visa applicants. According to a statement by the US Embassy here, recognising the continued high demand for US visas, the United States continues to invest heavily in our operations in India. "In the past year, the Mission has expanded its staffing to facilitate more visa processing than ever before. The Mission has made signif-icant capital improvements to existing facilities, such as the US Consulate in Chennai, and has inaugurated a new Consulate building in Hyderabad.

'The Mission has also implemented strategies to increase efficiency, extending interview waiver eligibility to new visa categories and utilising remote work to allow staff around the world to contribute to Indian visa processing. Early next year, the Mission plans to implement a pilot program that would allow domestic visa renewal for qualified H&Lcategory employment visa applicants," it said.

## NIA files supplementary chargesheet against four quality counterfeit Indian

The National Investigation Agency (NIA) on Thursday said it has filed a supplementary chargesheet against four persons, including a 'designated terrorist', in the Thane fake currency case.

Besides the designated terrorist Uncle alias Javed Chikna, those charge-sheeted under relevant sections of the Indian Penal Code (IPC) and Unlawful Activities (Prevenion) Act have been identified as Riyaz Shikilkar, Mohammad Fayaaz Shikilkar and Nasir Chaudhari, all residents of Mumbai.

One of the accused Fayaaz Shikilkar has also been charged under the Arms Act.

Three accused were chargesheeted earlier, in April last year, by the Thane police in the case, which was originally registered following the seizure of 149 high currency notes of the denomination of ₹2,000 from accused Shikilkar. Subsequently, NIA had taken over the case and,

after investigations, had arrested Fayaaz in May 2023 for possession of illegal arms. "Investigations also revealed that Fayaaz was in

contact with 'Úncle' alias Javed Patel alias Javed Chikna through WhatsApp, and had conspired to carry out unlawful activities in India. He had also received funds sent by 'uncle', a designated individual terrorist, through his associate 'bhai," the NIA said in a

statement. 'Uncle', a wanted accused, had committed acts of terror through his associates by possessing and circulating high-quality fake Indian currency notes (FICNs) with the aim of damaging the monetary stability of India, according to the NIA chargesheet.

## Govt has crushed hopes, dreams of youth: Congress

The Congress on Thursday L targeted the Narendra Modi Government over the issue of unemployment alleging that it has crushed the hopes and dreams of India's youth, leading to rising suicides among them.

Congress chief spokesman Jairam Ramesh alleged that the government, instead of dealing with the crisis of demographic dividend turning into a demographic disaster, might want to "manipulate" the National Crime Records Bureau (NCRB) data due for 2022 to hide the alarming suicide rate among the youth.

In a statement, he said unemployment in India remains a severe problem as well as the hidden underemployment.

Ramesh cited the interactions of Rahul Gandhi with porters at the Anand Vihar Terminal here where he had noted that large numbers of

educated youth, including those with engineering degrees, were unable to find formal employment and were forced into precarious informal jobs such as porters.

The Congress general secretary said the massive failure of the Modi Government to provide sufficient formal-sector employment has led to this

situation. Ramesh cited data from the Employees' Provident Fund Organisation (EPFO) for 2021-22 that shows that formal sector employment remains 5.3 per cent lower than it was in 2019-20. Further, the number of formal employers has declined by a massive 10.5 per

cent from 2019-20 to 2021-22. According to a report from Azim Premji University, the Congress leader said, 42 per cent of graduates under 25 were unemployed in 2021-22. Jobs in manufacturing dropped 31 per cent between 2016-17 and March 2023, according to Centre for Monitoring Indian Economy (CMIE) data.

## **CSIR** lab producing affordable green innovative technology

 $F^{\rm rom\ converting\ pathogenic}_{\rm biomedical\ waste\ into\ eco-}$ friendly soil additives to manufacturing vegan leather from agricultural waste like mango peel and banana stem, the CSIR's lab National Institute for Interdisciplinary Science and Technology (NÍIST), is busy churning out affordable green innovative technology.

These among others were displayed at the foundation day of the CSIR at Pragati Maidan here recently.

NIIST Director Dr C Anandharamakrishnan said that vegan leather has the potential to replace around 30-50 per cent of synthetic chemicals from the existing leather available in the market.

"Also, the developed leather sheet costs 50 per cent less than synthetic and animal leather and has a smaller carbon footprint as various agricultural residues such as mango peel, banana stem, pineapple waste, cactus, water hyacinth, corn husk, and rice-related waste are being used.

Vegan leather has a shelf



life of more than three years. It has also shown strong tensile strength, sleek finish, good water retention properties, temperature resistance, and stability compared to other existing synthetic and animal leather," he emphasised.

Though still held out by the fashion industry as a luxury material, leather is a co-product of the meat industry, and it comes with many environmental downsides.

A leather jacket has a climate cost of 176 kilograms of CO2, for instance, and manufacturers also dump toxic chemical compounds like lead, arsenic, cadmium and chromium into the water as the leather is processed, on top of the millions of goats and other animals slaughtered each year in India for leather.



## **Big guns roll out**

The BJP leadership is taking no chances in Madhya Pradesh, fielding 3 Union Ministers in Assembly polls

ith elections to five Assemblies scheduled by this year end, political temperature is already on the rise. However, as the situation persists today, the battleground of Madhya Pradesh has taken the lead in evoking competition and wonderment more fierce than in the other four States. As the X factor in these elections for the BJP is the party's decision to bring back to fight the Assembly polls three Ministers from the Union Government, at least four sitting MPs representing the State and other senior party office bearers holding influence across castes, religion and region. The ruling party has come up with its second list of 39 candidates for Madhya Pradesh. This move comes as the party faces tough competition from the Congress. The BJP has made a bold move by fielding heavyweights, including Union Ministers, to maintain its stronghold in the State. Union Ministers Narendra Singh Tomar, Prahlad Patel and Faggan Singh Kulaste, along with party MPs Rakesh Singh, Ganesh Singh, Reeti Pathak and



Uday Pratap Singh, as well as general secretary Kailash Vijayvargiya, will now contest the Madhya Pradesh Assembly elections. The inclusion of these prominent leaders as candidates has also opened up the field for chief ministership aspirants; Narendra Singh Tomar, Prahlad Patel and Kailash Vijayvargiya are now considered strong contenders.

Shivraj Singh Chouhan has held the CM's post for nearly 20 years, with a brief interruption after the 2018 elections. The BJP is concerned about fatigue setting in regarding Chouhan. During a recent rally, Prime Minister Modi did not mention Chouhan even once. Meanwhile, Congress is emerging as a formidable con-

tender under former CM Kamal Nath's leadership. This election promises to be a riveting showdown, with significant implications for Chouhan, besides the State's political future. Though Chouhan has served as the Chief Minister for multiple terms and is widely credited as a popular leader, his reputation and political future are now closely tied to this poll's outcome. If the BJP manages to secure a comfortable majority, it will consolidate his position within the party and strengthen his leadership in the State. On the other hand, a loss could raise questions about his ability to win elections and govern effectively. Kamal Nath, a seasoned politician, is working to consolidate the party's base and capitalise on anti-incumbency sentiments. The Congress' performance in recent byelections has been promising, boosting its confidence. The party is banking on issues such as unemployment, rural distress. Its campaign is centred on the promise of "change and improved governance". Meanwhile, the BJP's decision to field its stalwarts is an ominous sign for Chouhan and shows the party's dwindling faith in his leadership. Antiincumbency and a number of unsavoury incidents have led to the erosion of his reputation which could cost the party an important State in the Hindi heartland. The BJP would not like that to happen just ahead of the 2024 general elections.



# Air pollution renders antibiotics ineffective

A 'Lancet' study has established a connection between bacterial antibiotic resistance and air pollution; inhaling PM 2.5 can lead to antibiotic resistance

here was a sense of palpable urgency to address climate change, air pollution and degradation of the environment at the recently concluded three-day G20 summit held in New Delhi. Led by India, the G20 nations agreed to urgently accelerate their actions to address environmental crises and climate change challenges with the help of a green development plan. This in a way reflects the prophetic warning to world leaders by the UN Secretary-General António Guterres at the 27th Conference of the Parties to the UN Framework Convention on Climate Change (COP27) held in 2022, that humanity is on a "highway to climate hell with a foot on the accelerator". Because 80 per cent of the world's greenhouse gas emissions emanate from G20 nations, the member nations needed to understand the gravity of the problem and ensure meaningful progress in this regard.

As the stakes for mankind keep rising thanks to rising pollution and climate change, keeping global average temperatures below 2 degrees centigrade alone may not be the urgent goal of the nations. Newer and more perilous problems are arising due to unabated pollution levels. A recent study published in the health journal "Lancet" has established a connection between bacterial antibiotic resistance and air pollution, particularly PM 2.5. The study suggests that PM 2.5 contains elements of antibiotic resistance, and inhaling this pollutant can lead to an increase in the spread of antibiotic resistance. The authors of the study aimed to estimate the global premature death toll caused by resistance to antibiotics due to PM 2.5 pollution.

PM 2.5 refers to particulate matter with a diameter of 2.5 micrometres or smaller. These particles, consisting of solid and liquid elements, are of varying sizes, with some, like dust and soot, visible to the naked eye and others, such as PM 2.5, only observable under electron microscopes. Inhaling these pollutants can pose serious health risks, especially to the respiratory sys-



tem. The Lancet study compared and analysed the PM 2.5 levels with levels of antibiotic resistance and made a disturbing discovery that the higher the pollutant level, the greater the antibiotic resistance. PM 2.5 are smaller than human hair and contains antibiotic

resistance elements. As these pollutants travel through the ambient air, they disperse antibiotic resistance elements, which can then be inhaled by humans which in turn sets in motion the resistance. The concerning aspect is that antibiotic-resistant bacteria can withstand antibiotic treatments, rendering the drugs ineffective against them. Antibiotics are primarily used to eliminate microorganisms, especially bacteria, but resistant bacteria are impervious to their effects.

The data for this research was collated from 116 countries utilising sources like ResistanceMap, the European Center for Disease Prevention and Control Surveillance Atlas, and the PLISA Health Information Platform. Overall, nine pathogens and 43 drugs were analysed. It was observed that the surge in antibiotic resistance among bacteria is largely attributed to the indiscriminate use of antibiotics. Repeated and widespread

antibiotic usage can empower bacteria to develop resistance over time, often facilitated by Antibiotic Resistance Genes (ARGs). Pathogenic bacteria, responsible for infections and diseases, can acquire antibiotic resistance through ARGs in

a process known as horizontal gene transfer. The Lancet health report concluded that the need of the hour is to address the PM2.5 SOME MAJOR levels. Given these bleak conditions, India needs to cover a lot of ground to rein in otic efficacy is not held to ran-PM 2.5 levels while there is still time. The National Clean Air Program (NCAP) is a deter-

mined step in the right direction, but it needs more grit and resolve behind it if the initiative has to succeed.

Some major steps are the need of the hour for India. Firstly, immediate curbs on ammonia release in farms are essential, this must be followed by a full ban on refuse burning. Apart from this rural brick kilns must be persuaded to shift to cleaner kiln-firing technologies. Urgent efforts also need to be made to convert coal-based power plants to clean energy, as this by itself will make a huge difference. To make this a reality, India must make a push for creating the correct financial architecture through investment funds with a dedicated green focus that can play an instrumental role in catalysing the growth of green industries and simultaneously addressing the twin problems of air pollution and climate change. These funds would combine a returns-driven strategy with the sustainability imperative and accelerate investment in green industries. Measures such as these can help India fight air pollution and prevent a calamitous

## SIMULTANEOUS ELECTIONS

Sir — The 22nd Law Commission of India is poised to submit a report on the feasibility of conducting simultaneous elections in the country and is likely to recommend it for the 2029 elections. The Commission, led by Justice Ritu Raj Awasthi, has diligently worked on this final report since February 2023. The report, destined for submission to the Law Ministry, currently headed by Arjun Meghwal, arrives at a pivotal juncture. It coincides with the government's formation of a high-level committee, under the leadership of former President Ram Nath Kovind, tasked with examining and providing recommendations for simultaneous elections to the Lok Sabha, state assemblies, municipalities, and panchayats, all in the name of 'national interest.' According to reports, there's a possibility that the government may forward the Law Commission's report to the Kovind-led committee for their consideration. The Law Commission is likely to propose synchronized elections within the next five years, with the goal of implementing simultaneous elections by 2029.

## **FIRSTCOLUMN RESPECT INDIA'S** SOVEREIGNTY

Canada must not allow its soil to be used for anti-India activities

story of agents executing transnational operations, intelligence agen-Acies sharing crucial information, backetiantic superis playing out for the world audience, with Canada and India in the lead for the past few weeks. In a hurried and perhaps half-baked allegation Canadian PM Justine Trudeau blamed Indian agencies for carrying out extra-territorial executions of Canadian citizens.

India was quick to retort with a terse statement, which instead pointed out the long-standing issue of concern between the two countries in the form of Canada allowing Indian separatist groups to operate out of their country. The Indian statement said unequivocally "We have seen and reject the statement of the Canadian Prime Minister in their Parliament, as also the statement by their Foreign Minister. Allegations of the Government of India's involvement in any act of violence in Canada are absurd and motivated. Similar allegations were made by the Canadian Prime Minister to our Prime Minister and were completely rejected. Such unsubstantiated allegations seek to shift the focus from Khalistan terrorists and extremists, who have been provided shelter in Canada and continue to threaten India's sovereignty and territorial integrity. We reject any attempts to connect the Government of India to such developments. We urge the Government of Canada to take prompt and effective legal action against all anti-India elements operating from their soil.3

What is happening in the bilateral relationship is not a recent development but has been brewing for decades. Nearly forty years back India had demanded the extradition of a terrorist from Canada, responsible for one of the worst plane bombings in history, killing everyone on board an Air India flight. The several convicts responsible for the act of terror were never convicted by Canada, despite repeated inputs from India abandoning victims' families chasing long winding court cases for decades.

The reason Canada allows or even nurtures these anti-India forces



on its soil leads through the corridors of domestic politics. Millions of Indians particularly from Punjab make a substantial chunk of the Canadian demography. While most of them earn an honest living and are peaceloving, some notorious elements have managed to sneak into Canada, working through well-oiled semi-government machinery. Over some time, these criminals and terrorists wanted by India, have managed to control important real estate through the Gurudwaras committees. These mafiacontrolled gurudwaras also serve as a conduit for fulfilling the immigration dream of thousands of Punjab youth, working with their India handlers across Punjab and several other states of north India. The modus operandi for getting ground force for staging anti-India acts from Canadian soil starts with a letter issued by Indian handlers, about the youth facing discrimination, and persecution due to his religion, in India. It understands that a powerful, resilient, democratic India is important for a prosperous Indo-Pacific region, which indirectly translates to bringing more prosperity to its citizens. However, the domestic political concerns rise above geopolitics, and retaining the chair as PM seems more important for Trudeau at the moment. It may be argued that several news reports have pointed to US intelligence aid in Canadian allegations against India, however, the US knows which way the wind is blowing.

# Regulatory boost to self-sufficiency in energy

Modi Government is giving considerable policy support for the exploration of hydrocarbons so that investors can earn assured return on their investments

elivering the 75th Independence Day address, Prime Minister Narendra Modi set the country a target to achieve self-reliance in energy production by boosting the gas-based economy (besides giving a push to electric mobility and hydrogen production). Modi wants the share of natural gas (NG) in the total energy mix to go up from the current around 6 per cent to 15 per

Currently, India imports 50 per cent of its NG requirement. This is because domestic production is hovering around a low of 28.6 - 34 billion cubic metres (bcm) in 2020-21 to 2021-22 (down from a peak of 52 bcm in 2010-11). There is a dire need to give a massive push to domestic output to meet the target. India has 26 sedimentary basins (SBs) covering an area of 3.4 million sq km that could be searched for hydrocarbon resources. Only six of the SBs are under commercial exploitation; these too are sub-optimally utilized.

Hydrocarbon exploration is a highly capital-intensive and technology-intensive business involving a long-gestation period. It is risk-prone especially when it comes to drilling in deep/ultra-deep and high-pressure/high-temperature (D/UD/HP/HT) fields in offshore areas such as the Krishna-Godavari (KG) basin. However, these areas offer maximum promise in terms of reserves.

Multinational companies (MNCs) such as ExxonMobil, Chevron Total etc. which have the technology and resources can be enthused to take longterm bets in the Indian hydrocarbon sector provided the government offers them an opportunity to earn an attractive return on their investment in a 'sustained' basis. This in turn, requires that their efforts in the discovery and devel-opment of NG fields don't face regulatory hurdles leading to the commencement of production within a reasonable time frame and that they can sell the gas 'freely' at a 'remunerative' price. In all three areas, the MNCs faced impediments in the past. In recent years, the Modi - government has made significant progress in removing these though, a lot more ground remains to be covered. Let us look at the regulatory landscape.

The government has passed the Forest (Conservation) Amendment Bill, which says that seismic surveys (it is done in the initial stage to determine evidence of economically viable hydrocarbon resources below the ground) won't be treated as a non-forest activity. This implies that explorers would be granted prompt access to forest areas, thereby saving time spent on seek-

under the Hydrocarbon Exploration and Licensing Policy (HELP), also known as the Open Acreage Licensing Policy (OALP) launched in 2017, E&P firms are allowed to pick up a block of their choice unlike the earlier New loration and Licensing Policy (NELP) (launched in 1999) wherein they had to accept what the government offered. Besides, under OALP, an operator gets a composite license to search for hydrocarbon in whatever form; for instance, if it is 'shale gas', she won't need a separate license for extracting it. For long, E&P efforts were hamstrung by cumbersome procedures, multiple approvals and bureaucratic red tape. Approvals were needed at every stage viz. preparation of field development plans (FDP) including its revision, and extension of the contract, drilling wells, conducting tests to determine the commercial viability of the field, annual work program (AWP), laying the pipeline, reviewing production and so on. As many as 37 processes and procedures were required to be followed by a firm-awarded block

Team Modi has substantially liberalised and de-bureaucratised the approvals. It has identified 22 processes for which self-certification of documents by contractors is accepted. Besides, it has provided for pre-approved clearance of blocks which will substantially cut the time lost in taking approvals. The government is also keen to opt for globally recognised and accepted dispute resolution mechanisms and play-based exploration

Moreover, the 'revenue sharing' model under the OALP (currently in vogue) allows the operator to share an agreed percentage of the revenue with the Government of India (GOI) unlike the production sharing contracts (PSC) under erstwhile NELP wherein she could fully recover the cost incurred in exploration and development of the field before sharing profits with the GOI. The former does away with an additional layer of approval which was intrinsic to the latter wherein the costs incurred at every stage were subject to official scrutiny. Coming to the selling of NG and realisation therefrom, in respect of gas from fields given under HELP/OALP, the operators are allowed freedom of pricing and marketing. This is a big positive for E&P firms that are being allotted fields under this policy. Furthermore, supplies from the socalled marginal fields (there are a total of 149) previously with the central PSUs viz. ONGC and OIL auctioned to private entities during 2020/21 are also eligible for freedom of pricing. However, supplies from the socalled Legacy fields which account

for the bulk of the current gas supply are subject to government control over price as well as the marketing of the produce. The Legacy staff includes fields given to ONGC/OIL on a 'nomination' basis, those given under NELP and pre-NELP blocks. There are two

price ceilings. One, call it 'normal' price. Based on the recommendations of the Kirit Parikh committee and in force from April 1, 2023, this price expressed on a per million British thermal units (Btu) basis is arrived at by taking 10 per cent of the monthly average of the Indian crude basket in the preceding month and notified every month. The price thus calculated is subject to a price band of US\$4-6.50 per Btu.

Second, there is a 'premium' rice applicable to the difficult fields. These are deep/ultra-deep and high-pressure/high-temperature fields (the high-profile KG-D6 operated by Reliance Industries and neighbouring KG-DWN-98/2 operated by ONGC fall in this category). Technically though the price of NG flowing from these fields is market-determined, this is subject to a ceiling linked to the prices of alternate fuels, viz., fuel oil, naphtha and imported LNG. Even as the committee has recommended de-regulation of difficult gas fields' price by January 1, 2026, and that of normal price by January 1, 2027, the government is silent on this. Having substantially liberalized the regulatory space, besides removing the remaining hurdles, Modi needs to take the next logical step of unshackling marketing and pricing for supplies from the Legacy

lease rights for short tenure though extendable by 10 years for gas/oil & gas fields and by five years for oil fields. They had to go to the bureaucrats to seek approval for an extension of the lease which came in the way of undertaking long-term investment commitment.

Now, the government has granted E&P rights over the entire economic life of the allotted fields (this could extend up to 30 years, even beyond depending on the available reserves and the pace of their exploitation) instead of the extant system of allowing extensions. This will enthuse global firms to undertake long-term investment bets as they know for sure in

## **4 graft cases against Nawaz** Sharif set to be reopened

#### PTI LAHORE

Pakistan's anti-graft body is reopening at least four corruption cases against former prime minister Nawaz Sharif as he is scheduled to return to the country next month, ending four years of self-exile in the United Kingdom, an official said on Thursday.

The 73-year-old Pakistan Muslim League-Nawaz (PML-N) supremo is scheduled to return to Pakistan from London on October 21 to lead the party's election campaign. Nawaz left the country in November 2019 on medical grounds after the Lahore High Court granted him bail for four weeks. He was serving a sevenyear imprisonment in the Al-Azizia Mills corruption case at Kot Lakhpat Jail Lahore.

On arrival in Lahore, his party says he will address a rally at Minar-i-Pakistan where he will give a road map to steer the country out of the economic crisis, governance problems and other issues the country is facing today. The National Accountability Bureau (NAB) in the light of a Supreme Court

ruling which struck down amendments made to the accountability laws by the previous Pakistan Democratic Movement (PDM) government led by Nawaz's younger brother Shehbaz Sharif, is reopening the four pending probes against Nawaz. The cases are related to illegal plots and land allotment, dubious transfer of shares of his sugar mills and Toshakhana

(national treasury gifts). "Nawaz Sharif being chief minister of Punjab province in 1986 had allotted plots in Lahore to several people by misusing his authority. He is accused of illegal construction of several kilometres of road to his house in Jati Umra Raiwind, Lahore, in 1998 when he was prime minister in violation of rules. "The third case is related to the transfer of shares in 'illegal' manners in the Chaudhry Sugar Mills case which is owned by Nawaz Sharif and his family members.

In this case, his daughter Maryam Nawaz is also accused of being a major beneficiary," an official privy to the development told PTI on Thursday. The fourth is related to the

Toshakhana case in which he is accused of taking luxurious vehicles from the national treasury in violation of rules, he said. Besides these cases, Nawaz will have to face the case related to his conviction.

Meanwhile, Nawaz's close aide and senior PML-N leader Mian Javed Latif said the party has stopped "demanding accountability of former army chief Gen Qamar Javed Bajwa and former ISI head Gen Faiz Hameed" for conspiring against Nawaz to topple his government in 2017

"The PML-N doesn't want accountability of Gen Bajwa and Gen Hameed but only those characters and facilitators involved in May 9 events and

mutiny against the head (Army Chief Gen Asim Munir) of the institution," he said.

Latif was referring to attacks on military installa-tions following the arrest of Pakistan Tehreek-i-Insaf (PTI) chief Imran Khan in May.

On September 18, Nawaz demanded "strict accountability" of Gen Bajwa, Gen Hameed and chief justices — Asif Khosa and Saqib Nisar while addressing the party's ticket holders in Lahore via video link from London.

He had hinted at trying them under treason charges if his party returned to power in the upcoming elections, scheduled early next year.

Nawaz's demand for strict accountability left many in the party in a precarious position as the leaders became wary of a possible backlash from the military establishment if he continued with such statements. Sources told PTI that Nawaz backtracked from demanding accountability of army generals after a "strong message" was conveyed to him through his younger brother Shehbaz Sharif.

## American soldier who crossed into N Korea returns to US

The American soldier who **I** sprinted into North Korea across the heavily fortified border between the Koreas more than two months ago arrived back in the US early Thursday, video appeared to show.

North Korea abruptly announced Wednesday that it would expel Pvt Travis King. His return was organised with the help of ally Sweden and rival China, according to the White House.

While officials have said King, 23, is in good health and the immediate focus will be on caring for him and reintegrating him into US society, his troubles are likely far from over. At the time, he was supposed to be heading to Fort Bliss, Texas, following his release from prison in South Korea on an assault conviction.

He has been declared AWOL from the Army. In

¬aiwan's president launched L the island's first domestically made submarine for testing Thursday at a port in Kaohsiung. The submarine, if success-

ful in its tests, will be a major breakthrough for Taiwan in shipbuilding and design.

"In the past, a domesticmade submarine was considered impossible, but today a submarine designed and built by our countrymen is in front of vou," President Tsai Ing-wen said at the launch ceremony.

"Building a submarine is the concrete realization of our resolution to protect our country. Submarines are an important piece of equipment for the Taiwan navy to develop asymmetric combat power in terms of strategy and tactics," she said. The US has been pushing Taiwan to develop asymmetric warfare strategies by investing

in smaller and lighter weapons such as the reduced-size submarine. The process was "torturous," said Cheng Wen-lon, head of Taiwan's CSBC Corp, which led the construction of the submarine. "Although we

have worked quietly during the past several years, it doesn't mean the process was very smooth," he said at the ceremo-

ny held in CSBC's shipyard. After seven years of design and construction, the prototype will begin tests in the harbour before heading to the ocean. The submarine is named Hai Kun after a fish in Chinese mythology called kun with legendary proportions.

It will only be handed over to the military after passing both its harbour and oceanfaring tests. Taiwan plans to build another submarine if successful, with both to be deployed by 2027, according to the semi-official Central News

The Korean Central News Agency said Kim made the comments during a two-day session of the country's rubberstamp parliament which amended the constitution to include his policy of expand-ing the country's nuclear weapons programme. The Supreme People's Assembly's session on Tuesday and Wednesday came after Kim travelled to Russia's Far East

this month to meet with Russian President Vladimir Putin and visit military and technology sites.

The trip sparked Western concerns about a possible arms alliance in which North Korea

had the authority to declare it.

But experts say the amend-

would supply Putin with badly needed munitions to fuel his war on Ukraine in exchange for economic aid and advanced Russian technologies to enhance North Korea's nuclear and missile systems.

As North Korea slowly ends its pandemic lockdown, Kim has been actively boosting his partnerships with Moscow and Beijing as he attempts to break out of diplomatic isolation and join a united front against Washington. He has described the world as entering a "new Cold War" and that North Korea should advance its nuclear capabilities in response.

KCNA's reports on Kim's comments came a day after North Korea confirmed the release of US Army Pvt Travis King, who is now being flown back to America, two months after he sprinted across the heavily fortified border into the

North. King's relatively swift expulsion defied speculation that North Korea might drag out his detention to squeeze concessions from the United States, and possibly reflected the North's disinterest in diplomacy with Washington.

KCNA said members of the assembly gave unanimous approval to a new clause in the constitution to "ensure the country's right to existence and development, deter war and protect regional and global peace by rapidly developing nuclear weapons to a higher level."

North Korea's "nuclear force-building policy has been made permanent as the basic law of the state, which no one is allowed to flout with anything," Kim said in a speech at the assembly. He stressed the need to "push ahead with the work for exponentially boosting the production of nuclear weapons and diversifying the nuclear strike means," KČNA said. Kim pointed to what he described as a growing threat posed by a hostile United States and its expanding mili-

tary cooperation with South Korea and Japan, accusing them of creating the "Asian version of NATO, the root cause of war and aggression."

This is just the worst actual threat, not threatening rhetoric or an imaginary entity," he said. Kim urged his diplomats to "further promote solidarity with the nations standing against the US and the West's strategy for hegemony." South Korea's Unification Ministry, which handles relations with North Korea, said the North Korean constitutional amendment confirms Kim's unwillingness to relinquish his nuclear weapons program and his unwavering commitment to advancing that arsenal. It said in a statement that

Continuing his proposals of harsh policy changes, Indian-American presidential aspirant Vivek Ramaswamy, in his second Republican presidential debate, has said he would favour ending birthright citizenship for children of illegal immigrants in the US. The second Republican debate of the 2024 election cycle which was held at Ronald Reagan Presidential Library and Museum in Simi Valley, California on Wednesday, saw Ramaswamy sharing the stage with six other candidates including Florida Gov. Ron DeSantis and former United Nations Ambassador Nikki Haley.

When asked "what legal premise" he would use to expel undocumented immigrants and their Americanborn children from the country, Ramaswamy, the son of Indian immigrants, resurrected a 2015 proposal of ending birthright citizenship from then-candidate Donald Trump, reported the Washington Post on Wednesday. The first section of the cit-

izenship clause of the US Constitution's 14th Amendment says, "All persons born or naturalised in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside.

Although most agree with the long-held tradition that it grants citizenship to those born on US soil, some legal scholars argue that the phrase "and subject to the jurisdiction thereof" seems to give the government some leeway to restrict the right, just as other constitutional principles can be limited, the report said.

Because of this, he argued, children of undocumented immigrants born in the United States should not be granted citizenship, because their parents "broke the law" to be in the country.

Half of Nagorno-Karabakh's population has fled: Officials

## AP VEREVAN (ARMENIA)

The separatist government of Nagorno-Karabakh announced Thursday that it will dissolve itself and the unrecognized republic will cease to exist by the end of the year, and Armenian officials said more than half of the population has already fled.

That is after Azerbaijan carried out a lightning offensive to reclaim full control over its breakaway region and demanded that Armenian troops in Nagorno-Karabakh lay down their weapons and the separatist government dissolve itself.

A decree to that effect was signed by the region's separatist Samvel President Shakhramanyan. The document cited an agreement reached last week to end the fighting under which Azerbaijan will allow the "free, voluntary and unhindered movement" of Nagorno-Karabakh residents and disarm troops in Armenia in exchange.

Nagorno-Karabakh is a region of Azerbaijan that came under the control of ethnic Armenian forces, backed by the Armenian military, in sepa-ratist fighting that ended in 1994. During a six-week war in 2020, Azerbaijan took back parts of the region along with surrounding territory that Armenian forces had claimed

during the earlier conflict. Following the latest offensive and a cease-fire agreement brokered by Russian peacekeepers, Azerbaijan and Nagorno-Karabakh separatist authorities have begun talks on "reintegrating" the region back into Azerbaijan. Azerbaijani authorities have pledged to respect the rights of ethnic Armenians in the region and restore supplies after a 10month blockade. Many local residents, however, fear reprisals and have decided to leave for Armenia. By Thursday morning, more than half of Nagorno-Karabakh's population - over 65,000 people - had fled to Armenia,

The massive exodus began on Sunday evening, and the only road linking Nagorno-Karabakh to Armenia quickly filled up with cars that created an hourslong traffic jam.

On Monday night, a fuel reservoir exploded at a gas station where people seeking to leave were lining up for gas that due to the blockade had been in short supply. At least 68 people were killed and nearly 300 injured, with over 100 more still considered missing.

It isn't immediately clear if any of the ethnic Armenians that have populated the region will remain there. Shakhramayan's decree on Thursday urged Nagorno-Karabakh's population - includ-ing those who left - "to familiarize themselves with the conditions of reintegration offered by the Republic of Azerbaijan, in order to then make an individual decision about the possibility of staying in (or returning to) Nagorno-Karabakh."

Parliament. Just after Zelenskyy delivered an address in the House of Commons on Friday, Canadian lawmakers gave 98-year-old Yaroslav Hunka a standing ovation when Speaker Anthony Rota drew attention to him. Rota introduced Hunka as a war hero who fought for the First Ukrainian Division.

Observers over the weekend began to publicize the fact that the First Ukrainian Division also was known as the Waffen SS Galicia Division, or the SS 14th Waffen Division, a voluntary unit that was under the command of the Nazis.

"It is extremely troubling to think that this egregious error is being politicised by Russia, and its supporters, to provide false propaganda about what Ukraine is fighting for," Trudeau said. Net claims of non-residents on India increased USD 12.1 billion to USD 379.7 billion in the June guarter on account of higher rise in foreign-owned financial assets, according to RBI data released on Thursday.

Increase in reserve assets, at USD 16.6 billion, was the largest contributor to the rise in Indian residents' foreign assets during the April-June period, followed by direct investment, loans and trade credit, as per the data on India's international investment position' for June-end.

The rise in net claims of non-residents during the quarter was on account of higher rise in foreign-owned financial assets in India (USD 36.2 billion) when compared with Indian residents' overseas financial assets (USD 24.1 billion)," the Reserve Bank of India (RBI) said.

"Inward portfolio investment (USD 15 billion) and foreign direct investment (USD 8.9 billion) together accounted for two-thirds of the rise in foreign liabilities of Indian residents," it added.

As per the data, reserve assets accounted for 64.2 per cent of India's international financial assets at the end of the June quarter.

Variation in the exchange rate of rupee vis-a-vis other currencies impacted the change in liabilities, when valued in the US dollar terms, the RBI data said.

The RBI further said the ratio of India's international assets to international liabilities moderated to 70.9 per cent in June from 71.1 per cent a quarter earlier and 71.5 per cent a year ago. Debt and non-debt liabilities accounted for nearly equal share in total external lia-

similar show cause notice was served to online gaming company Gameskraft for recovery of Rs 21,000 crore GST. The company had approached the Karna-taka High Court which had quashed the show cause notice.

Following this, the revenue department in July filed a Special Leave Petition in the Supreme Court on the Karnataka High Court ruling in the Gameskraft case. The next date of hearing is listed for October 10.

A key monitorable, which will determine credit growth going forward, is the extent to which deposit growth picks up for banks, Crisil Ratings said

The retail credit demand will continue to go up in this fiscal but corporate credit demand is lagging, which is likely to pick up in the next fiscal on capex revival, the report noted.

In absolute terms, overall bank credit stood at Rs 148 lakh crore in FY23, clipping at 15.9 per cent year-on-year, and this is likely to grow to Rs 168 lakh crore or 13-13.5 per cent this fiscal and further grow to Rs 191 lakh crore or 13.5-14 per cent in the next, it added.

According to the agency, the credit demand moderation this fiscal will be because of the following four key reasons — gross domestic prod-uct growth is expected to fall to 6 per cent this fiscal from 7.2 per cent last fiscal, which will impact the overall credit growth.

Secondly, the easing of inflation with some cal



softening in commodity prices. 


