## SHOOTERS ADD TO GOLD HAUL MP Bidhuri faces

The men's 10m air pistol team continued India's success story at the Asian Games here, winning gold but two of the marksmen, who made it to the individual finals on Thursday, missed a medal.

The team of Sarabjot Singh, Arjun Singh Cheema and Shiva Narwal narrowly beat the Chinese team to take the top podium and earn India its fourth gold medal from the shooting ranges.
With Thursday's success,

Indian shooters have so far won four gold, four silver and five bronze medals.

The Indian trio's aggregate score of 1734 was just one better than the Chinese team. which settled for the silver medal, while Vietnam, with a score of 1730, bagged the bronze.

Sarabjot and Arjun also made it to the eight-shooter individual finals but finished fourth and eighth, respectively. Vietnam's Pham Quang Huy won gold with a score of 240.5, while South Korea's Lee Wonho (239.4) and Uzbekistan's Vladimir Svechnikov (219.9) took the silver and bronze, respectively.

Sarabjot, 21, finished fourth, scoring 199, while Arjun ended up eighth and last, exiting on the second elimination shot.

It was another fruitful day for Indian shooters, with Sarabjot, who will be celebrating his 22nd birthday on Saturday, giving himself an

early birthday gift as he led the air pistol trio to team gold, scoring 580 in the qualification round, while Cheema shot 578 and Narwal amassed 576 to aggregate 1734.

In the qualification round, whose aggregate score decides the team medallists, Sarabjot shot cards of 95, 95, 97, 98, 97 and 98 to aggregate 580 and entered the finals at fifth place.

Team-mate Arjun Cheema shot series of 97, 96, 97, 97, 96 and 95 for his 578 to also make the eight-shooter finals, placed

Shiva Narwal, the younger

brother of 2020 Tokyo Paralympic gold medallist in mixed 50m pistol Manish, came out of his elder sibling's shadow as the third member of the gold-winning team here, but he could not make it to the individual finals, finishing 14th.

Narwal shot series of 92, 96, 97, 99, 97 and 95 for his 576. This was the third team gold at the shooting ranges here after the 10m air rifle top-podium finish and women's 25-

metre pistol gold.
Sarabjot had won his first individual senior gold medal at the ISSF World Cup in Bhopal earlier this year, and was gunning for more success today in the individual category after being placed fifth among the eight finalists at the end of the qualification round.

But a string of below-par scores in the finals, undid his efforts in the qualification round. He managed just 9.8 and 9.4 on the third and fourth shots in the finals and another rank bad shot of 8.9 on the seventh shot pegged him further back from where he could not recover.

Sarabjot, whose success story started in 2021 when he



won the junior air pistol team and mixed team gold at the ISSF World Championships at Lima, Peru in 2021, has been performing consistently ever since, bagging the mixed team gold at the recently-concluded World Championships in Baku, Azerbaijan.

He would now be aiming to seal a 2024 Paris Olympics quota place at the Asian Championships in Changwon (South Korea) later this year.

Meanwhile, Indian men's and women's teams assured themselves of medals at the Asian Games after progressing to the semifinals of the squash events here on Thursday.

While the men's team blanked Nepal 3-0 in its final pool tie, the women were handed a 0-3 loss by Malaysia in their last pool B fixture. Both teams sealed top two spots in their respective pools to make the semifinals which guarantees them at least a bronze.

The Indian women's team began the day with veteran Joshna Chinappa enduring a 6-11, 2-11, 8-11 defeat to Subramaniam Sivasangari in 21 minutes. In the second match, Tanvi Khanna squandered a 2-1 lead before going down to Commonwealth Games gold medallist Aifa Binti Azman 9-11, 11-1, 7-11, 13-11, 11-5.

## **Privileges Committee**

ok Sabha Speaker Om Birla Lhas referred the complaints lodged by several MPs on the issue involving BJP member Ramesh Bidhuri's use of objectionable words against BSP's Danish Ali to the Privileges Committee, sources said on Thursday.

While Ali and several other
Opposition MPs, including
Congress leader Adhir Ranjan
Chowdhury and DMK's
Kanimozhi, wrote to the Speaker seeking action against Bidhuri, some BJP parliamentarians like Nishikant Dubey said the BSP member "incited" the South Delhi MP when he was speaking in the House and urged the Chair to look into this as well.

Sources said Birla has sent all these complaints to the Privileges Committee headed by BJP MP Sunil Kumar Singh.

Bidhuri had made certain derogatory remarks, later expunged from records, target-ed at BSP member Danish Ali on September 22 when he was speaking in the Lok Sabha during a discussion on the success of the Chandrayaan-3 mission.

Defence Minister Rajnath Singh, who was present in the House, expressed his regret at the ruling party MP's conduct.

As opposition parties rallied around Ali after a video of Bidhuri's remarks went viral triggering an outrage, the Lok

Sabha Speaker took "serious note" and warned him of "strict action" if such behaviour is repeated in the future.

The BJP also issued him a

show-cause notice. Ali wrote to the Speaker, seeking an enquiry by the Privileges Committee, describing Bidhuri's comments as

"hate speech".

Almost all Opposition parties also wrote to Birla, seeking action against him.

However, a few BJP MPs, including Dubey, asserted that Ali incited Bidhuri with highly objectionable remarks against the Prime Minister.

While Dubey condemned Bidhuri's conduct, he urged the Speaker to look into Ali's behaviour as well. Other BJP MPs echoed the view.

In a post on X on Thursday, Dubey thanked the Speaker for referring the matter to the committee.

"It was possible because the BJP has a majority in Lok Sabha," he said, as he cited several previous incidents to assert that no committee was formed to probe these issues and nor was anyone punished.

In this context, Dubey alleged that the RJD-JD(U)-Congress members were engaged in a fight involving shoes and microphones in 2006, Sonia Gandhi was involved in an incident in 2012 besides the commotion and injuries to parliamentarians in

2014 during the creation of Telangana as a separate state. Opposition leaders have slammed the BJP over Bidhuri being given poll responsibility by the party in Rajasthan's Tonk district.

In a post on X, Rajya Sabha MP Kapil Sibal said the BJP has "rewarded" Bidhuri for attacking Ali with the "unspeakable words" in Parliament.

"BJP rewards 'hate'. Bidhuri rewarded for attacking Danish Ali (BSP) for the unspeakable words he used in the Special Session of Parliament. Made BJP in-charge of Tonk District in Rajasthan."

Congress general secretary Jairam Ramesh, in a post on X last night, said, "Sabka saath, sabka vikas, sabka vishwas' yeh sab hai inka bakwaas."

TMC MP Mahua Moitra also slammed the BJP and said Bidhuri had been "rewarded" for his remarks against a Muslim MP. "How does a showcaused person be given a new role by BJP? Narendra Modi ji, is this your Sneha Yatra for minorities, your love outreach?" she said on X.

Congress leader Shashi Tharoor said, "So much for the #BhajaParty's show cause notice! The foul-mouthed MP is now in charge of Tonk, where no doubt he will have plenty of opportunities to polarise the electorate even further with his divisive

## Khalistanis at it again

Operatives of Khalistani ter-rorist outfit Sikhs For in a statement. Justice (SFJ) painted pro-Chalistan graffiti in Delhi on Wednesday, a month after defacing several Delhi Metro stations with similar slogans.

According to the police, "Delhi banega Khalistan" and "Khalistan Zindabad SFJ" slogans were found painted on both sides of the Kashmiri Gate flyover connecting North Delhi and North East Delhi and at some other places. The Delhi Police removed the graf-

fiti soon after they spotted it. Gurpatwant Singh Pannun, the US-based Khalistani terrorist and chief of the SFJ, claimed responsibility for the illegal act and threatened to storm the "Modi Stadium" Ahmedabad on October 5.

"Khalistanis from Canada are in Delhi to avenge assassi-

der Section 153 of the IPC (Indian Penal Code) and the Delhi Prevention of Defacement of Public Property Act against unidentified miscreants and an investigation has been launched in this connection," an official said on the condition of anonymity.

In a statement, the Delhi

Police said, "A video came to notice on September 27, wherein certain visuals showed defacement through graffiti. According to the signage boards visible in the video, an extensive search was conducted in the North District area, and graffiti was discovered on Yudhister Setu flyover, heading from Seelampur towards Kashmere Gate.

"An FIR has been filed under the relevant sections of nation of Nijjar," Pannun said the IPC and Delhi Prevention of Defacement of Public "A case has been lodged Property Act, and it is currently under investigation?

It is being said the defacement of walls in the national Capital was in response to the raids conducted by the National Investigation Agency on Wednesday across Punjab, Haryana, Delhi-NCR, Rajasthan, Uttarakhand and Uttar Pradesh in three separate cases linked to the terror-gang-

ster-smuggler nexus. The incident comes a month after similar pro-Khalistan slogans were sprayed on the walls of more than five Metro stations in the national Capital. "Delhi Banega Khalistan and Khalistan Zindabad" slogans were written on the walls.

Similar slogans were also

found on the walls of a Government school in Nangloi.

The crackdown on Khalistan elements came amid diplomatic tensions between India and Canada over the killing of Khalistan terrorist Hardeep Singh Nijjar.

Tensions escalated between India and Canada after Prime Minister Justin Trudeau made a serious allegation regarding the potential involvement of Indian agents in the murder of Nijjar, a Khalistani extremist, in British Columbia on June 18.

India had designated Nijjar as a terrorist in 2020. India has, as a terrorist in 2020. India has, however, strongly rejected Trudeau's allegations terming it as "absurd" and "motivated" and expelled a senior Canadian diplomat in a tit-for-tat move to Ottawa's expulsion of an Indian official over the case.

## Green Revolution Icon passes away

The new generation may not be aware of it but India had a recent past when the then Prime Minister of the country himself had asked the people to skip a meal daily so that the country's hunger could be satisfied to a certain extent.

The Prime Minister was none other than Lal Bahadur Shastri and the country was undergoing severe drought caused by deficient Monsoon and low productivity of the seeds and soil.

"We were leading a ship to mouth existence. Every day ships laden with wheat given by the USA under its PL-480 programme would arrive in Indian ports to feed the crores. Those were the days when India was dependent on the wheat offered by the USA," Professor MS Swaminathan, who breathed his last on Thursday morning, used to recall.

Kumbakonam-born Swaminathan was 98 and is survived by three daughters, Soumya, Mathura and Nitya. His wife Mina predeceased

Swaminathan, a plant geneticist by training, returned to India to work for the Indian Agricultural Research Institute and he had a dream of developing high yield varieties of rice and wheat, the staple food of the sub-continent's population.

Along with Dr Norman
Borlaug, the Nobel Laureate
and with the political patronage extended by C Subramaniam, the then food and Agricultural Minister of India, Professor Swaminathan launched the Green Revolution, which was the foundation stone of India's selfreliance in food production.

Within a decade, India became a food surplus State from a food deficient country. Having resolved the issue of food shortage, Professor Swaminathan turned his attention to other areas about which the then political leadership was ignorant. He drew the attention of the policy makers towards the poor mortality rate of women and children because of the shortage of nutritious food.

Professor Swaminathan also alerted the Government of It was the time when the day about LBW, the low

birth weight, of the newborn. "Every third child born in

India and several South Asian countries is characterised by low birth weight. The LBW children, resulting from maternal and foetal undernutrition, suffer setbacks in brain development and several serious health problems in adult life. Such enforced handicaps at birth represent the cruelest form of inequity in the emerg-ing knowledge age," he had

warned in 1999. Had the Governments of the day listened to his words, India would have experienced the Amrit Kaal long back. For Professor Swaminathan, agricultural research was not something to be confined to the laboratory. He was at home interacting with farmers, fishermen and agricultural workers to get first hand information about their grievances and problems.

He travelled to Orissa and Wayand in Kerala to study the traditional style of farming operations. The credit for informing the world about the vast collection of conventional rice seeds under the possession of tribals in Orissa should

go to him only. It was his vision to set up pulse and cereal villages across the country to address the malnutrition faced by the rural and urban folks. Professor Swaminathan stands out because of his strong views on sustained development. He was of the view that development and urbanisation were unavoidable, it could be done with minimum damage to the environment and ecology

"The coming decades will prove that whoever controls the genes and seeds would control the world. The days of nuclear warheads and conventional wars are over," he had said in his speeches.

The MS Swaminathan Research Foundation at Taramani in Chennai is a standing monument to the Father of India's Green Revolution. When he was awarded the first ever World Food Prize in 1987, he used the prize money of \$250,000 for setting up the MSSRF, a world class research institute and think tank on agricultural research.

Though he was for inter-linking of Indian rivers and

genetically modified seeds, Professor Swaminathan stayed away from all controversies.

He held the view that "if there are reservations against the GM foods and inter linking of rivers, we should try to address the apprehension in the minds of the people".

Since 2000, he has been

asking the authorities to include millets as a staple food in the food basket. The National Farmers Commission recommendations (which he headed) had asked the Government of India in 2005 itself that procurement price of farm products produced by them should be given twice the amount they spent on cultivation.

The recommendations are yet to be implemented in full. "Anything can wait but not agriculture," was his catchword till the end.

Professor Swaminathan had been honoured with Padma Vibhushan, Padma Bhushan and Padma Sri in addition to nearly 90 honorary doctorates.

Condolences poured in with President Droupadi Murmu and Prime Minister Narendra Modi hailing Swaminathan's yeoman service to the nation.

Murmu said Swaminathan left behind a rich legacy which would serve as a "guiding light to steer the world towards a safer and hunger-free future for humanity".

Modi said his groundbreaking work transformed the lives of millions, ensured India's food security.

Modi said on X: "Deeply saddened by the demise of Dr MS Swaminathan Ji. At a very critical period in our nation's history, his groundbreaking work in agriculture transformed the lives of millions and ensured food security for our

"I will always cherish my conversations with Dr Swaminathan. His passion to see India progress was exemplary. His life and work will inspire generations to come. Condolences to his family and admirers. Om Shanti."

The Congress party described him as the key scientific architect of the Green Revolution and hailed his contribution to the agriculture



## Police 'lies' on crackdown against criminals exposed

#### Two cops sent to RPL, probe ordered

The footage of a CCTV camera exposed how the men in khaki were patting their backs, citing action against "criminals". The alleged disclosure came to fore in Meerut after which two policemen were sent to Reserve Police Lines and a probe was ordered in the matter.

According to reports from Meerut, two police constables posted in Kharkhoda police station faced action after they were accused of arresting a youth by keeping a pistol in a bike and later showing its

The youth, identified as Ankit Tyagi, was arrested on Tuesday. His family members alleged that constables Santosh Kumar and Dinesh posted at Kharkhoda police station reached their residence in Khandavalli village on Tuesday night to search it and claimed that they had received information about illegal weapons in the house.

According to family members, during the so-called search, a country-made pistol was recovered from the bike, but later after examining the CCTV footage, it was found that the two policemen them-selves had kept it in the bike.

The family members of the arrested youth reached the office of Inspector General of Police Nachiketa Jha on the same night and kept pleading to intervene in the matter. In the meantime, the Kharkhoda police booked Ankit Tyagi

under the Arms Act. On Wednesday morning, the family met Jha and showed him the entire CCTV footage. Shocked with the development, Jha ordered Senior Superintendent of Police Meerut Rohit Singh Sajwan to investigate the matter.

Sajwan said that on the basis of the CCTV footage, both the accused policemen were removed from Kharkhoda police station and transferred to Reserve Police Lines. He said that the investigation into the case had been handed over to Additional Superintendent of

Police (Rural Area) Kamlesh Bahadur.

He said appropriate action would be taken on the basis of

the outcome of the probe. Meanwhile, Samajwadi Party (SP) president and former chief minister of Uttar Pradesh Akhilesh Yadav took a

dig at the functioning of the police, citing this incident.

Taking to social media platform X (formerly Twitter),
Akhilesh said: "First they keep it (weapon) themselves and then recover it, their raid is false and their detention is false."

Uttar Pradesh Congress spokesman Anshu Awasthi also attacked the government over the issue, claiming that the policemen in UP were having a nexus with criminals and arms dealers, hence they were carrying illegal country-made weapons which they use to book people under Árms Act and later pat their backs in the name of crackdown on criminals. Awasthi demanded that on the basis of the recording of CCTV footage in Meerut, it was clear that the illegal weapon was in possession of the two constables, so the innocent youth must be released immediately and both the policemen should be arrested

## Youth threatens to defame ex-girlfriend, arrested

A former boyfriend of a girl and his current girlfriend were accused of threatening to defame the former, using her old photos, in Krishna Nagar. A case was registered in this regard on Wednesday. He was arrested on Thursday.

The victim fell in love

with a youth named Atal Porwal of Bahraich district after they came in contact through a wrong phone call. Atal is studying in New Delhi.

In due course of time, they considered getting married. "He made physical relations after promising to marry me but later deserted me," the victim alleged. She said Atal later moved on and befriended another girl.

"Both of them harassed me and I was asked to forget Atal. Atal has my photos and videos which he is threatening to share on social media. His current girlfriend is also helping him. He abused me and threatened to reach my home and defame me," she alleged.

Police registered a case under relevant sections of the IPC. A spokesman said the accused was arrested on Thursday.

Meanwhile, an FIR was registered on Thursday against a lawyer and his group for allegedly manhandling cops and insulting a traffic police officer during a drive in Hazratganj on Wednesday. The arrest was made after a video of the incident went viral on social media on Thursday.

"An FIR was registered under sections 506 (criminal intimidation) and 353 (assault or criminal force to deter public servant from discharge of his duty)," the Hazratgani police said.

The police said that the accused was identified on the basis of the vehicle number which was seized. Along with the vehicle owner, several others were also booked.

According to the traffic police, the group of men came dressed as advocates and manhandled and misbehaved with a traffic cop who had towed a vehicle parked in the 'no parking' zone.

'They took back the vehicle parked in the towing yard at Hazratganj without paying the challan. The owner was booked on the basis of the vehicle's registration number. Others who are unidentified will be arrested soon," the traf-

In the viral video, a group of men dressed as lawyers was seen misbehaving with a traffic cop. One of the men intimidated the cop when he was shooting a video with his phone and was heard threatening and using offensive lan-

guages.

In order to control the traffic and dissuade people from parking their vehicles on roads, a towing drive has been underway since July 24.

#### **Teacher orders Muslim student** to slap Hindu classmate, held

**Sambhal (PTI):** A school father alleged that his son is a teacher was arrested on student of class 5 in the school Thursday for inciting communal hatred after she allegedly ordered a Muslim student to slap a Hindu classmate for not answering a question, police said. The incident took place at a private school on Tuesday in Dugawar village under the Asmoli police station limits in Sambhal district, they said.

On the basis of a complaint filed by the Hindu boy's father, the teacher, Shaista, was booked under IPC sections 153A (promoting enmity between different groups on grounds of religion, race, etc) and 323 (voluntarily causing hurt), Additional SP Shrish Chandra said. The accused teacher has been arrested, the official added. The boy's

where his class teacher got him slapped by a Muslim student after he could not answer a question asked by her. In his complaint, the father said that this hurt his son's religious feelings. A probe is on in the matter, Additional SP Chandra said.

In a similar incident at Khubbapur village in Muzaffarnagar last month, a teacher of a private school had got a Muslim child slapped in a class by his classmates for not doing homework. A case was registered against the accused teacher, Tripta Tyagi, under IPC sections 323 (voluntary causing hurt) and 504 (intentional insult with intent to provoke breach of the peace).

#### Girl dragged by crocodile in canal

Lakhimpur Kheri (PTI): An 18-year-old girl was dragged by a crocodile into a canal here when she was washing her feet in it, police said on Thursday. According to police, one Kamini Vishwakarma, a resident of Dulhipur village, was attacked by a crocodile Tuesday evening. Dulhipur village is located along the Sharda canal in which crocodiles often take shelter during monsoon.

Villagers said Kamini along with her friends had gone to a field to graze her goats Tuesday evening. When she went to Sharda canal to wash her feet, a crocodile pounced upon her and dragged her inside the water, said one of the villagers. Her friends raised an alarm but the reptile vanished into the water with the girl.

## UP RERA chairman urges buyers to adopt model agreement for sale

and booked under the Arms

Lucknow (PNS): The objective of UP RERA (Real Estate Regulatory Authority) is to create an environment where all buyers in the state's real estate sector can have financial security when purchasing houses, shops, or flats. Chairman of UP RERA Sanjay Bhoosreddy said on Thursday that one of the primary goals of consumer protection is to ensure that at the time of booking, consumers can transfer their funds to the promoter according to specific rules and a standardised documentation system that provides them with maximum financial security.

He mentioned that the draft Real Estate (Regulation and Development) (Agreement for Sale/Lease) Rules of 2018

were officially announced by the Government of Uttar Pradesh on October 17, 2018, taking into account all the necessary aspects for stake-

"Under Section 13 of the RERA Act, a draft agreement for sale is available, accessible through the official website (www.up-rera.in). A promoter shall not accept an amount exceeding ten percent of the cost of the apartment, plot, or building, as the case may be, as an advanced payment or application fee from a person without first entering into a written agree-ment for sale with that person and registering the side agreement for sale under any applic-

Lucknow (PNS): In a case of cyber fraud, a senior female CGST official was duped of over Rs 47,000 on the pretext of delivering an item which she had purchased online in Gomti Nagar. The incident took place on September 17 and a case was registered in this connection on September 22. However, the issue came to light on Thursday.

In her complaint, the officer said that she was tracking the delivery of the item which she had ordered online and came to know that it had reached the company's warehouse in the city. 

## BHU team enhances vehicle battery life

Tn a groundbreaking innova-Ltion that has the potential to transform the energy storage landscape, a team of researchers from the Department of Physics, Institute of Science, Banaras Hindu University (BHU) has successfully synthesised cutting-edge cathode materials designed to charge sodium ion batteries. These materials promise enhanced capacity and prolonged battery life, leading n more powerful lasting sodium ion batteries. A prototype battery pack featuring these innovative cathode materials has already been put to the test in an e-bicycle. Traditional lithium-ion batteries have long been the go-to choice for energy storage, but sodium ion batteries offer a compelling alternative. Unlike lithium, sodium is abundant and inexpensive, making it an eco-friendly choice. Moreover, sodium ion batteries possess chemistry similar to lithium, adding to their appeal. However, challenges like safety, stability, and energy density have held back their widespread adoption. A team of dedicated scientists from

Physics department, BHU led impact international journals by Prof Rajendra Kumar Singh like the Journal of Power

Other members of the team included Raghvendra Mishra, Rupesh Kumar Tiwari, Anupam Patel, Anurag Tiwari, Vikash, Shitanshu and Samriddhi. The team not only developed sodium nickel manganese cobalt oxide (Na-NMC) and sodium nickel manganese iron oxide (NFM) cathode materials but has also designed novel sodium super ionic conducting solid-state electrolytes tailored specifically for sodium ion batteries. This achievement was made possible through support from the Ministry of Education and the SERB-supported IMPRINT II project. These findings have been featured in reputed, high-

Materials and Interfaces, Energy & Fuels, Journal of Energy Storage, and Chemical Engineering Journal, etc. The newly created cathode materials offer both high capacity and extended battery life, revolutionizing sodium ion batteries. The breakthrough lies in the innovative sodium super ionic conducting solid-state electrolytes, which efficiently transport sodium ions within the battery. This development significantly enhances the battery's safety, stability, and energy density. To complement this achievement, an industry collaborator has developed a compatible battery management system (BMS) and a suitable charger. According

to Prof Rajendra Kumar Singh, "Sodium ion batteries hold the key to providing a cost-effective and sustainable energy storage solution. This breakthrough has the potential to accelerate the adoption of electric vehicles, renewable energy systems, and overall energy sustainability."

The research journey involved synthesising solid electrolytes, optimising the composition of NaNMC and NFM cathode materials, and fabricating cylindrical cells. A prototype battery pack, consisting of sodicylindrical c 6Ah pack), was tested in an ebicycle, achieving an impressive 54 km distance on a single charge with a maximum speed of 30 km/hr. As the world places an increasingly urgent emphasis on sustainability and cost-effectiveness, these advancements by the research team could serve as a significant boost to the 'Make in India' initiative and facilitate the commercialisation of sodium ion batteries. With readily available raw materials, the potential for cost reduction, and increased energy density, sodium ion batteries have the potential to reshape our energy storage landscape, propelling us toward a cleaner and more sustainable world.

## Big guns roll out

The BIP leadership is taking no chances in Madhya Pradesh, fielding 3 Union Ministers in Assembly polls

ith elections to five Assemblies scheduled by this year end, political tempera-ture is already on the rise. However, as the situation persists today, the battle-ground of Madhya Pradesh has taken the lead in evoking competition and wonderment more fierce than in the other four States. As the X factor in these elections for the BJP is the party's decision to bring back to fight the Assembly polls three Ministers from the Union Government, at least four sitting MPs representing the State and other senior party office bearers holding influence across castes, religion and region. The ruling party has come up with its second list of 39 candidates for Madhya Pradesh. This move comes as the party faces tough competition from the Congress. The BJP has made a bold move by fielding heavyweights, including Union Ministers, to maintain its stronghold in the State. Union Ministers Narendra Singh Tomar, Prahlad Patel and Faggan Singh Kulaste, along with party MPs Rakesh Singh, Ganesh Singh, Reeti Pathak and



Uday Pratap Singh, as well as general secretary Kailash Vijayvargiya, will now contest the Madhya Pradesh Assembly elections. The inclusion of these prominent leaders as candidates has also opened up the field for chief ministership aspirants; Narendra Singh Tomar, Prahlad Patel and Kailash Vijayvargiya are now considered strong contenders.

Shivraj Singh Chouhan has held the CM's post for nearly 20 years, with a brief interruption after the 2018 elections. The BJP is concerned about fatigue setting in regarding Chouhan. During a recent rally, Prime Minister Modi did not mention Chouhan even once. Meanwhile, Congress is emerging as a formidable con-

tender under former CM Kamal Nath's leadership. This election promises to be a riveting showdown, with significant implications for Chouhan, besides the State's political future. Though Chouhan has served as the Chief Minister for multiple terms and is widely credited as a popular leader, his reputation and political future are now closely tied to this poll's outcome. If the BJP manages to secure a comfortable majority, it will consolidate his position within the party and strengthen his leadership in the State. On the other hand, a loss could raise questions about his ability to win elections and govern effectively. Kamal Nath, a seasoned politician, is working to consolidate the party's base and capitalise on anti-incumbency sentiments. The Congress' performance in recent by elections has been promising, boosting its confidence. The party is banking on issues such as unemployment, rural distress. Its campaign is centred on the promise of "change and improved governance". Meanwhile, the BJP's decision to field its stalwarts is an ominous sign for Chouhan and shows the party's dwindling faith in his leadership. Antiincumbency and a number of unsavoury incidents have led to the erosion of his reputation which could cost the party an important State in the Hindi heartland. The BJP would not like that to happen just ahead of the 2024 general elections.

## Air pollution renders antibiotics ineffective



A 'Lancet' study has established a connection between bacterial antibiotic resistance and air pollution; inhaling PM 2.5 can lead to antibiotic resistance

here was a sense of palpable urgency to change, air pollution and degradation of the environment at the recently concluded three-day G20 summit held in New Delhi. Led by India, the G20 nations agreed to urgently accelerate their actions to address environmental crises and climate change challenges with the help of a green development plan. This in a way reflects the prophetic warning to world leaders by the UN Secretary-General António Guterres at the 27th Conference of the Parties to the UN Framework Convention on Climate Change (COP27) held in 2022, that humanity is on a "highway to climate hell with a foot on the accelerator". Because 80 per cent of the world's greenhouse gas emissions emanate from G20 nations, the member nations needed to understand the gravity of the problem and ensure meaningful progress in this

As the stakes for mankind keep rising thanks to rising pollution and climate change, keeping global average temperatures below 2 degrees centigrade alone may not be the urgent goal of the nations. Newer and more perilous problems are arising due to unabated pollution levels. A recent study published in the health journal "Lancet" has established a connection between bacterial antibiotic resistance and air pollution, particularly PM 2.5. The study suggests that PM 2.5 contains elements of antibiotic resistance, and inhaling this pollutant can lead to an increase in the spread of antibiotic resistance. The authors of the study aimed to estimate the global premature death toll caused by resistance to antibiotics due to PM 2.5 pollution.

PM 2.5 refers to particulate matter with a diameter of 2.5 micrometres or smaller. These particles, consisting of solid and mid elements, are of varying sizes, with some, like dust and soot, visible to the naked eye and others, such as PM 2.5, only observable under electron microscopes. Inhaling these pollutants can pose serious health risks, especially to the respiratory sys-

tem. The Lancet study compared and analysed the PM 2.5 levels with levels of antibiotic resistance and made a disturbing discovery that the higher the pollutant level, the greater the antibiotic resistance. PM 2.5 are smaller than human hair and contains antibiotic resistance elements.

As these pollutants travel through the ambient air, they disperse antibiotic resistance elements, which can then be inhaled by humans which in turn sets in motion the resistance. The concerning aspect is that antibiotic-resistant bacteria can withstand antibiotic treatments, rendering the drugs ineffective against them. Antibiotics are primarily used to eliminate microorganisms, especially bacteria, but resistant bacteria are impervious to their effects. The data for this research

was collated from 116 countries utilising sources like ResistanceMap, the European Center for Disease Prevention and Control Surveillance Atlas, and the PLISA Health Information Platform, Overall, nine pathogens and 43 drugs were analysed. It was observed that the surge in antibiotic resistance among bacteria is largely attributed to the indiscriminate use of antibiotics. Repeated and widespread

antibiotic usage can empower bacteria to develop resistance over time, often facilitated by Antibiotic Resistance Genes (ARGs). Pathogenic bacteria, responsible for infections and diseases, can acquire antibiotic resistance through ARGs in a process known as horizontal gene transfer.

The Lancet health report concluded that the need of the hour is to address the PM2.5 levels. Without this, antibiotic resistance may increase by approximately 17%, with related deaths rising by 56% globally by 2050. Conversely, adhering to the World Health Organization's recommended PM 2.5 level of 5 µg/m³ could lead to a 17% reduction in antibiotic resistance and a 23% decrease in deaths. But this is easier said than done. Of the world's 30 cities with the worst air pollution, 21 are in India. Capital New Delhi is the worst with PM 2.5 being nearly 10 times higher than the World Health Organisation levels.

According to the CleanAir organisation India sees 2 million early deaths and a loss of 95 billion to the economy due to PM 2.5. Given these bleak conditions, India needs to cover a lot of ground to rein in PM 2.5 levels while there is still time. The National Clean Air Program (NCAP) is a deter-

mined step in the right direction, but it needs more grit and resolve behind it if the initiative has to succeed.

Some major steps are the need of the hour for India. Firstly, immediate curbs on ammonia release in farms are essential, this must be followed by a full ban on refuse burning. Apart from this rural brick kilns must be persuaded to shift to cleaner kiln-firing technologies. Urgent efforts also need to be made to convert coal-based power plants to clean energy, as this by itself will make a huge difference. To make this a reality, India must make a push for creating the correct financial architecture through investment funds with a dedicated green focus that can play an instrumental role in catalysing the growth of green industries and simultaneously addressing the twin problems of air pollution and climate change. These funds would combine a returns-driven strategy with the sustainability imperative and accelerate investment in green industries. Measures such as these can help India fight air pollution and prevent a calamitous future where common antibiotic efficacy is not held to ransom by polluted air.

#### **SIMULTANEOUS ELECTIONS**

#### **RESPECT INDIA'S SOVEREIGNTY**

Canada must not allow its soil to be used for anti-India activities

story of agents executing transnational operations, intelligence agencies sharing crucial information, backchannel diplomatic conver-Asations, political instability and every chapter from a racy spy thriller is playing out for the world audience, with Canada and India in the lead for the past few weeks. In a hurried and perhaps half-baked allegation Canadian PM Justine Trudeau blamed Indian agencies for carrying out extra-territorial executions of Canadian citizens.

India was quick to retort with a terse statement, which instead pointed out the long-standing issue of concern between the two countries in the form of Canada allowing Indian separatist groups to operate out of their country. The Indian statement said unequivocally "We have seen and reject the statement of the Canadian Prime Minister in their Parliament, as also the statement by their Foreign Minister. Allegations of the Government of India's involvement in any act of violence in Canada are absurd and motivated. Similar allegations were made by the Canadian Prime Minister to our Prime Minister and were completely rejected. Such unsubstantiated allegations seek to shift the focus from Khalistan terrorists and extremists, who have been provided shelter in Canada and continue to threaten India's sovereignty and territorial integrity. We reject any attempts to connect the Government of India to such developments. We urge the Government of Canada to take prompt and effective legal action against all anti-India elements operating from their soil."

What is happening in the bilateral relationship is not a recent development but has been brewing for decades. Nearly forty years back India had demanded the extradition of a terrorist from Canada, responsible for one of the worst plane bombings in history, killing everyone on board an Air India flight. The several convicts responsible for the act of terror were never convicted by Canada, despite repeated inputs from India abandoning victims' families chasing long winding court cases for decades.

The reason Canada allows or even nurtures these anti-India forces



on its soil leads through the corridors of domestic politics. Millions of Indians particularly from Punjab make a substantial chunk of the Canadian demography. While most of them earn an honest living and are peaceloving, some notorious elements have managed to sneak into Canada, working through well-oiled semi-government machinery. Over some time, these criminals and terrorists wanted by India, have managed to control important real estate through the Gurudwaras committees. These mafiacontrolled gurudwaras also serve as a conduit for fulfilling the immigration dream of thousands of Punjab youth, working with their India handlers across Punjab and several other states of north India. The modus operandi for getting ground force for staging anti-India acts from Canadian soil starts with a letter issued by Indian handlers, about the youth facing discrimination, and persecution due to his religion, in India. This sets the ball rolling for the youth to get an easy Canadian citizenship, on mercy grounds and feeds into domestic political narratives. In the present case too, the trigger was PM Trudeau's falling political popularity. A few months back he accused China of meddling with domestic politics even as he was trying to warm up the India bilateral, through a trade deal.

Canada understands the rising importance of India in the new global order, especially with China and Russia facing flak. It understands that a powerful, resilient, democratic India is important for a prosperous Indo-Pacific region, which indirectly translates to bringing more prosperity to its citizens. However, the domestic political concerns rise above geopolitics, and retaining the chair as PM seems more important for Trudeau at the moment. It may be argued that several news reports have pointed to US intelligence aid in Canadian allegations against India, however, the US knows which way the wind is blowing.

## Regulatory boost to self-sufficiency in energy



Modi Government is giving considerable policy support for the exploration of hydrocarbons so that investors can earn assured return on their investments

elivering the 75th Independence Day address, Prime Minister Narendra Modi set the country a target to achieve self-reliance in energy production by boosting the gas-based economy (besides giving a push to electric mobility and hydrogen production). Modi wants the share of natural gas (NG) in the total energy mix to go up from the current around 6 per cent to 15 per

Currently, India imports 50 per cent of its NG requirement. This is because domestic production is hovering around a low of 28.6 - 34 billion cubic metres (bcm) in 2020-21 to 2021-22 (down from a peak of 52 bcm in 2010-11). There is a dire need to give a massive push to domestic output to meet the target. India has 26 sedimentary basins (SBs) covering an area of 3.4 million sq km that could be searched for hydrocarbon resources. Only six of the SBs are under commercial exploitation; these too are sub-optimally utilized.

Hydrocarbon exploration is a highly capital-intensive and technology-intensive business involving a long-gestation period. It is risk-prone especially when it comes to drilling in deep/ultra-deep and high-pressure/high-temperature (D/UD/HP/HT) fields in offshore areas such as the Krishna-Godavari (KG) basin. However, these areas offer maximum promise in terms of reserves.

Multinational companies (MNCs) such as ExxonMobil, Chevron Total etc. which have the technology and resources can be enthused to take longterm bets in the Indian hydrocarbon sector provided the government offers them an opportunity to earn an attractive return on their investment in a 'sustained' basis. This in turn, requires that their efforts in the discovery and development of NG fields don't face regulatory hurdles leading to the commencement of production within a reasonable time frame and that they can sell the gas 'freely' at a 'remunerative' price. In all three areas, the MNCs faced impediments in the past. In recent years, the Modi – government has made significant progress in removing these though, a lot more ground remains to be covered. Let us look at the regulatory landscape.

Nearly 50 percent of SB area or 1.73 million sq km lies offshore. Out of this, until recently 0.69 million sq km lay in the prohibited zone (fondly referred to as 'No go' area) due to security reasons. Now, the incumbent government has released a 0.67 million sq km sedimentary basin lying offshore. This should give a big boost to exploration and production (E&P) activity.

Until hitherto, É&P firms were getting lease rights for short tenure though extendable by 10 years for gas/oil & gas fields and by five years for oil fields. They had to go to the bureaucrats to seek approval for an extension of the lease which came in the way of undertaking long-term investment commitment.

Now, the government has granted E&P rights over the entire economic life of the allotted fields (this could extend up to 30 years, even beyond depending on the available reserves and the pace of their exploitation) instead of the extant system of allowing extensions. This will enthuse global firms to undertake long-term investment bets as they know for sure in

The government has passed the Forest (Conservation) Amendment Bill, which says that seismic surveys (it is done in the initial stage to determine evidence of economically viable hydrocarbon resources below the ground) won't be treated as a non-forest activity. This implies that explorers would be granted prompt access to forest areas, thereby saving time spent on seeking permits.

Under the Hydrocarbon Exploration and Licensing Policy (HELP), also known as the Open Acreage Licensing Policy (OALP) launched in 2017, E&P firms are allowed to pick up a block of their choice unlike the earlier New **Exploration and Licensing Policy** (NELP) (launched in 1999) wherein they had to accept what the government offered. Besides, under OALP, an operator gets a composite license to search for hydrocarbon in whatever form; for instance, if it is 'shale gas', she won't need a separate license for extracting it.
For long, E&P efforts were

hamstrung by cumbersome procedures, multiple approvals and bureaucratic red tape. Approvals were needed at every stage viz. preparation of field development plans (FDP) including its revision, and extension of the contract, drilling wells, conducting tests to determine the commercial viability of the field, annual work program (AWP), laying the pipeline, reviewing production and so on. As many as 37 processes and procedures were required to be followed by a firm-awarded block under NELP.

Team Modi has substantially liberalised and de-bureaucratised the approvals. It has identified 22 processes for which self-certification of documents by contractors is accepted. Besides, it has provided for pre-approved clearance of blocks which will substantially cut the time lost in taking approvals. The government is also keen to opt for globally recognised and accepted dispute resolution mechanisms and play-based explo-

Moreover, the 'revenue sharing' model under the OALP (currently in vogue) allows the operator to share an agreed percentage of the revenue with the month and notified every month. unlike the production sharing contracts (PSC) under erstwhile NELP wherein she could fully recover the cost incurred in exploration and development of the field before sharing profits with the GOI. The former does away with an additional layer of approval which was intrinsic to the latter wherein the costs incurred at every stage were subject to official scrutiny.

Coming to the selling of NG and realisation therefrom, in respect of gas from fields given under HELP/OALP, the operators are allowed freedom of pricing and marketing. This is a big positive for E&P firms that are being allotted fields under this policy. Furthermore, supplies from the socalled marginal fields (there are a total of 149) previously with the central PSUs viz. ONGC and OIL auctioned to private entities during 2020/21 are also eligible for freedom of pricing.

However, supplies from the socalled Legacy fields which account for the bulk of the current gas supply are subject to government control over price as well as the marketing of the produce. The Legacy staff includes fields given to ONGC/OIL on a 'nomination' basis, those given under NELP and pre-NELP blocks. There are two price ceilings.

One, call it 'normal' price. Based on the recommendations of the Kirit Parikh committee and in force from April 1, 2023, this price expressed on a per million British thermal units (Btu) basis is arrived at by taking 10 per cent of the monthly average of the Indian crude basket in the preceding Government of India (GOI) The price thus calculated is subject to a price band of US\$4-6.50 per

> Second, there is a 'premium' price applicable to the difficult fields. These are deep/ultra-deep and high-pressure/high-temperature fields (the high-profile KG-D6 operated by Reliance Industries and neighbouring KG-DWN-98/2 operated by ONGC fall in this category). Technically though the price of NG flowing from these fields is market-determined, this is subject to a ceiling linked to the prices of alternate fuels, viz., fuel oil, naphtha and imported LNG.

> Even as the committee has recommended de-regulation of difficult gas fields' price by January 1, 2026, and that of normal price by January 1, 2027, the government is silent on this. Having substantially liberalized the regulatory space, besides removing the remaining hurdles, Modi needs to take the next logical step of unshackling marketing and pricing for supplies from the Legacy fields.

### Thane fake currency case: NIA files supplementary chargesheet against four

The National Investigation Agency (NIA) on Thursday said it has filed a supplementary chargesheet against four persons, including a 'designated terrorist', in the Thane fake currency

Besides the designated terrorist Uncle alias Javed Chikna, those charge-sheeted under relevant sections of the Indian Penal Code (IPC) and Unlawful Activities (Prevenion) Act have been identified as Riyaz Shikilkar, Mohammad Fayaaz Shikilkar and Nasir Chaudhari, all residents of Mumbai.

One of the accused Fayaaz Shikilkar has also been charged under the Arms Act.

Three accused were chargesheeted earlier, in April last year, by the Thane police in the case, which was originally registered following the seizure of 149 high

quality counterfeit Indian currency notes of the denomination of ₹2,000 from accused Shikilkar.

Subsequently, NIA had taken over the case and, after investigations, had arrested Fayaaz in May 2023 for possession of illegal arms.

"Investigations also revealed that Fayaaz was in contact with 'Uncle' alias Javed Patel alias Javed Chikna through WhatsApp, and had conspired to carry out unlawful activities in India. He had also received funds sent by 'uncle', a designated individual terrorist, through his associate 'bhai," the NIA said in a statement.

'Uncle', a wanted accused, had committed acts of terror through his associates by possessing and circulating high-quality fake Indian currency notes (FICNs) with the aim of damaging the monetary stability of India, according to

## **CSIR** lab producing affordable green innovative technology

 $F^{\text{rom converting pathogenic}}_{\text{biomedical waste into eco-}}$ friendly soil additives to manufacturing vegan leather from agricultural waste like mango peel and banana stem, the CSIR's lab National Institute for Interdisciplinary Science and Technology (NİIST), is busy churning out affordable green innovative technology.

These among others were displayed at the foundation day of the CSIR at Pragati Maidan here recently.

NIIST Director Dr C Anandharamakrishnan said that vegan leather has the potential to replace around 30-50 per cent of synthetic chemicals from the existing leather available in the market.

"Also, the developed leather sheet costs 50 per cent less than synthetic and animal leather and has a smaller carbon footprint as various agricultural residues such as mango peel, banana stem, pineapple waste, cactus, water hyacinth, corn husk, and rice-related waste are being used.

Vegan leather has a shelf



life of more than three years. It has also shown strong tensile strength, sleek finish, good water retention properties, temperature resistance, and stability compared to other existing synthetic and animal leather," he emphasised.

Though still held out by the fashion industry as a luxury material, leather is a co-product of the meat industry, and it comes with many environmental downsides.

A leather jacket has a climate cost of 176 kilograms of CO2, for instance, and manufacturers also dump toxic chemical compounds like lead, arsenic, cadmium and chromium into the water as the leather is processed, on top of the millions of goats and other animals slaughtered each year in India for leather.

About the dual disinfection-solidification system for spontaneous and instantaneous disinfection of both liquid and solid biomedical waste, including urine, saliva and blood, bacterial broths, cotton, tissues, swabs, needles, and syringes, the NIIST Director said the innovative system converts degradable waste into soil additives while lab disposables are prepared

for direct recycling.

Segregation, transportation and disposal of such disinfected medical waste are easier and safer with significant reduction in cost for a healthcare facility and less expensive than red-bagging, a method currently in practice for containing medical waste, lained Anandharamakrishnan.



### Net claims of non-residents on India rise to \$379.7 billion in June quarter: RBI

Net claims of non-residents on India increased USD 12.1 billion to USD 379.7 billion in the June quarter on account of higher rise in foreign-owned financial assets, according to RBI data released on Thursday.

Increase in reserve assets, at USD 16.6 billion, was the largest contributor to the rise in Indian residents' foreign assets during the April-June period, followed by direct investment, loans and trade credit, as per the data on India's international investment position' for June-end. "The rise in net claims of

non-residents during the quarter was on account of higher rise in foreign-owned financial assets in India (USD 36.2 billion) when compared with Indian residents' overseas financial assets (USD 24.1 billion)," the Reserve Bank of India (RBI) said. "Inward portfolio invest-

ment (USD 15 billion) and foreign direct investment (USD 8.9 billion) together accounted for two-thirds of the rise in foreign liabilities of Indian residents," it

As per the data, reserve assets accounted for 64.2 per cent of India's international financial assets at the end of the

Variation in the exchange rate of rupee vis-a-vis other currencies impacted the change in liabilities, when valued in the US dollar terms, the RBI data

The RBI further said the ratio of India's international assets to international liabilities moderated to 70.9 per cent in June from 71.1 per cent a quarter earlier and 71.5 per cent a year ago. Debt and non-debt liabilities accounted for nearly equal share in total external liabilities during the quarter.

Sebi penalises YES Securities for wrong reporting of margin, other discrepancies

New Delhi, Sep 28 (PTI)

Capital markets regulator Sebi has imposed a penalty of Rs 5 lakh on YES Securities (India) Ltd for wrong reporting of margin and discrepancy in the computation of client's net worth.

It has been directed to pay

the fine within 45 days, the Securities and Exchange Board of India (Sebi) said in its order.

The order came after Sebi, jointly with the Stock exchanges — NSE, BSE and MCX — conducted inspection of documents and other records of YES Securities (India) Ltd to verify the possible violation of stock brokers' rule.

In its order, Sebi found several violations, including wrong reporting of margin and discrepancy in reporting of net worth of clients by YES Securities, during July 2021 to March 2022.

The regulator said the brokerage house sent the retention statements after the prescribed time of five days and also mailed the statements of accounts to wrong email addresses.

Further, it was found that the brokerage house had projected a wrong reporting margin of Rs 2,083. In addition, the regulator noted lapses on the part of YES Securities for not having maintained adequate margin for the client.

"There was a discrepancy in the computation of net worth submitted by the noticee (YES Securities) to the exchange... The noticee had overstated the net worth to an extent of Rs 1,89,45,070.32," Sebi said in its order on Wednesday.





## 4 graft cases against Nawaz Sharif set to be reopened

**D**akistan's anti-graft body is reopening at least four corruption cases against former prime minister Nawaz Sharif as he is scheduled to return to the country next month, ending four years of self-exile in the United Kingdom, an official said on Thursday.

The 73-year-old Pakistan Muslim League-Nawaz (PML-N) supremo is scheduled to return to Pakistan from London on October 21 to lead the party's election campaign. Nawaz left the country in November 2019 on medical grounds after the Lahore High Court granted him bail for four weeks. He was serving a sevenyear imprisonment in the Al-Azizia Mills corruption case at Kot Lakhpat Jail Lahore.

On arrival in Lahore, his party says he will address a rally at Minar-i-Pakistan where he will give a road map to steer the country out of the economic crisis, governance problems and other issues the country is facing today. The National Accountability Bureau (NAB) in the light of a Supreme Court

amendments made to the accountability laws by the previous Pakistan Democratic Movement (PDM) government led by Nawaz's younger brother Shehbaz Sharif, is reopening the four pending probes against Nawaz. The cases are related to illegal plots and land allotment, dubious transfer of shares of his sugar mills and Toshakhana (national treasury gifts).

"Nawaz Sharif being chief

minister of Punjab province in 1986 had allotted plots in Lahore to several people by misusing his authority. He is accused of illegal construction of several kilometres of road to his house in Jati Umra Raiwind, Lahore, in 1998 when he was prime minister in violation of rules. "The third case is related to the transfer of shares in 'illegal' manners in the Chaudhry Sugar Mills case which is owned by Nawaz Sharif and his family members. In this case, his daughter Maryam Nawaz is also accused of being a major beneficiary," an official privy to the develop-

ment told PTI on Thursday.

The fourth is related to the



Toshakhana case in which he is accused of taking luxurious vehicles from the national treasury in violation of rules, he said. Besides these cases, Nawaz will have to face the case related to his conviction.

Meanwhile, Nawaz's close aide and senior PML-N leader Mian Javed Latif said the party has stopped "demanding accountability of former army chief Gen Qamar Javed Bajwa and former ISI head Gen Faiz Hameed" for conspiring against Nawaz to topple his govern-

"The PML-N doesn't want accountability of Gen Bajwa and Gen Hameed but only those characters and facilitators involved in May 9 events and

Chief Gen Asim Munir) of the institution," he said.

Latif was referring to attacks on military installations following the arrest of Pakistan Tehreek-i-Insaf (PTI) chief Imran Khan in May.

Colombo (PTI): With the IMF saying that Sri Lanka's full economic recovery is not yet assured, the government on Thursday said it will focus on the recommendations of the global lender and will continue discussions with it to reach a staff-level agreement for the second tranche of the

bailout package.
In March this year, the International Monetary Fund (IMF) approved a 48-month, USD 2.9 billion extended arrangement under the Extended Fund Facility (EFF) to support Sri Lanka's economic policies and reforms.

'We have to take note of points made on tax administration, granting of tax relief and eliminating tax evasion", said State Minister of Finance,

Ranjith Siyambalapitiya. We are working with a contracted economy and a population hit by economic hardships," Siyambalapitiya said. Sri Lanka was hit by its worst economic crisis in history when its foreign exchange reserves fell to a critical low and the public came out on the streets to protest the shortage of fuel, fertilisers and essential commodities. On Wednesday, it emerged that Lanka's second tranche of the bailout package will likely be delayed given the inconclusive nature of the cash-strapped nation's external debt restruc-

turing.
The debt-ridden nation was banking on the release of the second tranche of around USD 330 million at the end of the review as stated by Siyambalapitiya last week.

However, the IMF in the review said more discussions were needed to reach the next staff-level agreement on the external debt restructuring. The Washington-based global lender, while noting Sri Lanka's commendable progress in implementing difficult reforms, said "the full recovery of the economy was not yet assured." It stressed the need to strengthen tax administration, remove tax exemptions, and actively eliminate tax evasion.

The IMF had originally set a September deadline for Sri Lanka to restructure its external debt. The completion of negotiations with external creditors was to culminate with the first review.

### American soldier who crossed into N Korea returns to US

The American soldier who sprinted into North Korea across the heavily fortified border between the Koreas more than two months ago arrived back in the US early Thursday, video appeared to show.

North Korea abruptly announced Wednesday that it would expel Pvt Travis King. His return was organised with the help of ally Sweden and rival China, according to the White House. While officials have said

King, 23, is in good health and the immediate focus will be on caring for him and reintegrat-ing him into US society, his troubles are likely far from over. King, who had served in South Korea, ran into the North while on a civilian tour of a border village on July 18, becoming the first American confirmed to be detained in the isolated country in nearly five years. At the time, he was supposed to be heading to Fort Bliss, Texas, following his release from prison in South Korea on an assault conviction.

He has been declared AWOL from the Army. In

many cases, someone who is AWOL for more than a month can automatically be considered a deserter.

Punishment for going AWOL or desertion can vary, and it depends in part on whether the service member voluntarily returned or was apprehended. King's handover by the North Koreans makes that more complicated.

Video aired Thursday by a Texas news station appeared to show King walking off a plane in San Antonio. Dressed in a dark top and pants, he could be seen speaking briefly with people waiting on the tarmac. He shook hands with one before being led into a building.

Emails seeking comment were sent to Lackland Air Force Base in Texas, the Air Force and the Army.

Officials earlier said he would be taken to Brooke Army Medical Center at Fort Sam Houston. He is expected to undergo psychological assessments and debriefings, and he will also get a chance to meet with family.

He will be in military custody throughout the process since his legal situation is com-

Many questions remain about King's case, including why he fled in the first place and why the North - which has tense relations with Washington over Pyongyang's nuclear programme, support for Russia's war in Ukraine and other issues — agreed to turn him over.

The White House has not addressed North Korean state media reports that King fled because of his dismay about racial discrimination and inequality in the military and US society.

The North's official Korean Central News Agency reported that King made such complaints but verifying that is impossible. On Wednesday, Swedish officials took King to the Chinese border, where he was met by US Ambassador to China Nicholas Burns, the Swedish ambassador to China, and at least one US Defence Department official.

He was then flown to a US military base in South Korea before heading to the US.

### China's defence min missing in action for a month

A Chinese Defence Ministry spokesperson said Thursday that he was "not aware of the situation" in the ministry's first public comments on the disappearance of the defence minister from pub-

lic view about one month ago. Senior Col Wu Qian, the director of the ministry's information office, gave only a onesentence response when asked at a monthly news conference whether Li Shangfu is under investigation for corruption and if he is still the defense minister. "I'm not aware of the situation you mentioned," Wu said in response to a question from a foreign news outlet.

Li, who became defence minister when a new Cabinet was named in March, hasn't been seen since giving a speech on August 29. He is the second senior official to disappear this year, following former Foreign Minister Qin Gang, who was removed from office in July.

has given no reason for his removal, or why both he and Li suddenly stopped making public appearances. There is no indication, at least so far, that their disappearances signal a change in China's foreign or defence policies.

 $T^{aiwan's}$  president launched the island's first domestically made submarine for testing Thursday at a port in Kaohsiung.
The submarine, if success-

ful in its tests, will be a major breakthrough for Taiwan in shipbuilding and design.

"In the past, a domesticmade submarine was considered impossible, but today a submarine designed and built by our countrymen is in front of vou," President Tsai Ing-wen said at the launch ceremony.

"Building a submarine is the concrete realization of our resolution to protect our country. Submarines are an important piece of equipment for the Taiwan navy to develop asymmetric combat power in terms of strategy and tactics," she said. The US has been pushing Taiwan to develop asymmetric warfare strategies by investing

in smaller and lighter weapons such as the reduced-size submarine. The process was "torturous," said Cheng Wen-lon, head of Taiwan's CSBC Corp, which led the construction of the submarine. "Although we have worked quietly during the past several years, it doesn't mean the process was very smooth," he said at the ceremony held in CSBC's shipyard.

After seven years of design and construction, the prototype will begin tests in the harbour before heading to the ocean. The submarine is named Hai Kun after a fish in Chinese mythology called kun with legendary proportions.

It will only be handed over to the military after passing both its harbour and oceanfaring tests. Taiwan plans to build another submarine if successful, with both to be deployed by 2027, according to the semi-official Central News

### **Taiwan launches its first** |N| Korean leader urges greater nuclear weapons production in response to a 'new Cold War'

North Korean leader Kim Jong Un called for an exponential increase in production of nuclear weapons and for his country to play a larger role in a coalition of nations confronting the United States in a "new Cold War," state media said Thursday. The Korean Central News

Agency said Kim made the comments during a two-day session of the country's rubberstamp parliament which amended the constitution to include his policy of expanding the country's nuclear weapons programme. The Supreme People's Assembly's session on Tuesday and Wednesday came after Kim travelled to Russia's Far East this month to meet with Russian President Vladimir Putin and visit military and

technology sites. The trip sparked Western concerns about a possible arms alliance in which North Korea

would supply Putin with badly needed munitions to fuel his war on Ukraine in exchange for economic aid and advanced Russian technologies to enhance North Korea's nuclear and missile systems.

As North Korea slowly ends its pandemic lockdown, Kim has been actively boosting his partnerships with Moscow and Beijing as he attempts to break out of diplomatic isolation and join a united front against Washington. He has described the world as entering a "new Cold War" and that North Korea should advance its nuclear capabilities in response.

KCNA's reports on Kim's comments came a day after North Korea confirmed the release of US Army Pvt Travis King, who is now being flown back to America, two months after he sprinted across the heavily fortified border into the North. King's relatively swift expulsion defied speculation that North Korea might drag

out his detention to squeeze concessions from the United States, and possibly reflected the North's disinterest in diplomacy with Washington.

KCNA said members of the assembly gave unanimous approval to a new clause in the constitution to "ensure the country's right to existence and development, deter war and protect regional and global peace by rapidly developing nuclear weapons to a higher level."

North Korea's "nuclear force-building policy has been made permanent as the basic law of the state, which no one is allowed to flout with anything," Kim said in a speech at the assembly. He stressed the need to "push ahead with the work for exponentially boosting the production of nuclear weapons and diversifying the nuclear strike means," KCNA said Kim pointed to what he said. Kim pointed to what he described as a growing threat posed by a hostile United States and its expanding mili-

tary cooperation with South Korea and Japan, accusing them of creating the "Asian version of NATO, the root cause of war and aggression."

"This is just the worst actual threat, not threatening rhetoric or an imaginary entity," he said. Kim urged his diplomats to "further promote solidarity with the nations standing against the US and the West's strategy for hegemony." South Korea's Unification Ministry, which handles relations with North Korea, said the North Korean constitutional amendment confirms Kim's unwillingness to relinquish his nuclear weapons program and his unwavering commitment to advancing that arsenal.

It said in a statement that South Korea will continue to expand its military cooperation with the US and Japan and work closer with other international partners increase pressure on North Korea to abandon its nuclear


