Telugu Desam Party (TDP) president N Chandrababu Naidu faced intense interrogation by the Crime Investigation Department (CID) as part of its inquiry into the multi-crore Skill Development Corporation scam on Saturday.

A team comprising nine seasoned CID officials, under the leadership of Deputy Superintendent of Police M. Dhanunjayudu, arrived at Rajahmundry Central Prison, where Chandrababu Naidu is currently lodged. The questioning session commenced at 9:30 a.m. and continued until 5 p.m. Prior to the commencement of the interrogation, Naidu underwent a thorough medical examination. The inquiry took place in a conference hall, with Naidu's legal counsel, D. Srinivas, observing the proceedings from a distance. Naidu is being control of five tance. Will amend women's quota Bill: Mallikarjun Kharge

Congress president Mallikarjun Kharge on Saturday said his party would amend the women's reservation bill if it comes to power at the Centre in 2024.

There are no major legal complications in implementing the bill right now but the Narendra Modi government putting it off for 10 years, he said. While supporting the bill in Parliament, the Congress demanded that it be implemented with immediate effect and a quota for women from Other Backward Classes (OBC) be included in it.

"When our government comes in 2024, the first thing we will do is make amendments to the bill," Kharge said, addressing a party rally in Jaipur in poll-bound Rajasthan.

The Constitution (128th Amendment) Bill, which seeks to reserve a third of seats in the Lok Sabha and state assemblies for women, was passed by Parliament earlier this week. It was the first bill to be taken up and passed in the new Parliament building.

In his address, Kharge alleged that the then president Ram Nath Kovind was not invited for the foundation laying of the new Parliament building because he is "untouchable".

If the foundation laying was done by an untouchable, then naturally it would have to be washed with Gangajal (water from the

Shortage of iron ore leading to low productivity in RINL

PNS VISAKHAPATNAM

Due to the lack of prompt response to the Save Our Soul (SOS) pleas made by Rashtriya İspat Nigam Limited (RINL) the corporate entity of Visakhapatnam Steel Plant, employees and stakeholders, who are urging the authorities to restore regular iron ore sup-ply from National Mineral Development Corporation (NMDC)'s Bacheli and Kirandul mines Chhattisgarh, the public sector company headquartered in Visakhapatnam is compelled to run its plant at a minimal production capacity.

The profound shortage of

working capital has exacerbated the circumstances, compelling RINL to further reduce its production levels. This has pushed the steel plant into a precarious situation, as NMDC, with which RINL has a longstanding agreement for iron ore supply, has reiterated its incapability to provide the complete allocation of the primary raw material from Chhattisgarh and has suggested that RINL procure it from their mines in Karnataka.

Despite the Chhattisgarh mines being located within a distance of less than 500 km,



obtaining iron ore from Karnataka necessitates transportation over a distance of 900 km, resulting in an additional cost burden ranging from Rs 800 to Rs 1,000 per tonne. NMDC, also under the Ministry of Steel, has conveyed to RINL that due to a shortfall in supply, partly due to heavy rains, they are unable to guarantee regular deliveries from Chhattisgarh.

In a letter addressed to Union Steel Secretary Nagendra Nath Sinha, GVL Narasimha Rao, BJP national spokesperson and Member of the Standing Committee on Finance, requested the Ministry of Mines to engage in resolving the predicament confronting RINL. He highlighted that currently, RINL possesses

a mere four-day supply of iron ore, while the facility necessitates a minimum stock of 10 days to operate two blast furnaces and 15 days to operate three blast furnaces. The Member of Parliament expressed significant apprehension about this situation, emphasizing the importance of timely intervention.

Reliable sources shared with The Pioneer that starting from August, NMDC has reduced its daily supply from three or four rakes to just one or two, thereby compelling RINL to significantly curtail its production. A senior official explained that there is currently no production in the Kirandul block, and efforts are underway at the ministry level to resolve this

of both RINL and NMDC. Calling for a resolution to the ongoing deadlock, D Adinarayana, RINL recognized union leader and AITUC national vice-president, emphasized that it was largely due to RINL that NMDC was able to thrive and overcome its financial challenges from 1989 to 2001. Notably, RINL remains NMDC's primary customer, and the company's head office is located in Hyderabad. RINL continues to contribute a significant portion, accounting for 30 percent of NMDC's turnover and profits.

He mentioned that back in 2006, NMDC made a commitment to provide iron ore from the Bailadila/Bacheli deposits, with a capacity of up to 11 MTPA. In line with this, the Government of India granted approval for RINL's expansion to a production capacity of 7.30 million tonnes per To achieve steel production

at full capacity, NMDC was expected to deliver 6 to 7 rakes of iron ore daily, including fines, lumps, and sized ore. It's worth noting that the ore from Chhattisgarh boasts a superior grade quality compared to the ore available in Karnataka.

CID chief rebuts Lokesh's claims on skills training

The Andhra Pradesh Criminal Investigation Department (CID chief N. Sanjay, has alleged that TDP national general secretary Nara Lokesh is spreading lies by saying that nearly 2 lakh students were trained under the SIEMENS programme. This claim, as per CID findings, is entirely baseless. The deceptive act took place during the 2015-2016 period when a swindle of Rs 371 crore transpired under the guise of a 90:10 financial arrangement. The perpetrators have attempted to obfuscate the facts by suggesting they trained a vast number of students in the state.

Sanjay disclosed that the previous government allocated a sum of Rs 745.56 crore over four years for skill development, excluding the SIEMENS project. However, approximately 337 crores, con-

certain leaders are wrongly attributing all the credit to SIEMENS and the APSSDC project, which, in reality, had minimal impact on enhancing

students' skills. The CID's investigation has unearthed questionable timelines in the allocation of funds to Design Tech by APSSDC. On December 5, 2015, APSS-DC assigned third-party evaluation work to CITD (Central Institute of Tool Design). Astonishingly, on the very same day, a substantial sum of 185 crore was released to DesignTech. Subsequently, on January 29, 2016, Rs 85 crore and on March 11, 2016, Rs 67 crore were disbursed.

Even more perplexing is the fact that, even before receiving the third-party evaluation report from CITD, which was dated March 22, 2016, APSS-

stituting 90% of the total project cost of 371 crores.
Furthermore, CITD was

manipulated by Siemens (SISW), being pressured to justify the release of 90% of funds during the evaluation process. In the deposition provided by Shujayat Khan to the CID, who was the principal director of CITD at the time, he stated that he was not informed that an independent evaluation was necessary. His actions were solely based on information received from Siemens and APSSDC officials, lacking the means to accurately assess the software's value.

These events not only raise concerns about the responsible allocation of public funds but also necessitate a thorough investigation into the proceallowed such significant fund diversion without proper evaluation or justification.

Moreover, an amount of Rs 42.50 lakhs has been allocated for underpass enhancements, Rs 1.38 crores for the installation of median grill structures, and Rs 54.05 lakhs for road lighting.

Hard blow to KCR govt: Revanth Reddy

"Take the Nari Shakti Vandan Adhiniyam for example. This law was pending for three decades. But today, it is your strength that even those political parties had to support it in both Houses of Parliament who never got tired of opposing it earlier," Modi said.

Giving credit to the women of the country for this, he said, "Because you, the mothers and sisters, have become aware and united, all the political parties of India are afraid and are trembling and that is why this bill was passed -- this is your strength." Striking a chord with the vot-

ers of Varanasi, Modi said "your MP from Kashi got the privilege" of getting the women's reservation bill passed in Parliament.

World is getting linked with India through cricket

Varanasi (UP):Prime Minister Narendra Modi on Saturday laid the foundation stone of an international cricket stadium in Varanasi and said that through the game, the world is "getting linked" with India. Highlighting that the design of the stadium dedicated to Lord Mahadev has instilled a feeling of pride among the citizens of Kashi, he said the facility would witness great cricket matches while young athletes would get an opportunity to train at the international level. Modi said recent sporting successes of India were due to a changed approach as now sports have been linked with fitness, employment and career of youths. Compared to nine years ago, this year's sports budget has been increased threefold, he said. "Through cricket, the world is getting linked with India" and many new countries are playing cricket leading to a greater

number of matches, he said, adding this stadium will cater to the rising demand for such facilities in the coming years. To be built near the Ring Road in Rajatalab area here at a cost of about Rs 450 crores and spread across an area of more than 30 acres, the stadium is likely to be ready by December 2025. The Uttar Pradesh government said it has spent Rs 121 crore to acquire the land for the stadium while the Board of Control for Cricket in India (BCCI) will spend Rs 330 crore on its construction. The spectators' gallery of the stadium would resemble the steps of the ghats of Varanasi. This will be Uttar Pradesh's third international cricket stadium after Kanpur and Lucknow. Addressing the gathering, Modi said he is visiting Kashi exactly one month after India reached the Shiv Shakti point on the moon where Chandrayaan landed.

The counting of votes for the DUSU's central panel posts of president, vice-president, secretary and joint secretary concluded on Saturday evening. The election was held on Friday. The DUSU elections have always seen a direct fight between the ABVP and the National Students' Union of India (NSUI). The ABVP won three of the four seats in the 2019 elections as well. The DUSU elections were last held in 2019. The polls could not be held in 2020 and 2021 due to COVID-19 while possible disruptions to the academic calendar prevented their conduct in 2022. Twenty-four candidates were in the fray for the four posts this year. Chander Shekhar -- the chief election officer for the polls -- said the university recorded a voter turnout of 42 per cent. Around one lakh students were eligible to vote in the election. While the voting percentage was higher than in 2019 when a turnout of 39.90 per cent was recorded, it failed to surpass the nearly 11-year-high figure of 2018.

Angry locals blame cops for teen's death, create ruckus at hospital



olice personnel were rushed Pto tackle chaos at a hospital in Maharashtra's Palghar district in the early hours of Saturday after an injured teen, who apparently tripped trying to escape cops, was declared dead, an official said on Saturday. While the police claimed that Vinod Bhoir (18) most likely suffered a heart attack while fleeing

and died, the boy's relatives said he was beaten up. According to a senior police official who spoke to the media at the hospital in Virar, Bhoir and his friends were near a Ganpati pandal at Agashi-Kolhapur village when a patrol vehicle from Arnala Sagari police station reached the spot around 2.45 am. Seeing the cops, Bhoir and his friends panicked and started running but he tripped and fell down and suffered injuries, said the official. Bhoir was rushed to a hospital, where doctors declared him dead. Angry local residents blamed the police for his death and kicked up a ruckus at the hospital, prompting authorities to call the cops. Fearing that the situation could go beyond control, more personnel were called in. Later, two relatives of the teen told the media that Bhoir was beaten up by the police. He was playing on his mobile, said one of them, claiming that three of the policemen from the patrolling team were drunk. The relatives said the police were not even ready to take an injured Bhoir to the hospital and did so only after the villagers insisted. Bhoir was to be shifted to another facility but the police fled from there, said the relatives. They said the villagers then took the teen to the second hospital but by that time he had died.

Suspected terrorist arrested by NIA amid ethnic unrest in Manipur

The NIA has arrested a suspected terrorist for his alleged links with Myanmar-based rebel groups and conspiring to wage war against India by exploiting the current ethnic unrest in Manipur, an official

Moirangthem Anand Singh was arrested from Manipur and brought to New Delhi for questioning, a spokesperson of the National Investigation Agency (NIA) Singh was one of the five

persons arrested by Manipur Police for possessing weapons looted from police armoury. The arrest had led to agitation by the majority community, who were claiming them to be village defence activists. A local court had granted bail to all the five on Friday.

However, Singh was immediately placed under arrest and whisked away to an undisclosed location before being brought to the nation-

The official said Singh was

arrested in a case related to a "transnational conspiracy" by Myanmar-based leadership of terror groups to wage war against the government of India by exploiting the current ethnic unrest in Manipur.

The case was registered suo moto by the NIA on July 19 in New Delhi and investigations revealed that in furtherance of the conspiracy, the proscribed terror groups are recruiting over ground workers, cadres and sympathisers to augment their strength to carry out attacks on security forces and opposing ethnic groups by exploiting current unrest in the state. They are collecting arms, ammunition and explosives by unlawful means, including plunder and pillage of government facilities and resources, the spokesperson said. After Singh was brought to Delhi on Saturday, he was produced before a jurisdictional court which remanded him in police custody for a spokesperson said.

Role of lawyers evolved to address myriad challenges: CJI

Chief Justice of India D Y Chandrachud on Saturday said the role of lawyers has evolved to address myriad global legal challenges in an era characterised by ever-increasing globalisation.

He said rapid technological advancement has created "complex legal issues", with lawyers leading the way in navigating this landscape. While the judiciary definitely bears the responsibility of administering justice and upholding the rule of law, lawyers play an equally vital role, he stressed.

"In an era characterised by ever-increasing globalisation, the role of lawyers has evolved to address myriad global legal challenges," the CJI said while speaking at the inaugural ceremony of the Bar Council of India's (BCI) 'International Lawyers Conference 2023' here.

He said lawyers ensure that clients and governments adapt to technological changes while upholding legal rights and regulations, covering areas like cybersecurity, data privacy and intellectual property. "Lawyers also bear significant commercial responsibility, driving economic growth by helping clients and governments enhance business efficiency and cross-border operations.

Rahul Gandhi: Why is PM afraid of caste census?

Congress leader Rahul Gandhi on Saturday advocated for a caste census and asked why Prime Minister Narendra Modi was "afraid" of it as well as demanded the immediate implementation of reservation for women in Lok Sabha and state assemblies.

A bill to reserve one-third of seats in the legislative bodies for women received the parliamentary nod on Thursday as the Rajva Sabha voted unanimously in favour of it.

The 128th Constitution amendment bill, referred to as the Nari Shakti Vandan Adhiniyam, will now require the approval of a majority of



state assemblies. It will be implemented after a delimitation exercise to redraw parliamentary and assembly constituencies based on a census which the government has said will be commissioned next year.

The BJP wants the reservation for women to be implemented in "10 years, but we backward classes) included in it", Gandhi told a conference of Congress workers here in pollbound Rajasthan. The bill was passed in a special session of Parliament that

Two big semiconductor proposals are under process and expected to take shape in the coming few months, Union minister Ashwini Vaishnaw said on Saturday.

Without divulging specifics of the proposals, the minister said the projects will focus on a special area where India can emerge as a leader at the glob-

While speaking with PTI on the sidelines of the ground-breaking ceremony of Micron's semiconductor plant, Vaishnaw said that the global semiconductor company is noticing the progress made by India in the segment and Prime Minister Narendra Modi's capability to execute large and complex policy decisions.

This has developed India as a major trusted geography in which global industry players want to come. We can see in the coming few months at least two more large semicon-ductor proposals taking shape," Vaishnaw said.

He said that there are some specific areas where India can take the lead and the focus of the semiconductor projects will be in areas that can help the country export technology to

other parts of the world. The minister said that the Micron plant, for which construction has started, will start producing the first chip from December 2024 onwards.

Memory chip maker Micron in June announced setting up a semiconductor assembly and test plant in Gujarat entailing a total investment of USD 2.75 billion (around Rs 22,540 crore).

Micron will invest up to USD 825 million in setting up the plant in two phases and the rest of the investment will come from the Centre and the state government.

The company has roped in Tata Projects for phased construction of the new assembly and test facility in Sanand.

Phase 1 will include 500,000 square feet of planned cleanroom space, and will start to become operational in late

The minister said semiconductor demand is expected to grow to Rs 5 lakh crore in coming years from about Rs 2 lakh crore.

"India is already a very large design hub. With manufacturing coming to India, the entire process and value chain will come to our country and Bharat will become a major semiconductor hub in coming years," Vaishnaw said.

Micron Senior Vice President Gursharan Singh at the event said that the company has boarded the first set of 34 employees for the plant.

Five suppliers of Micron including SIMTEC are evaluating possibilities to set up their plant in India, according

TRAI for boosting telecom infra in NE states

TRAI has issued recommendations for bolstering telecom infrastructure in North East, suggesting parleys with the state governments to harmonise their respective 'right of way' policies with related Central rules, as well as favouring provision of electricity to telecom sites on priority at utility tariffs.

The Telecom Regulatory Authority of India (TRAI) noted that while a number of initiatives have been taken by the government to improve telecom connectivity in the northeastern states, there is still a lack of high-speed mobile-



based internet and fixed broadband connectivity, mainly due to the inadequate transmission

bandwidth (optical fibre, Microwave and satellite). "The Northeast states contin-

ue to grapple with a significant digital divide due to various reasons such as inhospitable terrain conditions, poor availability of power supply, transmission media related limitations, poor return of investment prospects for TSPs, and Right of Way (RoW) related issues," the sector regulator said in a

The Northeastern Region (NER) comprises the states of Arunachal Pradesh, Assam, Meghalaya, Manipur, Mizoram, Nagaland, Sikkim, and Tripura - together they form part of the East

Himalayan region. The latest recommendations

LOW-INCOME NATIONS ILL-EQUIPPED FOR CVD FIGHT'

Even as cardiovascular diseases (CVDs) such as stroke, diabetes and hypertension are claiming millions of people prematurely every year, most healthcare facilities in many Low-and Middle-income Countries (LMICs) are unprepared to treat such patients, says a study. It comes as a wakeup call for India which is already facing burgeoning CVDs epidemic, reports ARCHANA JYOTI

lobally, nearly 18 million premature deaths in 2019 were due to CVD, of which 75 per cent were in LMICs, where they are leading causes of death and Disability Adjusted Life Years (DALYs) in adults. Diabetes and hypertension are key risk factors for CVD and amongst the top three risk factors for deaths and disability, globally.


Publishing their findings recently in PLOS Global Public Health, an international team of researchers led by the University of Birmingham, looked at readiness to provide care for HIV or CVD in Afghanistan, Bangladesh, Democratic Republic of Congo (DRC), Haiti, Malawi, Nepal, Senegal, and Tanzania.

They discovered that most facilities are unprepared to deliver services to treat or manage cardiovascular disease risk factors (CVDRF) such as diabetes and hypertension.

However, the increased investment in facilities to treat HIV - received as part of the drive to meet UN Millennium Development Goal (MDG) targets – may form part of a solution to tackle CVDRFs, which have been relatively neglected in terms of receiving global funding and attention. The study authors found that if facilities are able to provide HIV care, they are much more able to supply care for CVDRFs.

They found that despite UN targets to reduce CVDRF, facilities were significantly less ready to provide CVDRF care than HIV care, even though despite years of investment in HIV, facilities were often not dy to fully provide care for

Lead author Professor Justine Davies, from the worse." University of Birmingham, commented: "We've had global targets to reduce burden of CVDRFs since 2011, but tackling the problem requires healthcare services to have all the ingredients to care for patients vide healthcare for people with



including staff, facilities, medicines, or equipment.

"Given the long-term financial investment and advocacy for HIV, we looked to see what readiness to provide care could be achieved with good longterm investment. We then compared readiness for CVD care with that of HIV care. We found that, despite years of investment in HIV, facilities vide care. But we found that the situation for CVD was far

"Our findings provide policy makers, funders, and researchers evidence of where there are gaps in service provision which need to be filled to enable achievement of current global health goals."

The researchers found that in individual countries, readiness across all healthcare facilities to handle CVDRE was generally lower than for HIV. high blood pressure, air pollution, tobacco use, and elevated LDL cholesterol are among the leading contributors to CVD deaths.

Yet another study published in PLOS One, has called for a multifaceted approach to prevention that includes fiscal, inter-sectoral, public health and health-service level interventions at all—primordial, primarv seconda

tiary—levels.
"Several interventions have already been tested in various low-to-middle income countries and have shown to improve the CVD burden in a cost-effective manner. For example, the Disease Control Priorities report of the World Bank enlists an essential package of interventions that can prove beneficial," say the authors.

Some of the interventions enlisted include taxation on tobacco and sugar-sweetened beverages, regulations on processed and salt-rich food, ban on trans-fatty acids, improvements in built environment and introduction of school health programs to encourage physical activity, task-sharing or improving screening activities and better use of combination

In India too, the situation is grim. The Asian Pacific Society of Cardiology (APSC) recently published a report revealing that heart failure alone leads to 1.8 million hospitalisations each

Experts have been calling to tighten the noose around the companies marketing highly processed food which are mostly responsible for a spike in CVD with kids also being impacted.

For instance, a report, titled 'THE JUNK PUSH: Rising Ultra-processed Food Consumption in India — Policy, Politics and Reality', has recommended stronger policies to protect children from the harmful impact of food marketing.

Most of the products

analysed as part of the study are widely consumed brands mainly targeted at children. These included packaged products high in fat, sugar and salt (HFSS) or ultra-processed foods (UPF), with as thirse packing a quarter such as chips, cookies, sweets, soft beverages, instant noodles, sugary cereals, frozen meals, ice cream, bakery items, and choco-

According to the document, their advertisements were found to be in violation of the Consumer Protection Act, 2019, with some of them even violating the Food Standard and Safety Act, 2006, as they hid crucial information related to nutrients of concern.

"None of the legal frameworks or guidelines in India has the potential to stop most of the misleading advertisements of prepackaged junk or HFSS foods, or to ban misleading claims or warn people about the risks to health," said Dr Arun Gupta from Delhi-based nutrition think tank Nutrition Advocacy in Public Interest (NAPi) which has prepared the report.

CADILA PHARMA PHASE I CLINICAL TRIAL FOR CHICKEN POX SHOT: SEC **RECOMMENDS NOD FOR TRIAL**

The Subject Expert Committee (SEC) on vaccines, which reviews proposals and advises the Drugs Controller General (India) in matters for biologicals and post approval change proposals, has recommended granting nod to Gujarat-Pharmaceuticals to conduct phase I clinical trial for its

chicken pox vaccine. The decision was taken in a recent meeting last month of the SEC after the company submitted a revised phase I clinical trial protocol for grant of permission to conduct the trial for

(VZV) vaccine. The pharma firm had earlier submitted its proposal for grant of permission to conduct Phase I clinical trial of its Varicella-Zoster virus (VZV) vaccine along with preclinical data and it was considered in a SEC meeting held on May 16.

Varicella-Zoster Virus

The SEC, during then, after detailed deliberation

recommended that the company should submit single dose toxicity data as per the provisions of the New Drugs and Clinical Trials Rules,

Further, it recommended, the firm should revise the phase I clinical trial protocol with some changes such as the volume of blood to be withdrawn for analysis should be reduced.

According to the World Health Organisation (WHO) Varicella (chickenpox) is an acute, highly contagious disease caused by varicella-zoster virus (VZV), a member of the herpesvirus

"Ónly one serotype of VZV is known, and humans are the only reservoir. DECODED: How toxic proteins accumulate in Alzheimer's, Parkinson's?

When Tau protein -- part of the brain's infrastructure -- gets knotted up into tangles, it turns toxic to injure brain tissue, causing tauopathies, a group of neurodegenerative brain diseases such as Alzheimer's, Parkinson's and other brain diseases, researchers have found. The HEALTH PIONEER shares the findings published in the journal Molecular Psychiatry

nder normal circum-stances, tau protein is part of the brain's infrastructure, important for stabilizing neurons into their proper shapes. But sometimes tau gets knotted up into tangles and turns toxic, injuring brain tissue and causing tauopathies, a group of brain diseases characterized by problems with learning, memory and movement. Alzheimer's disease is the most common tauopathy, but the group also includes Parkinson's disease, chronic traumatic encephalopathy (CTE) and several rare genetic conditions.


In search of ways to prevent these destructive tau tangles, researchers at Washington University School of Medicine in St. Louis have identified a key step in their development. Intervening at this step potentially could forestall the destructive cascade of events that results in brain damage, the researchers said. The findings are published in the journal Molecular Psychiatry.

"Tauopathies are devastating diseases that have limited treatment options right now, and they all have this feature of author Celeste Karch, PhD, a researchers started with skin brain tissue.

"We've been thinking for a long time about whether there are factors that impact that common process of tau aggregation and if so, whether we could target those factors as a novel approach to treatment. These findings move us one step closer to finding a way to intervene and stop the process of tau aggregation that leads to First author Reshma

Bhagat, PhD, a postdoctoral researcher, came up with the idea of looking for such factors among a group of RNA molecules known as long noncoding RNAs (lncRNAs) that are not translated into proteins. Historically, RNA has not been considered an active element in biological processes, and most disease research has not focused on them. Only in the past decade have scientists recognized that these RNA molecules can play critical roles in disease processes. Bhagat became interested in lncRNAs because they are involved in regulating diverse cellular processes and have been implicated in cancers.

To investigate the role of tau aggregation," said senior lncRNAs in tauopathies, the



cells from three people with a genetic tauopathy, each of whom carried a different mutation in the tau gene. Using molecular techniques, the researchers converted the skin cells into brain neurons that carry each of the three mutations. For comparison, they used a molecular technique known as CRISPR to correct the mutations in some of the skin cells before converting them into neurons. In this way, they were able to obtain human brain cells with and without tau mutations, which didn't require using human

Using these cells, the researchers identified 15 lncRNAs that were significantly increased or decreased in brain cells with tau mutations compared to their genetically matched controls. One lncRNA in particular stood out: SNHG8, which was low not only in the three human brain cells with tau mutations but also in mice with a tau mutation and in brain samples from people who had died of any of three different tauopathies: Alzheimer's disease, frontotemporal lobar degeneration with tau pathology, or progressive supranuclear palsy. In other

words, SNHG8 levels were down in tauopathies regardless of mutation, species or disease — all signs that point to its role in a common pathological

Further investigation revealed that neurons with low SNHG8 levels also had high levels of stress granules, RNA-protein complexes that form to help cells survive stressful situations such as excessive heat or low oxygen and disintegrate once the threat passes. Stress granules are rich in tau, and therein lies the danger. If too many stress granules form or if they con-

prone to tangling — as is the case in genetic tauopathies — stress granules can kickstart the aggregation process by concentrating tau. "If we could somehow target this stress-induced protein-aggregation pathway,

Professor Gadgil's *A Walk Up the Hill* sheds light on the crisis in the Western Ghats, unveiling widespread illegal activities, and conflicts between the Church and political entities, writes **KUMAR CHELLAPPAN**

he memoir, "A Walk Up the Hill," authored by Professor Madhav Gadgil, a distinguished environmental scientist who headed the government-appointed Western Ghats Ecology Expert Panel (WGEEP), is poised to make a significant impact in India. The WGEEP was established by the Central Government through an order dated March 4, 2010.

The panel's mandate included

assessing the current ecological status of the Western Ghats region, demarcating areas within the Western Ghats region in need of designation as ecologically sensitive, and recommending the notification of such areas as Ecologically Sensitive Zones (ESZs) under the Environment (Protection) Act of 1986. Additionally, the panel was tasked with making recommendations for the conservation, protection, and rejuvenation of the Western Ghats region, following a comprehensive consultation process involving the people and governments of all concerned states.

The report by the Gadgil committee was presented to then Union Minister for Environment and Forest Jairam Ramesh on August 30, 2011. This, in itself, was a rare event, as a committee usually submits its final report years after it was constituted, availing as many extensions as possible so that the head of the panel and members could continue receiving funds indefinitely.

Though Prof Gadgil was told that the WGEEP report would be made public on September 21, it was not to be. The Government had a change of heart, and the panel members were instructed not to discuss the contents with the public or the media. The Delhi High Court had to intervene to make the report public, and the Ministry for Environment and Forest uploaded it on its website.

its website.

The reasons behind the ministry's initial opposition to releasing the report were numerous. What the Gadgil committee members witnessed during their studies across the Western Ghats was shocking. A cabal of private industrialists, contractors, and elected representatives of the people were involved in

plundering the ecologically fragile Western Ghats, despite the resistance of both the local population and the local self-governments. Although the Constitution of India demands that no industrialisation or commercial exploitation of ecologically and environmentally sensitive regions should be undertaken without obtaining green clearance from the local population and the Gram Sabhas, these laws were blatantly violated by politicians, religious leaders, and contractors whose sole ambition was to make more money without making any investment.

'The Western Ghats, the mountain chain running parallel to the west coast of the Indian peninsula, covers an area of 1,60,000 sq km over a stretch of 1 600 km spanning across the States Gujarat, Maharashtra, Goa, Karnataka, Kerala and Tamil Nadu. All over the world, such mountains, endowed as they are with high levels of environmental heterogeneity, are treasure troves of natural diversity. In the Western Ghats, the annual rainfall ranges from as much as 8000 mm in the southwestern corner of upper Nilgiris to a mere 500 mm in the Moyar gorge just 30 km to its east... The Western Ghats are no ordinary biome. They constitute the water tower of peninsular India, providing water to 245 million people and draining a large part of the country's land surface," writes Gadgil.

The studies conducted by Gadgil and other ecologists have confirmed the fact that Western Ghats have become an ecological hotspot. Only 7 per cent of the Ghat's primary vegetation has survived and it has 51 critically endangered species. Climate change will cause further stress. Observations and inferences made by Gadgil and others have proved to be true as the entire area that comes under the shadow of the Ghats experience unexpected torrential downpour, landslides and even dry spell lasting

months.

The verdant forests and greenery of the region have given way to barren lands. Unabated felling of trees and uncontrolled mining and quarrying have taken its toll as the forest and mining mafia have taken control of the entire stretch. Readers may be remembering forest brigand

Veerappan kidnapping Kannada matinee idol Rajkumar to the Sathyamangalam forests in Tamil Nadu. The reason for the kidnapping was the turf war between various mafia groups engaged in looting the forest wealth, including exotic trees and mining of costly granites from the reserve forests in the Ghats, though Gadgil has steered clear from this part.

The shocking disclosures made by

the ecologist are what he came across in the Western Ghats. The forests, rivers, mountains and valleys are on deathbed and are on life support systems. The Western Ghats have been exploited to the hilt by the mining and timber mafia. The region could not withstand any more invasions on its environment and ecology. The WGEEP brainstorming sessions, suggested to the government that enough was enough and it was time to put a full stop to mining activities and tree felling. Some of the crucial recommendations made by Gadgil and his colleagues include no special economic zones, no new hill stations, rescheduling reservoir operations to improve downstream flows, participatory sand auditing and strict regulation of sand mining, rehabilitation of mined areas with special focus on reviving water resources, promoting organic agricultural practices and precision agricultural practices, strictly controlling use of dynamite and other explosives to kill fish, no mining in areas demarcated as Ecologically Sensitive Zones (ESZ1), where mining exists it should be phased out in five years, by 2016 illegal mining to be stopped immediately, etc. The report was submitted to then minister Jairam Ramesh.

Though Gadgil was a fellow traveller, his comrades in the State had no qualms in lambasting the report. The resentment by the church led the Centre to appoint a committee headed by space scientist Kasturirangan to study the viability and feasibility of the Gadgil report. Kasturirangan did what he was asked to do and the story ended there. The Western Ghats continue its downward slide without any interruption. The man-animal conflict has become a regular event in the region as elephants, leopards and tigers come out of the forests in search of drinking water and a square meal which would sustain their lives. Who cares?

Even as Gadgil recounts his Western Ghats odyssey, another equally important study from Chennai-based CPR Environment Research Centre led by Dr Nanditha Krishna has more shocking disclosures to make. Sacred groves across India, home to local flora and fauna and mini biosphere reserves have shrunk and most of them have disappeared altogether from the face of the earth. "Sacred groves represent an ancient Indian conservation tradition protected by local people out of reverence, respect and fear. These untouched patches of forest contain some endangered rare and threatened medicinal plant species. The rural folk conserve and preserve species diversity that are the last remnants of native vegetation," explained Dr Nanditha Krishna, the first winner of Indira Gandhi Paryavaran Puraskaar for her relentless campaign against destruction of sacred groves which are known as Swami Shola, Koil Kadu in Tamil Pradesh, Kavu in Kerala, Mawflong in Assam and Meghalaya, Mangaoon in Western Ghats, Dev Vana in MP and Karnataka.

This is a unique conservation style which makes use of religion and tradition to preserve ecology as a natural heritage. Wherever there are sacred groves, they are adored as spiritual retreat. Before concluding, let me draw readers attention to what SK Pottekat, the legendary travelogue writer, wrote in 1955 about his experience in Finland. "Pine trees are the main source of income for European countries. When one cuts down a pine tree, he has to convince the authorities that six pine saplings have been planted." Did we have such laws in India at any time?

Khalistan terror: Globalised 21st century challenge

he rise of Sikh ethnonationalism in the 1980s posed a threat to India's territorial integrity. Since then, it has transcended the borders of India. The way the 21st-century Khalistan movement is shaped and propagated to its followers is markedly different from the violent upsurge of the 1980s. It is much more globalised now. While hardcore advocates like Amritpal Singh have followed in the footsteps of the Bhindranwale cult, the worldwide network of Khalistani sympathisers has provided the movement with an easier source of sustenance than in the past.

The history of Khalistan lies in the roots of Sikhism. The revered Sikh religion was founded by Guru Nanak in Punjab in the 15th century. It boasts more than 25 million followers worldwide, with Sikhs constituting a minority group in India, making up less than 2 per cent of the country's total population of 1.4 billion today. However, they are a majority in their home State of Punjab.

The word "Khalistan" signifies the establishment of an ethno-religious sovereign state for the Sikhs, referred to as the land of the Khalsa. This is defined as the "land of the pure." Additionally, Khalsa encompasses both a community of believers who consider Sikhism their faith and a group of initiated Sikhs. Devout orthodox Sikhs are ritually admitted to this community upon reaching puberty. The very concept of Khalsa was established by the tenth Sikh Guru, Gobind Singh, in the year 1699.

However, the demand for the establishment of Khalistan is a relatively recent development, originating during the period of British colonialism in Îndia. It primarily emerged in the Punjab region. Some proponents of Khalistan assert that their envisioned state encompasses the current Punjab State, while others advocate for the inclusion of the Punjab region in Pakistan, along with a demand to incorporate other significant neigh-

Furthermore, Shimla and Lahore are considered the two The original call for the formation of Khalistan was, in fact, a response to the Pakistan Resolution of 1940. This resoauthored and prepared by Muhammad Zafarullah Khan



Muslim League on March 23, 1940. The term "Khalistan" was first coined by Dr VS Bhatti to signify an independent Sikh State in March 1940.

The primary objective behind the Khalistan demand was to secure better representation for Sikhs in political institutions and to establish a homeland for the community. After the partition of India in 1947, the Sikhs were deeply affected as Punjab was divided into two parts — one remained with India and the other with Pakistan. As world's problems grow challenging, head of the United Nations gets bleaker

t the annual meeting of world leaders last year, the UN chief sounded a global alarm about the survival of humanity and the planet. This year, the alarm rang louder and more ominously, and the message was even more pressing: Wake up and take action right now. Secretary-General Antonio Guterres' assessment, delivered in his no-nonsense style, aimed to shock.

We are becoming "unhinged," he said. We are inching closer to "a great fracture." Conflicts, coups and chaos are surging. The climate crisis is growing. Divides are deepening between military and economic powers, the richer North and poorer South, East and West. "A new Rubicon" has been crossed in artificial intelligence.

Guterres has spoken often on all these issues. But this year, which he called "a time of chaotic transition," his address to leaders was tougher and even more urgent. And looking at his previous state-of-the-world speeches, it seems clear he has been headed in this direction for quite some time.

In his first address to world leaders in 2017 after taking the helm of the 193-member United Nations, Guterres cited "nuclear peril" as the leading global threat.

Two years later, he was warning of the world splitting in two, with the United States and China creating rival internets, currency, trade, financial rules "and their own zero-sum geopolitical and military strategies." He urged vigorous action "to avert the great fracture."

Then came the COVID-19 pandemic in early 2020. The global response Guterres called for never happened; richer countries got vaccines and poorer ones were left waiting. At last year's leaders' gathering, his message was almost as dire as this week's: "Our world is in peril and paralysed," Guterres said. "We are gridlocked in colossal global dysfunction." This year, his message to the presidents and prime ministers, monarchs and ministers gathered in the vast General Assembly hall was unambiguous and stark.

"We seem incapable," Guterres said, "of coming together to respond."

THE WORLD'S FUTURE, AND THE UN'S

At the heart of Guterres' many speeches this week is the very future of the United Nations, an institution formed immediately after World War II to bring nations together and save future generations from war. But in a 21st-century world that is far more interconnected and also more bitterly divided, can it remain relevant?

For Guterres, the answer is clear: It must. The Cold War featured two superpowers the capitalist United States and the communist Soviet Union. When it ended, there was a brief period of US-dominated unipolarity after the breakup of the Soviet

Union and its dissolution into a dominant Russia and smaller former republics. Now it is moving to a more chaotic "multipolar world" and creating, Guterres says, new opportunities for different countries to lead. But Guterres' key argument is rooted in history. He says it teaches that a world with many power centres and small groups of nations can't solve the challenges that affect all coun-

tries. That's why strong global insti-

tutions are needed, he told leaders on

Cough sounds analysed for assessing Covid severity

A cough analysis could soon reveal disease severity in COVID-19 patients, researchers

Differences in cough sounds depending on the severity of the respiratory condition were observed, the research team led by the Institute for Bioengineering of Catalonia (IBEC), Barcelona, Spain, said.

The results indicated that analysing coughs could help categorise

Covid patients as mild, moderate, or severe and also monitor those with persistent infection, they said in their study published in the European Respiratory Journal Open Research

Cough sounds of 70 patients with SARS-CoV-2 infection were recorded on the smartphone in the first 24 hours following hospital admission.

Previously, studies have analysed cough acoustics for diagnosing respiratory diseases, while this study "specifically investigates the connection between the acoustic characteristics of coughs and the varying levels of pneumonia severity in COVID-19 patients," said Raimon Jane, a senior co-author of the study and the principal investigator at IBEC.

Five frequency-based parameters of the cough sounds differed significantly with varying levels of disease severity and pneumonia progression, the researchers found by statistically analysing data collected between April 2020 and May 2021 at Hospital del Mar in Barcelona.

These differences may reflect the progressive respiratory system changes in patients with COVID-

19, they said. Jane's signal processing group at IBEC developed the methodology and algorithms for the acoustic analysis of cough signals collected via smartphones.

Further, cough analysis can serve a dual purpose - early Covid detection and remote monitoring of disease progression, the authors said, adding that further research involving more patients was needed to validate these study findings.

During emergencies and in regions with limited medical infrastructure, the method could prove useful in the prompt identification and isolation of Covid patients, enabling implementation of control measures and medical care, said senior co-author of the study and researcher at the Hospital del Mar, Joaquim Gea.

Despite being Covid-oriented, the study paved the way for applying this model in the context of other respiratory conditions, the researchers said, adding that the method presented a potential predictive, simple, and accessible tool to assess the risk of suffering severe pneu-

Biologists in race to help largest and rarest tortoise species

hile the average lifespan of North America's largest and most rare tortoise species is unknown, biologists have said it could span upward of a century.

So saving the endangered that got another nudge forward on Friday as US wildlife officials finalised an agreement with Ted Turner's **Endangered Species Fund** that clears the way for the release of more Bolson tortoises on the media mogul's ranch in central New Mexico.

The "safe harbour agreement" will facilitate the release of captive tortoises on the Armendaris Ranch to establish a free-ranging population. US Fish and Wildlife Service Director Martha Williams said the agreement, which offers private landowners protections from regulations, can serve as a model as officials look for more innovative ways to work within the Endangered Species Act.

Dozens of people gathered for the release on Friday of 20 more adult tortoises on the property, which is already home to 23 of them as well as dozens of juvenile ones. With the sun high in the sky and

temperatures nearing 90



degrees (32 degrees Celsius), the release was held off until the evening to ensure their well-being.

The tortoises usually spend about 85 per cent of the time in their earthen burrows, which in some cases can be about 21 yards (20 metres) long.

Shawn Sartorius, a field supervisor with the Fish and Wildlife Service, said the results of the breeding and restoration efforts for the slow-reproducing and longlived animals will not be known in his lifetime.

"What we're doing here is establishing a population here that can be handed off to the next generation," Sartorius said.

It's a step toward one day releasing the tortoise more broadly in the Southwest as conservationists push the federal government to consider crafting a recovery plan for the species.

Workers uncover eight mummies and pre-Inca objects in Peru

ome archaeologists describe describe Peru's capital layers of history, others consider it a box of surprises. That's what some gas line workers got when their digging uncovered eight pre-Inca funeral

"We are recovering those leaves of the lost history of Lima that is just hidden under the tracks and streets," Jesus Bahamonde, an archaeologist at Calidda, the company that distributes natural gas in the city of 10 million people, said Friday.

He said the company's excavation work to expand its system of gas lines over the last 19 years has produced more than 1,900 archaeological finds of various kinds, including mummies, pottery and textiles. Those have mostly been associated with burial

sites on flat ground. The city also has more than 400 larger archaeological sites that have turned



up scattered through the urban landscape. Known as 'huacas" in the Indigenous Quechua language, those adobe constructions are on top of hills considered sacred places.

The number of relics isn't surprising. The area that is now Lima has been occupied for more than 10,000 years by pre-Inca cultures, then the Inca Empire itself and then the colonial culture brought by the Spanish conquerors in 1535

Bahamonde showed the bales of ancient men sitting, wrapped in cotton cloth and tied with ropes braided from lianas that were in trenches 30 centimetres (nearly a foot) below the surface. The company's archaeologists believe the finds belong to the pre-Inca culture called Ichma.

The Ichma culture was formed around AD 1100 and expanded through the valleys of what is now Lima until it was incorporated into the Inca century, scholars say.

Archaeologist Roberto Quispe, who worked in the trench, said the funeral bundles probably hold two adults and six minors. Sometimes, the archeological finds prove to be from more recent times. In 2018, Quispe and other archaeologists working in the La Flor neighbourhood found wooden coffins holding three Chinese immigrants buried in the 19th century.

Archaeologists found the bodies next to opiumsmoking pipes, handmade cigarettes, shoes, Chinese playing cards, a Peruvian silver coin minted in 1898 and a certificate of completion of an employment contract written in Spanish and dated 1875 at a hacienda south of Lima. The eight burial bundles were found near some braised chicken restaurants and a road that leads to Peru's only nuclear power station.

Devoid of 'brain', jellyfish seen to learn from past experiences, new study finds

he ability to learn from past experiences could be independent of possessing a "central brain" like the one that humans, mice and flies possess, according to latest findings of a study in jelly-

Instead, the jellies saw obstacles and employed associated learning, that involves making mental connections between sensory stimulations and behaviours, to guide themselves through murky waters and around underwater tree roots to snare prey, the scientists from Germany and Denmark demonstrated in Caribbean box jellyfish (Tripedalia cystophora).

These "seemingly simple" jellies, no bigger than a fingernail and living in mangrove swamps, have a complex visual system with 24 eyes embedded in their belllike body, they said.

Shedding light on the evolutionary roots of learning and memory, the study findings challenge previous notions that advanced learning, including learning from prior experiences, requires a centralised brain, they said in their study published in the journal Current Biology.



"Learning is the pinnacle performance for nervous systems," said first author Jan Bielecki of Kiel University, Germany.

"Looking at these relatively simple nervous systems in jellyfish, we have a much higher chance of understanding all the details and how it comes together to perform behaviours," said senior author Anders Garm of the University of Copenhagen, Denmark.

The researchers observed the jellyfish for 7.5 minutes in a tank dressed with gray and white stripes to mimic a mangrove environment.

They saw that while initially the jelly bumped into these seemingly far stripes frequently, by the end of the experiment, it had on average distanced itself from the wall more by about a half and quadrupled the number of successful pivots to avoid

How ducks, geese and swans see the world - and why this puts them at risk

¬ ach year, millions of birds fly into power lines, wind turbines and the other man-made structures that litter the open air space. These collisions frequently result in the death of birds and, if power systems go down, disrupt our lives and pose financial challenges for power companies.

Numerous bird species, including macaws in Brazil, geese and swans in the UK, and blue cranes in South Africa have been found to be susceptible to collisions with power lines. But any flying bird can fall victim to such a collision. In some places, these collisions happen so often that they can jeopardise local populations of endangered species.

But birds are highly evolved flying machines. They can fly in tightly packed flocks that weave and turn to our delight and wonder. So why do they fly into things?

According to our latest research, the answer lies in how they see the world. We found that looking directly ahead is simply not that important to many

species of duck, geese and swans.

HOW BIRDS SEE THE WORLD Exploring the reasons behind why birds are victims of collisions has led to new ideas that challenge our fundamental perception of what birds are. In the past, scientists have described birds as "a wing guided by an eye"

This implies that flight has been central to moulding bird vision throughout their evolution. But now it is safe to conclude that a bird is instead best characterised as "a bill guided by an eye".

Rather than flight, the main driver of the evolution of bird vision has been the kev tasks associated with foraging, in particular detecting food items and getting the bill to the right place at the right time in order to seize them.

Alongside the detection of predators, this is the task that bird vision has to get right day in, day out. Birds differ in how much the view from each eye overlaps (called the binocular field of view). The more the eyes look straight

ahead, the more the view from each eye will overlap much as human eyes do thus broadening the binocular field.



For a bird such as a duck, with its eyes positioned high up on either side of the head, the view from each eye will be

very different (with smaller binocular field). We measured binocular field size across a broad range of 39 species of duck, geese and swans. We found that the key driver of diversity in vision between species is their diet and how they forage for food. Birds that primarily use their vision to locate foods such as seeds, or selectively graze on plants, tend to have broader binocular fields.

However, the binocular fields of species like mallards and pink-eared ducks are much narrower.

These birds rely less on their eyes for foraging and more on touch cues from their bills. The vision of birds like these instead provides them with a comprehensive view of the region above and behind their heads. Birds certainly need to have some visual coverage in front of them. But with eyes placed high on the side of the head, resulting in a very nar-row binocular field, they are restricted to retrieving rather scant detail from the

distant scene ahead. What matters to them more is placing their bill accurately at a close distance and seeing who is coming at them from the side or from behind.

This finding is not confined to ducks, geese and swans. It probably generalises to all birds, except perhaps some owls (which have more front-facing eyes and rely upon sound to locate prey). The great majority of birds are therefore vulnerable to collisions.

However, it is larger birds like geese, swans and bustards that face real problems. Their restricted forward vision is compounded by flying fast and being unable to change direction quickly.

These birds also often fly in flocks, and at dusk and dawn when the light level is lower.

WARNING BIRDS OF HAZARDS AHEAD

Understanding the vision of birds from the perspective of foraging and predator detection improves our understanding of what causes collisions. But, more importantly, it allows us to do something about it.
