A bench headed by Chief Justice

of India DY Chandrachud responded to senior advocate Sidharth Luthra, who represented TDP chief Naidu, with a cautious "We will see what to do, tomorrow." This came in response to Luthra's fervent request for an urgent hearing, despite the petition not being list-

ed for today's session. Luthra, making an unlisted mention, brought to the apex court's attention that Naidu has been in custody since September 8, and alleged that opposition voices in Andhra Pradesh were being stifled. However, the Supreme Court did not accede to the out-of-turn mentioning and instructed Luthra to remention the matter on September 26 for directions seeking an urgent

Bamboo shoots find their way into urban kitchens PNS VISAKHAPATNAM Bamboo shoots, known as 'Veduru

Kommulu' in local parlance, have seen a surge in popularity in a wide array of home kitchens, ranging from tribal communities to urban and rural areas. This heightened interest is a result of people recognising the nutritional and therapeutic advantages of bamboo shoots. The demand for bamboo shoots

in the market is steadily increasing, primarily driven by their growing utilisation in soups, stews, and curries. These shoots have evolved into an essential element of the tribal community's dietary habits, as they are seen as valuable for enhancing immunity. Consequently, bamboo shoot-based curries are gaining favor, not only at weekly markets in tribal regions but also making appearances on the menus of a few upscale hotels in the Telugu states.



The demand for bamboo shoots has seen a significant uptick in various tribal regions, including Chintapalli, Araku, Paderu Anantagiri, Munchingput, Hukumpet in Alluri Šitarama Raju district, and certain areas within Road, Araku, and Chintapalli.

the Parvathipuram Manyam district, as well as a few other tribal areas within the state. Presently, these bamboo shoots are readily abundant and accessible in areas such as Paderu, Lammasingi Ghat

Bamboo shoots represent the young, fresh, and tender stems of bamboo plants, gathered for diverse culinary applications. Dr Kiran Rao noted that, in the wake of the Covid-19 pandemic, people

from non-tribal regions in the

plains have also begun to include bamboo shoots in their diets to bolster their immune systems. In tribal areas, a bundle of five or six bamboo shoots typically sells for approximately 60 to 70 units, whereas the same quantity can command prices exceeding 120 units in urban areas and towns. Consequently, each vendor is generating daily earnings in the range of 1,500 to 2,000 units.

According to Divya Sudha, a scientist at Krishi Vigyan Kendra, bamboo shoots contain nutritional and bioactive elements that are linked to a range of health advantages. These advantages encompass reducing blood pressure and cho-lesterol levels, enhancing appetite, possessing anti-cancer and antidiabetic properties, as well as lowering the risk of conditions like cardiovascular diseases, hypertension, obesity, and cancer, among others.

Canada's action a blow to G-20 declaration

anada is a signatory to the declaration that no **⊿**G-20 nation should allow its territory to be used for promotion of terrorism in another country at the recently concluded G-20 Nations Śummit held in Delhi.

Surprisingly, anti-India terrorist activities are being allowed to continue in Canada. It may be recalled that in 1980s, some Sikhs who advocate creation of Khalistan led a separatist movement and claimed the lives of thousands. The then PM Indira Gandhi urged Canada in 1982 to see to it that Sikh extremism is not allowed in that country.

Then Pierre Trudeau, who was the father of current Canada PM Justin Trudeau, was the Prime Minister of Canada. However, in 1984 as misfortune would have it, Sikh bodyguards of Mrs Gandhi claimed her life. In 1985, Sikh extremists had blown up an Air India flight after it taking off from Canada claiming lives of 329 passengers, including 268 Canadians.

In spite of it, the Canadian PM is putting the blame on Indian officials for some unidentified persons gunning down a Sikh extremist called Hardeep Singh Nijjar outside a Gurudwara in Surrey on June

About Nijjar, Indian officials tipped off Canada about his terrorist activities way back in 2020. Nijjar had links with Khalistan Tiger Force, active in Punjab working for Khalistan. The NIA shared information with Britain, the USA, Australia, Canada, Dubai, Pakistan and other nations about 19 terrorists.

Surprisingly, running terrorist activities in countries like Canada was not illegal and terrorists enjoy protection under

Further, the Naidu's legal team, led by Supreme Court lawyer Pramod Dubey, was asked to file their counter, if any, on the custody petition by tomorrow.

Though the CID's prisoner on transit (PT) petitions in the AP FiberNet and Amaravati Inner Ring Road cases did not come up for hearing on Monday, Vivekananda observed that they are expected to be taken up one by one at a later date. However, he said that the court insisted on hearing the bail petition before the PT warrants as it is concerned with the personal liberty of an individual.

The Andhra Pradesh CID filed a fresh petition in court on Monday seeking further five-day custody of Naidu in the Skill Development Corporation scam case.

After the two-day police custody of Naidu ended on Sunday evening, the court had extended his judicial remand till October 5. On Friday, the Andhra Pradesh High Court dismissed the TDP chief's FIR quash petition, prompting Naidu to approach the Supreme Court.

Naidu was arrested on September 9, for allegedly misap-propriating funds from the Skill Development Corporation, which resulted in a purported loss of over Rs 300 crore to the state exchequer.

In his plea, Naidu asserted, "The petitioner was suddenly named in the FIR registered over twenty-one months ago, arrested in an illegal manner, and deprived of his liberty motivated only by political reasons, even though there is no material against him."

The plea also contended that both the initiation of the inquiry and the registration of the FIR against Naidu were non-existent in law, as both had been initiated and continued without mandatory approval under Section 17-A of the Prevention of Corruption Act, 1988.

Naidu was apprehended by the Criminal Investigation Department (CID) in Nandyal on September 9. The following day, the Anti-Corruption Bureau (ACB) Court in Vijayawada remanded him to judicial custody for 14 days. On September 22, the CID was granted custody of Naidu for two days for interrogation at the Rajahmundry Central Jail, where he is presently confined.

Following the conclusion of TDP chief Naidu's two-day police custody on Sunday, the ACB court further extended his judicial custody until October 5. The alleged case revolves around the establishment of Centres of Excellence (CoEs) clusters in the state of Andhra Pradesh, with a total estimated project value of Rs 3,300 crore during Naidu's tenure as Chief Minister.

The CID has alleged that this purported fraud led to a substantial loss of Rs 371 crore to the state government.

Police foil 'Chalo Vijayawada' march by Anganwadi workers

Preventive arrests of union leaders and workers rattle city

State-wide 'Chalo Vijayawada' protest was foiled by the Anganwadi and Midday Meal Workers' Union by police on Monday. Seeking solution to long-pending grievances and applying pressure on the government, the AITUC, CITU, IFTU, and Pragatisheela Mahila Sangams had jointly called for the widespread demonstration in Vijayawada.

In response, a multitude of Anganwadi workers and helpers had endeavoured to reach the protest site. However, police intervened, apprehending union leaders and workers across various locations. The police made detentions at the Railway station, Bus stand, Eluru Road, Gandhinagar, and several spots within the city and its outskirts.

Subsequently, those apprehended were transferred to nearby police stations and Kalyana Mandapams. A total of 150 Anganwadi workers and helpers were detained at Gujjula Saraladevi Kalyana Mandapam, 100 members at Singnagar Lagadapati Raja

Kalyana ident Baby Rani, secretary Mandapam, 100 more at Subba Ravamma, and State Nakshatra Convention, and leaders N Ch Supraja, V an additional 120 members at Umamaheswara Obulesu, among others. Auto Nagar Technician

Expressing outrage at the arrests, CPM State secretary V Srinivasa Rao and CPI State secretary K Ramakrishna vehemently condemned the crackdown on individuals who had come to Vijayawada for a peaceful demonstration. They asserted that Chief Minister YS Jagan Mohan Reddy had failed to fulfill promises related Anganwadi issues, salary increases, and other concerns.

Furthermore, they accused the police of refusing permission for the protest under the pretext of Sections 144 and 30 and highlighted that Anganwadi workers from all over the state had been apprehended. Family members of these workers were also taken to police stations, with allegations that many Anganwadi leaders were placed under

house arrest. "The police are behaving inhumanely, disregarding the dignity of these women. Ordinary citizens were also severely inconvenienced at bus and railway stations. The

In what can be considered a noteworthy advancement for the North Andhra region, Andhra University is currently in the midst of establishing a specialised 'Animal House' facility dedicated to the execution of 'Ġood Laboratory Practice' (GLP) testing. This endeavour will enhance Visakhapatnam's global recognition as a centre for GLP certification, a mandatory requirement for pharmaceuticals designed for both human and animal use.

The upcoming Animal House project with an estimated expenditure of Rs 1 crore will be linked to the Department of Pharmacy at AU at Element Block on the AU campus. This facility will function as a valuable asset for conducting preclinical assessments, particularly in the evaluation of medication safety and toxicity through order to uphold ethical stan-

dards, laboratory animals will be



procured from a breeder duly registered with the Committee for the Purpose of Control and Supervision of Experiments on Animals (CPCSEA) under the Ministry of Fisheries. Initially, the facility will be

stocked with licensed rats, mice, hamsters, gerbils, guinea pigs, and rabbits obtained from suppliers in Hyderabad, Chennai, and Bengaluru. As the need arises, there is also the possibility of procuring these animals from the United States, Germany, and the United Kingdom in the coming time.

According to Andhra University Registrar Professor V Krishna Mohan, AU will estab-Hyderabad-based company.

This initiative is aimed at benefiting students majoring in pharmacy, biochemistry, botany, zoology, and biotechnology, while also providing valuable resources for the pharmaceutical, biotechnology, and food industries.

Professor K Eshwar Kumar, the Pharmacology expert at AU, mentioned that construction on the facility has commenced and is expected to conclude within two months. However, before operations can begin, it is imperative to obtain No Objection Certificates (NOCs) from regulatory bodies such as CPCSEA and the Pollution Control Board.

Currently, pharmaceutical companies in the city are pursuing GLP certification from places like Hyderabad, Pune, and Chennai. Professor Eshwar Kumar noted that by establishing a local Animal House, thev can provide GLP certification with Rodenta Bioserve, a be outfitted with a variety of state-of-the-art facilities

Govt urged to procure MSME products

The Andhra Pradesh Chambers of Commerce and Industry Federation (AP Chambers) has demanded that the State government should take proactive measures to procure its required materials and goods from the MSME units spread across Andhra Pradesh. It stated that the procurement from MSMEs would not only provide much-needed support to these local businesses, but also stimulate regional economic growth.

from MSME units in Andhra Pradesh.

AP Chambers' office-bearers stated: "As per the Public Procurement Policy of the MSMED Act, 2006, the Union government set an annual target of 25 per cent mandatory procurement from MSMÉ Sector effective from April 1, departments, corporations, public sector undertakings, etc., are not adhering to the mandatory guidelines stipulated for procurement of goods and services from within the State. Out of 25per cent, four pc is reserved for SC/ST entrepreneurs and three pc for women entrepreneurs.

Stating that the policy was aimed to provide an assured Chambers delegation said that als and goods from the MSME the objective of the policy was

to promote and develop micro and small enterprises by supporting them in marketing of products and services rendered by them.

AP Chambers president Bhaskara Rao said, "There are 358 items reserved for exclusive procurement from MSMEs. Most of these reserved items are manufactured by MSMEs in the State. As part of the restart package, the Government of AP provided for preferential market access to micro and small enterprises in all government procurements. Unfortunately, the mandatory guidelines are not adhered to and the public procurement has been mainly happening from other States and other countries without transparent procurement poli-

Unlike Western countries where clinical pharmacists are seamlessly integrated into hospital settings, assisting physicians and patients with postdiagnosis medication decisions, India lacks a similar system. Despite offering a sixyear medical programme called Pharma D (Doctor of Pharmacy) to train clinical pharmacists, there is no mandatory requirement for their placement in govern-ment and private healthcare institutions.

Speaking with on the occasion of World Pharmacist Day, Prof. Ganapathi, former principal of AU College of Pharma

Sciences, expressed concern over the lack of job opportunities for Pharma D graduates in Vizag, where numerous colleges offer the course. He emphasised the need for the Pharmacy Council of India (PCI) to make it mandatory for hospitals to hire clinical pharmacists and educate doctors about their role. Currently, only a few corporate hospitals hire them with minimal salaries, and their utilisation remains limited.

S Ravindra, a Pharma D degree holder, highlighted the potential benefits of clinical pharmacists, especially in government healthcare setups where doctors often have limited time to interact with patients due to high patient

While the Rajya Sabha passed Bill 186-1 on March 9, 2010, it was not passed in Lok Sabha, she said. The Bills introduced or passed in Rajya Sabha do not lapse, hence the Women's Reservation Bill remained very much active, she explained.

Recalling that the Congress implemented reservations for

women in local bodies and passed the Women's Reservation Bill in the Rajya Sabha without having a majority, Pathak questioned why the Modi government did not implement the Women's Reservation Bill for nine-and-a-half years despite the BJP having a full majority. She asked why the BJP government was imposing conditions of census and delimitation as a delaying tactic.

According to a BJP leader, the event was attended by more than five lakh workers. "The Congress and its allies

in the 'ghamandia' (arrogant) bloc (INDIA) supported the Women's Reservation Bill out of compulsion and hesitation as they understood the power of 'nari shakti'. Its passage (in Parliament) became possible as 'Modi hai to Mumkin hai'. Modi means the guarantee of fulfilling guarantees," the PM

He slammed the Congress and its allies for not ensuring the passage of the long-pending legislation in Parliament when they were in power at the Centre.

COVID-19: India records 40 fresh cases, active caseload at 456

India witnessed a single-day rise of 40 new COVID-19 cases while the active caseload has been recorded at 456, according to Union

Health Ministry data.
The death toll has been recorded at 5,32,031 (5.32 lakh), showed the data updated on Monday.

The country's Covid case tally is at 4,49,98,565 (4.49 crore).

The number of people who have recuperated from the disease is at 4,44,66,078 (4.44 crore) while the national recovery rate stands at 98.81 per cent, according to the health ministry website.

The case fatality rate stands at 1.18 per cent.

According to the website, 220.67 crore Covid vaccine doses have been administered in India so far.

If voted to power, Cong will conduct caste census: Rahul

Congress leader Rahul Gandhi on Monday said his party would conduct a "caste census" if elected to power as only such an exercise would ensure "participation of OBCs, Dalits, tribals and women". He also asked why the

Narendra Modi government had not released the details of a 'caste census' conducted by the Congress (when it was in power) and sought to know if the PM was afraid of such an exercise.

Addressing the state govern-ment's 'Awas Nyay Sammelan' in Parsada (Sakri) village in Bilaspur, Gandhi also waved a remote control at the crowd and said the poor and needy were benefited when the Congress presses it, while "Adani gets ports, airports and railway contracts" when the ruling BJP does the same.

"The Congress had conducted a caste census that has



the record of the population of every caste in the country. The Union government has this report but Modiji doesn't want to reveal it," he claimed.

"Caste census has to be conducted if we want to give participation to Other Backward Classes, Dalits, tribals and women. If Modiji does not conduct a caste census, then when we are elected to power our first step will be to conduct a caste census to ensure OBC participation," Gandhi asserted. Gandhi said the government is run by secretaries and MPs and MLAs, and pointed out that only three of the 90 secretaries in various Union government ministries are

These three persons control only 5 per cent of the country's budget, Gandhi said and questioned if India only had 5 per cent OBC population. Asserting that the caste cen-

sus is the answer to such questions, Gandhi asked why Modi was scared of the enumeration

'Metal-mining pollution impacts 23 m people globally'

PNS NEW DELHI

An estimated 23 million people around the world live on flood-plains contaminated by potentially harmful concentrations of toxic waste from metal-mining activity, accord-

ing to a study. The research, published recently in the journal Science, provides new insights into the extensive impact of metal mining contamination on rivers and floodplains across the world.

Using a new georeferenced global database of 185,000 metal mines and employing a combination of process-based modelling and empirical testing, the research assessed the global scale of metal mining

contamination in river systems and its repercussions for human populations and live-

The study modelled contamination from all known active and inactive metal mining sites, including tailings storage facilities used to store mine waste. It looked at potentially harmful contaminants such as lead, zinc, copper, and arsenic, which are transported downstream from mining operations, and often deposited along river channels and flood-

plains for extended periods. "Our new method for pre-dicting the dispersal of mine waste in river systems worldwide provides governments, Lincoln, UK environmental regulators, the mining industry and local



communities with a tool that, for the first time, will enable them to assess the offsite and downstream impacts of mining on ecosystem and human health," said Professor Mark Macklin, from the University of

We expect that this will make it easier to mitigate the

environmental effects of historical and present mining and, most importantly, help to minimise the impacts of future mining development on communities, while also protecting food and water security," said

Macklin, who led the research. Released against the backdrop of growing demand for metals and minerals to feed the demands of the green energy transition, the new results highlight the widespread reach of the contamination, affecting approximately 479,200 kilometres of river channels and encompassing 164,000 square kilometres of

floodplains on a global scale. According to the findings, approximately 23.48 million people reside on these affected floodplains, supporting 5.72 million livestock and encompassing over 65,000 square kilometres of irrigated

Due to a lack of available data for several countries, the team behind the study believe these numbers to be a conservative estimate.



Canada must rein in extremists

Ottawa must be made to understand the sentiments of New Delhi; it should stop pampering pro-Khalistan elements

he ongoing massive diplomatic row has brought a sudden spotlight on the Canada-India relationship.

Differences emerged between the two countries after Canadian Prime Minister Justin Trudeau alleged Indian involvement in killing a separatist Sikh activist, Nijjar. Outraged, New Delhi vehemently denied the claim and dismissed it as "absurd and motivated."

On June 18 this year, a pro -Khalistani leader Najjar was shot dead outside a Gurudwara in Surrey, British Columbia. India had declared him a wanted terrorist. If the relationship between India and Canada had been trending smoothly, it was because of the Geopolitical developments, economic relations, and demographic trends. It worsened after the Nijjar killing. The two countries resorted to tit-for-tat reactions against each other. The ties between the visiting Canadian Prime Minister Justin Trudeau for the G20 summit last week were vis-

New Delhi has been protesting the presence of the pro-Khalistani elements in Canada. New Delhi also frowned on the referendum for Khalistan by them. When Trudeau was on a bilateral visit in 218, there were embarrassing moments about the presence of a Khalistni activist in his delegation. The pro-Khalistani elements sent death threats to Indian diplomats in Ottawa. The request for their extradition also has yet to be addressed so far.

Why is Canada important to India? The former British colony has the highest population of Sikhs outside their home state of Punjab. About 1.4 million Indian immigrants live in Canada out of 40 million. About 770,000 people follow Sikhism. New Delhi has often complained about their

After the controversy, Canada India acted swiftly to expel senior diplomats in reciprocal moves earlier this week. On Thursday, India's foreign ministry suspended visa services temporarily for Canadian citizens. Ottawa claims that Canadian security agencies had uncovered

evidence linking the Indian government to the assassina-

As for domestic politics, the Congress and other parties supported the Indian government and criticised Trudeau's statement. They are shocked at the allegation that the Indian government had orchestrated the killing of an Indian-origin Canadian citizen on Canadian soil and supported the South Bloc. Only Sukhbir Badal, the leader of Akali Dal, suggested that political parties should work together to stop anti-Sikh propaganda in the media.

As for the international scenario, the reaction towards India from its Western allies has been cautious. Top U.S. diplomat David Cohen claimed the shared intelligence among the Five Eyes made Justin's allegation. Five Eyes Network is an intelligence alliance comprised of the United States, the United Kingdom, Australia, Canada, and New Zealand. The New York Times said on Sunday, "In the aftermath of the killing in June of the Sikh separatist leader Hardeep Singh U.S. intelligence agencies offered their Canadian counterparts context that helped Canada conclude that India had been involved.

Trudeau called on India to cooperate with Canadian

authorities to "uncover the truth" about the killing but stated that he was not looking to escalate tensions between the two countries. The standoff will have repercussions for both India and Canada. India is Canada's tenth most significant trading partner. Secondly, India has a vital

role in Canada's 2022 Indo-Pacific Strategy. Thirdly, India is Canada's tenth most significant trading partner. The two countries have been in discussions about a trade agreement for more than a decade. The Department of Biotechnology granted six fellowships as part of its awards program.

The Department of Atomic Energy distributed 25 performance-based honours and 13 awards in noncore domains. Except for the one internal award given by the Department of Atomic Energy in the name of Homi Jehangir Bhaba, all other internal awards have been stopped.The new avatar 'Rashtriya Vigyan Puraskar' shall be limited to 56 prizes under 4 categories, viz., Vigyan Ratna, Vigyan Shri, Vigyan Yuva-Shanti Swarup Bhatnagar, and Vigyan Team. The Vigyan Ratna Award will honour the lifetime accomplishments of scientists, while

the Vigyan Shri Award will acknowledge notable contri-

butions to a specific field. The Vigyan Yuva Shanti Swarup Bhatnagar Award aims to inspire young scientists who have demonstrated outstanding contributions in their respective fields.

The Rashtriya Vigyan Puraskar will be conferred across 13 disciplines, encompassing Physics, Chemistry, Biological Sciences, Mathematics and Computer Science, Earth Science, Medicine, Engineering Sciences, Agricultural Science, Environmental Science, Technology and Innovation, Atomic Energy, Space Science and Technology, among others. The Rashtriya Vigyan Puraskar is open to every Indian citizen and also to people of Indian origin working in other countries. However, the limelight.

Vigyan Yuva-Shanti Swarup Bhatnagar (VY-SSB) there is no upper age limit for applying. In VY-SSB the upper age limit is fixed at 45.

In the earlier version of the award that has been followed for many years only people working in government sectors were considered. The Rashtriya Vigyan Puraskar is open to all researchers, irrespective of the organization. Even people working outside the gamut of any organization can also apply for these awards. This will help thousands of outstanding researchers working under various NGOs in the country to showcase their scientific talents and come to

A panel headed by the Principal Scientific Adviser will be responsible for choosing the recipients. The Rashtaries from all six science departments, four presidents chosen from science and engineering academies, and six eminent scientists and technologists representing various realms of science. Each year, nominations for these awards will be open from January 14 to February 28, coinciding with National Science Day. One landmark decision in the new award is the clause for self-nominations, which was not possible in the earlier version. Often the malpractice and unethical practices happening in science are because of this nomination culture. A TICKING TIME BOMB

Sir — Hypertension is a ticking time bomb. It is imperative that people take note of the fatalities and disabilities caused by this "silent killer" known as hypertension. The first report from the World Health Organization (WHO) on the perils of hypertension revealed that nearly 80 percent of individuals worldwide with high blood pressure suffer due to inadequate treatment. Shockingly, only 37 percent of Indians with hypertension are diagnosed, and merely 30 percent receive treatment, despite the abundance of anti-hypertensive medications, the expertise of skilled physicians, and a wealth of literature outlining its dangers. The danger of hypertension is encapsulated in the "rule of halves" - half of the global population is diagnosed, half of those diagnosed receive treatment, and only half of them attain sus-

tainable normal blood pressure levels. Neglected hypertension can lead to an enlarged heart and inefficient blood vessel function, resulting in casualties. This is particularly unfortunate given the simple and effective ways to prevent and manage this debilitating condition. Lifestyle adjustments, such as regular physical activity, a balanced diet with limited salt and sugar intake, minimal alcohol consumption, smoking cessation, stress reduction, and consistent medication under supervision, can make a significant difference. The relentless stream of information and sen-

sationalized news can contribute to information overload and heightened stress levels.

Rupee falls 20 paise to close at 83.14 against US dollar

IndianOil unveils India's first

green hydrogen-run bus

India's top oil firm IOC on Monday unveiled the nation's first green hydrogen-powered bus that emits just water as it takes the lead in bringing out unrivaled tools to replace fossil fuels. Indian Oil Corporation (IOC) will produce close to 75 kg of hydrogen by splitting water using electricity from renewable sources. This hydrogen will be used to power two buses which will ply across the national capital region for trial runs. Oil Minister Hardeep

Singh Puri, flagging off the buses, said hydrogen will be India's transition fuel for moving away from fossil fuels. IOC's R&D Centre at Faridabad is producing green hydrogen for the pilot run. Four cylinders with a capacity of 30 kg can run the buses for 350 km. It takes 10-12 minutes for the four tanks to fill. Hydrogen when burnt emits only water vapour as a by-product. With three times the energy density and the absence of harmful emissions. hydrogen shines as a cleaner, more efficient choice to meet the energy

DGTR initiates anti-dumping probe into Chinese imports

PNS NEW DELHI

India has initiated a probe into an alleged dumping of flasks and bottles by Chinese firms in the country following a complaint by a domestic player.

The move is aimed at pro-

tecting domestic players from cheap imports of 'vacuum insulated flasks or vessels of stainless steel' from the neighbouring country.

The probe was started after a complaint by Placero International Pvt Ltd was received, which stated that the domestic industry is getting injured due to an increase in dumped imports.

Directorate General of Trade Remedies (DGTR), the commerce ministry's investigation arm, is probing the dumping of this product originating in or exported from

The products under consid-

eration for the probe include flasks, cups, bottles, kettle, carafe, and dispensers.

According to a DGTR notification, there is prima facie evidence of injury being caused to the domestic industry by dumped imports from China.

"The authority, hereby, initiates an anti-dumping investigation" on the imports, the notification has said. If it is established

that the dumping has caused material injury to domestic play-ers, DGTR would recommend the imposition of antidumping duty on these imports.

Reserve Bank Governor Shaktikanta Das on Monday said the central bank has noticed "excessive dominance" by one or two board members even in "big commercial banks" and asked the lenders to desist from such practices.

No independent regulator in new e-commerce policy

PNS NEW DELHI

The proposed e-commerce policy, which is under formulation, has no provision for setting up of an independent regulator for online retail platforms, a senior official said.

The official also said regarding data related issues, the e-commerce firms have to comply with the Digital Personal Data Protection (DPDP) Act and the proposed policy will not cover that area.

The proposed national e-commerce policy is in the final stages and no new draft will be issued now for seeking views of stakeholders as that exercise has been completed

"The ministry has to give a presentation of the proposed policy to the prime minister's office. There is no plan to set up any regulator for the sector, at least not in the near future. As of now, it is not on the anvil," the official, who did not wish to be named, said.

The Department for Promotion of Industry and Internal Trade (DPIIT) on August 2 held a detailed discussion with representatives of ecommerce firms and a domestic traders' body on the proposed policy.

In that meeting, a broad level of consensus emerged among the concerned stakeholders on the proposed policy.



Demat accounts grow 26% to 12.7 crore

The number of demat accounts rose to 12.7 surge of 26 per cent on a yearly basis, primarily due to attractive returns from equity markets, and ease of account opening

Also, the incremental additions of such accounts were higher in August in comparison to the preceding month. Further, this was way

higher than the average 21 lakh monthly additions in fiscal year FY23, according to an analysis by Motilal Oswal Financial Services.

The new account additions rose 4.1 per cent month-on-month to 31 lakh in August compared to 30 lakh additions in July.

Going by the data, a total of 12.7 crore demat accounts were registered with the two depositories -- NSDL and CDSL-- at the end of August 2023 as compared to 10.1 crore a year earlier.

The number of demat accounts was 12.3 crore at July-end.

The Global Trade Research Initiative (GTRI) said that currently, India's limited participation in global value chains (GVCs) hampers its export potential, despite possessing substantial manufacturing capabilities across various GVC-relevant product cate-

The integration of Indian companies in the GVCs is fundamental as about 70 per cent of global trade operates witha wide range of products, from electronics and machinery to pharmaceuticals and apparel.

"India's weak GVC integration can be attributed to poor trade infrastructure, causing delays at ports and customs, which are detrimental to the timely flow of goods in these intricate value chains," GTRi Co-Founder Ajay Srivastava

Countries like China, Japan,



South Korea, Thailand, and Malaysia have excelled in GVCs due to investments in quality trade infrastructure.

The GTRI report has recommended six action points to the government which can help boost the participation of

domestic firms in GVCs. The suggestions include automating port and customs procedures, and implementation of green channel clearments; analysing the top 10,000 exporters responsible for 85 per cent of India's exports; matching global best practices for ship turnaround times, reducing queues, speeding up transactions, and optimizing infrastructure use; and enhance communication between traders and shipping companies, port operators, and Container Freight Stations

CTI to Centre: Ban lentil import from Canada

Delhi traders' body CTI on Monday urged the Central government to ban import of lentil (masur) from Canada, over Ottawa's allegations relating to the killing of a Khalistani separatist on Canadian soil.

Chairman of CTI, Brijesh Goyal, said that the development has sent ripples through the business world. Indian traders have demanded that India should ban import of lentils from Canada, which is a major suppli-

"Canada is becoming a stronghold of Khalistanis and their anti-India sentiment was displayed by protests at the Indian embassy.

However, Trudeau is making politically motivated statements in view of upcoming elections in Canada," he said.

India's annual pulse consumption is estimated at around 23 lakh tonnes of which 15-16 lakh tonnes is produced domestically and rest is imported from other countries. In the last financial year, India imported 4.85 lakh tonnes of lentil from Canada, Goyal said.

The Central government may contact other countries for pulses like Russia, Singapore, and Turkey, he added.

Sensex, Nifty end 4-day losing streak

Benchmark indices Sensex and Nifty closed marginally up in highly volatile trade on Monday, snapping their fourday losing streak even as weak global trends and foreign fund outflows dented the investor sentiment.

After gyrating 461.6 points during the day, the 30-share BSE Sensex eked out a marginal gain of 14.54 points or 0.02 per cent to settle at 66,023.69. During the day, it hit a high of 66,225.63 and a low of 65,764.03.

Snapping its four-day losing streak, the broader Nifty settled marginally up 0.30 points at 19,674.55 as 24 of its components advanced while 26 declined. Gains in financials, consumer durables, realty and banking shares were offset by losses in IT, oil & gas and pharma shares. In the four sessions to Friday, the 50-issue barome-

ter declined 3.37 per cent or 518 points while Sensex plunged 1,829 points or 3 per cent following a record 11-day Ánalysts said a fresh uptick in US treasury yields is making investors jittery amid rising concerns over inflation

BIS Director General Pramod Kumar Tiwari said, these standards will signifi-cantly complement the objectives of Global Biofuel Alliance under the aegis of the Food (GBA), the multilateral forum announced by Prime Minister Narendra Modi during the G20 leaders' summit held recently in the national capital.

"We are committed to support this path breaking initia-

through development of relevant Indian Standards and necessary quality parameters/performance specifications," he said in a statement.

He said development of standard on paraffinic (green) diesel, that is derived from second generation (2G) feedstock, is also under progress. BIS is a national standards body of India that works

Ministry. According to the BIS, the USA, Brazil, and India are the major producers and consumers of biofuels. These three countries collectively con-

tribute 85 per cent production and 81 per cent consumption of ethanol globally.

The global ethanol market was valued at USD 99 billion in 2022 and is expected to grow at a compounded annual growth rate of 5 per cent by 2032, creating a huge opportunity for Indian industries and contributing to farmers' income, job creation and overall development of the Indian

ecosystem, it said. Currently, about 98 per cent of the fuel requirement in India for the transportation sector is met by fossil fuels and the remaining 2 per cent by biofuels.

Indian Oil Manufacturing

Companies (OMCs) are working towards provisioning new distilleries for production of first generation (1G) and 2G ethanol and Indian vehicle manufacturers are developing engines compliant with

ethanol blended fuel. The government has also started an interest subvention scheme for molasses and grain-based distilleries to promote ethanol production.

It is also foreseen that flex fuel vehicles, which are capable of utilising ethanol-blended gasoline up to 85 per cent, that are already operational in the USA and Brazil, are soon to make an entry in India, the BIS added







UNDERSTANDING ATRIAL FIBRILLATION trial fibrillation (AFib) is a common cardiac arrhythmia that affects millions of individuals globally. It's a condition characterised by irregular and often rapid heartbeats, which can lead to various complications, including stroke. Atrial fibrillation is a heart rhythm disorder that originates in the atria, the upper chambers of the heart. In a normal heartbeat, the heart's electrical signals travel in a coordinated and organised manner, allowing for a rhythmic contraction and the pumping of blood throughout the body. However, in individuals with AFib, these electrical signals become chaotic, resulting in an irregular and often rapid heartbeat. This irregular heartbeat can lead to inefficient pumping of blood, causing symptoms such as palpitations, shortness of breath, fatigue, dizziness, and chest discomfort. If left untreated, AFib can significantly increase the risk of stroke, heart failure, and other cardiovascular com-

plications.

DETECTING ATRIAL FIBRILLATION

Early detection of atrial fibrillation is crucial for effective management and the prevention of complications. However, AFib can be challenging to detect as it may not always present noticeable symptoms. Regular check-ups and screenings, especially for individuals at higher risk, can aid in early diagnosis. An electrocardiogram (ECG or EKG) is the primary tool for diagnosing AFib. It records the heart's electrical activity, identifying any irregularities in the heart rhythm. Holter monitors, event monitors, and mobile health applications can also be used for longer-term monitoring, enabling the detection of intermittent or paroxysmal AFib.

Treating atrial fibrillation: The treatment of atrial fibrillation aims to manage symptoms, restore normal heart rhythm, and reduce the risk of complications. Treatment plans are personalised based on the patient's symptoms, overall health, and the presence of underlying conditions.

Medications: Medications are often the first line of treatment for AFib. Antiarrhythmic drugs help regulate the heart's rhythm and rate. Anticoagulants, also known as blood thinners, are prescribed to reduce the risk of blood clots and stroke, a significant concern for those with AFib.

Cardioversion: Cardioversion involves using electric shocks or medications to restore a normal heart rhythm. It's particularly effective for recent-onset AFib or when medications fail to control the irregular rhythm.

Ablation therapy: Ablation involves destroying or isolating the areas of the heart that are triggering abnormal electrical signals. This procedure can be done through catheter ablation and is often recommended for individuals with persistent AFib.

Pacemaker or implantable cardioverterdefibrillator (ICD): In some cases, a pacemaker or ICD may be implanted to help regulate

heart rhythms and prevent excessively slow or fast heart rates.

Stroke prevention in atrial fibrillation: Individuals with atrial fibrillation are at a significantly higher risk of stroke due to the potential formation of blood clots in the heart, which can travel to the brain and cause a stroke. Therefore, stroke prevention is a critical component of AFib management.

Anticoagulant therapy: Anticoagulant medications, such as warfarin, dabigatran, rivaroxaban, or apixaban, are commonly prescribed to reduce the risk of stroke by preventing blood clot formation.

Lifestyle modifications: Lifestyle changes, including a heart-healthy diet, regular exercise, limiting alcohol consumption, quitting smoking, and managing stress, can play a crucial role in reducing the risk of stroke and improving overall heart health.

Educating and empowering patients: Education and patient empowerment are vital in managing atrial fibrillation. Patients should be educated about their condition, treatment options, and the importance of adherence to medications and lifestyle modifications. Regular follow-ups with healthcare providers are essential to monitor progress and adjust treatment plans as needed.

Atrial fibrillation is a prevalent cardiac condition that requires comprehensive understanding and appropriate management to mitigate associated risks. Early detection, individualised treatment plans, and effective stroke prevention strategies are essential components of addressing AFib and improving the lives of those affected. With advancements in medical science and a proactive approach to healthcare, individuals with atrial fibrillation can lead fulfilling and active lives while minimising the potential complications of this condition. Regular communication with healthcare professionals and a commitment to a heart-healthy lifestyle are key elements in navigating the journey of atrial fibrillation.

Jemimah urges Indian men's team to aim for gold in Asian Games cricket

India's Jemima Rodrigues on Monday urged the men's team to aim for the gold after the women's team created history in the final of the Asian Games.

India Women's side beat Sri Lanka by 19 runs in the final to clinch the gold medal here on their maiden appearance.

Batting first, India posted 116 for seven on a difficult batting track before the Titas Sadhu-led bowling attack restricted Sri Lanka to 97 for

eight in 20 overs.

"We have spoken to the men's team. We have told them that we are bringing the gold; you guys also bring it," an elated Rodrigues told reporters

"(It) feels great. Just to win the gold is special, and being the first Indian cricket side to win the gold will make people go back in history and see that this was the team that actually won the first-ever gold in cricket in the Asian Games. It's an amaz-

ng feeling," she added.
Rodrigues said it was a proud feeling to add to India's medals tally at the Games.

"It is a very different experience, wearing this India jersey is a (matter of) different pride. Also, we can add a medal to India as a sporting nation," she

Talking about the gold medal contest on a challenging surface, Rodrigues said the contest had its own challenges.

"It wasn't easy as Sri Lanka gave us a good fight. Their bowlers bowled spot-on, and we really had to apply ourselves. Very proud of the girls, and the way we played today displays our character," she said our character," she said.

"It was an important partnership between me and Smriti (Mandhana) because the Sri Lankan bowlers were at the top

of their game.
"We are glad the way we played and built the partnership, along with the other girls coming in and chipping in," said Rodrigues (42), who added 73

runs with Mandhana (46) for the second wicket in a low-scoring

Rodrigues said the team had to adapt to different surfaces for every match. "We honestly did not know what to expect when we came over here," she said.

"We knew that we had to be ready for any condition, and in all three matches we had different kinds of wickets that we had to adapt to, which is the best part of our team's performance,' Rodrigues added.

"It's been a great experience in general, the way everyone has

welcomed us in China.

"It's not been easy since the communication has been a problem. But, they (the organisers) went out of their way to make us feel comfortable and make our stay easy," she added.

India coach and former international Hrishikesh Kanitkar too was delighted to have added to the country's

tally.
"We rank this gold right up there because it adds to the country's tally of gold medals. So, I think it's very, very important that we directly contribute to the country," he said.

Gold medal favourite Bopanna-Bhambri pair suffers shock exit

In a huge upset, gold medal favourites and top seeds Rohan Bopanna and Yuki Bhambri were knocked out of the Asian Games after being stunned by lower-ranked Sergey Fomin and Khumoyun Sultanov from Uzbekistan, here on Monday.

Bhambri struggled with his serve and strokes in the latter part of the match while the Uzbek players raised their game against their superior opponents to walk away with a 2-6 6-3 10-6 win in the second round.

The defeat will rankle the Indian pair all the more as Bopanna is a top-10 player in the doubles and Bhambri too is ranked among the top-100. The Uzbeks are not even in the top-300.



Serving at 3-4, 30-all in the second set, Bhambri served a double fault to go down by a break point. A wide backhand from Bhambri's racquet handed the Uzbeks the crucial break.

Sultanov made no mistake in serving out the set by consistently putting in his first serves.

In the super-tie breaker, the Uzbeks raced to a 3-0 lead and soon the Indians were down 5-1. The Uzbeks pulled off a stunning service return winner to make

Fomin earned four match points with a backhand winner. The Indians saved the first but Sultanov found a inside-out forehand winner on the second to close the contest in their favour.

Bhambri could not support Bopanna

India coach Zeeshan Ali said that Bopanna did not get the required support from Bhambri in the match.

Pakistani players issued Indian visa for World Cup travel

Members of the Pakistan cricket team were on Monday issued Indian visas for the ODI World Cup, the International Cricket Council (ICC) confirmed, hours after the PCB raised serious concerns with the global body over the delay in the national team's travel to Hyderabad.

The visa clearance came less than 48 hours before Pakistan's scheduled travel to India in the wee hours of September 27. They play their first warm-up game against New Zealand in Hyderabad on September 29.

"Visas have been issued to Pakistan," an ICC spokesperson told PTI.

However, confusion remained in the Pakistan camp over the grant of visa.

"We have not got the call from Indian High Commission yet over visa clearance. Member of our team is stationed there," PCB spokesperon Umar Farooq



told PTI.

The confirmation from the ICC came after the PCB wrote to ICC CEO Geoff Allardice on Monday over the visa delay besides claiming the anxious wait has adversely impacted the team's preparation for the 50over showpiece.

Pakistan were supposed to have a two-day team bonding session in Dubai before their scheduled arrival in Hyderabad on September 27 but was cancelled due to the uncertainty over Indian visa.

The Babar Azam-led side plays two warm-up games and as many World Cup matches in Hyderabad starting with the practice fixture against New Zealand.

In the letter addressed to Allardice, the PCB also claimed that its concerns over visa being granted to players, team officials, fans and journalists for the World Cup in India have not been addressed for more than three years. It also added that such inequitable treatment to Pakistan will not be acceptable.

Reiterating those concerns, Farooq added: "There has been an extraordinary delays in getting clearance and securing Indian visas for the Pakistan team for ICC World Cup.

The 26-year-old German will meet Roman Safiullin in Tuesday's final. The 55th-ranked Russian defeated second-seeded Lorenzo Musetti 6-3, 6-4.

Zverev hit 10 winners and four aces in the first set and his serve continued to be effective in the second set.

The 26-year-old Safiullin will be playing in his first career final in his eighth year on tour. At the Zhuhai Champion-

ships, top-seeded Karen Kha-chanov defeated fourth-seeded Sebastian Korda 7-5, 6-4 to move into the final in his second tournament since returning from iniurv.

Khachanov will face Yoshihito Nishioka in Tuesday's final. The eighth-seeded Japanese player beat Aslan Karatsev 6-4, 6-4.
